## **9 KILLED IN AP QUARRY BLAST**

TIRUPATI: In a tragic incident at least 10 workers were killed while several others were reportedly injured in a blast at a quarry in Andhra Pradesh's Kadapa district Saturday. It is alleged that the quarry was being operated without proper license near Mamillapalli village in Kalasapadu mandal of Kadapa district. The blast was triggered off when the workers were drilling holes on granite to insert explosive material inside. Due to the presence of large quantities of explosive material at the site which exploded at once, about nine work ers died on the spot while leaving several others injured. Villagers at Mamillapalli who heard the blast and noticed thick smoke emanating from the quarry rushed to the spot and alerted the local police who shifted the injured to the local area hospital for treatment.

## NOD FOR DRDO ANTI-COVID DRUG

**NEW DELHI:** The Drugs Controller General of India has approved an anti-COVID oral drug, developed by DRDO, for emergency use as adjunct therapy in moderate to severe coronavirus patients, the defence ministry said Saturday. It said clinical trials of the drug 2-deoxy-D-glucose (2-DG) showed that it helps in faster recovery of hospitalised patients and reduces supplemental oxygen dependence. The drug has been developed by Institute of Nuclear Medicine and Allied Sciences (INMAS), a leading laboratory of Defence **Research and Development** Organisation (DRDO), in collaboration with Dr Reddy's Laboratories in Hyderabad. The 2-DG comes in powder form in sachet and is taken orally by dissolving it in water. **P8**

New Delhi, May 8: The Supreme Court has set up a 12-member National Task Force to assess availability and distribution of medical oxygen - on scientific, rational and equitable basis - across the country

The Task Force will also suggest measures to ensure similarly rational and equitable availability of medicines needed to treat Covid-19, and provide inputs, based on members' scientific and specialised knowledge; to meet others challenges to have been raised by the Covid pandemic.

According to sources, Supreme Court judges spoke personally to each member of the Task Force, which is expected to begin work within a week. Reports will be submitted to the Centre and the court, but its recommendations will be sent directly to the Supreme Court.

### Covid report not must for hospitalisation

**SC Task Force to** 

oversee O<sub>2</sub> sharing

NEW DELHI: Requirement of a positive coronavirus disease (Covid-19) report is now no longer mandatory for admission to a Covid health facility, Union Health Ministry said Saturday. The ministry's revised national policy for admission of Covid patients to various categories of Covid facilities mentioned that a "suspect case shall be admitted to the suspect ward of CCC, DCHC or DHC as the case may be". "No patient will be refused services on any count. This includes medications such as oxygen or essential drugs even if the patient belongs to a different city," said the directive which was issued to the states and Union

Territories (UTs). The patient-centric measure was taken to ensure prompt, effective and comprehensive treatment of patients suffering from Covid-19. The court has directed the Centre

to provide the necessary assistance and said that all stakeholders from state governments to hospi-

The Task Force will have an initial tenure of six months.

tals - must co-operate.

The Task Force is to be led by Dr Bhabatosh Biswas, the former Vice Chancellor of the West Bengal University of Health Sciences, and will include Dr Naresh Trehan. Chairperson and Managing Director of Gurgaon's Medanta Hospital and Heart Institute.

Other members include leading doctors from Delhi's Sir Ganga Ram Hospital. Vellore's Christian Medical College, Bangalore's Narayana Healthcare and Mumbai's Fortis Hospital.

Setting up of the Task Force had been ordered by the top court Friday, when it called for a revamp of the Centre's allocation of oxygen to different states. The court said the Centre failed to consider factors like ambulances, lower-level Covid care facilities and patients in home quarantine.

The court had also demanded to know if the Centre was prepping for a possible third Covid wave.

## 'Community transmission' in Cuttack

Bhubaneswar, May 8: With the continuous surge in daily Covid-19 cases in Cuttack district during past few days, a senior government official Saturday said that a community transmission-like situation has emerged in the district.

Senior doctor and state government-appointed nodal officer for Cuttack district, Dr Umesh Ray told the media Saturday that the alarming rise in daily Covid positive cases in Cuttack city and the district could be due to community transmission.

However he said scientists at the Indian Council of Medical Research (ICMR) can only ascertain whether or not community transmission has occurred in the district. Claiming that the Covid surge in the district will peak in next 5-6 days, Dr Ray said the daily caseload in the district will gradually come down thereafter.

Talking about the probable reasons behind the surge in daily cases, the nodal officer said hundreds of people, including migrant workers from the other districts and states, returning to the district contributing to the number of Covid patients. It may be mentioned that only 27 new Covid cases were reported in the district April 1, while the number reached 1,052, Saturday (May 8).

Meanwhile, Cuttack Municipal Corporation (CMC) commissioner Ananya Das said the government is planning to increase the number of beds at SCB Medical College and Hospital in Cuttack and rope in more private hospitals for effective treatment of Covid-19 patients.

### 21 more succumb to Covid in state

BHUBANESWAR: Odisha Saturday reported 11,807 new Covid-19 cases, while 21 more people died in the state, a Health Department official said. The new cases were detected after 50.864 samples were tested Friday. The test positive rate (TPR) in the state stood at 23.21 per cent, indicating that one in every 4.3 people undergoing Covid tests is being found positive. In some districts, the TPR is nearly 50 per cent. the official said. There are 90.335 active cases in the state at present.

## Vaccination of 18+ in four more cities

Bhubaneswar, May 8: The state government plans to start a vaccination drive for people in the age group of 18-44 years in four cities of Odisha in the next few days.

This comes in the wake of the state receiving the first consignment of one lakh Covishield doses directly from the Serum Institute of India, Pune.

According to the state Health department, these vaccine doses would not be dispatched to the rural areas but will be sent to high burden urban areas to inoculate people in the 18-44 years age group.

"We have received 1 lakh doses of Covishield Saturday. We are now preparing a micro-plan to distribute them

#### PRESS TRUST OF INDIA

New Delhi, May 8: India and the European Union have agreed to resume talks for a balanced, ambitious and comprehensive trade agreement and also launch negotiations for a stand-alone investment protection pact, the External Affairs Ministry said Saturday.

These decisions were taken during a virtual summit between Prime Minister Narendra Modi and the heads of state or government of all the 27-member states of the bloc with a focus on expanding overall cooperation in areas of trade, investment and connectivity.

The two sides also launched a sustainable and comprehensive connectivity partnership; the ministry said and described the summit as a "watershed" moment in the ties.

The leaders also exchanged views on the Covid-19 pandemic and healthcare cooperation.



#### The India-EU leaders' meeting is hosted by Prime Minister of Portugal Antonio Costa. Portugal currently holds the Presidency of the Council of the European Union.

'We are opening a new chapter in #EUIndia strategic partnership at the meeting of EU Leaders with PM @narendramodi," tweeted Charles Michel, President of the European Council.

## Online speech shield under fire as Trump Facebook ban stays

UNDER THE 1996 COMMUNICATIONS DECENCY ACT, DIGITAL PLATFORMS HAVE LEGAL PROTECTION BOTH FOR CONTENT THEY CARRY AND FOR REMOVING POSTINGS

Washington, May 8: Lurking beneath Facebook's decision on whether to continue Donald Trump's suspension from its platform is a far more complex and consequential question: Do the protections carved out for companies when the Internet was in its infancy 25 years ago make sense when some of them have become global powerhouses with almost unlimited reach?

The companies have provided a powerful megaphone for Trump, other world leaders and billions of users to air their grievances, even ones that are false or damaging to someone's reputation,

Under the 1996 Communications Decency Act, digital platform companies have legal protection both for content they carry and for removing postings they deem offensive. The shelter from lawsuits and prosecution applies to social media posts, uploaded videos, user reviews of restaurants or doctors, classified ads - or the doxing underworld of thousands of websites that profit from false and defamatory information on individuals.

Section 230 of the law, which outlines the shield, was enacted when many of the most powerful social media companies didn't even exist. It allowed companies like Facebook, Twitter and Google to grow into the behemoths they are today.

Republicans accuse the social media platforms of suppressing conservative voices and giving a stage to foreign leaders branded as dictators, while Trump is barred. Democrats and civil rights groups decry the digital presence of far-right extremists and pin blame on the platforms for disseminating hate speech and stoking extremist violence.

"For too long, social media platforms have hidden behind Section 230 protections to censor content that deviates from their beliefs," Sen. Roger Wicker of Mississippi, the senior Republican on the Senate

On this, Trump and President Joe Biden apparently agree. Trump, while President, called for the repeal of Section 230, branding it "a serious threat to our national security and election integrity." Biden said during his campaign that it "immediately should be revoked," though he hasn't spoken about the issue at length as President.

Thunderstorm with lightning and gusty surface wind speed reaching 30-40 kmph is very likely to occur at one or two places of Balasore, Bhadrak, Jajpur, Kendrapara, Cuttack, Jagatsinghpur, Sundargarh, Deogarh, Angul, Dhenkanal, Keonjhar, Mayurbhanj, Sonepur, Sambalpur, Rayagada, Gajapati, Kalahandi, Kandhamal, Boudh and Nayagarh districts, Sunday. Similarly, a few places in Nayagarh, Ganjam, Gajapati, Koraput, Malkangiri, Nabarangpur, Rayagada, Kandhamal, Cuttack and Dhenkanal districts will also experience thunderstorm, Monday. However, light to moderate rainfall is likely to continue till May 13 morning, the Met department said.

Notably, the state Works department additional secretary, Hemanta Kumar Dutta, had written a letter to the chief general manager (technical), NHAI, Odisha, in this regard Friday.

Dutta, in his letter, said, "Take necessary action for exemption of charges at the toll gates under NHAI in the state to facilitate smooth transportation of the vehicles carrying medical oxygen in tankers or cylinders to the treating hospitals/Covid Care Centres (CCCs) in view of the Covid pandemic.

India is struggling with a second wave of the pandemic with more than 4,00,000 daily new coronavirus cases being reported in the past few days, and hospitals in several states are reeling under the shortage of medical oxygen and beds.

## Fewer carpenters for this year's Rath work

## Waiting for treatment, Covid +ve woman dies in front of hospital

**Dhenkanal, May 8:** A Covid-positive woman breathed her last in front of the district headquarters hospital here while waiting for the treatment Friday. Even her daughter's cries for help failed to move the medical authorities who did not attend to the patient leading to the woman's death.

The incident, which has been a talk of the town, has laid bare how miserably Covid patients are being mistreated in hospitals even as the government has been laying emphasis on making all possible help available to Covid patients.

While the health workers engaged for Covid patients are regarded as 'frontline Covid warriors', the incident proves to the contrary. ## Waiting for treatment, Sharp dip in milk offtake leaves dairy farmers in lurch

Kendrapara, May 8: Milk farmers in the district are a worried lot as there was a sharp drop in procurement of milk from farmers by the dairy companies, courtesy Covid-19 curbs. Moreover, a sharp rise in fodder and medicine prices for cattle has added to their woes. This has sparked resentment among farmers as they fear if the government does not alleviate their problems, they will lose their livelihood . Reports said various dairy companies and the stateowned OMFED have reduced their milk quotas from farmers after the enforcement of lockdown and shutdown.

OMFED lifts 35,000 litres of milk daily from farmers while Pragati Dairy at Ramiaganj lifts 30,000 litres. The Odisha Dairy at

Marshaghai Crossing lifts 10,000 litres while Milky Moo Dairy lifts 25,000 litres daily from the primary cooperative societies of farmers in the district.

This apart, various sweetmeat shops and tea stalls lift around 50,000 litres of milk daily from the farmers. Moreover, 10 quintals of cheese are transported to various

districts. A single household having three cows earns Rs 6,000 per month from milk sale.

Various dairy companies have already announced their decision before, OMFED announced it Friday. The state-owned entity said it would purchase only four lakh litres of milk, leaving milk farmers of the district clueless.

The shutdown has stopped sale of milk products with all hotels, sweetmeat shops, restaurants and tea stalls lying closed. Various milk producing farms have either stopped buying milk from farmers or reduced their daily quotas of milk purchased from them.

The district being an agricultural district, cattle and buffalo rearing is the prime occupation of over 2 lakh people here. People here have been

holding onto their occupation despite a shrink in pasture land.

These two lakh people alone hold over 310,000 cattle from which they produce milk and various milk-based products. These farmers have borrowed heavily for cattle rearing but they find it impossible to repay their loans.

Out of the total cattle population, over 170,000 are of indigenous varieties while 130,000 are hybrid. Similarly, the buffalo population in the district is over 10,000. While cattle rearing is the main occupation of people in various blocks, buffalo rearing is mainly done in Mahakalapara and Marshaghai blocks. Milk farmers Niranjan Parida, Jagdish Pati, Sk Asikuddin, confectioner Kailash Sahu and social activist Amarbar Biswal said Covid restrictions have hit the milk farmers of the district hard.

## Watch tower for tourists functional after 25 years

## Millet Mission strikes roots in Sundargarh

**Sundargarh, May 8:** In a bid to boost nutrition levels of people, the state government will introduce millet cultivation in three more blocks of Sundargarh district. The government has taken up a five-year action plan to encourage farmers to grow millet in Lahunipada, Lathikata and Gurundia blocks.

Funds will be allocated from the district mineral foundation (DMF) for the purpose. A tripartite agreement to this effect was signed among the DMF authorities, the agriculture and farmers' empowerment department and Agricultural Technology Management Agency (ATMA) at the DMF office here.

It was in 2018 Sundargarh was included among districts having potential to grow nutritious crops. In the first phase, farming of millets and other nutritious crops was taken up in Kutra, Nuagaon, Kuanrmunda and Rajgangpur blocks.

In 2020, Millet Mission was expanded to four more blocks in the district. Farmers of Tangarpalli, Hemgiri, Lefripada and Balishankara were provided financial assistance from the DMF to go in for millet farming.

Millets and other nutritious crops are now produced in eight blocks. As this farming is more lucrative than paddy, more farmers are keen to take up millet farming. Owing to its nutritional value, demand for millet is also going up in the district as well as in the state.

Significantly, millet has been added to the menu of schemes like Mid Day Meal Scheme (MDM), supplementary nutrition programme (SNP) under the Integrated Child Development Services (ICDS) and the Anganwadi Centres.

In view of this, the district administration had earlier proposed to the state government to promote millet farming in three more blocks. The government has given a go-ahead to the proposal of the district administration.

## **Come Clean**

The world is worried about its Vishwaguru as our mismanagement of corona has become a global story. The Institute for Health Metrics and Evaluation, an independent research centre in the United States, has estimated that by September, which means four months, another 10 lakh Indians will die. And this is based on the official numbers, which are difficult to accept given what has been revealed by the scenes in the crematoria and also by the numbers that newspapers have put out. A newspaper in Gujarat reported on May 6 that 17,822 bodies had been cremated or buried with Covid protocols in one month in the state's seven major cities: Ahmedabad, Gandhinagar, Baroda, Surat, Rajkot, Jamnagar and Bhavnagar. But the government had acknowledged only 1,745 deaths officially from Covid, or 10 per cent. And remember that these cities are only about a third or less of the state's total population. In the villages the chances of those being tested and treated are even fewer

This is not only about Gujarat of course. On May 3, a newspaper reported that Bhopal had acknowledged 104 deaths from Covid while reports from crematorium and cemetery spoke of 2,557 Covid

patients among the total of 3,811 who were cremated or interred. That is a ratio of 1:25.

A report on May 4 from Haryana said the difference between the official death toll and the number from crematoria was 1:2. This is similar to the number reported for Bangalore for last month (1,422 official toll versus 3,104 cremated with Covid protocols). In Uttar Pradesh, a report from Meerut said the difference was 1:7.

If we remove the outliers and look at the data it seems like a figure of twice and perhaps three times the official is not unreasonable. If we take that into account, our official death toll of 2.3 lakh, the third highest in the world, actually looks like 5.6 lakh or more than 7 lakh and easily the highest in the world. This will not surprise anyone and has been borne out by the saddening and shameful and horrific visuals that the entire world has now seen from India.

I should clarify that the fudging of the numbers is not entirely because of government fraud. It has happened in part because most people are dying at home, unable to access medical facilities or unable to afford them and they are not tested. Secondly, how a death is classified depends on the state government and the people making out the certificate. A person who has Covid but also has another disease can be classified as a Covid death or not. It serves the immediate purpose of the government to pre-

tend that the official number is low because it makes it appear less incompetent and helpless than it is. But hiding the number and not actively promoting the fact that things are worse is dangerous for us all.

The first reason why the government should come clean and say that its numbers are an undercount is public safety. If people are fed nonsense like "recovery rate" (a meaningless number for a disease that has no cure) then they will be less alert and more prone to carelessness on masking and social distancing. If they knew that many more people are dying after being infected especially because the government cannot manage hospitals at this point in time they would not think they were personally safe.

The second reason is our shortage of oxygen. After Delhi, now two BJPrun states, Gujarat and Karnataka, have said that they are not getting enough oxygen from the Modi government. Gujarat has said it needs 1400 tonnes a day and will need 1600 tonnes a day by May 15 but is currently getting only 795 tonnes. Karnataka had asked for 1200 tonnes instead of 962 tonnes allotted by the Centre.

The Centre says it has enough oxygen but this is untrue. We will make our jobs more difficult if we continue to be in denial. The third reason is credibility. The world is reporting the Indian numbers and saving that these cannot be believed. And the world cannot be blamed for feeling this, because it is true based on what our own media is reporting. The damage to India has already been considerable in terms of reputation but that is not important. What will happen is more countries banning Indian travellers. Already that list is guite large. In time the wave will recede but another is likely to come. At that point, the world will look at our official numbers and try and add a factor of their own to arrive at the real number if they think we are still fudging. This will harm Indians on work visas, families who are separated and Indian business in general. That is why in our self-interest we should actively make attempts to find out the real fatality rate as the first step for trying to curb this pandemic.

imposed only as a last resort. He has also said that the poor are left without food which leads them to breaking the lockdowns. That leads to greater spread of the virus and makes the lockdown unsuccessful for rich and poor alike. We have seen how the huge movement of migrant labour in the first lockdown had taken place and added to the infections.

**TARGETED LOCKDOWNS** 

It is clear that imposition and non-imposition of lockdownboth have a negative impact on the economy. The way out is to impose a lockdown but fine tune it to reduce the economic hardship. The Economist Today has suggested that construction workers could be required to stay within the boundaries to reduce possibility of infection. The same could be done for manufacturing industries and software parks. Another suggestion is to segregate workers in two groups and place them in alternate shifts so that, in case infection takes place, it affects only one-half of the workers and production does not come to a standstill.

It is also necessary to determine on which activities to impose, and on which activities not to impose a lockdown. Economists calculate the costs and benefits of various projects. The costs and benefits of locking down various activities can be calculated separately. For example, the costs and benefits of lockdown in schools, bus travel. rail travel. international

travel, restaurants, cinema halls, street corner markets and manufacturing activities can be calculated separately. Those activities that have high costs and low benefits can be locked down while others can be allowed. For example, cinema halls may have a high cost because large numbers of people are confined in a closed space but the benefits may be nominal since they add very little to the economic activity. Such activities can be locked down. While schools that create long term economic value may be allowed to open.

With certain activities there can be multiple scenarios. For schools, for example, the costs and benefits can be calculated in following scenarios: (1) complete lockdown: (2) complete lockdown with e-learning; (3) no lockdown with aggressive testing and tracing; and (4) no lockdown without testing ad tracing. This calculation can then be done separately for primary, secondary and higher education. It can further be done for residential and non-residential schools. It may appear cumbersome to make these calculations. But given that the pandemic shows no signs of abating it is necessary to assess these multiple options and implement the best among them. Such fine tuning would encourage the institutions to move to Covid-resistant models. For example, schools may move towards the e-learning and residential models so that they can operate de

spite lockdowns.

A paper in the Wiley Clinical Practice journal has emphasised that lockdowns are more likely to succeed if people are taken into confidence rather than imposed from the top. I recall that last year towards the beginning of the pandemic, New York Governor Andrew Cuomo used to hold onehour long press briefings every day and informed people of the true state of the pandemic and the facilities that he was trying to arrange. I believe that had a great impact on compliance by the public. Even I sitting in India was impressed. On the other hand, even during the strict lockdown last April, the ministers in Uttarakhand were nowhere to be seen and officials were issuing passes to one and sundry. The holding of public meetings and family functions without social distancing in the presence of leaders sends exactly the opposite message. A daily press briefing by our Minister of Health would help clear a lot of misinformation that may be circulating. I recall that Lal Bahadur Shastri had asked the people of the country to fast one day a week to save food grains. I was only 15 vears old at that time and was en-

couraged to follow the advice. A study by Harvard University has said that direct cash transfers to poor must be made while imposing strict lockdowns. A paper published by the scholars of the London School of Economics has said that helping small industries and affected people to manage through the pandemic by giving loans may not work. The borrow ers will be burdened by debt and, in absence of quick revival of economic activity, will not be able to repay the debt. That may necessitate write-offs and further impose costs on the economy.

We need to shift gears. More nuanced lockdowns are needed along with cash transfers to get out of the pandemic.

### Mulct

s this word said as mulch? No, the c is hard, like the effect on the person being mulcted. It derives from classical Latin, in which multa or mulcta meant a fine or penalty. The c was probably introduced as the result of confusion with the verb mulcare, to handle roughly or damage, an unsurprising association of ideas. But many centuries passed before the change became general. Both Anglo-Norman and Middle French had multer, to pay a fine. It came into in English in the fifteenth century as mult and it was a century before the c became wedged permanently into place. (The same thing happened in French, in which mulcter evolved from multer at about the same time, though the verb has disappeared from the modern language.) Mulct remains in English, though in its original sense it is now restricted to the world of lawyers and judges. Elsewhere, it has shifted to refer to the illegal extraction of money through fraud or extortion. Since it appears in phrases such as "mulcting the poor taxpayer", we may assume people subject to some legally sanctioned mulct came to regard it as excessive. The [energy supply] industry is quick to pass on price increases, and damnably slow to give customers the benefit of today's tumbling costs. It is no good urging these hardfaced profiteers. The only thing they understand is the brute force they use to mulct their customers (Daily Mirror, 12 Dec. 2008). Scots once had a related term, multure, based on the older spelling of mulct, which can be traced back to the early thirteenth century for a charge or toll made by a miller, a multurer, for grinding corn.

WHETHER THE US **WOULD STILL FIGHT A WAR OVER TAIWAN HAS** BECOME **A QUESTION** SUBJECT TO WHAT **HENRY KISSINGER** LONG AGO TERMED **"STRATEGIC** 

**AMBIGUITY**"

China, better known as Taiwan? President Biden laid out his vision clearly last week. He sees the rivalry between the PRC and US as a global conflict between democracy and autocracy, and the ROC is unquestionably one of Asia's most successful democracies.

In 1954, President Eisenhower threatened to use nuclear weapons after China shelled a rocky islet near Taiwan's coast, when the ROC was still a military dictatorship. But things were different then. The US was treaty-bound to defend Taiwan. This changed after 1972, when President Nixon agreed that Taiwan was part of "one China," and President Carter nullified the defense treaty in 1979. Whether the US would still fight a war over Taiwan has become a question subject to what Henry Kissinger long ago termed "strategic ambiguity."

As a result, American military commitments in the East China Sea are peculiar. A defense treaty with Japan obliges the US to defend a few uninhabited rocks called the Senkaku Islands (or the Diaoyu Islands in Chinese), but not democratic Taiwan and its 23 million people. There are practical reasons why a Chinese military attack on Taiwan

pen could start a dangerous nuclear arms race in East Asia. Taiwan also has highly advanced computer technology, which the US and its democratic allies would prefer not to see in the PRC's hands.

Then there is the long hand of history. We are not determined by the past, but we ignore it at our peril. At the core of contemporary Chinese nationalism is the idea of national humiliation redeemed by renewed greatness. According to this narrative, for at least one hundred years, between the Opium Wars in the 1840s and the brutal Japanese invasions in the 1930s and 1940s, China was degraded, bullied, and occupied by foreign powers. Only the national revival overseen by the CPC will ensure that this never happens again.

This lesson is taught throughout the country, in patriotic museums, memorials, movies, books, musicals, and of course history textbooks One reason for the current dominance of revanchist nationalism in official Chinese rhetoric is the weakening of Marxist-Leninist or Maoist ideology in China. With so few Chinese, even Communists, still believing the old dogma, the Party needed a new justification for

China never cared much about Taiwan. Nor is it important that it was not the Chinese people who were humiliated, or even China as such, but rather the Qing Dynasty's empire, ruled by Manchus, which the Chinese Revolution in 1911. led by Han Chinese, brought down. None of that matters: the Party regards restoring or keeping the Qing imperial possessions, like Taiwan and Tibet, as a sacred patriotic duty Americans are affected by a different history – for which they weren't even directly responsible. It was Britain's Neville Chamberlain who signed the Munich Agreement in 1938, allowing Hitler's Germany to begin dismantling Czechoslovakia. Chamberlain's name would be associated forever with cowardly appeasement, while Winston Churchill emerged as the great war hero.

But the Munich Agreement has haunted American foreign policy, possibly even more than Britain's. like a vengeful ghost. Presidents and prime ministers have been terrified of being compared to Chamberlain and have dreamed of being heroic Churchills. When the British refused to send troops to Vietnam to help the French fight against Ho Chi during the 1960s, Richard Nixon, among many others, warned of another Munich. More recently, in the US-led wars against Saddam Hussein, both Presidents Bush, father and then son, compared the Iraqi dictator to Hitler, and fancied themselves in the role of Churchill. On the eve of that war, British PM Tony Blair read Chamberlain's diaries as a lesson in what not to do.

It may be that in today's world, when a superpower conflict could destroy much of mankind, China and the US will avoid a war over Taiwan. So far, China appears to be playing a game of chicken, probing Taiwanese defenses, flying into its airspace, stepping up naval patrols, engaging in military practice runs for an invasion, and making provocative statements about "not ruling out the use of force." This is met on the American side with more arms shipments to Taiwan and tough talk about a new cold war

Being in thrall to the ghosts of history makes it harder to back down. If both sides refuse to do so in a crisis, everyone will lose.

## **Battling Covid & govt denial in rural UP**

Moradabad, May 8: People in India's most populous state Uttar Pradesh are fighting not just a raging pandemic but also a prickly local government that many say is in denial

The state authorities insist there are no shortages and take a dim view of those "spreading fear" But the virus is clearly wreaking havoc as it spreads beyond big cities into the towns and villages not only of Uttar Pradesh, home to 240 million people, but elsewhere in India's colossal hinterland.

Brijesh Pandey spends hours every day in the hot sun jostling with others for medical oxygen for his brother-in-law, who is now at home struggling to breathe.

The 42-year-old said the family spent an astronomical Rs 40,000 to arrange an empty oxygen cylinder."The government says that there is ample supply of medicines and oxygen. But look how hundreds of desperate people are struggling to save their brothers, sis-

where many experts suspect this is a major underestimate.

In the state capital Lucknow, the official death toll for April is 830. But two crematoriums say they handled more than 1.900 bodies while 500 others were buried in the Muslim graveyard.

### **BURNING PROOF**

Vivek Awasthi, founder of the non-profit Uttar Pradesh Voluntary Health Association, told AFP that villagers were sometimes treating the virus like a common cold and not taking proper precautions to stop it spreading. Their nearest hospital is also often far away.

Ramchandra Nirmal, 49, who works as a security guard in

Mumbai said that people back in his village in Uttar Pradesh could travel to small nearby clinics.

"But if you want to get oxygen you have to go to a hospital which is around 110 kilometres away,' Nirmal told AFP. Many have blamed the spread on migrant workers returning from cities and on pilgrims who attended the enormous - and largely mask-free -- Kumbh Mela

Another factor is recent villagelevel elections across Uttar Pradesh in which millions of people voted even as the pandemic raged.

Pavan Singh said his 42-year old brother, a science teacher, contracted the virus and died after working as one of thousands of election officials.

Teacher unions have said that more than 700 members have died in recent weeks after being involved in the process.

"He was admitted to three hospitals in a span of a week because some of them were running out of medicines and oxygen," Singh told AFP. "My brother would be alive if the government had used some sense," he said.

Singh's anger was shared by others gathered at the same makeshift crematorium on the banks of the Gagan river to perform last rites. "The government is lying that there is no crisis," said Sanjeev Yadav, whose sister-inlaw died at home. "These burning pyres prove that there is a crisis and the government is just trying to cover-up.

# Guj: Black fungus claims eyesight of Covid survivors

Ahmedabad, May 8: Cases of Mucormycosis, a fungal infection, affecting some COVID-19 survivors are on the rise in Gujarat which has left many patients blind, doctors and officials claimed Saturday.

Mathur Savani, chairman of Surat-based Kiran Super multispeciality hospital, said Mucormycosis was detected in a patient who had recovered from COVID-19 disease around three weeks back.

'This number has gone up to around 50 now while 60 more such patients are awaiting treatment," Savani told PTI.

The hospital, which is managed by a trust, has been receiving several patients diagnosed with Mucormycosis who are being referred from various areas in Surat and other parts of Gujarat, he said.

"As of now, 50 Mucormycosis patients are getting treated at Kiran Hospital and 60 others are awaiting (treatment). They all came to our hospital in the last three weeks. All the patients who are suffering from Mucormycosis had recovered from COVID-19 recently," said Savani.

According to Savani, seven such patients have lost their eyesight so far. Meanwhile, considering the growing number of patients with Mucormycosis, Surat's civil hospital has set up a separate facility for their treatment, said in-charge Resident Medical Officer (RMO) Dr Ketan Naik.

In Ahmedabad, at least five patients with Mucormycosis are being operated upon every day at the civil hospital at Asarva, a senior doc-

tor said. "In Ahmedabad, we are receiving 5 to 10 such cases at the civil hospital, especially since the second wave of COVID-19 started. These patients are being examined on priority and operated on as early as possible," said Dr Devang Gupta, ENT doctor at the city civil hospital. He said various resources, including manpower, equipment and injection required for the treatment of Mucormycosis patients, have been provided by the government. "At least one out of the

five such cases is related to eyes. Several of them (patients) are suffering from blindness," he said.

Niti Aayog Member (Health) VK Paul Friday said Mucormycosis is being found in patients with COVID-19 disease.

"It is caused by a fungus named mucor, which is found on wet surfaces. It, to a large extent, is happening to people who have diabetes. It is very uncommon in those who are not diabetic. There is no big outbreak and we are monitoring it," he had said.

According to Dr Paul, mucor attacks people with uncontrolled sugar. He had also said when the same COVID-19 patient is put on oxygen support, which has a humidifier containing water, the chances of him or her getting the fungal infection increase.

## Guj urges Centre to raise oxygen allocation to state

Ahmedabad, May 8: The Gujarat government has requested the Centre to raise to 1,400 metric tonnes the allocation of medical oxygen to the state by May 12, saying that due to the shortage of the life-saving gas, it was unable to operationalise 11,500 additional beds for COVID-19 patients

It said that the Centre's current allocation of 975 metric tonnes (MT) is way below the requirements of the state.

"The Government of India has not increased the allocation of (med-

etc, the state is not able to meet the rising demand for oxygen and as a consequence, is not able to operationalise additional 11.500 beds. created with oxygen line, just for want of oxygen, he added.

This is causing tremendous distress in rural areas, because now the COVID-19 cases are picking up there and yet, hospitalisation with oxygen therapy is not available resulting in long wait before the hospital admission, the letter said.

"Under these circumstances. I request you to immediately enhance allocation of medical liquid oxygen under central allocation to Gujarat to 1,200 MT for today (May 6) and 1,400 MT for May 12," Mukim said. Meanwhile, in the same affidavit, the state government said that it has administered 2,24,749 doses of COVID-19 vaccine to 18-44 age group till May 5, and orders have been placed for two crore doses of Covishield from Serum Institute of India in Pune, and 50 lakh doses of Covaxin from Bharat Biotech in Hyderabad on April 25 for that purpose.

Accordingly, Gujarat's requirement of medical oxygen has gone up from projected 1,250 MT (as on April 30), to 1,400 MT for today (May 6) and is likely to increase to 1,600 tonnes by May 15, Mukim said in the letter.

This government order would be applicable within the Municipal Corporation limits.

Chief Minister Yogi Adityanath announced this decision after reviewing the matter with Team Nine about the exorbitant amount of money charged for a funeral following death due to Covid-19 in several districts.

Additional Chief Secretary Manoj Kumar Singh has sent a letter to all the municipal corporations and civic bodies directing them to arrange free funerals of deceased Covid patients falling within the limits of the urban bodies. The municipal corporations will bear the expenses of funerals at all crematoriums, cemeteries and cremation grounds falling within the limits of the corporation. It has been made mandatory to follow Covid-19 protocols while conducting such funerals. Lucknow. May 8: Students and faculty at an engineering college in Lucknow have created an indigenous oxygen concentrator that claims to aid those suffering from Covid-19.

Adarsh Vikram and Ambesh Pratap Singh, both electrical engineering students at Tirupati College of Engineering in Mohanlalganj in Lucknow, created this indigenous concentrator under the leadership of Project Guide and College Director Ashutosh Sharma as well as Head of the Department (HOD) of Electrical Engineering, Rajendra Dixit.

Dixit said after the shortage of oxygen during the Covid-19 crisis, people are buying oxygen concentrators from the market at exorbitant prices.

"Moved by this overcharging of people in need of oxygen, together with the help of the students, we have created an indigenous concentrator which has been prepared at half the price of a concentrator available in the market. The speciality of our oxygen concentrator is that it is completely indigenous.' he said.

Dixit added, "We are doing our best to launch our oxygen concentrator in the market. We have contacted administration officials. This concentrator operates at a capacity of nearly 10 litres per

## Profiteering in pandemic

Ahmedabad, May 8: There is rampant black marketing of Covid-essentials in Gujarat. In the latest case, police arrested three people for alleged black marketing of oxygen cylinders, while three others have been nabbed for illegally storing 35 vials of Remdesivir in Ahmedabad, an official said Saturday.

Acting on a tip-off, officials from the city crime branch raided a godown in Sarkhei area and seized 39 oxygen cylinders Friday, the official said. The team nabbed three persons who were allegedly involved in selling oxygen cylinders at inflated prices to COVID-19 patients, he said. "They were selling six-litre capacity cylinders for Rs 15,000 each and the 10-litre ones for Rs 25,000 each. They did not have the permit to store or sell medical oxygen cylinders," the official said.

The police have recovered 28 six-litre capacity cylinders, five 10litre ones, apart from six empty cylinders from the accused, he said. The accused have been booked under sections 286 (negligent conduct with respect to explosive substance). 420 (cheating), among other provisions of the IPC. Essential Commodities Act and Disaster Management Act.

In another development, the city crime branch arrested owners of a city-based medicine distribution company for illegally storing 35 vials of Remdesivir in their godown, medical store and office, an official said. Police arrested owners of Ahmedabad-based Anand Medicine Pharmaceutical Distributors Chirag-Shah and Sandip Mehta as well as Jayesh Bhaysar, he said.

The Central government has so far provided more than 17.49 crore vaccine doses (17,49,57,770) to states and UTs free of cost. Of this, the total consumption including wastages is 16,65,49,583 doses, according to official data made available at 8 am.

More than 84 lakh Covid vaccine doses (84,08,187) are still available with the states and UTs to be administered. States with negative balance are showing more consumption (including wastage) than vaccine supplied as they have not reconciled the vaccine they have supplied to armed forces, the Ministry said.

## '8 Covid survivors die of black fungus in Maha'

Mumbai. May 8: At least eight COVID-19 survivors have died due to mucormycosis, a fungal infection, during treatment in Maharashtra. a senior official said Saturday, adding the total 200 such patients are being treated. According to Dr Tatyarao Lahane, who heads the Directorate of Medical Education and Research (DMER), cases of mucormycosis are on the rise. Eight out of 200 such patients treated so far in various parts of the state have died due to mucormycosis, also known as a black fungus. They survived COVID-19 infection but the fungal infection attacked their weak immune system which proved fatal, Dr Lahane told PTI. Niti Aayog Member (Health) V K Paul Friday said mucormycosis is caused by a fungus named mucor, which is found on wet surfaces. He had also said when the same COVID-19 patient is put on oxygen support, which has a humidifier containing water, the chances of him or her getting the fungal infection increase

are increasing because of COVID-19 related complications, wherein the use of steroids elevates the sugar level in blood while some medicines result in suppression of immunity of patients

### Hosp staffer held for selling fake Remdesivir

New Delhi: The complicity of hospital staff in the black marketing of medicines and selling fake injections amid the Covid-19 crisis has shaken people's belief in the healthcare system in the national capital. The Nangloi police have uncovered a similar nexus where a person working as a dialysis staffer at a hospital in New Delhi's Shalimar Bagh area has been arrested for selling fake Remdesivir injections.

Dr Lahane said the fungal disease is already known but the cases

In such a scenario, the black fungus infects the patient easily and spreads. If the fungus reaches the brain of the infected person, it can prove fatal. In one such case, one of the eyes of a patient had to be removed permanently to save his life, he said.

Dr Lahane said mucormycosis is a serious fungal infection that is found among people with a low level of immunity as well as among those suffering from chronic diabetes, or those who have gone through a kidnev transplant among others. Though this fungus is present in the environment, people with suppressed immunity as well as who have received steroids during COVID-19 treatment are more susceptible to it. COVID-19 patients with co-mor-

bidities are also vulnerable and can catch the infection early, he explained. Dr Lahane said the general symptoms of mucormycosis include headache, fever, pain under the eyes, nasal or sinus congestion, and partial loss of vision among others.

## Modi govt bogged by 11,424 LoC ceasefire violations in 7 yrs: RTI

YEAR-WISE, THE BORDER INFRINGEMENTS SHOT UP ASTRONOMICALLY FROM JUST 1 IN 2004 TO A STAGGERING 4,645 IN 2020 - OR A ROUGH DAILY AVERAGE OF 13 - A YEAR AFTER INDIA'S SENSATIONAL AIR-STRIKES IN BALAKOT

Mumbai, May 8: In a glaring indicator of the growing tensions in India's immediate neighbourhood, it has now emerged that there were a whopping 11,424 Ceasefire violations (CFVs) on the border under the seven years of the NDA government, compared with just 523 CFVs during the UPA's 10-year rule.

Year-wise, the border infringements shot up astronomically from just 1 in 2004 to a staggering 4,645 in 2020 - or a rough daily average of 13-a year after India's sensational air-strikes in Balakot (Feb 2019) and the country acquired a sleek fleet of Rafale fighter jets. (July 2020)



As per RTI replies given to Pune-based activist Prafful Sarda, the revelations largely pertain to the CFVs along the India-Pakistan borders (LoC), which has always been a super-sensitive issue with India.

However, the government has categorically refused to divulge details of CFVs on the India-China borders (LAC) including specific details of the Doklam incidents, under RTI Act. 2005, Sec 8(1) (a), in the replies furnished by Brig V K Bhat, CPIO, Indian Army Headquarters.

The government ostensibly feels such disclosures could affect India's sovereignty and integrity, her security, strategic, scientific or economic interests, relation with foreign state, etc, Sarda told IANS.

The RTI replies reveal how during the UPA government of Prime Minister Manmohan Singh between 2004-2013, there were a total 523 CFVs on the border, starting with just one in 2004, 6 the next vear and 3 the following year.

The CFVs entered the doubledigit and kept fluctuating with ups and downs, starting with 21 in 2007, jumping to 77 in 2008, down to 28 in 2009, spelling relief.

From then, there was no looking down and the CFVs kept soaring each year, starting with 44 in 2010, 51 (2011), 93 (2012), and 199 in 2013, almost till the end of the UPA government's second term. In the Bharativa Janata Party-led NDA's first couple of years, things appeared bright with CFVs dropping from 199 the previous year (2013) to 153 in 2014 and 152 (2015).

After Prime Minister Narendra Modi's unscheduled trip to greet former Pakistan PM Nawaz Sharif for his birthday in Dec 2015, things were expected to improve further, but in 2016, there were 228 CFVs...!

The following year, 2017, when Nirmala Sitharaman became the Defence Minister the borders became hyperactive and the year saw 860 CFVs. That was nearly four times compared with 228 in 2016 when Pakistan rattled India with the Uri attacks and India retaliated with the 'surgical strikes' in-Pakistan Occupied Kashmir (POK) in September that year.

Of the eight cell lines tested, the spikes of B.1.617 and B.1351 mediated entry into Calu-3 lung cells and Caco-2 colon cells with slightly increased efficiency, compared with the original strain.

New Delhi, May 8: The Central Board of Indirect Taxes and Customs (CBIC) Saturday allowed businesses to import and export goods without furnishing bonds to the customs authorities until June-end, a move aimed at ensuring no delay or disruption in EXIM trade due to Covid.

In a circular, the CBIC said importers and exporters will have to

furnish an undertaking to the Customs authorities in lieu of the bonds till June 30.

The indirect tax body said it has received representation from traders to accept undertaking in lieu of bonds in certain cases of Customs clearance, in view of the difficulties being faced in the ongoing lockdown/constraints imposed in different regions of India. To expedite Customs clearance of goods and for maintaining bal-

ance between Customs control and facilitation of legitimate trade, the CBIC said it has approved relaxation of the requirement to submit bonds. '...The Board has decided to re-

store the facility of acceptance of an undertaking in lieu of bond by Customs formation ... Till June 30, 2021. Importers/exporters availing this facility shall ensure that the undertaking furnished ... Is duly replaced with a proper bond by July 15, 2021," the CBIC said in a circular.

Last year too in the wake of Covid pandemic, the CBIC had allowed businesses to import and export goods without furnishing bonds to the customs authorities.

AMRG & Associates Senior Partner Rajat Mohan said due to the resurgence of the pandemic, customs has yet again eased out certain customs procedures. "These measures would facilitate international trade and ensure continuance of business operations,' Mohan added.

To guard against such cash being taken over, the finance ministry has asked PSBs to be extra vigilant and immediately report back any attempt Cairn makes to legally attach the deposits, two sources aware of the matter said.

# **CHANGE IN HOST LIKELY** Atletico draw with Barca to keep lead

ENGLAND COULD HOST CHAMPIONS LEAGUE FINAL BETWEEN MANCHESTER CITY AND CHELSEA DUE TO NEW TURKEY TRAVEL CURBS

London, May 8: The all-English Champions League final could be played at home after Turkey was added to England's "red list" of countries where all but essential travel is banned due to severe coro navirus outbreaks.

Chelsea and Manchester City are due to meet May 29 in Istanbul and UEFA was hoping to allow around 10,000 fans into the biggest club game of the European football season.

But the British government Friday warned supporters not to travel to Turkey after imposing the new travel restrictions, and said the English Football Association was in talks with Champions League organizer UEFA about staging the game in Britain, instead.

The most logical English venue to move the game to is Wembley with the London stadium staging eight games of the European Championship across June and July, so it has UEFA's required logistics and broadcasting infrastructure already in place. Wembley was also already due to stage the

been floated as an option, it is an older stadium that would require significant infrastructure being installed to reach UEFA requirements.

"We are very open to hosting the final but it is ultimately a decision for UEFA," British Transport Secretary Grant Shapps said.

"The UK has already got a successful track record of football matches with spectators, so we are well placed to do it. Given there are two English clubs in that final, we look forward to what they have to sav.

Turkey is in the second week of a three-week national lockdown and government figures show coronavirus cases are declining but 20,107 new infections were announced on Friday and 278 deaths. The vaccine rollout in Britain meant the country recorded 2,490 cases Friday and 15 deaths.

People from England should visit only red-list countries "in the most extreme of circumstances," Shapps said. Anyone returning from them must stay in hotels for 10 days at their own expense, with meals delivered to their door. Players would also be required to enter quarantine, unless exemptions were granted, which would impact their preparations for the European Championship, which opens June 11 and is being staged across 10 countries.

If the Champions League final was moved to Wembley, the English Football League would have to accept moving the date of the Championship playoff to determine the final promotion place to the Premier League, which is scheduled to be played at the stadium May 29.

Wembley in recent weeks has staged the only football games with fans in England in 2021 as part of test events, with the crowd for the FA Cup final on May 15 rising to 21,000 people who have to produce a negative coronavirus test.

At least 22,500 fans will be allowed into the three group-stage Euro 2020 games at Wembley in June, with the 90,000-capacity Wembley set to be half-full for the final July 11.

The pandemic already prevented Istanbul staging the 2020 Champions League final with the game moved to Lisbon to be played in an empty stadium.

Madrid, May 8: Atletico Madrid held on as leader of the Spanish league by holding Barcelona to 0-0 at the Camp Nou Stadium Saturday. Atletico remained two points in front of Barcelona with three rounds to go, still in position to win its first league title since 2014.

Atletico can be surpassed Sunday if defending champion Real Madrid defeat Sevilla at home. Madrid is three points behind Atletico but would take the lead because it holds the head-to-head tie-breaker against its city rival. Sevilla were seven points behind Atletico and remained a title contender. Atletico played well at the Camp

Nou but couldn't capitalize on their

chances, with Luis Suarez unable to break through with a goal against his former club.

Lionel Messi had some of the few chances for Barcelona, his best near the end of the first half after a great run past defenders. But his shot was brilliantly saved by Atletico goalkeeper Jan Oblak. Messi's 90th-minute free-kick just missed the post.

Barcelona defender Ronald Araujo had a goal disallowed for offside in the 70th. Atletico remained winless at the Camp Nou since Diego Simeone took over as coach in late 2011. The team is winless in 15 consecutive away matches against Barcelona, since 2006. However, a 1-1 draw at the stadium in 2014 was enough to clinch Atletico their last league title.

According to family sources, Singh had recovered from the virus and was shifted to non-COVID ward Thursday after testing negative. But his condition suddenly deteriorated Friday and he was put on a ventilator.

Singh, who also played at the 1984 Los Angeles Olympics, did not get married and is survived by a niece. Pragya Yaday Singh also played in the 1979 Junior World Cup and took voluntary retirement from State Bank of India after quitting hockey. Born in Sitapur September 6, 1960, Singh excelled as a centre-half from 1979 to 1984. Besides two Olympics, Singh had also represented India in the Champions Trophy in Karachi (1980, 1983), Silver Jubilee 10-na-

tion Cup in Hong Kong in 1983, 1982 World Cup in Mumbai and 1982 Asia Cup in Karachi, among other tournaments.

Sports Minister Kiren Rijiju condoled the death of the double Olympian. "I'm deeply saddened to learn that Shri Ravinder Pal Singh ji has lost the battle to COVID-19. With his passing away India loses a golden member of the hockey team that won Gold in the 1980 Moscow Olympics. His contribution to Indian sports will always be remembered," he tweeted. Hockey India also mourned the untimely demise of Singh. "Hockey India extends its deepest condohis achievements will always be remembered. May Ravinder's family and friends have the strength to pass through this difficult time," HI president Gyanendro Ningombam said.

New Delhi, May 8: Indian cricketers will complete an eight-day hard quarantine period in Mumbai before leaving June 2 for a marathon tour of United Kingdom, where they will play six Test matches including the marquee World Test Championship final against New Zealand.

The BCCI is still carrying out negotiations regarding the duration of 10 days of soft quarantine (training allowed) for players after reaching the UK where they will be based for three and half months.

"Indian team will have eight days of hard quarantine (confined to hotel rooms) in India with mandatory negative RT-PCR reports on second, fourth and seventh day required to board the flight," a senior BCCI official told this agency,

Saturday. "Since we have a bubble to bubble transfer, it needs to be seen if the duration of the 10-day quarantine can be reduced a bit. However players during soft quarantine can go for training. In any case, Hotel Hilton where the teams will be put up in Southampton, is a part of the Ageas Bowl property," the source added.

In case it's a 10-day quarantine, the Indians will be allowed to move



around the city from June 13 while the WTC final against New Zealand will start June 18.

It is also learnt that looking at the length of the tour, players' families will accompany them. However it is still not clear whether the WAGs and children will join from the start of the tour or come after the WTC final when there is a substantial gap of more than a month before the start of the Test series August 4.

The BCCI is also confident that all the players will get their first dose of vaccine before embarking on their journey to the UK. However it will be difficult for Prasidh

Krishna, who has tested positive after coming in contact with Varun Chakravarthy, to get vaccinated before leaving for UK.

If all Indian players get Covishield vaccine in India, it will be easier to get the second jabs in the UK as it's the Oxford vaccine.

BCCI president Sourav Ganguly and secretary Jay Shah are expected to be present in Southampton for the WTC final. One could expect them having some discussions with ECB brass with regards to the option of hosting the remaining 31 games of IPL in the United Kingdom apart from various ICC policy decisions.

## **HAMILTON TAKES HIS 100TH POLE**

Hamilton won his 100th career pole position after barely edging Max Verstappen to the fastest time in qualifying for the Spanish Grand Prix Saturday. Hamilton pushed his Mercedes to a flying lap of one minute, 16.74 seconds. Verstappen in his Red Bull was only 0.03 seconds behind. Hamilton's teammate Valtteri Bottas was right behind in third. Hamilton leads the F1 standings by eight points over Verstappen going into the fourth race of the season. Hamilton has won the Spanish GP five times, including each of the past four years. He will be looking to equal Michael Schumacher's six wins in Montmelo Sunday and claim his 98th career victory.

### **NEYMAR EXTENDS CONTRACT WITH PSG**

PARIS: Neymar has signed a three-year contract extension with Paris Saint-Germain, keeping the Brazil star at the club until 2025. PSG announced the deal Saturday, posting a video of Neymar wearing a jersey with 2025 on the back and saying "Ici c'est Paris" - 'This is Paris', a favorite chant of the fans. Neymar also spoke to the club's website. "I'm really pleased to continue my adventure at PSG. I'm very happy in Paris, and proud to be part of this squad," he said. The 29-year-old Neymar would have been out of contract next June, along with striker Kylian Mbappe - who has yet to re-sign and has been linked with a move to Spanish giant Real Madrid.

### RAHANE, UMESH GET FIRST DOSE OF VACCINE
