Bhubaneswar, May 10: In a move to ensure undisrupted vaccination, the state cabinet Monday decided to float a global tender for procurement of Covid-19 vaccines.

The state cabinet headed by Chief Minister Naveen Patnaik took the decision and allowed the health department to take necessary steps for procurement of vaccines so that all the people of the state are vaccinated

The cabinet's move came in the wake of poor supply of vaccines to the state by the Centre

PVT HOSPS TO WAIT LONGER FOR SHOTS

BHUBANESWAR: Those wishing to get vaccinated at private healthcare centres may have to wait longer as the Bhubaneswar Municipal Corporation (BMC) Monday clarified that the city was facing a shortage of vaccines. Even though the state government had earlier permitted people to take vaccines at private healthcare centres by paying just ₹100 as administration fees, BMC Commissioner Prem Chandra Chaudhary stated that private hospitals have not been provided vaccines due to undersupply of doses.

The cabinet has also approved a proposal on rules to regulate the method of recruitment and service conditions of the persons appointed in Odisha nursing college education service. The proposal for irrigation at command areas utilizing ground water resources through deep bore wells with solar pump system in remote areas of the state under the Buju Krishak Bikash Yojana Deep Borewell Secha Yojana also received the cabinet nod.

The tender for construction of sports infrastructure facilities in Kalinga Stadium Bhubaneswar and construction of a new international hockey stadium at Rourkela for Hockey World Cup were also approved. The panel further okayed amendment to the Odisha Transport- Traffic and Enforcement Rules, 2013 for manufacturing and refilling of medical oxygen.

Amendment of the Odisha ex-servicemen (recruitment to state civil services and posts) rules, annual report on activities of Odisha Public Service Commission for the year 2017-18 and framing of the rules for accommodation and other services in Odisha Bhawans owned and maintained by the home department outside the state-2021 was also approved by the cabinet.

COVID TOLL UP **BY 17 IN STATE**

BHUBANESWAR: Odisha's COVID-19 caseload Monday rose to 5,44,873 after 10,031 more people tested positive for the infection, while 17 fresh fatalities pushed the toll to 2,197. Monday was the fifth consecutive day when the state registered more than 10,000 new cases. Of the 10,031 new cases, 6,623 were reported from various quarantine centres, and the rest detected during contact tracing. Khurda district, of which the state capital Bhubaneswar is a part, recorded the maximum number of new cases at 1,329, followed by Sundargarh at 824, Cuttack at 720 and Cuttack at 708. Barring Gajapati, Kandhamal and Malkangiri, all 27 other districts registered more than 100 cases. Three deaths each were recorded in Khurda, Kalahandi, Rayagada and Sundergarh districts, two in Puri.

lowed global tenders to be floated for less than ₹ 200 crore as well.

The department of expenditure. under the ministry of finance, April 24 issued special instructions relating to relief operations for COVID-19 pandemic and said that the prevailing health emergency on account of the unprecedented surge in COVID-19 cases across the country requires immediate procurement of certain items in quantities which may not be available with a single supplier and/ or within the time frame in which they are needed.

"The instruction in this department's OM (office nemorandum)... dated May 15, 2020... Specifying that no global tender enquiries shall be invited for tenders up to ₹200 crore shall stand relaxed and hence it shall be permissible to invite GTE wherever necessary," said the instructions, which have been put up on the ministry's website Monday. As part of its Aatmanirbhar Bharat, the government had notified amendments to General Financial Rules to ensure that goods and services valued less than ₹200 crore will be procured from domestic firms.

Sonia to form panel to dissect poll rout

New Delhi, May 10: Interim Congress President Sonia Gandhi has decided to form a fact finding committee to find reasons for the party's defeat in the four states which went to the polls recently. After the Congress Working

Committee meeting Monday, party General Secretary KC Venugopal said, "The committee will be constituted within 48 hours." "I intend to set up a small panel to look at every aspect that caused such reverses (in the elections) and report back very quickly. We need to candidly understand why we failed to

dislodge the incumbent governments in Kerala and Assam, and we drew a complete blank in West Bengal," Sonia Gandhi said in the CWC meeting, in which Rahul Gandhi was not present as he is still recovering from Covid-19.

"This CWC meeting has been convened to discuss the results of the recently-held Assembly polls. We have to take note of our serious setbacks. To say that we are deeply disappointed is to make an understatement," she said. "These will yield uncomfortable lessons, but if we do not face up to the reality, if we do not look the facts in the face, we will not draw the right

During the meeting, all the state in-charges presented their views on the recent poll debacle, with the party's West Bengal in-charge Jitin Prasada saying the alliance with the Indian Secular Front (ISF), formed

by preacher-turned-politician Pirzada Abbas Siddiqui, ruined Congress' prospects in the state, sources said

Congress leader Digvijay Singh asserted that the alliance with the All India United Democratic Front (AIUDF) in Assam was wrong, while Ghulam Nabi Azad said that the party should have committee at the AICC level to deal with the alliances, sources said.

The party's in-charge for Kerala, Tariq Anwar, told the CWC that Congress became overconfident which led to its defeat in the state, and by the time it realised the same, it was too late, sources said



Amazon has been wrestling with counterfeits for years. But since 2019, it has warned investors in government filings that the sale of phony goods poses a risk to the company and its image. Brands may not want to sell their items on the site if they know there are fake versions being offered. And knockoffs could cause shoppers to lose their trust in Amazon.

Counterfeiters try to get their products on Amazon through its third-party marketplace, where sellers can list their items directly on the site. The company destroyed 2 million counterfeit products sent to its warehouses last year before they could be sold. And it said fewer than 0.01 per cent of all items bought on the site received counterfeit complaints from shoppers.

Amazon said it can stop counterfeiters before they can sell anything thanks to machine-learning technology, which automatically scans listings to remove suspected counterfeits. -The company also gives brands a way to remove fake items from the site themselves, rather than reporting them to Amazon and waiting for it to do something. The company's efforts come as law-makers are looking at ways to reduce counterfeits online.

The government further said, "It is also submitted that citizens of 18 to 44 years are getting vaccination free of cost as all state governments have announced free vaccination for this population group of 18-44 years. Thus, all citizens of all age groups will get free vaccination throughout the country."

States have also been provided the information of the total number of doses of both vaccines available to them and the UTs from "Government of India channel" for the identified priority groups (health care workers, frontline workers and population above 45 years of age) free of cost from May 1 to May 15 and this data would be released every fortnight, it said.

"It is most respectfully submitted that in the times of such grave and

unprecedented crisis which the nation is fighting the disaster of an unprecedented magnitude, the executive functioning of the government needs discretion to formulate policy in larger interest. It is submitted that in view of the unprecedented circumstances under which vaccination drive is devised as an executive policy, the wisdom of the executive should be trusted," the affidavit said.

The government said that in a plethora of judgements, the top court has laid down the parameters for judicial review of executive policies, which can only be interfered with on the grounds of manifest arbitrariness.

Take care of orphaned, distressed kids, DMs told

Bhubaneswar, May 10: In a bid to ensure proper care of children during the Covid-19 pandemic, the state government has directed the district Collectors to take care of the children who are either orphaned after losing their parents to the virus or whose parents are lodged at Covid care centres (CCCs).

Women and Child Development and Mission Shakti department has asked the Collectors to identify at least one child care institution in their respective districts to take care of the distressed children during this pandemic.

In a letter to the Collectors, director of Integrated Child Development Services (ICDS) and Social Welfare, Aravind Agrawal said, "I am directed to intimate that immediate measures be taken for rehabilitation of the children

The reception of the Covid care facility will guide the patients regarding this arrangement

Similarly, the district child protection officers (DCPOs) have been asked to make provision of oximeters, mobile phones and thermal scanners for the child care institution on priority basis.

The Childline coordinators and volunteers have been directed to be on alert and rescue all types of vulnerable children at any time.

State reports first black fungus case; patient 'stable'

Potato mission fails in Jajpur district

Rasulpur, May 10: The state government had launched a potato mission in 2015 with the aim to increase production of tuber in the state and overcome the shortage of potato, but the programme has gone haywire in Jajpur district due to lack of effective implementation.

According to reports, the potato mission was launched with multiple aims - to augment tuber production, ensure proper marketing facilities, enhance the capacity of cold storages, production of quality potato seeds, credit linkage facilities for cultivation and storage and formation of potato farmers' association.

This year, the farmers reportedly produced a surplus harvest and were expecting to earn a few bucks more, but everything went wrong due to lack of foresight and shoddy implementation of the programme by the district Horticulture Department. The local intelligentsia and senior citizens claimed that the subsidy given to farmers could have been invested in buying the harvested tuber from the farmers and selling them to people at fair price.

The farmers' plight is attributed to lack of adequate cold storages in the region to store the sur-



plus harvest for sale in the next year as well as absence of government support. Till a month back, farmers were selling the crop at throwaway prices due to lack of storage facilities, but now they do not have any tuber to sell in the market at a time when the prices have gone up. A month back, a kg of potato was selling at anything between ₹5 and ₹10 but its price has now gone up to ₹30 per kg.

Lack of storage facilities has deprived them of earning some

extra money on their produce. This has been happening every year and farmers are facing losses.

Reports said that over 150 farmers in Rasulpur and Dharmasala blocks in Jaipur district were supplied with 150 quintals of 'Pokhran' variety of seeds in the 2020-21 agricultural year for cultivation on 10 hectares (25 acres) in both the blocks. The farmers were used to cultivating 'Jyoti' variety of seeds but instead were given 'Pokhran' variety of seeds last year. However, see-

Accordingly, the cultivation was to be done on five acres in Rasulpur block and 20 acres in Dharmasala block. The land for tuber cultivation was identified at Marjitapur, Jenapur, Kabatabandha, Choramuhan villages under Dharmasala block and in Rahamba, Bhotka, Rasulpur villages under Rasulpur block. The farmers were also given ₹5.80 lakh as incentive on

the basis of harvest from per hectare in two phases.

The Horticulture Department claimed that the harvest was as per expectation. Subhashree Privadarshini, the assistant horticulture officer in Dharmasala block, said that the harvest was 200 quintals per hectare.

She, however, failed to specify the exact quantity of harvest. Similarly, Jaydev Sit, the assistant horticulture officer in Rasulpur block also failed to ascertain the exact quantity of harvest of tuber in the block. The farmlands in Rasulpur block are well suited for tuber cultivation. However, farmers were allegedly given less quantity of seeds.

This is because the farmers had to face wilting of tuber crop in some places, while rotting of tuber was also reported from many places. Farmers planning to sell tubers during the price rise kept the tuber in the ground without harvesting them. However, the entire crop left in the field perished. Mania has been felicitated at several functions and events. Recently, he was honoured at an event at Jaleswar Nuabazaar.

Lack of testing kits blamed for Covid surge in Angul

Boinda, May 10: The number of Covid-19 patients in Kishorenagar block of Angul district is increasing alarmingly. As a result, residents of this block are living in fear and apprehension. They now hold the local administration responsible for the surge in Covid-19 caseload in the area.

The block reported 557 Covid-19 positive cases during the last one month. Local residents alleged that despite the rise in Covid-19 caseload, the block administration officials are hardly taking any steps to stop the virus from spreading. They further alleged that Covid testing is not being carried out in a proper manner.

Locals pointed out that testing of family members and friends of Covid-19 positive patients is not being done on a priority basis. They said that when such people visit the hospital for tests, they are made to wait endlessly and at times even asked to come on another day.

Scarcity of testing kits is leading to delay in identifying positive patients, they informed. Hence, these people contribute to the increasing cases of Covid-19 patients.

Eight panchayats in Kishorenagar block have reported 369 positive cases and four deaths in the last one month and all of them were under treatment at the Boinda government hospital. Similarly, 188 positive cases and one death were reported last month from 15 panchayats from where most are undergoing treatment at the Kishorenagar government hospital.

According to local residents, infected persons from nearby villages are coming to Boinda on a daily basis for buying essential commodifies. "They are spreading the virus. The police have failed to identify such persons and have failed to stop their entry into Boinda," locals alleged. "Even those who have been caught, get away by paying a nominal fine," they added.

Since the number of Covid-19 pa-



tients in eight panchayats in Zone No-13 is increasing rapidly, the villagers have demanded that a temporary testing facility be set up there. However, their demand has not been fulfilled so far.

Residents of Urukula village also had similar grievances. They informed that a number of villagers are down with fever. A medical team should visit the village and collect samples for testing. But nothing has been done so far.

Social activist, Ranjit Patnaik alleged the administration has completely failed in protecting the people from coronavirus.

When contacted, Dr Saroj Kumar Nanda of Boinda government hospital said the administration has taken steps to save people from contracting the disease. He however, alleged that people are not following the Covid-19 guidelines in a proper manner.

Many of them are not wearing masks and not implementing social distancing," Dr Nanda said. "We have been telling people to visit hospitals for testing only if they have Covid-19 symptoms. Children, pregnant women and elderly persons have been advised not to leave their homes. If they come out in case of emergency, they should wear masks properly and maintain social distancing," he added.

When contacted, Angul chief district medical officer Dr Abhay Kumar Das admitted that the district is facing an acute shortage of test kits. "However, this problem will be solved soon," he added.

Hey Ram!

The Centre seems to have lost its direction and priorities in battling the COVID-19 pandemic forcing millions to run helplessly from pillar to post to get oxygen, vaccines, immunity boosting drugs and beds in hospitals. In the process thousands are dying daily and lakhs are in excruciating pain and mental trauma after contracting the virus. The Indian Medical Association has questioned the lack of transparency even in reporting deaths due to the pandemic and sought to shake the government from its 'slumber'. It is of crucial importance to ascertain the mortality rate with accuracy so as to try and devise a strategy to insulate the population against the calamity. The government, however, claims before the Supreme Court its vaccination policy is "just, equitable, non-discriminatory and based upon an intelligible differentiating factor between the two age groups (45 plus and those below)". The ground reality, however, clearly shows the hollowness of the claim couched in legal language and pompous phraseology.

The insensitivity of the government is further revealed in its resolve to accord priority to the completion of its grandiose and questionable ₹20,000 crore worth Central Vista project to construct a new parliament complex and Prime Minister's residence by making it an 'essential service'. Bengal Chief Minister Mamata Banerjee has rightly condemned it pointing out that saving the lives of millions of people through free vaccination costs ₹30,000 crore, a price that is 'nothing for the Centre' to pay. In fact, it is a mystery what has prevented the Centre from making vaccination against COVID-19 free when the government had allocated ₹35,000 crore in the last Budget for tackling the pandemic. The Budgeted amount is enough to produce 200 crore doses of Covid vaccine needed for the whole country.

When the government is making hollow claims on its handling of the public health catastrophe, the IMA's diagnosis of the situation should act as an eye-opener and propel it to act fast and effectively. There has been colossal failure by the government in ensuring there is no shortage of drugs, vaccinations and manpower.

Since production has not been raised to the desired levels because of the Centre's failure to foresee the ferocity of the pandemic in its second or third waves, black marketing and hoarding have become rampant. If the Uttarakhand Chief Minister's decision to allow "holy dip" by over four million people during the Kumbh Mela in Haridwar last month has turned the country into hell through super spread of the virus, the revelation of the young son of the BJP MLA of Haridwar getting the jab before the government rolled out vaccination for the age group from 18 to 45 years shows the ruling BJP leadership has no conscience left.

There has been a clamour for price capping and systematic tracking with surveillance for such drugs, but the government seems highly disinterested in such measures nor has it removed the Goods and Services Tax on masks, PPE kits and lifesaving drugs. Union Finance Minister Nirmala Sitharaman ruled out the waiver and explained in a string of 16 tweets on May 9 that if full exemption from GST were given, the domestic producers of these items would be unable to offset taxes paid on their inputs and input services and would pass these on to the end consumers by increasing their price. Alas, this minister is too experienced to be told that in such a national catastrophe the rules can be easily bent to save the lives of the people and also that GST or import duty could be removed on inputs to enable producers retain today's cost. It is the government's job and not the people's, who voted the BJP to power, to find the ways and means to alleviate their suffering.

It was Prime Minister Narendra Modi who had assured the country that the vaccination drive for those above 18 years of age would begin from May 1, but the health ministry is yet to make the required roadmap and ensure vaccine stock. In its absence the people of this age group are helplessly waiting for their turn to get vaccinated. There are reports of the vaccination drive being stalled in many places. The government seems to have abdicated its responsibility to the people. In between, the Tika Utsav of two days left the people wondering about their fate.

On the other hand the Delhi High Court on May 10 agreed to hear on May 11 a petition seeking an interim stay on the construction of Central Vista during the peak phase of the pandemic. The court had earlier listed the case for hearing on May 17, but the Supreme Court told the petitioners to request the High Court for an urgent hearing.

The petitioners are concerned over the threat of super spreading of the virus which was posed by the continuing construction at the massive project site and the plight of the workers who are being exposed to the infection daily. They are also questioning why or how the project constitutes an 'essential service' merely because some executive mandated contractual deadline has to be met. Clearly, the government, by not immediately stopping the construction, is strengthening the suspicion that it is hell bent on implementing the individual desire of PM Modi to rewrite history his way, even at the cost of thousands of lives of people working at the site.

PATENT WAIVER NECESSARY

ast October; India and South Africa proposed in the World Trade Organization that intellectual property rights of Covid-related drugs and vaccines be suspended. This proposal was supported by 60 countries. However, the US, still under the Trump administration and the EU were opposed to the proposal. Then presidential candidate Joe Biden in early July itself had said that he supported such a proposal. So, there was expectation, but pressure from the pharma lobby was intense too. Besides, abruptly curtailing patent rights is against the basic sanctity of contracts. You can't renege on a sovereign promise, which is what patent rights are. Then in April last month more than 100 Nobel Prize winners, and several prominent world leaders, including former heads of State, urged the US to support a waiver of the TRIPS (Trade Related aspects of Intellectual Property Rights) clause in the WTO. Such a waiver they said, would vastly increase inoculation rates, and would legally allow developing countries to make their own vaccines, which were currently developed and produced by global pharma companies. The signed letter also said that

vaccine knowhow and technology should be shared openly, and industry monopolies should not be allowed to create artificial supply shortages. This is seen as essential to winning the war against the pandemic. Winning over US support for a patent waiver is crucial because it entails taking on the might of major pharma companies like Pfizer, Moderna, Novavax, Johnson and Johnson and AstraZeneca.

Of course, there is the argument, which has been examined by India as well, that the current TRIPS regime of the WTO has an escape clause in case of emergencies. This is called compulsory licensing wherein a company can be forced to disclose and license its patents to others, for the sake of national emergencies. But developing countries have been reluctant to use this clause for fear of displeasing the US, which

could counter the move with some other diplomatic or economic punitive measures. It must be remembered that during the anthrax scare of 2001, the Canadian government had threatened to break the patent protection of Bayer, and use compulsory licensing to produce ciprofloxacin on a mass scale through a small company. Bayer however settled the matter with the Canadian government by donating large amounts of ciprofloxacin and offering more in case of an emergency. This led the Canadian government to agree to acquire cipro exclusively from Bayer for the duration of the patent agreement. So, there is a precedent, but many developing countries of Africa have been reluctant to use this route, even for genuine national emergencies like AIDS. An interesting success story without breaking any patent rules was that of CIPLA, an Indian pharma company which in 1993 developed and sold a drug at one tenth the then prevailing price. By 2001 CIPLA had developed an anti-AIDS drug cocktail and sold it at a very low cost, upending the hitherto monopolies, and vastly contributed to the effort to combat and control AIDS.

So, in the present context of Covid, the compulsory licensing avenue is only of academic interest. Besides the US has been increasingly under diplomatic pressure to relax the restrictions on export of vaccines which lie

unutilised. Last week President Biden announced that he would support a TRIPS waiver at the WTO. This is a historic decision. It comes after surmounting the challenges and pressures mounted by the pharma lobby, including the scare that the Russians and Chinese would get the American pharma technology, and that if there was an indiscriminately large production of vaccines all around the world, it would create a big stress on supply chains. As of this writing 120 out of 164 member countries in the WTO are supporting the TRIPS waiver for vaccine patents. Added to this is the statistical evidence that 60 per cent of the world's supplies have been cornered by the rich countries, or only about 16 per cent of the world's population. There is excess stock sitting around in the US which will remain unutilised.

Sure enough the US decision was opposed by many pharma companies and leaders like German Chancellor Angela Merkel. She said that patents were not the limiting factor responsible for the vaccine shortage. It was production capacities and highquality standards. But she surely misses the point, that patent waiver allows production to happen on a massive scale, so that the current capacities are no longer the bottleneck, since newer capacities will come up, without fear of infringing on patents. A German company BioNTech also echoed similar sentiments, saying that replicating the manufacturing

process and mastering that tech nology can take years. It also added that it was committed to selling the mRNA vaccine to developing countries on a no-profit basis. But that no-profit price surely has the value of the patent, which itself makes it prohibitive. Strangely even Brazil has opposed the patent waiver proposed by Biden, and so has Bill Gates. Of course, if Covid vaccine patents are going to be breached now, the world has to find a way to compensate the pharma companies for the breach of contract. How this waiver proposal will travel through the WTO's voting process remains to be seen Crucial time may be lost, so India cannot count on this proposal to help its cause. It needs to rapidly ramp up vaccine production and imports, and immediately go for universal and free vaccinations. It should not only depend on "app' based booking, because given the great digital divide, it puts the poor and underprivileged at a great disadvantage. Imagine the areas where telecom connectivity is poor, digital literacy is low (can you do a captcha in 20 seconds), and when the CoWin website open slot is as elusive as a passing comet in the sky

The issue of the TRIPS waiver for Covid vaccines is also the right time to examine excessive patent protection, and overall exorbitant monopoly drug prices. There is now abundant research which shows that the maxim "no patents, no drugs" is false. And the billions in dollars needed to develop a new drug is mostly due to costs incurred on stage 2 and stage 3 clinical trials, which are actually in the nature of "public goods" That's because once the safety and reliability of the new drug is established in those trials, it deserves to be public knowledge. Hence that cost should simply be reimbursed, and patent-induced monopoly rights should be drastically reduced. This is a longerterm plan. Right now the Covid vaccines are on the agenda.

His spelling has been used by others but mine is that in the Oxford English Dictionary, which has just one example, from 1652. It's not quite that rare, though one has to search around for instances. It appeared in an article, The Industrial Value of Woman (a title that would today raise eyebrows) in The North American Review in 1882, in which the author wrote of a muliebrious or over-feminine woman. Its companion adjective is muliebral, characteristic of women or womanhood, which lacks the other's negative implications and which featured in the magazine The World & I in 1995: "Muller and Gillis represent the vibrant and irresistible muliebral force that has been weaving its way through the dance world for the last twenty years." Both derive from the classical Latin muliebris, womanly, which is from mulier, a woman. The latter is also the source of the even rarer and long obsolete legal term mulier that describes a child born in wedlock and so legitimate, and of the rather more common muliebrity, womanhood or femininity.

advantage for the same.

Prima facie, there is no problem with the electoral bonds but the process in which the scheme was designed and implemented raised several questions about the intention of creating this financial instrument. Often well intended products fail in achieving their objectives because of ill-designed processes.

In the case of electoral bonds the ill-designed process seems to be well-planned, which is more worrisome. In a rush to introduce electoral bonds, the government amended five major acts: The Reserve Bank of India Act (1934), the Companies Act (2013), the Income Tax Act (1961), the Representation of People's Act (1951), and the Foreign Contribution Regulation Act (FCRA) through the Finance Act of 2017. Amendment in statues is an important feature of democracy but such amendments should always be preceded by open discussion and public participation. We did not see much debate on these amendments.

Through an amendment to the Finance Act 2017, the government allowed non-disclosure of details of contribution received by the political parties through electoral bonds

in the electoral funding? The amendment of the Companies Act eliminated the cap of 7.5 per cent of a company's earnings on donations and requirement of three years balance sheet. Now any company including a loss-making one and even a shell company can fund political campaigns without any upper limit. An icing on the cake was provided for the companies by removing the need for disclosure of such funding in the annual financial statements. Will this not further aggravate the agency problem which has been

haunting shareholders for ages? The Foreign Contribution Act too was amended with retrospective effect to define Indian arms of foreign firms as not being a "foreign source" of funding. This opened the flood gates for political parties to receive contributions from foreign companies. Will this not lead to an increase in foreign capital's control on political campaigns?

The government introduced electoral bonds with an objective of increasing transparency in electoral financing, but it seems the bonds have become an epitome of financial opacity. No wonder that electoral bonds emerged as the most popular route of political dosearch for better financing solutions should continue. Countries like the UK. Australia and the US tried to ensure transparency in electoral donations. Others like Croatia, Sweden, Germany, Israel and Russia used different models of public funding. It is time for us to learn from our own experience and from global experiments too.

Election and campaigning are important for democracy to sustain. However, to maintain independence and neutrality in election there is a need for a robust and transparent method of financing. Electoral bonds seem to have miserably failed the nation in that respect. So how about setting a special fund for the purpose and call it India Democracy Fund (IDF). The fund to be managed under the supervision of the Election Commission and all political donations is diverted to the IDF. The fund could be distributed among political parties using some transparent rules. Creating such transparent means of financing political parties and elections may help in improving our position in Democracy Index's global ranking. The writer is a Professor,

Lockdown gains

Sir, Apropos "26 states/UTs under lockdown", Orissa POST, May 10, all those States/UTs have done the inevitable, going into a strict lockdown for a fortnight to arrest India's calamitous descent into COVID-19 hell since mid-March. The horror of sweeping infections, severe disease and staggering death rates has made a lockdown a popular measure. What people now look forward to are measures that draw insights not from crude policing, but public health research and insistence on wearing good masks, social distancing and a prohibition on risky gatherings. For an exhausted medical community amid a severe shortage of medical oxygen and drugs, the pause in activity comes as a life saver. The lockdown window can help it manage existing patients while governments augment critical supplies; a slowing infection curve will give everyone breathing space in coming weeks, although the heart-rending death rate may take time to decline due to the lag effect. It is incumbent upon the Centre to arrange for vaccine imports or augment domestic production to scale up vaccination. Testing access must also be dramatically increased by May-end to assess the true scale of the pandemic. Without such progress, the lockdowns may yield only small gains.

Augment supply of O₂, vax to TN, HC tells Centre

Chennai, May 10: The Madras High Court Monday said it was necessary for the Centre to take urgent measures to augment the supply of oxygen to Tamil Nadu, which foresees a sharp rise in demand for the life-saving gas in the coming days in the wake of surging COVID-19 cases

Besides oxygen, supply of vaccines and drugs needs to be augmented for the State and neighbouring Union Territory of Puducherry, the First Bench of Chief Justice Sanjib Banerjee and Senthilkumar Ramamoorthy said.

The court was hearing a case taken up on its own on issues, including shortage of beds and ventilators, besides diversion of oxygen. Regarding oxygen supply, the Bench noted that while the demand in the State a week back was 475 MT on a daily basis, the allocation of May 8, 2021 provides for 419 MT, including a daily 40 MT supply from Palakkad in Kerala, till May 12, 2021

"The State now perceives that, with the rising (COVID) numbers, the demand for oxygen will hit 800

TN politics to revolve around ideologies

NONE OF THE EXISTING LEADERS -- STALIN, PALANISWAMI AND PANNEERSELVAM -- ARE TOWERING PERSONALITIES LIKE MGR. JAYALALITHAA OR KARUNANIDHI

Chennai, May 10: Politics in Tamil Nadu is going to revolve around three different ideologies and not mainly around personalities that is what has become clear following the humiliating defeat of actors like Kamal Haasan, Vijayakant and R. Sarathkumar floated parties, as well as that of politician TTV Dhinakaran's AMMK party, said political strategists and analysts.

"The major outcome of 2021 Tamil Nadu assembly poll is the settlement of the leadership issue in the state with DMK under its president MK Stalin winning it. The other outcome is that the re-emergence of three different ideologies -- Dravidianism by DMK (social justice, state autonomy, self-respect, rationalism), Tamil nationalism (Liberation of Language pride and Land) by Naam Tamilar Katchi (NTK) and nationalism/Hindutva by the BJP -- around which the state politics will revolve," Jhon Arokiasamy, political strategist told IANS.

"Stalin proclaiming himself 'Belongs to the Dravidian stock on his Twitter handle shows that the ruling party will go full steam on Dravidianism against NTK's Tamil Nationalism," an analyst not wanting to be quoted told IANS. Political analysts said the

AIADMK has the word Dravida in its name but it does not profess it like that of DMK.

For a long time Tamil Nadu politics was dominated by personalities like actor-turned-politician and AIADMK founder MG



Ramachandran (MGR) and successor J Jayalalithaa and DMK's M Nadu politics with his 'spiritual Karunanidhi. Now none of the politics' ideology later backed out three are alive. The MNM party secured about two per cent vote share down from about four per cent secured in the 2019 Lok Sabha poll.

Similar was the case with DMDK floated by another actor-turnedpolitician Vijayakant. While Vijayakant was not able to contest due to his health condition, his wife and party Treasurer Premalatha lost badly in Virudhachalam seat. The party got a mere 0.43 per cent vote share with all its candidates losing miserably.

Riding solo during the past three elections NTK notched up about seven per cent vote share or about 30 lakh votes and became the third largest party after DMK and AIADMK with MNM, AMMK and DMDK trailing far behind. Seeman, NTK's founder is the sole and star campaigner for the party. However, his party is known for espousing Tamil Nationalism ideology than him being a former movie director and an actor. "Seeman can target the population segment that are not beneficiaries (mostly forward castes) of the government schemes,' Raveendhran Dhuraiswamy told IANS

Tablighis perform last rites of 560 Covid victims in Tirupati

Tirupati, May 10: When 26-yearold K Damodar Reddy lost his battle to Covid-19 at SVIMS Hospital in this temple town, his blood relatives did not come forward to perform his funeral, but a group of Muslims ensured his last rites as per Hindu traditions.

When a church pastor Vetti Dasu died of Covid at Ruia Hospital, nobody from his relatives came to receive the body and again the Muslim group rushed to the hospital, received the body and arranged for his last rites as per Christian customs.

Unfazed by the hateful propaganda carried out against Tablighi Jamaat last year, blaming it for spreading Covid-19, members of this Muslim religious organisation in this Andhra Pradesh town are conducting last rites of Covid victims, irrespective of their religion.

Active under the banner of Covid-19 Joint Action Committee (JAC), 60 volunteers belonging to Tablighi Jamaat have cremated bodies of 560 Covid victims since the outbreak of the pandemic last year.

They are performing the last rites of not only the unclaimed bodies but also of those whose families abandoned them for fear of contracting the infection.

JAC president Shaik Imam Saheb told IANS that they perform the last rites of the bodies according to the religious beliefs of the deceased. "If the deceased is a Hindu or a



Christian, we use services of their priests to conduct the last rites," he said.

Imam believes it is an opportunity to respond to those who maligned Jamaat out of their hatred. 'We are responding to their hate with our love, compassion and humanitarian service. We believe that Almighty Allah has given us this opportunity," said Imam, a practicing advocate at Andhra Pradesh High Court

He recalled how 'false propaganda' was carried out against Tablighi Jamaat last year after the congregation in Delhi. "They even dubbed Jamaat members as terrorists. Today, the same Jamaat members are conducting the last rites of Covid victims by risking their lives. There couldn't have been a better answer to them," he said.

A group of Muslims had formed

during natural calamities. Last year after the pandemic broke out, it formed the JAC and requested the local authorities to allow them to perform the last rites of the victims according to the religious beliefs of the deceased. JAC works under the guidance of ulema or Muslim religious leaders of the town. Moulana Ibrahim

Hashmi, Hafiz Ishaq Mohammed and Moulana Jaber are the key leaders of the group.

"JAC received Rs 20 lakh as public donations. We bought a new ambulance. We now have two ambulances offering free service, said Imam.

He thanked Tirupati MLA Karunakar Reddy for extended all help to the JAC. The legislator belonging to the state's ruling YSR Congress Party also provided some monetary support.

Despite testing Covid positive twice, the MLA personally participated in the last rites of some deceased along with JAC members. He also praised the services being rendered by the JAC. The JAC now plans to expand its activities by arranging free oxygen cylinders to Covid patients.

Its activities have come in for praise from various sections of the society and authorities, who were worried over piling up of bodies in various hospitals.

According to the police, the brawl involved Kumar, Ajay, Prince Dalal, Sonu, Sagar, Amit and others. A case was registered under sections of the Indian Penal Code (IPC) and the Arms Act at the Model Town Police Station.

Indian Navy brings huge

New Delhi, May 10: Three Indian Navy warships are bringing to India Monday 80 tonnes of liquid oxygen, 20 cryogenic oxygen tanks, 3,150 cylinders and a large amount of other medical supplies from abroad as the country reels under

a severe second wave of the coronavirus pandemic. The medical supplies being brought by the ships included 900 oxygenfilled cylinders and 10,000 rapid antigen COVID-19 test kits, 54 oxygen concentrators, 450 PPE (personal protective equipment) kits, Indian Navy spokesperson Commander Vivek Madhwal said.

Indian Navy ship Airavat is reaching Visakhapatnam from Singapore carrying eight cryogenic oxygen tanks each having a capacity of 20 metric tonnes of oxygen and other supplies. Another warship, INS Kolkata, is arriving at New Mangalore port carrying 40 metric tonnes of liquid oxygen, 400 Oxygen cylinders and 47 oxygen concentrators from Qatar and Kuwait, Commander Madhwal said.

with 40 tonnes of oxygen from Qatar, he said. Last week, the Indian Navy deployed nine warships to bring liquid medical oxygen and other supplies

It has been reported that a fake SMS message is in circulation that falsely claims to offer an app to let users register for COVID-19 vaccine in India. The SMS carries a link that installs the malicious app on Android-based devices, which essentially spreads itself via SMS to victims' contacts, the Indian Computer Emergency Response Team or CERT-In said in a public advisory issued Saturday.

The agency is the federal technology arm to combat cyber at-

tacks and guarding the Indian cyber space against phishing and hacking assaults and similar online

attacks It added that the app also gains unnecessary permissions that attackers could leverage to acquire user data such as contact list.

Some of its identified variants are Covid19.Apk; Vaci_Regis.Apk; MvVaccin_v2.Apk; Cov-Regis.Apk and Vccin-Apply.Apk.

The advisory said that the only official online link to register for coronavirus vaccination in the country is the portalhttps://www.cowin.gov.in.

It asked users to be alert against all attempts of phishing through

fake domains, emails and text messages that promise registration for a jab against the pandemic.

As part of measures to check such malicious attempts of data breach, it advised users to tune their phone setting in a manner that disables installation of apps through untrusted sources and that sides should undertake safe browsing and use trusted anti-virus and internet firewall tools.

India at present is administering two COVID-19 vaccines -- Covishield and Covaxin - to its citizens and according to official data, the central government has so far pro-vided nearly 18 crore vaccine doses to states and union territories.

In the past 3-4 weeks, a total of five patients have been reported with this infection at Continental Hospitals, indicating rise in the condition among the Covid-hit, the hospital said on Monday.

While three ministers Amit Mitra, Bratya Basu and Rathin Ghosh took their oath virtually. The rest -- 40 ministers were divided into three groups -- Cabinet, MOS (Independent Charge) and MoS and they took their oath together to cut short the program.

Mitra has not been well for a long time and the other two ministers have Covid. Later Chief Minister Mamata Banerjee allocated the departments to the ministers. Banerjee kept with herself important departments like Home and Hill Affairs, Health and Family Welfare, Information and Cultural Affairs, Land and Land Reforms and Refugee Rehabilitation. The chief minister will also take care of North Bengal. As expected, Amit Mitra was given the responsibility of Finance but his other department Commerce and Industries was given to former Education Minister Partha Chatterjee. Chatterjee will also hold the portfolio of IT and Parliamentary Affairs.

On the other hand, Bratya Basu who was handling IT is now given the responsibility of the School and Higher Education Department. Mitra is physically not well and didn't contest the election but he was brought back by the chief minister so that he could continue to handle finance.

Though most of the former ministers retain their department but former Urban Development minister and former Mayor Firhad Hakim will be holding the portfolio of Transport and Housing. Earlier the state Transport Department was with Suvendu Adhikari who left TMC and joined BJP before the election.

Interestingly enough three most powerful ministers in the last cabinet Arrop Biswas, Jyotipriya Mullivk and Sovondeb Chattopadhyay have been given relatively insignificant portfolios. Similarly, Mamata's close aide

and loval for long time Sovondeb Chattopadhyay has been transferred from Power to Agriculture and Aroop Biswas, who is one of the most trusted of the chief minister has been given the portfolio of Power: Biswas was the PWD minister that has not been allotted vet. India, other tea producing nations face climate impacts

New Delhi, May 10: A new report from the charity Christian Aid Monday showed that India along with other tea producing nations, are facing a host of climate related impacts such as rising temperatures, erratic rainfall, droughts and new insect infestations.

The report shows that Assam, the largest single tea growing region in the world, is particularly vulnerable with growers there already suffering from the impact of the climate crisis. In a survey of producers in Assam, 88 per cent of plantation managers and 97 per cent of smallholders stated that the challenging climate conditions were a threat to growing and pro-



duction of tea. The changes in average temperature and rainfall patterns could lead to some tradi-

More extreme bouts of heavy rainfall in Darjeeling and rising temperatures have also led to new and increased pests and insects, yet another challenge that tea farmers need to respond to.

The dire situation facing tea farmers in Assam and elsewhere has not gone unnoticed by some of the world's biggest tea manufacturers. Tata, Unilever and Twinings as well as the Fairtrade Foundation all shared their concern about the impact climate change is having on their growers

Sebastian Michaelis, Head of Tea International Tea Buying & Blending at Tata Tea, said the company had undergone research into the impact of climate change on Assam.

"Water is vital to sustain the future of the tea industry. Tea growing regions rely on the rainy seasons to keep their tea bushes healthy and productive, but it's evident that seasonal rains are becoming more unpredictable and the impact this has on crop growth is far reaching; not least in loss of income of those employed at a local level on the farms," he said.

Inside one area of the compound, shoes and debris lay scattered over ornate carpets.

In an apparent attempt to avoid further confrontation, Israeli authorities changed the planned route of a march by ultranationalist Jews through the Muslim Quarter of the Old City to mark Jerusalem Day, which celebrates Israel's capture of east Jerusalem

But tensions remained high. More than 305 Palestinians were hurt, including 228 who went to hospitals and clinics for treatment, according to the Palestinian Red Crescent. Seven of the injured were in serious condition. Police said 21 officers were hurt, including three who were hospitalized. Israeli paramedics said seven Israeli civilians were also hurt.

Cyberattack on US pipeline is linked to criminal gang

New York, May 10: The cyberextortion attempt that has forced the shutdown of a vital US pipeline was carried out by a criminal gang known as DarkSide that cultivates a Robin Hood image of stealing from corporations and giving a cut to charity, two people close to the investigation said Sunday.

The shutdown, meanwhile, stretched into its third day, with the Biden administration loosening regulations for the transport of petroleum products on highways as part of an "all-hands-on-deck' effort to avoid disruptions in the fuel supply.

Experts said that gasoline prices are unlikely to be affected if the pipeline is back to normal in the next few days but that the incident - the worst cyberattack to date on critical US infrastructure - should serve as a wake-up call to

Wellington: A man began stabbing people at a New Zealand supermarket Monday, wounding five people, three of them critically, according to authorities. Police said a suspect had been arrested and taken into custody after the incident at a Countdown supermarket in the city of Dunedin. Two supermarket staff members were among those wounded. People in the store at the time told local media that it was a chaotic scene as people began screaming and running toward the exits. They said some brave shoppers had tried to stop the man and pin him down.

3 soldiers dead in Pak terror attacks

Islamabad: Three soldiers were killed and five others injured in two separate terrorist attacks in Pakistan's Balochistan province, an army statement said. One of the attacks took place on Sunday in the provincial capital of Quetta where militants attacked paramilitary troops Frontier Corps (FC) deployed on security duties, the military's media wing Inter-Services Public Relations (ISPR) said in the statement. The attack left three soldiers killed and one injured, Xinhua news agency quoted the statement as saying.

Moscow, May 10: A Siberian doctor who treated Kremlin critic Alexei Navalny after he collapsed on a flight in Russia last year has gone missing, Russian police said Sunday

Police in the Omsk region, about 2.200 km east of Moscow, said physician Alexander Murakhovsky had left a hunting base in a forest on an all-terrain vehicle on Friday and had not been seen since.

It said that emergency services, drones, a helicopter and volunteers on the ground had joined the search effort

Murakhovsky was the head doctor at the hospital in the Siberian prominent critic. Murakhovsky was subsequently promoted to the

post of regional health minister. After tense negotiations with the authorities, Navalny was airlifted to Germany from Omsk for further treatment.

Laboratory tests in three European countries, confirmed by the global chemical weapons watchdog, established that Navalny had been poisoned with a Soviet-style Novichok nerve agent.

The Kremlin has repeatedly rejected any suggestion that Russian authorities tried to kill Navalny. He was jailed in February on what he said were trumped up charges.

Islamabad, May 10: Pakistan, keen to exit from the grey list of the FATF, is set to introduce new rules relating to anti-money laundering cases and change the prosecution process to meet its remaining tough conditions, a media report said Monday.

Pakistan was put on the grey list by the Paris-based Financial Action Task Force (FATF), the global watchdog for money laundering and terror financing in June 2018 and the country has been struggling to come out of it.

The Dawn newspaper reported that the changes being made also include the transfer of investigations and prosecution of anti-money laundering (AML) cases from police, provincial anti-corruption establishments (ACEs) and other similar agencies to specialised agencies.

This is part of two sets of rules including the AML (Forfeited Properties Management) Rules 2021 and the AML (Referral) Rules 2021



under the National Policy Statement on Follow the Money approved by the federal Cabinet meeting a few days ago, the report said.

These rules and related notifications for certain changes in the existing schedule of Anti-Money Laundering Act 2010 (AMLA) would come into force immediately to be followed by the appointment of administrators and special public prosecutors for implementation.

Based on these measures, the FATF would conclude if Pakistan has complied with three outstanding benchmarks, out of 27, that blocked its exit from the grey list in February this year.

FATF are scheduled to begin in the second week of June, culminating in the next FATF plenary June 21-25.

The three outstanding action points (out of a total of 27) include (i) demonstrating that terrorist financing (TF) investigations and prosecutions target persons and entities acting on behalf or at the directive of the designated persons or entities. Now, the government has decided to appoint dozens of administrators with the powers to confiscate, receive, manage, rent out, auction, transfer or dispose of or take all other measures to preserve the value of the properties.

None of the children at the party were injured in the attack, according to the police, and they were being cared for by family members.

China to draw 'separation line' on peak of Mt Everest

CHINA HAS BANNED FOREIGN NATIONALS FROM CLIMBING EVEREST SINCE LAST YEAR DUE TO THE VIRUS OUTBREAK

Beijing, May 10: China will set up a "separation line" on the peak of Mount Everest to avoid possible Covid-19 infections by climbers from virus-hit Nepal, state media reported, after dozens were taken ill from the summit's base camp.

While the virus first emerged in China in late 2019, it has largely been brought under control in the country through a series of strict lockdowns and border closures.

Over 30 sick climbers were evacuated from base camp on the Nepalese side of the world's highest peak in recent weeks as Nepal faces a deadly second wave, raising fears that the virus might ruin a bumper climbing season.

Mount Everest straddles the China-Nepal border, with the North Slope belonging to China.

Tibetan authorities told reporters at a press conference they would take the "most stringent epidemic prevention measures' to avoid contact between climbers on the north and south slopes or at the top, reported the official Xinhua news agency Sunday. Mountain guides will set up di-

viding lines on the summit of the mountain before allowing mountaineers to start the gruelling climb up; the head of the Tibet Mountaineering Association was



Twenty-one Chinese climbers have been approved to climb to the summit of Everest this year after having quarantined in Tibet since early April, the official added.

The Chinese side will also step up virus control measures at the Chinese base camp on the northern side of the mountain, with non-climber tourists in the Everest scenic area forbidden to enter.

China has banned foreign nationals from climbing Everest since last year due to the virus outbreak

But this year Nepal has issued a record number of climbing permits to try and boost visitors after its tourism industry suffered a devastating blow through 2020 from the pandemic.

An Everest permit alone from Nepal costs \$11,000 and climbers pay upward of \$40,000 for an expedition.

More than a thousand people are typically camped at the bustling tent city at the foot of Everest on the Nepalese side at any one time, including foreign climbers and the teams of Nepali guides that escort them to the peak.

In the last three weeks, Nepal's daily case trajectory has shot up with two out of five people tested now returning positive as infec-tions spill over from neighbouring India's deadly second wave.

London, May 10: G7 countries should invest \$10 trillion to stoke an investment-driven recovery that puts Covid-19 vaccines in arms and triggers a sweeping energy transformation to slow climate change, according to a report requested by Prime Minister Boris Johnson.

US President Joe Biden is expected to join other Group of Seven leaders at a G7 summit chaired by Britain's Johnson in Cornwall, southern England, June 11-13. Founded in 1975 as a forum for the West's richest nations to discuss

crises such as the OPEC oil embargo, the G7 will discuss what it perceives as the biggest threats: China, Russia, climate change and the coronavirus pandemic.

New Delhi, May 10: Fitch Ratings Monday warned that India's slow pace of vaccination could mean that the country remains vulnerable to further waves of the pandemic even once the current surge subsides. Just 9.4% of the population had received at least one vaccine dose as of May 5, according to figures from Our World in Data, the agency said.

"India's slow pace of vaccination means that the country could remain vulnerable to further waves of the pandemic even once the current surge subsides," Fitch added.

The Centre has already provided more than 17.56 crore vaccine doses to states/UTs free of cost. The cumulative number of Covid-19 vaccine doses administered in the country exceeded 16.94 crore May 9.

Mumbai, May 10: The partial-tofull lockdowns imposed by various states to contain the second wave of the pandemic are likely to have a muted impact on the overall business environment, given strong export demand and improved balance sheets in the past six months, according to a report.



Though supply chain disruptions could play out, overall impact on corporates is expected to be moderate to minimal. But, small businesses and retail borrowers are likely to see stresses, India Ratings said in a report Monday.

It added that retail borrowers and small business will see stress, leading to a build-up of potential asset quality issues in the unsecured lending books of lenders and an increase in softer delinquencies in the MFI segment.

The assessment will change if there were a stringent national lockdown or a protracted normalisation of activities due to the pandemic, the agency warned and cautioned that the economy in general will have a bumpy road to recovery.

The second wave of the pandemic infections will be less disruptive than the first wave for overall businesses, despite the daily caseload reaching more than four times of the peak level seen during the first wave. This is because the administrative response is likely tobe confined to the regional/local lockdowns and containment zones.

New Delhi, May 10: The Covid-19 pandemic has brought automation technologies to the forefront and the Intelligent Automation (IA) market in India is estimated to grow at a compound annual growth rate (CAGR) of 55%, with large enterprises expected to spend nearly \$340-\$350 million in IA capabilities in 2024, a new report said Monday.

The overall expenditure is expected to exceed this figure since the market now also includes startups and various SMEs. IA combines the capabilities of robotic process automation (RPA) with smart optical character recognition (OCR), conversational AI and cognitive intelligence.

Madrid blasted the referee and VAR after Sunday's 2-2 draw against Sevilla, which kept the club from taking the lead with three rounds to go. The result benefited first place Atletico Madrid, which drew 0-0 with Barcelona at the Camp Nou Stadium Saturday.

Chasing their first league title since 2014, Atletico stayed two points in front of both secondplaced Real and Barcelona

The complaints by Madrid came after video review turned a penalty kick for the hosts into one for Sevilla with the game at 1-1 in the second half.

The referee had called a penalty for a foul on Karim Benzema in the 74th minute, but VAR went back to find a controversial hand ball by Madrid defender Eder Militao a few seconds earlier in the other area. Madrid also had a first-half goal by Benzema over turned for offside by VAR.

Madrid coach Zinedine Zidane couldn't hold back against the officials. "I never speak about the referees, but today I'm angry," said Zidane, who entered the field to question the referee after the match. "I didn't understand anything. I'm not convinced by anything that he told me.

Madrid twice trailed against Sevilla, needing a late goal by Eden Hazard deep in stoppage time to earn the final equalizer at the Alfredo Di Stefano Stadium.

Fernando had put the visitors ahead in the 22nd before Marco Asensio evened the match in the

67th. Ivan Rakitic converted the controversial penalty kick in the 78th to put Sevilla in front, and Hazard deflected a shot by Toni Kroos in the fourth minute of injury time to salvage a point for Madrid.

Sevilla was six points off the lead and kept a very slim chance of winning its first league title since 1946. Rakitic said it was a 'clear" penalty after Militao's handball. "The ball hit his hand and changed direction, to me that's a penalty." he said.

Madrid hadn't conceded in four

consecutive league games and had won four in a row against Sevilla in the domestic competition. The late goal kept the defending champions unbeaten in 15 straight games in the league.

OTHER RESULTS Valencia beat Valladolid 3-0 with

two goals by Maxi Gomez and one from Thierry Correia, moving the team further away from the relegation zone. The home victory came a day after thousands of fans protested outside the team's stadium against the club's Singaporean owner Peter Lim

Celta Vigo won 4-2 at Villarreal in a match with three penalty kicks, two of them for the visitors in the first half. Sixth-place Villarreal had two players on the bench shown the red card for complaining. Eighth-place Celta was reduced to 10 men late in the match.

Juve lose to AC Milan

RONALDO & CO'S LOSS AT HOME DROPS THEM TO FIFTH; CHANCES OF CHAMPIONS LEAGUE QUALIFICATION IN PERIL

Milan, May 10: Juventus lost 0-3 at home to AC Milan and dropped to fifth to leave its chances of qualifying for the Champions League in peril, on the same weekend that Juventus insisted on forging ahead with a European Super League competition that would guarantee it a spot among elite clubs.

Juventus, which had its nineyear grip on the Serie A title ended by Inter Milan last weekend, slipped out of the Champions League qualifying positions. It is a point behind fourth-place Napoli, with three rounds remaining in the Italian league.

The Bianconeri, along with Barcelona and Real Madrid, stepped up criticism of UEFA Saturday, denouncing "threats" for their refusal to back down on the prospect of a breakaway competition.

The other nine clubs who formed the ill-fated Super League three weeks ago accepted a settlement Friday to be fined by UEFA and stay within the open Champions League structure.

Milan was one of those clubs and the win boosted its chances of getting back into the Champions League as the Rossoneri moved level on points with second-place Atalanta, which earlier won 5-2 at Parma

The match in Turin was a direct fight for a top four finish, with both Milan and Juve locked on the same number of points. With Atalanta and Napoli already having won this weekend, the pressure was on the teams in what was being billed as a Champions League playoff.

And it was Milan which broke the deadlock in first-half stoppage time. Juventus goalkeeper Wojciech

Szczesny failed to properly punch clear a free kick and Brahim Diaz was able to control and cut inside before curling the ball into the top right corner.

Milan could have doubled its lead 13 minutes into the second half when it was awarded a penalty for a handball by Giorgio Chiellini. But Szczesny made up for his earlier error by saving Franck Kessie's spot-kick.

Szczesny was left with no chance in the 78th minute when Ante Rebic unleashed a powerful 25-yard strike into the top right corner. And Milan sealed the result four

minutes later when Fikavo Tomori headed in a free kick for his first goal for Milan since joining on loan from Chelsea in January. The defender's goal also means Milan has the better head-to-head record over Juventus - after losing the first match between the teams 3-1. That is the first tie-breaker if the teams are level on points at the end of the season.

Atalanta coach Gian Piero Gasperini's halftime changes had an immediate impact against already-relegated Parma.

Matteo Pessina doubled Atalanta's lead shortly after coming on and fellow substitute Luis Muriel scored twice. Another substitute, Aleksei Miranchuk, scored Atalanta's final goal. Ruslan Malinovskvi had opened the scor ing in the 12th minute.

The sixth-ranked German also won the Mexican Open in Acapulco in March. Zverev won his first Madrid title in 2018 in a final against Thiem. The win on Sunday gave him his fourth Masters 1000 title. and first in three years. Zverev will be trying to improve from his fourth-round exit last year at the French Open. West Bromwich relegated after losing to Arsenal

London, May 10: West Bromwich Albion was relegated after one season back in the Premier League after losing 3-1 at Arsenal Sunday, ending Sam Allardyce's proud record of never having taken a side down from England's top division in 30 years as a manager.

A 19th defeat of the campaign left next-to-last West Brom 10 points from safety with just three games remaining and joining last-place Sheffield United in returning to the second-tier Championship. Fulham, which is in third-to-last place, will join them if it loses at home to Burnley Monday. West Brom didn't manage to improve its position under Allardyce and has the worst defensive record in the league, with the Arsenal goals scored by Emile Smith Rowe, Nicolas Pepe and Willian taking that tally conceded to 68. Rowe volleyed in from Bukayo Saka's left-wing cross in the 29th minute, before Pepe doubled the lead six minutes later by curling home a shot into the top corner from the right of the penalty area. Matheus Pereira has been a rare bright spark in an otherwise dismal season for West Brom and the Brazilian playmaker showcased his ability to any potential suitors by scoring his 10th goal of the season - and it was perhaps his best.

Former India footballer Fortunato Franco passes way

New Delhi, May 10: Fortunato Franco, one of the pillars of India's last Asian Games gold-winning football team in 1962, died in Goa Monday. He was 84. The AIFF confirmed the news of his death but did not specify the cause of his demise. Franco is survived by his wife, son and daughter.

One of India's finest mid-fielders (half-back as per 1960s parlance), Franco was a part of Indian football's golden era between 1960 and 1964

He was a part of the 1960 Rome Olympics squad but didn't get a game. However, he was an integral part of the 1962 Asiad gold winning team in Jakarta.

He made 26 appearances for India, including the 1962 Asian Cup, where India finished runners-up, and silver and bronze medal winning sides of 1964 and 1965 Merdeka Cup.

But his best performance was in the 1962 Asian Games where Indian football witnessed its finest hour, beating South Korea 2-1 in the final in Jakarta in front of 100,000 people.

While the more illustrious quartet of PK Banerjee, Chuni Goswami, Tulsidas Balaram and Jarnail Singh hogged the limelight, Franco would forever be remembered for



providing the assist that enabled Jarnail to nod home the winner.

At the domestic level, Franco, a Goan, played his best years for the powerful Tata Football Club in Mumbai. In fact, he worked in the company's public relations department for four decades before retiring in 1999.

He was probably the tallest name in Maharashtra football having captained the state for eight successive years between 1959 and 1966 in the Santosh Trophy and was the architect of their title triumph in 1964

During his last years in competitive football, he did play for Goan giants Salgaocar but a knee

injury ended his career even before he was 30 years old.

"His contribution to Indian Football can never be forgotten. I share the grief," he added.
