Bhubaneswar, May 15: State Chief Secretary Suresh Mohapatra Saturday said that the Odisha government has formed an expert advisory committee to recommend ways and means to bolster the healthcare system and help in preparedness to tackle any future Covid waves.

Mohapatra said that the panel comprises reputed doctors and scientists who would recommend ways to perk up the state healthcare system to combat the emerging threats to people's health due the pandemic.

"We have decided to form a high-level committee which will have renowned doctors and researchers. The panel formed Friday is headed by Dr Srinath Reddy. It will advise the government on the matters related to anti-Covid vaccination and prepare the state for future waves of the pandemic, if any," Mohapatra said.

The Chief Secretary added, "This committee will advise the state government on various important issues. The panel comprises experts like Dr Devi Shetty, Dr Ramakant Panda and others. They will keep us abreast about the best global practices, ways to improve our present healthcare system and ways to protect children from the pandemic. We will implement their recommendations promptly."

The top bureaucrat also urged the people not to take Covid cases lightly. He said that compared to the first wave of the pandemic, more Covid patients are undergoing treatment at hospitals and more patients are admitted to ICUs due to the viral infection this time.

Covid cases cross 6L, 21 more fatalities

BHUBANESWAR: The Covid-19 tally in Odisha crossed the six-lakh mark Saturday as 11,805 more people tested positive for the infection, while 21 fresh fatalities pushed the state's death toll to 2.294, a health department official said. With these new infections, the caseload of coronavirus disease reached 6,00,492 in this coastal state, he said. At least 6.611 fresh cases were reported from quarantine centres and 5,194 detected during contact tracing. Khurda district, which comprises the state capital Bhubaneswar reported the highest number of new cases at 1,414, followed by Sundargarh (1,209) and Cuttack (1197). **MORE P4**

"Many people are not aware about the seriousness of the issue. When Covid was at its peak during the first wave, around 8,000 people were receiving treatment daily. Presently, we are treating 15,000 patients every day and around 3,000 are in ICUs. I would expect that people comply with the Covid norms to remain safe,' Mohapatra said.

Citing the relatively higher rate of infections this time compared to the first wave, Mohapatra urged people to comply with the Covid-19 safety protocols. There are cases where an entire village got infected after one person from the area tested positive. If we can comply with the safety norms for 15 days, we can surely bring down the cases and control the disease. However, the condition in Odisha is better compared to many other states.'

2,000 BODIES UNDER SAND

Lucknow, May 16: It's a ghastly sight for people living near the banks of the Ganga river in Uttar Pradesh as more and more dead bodies are washing up on the ghats of the river.

So far, more than 2,000 bodies have been found along a stretch of 1,140 kms on the bank of Ganga, spread across several districts in Uttar Pradesh. In fact, the Ganga flows 1,140 kms in UP and then enters Bihar. According to reports, 350

bodies were found buried near Mahadevi Ganga Ghat in Kannauj and the administration is allegedly covering up the bodies with soil on them. In Kanpur, 400 corpses were buried near Sherreshwar Ghat and a report in Dainik Bhaskar said the police covered them with soil.

NEW DELHI: Amid a growing chorus over the GST Council meeting not being convened for over seven months, the Union Finance Ministry Saturday announced that the next meeting of the panel that decides on taxes on goods and services will be held May 28. After over a dozen Central and state levies such as excise duty, service tax and VAT were subsumed in a nationwide Goods and Services Tax (GST) in 2017, the Council, headed by Union Finance Minister and including representatives of all states and union territories, was mandated to meet every quarter to deliberate on issues at hand. The GST Council last met October 5, 2020.

Cairn sues AI to enforce \$1.2bn arbitration award

New Delhi, May 15: Cairn Energy has sued India's flagship carrier Air India to enforce a \$1.2 billion arbitration award that it won in a tax dispute against India, according to a US District Court filing reviewed by Reuters. The move ratchets up pressure on India's government to pay the sum of \$1.2 billion plus interest and costs that the British firm Cairn was awarded by an arbitration tribunal in December. The body ruled India breached an investment treaty with Britain and said New Delhi was liable to pay. Cairn filed the lawsuit Friday in the US District Court for the

Perseverance, hope and a fire god: A history of Mars rovers

CHINA'S TIANWEN-1 PROBE SUCCESSFULLY LAUNCHED LAST JULY AND ENTERED MARS' ORBIT IN FEBRUARY - A MAJOR MILESTONE FOR BEIJING'S AMBITIOUS SPACE PROGRAMME

Beijing, May 15: China's probe to Mars touched down on the Red Planet Saturday to deploy its Zhurong rover, during a busy time for Martian exploration. China, the US and hitherto space minnows the UAE have sent probes to the treacherous planet, where failure to land safely is more frequent than success.

China's Tianwen-1 probe successfully launched last July and entered Mars' orbit in February a major milestone for Beijing's ambitious space programme. The sixwheeled, solar-powered Zhurong – named after the god of fire in ancient Chinese mythology-is on a mission to collect rocks and data, and scan the surface.

Here is a look at how China's efforts to reach the red planet com-

weighs a metric ton and has 19 cameras and two microphones which scientists hope will be the first to record sound on Mars. Scientists hope the rover, equipped with its own oxygen-producing facilities, can help pave the way for future manned missions.

The Arab world's first mission to another planet successfully arrived in Mars' orbit in February, after it was launched by the United Arab Emirates last July. The spacecraft, which will remain high above the surface in orbit, is designed to further study Mars' atmosphere and how its climate has changed over time. The European Space Agency and Russian space agency's ExoMars joint mission got off to a rocky start when its first phase, the Schiaparelli lander, spun out of control and crashed on Mars surface in October 2016.

Named after a 19th-century Italian astronomer, the failed mission will pave the way for the second part of the ExoMars programme – the Rosalind Franklin rover, set to launch in 2022. NASA's flagship Curiosity rover-of which Perseverance is an updated version-remains active on Mars' surface after landing in 2012 in a spectacle watched by millions

Charged with finding out whether Mars could have once supported life, the sophisticated carsized rover has built on the work of its NASA predecessors and discovered further evidence of water previously on the planet's surface. It is now studying Mars' geology and the history of its environment. To do this, it is climbing a five-kilometre-tall mountain in an ancient lakebed.

NASA's Opportunity, the longestrunning Mars rover, reached the surface of the Red Planet in 2004, staving operational until 2018 when it was hit by a dust storm. It and its twin rover, Spirit, confirmed that there was once liquid water on Mars' arid surface. After several failed Mars flyby and orbiter attempts between 1960 and 1971, two identical Soviet Union spacecraft finally reached the Red Planet in November and December 1971 only to both get swept up in a huge dust storm. This occurred at the height of the Space Race, when the US and Soviet Union were com-

peting to demonstrate superior spaceflight ability amid Cold War hostilities.

The earlier spacecraft, Mars 2, crashed upon landing after orbiting successfully for 18 hours, but Mars 3 landed successfully and operated for 20 seconds on the surface before it fell over. Both spacecraft sent images, temperature readings and information about Mars' gravity and magnetic fields back to the Soviet Union.

Global bidding for nCoV jabs May 28

Bhubaneswar, May 15: The state government Saturday decided to conduct the global bidding for procurement of Covid-19 vaccines May 28 to ensure timely supply of the jabs to the state.

Chief Secretary Suresh Mahapatra Saturday said that the pre-bidding consultation on the same has been planned for May 19. The government plans to procure around 3.80 crore vaccine doses through the tender process he added

The state Cabinet had earlier decided to issue global tender for procurement of vaccines from across the world. We have done the work and the same has been uploaded on the website of Odisha State Medical Corporation Limited (OSMCL). Odisha is the first Indian state to issue a global tender on the issue in a very short period of time. We



want to provide vaccination to the people as early as possible," he said. He also added, "We have issued the tender to procure a total of 3.80

crore vaccines and have asked for the same within four months. We have a pre-bidding consultation May 19 and 28. Indian and foreign manufacturers of Covid vaccines could take part in the tender. We can start procuring the vaccines in good numbers as soon as the tender is submitted.'

Covid positivity rate of Include all eligible farmers under PM Kisan: Oppn Khurda highest in state

Bhubaneswar, May 15: Khurda has recorded the coastal state's highest test positivity rate at 37.5 per cent during last week (May 8 to 14), as per a list published by Union Health Ministry.

At least 20 out of the 30 districts of the state recorded a test positivity rate above 20 per cent in last week. While Khurda was on top position in the list, Kalahandi was in second position with 34.9 per cent, followed by Angul (34.3%), Boudh (29.9%), Balasore (29%), Bargarh & Bhadrak (28.9% each), Sundargarh (28.2%), Cuttack (27.6%), Nuapada (27.3%) and Puri (26.1%).

Similarly, Dhenkanal district witnessed a positivity rate of 24.9 per cent while it was 24.2 per cent in Nabarangpur, 24 per cent in Bolangir, 23.8 per cent in Sonepur, 23.2 per cent in Jajpur, 22.1 per cent in Jagatsinghpur, 21.6 per cent in Keonjhar and 20.4 per cent in Jharsuguda district, the data shared by Ministry said

BMC starts sanitisation drive in high-caseload areas

Bhubaneswar, May 15: The Bhubaneswar Municipal Corporation (BMC), Saturday, began a massive sanitisation drive deploving three dedicated vehicles in each of its administrative zones.

As per sources, the three dedicated vehicles will focus on areas that are reporting higher caseload and major public places like Unit I and Unit IV along with areas near hospitals and crematoriums. The civic body is presently engaging nine vehicles for sanitisation activities which are managed by three staffers and sanitation ex-

perts of the BMC under the respective Zonal Deputy Commissioners (ZDCs)

"Zones have been divided for sanitisation during first and second half of the day. The vehicles are then deployed accordingly to sanitise areas which experience large footfall every day. With areas like Patia, Rasulgarh and Damana reporting high positive cases, the North Zone of the BMC carried out disinfection drive in these areas on priority basis.

Infected moms can breastfeed: Govt

Bhubaneswar, May 15: With the Covid-19 cases showing no signs of abating, the state government has issued an advisory for safety of children, pregnant women and mothers. The government, in its advisory, said that lactating mothers can continue breastfeeding, with precautions, even if they are found positive for Covid-19.

The Women & Child Development and Mission Shakti department has issued the advisory and directed the district Collectors to ensure strict adherence to it for smooth implementation of various Anganwadi services under ICDS programmes catering to the needs of children, pregnant and lactating women, adolescents in the state.

Department secretary Anu Garg has also reviewed the current Covid situation and measures taken through a virtual meeting with



district social welfare officers (DSWOs) and functionaries of Integrated Child Development Services (ICDS).

"Since many children are getting affected by the virus during the second wave, children must always wear masks when they move out of their homes. Parents must ensure that children above two years must always mandatorily wear face masks when they step out of their houses," the government advisory said.

A majority of children with Covid-19 infection may be asymptomatic or mildly symptomatic. In case of cold, cough, fever, diarrhoea, vomiting, stomach pain, loss of smell/taste, poor feeding

morbid condition may also be managed at home, if they have features of mild disease and there is easy access to health facility in case of any deterioration, it said.

The Collectors were asked for counselling of pregnant and nursing women and children to avail optimal nutrition for improved immunity.

The food ration meant for pregnant women must not be shared by other family members. Pregnant women should consume nutritious food, take adequate rest and follow all Covid protocols.

In case a nursing mother or the child (0-2 years) is found positive, the government has advised to continue the breastfeeding as breast milk strengthens the immune system by directly transferring antibodies from the mother.

However, appropriate precautions are to be followed duringbreastfeeding and handling of the child, it said.

After people came to know about the development of the project, they expressed their displeasure and warned of an agitation.

IFFCO O₂ factory to function by June 15 POST NEWS NETWORK

Jagatsinghpur, May 15: The dis trict administration has granted approval to an oxygen plant proposed by the IFFCO at Paradip. The company has set a target to commission the plant by June 15. The plant capable of producing 700 cylinders per day will come in handy while meeting the need of oxygen for Covid-19 patients.

According to report, the district level single window clearance authority gave the go-ahead to the plant which will be built at a cost of ₹7.2 crore.

Meanwhile, IFFCO has obtained drugs licence, explosive licence and permission of the factory and boiler department for the plant.

The oxygen plant will produce 520 cylinders (46.7 litre each) and 200 cylinders (10 litre each) per day. Various hospitals will be provided oxygen cylinders from the plant.

Reports from Keonjhar said, the district administration has installed a dedicated oxygen supply unit at the dedicated Covid hospital at Ranki

The district administration had earlier decided to purchase a dedicated 'Oxygen Generator Machine' based on Pressure Swing Adsorption (PSA) technology with the DMF funds for overcoming the short supply of medical grade oxygen in the district in October 2020.

The Oxygen Generator Machine was delivered in January 2021 to the district and the installation started towards the last week of April 2021.

When contacted, Prakash Chand Gogineni, divisional forest officer (DFO) said the report has confirmed the death of 'Hero' due to herpes virus. He said they are now concerned about Padma and the rest of the jumbos.

Notably, an examination of all the elephants in the zoo regarding the presence of herpes virus in January had come out negative. However, the sudden death of Hero due to herpes virus has left them worried. He added that a close watch is being kept on all the jumbos in the zoo.

Leading Sans Grip

e is a famous name in war but Field Marshal Bernard Montgomery does not have many battlefield victories to his name. In fact his most famous engagement, called Operation Market Garden (after which the Hollywood movie 'A Bridge Too Far' was made) was a disaster. But historians agree that Montgomery had something that all generals should have and this is 'grip'. This is the faculty of being aware of the situation, being knowledgeable about what resources are at hand and what may be required in future, and being conscious of what events to anticipate.

These are not qualities we associate with our prime minister. His interest is not in the details but in the broad scheme. In a famous interview just before the 2014 elections he said to the journalist Madhu Kishwar: "Even today if my officers show me some paper, I say: 'Tell me what's in it in two minutes. For me two minutes is sufficient for a 10-page document. This skill is something I have developed.

But while he has no interest in details, his preference is not to stand aloof from operations but to insert himself through the bold and imaginative stroke. For instance, the BBC reported at the end of March this year that before the lockdown last year not a single ministry was consulted about what the consequences would be

The BBC filed 240 Right to Information applications with various Indian government departments - health, finance, disaster management - to find out if and how much they were consulted ahead of the lockdown. The responses revealed that no experts or government departments were consulted. The government denied to give the BBC a statement explaining why concerned departments were not consulted ahead of time. A second example of the prime minister's style of functioning is the famous demonetisation. Here also only a handful people knew that this was about to happen. As a parliamentary democracy India follows the principle of collective responsibility. But even

the Cabinet was not told till the day of demonetisation, Tuesday, 8 November, that India's 1000 rupee and 500 rupee notes, 86 per cent of all currency by value, would be wiped out that evening. The government was not only unprepared for Modi's move; it was deliberately kept hidden from the government.

My point is not to say that this style is good or bad or whether it has advantages or disadvantages. The evidence is clear and there is no point in discussing that here. The point is to examine whether it works in situations such as the one we find ourselves in. The problem of the pandemic cannot be approached through the single brilliant stroke. It needs the State to be aware of the situation, be knowledgeable about what resources are at hand and what may be required in future, and being conscious of what events to anticipate. In a centralised State, where decision making is often the purview of a few people and sometimes that only of one man, this may be harder to do as we are discovering.

The official position of our government in response to a shortage of vaccines and a shortage of oxygen and of ventilators is that nobody could have anticipated this. But the fact is that the rest of the world anticipated it. What we are receiving today as aid is not new material

manufactured yesterday around the world. It is the surplus that was produced by nations which had anticipated the crisis we are going through today. They dealt with it because of their preparedness and that is the reason this material became surplus. No nation keeps useless stocks of expensive things lying around in case India will urgently need them. The reason we don't have enough vaccines is that we did not order them at the right time because we didn't think we needed them. As the Prime Minister said to the World Economic Forum in late January, "India is among those countries which have succeeded in saving the lives of the maximum number of its citizens and the number of people infected with corona is rapidly decreasing." He added that "it would not be advisable to judge India's success with that of another country. In a country which is home to 18 per cent of the world population, that country has saved humanity from a big disaster by containing corona

The sudden eruption of war outside and inside Israel's borders has shocked a complacent nation. Throughout Benjamin Netanyahu's 12-year premiership, the Palestinian problem was buried and forgotten. The recent Abraham Accords, establishing diplomatic relations with four Arab states, seemed to weaken the Palestinian cause further. Now it has reemerged with a vengeance.

Wars can be triggered by an isolated incident, but their cause is always deeper. In this case, the trigger, the eviction of Palestinians in favour of Israeli nationalists in the Sheikh Jarrah neighborhood of East Jerusalem, touched all the sensitive nerves of the Israeli-Palestinian conflict. Israel's occupation of East Jerusalem, its humiliating control of access to the Al-Aqsa mosque, the ever-present memory of the 1948 Nakba (the displacement of 700,000 Palestinians when Israel was founded), and the grievances of Israel's Arab minority are all fueling the current flare-up. It may be true that the contested real estate in Sheikh Jarrah did belong to a Jewish family before 1948. But Palestinians saw the incident as part of Israel's unrelenting drive to 'Judaise' Jerusalem, and a striking injustice, because Israel was built partly on abandoned properties of Palestinian refugees. While Jews are entitled to reclaim property they owned before Israel's founding, Palestinians may not. Those facing eviction in Sheikh Jarrah cannot recover homes in Jaffa and Haifa that they once owned.

On the face of it, the latest escalation of violence is following the template of all inter-ethnic wars. Muslims observing Ramadan shouted nationalist slogans and clashed with Israeli right-wing groups chanting "Death to the Arabs." The Israelis haughtily marched with their national flag on Jerusalem Day, marking Israel's capture in 1967 of East Jerusalem and the Temple Mount, the site of the biblical Second Temple. and of Al-Aqsa, completed in the year 705. Battles in and around

the Al-Aqsa compound erupted, with worshipers inside throwing stones at the Israeli police, who responded by firing rubber-tipped bullets and other projectiles, wounding hundreds. But the young Arab protesters could claim victory, for they forced the postponement of an Israeli Supreme Court ruling on the evictions in Sheikh Jarrah. They also forced the police to change the route of the Jerusalem Day march away from the Muslim Quarter in the Old City.

The flare-up spilled over into pre-1967 Israel, where Islamist groups incited young Israeli Arabs. Mixed Jewish-Arab cities that were supposed to be exemplars of coexistence, such as Acre, Ramla, Jaffa, and Lod, erupted in an orgy of violence and vandalism. Lod was practically taken over by gangs of young Arabs. This was a pogrom, said Jewish residents. An old Jewish woman spoke of memories of Kristallnacht. The mayor of Lod drew the same comparison.

But Jerusalem has emerged as the crucible of conflict. It offered Hamas a golden opportunity to assert its predominance over Israel's collaborators in the West Bank's Palestinian Authority and sweep away PA President Mahmoud Abbas' moribund leadership. Under Israeli pressure, Abbas had just canceled legislative

elections for fear that Hamas. which has ruled Gaza since 2006. would win and extend its control to the West Bank

Abbas framed his decision as a protest against Israel's refusal to allow the Palestinians in East Jerusalem to participate in the elections. But the truth is that the PA's presence in East Jerusalem had practically vanished, with the vacuum filled by a mostly secular young Palestinian generation that turned the Temple Mount (Haram Al-Sharif to Muslims) into the symbol of their resistance to Israeli occupation. In the current eruption of violence. Hamas connected all the dots needed to gain primacy in the Palestinian national movement. It positioned itself as the protector of Jerusalem and Al-Aqsa, as the spearhead of the Palestinians' national and religious struggle against the Israeli-Jewish occupier, and also as the voice of the Arab minority in Israel proper.

Israelis and their complacent government were caught off guard. Hamas conducted an unprecedentedly massive missile attack on Israeli cities. They even launched salvos at Jerusalem and Tel Aviv, sending half the country's population to shelters. Israelis were left to wonder how their vulnerable home front could withstand a war with Hezbollah. the Iran-backed

militia across the border in south ern Lebanon. Hezbollah has an arsenal of 150,000 missiles many times more lethal than Hamas'.

To make its case. Hamas was willing to pay a high price. Israel's punitive airstrikes on Gaza have been devastating, targeting Hamas military commanders with brutal efficiency. But Hamas knows that in the asymmetric wars of this era, a militia hidden among two million civilians in one of the world's most densely populated areas has practical immunity from defeat. Hamas also knows that the war's reverberation throughout the region will force neighbours like Egypt and Hamas' patron, Qatar, to mediate a ceasefire.

From the debris of Gaza, Hamas will then claim victory, not necessarily on the battlefield, but in the minds of its people. At that point, Hamas will have achieved its main objectives: an utterly discredited PA and heightened prestige as the ultimate protector of Islam's holy shrines in Jerusalem

Paradoxically, Netanyahu has no interest in destroying Hamas Quite the contrary: he has struck an unwritten deal with it against Abbas' PA, which his governments have consistently done all they could to weaken and humiliate. A Hamas Islamic state in Gaza offers Netanyahu the ideal pretext to reject peace negotiations and a two-state solution. Netanyahu even allowed Qatar to keep Gaza functioning by paying the salaries of Hamas' functionaries.

Israel certainly cannot claim victory. The fragile coexistence between Jews and Arabs within its borders has been shaken. The prevailing consensus among Israelis that Palestinian nationalism had been defeated-and thus that a political solution to the conflict was no longer necessary-lies in tatters. And even as the violence escalates, it has be come clear to both sides that the era of glorious wars and victories is over. Mutoscope

n the 1890s, something like a technological gold rush took place to find a practical way of presenting moving pictures. In the US, for example, Edison demonstrated his kinetoscope in 1894. Alongside considerable mechanical ingenuity lay great linguistic creativity, as a little squib that appeared in the Chicago Record in early 1898 will demonstrate: The single invention of throwing moving pictures on screen, variously known as the vitascope or kinetoscope, has added dozens of new words to the language within the last year or two. Here is a list of the various names for "movement photography:" Phantoscope, criterioscope, vitascope, cinematograph biograph, kinematograph, wonderscope, animatoscope, vitagraph, panoramograph, cosmoscope, anarithmoscope, katoptikum, magniscope, zoeoptrotrope, variscope, phantasmagoria, projectoscope, cinograph, hypnoscope, centograph, X-ograph, electroscope, cinegraphoscope, craboscope, vitaletiscope, cinematoscope, mutoscope, cinoscope, animaloscope, theatograph, chronophotographoscope, cinnomonograph, motograph, kinetograph, rayoscope, motorscope, kinetiphone, thromotrope, phenakistoscope, venetrope, vitrescope, zinematograph, vitopticon, stinnetiscope, vivrescope, diaramiscope, lobsterscope, corminograph, kineoptoscope or any other old scope. Lobsterscope? Craboscope? Was this some joke of the writer's? Buried in that list was one that was certainly real, mutoscope, a device created by the American inventor Herman Casler and patented in 1894. The word is assumed to be from Latin mutare, to change. Both the kinetoscope and the mutoscope required the viewer to peer into a viewing slot while turning a handle. But whereas Edison's device used a strip of film, Casler's was very close in idea to the flip-book, in which riffling through a sequence of still pictures seems to create a moving image. In the mutoscope the pictures were arranged around a drum; turning a handle caused them to appear one after the other at about 16 frames a second, the minimum needed to give an illusion of movement.

New Delhi, May 15: The national capital recorded 6,430 new COVID-19 cases and 337 fatalities Saturday while the positivity rate dipped to 11.32 per cent. This is the second consecutive day when Delhi has recorded less than 10,000 cases in a day.

Delhi Friday recorded 8,506 COVID-19 cases, the daily count dipping to below the 10,000-mark again after a month, with medical experts believing the lockdown to be the main factor behind the dip amid the second wave of the pandemic.

Doctors at leading government and private hospitals in Delhi said there is a relative fall in the number of cases and "still a long way to go" before the daily count falls below the 2,000-mark, as it was a few months earlier.

"Lockdown. I would say is the biggest factor in arriving at a situation where we are now, when daily cases from 28,000 have come down to about 8,500. However, it is still a huge figure, and there should be no room for complacency, on any front," Medical Director of Rajiv Gandhi Super Speciality Hospital (RGSSH), B L Sherwal, told PTI.

"While daily cases have come down, the severity of infection is still the same, and new patients are being brought to our hospital in the same condition as before. Many of them are brought dead or die shortly after being brought to emergency. So, we must understand the gravity of the situation," he added. Delhi had been reeling under a brutal second wave of the pandemic that is sweeping the country, claiming a massive number of lives daily, with the recent oxygen supply shortage issue at various hos pitals adding to the woes.

Lockdown leads to fall in Delhi's Covid

Chandigarh, May 15: Chief Minister Amarinder Singh Saturday criticised his Uttar Pradesh counterpart Yogi Adityanath over his 'inflammatory' tweet on the declaration of Malerkotla as the 23rd district of Punjab, terming it an attempt to incite 'communal hatred' in the peaceful state.

Contrasting the communal harmony in Punjab with the 'divisiveness' being promoted by the Yogi Adityanath government in Uttar Pradesh, Singh asked the former to stay out of his state's affairs as they are in much better shape than those in UP.

"Any distinction on the basis of belief and religion is contrary to the basic spirit of the Constitution of India. Presently, the formation of Malerkotla (Punjab) is a reflection of the divisive policy of the Congress," Adityanath had tweeted earlier in Hindi.

The UP chief minister's tweet came a day after Singh announced the only Muslim majority town in Punjab to be the state's 23rd district on the occasion of Eid. "What does he (Yogi Aditvanath) know of Punjab's ethos or the his-

Pointing to the "spate of changes in names" of various UP cities, including Mughal Sarai to Pandit Deen Dayal Upadhyay Nagar, Allahabad as Prayagraj and Faizabad as Ayodhya, he dubbed it an "attempt by the Yogi government to rewrite history", which the peace-loving people of India will never condone.

Citing media reports, Singh recalled that UP was the first state in the country to approve 'love jihad' laws, and Yogi Adiyanath's "open hatred" for Taj Mahal (which he sees as a legacy of the Mughals) has been the subject matter of criticism in international press. In fact, the UP chief minister is

reportedly the founder of Hindu Yuva Vahini, an organisation that was responsible for starting cow vigilantism, which led to lynching of Muslims in his own state, Singh pointed out.

It was obvious that the tweet of the UP government head on Malerkotla was nothing but a provocative gesture aimed at creating "conflict" among the communities living in perfect harmony in Punjab, the chief Minister said.

He termed it a "conspiracy on the part of the BJP to spread disharmony" in Punjab ahead of the assembly elections, which are iust months away.

"But the UP chief minister seems to have forgotten that his own state is also going to the polls at the same time, and if the recent Panchayat poll results are any indication, the BJP is in for a complete and shocking rout," he quipped.

Adityanath should focus his energies on saving his own state, where the COVID situation is spirally out of control, with bodies of the victims of the pandemic being found dumped in rivers, thus depriving them of even the dignity of a decent cremation/burial, Singh said.

"A chief minister who cannot protect even the basic human rights of his state's people and allows them to be treated with such shocking disrespect has no moral right to continue in office, leave alone comment on the functioning of another state government." the Punjab chief minister added.

Delhi's 'ambulance couple' goes the extra mile

New Delhi, May 15: Profiles of humaneness in the time of Covid, Himanshu and Twinkle Kalia spend their days between helping the ill get a fighting chance at life and ensuring dignity in death for those who don't make it.

As the second COVID-19 wave ravages large parts of India -- including the national capital that has seen thousands scramble for oxygen, hospital beds and crematorium spots -- the Kalias, Delhi's 'ambulance couple', ferry the ill to hospital, fetch medicines, arrange funerals and sometimes step in to perform last rites too

Cloaked in PPE suits, face shields and masks, the Kalias go where even close relatives fear to tread, spending their days tending to people suffering from Covid or those who have died of it and making sure their fleet of 12 ambulances are road ready to tackle any emergency.

"We don't put it in records but in the second wave of coronavirus we have been helping almost 20-25 patients daily reach hospitals. We have performed cremations of 80 people who have died of COVID-19 and helped over 1,000 people in arranging for cremations," Himanshu told PTI.

It's all free of course, the 42-yearold hastened to add. A few days ago, they got a call from Mayur Vihar in east Delhi about a patient who had died in an auto-rickshaw on the way to hospital, said Twinkle.

The Kalias, who live in Pratap Nagar in north Delhi, reached there quickly, got the body verified by a doctor and helped in the last rites.

"We got a call from Sandeep Mitra whose wife Madhura had collapsed in an auto-rickshaw while he was taking her to a hospital. He was not getting any help from his society or elsewhere. We reached there, got a doctor to the spot and performed her cremation at the Sarai Kale Khan crematorium,' Twinkle said.

The 39-year-old is a cancer survivor and the couple has two daughters, Japji (13) and Riddhi (7). But personal commitments don't come in the way of their zeal to help others in these days of India's most se-



rious health crisis.

At a time ambulances are in short supply and stories of ambulance drivers and owners fleecing those in need make the rounds, the Kalias have publicised the free services of their fleet. Himanshu's mobile number has been pasted at various places across the city.

As a result, he said, distress calls come in from all over Delhi and also from Ghaziabad and Noida. The word has spread and some hospitals have also started reaching out.

Some know him for not just services but also his skills behind the wheel, he said proudly.

"Due to my fast driving, even through traffic, many hospitals call me in emergency situations to save the lives of patients," he said.

And sometimes the ambulance has to do the job of a hearse. It's not an easy existence. There is a fleet of vehicles to maintain, a team of 18 people to support and a home to run. Both Himanshu and Twinkle work as insurance agents and said they spend their earnings in serving humanity.

The ambulance service started in 2002 when his parents-in-law gifted him an ambulance, said Himanshu. It has built up steadily since with the Kalias adding vehicles over the years.

Six of the ambulances are parked at their residence and six elsewhere. The couple was doing charitable work even before the pandemic struck and has received several awards.

In 2019, Twinkle was awarded the Nari Shakti Puruskar by President Ram Nath Kovind. Four years before that, in 2015, an organisation in Dubai honoured her as the 'First Woman Ambulance Driver'. In 2016. Himanshu got the 'Ambulance Man' award in Malaysia. Hoping to ramp up their work of facilitating hospital admissions, blood donations and arranging funerals, Himanshu and Twinkle said they have expanded their team.

As millions of Indians battle infection and death, there are many more miles to go and hurdles to cross for this intrepid couple.

'Centre should be lone agency for procurement of vaccines'

PLASMA THERAPY 'Not effective, likely to be dropped from COVID guidelines'

New Delhi, May 15: Plasma therapy on COVID-19 patients has not been found effective in reducing the progression to severe disease or death and is likely to be dropped from the clinical management guidelines, sources said.

In a meeting of the ICMR-National Task Force for COVID-19 Friday, all members were in favour of removing the use of convalescent plasma from the Clinical Guidance for Management of Adult COVID-19 Patients citing its ineffectiveness and inappropriate use in several cases, they said. The Indian Council of Medical

Research (ICMR) will issue an advisory on the matter soon, they said. The present guidelines allow off label use of plasma therapy at the stage of early moderate disease, that is, within seven days of the onset of symptoms and if there is availability of a high titre donor plasma.

The decision to remove it from the guidelines comes in the backdrop of some clinicians and scientists writing to Principal Scientific Advisor K VijayRaghavan cautioning against the irrational and non-scientific use of convalescent plasma for COVID-19 in the country. In the letter, which was also marked to ICMR chief Balram Bhargava and AIIMS Director Randeep Guleria, public health professionals alleged that the current guidelines on plasma therapy

are not based on existing evidence and pointed out some very early evidence that indicates a possible association between emergence of variants with "lower susceptibility to neutralising antibodies in immunosuppressed people given plasma therapy.

This raises the possibility of more virulent strains developing due to irrational use of plasma therapy which can fuel the pandemic, according to the letter signed by vaccinologist Gagandeep Kang, surgeon Pramesh C S and others.

We are writing to you as concerned clinicians, public health professionals and scientists from India about the irrational and nonscientific use of convalescent plasma for COVID-19 in the country.

This has stemmed from guidelines issued by government agencies, and we request your urgent in-

tervention to address the issue which can prevent harassment of COVID-19 patients, their families,

their clinicians and COVID-19 survivors," said the letter. The current research evidence

unanimously indicates that there is no benefit offered by convalescent plasma for treatment of COVID-19. However, it continues to be prescribed rampantly in hospitals across India," the letter said.

Families of patients run from pillar-to-post for getting plasma, which is in short supply. The desperation of patients and their families is understandable because they like to try the best for their loved ones, when a doctor has prescribed this, the public health professionals said.

In the plasma therapy, antibodies from the blood of a patient who has recovered from COVID-19 are used to treat serious patients.

States, Forces prepare for Tauktae

Prime Minister Modi reviewed the preparedness of states, central ministries and agencies concerned to deal with the situation arising out of cyclone Tauktae and asked them to take every possible measure to ensure that people are safely evacuated

New Delhi, May 15: Indian Air Force, Navy and National Disaster Response Force (NDRF) are making preparations for Cyclone Tauktae, which is expected to cause 'very heavy' to 'extremely heavy' rainfall along the western coast of India in the next few days.

Further, the Airports Authority of India (AAI) has suspended all scheduled flights to the Agatti Airport in Lakshadweep due to heavy rain projections till 10am Sunday.

The Indian Air Force (IAF) has kept 16 transport aircraft and 18 helicopters on operation readiness in peninsular India. One IL-76 aircraft has airlifted 127 personnel and 11 tonnes of cargo from Bhatinda to Jamnagar, the force said in a statement.

The IAF also stated that a C-130 aircraft has airlifted 25 personnel and 12.3 tonnes cargo from Bhatinda to Rajkot. Two C-130 aircraft have airlifted 126 personnel and 14 tonnes cargo from Bhubaneswar to Jamnagar, it added.

Additionally, IAF's Covid relief operations have been focused in these coastal areas for the coming few days, as bad weather might to affect air operations later.

The cyclone relief operations are in addition to those underway

CYCLONE INTENSIFYING: IMD

Mumbai/Ahmedabad: Cyclonic storm Tauktae had intensified and was heading towards the coast of Gujarat and the Union Territory of Daman and Diu and Dadra and Nagar Haveli, the India Meteorological Department (IMD) said Saturday evening. The storm is very likely to intensify further into a very severe cyclonic storm by late Saturday night, the IMD said, adding it was very likely to move north-northwestwards and cross Gujarat coast between Porbandar and Naliya around May 18 afternoon. As it would bring very heavy rainfall in that region, cities like Mumbai would not be affected much, the IMD added. There will be strong winds and heavy rainfall at isolated places May 17 over north Konkan, including Mumbai, the IMD said. The Maharashtra capital can expect showers from Sunday afternoon, said Shubhani Bhute, senior director (weather) IMD, Mumbai. The storm is currently 250 km southwest of Goa, she added. Goa alongwith Sindhudurg and Ratnagiri districts of Maharashtra would be mostly affected in terms of showers and gusty winds, Bhute said, adding the wind speeds would be around 60 to 70 kmph. The IMD has issued an 'orange alert' which means heavy to very heavy rainfall is likely over entire Konkan and hilly areas of western Maharashtra, mainly Kolhapur and Satara Sunday and Monday, she said.

Stalin orders to bring 82 fishing boats ashore

Stricter action needed as WhatsApp privacy policy goes live

New Delhi, May 15: With the controversial WhatsApp privacy policy coming into effect from Saturday for its over 2 billion users including more than 400 million in India, industry experts emphasised that the government must implement stricter data privacy rules and restrain the Facebook-owned app as was done while banning Chinese apps to protect the sovereignty of the country.

Giving an interim solace for those who do not accept the new policy, WhatsApp has said that its users will not immediately lose their accounts or face curtailed functionalities on the platform May 15, but they will have to eventually go through limited functions if they fail to accept the new



norms in the due course of time. Thursday, a senior Ministry of Electronics and IT official said during an Assocham event that the government is pro-actively looking at a best possible action over the new WhatsApp privacy policy. MeitY Special Secretary and Financial Advisor Jyoti Arora stated that the ministry is aware about the fact that Germany has banned the privacy policy of WhatsApp.

There is no judicial order in favour of WhatsApp. In view of the unlawful nature of this privacy policy, the government should restrain WhatsApp as was done while banning Chinese apps to protect sovereignty of India, said Advocate Virag Gupta, who is arguing K N Govindacharya's matter before the Delhi High Court for disclosure of details of designated officers of social media companies.

WhatsApp has said that after giving everyone time to review the privacy policy from May 15, after a period of several weeks, the reminder people receive will eventually become persistent.

After persistent reminders, the users will encounter limited functionality on WhatsApp until they accept the updates.

The users won't be able to access chat list. After a few weeks of limited functionality, they won't be able to receive incoming calls or notifications and WhatsApp will stop sending messages and calls to their phones.

WhatsApp's new terms requiring users to accept them by a cut-off date to continue to avail full functionality has brought click wrap contracts and their intended manner of operation under the glare. Click wrap contracts require a user to click 'yes' or 'ok' to the terms, which constitutes legal consent for availing a service, said Raj Ramachandran, Partner, J Sagar Associates.

Given the substantial user base and the apparent network effect, it literally leaves little room for users to make a choice.

New Delhi, May 15: Prime Minister Narendra Modi Saturday emphasised on localised containment strategies in states where Test Positive Rate (TPR) in districts is high and adopting door to door testing and surveillance in rural India to contain the spread of Covid-19.

The Prime Minister gave the direction while chairing a high-level meeting to discuss the Covid-19 and vaccination related situation in the country which is passing through the second wave of the deadly disease.

Localised containment strategies are the need of the hour specially for states where TPR in districts is high, said the Prime Minister, instructing that testing needs to be scaled up further, with use of both RT PCR and Rapid Tests, especially in areas with high test positivity rates.

Modi said that states should be encouraged to report their num-

gen, Modi directed that a distribution plan for ensuring oxygen supply in rural areas must be worked out, including provision of oxygen concentrators.

The Prime Minister also stressed on the need to provide necessary training to health workers in the operation of equipment like oxygen concentrators, and that there should be proper power supply to ensure smooth operation of such medical devices

The Prime Minister took serious note of some reports about ventilators lying unutilised in storage in some states and directed that an immediate audit of installation and operation of ventilators provided by the Central government should be carried out.

He added that refresher training for properly operating ventilators should be provided to health care workers if necessary. Modi assured that India's fight against Covid has been guided throughout by scientists and subject experts and will continue being guided by them.

New Delhi: The Delhi Police has registered 25 FIRs and arrested as many people for allegedly pasting posters critical of Prime Minister Narendra Modi in connection with the vaccination drive against COVID-19, officials said Saturday. BJP MP Meenakshi Lekhi said Kalra was given the membership of Golf Club, one of the most premium clubs in the national capital, by Congress leader Ajay Maken when he was the urban development minister in the UPA-I government.

Congress MP Abhishek Manu Singhvi is lawyer of all such "criminals" and black-marketeers, she said, hitting out at the opposition

party. Kalra and officials of Matrix Cellular had hoarded about 7,500 concentrators, she said, alleging their links with the Congress.

She claimed that an artificial shortage of oxygen was created and exploited by those close to the party. Lekhi said Kalra's Facebook page shows his pictures with Congress leaders Sonia Gandhi and Rahul Gandhi.

The businessman has also

claimed in his page that Prime Minister Narendra Modi is responsible for the COVID-19 pandemic, she added.

The chef who works at Kalra's restaurant had described Gandhis as the first family of the country, she said.

"The Congress' hand is always with black marketeers and hoarders, and this is evident from the events which have unfolded themselves. These people are directly in links with the Congress. The Congress has encouraged such people when it was in power," she alleged.

After 2006, this is the second time the anti-talk banned outfit has announced a unilateral cease fire in the state. The ULFA-I announcement came five days after Assam Chief Minister Himanta Biswa Sarma appealed to ULFA-I supremo Barua and other extremist outfits to come forward for peace talks. After taking oath as the 15th Chief Minister of Assam, Sarma Monday had urged ULFA-I led by Paresh Barua and other militant groups to shun the path of violence and join the mainstream. Tedros Adhanom Ghebreyesus, WHO Director General said in a briefing that WHO is responding and has shipped thousands of oxygen concentrators, tents for mobile field hospitals, masks and other medical supplies. And we thank all the stakeholders who are supporting India, he said.

COVID-19 has already cost more than 3.3 million lives and we're on track for the second year of this pandemic to be far more deadly than the first, Tedros said.

However, it's not only India that has emergency needs, he added. Nepal, Sri Lanka, Vietnam, Cambodia, Thailand and Egypt are just some of the countries that are dealing with spikes in cases and

hospitalizations. He added that the fact that so

many are still not protected is a sad reflection on the gross distortion in access to vaccines across the globe.

In January, I spoke about the potential unfolding of a moral catastrophe. Unfortunately, we are now witnessing this play out. In a handful of rich countries, which bought up the majority of the vaccine supply, lower risk groups are now being vaccinated, he said.

I understand why some countries want to vaccinate their children and adolescents, but right now I urge them to reconsider and

to instead donate vaccines to COVAX. WHO said. Because in low and lower-mid-

dle income countries, vaccine supply has not been enough to even immunize health and care workers, and hospitals are being inundated with people that need lifesaving care urgently. At present, only 0.3 per cent of vaccine supply is going to low-income countries, he added.

China approves inactivated vax

Beijing: China has approved one more inactivated Covid-19 vaccine for emergency use, according to an announcement by the developer of the jab. Shenzhen Kangtai Biological Products Co. Ltd., the developer, said Friday that the vaccine it developed has started related work for Phase III clinical trial. The vaccine reported no adverse events with an intensity of grade 3 or above in the first two phases of its clinical trials.

Revoking steps issued by Trump

Washington: US President Joe Biden signed an executive order that will revoke several measures issued by his predecessor Donald Trump. The order signed Friday will revoke the measure to establish a "National Garden of American Heroes" that called for erecting statues of hundreds of prominent Americans though some of them are controversial over their racial records. The order also revoked Trump's another action which prioritised punishment for those caught vandalizing statues or monuments.

London, May 15: The vaccines being administered to protect against Covid-19 are "almost certainly less effective" against preventing the transmission of the B1.617.2 variant first identified in India, a leading UK scientist who advises the country's vaccination programme said Saturday. Professor Anthony Harnden,

from the University of Oxford who is the deputy chair of the Joint Committee on Vaccination and Immunisation (JCVI), said it was important to approach the easing of lockdown in England with "utmost caution" as it remains unclear exactly how much more transmissible the variant detected in India is. But he reiterated that there is no evidence so far of increased sever-



ity of illness or that the particular mutation of the coronavirus evades the vaccine.

'The vaccines may be less effective against mild disease but we don't think they're less effective against severe disease. But in combination with being less effective against mild disease, they're almost certainly less effective against transmission," Prof.

Harnden told the BBC "We don't know how much more transmissible it is yet. All the evidence so far suggests there is no evidence of increased severity of illness or that it evades the vaccine. So, at the moment, on the basis of the evidence we are doing the right thing, coolly, calmly continuing with Monday, but keeping everything under review," he said, in reference to the next stage in

the easing of lockdown that begins in England from Monday.

Under the UK's action plan laid out to tackle the B1.617.2 variant of concern (VOC) first identified in India, all over-50s and the most vulnerable groups are to be offered their second Covid-19 vaccine dose earlier than scheduled. "We have implemented meas-

ures at record pace to get on top of this new variant and control the spread. Everyone has a role to play in this effort - accept the invitation to get a jab when it comes, and if vou live in one of the areas where we've introduced surge testing. get your free PCR test. Let's work to fight this together," said UK Health Secretary Matt Hancock.

UK PM speeds up 2nd dose for 50+

A rise in cases of the coronavirus variant dominant in India could "pose serious disruption" to Britain's reopening plans, Prime Minister Boris Johnson warned Friday. England will take the next step of reopening Monday as planned, but the final stage, currently scheduled for June 21, could be in doubt. "I do not believe we need to delay our roadmap," said Johnson. But, "this new variant could pose a serious disruption to our progress," he said, adding "We will do whatever it takes to keep the public safe." Second doses of vaccines will be accelerated for the over-50 and the clinically vulnerable in a bid to keep the strain at bay, Johnson told the press briefing.

the number of cases across the UK has risen from 520 last week to 1,313 cases this week. Most cases are in the north west of England, with some in London. Yangon, May 15: Myanmar's army battled local militia fighters in the northwestern town of Mindat Saturday, residents said, to try to quell a rebellion that has sprung up to oppose the junta that seized power in the Southeast Asian country in February.

The junta imposed martial law in Mindat Thursday and then stepped up attacks on what it called "armed terrorists". A spokesman did not answer calls requesting comment on the fighting Saturday.

Residents taking cover in the town said fighting raged Saturday. The Irrawaddy news service said some homes had been destroyed as the army resumed artillery bombardment Saturday.

Myanmar already had some two dozen ethnic armed groups, who have waged war for decades against an army dominated by the Bamar majority. The Chinland Defence Force was set up in response to the coup.

US joins global push against violent extremism online

Wellington, May 15: Two years after a white supremacist in New Zealand live streamed the slaughter of 51 Muslim worshippers on Facebook, French President Emmanuel Macron says the internet continues to be used by terrorists as a weapon to propagate hate.

Macron and other leaders from tech giants and governments around the world including the US for the first time gathered virtually Saturday to find better ways to stop extremist violence from spreading online, while also respecting freedom of expression. It was part of a global effort started

Jacinda Ardern after deadly attacks in their countries were streamed or shared on social networks.

The US government and four other countries joined the effort. known as the Christchurch Call, for the first time this year. It involves some 50 nations plus tech companies including Google, Facebook, Twitter and Amazon, and is named for the NZ city where the slaughter at the two mosques took place.

Gaza City, May 15: Turmoil from the battle between Israel and Hamas spilled over into the West Bank, sparking the most widespread Palestinian protests in years as hundreds of young demonstrators in multiple towns clashed with Israeli troops, who shot and killed at least 11 people.

Israel's bombardment of the Gaza Strip continued into early Saturday, when an airstrike on a house in Gaza City killed at least seven Palestinians — the highest number of fatalities in a single hit. That strike came a day after a furious overnight barrage of tank fire and airstrikes that wreaked destruction in some towns, killed a family of six in their house and sent thousands fleeing their homes.

Gary called the strike "an incredibly disturbing development".

Govt mulls sops to offset GST COUNCIL spike in fert input prices TO MEET MAY 28 AGENCIES

International prices of raw materials of Di-ammonium Phosphate (DAP) and other P&K fertilisers have increased sharply

P&K fertilisers have been kept unchanged. New Delhi, May 15: The Centre In a statement, the Fertiliser Saturday said it is considering sub-Ministry said in the last few months, sidies to offset rise in global prices

the international prices of raw materials of Di-ammonium Phosphate (DAP) and other P&K fertilisers have increased sharply. Prices of finished DAP, etc in the international market have also risen proportionately. "Despite this sharp increase,

DAP prices in India were not increased by the companies till last month. However, some companies have now increased the DAP price," it said.

However, the government is fully sensitive to the concerns of farmers and is already taking steps to tackle the situation so that the farming community can be saved from the effects of this price rise of P&K fertilisers (including DAP). it said.

On the pricing front of DAP, the government has already asked all the fertiliser companies to sell their old stocks of DAP, etc at old prices only, it said.

"Additionally, the Government of India is also considering the subsidy rates to offset the rise in international prices of raw materials of P&K fertilisers and DAP in order to support the farmers' cause and lessen the financial burden on them," the ministry noted.

The government is fully aware of the situation, and it is being closely monitored at a very high level in the government, it said. In accordance with its farmerfriendly approach, the ministry said the government is committed to ensuring the availability of P&K fertilisers to farmers at affordable prices, it added.

Fertiliser companies had raised the retail prices of P&K fertilisers like DAP in line with the global market effective from April 1. But they were directed not to increase the rates for the time being.

New Delhi, May 15: The GST Council will meet May 28 and is likely to discuss tax rates on COVID-related drugs, oxygen equipment and vaccines. The meeting among other things is also likely to discuss the compensation mechanism for states' GST revenue shortfall for the ongoing fiscal which began April 1. Finance Minister Nirmala Sitharaman will chair the 43rd GST Council meeting via video conferencing on May 28, 2021. 'The meeting will be attended by MOS Shri @ianuragthakur besides Finance Ministers of States & UTs and Senior officers from Union Government & States,' Office of Nirmala Sitharaman tweeted.

Earlier this month, West Bengal Finance Minister Amit Mitra and Punjab Finance Minister Manpreet Singh Badal had demanded that a virtual GST Council meeting be held.

The meeting of the Council is supposed to take place at least once every quarter of a financial year. However, the panel has not met since October 5 last year.

Congress working president Sonia Gandhi had last month demanded that all life-saving drugs, equipment and instruments required to treat COVID-19 patients must be exempted from GST. Mamata Baneriee's Trinamool Congress has also made a similar demand.



Sitharaman had, however, ruled out exempting COVID vaccines, medicines and oxygen concentrators from GST saying such an exemption will make the lifesaving items costlier for consumers as manufacturers will not be able to offset the taxes paid on inputs.

Currently, domestic supplies and commercial imports of vaccines attract 5 per cent Goods and Services Tax (GST), while COVID drugs and oxygen concentrators attract 12 per cent levy.

The Centre had last fiscal year released ₹70,000 crore to states on account of GST compensation. This is over and above the ₹1.10 lakh crore released to states under the special borrowing mechanism to compensate them for shortfall in the GST collection this finan-

cial year. As much as ₹63,000 crore worth compensation is still due to be paid for 2020-21 fiscal year which ended March 31, 2021.

Accordingly, the report cited that this policy path was the best suited one given the strong positive externalities. "The overall estimated welfare cost of vaccinating universal population would be 0.6-0.7 per cent of GDP, assuming no wastage and optimal distribution," Emkay's Lead Economist Madhavi Arora said.

"This is much lower than the current 0.9-1 per cent loss of monthly output amid existing soft local lockdowns, clearly implying a successful vaccine strategy is the cheapest optimal policy path to economic normalisation.

During the first fortnight of May this year (from May 1 to 14), peak power demand met or the highest supply in a day touched the highest level of 168.78 GW (on May 6, 2021) and recorded growth of over 15 per cent over 146.54 GW (peak met) recorded in the same period in 2020 (on May 13, 2020).

The power consumption in April grew nearly 40 per cent to 118.08 BU. Power consumption in April 2020 had dropped to 84.55 BU from 110.11 BU in the same month in 2019, mainly because of fewer economic activities following the imposition of lockdown by the government in the last week of March 2020 to contain the spread of deadly



COVID-19

The power consumption also fell in May 2020 to 102.08 BU from 120.02 BU in May 2019. Similarly, peak power demand met or the highest power supply in a day also slumped to 132.73 GW in April last year from 176.81 GW in the same month in 2019, showing the impact of lockdown on economic activities.

The fewer economic activities also resulted in a fall of peak power demand in May 2020 to 166.22 GW from 182.53 GW in May 2019.

Taking to PTI, Davinder Sandhu, Advisor Primus Partners said, "Energy is derived demand, and

economic output as well as sharp uptick in exports.'

The second wave of lockdowns will certainly impact economic activity, and in turn, energy demand. The larger than usual increase in part is attributed to lower base, and as well as to the pent up demand being executed now, he added.

After a gap of six months, power consumption had recorded a 4.6 per cent year-on-year growth in September 2020 and 11.6 per cent in October 2020.

In November 2020, the power consumption growth slowed to 3.12 per cent, mainly due to the early onset of winters. In December 2020, power consumption grew by 4.5 per cent while it was up 4.4 per cent in January 2021.



According to the report, there exists an average monthly supply gap of 170 million jabs to cover universal population by CY21-end. "The vaccination drive is skewed state-wise and has overall slowed sub-

India's pharma industry grows to 59 pc in April

New Delhi, May 15: The fresh wave of Covid-19 in the country has pushed up sales of medicines and resulted in exponential growth for the pharmaceutical sector.

According to total sales audit data from world's largest pharmaceutical market research firm IMS Health, the Indian Pharma Market (IPM) grew 59 per cent yoy in April, 2021 vs 16 per cent yoy in March, 2021 due to the low base effect in April, 2020 and sharp surge in Covid-19-related sales.

On the MAT (moving annual turnover) basis, IPM grew 9.6 per cent, primarily driven by pricing growth of 4.3 per cent and new product launch growth of 4.6 per cent. Volume growth was muted at 0.8 per cent.

According to a report from Emkay Global Financial Services, all major therapies posted high double-digit growth in April 21. Within Chronic therapies, Cardiac therapy grew 22 per cent. Similarly Anti-diabetic therapy grew 10 per cent. VMS (vitamins, minerals and supplements) posted record growthof 80 per cent in April 21 vs 27 per cent in March 21.

Trident plans to raise ₹1,100 cr

New Delhi: Textiles and paper maker Trident Ltd is planning to raise up to ₹1.100 crore from the market by issuing NCDs and equity shares in tranches. The company's board on Saturday approved raising up to ₹600 crore by issuing Non-Convertible Debentures (NCDs) and up to ₹500 crore through equity shares. Trident said in a regulatory filing. The board also recommended the fund raising resolution to be approved by the shareholders in the next meeting, it added. Besides, it okaved the appointment of Naveet Jindal as CEO for Paper, Chemicals and Energy Business of the company and Swapan Nath as CEO for Budhni Location

New Delhi, May 15: The government Saturday eases certain norms under Gas Cylinders Rules, 2016 to fast track approvals for imported cylinders and pressure vessels for storage and transportation of medical oxygen amid rising Covid cases.

The relaxations would be valid for six months or till further orders of the Department for Promotion of Industry and Internal Trade (DPIIT), an official statement said.

The department said that the certification of Petroleum and **Explosive Safety Organization** (PESO) will not be mandatory before importing consignment of oxygen cylinders, and containers.

The certification of PESO will be required before use of the oxygen cylinders, which entails weight and hydro testing, it added.

"The Indian missions should, however, ensure that the oxygen cylinders should comply with India or international standards before shipment," it said. In case of filled cylinders, the

agency exporting to India would



have to certify that the oxygen filled in the cylinder is of such purity and concentration that is fit for medical use

The certification would be attested by the Indian mission in the exporting country and soon upon arrival in India, such filled cylinders will be inspected on sample basis by an empanelled agency of PESO.

"All the filled cylinders must be

verified for quality of gas filled therein under the supervision of medical/ Food and Drugs Controllers and if quality of gas conforms to their requirement of medical oxygen, cylinders may be sent directly to hospitals for use," the department said.

Regarding PSA (pressure swing adsorption) installations at hospitals with filling facilities or at COVID centres, it said PSA plants where generated oxygen is directly supplied to hospital and no filling of cylinders is taking place, in such cases the facilities do not need any permission or license under PESO rules.

The department instructed that if the PSA is attached with a compressor and filling of oxygen cylinder is to take place, hospitals have to notify it to PESO with certain information like number of cylin**The PESO certification** will be required before use of oxygen cylinders, which entails weight and hydro testing. ders to be stored at site; and number of filling points.

"Any COVID centre may utilise liquid cylinders on board with vaporizer for supplying of gaseous medical oxygen through pipeline or for filling cylinders in open places are permitted" subject to certain conditions, it said.

Further, it said that in case if consignment of oxygen cylinders, ISO containers or PSA plants or its related equipment have already arrived in India, without taking import permission from PESO, due to an urgency, the filling permission for these cylinders will be issued based on relaxed rules.

enjoyed himself at St. James' Park. He is finishing his first season at the club in impressive fashion, taking his tally to five goals in his last four league games by scoring twice in three minutes from the 64th as City fought back from

FERRAN ECLIPSES MESSI RECORD

NEWCASTLE: Ferran Torres broke a record previously held by Lionel Messi when he struck a memorable hat-trick for Manchester City against Newcastle Friday. The 21-yearold's treble helped the newly crowned Premier League champions to a thrilling 4-3 victory against Newcastle at St James' Park. In doing so he became the youngest player to score a league hat-trick for a Pep Guardiola side, the previous record being set by Messi 11 years ago. Argentine superstar Messi was 22 years and 200 days old when he scored a hattrick in a 5-0 La Liga win for Guardiola's Barcelona against Tenerife in 2010. Fast forward 11 years and Torres is 125 days younger than Messi was, with all three of his goals coming in a remarkable 24-minute spell either side of halftime.

She added, "A true association should deeply care about the players that play the game... Not focus

solely on just the game at any cost. So disappointed.'

The 28-year-old Bangalore-based Veda recently paid an emotional tribute to her sister and mother. who succumbed to the virus in a span of two weeks.

The all-rounder, who has been helping others through her social media by amplifying their requests for aid, has represented India in 48 ODIs and 76 T20s.

Sthalekar, the first player to achieve the double of 1000 runs and 100 wickets in women's ODIs, felt the time has come for a player association for the Indian women's team.

"As a past player the ACA (Australian Cricketers' Association) have reached out daily to see how we are and pro-

vided all kinds of services. If there was a need for a player association in (India) surely it is

now." The 41-year-old Sthalekar, now a commentator, said being looked after has become more important at the moment, with the pandemic wreaking havoc across

the world. 'The stress, anxiety, fear and grief that many players have experienced through this pandemic will take its toll on them as individuals and inadvertently affect the game," Sthalekar signed off. India is reeling under a devastating second wave of the pan-

demic with cases rising by over three lakh everyday and the crisis has been compounded by a shortage of some crucial medicines and oxygen supplies.

Injured Ibrahimovic out of Euro Camp cancelled for Tokyo-bound wrestlers

New Delhi, May 15: The planned camp for eight Olympic-bound Indian wrestlers in Sonepat has been cancelled due to hard quarantine and they will instead train in multiple European cities, with the national federation allowing each of them a sparring partner of their choice.

The wrestlers - both men and women – were to assemble at the SAI centre in Bahalgarh Tuesday but now, as per the plan devised by the Wrestling Federation of India (WFI), all of them will travel to Warsaw in the last week of May The capital city of Poland will host the last Ranking Series event before the Tokyo Games from June 8-13, giving a chance to all to earn some crucial ranking points that will help them get better draw at the Olympics.

"We had planned a camp in Bahalgarh but since they would not be allowed to train for 14 days due to hard quarantine, we thought it is better they for the time being they train at their respective 'akhadas' and then travel to Poland," WFI assistant secretary Vinod Tomar told this agency. 'We are also allowing all the

wrestlers to travel with one partner of their choice for practice. A few, like Vinesh Phogat, Bajrang Punia, Ravi Dahiya and Deepak Punia, will be accompanied by their personal coaches too," he added

The WFI has written to its counterparts in Poland that Indian wrestlers be allowed to use their facilities for a training camp ahead of the tournament in Warsaw next month

After the tournament gets over, the Indian wrestlers will stay put

in Warsaw for another training camp, which is being organised by the Polish federation.

Following the Warsaw trip, the Indian contingent will move to Hungary for a training camp and

Vinesh is already abroad with her Hungarian coach Woller Akos and will reach Poland directly from there. It will be interesting to see if young Sonam Malik (women 62kg) and Sumit Malik (men's 125kg) will be part of the near 40day trip since both of them are recovering from their respective knee injuries.

Sonam had suffered the knee injury during the Asian Olympic Qualifier in Almaty while Sumit had suffered the injury during the national camp but still competed at both the Olympic Qualifiers. He had secured the quota in Bulgaria, where he settled for a silver medal. India will field a strong eight-
