Yaas landfall between Paradip, Sagar

MET DEPARTMENT SAID THAT THE LOW PRESSURE AREA WAS AROUND 590 KMS AWAY FROM THE EAST SOUTHEAST OF PARADIP

Bhubaneswar, May 23: Cyclone Yaas may make a landfall anywhere between Paradip in Odisha and Sagar Islands in West Bengal, the India Meteorological Department (IMD) said Sunday.

The MeT department said that the low pressure area was around 590 kms away from the east southeast of Paradip and was likely to move north westwards and intensify into a severe cyclonic storm by May 24. Later, it may intensify into a very severe cyclonic storm by May 25.

"The cyclone will continue to move towards north-northwest, intensify further and reach Northwest Bay of Bengal near West Bengal and north Odisha coasts by May 26 morning. It is very likely to cross north Odisha and West Bengal between Paradip and Sagar Islands by the evening of May 26 as a very severe cyclonic storm and make a landfall in between," the department said in its evening bulletin.

The department has issued Distant Cautionary Signal Number 1 to all the ports across the state and advised them to be prepared for the cyclone. The department has issued Yellow Warning for May 24 and May 25 forecasting heavy to very heavy rainfall



in the northern coastal parts of Odisha. The department, however, has issued Red Alert for May 26 forecasting heavy to very heavy rains. "Heavy to very heavy rainfall is very likely to occur at a few places over Balasore, Bhadrak, Jajpur, Kendrapara, Cuttack, Jagatsinghpur, Mavurbhani

and Keonjhar districts with extremely heavy rainfall at one or two places over Balasore, Bhadrak, Kendrapara and Mayurbhanj districts," the department said in its forecast for May 26.

Meanwhile, the Special Relief Commissioner (SRC) Pradeep Jena vis-

ited Balasore and Bhadrak to review the situation and claimed that the vulnerable northern coastal states of Odisha were prepared to counter the cyclone Yaas.

The SRC directed the officials to shift people staying in thatched huts and houses along the coast and makeshift dwellings to the 18 cyclone shelters and 29 schools in Balasore.

The district administration has targeted evacuating 8,540 persons from Bahanaga block alone. Elaborate arrangements have been made to ensure that coronavirus infection does not spread among the evacuees. For this purpose, sufficient number of masks and enough sanitisers have been stocked in the cyclone shelters.

The schools and shelters are being regularly sanitized, while special arrangements have been made to supply dry and cooked food at the cyclone shelters.

The state Panchayati Raj and Urban Development Minister, Pratap Jena also reviewed the situation in the vulnerable districts of Odisha. He asked the urban local bodies and panchayati raj institutions to be prepared to handle the emergency situation and plan well in advance for shelter homes and evacuation before and during the cvclone.

DGP reviews cyclone preparedness

BHUBANESWAR: The Director General of Police Abhav Sunday reviewed the preparedness of the police in the costal districts of the state ahead of the impending cyclone Yaas. The DGP discussed the steps taken by the district police officials in connection with the evacuation process, safety and relief measures to be taken before and after the cyclone through a video conference at the DGP camp office here. The Superintendents of Police (SPs) of Balasore, Bhadrak, Jagatsingpur, Puri, Kendrapada, Ganjam and Berhampur districts along with all the range DIGs participated in the virtual video meeting. The DGP also held discussions with ADGPs of Communication and Marine police. "Preparedness for evacuation and pre-cyclone actions, as well as post-cyclone relief and rescue were reviewed in detail. Sixty formations of ODRAF have been mobilised and equipped with high-end equipment to effectively undertake rescue and recovery work," the state police stated in its press note.

New Delhi, May 23: There is a broad consensus among states about conducting Class XII board exams and an "informed, collaborative" decision will be taken by June 1, Union Education Minister Ramesh Pokhriyal 'Nishank' said Sunday.

However, states like Maharashtra said at a highlevel meeting Sunday that "non-examination route" for Class XII students should be actively examined and Delhi and Kerala governments suggested vaccinating students before the exams. According to sources, the CBSE has proposed conducting exams between July 15 and August

STATE RECORDS HIGHEST SINGLE-DAY COVID (

Bhubaneswar, May 23: Odisha's Covid-19 tally mounted to 6,92,382 Sunday as the state reported its highest single-day spike of 12,852 new cases, despite undergoing lockdown for more than two weeks, a health department official said.

The state also registered 28 fresh Covid fatalities, the biggest one-day

1,909, followed by Cuttack (1,073), Angul (874), Sundergarh (848), Kalahandi (668), Mayurbhanj (586) and Balasore (508). The remaining cases were registered in several other districts.

Taking to Twitter, the Health and Family Welfare department said. "Regret to inform the demise of twenty-eight COVID positive patients while under treatment in hospitals." Five new fatalities were recorded

the state due to comorbidities. The state now has 1,11,862 active cases, while 5,77,983 patients have recovered from the disease.

The state has so far conducted over 1.13 crore sample tests for Covid-19, including 67,156 on Saturday, and the positivity ratio stands at 6.12 per cent.

Meanwhile, the state government has decided to create a designated "Paediatric Covid Wing" in health centres and hospitals where coronavirus patients are being treated.

Make party visible, desperate BJP to workers

New Delhi, May 23: The BJP has reminded its workers of the need to serve people in their moment of pain and struggle - and the need to be seen doing it. The party, wincing from criticism that its leaders were missing in action, especially during the second wave of the Covid pandemic, is now eveing course correction.

In a letter to all BJP-ruled states, party chief JP Nadda has said that all functions to mark seven years of the Narendra Modi government be avoided May 30. "Party workers should dedicate themselves in the service of the society," he recommended instead, saying people must be thanked for giving the BJP a chance to serve for seven years.

Party-ruled states will also launch a scheme on this occasion to help children orphaned during the pandemic, he said, the details of which will be circulated shortly.

"Standing by children who have lost both parents and providing them every support for their safe future is also our social responsibility...The idea is that all BJP-ruled states launch

the programme together when the BJP-led government at the Centre completes seven years," he said.

Its top leadership has also asked workers to arrange medicines, hospital beds, oxygen supplies in government hospitals-the country's medical system has suffered a severe paucity of these resources in recent months.

Nadda has spoken to the party's 317 MPs in the past four days to mobilise activities on this front. His letter today reminded BJP workers of its motto, 'Seva Hi Sangathan' (Service is organisation).

The party has in the recent past faced severe criticism as its leaders were perceived to be missing in helping people hit by the pandemic. This is in contrast with last year when, during the migrant crisis, its workers were seen arranging food packets and other facilities at a mass level.

Party sources said that since it is the world's largest political outfit, its workers must be 'seen helping those in distress'. Several MLAs in Uttar Pradesh, meanwhile, have complained about the administration ignoring them, leaving them unable to help the needy.

12th fuel price hike in 19 days

New Delhi, May 23: After a day's relief, petrol and diesel prices increased again Sunday. With an increase of 17 paise, the price of petrol price in Delhi has gone up to ₹93.21 per litre. On the other hand, the price of diesel in the national capital went up by 27 paise to ₹84.07 per litre.

However, Sunday's hike is lower than the increase Friday when the price of petrol went up by 19 paise and the price of diesel increased by 29 paise.

The state-run Oil Marketing Companies (OMCs) have hiked the prices of petrol and diesel 12 times since May 4 with fuel prices reaching a record high May 21. Petrol has become costlier by ₹3.24 per litre while diesel has become more expensive by ₹2.94 per litre this month.

After Sunday's hike, the price of petrol inched closer to ₹100 mark in the financial capital, Mumbai. With petrol retailing at ₹99.49 per litre and diesel trading at ₹91.30 per litre, fuel rates in Mumbai remain the highest among the metro cities.

Other than that, fuel prices have already breached ₹100 mark in Rajasthan and Madhya Pradesh. Last week, Bhopal became the first state capital where people spent more than ₹100 for one litre of petrol, whereas in Jaipur, the price of petrol and diesel stands at ₹99.68 per litre and ₹92.78 per litre respectively. Fuel prices in Sri Ganganagar district of Rajasthan remain the highest in the country with a litre of petrol available at-

US considered nuclear strike on China over Taiwan in 1958

Former military analyst Ellsberg posted online the classified portion of a top-secret document on the crisis that had been partially declassified in 1975

Washington, May 23: US military planners pushed for nuclear strikes on mainland China in 1958 to protect Taiwan from an invasion by Communist forces, classified documents posted online by Daniel Ellsberg of "Pentagon Papers" fame show.

US planners also assumed that the Soviet Union would aid China and retaliate with nuclear weapons - a price they deemed worth paying to protect Taiwan, according to the document, first reported by the New York Times.

Former military analyst Ellsberg posted online the classified portion of a top-secret document on the crisis that had been only partially declassified in 1975.

Ellsberg, now 90, is famous for his 1971 leak to US media of a top-secret Pentagon study on the Vietnam War known as the Pentagon Papers. Ellsberg told the Times that he copied

the top-secret Taiwan crisis study in the early 1970s, and is releasing it as tensions mount between the United States and China over Taiwan.

Had an invasion taken place, General Nathan Twining, the chairman of the Joint Chiefs of Staff at the time, "made it clear that the United States would have used nuclear weapons against Chinese air bases to prevent a successful air interdiction campaign," the document's authors wrote.

If this did not stop an invasion, then there was "no alternative but to conduct nuclear strikes deep into



China as far north as Shanghai," the document said, paraphrasing Twining. In the event, US President Dwight D Eisenhower decided to rely ini-

tially on conventional weapons. The 1958 crisis ended when Communist forces halted artillery strikes on islands controlled by Taiwan, leaving the area under the control of Nationalist

forces under Chiang Kai-shek. China considers Taiwan to be a

rebel province that will one day return to the mainland's fold, by force if necessarv

Washington has recognised Beijing since 1979, but maintains relations with Taipei and is its most important military ally.

Tensions remain high

In recent months the Chinese air force has increased incursions into Taiwan's air defense identification zone. The United States also frequently conducts what it calls "freedom of navigation" operations in the flashpoint Taiwan Strait waterway.

US President Joe Biden is expected to announce his strategy toward China soon, and calls are growing for him to make a clear public commitment to defend Taiwan militarily. A US law requires Washington to help the island defend itself in the event of a conflict, but the United States has pursued a policy of "strategic ambiguity" for decades, refraining from clearly stating what circumstances would lead it to intervene militarily on Taiwan's behalf.

Bhubaneswar; May 23: Panchayati Raj and Drinking Water, and Housing and Urban Development Minister Pratap Jena Sunday directed officials to identify and motivate the vulnerable households and ensure their timely evacuation ahead of cyclone 'Yaas' that is expected to make a landfall on the eastern coast May 26

While reviewing the cyclone preparedness of the departments through videoconference, Jena asked the Urban Local Bodies (ULBs) and Panchayati Raj institutions to have alternative shelters and evacuation plans along with provision of adequate food stuff for the affected.

The Minister directed the municipal commissioners and executive officers to remain alert so as to mitigate the effects of the tropical cyclone as well as subsequent heavy rain-induced flood-like situation.

The Minister directed the officials to ensure that supply of power and drinking water are not affected in the ULBs, especially in 56 ULBs including Cuttack Municipal Corporation and Bhubaneswar Municipal Corporation of 12 costal districts. This apart, special care to elderly, differently-abled, children, pregnant as well as lactating mothers

Mishra for steady power supply to hospitals

Bhubaneswar, May 23: Energy Minister Dibya Shankar Mishra Sunday asked the officials of the department to make all arrangements to face impending cyclone Yaas.

The minister put emphasis on steady power supply to hospitals and oxygen plants during the cyclone and its immediate aftermath. He asked the officials to arrange adequate manpower and equipment to restore power supply in the aftermath of the cyclone.

Mishra stressed on the use of equipment like pole master, crane, power saw and hydraulic trolley in the restoration work. He advocated for minimum use of manpower to check the spread of Covid-19.

"Equipment should be stationed at strategic positions to carry out the restoration work," said the minister.

He also directed the CEOs of DISCOMs and OPTCL to position adequate stocks of materials at tactical points for prompt mobilisation of the same for the restoration work.

"We have adequate stocks of essential drugs, dry food, fodder and other commodities. The district administration is ready to manage the situation. People who are in home isolation after being infected with coronavirus would be shifted to Covid care centres," said the collector.

government departments including police, fire brigade, health and water supply have been put on high alert to face the situation.

8 shops gutted in fire mishap

Bhubaneswar, May 23: As many as eight fruit and vegetable shops were gutted in a major fire at Pokhariput under Airfield police limits in the city here.

However, no casualties have been reported in the accident.

According to sources, one of the shops in the vending zones suddenly caught fire when some locals and vendors were busy in cooking for a feast Sunday morning.

The fire soon engulfed other shops in the vending zone. The fire services personnel

along with two fire tenders rushed to the spot after getting information at around 11am.

The officials took around 2 hours to douse the flames completely.

Sources claimed that properties worth over lakhs were destroyed in the mishap.

Utkal Hosp conducts rare knee surgery

Bhubaneswar, May 23: A team of orthopaedic doctors and others at Utkal Hospital, specialising in sports injuries and rehabilitation, performed a rare knee dislocation surgery.

The 18-year-old male patient from Puri was of short stature and had been suffering from dislocation of his knee bone for the last five years. Dr Dibya Singh, orthopaedic surgeon at Utkal Hospital and his team performed the surgery successfully.

"The patient came to us in a stressful condition where his knee bone was found to be dislocated. We conducted the MRI scanning and other tests and came to know that the ligament supporting his knee bone and the areas around the bone needed some reconstructing and interventions," said Dr Singh

According to the medical team. implantation of graft and some surgeries in the knee area were done to handle the ligament tear and other issues which were creating hurdles for the knee bone of the patient.

The hospital said that the surgeries were done through minimal invasive techniques. The patient was able to walk with support from the next day and his knee bending abilities improved manifolds after the surgery.

NO COVID VACCINATION IN BALASORE TODAY

Bhubaneswar, May 23: The State Health department Sunday said that there would be no Covid-19 vaccination drive in Balasore which is now under the looming threat of cyclone Yaas in the days to come. The district administration is busy preparing the area to face the natural disaster.

The State Health department Sunday was able to vaccinate only a total of 13,806 persons through 39 active sites out of which three were sites where Covaxin was given.

Meanwhile, the total vaccination coverage in the state crossed 70,000 Sunday with the total persons inoculated till now touching 70,20,353. Sunday the highest vaccination was given to people above 45 years where a total of 8321 persons in the segment received their first dose of the vaccine.

Meanwhile, a total of 5231 persons between 18 years to 44 years got their first dose of the vaccination Sunday. The department meanwhile has planned 799 sessions for vaccination Monday. The department said that till Sunday evening it was left with a total of 2,33,830 doses of Covishield and 3,37,560 doses of Covaxin, procured from the Union government for inocu-



lating persons against Covid-19. The department meanwhile Sunday had planned sessions only in Balasore, Puri, Cuttack,

Bhubaneswar and Sundargarh. The government said that out of the 3,34,929 registered health care workers, a total of 3,28,426 (98 percent) health care workers have received their first dose of their vaccination. It also said that while earlier a total of 2,24,220 persons were identified to be vaccinated, a total of 2,77,285 persons identified as frontline workers received their first dose of the vaccination.

Covid positivity rate constant: Govt MAS BHUDANESWAR MA

Bhubaneswar, May 23: The state Health department Sunday said that the positivity rate of Covid-19 in Odisha remained stagnant and there had been no major hike of the same in the past few days

Health Services Director Bijav Mohapatra said that the state government had recently increased the intensity of testing for the pandemic which had pushed the number of cases in the coastal state. The government official also tried to allay fear among the people on the issue.

He said, "Covid cases seem to be rising as we are conducting more tests these days. The Odisha government has now increased the number of testing everyday done to screen Covid positive persons from the coastal state. On Sunday, the positivity rate was 20. It was 19 Saturday."

He added, "It has been around that level now. The number of cases is proportional to the hiked number of testing done in the state. The positivity rate in the state has not increased and it has been more or less stagnant. We are hopeful

that we are going now in a stagnant phase.'

The health official also said that the state government has prepared adequate health infrastructure and mobilised persons to ensure tackling Covid-19 cases and also the threat of cyclone Yaas in the

coming few days. "As Bhubaneswar and Cuttack often see more migration of people it has seen a rise in positivity rate. We are also working in line with the government orders to ensure that we can tackle the Covid issues during the threat of cyclone Yaas," he

The state Health department has also issued advisories to the district Collectors so as to ensure testing of persons whom they plan to shift to shelter houses or other places during cyclone Yaas.

It has also asked the district administrations to mobilise the ambulance services, Rapid Response Teams and other emergency health service providers during the cyclone. Special instructions have been given to the district administrations to ensure Covid-19 appropriate protocols in evacuation and rehabilitation of the people.

Bhubaneswar, May 23: With the state government extending lockdown till May 31, the Bhubaneswar Municipal Corporation (BMC), Sunday, stated that it will continue feeding stray animals, including street dogs and bulls, during this period.

The civic authority here, which had been earlier involved in feeding stray animals during lockdown periods, stated that it will extend its initiative until complete normalcy is restored. It can be mentioned that the stray animals which are largely dependent on waste food from restaurants, hotels, meat shops and vegetable and fruit markets have been hit hard after lockdown imposed restrictions on all commercial activities.

"Under the feeding initiative, 7.5 quintal of cooked food is prepared daily at the Saheed Nagar Veterinary Clinic campus for distribution in the morning and afternoon hours, 3 quintal of cattle feed is distributed among the stray



bulls and cows across the city," a BMC official said.

"The canine food is prepared under the supervision of the veterinary experts at Saheed Nagar facility. While 5 quintal food is distributed between 8am to 10am in the morning, rest is given between 4pm and 6pm. The cooked food for dogs has ingredients like rice, dal and chicken pieces," he added.

Moreover, in a bid to make the food distribution process participatory and people-centric, the BMC has also engaged organisations involved in the field of animal welfare. As the food distribution for animals is zone-based, the civic authority has deployed 'People for Animal' in South East Zone, 'Alap' in North Zone and 'Rehabitat Foundation' in South West Zone respectively

While the food quality for stray animals is checked by the experts at the Sub-Divisional Veterinary Office of the Fisheries and Animal Resources Development Department, BMC provides logistics for the transportation of the cooked food and cattle feed to the various zones concerned.

However, it is learnt that while the stray animals in the residential zones are fed by the people, those roaming around markets and other public places are now facing a difficult time due to the lockdown. While the move to extend the feeding of stray animals was welcomed by many, a few were of the opinion that people should take individual responsibility in order to help the strays.

It can be mentioned that the civic authority had begun the process of feeding stray animals after the state government in a letter had instructed all Urban Local Bodies to provide food for the animals.

Rise in illegal firearms trade in twin city

cities of Cuttack and Bhubaneswar have gradually turned into a thriving market for illegal firearms. The recent seizure of firearms in

the city. They are using fake ID cards to dodge police on vigil at the check points. The Special Task Force (STF) of state Crime Branch Saturday arrested a history-sheeter and seized firearms in his possession at Acharva Vihar here.

According to available data, around 1000 criminals engaged in firearms trade have been arrested by the Commissionerate Police during the last 15 years. There were 36 cases related to seizure of illegal firearms reported in 2007 while the number of similar cases rose to 128 in 2016 149 cases each were registered in both 2014 and 2015 years involving illegal firearm seizure. The registration of such cases started declining after 2016. Sources claimed the major reason behind the decline was the special drive 'Black Smoke' launched

by Commissionerate Police under its Quick Action Team (QAT) in 2014. However, the QAT had seized 93 firearms and 249 live ammunitions during 2014. In 2015, 63 fire arms and 162 live ammunitions had been seized by the QAT. The cops managed to seize 89 firearms and 212 ammunitions during 2016 under Black Smoke. The QAT got embroiled in various controversies and has turned inactive since long. The twin city recently witnessed a significant rise in the illegal trade of arms during the last couple of years.

IMMEDIATE INTERVENTION WAS DEMANDED TO STOP SPREAD OF COVID AMONG DONGRIAS IN NIYAMGIRI AND BONDAS IN MALKANGIRI

Bhubaneswar, May 23: In the matter of immediate intervention into the issue of spread of Covid among Dongrias in Niyamgiri and Bondas in Malkangiri, several social activists wrote letter to Chief Minister Naveen Patnaik suggesting steps to be taken to protect the Dongria and Bonda communities from becoming victims of Covid pandemic.

In the letter the activists said, "It is with great concern we write to you about the recent surge of Covid cases amongst the Dongria Kandha and Bonda communities in Odisha. These two tribal communities are very vulnerable to being affected by the spread of the Covid virus. Lingaraj Azad, social activist and member of Niyamgiri Surakshya Samiti said home quarantine as a Covid protocol being suggested by the government in other places will not work within Adivasi communities because of different



ideas about privacy and isolation in Adivasi cultures. Home quarantine within Adivasi areas is not the right way to contain the spread of the virus or in breaking the chain of pandemic

The government should take special and adequate community measures to protect the life of Dongria and Bonda communities from becoming victims of Covid pandemic. They suggested that the government should run different guarantine centres exclusively for Adivasi people and have separate centres for suspected and confirmed Covid cases funded by the public exchequer near (within 2 kms) Dongria and Bonda settle-

They also suggested door to door surveys must be done by a team of trained local volunteers from villages for regular monitoring of symptoms and reporting to quarantine centres for any suspected cases.

All the Dongria and Bonda families must be provided with a special livelihood relief package as compensation for their agriculture and minor forest produce (MFP) which they cannot sell in the haats/local markets which are non-functional due to prolonged shutdown/lockdown. All the residents of the entire area should be distributed adequate 3 layered masks with PPE kits, necessary medicines and vitamins

ODISHA SENDS 20,007 MT **OXYGEN TO NEEDY STATES**

Cuttack, May 23: Odisha has sent 1.091 tankers with 20.007.336 MT of medical oxygen under strict supervision of the state police to at least 15 states facing acute shortage of the life-saving gas over the last 31 days, an official said Sunday.

As many as 100 tankers were dispatched from Angul with 1611.582 MT of oxygen, 265 tankers from Dhenkanal with 4269.5 MT of the life-saving gas, 252 containers from Jaipur with 5166.327 MT of the gas and 474 tankers from Rourkela with 8959.927 MT of the medical grade oxygen, according to data shared by the Odisha Police headquarters here.

While 340 tankers with 6693.074 MT of oxygen have so far been sent to Andhra Pradesh, Telangana received 4744.049 MT of oxygen sent through 278 tankers.



Tamil Nadu, on the other hand, received 78 tankers filled with 1382.667 MT of medical oxygen. Haryana has received 149 tankers

filled with 2753.233 MT of oxygen. As many as 41 tankers with 660.051 MT of oxygen have so far been sent to Maharashtra. Similarly, 598.35 MT of oxygen filled in 37 tankers have been dispatched to Chhattisgarh. While 58 tankers carried 1154.892 MT of oxygen to Uttar Pradesh, 65 tankers with 1147.76 MT of oxygen have been

sent to Madhya Pradesh As many as 22 tankers with 410.24MT of oxygen have been sent to Delhi, an official pointed out.

bility in the ecosystem. He threw light on the exploitation of biodiversity in underdeveloped countries on the plea of achieving development.

Behera suggested that the information related to biodiversity should be converted into knowledge and then to wisdom. The spread of wisdom will protect and promote nature, he said.

"If biodiversity decimation is a crisis, it can be solved by 3 'As'--attitude, action and awareness. We all should be part of the solution for nature for our survival," he added.

Principal-ESG at National Investment and Infrastructure Fund (NIIF), New Delhi, Ashok Emani, emphasised on the materiality of the biodiversity in ecosystem and its application to protect ecological balance.

He said that though India is one of the 17 mega-diverse countries in the world, biodiversity and ecosystem issues are very often over-



looked in traditional materiality calculations. He gave the value of biodiversity in economic terms for the Himalayan region.

Emani highlighted the economic importance of rich biodiversity of Eastern Ghats and Deomali as well as Similipal Tiger Reserve of Odisha. He claimed that the students of biodiversity have a lot of op-

1 killed in clash over land dispute

Padmapur, May 23: A person who was critically wounded Tuesday last in a clash between two families over land dispute at Karanjadia village under Basudevpur block in Bhadrak district, died Sunday at a hospital. The deceased was identified as Babaji Siala.

According to reports, the land dispute between the families of Rabi Siala and Gouranga Behera (a res ident of the same village) took an ugly turn May 18. Babaji was at tacked by Gouranga and three others for supporting Rabi. He suffered grievous injuries and was admitted to SCB Medical College and Hospital in Cuttack. However, he failed to respond to treatment and breathed his last Sunday

Following a complaint from Rabi, Nayakanidihi police have registered a case of murder against Gouranga Behera, Debendra Behera, Laxmidhar Behera and Ghanshyam Behera. Investigating Officer Dillip Kumar Dehuri said that Laxmidhar was arrested while the three others are absconding.

Paradip, May 23: Thirteen persons fell ill after inhaling ammonia gas which reportedly leaked from a prawn processing plant situated close to an ice factory at Paradip Garh Industrial Complex on the outskirts of this port town Sunday. Among those who fell ill, there were three women

Lock police station officials and sarpanch Mihir Sahu of Paradip Garh panchayat rescued those who had fallen ill took them to the Biju Memorial hospital here for treatment. Later, the critical persons were shifted to the SCB Medical College and Hospital in Cuttack while the rest were discharged after primary treatment.

ADM Kanhu Charan Dhir and ASP Nimain Sethy and Lock police station officials reached the spot and engaged technicians and

experts from two fertiliser plants to assist in the efforts to contain the leak. The ADM also ordered the shutdown of the prawn plant with immediate effect and directed Assistant Director of Factories and Boilers, Chandrakant Dalei to conduct a probe into the gas leak.

Speaking about the mishap, Dalei said, that the incident occurred after a hose pipe burst at the 'Laxmi Narayan Exports Prawn Processing' plant in Paradip Garh. It led to the leak of the ammonia gas.

The plant had restarted operations from May 1 after being closed for a lengthy period, informed Dalei. The people working in the plant came in contact with the gas and fell sick. Dalei informed that legal action will be taken against the errant plant owner. Efforts to contact the plant owner over phone failed as he did not respond to calls.

Vaccine Mess

THE MOTHER

rime Minister Narendra Modi continues to blame states and government officials for the Centre's utter failure to provide vaccines for people against COVID-19. While the states have been left in the lurch, whether it be procurement of vaccines or oxygen and medicines for citizens, the pandemic is tightening its grip on the country. The history of the Modi government has always been to deflect blame in matters of policy and welfare. In the case of vaccines, the missteps have been very evident and clear. India has always had a precedence of the Centre sourcing and providing vaccines for citizens. This has been the case for Polio, Small Pox and all other vaccines that are administered on a regular and continuous basis. There have never been any major hurdles in disbursement and distribution to various states in this tried and tested method. This is probably the first time the process has been altered and a completely new method is being tried, that too during the biggest pandemic the world has seen in recent times. The new method is putting the responsibility of procurement and distribution of vaccines squarely in the hands of the state governments. The major issue with this process is that state governments do not have the resources or the clout to outbid other countries and each other to snag vaccine deals from major producers. At a time when countries, including India, are failing to sign deals in the race to vaccinate their populace at the earliest, expecting state governments to participate and win in the international level tug of war is not only impractical, it is outright cruel. In the process, the Centre has completely abdicated its responsibilities and left the citizens helpless and to fend for themselves in one of the most critical times. A

pointed example of the helplessness of the states can be taken from Punjab, which is buckling under the pressures of the second wave, like most other states. The Punjab government has stated that it had independently reached out to various vaccine manufacturers including Pfizer, Johnson and Johnson, Sputnik V and Moderna. Out of these, only Moderna responded, refusing to provide vaccines directly to Punjab, say-



ing according to its official policy, it will only deal with the Government of India. Most other manufacturers would probably have similar policies. It may be noted that Punjab has been forced to stop vaccination due to non-availability of vaccines

At such a juncture, the Prime Minister has been making video conferences with district magistrates to issue sermons to them to ensure, among other things, there is no wastage of vaccines. This is presuming as if there is enough availability of vaccines and the state administration is failing to plug wastage. Nothing can be further from the truth. The government has no answer to the barrage of criticism from the judiciary, several states and international media.

Whatever falsehood the BJP-led government at the Centre has been relying on to save its skin fell flat with the damning disclosure on May 21 by the executive director of the Pune-based Serum Institute of India (SII). Suresh Yadav, producing the high in demand Covishield vaccines in India. Yadav squarely blamed the Centre for the country's vaccine shortage. He claimed the government did not take into account the available stock of vaccines and ignored World Health Organization (WHO) guidelines while rolling out inoculation phases. Initially, 300 million people were to be administered the vaccine for which 600 million doses were required. But, before the target could be reached, the government opened vaccination for all above 45 years, quickly followed by those aged 18 plus despite knowing very well that the required number of vaccine doses would not be available. A good example of successful vaccine rollout can be seen in many European nations. Take for example the UK. India, on the other hand, has already declared vaccines for all above the age of 18. The announcement has been made by the Central government and not by states. This has resulted in a huge rush for vaccines, bottlenecks created at every level, jamming of ill functioning websites needed to book slots and basically resulted in chaos. This shows the utter carelessness and miscalculation on the part of the government at Centre. The urge of the Modi government to build image without backup action has taken a heavy toll on the nation. The pandemic has taken a death grip on India in the so-called second wave, taking millions of lives and wreaking many families. Another sad post script

ENEMY IS CLEARLY VISIBLE

The cataclysmic second wave of the pandemic in India has triggered global concerns about the horrifying human tragedy unfolding across the country that has decimated the lives and livelihoods of many people. The death toll is continuously rising alarmingly and has sparked a sense of consternation, trepidation, and dystopian nightmare. The situation is graver as India may have undercounted deaths by at least 4.3 lakh as per a new analysis from the University of Washington Institute.

The medical response to quell and tame the virus is encumbered by our dilapidated health infrastructure, inefficiency, dysfunction, and acute shortage of healthcare delivery systems. The world is fanatical on the shocking images and heartrending, poignant stories of hopelessness flowing out of India - people struggling to find hospital beds, dying on pavements, in ambulance from scarcity of oxygen or not being able to procure life-saving drugs.

The melancholy image of the flames rising from the mass funerals in cremation grounds, queues in graveyards and crematoriums are found on the front pages of national and international newspapers. What is reprehensible is that there was no dignity in death for some Covid patients who succumbed to the infection. Unattended for several days, thousands of bodies have been found, some either floating in Ganga and Yamuna or buried along their banks, in Uttar Pradesh, Bihar and Madhya Pradesh.

All major foreign newspapers and TV channels have unanimously made scathing criticism on the Modi government's gross carelessness and utter ineptitude in ignoring warnings, holding an extended election in West Bengal, and not cancelling the Kumbh Mela. On 12 May 2021, a World Health Organisation (WHO) panel said the world could have prevented the catastrophe. It linked the surge in coronavirus cases in India to religious and political gatherings. Top journal, The Lancet, called it a 'self-inflicted catastrophe'.

According to an APU survey, globally, Covid relief cash transfers have amounted to 32 per cent of monthly per capita GDP. But India's total transfer of Rs 1,500 amounted to a mere 12 per cent of the month's GDP per capita which is approximately Rs 13,000. There is no enhancement on health expenditure. The government should remember that a nation cannot prosper by hiding its failures or by comparing its abysmal performance with the worst performance of any previous regimes or that of any nation.

Nepenthes

Anepenthes (you will note the word is singular) is a drug or potion Athat brings welcome forgetfulness of bad memories. It appears in Homer's Odyssey, in which it was the name of the drug that Paris gave to Helen after he had abducted her to make her forget her old home. It's from classical Greek nepenthes (pharmakon), "anti-sorrow drug", where the first word is made up from ne-, not, plus penthos grief. (The second word is the root of English words such as pharmaceutical.) Expert plantspeople probably know it best as the botanical name for a genus of tropical carnivorous pitcher plants. As the pitcher plants contain liquid in which the captured insects drown, the botanical name would seem appropriate, though in this case any forgetting is terminal. Some writers have suggested Homer's potion was opium. This is one old receipe, which should be enough to make anybody forget anything: Take of tincture of Opium made first with distilled Vinegar, then with spirit of Wine, Saffron extracted in spirit of Wine, of each an ounce, salt of Pearl and Coral, of each half an ounce, tincture of species Diambræ seven drams, Ambergris one dram: bring them into the form of Pills by the gentle heat of a bath (The Complete Herbal, by Nicholas Culpeper, 1653). The word has commonly appeared as nepenthe, lacking its final letter: "Quaff, oh quaff this kind nepenthe and forget this lost Lenore!" Quoth the raven, "Nevermore" (The Raven, by Edgar Allan Poe, 1845). This is a more recent example: He was scarcely conscious of her now, for this utterly soft end of a hard day was as soporific as the fabled nepenthe and he could feel himself slipping away, as though his fingertips were relaxing from the edge of the cliff of harsh reality in order that he might drop-drop-through the soft clouds of gathering sleep into the slowly swaying ocean of dreams (The Robots of Dawn, by Isaac Asimov, 1983). It would make a wonderful name for some spirituous drink and indeed the owner of an Australian winery has called his enterprise Nepenthe.

he coronavirus pandemic has inflicted miseries on the entire world population. India has witnessed massive migrations from urban to semiurban and rural areas mainly due to unemployment for certain populations and the luxury of work from home (WFH) for the rest. The purpose of this article is to

highlight the effectiveness of the WFH system of working adopted by most IT sector firms as well as those in other sectors in addressing the typical problem of urban congestion of the primary metropolitan areas in India. Many governments have failed to tackle this efficiently due to the employment generating capabilities of the urban areas

Before the first lockdown came into effect and all offices shut down in a week's notice, the idea of a remote workplace was unthinkable for many MDs and CEOs. The basic thought behind it being the Indian environment doesn't support a remote workplace policy. But with extended lockdown in the country, the entire IT industry was forced to adopt a full scale WFH model of working. Advancement in optical fibre and emergence of local service providers during lockdown have paved the way for a digitally connected India with higher broadband speeds achieved even in Tier-3 cities. With some minor disruptions in the initial months, the entire setup was ready for a decentralised and distributed workforce in the IT industry. The communication infrastructure build-up in semi-urban and rural areas during the first phase of the pandemic has eliminated problems with internet speed and connectivity which are the heart and lungs of the IT infrastructure.

India witnessed urban migration of the masses in the early 21st century. Most of this could be attributed to the expansion of the IT industry. This is evident by the rise of Hyderabad and Bangalore as new metropolises of India. At present, Bangalore is the third largest urban agglomeration in India.

Rapid urbanisation has been a pressing issue for the past few decades. The population density of megacities is somewhere around 5-10 times of Tier-2 cities. This rising population leads to class divide and economic difference between two areas of the same cities. The crux of the first wave of the pandemic was borne by these

urban areas. Drainage and waste management are already a problem for municipal corporations. Unhygienic conditions have made them breeding centres for diseases such as dengue and malaria. Lack of ample healthcare facilities by the government has made the economically backward population stand in long queues for medical consultations.

The government has always overlooked the urbanisation issue over its revenue generation abilities and the depiction of growth to the world. Steps taken to decongest urban settlements only included building satellite cities in the suburbs. Although it is successful in developing infrastructure, it leads to traffic-induced pollution due to increased travel time to office. Even if some IT companies are crawling up in Tier-2 cities, most people refrain themselves from shifting places due to limited professional growth opportunities.

The pandemic-induced status quo will be a positive reinforcement on the environment as well as the available resources for the metro cities which experience substantial waste and water management issues. Immediate relief as already wit-

Some auxiliary benefits would also include better urban planning capacities and rationalisation of real estate prices which were pushing through the roof. Mucormycosis epidemic

Sir, Apropos the news item "India reports 8,848 mucormycosis cases", Orissa Post, May 23, government experts have attributed black fungus epidemic to a combination of Covid, diabetes and irrational steroid use that suppresses immunity. But rheumatology head of AIIMS, New Delhi, says, doctors had been using steroids routinely in rheumatology patients, but they had never seen such high cases of mucormycosis. On the other hand, experts claim unhygienic delivery of oxygen to patients was the root cause. Medical oxygen as opposed to industrial oxygen was highly purified, undergoes a range of processes such as compression, filtration and purification. Even its cylinders undergo disinfection and cleanliness processes. Meanwhile, the first study by Indian researchers on the spread of mucormycosis published in international journal Elsevier found overall 101 cases of mucormycosis in Covid patients worldwide - 82 from India and 19 from the rest of the world. Do all these observations point to a possible role of unclean delivery of industrial oxygen for Covid treatment - that resulted in surge of black fungus in India? N Sadhasiva Reddy, BANGALORE

Death of teachers in UP: Priyanka demands ₹1cr compensation, job for kin

New Delhi, May 23: Slamming the Yogi Adityanath dispensation over the death of teachers and workers who were on panchavat poll duty, Congress leader Priyanka Gandhi Vadra Sunday demanded that the Uttar Pradesh government give Rs1 crore compensation each to the next of kin of the deceased and employment to one dependent from the bereaved family.

Attacking the government, Priyanka Gandhi said, "1,621 teachers who have died during the panchayat election duty should not fall prey to the government's callousness." They fulfilled their responsibilities towards their duty, the Congress general secretary asserted.

"Now, the UP government should not indulge in a cover-up and should give compensation of Rs 1 crore to the families of all the deceased teachers, workers, and give a job to a dependent from the bereaved family," she said.

That will be the real tribute to them, Priyanka Gandhi said in a tweet in Hindi, using the hashtag 'Nyay4ElectionWorkers'. Last week, Uttar Pradesh

Prathmik Shikshak Sangh president Dinesh Chandra Sharma had said that 1.621 teachers and workers of the Basic Education

Department have died since the first week of April following the outbreak of the second wave of COVID-19. Of these 1,621 deaths, more than

90 per cent of the teachers were on panchayat election duty, he had said, while also demanding Rs 1 crore to be paid to the kin of deceased teachers and workers as fi nancial assistance.

However, Satish Chandra Dwivedi, the UP minister of state (independent charge) for basic education, had said that all these deaths cannot be attributed to elections and according to government data. only three teachers died due to Covid. Earlier Sunday, in a Facebook post, Priyanka Gandhi cited a media report to allege that the brother of the UP minister of state (independent charge) for basic education got an appointment as an

assistant professor, "posing as poor". "In this crisis, the ministers of the UP government are absent in helping the common people but are eager in grabbing 'opportunity in disaster'," she alleged.

In Parsaul village, about 60 km (40 miles) from the capital New Delhi, villager Ashok said people in his area were afraid to step out of their houses. He suspects that coronavirus had killed around 15 people nearby in recent days.

Ashok has come with a patient who had fever to the clinic run by a 52-year-old former hospital assistant who moves from one cot to another to check IV levels. Empty intravenous drips lie piled up under a brick-walled staircase

"Patients with fever and breathing problems have increased in the last two months," said the former assistant, who said he had been helping patients at his clinic since 1993 but did not wish to be identified as he feared a backlash

seven villages know me personally and trust me." Some patients wore face masks

lying on cots, while others had their faces covered with clothing.

Last year, almost 17 districts in Uttar Pradesh were put on alert after the locust swarms which travelled from Pakistan invaded India

and made their way to at least five states, leaving a trail of destruction.

According to District Agriculture Officer Vinod Kumar Singh, on the basis of the advisory issued by UN's Food and Agricultural Organization (FAO), Rajasthan has sounded an alert for a possible locust attack and directed authorities to plan, coordinate and execute a strategy to repulse it. Following this, the Uttar Pradesh government has issued directions to be fully prepared and ensure a timely response to tackle an infestation of the short-horned grasshoppers.

New Delhi, May 23: As India grapples with alarmingly rising cases of the Black Fungus (Mucormycosis disease) after battling severe oxygen shortage amidst the second wave of the pandemic, the heath fraternity is now concerned with White Fungus which is being reported among Covid-recovered patients who are on longterm steroid use and suffer from severe uncontrolled diabetes, among other conditions.

White Fungus has generally been seen in immuno-compromised people like those on chemotherapy or undergoing bone marrow transplant.

Covid-19 itself is a condition which predisposes body to other added infections via use of highdose steroids, broad spectrum antibiotics, monoclonal antibodies and industrial oxygen, which can carry mucor during non-sterilised

equipment for humidification. Now, a case of White Fungus has been found in a Covid-recovered patient from Mau district in Uttar Pradesh, and the health fraternity fear that many such cases are going unreported

'White Fungus usually referred as to infection from Candidiasis. It is usually seen as an opportunistic infection among immunocompromised host such as patients with HIV, on anti-cancer therapy, on long-term steroid use or severe uncontrolled diabetes," said Harshal

'Diabetes may increase risk of mucormycosis'

Since the early days of the coronavirus pandemic, patients with diabetes have been in the spotlight for their increased risk of severe Covid-19 outcomes. Now health experts say diabetes, coupled with Covid, may be the reason for the sudden spike in mucormycosis or 'black fungus' infections in the country. India is known as the world's diabetes capital. Nearly one in six people with diabetes in the world is from India. Available scientific literature reveals that

diabetes damages the pancreatic beta cells and leads to insufficient insulin production, resulting in hyperglycemia -- a condition which causes dysfunction of the immune response.

R. Salve, Associate Professor at the Centre for Community Medicine, AIIMS, New Delhi.

According to Pratibha Dogra, senior pulmonologist from W Pratiksha Hospital in Gurugram, first signs or symptoms could be severe headache and pain in the sinus area, blackish growth or discharge from nose.

"Diagnosis is simple through routine microscopic sample of mucor growth. If not diagnosed early, it has mortality of over 50 per cent," she said.

The opposition leaders said that May 12, they had jointly written to Prime Minister Narendra Modi demanding the "repeal of farm laws to protect lakhs of our 'annadatas' becoming victims of the pandemic so that they can continue to produce food to feed the Indian people".

"We demand the immediate repeal of the farm laws and the legal entitlement to the Minimum Support Price (MSP) of C2+50 per cent as recommended by the Swaminathan Commission," they said. The three farm laws were passed by the parliament in September last and were later made a law after presidential assent. The farmers have been protesting at Singhu and Tikri borders with Haryana, Ghazipur border with Uttar Pradesh and other places.

Moderna refuses to send jabs to Pb

Chandigarh, May 23: US-based Covid-19 vaccine manufacturer Moderna has refused to send vaccines directly to the Punjab government stating that it only deals with the Centre, a senior state official said Sunday



Punjab's nodal officer for vaccination Vikas Garg said according to Chief Minister Amarinder Singh's directions, all vaccine manufacturers were approached for direct purchase of Covid vaccines including Sputnik V, Pfizer, Moderna, and Johnson & Johnson.

A reply was received only from Moderna wherein the company refused to deal with the state government, he said. According to Moderna's policy, it deals with the government of India and not with any state government or private parties, the Puniab government said in a statement. Earlier, CM Singh had directed officials to explore possibilities of floating a global tender for the procurement of vaccines from all possible sources to ensure that people of the state are vaccinated against Covid-19 at the earliest. Notably, Punjab was forced to stop vaccination for phase 1 and phase 2 categories because of the non-availability of vaccine doses.

BOY 'BEATEN TO DEATH' BY SECURITY PERSONNEL IN UNNAO

Unnao (UP), May 23: A home guard jawan accused of beating a 17-vear-old boy to death for violating the Covid lockdown in the Bangarmau area of Uttar Pradesh's Unnao has been arrested, police said Sunday.

Three persons - police constables Vijay Choudhury and Simavat and home guard jawan Satyaprakash -- were booked on the charge of murder for allegedly beating up the boy, a vegetable vendor; first outside his house in Bhatpuri and then at the police station Friday.

"One accused has been arrested, while efforts are on to nab the other two," Unnao Superintendent of Police (SP) Anand Kulkarni said in a statement. "The matter is being probed by the Crime Branch and they are collecting evidence. Action will be initiated against the guilty persons," he added. Police sources said the arrested person is home guard jawan Satyaprakash.

The police booked the three security personnel following a protest by the locals after the boy's death.

Sources in the state health department said according to the post-mortem report, head injuries above the right ear were the main reason behind the boy's death, while there were 13 injury marks on his back

The family members of the boy have alleged that he was beatenup at the police station in front of the inspector in-charge.

Women can get jab anytime after delivery: Experts

New Delhi, May 23: A woman can get vaccinated against COVID-19 anytime after the delivery of her baby, healthcare experts have said and stressed on the need to permit vaccination of even pregnant women to protect them from the infection.

The government recently allowed vaccination for lactating mothers. The NITI Aavog Member (Health) has stressed that there is no problem in breastfeeding after vaccination and it must not be halted "even for an hour".

Healthcare experts have also said that a woman can get vaccinated against Covid-19 anytime after the delivery of her baby.

Dr Khan Amir Maroof, Professor, Department of Community Medicine, University College of Medical Sciences and GTB Hospital, Delhi, said there is no risk to the



neonate from a vaccinated, breastfeeding mother. "There is no reason to delay the vaccination after delivery," he said. Further, he said, no specific precautions need to be taken by lactating women in view of vaccination and the same precautions which apply to the general population are applicable to them as well. Dr. Loveleena Nadir, senior consultant gynaecologist and obstetrician at Fortis La Femme, Rosewalk Hospital and Apollo Cradle Royale, said vaccination can also be done during any phase of menstrual cycle. "Covid-19 is not an indication

for caesarean delivery but there has been an increased frequency of pre-term births and caesarean deliveries, probably due to maternal illness associated with Covid-19 infection. If one has recovered from Covid infection, defer vaccination for 3 months from date of recovery," she said.

She further said that if a patient has taken the first dose and later turned out to be pregnant, they are advised to continue the pregnancy. "Pregnancy doesn't increase the risk of acquiring SARS-COV-2 infection but appears to worsen the clinical course as compared to non-pregnant women, she added. Experts have stressed on the need to vaccinate pregnant women to protect them from the infection. Maroof said the government guidelines has not yet recommended Covid-19 vaccination for pregnant women. "This is because the Covid

vaccine trials were not done on pregnant women and their safety and efficacy related data is not available. The Federation of Obstetric and Gynaecological Societies of India has, however, recommended that Covid vaccine should be given to pregnant women as the risk of getting infected with Covid and mortality is high during this pandemic," he said.

"This seems to be higher than the risk due to the side effects of the vaccine," he said.

Dr. Sujeet Ranjan, Executive Director of the Coalition for Food and Nutrition Security (CFNS), New Delhi, said WHO guidelines state that pregnant and lactating mothers can be vaccinated but in India, the matter regarding inoculation of pregnant women is under discussion and further deliberation by the National Technical Advisory Group on Immunization (NTAGI).

Cable car plunges to the ground killing at least 13

Rome, May 23: At least 13 people were killed and two children seriously injured Sunday after a cable car plunged into the side of a mountain in northern Italy, emergency services said.

The accident occurred by the resort town of Stresa, which lies on the shores of Lake Maggiore in the Piedmont region.

The 20-minute cable car ride, popular with tourists, links Stresa with the 1,500-metre summit of the Mottarone mountain, and offers spectacular views of the Alps.

An emergency services spokesman said thirteen people were killed and two children aged nine and five injured and taken by helicopter to a pediatric hospital in the city of Turin. The ministry of infrastructure said in a statement that the accident occurred around 12:30 pm as the cabin was about 100 metres from the summit.

Tehran, May 23: The Iranian Parliament Sunday called to limit cooperation with the International Atomic Energy Agency (IAEA), even though a resolution is in sight regarding talks with the US about ending sanctions linked to Tehran's nuclear programme.

"The IAEA had three months to fulfil its obligations, it did not do so and the deadline expired yesterday (Saturday)," Parliament Speaker Mohammad Bagher Ghalibaf said Sunday.

Accordingly, the UN agency should no longer have access to pictures of and information from Iran's nuclear facilities, dpa news agency quoted Ghalibaf as saying.

Under an interim agreement reached between Tehran and the IAEA at the end of February, full monitoring of Iran's nuclear facilities would only start when the 2015 Vienna nuclear deal was implemented, and US sanctions lifted.

Iran would continue to allow the agency to monitor, but not within the framework of the socalled IAEA Additional Protocol and, accordingly, only in a very limited way.

Ghalibaf's statements are seen by observers as part of an internal power struggle that has been going on for months ahead of the presidential election June 18.

The hardliners believe that an international agreement in the nuclear dispute before the election could harm their chances of victory.

Moderate forces around President Hassan Rouhani are pushing for a deal, as they say this could lead to an end to US sanctions. and the economic crisis that has lasted for more than two years.

Intensive negotiations between Iran and the five parties to the Vienna nuclear agreement have been going on in Vienna for more than a month.

According to Rouhani, an agreement is imminent.

Brussels, May 23: The European Union Sunday denounced a proposal by Myanmar's junta-appointed election commission to dissolve deposed leader Aung San Suu Kyi's party, the National League for Democracy (NLD), which overwhelmingly won the general election in November.

"If the Commission were to proceed with this proposal, it would show yet again the junta's blatant disregard for the will of Myanmar's people and for due legal process,' a spokeswoman of the EU's executive Commission said in a statement

Friday, media cited the chairman of the junta-appointed Union Election Commission (UEC), Thein Soe, as saying the panel would have to dissolve the NLD for committing vote fraud in the November election.

Myanmar's army seized power Feb 1, overthrowing and detaining the elected civilian leader Suu Kyi, who led a non-violent struggle against dictatorship in the last two decades of the military's 1962-2011 rule of Myanmar.

The military justified its coup by accusing the NLD of obtaining a landslide victory through a manipulated vote, though the electoral commission at that time rejected its complaints. The NLD says it won fairly.

The EU echoed the NLD's position, underscoring the party's victory had been confirmed by all independent domestic and international observers.

"No repression or unfounded pseudo-legal proceedings can grant legitimacy to the junta's illegal takeover of power," the spokeswoman for the EU Commission said.

"The EU will continue to denounce all attempts to overturn the will of the Myanmar people and -(to alter the outcome of the last general elections.

Dubai: The 2021 edition of the Asia Cup will now be held in 2023 due to a lack of window in a rejigged cricket calendar that is constantly subject to change amid an evolving Covid-19 situation. This year's continental tournament was moved from Pakistan to Sri Lanka but rising cases in the island nation had led to its cancellation. All the big four Asian sides have packed schedules until the end of the year. So finding a window for the tournament this year would have been extremely difficult, the Asian Cricket Council said. "We want an event with top teams, so we will have it in 2023," the ACC said.

Covid-19 outbreak on Mount Everest

Kathmandu: A coronavirus outbreak on Mount Everest has infected at least 100 climbers and support staff, an expert mountaineering guide said. It is the first comprehensive estimate amid official Nepalese denials that the disease has spread to the world's highest peak. Lukas Furtenbach of Austria, who last week became the only prominent outfitter to halt his Everest expedition due to virus fears, said Sunday one of his foreign guides and six Nepali Sherpa guides have tested positive. "I think with all the confirmed cases we know now, there are 100 people positive for Covid-19 in the base camp. Furtenbach said on his return to this city.

New Delhi, May 23: There was lingering disbelief and considerable disappointment as India's sports fraternity came to terms with Sushil Kumar's monumental fall from being one of India's greatest Olympians to an arrestee in a murder case. The stockily-built man, who used to be wrapped in the Tricolour after winning medals for India, had his face masked by a towel and both hands held by Delhi Police's special cell officers Sunday after being on the run since May 5. Ironically, all this unfolded on 'World Wrestling Day'.

Sushil has been remanded to police custody for six days. He had been evading a non-bailable warrant for his alleged involvement in the death of a 23-vear-old wrestler Sagar Dhankar during a brawl at the Chhatrasal Stadium.

Incidentally Sushil is the only Indian two win two Olympic medals - a bronze at Beijing (2008) and a silver at London (2012). He is also a three-time Commonwealth Games gold-winner.

"What he has done for Indian sports is something that can never be taken away from him. That's all I want to say at this point. Let things be clearer," said boxer Vijender Singh. Incidentally both Vijender and Sushil won medals at the Beijing Games.

21 killed during China marathon

Beijing, May 23: Twenty-one ultramarathon runners were killed in northwest China after high winds and freezing rain struck a 100-kilometre mountain race at the weekend. Extreme weather hit participants in the race Saturday at the Yellow River Stone Forest, the staterun 'Xinhua' news agency reported Sunday. Officials involved in the marathon confirmed the death toll at 21. A total of 172 people participated in the mountain marathon. The rescue work, which lasted

almost 24 hours, was completed Sunday. The remains of all 21 victims had been transferred from the site of the incident, the rescue headquarters said. The other 151 participants were confirmed safe, of whom eight with minor injuries were treated in hospital. There were in stable condition, the 'Xinhua' report said.

The public safety incident was caused by a sudden change in local weather. The provincial authorities have set up an investigation team to look into the cause of the incident, Zhang Xuchen, mayor of Baiyin City told the media.

According to the rescue staff, at about 1.00pm Saturday, hail, freezing rain and gales hit the area of the race's high-altitude stage, between 20km and 31km. Participants suffered from physical discomfort due to the sudden drop in air temperature. The race was halted when some participants went missing.

"At 1.00pm Saturday, the wind got stronger. It was hard to stand up straight and move forward. When the wind was the strongest, I had to grasp the ground with my hands to avoid being blown over," one survivor, who declined to be named, said. "I felt nothing but cold at the

time. I just ran about 30 km and quit the race. I the fainted," he added.
