Bhubaneswar, May 24: The India Meteorological Department Monday said cyclonic storm Yaas (pronounced as 'Yass') formed over east-central Bay of Bengal is likely to make landfall near Balasore May 26 noon as a very severe cyclonic storm.

As per the latest weather bulletin, the cyclone was moving north-northwestwards with a speed of about 12 kmph and lay centred at about 420 km south-southeast of Paradip, 510 km south-southeast of Balasore and 500 km south-southeast of Digha.

The very severe cyclonic storm is very likely to cross north Odisha-West Bengal coasts between Paradip and Sagar Island around Balasore during noon on the same day.

The windfall will be 155-165 kmph with gusting up to 185 kmph along and off West Bengal & north Odisha including Jagatsinghpur, Kendrapara, Bhadrak, Balasore during landfall.

Wind speed will be about 90-120 kmph gusting up to 145 kmph over Mayurbhanj district. Gale wind speed reaching 70-90 kmph gusting up to 100 kmph would also prevail over Puri, Cuttack, Khurda, Jajpur districts from early hours May 26.

Under its impact, heavy to very heavy rainfall would occur at a few places of Balasore, Bhadrak, Jajpur, Kendrapada, Jagatsinghpur, Cuttack, Puri, Khurda, Mayurbhanj, Dhenkanal and Ganjam districts Tuesday.

Bhadrak, Jajpur, Kendrapara, Jagatsinghpur, Cuttack, Mayurbhanj, Keonjhar, Dhenkanal, Angul, Deogarh, Khurda, Puri and Sundargarh are likely to experience heavy to extremely heavy downpour on the next day (May 26). Tidal waves of height 2-4 meters above astronomical tide are likely to inundate low-lying coastal areas of Balasore, Bhadrak, Kendrapara and Jagatsinghpur districts around the time of the landfall, the Met department said.

Local warning signal No 4 (LW-4) was hoisted at Paradip and Dhamra Ports while local cautionary signal No 3 (LC-3) was issued for Gopalpur and Puri ports. Considering the inputs given by the weather office, the state government is preparing for the possible landfall in Balasore or Bhadrak district,

Special Relief Commissioner (SRC) PK Jena told reporters.

A massive evacuation drive will be launched in all low-lying areas and vulnerable storm-surge pockets, following the IMD predicting a tidal surge of 2-4.5 meters during the landfall, Jena said. "The process of evacuation has already begun in the state and would be completed by Tuesday afternoon. The government is working in zero casualty approach," he said. About 6,500 pregnant women having delivery date before June 1 have been identified in vulnerable areas and all will be shifted to hospitals.

People residing in Kendrapara, Jagatsinghpur, Balasore, Bhadrak and Mayurbhanj will be evacuated to safer places, he said, adding, the Collectors

of sensitive districts have been in-structed to commence evacuation process keeping in mind the prevailing weather condition in their respective areas. The SRC also stressed strict adherence to Covid protocols at all cyclone centres. Anganwadi and ASHA workers will remain present in the cyclone centres due to Covid situation, he added. The state government has already deployed 53 teams of NDRF, 60 teams of ODRAF, 260 fire services personnel and 86 tree-cutting teams in the vulnerable districts.

Over 12,000 electricity restoration workers have also been deployed with required machines and equipment. All arrangements have been made to ensure that there is no disruption to manufacturing and transportation of medical oxygen to other states as well within the state. Meanwhile, the state government has allowed shops to operate from 7 am to 1 pm during Monday and Tuesday in 10 districts in order to give more time to people for buying essential items before the impact of the cyclonic storm Yaas.

These districts are Balasore, Bhadrak, Jagatsinghpur, Kendrapara, Mayurbhanj, Keonjhar, Puri, Jajpur, Cuttack and Khurda. Similarly, professionals, who will arrive in Odisha for cyclone management works, will not need to get RTPCR negative reports. Such officials won't need to go for 14-day quarantine. Over 10,000 persons have been evacuated and the process was going on at the time of going to the press.

State's daily Covid toll 32; tally tops 7L



Bhubaneswar. May 24: Odisha's COVID-19 caseload crossed the 7-lakh mark Monday with 11,059 more people testing positive for the infection, a health official said. The state also registered its highest singleday fatalities at 32, taking its

death toll to 2,516, he said. As many as 6,193 new Covid cases were reported in quarantine centres, while the remaining 4,866 infections were detected during contact tracing, he said. The fresh infections have pushed the state's coronavirus caseload to 7,03,441, the official said.

Cuttack district reported the highest number of fresh cases at 1,133 which was followed by Khurda (1,010) and Angul (859).

Of the 32 fresh fatalities, Khurda district, under which Bhubaneswar falls, reported the highest at six,



followed by four each in Ganjam and Jharsuguda and three each in Angul, Kalahandi and Sundargarh.

Fifty-three other COVID-19 patients have died due to comorbidities to date, he said. The state now has 1,11,262 active cases, while 5,89,610 people have recovered from the disease, including 11,059 Sunday.

Odisha has thus far tested

over 1.13 crore samples for COVID-19 including 66,512 on Sunday. The state's positivity rate now stands at 6.18 per cent, as per data released by the Health Department.


LEAVE CANCELLED

Besides, the housing and urban development department has deployed eight senior ORS officers Bhubaneswar to address the grievances relating to cyclone Yaas.

All arrangements have been made to ensure that there is no disruption to manufacturing and transportation of medical oxygen to other states as well within the state. The most vulnerable Balasore district has an 84-kilometerlong coastline and is covered by 10 police stations, including three marine police stations, DGP Abhay said.

The 136 villages in 26 gram panchayat areas near the coast in the low-lying areas have been identified for evacuation, he said. As many as 140 cyclone shelters and 1,102 alternative shelters have been readied to house the evacuated people in Balasore, the DGP said. The IMD forecast said that tidal waves of height 2-4 meters above astronomical tide are likely to inundate low-lying coastal areas of Balasore, Bhadrak, Kendrapara and Jagatsinghpur districts around the time of landfall.

EU to respond to Belarus diverting plane to nab scribe

Brussels, May 24: Angry European Union leaders were set to consider a joint response Monday to Belarus' diversion of a plane travelling between EU member nations in order to arrest a prominent Belarusian opposition journalist

Raman Pratasevich, who ran a popular messaging app that played a key role in helping organise massive protests against Belarus' authoritarian president, was on board the Ryanair flight from Athens, Greece, to Vilnius, Lithuania, when it was diverted to the Belarusian capital, Minsk while flying over Belarus.

Belarusian flight controllers had warned the plane crew of an alleged bomb threat and ordered it to land in Minsk, and a Belarusian fighter jet was scrambled to escort the Rvanair airliner.

Shortly after the landing, the 26-yearold Pratasevich and his Russian girl-

Lithuanian President Gitanas Nauseda on Sunday called the incident a "state-sponsored terror act" and amid united condemnation of Belarusian President Alexander Lukashenko.

EU foreign policy chief Josep Borrell called it "yet another blatant attempt by the Belarusian authorities to silence all opposition voices." He called the diversion of the plane an "inadmissible step" highlighting a further worsening in relations between both sides. US Secretary of State Antony Blinken called the incident "shocking" and accused the Belarusian government of endangering the lives of those aboard the aircraft, including some Americans. He called for the release of Pratasevich and for the Council of the International Civil Aviation Organization to review the incident.

Flight tracker sites indicated the plane was about 10 kilometers (six miles) from the Lithuanian border when it was diverted. "I saw this Belarusian guy with girlfriend sitting right behind us. He freaked out when the pilot said the plane is diverted to Minsk. He said there's death penalty awaiting him there," passenger Marius Rutkauskas said after the plane finally arrived in Vilnius.

"We sat for an hour after the landing. Then they started releasing passengers and took those two. We did not see them again." Pratasevich was a cofounder of the Telegram messaging app's Nexta channel, which played a prominent role in helping organize major protests against Belarus' President Alexander Lukashenko.

The Belarusian authorities have designated it as extremist and leveled charges of inciting riots against Pratasevich, who could face 15 years in prison if convicted.

Months of protests in Belarus were fueled by Lukashenko's election to a sixth presidential term in an August vote that the opposition denounced as rigged. More than 34,000 people have been arrested in Belarus since August, and thousands were brutally beaten. MORE P10







Bhubaneswar, May 24: With the state bracing for Cyclone Yaas which is likely to make landfall in Balasore district May 26. Chief Minister Naveen Patnaik Monday urged the people of the vulnerable areas to move to nearby cyclone shelters or pucca houses.

In a video message, Naveen said the state is facing twin challenges - Covid-19 and cyclone - and the government is well prepared to tackle both the disasters.

"Four-and-a-half crore people of Odisha are my family and their safety is my top priority. Our aim is to shift all the people to safer places. Therefore, I appeal to all to move to nearest cyclone centres or pucca houses," he said.

The state administration is in pressure for the last two months due to Covid-19 pandemic. Hence, he appealed to people to cooperate with the administration in the evacua-



fall between Paradip and Sagar Islands, around Balasore, in the afternoon of May 26. Which areas of the state will be affected and what would be the intensity of the summer

It will have wind speed upto 155 to 165 kmph gusting upto 185 kmph at the time of landfall. And these wind speeds will prevail over Balasore, Bhadrak, Jagatsinghpur and Kendrapara districts. The wind speed will diminish as it would move towards the hinterland. For Mayurbhanj, we can expect wind speed upto 120 to 130 kmph while areas like Keonjhar, Dhenkanal and Bhubaneswar will also have wind speed in different ranges. We would be providing districtwise wind warning.



How severe Yaas would be as compared to previous cyclones that had hit Odisha like Fani?

Fani's wind speed was 205 kmph and here we are telling of wind speed upto 165 kmph. It is far less than that of Fani but it will have same intensity as that of Cyclone Titli which crossed south of Gopalpur in 2018. The intensity of Yaas would be almost the same but slightly less than cyclone Amphan which crossed the Sunderbans in 2020. Yaas will have less intensity as compared to storms like Tauktae and Amphan.

• How is IMD tracking the storm? Tell us about the radars being used for the purpose.

 We have got Doppler radars at Gopalpur, Paradip and Kolkata. This particular cyclone will be tracked by these three radars. Vizag radar will also be used to some extent if the cyclone comes near

Andhra coast, which may not be the case now.

- Will it affect the arrival of southwest monsoon in the state?
- The cyclone will not have any impact on arrival of the monsoon. The southwest monsoon comes to Odisha around June 10/12. So, it is far away now. We have predicted that monsoon may hit Kerala around May 31.
- Do you think that human activities make coasts vulnerable to cyclonic storms?

It's a very tricky question. Cyclone frequency and intensity depends on the climate change upto some extent. It has been studied for the Arabian Sea and Bay of Bengal. I was the member of the study panel. We found that frequency of intense cyclones is increasing Arabian

Sea not over Bay of Bengal. It remains the same over Bay of Bengal, There are many coastal activities which have some relationship with respect to the impact of cyclone. It does not have any relation with respect to frequency or intensity of the storm. When I say impact of cyclone that means activities on the coast will be associated with the land use and land cover. Land use and land cover affect the surface run-off. river svstem etc if the development is taking place in that ecological place. In that sense, when cyclone comes it will have indirect impact in terms of flooding and others.

- How much is Odisha government prepared to tackle the storm and how is your department coordinating with the state governments?
- Odisha has set an example in the country when it comes to cyclone management. There is complete coordination between the Central and state agencies whenever a storm hits the state. We are also providing all required information to the state. The decisions taken by the state government are forwarded to all district Collectors and the state-level officials. We have specific warning system for every sector. For example, we have warning for ports, for fisheries sector, fishermen warning, for coastal shipping, we have coastal warning, for deep sea shipping, we have specific warning system and for airports operating in the state, we have got specific aviation bulletin. For naval operation also we have information. We had a meeting with industries Monday and all of them were informed about the impending storm.

Shah takes stock of Yaas preparations

New Delhi, May 24: Union Home Minister Amit Shah Monday held a virtual review meeting with Chief Ministers of Odisha, West Bengal and Andhra Pradesh and Lt Governor of Andaman and Nicobar Islands to assess the preparedness to deal with the situation arising out of Cyclone 'Yaas', which is forming in the Bay of Bengal.

The Union Home minister asked the administrations of the states and the UTs to make adequate power backup arrangements in all Covid-19 hospitals, labs, vaccine cold chains and other medical facilities

He also advised them to ensure adequate stock of essential medicines and supplies in hospitals, keeping in view likely disruption of movement of vehicles.

Reviewing the impact of the cyclone on oxygen generation plants in states of Odisha, West Bengal and Andhra Pradesh, Shah advised the state governments to make advanced planning for keeping a buffer stock of oxygen for two days. The Home minister asked the state governments to make necessary arrangements for safety of power plants to ensure uninterrupted power supply to hospitals and health facilities.

The Union Home minister also reviewed the preparedness of the concerned states and UTs to ensure that all fishermen are brought back to shore and the timely evacuation of people from low-lying and vulnerable areas. He advised them to disseminate messages in local languages over mobile phones, television, social media and through village panchayats, with a view to educating and motivating people.

"As practiced by Odisha, volunteers, such as home guards, NCC and civil defence may also be mobilised for assistance in the evacuation of people," Shah said.

He said that a 24x7 control room is functioning in the MHA, which can be contacted at any time for any assistance by the states and UTs. He said the Indian Coast Guard, the Navy, the Army and the Air Force units have also been put on standby and surveillance aircraft and helicopters are carrying out aerial sorties.

Akhaya instructed the officers to clear roads by cutting tree branches, shifting utility poles and other materials that would have fallen on the roads during the cyclone with the advanced equipment supplied to them. He directed the officials to follow Covid-appropriate behaviour while on duty in cyclone-affected areas.

The officials were also directed to keep ready water pumps to tackle the waterlogging problem due to heavy rain during cyclone in cities like Puri, Bhubaneswar and Cuttack. According to sources, around seven fire services teams have been kept ready in Bhubaneswar to tackle the effects of cyclone. The fire services officials in the city have as many as 36 power saws and 26 water pumps to meet the eventualities.

Srimandir rituals to continue amidst storm

Puri, May 24: With Cyclone Yaas fast approaching towards Odisha, the Puri administration Monday decided to continue with the rituals inside Srimandir ensuring safety of the servitors.

A decision to this effect was taken at a virtual meeting held by SJTA chief administrator Krishan Kumar and attended by Puri Collector Samarth Verma and other senior officials here, Monday. The officials were instructed to make necessary arrangements for the safety of Chapa (boats) used for Chandan Yatra.

However, the officials have decided to suspend the work at Rath Khala for Tuesday. Sources said that post Guja Anukula ritual, the work at Ratha Khala will be suspended and a dedicated team will be deployed at Ratha Khala. Furthermore, discussions were held to take necessary steps for making arrangements at Covid Care Centre (at Neeladari Bhakta Niwas) and providing sufficient back-up for oxygen cylinders for the patients.

GOVT INSTRUCTIONS FOR RESTORATION WORKERS

Bhubaneswar, May 24: The State government Monday gave several instructions for manpower and labourers deployed for post cyclone Yaas restoration work.

In the first instruction, Health and Family Welfare department instructed Collectors, Municipal Commissioners and CDMs to arrange for Rapid Antigen Testing (RAT) of the workmen deployed in the restoration sites.

This instruction was given because it is expected that due to cyclone Yaas the electricity distribution network will suffer heavy damage. About 20,000 men have been mobilised by TPCODL and TPNODL for restoration of electricity distribution network. So it is necessary to prevent Covid-19 infection among these workers so that restoration work goes on smoothly.

The state government also informed that the government will provide food and other charges of Rs 175 per day per labourer to be deployed in post cyclone restoration work. One triple layer mask will also be provided to each worker per day out of this amount. This instruction was given by the Energy depart-



clone restoration work of the damaged electrical infrastructure. These rates are applicable for the post cyclone restoration work

only. For unskilled labour the rate is Rs 462, for semi skilled Rs 522 and for skilled Rs 597.

Finally, the government also instructed that during electric restoration work, use of generator sets for private purpose is prohibited from 6am to 6pm as the back current of the generator may endanger the lives of electrical workers.

Potable water still a pipe dream for many in Jajpur district

Jajpur, May 24: Odisha govern ment has sanctioned crores of rupees for hundreds of piped water supply (PWS) and mega PWS projects in this district during the last three years. However, over 90 per cent of the rural households are still deprived of clean drinking water.

According to reports, there are five mega projects in the area, while 42 are in the PWS category. Even though the deadlines of many of these projects have passed, residents are still waiting for clean water to arrive in their taps. The water problem has become acute this summer as the groundwater level is declining. while the tube-wells, open wells, rivers and ponds have dried up. This situation has forced people to dig pits or draw water from other sources. Scenes of villagers digging pits near the river banks in Ghagiasahi under Kaliapani panchavat of Sukinda block. Kadam and Aichpur villages under Korei blocks to collect water are cases in point. Consumption of unhealthy pit water has led to

spread of many water-borne diseases among the people in the district, claimed locals.

The state government sanctioned ₹79.56 crore for a mega PWS for 37 villages under Sukinda block, ₹351.44 crore for a project in Barchana and Dharmasala blocks and ₹191.85 crore for Dasarathpur block. It has also sanctioned ₹106.91 crore and ₹34.46 crore in two phases for two projects for the mineral-rich areas of Sukinda block. However, in spite



of allocation of huge funds, throats remain parched. Reports said that work on 95

piped water projects worth ₹88.84 crore was yet to be completed till the end of January this year. A report published May 5, 2021 says that 42 PWS built at an outlay of ₹58.99 crore are yet to be implemented. Moreover, five mega PWS projects to be built at a cost of ₹764.22 crore have remained nonstarters. The report has been jointly published by Engineer-in-

This has happened due to use of sub-standard pipes, sanitary fittings and raw materials during construction of the projects, they alleged

Chief and Accounts Officer of Rural Water Supply and Sanitation (RWSS) department. Moreover, water supply is yet to resume from many of the projects marked complete.

Villagers alleged that they continue to wait for drinking water supply to their households as many of the completed projects have become defunct within four to five months of their operation. This has happened due to the use of sub-standard pipes, sanitary fittings and raw materials during construction of the projects, they alleged.

Sources said that the state government has sanctioned around 200 PWS projects during last two years. However, influential contractors, who are stated to be in hand in gloves with the public representatives and concerned officials, have allegedly spoiled the projects by using sub-standard raw materials.

When contacted, Motilal Tiwari. executive engineer of RWSS, said the concerned contractors have been asked to execute the projects as per agreements.

The District Collector said this is not the time for anyone to violate Covid lockdown guidelines. "Be it an officer or the public. All should have some rationality in their approach," he added.

The woman officer was work ing as a tehsildar of Sukinda block. She was found in a video dancing without having face mask or social distancing at a time when the state government has completely banned marriage processions and made a ceiling of 25 participants to attend such an event. The woman officer was also assigned the responsibility to impose the Covid-19 guidelines and ensure that the general public abides by the rules.

Though the woman officer was working in Jajpur district, she had gone to attend the *barat* of her brother in nearby Jagannathpur village under Tirtol block of Jagatsinghpur district May 21.

lockdown and weekend shutdowns in the state to curb the spread of Covid-19 pandemic, murram smuggling goes on unabated under Danagadi tehsil in Jajpur district.

It is alleged that hundreds of tons of murram have been excavated from a Sal forest under Trijanga panchavat of the tehsil using machines and smuggled out in tippers and dumpers during the period by greasing the palms of some unscrupulous tehsil officials. This has been going on when people have been asked to stay home during the lockdown and weekend shutdowns to check the spread of Covid-19.

Surprisingly, murram smuggling is taking place despite the tehsil office being located just around 500 metres from the mining site. Recently, heavy vehicles like dumpers and Hyva were seen smuggling minor minerals from the jungle. The illegality was caught again when five Hyva vehicles transporting the minerals to a land site for leveling work got stuck in rain induced mud at



Mangalpur village under the tehsil, May 14.

After the reports surfaced, the smuggling of the minor minerals has sparked resentment and anger among the residents. They alleged that some tehsil officials who been here since last seven to eight years were responsible for the mineral smuggling.

During verification, it was found that the Hyva vehicles engaged in murram smuggling had a sticker of a consultancy agency engaged in national highway construction work. This has been done to avoid

getting caught by the law enforcement agencies and locals

Later; the vehicles were found unloading the smuggled minerals at a site by a influential middlemen of the area. In the latest incident, tractors and Hvva vehicles were seen transporting murrams from the forest land Sunday. According to a rough estimate, the dispatch might be over 200 trips of murrams transported to various locations, Sunday.

Phone calls to tehsildar Namrata Modi for her comments on the issue went unanswered.

Bibi Biden Balance

'S President Joe Biden once famously told Israeli Prime Minister Benjamin Netanyahu addressing him by his nickname, Bibi, that he did not agree with a "damn thing" he said, but he loved him. This was in response to Netanyahu's endearing words for Biden whom he described, using the Hebrew word, "mishpucha", meaning family, as part of Israel's family.

The same symbiosis is still working when Biden declared May 21, a day after Israel and Hamas declared an unconditional ceasefire ending an 11 daylong bloody conflict, that a two-state solution was the 'only answer' to the Israel-Palestine conflict. He thus emphatically iterated the US' decades-old policy that had been reversed by his immediate predecessor, Donald Trump, who had batted for Israel ignoring the Palestinians. In the same breath, Biden did not deviate from the position he had been consistently taking in favour of Israel that "there will be no peace" in the region if Israel's right to exist as an independent Jewish nation is not acknowledged and accepted.

This is typical of Biden who, throughout his political career, advocated a US policy that never flinched from providing billions of dollars of aid to Israel to equip and defend itself from attacks from Palestinians and the Hamas.

Biden was sceptical of President Barack Obama's advocacy for the nuke deal with Iran as well. He, as Vice President, argued that a nuclear-powered Iran would harm the interests of Israel. However, taking a middle of the road position, he did argue with his friends in Israel that a nuke deal with Iran with proper restrictions would help promote peace in the region.

With the US mentoring and Egypt brokering peace, Israel and Hamas declared ceasefire. Strangely enough, Hamas even went ahead to claim victory. If the unrelenting bombardment by Israel on the Hamas' "infrastructure of terror" represents Israel's victory, the firing of rockets by the Hamas into Israel is being construed as a signal of triumph for the Palestinians. But, the situation is still fragile. Palestinians are waiting for the Supreme Court verdict on Israel's plan for evicting Palestinian families in East Jerusalem.

On the other hand, the increased assertion of rightists in Israel demanding total occupation of East Jerusalem to the exclusion of the Palestinians poses a real danger to the peace plan. Netanyahu had unnecessarily sided with these elements when trouble broke out in East Jerusalem during the Ramadan month and started bombarding the Hamas "infrastructure" in Gaza after the latter fired rockets in protest against harassment to Palestinians in East Jerusalem. The precarious position of Netanvahu's party in the March election prompted him to take the calculated risk of military engagement with the Hamas.

President Biden finds himself in an unenviable position as his top priority now is to focus on passing trillions in economic packages at home while competing with China abroad. Wading into yet another Middle East conflict is the last thing the Biden government would want. Moreover, Biden has also time and again championed the rights of the Arabs residing in East Jerusalem whom Israeli authorities had been evicting to settle Israelis there, instead. This is the reason that triggered the conflict on May 6 that led to the killing of at least 240 people, mostly Palestinians, and including about a dozen Israelis. In the past, Biden had tried to convince Israeli leadership that its policy of evicting Palestinians from East Jerusalem to occupy the entire territory won't receive support from the US administration. Because of his empathy for Israel, which he inherited from his parents, he has always adopted a soft policy officially towards Israel and mounted pressure on the latter "privately". This time too, US efforts to end the Israel-Palestine strife included upwards of 80 phone calls made by its officials to their counterparts in the region and six between Biden and Netanyahu to agree to a peace plan.

Two things become clear about Biden's current handling of the Israel-Gaza crisis. First, Biden is unlikely to back away from defending Israel when it's faced with a security threat. Incidentally, Israel had got the Iron Dome defence system, that it used to intercept Hamas rockets, thanks to lobbying by Biden as Vice President. Second, if Biden disagrees with his friend Netanyahu, he might keep it private and not articulate his position publicly. This seems to be the case so far with the current conflict. But, it is questionable how long the ceasefire will continue

Facing a wave of criticism from US legislators about US weapons sale to Israel, Secretary of State Antony Blinken has said the Biden administration remains committed to "giving Israel the means to defend itself." Hamas, on the other hand, is now seeking to unite Palestinians and is positioning itself as a leader in the political scene rather than just a party or a movement. This truce could be short-lived.

This was accompanied by a sharp drop in the official count of Covid infections, so much so that by the end of January a victory was declared. In a speech to the World Economic Forum on January 28, describing India's success in its fight against the virus, Prime Minister Modi said "In a country which is home to 18 per cent of the world population, that country has saved humanity from a big disaster by containing corona effectively." Unfortunately, the celebration proved to be premature as the second wave of the pandemic hit India viciously.

In just a couple of months the country's unpreparedness was starkly exposed, as the daily number of infections rose about forty times, to reach nearly half a million per day. Fatalities mounted caused by lack of oxygen, ICU beds, ventilators, medicines and emergency facilities. Even space in cremation and burial grounds ran out as bodies waited some times for days for the final rites. Topping it all has been the spectre of corpses hastily buried in the sandy banks of the holy river Ganga, or thrown into the water. Based on ground reports the number of these unclaimed, unacknowledged, uncounted bodies are estimated to be several thousand. One of the reasons for the furtive dumping of bodies is that the poor cannot even afford to buy the expensive firewood required for the funeral pyre, the other is the fear of the disease. Or perhaps there is the stigma associated with it. The fact is that the virus has spread to remote villages, even distant hilly areas of Uttarakhand, the deep forests of Chhattisgarh, and small towns across India. Since many rural areas are utterly lacking even in basic healthcare facilities, the illness and deaths are often not even attributed to Covid. So, the official count of infections and fatalities may be severely underestimated.

Thankfully, the second wave which rose steeply in the past two months seems to be also coming down rapidly. At least in the major metro cities, the panic cries for oxygen, beds and ventilators are fewer. But the situation in the rural areas is still precarious, at least in some states. Hence many states are persisting with lockdowns, which curtail economic activity.

Which brings us to an assessment of the impact on the economy. Back in November many analysts believed that the growth rate for fiscal year 2021-22 could be as high as 12 or 13 per cent. This was mainly due to a V-shaped recovery from the economic contraction last year. But now that assessment is being pared down, and the most optimistic estimate for the current fiscal is around 8 per cent. This would mean that after two years, the economy's size would be still a bit smaller than it was in 2019. Also, since tax collection is related to economic growth, lower growth this year, would mean a further shortfall in tax revenue to the tune of around Rs1 to 1.5 lakh crore. This would make the fiscal deficit wider than projected in the Union Budget in February. That would mean an increase in borrowing by the Central government, making it difficult to keep the interest rates (i.e. the cost of borrowing) low.

The latest data on inflation shows wholesale price index (WPI) based inflation to be at an 11-year high of 10.5 per cent. Of that the fuel and power subcomponent is at 20 per cent. This high inflation is predicted to continue for the next few months. The nonfood inflation captured in WPI is at 15.6 per cent. These are alarmingly high numbers. The WPI inflation mainly reflects the input cost escalation experienced by producers. Sooner or later this input cost pressure will be passed on to consumers. In that case even the consumer price index (CPI) based inflation will start going up. Right now, the consumer inflation is below 6 per cent which is the upper limit of the tolerable bond. CPI inflation has a very big food component. With a normal monsoon and a bumper crop expected later, the foodgrain inflation may not spike up. But meat, poultry, milk, pulses and other sources of proteins might become costlier. Ironically some tomato farmers have chosen to destroy their current bumper crop, since prices have crashed much below their cost of production. The input costs like electricity, fertiliser, labour have gone up significantly. Maybe that is the reason why the Prime Minister chose to keep fertiliser prices low and unchanged despite a big

increase internationally, and hence allowed a bigger subsidy to farmers this year. Internationally the Food and Agricultural Association says that the food price index is at a seven-year high. Edible oil prices have doubled from last year, and even sugar has gone up by sixty per cent. In India at the retail pump petrol prices have crossed Rs 100 which will hurt transportation costs, including that of food.

Coupled with inflation is the worrying trend in unemployment. In April unemployment shot up to 8 per cent as per CMIE data. The labour force participation rate is down to just 40 per cent. That means 60 per cent of the ablebodied workforce between the ages of 16 and 60 are out. They have either given up on the prospects of finding a job, or are tending to homes or are in school, college or training. It is well known that the pandemic has caused a very large proportion of women to drop out of the workforce alto gether. India's female labour force participation rates are among the lowest in the world.

With such grim unemployment and inflation prospects, the government has its work cut out. There must be a substantial fiscal injection in the form of enhanced foodgrain allocation to households from the PDS, free and universal rapid vaccination, much higher allotment to rural employment guarantee (MN-REGA), quick ramp up of infrastructure projects already sanctioned by the national infrastructure pipeline, and filling up of all vacancies in government and government-owned bodies to the extent possible. Such fiscal action will of course be aided by the accommodative monetary policy of cheap money, and support for the government's borrowing programme. Policymakers and administrators have their work cut out as we struggle to make our way out of the health and economic crisis.

Nerd

N appearance in print a little over half a century ago but we don't know enough to be sure where it comes from. The Oxford English Dictionary says "Origin uncertain and disputed". It's worth noting that nerd (also nurd) has evolved in meaning. Early on, it meant a dull, unattractive, or offensive person. The associations with obsessive technical expertise and fussy dressing (remember nerd pack for a pocket protector?) only came along in the 1970s - illustrated in the National Lampoon's "Are you a Nurd?" poster of 1977 (see right). Compare and contrast geek, which once had similar links (if you disregard the stories about biting the heads off live chickens in fairground booths) but has largely been rehabilitated. Geeks are intelligent, hugely knowledgeable about a technical subject but able to get ahead in life (Time had a headline in 1995: "The Geek Shall Inherit the Earth"). Nerds are thought to be obsessively good at one thing but poor at anything else. Nerds are geeks with no social skills. The two earliest appearances of nerd, the two you mention, are these: And then, just to show them, I'll sail to Katroo And bring back an It-Kutch, a Preep and a Proo, A Nerkle, a Nerd and a Seersucker too (If I Ran the Zoo, by Dr Seuss, 1950). Nerds and Scurves: In Detroit, someone who once would be called a drip or a square is now, regrettably, a nerd, or in a less severe case, a scurve (Newsweek, 8 Oct 1951). The Dr Seuss origin might be considered confirmed by these, but as you say, a shift from a work for young children to a fashionable teenager term is unlikely to have happened so quickly. Several other theories have been proposed. One is that it's short for the Northern Electric Research and Development Laboratories, part of a power utility of Ontario, not so far from Detroit. But the laboratory wasn't given that name until 1959. As one early spelling was nurd, another suggestion is that it's a modified or rhyming-slang form of turd. That's very unlikely. In 1938, the ventriloquist Edgar Bergen created a new addle-pated countrybumpkin dummy to accompany his suave top-hatted Charlie McCarthy and gave it the name Mortimer Snerd. It's been argued that Dr Seuss may have subconsciously had this in mind. This source is dismissed by etymologists, but we have come across a few instances of somebody being nicknamed Snerd in the years before nerd was first recorded. There's also knurd. which is drunk backwards. The Rensselaer Polytechnic Institute usually gets a mention here, since there are persistent reports that the term was in use there in the 1950s. It would be impossible - or at least deeply unwise - to support a claim for any of these words being the direct source. Our suspicion is that there's something about the combination of sounds that we conventionally spell nerd that causes it to be reinvented from time to time as a term of disparagement. Perhaps this is because it reminds us of a growl of disgust, disapproval or negation.

cision to back the call for waiving intellectual-property protections for COVID-19 vaccines reflects the extent of global pressure for universal vaccine access. Yet the world's poor suffer from many other preventable and treatable diseases, with dire social and economic consequences.

Neglected tropical diseases such as elephantiasis, trachoma, river blindness, and intestinal worm infections - are virtually nonexistent in advanced economies. But among people living in extreme poverty, they are the most common infections. About a billion people worldwide - including more than 750 million people living below the World Bank poverty line of \$1.90 per day - suffer from NTDs every year.

Their suffering can be extreme. NTDs cause severe pain and longterm disability, often leading to social stigmatisation. Among children, infection interrupts education and causes malnutrition, impairing intellectual and cognitive development and stunting growth. And by interfering with education and employment, NTDs keep people trapped in poverty. And yet, while nearly 17 milannually to NTDs, these diseases are largely preventable, and many can be treated with a few simple pills. Ensuring broad access to these medications would not only bring obvious health and humanitarian benefits, but also pay remarkably high and sustained social and economic dividends.

Consider intestinal worms, the most prevalent - and among the most treatable - NTDs. Starting in 1998, we studied a public-health programme providing treatment for intestinal worms to tens of thousands of primary-school children in Kenya. Using a randomised control trial, we could reliably measure the programme's causal impact by comparing schools where treatment was provided with otherwise identical schools where it wasn't.

In the schools that received treatment, we recorded gains in childhealth measures and considerably higher school attendance. We then engaged in a two-decade effort to track a representative subsample of thousands of the same children. Roughly every five years, the research team carried out surveys to gather information on these individuals' earnings and living standards, as well as residential choices

from this unusual longitudinal data set are stunning. Twenty years later, individuals who had received additional deworming treatment in school - now in their late twenties and early thirties - reported 13 per cent higher hourly wages and 14 per cent higher spending on consumption goods than those who did not. They had also moved to large urban areas, like Nairobi, in far greater numbers, affording them better economic

opportunities. Considering that an annual deworming treatment costs about \$0.50 per child when delivered at scale, the rate of return on this investment in child health is astronomical and pays for itself many times over. Fortunately, governments in India, Kenya, Nigeria, Ethiopia, and Pakistan have recognised this, and are working with NGOs to implement mass deworming programmes that currently reach over 280 million children each year. But there is still much work to be done to reach the nearly 600 million children who remain at risk of parasitic worm infections.

With the COVID-19 pandemic pushing even more of the world's

creasing the risk of debilitating illness - now is the time to redouble our efforts to combat NTDs. But growing demands on government budgets and more competition for funding seem set to halt progress - and even reverse it. The British government – a global leader in innovative for-

eign-assistance programmes - recently announced that it would cut 90 per cent of its funding for NTDs. As a result of this decision, millions of people will miss out on treatments, and many medicines that are already in-country could expire on the shelf, owing to a lack of funds to distribute them. For the world's most vulnerable populations, the consequences will be catastrophic. That is why we urge the British government to reverse its decision, and encourage other governments to fill the gaps in funding. Take action: Shivraj to Sonia on Kamal's virus remark

Bhopal, May 24: A war of words broke out between Madhya Pradesh Chief Minister Shivraj Singh Chouhan and state Congress president Kamal Nath Monday following registration of an FIR against the latter for allegedly creating panic over the COVID-19 pandemic through his remarks.

Chouhan asked Congress president Sonia Gandhi to take action against Nath for his "Indian variant" and other remarks related to the pandemic.

On the other hand, Nath said an FIR cannot suppress his voice and asserted he will keep fighting for people and raise issues of public interest.

Sunday, the Crime Branch of the Bhopal Police had filed an FIR against Nath following a complaint by BJP leaders who alleged the former chief minister has been creating panic over the coronavirus pandemic through his remarks.

"Sonia Gandhi should take action against Kamal Nath ji and if she agrees with his views, then let the country know so that the public can be aware about the Congress stand," Chouhan said in a tweet Monday.

In another tweet, Chouhan said the government is trying to control the COVID-19 infection with co-

ferring to a video circulated by the BJP in which Nath is purportedly heard saying to a person 'this is the time to set (sentiments) on fire" during a discussion on problems being faced by farmers. The Congress, however, claimed the video was doctored.

On the other hand, a defiant Nath, in a statement issued to the media Monday, said, "The Shivraj government wants me to keep quiet, not to raise public's voice, not to fight for their rights but I will not sit quiet. I will keep fighting for public interest till the last breath of my life, an FIR cannot suppress me.'

The Leader of Opposition alleged the BJP government in the state has left people at the mercy of God at the time of the coron avirus crisis.

Nath said the BJP government is hiding data on COVID-19 deaths and alleged people were dying in absence of hospital beds, shortage of medical oxygen and essential medicines, including Remdesivir, a claim repeatedly rejected by the state administration. "Thousands of people have died

in the state due to carelessness and negligence of the state government," the Congress leader said, adding despite being alerted. the BJP administration did not arrange for medical oxygen and adequate hospital beds.

"When people are in trouble,

the medical system is in tatters, people are dying, the Shivraj government wants me to keep quiet," he said.

The MP Congress president said the state government was trying to divert people's attention from real issues by filing FIR against him. He demanded that people who have died of COVID-19 be given an exgratia of Rs 5 lakh instead of Rs 1 lakh announced earlier.

Sunday, Nath was charged under section 188 (disobedience to order duly promulgated by a public servant) of the IPC and section 54 (making or circulating a false alarm or warning as to disaster or its severity or magnitude, leading to panic) of the National Disaster Management Act 2005 in the FIR registered at the Crime Branch Station in Bhopal, an official said.

The BJP leaders, in their complaint, alleged that Nath had said at a press conference at Ujjain on Saturday said that, "Corona, which has spread in the world, is being known as the Indian variant of the virus.'

Nath's statement is creating confusion and defaming the country internationally, the complaint said.

The former Union minister has disobeyed the World Health Organization (WHO) guidelines to stem COVID-19 and his act amounts to sedition under the IPC, the complainants said.

Guj communal clash: FIR against over 2,000 people

Gir Somnath, May 24: Police have registered an FIR against nearly 2,000 unidentified people on charges of attempt to murder and rioting after members of two communities clashed with each other here in Gujarat, leaving six policemen and around a dozen other people injured, an official said Monday.

The FIR also names 47 other persons for similar offences in connection with the incident that took place Sunday, he said. The clash broke out at Nava Bandar village in Una taluka of Gir Somnath after an altercation over collision of two fishing boats at a jetty in the village, he said.

Around 1,500 to 2,000 people belonging to two communities allegedly hit each other with sticks. swords, iron and plastic pipes, and also hurled stones and empty glass bottles, the official said.

When police intervened to control the mob, the rioters attacked them, injuring six personnel, including Assistant Superintendent of Police Om Prakash Jat, two sub-inspec tors and three constables, an official from Nava Bandar Marine police station said. The police had to lob several teargas shells to control the mob. he said. An FIR was registered against 47 named and 1,500 to 2,000 unidentified people from both the communities late Sunday night under IPC Sections 307 (attempt to murder), 332, 333 (voluntarily causing grievous hurt to public servant), 337, 338 (hurting with negligent act endangering human life), 143 (unlawful assemblv). 147 and 148 (rioting), he said.

Efforts were on to arrest them, the official said. Following the clash, a large police team comprising personnel from three nearby police stations at Una, Gir Gadhada and Kodinar: and from local crime branch.



Ahmedabad, May 24: A coaching centre owner in Jasdan town of Gujarat's Rajkot district was arrested for allegedly flouting COVID-19 norms after police found more than 550 students on his premises during a raid, police said Monday. The raid on the centre, located

some 215 kilomeres from here, took place Sunday and its owner, 39year-old Jaysukh Sankhalva, was arrested Monday, said Rajkot Superintendent of Police Balram Meena.

"He was arrested under IPC and Epidemic Diseases Act provisions for disobeying police notification on COVID-19 norms as well as for negligent act which may spread infection. The children have been handed over to their parents." he said. According to police, Sankhalva runs a coaching centre-cum-hostel to provide training to students appearing for Jawahar Navodaya Vidyalaya and Balachadi Sainik School entrance exams.

"Based on a tip-off, we raided the premises and found 555 students between the age of 9-10 tak-



Before his arrest, Sankhalva told reporters the students were staying in his hostel since May 15 with parental consent.

"Most of them are supposed to appear for Navodaya Vidyalaya entrance test, which got postponed. The parents of these children asked me to keep them in the hostel rather than send them home." he claimed

'Tiger state' all set to welcome African cheetahs

Bhopal, May 24: Cheetah, the world's fastest land animal which was declared extinct in India in 1952, is expected to be re-introduced into the country in November this year at the Kuno National Park in Madhya Pradesh, state Forest Minister Vijay Shah has said.

The country's last spotted cheetah died in Chhattisgarh in 1947 and it was declared extinct in the country in 1952.

The Wildlife Institute of India (WII) some years back prepared a cheetah re-introduction project.

The Supreme Court had earlier given its approval to introduce African cheetahs to a suitable habi tat in India on an experimental basis

"We have started the process of creating an enclosure for around 10 cheetahs, including five females, to be brought from South Africa to Kuno in Sheopur district and it is going to be completed by August," Shah told PTI.

Officials from India will be sent to South Africa for sensitisation and training in June and July this year and according to the plan, the trans-



portation of the cheetahs will take place in October and November, he said

Kuno, located in the Chambal region, is spread over an area of over 750 sq km and has a conducive environment for the cheetah, he said

The protected area, comprising a considerable population of fourhorned antelopes, chinkara, nilgai, wild boar, spotted deer and

prey base for the cheetahs, he said.

"According to the approved timeline sent to us by the Ministry of Environment, Forest and

Climate Change this week, the tentative budget outlay of the 'Project Cheetah' is Rs 1.400 lakh for this fiscal," the minister said. The National Tiger Conservation

Authority (NTCA) is going to release the money for the project to Madhya Pradesh and the Wildlife Institute of India (WII) at Dehradun next month, Shah said.

An expert from South Africa visited the Kuno National Park April 26 this year along with scientists from the WII and inspected the facilities and habitat created there for the introduction of African cheetahs. They approved it and now the final process of

The WII team had visited the Kuno National Park in MP's Sheopur district, the Nauradehi sanctuary in Sagar district, the Gandhi Sagar sanctuary on the northern boundary of Mandsaur and Neemuch districts and the Madhav National Park in Shivpuri district, Chauhan said.

"Madhya Pradesh had in the past been home to cheetahs. The state has a long conservation history...We have the habitat. We also have a successful animal translocation track record," Chauhan said, referring to the tiger reintroduction programme in the Panna Tiger Reserve in 2009.

Cheetah is considered vulnerable under the International Union for Conservation of Nature's (IUCN) red list of threatened species, with a declining population of less than 7,000 found primarily in African savannas.

The Supreme Court last year set up a three- member committee to guide the NTCA on the cheetah re-introduction project. The panel has asked the WII to carry out a technical evaluation of all possible sites for the re-introduction of cheetah in the country.



'Identify fungus by name, not colour'

New Delhi, May 24: With the 'black fungus' identified in Covid patients, followed by a 'white' variant and now 'yellow', AIIMS Director Dr Randeep Guleria Monday advised that mucormycosis should be identified by its name, rather than by its colour. He said that it is better not to use the term 'black fungus' while talking of mucormycosis, as it leads to a lot of avoidable confusion. "Black fungus is another family; this term got associated with mucormycosis due to the presence of black dots among the culture of white fungal colonies. In general, there are various types of fungal infections such as candida, aspergillosis, cryptococcus, histoplasmosis and coccidioidomycosis. Mucormycosis, candida and aspergillosis are the ones observed more in those with low immunity," he told the media here.

New Delhi, May 24: Director General CISF Subodh Kumar Jaiswal, SSB DG Kumar Rajesh Chandra and Special Secretary Home Ministry VSK Kaumudi were short-listed for the post of CBI director during a meeting of a high-powered committee, comprising Prime Minister Narendra Modi and two others, Monday, sources said.

Jaiswal, a 1985-batch Indian Police Service (IPS) officer, is a former Maharashtra director general of police. He is at present the director general the Central Industrial Security Force (CISF). Chandra, a 1985-batch IPS officer of the Bihar cadre, is at present posted as the director general of the Sashastra Seema Bal (SSB), while Kaumudi, a 1986-batch IPS officer of the Andhra Pradesh cadre, is posted as the special secretary for internal security in the Home Ministry. The name of Uttar Pradesh DGP HC Awasthy, a 1985-batch IPS officer of the Uttar Pradesh cadre, was also under consideration. The meeting of the high-powered committee, comprising Prime Minister Modi, Chief Justice of India NV Ramana and Leader of Opposition in Lok Sabha Adhir Ranjan Chowdhury, started around 6:30 pm at the 7, Lok Kalyan Marg, official residence of the Prime Minister, the sources said. During the 90-minute meeting, Chowdhury objected to the process of selection of officers for the coveted post of CBI director. cases are increasing, it is not contagious or infectious like Covid," he said. Guleria also clarified that there is "no definite link between oxygen therapy and catching the infection as 90 to 95 per cent of mucormycosis patients are either diabetic and/or taking steroids".

"This infection is seen very rarely in those who are neither diabetic nor taking steroids," he said. He said that some of the common symptoms of mucormycosis are one-sided facial swelling, headaches, nasal or sinus congestion, black lesions on nasal bridge or upper inside of mouth that quickly become more severe, and fever.

The AIIMS director said antifungal treatment goes on for many weeks, so it is proving to be challenging for hospitals, since Covidpositive patients and Covid-negative patients who catch mucormycosis need to be housed in separate hospital wards. Surgery also needs to be done judiciously since aggressive surgery for mucormycosis can have adverse outcomes for Covid patients.

More troubles for 'Leprosy must not be forgotten amid pandemic'

New Delhi, May 24: Thirty years ago this month, the World Health Assembly (WHA) adopted a resolution to eliminate leprosy as a public health problem.

Today, as the 74th WHA gets under way, WHO Goodwill Ambassador for Leprosy Elimination Yohei Sasakawa is urging countries not to overlook leprosy amid the global coronavirus pandemic and aim for zero leprosy. The resolution adopted at the

44th World Health Assembly in 1991 called for the elimination of leprosv as a public health problem at the global level by the year 2000. "Elimination" was defined as reaching a prevalence rate of the disease of less than 1 case per 10,000 population. This was achieved globally by the end of 2000 and almost all countries have since replicated that success at the national level.

Some 3-4 million people are thought to be living with visible impairments or deformities due to leprosy, while stigma and discrimination towards those with the disease persist.

In April, the fight against leprosy entered a new phase with the launch by the WHO of "Towards Zero Leprosy: Global Leprosy (Hansen's disease) Strategy for 2021-2030". The targets include zero leprosy patients in 120 countries and a 70 percent decrease in new cases detected globally by 2030.

Yohei Sasakawa, who has visited over 100 countries since first being appointed Goodwill Ambassador in 2001, welcomes the new strategy and believes it will accelerate momentum towards a leprosy-free world. But he cautioned:

'These are ambitious targets, so commitments from national governments will be required if they are to be achieved. I realize



these are challenging times, but we mustn't allow leprosy to be overlooked amid Covid-19.

Noting that the impact of the coronavirus pandemic has been particularly hard on already-marginalized communities such as

persons affected by leprosy, Sasakawa said this underscored the needed to tackle the social and economic consequences of leprosy. For that reason, he hailed the focus on combating stigma and ensuring respect for human rights in the

new global leprosy strategy.

'Tackling discrimination is as important as curing the disease if we are to truly achieve a leprosy-free world. Key to this will be the full implementation of the UN principles and guidelines," he said, referring to principles and guidelines accompanying the landmark 2010 UN General Assembly Resolution on elimination of discrimination against persons affected by leprosy and their family members.

Goodwill Ambassador Sasakawa, who has been involved in efforts against leprosy for nearly half a century with The Nippon Foundation, the Japanese nonprofit grant-making organization he serves as chairman, said the 30th anniversary of the WHA resolution on eliminating leprosy is an appropriate moment to recall the spirit that brought countries together in a sense of common purpose against leprosy.



On Friday, a 40-year old patient with confirmed black fungus infection died in a government medical college hospital in Jammu.

New Delhi, May 24: WhatsApp Monday said it has sent a reply to the notice by Ministry of Electronics and Information Technology (MeitY) after the ministry directed the Facebook-owned platform to withdraw its controversial user privacy policy.

In its fresh notice to the company, the MeitY told WhatsApp to respond to its concerns by May 25. A WhatsApp spokesperson said in a statement that the company has responded to the Government of India's letter and assured them that the privacy of users "remains our highest priority".

"As a reminder, the recent update does not change the privacy of people's personal messages. Its purpose is to provide additional information about how people can interact with businesses if they choose to do so," the spokesperson said. Noting that many Indian users depend on WhatsApp for communicating on a daily basis, the ministry had said in the notice that it is irresponsible for WhatsApp

to leverage its position in the Indian market to impose unfair terms and conditions. As per the ministry, the changes to WhatsApp privacy policy and the manner of introducing the changes undermines the sacrosanct values of informational privacy data security and user choice and harms the rights and interests of Indian citizens.

The WhatsApp spokesperson said that the company "will not limit the functionality of how WhatsApp works in the coming weeks. "Instead, we will continue to remind users from time to time

about the update as well as when people choose to use relevant optional features, like communicating with a business that is receiving support from Facebook," the spokesperson added. "We will maintain this approach until at least the forthcoming PDP (personal data protection) law comes into effect". The MeitY communication had noted that WhatsApp's new privacy policy is a violation of several provisions of the existing Indian laws and rules.

WhatsApp has rolled out its privacy policy globally including in India, where it has more than 400 million users. The users will not immediately lose their accounts or face curtailed functionalities, but they will have to eventually go through limited functions if they fail to accept the new norms in the due course of time. After persistent reminders, the users will encounter limited functionality on WhatsApp until they accept the updates.

Delhi Police sends notice to Twitter-India

The Delhi Police's Special Cell Monday sent a notice to Twitter India in connection with the probe into a complaint about the alleged 'Covid toolkit', asking it to share information based on which it had classified a related tweet by BJP spokesperson Sambit Patra as "manipulated media", officials said. Two police teams also descended on the microblogging site's offices in Lado Sarai in Delhi and in Gurgaon this evening. "The Delhi police team went to the Twitter office to serve a notice to Twitter as a part of routine process. This was necessitated as we wanted to ascertain who is the right person to serve a notice, as replies by Twitter India MD have been very ambiguous," Delhi Police PRO Chinmoy Biswal said The BJP has accused the Congress of creating a 'toolkit' that seeks to tarnish the image of the country and Prime Minister Narendra Modi over the handling of the Covid pandemic.

New Delhi, May 24: The first total lunar eclipse of the year will take place May 26 and according to the India Meteorological Department (IMD), only a few places in the country will be able to witness the partial lunar eclipse.

The partial lunar eclipse will be visible for a short span from the north-eastern region (except Sikkim), some parts of West Bengal, some costal parts of Odisha and Andaman and Nicobar Islands, the IMD said.

This will be the first total Lunar Eclipse since January 21, 2019 and it will be a supermoon.

The eclipse will be visible in the region covering South America, North America, Asia, Australia, Antarctica, the Pacific Ocean and the Indian Ocean.

According to NASA, a series of celestial events have been happening since May 17 which will culminate in the total lunar eclipse.

The partial phase of the eclipse will begin at 15h 15m IST (Indian standard time). The total phase will begin at 16h39m IST. The total phase will end at 16 h 58m IST. The partial phase will end at 18h 23m IST

The next lunar eclipse will be visible from India November 19,2021. It will be a partial lunar eclipse.

Lunar eclipse occurs on a full Moon day when the Earth comes in between the Sun and the Moon and when all the three objects are aligned.

A total lunar eclipse occurs when the Moon comes under the umbral shadow of the Earth and the partial lunar eclipse occurs when only a part of the Moon comes under the umbral shadow of the Earth.



Washington, May 24: Three researchers from China's Wuhan Institute of Virology (WIV) sought hospital care in November 2019, months before China disclosed the Covid-19 pandemic, the Wall Street Journal reported Sunday, citing a previously undisclosed US intelligence report.

The newspaper said the report which provides fresh details on the number of researchers affected, the timing of their illnesses, and their hospital visits - may add weight to calls for a broader probe of whether the Covid-19 virus could have escaped from the laboratory. The report came on the eve of a

meeting of the World Health Organization's decision-making body, which is expected to discuss the next phase of an investigation into the origins of Covid-19.

A National Security Council spokeswoman had no comment on

The United States, Norway, Canada, Britain and other countries in March expressed concerns about the WHO-led COVID-19 origins study, and called for further investigation and full access to all pertinent human, animal and other data about the early stages of the outbreak.

No decision on Haj 2021 yet: Saudi embassy in Pak AGENCIES

Islamabad, May 24: Pakistan Minister for Religious Affairs Noorul Haq Qadri has clarified that the Saudi Arabia government had not vet taken a decision regarding the number of pilgrims being allowed to perform Haj this year.

The Saudi embassy in Pakistan Sunday said that no decision has been taken yet on hosting the Haj pilgrimage this year.

A spokesman in the Saudi embassy said, "No decision has been taken yet regarding the Haj. All that is said in this regard are proposals that are still under study.

The statement by Taher Al-Ashrafi, Special Representative of the Pakistan Prime Minister on Religious Harmony, regarding Haj is incorrect. On Saturday, he said that the Saudi government has allowed 60,000 people from across the world to perform Haj this year, including Pakistan.

Meanwhile, Pakistan Minister for Religious Affairs Noorul Haq Qadri clarified on Sunday that the Saudi Arabia government had not yet taken a decision regarding the number of pilgrims being allowed to perform Haj this year or the Covid SOP.

He said, "I have spoken to the Saudi Haj and Umrah minister. The news that is circulating is the recommendations by the Saudi Health Ministry, and no final decision has been made yet.'

Iran to extend deal on cameras at its N-sites

Vienna, May 24: Iran and the UN's nuclear watchdog agreed Monday to a one-month extension to a deal on surveillance cameras at Tehran's atomic sites, buying more time for ongoing negotiations seeking to save the country's tattered nuclear deal with world powers.

The last-minute discussions further underscored the narrowing window for the US and others to reach terms with Iran as it presses a tough stance with the international community over its atomic programme. The Islamic Republic is already enriching and stockpiling uranium at levels far beyond those allowed by its 2015 nuclear deal.

Speaking at a news conference Monday in Vienna, IAEA Director-General Rafael Mariano Grossi told journalists that came after a discussion with Ali Akbar Salehi, the head of Iran's civilian nuclear programme.

Kazem Gharibabadi, Iran's representative to the IAEA, acknowledged the deal at the same time on Twitter: Under a confidential agreement called an "Additional Protocol" with Iran, the IAEA collects and analvzes images from a series of surveillance cameras installed at Iranian nuclear sites. Those cameras helped it monitor Tehran's program to see if it is complying with the 2015 nuclear deal.

The deadly explosion on Sunday was "caused by a landmine laid previously by the Houthi rebels in Hays district in southern Hodeidah", the official said. The three women were killed "while they were caring for their sheep near an agricultural area", the official added. The Houthi-laid landmines and IEDs continue to pose a real threat to the civilians despite the ongoing efforts by the experts of the mine-clearing projects in Yemen.

Dogs can be trained to detect 90% Covid cases: Study

Paris, May 24: Dogs can be trained to detect more than 90 percent of Covid-19 infections even when patients are asymptomatic, according to research published Monday, which authors hope could help replace the need to quarantine new arrivals.

Using their remarkable sense of smell-which can pick up the equivalent of half a teaspoon of sugar in an olympic-sized swimming pooldogs have already shown that they can sniff out maladies such as can-

cer, malaria and epilepsy. Several previous studies have shown proof-of-concept that dogs symptoms. can detect SARS-CoV-2. Researchers from the London School of Tropical Medicine wanted to see if dogs could detect a distinctive odour given off from chemical compounds



Covid positive but doesn't show

They gathered samples of clothing and face masks from people who had tested positive for mild or symptomatic SARS-CoV-2. Samples of the socks of 200

Covid-19 cases were collected and

arranged in lab tests for six dogs that had been trained to indicate either a presence or absence of the chemical compound.

The dogs needed to be trained not to identify "false positives" in a bid to hack their reward system and obtain treats even if there were no Covid-19 samples in a given test. 'This means that the dog fully understands and gets a reward for a correct negative as well as a correct positive," said Claire Guest, from the school's Faculty of Infectious and Tropical Diseases.

Overall, the dogs were successfully able to identify between 94 and 82 percent of SARS-CoV-2 samples.

The researchers then modelled how effectively these success rates. combined with traditional PCR tests, could help detect mild or asymptomatic Covid-19 cases.

They found that using dogs to screen arrivals at terminuses such as airports could detect 91 percent of cases, resulting in a 2.24 times lower rate of transmission than with PCR tests alone.

'Important start'

Authors of the research, which has yet to be peer-reviewed, said they hoped it could eventually replace the need for travellers to quarantine - which necessarily disrupts every arrival even though the vast majority are not Covid positive.

"The key thing is that dogs are significantly quicker than other tests," said co-author James Logan.

"What we're suggesting is that dogs would give the first initial screening, and then those (arrivals) that were indicated as positive would then receive a complimentary PCR test."

The team said that out of a plane full of arrivals – around 300 people - less than one percent were statistically likely to be carrying SARS-CoV-2.

Under current quarantine regulations employed by some countries, all 300 would need to isolate, causing significant inconvenience.

Washington, May 24: At least 12 people, including two girls, were killed and dozens injured in multiple shootings in several US states over the weekend, according to authorities and media reports.

A 16-year-old girl died just after 1 am Sunday, shortly after gunfire broke out at the Bicentennial Park Amphitheater in Columbus, the capital city of Ohio, Xinhua news agency quoted the local police as saying.

Five other teens were injured in the shooting. The incident occurred at a pri-

vate event that was promoted on social media, according to the police statement.

What sparked the shooting remains unclear, and police have not identified a suspect, the NBC Columbus-affiliate WCMH reported.

In Youngstown, the ninth largest city in Ohio, three people were shot dead and five others injured at a bar on early Sunday morning, according to a CNN report, citing local police sources.

Police responded to the reports of shooting at the Torch Club Bar & Grille in Youngstown shortly after 2 am Sunday said the report.

Detectives said some sort of argument broke out near the bar and there was "an exchange of gunfire", local media outlet WKBN reported.

Youngstown has witnessed 11 homicides this year, with 42 people shot and wounded, said WKBN.

In Bridgeton, New Jersey, two people were killed with 12 others injured in a house party shooting just before midnight, the authorities said Sunday.

Troopers responded to the scene at 11.50 p.m. Saturday, the state police said.

More than a hundred people were at that home for a party at the time, according to an ABC News report.

Mumbai, May 24: Continuing lockdowns in several states have led to a further decline in business resumption, and economic activity has now dipped to levels seen in June last year, a Japanese brokerage said Monday.

Using a proprietary index of gauging activity deployed since the national lockdown last year, Nomura said the worst hit to the activity will occur in May, followed by a sequential improvement in June.

"Lockdowns look to spill into June, but a few states are announcing a slow rollback of restrictions as their virus caseloads fall, which suggests a sequential improvement in activity in June,' the brokerage said.

The business resumption index slipped to 60 for the week ended May 23, down from 63 in the pre-



vious reporting week, it said, adding that these levels were last seen in June 2020

Both mobility and non-mobility sectors have been hit, it said, pointing out that Google's workThe business resumption index slipped to 60 for the week ended May 23. down from 63 in the previous reporting week, said the Japanese brokerage firm, adding that these levels were last seen in June 2020

Power demand continued to contract, down by 5 per cent, while the labour participation rate moderated to 39.4 per cent from 40.5 per cent, with the unemployment rate up to 14.7 per cent from 14.4 per cent last week, near its one-year high.

For a sustained recovery, the pace of vaccination needs to pick up, which is expected to happen only after June, it said. Meanwhile, analysts at Kotak

alysts said. Mobility metrics, trending downwards across India, have started to improve in Mumbai and Pune. Mumbai and Pune were two of the first cities to peak in the second wave, it pointed out. Stating that most of the states have "peaked" in terms of infections, they also flagged the slow pace of vaccinations as an area of concern.

New Delhi, May 24: Mobile phone subscribers may soon be allowed to switch from a postpaid connection to prepaid and vice versa by using an OTP-based authentication and without a need to change SIM card, according to an official DoT note.

Industry body Cellular Operators' Association of India (COAI) has proposed the mechanism to the Department of Telecom (DoT) and the department has asked telecom operators to carry out proof of concept (PoC) on the same.

The final decision on allowing the change in the account will depend on the outcome of PoC, according to the DoT note.

"The PoC for conversion from prepaid to postpaid and vice versa may be carried out by the telecom service providers as per the procedure.

The decision regarding implementation of the procedure shall be taken after the assessment of the outcome

of the PoC," DoT ADG Suresh Kumar said in the note issued May 21.

The COAI had requested the DoT April 9 for permission to allow mobile customers to migrate from prepaid to postpaid and vice versa without undertaking fresh KYC procedure and by using OTP-based authentication.

"OTP based authentication has become an acceptable norm in all sectors in recent past and most of the citizen-centric services are being offered with OTP authentication. Contactless services in present times are to be promoted for user convenience and also for ease of doing business," the note said.

Milan, May 24: Seven-time European champion AC Milan is back in the Champions League after an eight-year break. And Juventus also narrowly qualified on the final night of Serie A.

Two penalties from Franck Kessie Sunday helped Milan to a 2-0 win at Atalanta, which had already claimed a top-four spot along with Serie A champion Inter Milan.

Juventus won 4-1 at Bologna with two goals from Alvaro Morata plus scores from Federico Chiesa and Adrien Rabiot. Still, Juventus needed help and got it when Hellas Verona held Napoli to a 1-1 draw, leaving Napoli in fifth place.

Amir Rrahmani had put Napoli ahead on the hour mark but Davide Faraoni quickly equalized for Verona.

When Juventus' game finished a few moments earlier. Bianconeri players watched the final moments of the Napoli-Verona match on the touchline before they could celebrate. The final standings read Inter (91 points), Milan (79), Atalanta (78), Juventus (78) and Napoli (77). CONFERENCE LEAGUE

had put Spezia ahead.

Guardiola suggested Aguero would soon be signing a contract at Barcelona. "Maybe I'll reveal a secret. "He's going to play alongside the best player in all time, Lionel Messi. I'm pretty sure he's going to enjoy it.

It was a first chance for City's fans to salute the champions and acknowledge their European exploits, and they certainly made their presence felt throughout the afternoon. Before the game, big numbers spilled into the streets as City's team coaches made what is normally a straightforward journey from the nearby training complex to the stadium.

Only 10,000 were permitted inside the stadium but the atmosphere they generated inspired the team. Everton formed a guard of honor to greet City players as they came onto the field and players from both sides then did likewise for Aguero.

Roma came back from two goals down against Spezia for a 2-2 draw to take seventh place and a spot in the new Europa Conference League for incoming coach Jose Mourinho.

Giro d'Italia: Bernal Mickelson the oldest Major champ conquers Stage 16

Rome, May 24: Egan Bernal stamped his authority on the race by soloing to victory on stage 16 of the Giro d'Italia 2021 Monday after attacking on the final climb of the day before descending to the line.

The Colombian cyclist has battled grim weather to not only win the stage, but also strengthen his grip on the overall leader's Maglia

The queen stage of the Giro d'Italia – the race from Sacile to Cortina d'Ampezzo, was shortened from 212km to 155km due to cold, wet and snowy conditions. Two high-altitude climbs at the Fedaia and Pordoi passes were also cut from the race.

Bernal made his move half-way up the 10-kilometre first-category climb, after EF Education-Nippo had shredded the bunch to an elite selection of GC riders. The Colombian breezed past the breakaway remnants to lead alone over the 2236metre summit of what was now the 'Cima Coppi' - the highest point in the Giro - and he safely negotiated the 17km descent to celebrate his second stage win in Cortina

d'Ampezzo. The Ineos Grenadiers rider battled against the elements to finish 27 seconds ahead of Frenchman Romain Bardet and Italy's Damiano Caruso. Bernal now has a lead of two minutes and 24 seconds over second-placed Caruso in the general classification rankings.

Kiawah Island (US), May 24: Phil Mickelson has delivered so many thrills and spills over 30 vears of pure theater that no one ever knows what he will do next. His latest act was a real stunner: A major champion at age 50.

Mickelson captured his sixth major and by far the most surprising Sunday at the PGA Championship. He made two early birdies with that magical wedge game and let a cast of contenders fall too far behind to catch him in the shifting wind of Kiawah Island.

He closed with a 1-over 73, building a five-shot lead on the back nine and not making any critical mistakes that kept him from his place in history.

Julius Boros for 53 years held the distinction of golf's oldest major champion. He was 48 when he won the 1968 PGA Championship in San Antonio.

Pure chaos broke out along the 18th hole after Mickelson hit 9iron safely to just outside 15 feet that all but secured a most improbable victory. Thousands of fans engulfed him down the fairway — a scene typically seen only at the British Open - until Mickelson emerged into view with a thumbs-up.

Chants of 'Lefty! Lefty! Lefty! chased him onto the green and into the scoring tent, his final duty of a week he won't soon forget.

Three months after 43-year-old Tom Brady won a seventh Super Bowl, Mickelson added to this year of ageless wonders. Mickelson became the first player in PGA Tour history to win tournaments 30 years apart. The first of his 45 titles was in 1991 when he was still a junior at Arizona State.

Mickelson became the 10th player to win majors in three decades, an elite list that starts with Harry Vardon and was most recently achieved by Tiger Woods.

Brooks Koepka and Louis Oosthuizen had their chances, but only briefly. Koepka was 4 over on the par 5s when the game was still on and closed with a 74. Oosthuizen hit into the water as he was trying to make a final run and shot 73. Mickelson finished at 6-under 282

The victory came one week after Mickelson accepted a special exemption into the US Open because at No.115 in the world and winless the last two years, he no longer was exempt from qualifying.

He had not finished in the top 20 in his last 17 tournaments over nearly nine months. He worried that he was no longer able to keep his focus over 18 holes. And then he beat the strongest field of the year - 99 of the top 100 players - and made it look easy.

Hospitalised Milkha in 'stable' condition

Chandigarh, May 24: Legendary Indian sprinter Milkha Singh, who has tested positive for COVID-19, was Monday hospitalised, with his son and ace golfer Jeev Milkha Singh saying that the move was a precautionary measure.

The 91-year-old Milkha had been in home isolation at his Chandigarh residence after he tested positive for the virus Wednesday. He has now been admitted to Fortis hospital in Mohali. Hospital sources said that

Milkha's condition was 'stable'.

"He has been hospitalised. He was weak and not eating since yesterday, so we had to hospitalise him. Though his parameters seemed alright, we thought it is safer to have him admitted where he would be under supervision of senior doctors," Jeev told this agency.

"He is under good care of doctors there. He is a strong man, always positive and will recover soon,' added the golfer, who reached here Saturday from Dubai after his father tested positive.

Milkha had earlier said that a couple of house helps had been infected by the virus after which his family underwent tests. "Only I returned positive on Wednesday and I am surprised," Milkha had told this agency after testing pos itive.

None of the other family members, including Milkha's wife Nirmal Kaur, a former India volleyball captain, returned a posi- ২ tive test.

"Wishing speedy recovery to 'Flying Sikh' Milkha Singh Ji who has been admitted in hospital in Mohali for #Covid19 treatment. Get well soon Sir!" Punjab chief minister Capt. Amarinder Singh tweeted.
