STATE ORDERS 5K SACHETS OF 2DG DRUG

Bhubaneswar, May 29: The state government Saturday placed an order for 2-deoxy-D-glucose (2DG), the oral anti-viral drug for Covid-19 patients developed by Defence Research and Development Organisation (DRDO) in collaboration with Dr Reddy's Laboratories

The Health and Family Welfare department has placed the order with Hyderabad-based Dr Reddy's Laboratories (DRL) for purchase of 5,000 sachets of 2DG drugs. The price of 2DG has been fixed at ₹990 per sachet. The drug will be of immense benefit to the people suffering from Covid-19, sources said.

While the product has been softlaunched a couple of weeks ago, the commercial launch and supply of 2DG to major government and private hospitals is expected to commence in mid-June.

The 2DG drug can be administered only on prescription to hospitalised Covid patients suffering from moderate to severe symptoms.

According to a statement issued by the Union government, clinical trial data of the drug shows that the molecule helps in faster recovery of patients hospitalised with Covid-19, and reduces their dependence on supplemental oxygen.

The drug accumulates in cells infected by coronavirus and prevents the growth of the virus by stopping viral synthesis and energy production. Its selective accumulation in virally-infected cells makes this drug unique.

REMAINING IPL MATCHES IN UAE

NEW DELHI: Indian Premier League's (IPL) remaining matches this season will be held in United Arab Emirates in the months of September-October, the Indian cricket board confirmed Saturday. "The Board of Control for Cricket in India (BCCI) Saturday announced to complete the remaining matches of VIVO Indian Premier League 2021 season in the United Arab Emirates (UAE) considering the monsoon season in India in the months of September-October this year," said a statement from the BCCI Saturday. "The decision was taken at a Special General Meeting (SGM) held virtually, where members unanimously agreed to resume IPL," the statement added. The BCCI will also speak to the International Cricket Council (ICC) regarding the T20 World Cup scheduled to be held in India in October-November.



New Delhi, May 29: The Centre will borrow ₹1.58 trillion (\$22 billion) from the market to compensate the states for a shortfall in tax receipts this fiscal year, but it deferred cutting taxes on medicines and medical equipments used to treat Covid-19 patients.

This borrowing would be additional to the ₹12 trillion (\$166 billion) it already plans to raise in the fiscal year that started April 1.

India's deadly second wave of coronavirus that killed thousands of people in the last two months is now threatening an economic revival that had begun to take hold since the beginning of the year. The economy is showing signs of distress, such as falling tax collections and slump in sales of a variety of goods, including automobiles.



The Goods and Services Tax (GST), India's biggest tax reform, was introduced in 2017 to replace an array of federal and state duties. State governments were promised compensation through a surcharge on taxes on luxury goods for five years to ensure 14% annual growth in GST revenue.

Union Finance Minister Nirmala Sitharaman told the media after the meeting with the Goods and Services Tax Council, which she chairs and includes all state Finance Ministers of the country. The outcome of the meetbers and experts, after it deferred reducing taxes on Covid-19 related medical equipments and medicines.

"The council has failed to address major pain points of the industry and the common man resulting from the pandemic," said Rajat Bose, partner at Shardul Amarchand Mangaldas & Co. a law firm.Sitharaman said that a committee would be set up to look into reducing rates of various medical equipments and medicines. The committee would submit its report in the coming 10 days, she added.

Remains of 215 children found at closed native school in Canada Kamloops Indian Residential School was the largest of 139 boarding schools set up in the late 19th century

Ottawa, May 29: The remains of 215 children have been discovered on the grounds of a former boarding school set up more than a century ago to assimilate Canada's indigenous people, according to a local tribe.

A specialist used ground-penetrating radar to confirm the remains of the students who attended the school near Kamloops, British Columbia, the Tk'emlups te Secwepemc tribe said in a statement late Thursday.

'Some were as young as three years old," said chief Rosanne Casimir, calling it "an unthinkable loss that was spoken about but never documented" by school administrators.

Its preliminary findings are expected to be released in a report next month, she said.

In the meantime, the tribe is working with the coroner and museums to try to shed further light on the horrific discovery and find any records of these deaths.

It is also reaching out to the students' home communities across British Columbia and beyond.

"My heart breaks for the families and communities impacted by this tragic news," Crown-Indigenous Relations Minister Carolyn Bennett said in a tweet, offering government support for their "healing as we honour loved ones lost

The Kamloops Indian Residential School was the largest of 139 boarding schools set up in the late 19th century, with up to 500 students registered and

attending at any one time. It was operated by the Catholic

church on behalf of the Canadian government from 1890 to 1969.

Some 150,000 Indian, Inuit and Metis youngsters in total were forcibly enrolled in these schools, where students were physically and sexually abused by headmasters and teachers who stripped them of their culture and language.

Today those experiences are blamed for a high incidence of poverty, alcoholism and domestic violence, as well as high suicide rates, in their communities

A truth and reconciliation commission identified the names of, or information about, at least 3,200 children who died from abuse or neglect while attending a residential school. The exact number remains unknown.

Ottawa formally apologised in 2008 for what the commission later termed a "cultural genocide" as part of a Can\$1.9 billion (\$1.6 billion) settlement with former students.

RMRC to study post-vax infection & severity

Bhubaneswar, May 29: Even as the state is witnessing several cases of Covid-19 infection and severity in people who have already taken two doses of the vaccines, the state government has asked the Regional Medical Research Centre (RMRC) to conduct a follow-up study in this regard.

Health and Family Welfare department additional chief secretary (ACS), PK Mohapatra has written a letter to RMRC director Sanghamitra Pati to this effect.

"Some cases of Covid-19 positive cases are being reported from various districts of Odisha post double doses of the vaccination. In this regard, it is requested that RMRC, Bhubaneswar may carry out a follow-up study to assess the hospital isation and severity among Covid 19 positive individuals post vaccination as compared to nonvaccinated Covid positive individuals," Mohapatra wrote to the director. Gangrape victim gets ₹3.50L aid at NHRC's behest

Bhubaneswar, May 29: The victims of rape or other heinous crimes rarely receive any financial aid under the much touted Victim Compensation scheme. However, some managed to receive the aid after the intervention of courts and rights bodies.

A gangrape victim, a minor girl, from Ganjam district has recently received Rs 3.50 lakh as compensation under the Victim Compensation scheme following the intervention of National Human Rights Commission (NHRC). The police also arrested the accused persons involved in the heinous crime after being chided by the commission.

According to sources, the eightyear-old girl from Polasara area of Ganiam was raped by some miscreants near her residence October 31, 2018. Later. Congress leader and advocate Nishikant Mishra approached the NHRC seeking the commission's intervention in the matter in November, 2018. Mishra had urged the commission to direct the district administration to immediately arrest the culprits and award financial compensation to the victim's family.

On March 1, 2021, the NHRC issued summon for personal appearance of the Ganjam SP before the commission April 29, 2021. A livid commission also warned SP of criminal action against him.

The SP then provided Rs 3.50 lakh compensation to the victim through the District Legal Services Authority of Ganjam.

Urban poor left to beg as lockdown continues

Bhubaneswar, May 29: It's another morning here and a 26-yearold Heena Sheikh scoots off to her nearest general store but not to buy ration, rather to beg from those who can lend a helping hand to her.

A migrant from neighbouring Chhattisgarh. Heena is one of the many who have borne the brunt of the month-long lockdown clamped in the state including the Capital city. Heena, a hapless mother of four and a widow, used to sell balloons and brooms at traffic signals until lockdown strangled her

livelihood "My husband passed away recently which brought me immense misery. My **SPECIAL** eldest son, who is at his tender age of 15, works as a daily wager but he is left with no work. I am left with no other option than to beg for food. Even though some benevolent people buy me daily ration, it becomes hard to stock up the food for weekend shutdowns," Heena lamented. While the entire state is under Covid-induced lockdown, tales of such misery are many among the urban poor even in the Capital city. However, urban planners and activists here say that the measures taken by the civic authority are not enough. "The condition of poor on city outskirts like Jatni, Mendhashala, Pahala is even worse. No one reaches out to them. Moreover, these destitute have no idea which NGOs are operating in their area and how to contact them. As their means of earning have been shut, they are left with nothing to arrange even one meal a day for survival," said Susanta Behera, a right to food activist here.

"We have registered an FIR in this regard with Singhadwar police," Sahu said.

"However, our IT team is investigating to find out whether the photo is a real one. The team's report will decide the future course of action," he added

The devotee reportedly tagged the photo to the Facebook accounts of eight people, including a senior servitor of Srimandir.



While the picture is suspected to have been captured with a mobile phone, it is vet to be understood how devotees manage to enter the temple precincts with their mobile phones when phones and cameras are strictly prohibited at the

Despite round-the-clock tight security and presence of metal detectors at the four gates, the in-

Meanwhile, the floodwaters in Subarnarekha in Balasore district started receding after crossing the danger mark at Rajghat at Jaleswar. The floodwaters have started receding following a stop in the rainfall in the upstream in Jharkhand and the Galudihi barrage closing its gate. The decline in floodwaters has brought a sigh of relief to the residents who are battling to save their lives and properties.

People are having a harrowing time with floodwaters entering their houses and farmlands. As the floodwaters in Kansabansa are increasing large tracts of land in Jagannathpur and Padhuan panchayats have been submerged. The

riparian villages remained marooned while the floodwaters entered houses in low-lying areas.

Fishermen and traders who have been carrying out fish and prawn cultivation in the islets of these two rivers have suffered terrible losses after the floodwaters submerged their ponds and gheries. Moreover, vegetable cultivation on hundreds of hectares near the riverbanks has been damaged.

Cough syrup racket busted in Bolangir

Bolangir, May 29: Police Saturday busted an interstate cough syrup smuggling racket and seized 14,400 bottles from a truck in Kandagada forest under Turekela police limits in Bolangir district. The cops arrested two persons for their involvement in smuggling of cough syrup bottles worth over ₹20 lakh.

One of the arrested persons is the driver of the truck and a resident of Karnataka, while the second one is a resident of Khujenbahal under



Turekela police limits. The police were tipped-off that a truck with a consignment of Ascoril cough syrup bottles was passing through

Kandagada forest. A team was formed and it raided the forest and seized the truck. Upon carrying out a search. they found 14,400 cough syrup

bottles in 90 cartons. As the driver and another occupant of the truck couldn't produce any valid documents to prove their innocence, they were arrested.

In a press release, Bolangir SP Kusalkar Nitin Dagdu informed that the accused were planning to sell the cough syrup bottles through local retailers at inflated prices.

The police also seized some tablets and ₹13,000 in cash from the accused. A detailed investigation is underway to find out if others are involved in the racket.

Kendrapara, May 29: A 50-year-old man was arrested Saturday for allegedly thrashing a stray dog to death in Kendrapara district, police said.

The accused, Babula Singh -- a native of Praharajpur locality, was arrested after the video of the fatal assault on the dog went viral on social media, police said.

Singh was booked under Section 429 of the IPC that deals with mischief by killing or maiming cattle of any value or any animal of the value of ₹50

During interrogation, the accused told the police that the dog had killed two cocks, which provoked him to thrash the animal, they said.

Police took cognisance of the viral video and arrested Singh after verifying the content, an officer said.

Singh was booked under Section 429 of the IPC that deals with mischief by killing or maiming cattle of any value or any animal of the value of ₹50. Further, Section 11(1) of the Prevention of Cruelty to Animals Act, 1960 was imposed on him. A court in the district sent him to judicial custody.

Angul Covid graph rises as police go soft on violators

Angul, May 29: Covid-19 cases have been on the rise in Angul district and this has been ascribed to the police administration being lenient towards Covid violators during lockdown.

Pandemic-induced lockdown is underway in the state since May 5. There are weekend shutdowns as well. A relaxation of some hours has been given for people to buy essentials. At the same time, the government has asked people to go to shops and markets within walking distance



These guidelines were seen flouted with impunity in Angul town Friday.

Ahead of the weekend shutdown, people thronged almost all the markets, specifically fish markets in the town. People were seen pushing each other to buy fish at shops. While none seemed to be careful about maintaining social distance, many were seen wearing masks improperly. Some town dwellers alleged that cops on duty in fish markets were looking the other way.

"If the district and police administrations don't take stringent action against Covid violators, the situation will go from bad to worse in coming days," said Shantanu Kumar Sar, an educationist

According to some residents, the police department has been short handed since many cops are presently undergoing treatment for Covid-19. This is the reason the police department is not able to perform up to expectation. Taking advantage of this, Covid violators were seen fearlessly roaming around the town riding bikes

When contacted, Angul SP, Jagmohan Meena, said they are taking action against the violators. "Fines are being collected from them. We have not been shorthanded. Angul town police will be asked to conduct raids more frequently in markets," Meena said.

Angul Sub-Collector; Basudev Satpathy, said the violators are being penalised and made aware of Covid rules and their importance. Yet, reports of markets being overcrowded are arriving. Soon there will be a meeting involving administrative and police officials to find a way out. There will be a magistrate accompanied with policemen at each and every square to deal with Covid violators, Satpathy said.

Angul Saturday reported 515 new Covid cases. With this the district's case load has gone up to 31,998, with 6,659 active cases.

Science, spirituality & Swami Chetanananda

DHANADA K MISHRA

t must have been in the last week of December 2001 when I saw my father Crying for the first time. It was the annual bhakta sammilani (gathering of disciples) being held in Rajgangpur, Odisha. My father had retired from his position as Dean of Research at Odisha University of Science and Technology (OUAT) in 1993. He had taken sanyas shortly afterwards in 1995 from Swami Vishuddhananda Saraswati in the order of Srimad Swami Nigamananda Paramahamsa. For someone with a PhD from the University of California and lifelong pursuit of science as a teacher and researcher of international repute, it was a bit of an odd scene for me. A long line of disciples waited their turn to take leave of their Guru and as each one got up on the stage and prostrated, my father would bless him/her, ask about their wellbeing and say goodbye. Through the process that lasted 2-3 hours, I was stunned to see that tears flowed freely and nonstop down his cheeks! But when his mother passed away in 2005, I don't remember seeing him cry, at least not in public!

In his book "Wake Up - Searching for Spirituality Without Religion," wellknown neuroscientist, philosopher and spiritualist Sam Harris describes his first experience with the hallucinogenic drug called ecstasy in his early twenties. He felt an expansion of his consciousness in a way that made him feel infinite love and compassion for his companion and, in fact, for all living beings. The experience was so powerful that he spent the next several years searching for the same experience without using the drug. His quest took him to many monks, yogis, gurus in India and Nepal until he became adept at the meditation techniques that would take him to the depth of spiritual experience.

After that moving experience in 2001, I would on several occasions witness



my father sobbing like a child as he would meditate in the early morning on rare occasions he was home. Born on 27 March 1933 in a poor family in Digapahandi of Ganjam district, Prof (Dr) Chakrapani Mishra studied in Digapahandi high school, SCS College, Puri, BHU, IARI and finally received his PhD in Agriculture Sciences from the University of California, Davis. From his childhood, he was a profoundly religious person, accomplished the highest level in scientific pursuits, and also experienced spiritual bliss through both yogic techniques and the twin paths of knowledge and bhakti. He has described it in some detail in his recently published autobiography - Atmajyoti (Inner Light). Most importantly, his life illustrated how to reconcile the apparent contradictions between religion, science and spirituality. It's a very delicate and subtle balance and very difficult to achieve for us ordinary mortals.

From time immemorial, man has looked up in awe and wonder at the sky and the splendour of nature to try and figure out the secrets of the universe. Such contemplation has given birth to deep insights into the nature of creation and the meaning of life in the broader context. Some of it is beautifully captured in the wisdom embedded in ancient Indian

texts like the Upanishads and the Vedanta. In his autobiography, Swami Chetanananda says in the foreword to his book -- "Spirituality is the realisation of self and identification of it with the supreme consciousness. Vedanta explains spirituality using four mahayakyas (aphorisms): Aham Brahmasmi (I am the brahman or the super soul, super consciousness), Tat Twam Asi (Thou art thee, you are Him or the soul itself is the super soul or the creator), Ayamatma Brahman (this Self / Atman is Brahman) and Prajnanam Brahman (Insight is Brahman)." When one takes sanyas, he/she is instructed by the Guru to go on a pilgrimage to the four famous spiritual centres (Badrinath, Dwaraka, Puri and Rameswaram) and reflect on these four aphorisms to identify oneself with their import which has the power to expand one's consciousness. Such a profound realisation has the capacity to take one beyond the mundane transitory world of pleasure and pain and instead help one achieve the highest of all goals spiritual bliss.

"Science and spirituality are twin driving forces in my life. Science seeks truth by reasoning, and so does spirituality. In a way, science and spirituality seek the same divine blessings for a happy life." It is the essence of my father's life in his own words.

I feel privileged to have been born to a person who made it possible for me to have an upbringing in which religion, science and spirituality have been in harmonious coexistence. As I peek from the base of Mount Everest with my own fleeting experiments to try and grasp the enormity of the peak at the distance, I feel my father in my heart. I realise that being free of his physical body he has become available to me or anyone seeking him anytime and anywhere. We celebrate his life as we fully understand the message of the Bhagavad Gita that the body is transient but the soul is immortal.

If Big Tech has been able to gain so much influence over people's lives, then these same technologies could be much more dangerous in the hands of governments

These developments have three major implications for how the state functions. For starters, governments can potentially deliver services better, faster, and at lower cost. If Amazon, Google, and Facebook can harness big data to provide a huge number of customers with a seamless and efficient experience, while relentlessly seek ing to improve it, surely governments can do the same for their citizens. In India, for example, the federal government gave over one billion citizens a unique digital identity in just over five years at

a cost of less than \$1 per person. More worryingly, governments can also use digital tools to gain greater control over their citizens, monitor them more closely, and accrue more power. If Big Tech has been able to gain so much influence over people's lives, then these same technologies could be much more dangerous in the hands of governments. For example, the Chinese government's Social Credit System uses digital technologies

to track citizens' and businesses interactions and transactions, and assigns them a rating that combines Western-style credit scores with more expansive and intrusive reputational scores based on their public and private behaviour. These ratings have real consequences for people's access to employment, finance, and social services, as well as their freedom to travel.

Then there is the question of how governments should view and manage the private sector's use of such tools and technologies. Policymakers must decide how to regulate immensely powerful digital platforms, and how to engage with large and small firms to stimulate innovation and drive inclusive growth. Although digital technologies are recent inventions, the question of how to balance government effectiveness and individual liberty is far older. In 1936, John Maynard Keynes noted that, 'The authoritarian state systems of today seem to solve the problem of unemployment at the expense of efficiency and of freedom." But, he added, "it may be possible by a right analysis of the problem, to cure the disease whilst preserving efficiency and freedom.'

Meeting this challenge will re-

quire governments to adhere to four key principles. First, states must be responsive to citizens' needs. In designing and delivering public services, they need to work outside-in, from the perspective of the people who use them, rather than inside-out, from public officials' viewpoint. Countries like the Netherlands are doing this in areas such as social care.

Second, the state must be inclusive, and balance the interests and needs of different groups of citizens. In designing social-security and employment laws, for example, governments must weigh the needs of employers against those of job seek ers. This is the goal of Denmark's "flexicurity" system, and of experiments with universal basic income schemes around the world.

Third, states need to experiment. They should constantly test new initiatives in pilot programmes to reduce the risk of failure, evaluate them, and then scale up the ones that work. The UK has done this in education and criminal justice through the Behavioural Insights Team and the What Works foundations.

Fourth, states must be entrepreneurial. That means proactively engaging with new technologies and firms, regulating them in innovative ways, and cultivating them so that they flourish. Examples include the UK's regu latory sandbox approach to fostering the fintech and autonomousvehicle sectors.

With the world reeling from the pandemic and struggling to address complex systemic issues such as climate change, it is vital that we return to the fundamental question of politics: how a government should be. If we don't ask it - and ask it often - we risk ending up with a government we would never choose.

Gig workers: Genesis, problems, possibilities

tion technology, increasing usage of smart-phones, dissemination of digital literacy and modes of digital payments have accelerated creation of a new breed of workers. Occupying a space between informal and formal workforce, they are termed as 'gig workers' and are a product of a technology-platform based service ecosystem. The potential for the Indian economy has been brought out recently in a report titled 'Unlocking the Potential of Gig Economy in India' published by the Boston Consulting Group. The report estimates the gig economy has the potential to serve 90 million jobs (roughly 30% of India's nonfarm workforce) and add up to 1.25% incrementally to GDP growth. An ideal gig worker is an individual with the flexibility and option to choose when to work and for whom to work. He works for a fixed time, in lieu of pre-negotiated wages/fees. The interface, between a worker and his client, is enabled by a technology platform. It is a self-regulating and self-rewarding ecosystem, where earnings are proportional to the number of hours put-in by the gig worker. In the past, the Jajmani system created a framework of patron-client relationship. Within this personalised framework, largely suited to a rural, agrarian economy, various kinds of service-providers parted with their skills and rendered requisite services over generations, in exchange for goods through a barter system.

Neurocinematics

n essence, this is the study of the way watching films affects the human mind. The term was invented in a paper by Uri Hasson in 2008, which showed that some films exert considerable control over brain activity and eve movements but that this depended - as one would expect - on their content, editing, and directing style. The paper suggested that this work, using magnetic resonance imaging, could lead to a fusion between film studies and cognitive neuroscience and suggested the name neurocinematics for it. In February 2010, research by Professor James Cutting and his team at Cornell University was widely reported. They measured the length of every shot in 150 high-grossing Hollywood films released between 1935 and 2005. The more recent the film, the more likely it is that the pattern of duration of shots matches the attention span of its audience. This pattern, known as the 1/f rule or pink noise rule, had been deduced in earlier studies of volunteers working on tasks. It seems that, through experience, film editors have intuited the formula. The term has appeared a number of times online but only rarely in print. As yet, it's a niche formation and may not survive.

as oil and gas, healthcare and beauty, construction, retail. According to a rough estimate, there are around 200 million blue/grey collar workers in India, who in a way are potential gig workers. The number of workers registered on various digital platforms comes to 10-15 million. These numbers are indicative of the immense scope that exists for scaling up. For this, certain fundamental issues relating to skilling, financial inclusion and capacitybuilding need to be addressed.

The first issue is bridging the skill divide. It is a fact that students emerging out of formal education or vocational ecosystem are mostly not 'employable'. The poor quality of pedagogy and training, requires such platforms to invest substantially in upgrading skill sets of those who seek onboarding onto the respective platforms. This indicates the limitation of the skill-modules being undertaken by government under various sponsored schemes - Prime Minister Kaushal Vikash Yojana, Deen Dayal Upadhay Grameen Kaushal Yojana and a plethora of other programmes being run by various ministries. It calls for close coordination with such tech-platform aggregators with respect to

up-skilling of existing workforce. This has the potential to be a gamechanger, as it will facilitate transition of a large majority of unskilled and semi-skilled workers into more aspirational gig work space. A well designed curriculum, qualified trainers and a credible certification system will have a critical role to play.

The second issue is with respect to supply-side information asymmetry. For instance, there is a huge shortage of good quality welders in the country, and the job commands a substantially higher wage vis-a-vis a normal B.Tech graduate. Outreach programmes aimed at exposing students, dropouts and their parents to myriad opportunities in various sectors will help them in taking informed decisions. This will ensure a matching between the demand for various jobroles and supply of trained and adequate manpower. Sectors like health and wellness, construction, retail and logistics are going to be significant job-generators.

The third aspect relates to providing access to capital. Many in the gig economy space are aspiring micro-entrepreneurs. They would need an initial financial support to equip themselves with tools for de-

purpose. The wide network of Rural Self-Employment Training Institutes patronised by public sector banks can be used for capacitybuilding of prospective workers. Creating an appropriate business model, along with imparting training in rudimentary book-keeping, digital technologies and soft-skills will enable them to boost their earnings and also better equip them negotiate various regulatory and legal landscapes.

In times to come, gig workers will come to play an important role in India's economic landscape. Therefore, it is also imperative to devise appropriate intervention strategies for their welfare, create a reliable database. Flexibility of timing sets women free from the rigidity of 10-5 routine. It will foster greater women participation in labour force. Recognising the potential of the sector, the government has taken a decision to collect information and extend social benefits like ESIC to such workforce. As we go along, the gig worker is going to be a distinct 'technological class', beyond the Marxist binary of bourgeoisie and proletariat.

Kerala extends lockdown

Thiruvananthapuram, May 29: The Kerala government Saturday announced one more week extension of the statewide lockdown till June 9, to contain the spread of the Covid-19 pandemic, with some relaxations to perform essential activities

Chief Minister Pinarayi Vijayan announced the extension of the shutdown at a press conference here.

"Although prevalence of the disease is declining significantly in the state, we have not yet reached a stage to remove restrictions. The lockdown will continue in all districts from May 31 to June 9," the chief minister said.

The state has been under lockdown since May 8 following the sharp rise in coronavirus cases. The chief minister also an-

nounced withdrawal of "triple lockdown" in Malappuram district, where the number of cases was high.

However, the general lockdown will continue in the district along with other districts in the state. The government had earlier ex-

tended statewide lockdown twice - May 16 and May 23 - after reviewing the situation.

Kolkata, May 29: More than 96,000 hectares of agricultural land has been inundated in parts of an eastern Indian state hit by a powerful storm this week, a year after the coastal region was ravaged by a super cvclone.

Cyclone Yaas swept in from the Bay of Bengal Wednesday, triggering storm surges that broke through embankments in West Bengal state, particularly hitting hard the ecologically sensitive Sundarbans delta that stretches into neighbouring Bangladesh.

Initial assessment by the West Bengal government showed that water had entered around 96,650ha of land that had standing crops, a state official said.

Fresh flooding was reported from many areas during high tides as the embankments have been left with gaping holes, West Bengal's fisheries minister Akhil Giri said. In the Sundarbans, still reeling from the damage wrecked by Cyclone

Amphan last year, residents said wide swathes of farmland and fresh water ponds used for small-scale

fisheries had been inundated. The area is stinking with rotten fish and movement has become extremely difficult because of stagnant water, said Kanai Haldar, a resident of Raidighi in the Sundarbans, where spurs and dykes meant to hold back floodwaters have been damaged.

With climate change pushing

up sea surface temperatures, the cyclonic storms that barrel in from the Bay of Bengal have become fiercer and more frequent, particularly in the last decade, according to researchers.

Haldar said the damage caused by Yaas appeared more significant compared with last year's storm, because of the scale of sea water ingress, which often ren-ders farmland temporarily unfit for cultivation.

DAILY RISE IN COVID CASES AFTER 45 DAYS

New Delhi, May 29: The single day rise in coronavirus cases was recorded at 1,73,790, the lowest in last 45 days, taking India's total tally of Covid-19 cases to 2,77,29,247, according to the Union health ministry data updated Saturday.

The daily positivity further declined to 8.36 per cent, remaining below 10 per cent for five consecutive days, while the weekly positivity rate dropped to 9.84 per cent, it said.

The death toll climbed to 3,22,512 with 3,617 fatalities, the data updated at 8 am showed.

Also, 20,80,048 tests were conducted Friday taking the total cumulative tests conducted so far for detection of Covid-19 in the country to 34,11,19,909, the ministry said.

The active cases have further reduced to 22,28,724, comprising 8.04 per cent of the total infections, while the national Covid-19 re-



covery rate has improved to 90.80 per cent, it said.

The number of people who have recuperated from the disease surged to 2,51,78,011 while the case fatality rate stands at 1.16 per cent, the data stated.

India's Covid-19 tally had crossed the 20-lakh mark August 7, 30 lakh August 23, 40 lakh September 5 and 50 lakh September 16.

It went past 60 lakh September 28, 70 lakh October 11, crossed 80 lakh October 29, 90 lakh November 20 and surpassed the one-crore mark December 19. India crossed the grim milestone of 2 crore May 4.

While all crewmen were saved by the Indian Navy and Indian Coast Guard battling extreme weather conditions in the Arabian Sea during those three harrowing days, a new problem has emerged now with oil seeping out of the stranded vessel, 12 days after it hit the ground.

Jindal said directions have been issued to ensure emergency triage and treatment services for newborns and children at all levels.

Directions have also been issued to make all non-functional equipment in SNCUs functional at the earliest. he said.

Jaipur, May 29: Nurseries of the Rajasthan Forest department are developing hundreds and thousands of medicinal plant saplings that shall soon be gifted to state residents as part of state government's

'Ghar Ghar Aushadhi Yojana'. The mega scheme plans to reach out to all 1,26,50,000 families residing in the state (according to census 2011), extending them an opportunity to take home saplings of the four selected medicinal herbs, namely Tulsi, Aswagandha, Gilloy and Kalmegh.

In the five-year duration of the scheme, each family shall be entitled to receive 24 saplings, starting with eight saplings in the first year, that aggregates to more than

30 crore saplings. These plants have been native to Rajasthan and have traditionally been used as health supplements and in herbal medicines. As part of the campaign the plant saplings will be provided with information on their upkeep and

proper use. Rajasthan is rich in biodiversity and is home to several medicinal plants. The Ghar Ghar Aushadhi



Yojana of the state government will help in conservation of this natural wealth and help people understand the importance of herbs and plants around them for health," said Sreya Guha, Principal Secretary Forest and Environment Department, Rajasthan.

Several of the state government departments are contributing to make the scheme a success. While the Forest Department is the nodal department for the scheme, district level task forces have been constituted in all districts under their respective District Collectors to ensure due implementation at ground level. The scheme will be monitored by state level committee headed by the state chief secretary.

A fund of ₹210 crore has been sanctioned by the state government for the five-year scheme, of which ₹31.4 crore will be spent in first year for distributing more than 5 crore saplings among half of the households in state.

New Delhi, May 29: The National Commission for Protection of Child Rights (NCPCR) has asked all states and union territories (UTs) to upload data of children who have lost either one or both parents to

Covid-19 on its portal. Women and Child Development Minister Smriti Irani had Tuesday said as many as 577 children across the country were orphaned after their parents succumbed to Covid-19, citing reports of states and union territories from April 1 till March 25.

The announcement by the apex child rights body comes a day after the Supreme Court directed all district officers across the states/UTs to fill data related to children who have lost either one of both parents to Covid within 24 hours on the Bal Swaraj portal under the 'Covid Care' link.

Bal Swaraj is an online tracking portal of the NCPCR for children in need of care and protection. "Keeping in view the current situation of Covid-19, the

Commission has extended the use of this portal for tracking children who have lost both parents or either of them... and provided a link under the name of 'Covid Care' on this portal for filling of data of such children by the concerned officer/department," the NCPCR said in a letter to all principal secretaries of the states'/UTs' Women and Child Development Department.

The NCPCR said the login ids of district child protection officers for uploading the data and filling up the forms of social investigation report and individual child care plan as provided by the commission have been issued.

The login ids for all principal secretaries for uploading of data on the portal concerned with the state government have also been issued.

New Delhi, May 29: A Delhi court Saturday granted bail to businessman Navneet Kalra arrested in a case for alleged hoarding of oxygen concentrators.

Judge Arun Kumar Garg directed Kalra not to contact anyone to whom he sold the oxygen concentrators. The Delhi Police have opposed Kalra's bail plea in the court stating that his intention was to cheat persons in vulnerable condition and make profit. The court, while granting bail, imposed three conditions on him he will not tamper with the evidence in the case, make no attempt to influence the witnesses and he will also join the investigation whenever required.

Kalra was granted bail subject to personal bond of ₹1 lakh and two sureties of the like amount. The police had cited report from medical devices testing laboratory, and argued that the seized oxygen concentrators were useless and in fact, harmful for the persons using it. Kalra's counsel argued that no



purpose would be served by keeping his client in pre-trial detention as no more recoveries have to be made from him. The court had earlier dismissed Delhi police plea seeking five days police custody of Kalra in the case

Kalra was on the run after the seizure of 524 oxygen concentrators from three restaurants -- Khan Chacha, Town Hall, and Nege & Ju - owned by him, but later he was arrested by the police. Four employees of Matrix Cellular company, including its CEO and vice president, who were also arrested, were granted bail in the same case. Kalra bought oxygen concentrators from Matrix Cellular which imported them

A case was registered against Kalra May 5 under Section 420 (cheating), 188 (disobedience to order duly promulgated by public servant), 120-B (criminal conspiracy) and 34 (common intention) of the Indian Penal Code. The case was also registered under Essential Commodities Act and Epidemic Diseases Act.

New Delhi, May 29: Scientists have found that natural indigo dye, extracted from leaves of a plant of the bean family, is capable of protecting human eye from harmful laser radiation.

It can be used to develop optical limiters for weakening potentially harmful radiation and protecting the eves and sensitive optical devices from accidental damage in an environment where lasers are in use, the Department of Science and Technology said in a statement Saturday.

Researchers from the Raman Research Institute (RRI), and Kensri School and College, Bengaluru,

studied the optical properties of natural indigo dye and found that it can protect human eyes from harmful laser radiation. The study, funded by the Department of Science and Technology, Government of India, was published in the journal 'Optical Materials'.

The researchers extracted the dye and stored it in a refrigerator below 4 degrees Celsius to preserve its natural properties. Their study on how much it ab-

sorbed light at different wavelengths of the electromagnetic spectrum showed that the absorption is maximum in the ultraviolet region of the spectrum, at a wavelength close to 288 nanometres, and in the visible region, close

to 660 nanometres. The absorption is comparatively



high for the green light as well. 'Indigo absorbs light because The team found that when they increase the intensity of the laser pulse, the dye absorbs more light. That is, it is more opaque to higher intensity light. Scientists refer to such materials as an 'optical limiter'

of molecular absorption bands. The maximum absorption wavelength can vary over several nanometers depending on the dye's solvent and concentration," explained Reji Philip, a professor at RRI and a co-author of the study.

The absorption's variation with wavelength indicated that chlorophyll, an organic compound that takes part in photosynthesis, is present in the dye.

The researchers wanted to study whether the organic dye showed additional absorption when the input light intensity is high.

Optical limiters are useful in 🗎 weakening the potentially harmful radiation emitted by powerful lasers and protecting both eyes and sensitive optical instruments.

"Making a prototype optical limiter using natural Indigo is the next logical step, followed by a commercially viable product," Reji said.

Great Barrier Reef protection to be enhanced with new barge

Canberra, May 29: The protection of the Great Barrier Reef in Australia is expected to be enhanced with a barge to be built at a cost of A\$5 million (\$3 million). the Queensland state government announced.

The 19-metre vessel, based in Townsville, is designed to carry a small excavator, earthmoving machinery or 4WDs, and a rigid hulled inflatable, Xinhua news agency quoted the state government as saying. With a cruising speed of 20 knots, the floating ranger station

is expected to operate up to 270 days a year and provide overnight accommodation for seven rangers, and up to 24 for day trips.

The barge will play an important role alongside other initiatives aimed at protecting the reef, by supporting rangers to undertake extended patrol and infrastructure management duties, including protecting marine area and island national park

Environment Minister Sussan Ley said the barge would help prioritise the key conservation and rehabilitation activities. "Enhancing the resilience of our amazing islands and reefs through activities such as controlling invasive pests, re-planting native vegetation to support species like seabirds and turtles and trialling the application of reef rehabilitation techniques is a task our rangers are uniquely placed to do," Ley said.

'Income Tax Department will launch its new e-filing portal http://incometax.Gov.In on 7th June'21. It will replace the existing portal of the Department http://incometaxindiaefiling.Gov.In," the I-T department tweeted.

Giving the salient features of the "e-filing 2.0 portal", the I-T Department said there will be a "all new mobile app" and taxpayers will have a step-by-step guidance with user manuals and videos.

Besides, multiple options for on-portal tax payments, multiple options for login, helpdesk support and chatbot are the features in the portal.

E-filing services will be unavailable from June 1-6. "If you have to submit any response or avail any service please do it before or after these dates," it said.

The e-filing portal is used by the taxpayers to file their income tax returns (ITRs) and also to raise complaints seeking refunds.

Taxmen use it to issue queries, notices, get responses from the taxnaver and to communicate final orders like assessments, appeals, among others, on the taxpayers' dashboard

"Dhoni has been in that one spot his whole career and no wonder he's so good at it. Hardik Pandya and Kieron Pollard are similar - these guys continually win games of cricket for their country and in the IPL, they're used to going in batting at those spots," he added.

Ponting, who coached Delhi Capitals in the currently-suspended Indian Premier League, said one of the reasons for Australia not having a good 'finisher' was that all of the best batsmen of the country bat in top four in Big Bash League. "So you've actually got no one

'Managed isolation' for India before WTC

Dubai, May 29: The Indian team will stay in "managed isolation" before the World Test Championship (WTC) final against New Zealand the ICC announced Saturday but did not mention the exact period of hard quarantine upon reaching UK. World's top two Test teams will fight it out at the Hampshire Bowl in Southampton from June 18-22.

While New Zealand are already in England for a bilateral series against the hosts, the Virat Kohliled Indian team will arrive in the UK June 3 after competing a 14day quarantine period in India

'Upon landing, they will proceed directly to the on-site hotel at the Hampshire Bowl where they will be tested again before commencing a period of managed isolation," said the ICC release.

However the ICC release doesn't specify the duration of hard (room) quarantine in Southampton. For New Zealand team, ECB made it a three-day mandatory room quarroom quarantine and three negative tests.

However a few like skipper Virat Kohli, his white ball deputy Rohit Sharma, all of whom joined late will have a complete room quarantine before boarding the UK flight. They have been provided with gym equipments inside their rooms.

In the UK, players' activity will be allowed in a gradually increasing manner after each round of negative testing, moving from exercise in isolation to small group and then larger squad activity, whilst always remaining within the bio-secure venue.

The New Zealand team will move from the ECB bio-secure environment into the World Test Championship Final bubble June 15 and will be subject to regular testing prior to and post arrival in Southampton.

Sushil's police custody extended

New Delhi, May 29: A Delhi court Saturday extended by four days the police custody of Olympic wrestling medallist Sushil Kumar and Ajay Kumar Sehrawat, arrested in connection with the murder of a 23-year-old grappler, saying that no one is above the law.

Sushil Kumar and his associates allegedly assaulted Sagar Dhankar and two of his friends at Delhi's Chhatrasal Stadium. Sagar succumbed to injuries later. Following Sushil and Ajay Kumar's arrest, the court had remanded them in six days police custody May 23.

On being produced before the court at the end of the remand pe-

Allowing their interrogation for only four days, Metropolitan Magistrate Mayank Goel said, "No one is above law and law treats everyone equally. Though the Constitution guarantees the right to life and liberty to all persons whether they are accused or not, but that right is also subject to certain exceptions."

The allegations against the ac cused persons are very grave and serious in nature, the court said. emphasising on the importance of the initial days of investigation to unearth the truth.

The judge said the involvement of a large number of persons, some of whom belong to some notorious gangs stationed in and outside Delhi, is also suspected and they are

Or, put another way, whether a younger generation of men finally is poised to consistently win Grand Slam titles.

"I mean, I said it a thousand times. I don't know how many times people want me to repeat it. Of course the Next Gen'"-a marketing slogan pushed by the ATP — "is there, is coming, whatever. But here we are, still winning the biggest tournaments and Slams. I don't know what to tell you other than that," Djokovic said.

"I'm not focused on the Next Gen,' even though I know ... It creates a story. People like to talk about it. Fine. The guys are there. They are already establishing themselves in the Top 5, Top 10 of the world. Nothing new," he continued, then noted with pride: "But we are still there.

When the French Open begins in Paris Sunday, it will feel in some ways like order restored after the 2020 edition was altered in two significant ways because of the coronavirus pandemic: Only 1,000 spectators were let into Roland Garros per day, and competition started in September instead of May.
