

**ODISHA CM WANTS DECENTRALISATION OF VACCINATION PROGRAMME TO PREVENT 3RD WAVE**

Bhubaneswar, June 2: Odisha Chief Minister Naveen Patnaik wrote Wednesday to all his counterparts in India and urged them to build a consensus over procurement of Covid-19 vaccines by the Centre for distribution among the states. In his own way, Patnaik informed the other states that all will be better off if they are in agreement regarding the procurement of vaccines and not fight against one another.

In the letter, Patnaik wrote that no state is safe unless all adopt vaccination as topmost priority and execute it on war-footing. "The only way to protect our people against future Covid-19 waves and provide them with a hope of survival is vaccination," Patnaik wrote in the letter that he shared on Twitter. He tagged all the chief ministers. "But this cannot be a battle among the states to compete against each other to procure vaccines," Patnaik added. The Odisha chief minister noted that after the Centre announced phase-3 of the vaccine policy, allowing vaccination for everyone above the age of 18 years and opened procurement for the states and private sector, the demand

has increased. 'Many states have floated global tenders for vaccine procurement. However, it is quite clear that the global vaccine manufacturers are looking forward to the Union government for clearances and assurances," he said. "They are unwilling to get into supply contracts with the state governments.

#### **HIGHEST SPIKE IN DAILY DEATHS**

BHUBANESWAR: Odisha reported Wednesday 40 more deaths due to Covid-19. It is the highest number of casualties in a single day so far. The new fatalities pushed the toll to 2.831. a Health department official said. The state also registered 8,399 new positive cases of Covid-19 taking the total caseload to 7,82,131. The districts of Angul, Khurda, Cuttack and Kalahandi reported five fatalities each. The active number of cases in Odisha now stands at 87,220. P4

The domestic vaccine manufacturers on the other hand have supply constraints and are not able to commit to supplies required," the chief minister pointed out.

Patnaik said that under these circumstances, the best option available is for the Centre to centrally procure vaccines and distribute them among the states so that the people are vaccinated at the earliest.

"At the same time, the execution of the vaccination programme has to be decentralised and states allowed the flexibility to determine their own mechanism to ensure universal vaccination," Patnaik mentioned.

"For example, many hilly and rural areas cannot access the internet and therefore online registration has to be flexible," Patnaik added. He also said vulnerable tribes can be given priority for immunization

Patnaik said that he has already raised the matter with the Centre and also spoken to a few chief ministers. "I would respectfully suggest that all state governments should come to a consensus on this issue for early resolution of this problem. We should act fast before any third wave comes and creates further havoc," he wrote in the letter. Patnaik's letter comes a day after Odisha Health Minister Naba Kishore Das had urged Union Health Minister Harsh Vardhan to formulate a national-level policy for procurement of vaccine from global manufacturers and supply it to the states.

Bhubaneswar. June 2: With Covid-19 turning out to be a cause of concern, the Odisha government Wednesday announced a special package for the particularly vulnerable tribal groups (PVTGs).

Sources in the ST & SC Development department informed that government will provide dry rations worth ₹2,500 to all Covid-19 affected PVTG households. Incentive of ₹1,400 (₹100 per day) will also be provided to all such tribal groups who are affected by Covid-19 for stay in quarantine centres.

Similarly, free masks and sanitisers will be distributed to all PVTGs. Doorto-door survey and screening will be carried out for detection of Covid-19 symptoms, the sources said.

#### SC slams Centre over vaccination

New Delhi: Observing courts cannot be 'silent spectators' when constitutional rights of citizens are infringed by executive policies, the Supreme Court slammed Wednesday the Centre's Covid-19 vaccination policy. The apex court describing the policy as 'prima facie arbitrary and irrational' said states and private hospitals were charging those in the 18-44 age group while jabs were offered free for groups in the first two phases. The SC ordered a review of the policy. The top court also asked the Centre to provide information as to how ₹35,000 crore, earmarked for vaccines, has been spent.

#### Dredging can cause huge floods in Cuttack city, say experts

Bhubaneswar, June 2: Despite opposition from environmentalists and experts over use of floodplains of Mahanadi river in Cuttack and other districts for human-related activities and construction, the Odisha government is determined to go ahead with its plans. Sources said that the Mahanadi floodplains will be used to develop parking spaces, playgrounds of BOSE and SCB Medical College and other amenities for citizens of Cuttack. Dredging of the Mahanadi has already started with funding from a PSU. It has provided funds to the tune of ₹300 crore.

The alleged dumping of sand to low lving areas and utilising it for urban development have come under the scanner of environmentalists. Officials of Water Resources department however, clarified that dredging is being carried out as per the 2012 Orissa High Court order and recommendations of IIT (Madras).

However, threats regarding the Baliyatra River Front Improvement (BARFI) project were allayed by the department. "There is no project named BARFI on pen and paper. It was an imaginary announcement made by the then Cuttack district collector.



#### RIVERS IN PERIL - II

River dredging and filling of low lying areas on the Mahanadi floodplains are in accordance with law," an official from the State Water Resource department, said Wednesday.

There is however, no clear cut demarcation of the Mahanadi floodplains and that is attracting the wrath of the environmentalists. They said that the National Green Tribunal (NGT) had earlier asked for a clear cut demarcation policy. However, it is yet to get one.

Sources said, that the National Institute of Technology (NIT), Rourkela in association with National Institute of Hydrology (NIH), Roorkee are now working together to formulate the policies for demarcation of the sensitive zones on Mahanadi river floodplains.

Environmentalists have pointed out that if floodplains are plundered through man-made projects in an indiscriminate manner, it will lead to a number of major problems. The threat of urban flooding will increase manifold. Also loss of trees will lead to climate changes and Cuttack city may suffer due to groundwater contamination.

The NGT earlier had lamented that there is a dearth of laws both at the central and state-level to regulate utilisation of floodplains. It pointed out that only a few Indian states have some local norms rules related to their river floodplains. However, there should be proper regulations both at the central and state levels to control the indiscriminate use of floodplains.

New Delhi, June 2: The Government of Dominica has told a court there to reject the habeas corpus petition filed on behalf of businessman Mehul Choksi who had claimed that he was abducted and forcefully brought to the Caribbean island nation, local media reported, Wednesday. Sources said that it wants Choksi deported to India

The High Court of Dominica ordered that Choksi be produced in a magistrate's court to answer charges of his illegal entry into the country. The hearing on the habeas corpus petition was adjourned till Thursday, local media said.

Rejecting Choksi's submission the prosecution said the habeas corpus petition does not stand as he had illegally entered Dominica and was subsequently detained. In case of an adverse order, Choksi has the option of appealing in a higher court.

"The matter being heard is of habeas corpus petition ... And not of his repatriation to India. His citizenship is not in question before the court,' Choksi's lawyer Vijay Aggarwal said.

High Court of Dominica Judge Bernie Stephenson heard the matter through video-conferencing with the diamond trader attending the hearing from a hospital where he was admitted recently. Choksi's lawyers said he should be sent back to Antigua.

Bhubaneswar, June 2: The National Bank for Agriculture and Rural Development (NABARD) has sanctioned Rural Infrastructure Development Fund (RIDF) of ₹254 crore for setting up mega piped drinking water supply projects in Odisha. Nabard will set up two mega piped drinking water supply projects, one of which will be in Jajpur district and the other in Puri district. The project in Jajpur will cover the

Badachana and Dharmasala blocks, while the one in Puri will facilitate water supply to the Brahmagiri and Krushnaprasad blocks.

The two projects are expected to provide clean and safe drinking water to 8.78 lakh rural population across 1.37 lakh household in 565 villages on completion, Nabard said in its official notification

released Wednesday. The mega piped drinking water supply projects are intended for providing 70 LPCD of clean, safe hygienic portable drinking

The drinking water projects will benefit Badachana and Dharmasala blocks in Jajpur and Brahmagiri and Krushnaprasad blocks in Puri

water through Functional Household Tape Connection (FHTC). The supply to the households in the four blocks will last for eight hours every day.

The projects will contribute in achieving the goal of provision of drinking water to the rural population by 2022, added Nabard.

The Odisha government accords top priority to mega piped water supply projects in the state. Nabard said in the statement that it aims to boost development in rural belts of Odisha through RIDF.

#### More than 8K killed in train accidents **MOST VICTIMS WERE MIGRANTS WHO THOUGHT** TRACKS WERE SAFE MODE OF TRAVEL DURING LOCKDOWN

New Delhi, June 2: More than 8.700 people have been mowed down on railway tracks in 2020 even though passenger train services were severely curtailed due to the nationwide coronavirus lockdown. Railway officials said Wednesday

"Based on the information received from police departments of various states, 8,733 people died on railway tracks between January and December 2020. A total of 805 people also suffered injuries," the Railway Board said.

However, deaths of 16 migrant workers after being run over by a freight train in Maharashtra's Aurangabad last May rattled many. # DAILY TESTING IN CAPITAL **DECLINES AS CASES SURGE**

Bhubaneswar, June 2: With the daily Covid-19 cases in the state capital hovering around 1,000, the Bhubaneswar Municipal Corporation (BMC) seems to have reduced the daily testing since last week.

As per the information provided by the civic authority, the Capital city recorded 7,943 cases between May 24 and May 31. Meanwhile, during the same period, about 30,275 tests were conducted for the suspected patients. The duration also saw the city witnessing cyclone Yaas when the BMC did not conduct any tests.

The figures also revealed that while 3,723 tests were conducted May 24, the number dropped to 2,944 tests the following day. However, the BMC abandoned testing May 26, when the summer storm hit the state, citing safety concerns. Although a whopping 4,668 samples were tested May 27,



the number gradually started to fall with only 3,055 tests done June 1.

"We have been constantly making efforts to increase the testing. As per directions, we have achieved close to 3,000 tests on a daily basis which will be increased to 5,000 soon. The marginal drop could be due to Sundays when only mobile testing vans collect samples. Moreover, cyclone Yaas had also effected the daily testing," a BMC official said.

Meanwhile, sources at the BMC also said that the data for daily Covid cases is largely based on the tests conducted during the previous day. This was substantiated from the fact that May 27, the day after the cyclone, reported only 471 new

"I would like to urge the state government to take the issue seriously and ensure that good quality cereals are distributed among the people under PDS," he said.

### Odisha 2nd largest contributor of LMO: Rlys

New Delhi, June 2: The Union Ministry of Railways Wednesday said that Odisha is the second largest contributor of liquid medical oxygen (LMO) delivered through Oxygen Expresses of Indian railways to various states across the country. According to the Railway ministry, Oxygen Expresses loaded 7,102 MT of LMO from Odisha, 6,384 MT from Gujarat, 1,360 from West Bengal, 488 MT from Maharashtra, 218 MT from Chhattisgarh and 164 MT from Andhra Pradesh for delivery across the country. Jharkhand tops the chart with 8,025 MT of LMO loaded from the state.

Bhubaneswar, June 2: Odisha Wednesday registered 40 more deaths due to Covid-19, the highest so far in a single day, pushing the toll to 2,831, a Health department official said.

At least 8,399 new coronaviruspositive cases raised the caseload in the coastal state to 7,82,131, said the official.

Taking to Twitter, the Health and Family Welfare department said, "Regret to inform the demise of forty Covid positive patients, while under treatment in hospitals (sic).

Five fresh fatalities each were reported from Angul, Cuttack, Kalahandi and Khurda, four from Jharsuguda, three each from Boudh and Rayagada and two each from Deogarh, Nabarangpur and Sambalpur. One patient each succumbed to the infection in Balasore, Dhenkanal, Jajpur and Malkangiri, the official said.

#### Cong urges CM to cancel Class XII state board exam

Bhubaneswar, June 2: Odisha Congress president Niranjan Patnaik Wednesday demanded that the state government should cancel the Class XII board examination due to the prevailing second wave of the Covid-19 pandemic.

The demand came a day after the Centre announced the cancellation of Class XII CBSE exams over the pandemic situation

The CISCE has also announced its decision to cancel Class XII ISC examinations.

"It will be unreasonable to push students of Odisha to appear for the #CHSE (Council of Higher Secondary Education) exams in the midst of a raging pandemic," Patnaik tweeted.

With the death of 40 people Wednesday, Odisha registered its highest single-day spike in Covid-19 fatalities. The state also recorded 8,399 fresh cases during the day.

"We shouldn't have unrealistic expectations from our children in these difficult times. Ensuring their safety should be our top priority," the OPCC pres ident said.

# **Conscious Fashion**

't's not just what you eat that is killing the earth and all its inhabitants. It is also what you wear. Every time you buy an article of clothing you L make a choice between the biosphere and the lithosphere. The biosphere is an agricultural field where cotton, linen (made from flax), hemp-even silk (mulberry trees) - are grown. Wool, though cruel in another way, is also grown. The lithosphere is the protective crust of the earth. Fossil fuels are extracted from this and turned into synthetic fabrics like polyester.

Clearly, a sensible human being would choose a renewable resource; something that can be grown again and again. But 70% of all clothing comes from non renewable fuels - we humans are wearing plastic, nylon, acrylic, polyester. Even the wonderful sarees from Benaras, which were heirlooms for all brides, are now mixed with polyester.

Fashion is as much an agricultural choice as food. It is common for us to pay attention to vegetables and grain and interrogate the farming community, but we pay no attention to the fashion industry. Think about cloth as emerging from the ground and then concern yourself about the practices required to grow and harvest it.

The beef industry is responsible for the cutting of thousands of forests – but the fashion industry is no less. Tree based fabrics, such as bamboo and eucalyptus, cause forests to be cut and turned into plantations and these trees are turned into clothes.

If we choose cotton, as I have done my whole life, I am guilty of ignoring the massive pesticides used and how they impact all life. Cotton in India uses Neonicotinoid pesticides - which are responsible for the destruction of billions of bees, putting our food supplies at major risk. But polyester/nylon is responsible for massive mining, destroying forests, leaving gaping holes in the ground and contaminating water sources for miles around.

However, even if you make the choice to wear a sustainable agricultural produce, the next problem is dyes. The cloth may be organic cotton but its colour comes from synthetic dyes. First the cotton is bleached - and bleach kills all sea life. Then it is dyed. Synthetic dyes colour most of the textiles we wear.

It's estimated that 25% of chemicals produced globally are used to produce clothing, and many of these go toward dyeing. Heavy metals, such as cadmium, mercury, tin, cobalt, lead, and chrome, are needed to bind the dyes to the fabric, and are present in 60-70% of dyes. Vast amounts of water are needed in the dyeing industry as well and the surplus chemical dyes are rinsed out and thrown into rivers as effluent. Some years ago I was in Udaipur and I came across the

most terrible rivers: blood red waters with so many animal corpses around -animals that had been forced to drink, as there was no other water. All this was the downstream of the cloth dyeing industry.

The effect of working with chemical dyes is apparent in communities employed in this work (they suffer the effects of exposure to endocrine disruptors contained in the dyes. Endocrine disrupting chemicals can interfere with hormones, causing cancerous tumours and birth defects). Who knows the effect of synthetic dyes on human bodies through the clothing. Dyes are not the only problem: There are far more chemicals contained in our clothing than we may realize

The textile industry is the most polluting of all industries in India. Worldwide, clothes are the second largest source of pollution after oil. This industry is responsible for 10% of global carbon emission and becomes world's fifth biggest emitter of carbon dioxide. It is also one of the top 3 water wasting industries and pollutes fresh water resources badly. About 2600 litres of water are required to produce a single t-shirt.

Every time you wash synthetic materials they shed millions of plastic microfibres, according to the National Oceanic and Atmospheric Administration's Marine Debris Program. Microfibres are a type of microplastic, which is a plastic-based thread that is thinner than a human hair, below 5mm in size. The threads are so small, they pass straight through wastewater treatment plants into the sea. Lots are caught up in sludge at the treatment plants - which is then sprayed over the soils as fertilizer. Sea organisms, like plankton, mistake these tiny plastics for food. Smaller animals and fish depend on plankton as their main food. And humans eat fish. So the fibres get off your

# WASTE LESS, EARN MORE

ur world is extraordinarily inefficient. We waste enormous quantities of energy, water, raw materials, and food. We even waste our waste and the precious resources it contains. We do so not necessarily because we lack ecological awareness, but rather be cause the society we live in is built on the myth of infinite resources. Sustaining this situation of false abundance is morally unacceptable when a large part of the world's population lacks what a small part routinely wastes. It also has a considerable financial cost now that technologies exist

to end this waste. While some are considering economic degrowth as an option to achieve global climate targets and other environmental goals. there is a much stronger case for adopting technologies that allow us to become more efficient. That means replacing old polluting infrastructure with cleaner modern systems.

The good news is that the resulting efficiency gains outweigh the financial cost of the transition. Better still, we won't have to sacrifice economic growth in the process. Over the past four years, the Solar Impulse Foundation has selected and labelled more than 1,000 products, services, and processes that can greatly increase efficiency in the fields of mobility, construction, agriculture, industry, energy, and water.

Efficiency is the ability to achieve the most with the least. Energy efficiency, for example, means maximising service while minimising consumption.

The search for efficiency long had a bad reputation because of the so-called rebound effect, a perverse phenomenon whereby technological improvements result in increased resource consumption. The British economist William Stanley Jevons first described it in 1865. The emergence of more efficient steam engines, he observed, led to greater coal use.



While some advocate economic degrowth as an option to achieve climate targets and other environmental goals, there is a much stronger case for adopting efficient clean technologies. The gains from introducing them would outweigh the financial cost of the green transition, and economies would not have to sacrifice growth in the process

But Jevons was observing conditions in a totally free market. Today, ecological regulations and incentives to reduce consumption, such as carbon taxes, help to preserve the environmental gains of efficiency. Moreover, rebound effects work both ways: current heightened environmental awareness could produce a positive effect, whereby a household spends the economic gains from lower energy costs on a healthier diet or the purchase of an electric vehicle.

In any case, efficiency must be part of our overall response to the climate challenge. The International Energy Agency estimates that today's technologies could reduce our electricity consumption by about 3,000 terawatt hours, or more than 10 per cent of the total in some regions and 5 per cent globally. By 2040, this potential for improvement will almost double, to roughly a quarter of total consumption.

This is because energy-management systems in recent years have become able to limit generation and distribution losses and

support increasing shares of variable and distributed renewables while increasing grid flexibility. They have also become much smarter, integrating external data sources such as weather conditions and traffic patterns. Using artificial intelligence, these advanced systems can forecast energy demand more accurately and improve grid-response capabilities. Public policies to boost effi-

ciency would also improve access to electricity for the 13 per cent of the world's population still without it. As the global standard of living increases, we must ensure that new consumption demand - including for electricity, goods, and mobility - is met with efficient devices. That way, we can reconcile greater prosperity with adherence to our environmental commitments Technologies that boost effi-

ciency are not limited to the energy sector. We are also wasting huge amounts of water at a time when scarcity is affecting hundreds of millions of people-often fuelling conflict, displacement, and other disruptions of lives and livelihoods. But today's tech nologies enable us, for example, to allocate the minimum quantity of water needed to increase agricultural yields.

The responsibility of policy makers today is to set higher efficiency standards in every sector. This will increase demand for clean and efficient technologies and thus encourage innovative firms to bring them to market. Such regulations would be hard to accept if they penalised citizens and undermined economic growth. But new green technologies do exactly the opposite: they increase corporate profits and create jobs. As a result, we can now finally

escape from the sterile debate pitting economic growth against ecological stewardship. The two must go hand in hand. Clean, efficient, and profitable technologies are available today, and the faster we implement them, the more will be available tomorrow.

In a study in Science News, it was shown that nitrous oxide is increasing in the atmosphere by 0.2% annually and a portion of this comes from the production of nylon and polyesters. Nitrous oxide is a powerful greenhouse gas and has 300 times more potentiality than carbon dioxide. Polyester production, for textiles, released about 706 billion kg (1.5 trillion pounds) of greenhouse gases in 2015; the equivalent of 185 coal-fired power plants' annual emissions

What do they do to you? Plastic clothing has an effect on the skin and respiratory tract. It has also been found to cause infertility in men. Nylon, used in swimsuits, tights and stockings, requires chemicals to reduce the electric static. Formaldehyde in fabrics causes skin allergies, eye watering, and is also a known potent carcinogen.

How does one get out of this mess? There are only a few solutions at the moment, but they are important ones.

Do not buy any artificial cloth: no nylon, polyester, lycra, acrylic, no 'upcycled plastic' which many fashion brands say are green. If you stop using man made synthetic, artificial cloth, the mining will reduce and you might save some forests. You will certainly save a great deal of petroleum. And none of these artificial materials are biodegradable. There's also something that is often referred to as semi-synthetic, like rayon, which is made from natural materials like cellulose from trees, but the fibres are made artificially Rayon causes massive deforestation because trees have to be stripped, and this includes protected forests. Some animals are on the endangered species list specifically due to rayon. Bamboo is also not to be encouraged. Its stiffness is converted to softness by using toxic chemicals such as carbon disulfide, sodium hydroxide, and sulphuric acid.

Don't buy so many clothes and don't throw away clothes because they are out of 'fashion'. A recent study by the Ellen McArthur Foundation found that one garbage truck of textiles is wasted every second. The Copenhagen Fashion Summit reported that fashion is responsible for 92 million tonnes of solid waste dumped in landfills each year. Synthetic fibres can take up to 200 years to decompose. More than 1 million tonnes of textiles are thrown away every year. An estimated 150 billion garments are produced annuallyabout 20 new garments to every individual. From 1999 and 2009 the discarding of clothes has grown by 40%.

Try out fibres like pineapple leather. Plant or fruit leather, made from waste materials, is gaining attention. Pinatex, for example, is a material made from the leaves of pineapples grown in the Philippines. Its production is much more sustainable than traditional leather. It requires less water and no harmful chemicals that are ecologically toxic to wildlife. The leftover leaf waste is recycled and used for fertiliser or biomass. Soy fabric is an eco-friendly fabric made from the hull of sovbeans, leftover from food production; a crueltyfree and sustainable option. They are biodegradable, and the material is renewable

Keep it simple: Just buy organic cotton with organic dyes and you will save the world

high. Management of unemployment is one such need.

If we go by the recent report of the Centre for Monitoring the Indian Economy (CMIE) the number of employees has come down from 400.7 million to 390.7 million during January-April 2021. The report further says the unemployment rate has increased from 6.52 per cent to 7.97 per cent during this period.

The above data is not from any government source. CMIE, a privately owned organisation, generates this important information and makes it available for free. This is an example of a private entity generating public good. Before we examine the data there is a need to understand CMIE's definition of labour force and the unemployment rate.

Labour force consists of persons who are of 15 years of age, employed or unemployed but actively looking for a job.

Unemployment rate is the unemployed actively looking for a job expressed as a percentage of the labour force.

The report says the number of unemployed actively looking for iobs has increased from 2.7 crore to 3.38 crore during January-April

that the number of unemployed keeps on fluctuating. Monthly fluctuation during the last one year was in the range of negative 11 crore to positive 6 crore. The fluctuation is the reflection of the temporary nature of unemployment. Situations like pandemics and other contingencies push people

into short term unemployment. People may find it extremely difficult to survive during those days of unemployment. For some, it may lead to personal depression and some may get into the vicious cycle of poverty due to unemployment driven debts.

According to a survey (www.statista.com) among the Indian urban youth about life in lockdown, less than 20 per cent of full-time employees had paid sick leave and only one per cent had unemployment insurance. Though the survey was done only in the metros, it is a reflection of the state of unemployment support available in India. It is time for the government to seriously work on unemployment support system otherwise the demographic dividend will become a demographic burden. One policy intervention in that direction is unemployment insurance.

Unemployment benefits were introduced in Germany in 1927 and in most European countries immediately after the Second World War. Unemployment insurance in the US originated in 1932 and further got strengthened by the Coronavirus Aid. Relief. and Economic Security (CARES) Act. enacted in March 2020.

Unemployment insurance aims to immediately tackle the risk of poverty, while at the same time creating incentives for individuals to look for a job and increase their employability. The financial support under unemployment insurance helps in maintaining the liquidity at the bottom of the pyramid. Several researchers have shown that unemployment insurance can be used as one of the government's most effective fiscal tools against economic recessions and personal depression. But who will bear the cost of unemployment insurance?

One of the popular methods is distributing the cost across different stakeholders: employees, employers, and the government. As per a report of the ILO, the average contribution by employees is 1 per cent of the wage in advanced economies and 0.5 per cent in emergmoment. Some general insurers sell this insurance bundled with the health or home insurance products. The government owned ESIC provides some form of unemployment insurance for eligible emplovees, but the conditions attached to it restrict the benefits to a small number of unemployed people.

It is time for the government to work on a comprehensive unemployment insurance policy in consultation with the IRDA. Both, the employee and employer should contribute to the fund with a matching contribution by the state or the central government. The public-sector insurance companies may be entrusted with the responsibility of managing the scheme. Executing such a scheme needs timely, correct, and comprehensive employment data. Organisation like the CMIE may be roped in to provide such data. Efforts should be made to create awareness about unemployment insurance so that every employee will have one such policy in her portfolio of financial products like mutual funds, life insurance, and other investment instruments.

However, the third wave of the pandemic, said to infect children, is looming large, and the parents are a worried lot. As of now, no worthwhile vaccination programmes has been chalked out for children. But there may be one on the anvil. States should be ready with their agendas for school children

## 82 hostels for children of migrant sugarcane workers

Mumbai, June 2: The Maharashtra government has decided to provide 82 permanent residential accommodations for the children of the migrant sugarcane workers in the state under the Sant Bhagwan Baba Government Hostel Scheme.

New Delhi, June 2: The first lockdown imposed in India last year due to the COVID-19 pandemic led to an improvement in air quality and a reduction in land surface temperature in major urban areas of the country, according to a study.

The findings, published in the journal Environmental Research, provide a strong evidence for potential environmental benefits through larger scale policy implementation. The study found that travel and work restrictions imposed early in the pandemic resulted in a significant environmental improvement, due to an

abrupt reduction in industrial activities and a major decrease in the use of land and air transport.

The researchers used data from a range of Earth observation sensors, including those from the European Space Agency's Sentinel-5p and NASA's MODIS sensors, to measure changes in surface temperature and atmospheric pollutants and aerosols.

They concentrated on six major urban areas: Delhi, Mumbai, Kolkata, Chennai, Bangalore, and Hyderabad, comparing data from the lockdown in March to May last year with pre-pandemic years. The study revealed a significant reduction in nitrogen dioxide (NO2),

face temperature over major cities in India substantially declined in contrast with the previous fivevear average (2015-2019) with day temperatures being up to 1 degree Celsius cooler, and those at night up to 2 degrees Celsius cooler. "The lockdown provided a natural experiment to understand the coupling between urbanisation and local microclimate," said study coauthor Jadu Dash, Professor at the University of Southampton in the UK. "We clearly observed that reduction in atmospheric pollutants resulted in a decrease in local day and night-time temperature. This is an important finding to feed into the planning for sustainable urban development," Dash said. The study found that along with surface temperature, the atmospheric fluxes at the surface and top of the atmosphere also significantly declined over major parts of India.

The reduction of greenhouse gas concentration, higher atmospheric water vapour content and meteorological conditions played a complex role in the land and near-surface temperature reduction.

# Security, intel officials face new gag order

#### PRESS TRUST OF INDIA

New Delhi, June 2: The Centre has amended its rules barring officers who had worked in intelligence and security related organisations from publishing sensitive information by adding new clauses, including the conditions that they can't share any material on 'domain of the organisation' or its personnel.

The Central Civil Services (Pension) Amendment Rules, 2021, dated May 31 and notified late Tuesday, also states that they need to take prior permission from the 'head of the organisation' for publishing such material. In the earlier 2007 rules, permission was to be taken from the head of the department. All employees would have to give an undertaking to the

head of organisation that they would not publish such information failing which pension can be 'withheld or withdrawn', the amendment states.

The rules apply to employees who retire from the Intelligence Bureau (IB), Research and Analysis Wing (RAW), Directorate of Revenue Intelligence (DRI), Central Economic Intelligence Bureau, Directorate of Enforcement (ED), Aviation Research Centre, BSF, CRPF, NSG, CISF and the Indo-Tibetan Border Police. According to the Central Civil Services (Pension) Amendment Rules 2007 that was notified in March 2008, all such employees are already barred from publishing any sensitive information, 'the disclosure of which would prejudicially affect the sovereignty and integrity of India'.

# 594 docs have died of Covid in 2nd wave: IMA

#### **DELHI, BIHAR, UP AND RAJASTHAN HAVE LOST THE MAXIMUM NUMBER OF DOCTORS**

New Delhi, June 2: As many as 594 doctors have died due to COVID-19 in the ongoing second wave with Delhi recording the maximum 107 fatalities, the Indian Medical Association (IMA) has said.

According to the IMA, 748 doctors died of the infection across the country in the first wave of the pandemic. Delhi recorded 107 deaths in the second wave, followed by Bihar 96. Uttar Pradesh 67, Rajasthan 43, Jhakhand 39 and Andhra Pradesh and Telangana



32 each, according to data compiled at the IMA's COVID-19 registry. "Last year 748 doctors across India succumbed to COVID-19,

while in the current wave we have lost 594 doctors in a short period. IMA president J A Jayalal said.

The data shared by IMA showed that as many as 107 doctors had died in Delhi during the second wave. Bihar saw the deaths of 96 doctors. while 67 died in Uttar Pradesh, 43 in Rajasthan, and 39 in Jharkhand, too. However, the IMA

In light of the Liberalized Vaccination Policy, the Central Government is directed to clarify how these funds have been spent so far and why they cannot be utilized for vaccinating persons aged 18-44 years," said a special bench of Justices D Y Chandrachud, L Nageswara Rao and S Ravindra Bhat.

We direct the Union of India(UoI) to undertake a fresh review of its vaccination policy addressing the concerns raised," said the order which is a part of a series of judicial decisions rendered on the suo motu case on Covid-19 management in the country.

Finding fault with the vacci nation policy, it said unlike the previous one, it did not prioritize persons with comorbidities and this became important in view of the fact that in the second wave, persons between 18-44 years of age have suffered severe effects of infection including deaths in unfortunate cases

"Due to the changing nature of the pandemic, we are now faced with a situation where the 18-44 age group also needs to be vaccinated, although priority may be retained between different age groups on a scientific basis.

"Hence, due to the importance of vaccinating individuals in the 18-44 age group, the policy of the Central Government for conducting free vaccination themselves for groups under the first 2 phases, and replacing it with paid vaccination by the State/UT Governments and private hospitals for the persons between 18-44 years is, prima facie, arbitrary and irrational," Justice Chandrachud said in the 32-page order. # No clinical trials necessary for global vaccines in India

New Delhi, June 2: Globally available Covid 19 vaccines can now be launched in India without the requirement of post approval clinical trials and testing every batch of the vaccine.

The Drugs Controller General of India in a notification has said that vaccines which have been approved for restricted use by US FDA, EMA, UK MHRA and PMDA Japan and under the WHO Emergency Use Listing (EUL) and where millions of individuals have been vaccinated, the requirement of conducting post approval clinical trials and the requirement of testing every batch of the vaccine by Central Drugs Laboratory (CDL), Kasauli can be exempted if the vaccine batch has been certified and released by National Control Laboratory of country of origin.

However, scrutiny and review of their summary lot protocol and certificate of analysis of the batch shall be undertaken by CDL, Kasauli for batch release as per standard procedures and the requirement of assessment of the first 100 beneficiaries for first 7 days for safety outcomes before the vaccine rolled out

for further immunisation programme and other procedures for applications will remain the same.

This nod is likely to apply first to Pfizer and Moderna vaccines. AstraZeneca's Covishield and Russia's Sputnik have already been approved.

It is not clear whether the Chinese vaccines will come under this ambit or they will apply in India

This is being done to augment the increased availability of imported vaccines for meeting the national requirements even though the domestic manufacturing is being lifted.

I have not seen a suit where a person savs I don't know, please conduct an inquiry," the judge said. The court asked about the knowledge of plaintiffs on the facts and warned to prosecute them on filing false claims. # '86% Indians maintain digital hygiene amid WFH'

New Delhi, June 2: While there has been an increase in Covidthemed attacks targeting people working remotely, more Indians (86 per cent of those surveyed) have implemented more protection for their digital devices at home, a report showed Wednesday. Nearly 88 per cent of Indian consumers feel more digitally connected since the pandemic via de-

vices, online activities and connected homes, and 57 per cent of them that digital hygiene or the lack of it can put them and their families at risk, according to cybersecurity firm McAfee's e2021 Consumer

Security Mindset Survey Cybercriminals have worked



feverishly to launch Covid-themed attacks that increased by 240 per cent in Q3 2020 and 114 per cent in Q4 last year, with an average of 648 new threats per minute.

"While the study indicates that more Indians are digitally connected owing to the pandemic, they are also now actively taking steps to keep themselves protected from online threats," said Venkat Krishnapur, vice-president of engineering and managing director, McAfee India

"The spike in our digital footprints during this time, makes it critical for everyone to understand the importance of online security and take measures towards protecting themselves," Krishnapur said in a statement.

Two out of three Indians check if the network that they are joining is secure before connecting.

Furthermore, more than half (53 per cent) feel more vulnerable to risks when someone has visited their home and has connected to their internet.

"Remote working, online learning, and a surge in the usage of connected devices due to more time being spent indoors has resulted in increased digital dependence among Indians," Krishnapur said.

More than half of Indians (58 per cent) indicate having a good understanding of the data they store on their mobile devices.

Nearly 81 per cent of Indians said that since 2020, members in their household have started to participate in distance learning via virtual platforms.

However, less than half (36 per cent) of these purchased new security/protection technology to protect their family and home when distance learning was introduced into their new life routine, the findings showed.

The study found "there is a probable link between receiving the second dose (of Pfizer) vaccine and the appearance of myocarditis among men aged 16 to 30," it said in a statement.

Moscow, June 2: The upper house of Russia's parliament Wednesday overwhelmingly backed legislation that is expected to be used to ban allies of jailed Kremlin critic Alexei Navalny from running in elections.

The bill approved by the Federation Council would make it impossible to run in elections for leaders, sponsors and rank-and-file members of "extremist" organisations, a designation being considered for Navalny's organisations. A Russian court is considering whether to designate his political network an "extremist" organisation and could make a decision as

early as next week. Kremlin critics say Russian authorities are widening a crackdown on the opposition ahead of parliamentary elections in

September.

A total of 146 senators backed the legislation, while one voted against and one abstained. The bill will now have to be signed by President Vladimir Putin to become law.

The legislation could affect not only senior members and activists of Navalny's political network but potentially tens of thousands of Russians who supported its work with donations. Leaders of such groups will not

be able to run in parliamentary elections for five years while members and those who helped finance their work will be banned from running for three years.

Russian authorities had for years tolerated opposition groups including Navalny's political movement but Kremlin critics say authorities are moving to remove any vestiges of dissent.

# Plant-based diets could help prevent the next pandemic

ALL VIRUSES HAVE ARISEN WHERE ANIMALS AND HUMANS MEET, AND RAISING BILLIONS OF ANIMALS AS FOOD WILL HAVE EFFECTS

Saskatoon, June 2: Viruses like Covid-19, SARS, bovine spongiform, swine flu and avian flu all have something in common: They all come from animals, described by scientists as zoonotic diseases.

Yet, these diseases do not really "come from animals." After all, it is not like animals conspire against humans, throwing Covid-19 over the backyard fence. When we say this pandemic "comes from animals," it means that these diseases come from the way society raises, harvests and eats animals.

A well-rounded policy strategy for avoiding the next pandemic should include reducing the demand for animal products. Fortunately, an effective ap-

proach need not imply government telling people what they should or should not eat.

#### **Zoonosis and food production**

The fact that a growing list of pandemics originate exclusively within the animal and agricultural sectors is nothing new to a small but growing group of independent scientists. The United Nations recently voiced a similar concern. In its report, Preventing the Next Pandemic: Zoonotic diseases and

how to break the chain of transmission, the UN laid out some of the things needed for improving health governance in relation to food production.

Some of the policy options include expanding scientific inquiry into the environmental di-



mensions of zoonotic diseases and developing and implementing stronger biosecurity measures. It calls for policies that strengthen animal health and increased capacity in monitoring

and regulating food production.

#### **Origins of a pandemic**

Early cases of Covid-19 were linked to markets in China where wild animals were sold. Pangolins

and bats have been identified as possible sources of infection, neither of which is on the shopping lists of the average global consumer. The deeper roots of this pandemic, however, are more complicated.

Many earlier viruses have originated in the animal husbandry industrial production chain.

In the 1980's the United Kingdom's cattle production began to see outbreaks of Bovine spongiform encephalopathy (mad cow disease), and its human equivalent variant Creutzfeldt-Jakob disease

In 1997, the bird flu (H5N1) was traced to chicken factories in China. In 2009, the swine flu (H1N1) originated in pig farms in Mexico and North Carolina in the United States

More recently, a possible new

strain of Covid-19 has been found in farms in Denmark, where mink are raised for fur coats.

#### Plant-based diet as policy

A reason why politicians might not see a move towards a plantbased diet as a viable policy option could be because it relies on changing peoples' behaviour, and some would argue that governments should not be in the business of trying to impose dietary choices. Yet there is good reason to think that people are already open to transitioning to a plant-based diet.

According to a recent UN survey, 30 per cent of the world supports a plant-based diet as a climate policy. The number of people at-tempting to eat plant-based diets is growing fast.

New Delhi, June 2: India's exports grew by 67.39 per cent to \$32.21 billion in May driven by healthy growth in sectors such as engineering, petroleum products and gems and jewellery, even as trade deficit widened to \$6.32 billion, according to government data released Wednesday. Exports in May last year stood at \$19.24 billion and in May 2019 it was at \$29.85 billion, the commerce ministry's preliminary data showed

Imports in May rose by 68.54 per cent to \$38.53 billion, from \$22.86 billion in May 2020. In May 2019, imports stood at \$46.68 billion. India is thus a net importer in

May 2021 with a trade deficit of \$6.32 billion, an increase of 74.69 per cent over trade deficit USD 3.62 billion in May 2020 and reduction by 62.49 per cent over trade deficit \$16.84 billion in May 2019,' the ministry said. The country's merchandise ex-

ports in April had jumped nearly three-fold to \$30.63 billion, even as the trade deficit widened to Oil imports during May this

year rose to \$9.45 billion, as compared to \$3.57 billion in May 2020. In May 2019, it stood at \$12.59

# Global IoT market to surpass \$1tn-mark by 2024: Report

New Delhi, June 2: The global internet of things (IoT) market by revenue will be worth \$1.1 trillion by 2024, with much of the growth coming from wearables, a new report said Wednesday.

The global IoT market was worth \$622 billion in 2020, up from \$586 billion in 2019, and will grow to reach \$1,077 billion by 2024, with a compound annual growth rate (CAGR) of 13% over the period, according to data and analytics company GlobalData.

The dominance of the enterprise IoT will continue for the foreseeable future. The enterprise IoT dominates the overall IoT market, generating 76% of total revenue in 2020. GlobalData expects this segment to still occupy 73% of the overall IoT market in 2024.

"The ongoing Covid-19 pandemic has highlighted the crucial role the IoT has come to play in our lives. Several IoT use cases saw growing adoption during the pandemic, including using connected thermal cameras to detect potential Covid-19 infections and sen-

# Virus disaster leaves deep scars on Indian economy

#### New Delhi, June 2: Expectations for India's economic growth are being revised sharply lower as a surge in people losing their jobs and defaulting on debt suggest a more halting recovery from the financial shock of the Covid-19 pan-

demic. Economists are downgrading their estimates as a range of data - from the rate of cheques bouncing to the amount of mortgaged gold jewellery up for sale - shows the extent of the economic damage from a devastating second wave of the disease

Some observers also fear the psychological blow from the virus disaster that ripped through India this year killing tens of thousands of people will leave consumer re-

#### luctant to spend.

India's government is sticking with a forecast that the economy will grow 10.5% in the fiscal year that started April 1, but on Tuesday State Bank of India - the country's largest lender - slashed its growth forecast to 7.9% from 10.4%. Several international banks such

as Barclays and UBS have also cut back their predictions.

After a 7.3% contraction in 2020-21 - the sharpest ever recorded by India - the relatively muted recovery puts India at odds with countries like United States and China that are seeing a swift rebound as they emerge from the pandemic, and suggests deeper damage has been

done to an economy worth around \$2.9 trillion before the crisis hit. The knock-on effects of sub-par growth on a rapidly developing



economy like India could be significant

"GDP growth of less than 10% will be a - I won't use the word disaster, but it will not be very beautiful." SBI's Chief Economist Soumya Kanti Ghosh told Reuters after lowering his forecast.

The situation has exacerbated unemployment that touched a 12month high of 11.9% in May from 7.97% in April, according to data from the Centre for Monitoring Indian Economy. Rural unem-

ployment that normally hovers around 6-7% also hit double digit levels in May, according to the privately owned firm.

Last year, India announced a \$266 billion package to support the economy during a strict nationwide lockdown to contain the first coronavirus wave. But this was largely liquidity support given to banks to boost company credit, with less than a tenth of the sum used for welfare programmes for the poorest in the country.

India did not launch job support schemes on the scale of those seen in some developed economies and the government has not announced a major stimulus package since the second wave hit.

Surging unemployment, coupled with state lockdowns, a large increase in hospitalisations and the recovery was brief.

## **UEFA EURO 2020** Absent Ramos still attracting attention

Madrid, June 2: For the first time in 15 years. Spain finds itself preparing for a major tournament without Sergio Ramos. The veteran defender, however, is still attracting much of the attention ahead of the European Championship as Spain starts its preparations in Madrid.

"Sergio Ramos has always been with the national team, so it's a bit strange that he isn't here now," Koke said Tuesday at the team's training camp. Ramos had been with "La Roja"

for every major tournament since the 2006 World Cup, having first made the senior team in 2005 at age 18. He was a surprising absence for the Euro 2020 squad despite a season plagued by injuries. Coach Luis Enrique decided to leave the veteran captain off his list because of a lack of play in recent

months. The 35-year-old Ramos missed most of the second half of the season with Real Madrid after a series of muscle injuries and a knee problem that required surgery. He also tested positive for COVID-19 in April, but was expected to be injury free by the time Euro 2020 started.

Many in Spain criticised Luis Enrique for leaving the star defender out, especially because the coach decided not to use two of the 26 spots available, with Ramos potentially benefiting the squad with his experience and leadership even if he wasn't fully fit. "In the end, these decisions are

made by the coach, he is the one who announces the list," said Koke. "It wasn't only Sergio Ramos who was left out, but also other very important players for their clubs, and other very important players for



Spain. We have to respect these decisions.'

Luis Enrique said he didn't want to pick a full complement of 26 players because some wouldn't end up being used at all. "There is always controversy when it comes to any decision related to Ramos," Luis Enrique said when the list was announced. "But I see it as something normal, I don't think his absence will affect the national team."

Ramos came out supporting the coach's decision, saying that in his case it was best to rest and try to fully recover for the future. He had hinted before that he could play in the Tokyo Olympics, and was still aiming at playing in the 2022 World Cup in Qatar.

Ramos is close to breaking the record for most appearances for a national team. He already holds the European record with 180 appearances, four fewer than the world record held by Egypt player Ahmed Hassan.

#### **KOHLI NOT TOO CONCERNED** LACK OF PREPARATION TIME FOR WTC FINAL

#### Mumbai, June 2: India captain Virat Kohli is not too concerned about the limited preparation time that his team will get for the World Test Championship (WTC) final against New Zealand as he believes that it has the requisite understanding of conditions from its past experience of playing in England. India take on New Zealand in the marquee game at Southampton from June 18. Currently, New

Zealand are engaged in a two-Test series against England, while India would be in quarantine after landing there, including three days of hotel quarantine.



## DJOKO EASES PAST SANDGREN; KASTAKINA ENDS BENCIC RUN AT FRENCH OPEN Zverev toils hard to enter third round

Paris, June 2: Down 1-4 in the third set, Alexander Zverev decided it was time to shorten his match at Roland Garros. He was determined to avoid another lengthy fight following a five-set battle in the previous round, so he applied pressure on qualifier Roman Safiullin.

The sixth-seeded German won the next game at love, broke back by pushing his rival into unforced errors and was nearly flawless in the tie-breaker. The reward was a 7-6(7-4). 6-3. 7-6(7-1) victory to advance into the third round at the French Open. Elsewhere, World No.1 Novak Diokovic completely outplayed unseeded Tennys Sandgren 6-2, 6-4, 6-2 to make it into the second round. The Serb will next face Laslo Dere, who came from two sets down to outwit Miomir Kecmanovic 4-6, 4-6, 6-3. 6-2. 6-3.



He took the next five points to seal the match and extend his perfect record against qualifiers to four matches on the Paris clay.

In the women's draw, 2019 runnerup Marketa Vondrousova reached the third round with a 6-1, 6-3 win over wild card Harmony Tan.

Earlier, tenth-seeded Belinda Bencic's campaign at Roland Garros ended with a 6-2, 6-2 loss to Daria Kasatkina while Katerina Siniakova saved two match points to oust 29th-seeded Veronika Kudermetova 7-6(9-7), 5-7, 7-5.

Ahead of the French Open Siniakova made a deep run in Parma, where she upset top-seeded Serena Williams. Bencic struggled with her serve throughout and was broken four times by her Russian rival. The Swiss player has never progressed past the third round at the French Open in five appearances.

"Look, in the past we have landed in places three days prior even in a proper schedule and have had a hell of a series and hell of competition, so it is all in the head," Kohli said in the pre-departure press conference.

Virat insisted that it was also about the mindset. "It is not the first time we are playing in England, we all know what the conditions are like." he said.

"And even if you are used to the conditions, if you don't enter the field in the right frame of mind, you are going to nick that first ball or you are going to find it tough to pick

wickets," added the superstar. According to Kohli, his side would not have any issues even if it gets just four practice sessions. "We don't have any issues even with four practice sessions head-

ing into the game, because we are absolutely sure of what we can do as a team and we all have played in England.

Whether it is with the Indian team or India A as well, for the likes of (Mohammed) Siraj. So we are not bothered by that at all and we just want to get there and make the most of the opportunity at hand," he added.

Among others, Fabio Fognini, 23rd seed, beat Marton Fucsovics 7-6(8-6), 6-1, 6-2. The 31st seed John



Isner also had to toil hard to get past Filip Krajinovic 7-6(8-6), 6-1, 7-6(7-5). Both Fognini and Isner advanced to third round

However, it was a tough day for 11th seed Roberto Bautista Agut as the Spaniard went down to an unseeded Henri Laksonen of Switzerland 3-6, 6-2, 3-6, 2-6. Zverev, facing a rival he has known since their days in the boys' categories, dropped his serve three times on Court Suzanne Lenglen but managed to catch up with Safiullin with his fighting spirit.

A 25-shot rally in the final tiebreaker epitomized Zverev's combative attitude. First on the defensive, Zverev turned it around and won the point with a passing shot.

Kasatkina made it to the quarterfinals in Paris in 2018, but it's the first time this season that she has won consecutive matches on clay.

# EURO 2020: Foden leads continent's young guns

Any European Championship offers young players a chance to make their name on the international stage. Even more so this time. The coronavirus pandemic means three years have passed since the World Cup, so more players are making their major tournament debuts. UEFA has expanded squads from 23 play- 🐰 ers to 26, which could encourage coaches to take a chance on less experienced players. Here is a look at some young players who can make their major tournament debuts at Euro 2020...

#### **PHIL FODEN**

When Manchester City faced Borussia Dortmund in the Champions League quarterfinals, all eyes were on Dortmund striker Erling Haaland. But it was Foden who decided the outcome from midfield with a goal in each leg as City won 4-2 on aggregate.

The 21-year-old Foden was born a few miles from City's home stadium and came through stiff competition in the club's youth system to stake his place in the first team. He played almost every game this season in City's run to the Premier League title. Foden was too young to play at the 2018 World Cup but made his England debut last year and immedi-

ately looked com-

fortable.



A hat-trick in Spain's 6-0 rout of Germany last year underlined just how much the 21-year-old Torres means for a new-look Spain team. He's already a regular starter at international level and proved his worth for Manchester City this year with four goals in the group stage of the Champions League. Record-breaking 18-year-old Ansu Fati has sometimes outshone Torres in the Spain squad, but a severe knee injury in November means Fati won't return in time for Euro 2020.

#### **JOAO FELIX**

The Atletico Madrid forward has sometimes seemed to be weighed down by expectations since moving from Benfica for 126 million euros (USD 153 million) in 2019. Injuries and a coronavirus infection disrupted his rhythm this season, but Joao Felix can be devastating when he is in form.



#### **GIANLUIGI DONNARUMMA**



The AC Milan goalkeeper is still only 22, but he's already been part of the Italy team for nearly five

years. Donnarumma is the definitive goalkeeping prodigy of the last decade and Italy's heir to the great Gianluigi Buffon. Donnarumma made his debut for Milan in Serie A at 16 in 2015 and immediately pushed aside more experienced teammates to make himself the club's first choice in goal. Italy's failure to qualify for the 2018 World Cup means that Donnarumma is set to make his major tournament debut at Euro 2020.

**KAI HAVERTZ** 



Chelsea made a splash by signing the 21-year-old Havertz for a reported 70 million pounds (USD 99 million) from Bayer Leverkusen last year. He's taken time adapting to life in the Premier League but seems more at home since German coach Thomas Tuchel took charge at Chelsea. Joachim Loew could

select more young talents for his last tournament as Germany coach. Bayern Munich forward Jamal Musiala made his debut in March after choosing Germany over England, and 17-year-old Leverkusen midfielder Florian Wirtz is on the fringe of the squad.

#### **MATTHIJS DE LIGT**



The Netherlands has developed a whole new generation of players since its last tournament appearance at the 2014 World Cup. De Ligt emerged alongside international teammates Frenkie de Jong, Donny van de Beek and Ryan Gravenberch on the Ajax team which reached the 2019 Champions League semifinals. Since joining Juventus, De Ligt has cemented his place as one of the world's leading defenders. At the age of 21, he's already played ( more than 20 times for his country.
