Govt 'ultimatum' to Twitter

CENTRE WARNS TWITTER OF PENAL ACTION IF IT DOESN'T COMPLY WITH IT RULES

New Delhi, June 5: The government Saturday issued a notice to Twitter giving it one last chance to "immediately" comply with the new IT rules and warned that failure to adhere to the norms will lead to the platform losing exemption from liability under the IT Act.

The Ministry of Electronics and Information Technology (MeitY) said that Twitter's refusal to comply with the rules demonstrated the microblogging site's "lack of commitment and efforts towards providing a safe experience for the people of India on its platform".

"Despite being operational in India for more than a decade, it is beyond belief that Twitter Inc has doggedly refused to create mechanism that will enable the people of India to resolve their issues on the platform in a timely and transparent manner and through fair processes, by India based, clearly identified resources," the IT Ministry said. The ministry said that though with effect from May 26, 2021, "consequences follow" given Twitter's noncompliance with rules "however, as a gesture of goodwill, Twitter Inc is hereby given one last notice to immediately comply with the rules, failing which the exemption from liability available...Shall stand withdrawn and Twitter shall be liable for consequences as per the IT Act and other penal laws of India".

The notice, however, did not mention a specific date to comply with the rules.



The IT Ministry in its notice observed that the world's largest democracy had been among the first countries in the world, outside the parent country of Twitter Inc, to enthusiastically adopt the microblogging platform.

"Users who are abused on the platform or are harassed or are subject to defamation or sexual abuse or become victims or a whole range of other abusive content must get a redressal mechanism that the same people of India have created through a due process of law," the IT Ministry asserted.

The people of India, who use Twitter, "deserve and demand" a fair mechanism to address their grievances and resolve their disputes, it said. "Leave alone proactively creating such a mechanism, Twitter Inc is in the inglorious bracket of refusing to do so even when mandated by law," the ministry said in its notice to the company. Twitter declined to comment to an

TWITTER RESTORES VP'S VERIFIED BLUE TICK

NEW DELHI: Microblogging social media site Twitter Saturday removed the blue verified tick badge from the personal handle of Vice President M Venkaiah Naidu for a few hours. The blue tick badge was later restored after a few hours. However, the official handle of the Vice President of India @VPSecretariat, which was run by the Vice President's Secretariat, continues to have the blue badge. "The personal Twitter handle of the Vice President was not being used for some time because his tweets were being posted from his official account. It came to our notice Saturday that the blue tick has been removed from Vice President's personnel Twitter account." "Subsequently, we talked to Twitter over the issue and they informed us that the algorithm had been removed automatically as the account was not active for long," a source said.

Covid TPR declining; fatalities a concern

Bhubaneswar, June 5: While the Covid-19 test positivity rate (TPR) in the state has declined gradually, the fatality rate has remained a cause for worry.

The TPR of Odisha was 21.15 per cent May 22 and declined to 10.51 per cent Saturday. Health experts are optimist that it will drop further in the coming days.

According to the state Ministry of Health and Family Welfare, 19 districts of Odisha recorded an average TPR of above 10 per cent in the past week, while the TPR in nine districts is between 5 and 10 per cent. Similarly, only two districts Kandhamal and Bolangir have recorded below 5 per cent TPR in the past seven days (May 29 to June 4).

With the decline in the number of daily Covid cases, the districts under red zone (having active cases above pandemic, the state recorded over 3.20 lakh new cases and 711 fatalities during May, whereas only 118 persons were killed due to the virus in the previous month. In June, 198 Covid deaths -more than the total in April were reported so far in the state. The state recorded the highest fatalities (42) June 3,

Bhubaneswar, June 5: The state government's claims to provide Covid-19 test reports online through a Covid dashboard seems to be more on paper than on the ground, escalating the woes of coronavirus-infected patients and their families.

Several persons who gave their samples to the state-run testing labs for RT-PCR tests in Bhubaneswar Municipal Corporation (BMC) and Cuttack Municipal Corporation (CMC) areas are yet to receive their test reports on the website. When they contacted the civic authorities, they were told to personally visit the Capital Hospital in Bhubaneswar to get the physical copy of their reports.

"I gave my sample May 29 and received a call from the BMC May 31 saying that some of my family members had tested Covid positive. But we did not get the report online even after eight days after the phone call. When I asked for a report, the BMC told me



to visit Capital Hospital to get a physical copy of the report," Dipesh Patel told Orissa POST

He even posted the matter on Twitter and approached the BMC and other officials with his SRF ID and other details but no one responded. Similar is the fate of people of CMC area in Cuttack. A resident of Cuttack who submitted his sample May 21 did not receive the report even after 10 days. According to several aggrieved citizens who have faced such problems, positive patients about the result of their tests over phone but do not provide them with a physical copy.

People who test Covid negative suffer the most as in many cases they receive the result via SMS more than a couple of weeks later. Many of them even do not receive their reports online. Thus, such apathy of the authorities forces many to look for private players for fast testing and reports.

This reporter verified the claims of the aggrieved a few people with their SRF IDs on the system, but didn't find their report online.

When contacted, IT Secretary Manoj Mishra said, "To my knowledge, this is not true as I too get a lot of feedback. Data comes from all private and government setups and they get uploaded as they come." Health department additional chief secretary PK Mohapatra said, "All is well and the system is in place. People can access their reports online.'

New York, June 5: Amid the leaked Anthony S Fauci emails and independent investigations into the Wuhan lab secrets, reports have emerged again that the Wuhan Institute of Virology in China was funded by the US government and the virology lab, headed by Shi Zhengli, received nearly \$600,000 in 'gain-of-function' research.

At a US Senate hearing May 11, Senator Rand Paul said that scientists in the US have long known how to mutate animal viruses to infect humans. "For years, Dr Ralph Baric, a virologist in the US, has been collaborating with Dr Shi Zhengli of the Wuhan Virology Institute, sharing his discoveries about how to create super viruses. This gain-of-function research has been funded by the NIH. Dr Fauci, do you still support fund-



ing of the NIH funding of the lab in Wuhan?" he told the hearing.

cording to documents obtained by Daily Mail last year, the controversial Wuhan Institute of Virology in China undertook coronavirus experiments on bats and other wild animals which were funded by a \$3.4 million grant from the US government.

Zhengli, also known as the "Bat Women," is back in limelight as the conversation around the 'gain-of-function' research has once again started to dominate the headlines.

In 2014, the National Institute of Allergy and Infectious Diseases, the NIH arm which Fauci heads, awarded a \$3.4 million grant to the New Yorkbased EcoHealth Alliance, which aims to protect people from viruses that jump from species to species.

The group hired the virology lab in Wuhan to conduct genetic analyses of bat coronaviruses collected in

Yunnan province, about 800 miles southwest of Wuhan, Tampa Bay Times reported last month.

The research was considered crucial in part because coronaviruses had previously emerged in China and begun to spread among humans. EcoHealth Alliance paid the lab \$598,500 over five years. The lab had secured approval from both the US State Department and the NIH," the report mentioned. All parties involved in the grant to the Wuhan Institute of Virology have denied that it involved gain-of-function research.

In Wuhan, China, where the first cases of the coronavirus emerged in late 2019, at least two labs studied coronaviruses that originate in bats - the Wuhan Institute of Virology (WIV) and the Wuhan Center for Disease Control and Prevention (WHCDC).

Doorstep O₂ for home isolation patients in City

Bhubaneswar, June 5: In what would bring relief to home isolation Covid-19 patients in the Capital city, the Bhubaneswar Municipal Corporation (BMC) Saturday said that it would provide oxygen cylinders at the patients' doorsteps.

Addressing the media, BMC Commissioner Sanjay Singh said that the state government has provided 100 oxygen concentrators to the BMC which will be provided to the patients who have opted for home isolation. The much-awaited service would begin, Monday.

"We have developed an App for Covid-infected people who are under home treatment. They can book oxygen concentrators through the app and the BMC will provide the oxygen concentrators at their homes. People can also call 1929 crew who can assist the patients regarding the process to avail the fa-



cility," Singh said.

Meanwhile, clearing the air on availability of vaccines, the BMC Commissioner said that a blueprint is being prepared for inoculation of 18-44 age group and that

the vaccination drive for first and second dose to the beneficiaries will be intensified, Jun 8.

"Around 8, 57, 300 doses have been administered during the ongoing Covid-19 vaccination drive till

Moreover, he also stated that most people in the age group of 45 years (and above) have been covered with the first dose while 1, 70, 140 doses have been administered to the beneficiaries belonging to 18-44 age group.

This apart, the civic body has also decided to take up vaccination drive for students who want to pursue higher studies abroad. The registration process for such students will start, Sunday.

The BMC Commissioner further stated that daily Covid-19 cases are registering a decline in Bhubaneswar: Similarly, the pressure on ICU and other beds in hospitals is also reducing considerably.

COVID & JOBLESSNESS Plea in NHRC for ₹7K per month to all poor families

Bhubaneswar, June 5: At a time when Covid-induced restrictions have resulted in cessation of livelihood sources, a city-based trade union leader and rights activist moved the National Human Rights Commission (NHRC) seeking a direction to the Centre to provide ₹7,000 per month to the non-income tax payer families for six months.

The petitioner also urged the commission to direct the Union government to provide free ration of 10 kg per head per month up to 6 months to the needy families without any ration card.

Oppn slams govt over SDG report as BJD sees diversionary tactic

Power abuse charge against cops

If sources are to be believed, the investigating officer, who misbehaved with the victim's elder brother at the police station, was immediately shifted from the Airfield police station as soon as Bhubaneswar Deputy Commissioner of Police (DCP) Umashankar Dash learnt about the issue.

Mathuri, a resident of Airfield area, had a tiff with one of his friends, Ashis Kumar Mishra, in September 2020. Mishra had lodged a complaint with Airfield police who registered a case under different sections of IPC including 307. However, both the parties arrived at an amicable settlement after the villagers' intervention and requested the police to with-



draw the complaint. This reportedly irked the then IIC of Airfield police station, Deepak Kumar Mishra, who chided both the parties for wasting the time of police.

Mathuri's advocate alleged that the IIC, who was acquiesced to release Mathuri following the compromise, later instructed the staff to file a false case against Mathuri accusing him of fleeing police custody. The IIC also allegedly filed another case on the basis of the complaint filed by Mishra.

Subsequently, when both the parties learnt about the filing of a false case, they moved SDJM court to carry out a legal compromise agreement in the presence of the Judge February 4, 2021.

State to build panchayat bhawans to give jobs to returnee migrants

Woman's body recovered in Mayurbhani

Mahakalapara, June 5: In what is sure to bring smiles on the faces of fishermen and fish lovers the Hilsa fish was caught from the Gobari river in Kendrapara district after a long hiatus of 30 years, courtesy the cyclonic storm Yaas which recently hit the state.

Hilsa is known as 'Ilishi' in the local parlance and is a delicacy in almost every Odia household for its incredibly soft meat. The fish is rich in Omega-3 fatty acid that prevents coronary heart diseases in humans.

The cyclonic storm Yaas might have caused much devastation in Kendrapara district but it also brought cheers to fishermen and fish lovers as the high tidal waves during the calamity pushed the Hilsa fish from the sea into the Gobari river.

During the storm, tidal waves rose above 10 feet and crossed the coast at many places. As a result, the fish entered into various rivers near the coastline of the state.

The availability of Hilsa in Gobari brought windfall gains for small and marginal fishermen as they had a good catch. The villagers living near the river were also seen spreading out their

ermen sold the fish at over Rs 1,500 per kg to local traders. The traders then packed it in containers and transported it to Paradip and other parts of the state as well as Kolkata.

The local fishermen, who were struggling to earn their livelihood due to Covid induced lockdown and shutdown in the state, earned handsome profits. However, the high price made it difficult for locals to buy the fish for their households.

Thirty years back Hilsa was available in the Gobari river. However, with passage of time the availability of the fish in the river became a dream for fishermen

The fish generally lives in groups in deep sea but enters the rivers whenever floodwater in Mahanadi flows into the sea through the river mouth.

7 years of 'feats'

The National Democratic Alliance government marked its seventh anniversary at the end of last month. Celebrations were muted because of the sickness and death that the pandemic has brought to us. But the prime minister did put out a document on the achievements of the seven years. It was called Vikas Yatra and has 15 points.

The first point was 'Ease of doing business.' In the World Bank's report, India has risen from 142 to 63 in 'doing business'. This is indeed commendable. What does it mean? It is a survey of limited firms of a particular size and how easily they are able to obtain permits in two cities (Mumbai and Delhi). The Vikas Yatra document does not refer to what the result of India climbing on the index was. Presumably making doing business easier would result in more businesses investing.

But India's investment rate has fallen from 38 per cent of GDP before Modi to 28 per cent now.

The second point is called 'Ease of living'. This is not an index the world measures and it is not clear what is meant by it so I will leave it alone. The third one is 'Eliminating corruption' and says that 'PM Narendra Modi has led a historic battle against corruption. Now, honesty is honoured and transparency is the norm.

In Transparency International's Global Corruption Perceptions Index, India has fallen from 76th in the world in 2015 to 86th this year.

The fourth point is called 'Empowering youth opportunities'. It says "the last 7 years of Modi government have focused on clearing the path of India's youth as they navigate through opportunities across fields.'

The latest Periodic Labour Force Survey conducted by the Modi government says that youth unemployment in urban India is 23 per cent. Meaning one in four young people looking for work cannot find it. This is the highest rate India has ever had.

The fifth point is 'Health for all'. Here we need not look beyond what is going on around us at this very time. India's government is unique in the world in several ways. First because it has the highest cost of vaccination in the world. Second because there are three different vaccination procurements: the Centre, states and private companies. And third because India has defaulted on its commitments to vaccinate the world. We need not go into details of this today. So far as health for all is concerned only a few days ago oxygen was being sold for Rs 60,000 a cylinder lasting a few hours in Delhi and there was (and there is) no national helpline for finding oxygen and essential drugs.

The sixth point is called 'Infra for growth'. India's GDP growth has been falling since January 2018, according to the government's figures. It fell from 8 per cent to 7 per cent to 6 per cent to 5 per cent to 4 per cent to 3 per cent before the pandemic. Last year the economy contracted in its biggest fall in history.

The seventh point is called 'Mobility for the middle class' and says 'no other government has done more for them as the Modi government'. Last month a report by the Azim Premji University showed that during the pandemic

27 crore Indians were pushed into poverty. Meaning that they were not poor according to the government poverty line before but have become now.

Vikas Yatra point number 8 is called 'Nari Shakti for new India'. The participation of women in India's labour force is around 10 per cent today, the lowest in history. In a 2018 study by Thomson Reuters, India was found to be the most dangerous place for women in the world. In the 2020 Georgetown Institute's Women, Peace and Security Index, India ranked 133, having fallen two places since 2017.

Point 9 says 'Prosperous farmers for prosperous India'. It claims 'farmer welfare is a top priority for the Modi government.' The tens of thousands of farmers currently on protest outside Delhi who have been vilified as terrorists, khalistanis and anti-nationals will disagree.

Number 10 is 'Putting India first'. The claim here is on national security. We have not been told vet what the status of our patrolling in Depsang is by the government but if experts are to be believed we have given away space to China Number 11, 12, 13 and 14 are called 'Renewed focus on Northeast' and 'Social empowerment' and 'Taking development to the poorest' and 'Transformative economic growth'. These are generic terms but we can accept that work has been done on them. The final point is 'India fights Corona'. It would be interesting to see what the world thinks of that statement. Even with its underreporting of numbers on infections and deaths India has the second highest number of cases in the world and the third highest number of deaths. Estimates say that in reality it is the leader in both and that the number of deaths just in the second wave were over 10 lakh across India. This then is the state of the government of India and of our country as we enter the eighth year of the Modi government.

In 2018, 80 per cent of all net IUD placements in China (calculated as placements minus removals) were fitted in Xinjiang, a region with 1.8 per cent of China's total population. Between 2017 and 2019, the birth rate in Xinjiang declined by nearly half - the most extreme such drop anywhere since the UN began recording these statistics. More disturbing still, Xinjiang's 2020 statistical yearbook contains no birth-rate data.

The Chinese government has eliminated Uyghur education and demolished most of Xinjiang's sacred sites. Senior officials have issued orders to "eradicate tumors," "round up everyone," "wipe them out completely," and "break their lineage, break their roots, break their connections, and break their origins." As the Supreme Court of Canada held, incitement to genocide is a breach of the Genocide Convention in and of itself. The rhetoric of combating "extremists" is simply code for persecuting Uyghurs, as China's ruthless policies target southern Xinjiang, where Uyghurs constitute about 90 per cent of the population. In fact, the government publicly admitted that the sharp of mass detention and forced labour transfers, and other highlevel directives. The fact that highranking officials risked their lives to disclose these classified docu ments indicates how severe the atrocities have become. Countless others have testified at extreme risk to themselves and their families to record their accounts with the Xiniiang Victims Database. which is expanding by the day.

The only international courts that can hear genocide cases - the International Court of Justice and the International Criminal Court - cannot realistically exercise jurisdiction anytime soon. China does not recognise the ICJ's authority over questions of genocide and is not a party to the ICC. Moreover, as a permanent member of the UN Security Council, China can block any attempt at an ICC referral.

While a UN fact-finding mission may fill this impunity gap, China has denied foreign observers unfettered access to Xinjiang for years, and is now aggressively denying the existence of any atrocities. Over the last year, it has expelled foreign journalists, scrubbed the internet of evidence, sance tioned and smeared parliamentarians and experts, and lectured other countries on mass atrocities and genocide. China's Foreign Ministry even called camp survivors of rape and forced sterilisation "actresses," and questioned their character.

In March, following an independent examination of the situation in Xinjiang, more than 50 experts on international law, geno cide, and the region agreed that the Chinese state's atrocities rise to the level of genocide. With all other paths to justice foreclosed, the responsibility falls on national governments to speak up for the victims and fulfill their obligations under the 1948 Convention to prevent and end complicity in the genocide.

Nick of time

his is definitely one of the stranger idioms in the language. The This is definitely one of the stranger formation in the same word as that for a language experts are sure that nick here is the same word as that for a small cut or notch. Sometime round about the 1580s the phrase in the nick or in the very nick began to be used for the critical moment, the exact instant at which something has to take place. The idea seems to have been that a nick was a narrow and precise marker, so that if something was in the nick it was precisely where it should be. It seems that users of the expression pretty soon afterwards found this association of ideas needed some elaboration, so started to add of time to the expression, and that's the way it has stayed ever since. These days, the phrase more usually refers to something that only just happens in time, at the last possible moment. There are a number of other expressions involving nick, as in yet another name for the devil (this time from the personal name Nicholas). There are the British slang terms for theft ("my car's been nicked!") or for a police station ("the nick"), or the act of being arrested ("you're nicked!"). There's also the American sense of defrauding a person of money, and the Australian ideas of moving guickly or furtively, or of being in the nude ("in the nick"). Most of these, except perhaps the last, come from senses of nick that may derive from an old and defunct colloquial sense of seizing an advantage or grabbing an opportunity, which isn't far from the idea of being in the nick of time. But the history of the word is confused and complicated (there's also the animal breeders' sense of a mating that has had excellent results, for example, as well as the old sporting sense of a winning throw at dice) to the extent that you'd need half a book to explain them all.

nforming someone that they have cancer is indescribably difficult. It is all the more heartwrenching when we know that their disease possibly could have been detected and treated earlier, thus increasing their survival chances, or even prevented entirely.

Ten million people died prematurely from cancer in 2020. Half of these deaths could have been prevented by greater awareness of risk factors and early warning signs, earlier consultations, and easier and more timely access to health services and high-performance testing equipment. Moving swiftly toward universal health coverage (UHC) can help to achieve this goal.

There are several reasons why we currently are not all equal before cancer. These "social determinants of health"-such as where we are born and grow up, where we currently live and work, and our income level – influence our perceptions and understanding of cancer and the risks that contribute to its development.

Crucially, these factors also help to determine the quality of care we can access, which depends on the robustness of our local health sys-

tem, the number of available health facilities or specialised doctors, the ease of travelling to a facility and staying for care, and the cost of the care itself. A range of personal, social, cultural, and religious influences also play a role. Stigma and discrimination related to age, sexual orientation, and ethnicity for example, create real barriers that prevent people from receiving the level of healthcare they need.

Extending health coverage to everyone can help to overcome socioeconomic inequities in healthcare access, thereby preventing millions of cancer-related deaths. At the same time, resource-efficient measures that all countries can take to reduce the cancer burden-developed and implemented via national cancer control planning - can facilitate the move to UHC. In this sense, cancer control and UHC go hand in hand.

For example, most people do not think of cancers as being preventable through vaccination, because they are non-communicable diseases that arise due to changes or mutations in the body's cells rather than from transmissible pathogens. But 70 per cent of cervical cancer cases are caused by the

human papillomavirus (HPV), which is contagious through sexual contact and can be contained, if not eliminated, through vaccination. Furthermore, the earlier cervical cancer is detected, the higher the survival rate. The international community has thus committed to vaccinating 90 per cent of girls aged 9-15 against HPV by 2030, and to screening 70 per cent of women between the ages of 35 and 45 for cervical cancer. Achieving these targets would save millions of lives over the coming decades. HPV is also responsible for causing several other genital cancers, as well as for the dramatic rise in oropharyngeal cancers (affecting the tonsils and the base of the tongue) in the West over the last decade.

Early detection is also vital to treating other cancers. The five-year survival rate for breast cancer can be above 90 per cent in well-resourced countries such as the United States. where women have greater access to health information and services. But in countries where cancers are often detected later and are thus harder to treat, the five-year survival rates are much lower – 66 per cent in India and 40 per cent in South Africa, for example. UHC not only saves lives

and upholds people's fundamental right to health and human dignity, but also contributes to social and political stability and yields valuable economic benefits. After all, the healthier a population is overall, the more resilient and productive it tends to be. For example, in my home country. India, a majority of the population lacks health insurance. The federal government's National Health Protection Scheme (NHPS, or Ayushman Bharat, popularly known as Modicare) is a welcome first step toward making health services more accessible and affordable, particularly for the poor and in rural areas where such services are most needed.

The pandemic has highlighted the need for stronger health systems and universal health coverage in order to prevent further avoidable deaths. Taking the same approach to controlling cancer can help to ensure that five million people a year do not die prematurely – and that no doctor needs to tell another cancer patient that their illness could have been prevented.

Living in denial

Sir, In Odisha, despite repeated counselling by contact tracers, those in isolation still do not understand the gravity of the situation and believe they can go out to dispense money from ATMs or for some such errands. Even before receiving the test reports many returnees are already in contact with family, friends and neighbours, thereby allowing the virus a free rein. But perhaps this is also a learning curve. The Health Department has done a commendable job by analysing the Covid deaths and consequently finding out the close correlations between vaccination and a life saved. What's also true in Bhubaneswar is public hesitancy to be randomly tested for fear of being tested Covid positive. People prefer to live in denial. Even when they do fall sick and develop symptoms, many prefer to self medicate, telling themselves and others that it's a common cold or influenza that will heal itself. Perhaps the number of deaths could have been prevented through timely healthcare and hospital admission. The district administrations through ASHAs have tried their utmost to reach out to people with the right messages, calling them for random testing and trying to convince especially the elderly to vaccinate themselves, but to no avail. The problem is compounded by social media, particularly WhatsApp where conspiracy theories on Covid vaccination go viral. **K Ravi**, BHUBANESWAR

Scarcity at core

Sir, Apropos the news report 'Rethink vaccination policy', ORISSA POST, June 4, India's vaccination policy is under severe public scrutiny. Scarcity is the root of all questions being asked of the vaccination policy. The Centre's 'liberalised' policy of allowing vaccine companies to strike deals with states and private hospitals has borne limited fruit. While the age group of 18-44 years accounts for the bulk of vaccines being administered, attempts by states to negotiate deals with international vaccine companies have come to naught. The Supreme Court too has expressed its dissatisfaction over the existing system that puts states in competition with each other and the Centre, almost like another competitor, for vaccine supplies. Kolkata, June 5: The West Bengal government is issuing certificates of Covid-19 vaccination to the people in the age group of 18-44 sponsored by the state with the photograph of Chief Minister Mamata Banerjee.

An official said Saturday this is being done since the state government has been procuring vaccines directly from the manufacturers from its own resources

While beneficiaries of 45 plus are getting certificates of vaccination with the photograph of Prime Minister Narendra Modi as in other parts of the country, but those falling in the 18-44 age bracket have photographs of Mamata Banerjee.

The government has started procuring vaccines directly from the manufacturers and arranging for inoculating the pouplation. That is the reason it has been decided to use photograph of the CM on the certificates, a senior state official told PTI on condition of anonymity.

When contacted, state minister for Housing and outgoing Mayor of the city Firhad Hakim, who is also the chairman of the Kolkata Municipal Corporation board of administrators, justified the practice, saying since the Centre was not vaccinating 18-44 years of the population and the state is spending money for it, then there will be photograph of the CM.

All information regarding inoculation is there on the certifi-



cate. Starting from the batch number of the vaccine, there is also CoWIN Registration number. Besides, a special message of the CM, Hakim said.

Hakim said there is nothing unusual about this as the state governments of Punjab, Chhattisgarh and neighbouring Jharkhand have already started issuing similar vaccination certificates to people in the 18-44 years with photographs of their respective Chief Ministers.

But, the move has created confusion among some recipients of the jabs as whether they will be getting another certificate issued by the Central government through CoWin having photographs of PM Narendra Modi, officials admitted. Till Friday, the state government

has spent nearly Rs 150 crore to procure vaccines to inoculate population in the 18-44 age group, an official said, adding that so far around 29 lakh people of this cat-



egory have been vaccinated.

Earlier controversy had erupted in Bengal after the Centre had started issuing certificates to people administered shots through CoWIN with Modi's photograph since the inoculation drive began January 16 Amidst state polls, the Trinamool

Congress had moved Election Commission of India (ECI) on the issue, stating that the PM's photograph on such certificates was violating the model code of conduct. Following this, the PM's pho-

tograph was removed from the certificates and soon after the results of the elections were out, the images started resurfacing on the certificates of people getting inoculated.

Reacting to issuance of certificates with Banerjee's photo, BJP MP from Bankura Dr Subhas Sarkar, when contacted said it is petty politics of the TMC.

States ease lockdowns as Covid cases decline

Overall, India saw 120,529 new coronavirus infections emerge over the last 24 hours, while deaths rose by 3,380. The country's total case tally stands at 28.69 million while 344,082 people have died.

New Delhi, June 5: Some of India's states are easing lockdown restrictions as coronavirus infections subside, with the world's second most-populous nation Saturday logging its lowest daily case count in nearly two months.

The national capital territory of Delhi, the seat of India's federal government, was among those relaxing restrictions and will allow shops to open on alternate days. Shops with even numbers will open on one day while those with odd numbers will open the next day. Private offices will also now be allowed to operate at 50% of normal staffing levels.

"The coronavirus situation in Delhi is slowly getting better,' Chief Minister Arvind Keiriwal said in an online news conference as he announced that the state will build oxygen storage capacity of 420 tonnes

Hospitals in Delhi had struggled to provide oxygen cylinders and beds to patients as infections surged but that wave began subsiding from the middle of last month.

Keiriwal said the state would in future be prepared to deal with 37,000 new cases a day. Its peak thus far was 28,395 new infections April 20.

In northern Uttar Pradesh, the country's most populous state, only night curfew restrictions remain for 55 of its 75 districts

'Oxygen Express' trains have crossed the milestone of delivering 25,000 tonnes of liquid medical oxygen across 39 cities in 15 states/UTs amid the Covid-19 outbreak, the national transporter said Saturday.

The Indian Railways has so far delivered more than 25.629 tonnes of liquid medical oxygen (LMO), in more than 1,503 tankers, to various states and Union territories (UTs) across the country.

While 368 Oxygen Express trains have completed their journey so far and brought relief to various states/UTs, seven loaded trains with more than 482 tonnes of LMO in 30 tankers are on their way.

Assam received its fifth Oxygen Express with 80 tonnes of LMO in four tankers from Jharkhand, whereas 3,000 tonnes oxygen was offloaded in Karnataka.

The railways' special Oxygen Express trains started their deliveries April 24 in Maharashtra with a load of 126 tonnes of oxygen.

The oxygen relief by Oxygen Express so far reached 15 states/UT, namely Uttarakhand, Karnataka, Maharashtra, Madhya Pradesh, Andhra Pradesh, Rajasthan, Tamil Nadu, Haryana, Telangana, Punjab, Kerala, Delhi, Uttar Pradesh, Jharkhand and Assam.

So far, 614 tonnes of oxygen has been offloaded in Maharashtra, nearly 3,797 tonnes in Uttar Pradesh, 656 tonnes in Madhya Pradesh, 5,790 tonnes in Delhi, 2,212 tonnes in Haryana, 98 tonnes in Rajasthan, 3,097 tonnes in Karnataka, 320 tonnes in Uttarakhand, 2,787 tonnes in Tamil Nadu, 2,602 tonnes in Andhra Pradesh, 225 tonnes in Punjab, 513

tonnes in Kerala, 2,474 tonnes in Telangana, 38 tonnes in Jharkhand and 400 tonnes in Assam.

New Delhi, June 5: The National Medicinal Plant Board (NMPB) and the National Botanical Research Institute(CSIR-NBRI) have signed an MoU for extending joint collaborative efforts to boost the cultivation and production of medicinal plants and herbs in India.

The MoU will facilitate development of Quality Planting Material (QPM) of medicinal plants and herbs identified by NMPB, help in establishment of their nurseries for QPM, development, promotion, conservation and cultivation of the appropriate medicinal plants in different agro-climatic zones, including the threatened medicinal plant species and plants for the high-altitude regions.

Through this collaboration, NMPB will support CSIR-NBRI in carrying out the potential medicinal plant species with high commercial value for the germplasm collection or conservation and establishment of nursery, seed banks, and gene banks. The MoU was signed Friday.

NBRI while undertaking the survey of medicinal plants will work in coherence with NMPB in the desired direction.

The outreaches of NMPB and its implementing agencies like State Medicinal Plants Boards (SMPB's), Regional-cum-facilitation centres will work together under the ambit of this MoU. Working under the Ministry of Ayush, NMPB is mandated to coordinate all matters relating to medicinal plants and support policies and programmes forgrowth of trade, export, conservation and cultivation of medicinal plants.

This indicates that air pollution is a regional issue and the solution to this crisis also needs immediate attention and implementation of a comprehensive clean air action plan at regional levels rather than only focusing on a few cities like Delhi," he said.

As many as 66.7 lakh people died in the world due to air pollution in 2019 out of which 16.7 lakh people died in India alone, making it the second highest after China where 1.85 million died due to air pollution, according to the report.

It also said in 2019, toxic air caused 60 % of chronic obstructive pulmonary disease deaths, 43 % of lower respiratory infection deaths, 35 % of ischemic stroke deaths and 32 % of lung cancer deaths.

Just five states — Uttar Pradesh (3.5 lakh), Maharashtra (1.39 lakh), Bihar (1.26 lakh), West Bengal (1.23 lakh) and Rajasthan (1.13 lakh) account for half of the deaths due to air pollution in 2019

FATF's regional body retains Pak on 'enhanced follow-up'

Islamabad, June 5: The Asia Pacific Group (APG) on Money Laundering, a regional affiliate of FATF, has retained Pakistan on "enhanced follow-up" status for sufficient outstanding requirements, while improving the country's rating on 21 of the 40 technical recommendations of the global watchdog against money laundering and terror financing.

Pakistan was put on the grey list by the Paris-based Financial Action Task Force (FATF) in June 2018 and the country has been struggling to come out of it. The second Follow-Up Report

(FUR) on Mutual Evaluation of Pakistan released by the APG also downgraded the country on one criteria

The report said Pakistan was re-rated to 'compliant' status on five counts and on 15 others to 'largely compliant' and on yet another count to 'partially compliant'. Dawn newspaper reported that overall, Pakistan is now fully 'compliant' with seven recommendations and 'largely compliant' with 24 others.

The country is 'partially compliant' with seven recommendations and 'non-compliant' with two out of a total 40 recommendations. All in all. Pakistan is now compliant or largely compliant with 31 out of 40 FATF recommenda-



tions. The reporting date for this evaluation was October 1, 2020, which means Islamabad may have made further progress since then that would be evaluated at a later stage

"Pakistan will move from enhanced (expedited) to enhanced follow-up, and will continue to report back to the APG on progress to strengthen its implementation of anti-money laundering and combating financing terror (AML/CFT) measures," the APG said. Pakistan submitted its third progress report in February 2021 which is yet to be evaluated.

"Overall, Pakistan has made notable progress in addressing the technical compliance deficiencies identified in its Mutual Evaluation Report (MER) and has been rerated on 22 recommendations,' the APG added.

FATF's Mutual Evaluation Report (MER) of jurisdictions is assessed in two domains - technical compliance or legal instruments (40 FATF recommendations) and demonstration of effectiveness (11 immediate outcomes).

It has been more than a year since the military standoff between China and India erupted in eastern Ladakh May 5, 2020 during which there were fatalities on both sides for the first time in 45 years. They have made limited progress in achieving disengagement at the Pangong Lake area while negotiations for similar steps at other friction points remained deadlocked.

Asked about the growing proximity between Russia and China and if that will impact the Indo-Russia security and defence cooperation, Putin said the relations between India and Russia were developing quite rapidly, quite successfully based on "trust"

"We highly appreciate such a high level of cooperation with our Indian friends. These relations are of a strategic nature. They cover a whole range of avenues of our cooperation in economy, energy and hi-tech. In defence, and I am not just talking about purchase of Russian arms...We have very deep profound relations with India based on trust," he said.

Washington, June 5: The blob, captured on distant. fuzzy video by Navy pilots, seems to skitter just above the ocean waves at improbable speed, with no discernible means of propulsion or lift. "Oh my gosh, man," one aviator says to another as they laugh at the oddity. "What ... Is it?" Is it a bird? A plane? Super drone? An extra-terrestrial

something? The US government has been taking a hard look at unidentified flving objects like this one. A report summarising what the US knows about "unidentified aerial phenomena" — better known as UFOs - is expected to be made public this month.

There won't be an alien unmasking. Two officials briefed on the report say it found no extra-ter-

restrial link to the sightings reported and captured on video. The report won't rule out a link to another country, according to the officials, who spoke on condition of anonymity because they weren't authorised to discuss it.

While the broad conclusions have now been reported, the full report may still present a broader picture of what the government knows. The anticipation surrounding the report shows how a topic normally confined to science fiction and a small, often dismissed group of researchers has hit the mainstream. Worried about national security threats from adversaries, lawmakers ordered an investigation and public accounting of phenomena that the government has been loath to talk about

for generations. 'There is stuff flying in our air-



space," Republican Sen. Marco Rubio of Florida, one of the senators who pressed for the probe, recently told Fox News. "We don't know what it is. We need to find out."

Congress late last year instructed the director of national intelligence to provide "a detailed analysis of unidentified aerial phenomena data" from multiple agencies and report in 180 days. New Delhi, June 5: India's gross Good and Services Tax (GST) revenue collections remained above the psychological mark of Rs 1 lakh crore, clocking a high of Rs 1,02,709 crore in May 2021, beating all the expectations of lower collections in the wake of the disruptions caused by the second wave of the Covid-19 pandemic. Though the GST revenues in May 2021 are lower than the record Rs 1.41 lakh crore collections made in the previous month, the highest since the introduction of the tax in 2017, they are still significant as most tax experts had feared that the real impact of the pandemic and the lockdowns in different parts of the country would pull down GST collections significantly in May.



"The revenues for the month of May 2021 are 65 per cent higher than the GST revenues collected in the same month last year," the Finance Ministry said in a statement.

"During the month, revenues from import of goods were 56 per cent higher, while the revenues from domestic transaction (including import of services) were 69 per cent higher than the revenues from these sources during the same month last year," it

added. According to the statement, the gross GST revenue collected in May 2021 was Rs 1,02,709 crore of which CGST was Rs 17,592 crore, SGST Rs 22,653 crore, IGST Rs 53,199 crore (including Rs 26,002 crore collected on import of goods) and Cess Rs 9,265 crore (including Rs 868 crore collected on import of goods).

The revenue figures include GST collections from domestic transactions till June 4 since the taxpayers were given various relief measures in the form of waiver or reduction in interest on delayed return filing for 15 days for the return filing month of May in the wake of the second wave of the pandemic.

In May, the government settled Rs 15,014 crore to CGST and Rs 11,653 crore to SGST from IGST as regular settlement, the statement said.

With May collections staying above the Rs 1 lakh crore-mark it is the eighth month in a row when GST revenues crossed the threshold. The collections are surprising as most of the states have been under strict lockdown due to the pandemic.

In addition, while the taxpayers with a turnover of above Rs 5 crore had to file their returns by June 4, which they would have otherwise filed by May 20, smaller taxpayers with turnover less than Rs 5 crore still have time till the first week of July to file their returns without any late fee and interest.

G7 nations reach historic deal to tax big MNCs

New York, June 5: A group of the world's richest nations reached a landmark deal Saturday to close cross-border tax loopholes used by some of the world's biggest companies. The Group of Seven said it would back a minimum global corporation tax rate of at least 15%, and put in place measures to ensure taxes were paid in the countries where businesses operate.

"After years of discussion, G7 finance ministers have reached a historic agreement to reform the global tax system to make it fit for the global digital age," British finance minister Rishi Sunak told reporters.

The accord, which could form the basis of a global pact next month. is aimed at ending a decades-long "race to the bottom" in which countries have competed to attract corporate giants with ultra-low tax rates and exemptions.

That has in turn cost their public coffers hundreds of billions of dollars - a shortfall they now need to recoup all the more urgently to pay for the huge cost of propping up economies ravaged by the coronavirus crisis

According to a copy of the final agreement seen by Reuters, the G7 ministers said they would "commit to a global minimum tax of at least 15% on a country by country basis".

"We commit to reaching an equitable solution on the allocation of taxing rights, with market countries awarded taxing rights on at least 20% of profit exceeding a 10% margin for the largest and most profitable multinational enterprises," the text added.

The ministers also agreed to move towards making companies declare their environmental impact in a more standard way so investors can decided more easily whether to fund them, a key goal for Britain.

Notably, Radhakrishna's post on Saturday coincides with the Indian government issuing a notice to Twitter, giving it one last chance to "immediately" comply with the new IT rules. Twitter has also been warned that failure to adhere to the norms will lead to the platform losing exemption from liability under the IT Act.

Koo had earlier said it has already complied with the IT rules and has shared necessary details as sought by the government on the issue.
