

NINE CORPORATE HOSPITAL GROUPS CUMULATIVELY BOUGHT 60.57 LAKHS OF THE 1.20CR VACCINE DOSES IN MAY SINCE THE CENTRE REVISED ITS POLICY AND OPENED IT TO THE MARKET



According to a report, the remaining 50 per cent of the vaccine stock was procured by 300-odd hospitals, mostly located in the urban centres who hardly served people beyond the Tier-2 cities.

The Centre had allowed state governments and private players to buy 50 per cent of total production directly from vaccine manufacturers from May 1, itself purchasing the remaining 50 per cent of the output to distribute it to states to vaccinate the 45-plus age group.

The purchases by private hospitals in May was 1.20 crore doses or 15.6 per cent of the total procurement of 7.94 crore doses. Of this, they administered only 22 lakh doses or 18 per cent of the doses received during the month. On the other hand, the states procured 33.5 per cent or 2.66 crore doses and the Centre 50.9 per cent or 4.03 crore doses.

The top nine private hospitals are Apollo Hospitals (16.1 lakh doses); Max Healthcare (12.97 lakh doses); Reliance Foundation-run HN Hospital Trust (9.89 lakh doses); Medica Hospitals (6.26 lakh doses); Fortis Healthcare (4.48 lakh doses); Godrej (3.35 lakh doses); Manipal Health (3.24 lakh doses); Narayana Hrudalaya (2.02 lakh doses) and Techno India Dama (2 lakh doses).

All these groups have their presence mostly in metros, state capitals and Tier-I cities. While the Centre has fixed the price of single dose of Covishield produced by Serum Institute

of India (SII) and Covax produced by Bharat Biotech at ₹150, these private hospitals are reportedly charging ₹850 - ₹1,000 for each dose of Covishield and ₹1,250 for a single dose of Covaxin. This may be affordable for a section of city residents, but it is not so for the lower middle class and the poor.

Tejal Kantikar, Associate Professor, National Institute of Advanced Studies in Bangalore, said, "Manufacturers will prefer to sell their stock to private players and hospitals that have more bargaining power."

In a suo motu hearing on vaccina-

tion, the Supreme Court last Wednesday rapped the Centre on its vaccine policy, calling the decision to make 18-44 year olds pay for their doses "arbitrary and irrational." It asked the Centre to review the vaccine policy while observing that the digital divide had hampered vaccination in rural areas, the report said.

But it is not just the digital divide. May's procurement data shows most stock purchased by the private sector is concentrated in urban regions. Apollo Hospitals purchased stock in nine cities, Max Healthcare purchased stock in six cities, HN Hospital (of Reliance Foundation) has only two hospitals in Mumbai and Navi Mumbai, while Medica has one hospital in Kolkata. The procurement data further reveals a strong urban bias with hospitals in the National Capital Region (NCR), Mumbai Metropolitan Region (MMR), Kolkata, Bengalore and Hyderabad together accounting for 80 per cent of total stock in May.

In stark contrast, Tier-III cities could procure only a few thousand doses. For example, Sarji, a small private hospital in Shimoga, a small city in Karnataka with 3.22 lakh population, bought 6,000 Covishield doses. In Jalgaon, Vishwaprabha Hospital bought 5,120 doses.

Fuel prices hiked again

New Delhi, June 6: Petrol price Sunday crossed ₹95 a litre in Delhi and diesel breached ₹86 per litre mark for the first time ever as fuel prices were hiked again.

Petrol price was increased by 21 paise per litre and diesel 20 paise a litre, according to a price notification of stateowned fuel retailers.

The hike - 20th since May 4 - took fuel prices across the country to a historic high. Petrol is now above ₹100 per litre mark in six states and union territories - Rajasthan, Madhya Pradesh, Maharashtra, Andhra Pradesh, Telangana

and Ladakh. In Delhi, petrol hit an all-time high of ₹95.09 a litre, while diesel is now priced at ₹86.01 per litre. Fuel prices differ from state to state depending on the incidence of local taxes such as VAT and freight charges.

Shots for 18-44 age group in 22 new urban areas soon

Bhubaneswar, June 6: The state Health Department Sunday said that vaccination drive for people in the 18-44 age group will soon be expanded to 22 more municipalities and Notified Area Councils (NAC) with the availability of more number of Covid-19 vaccine doses

The government's decision came at a time when the state is expecting to receive 6,45,790 doses of Covishield in three trenches. With the availability of these doses, the vaccination drive would be expanded in the state. The department plans to give priority to students and athletes in the 18-44 year age group, officials said.

Earlier, the vaccination drive for this group was confined to five municipal corporations and six municipalities/NACs. BMC Commissioner Sanjay Singh said that more online slot bookings for vaccination of 18-44 age group will be taken up in the next four to six weeks.

Meanwhile, online slot booking for the first dose for the 18-44 age group started in several districts of Odisha Sunday.

Bijay Panigrahi, Director, Health and Family Welfare, said that vaccines received from the Centre were not used for inoculating this age group. Instead, vaccines procured directly from the manufacturers were used to inoculate this group of people.

Biden reinvigorates tariff war against India

PRESIDENT BIDEN THREATENS TO INCREASE IMPORT DUTIES ON A RANGE OF ITEMS IN RETALIATION AGAINST NEW DELHI IMPOSING DIGITAL SERVICES TAX ON TECH GIANTS

New York. June 6: The US tariff war against India has been reinvigorated by President Joe Biden threatening to increase import duties on a range of imports, from prawns and Basmati rice to furniture and jewellery, in retaliation against New Delhi imposing Digital Services Tax (DS) on tech giants.


The US Trade Representative Katherine Tai announced June 2 the plan for the 25 per cent increase in the tariffs on 26 items from India, but said that the hikes will be on hold till

India imposed a two per cent tax starting in April last year on earnings in the country by foreign technology and e-commerce companies like Amazon, Facebook and Google. It was opposed by the administration of former President Donald Trump, and Biden has picked up the baton.

The Trade Representative's Office said: "India's DST is unreasonable or discriminatory and burdens or restricts US commerce.

The Office estimated the increased taxes on the selected imports from India will equal the taxes India assesses on the US companies under the DST.

"Estimates indicate that the value of the DST payable by US-based com-



pany groups to India will be up to approximately \$55 million per year. The level of trade covered by the action takes into five account estimates of the amount of tariffs to be collected on goods of India and the estimates of

the amount of taxes assessed by India." The other items threatened with increased duties include bamboo, window shutters, cigarette papers, pearl, copper foil and bedroom furniture.

Inaugurating the new phase of trade

wars, the Biden administration also threatened to increase tariffs on imports from five other countries - the UK, Austria, Italy, Spain and Turkey over their DST.

Explaining the reason for holding the increases in abeyance for the six countries, Tai said it was to help the international negotiations on taxation.

"The US remains committed to reaching a consensus on international tax issues through the OECD (Organisation for Economic Cooperation and Development) and G20 processes. Today's actions provide time for those negotiations to continue to make progress while maintaining the option of imposing tariffs.

In the first phase of the negotiations, the Finance Ministers of the G7, the major western industrial powers, meeting in London agreed Saturday to a minimum 15 per cent corporate tax rate to prevent companies using legal loopholes to avoid paying taxes on incomes in countries where they operate.

The deal will next go to next month's meeting in Italy of the G20 – a group of 19 countries, industrialised and developing, and the European Union.

The latest Biden salvo opens a new front in the trade war between the two countries that started in 2018 when Trump imposed 25 per cent duties on steel and aluminium imports from India.

In 2019, Trump withdrew the special treatment for some Indian exports, mostly low-tech items and handicrafts, under the General System of Preferences (GSP) that exempted them from import duties.

New Delhi retaliated with higher tariffs on 28 US products that included walnuts and almonds

Biden has not so far taken steps to reinstate the GSP facility for India.

Odisha puts up improved show in PGI 2019-20

New Delhi, June 6: The Odisha government has shown improvement of over 10 per cent in the Performance Grading Index (PGI) 2019-20 released by the Union Education Ministry with a set of 70 parameters to catalyse transformational change in the field of school education across the country.

Odisha, which had scored between 701 and 750 in 2017-18 and 2018-19, has secured 838 points in PGI 2019-20. The state has been given Grade-I in PGI 2019-20 along with Andhra Pradesh, West Bengal, Karnataka, Himachal Pradesh and others.


The state has shown over 20 per cent improvement in PGI domain – infrastructure and facilities. It has also improved its performance in Equity domain by 10 per cent along with Arunachal Pradesh and Manipur.

"The state of Odisha scored 109 in 2019-20 from 72 in 2018-19 showing marked improvement in infrastructure domain between 2019-20 and 2018-19. This indicates that the state has

started to take action for improving its infrastructure and facilities," the ministry said. Union Education Minister Ramesh Pokhriyal 'Nishank' approved the release of Performance Grading Index (PGI) 2019-20 for states and Union Territories of India Sunday.

The ministry informed that Punjab, Chandigarh, Tamil Nadu, Andaman & Nicobar Islands and Kerala occupy the highest grade (Grade A++) for 2019-20. The state of Punjab topped the chart with the score of 929 followed by Chandigarh (912), Tamil Nadu (906), Kerala and Andaman & Nicobar Islands both scored 901.

The PGI exercise envisages that the index would propel states and UTs towards undertaking multipronged interventions that would bring about the muchdesired optimal education outcomes. The PGI helps the states/UTs to pinpoint the gaps and accordingly prioritise areas for intervention to ensure that the school education system isrobust at every level." the Education Ministry said.

Toxic chemicals in street food worrisome

Bhubaneswar, June 6: Several street food items examined by the Food Safety department in the last one year were found to be laced with high levels of synthetic colours, revealed an official of the department.

During random checks of street food items in Bhubaneswar and Cuttack, it was found that the varieties of sauces used by the fast food sellers contained industrial dyes which could aggravate health complications if consumed for a longer period of time, department sources

said. "During the checks, we found that vendors selling noodles and other fast food items used sauces which contained synthetic dyes unfit for human consumption,' said the official.

Adulterated paneer, oil and other food items also became a cause of concern among the officials of the Food Safety department. The department also found higher levels of monosaccharides in paneer and dairy products available in the market. Health experts are of the view that people should consume naturally-grown food to avoid health

complications. "People often get lured by the street foods. But, the harmful chemicals in street foods are causing several health complications. The best way to remain healthy is to opt for the natural food sources and shun packaged items and fast food," said Maheshwari Sangolli, a lifestyle

physician from the city. She also added, "The best way is to look for plant-based food items and cook those at home. Animalbased foods often contain antibiotics and other harmful elements which can cause health complica-

tions. By eating homemade food, people can avoid preservatives and harmful chemicals present in many unhealthy street foods.'

Avashkant Singh, a gastroenterologist from the city, said consumption of chemical dyes could have long lasting effect on health of a person. "It varies from shortterm effects like diarrhoea and ulcer to serious cases like cancer if consumed for longer period."

"We know what unsafe food can do. Consumption of safe food will improve nutrition among the youths and protect them from diseases. Safe food can lead to less cases of hospitalisation," he added.

According to government data the Food Safety department tested more than 500 samples of food and beverages and found several cases of adulteration and misbranding.

State turning hotbed of drug trade

Bhubaneswar, June 6: The growing tentacles of drug abuse across Odisha have turned into a major cause of worry for the security agencies in the state.

Illegal trade of brown sugar is rapidly making its inroads into different parts of the state.

The data released by Odisha Police Saturday exposes the grim reality of drug abuse in the state during the last couple of years. According to the data, the state police seized 35.616 kg of brown sugar in 2020. The amount of seizure of illegal drugs in 2020 is more than 17 times the amount seized in 2019.

The state police had seized 2.647 kg of brown sugar in 2019 while the seized amount stood at 1.45 kg in 2018.

Speaking to Orissa POST, an official of the Special Task Force (STF) on condition of anonymity said that the huge seizure barely impacted the rampant drug trade in the state. The seizure is like a tip of the iceberg.

A DRI officer claimed that due to the rapid urbanisation, Bhubaneswar has become a hotspot for illegal trade in drugs. The slums with their ever increasing popu-

2 CYBER FRAUDSTERS NABBED IN CUTTACK, ₹1 LAKH SEIZED

Cuttack, June 6: Chauliaganj police Sunday claimed to have arrested two cyber fraudsters and seized around Rs 1 lakh from them.

The accused were identified as Supravat Mahapatra, 26, of Satyabadi area in Puri and Tanmaya Kumar Behera, 24, of Biridi in Jagatsinghpur.

The two fraudsters were produced in a local court. We have seized around Rs 1 lakh, three mobile phones and a scooter from the duo," said Cuttack Deputy Commissioner of Police Prateek Singh. According to the DCP, Rabi Narayan Mahapatra, a resident of Nuabazar in the city here, had received a phone call from an unknown person a few days ago.

The caller identified himself as

a senior official of SBI and told Mahapatra that a cheque worth Rs 1 lakh as insurance money has arrived in the latter's name.

The caller sought Rs 45,000 from Mahapatra to clear the cheque. Soon, Mahapatra deposited the money in two installments in two separate accounts of the caller.

After receiving the money, the caller remained incommunicado to Mahapatra. A complaint in this regard was filed with the Chauliaganj police.

"During interrogation, we found that the two accounts were in the name of Supravat. Tanmaya had assisted Supravat in the crime," said the DCP. The police, meanwhile, claimed that several cases have been filed against Supravat at various police stations in Cuttack, Dhenkanal and other districts.

Rural women in Khurda take to kitchen gardening

Bhubaneswar, June 6: Converting the dreadful Covid-19 crisis into an opportunity, a handful of rural women from underprivileged communities in Khurda district are raising vegetable gardens at home, as a viable source of income during the lockdown that saw men, the primary breadwinners of their families, lose jobs.

The women are the direct beneficiaries of Family Strengthening, the community outreach programme of SOS Children's Villages of India (SOSCVI) an NGO. The programme aims at increasing the household income of vulnerable families, and thus, upholds and enhances the quality of parental care for their children. The programme covers over 250 families with more than 600 children in the villages of Mahimangar, Kujimahal, Dalua, Nadhara, Giringaput and

Haridamada of Khurda district. The families belong to tribal, scheduled castes and other backward classes with many of them

working as migrant labourers. With

agricultural inputs like seeds, tech-

nical guidance, and cash support from SOSCVI, the women have become successful in cultivating vegetables such as spinach, pumpkin and brinjal that fetch them up to Rs 100 per day, besides catering to the

nutritional needs of the family. Commenting about the enterprising rural women, "Many of these families suddenly became cash-strapped when men, the sole breadwinners, lost their jobs during successive lockdowns. About 100 to 150 men, who were working in Bhubaneswar and other cities nearby, are now homebound. Hence, we are helping these families explore alternative livelihoods including home gardening," said Sumanta Kar, Secretary General,

"We provide agricultural inputs and arrange guidance from agriculture experts. It has proven to be a game changer. Though these women did not have prior experience in gardening, they were determined to succeed when they saw that home gardening could be a sustainable source of decent income. The initiative has also led to provision of healthy and nutritious food for their children. When households have secure income, the quality of childcare is enhanced. We are planning to replicate thissuccess in more communities in other locations," she added.

State to cover 5.26 lakh ha under watershed project

Bhubaneswar, June 6: The state government has set a target to cover around 5.26 lakh hectare land spreading over 705 micro-watersheds under the proposed Rejuvenating Watershed for Agricultural Resilience through Innovative Development (Reward) project over a period of six years.

Chaired by Chief Secretary Suresh Chandra Mahapatra, a highlevel meeting held virtually from the Lok Seva Bhawan here Sunday outlined the modalities of the programme

Official sources said that a tar get was set to cover a total of around 5.26 lakh hectare of land spreading over 705 micro- watersheds under the proposed Reward project. "Around 1.15 lakh hectare of land under 152 micro-watershed units in five pilot districts—Koraput, Nayagarh, Dhenkanal, Deogarh and Sambalpur—would be taken up in the first phase. Besides, around 4.11 lakh hectare of land in seven districts covering about 533 micro-watershed units would be covered both for pilot intervention and intensive agriculture. These seven districts included Nabarangpur and Sundargarh in addition to above five districts, said a source.

The expected ecological outcomes of the project include prevention of soil run-off, regeneration of natural vegetation, rain water harvesting and recharging of the ground water table. This would enable multi-cropping and adoption of diverse agro-based activities for providing sustainable livelihoods to the people in the wa-

Mahapatra directed to focus enhancing productivity and opening up new sustainable livelihood opportunities for increasing the net income of the farmers. The Chief Secretary also directed treating the watershed and

adjacent areas on saturation mode through adoption of new technology and data-driven approaches. Agriculture & Farmers **Empowerment Secretary Suresh** Kumar Vashishth, who also took part in the meeting, said that the programme would positively promote resource efficient growth in

watershed areas, investment in

human capital and developing networks of scientific and technical Describing Odisha is a forerunner in watershed management, Pritee Kumar of the World Bank said that the proposed programme would be helpful in making the watersheds 'climate resilient

through land resource inventory,

land use planning, and precision farming in the context of the specific agro-ecological conditions'.

The project would directly address key strategic actions around increasing farmers' income, more crops per drop of water, water to every plot and soil health. It would also focus on promotion of entrepreneurship through technical and financial support.

Odisha is one of three states in the country to have planned for such an ambitious programme. The other two states are Karnataka and Andhra Pradesh.

According to sources, the approximate cost of the project was estimated around 211.57 million dollar out of which state and Centre would provide around 162.57 million dollar through convergence of different scheme and International Bank for Reconstruction and Development (IBRD) of the World Bank would provide 49 million dollar as loan.

27 RRTs for home isolation patients

Khurda, June 6: The district administration has arranged a total of 750 beds at 23 Temporary Medical Centres (TMCs) in rural areas of Khurda for the treatment of people infected with novel coronavirus.

As per a report, the administration has set up 23 TMCs for the Covid patients of 190 panchayats under 10 blocks in Khurda. This apart, at least 145 beds have been arranged in six TMCs to treat Covid patients of Khurda and Jatni municipalities and Balugaon and Banapur Notified Area Councils (NACs), said the report.

Moreover, a Dedicated Covid Hospital (DCH) and three Covid Care Centres (CCCs) have been

set up in Khurda district to treat critical Covid patients. The DCH and the CCCs have altogether 810 beds, including 460 beds fitted with

Neelachal DCH at Balakati has 160 beds, including 86 general beds 34 intensive care units (ICUs) and 40 high dependency units (HDUs), said the report released by the district administration.

The CCC at INS-Chilika has 100 general beds and 50 oxygen-supported beds. Khudupur CCC has 100 oxygen-fitted beds and 200 general beds. Similarly, the CCC at Manjari Devi Homeopathic Medical College and Hospital has 150 oxygen-supported beds and 50 general beds to treat the Covid patients, added the report.

tuted 27 rapid response teams (RRTs) to attend patients who are under home isolation. "The rapid response teams are working under the supervision of the doctors at the community health centres (CHCs). The teams are providing medicine kits to home isolation patients and taking care of the people residing in the micro containment zones," said an official of the district administration.

According to the official, control rooms have been set up at all CHCs of the district for better management of the Covid-19 situation. This apart, three district-level control rooms have been established in Khurda to supervise the treatment of Covid patients, he said.

Odisha sends 27,348 MT O₂ to 16 needy states

Cuttack, June 6: Odisha has sent at least 27,348.034 metric tonne (MT) medical oxygen through 1,482 tankers to 16 states facing shortage of the life-saving gas for treatment of Covid-19 patients during the second wave of the pandemic, an official said Sunday.

During the last 45 days, as many as 125 tankers have been sent to different states from Angul with 2036.562 MT of oxygen, 336 tankers were sent from Dhenkanal with 5574.19 MT of the gas, 295 containers left Jajpur with 6026.765 MT of oxygen and 726 tankers left Rourkela with 13710.517 MT of medical grade oxygen, according to the Odisha Police that has been entrusted with the mammoth task of ensuring hassle-free transportation of oxygen.

While Andhra Pradesh has received 439 tankers containing 8598.722 MT of oxygen, 375 tankers have reached Telangana with 6626.379 MT of oxygen. Tamil Nadu has received 203 tankers containing 3665.258 MT of medical oxygen and Haryana has received 3331.793 MT of oxygen through 182 tankers, sources at the state police headquarters said.

"At least 41 tankers with 660.051 MT of oxygen reached Maharashtra, while 667.231 MT of the life-saving gas filled in 41 tankers have so far been sent to Chhattisgarh. As many as 67 tankers have carried around 1297.662 MT of oxygen to Uttar Pradesh. 67 tankers with 1182.6 MT of oxygen have been sent to Madhya Pradesh," the sources said.

While 22 tankers with 410.24 MT of oxygen have so far been sent to Delhi, four tankers with 107.89 MT of the gas have reached Punjab. On the other hand, Karnataka, Bihar and Chandigarh have so far received 235.19 MT, 66.14 MT and 25.29 MT of oxygen respectively. While 21 tankers carried 405.068 MT of oxygen to Kerala, one tanker with 29.1 MT of the life-saving gas has reached West Bengal till date. Moreover, Rajasthan has received two tankers containing 39.42 MT of oxygen in the last 45 days.

The special cell, led by ADG (Law and Order) YK Jethwa, has been supervising the transportation of oxygen, added the sources.

Registration of workers disappointing in Nayagarh

Nayagarh, June 6: Registration of workers in the unorganised sectors in this district is quite disappointing, a report said. This has happened due to lack of aware ness, sources said. Many of them do not even know that by registering themselves they can become beneficiaries of a government scheme. As a result, Navagarh district lies at the bottom of the list of the registration of workers in the unorganised sector while Boudh district takes top position. It is pertinent to mention here that only a handful of 376 workers have registered for this government scheme in Nayagrah district while 26,236 have signed up in Boudh district.

This raises questions regarding the efficiency of the labour department in the district. The matter came to the fore from a reply obtained from the office of the state Labour Commissioner in an application filed under Right to Information Act (RTI) by a resident of Nayagarh district, Devi Prasad Mohapatra.

According to the reply, over 1,74,564 unorganised workers have been registered themselves from April, 24, 2017 to March 15, 2021 under the Odisha Unorganised Workers Social Security Board in



are from Angul district, 7,468 from Balasore district, 9,618 in Bhadrak district, 2,393 in Bargarh district and 11,153 in Bolangir district.

People suffer as saline water wreaks havoc

Jajpur/Bari, June 6: Groundwater in the delta region of Bari block in Jaipur district turning saline has sent alarm bells ringing among the residents and farmers in the area, a report said

Brahmani, Birupa and Genguti rivers forms the delta region in Bari block. Digging of soil leads to oozing out of saline water. It is unfit for drinking, cooking and

As a result, over 40,000 residents in Ratnagiri, Mandari, Amathpur and Serpur panchavats under this block are being deprived of clean drinking water. Hundreds of hectares of farmlands have also been rendered uncultivable with farmers abandoning agriculture due to this reason.

Saline water oozed out of the ground when a survey was undertaken for installation of a 200feet long lift irrigation point at Benjerapur in Mandari panchayat of the block. Residents said that clean drinking water will be available only if over 750 feet deep ex-



cavation is carried out.

The residents have drawn the attention of Chief Minister Naveen Patnaik, irrigation minister, principal secretary, Irrigation and the Rural Water Supply and Sanitation (RWSS) departments towards their plight but to no avail. MLA Adhiraj Panigrahi also raised a question in this regard in the last session of the State Assembly. However, no solution has emerged till date for the problem due to which residents have been forced to use fluoride mixed water.

Reports said that over 10 bore wells each of 200-feet in length

have been dug up in Anikana and Mandari revenue villages under Bari block. However, the water pumped out by the bore wells is not conducive for agriculture for which farmers are not interested

in taking up cultivation of crops. Farmers, Raghunath Jena, Bishnu Charan Jena, Shyam Sundar Jena said that cultivation could be taken up in hundred of hectares of farmlands if the Irrigation department helps them in getting clean drinking water. The availability of clean water could benefit the farmers as this is a locality which is famous for veg-

ing water problem is quite acute in the area. There are two piped drinking water supply projects in Patna and Ratnagiri areas under the block. However, the projects are pumping out only saline water.

Residents are suffering a lot a the authorities have not installed any filter in the pipes supplying water. The non-availability of drinking water is a very serious problem for the residents of this panchayat. However, the district administration is vet to take any constructive step to resolve the problem.

Efforts to contact Motilal Tiwari, executive engineer of RWSS department for his response went unanswered. His phone was switched off.

Debasmita Behuria a local resident of the area attributed the problem to the location of the Bari block. She said the locality is 20-25 km from the coastline, so saline water tends to slip into the soil quite easily. She said that government has not taken any steps to ease the plight of the people in

Vaccine Famine

hen the head of India's coronavirus taskforce, Dr VK Paul, said June 5 that the country has overtaken the United States in terms of the number of people who have received their first shot of a Covid-19 vaccine, he was rather too economical on truth. His claim, made at a time when the country is virtually facing a vaccine famine, sounds like a crude joke bordering on cynical unconcern for millions helplessly running from pillar to post for one jab. People in the age group from 18 to 44 years are being given a raw deal with the Centre refusing to provide vaccines free as it did in the case of people above 45 years. Private hospital chains are on an average charging between ₹900 and ₹1,500 per shot. It is so easy to reel off statistics the way Dr Paul did that the number of people getting at least one dose of vaccine in India is 17.2 crore. (According to latest government figures, the number of vaccinated has increased to 22.9 crore).

Numbers can be interpreted to suit different interests of different people and agencies. It is one thing to score political brownie points with statistics and another to reassure people groaning under the pandemic with concrete actions. Certainly, it is not the time for any government official to try and fool people with jugglery of figures as has been done by Dr Paul. A report released by the International Monetary Fund states the US and the UK have already inoculated 35-40 per cent of their population, while more that 50 per cent have received at least one jab. India's vaccination record so far is about 3 per cent. Comparing the number of people in India with that of the US or the UK to claim achievement in vaccination is illogical as the population sizes greatly differ.

The other things that Dr Paul said were pious platitude and inane lecture. He reminded the people "not to act carelessly as Covid-19 cases dip." What the country desperately needs now is ramping up of vaccine production with speed which, no doubt, is easier said than done. It is also not difficult to understand why the government has gone on an overdrive in releasing statistics to create the impression that it is doing reasonably well in fighting the pandemic. The Supreme Court last week put the government on the mat by asking tough questions on its vaccination policy with the Amicus Curiae Jaideep Gupta graphically presenting production figures to demonstrate that the government's claim to vaccinate the entire population by the end of December or January, 2022 has no substance. The apex court has given the government two weeks time to submit a report on the money being spent and the quantum of vaccines the Centre has procured and distributed. The government. it seems, is trying to build its case by dishing out figures to buttress its claim

Simple arithmetic will show the dire situation the country is in. The country needs 190 crore vaccine doses for herd immunity is what we are told. If 70 per cent of the population is to be vaccinated, ₹10,400 crore will be required at the rate of ₹400 per dose. Against this the Centre has allocated ₹35,000 crore for buying vaccines. There are currently two locallymade vaccines for the coronavirus: Oxford Astra-Zeneca developed Covishield made by the Serum Institute of India (SII) and ICMR developed Covaxin by Bharat Biotech. Covishield constitutes 90 per cent of the locally available vaccines

The government said in May that earlier this year it had ordered a total of 356 million doses of the two vaccines to be available for use up until July but not all of these doses have been delivered. The Sputnik V vaccine, which was approved for use in April, is also now available exclusively at Apollo Hospital chain, with three million doses supplied by Russia. SII's projections include 750 million doses of Covishield. Bharat Biotech plans to produce 550 million doses of Covaxin. The SII recently told the government they would produce 100 million doses per month from June onwards and Bharat Biotech's capacity would be boosted to 80 million doses per month from August.

After much dillydallying, the government has begun negotiations with US producers - Pfizer, Moderna and Johnson & Johnson-for additional supplies. But these makers have said they can discuss availability only by October this year. That too if India enacts an indemnity clause

In such a bleak situation the nation also hears reports of malfunctioning ventilators provided by the Centre to the states under the different schemes, including PM CARES. The courts have taken note of a large number of complaints of ventilators not working when patients were gasping for lack of oxygen. The Central exercise seems directed at passing the blame to the states which in some cases have allegedly left the devices unused in warehouses.

The Centre needs to stop taking refuge in excuses and hiding its colossal failure in fighting the pandemic. A lot of time has already been lost and lakhs of families ruined. The spectre of the third wave is looming large when babies in the cradle, toddlers and urchins would also come in the death grip of the lethal virus. The government must act fast, no blame-game would save the nation.



The result was nidering, which later writers made to conform with the usual rules of English spelling by adding a second d. Its original, nithing, derives from an ancient Scandinavian legal term, the Oxford English Dictionary explains, that meant a person "who has committed a crime so heinous that no possible compensation may be made for it." It was taken over into the legal system of England before the Norman Conquest in the sense of a coward or outlaw. Later, it came to mean a miser or a treacherous person. Conversely an unnithing was an honest or generous man. Niddering owes much of what little circulation it has had in the past two centuries to the once-popular Sir Walter Scott, who used it in Ivanhoe in 1819.

ON THE ORIGIN OF VIRUS

SCIENCE IS A NEVER-ENDING PROCESS AS NEW DISCOVERIES ALWAYS LEAD TO NEW QUESTIONS

t is already one and a half years since the first COVID-19 case was reported in Wuhan, China. Wuhan is home to the Wuhan Institute of Virology (WIV) and the Wuhan Center for Disease Control. Both institutes are leaders in bat-coronaviruses research and have huge collections of these viruses. The virus that caused the pandemic is called SARS-CoV-2. From the beginning SARS-Cov-2 has spread like wildfire claiming the lives of around 3.7 million people worldwide. Also, it has infected over 171 million people globally and is still counting. Furthermore, post-COVID-19 complications (like mucormycosis) are creating havoc The unprecedented multiple waves of the pandemic led to loss of human life, loss of jobs and completely overwhelmed the existing healthcare system.

In the midst of ongoing chaos, the scientific community is yet to pinpoint on the true origin of the virus. There has been debate around the world about the source of the virus. Several theories are floating around for instance: i) a form of animal-tohuman transmission via a host (Zoonoses) and ii) it is leaked from a laboratory (lab leak). Various excellent articles on these topics were written by Nicholas Wade, David A. Relman, Katherine Eban, Rowan Jacobsen and many others.

On 20 October 2020, two Indian researchers (MC Rahalkar and RA Bahulikar) from the Agharkar Research Institute. Pune and the BAIF Development Research Foundation, Pune published a paper in the Frontiers in Public Health proposing lethal pneumonia cases in Mojiang Miners (2012) and the mineshaft could provide important clues to the origin of SARS-CoV-2. This publication cited a master's thesis by Li Xu entitled: "The Analysis of Six Patients with Severe Pneumonia Caused by Unknown Viruses" (May 2013, Kun Ming Medical University). An Indian twitter user (@TheSeeker268) first found the thesis and then sent it to the researchers based in Pune. An English version of the thesis is available online: https://www.documentcloud.org/do

cuments/6981198-Analysis-of-Six-Patients-With-Unknown-Viruses.html. Several internet users (including TheSeeker, Rahalkar and Bahulikar) from across the world formed a group called DRASTIC (Decentralized Radical Autonomous Search Team Investigating COVID-19) and unearthed data from various available publications and websites. The documents found by DRASTIC brought out new facts about the origin of SARS-CoV-2 (drasticresearch.org).

The Wall Street Journal (WSJ) reported on 23 May 2021 (by citing undisclosed US documents) that three researchers from the WIV became sick in November 2019 and they were hospitalized. Another investigation report by the WSJ on 24 May 2021 stated that its reporter was detained by the police in Mojiang, China for several hours; later, photographs of an abandoned copper mine located in Mojiang were deleted from the journalist's electronic device. The WSJ report further added that in April 2012, six miners fell ill after cleaning bat excreta in the mine and three of them died. On 28 May 2021, the EL ESPANOL described that the hospital where the miners were treated decided to send samples to the WIV. Subsequently, a team from the WIV led by Shi Zheng-Li (a prominent Chinese virologist working on bat coronavirus, known as the 'Bat woman') conducted research on it. The re-

sults of the study (describing new coronavirus) was published in which six cases of the disease as well as death of three miners were not mentioned. A year before the publication of the said article, Shi Zheng-Li and her team from the WIV approached the abandoned copper mine to collect more bat samples. Thus far, no information is available about these samples. The chain of emerging events indicates that the master's thesis by Li Xu (found by the DRASTIC team) is corroborating facts mentioned in several news reports.

Recently, a team appointed by the WHO and its Chinese counterpart conducted a joint investigation to look into the source of SARS-CoV-2. Liang Wannian, the Chinese head of the team, reportedly said that Chinese authorities tested 50,000 animal specimens, including 1,100 bats. But they did not find a matching virus. The report remains inconclusive.

Science is a never-ending process as new discoveries always lead to new questions. Science is about never-ending questioning and demanding for adequate experimental evidence about any the ory. Are the samples collected from six Mojiang miners available? Are the samples collected from bats in the abandoned copper mine available? Will it be possible to collect samples from the miners who survived the illness? Can an independent group of scientists examine these samples? Will China

allow access to the abandoned cop per mine in Mojiang? Why are investigative journalists denied access to the abandoned mine? Will the joint report submitted by Chinese-WHO team undergo a peer review process? Will we ever know the true origin of COVID-19?

A group of 18 eminent scientists recently published a letter in the Science journal. They have sought a thorough investigation into the origins of COVID-19.

The current scenario looks even more complicated since Shi Zheng-Li had conducted research projects in collaboration with US-based virologists. For instance, Peter Daszak, EcoHealth Alliance, US had been collaborating with Shi Zheng-Li for several years. Also, Daszak's organization funded coronavirus research at the WIV and channelized government funds for it. Notably, researchers from the WIV are performing gain-of-function research (experiments designed to alter a pathogen to make it more infectious). Fredrik Elgh Professor of Virology at Umeå University, Sweden, who examined the 2003 SARS virus leak, says it is possible that the ongoing pandemic began with a laboratory leak.

An open scientific investigation into the true origin of COVID-19 will help policymakers formulate strategies to educate citizens and mitigate the risk of future outbreaks. For example, the Odisha government has passed a resolution to make disaster and pandemic preparedness a part of the curriculum of schools and colleges. In addition, knowing the origin of the pandemic will help to understand and prevent accidents/leaks in biological laboratories since proliferation of bio-labs worldwide has increased the risks of a pandemic. Politics should not take precedence over data, facts, and science. At present, the focus should be on information gathering, and to conduct an open investigation by giving equal weightage to both zoonotic spillover and lab-leak. The conclusion can be drawn once adequate information is available.

Making of the Oxford English Dictionary



THE PRODIGIOUS EFFORTS OF DICTIONARY MAKERS IN SEVENTEENTH AND EIGHTEENTH CENTURIES WERE MERELY STEPPING STONES TO THE STELLAR EFFORTS MADE FOR THE OED

It was in the eighteenth century that the British felt the want of a good dictionary to know their language n more detail. Dictionaries were here with lexicographers making remendous efforts at corralling the entire language. One of the greatest literary figures of all time, Samuel Labrson created "A Dictionary of in more detail. Dictionaries were there with lexicographers making tremendous efforts at corralling the entire language. One of the greatest literary figures of all time, Samuel Johnson created "A Dictionary of the English Language" which has remained ever since, a portrait of the language of the day in all its majesty, beauty, and marvellous confusion. With such illustrious predecessors, the monumental OED took birth in 1857, which took 70 years to complete, Simon Winchester, a geologist and globetrotting correspondent and writer tells us in his fascinating novel the genesis and journey of the great dictionary that symbolises everything English. "The Professor and the Madman: A Tale of Murder. Insanity and the Making of the Oxford English Dictionary" is the story of the strange collaboration of two men to produce the definitive of all guides to the language that for good or ill has become the lingua franca of the civilized modern world.

The two protagonists of the tale are, apart from the dictionary itself, the great philologist editor of OED, Dr James Murray and an American army surgeon, William Chester Minor, a murderer incarcerated at



an asylum for the criminally insane, who made the dictionary possible with their magnificent obsession for words. Murray is a towering figure in British scholarship who had an impassioned thirst for knowledge and believed in 'vita diligentissima' - nothing is better than a most diligent life. Murray after an interview with a formidable committee was appointed editor of OED. While Murray was of humble origin. Minor graduated from Yale Medical School and applied to the army during the civil war. Born in the serendipitous island of Ceylon, to missionary parents, experiencing the beauty of the island, he had access to a good life.

The exposure to the war and its horrors resulted in a mental condition that made him unfit for the easel, water colours, his paranoia and delusions. In London he took up quarters in Lambeth, a disreputable suburb and ended up killing, pursued by a psychotic fantasy, a man he had never known or met, George Merret. Dr Minor on trial was found not guilty on grounds of insanity but would be detained in permanent custody as a criminal lunatic.

To go back to the dictionary, the prodigious efforts of dictionary makers in seventeenth and eighteenth centuries were merely stepping stones to the stellar efforts made for OED. The new project wanted every word of the English language with its evolution, meanings, shades, and nuances spelling and pronunciation, every illustrative citation from every English author. Since this titanic task was not possible without 'crowd sourcing', an appeal from Murray went out to volunteers to find words, supply quotations and definitions. This appeal was enclosed with books and journals, to shops and libraries. Meanwhile, stricken with remorse, Minor reached out to Eliza Merret, the widow of George Merret, with financial offers. She accepted the gesture, came to see him, collecting books on his behalf from London.

army. He left for London in a dis- It is in one of these books he found imprisonment Minor's self-worth began to re-emerge. He responded and Minor's contributions were remarkable with 12,000 quotes furnished with astonishing accuracy and detail. Unaware of Minor's condition, Murray undertakes a journey to meet him. Amazed at finding the truth about Minor a firm friend ship began with mutual respect and love of words lasting twenty years.

However with time, Minor's health deteriorated, he was allowed to leave for an asylum in Washington and subsequently shifted to a hospital for the elderly insane in Hartford Conn and died at the age of 85 in 1920 in obscurity. It is sad and ironical that his very insanity and incarceration has granted us the dictionary. Murray with OED still incomplete died at 76 in 1915. Both men earned their redemption through the dictionary. But most unsung of all the players in the drama is George Merret to whom Winchester magnanimously dedicated his novel.

The OED was completed on New Year's Eve 1927 and was announced on the front page of the New York Times. The work was done and the alphabet exhausted. The newspaper called it "one of the great romances of English Literature.'

Jammu. June 6: About 8.000 underground bunkers have been completed for the safety of the people living along the Line of Control (LoC) and International Border (IB) in Jammu province, officials said Sunday.

The Centre has sanctioned the

construction of 14,460 individual and community bunkers for the border residents in the five districts of Jammu, Kathua and Samba covering the villages located along the IB and Poonch and Rajouri villages on the LoC. Later, the government sanctioned over 4,000 additional bunkers to cover a more vulnerable population. "A total of 7,923 bunkers, including 6,964 individual and 959 community bunkers, have been completed so far in (Jammu) division," an official spokesman said, as Divisional Commissioner Jammu Raghav Langer reviewed the progress on the construction of the safety structures at a meeting here. There has been no major ceasefire violation over the past three months in Jammu and Kashmir after India and Pakistan



signed a fresh agreement to maintain calm along the borders on February 25 this year.

The spokesman said the work is also in progress on 9,905 bunkers which are under different stages of construction. The deputy commissioners informed that 1,592 bunkers have been completed in Samba, 1,228 in Jammu, 1,521 in Kathua, 2,656 in Rajouri and 926 in Poonch.

Langer took strong note of delay in tendering of pending bunkers and directed the executive engineers concerned to float the tenders afresh for the construction of the bunkers which have not been taken up as yet for their early completion, the spokesman said. The divisional commissioner also directed the deputy commissioners to personally monitor already executed work.

Nothing can be achieved by killing political activists: Mehbooba Mufti

Srinagar, June 6: PDP president Mehbooba Mufti Sunday asserted that nothing can be achieved by killing political activists like BJP councillor Rakesh Pandita and said such incidents only defame the people of Jammu and Kashmir.

Pandita was shot dead by militants in the Tral area of Pulwama district Wednesday.

"It was unfortunate. We condemn those who killed him and nothing can be achieved by such things. In fact, it defames the people of Jammu and Kashmir," Mufti told reporters in south Kashmir's Anantnag district. She said the entire Union Territory

has to bear the brunt of such incidents. Asked about the possibility of the government conducting the Amarnath Yatra amidst the Covid pandemic, the former Jammu and Kashmir chief minister said the decision on allowing the annual pilgrimage in the south Kashmir Himalayas was for the Centre to take. She also criticised the police over reports of the booking of a 15year-old boy under the Unlawful Activities (Prevention) Act (UAPA) in north Kashmir's Bandipora.

'They (Centre) do not listen to the people of Jammu and Kashmir. Had they listened, they would not have booked a 15-year-old under UAPA. They do whatever they want.

Taj Mahal, a victim of nature and man

Agra, June 6: Green crusaders have raised questions on the safety of the iconic Taj Mahal from pollution in Agra.

INDO-ASIAN NEWS SERVICE

Since 1993, after the Supreme Court intervened and passed a series of orders to secure the sensitive Taj Trapezium Zone, from the ravages of pollution, the Union and the state governments have spent thousands of crores on a slew of projects designed to bring down the air pollution level.

However, according to environmentalists the positive results of these measures have vet to show. The crude reality is that neither the air pollution level has come down. now has the general quality of life improved in the 10,000 sq km ecosensitive zone around the Taj Mahal.

The suspended particulate matter (SPM) in the ambient air continues to remain alarmingly high round the year, and the dry-polluted river Yamuna poses a serious threat to the Taj Mahal and other Mughal monuments along its banks.

"India's tourism icon and a symbol of earthly love, the 17th century white marble mausoleum, the Taj Mahal, is a victim of both nature and man. If the monument looks sick and pale to visitors, the reason is the dry and heavily polluted Yamuna that once formed an integral part of the Taj Mahal complex," says eminent environmentalist Devashish Bhattacharya of the River Connect Campaign.



During the scorching summer months the Taj is enveloped in yellowish sand from the neighbouring Raiasthan desert. Any discernible visitor can tell that the summer heat is taking its toll on the Taj Mahal, the timeless monument of love, blasted by sand from the dry Yamuna bed and the dust-laden winds from the Rajasthan desert. Bhattacharya added.

Many scientific studies in the past have identified the gaps left by illegal mining in the Aravali ranges that have raised the SPM in Agra.

A leopard attack that cut short 5-yr-old girl's life

Against a standard of 100 microns per cubic metre, it remains as high as 300, touching 500 during summer months. The problem is that sandy particles rub against the monument and leave pock marks that make the surface rough.

The biggest challenge to the environment in the TTZ has been the continuously increasing number of automobiles. The number of vehicles in the past three decades has shot up from thousands to lakhs. Fortunately, a large number of vehicles in the city are now running on CNG, as are the industries that are being allowed to run after the 1996 Supreme Court directive to shut down all coal based industries in the TTZ.

From a few hundred daily some decades ago, the Taj today is daily visited by thousands. This number does not include children below 15 years_ for whom entry is free. For five days in a year the entry to the monument is free for everyone. This opportunity is availed by lakhs of people.

Curbs eased in UP as virus caseload declines



Lucknow, June 6: The Uttar Pradesh government has allowed shops and markets outside containment zones in Varanasi Muzaffarnagar, Gautam Buddh Nagar and Ghaziabad to open for five days a week from Monday after active COVID-19 cases in these four districts fell below 600.

With this, the number of districts where active COVID-19 cases have fallen below 600 has reached 71, the state government said in a statement Saturday

It said the relaxations will come into effect from June 7 and will be effective from Mondays to Fridays from 7 am to 7 pm. However, night and weekend curfews will continue

"A watch is kept on Lucknow, Gorakhpur, Meerut and Saharanpur locality just outside the city limits in the central district of Budgam,

be taken Tuesday," according to the statement. In view of the number of COVID-19 patients recovering in the state, four to five districts are likely to witness active cases fall below 600 by Monday.

May 30, the Uttar Pradesh government had relaxed the COVID-19 lockdown in 55 of 75 districts in the state.

Prior to Varanasi, Gautam Buddh Nagar, Muzaffarnagar and Ghaziabad, coronavirus curfew was relaxed in Bareilly and Bulandshahr on Saturday and in Jhansi June 3.

June 1, the curfew relaxations were extended to Lakhimpur Khiri, Ghazipur and Jaunpur while the curbs were relaxed in Sonbhadra, Deoria, Baghpat, Prayagraj, Bijnor and Moradabad May 31.

They bid a tearful adieu to her as she was laid to rest Saturday and people reminisced about her smile and banter. Her relatives, who could not visit due to COVID-19 restrictions, took to Twitter to mourn her death.

"Adda rani, she would call herself. Can't forget the sound of her laughter and her running around. What a tragedy!" tweeted Sana Fazili, who stayed in the same locality.

She also posted a video, where Adda was copying a viral trend of social media. "Yeh mein hoon....Yeh meri party ho rahi hai (This is me...And I am having a party)."

Twitter and other social media platforms were full of users sympathizing with Adda and someone posted, "Heaven must be a beautiful place now as it has you Adda...

Parents of the little girl are still in shock. This is the second tragedy in their family as Adda's grandmother had passed away earlier

this year. The death of Adda, who was a student of DPS School, Srinagar, led to some suspensions in the Forest Department and pushed the Jammu and Kashmir administration to address the concerns of Ompura locality about wild animals. "She was an extraordinary girl, always bubbly and with a smile. But what happened to her should not happen to anyone," an inconsolable Ahmed said.

Her father, Muddasir had returned from Thailand last year following the outbreak of Covid.

Her school also expressed condolences and circulated a message saying, "We are heartbroken by the suffering and loss of the little one and we stand with the family in grief and solidarity. We pray for the eternal peace of the departed soul and healing for those who she left behind shattered and inconsolable.'

The sighting of wild animals was caught on camera but nobody had done anything, said Ahmed and other neighbours held the Forest Department responsible for the tragedy.

The Ompura area has a 20 acre nursery adjacent to it which is maintained by the Social Forestry Department.

"The purpose of the nursery was to grow saplings which could be later planted in the forest area. But they have not maintained the nursery and it has virtually turned into a forest.

"After her death, they started pruning trees and clearing the bushes which they should have done over the years. We feel the death of the child is the outcome of the Forest Department's actions. This nursery is surrounded by human habitation and there are wild animals roaming freely in the

nursery," Ahmed said. Regional Wildlife Warden, Kashmir, Rashid Naqash, expressed shock over the tragedy but said his department could not be blamed for it.

"We have repeatedly raised the issue of the nursery and the pres-

ence of wild animals with the Forest Department over the last four years after the first sighting of a leopard there," Naqash told PTI. He said the department did its duty with professionalism after it came to know about

the leopard sighting. "We launched a vigorous houseto-house campaign to educate people about the threat and preventive measures needed to be taken for their safety. We asked them not to allow children outside their homes, especially at dawn and after dusk,' the official said. He said they also pasted do's and don'ts at vantage points and used mosques to reach out the residents, besides making efforts to catch leopards. "We succeeded in capturing a leopard in the vicinity over two weeks ago."

Asserting that the department has been making all out efforts to ensure that there is no man-animal conflict, he said, "Our efforts can be gauged by the fact that the trend (man-animal conflict) is on steady decline over the past several years despite facing shortage of manpower."

Urging the people to follow the guidelines religiously, he said the victim's house is located near the nursery and there is no proper fencing separating the two.

"The household has rabbits 🗦 and poultry, and the girl was attacked when she was moving alone at dusk," he said. "I cannot bear the burden of being dubbed the girl's murderer...", an emotional Nagash said.

The place was filled with people looking to get vaccinated since 8 a.m. when the drive began and it was slated to continue till 9 p.m. With over 500 counters for no waiting, different time slots were allocated all through the day.

NCB seizes 40 kg ganja

Mumbai: The Narcotics Control Bureau (NCB) Mumbai has seized 40 kg ganja and Rs 100,000 cash from drug peddlers in Thane, a top official said Sunday. Continuing a follow-up operation in an ongoing probe, the NCB sleuths intercepted wanted peddler from Badlapur (Thane) Sunil Bhandari and accomplice Aman Gagade, along with the car in which they were travelling, near Patas toll plaza on the Pune-Solapur Highway.

Gujarat to set up over 75 O₂ plants

Ahmedabad: The Gujarat government has initiated the process to set up more than 75 oxygen plants to produce additional 300 MT of the lifesaving gas if the demand for it goes up during the possible third wave of Covid-19, Deputy Chief Minister Nitin Patel said.

Srinagar: At least seven people were injured in a blast in Pulwama district of Jammu and Kashmir Sunday, a police official said. He said police are trying to ascertain the cause of the blast that occurred at a bus stand in Tral. The injured were taken to the hospital where their condition is stated to be stable, the police official said.

nCoV count in India **lowest in 60 days**

New Delhi, June 6: India reported 1,14,460 new coronavirus infections, the lowest in 60 days, while the daily positivity rate further dropped to 5.62 per cent, according to the Union Health Ministry data updated Sunday

With the fresh cases, the total tally of coronavirus cases in the country climbed to 2,88,09,339. The Covid-19 death toll climbed to 3.46,759 with 2.677 daily deaths, the lowest in 42 days, while the active cases dropped below 15 lakh, the data updated at 8 am showed.

A total of 96,982 new cases were recorded in a span of 24 hours April 6. Also, 20,36,311 tests were conducted Saturday taking the total cumulative tests conducted so far for detection of Covid-19 in the country to 36,47,46,522. The daily positivity has further declined to 5.62 per cent . It has been less than 10 per cent for 13 consecutive days, the ministry said.

The weekly positivity rate has declined to 6.54 per cent. The active cases have reduced to 14,77,799 comprising 5.13 per cent of the total infections, while the national Covid-19 recovery rate has improved to 93.67 per cent. A net decline of 77,449 cases has been recorded in the Covid-19 caseload in a span of 24 hours.

Recoveries continue to outnumber daily new cases for the 24th consecutive day. The number of people who have recuperated from the disease surged to 2,69,84,781, while the case fatality rate stands at 1.20 per cent, the



data stated. A total of 23,13,22,417 vaccine doses have been administered so far. India's Covid-19 tally had crossed the 20-lakh mark August 7, 30 lakh August 23, 40 lakh September 5 and 50 lakh September 16. It went past 60 lakh September 28, 70 lakh October 11, crossed 80 lakh October 29, 90 lakh November 20 and surpassed the one-crore mark December 19. India crossed the grim milestone of 2 crore May 4.

The 2,677 new fatalities include 741 from Maharashtra, 443 from Tamil Nadu, 365 from Karnataka, 209 from Kerala. 120 from Uttar Pradesh and 118 from West Bengal

A total of 3,46,759 deaths have been reported so far in the country including 99,512 from Maharashtra, 31,260 from Karnataka, 26,571 from Tamil Nadu 24 557 from Delhi 21,151 from Uttar Pradesh, 16,152 from West Bengal, 15,009 from Punjab and 13,192 from Chhattisgarh. CYCLONE YAAS

Central team to visit WB to assess damage

New Delhi, June 6: A central team headed by a joint secretary of the Ministry of Home Affairs (MHA) will visit West Bengal to assess the damage caused by Cyclone Yaas, days after Chief Minister Mamata Banerjee abstained from a cyclone review meeting convened by Prime Minister Narendra Modi triggering a controversy.

The very severe cyclone Yaas made landfall in Odisha May 26 and affected a large part of the state as well as West Bengal. A central team led by a joint secretary of the MHA will visit West Bengal for three days to assess the damage caused by the cyclone, a Home Ministry official said.

The West Bengal chief minister had said, as per preliminary assessment, the cyclone had led to damage of an estimated ₹20,000 crore to property and agriculture. She had also said that 18 lakh people were affected by the cyclone and around 2.21 lakh hectares of crops and 71,560 hectares of horticulture area suffered damage.

Prime Minister Narendra Modi conducted an aerial survey of the cyclone-affected area of West Bengal May 28 and later called a review meeting at the Kalaikunda air force

station. However, the chief minister and the then chief secretary, Alapan Bandyopadhyay, a senior IAS officer, did not attend it, even though they met the prime minister for a few minutes.

Following this, the Department of Personnel and Training (DoPT), the cadre controlling ministry for the IAS officers, summoned Bandyopadhyay for serving in the central government. However, he did not come to the capital and chose to retire May 31, instead of accepting a three-month extension sanctioned to him by the state and central government. Subsequently, he was appointed as the chief advisor to the state government by Banerjee. On May 31 itself, the MHA slapped

a show-cause notice on Bandyopadhyay under a stringent provision of the Disaster Management Act that entails imprisonment for up to two years for abstaining from the meeting presided by the prime minister at Kalaikunda. Chief Minister Banerjee had alleged that the officer was targeted by the central government due to a "political vendetta". The ruling Trinamool Congress claimed that the Centre was wreaking vengeance on the West Bengal government and that the notice sent to Bandyopadhyay was an "illegal" move.

17 MENTALLY **ILL INDIANS** IN PAK JAILS

New Delhi, June 6: Six years after Pakistan conveyed to India about 17 "mentally unsound" Indians languishing in jails in that country, efforts to confirm their identity have not yielded any result despite the Ministry of Home Affairs putting up their photos on its official website and seeking assistance from the general public as well as states and UTs.

They have completed their sentences but due to non-confirmation of their nationality they could not be repatriated to India, an official said.



Among the 17 prisoners in Pakistan who are believed to be Indians, four are women and were named Gullu Jan, Ajmeera, Naqaya and Hasina by Pakistani authorities. The others are Sonu Singh. Surinder Mahto, Prahalad Singh, Silrof Salim, Birju, Raju, Bipla, Rupi Pal, Panwasi Lal, Raju Mahouli, Shyam Sunder, Ramesh and Raju Rai.

The MHA has said anyone who can identify these 17 persons should give information to the Under Secretary (Foreigners) in the Ministry of Home Affairs, the home department of state governments or union territory (UT) administration concerned or respective Director General of Police or Inspector General of Police or Commissioner of Police.

"Photographs of 17 mentally unsound persons, believed to be Indian nationals, who are lodged in jails in Pakistan, are attached. These persons have not been able to disclose any other particulars about them including the names of their parents or relatives, address in India, etc. Due to their mentally unsound condition," the MHA notification said.

In 2015, Pakistan had conveyed to India about these 17 Indians lodged in their jails and said they have completed their jail terms in that country but they cannot be sent back home as they are unable to recall their whereabouts since they are "mentally unsound".

Kochi, June 6: Amid protests by islanders against its "reform" measures, the Lakshadweep island administration has taken a set of decisions, including deputing government officials onboard local fishing boats for intelligence gathering.


The administration also issued a new order on managing cleanliness and hygiene, June 4, directing the people of the islands to scientifically dispose of the tender coconut shell, tree leaves, coconut husk, coconut shell, trunk etc in and around dwelling and public places.

Lakshadweep MP Mohammed Faizal attacked the administration for its new directives, terming them as a "mockery" and urged the authorities to withdraw them immediately. It was May 28, a meeting chaired by Principal Secretary cum Advisor to the Administrator decided to depute responsible gov-

ernment servants onboard local fishing boats for intelligence gathering. The meeting also decided to strengthen the security measures to monitor the local fishing boats and crews, intensify checking of passenger boats and vessels reaching the islands and strengthen the ship berthing points and helibase by installing CCTV cameras. The administration later gave direction to officials concerned to initiate action as per decisions taken on the meeting.

He questioned the practicality of implementing the order, saying there are hundreds of fishing boats operating from the islands and how many officials are going to be deployed in such vessels. Noting that a well established system of surveillance by the Navy and the Coast Guard was already in place in all the islands, the MP said the Coast Guard headquarter in islands have an effective radar system which can cover activities of any vessels operating in 30 nautical mile areas. Faizal said every month or once in three months Coast Guard is having regular interaction with the local fishermen to train them on how to report the movement of suspected objects in the seas.

9.27L severely malnourished kids identified till Nov 2020

New Delhi, June 6; More than 9.2 7 lakh children in India are 'severely acute malnourished', with the most in Uttar Pradesh followed by Bihar, according to government data, underscoring concerns that the Covid pandemic could exacerbate the health and nutrition crisis among the poorest of the poor. An estimated 9,27,606 'severely acute malnourished' children from six months to six years were identified across the country till November last year, the Women and Child Development Ministry said in response to an RTI query from PTI.

Of these, Uttar Pradesh counted for 3,98,359 and Bihar 2,79,427, according to the figures shared by the ministry.

Ladakh, Lakshadweep, Nagaland, Manipur and Madhya Pradesh reported no severely mal-

nourished children. Except for Ladakh, none of the anganwadi centres in the other four, including Madhya Pradesh, one of India's largest states, reported any data on the matter, according to the RTI reply

The World Health Organisation (WHO) defines 'severe acute malnutrition' (SAM) by very low weight-for-height or a mid-upper arm circumference less than 115

tional oedema. Children suffering from SAM have very low weight for their height, and are nine times more likely to die in case of diseases due to their weakened immune system.

The Women and Child Development Ministry had last year asked all states and union territories to identify SAM children for their early referral to hospitals. The figure of 9,27,606 came following that exercise.

27L caught without ticket on trains in 2020-21: RTI

The 2020-2021 financial year was the period when the Railways ran the least number of passenger trains in its history due to the coronavirus pandemic and there were severe restrictions on the movement of people inside railway premises, including non-issuance of platform tickets

New Delhi, June 6: Despite severe restrictions on entry at railway stations without confirmed tickets in view of the coronavirus pandemic, over 27 lakh people were caught travelling on trains ticketless in the last fiscal, an RTI query has revealed.

This was, however, less than 25 per cent of the number of cases recorded the previous financial year and that is attributable to the restrictions imposed to check the Covid-19 contagion, say officials.

The data made available by the Railway Board following an RTI query made by Madhya Pradeshbased activist Chandra Shekhar Gaur showed that between April 2020 and March 2021, 27.57 lakh people were caught travelling ticketless and ₹143.82 crore was levied as a fine from them.

In the 2019-2020 fiscal, 1.10 crore people were caught travelling ticketless and in total, a fine of ₹561.73 crore was realized from them.

"Traveling ticketless or with an unauthorised ticket is a long-standing challenge before the Indian Railways. On its part, the Railways makes informative, educative and punitive measures to discourage people from doing the same," said Railway spokesperson DJ Narain.

The 2020-2021 financial year was the period when the Railways ran the least number of passenger trains in its history due to the coronavirus pandemic and there were severe re-



strictions on the movement of people inside railway premises, including non-issuance of platform tickets. It includes the lockdown period between April 14 and May 3

when the Railways was not operating any passenger trains except the Shramik Specials which started from May 1. These trains were run at the request of the state governments and the tickets were issued only to those authorised by the states.

In June last year, the Railways began running special trains and issued strict guidelines -- e-ticketing through IRCTC website or through mobile App, no tickets booking at reservation counter, only passengers with confirmed tickets to be allowed entry at station and screening to be done before boarding with only asymptomatic passengers allowed to enter the train.

Fully waitlisted passengers and unreserved passengers were not allowed to travel on trains as the unreserved coaches were booked as reserved second sitting coaches to ensure that the necessary Covid-re-

lated protocols are followed. "Accordingly, in line with these instructions, without ticket passengers at railway premises and trains were being identified and charged as part of normal as well

as special ticket checking drives. "The number of without ticket cases in 2020-21 (27.57 lakh) was less than 25 per cent of the number of such cases detected in 2019-20 when such figure was 1.10 crore. This was feasible due to wide publicity efforts by railways to create awareness and to discourage irregular travel," Narain said.

Currently, the Railways is running 809 special Mail Express trains on an average per day, 2,891 suburban services, 26 special trains being operated as clones of highlypatronised trains and 403 passen-

For Covid not to further aggravate the already heavy burden of maternal and under five mortality, there is a strong case for inclusion


of pregnant women as a high priority group for vaccination. a report

pared by a group of doctors led by Yamini Sarwal of Delhi-based Vardhman Mahavir Medical College and Safdarjung Hospital said.

"We recommend including Covid-19 vaccination in the routine protocol for antenatal care in all countries, particularly India and Indonesia, in view of their high dual burden," it said. Currently, either pregnant women are not included for vaccination, or the policies are ambiguous with the decision being often left to the woman, the report said.

Evidence is emerging of the safety and efficacy of Covid vaccination, which along with benefits of passing on the protection to the newborn, call for including pregnant women in the high priority group for vaccination, it said.

Observing that pregnant women are known to be at significantly higher risk for severe coronavirusrelated complications compared with non-pregnant women, it said. the issue of protecting such women is critical. Vaccination has emerged as a reliable protective measure against severe Covid-19 infection, the report noted.

Ranchi, June 6: Leopards now rein in Palamus Tiger Reserve, known globally for undertaking the world's first census for big cats

Tourists these days flock Palamu Tiger Reserve to have glimpses with leaps of leopards, say officials, who add that no tiger has been sighted since a tigress was found dead in February 2020 near Betla National Park.

"We now have about 150 leopard population, which has become an attraction for tourists coming to Palamu. Happy tourists are often seen taking photographs with the leopards. However, we are making all efforts to facilitate the return of the tigers" Chief Conservator of Forest (CCF) and Project Director, PTR YK Das said.

11 crore Covaxin doses a month

The Centre and a few states are funding Bharat Biotech Limited (BBL) to increase Covaxin production to 11 crore doses a month from the current level of two crores. The Centre is funding three PSUs as grant-in-aid -- Mumbaibased Haffkine Biopharmaceutical Corporation (HBC), Indian Immunologicals, a NDDB unit and Bharat Immunologicals and Biologicals Ltd (BIBCOL), Bulandshahr. The HBC will produce 2 crore doses a month as Centre has given Rs 65 crore grant while Maharashtra is pumping Rs 95 crore. This shut down unit will take a long time to become operational. The NDDB is pumping huge money in Indian Immunologicals to make 12 million doses per month along with BIBCOL. The Centre has given Rs 30 crore to BIBCOL. It is yet to set up a new laboratory. All this starts sometime in October -November only. The BBL is setting up its own facilities which are expected to be operational by

October-November to scale to 5-6

million doses. As of now, the BBL has supplied only 3.11 crore doses to Centre. The good news is Serum's has been supplying 7 crore doses of Covidshield a month now and ramping up to 11 crores by July.

How Sarma twisted BJP arm?

There is a mystery behind how Himanta Biswa Sarma made his way to become Chief Minister of Assam dislodging incumbent Sarbananda Sonowal. There is no doubt that Sarma is BJP's rising star ever since he quit Congress ridiculing Rahul Gandhi personally in 2015. Amit Shah was BJP chief and then Sarma became his chum. Shah was desperate to open BJP's account in North-East under his tenure. But Sonowal had already been groomed for the role by Nitin Gadkari since 2011 after he joined the party from AGP. Taipei, June 6: The US will give Taiwan 750,000 doses of Covid-19 vaccine, part of President Joe Biden's move to share tens of millions of jabs globally, three American senators said Sunday. after the self-ruled island complained that China is hindering its efforts to secure vaccines as it battles an outbreak.

Democratic Sen. Tammy Duckworth of Illinois, who made a three-hour stop in Taiwan with fellow Democrat Christopher Coons of Delaware and Republican Dan Sullivan of Alaska, said their visit underscores bipartisan US support for the democratic island that Beijing claims as its own renegade territory.

Taiwan faces a severe vaccine shortage and has geopolitical significance as a flashpoint in US-China relations.

"I'm here to tell you that the United States will not let you stand alone," Duckworth said at the airport after landing on a US military transport plane.

"We will be by your side to make sure the people of Taiwan have what they need to get to the other side of the pandemic and beyond."

Taiwan was included on a long list of places announced last week that would receive 25 million doses from the United States in what the Biden administration says is the first tranche of at least 80 million

which lies 160 kilometers (100 miles) off China's east coast, is desperate for vaccines after a sudden outbreak that started in late April caught authorities by surprise. Japan shipped 1.2 million doses to Taiwan Friday, opting to skip the COVAX process in the interest of speed. It was unclear when the 750.000 American doses would arrive.

Taiwan has accused China of blocking its efforts to reach a deal with BioNTech to import the vaccine co-developed by the German company and Pfizer. Beijing has said it is willing to supply vaccines to Taiwan, including BioNTech, through Chinese partner Fosun, and that the island's government is to blame for putting politics above the lives of its people.

Brussels, June 6: NATO Secretary General Jens Stoltenberg Sunday warned Russia and Belarus against threatening the alliance's allies, following the forced landing of a passenger plane within the European Union (EU0 by Belarusian authorities.

"We are of course ready, in an emergency, to protect and defend any ally against any kind of threat coming from Minsk and Moscow,' dpa news agency quoted Stoltenberg as saying to the Welt am Sonntag newspaper. "We are vigilant and we are following what is happening in Belarus very closely," he said. Belarus is becoming "more and more dependent" on Russia, he added.

Stoltenberg said NATO was seriously concerned about the closer



cooperation between Moscow and Minsk in recent months.

"We have had to learn in the past that Russia has massively violated the territorial integrity of states such as Ukraine, Georgia and Moldova." He did not want to speculate too much, Stoltenberg said, noting, "NATO is a defensive alliance." Lithuania, Latvia and Poland, all members of NATO, share borders with Belarus

Nasa announces two missions to Venus by 2030

THIS MARKS A CONSIDERABLE CHANGE IN DIRECTION FOR NASA'S PLANETARY SCIENCE DIVISION, WHICH HASN'T SENT A MISSION TO THE PLANET SINCE 1990.

Nottingham, June 6: For decades, the exploration of our solar system left one of our neighbouring planets, Venus, largely unexplored. Now, things are about to change. In the latest announcement from Nasa's solar system exploration programme, two missions have been given the go-ahead – and they're both bound for Venus. The two ambitious missions will launch between 2028 and 2030.

This marks a considerable change in direction for Nasa's planetary science division, which hasn't sent a mission to the planet since 1990. It's exciting news for space scientists like me.

Venus is a hostile world. Its atmosphere contains sulphuric acid and the surface temperatures are hot enough to melt lead. But it has not always been this way. It is thought Venus started out very similar to the

Earth. So what happened? While on Earth, carbon is mainly



trapped in rocks, on Venus it has escaped into the atmosphere - making it roughly 96% carbon dioxide. This has led to a runaway greenhouse effect, pushing surface temperatures up to 750 kelvin (470 degree celsius or 900 degree Fahrenheit).

The planet's history makes it an

excellent place to study the greenhouse effect and to learn how to manage it on Earth. We can use models which plot the atmospheric extremes of Venus, and compare the results to what we see back home.

But, the extreme surface conditions are one of the reasons planetary exploration missions have avoided Venus. The high temperature means a very high pressure of 90 bars (equivalent to roughly one kilometre underwater) which is enough to instantly crush most planetary landers. It might not come as a surprise, then, that missions to Venus haven't always gone to plan.

 $Most of \ the \ exploration \ done \ so$ far was carried out by the then Soviet Union between the 1960s and the 1980s. There are some notable exceptions, such as Nasa's Pioneer Venus mission in 1972 and the European Space Agency's Venus Express mission in 2006.

The first landing happened in 1970, when the Soviet Union's Venera 7 crashed due to the parachute melting. But it managed to transmit 20 minutes of data back to Earth. The first surface images were taken by Venera 9, followed by Veneras 10, 13 and 14.

THE DESCENT MISSION

The first of the two selected Nasa missions will be known as Davinci+

(a shortening of Deep Atmosphere of Venus Investigations of Noble Gases, Chemistry and Imaging). It includes a descent probe, meaning it will be dropped through the atmosphere, taking measurements as it goes. The descent has three stages with the first investigating the entire atmosphere.

The probe will be looking at the composition of the atmosphere in detail, providing information on each layer as it falls. We know sulphuric acid is confined to cloud layers at around 50km (30 miles) up, and we know that the atmosphere is 97% carbon dioxide.

But studying trace elements can provide information on how the atmosphere ended up in this state. The second stage will be looking at lower altitudes to measure weather properties such as wind speed, temperature and pressure in detail. The last stage take surface images in high resolution. While this is very common for Mars, it has always been a challenge on Venus.

'Delta variant 40% more transmissible'

London, June 6: The Delta variant of Covid-19, or the B1.617.2 variant first identified in India, is around 40% more transmissible than the Alpha or so-called Kent variant of concern (VOC), UK Health Secretary Matt Hancock said Sunday.

The senior Cabinet minister said the spread of the Delta variant, behind a recent rise in coronavirus infections in the country, had made the unlocking plans set for June 21 more difficult.

However, he pointed out that a maiority of those in hospital as a result of the Delta variant had not had a vaccine at all but only a few had both doses of a vaccine, which the minister said reflects the scientific advice that one vaccine is not quite as effective against the Delta VOC as against the Alpha variant.

Can India suspend Twitter if it fails to comply with IT rules?

New Delhi, June 6: As India takes its fight with Twitter over noncompliance of the new IT rules to the final round, can the country go ahead and block or suspend the platform the way Nigeria has done?

The Nigerian government has indefinitely suspended Twitter, just days after it accused the US microblogging platform of double standards and supporting the seces-

The government expressed doubts about Twitter's operations in the country, after it deleted a tweet by President Muhammadu

In India, Twitter is in the eye of storm for not complying with the new IT (intermediary) rules 2021 requires the social media firms to appoint a grievance officer in the country. The company has requested the IT Ministry to consider a minimum of three-month extension in order for the company to implement the new intermediary guidelines.

Amid the ongoing notice-andletter game with Twitter, the Indian government has now told the microblogging platform it is clear from the responses of the company that till date it has not informed about the details of the Chief Compliance Office as required under the Rules. The IT Ministry also said in its

fresh notice that the Resident Grievance Officer and Nodal Contact Person nominated by the platform are not its employees in India as required under the new rules.

According to experts, although it may be difficult for India to impose a suspension of services on Twitter for indefinite period as done by Nigeria, the company must ensure it has its grievance officers in India and not in the US.

then similar enforcement of law will have to be ensured across other social media platforms including Facebook and WhatsApp," said Virag Gupta, the lawyer of former RSS ideologue K.N. Govindacharya, who is arguing the social media Designated Officers' matter before the Delhi High Court. "As per new intermediary rules,

Twitter and other social media giants must have their grievance officers in India. These companies are stakeholders in the intermediary rules and must comply with new IT rules, in order to ensure protection under Section 79 of IT Act, and further criminal liability,' Gupta told IANS.

Twitter did not comment on the latest notice by the IT Ministry. The platform and the Centre are

at the loggerheads for quite some time. The war of words has been going on, but no stern action has been taken by the government to date. According to leading cyberlaw

expert Pavan Duggal, India needs to effectively enforce the provisions of the IT (Intermediary Guidelines and Digital Media Ethics Code) Rules, 2021, which have sought to define new parameters of due diligence that need to be followed by social media intermediaries.

"India needs to ensure that the new IT rules do not become mere_ paper tiger and are effectively implemented. Measures like invoking the criminal liability against social media companies could be a good way to transmit a message of deterrence to social media service providers that the Indian Cyberlaw means business," Duggal told IANS

Indian Public Cloud market to reach \$9.5bn by 2025

New Delhi, June 6: The Indian Public Cloud services market revenue reached \$3.6 billion for 2020 and is set to reach \$9.5 billion by 2025, grow at a CAGR of 21.5 per cent, according to a new IDC report.

For the second half of 2020, the Indian public cloud services market totalled \$1.9 billion, according to according to IDC's 'Worldwide Semiannual Public Cloud Services

The Public Cloud services market includes infrastructure-as-aservice (IaaS), platform-as-a-service (PaaS) solutions and software-as-a-service (SaaS).

"Public clouds played a critical role for organisations in 2020, driven by business continuity, flexibility and agility. Cloud will become crucial as organisations expedite the development process and deployment of business applications to meet the changing work and business environment," said Rishu Sharma, Principal Analyst, Cloud



and Artificial Intelligence, IDC India.

SaaS continued to be the largest component of the overall public cloud services market, followed by IaaS and PaaS last year.

The spending continues to accelerate, with the top two service providers holding 49 per cent of the Indian public cloud services market for 2020.

Even though enterprises in the country have been discussing cloud adoption for the past few years, the Covid-19 pandemic forced enterprises to expedite their cloud strategy.

New Delhi, June 6: The second wave of Covid-19 has accelerated digital piracy in India, which was already on the rise when the pandemic hit the country last year, making original content creators lose money by up to five times of what they make through genuine displays, according to a senior official of consultancy firm EY India.

The shift of organised content from theatres to OTT platforms with the advent of new technologies has also increased digital

piracy as these platforms don't come for free.

"The second wave has accelerated this problem because more and more people are now looking at these things sitting at home, and now the technology infrastructure enables you to view anything and everything from home," EY India, Partner - Forensic and Integrity Services, Mukul Shrivastava, told PTI.

He further said, "The situation was the same then (first wave) and probably worse now because people are now used to watching every-

India likely to gain from global min 15% 'corporate tax pact'

THE FINANCE MINISTERS OF G7 COUNTRIES, SATURDAY REACHED A LANDMARK DEAL ON TAXING MNCS AS PER WHICH THE MINIMUM GLOBAL TAX RATE WOULD BE AT LEAST 15%

New Delhi, June 6: India is likely to benefit from the global minimum 15 per cent corporate tax rate pact inked by the world's richest nations as the effective domestic tax rate is above the threshold, and the country would continue to attract investment, tax experts said

The Finance Ministers of G-7 countries, comprising US, UK, Germany, France, Canada, Italy and Japan, Saturday reached a landmark deal on taxing multinational companies as per which the minimum global tax rate would

They also agreed to put in place

measures to ensure businesses pay taxes in the countries where they operate, a move aimed at plugging

loopholes in cross-border taxation. Nangia Andersen India Chairman Rakesh Nangia said the G7 commitment to global minimum tax rate of 15 per cent works well for the US government and most other countries in western Europe. However, some low-tax European jurisdictions such as the Netherlands, Ireland and Luxembourg and some in the Caribbean rely largely on tax rate arbitrage to attract MNCs.

"The global pact would face the challenge of getting other major nations on the same page, since this impinges on the right of the sov-



ereign to decide a nation's tax policy," Nangia added.

India had in September 2019 slashed corporate taxes for domestic companies to 22 per cent and to 15 per cent for new domestic manufacturing units. The concessional tax rate was extended to the existing domestic companies as


well, subject to certain conditions. Consulting firm AKM Global Tax Partner Amit Maheshwari said India is expected to benefit as it is a big market for a large number of tech companies.

'It remains to be seen how the allocation would be between market countries. Also, the global minimum tax of at least 15 per cent means that in all probability the concessional Indian tax regime would still work, and India would continue to attract investment, Maheshwari added.

EY India National Tax Leader Sudhir Kapadia said the global corporate tax pact is a path breaking one, especially for large and developing countries like India which would always find it very difficult to keep corporate tax rates artificially lower in a bid to increase much needed foreign direct investments in the country.

"Even the recently announced lower rate of 15 per cent for new manufacturing units in India just about meets this new threshold, thus, not affecting this much needed boost to manufacturing in India. Equally important is the explicit granting of taxing rights to 'market countries" for a share of global profits of multinational corporations, thus aligning right to taxation with place of economic contribution," Kapadia added.

The decision of the Group of seven (G-7) advanced economies would be placed before the G-20 countries, a group of developing and developed nations, in a meeting scheduled for July in Venice.

Federer withdraws

Paris, June 6: Roger Federer pulled out of the French Open on Sunday, less than 12 hours after he won a difficult and lengthy third round match. The tournament committee announced the 20-time Grand Slam champion's withdrawal.

Federer said in a statement that it is important for him to listen to his body as he returns to action after two operations on his right knee. "After discussions with my team, I decided that I should withdraw from the French Open today (Sunday). After two knee operations and more than a year of rehabilitation, it's important that I listen to my body and not rush back into competition," Federer said in a statement.

Earlier in the day, the Swiss had indicated that he would withdraw. Just a couple of months away from

his 40th birthday Federer took three hours and 35 minutes to achieve a 7-6 (7-5), 6-7 (3-7), 7-6 (7-4), 7-5 victory over 59th-ranked Dominik Koepfer. The match began Saturday night and ended at around 1.00am Sunday morning on Court Philippe Chatrier.

"I don't know if I am going to play," said Federer after the match. "I have to decide whether or not to continue playing. Is it too risky to keep putting pressure on the knee? Is it a good time to rest?" he asked.

Federer has always said Wimbledon is his priority this year. He is chasing a ninth title at the All England Club where the action starts June 28.

"Every match I have to reassess the situation and see the next morning in what state I wake up and how my knee is doing," informed Federer: "I wish I could play the way Novak (Djokovic) and Rafa (Nadal) are playing, but frankly speaking, I am not," the Swiss added.

Serena knocked out

In a women's singles match played later in the day Anastasia Pavlyuchenkova reached the last eight with a 5-7, 6-3, 6-2 win over former World No.1 Viktoria Azarenka.

However, the biggest upset was to come later in the evening as Elena Rvbakina knocked out 23time Grand Slam winner Serena Williams 6-3, 7-5. The American was not her usual self in the contest.

Manjrekar won't brand Ashwin as a 'great' spinner

Mumbai, June 6: Former India batsman Sanjay Manjrekar has said that he has a 'few problems' when people call Ravichandran Ashwin as 'one of the all-time greats of the game'. The off-spinner, who has played 78 Tests and taken 409 wickets, has 30 five-wicket hauls. most of them on Indian pitches.

When people start talking about him as being one of the all-time greats of the game then I have a few problems. When you look at SENA (South Africa, England, New Zealand and Australia) countries, Ashwin doesn't have a single fivewicket haul there," Manjrekar was quoted as saying by a cricket-specific website.

Of Ashwin's 409 Test wickets, 286 have come in India, including 24 fivewicket hauls. Manjrekar said that all-rounder Ravindra Jadeja has matched the off-spinner in the last

'The other thing is when you talk about him (Ashwin) running through sides on Indian pitches that are suited to his kind of bowling. However, in the last four years, Jadeia has matched him with wickettaking abilities," Manjrekar pointed out. "Then, interestingly, in the last series against England, Axar Patel got more wickets than Ashwin on similar pitches. So that is my problem with accepting Ashwin as a real all-time great," he added.

BLUE TIGERS TRYING TO END WINLESS STREAK

Positive India eye win over B'desh

Doha, June 6: A winless India desperately need a positive result against neighbours Bangladesh in their joint World Cup and Asian Cup qualifiers match here Monday, if they want to avoid the ignominy of playing in the qualifying play-off round of the continental showpiece. India are already out of contention for a World Cup berth but still in the reckoning for a place in the 2023 Asian Cup.

However, with just three points from six matches, India are at the fourth spot in Group E and are not vet guaranteed an automatic berth in the third round of the Asian Cup qualifiers. Only the best four fourthplace finishers in each of the eight groups directly qualify for the third round of the Asian Cup qualifiers.

Historically, 105th-ranked India have the edge over Bangladesh (184th). India had beaten Bangladesh twice in the World Cup qualifying rounds, though the wins were registered way back in 1985 (2-1 result in both double-legged matches).

"We still haven't opened our account in Doha. We need to focus (against Bangladesh) and then the next game," said senior defender Sandesh Jhingan. But India cannot be complacent as Bangladesh can be tough opponents. The last time the two sides met in 2019 in Kolkata, the Blue Tigers could only manage a 1-1 draw.

Perez triumphs in Azerbaijan GP

Baku (Azerbaijan), June 6: Sergio Pérez won the Azerbaijan Grand Prix in a two-lap shootout after championship leader Max Verstappen crashed while leading with a tire failure and Lewis Hamilton went off course trying to seize the win on the standing restart.

Verstappen was four laps away from a second consecutive victory Sunday when his Red Bull suddenly slammed hard into the wall with a puncture to his left rear tire. The Dutchman climbed from his car, inspected the tire and kicked it in anger before stomping off in disgust over the race-changing failure. "Is he OK?" radioed rival and seventime champion Hamilton.

Four-time champion Sebastian Vettel took second to give Aston Martin its first ever F1 podium in an impressive drive after qualifying 11th. It was Vettel's highest finish since 2019. Pierre Gasly was third for AlphaTauri as all three drivers made their first trip to the podium this season.

Pérez was the leader but Hamilton shot past him in his attempt to win the race and reclaim the points lead from Verstappen. But he failed to brake in the first corner and his Mercedes slid off track. This was the first time after 54 consecutive races that Hamilton failed to get to the points table.
