

State to boost paediatric care

ONE ATTENDANT MAY BE ALLOWED TO STAY IN THE HOSPITAL CONSIDERING REQUIREMENTS

Bhubaneswar, June 8: The state government has decided to strengthen its medical infrastructure to tackle the possible third wave of Covid-19 that may hit the children hard.

Accepting the recommendations of the Technical Committee headed by Director, Medical Education & Training (DMET), CBK Mohanty, the Health and Family Welfare department has asked all Collectors, municipal commissioners and heads of healthcare institutions to start preparing to strengthen childcare in the hospitals in their respective areas.

The government has decided to create a designated wing for paediatric cases in the existing Covid hospitals for better and safe management of cases as strict isolation of Covid-19 positive paediatric cases may not be possible in general wards, as it may lead to transmission of infection to non-Covid children

As per the plan, 357 beds will be created in seven state-run medical colleges and hospitals for the treatment of coronavirus-infected children. In all, 155 isolation beds, 44 HDU (High Dependency Unit), 94 Paediatric Intensive Care Unit (PICU)/ Special Newborn Care Units (SNCU) and 64 Neonatal Intensive Care Unit (NICU) will be created in the medical col-

leges at Burla, Cuttack, Balasore, Koraput, Berhampur, Baripada and Bolangir.

Similarly, 15 per cent of the total beds in Covid hospitals would be reserved for the paediatric patients. As many as 10,736 general beds and 4,072 ICU like beds are there in the existing Covid hospitals across the state. Hereafter, 1,455 general beds and 408 ICU beds will be dedicated to the children.

All the district and sub-divisional hospitals have been directed to reserve at least 10 beds for isolation of the suspected cases and transfer the symptomatic patients to the appropriate Covid hospitals. About two to four beds will be reserved in the community health centres for such patients, the government said. If a child found Covid positive, he/she will be transferred to appropriate Covid hospital.

The superintendents of government medical colleges and chief district medical officers (CDMOs) have been asked to keep sufficient stocks of the required medicines, consumables and medical oxygen for the treatment of children.

In the areas where the caseload is expected to be high, the government will set up standalone paediatric Covid Care facilities.

To start with, the facilities created will be managed by the available manpower, while trained manpower will

Bhubaneswar, June 8: With the decline in daily Covid cases during the past few days, Chief Minister Naveen Patnaik Tuesday indicated that the state will begin the unlock process in phases.

Chairing the weekly Covid review meeting, Naveen said that the government is considering relaxing the restrictions in districts where test positivity rate has declined considerably.

Lockdown restrictions are in force in the state since May 5 following the outbreak of the second wave of Covid-19. The ongoing restrictions are to continue in the state till June 17.

The Chief Minister expressed relief as the test positivity rate (TPR) is declining in the state and hoped that the rate will come down further in the com-

As the Prime Minister said in his Monday address, no state government will have to spend on vaccine procurement.

However, the Centre has made it clear that the allocation of doses will depend on factors including the population of states and vaccine wastage. "Vaccine doses provided free of cost by the Government of India will be allocated to states/UTs based on criteria such as population, disease burden and the progress of vaccination. Wastage of vaccine will affect the allocation negatively." a notification read.

Domestic vaccine manufacturers will be given the option to provide vaccines directly to private hospitals. And private hospitals will be allowed to levy a maximum of ₹150 as service charge.

be supplied to them. The government has said that the states should similarly allocate doses well in advance for districts and vaccination centers.

Bloomberg News said Tuesday, The government of the world's second most populous nation will earmark an additional between ₹1.1 lakh crore and ₹1.3 lakh crore to provide food until November to the poor and other eligible groups, it said, citing people familiar with the matter. The government may not have to tap the bond market for the funds, the sources said, citing a dividend of ₹99.122 crore it received from the central bank and inflows expected from asset sales.

"They should also put in the public domain the information about the above availability at district and vaccination center level, and widely disseminate it among the local population, maximizing the visibility and convenience of citizens," the guidelines read.

The guidelines state that the vaccination will be prioritised and will be administered to healthcare workers first followed by frontline workers, citizens more than 45 years of age, citizens whose second dose is due, and then to those above 18 years of age

In a letter to all states and Union Territories, the Health Ministry suggested that appropriate strict action be taken against private vaccination centres for overcharging.

The maximum price of Covishield for private Covid-19 Vaccination Centres (CVCs) has been fixed at ₹780 per dose, while that of Covaxin is ₹1,410 per dose and Sputnik V ₹1,145 per dose, it said. The Health Ministry has asked states to ensure that the prices declared by various private CVCs do not exceed the ceiling.

The Serum Institute of India sells its Covishield to private hospitals at ₹600 per dose (excluding GST). Bharat Biotech has set the cost of its Covaxin at ₹1,200 a dose for private establishments. Both vaccines are supplied to the Central government at a cost of ₹150 a dose. Sputnik-V is supplied to private hospitals at ₹948 per dose.

"The private hospitals may charge up to a maximum of ₹150 per dose as service charges. State governments may monitor the price being so charged," the ministry said.



Swaths of internet go down after cloud outage

MULTIPLE WEBSITES WENT OFFLINE BRIEFLY TUESDAY AFTER AN OUTAGE AT THE CLOUD SERVICE COMPANY FASTLY

London, June 8: Multiple websites went offline briefly across the globe Tuesday after an outage at the cloud service company Fastly, revealing how critical a handful of companies running the internet's plumbing have become

Dozens of sites including the New York Times, CNN, some Amazon sites, Twitch, Reddit, the Guardian, and the UK government's home page, could not be reached.

In Asia, cities like Hong Kong and Singapore were also affected, with users unable to access the CNN website. In China, where most foreign media websites are blocked, there was little discussion on the outage on social media platforms such as Weibo.



San Francisco-based Fastly acknowledged a problem just before 6 a.m. Eastern. It said in repeated updates on its website that it was "continuing to investigate the issue." About an hour later, the company

said: "The issue has been identified and a fix has been applied. Customers may experience increased origin load as global services return." A number of sites that were hit early appeared to be coming back online.

Fastly said it had identified a service configuration that triggered disruptions, meaning the outage appeared to be caused internally.

Still, all major futures markets in the US dipped sharply minutes after the outage hit almost exactly a month after a cyberattack that caused the operator of the largest fuel pipeline in the US to halt its operations.

Internet traffic measurement by Kentik show that Fastly began to recover from the outage roughly an hour after it struck at mid-morning European time – and before most Americans were awake.

"Looks like it is slowly coming back," said Doug Madory, an internet infrastructure expert at Kentik. He said 'it is serious because Fastly is one of the world's biggest CDNs and this was a global outage."




State to start antibody cocktail treatment

Bhubaneswar, June 8: The state government has decided to make available a cocktail of antibody drugs for treatment of Covid-19 patients

Following permission of Drugs Controller General of India (DCGI), the government has decided to make available the Pegylated Interferon alpha-2b (PegIFN) & casirivimab and imdevimab (antibody cocktail) drugs for the use by the prescribing physicians strictly complying with the indication and requirement under EUA (Emergency Use Authorization) regulations. Additional Chief Secretary Health, PK Mohapatra has writ ten to heads of all medical institutions in this regard, Tuesday. The drugs will be kept in stock at Odisha State Medical Corporation Ltd (OSMCL) and other selected distribution sites. The drugs will be issued against the requisition by the prescribing physician through superintendent and chief district medical officers (CDMOs), he said The drug is a cocktail of two antibodies, casirivimab and imdevimab, which is used for the treatment of mild to moderate Covid-19 in adults and paediatric patients (12 or older) who are at high risk of developing severe disease.

Experts bat for instant, online tests

Bhubaneswar, June 8: Several educationists have suggested alternative methods for evaluation of Plus II students whose exams have been cancelled in the wake of Covid-19 pandemic.

Educationists GC Nanda, RN Panda, Pritish Acharva, Satvakam Mishra, Basudev Chhatoi, Bijav Kumar Sahoo, Golak Nayak and Pabitra Mahal sent their suggestions to Chief Minister Naveen Patnaik, sources said.

The state government had earlier decided to cancel this year's Plus II exams, conducted by the Council of Higher Secondary Education (CHSE), in view of the pandemic. It has formed a 14-member expert committee to suggest alternative evaluation criteria for Plus II students. Pritish Acharya suggested that an instant examination in condensed form seems to be the only option before the state government.



"The instant exam can give proper justice to the students. The examination can be held in one sitting with MCQ and OMR mode," he added. The evaluation could be made quickly. All care may be taken to prevent copying in the exam. Questions based on understanding and application skills should be the focus area in the instant exam. The National Testing Agency (NTS) may be contacted for the required number of multiple choice questions (MCQs), Acharya said.

According to him, colleges can

this critical situation. The government should arrange tablets or laptops for students for the online examinations, he added.

"There shall be multiple objective questions (1-2 marks) with three papers in three hours. HSC mark and subject-wise attendance of students may be taken into account during the evaluation. We should conduct internal examinations regularly to avoid such situation in future,' Nanda suggested. Raghunath Panda said the state government can go for examinations based on MCQs when there is improvement in the pandemic situation. The government should not go for physical or online examination now.

However, Basudev Chhatoi said HSC mark is the only option for the government under the prevailing situation. The highest marks of individual subjects in HSC exams or the average marks of two-three papers can be taken into consideration for assessing the Plus II students.

NGT lashes out at panel examining illegal sand mining in Subarnarekha

THE PANEL COMPRISED BALASORE DM, SPCB, CPCB AND SEIAA

Bhubaneswar, June 8: The National Green Tribunal (NGT) has now lashed out at Balasore Collector and others who were part of a special committee formed by the tribunal to examine the allegations of illegal sand mining along the Subarnarekha river for their alleged lax attitude in complying with its earlier order.

The tribunal bench comprising Justice B Amit Sthalekar and Saibal Dasgupta as expert member in their court order hinted that there had been some deliberate concealment of facts. It also granted the committee one last opportunity and threatened the panel with criminal action if the earlier order of the tribunal were not complied with.

The case was related to allegations of illegal sand mining at Jaleshwar area in the district along the Subarnarekha river. The NGT in its earlier order January 21 had directed for formation of a fourmember committee comprising members from the Central Pollution Control Board (CPCB), State Pollution Control Board (SPCB) and State Environment Impact Assessment Authority (SEIAA) and the District Magistrate of Balasore

"We have seen the report of the joint committee starting from page 224 of the paper book. We find the report to be very sketchy and devoid of facts at a number of places...We are of the view that there is some deliberate concealment of facts ... " the NGT



The tribunal also expressed its displeasure over the non

determination of the monetary value of the damage caused to the environment due to the alleged illegal sand mining

order said.

'We find that the District Magistrate was a member of the core committee which was required to submit its report, but it is to the discredit of the then District Magistrate that a report should have been submitted expressing his inability to determine the amount of illegal sand excavated causing loss to the state revenue and rampant damage to the environment," the order said.

The tribunal also expressed its

displeasure against the panel over the non determination of the monetary value of the damage caused to the environment due to the alleged illegal sand mining. It also attacked the panel for not collecting the royalty despite a report of the tehsildar on the matter.

The NGT in its written order has also warned the panel of criminal action in case of defiance and gave the panel one more chance to work on their report.

"We, therefore, grant the committee one more opportunity to submit a fresh comprehensive report to avoid any criminal action being initiated by the tribunal. This fresh comprehensive report shall be filed positively by the next date of listing," the

NGT order said. The NGT earlier in another case had also warned the Khurda Collector of criminal proceedings for his alleged non-compliance of tribunal orders.

Mangroves saved Bhitarkanika island from Yaas fury

Kendrapara, June 8: While the se vere cyclonic storm Yaas caused much destruction in this district as it blew away thatched houses, uprooted trees, utility poles, telephone towers and destroyed paddy crops, it has failed to cause any visible destruction in Kalibhanjadiha island inside the Bhitarkanika National Park due to the presence of mangrove forests, a report said.

The speed of the cyclonic storm was more than 145 km per hour. Its impact was so severe that high tidal waves crossed the shore in coastal Rangani, Talachua and Satabhaya villages.

The cyclonic storm uprooted over 100 trees and partially damaged more than six houses meant for tourists in the natural tourist site Havelikhati island. However, it caused very negligible destruction in Kalibhanjadiaha island close to the coastline in Bhitarkanika owing to presence of mangrove forests in 8.5 sq km of area in the island.



This has once again proved that mangroves can save the coastal regions from the impact of such calamities. Kalibhanjadiha island has set an example and shown the way regarding how to protect the coastline.

The utility of mangroves in protecting the coastline from the impact of the cyclonic storms and tsunami has been realised well by the state government. local residents and environmentalists.

Consequently, the government has decided to create a green belt on 3,500 hectare on the coastline to protect the area from coastal erosion as well as contain the loss of lives and properties during floods, cyclonic storms and tsunamis.

Environmentalists Hemant Kumar Rout, Srikant Nayak, Dolagobind Jena and Alok Parida said that Kendrapara is prone to natural calamities like floods, cyclonic storms, storm surges and tsunamis. The district has so far faced six cyclonic storms, including the Super Cyclone-1999, while floods have become a regular feature every year.

However, the presence of mangroves helped protect Bhitarkanika during such calamities where the total loss is much less compared to the losses suffered in other parts of the district.

During the Super Cyclone-1999, tidal waves crossed the coast like tsunamis. The calamity then snatched away 10,000 lives across the state, while 397 persons died in the district.

Yaas also left a trail of destruction in the state and affected over 150 villages in Balasore, Bhadrak and Kendrapara districts. The total losses in Bhitarkanika were estimated at Rs 48.37 lakh while the Kalibhanjadiha island within it faced negligible destruction.

Mangroves cover over 70 per cent of the 8.5 sq km of the island but not a single tree was uprooted during the cyclone Yaas, they said. Mangroves are the only means to save the coastal region from natural calamities like floods, cyclonic storms, storm surges and tsunamis as they act as a protective wall against the onslaught of nature, they said.

When contacted, Susant Nanda, director of the Odisha Forest, Environment and Climate Change department, said that the state government has decided to plant casuarinas and cashew trees over 3.500 hectares near the coastline. The state already has mangrove forests on 220 sq km of area.

The fear and impact of natural calamities like floods, cyclonic storms and tsunamis could be reduced to a great extent if mangrove forests were created on an additional 400 hectares, he added.

Bikash Chandra Dash, Divisional Forest Officer, said that checking coastal erosion has become our priority for which stress is being laid on removing the prawn gheries as they are harming the environment. The space created by removing the gheries could be utilised for creating mangrove forests. The department is already growing new mangrove saplings.

Reverse Vaccination

ndia, like the rest of the world, is in the grip of a once in a century pandemic snuffing out tens of thousands of lives, inflicting excruciating $_{-}$ pain and trauma on millions and ruining countless families. It has been passing through a colossal tragedy with the Centre and the states miserably failing to provide adequate vaccines, oxygen and immunity-inducing drugs to the people, while in some states, bodies of coronavirus victims have been dumped into the rivers for lack of facilities and manpower at crematoriums.

In such a situation it does not behave the ruling party's national president to try to score political brownie points when the Centre is more responsible for the scandalously inept handling of the pandemic than the states.

From the beginning, the Centre took the matter casually while exhorting people to use horrible and unscientific methods, including clapping and banging thalis, to ward off the lethal virus. Then it tried to claim all the credits for vaccination by monopolising procurement and distribution of vaccines to the states. Even the executive director of the Serum Institute of India (SII) producing 90 per cent of the vaccines - Covishield - in the country rued that the Centre had announced the first vaccination programme for inoculating people of the age group of 45 years and above when the arithmetic of available doses was still being worked out and there was massive shortage. This was followed by complaints by Opposition-ruled states that the Centre was making partisan distribution of the vaccines favouring BJP-ruled states. There was no transparency in the vaccination policy. This made the states raise a chorus of demand for decentralising procurement of vaccines. The BJP-led NDA government generally never relents in the face of Opposition criticism of its functioning and policies, the most glaring case being the controversial farm laws which are yet to be rolled back despite the farmers' continuing agitation. But, surprisingly it caved in and allowed the states and private hospitals to buy 50 per cent of vaccines from the producers retaining 50 per cent for itself.

Soon, the reasons for the Centre's uncharacteristic capitulation to Opposition attack became clear. The states, to their utter dismay and consternation, found they could not get supplies from the local producers and their efforts to float global tenders for buying the doses from the international market met with a roadblock. The foreign vaccine producers flatly said they would negotiate only with the Centre and won't be able to make the vaccines available to the Centre any time soon for their prior commitment and deals with other countries


The Supreme Court, luckily for the common citizen, did not remain a passive spectator and in a suo motu hearing tore into the Centre's vaccination policy riddled with holes. After asking tough questions for many discrepancies in its policy, the apex court directed the Union government to submit a report within two weeks on details of procurement, availability, rationale of distribution and pricing of the vaccines in the open market. In the first place, the Centre turned on its head the country's time tested policy of free universal vaccination being followed since Independence. It forced people in the age group of 18 to 44 to pay for the jabs and then let the market forces determine the prices that ranged from ₹900 to ₹1500 per shot on an average. The SC termed such a policy 'arbitrary and irrational.'

Caught in this vicious circle, the states approached the Centre to take back the responsibility of procurement and distribution of vaccines and arrange for free inoculation for all age groups. More than the pressure by the states, it is the prospect of facing the apex court in the next few days that forced the Centre to yield to this demand. The whole country and the rest of the world have seen how the Centre abdicated its responsibility first of saving the people from the deadly pandemic and then change stand as an afterthought.

Going by the Central statistics, a total of over 23 crore doses have been administered so far. But the number is too small considering the need for vaccinating at least 70 per cent of a population of 135 crore to achieve herd immunity. The toll taken by the second wave has been stupendous and the third wave is threatening to wreak further havoc when even babies in the cradle won't be spared. Over 2 billion vaccines, enough to cover the entire adult population, it is said, may be available by the end of 2021. But, for this a massive ramping up of production capacities is needed. The Union government does not seem to have any such plans as of now. It needs to make genuine efforts to achieve the target at the correct time. This is no time for self-congratulation and blatant propaganda but for atonement for the wrongs done to the people. This is time for tangible action to protect citizens from the catastrophe now onwards.

WAR ON RANSOMWARE ansomware is a type of malicious software cyber criminals use to block you from accessing your own data. The digital extortionists en-

crypt the files on your system and add extensions to the attacked data and hold it 'hostage' until the demanded ransom is paid. Ransomware is often spread through phishing emails that contain malicious attachments or through drive-by downloading.

Foreign cybercriminals with scant dread of upshots have paralysed US schools and hospitals, leaked highly sensitive police files, triggered fuel shortages and, most recently, threatened global food supply chains.

The intensifying mayhem caused by ransomware gangs raises an obvious question: Why has the United States, believed to have the world's greatest cyber capabilities, looked so powerless to protect its citizens from these kinds of criminals operating with near impunity out of Russia and allied countries? Until recently, it just hasn't been a high priority for the US government.

President Joe Biden anticipates confronting Russia's leader, Vladimir Putin, about Moscow's concealing of ransomware criminals when the two men meet in Europe later this month. The Biden administration has also promised to boost defenses against attacks, improve efforts to prosecute those responsible and build diplomatic alliances to pressure countries

that harbor ransomware gangs. Pugnacious ransomware requires the nonlethal equivalent of the "global war on terrorism" launched after the September 11 attacks, said John Riggi, a former FBI agent and senior adviser for cybersecurity and risk for the America Hospital Association. Its members have been hard hit by ransomware gangs during the coronavirus pandemic. "It should include a combination of diplomatic, financial. law enforcement, intelligence operations, of course, and

military operations," Riggi said. A public-private task force including Microsoft and Amazon made similar suggestions in an 81-page report that called for intelligence agencies and the Pentagon's US Cyber Command to work with other agencies to "prioritise ransomware disruption operations

"Take their infrastructure away, go after their wallets, their ability to cash out," said Philip Reiner, a lead author of the report. He worked at the National Security Council during the Obama presidency and is now CEO at The Institute for Security and Technology.

The FBI's list of most-wanted cyber deserters has grown at a rapid clip and now has more than 100 entries, many of whom are not exactly hiding. Evgeniy Bogachev, indicted nearly a decade ago for what prosecutors say was a wave of cyber bank thefts, lives in a Russian resort town and "is known to enjoy boating" on the Black Sea, according to the FBI's wanted listing.

Ransomware gangs can move around, do not need much infrastructure to operate and can shield their identities. They also operate in a decentralised network. For occurrence, DarkSide, the group responsible for the Colonial Pipeline attack that led to fuel shortages in the South, rents out its ransomware software to partners to carry out attacks. Katie Nickels, director of intelligence at the cybersecurity firm Red Canary said identifying and disrupting ransomware criminals takes time and serious effort.

The White House has been vague about whether it plans to use offensive cyber measures against ransomware gangs. Press secretary Jen Psaki said last Wednesday that "we're not going to take options off the table," but she did not elaborate. Her comments followed a ransomware attack by a Russian gang that caused outages at Brazil's JBS SA, the second-largest producer of beef, pork and chicken in the United States.

Gen. Paul Nakasone, who leads US Cyber Command and the National Security Agency said at a recent symposium that he believes the US will be "bringing the weight of our nation," including the Defense Department, "to take down this (ransomware) infrastructure outside the United States.'

Sen. Angus King, an independent from Maine who is a legislative leader on cybersecurity issues, said the debate in the Congress over how aggressive the US needs to be against ransomware gangs, as well as state adversaries will be "front and center of the next month or two." "To be honest, it's complicated because you're talking about using government agencies, government capabilities to go after private citizens in another country," he said.

The US is widely believed to have the best offensive cyber capabilities in the world, though details about such highly classified activities are scant. Documents leaked by former NSA contractor Edward Snowden show the US conducted 231 offensive cyber operations in 2011. More than a decade ago a virus called Stuxnet attacked control units for centrifuges in an underground site in Iran, causing the sensitive devices to spin out of control and destroy themselves. The cyberattack was attributed to America and Israel

Biden promised that his administration was committed to bringing foreign cybercriminals to justice. Yet even as he was speaking from the White House, a different Russian-linked ransomware gang was leaking thousands of highly sensitive internal files - including deeply personal back-ground checks — belonging to the police department in the nation's capital. Experts believe it's the worst ransomware attack against a US-based law enforcement agency.



Nihilartikel

you have a copy of the New Oxford American Dictionary, please disregard the entry for esquivalience, which is supposedly the wilful avoidance of one's official responsibilities or the shirking of duties. It has been discovered to be a fake entry. Compilers of reference works sometimes include them to reveal copyright infringements by competitors. Map makers might include a fictitious location, for example, or the compilers of wine encyclopaedias add entries for non-existent beverages (such as that for Via Gra in one of Robert Parker's recent wine guides). The 1980 edition of the New Grove Dictionary of Music had a spoof entry for the composer Esrum-Hellerup. Since nobody consulting such works would ever have cause to look them up, they do no harm (unless you're one of that vanishingly rare breed that reads such works cover to cover and commits the whole to memory). Since we have no English word for deliberately invalid entries, some academics have used the German Nihilartikel. This is formed from the Latin nihil, nothing, plus German Artikel, so "nothing article". In the past, we weren't sure whether this was a real German word or one that had been invented as a joke by some English writer. However, half a dozen appearances in German sources since 2000, more than in English, suggest that it is a real, albeit rare, native German word. The first so far found is this: Dass jedes Lexikon im Fachjargon "Nihilartikel" genannte Stichwörter enthält. [That every dictionary contains terms which are called "Nihilartikel" in technical jargon.] -- Der Orthodidakt by Katharina Hein, in the Berliner Morgenpost, 16 Jul. 2000. This is another example: Der Artikel "Apopudobalia" is schon jetzt berühmt: er suggestiert, es habe in der Antike eine Vorfall des Fußballs gegeben. Er gehört in die Tradition der sog. Nemo- oder Nihilartikel: dabei werden erfundene Artiken oder Fußnoten in ernste Werke eingeschleust. [The article on "apopudobalia" is already famous: it suggests that a precursor of football existed in antiquity. It belongs in the tradition of the so-called Nemo- or Nihilartikel. in which invented articles or footnotes were smuggled into serious works.] -- Das Studium der Kunstgeschichte, by Rente Prochno, 2003. Nemo is another Latin word, meaning "nobody", so Nemoartikel is presumably a false article about a person. The word has made only very rare appearances in non-specialist English-language works. This is one of them: There is considerable distrust among the community that the PostZon database is "clean" - that is, contains no intentionally wrong entries that Royal Mail could use to identify unlicensed use. Such an intentional mistake - known as a Mountweazel or Nihilartikel - effectively poisons the database to unlicensed users, because its presence proves that the data was copied rather than created from scratch.-- Guardian, 24 Sep. 2009. The other term in this quotation. Mountweazel, derives from the fake entry for Lillian Virginia Mountweazel that was inserted by its editors into the 1975 edition of the New Columbia Encyclopedia.

This is amazing to me because when I was 2 years old, I didn't even know that the world was divided into countries.

"At the age of just 2 years, she has memorised the names of the capitals of 205 countries," Shukla tweeted. "Pradeep says that Praneena's memory has been extraordinary from the very beginning."

From the very beginning? Even as a baby, she apparently surprised everyone with her memory. Perhaps she remembered to scream in excitement every time Chhota Bheem appeared on TV.

As you can imagine, many Twitter users were impressed with Praneena's memory. Calling her a "wonder kid," a man named Vinit

Parashar wrote: "Her talent needs to be honed properly. Kudos to the parents.'

I'm not sure what he means by "honed properly," but maybe he believes that with the right training, she'll be able to name not just the capital cities of 205 countries, but also their currencies, chief exports, and gross domestic product (GDP). By age 5, she'll be able to make recommendations to help them diversify their economies.

Parashar added that he was "very happy that these videos were not there during my time of growing up.

I'm happy about that, too. Neither the internet, nor Twitter, existed during my childhood, which meant that my mother could not brag about my memory: "Here's a video of my brilliant son. He has memorised the names of all 50 of his cousins.

While Parashar complimented Praneena's parents, a few Twitter users were not so positive. "I never understood this fascination of parents to force a child of this age to-

wards rote learning," a man named Jitendra Sahu tweeted. "It would have been better if parents start inculcating logical thinking in their children specially of this age which will help them in future.'

His criticism would be valid if Praneena's parents were actually forcing their daughter to memorise capital cities But here's how her father, Pradeep Tandan, responded to Sahu's tweet: "These are her extra learnings with her interest in a playful way. She plucks best coriander leaves everyday morning from our kitchen garden. Take your time to meet her, you will be very much pleased by her logical thinking.'

If she enjoys memorising capital cities, what's the harm? Thanks to her, many people on Twitter learned the capitals of countries they had never heard of, such as Azerbaijan, Kazakhstan and Kyrgyzstan.

I understand Sahu's concern about rote learning. Memorising facts is not always the most effective or enjoyable way to learn,

but it's often the easiest way. It's how many of us learned the alphabet, numbers and multiplication tables, not to mention numerous other facts that we would be tested on.

If you were lucky enough to go to a well-funded school, your biology teacher might have used a replica of a human skeleton to help you learn the names of all the bones. You'd have touched them all and seen exactly how they fit together. But you'd still have to do quite a bit of memorising.

Memorising is a talent in itself. Not every kid can do it as well as Praneena. And no one in the world can memorise digits of pi as well as Suresh Kumar Sharma, who set a world record in 2015 by reciting 70,030 digits. That's unfathomable to me. I can barely remember the digits in my wife's phone number. Praneena's talent for memori-

sation will serve her well in life, especially if she combines it with logical thinking. She'll not only pluck the best coriander leaves, she'll also pluck the best jobs.

Door-to-door vax impossible: Centre to HC UP relaxes Covid lockdown PRESS TRUST OF INDIA

Mumbai, June 8: The Centre told the Bombay High Court Tuesday that a door-to-door Covid-19 vaccination programme for senior citizens, specially-abled, bed-ridden and wheelchair-bound people is currently not possible, but it has decided to start "near-to-door" inoculation centres.

The Union government in its affidavit filed in the HC said the National Expert Group on Vaccine Administration (NEG-VAC) has considered the issue of door-to-door vaccination and opined that "near-to-door" vaccination would be an appropriate solution, and not door-todoor vaccination. The court noted that almost 25 crore people have been vaccinated in India.

"Which other country has been able to do so with so much population. The government can do this (door-to-door vaccination) too. You (government) need to find your own way," Chief Justice Dipankar Datta said. A division bench of Chief Justice Datta and Justice G S Kulkarni last month directed the NEGVAC to consider if door-to-door vaccination programmes can be started for senior citizens, specially-abled people and those who are wheelchair-bound or bed-ridden. The Centre's affidavit claimed that till May, 25,309 cases of adverse reaction after vaccination were reported out of which 1,186 were serious. "475 deaths were reported following Covid-19 vaccination till May 28, 2021," it said. The court will continue hearing the matter Wednesday

Lucknow, June 8: The Uttar Pradesh government Tuesday extended relaxation in Covid restrictions to all 75 districts of the state, with the active cases coming down the 600-mark in each of these districts.

The night curfew from 7 pm to 7 am and weekend curfew (for the entire day) will, however, continue throughout the state, an official spokesman said.

By Monday, the relaxation was extended to 72 districts barring Meerut, Lucknow and Gorakhpur. In a high-level meeting convened through virtual medium Tuesday,

Chief Minister Yogi Adityanath reviewed the Covid-19 situation and decided to give the relaxations in the Covid curfew.

The spokesman said in view of the decreasing infection rate, a standard of 600 active cases was set for having coronavirus curfew effective in the districts.

In an order issued in this regard by Additional Chief Secretary, Home, Awanish Kumar Awasthi said the curfew will be relaxed as per the conditions mentioned in the government order issued May 30 by Chief Secretary R K Tiwari.

According to the order issued by Tiwari, shops and markets out side containment zones would be allowed to open for five days (Monday to Friday). Instructions were issued that over the weekend, cleanliness, sanitisation and fogging



While there would be full attendance for frontline workers, for the rest of the government employees, there would be 50 per cent attendance on rotation

campaigns will be carried out.

Shopkeepers and their employees will have to wear masks, maintain two-vard distance with each other and customers, and ensure the arrangement of hand sanitisers

According to the order, industrial units will stay open while vegetable markets in the

densely-populated areas will function in open places. At railway stations, airports and bus stands, all Covid protocols have to be followed. Screening of passengers and antigen tests have to be conducted. The roadways buses have been allowed to operate within the state. Schools, colleges and educational institutes will remain closed while teachers and other staff have been allowed to come to school for administrative work.

Not more than five devotees will be allowed inside a religious place at a time. Coaching centres, cinema halls, gymnasiums, swimming pools, clubs and shopping malls will remain closed, it said. A maximum of 20 people will be allowed at a funeral procession, it added.

New Delhi, June 8: India Tuesday logged 86,498 new Covid infections in 24 hours, less than one lakh cases for the first time in past 66 days, the Union Health and Family Welfare Ministry said.

It is also the lowest number of cases since April 2 when the country logged 89,129 new cases. In the past 24-hour, 2,123 more peo-

ple succumbed to the pandemic. Monday, India had reported 1,00,636 cases, lowest spike since April 6. India's overall tally of Covid-19 cases now stands at 2.89.96.554 with 13.03.702 active

cases and 3,51,309 deaths so far. Over the last few days, India's fresh Covid cases have seen downward trend, maintaining over one lakh infections every 24 hours. while the deaths have also remained below the 3,000 mark. After battling a brutal second wave for weeks, fresh Covid cases came down below the three lakh-mark for the first time May 17 after touching record high of 4,14,188 May 7.

In the last three weeks, India has recorded over 90,000 deaths.

In the past 24-hour, 2,123 more people succumbed to the pandemic

India registered record fatalities due to Covid-19 May 21 with 4,529 deaths -- the highest from Covid infection in any country in a day since the coronavirus outbreak was reported in China's Wuhan in December 2019. It surpassed 4,468 deaths in the US January 12, 2021, and 4,211 in Brazil April 6, 2021.

According to the Health Ministry, a total of 1,82,282 people have been discharged in the last 24 hours. taking the total discharge to 2,73,41,462 till date.

The Health Ministry said that a total of 23,61,98,726 people have been vaccinated so far in the country, including 33,64,476 who were administered vaccines in the last 24 hours. According to the Indian

Council of Medical Research, 36,82,07,596 samples have been tested up to June 7 for Covid-19. Of these 18,73,485 samples were tested Monday.

Cumulative vax coverage reaches 23.88Cr

New Delhi, June 8: The cumulative number of Covid-19 vaccine doses administered in the country has reached 23.88 crore, the Union health ministry said Tuesday.

It said 13,32,471 beneficiaries in the age group of 18-44 years received their first dose and 76,723 beneficiaries of the same age group received their second dose of Covid-19 vaccine during the day.

Cumulatively, 3,17,37,869 people in the same age group across states and union territories have received their first dose and 3,16,134 their second dose since the start of Phase 3 of the vaccination drive.

Bihar, Delhi, Gujarat, Haryana, Karnataka, Madhya Pradesh, Maharashtra, Rajasthan, Tamil Nadu, Uttar Pradesh and West Bengal have administered more than 10 lakh beneficiaries of the



age group 18-44 years for the first dose of Covid-19 vaccine, the ministry said.

This total of 23,88,40,635 beneficiaries include 99,95,552 healthcare workers who have taken the first dose and 68,91,662 such workers

who have taken the second dose. As many as 1,63,80,521 frontline workers have received the first dose and 87,26,071 such workers have taken the second dose.

Also 3,17,37,869 and 3,16,134 individuals in the 18-44 age group

have received the first and second dose respectively. Besides, 7,25,46,765 and 1,15,34,478

beneficiaries aged over 45 to 60 years old have been administered the first and second dose respectively while, 6,12,75,505 and 1,94,36,078 beneficiaries aged above 60 years have taken the first and second dose.

The ministry said 22,67,842 beneficiaries were vaccinated for the first dose and 2,90,810 beneficiaries received the second dose of vaccine, according to the provisional report till 7 PM.

The vaccination exercise as a tool to protect the most vulnerable population groups in the country from Covid-19 continues to be regularly reviewed and monitored at the highest level, the ministry underlined. As on the 144th day of the vaccination drive, 25,58,652 doses were given.

The smugglers were held in a special operation conducted by the BSF troops along the border Monday, the BSF said in a statement, adding the two smugglers are Indians.

New Delhi, June 8: There is no data, either from India or globally. to show that children will be seriously infected in any subsequent Covid-19 waves, AIIMS, Delhi, Director Dr Randeep Guleria said Tuesday.

Addressing a media briefing here. he said that "it is a piece of misinformation that subsequent waves of the Covid-19 pandemic are going to cause severe illness in children". Noting that 60 per cent to 70 per cent of the children who got infected and got admitted in hospitals during the second wave in India, had either comorbidities or low immunity, the All India Institute of Medical Sciences (AIIMS) Director said that healthy children recovered with mild illness without need for hospitalisation.

Explaining why pandemics return again, the AIIMS Director said "waves normally occur in pandemics caused due to respiratory viruses: the 1918 Spanish Flu, H1N1



(swine) flu are examples". "The second wave of 1918 Spanish Flu was the biggest, after which there was a smaller third wave," said Guleria. "And as we know. SARS-Cov-2 is a respiratory virus."

Multiple waves occur when there is a susceptible population and when a large part of the population acquires immunity against the infection. "the virus becomes endemic and infection becomes seasonal like that of H1N1 that commonly spreads during monsoon or winters", he said.

"Waves can occur due to change in the virus (such as new vari-

ants). Since new mutations become more infectious, there is a higher chance for the virus to spread."

Guleria said that one of the reasons behind a wave can be human behaviour and cautioned that "whenever cases increase, there is a fear in people and human behaviour changes. People strictly follow Covid appropriate behaviours and non-pharmaceutical interventions help breaks the chain of transmission. But when unlocking resumes, people tend to think that not much infection will happen and tend to not follow Covid appropriate behavior".

Climate crisis will have catastrophic impact: Study

New Delhi, June 8: The climate emergency will have a catastrophic human and economic impact in India. Different threats will interact to devastating effect, as exem-

plified by cyclones Tauktae and Yaas during the second wave of the Covid-19 pandemic. A new review by the global think tank, ODI, The costs of climate change in India, released Tuesday, laid out how rising temperatures will jeopardise India's economic development through different channels, including falling agriculture productivity, impact to public health, reduced labour productivity and sea level rise. The study is a first-ever literature

review on the economic costs of climate inaction in India. At one degree Celsius of global warming, the country is already experiencing damages. Flooding in India over the last decade caused \$3 billion in economic damage -- accounting for 10 per cent of global economic losses from flooding.

Angela Picciariello, Senior Research Officer at ODI, said, "India



is already feeling the costs of climate change, with many cities reporting temperatures above 48 degrees in 2020 and a billion people facing severe water scarcity for at least a month of the year."

"If action is not taken to cut emissions enough to limit the global temperature rise to 1.5 degrees Celsius, the human and economic toll will rise even higher.

The total cost of heat waves. flooding, water scarcity, cyclones, sea-level rise and other climaterelated hazards will be determined by the direction and level of economic development; the choices made in spatial planning

and infrastructure investment; and the way different hazards intersect.

Amir Bazaz, Senior Lead-Practice at the Indian Institute for Human Settlements, said: "As we are seeing now with Cyclones Tauktae and Yaas, low-income and other marginalised groups are most vulnerable to the impacts of climate change. They often live in dense settlements that lack basic services and infrastructure that could reduce risk.

"Many households also live on hazardous sites such as steep slopes and floodplains. It is therefore crucial to bring climate and development goals together."

Rathin Roy, Managing Director (Research and Policy) at ODI, said "Pursuing a cleaner, more resourceefficient path to development could stimulate a faster. fairer economic recovery for India and help secure India's prosperity and competitiveness in the long term."

"Lower-carbon options are more efficient and less polluting, producing immediate benefits such as cleaner air, greater energy security and rapid job creation.'

Much depends on India's policy, investment and diplomatic choices over the next decade.

As the only country in the G20 that currently has a 'two degrees Celsius compatible' Nationally Determined Contribution (NDC), India is already doing its fair share for climate mitigation.

However, pursuing a more carbon-efficient and resilient pathway would enable India to climateproof its development gains.

Given India's low per capita emissions and lower-middle income country status, it mayneed international support to make it happen.


HC cancels MP's caste certificate

'LICENSE TO LOOT' Withraw 25% vaccine reservation for private sector: Left to Centre

New Delhi, June 8: Left parties demanded Tuesday that the government withdraw the 25 per cent reservation of vaccines for the private sector, alleging that it was a "license" to loot.

Prime Minister Narendra Modi announced Monday that the Centre will provide free coronavirus vaccines to the states for the inoculation of all above the age of 18 years from June 21. He also said private hospitals can continue to procure 25 per cent of the vaccines, but their service charge would be capped at ₹150 per dose over the fixed price of the vaccine.

The Communist Party of India (Marxist), in a statement, said people will reject the "condemnable" effort by the prime minister to level false charges against the state governments and shift the responsibility to them.

"However, the failed vaccine policy has not been fully reversed. The government has chosen to continue the dual pricing policy. As

much as 25 per cent of vaccine production is still reserved for the private sector. This is nothing but a license for loot by private manufacturers to make super profits. "Further, at a time of an acute

vaccine shortage, the continuation of such a policy will dilute and weaken the need for universal vaccination, essential to prevent a third wave of the Coronavirus. Only the rich can afford the exorbitant pricing of vaccines for the private hospitals permitted by the government," the CPI(M) said, demanding the withdrawal of the 25 per cent reservation for the private sector.

CBI books FCI official in DA case

"It will be a two-month long campaign with a series of events on reducing plastic waste generation, recognising the need of effective plastic waste management, increasing the awareness of suitable alternatives, sustainable consumption and production and extended producer responsibility (EPR)," Gupta said.

The campaign is being organised by the Federation of Indian Chambers of Commerce and Industry (FICCI). United Nations Environment Programme (UNEP) and GIZ (Deutsche Gesellschaft für Internationale Zusammenarbeit), a German organisation working jointly with partners in India for sustainable economic, ecological, and social development

Gupta said intensive efforts have been put in by the ministry to raise awareness and sensitise citizens on the environmental impact of SUP

UK lockdown end may be delayed

London: The UK government is said to be weighing up a delay of around a fortnight beyond the June 21 timeline set for the final stage of a roadmap to end all legal lockdown restrictions, amid a continuing rise in the cases of the Delta variant of Covid in parts of the country. The delay being considered is to enable all over-50s to be fully vaccinated with both doses of a vaccine, found to be most effective against the highly transmissible variant of concern (VOC) first identified in India, and also to leave sufficient time for the jabs to take effect.

IS militants abduct five people in Sinai

El-Arish (Egypt): At least five Egyptians were abducted by Islamic State militants Tuesday in the restive northern part of the Sinai Peninsula, security officials said. The five were driving to their workplace in the small town of Bir al-Abed when the militants from the Islamic State group stopped their vehicle and took them to an unknown place. The five include three engineers, a labourer and their driver, said the officials. They all work at the el-Salam canal project that moves the Nile Delta drainage water to be reused in agriculture in the peninsula.

Beijing, June 8: Already famous at home, China's wandering elephants are now becoming international stars. Major global media are chronicling the herd's more than yearlong, 500-kilometer (300mile) trek from their home in a wildlife reserve in mountainous southwest Yunnan province to the outskirts of the provincial capital of Kunming.

Twitter and YouTube are full of clips of their various antics, particularly those of two calves who slipped into an irrigation ditch and had to be helped out by older members of the group.

'We should be more like the elephant and be more family oriented, take family vacations and



help and care for and protect each other," read one comment on YouTube signed MrDeterministicchaos. The elephants have been trending for days

on China's Weibo microblogging service with photos of the group sleeping attracting 25.000 posts and 200 million views Mondav night. The 15-member herd has been

caught at night trotting down urban streets by security cameras, filmed constantly from the air by more than a dozen drones and followed by those seeking to minimize damage and keep both pachyderms and people out of harm's way.

They've raided farms for food and water, visited a car dealership and even showed up at a retirement home, where they poked their trunks into some of the rooms, prompting one elderly man to hide under his bed. While no animals or people have been hurt, reports put damage to crops at more than \$1 million. Sixteen animals were originally in the group, but the government says two returned home and a baby was born during the walk. The herd is now composed of six female and three male

adults, three juveniles and three calves, according to official reports.

What exactly motivated them to make the epic journey remains a mystery, although they appear to be especially attracted to corn, tropical fruit and other crops that are tasty, plentiful and easy to obtain in the lush tropical region that is home to about 300 of the animals. Others have speculated their leader may be simply lost.

Asian elephants are loyal to their home ranges unless there have been disturbances, loss of resources or development, in which case they may move out, according to Nilanga Jayasinghe, manager for Asian species conservation at the World Wildlife Fund.

Oz state finds source of Covid-19 variant

Melbourne. June 8: Health authorities in the Australian state of Victoria, which is battling to contain the highly contagious B.1.6172 or the Delta Covid-19 variant, have found a genomic link to one of the positive cases.

The health authorities, who have been investigating the Delta cases in Victoria since last week, have yet to find a link with any other cases across Australia, reports Xinhua news agency.

Victoria's Acting Premier James Merlino said Tuesday that a match had been made with a returned traveller who had entered hotel quarantine in the state capital of Melbourne May 8.

"While we have a genomic link, we do not currently have an epidemiological link," Merlino said. 'There's currently no definitive

understanding of where a transmission event may have occurred." Investigations are continuing as to whether there was any contact between the returned trav-

eller and those other Delta cases. As of Tuesday, the state recorded two locally-acquired Covid cases of from 22,814 test results in the past 24 hours, both of which were linked to existing outbreaks, according to Merlino. Overall there are now 92 active cases in the state, with 83 are locally acquired.

Merlino said the tracking down and isolating of cases meant that the lockdown was likely to be lifted Thursday.

'We remain on track to later in this week announce further easing of restrictions in regional Victoria and careful easing of restrictions in Melbourne," he said.

UNSC recommends **Guterres for 2nd** term as UN chief

United Nations, June 8: The UN Security Council Tuesday recommended Secretary General Antonio Guterres for a second five-year term as chief of the world organisation beginning January 1, 2022.

The 15-nation Council held a closed meeting where it unanimously adopted a resolution recommending Guterres' name to the 193-member General Assembly for a second term as Secretary General.

Last month, India had conveyed its support to Guterres for his candidature as chief of the world body for a second term beginning January 2022. External Affairs Minister S Jaishankar had met Guterres at the United Nations headquarters and expressed New Delhi's support to him for his second term as the world's top diplomat. "India values UNSG's leadership of the UN, especially in these challenging times. Conveyed our support for his candidature for a second term." Jaishankar said in a tweet after the meeting. Later a press release issued by the Permanent Mission of the India to the UN also stated that Jaishankar "conveyed that India values Secretary General's leadership of the United Nations, especially in these challenging times.

FBI-run messaging app tricks organised crime than 300 gangs operating in more GLOBAL

The Hague, June 8: Criminal gangs divulged plans for moving drug shipments and carrying out killings on a messaging app secretly run by the FBI, law enforcement agencies said Tuesday. as they unveiled a global sting operation they said dealt an "unprecedented blow" to organised crime in countries around the world.

The operation known as Trojan Shield led to police raids in 16 nations. More than 800 suspects were arrested and more than 32 tons of drugs — including cocaine, cannabis, amphetamines and

methamphetamines - were seized along with 250 firearms. 55 luxury cars and more than USD 148 million in cash and cryptocurrencies. The seeds of the sting were sown when law enforcement agencies earlier took down two encrypted platforms. EncroChat and Skv

ECC, that had been used by criminal gangs to organize drug trafficking and underworld hits. With the gangs in the market

for a new means of communication, the FBI stepped in with a covertly developed app called ANOM that was installed on modified mobile phones. Over the past 18 months, the FBI provided phones via unsuspecting middlemen to more

WHO warns against overpriced Covid vax

Geneva, June 8: The World Health Organization (WHO) warned against the danger of buying overpriced Covid-19 vaccines from intermediaries, reminding countries to buy jabs certified by the WHO and make sure to identify the origin of the product.

"We have received concerns regarding other vaccines with intermediates selling it (one vaccine) at a much higher price than what has been actually sold by the manufacturers," said Mariangela Batista Galvao Simao, WHO Assistant Director-General for Access to Medicines and Health Products, during a press conference here on Monday. The issue of the role of intermediates for buying vaccines was raised recently as a middleman, located in the United Arab Emirates, was caught selling Sputnik vaccines to Ghana and Pakistan at double the original price, reports Xinhua news agency.

Simao said that countries should either buy directly from the manufacturer or "contact the manu-

Jerusalem, June 8: Israel's parliament speaker has scheduled a vote for Sunday on a new government that would end Prime Minister Benjamin Netanyahu's 12-year rule, the longest in the country's history. Parliament speaker Yariv Levin, a Netanyahu ally, announced the timing of the vote Tuesday, a day after acknowledging that a coalition had been formed.

The fragile coalition consists of eight parties spanning Israel's political spectrum, with only a narrow majority in the 120-member Knesset, or parliament. But it appears to have held together despite a furious campaign by Netanyahu's supporters that has included death threats and protests outside lawmakers' homes.

Netanyahu has accused his erstwhile right-wing allies of betrayal for allying with leftists and a small Arab party that he had also courted. Naftali Bennett, an ultranationalist former Netanyahu ally, would serve as Prime Minister for two years, followed by the centrist Yair Lapid, the driving force behind the coalition, who thanked the speaker for scheduling the vote. "The unity government is on the

way and ready to work on behalf of all the people of Israel," Lapid said. Israel held four elections in less than two years, the most recent in March.

Each time, voters were deeply polarised over whether Netanyahu should remain in office while facing allegations of corruption, for which he is now on trial. An emergency government formed last year to address the coronavirus pandemic was mired in political infighting and collapsed in December.


'A lot of anxiety' for Dems as Biden agenda stalls

Washington, June 8: Hopes for a big infrastructure investment are teetering. An ambitious elections and voting bill is all but dead. Legislation on police brutality, gun control and immigration has stalled out.

Nearly six months of Democratic control in Washington, the party's progressive wing is growing increasingly restless as campaign promises go undone - blocked not only by Republican obstruction, but also by Democrats' own inability to unite fully around priorities

The time ahead is pivotal for President Joe Biden and his allies in Congress to seize what some view as a transformative moment to rebuild the economy and re-



shape the country. "There's a lot of anxiety," said Rep. Ro Khanna, D-Ca., who had been a co-chair of Bernie Sanders' presidential bid. "It's a question really for President Biden: What kind of president does he want to

The summer work period is traditionally among the busiest for Congress, but especially sharpened this year as Democrats strain to deliver on Biden's agenda. Senate Majority Leader Chuck Schumer warned colleagues that June will "test our resolve." Infrastructure talks are dragging, though Biden is expected to talk again Tuesday with Sen. Shelley Moore Capito, the lead Republican negotiator. But the limits of bipartisanship in the 50-50 Senate are increasingly clear.

The party suffered a debilitating blow over the weekend when Sen. Joe Manchin, D-W.Va., announced his opposition to the voting bill, titled S.1 because it is a top party priority. Many Democrats view it as crucial to protecting democracy and a direct response to restrictive new voting laws being passed in Republican-led states egged on by Donald Trump, the former president.

"Do I feel discouraged? Yes," said Rep. Pramila Jayapal, D-Wash., chairwoman of the Congressional Progressive Caucus, warning of a failure to deliver on the promises. 'We will lose voters for a generation."

Schumer, in setting the agenda, is challenging senators to prepare to make tough choices. But he is also facing a test of his own ability to lead the big-tent party through a volatile period of shifting priorities and tactics in the aftermath of the Trump era and the Capitol insurrection

While Democratic senators have

been generating goodwill by considering bipartisan bills in the evenly split Senate, they face mounting pressure from voters who put them in office to fight harder for legislation that Republicans are determined to block with the filibuster. Democrats hold the edge in the Senate because Vice President Kamala Harris can break a voting

Fed up by the delays, some senators are ready to change the rules to eliminate the filibuster, which they blame for the inaction. The long-running Senate filibuster rules require 60 votes to advance most legislation, meaning as many as 10 Republicans would need to cross party lines to help Democrats achieve their priorities. Some senators propose reducing the voting threshold to 51.

Favipiravir effective: Glenmark cites study

New Delhi: Drug firm **Glenmark Pharmaceuticals** Tuesday said interim data from its post marketing surveillance study on antiviral drug favipiravir in India supports its safety and effectiveness in real world settings with no new safety concerns for COVID-19 patients. The study commenced in July 2020, aimed to evaluate safety and efficacy of favipiravir in mild to moderate COVID-19 patients. As on date, a total of 1,083 patients have been enrolled in the prospective, open label, multicenter, single arm study, Glenmark said in a regulatory filing. Interim data presented by the company to the regulator reveals no new safety signals or concerns with the use of favipiravir and already-known side effects which were found to be mild in nature, the filing said.

Mumbai, June 8: A union representing India's largest state-run bank and a global alliance have asked the central bank to bar large companies from setting up payment networks, saying in a letter seen by Reuters Tuesday that privatisation could compromise data safety.

In a bid to reduce concentration risks in the payments sector, RBI last year invited companies to forge so-called New Umbrella Entities (NUEs) to create a payments network that would rival the country's flagship processor, the National

Payments Council of India (NPCI). The NUE will be allowed to op-

erate new payment systems including digital and ATM transactions. Amazon, Google, Facebook, and others have applied for such licences in partnership with Indian companies such as Reliance and

ICICI Bank. Involvement of big multi-national companies raises fears of abuse of user data and India's digital payment networks should continue to operate on a non-profit basis, the All India State Bank of India (SBI) Staff Federation and the UNI Global Union, a vocal critic of tech giants, wrote in the letter.

The letter urged the central bank to scrap the "whole process of NUE licensing" and focus on strengthening the domestic payments group, NPCI, which operates as a non-

The RBI did not immediately respond to a request for comment on the letter, which has previously not been reported.

While state-backed NPCI forms the backbone of the country's digital payments system. India is an increasingly attractive digital payments market for everyone from Amazon to Google. An Assocham-PWC India study in 2019 said digital payments in India could rise to \$135 billion (roughly ₹9,84,250 crores) in 2023 from \$65 billion (roughly ₹4.73.900 crores) in 2019

In the letter, groups including the SBI union, which represents 100,000 of its nearly 250,000 employees, and UNI Global Union, that represents about 20 million workers globally, specifically raised concerns about the NUE application by a consortium led by Amazon. It highlighted the US company was facing several investigations into its business practices in India and abroad.

Central Bank of India, Indian Overseas Bank, Bank of Maharashtra and Bank of India are some of the names that may be considered for privatisation by the Core Group of Secretaries on Disinvestment.

CCI nod for acquisition of 3 power utilities by TPCL

Bhubaneswar, June 8: The Competition Commission of India (CCI) approved acquisition of 51% of the equity share capital in each of the three electricity supply companies of Odisha-Western Electricity Supply Company of Odisha (WESCO Utility), Southern Electricity Supply Company of Odisha Limited (SOUTHCO Utility) and Central Electricity Supply Company of Odisha Limited (CESCO Utility) by the Tata Power Company Limited (TPCL), under Section 31(1) of the Competition Act, 2002, Tuesday.

According to the report, proposed combinations relate to acquisition of 51% of equity share capital in each utility by the TPCL from Grid Corporation of Odisha Limited (GRIDCO) pursuant to separate competitive bidding processes initiated by the Odisha Electricity Regulatory Commission (OERC) under Section 20 of the Electricity Act, 2003.

WESCO Utility, is engaged in the business of distribution and retail supply of power in five western districts of Odisha namely Rourkela, Burla (Sambalpur), Bhawanipatna (Kalahandi), Bolangir, and Bargarh. SOUTHCO Utility is engaged in the business of distribution and retail supply of power in six southern districts of Odisha namely, certain areas in Ganjam district, Berhampur, Aska, Bhanjanagar, Jeypore and Rayagada.

CESCO Utility is engaged in the business of distribution and retail supply of power in four central districts of Odisha namely Bhubaneswar (1 and 2), Cuttack, Paradip and Dhenkanal.

Biden admin's 'strike force' to go after China on trade

Washington, June 8: The United States will target China with a new "strike force" to combat unfair trade practices, the Biden administration said Tuesday, as it rolled out findings of a review of U.S. access to critical products, from semiconductors to electric-vehicle batteries.

The "supply chain trade strike force," led by the U.S. trade representative, will look for specific violations that have contributed to a "hollowing out" of supply chains that could be addressed with trade remedies, including toward China, senior administration officials told reporters

President Joe Biden ordered the review of critical supply chains in February, requiring executive agencies to report back within 100 days on risks to U.S. access to critical goods like those used in pharmaceuticals as well as rare earth minerals, for which the United States is dependent on overseas sources.

Though not explicitly directed at China, the review is part of a broader Biden administration strategy to shore up U.S. competitiveness in the face of economic challenges posed by the world's second largest economy.

"Semiconductors are the building blocks that underpin so much of our economy, and are essential to our national security, our economic competitiveness, and our daily lives," U.S. Commerce Secretary Gina Raimondo said in a statement. Other top U.S. economic officials are scheduled to address reporters at the White

What also poses a concern for Dalic is the fact that the squad he now has in front of him is ageing, with the key players no spring chickens anymore. Croatia have also slipped up early on in

the 2022 FIFA World Cup Qualifiers, so the odds do seem to be stacked against them heading into UEFA Euro 2020. Croatia, though, still have the inspirational Luka Modric leading by example, while out in front, there have been some positive but key changes. Defence, however, might pose a bit of a concern for the Balkan side, which then brings Scotland and Czech Republic into the picture.
