12 die in Mumbai building collapse

MUMBAI: At least eight children and four adults were killed and seven others injured after a singlestorey house collapsed on another structure in Malwani area of this city, a civic official said Thursday. The incident took place around 11.15pm Wednesday at the New Collector Compound on Abdul Hamid Road in the Malwani area. Many more bodies are feared trapped under the debris as fire brigade and other agencies are carrying out rescue operations, an official of the Brihanmumbai Municipal Corporation (BMC) said. Joint Commissioner of Police (Law and Order) Vishwas Nangre Patil told reporters that the building was constructed illegally and had serious structural faults. He added the tragedy could have been averted if precautions had been taken. **P9**

Chinese national arrested by BSF

NEW DELHI: The Border Security Force (BSF) intercepted Thursday a Chinese national in West Bengal's Malda district from near the border following suspicious activities, an official of the paramilitary force said. A laptop and a passport have been recovered from his possession. In a statement, the BSF said concerned agencies are interrogating the Chinese national. He has been identified as Han Junwe, a resident of China's Hubei province. BSF officials said that Junwe is a 'wanted criminal' and it is trying to ascertain whether he has any connections with Chinese spying agencies.

RELIEF PACKAGE FOR 'YAAS' ANNOUNCED

Farmers, fishermen, artisans brought under various compensation packages

Bhubaneswar, June 10: Chief Minister Naveen Patnaik announced Thursday a relief package for persons affected due to cyclone Yaas which hit hard the north Odisha coast May 26 morning. The government is attempting to compensate the loss suffered by farmers, fishermen, artisans and people from all other segments of life. The government said it will provide agriculture input subsidy to small and marginal farmers who have sustained crop losses of 33 per cent and above.

Also farm machinery subsidy of ₹20 crores to the farmers of affected districts will be provided through direct benefit transfer (DBT) mode. House building and other assistances will be provided to the eligible beneficiaries as per state government norms.

Agricultural input subsidy of ₹6,000 per hectare will be provided to farmers with land in non-irrigated areas, ₹13,500 per hectare in areas under assured irrigation and ₹18,000 per hectare for all types of perennial crops. All the assistance will be provided to actual cultivators, the Chief Minister's Office (CMO) is in a statement. Agricultural input subsidy to any affected farmer will not be less than Rs 2,000 for perennial crops and Rs 1,000 for other crops, it added.

The short-term Kharif loans advanced in the cyclone affected areas hav-

ing crop losses of 33 per cent and above will be converted into medium term

(conversion) loans, it said. Similarly, 2,000 pump sets will be distributed with 50 per cent (maximum of Rs15,000 per set) subsidy and 3,000 sprayers will be made available to the affected farmers at a subsidy of 50 per cent limited to maximum of ₹3,800 for power sprayers and ₹750 for hand operated sprayers. Affected farmers in saline-inundated areas will be given assistance of ₹750 per hectare for soil nutrient management and soil ameliorants.

The statement also said an incentive of ₹15,000 per person will be provided to 125 affected farmers for repair and renovation of betel vine cultivation. Also more than 10,000 free vegetable mini-kits (₹150/

kit) will be distributed in the cyclone-affected areas.

The Chief Minister's Office has also announced compensation towards loss of animals. People who have lost milch cows and buffalos will get ₹25,000 per animal. Similarly ₹3,000 will be given for loss of a goat, ₹16,000 for the death of a cow or buffalo calf and ₹50 per poultry bird. Compensation of ₹2,100 will be provided towards construction/ren ovation of damaged cattle shed.

Relief has also been provided for mushroom farmers in the package announced. Cyclone-hit farmers involved in mushroom farming will each get Rs 40,000.

Aid for fishermen who have suffered losses due to the cyclone was also announced. Assistance of ₹4,100 will be given for repair of partially damaged boats and 9,600 for replacement of fully damaged boat. Similarly ₹2,100 will be provided for repair of partially damaged nets, and ₹2,600 for replacement of fully damaged nets.

Further, financial aid of ₹12,200 per hectare will be distributed to the affected fish farmers while input subsidy of ₹8,200 per hectare will be provided for damaged fish seed farms. Under handicrafts and handloom sector, assistance of ₹4.100 per artisan.

Sericulture farmers would get subsidy of ₹4,800 per hectare for Eri, Mulberry, Tussar and ₹6,000 for Muga, the CMO statement said.

₹8L refunded by police to victims of cyber fraud

Bhubaneswar, June 10: Odisha Police have recovered and refunded a total of ₹8.73.580 in the last 10 days to victims of cyber frauds, ADGP Crime Branch, YK Jethwa told reporters Thursday in a press release. He also warned people about the rising incidents of cyber frauds during lockdown and urged victims to immediately contact the cyber cell of Crime Branch through a dedicated toll free number 155260. By immediately reporting the matter, the victims can help police block transactions and also recover the amount fraudulently withdrawn by the cyber criminals, Jethwa informed during a virtual press conference.

Recently, the cyber cell has succeeded in retrieving ₹33,990 of a victim from Jagatsinghpur who lost ₹6.26.000 in three installments to cyber fraudsters. The portion of the money was retrieved from account of the accused from the Canara Bank branch at Gomti Nagar in Lucknow, Jethwa informed.

The ADGP Crime Branch also said Odisha Police have so far collected more than ₹14 crore in fines from approximately 5,00,000 persons for flouting various Covid-related norms across in the state in the last two months. Jethwa revealed that 4.76 lakh persons have been pulled up for violating Covid-19 guidelines in April and May. Approximately 3,500 shops, markets and other institutes that were found flouting Covid guidelines have been sealed by the local police during the same period. The police have arrested 1,332 Covid-19 violators and have seized 29,000 vehicles in the last two months.

Rath Yatra to be held only in Puri

DEVOTEES CAN'T ATTEND FOR SECOND YEAR IN SUCCESSION

Bhubaneswar, June 10: In view of the prevailing Covid-19 situation, the Odisha government announced Thursday that the Rath Yatra festival will only be conducted in Puri and not in any other part of the state. The festival is scheduled to start July 12.

"In larger interests of public health, the annual Rath Yatra will only be conducted at the Jagannath Temple, Puri. It will be sans devotees and curfew will be imposed in the city during the period of the festival as decided by the local authorities," Special Relief Commissioner (SRC), PK Jena said. No other temple in Odisha can organise the festival this year. The festival will be conducted following all Covid-19 norms and Supreme Court guide-lines," he added.

Jena also ruled out the participation of devotees and said only Sevayats with RT-PCR negative reports or those who have got both doses of vaccine can participate in the festival.

As per the Supreme Court's guidelines, a maximum of 500 persons will be allowed to pull each chariot. Those will be pulled by sevayats, police personnel or others permitted by the Jagannath Temple administration. Those who will take part must have tested RT-PCR negative 48 hours before the event or have received both doses of Covid-19 vaccine, Jena informed.

Jena also stated that there will be sufficient gaps between the chariots and social distancing will be implemented strictly. All entry points in Puri town including railway station, bus stand, roads and sea routes will be closed during the festival, the SEC said.

In other temples, rituals relating to Rath Yatra can be performed within its premises. The Information and Public Relation (I&PR) Department will arrange live telecast of the festival for media houses, informed Jena.

This is the second year in succession that the festival will be conducted in Puri

US vax aid for India

Washington, June 10: India will be receiving a share of the 80 million (eight crore) unused Covid-19 vaccines through the UN-backed COVAX global vaccine sharing programme that President Joe Biden has announced, a senior State Department official said here Wednesday.

Biden had announced June 2 that the US will allocate 75 per cent - 1.9 crore of the first tranche of 2.5 crore doses – unused Covid-19 vaccines from its stockpile to countries in South and Southeast Asia as well as Africa.

According to a White House fact sheet, nearly 19 million vaccines will be

shared through COVAX. "I don't have the specific details on when the shipment of vaccines will be arriving in India. All I know that India will be in receipt of a share of those eight crore vaccines," State Department spokesperson Ned Price told reporters at a news conference here Wednesday.

"We know that India has suffered tremendously with this pandemic. As we have done in the case of these vaccines, and even prior to this sharing announcement, we have demonstrated our commitment to work closely with our partners in India to help them see the way out of this epidemic. India is an important ally," Price

Fudged Bihar figures behind record Covid fatalities

1 ₹0.11 New Delhi/Patna, June 10: India **1** ₹0.09 recorded 6,148 deaths in the last 24 hours – the highest since the pandemic hit last year - according to data released Thursday by the Union Health Ministry. This record spike happened as Bihar sharply revised its toll upwards. Bihar's previously unaccounted 3.951 deaths, which has sent its toll soaring above 9,000, is behind this spike. If the state's revised tally is reduced, then the death toll stands at 2,197 across India in the last 24 hours.

The Bihar Health department reported 9.429 deaths due to coronavirus Wednesday evening. It is a jump of 3,951 more deaths compared to a day before. The total deaths in Bihar due to Covid-19 were 5,458 as on Tuesday.

Except for Munger district all the other 37 districts in Bihar revised their death toll. In some of the districts, the figures rose by close to 200 per cent. Patna has registered 2,303 deaths which is the highest in Bihar followed bv Muzaffarpur (609) and Begusarai (316).

The Bihar government undertook a 20-day exercise to audit Covid-19 deaths after the Patna High Court flagged irregularities in death figures in Buxar district May 17. After verification, the state's Covid-19 cumulative toll

After the mismatch, a senior state Health Department official said that the matter is under investigation. "These deaths occurred 15 days ago and were only uploaded now in the government portal. Action will be taken against some of the private hospitals," a Health department official was quoted as saving by 'Reuters'. The official attributed these fatalities to private hospitals and

Bihar Health Minister Mangal Pandey said Thursday the government has been working on revising the Covid-19 death toll for the past few weeks after it came to know from various sources that the death toll due to Covid-19 could be more in number.

It is not just that the Bihar government has mismatched data about the fatalities. It reported 7.01.234 recoveries from Covid-19 infection Tuesday while it published 6,98,397 recoveries a day later. The recovery rate Tuesday was shown at 98.7 per cent while Wednesday it was 97.65 per cent.

The revision exercise has resulted in a 72.8 per cent increase in the Bihar's Covid-19 toll. The fatalities have been attributed to private hospitals and homes. Following the revision, Bihar's Covid-19 death toll almost doubled from 5,458 to 9,429.

gurated June 27, July 19, July 20 and July 21 respectively, it was learnt. The participants can send their short films


and poems by logging into the festival website www.jbseec.com. Jagannath Pani, the head of the events

and Culture Minister Jyoti Prakash Panigrahi attended the camp virtually and wished success of the camp and safety_ of the participants.





New Delhi, June 10: The All-India Survey on Higher Education (AISHE) 2019-20 revealed that the college density (colleges per one lakh eligible population in the age group of 18-23 years) in Odisha is 24, which is lower than the national average of 30.

According to the survey, Karnataka tops the list with maximum 59 colleges per one lakh population while Bihar was placed at the bottom with the density of seven.

Odisha has a total of 1,087 colleges as per the survey and it was placed below 20 among 39 states and Union territories in terms of college den-

The average enrolment per college in Odisha is 659. As many as 4.40 lakh students are enrolled in private colleges while 2.68 lakh students are enrolled in government colleges in the state. Similarly,

0.92 lakh of students in Odisha are enrolled in polytechnics.

Significantly, female students have outnumbered male students in M Phill and postgraduate courses. There are 584 females as compared to 419 male students in M Phill and 50,717 females as compared to 47,838 male students at postgraduate level. In total, 5.29 lakh male and 4.65 lakh female students are enrolled at various levels in the state

Odisha has a total of 32 universities comprising 16 state public universities, six private universities, five institutes of national importance, three deemed universities (private), one central university and one state open university.

The survey states that there are 1,043 universities in the country, out of which 396 are privately managed and 420 universities are located in rural areas. There are 17 uni-

2 ECMO machines at AIIMS soon

Bhubaneswar, June 10: The All India Institute of Medical Sciences (AIIMS), Bhubaneswar is all set to get two Extracorporeal Membrane Oxygenation (ECMO) machines to further bolster the healthcare system to treat critically-ill Covid-19 patients.

ILS develops models of nCoV infection using local virus

Bhubaneswar, June 10: Researchers at the Institute of Life Sciences (ILS) here have recently established and characterised hamster models of SARS-CoV-2 infection by using a local virus.

The proteomic studies carried out at ILS show the similarities between SARS-CoV-2 infection in humans and hamsters.

This along with analysis of clinical parameters it has been observed that tissue samples show pathophysiological manifestation of SARS CoV 2 infection similar to that reported earlier in Covid 19 patients.

Among different available animal models, hamsters have so far been widely utilised in SARS-CoV-2 infection studies. The Hamster model of Covid-19 mimics a mild pattern of human disease with full recovery. Realising the importance of these requirements for developing antiviral and vaccine candidates for SARC-COV-2, scientists at ILS Bhubaneswar have established these animal models and a ABSL3 laboratory

This platform at ILS has been established with the support of the Biotechnology Industry Research Assistance Council (BIRAC) under Mission COVID Suraksha.

ILS Director Ajay Parida believes that this animal model and the ABSL3 facility of the institute will contribute to a major role in providing services for the testing

and evaluation of drugs and vaccine candidates for SARS-COV-2. ILS has also established K18-h

ACE2 Transgenic mice colonies which will be complementary to the evaluation efforts, said Dr Parida.

This facility will be operating on a fee-for-service mode or a partnership mode and will be available for use by researchers from academics, industry and start-ups

from India and abroad. The Covid-19 research team of ILS, an autonomous research institute of the Department of Biotechnology, of the Union government provided strong molecular evidence that supports the clinical relevance of this model in Covid-19 research

The findings of this study have recently been published in a prestigious journal, Federation of American Societies for Experimental Biology (FASEB) Journal. The current and prospective users of the ILS platform included NIRRH, Mumbai, IIT Indore, NCBS-InStem, Bangalore, NCL,

Senapati and Dr Gulam Syed. Animal models that closely resemble the pathogenesis of SARS-CoV-2-induced disease in humans are essential for research on disease mechanisms and the evaluation of potential vaccines and antiviral drugs, the study says

Small animals like mice and Syrian hamsters are advantageous to study SARS-CoV-2, as they reproduce faster and faithfully reproduce Covid-19 pathology in humans.

But, the BJP government at the Centre is yet to implement the commission report.

The BJP, on the other hand, attacked both the Congress and the BJD on the MSP issue. BJP leader Pradeep Purohit said, "The Congress party which ruled the country for many years failed to give justice to the farmers. Many were deprived of their rights under the Congress governments at the Centre. The BJD government in the state should implement the MSP hike immediately.

Kendu leaf plucking provides livelihood to 8 lakh jobless

Sambalpur, June 10: Kendu leaf, a minor forest produce known as green diamond, has proved to be leaves of bounty as it is providing livelihood to scores of people who had lost their jobs due to Covid-19 pandemic in this district, a report said.

As many as 8 lakh people who had lost their jobs due to the pandemic have been able to become selfreliant through sale of kendu leaves in this district. Cumulatively, they have been able to earn over ₹166 crore by collecting kendu leaves.

They have been able to earn their livelihood without the state government having to spend a pie to provide them with alternative employment. This has spread cheers among the residents as the minor forest produce has proved to be succour at the time of their distress.

Reports said that Kendu leaf is non-timber forest product and provides livelihood opportunities throughout the year to forest dwellers as well as people living on the fringes of forests. In fact, the government has framed special rules for collection of kendu leaves and providing benefits to those plucking/collecting them.

Moreover, over 20,000 skilled labourers and 18,000 kendu leaf binders will be able to get work in coming days as kendu leaf collection and binding goes on till October. He, however, lamented the imposition of 28 per cent GST on kendu leaves and 28 per cent GST on bidi (locally made cigars) is adversely affecting the bidi business as well as the workers in the state.

Prohibitory orders imposed to prevent illegal mining

Jajpur, June 10: In a bid to prevent illegal stone quarrying and mining activities, the Jajpur district administration Thursday imposed prohibitory orders under Section 144 of CrPC in black granite quarries at Aruha hillock under Dharmasala tehsil, officials said.

The district administration clamped the restrictions after allegations surfaced on operation of mines in Dharmasala tehsil jurisdiction without valid documents and environmental clearance.

Many countries have generous loopholes and exemptions that reduce the effective tax rate to single digits. Even more damaging, global corporations have been able to shift profits to pure tax havens such as the British Virgin

Islands, the Cayman Islands, or Bermuda, without having to move any of their actual operations there. Estimates by Gabriel Zucman of the University of California, Berkeley, reveal that an inordinate share of US corporations' foreign profits are booked in such tax havens, where they employ only a few people.

Leaving questions about administrative feasibility aside, the new agreement might face two opposing objections. Tax-justice advocates will criticize the global minimum of 15% as too low, while many developing countries will decry the global minimum as an unwarranted restriction that will impede their ability to attract investment. The deal struck by the G7 appears to reflect both sets of concerns: the low threshold could assuage developing countries concerns, while the global apportionment of profits will enable high-tax jurisdictions to recoup some of their lost revenues.

Café Scientifique

It sounds a dauntingly highbrow term, but the intention is just the opposite — to demystify science and help people engage with it. The technique is based on the discussion of topical scientific ideas with interested people in determinedly non-academic surroundings. The Cafés sum up their intentions with a maxim, too long to be considered a slogan, "We want people to be as opinionated about science as they are about football". Informal meetings are usually held in cafés or bars; a guest speaker talks briefly on a topic and then leads a discussion. The first Café Scientifique was held in Leeds in 1998, with its name invented by the man who started it, Duncan Dallas. "I was reading the paper's obituary of Marc Sautet, the man who founded the cafés philosophiques in France," he recalls, "and I thought 'I'd like to do that'. But the British don't think philosophy is a real subject, so I opted for science instead." The scheme has extended with the help of funding from the Wellcome Trust from 2001 onwards. Most Cafés are in university towns and cities — the fifteenth, in Bristol, was inaugurated in April 2003.

The impact is reflected in high joblessness at 17.88 per cent, according to Centre for Monitoring Indian Economy (CMIE) May 30. It has risen by three per cent from 14.71 per cent a fortnight earlier. Urban labour force participation also came down to 35.69 per cent from 37 per cent and rural around

5 per cent during the fortnight. The lockdowns causing closure of activities are being stated as prime reasons for the grim situation. The unemployment situation may remain high for about six months amid policy uncertainties and knee-ierk localised lockdowns and administrative highhandedness. Employment situation remains critical almost in all industries FMCG, automobile, informal sectors, hospitality and tourism. In Noida, close to Delhi. eateries and restaurant have shut shops permanently as the owners have lost their reserves.

Thus, the RBI outlook on consumer confidence is a mere indicator of the stark reality. In gross terms it means consumers do not have cash to buy products even if they are in dire need. The indices touching record lows may indicate a graver situation. Both the Current Situation Index (CSI) and the Future Expectation Index fell to an all-time low of 48.5 and 96.4 in the latest RBI consumer survey. The figures a year ago were CSI 63.7 and FEI 97.9, when the lockdown was more severe. These are the lowest since 2012. The wariness is because of the feeling of uncertainty about the future. Whether this would mean grim-

mer future or not is not easy to say. The GDP had contracted 24.4 per cent and 7.4 per cent in the first and second quarters of 2020-21 and grew by 0.5 per cent in the third quarter. But the second wave of LD has hampered recovery. The eight core sector industries in April 2021 slumped to 126.7 (IIP), the lowest since November 2020. It rose to 149.2 in March 2021 as activities started in construction (14.5 per cent) and manufacturing (6.9 per cent). Most others like labour-intensive activities like hotels, transport, entertainment and communication contracted. The Nomura India Business Index fell to 60 on May 23 from 99.3 on February 21.

The RBI report notes that the values of other indices on non-essential items have worsened and are in the negative. In the prevailing situation RBI has drastically cut quarterly projections. Its revised projections are – 18.5 per cent, 7.9 per cent, 7.2 per cent and 6.6 per cent against those expressed in RBI annual statement - 26.2 per cent, 8.3 per cent, 5.4 per cent and 6.2 per cent. This cuts growth to 9.5 per cent. The situation remains fluid, the numbers have come down but the threat of disruption to normal work remains.

Another aspect has been the large unemployment of the tiny daily use goods market reeling under a cash crisis. A large population still is getting food doles

though all beneficiaries of last LD are not included. Large numbers of people lost jobs, including in the IT sector, in the first phase of LD, are still without jobs. Many revivals owing to dwindling of savings may not be easy though the government has announced special loan packages of ₹15000 crore for MSMEs; it is not certain how many would be in a position to avail it.

Another critical aspect has been the repeated displacement of labour. As uncertainties about Covid-19 may continue, the industry may continue to have labour shortage. It would affect production.

It is also linked to global situation. Union Trade Minister Piyush Goyal has put a target of \$400 billion export target this year against \$290 billion last year. But India's trade deficit touched an eightmonth low in May at \$6.3 billion because of fall in imports due to lack of domestic demand. The May exports remained at \$32.2 billion but imports contracted to \$38.5 billion. One reason for import slump is due to rising global prices. The WTO last month said that merchandise trade would continue to increase by 8 per cent, considered a bit more optimistic. The world uncertainty may dent India's trade.

In this situation the rising forex kitty to \$590 billion may not be as rosy as it looks. The RBI does it by various gold and foreign currency management much to the chagrin of the US as it feels that

dollar prices are suppressed. It also needs to be assessed against total external debt, and corporate external commercial borrowings (ECB) and repatriation costs.

The rising figures of FDI, not all, are suspect. The IMF says it is being used for routing black money. According to RBI, large percentage of the FDI \$ 20110 million came from Mauritius and Singapore and a mere \$3,401 million from the US. It is to be noted that Singapore comprised a mere 0.42 per cent of world economy and the US 24.42 per cent. This is not considered a quality FDI but projects a larger than life picture through virtual inbreeding. It calls for a proper scrutiny of large

net-worth groups. Globally, phantom FDI investments amount to an astonishing \$5 trillion. India is also a part of it. Such siphoning and rerouting of investments affect the basic economic conditions and increases disparity. Whether this should be linked to increasing hunger and poverty in the country or not is a moot question. It is sometimes believed that 80 crore people are on food dole for this kind of inversion.

The lack of consumer confidence and purchasing power emanates from such operations. Ignoring it for long is never desirable. It is a bubble but if it bursts there could be social trouble. Cosmetic promises and doles cannot contain it for long.

Disaster on Sri Lankan coast

AN ENVIRONMENTAL **DISASTER IS LOOMING LARGE ON** THE SRI LANKAN **COAST AS A CHEMICAL-LADEN CARGO SHIP, RAVAGED BY FIRE,** IS SINKING IN **SEA WATERS**

n environmental disaster is looming large on the Sri Lankan coast as a chemical-laden cargo ship, ravaged by fire, is sinking in sea waters not far from the Colombo coast in a worst ever marine mishap threatening the country. The ship was carrying 1,500 containers filled with chemicals, including 25 metric tons of nitric acid. Waves of plastic wastes are washing up on the shore and navy sailors were deployed to clean the beaches of the plastic pellets as smoke billowed out from the burning and the sinking ship. There is also a danger of oil leak into the sea from the tank of the ship containing 350 metric tons of oil threatening an oil spill. Sri Lanka's Marine Environment Protection Authority (MEPA) said in a statement that the micro-plastic pollution of the containers could cause years of untold ecological damage to the fragile ecosystem of the island nation.

The environmental impacts of the disaster are terrible! The ef-

fect of oil spill on the environment and biological habitats is catastrophic as it can kill plants and animals and also disturb the various parameters of the sea waters including salinity and pH levels and altering the food chain of the marine ecosystem. When an oil slick from a large spill reaches a beach, the oil coats and clings to every surface of the beach including rocks and grains of sand. If the oil washes away into the coastal marshes and wetlands like the mangrove forests, fibrous plants and grasses absorb oil which can damage their cells and make the area unsuitable as a wildlife habitat.

The greatest victims of the oil slick are, however, the aquatic birds, marine mammals and fishes. Oil coats the feathers of the aquatic birds reducing their ability to fly and get air-borne escaping from the predators. Oil spills also kill mammals such as whales, dolphins, seals, and sea otters. Oil can clog blow-holes of whales and dolphins

making it impossible for them to breathe properly and disrupting their ability to communicate Oil coats furs of otters and seals leaving them vulnerable to hypothermia. Oil spills often take a deadly toll on fish, shellfish, and other marine life population particularly if many fish eggs or larvae are exposed to oil.

Apart from the environmental impacts, the economic impacts of the oil spill are also immense. The impact has started to be felt in the lives and livelihoods of the fishing community of coastal Sri Lanka and the fishing industry of the country. The ship is sinking in a rich fishing area prompting the government to suspend the fishing activity along a 50-mile stretch of the coastline. Fishing, which is the primary source of livelihood in coastal towns of the island nation, has been hit harder as a result of the incident with people refusing to buy chemical coated fish.

The severity of the oil spill to the marine ecosystem can be ap-

preciated from the fact that the Exxon Valdez oil spill incident in Alaska on March 29, 1989 killed as many as 250,000 sea birds, 2,800 sea otters, 300 harbour seals and up to 22 killer whales. In the years that followed, scientists noted higher death rates among sea otters and other species affected by the spill and stunted growth or other biological damages among additional species. The spill destroyed billions of salmon and herring eggs. Fisheries impacted by the Exxon Valdez were so huge that it took over three decades to

recover. The greatest concern of the Sri Lankan disaster is, however, the fact that while the environment impacts of the oil spill on the ecosystem has been fairly studied, the chemical pollution, resulting out of that, has hardly been evaluated and documented.

Initiating a suo motu PIL on the ssue, a division bench comprising Acting Chief Justice Rajesh Bindal and Justice Arijit Banerjee directed that reasons for delay in filing of charge-sheets and details of officers who are sitting tight over the files and not granting sanction for prosecution be submitted to the court.

The Registrar General of this Court is being directed to collect information from all the courts in the state of West Bengal as regards the cases in which the charge sheets have not been filed in court within the time permissible in law, the bench ordered Wednesday.

The information be placed before the court before the next date of hearing in a tabulated form, district wise, the bench said, fixing the PIL for further hearing June 28.

The Acting Chief Justice, after having perused information provided by the state Criminal Investigation Department (CID) in reference to an order of the Jalpaiguri Circuit Bench, stated that the matter be taken on judicial side as a PIL

The court further noted that as per the information received from the CID there are 999 cases where charge-sheets had not been filed within the time permitted in different statutes, with some of being more than a decade old.

Record litchi production of 15K MT in Malda this yr

Malda (WB), June 10: Litchi district are set to witness a record production of about 15,000 metric tonne this year due to favourable weather condition and adequate rainfall, an official said Thursday.

Last year, the production of the summer fruit was around 12.000 metric tonne, the district horticulture department's deputy director Krishnendu Nandan said.

Litchi has been cultivated around 1,420 hectare of land this year, up from the coverage of 1,380 hectare in 2020, he said, adding that no major damage to the fruit due to nor'wester or hailstorms and pest attack was reported this season.

We see the area under litchi cultivation in Malda is growing by around 40-50 hectare every year. The summer fruit is mostly produced in Kaliachak and Ratua areas. Farmers have started harvesting the fruit and are expected to get a better price this time, Nandan told PTI.

However, farmers are apprehensive of making good profits as Covid-related restrictions in several states, could affect the transport of



the summer crop to other parts of West Bengal and neighbouring states such as Bihar and Jharkhand.

Last year, we had a bumper production, but could not fetch a remunerative price due to the coronavirus pandemic. This time too. Covid-restrictions are there. Big traders are not able to visit us, and there could be transport issues, a litchi farmer said.

Countering the farmers' appre hension, the official said litchi is being sold around ₹70-80 a kg in Malda markets, while the same is available at ₹120-150 in South Bengal districts.

According to market estimates, Malda's litchi growers could fetch a margin of around ₹10-20 per kg more than last year, Nandan said.

Century old seaside Sunderban retreat lost to Yaas

Fraserganj (WB), June 10: More than a century-old seaside retreat on the southern edge of the tigerinfested Sunderbans, where India's colonial rulers once wined and dined to the sound of orchestra music, has been swallowed by the hungry waves which lashed onto the beaches and forests when cyclone Yaas hit last month.

A few broken portions of brick walls defended by Mangrove roots which desperately cling to it are all that remain of the Fraserganj residence- a spacious bungalow built by Sir Andrew Fraser, lieutenant governor of Bengal between 1903 and 1908- where India's high society including the likes of Viceroy Lord George Curzon once danced away their nights to the sound of laughter of their ladies and tinkling of wine glasses, as live orchestras shipped down from Kolkata

played in attendance. The historical bungalow which

served as a retreat where the rulers of Bengal entertained the high and mighty could not withstand the might of the storm surge the cyclone brought May 26, Namkhana Block Development Officer (BDO) Santanu Singha Thakur said. Sir Andrew Fraser had finished

part of his planned retreat which boasted of a ballroom and a bar for the entertainment of the then capital of India's high society, said Debisankar Middya, an archaeologist specialising in coastal Bengal.

Fraser, born in the then Bombay Presidency in 1848 had joined the Indian Civil Service in 1871. He spotted the beach at Narayantala, and decided it was the ideal location for his retreat and probably started building the bungalow before he became the lieutenant governor, the top job in Bengal province, which then included Bihar, Odisha, modern Bangladesh, Assam and Meghalaya, besides West Bengal.

Middya told PTI that a golf course had also been laid out by Fraser



close to the bungalow. I had seen a remnant of the golf course during a visit, he said.

The sea and the weather over the years, had already started eroding parts of the historical residence probably built in 1901-02 on the highest dune in the area. The twin blows from Cyclone Amphan

which hit the state last year and Yaas which hit the area last month, dealt the final blow to Fraser's bungalow.

Only a bathroom is still standing, Thakur said. Bricks that had been dislodged from the broken walls were strewn on the ground.

The bungalow once also had a

museum in which stuffed carcasses of hunted animals were probably on display, Middya said.

The archeologist said that Fraser had a larger plan to develop the area, referred to as Mecklenberg Island in contemporary Admiralty charts, and had cleared jungles in most parts of it, constructed roads and embankments, besides trying to set up a post-office and a school

There was also a plan to develop the area as a health resort for the English elite who ruled India.

However, the administration had to abandon the idea due to the huge cost involved in the project, failure to get farmers to settle in the locality and resistance by a small community of local fishermen.

The area later came to be known as Fraserganj after the lieutenant governor, but with the sea and high tides lapping hungrily at it, it is difficult to predict for how long even the remains of Fraser's dream retreat will stand.

'Muzrai dept grants only for Hindu institutions, temples'

Bangalore, June 10: Karnataka Muzrai Minister Kota Sreenivasa Poojary has instructed the Hindu Religious Institutions and Charitable Endowments Department not to allocate its tasdik grants to non-Hindu religious

institutions. The Minister said the grants from the endowments department will only be spent on Hindu temples and institutions, and appropriate instructions have been given in this regard.

This was following concerns expressed by a section of the religious leaders that the funds under the department were being diverted to non-Hindu institutions

I hereby clarify that out of 34,500 Hindu temples in Karnataka, 27,000 temples are released ₹48,000 (each) annually, totalling up to about ₹133 crore as tasdik grants. Other than this, religious centres that have lost land during land reforms are released other allowances, Poojary said in a video statement.

He said, on getting to know about widespread criticism, he got a report from the commissioner of the department, according to which out of 27,000 temples, 764 non-Hindu religious institutions and temples were receiving tasdik annually and 111 of them are also getting other allowance.

As per law, the grant given by the endowment department can only be spent on Hindu religious institutions. So I have instructed the officials that, here on, the grants from the department should only be spent

for Hindu temples, Poojary said. The Endowment Commissioner, following his instructions, has written to the Chief Secretary and an order will be issued in a couple of days, he further said, adding that non-Hindu religious institutions canobtain grants from other departments like the Minorities Welfare.

India's vax policy leading to avertable deaths: Experts

New Delhi/London, June 10: The Indian government's Covid-19 vaccination approach has inappropriately prioritised people and is thus causing huge numbers of avertable deaths, warn a team of nine experts from research institutes in the UK and India.

The government's current approach to vaccination -- focusing on younger age groups -- "is causing huge numbers of avertable deaths and is deeply inequitable, both between age groups and within them", argue doctors and researchers in a commentary published in British medical journal fro BMJ Wednesday.

From May 3 to June 5, 2021, more first doses were administered to people under 45 than over 60, even though at least 77 million people aged

60 remain unvaccinated, they wrote. They urged the government to take a more targeted approach and

reallocate available doses to older people, especially in more deprived areas. India's vaccination programme began, in January 2021, with health professionals and "frontline workers." In March, it was ex-

tended to people aged 60 or over and those aged 45 or over with comorbidities, and in April to anyone aged 45 or over. From May 1, vaccine entitlement was extended to all people aged 18 or over, although people under 45 had to pay.

Earlier this week, Prime Minister Narendra announced that vaccines would now also be free for people aged 18-45. But, authors suggest it is likely to increase the focus of vaccination on people in this young age group, rather than those aged

"In practice, access to Covid-19 vaccination is mainly determined by socioeconomic status, with very low coverage in rural areas and among disadvantaged urban populations," they wrote. "As a result, Indians of all ages are increasingly resorting to private purchases, and the country's minimal pension system makes this especially unaffordable for older people," they added.

There is also no special provision to facilitate vaccine access for adults with impaired mobility, they said, adding that older people are less familiar with the digital tech-

nology that is required to make a booking for taking the jab. The concern was also voiced by World Health Organisation Director General Tedros Adhanom Ghebreyesus. "There is a disturbing narrative in some countries that it's OK if older people die. It's

"It is important that everywhere older people are prioritised for vaccination. Those most at risk of severe disease and death from Covid-19, including health workers and older people, must come first. And they must come first everywhere, he added, in a recent statement.

While some Indian states have reallocated available doses to older people, the researchers urged the Central government to do the same until all elderly people in India receive at least one dose.

Woman, 5 daughters jump to death before speeding train

Raipur, June 10: A woman and her five daughters allegedly committed suicide by jumping in front of a moving train apparently after a domestic dispute in Chhattisgarh's Mahasamund district, police said Thursday.

As per preliminary information, Uma Sahu (45), a native of Bemcha village, had a quarrel with her husband Wednesday. After the tiff, the woman along with her daughters - Annapurna (18), Yashoda (16), Bhumika (14), Kumkum (12) and Tulsi (10) - rushed to the railway tracks, located around 1.5 km from their village, and took the extreme step, Mahasamund's Additional Superintendent of Police Megha Tembhurkar Sahu told PTL

PM to attend outreach sessions of G7 summit

New Delhi, June 10: Prime Minister Narendra Modi will participate virtually in the outreach sessions of the G7 summit June 12and 13, the Ministry of External Affairs (MEA) said Thursday.

This is the second time Modi will participate in a G7 meeting. India was invited by France in its capacity as G7 presidency to the Biarritz summit in 2019 as a 'Goodwill Partner' and he participated in the sessions on 'Climate, Biodiversity and Oceans' and 'Digital Transformation'.

Last month, the MEA said Modi will not travel to the UK to attend the summit of the G7 grouping in view of the prevailing coronavirus situation in the country.

The Group of Seven (G7) comprises the UK, Canada, France, Germany, Italy, Japan and the US. As chair of G7, the UK has invited India, Australia, South Korea, South Africa to the summit as Guest countries.

"At the invitation of UK Prime Minister Boris Johnson, Prime Minister Narendra Modi will participate in the outreach sessions of the G7 summit June 12 and 13 in virtual format," MEA spokesperson Arindam Bagchi said



He said the theme for the summit is 'Build Back Better' and the UK has outlined four priority areas for its presidency of the powerful grouping. "These are leading the global recovery from coronavirus while strengthening resilience against future pandemics; promoting future prosperity by championing free and fair trade; tackling climate change and preserving the planet's biodiversity; and championing shared values and open societies," Bagchi said.

He said the leaders are expected to exchange views on the way forward on global recovery from the pandemic with a focus on health and climate change.

Last month, External Affairs Minister S Jaishankar travelled to London to participate in the G7 foreign ministers' meeting. However, he could not attend the meeting in person after two members of his delegation tested positive for Covid-19. The external affairs minister attended the meeting in virPRESS TRUST OF INDIA

New Delhi, June 10: India Thursday once again called for completion of the disengagement process at the remaining friction points in eastern Ladakh to pave the way for both the Indian and Chinese troops to consider de-escalation and ensure full restoration of peace and tranquillity in border areas. At a media briefing, External

Affairs Ministry spokesperson Arindam Bagchi, referring to the last rounds of military and diplomatic talks, said both sides agreed on the need to resolve the outstanding issues in an expeditious manner in accordance with the existing agreements and protocols. "We have repeatedly stressed that completion of disengagement in other areas would pave the way for the two sides to consider deescalation of forces and ensure full restoration of peace and tranquillity and enable progress in bilateral relations," he said. Bagchi was replying to a question on the status of the talks between the two sides on the border standoff.

The 11th round of Corps Commander-level talks was held on April 9 while the last edition of diplomatic negotiations under the framework of the Working



Mechanism for Consultation and Coordination (WMCC) on border affairs took place March 12.

"During these meetings, both sides agreed on the need to resolve the outstanding issues in an expeditious manner in accordance with the existing agreements and protocols," Bagchi said.

India and China are locked in a military standoff at multiple friction points in eastern Ladakh since early May last year. However, the two sides completed the withdrawal of troops and weapons from the North and South banks of Pangong lake in February following a series of military and diplomatic talks. The two sides are now engaged in talks to extend the disengagement process to the remaining friction points.

There was no visible fo

movement in disengagement of troops at the remaining friction points as the Chinese side did not show flexibility in their approach towards this end at the 11th round of military talks. Last month, Army Chief Gen MM Narayane said there can be no de-escalation without complete disengagement at all friction points in eastern Ladakh and that the Indian Army is prepared for all contingencies in the region.

Gen Naravane also said that India is dealing with China in a "firm" and "non-escalatory" manner to ensure the sanctity of its claims in eastern Ladakh, and that it was even open to initiating confidence-building measures India has been insisting on complete disengagement at the remaining friction points to de-escalate the situation in eastern Ladakh.

Ramdev will take Covid jab

ASARAM BAPU RAPE CASE

Victim's father moves Top Court

New Delhi, June 10: Apprehending threat to the life of family members, father of the child rape-victim has moved the Supreme Court Thursday opposing the bail plea of self-styled godman Asharam Bapu.

The application for intervention has been filed in the pending petition of Asharam in which he has sought suspension of his sentence and interim bail to undergo treatment for various ailments at an ayurvedic centre near Haridwar in Uttarakhand.

A Jodhpur court, April 25, 2018, had sentenced Asharam to life in prison after finding him guilty of raping a teenage girl in his ashram in 2013. "It is humbly submitted that the petitioner (Asharam) is highly influential and politically

connected and has a force of millions of blind followers around the country and also a hired killer Kartik Haldar who killed and attacked evewitnesses confessed to the Police that Petitioner ordered the killings," the father of rape survivor said in the application.

He said that till now 10 eyewitnesses have been attacked and in all likelihood if Asharam is granted bail he may organise revenge killing of the child rape victim and her family and eyewitnesses of case pending at Surat, Gujarat.

"Recently also, the applicant herein has been threatened by the followers/ henchmen of the petitioner (Asharam) and shockingly the State of Uttar Pradesh has reduced the security of the applicant and his family and they are again very vulnerable to murderous attacks by the followers/henchmen of the petitioner," the appli-

cation said. The plea filed through advocate Utsav Bains said that in case Asharam is admitted to interim bail, there is likelihood that out of vengeance, he may get the applicant, his daughter and his family members killed. "The petitioner (Asharam) herein has no regard to the rule of law and indulged in getting the prosecution witnesses threatened or eliminated who stood against him. And the Petitioner in all likelihood would do the same and with greater impunity and ease when granted bail and is out of Jail. It is humbly submitted that the petitioner herein does not deserve any leniency and his bail application is liable to be dismissed,' the plea said.

Muslim man conceals and takes care of Hindu wife for 10 yrs

Thiruvananthapuram, June 10: "Love is blind" goes the old saying and it happened in Kerala's sleepy village in Palakkad, where a Muslim man looked after and concealed his Hindu wife for a decade.

She was tucked away inside his room for 10 years, without getting noticed by anyone including the latter's parents and his mentally chal-

lenged sister. Speaking to IANS, Deepukumar, SHO, Nenmara Police station, the investigating officer in the case, said that nobody at first believed what happened in that village, but

that was the truth "There were two 'missing' cases registered in this police station. One was registered 10 years back, when 18-year-old Sajitha was reported missing and the other was in March this year, when 34-yearold Rahman had gone missing," said Deepukumar.

Things began to unfurl when Rahman was spotted by his brother on Tuesday and soon he alerted the police, and later the mystery was unravelled.

The police have also found that the couple had shifted from his house to a rented house in another place, three months back and were living alone. "Rahman was in love with Sajitha

and 10 years back she came to his

room. It's a tiled three-room house,

where Rahman was living with his parents and mentally chal-

lenged sister. During the day, Rahman's parents used to go out for

work, and he used to keep his room

'After we took both of them to his house where they had lived for 10 years, they told us how they had used the window of the house as a door to go out of the room in the night to buy essentials for the

woman," added Deepukumar. "Later, we took them before the Magistrate and the woman said that she wants to live with her husband to which the court agreed and she was allowed to go with him. We have now closed the cases," said the SHO. Rahman told the media that he feared his parents might not like his relation with Sajitha, so he had to resort to this. "On and off I used to go for work, but I always made it a point to return by early evening. I am engaged in electrical work,

added Rahman. Expressing happiness, Sajitha said now she feels her ordeal is over. "When he used to go out for work. I spent my time watching TV using headphones. When he went for work, he used to keep food for me in the room. Now after the intervention of the police, I feel I am free. My parents are also happy," said Sajitha. Sajitha's father said they are extremely happy that they have found their daughter.

"We felt she had died. We never would have had any problem if she wanted to live with him. Now everything is over and we are all happy," said her father.

HC refuses to stay release of films 12 killed in building collapse

Mumbai, June 10: At least 12 people, including eight children, were killed and seven others injured after two floors of a threestorey residential building collapsed on an adjoining single-storey house in Malwani in suburban Mumbai, officials said Thursday.

One person died in a separate incident of house crash at Dahisar, a western suburb of Mumbai, Thursday evening, civic officials said. Nine members of a family were among the deceased in the first incident which took place around 11.15 pm Wednesday, when Mumbai experienced heavy rains throughout the day, at the New Collector Compound on Abdul Hamid Road in the Malwani area of

suburban Malad, the officials said. The ill-fated building was constructed illegally and had suffered damage in cyclone Tauktae, which passed close to the Mumbai coast

last month, police said, adding its contractor has been arrested on culpable homicide charge.

The Maharashtra government announced an ex-gratia of Rs five lakh each to the kin of those who lost their lives in the house collapse at Malwani, while the Centre will give an additional Rs 2 lakh exgratia to them. While earlier civic officials said a single-storey house had collapsed, they later clarified it was a three-storey building. The second and third floors of the threestorey building collapsed on the adjoining single-storey house, said Santosh Dhonde, acting ward officer of the city's P-North ward. Fire brigade and other agen-

cies immediately rushed to the spot and started a search and rescue operation, the official from the Brihanmumbai Municipal Corporation (BMC) said. Eight children and four adults, including a 60-year-old man, died, he said, adding that most of the deceased were from two families. Seven others were injured and the condition of one of them was critical, he said.

People rescued from under the debris were taken to nearby hospitals, he added. The civic body said of the 12 people who died, nine were from a single family. As per the BMC, the collapsed building was located on collector's land and its owner got permission from the collector's office while constructing a permanent structure.

FIR registered after students break into **JNU library**

New Delhi, June 10: The Jawaharlal Nehru University administration Thursday alleged that a group of students broke into the central library and clashed with the staff there following which an FIR has been registered with the police.

The varsity alleged that the students have been occupying the library for the last two days.

The students' union, however, accused the varsity administration of using criminal intimidation against students and demanded that they withdraw the FIR and reopen the library which has been closed for a long time.

According to the police, the incident took place June 8 and based on a complaint from the varsity's chief security officer, a case was registered Wednesday.

Deputy Commissioner of Police (Southwest) Ingit Pratap Singh said "Based on the complaint, a case was registered under section 188 (disobedience to order duly promulgated by public servant) of the Indian Penal Code, Delhi Disaster Management Act and prevention of damage to public property." No arrests have been made in the case so far, police said, adding that a meeting between the stu-



dents and chief librarian of the varsity was also held in this regard. In a statement, the varsity said. "This (incident) has caused health risk for the library staff and even other students residing in the hostels, since these unruly students return to hostel for lunch/dinner or other purposes.

It added that the students did not vacate the library building even during the night.

Cong disconnected from people: Jitin

PRASADA DIDN'T PUT BLAME ON ANY INDIVIDUAL WITHIN THE CONGRESS FOR HIS DEPARTURE

New Delhi, June 10: A day after switching over to the BJP, Jitin Prasada Thursday said he left the Congress not because of any individual or for any post, but due to its shrinking vote base and the "rising disconnect" between the party and the people of Uttar Pradesh.

Prasada, whose family had been associated with the party for three generations and who himself had served as a Union minister in the Congress-led UPA government, joined the BJP Wednesday, terming it the "only true national party" in the country.



'I left the Congress not due to any individual or for any post. The reason I left the Congress was because there is a rising disconnect between the party and the people. And that is the reason, its vote share is shrinking in Uttar Pradesh and there is no plan to revive the party," Prasada said. He was among the group of 23 Congress leaders who had written

to party president Sonia Gandhi last October seeking an organisational overhaul, triggering a storm within the party. Claiming that he could not protect his people's interests while being in the Congress, Prasada said, he will achieve this in the BJP, which he described as the only institution alised national party in the country.

"It (joining the BJP) was not a sudden decision," he said. "I have taken this decision after long discussions and deliberations. I want to serve people, work for them and in the BJP, under the leadership of Prime Minister Narendra Modi, I would be able to do that." Talking about his future plans, Prasada said he will work to strengthen the BJP and for

the welfare of his state. "Whatever I do, wherever I will be, I will work for my people, for my state Uttar Pradesh and for my country," he said. The 47-year-old former Union minister, who comes from a wellknown Brahmin family of Uttar Pradesh, has refrained from at tacking the Congress leadership.

Jitin is son of Jitendra Prasada, a key Congress leader before his fortunes plunged following his decision to contest against Sonia Gandhi for the post of party president in 2000. His joining the BJP may help him politically at a time when the saffron party is working overtime to boost its ranks in preparation for the assembly polls.

Vista challenged in SC

HC order on Central

New Delhi, June 10: A plea has been filed in the Supreme Court, challenging the Delhi High Court's judgement declining to stop the construction activity at the Central Vista Redevelopment project amid the second wave of Covid-19 pandemic, and imposing ₹1 lakh cost on the petitioners.

Petitioners Anya Malhotra, a translator, and Sohail Hashmi. a historian and documentary filmmaker, claimed the High Court judgment, apart from misconstruing their bonafide intentions, without cause ,cast them in negative light, as it dismissed their plea on the face

value without any inquiry. The petitioners have argued that their plea was a purely public health and safety issue during the catastrophic Covid second wave, which ravaged the capital and exposed its crumbling health infrastructure. But the High Court con-

strued it as an attack on the project. The plea argued that the ongoing construction activity has the potential of being a super spreader activity, on the account of to-and-fro movement of the workers from the site to their accommodation, located in various parts of the city, poses a grave risk to the health and safety of workers and the residents of Delhi.

New Delhi, June 10: Cyber-security researchers in India Thursday said they have discovered a malicious free gift campaign pretending to be an offer from Tata Motors that is collecting users' data, and the campaign has been traced to China-based hackers.

The research wing of New Delhibased CyberPeace Foundation received some links via WhatsApp, related to a free gift offer from Tata Motors, collecting browser and system information as well as the cookie data from the users.

'The campaign is pretended to be an offer from Tata Motors but hosted on the third-party domain instead of the official website of Tata Motors which makes it more suspicious," the research team said in a statement.

If any user opens the link from a device like smartphones where WhatsApp application is installed, the sharing features on the site will open the WhatsApp application on the device to share the link.

'The prizes are kept really attractive to lure the laymen," the team said. The title of the fake website is "Tata Motors Cars, Celebrates sales exceeding 30 million." On the landing page, a congratulations message appears with an attractive photo of a Tata Safari car and asks users to participate in a quick survey to get a free TATA



"Also, at the bottom of this page, a section comes up which seems to be a Facebook comment section where many users have commented about how the offer is beneficial,"

the research revealed.


After Clicking the OK button, users are given three attempts to win the prize. After completing all the attempts, it says that the user has won 'TATA SAFARI'.

"Congratulations! You did it! You won the TATA SAFARI!" Clicking on the 'OK' button, it then instructs users to share the campaign on WhatsApp.

The user then has to click the WhatsApp button in order to complete the progress bar. After clicking on the green 'Complete registration' button, it redirects the user to multiple advertisements webpages, and it varies each time the user clicks on the button.

According to the researchers, cybercriminals used Cloudflare technologies to mask the real IP addresses of the front-end domain names used in the free gifts from Tata Motors campaign. "But during the phases of investigation, we have identified a domain name that was requested in the background and has been traced as belonging to China," the researchers revealed.

CyberPeace Foundation, a think tank and grassroot NGO of cyber security and policy experts, along with Autobot Infosec Private Limited looked into this matter to realise that these websites are online fraud. "The campaign is pretended to be an offer from Tata Motors but hosted on the thirdparty domain instead of the official website of Tata Motors which makes it more suspicious," the Foundation said. The Foundation recommended that people avoidopening such messages sent via social platforms.

Islamabad: Pakistan-occupied Kashmir's top election official announced Thursday to hold the general election for the legislative assembly July 25, despite appeals to postpone the polls for two months due to the threat of resurgence of the coronavirus. India had slammed Pakistan for its decision to hold elections in Gilgit-Baltistan and said any action to alter the status of the militarily-occupied region has no legal basis.

Junta plane crash leaves 12 dead

Nay Pyi Taw: At least 12 military aircraft crashed in Myanmar, according to a fire brigade spokesperson Thursday. The accident occurred near the central city of Mandalay, the spokesperson told dpa news agency. The weather conditions were very bad, according to local news reports. Soldiers and Buddhist monks were on board. The monks had been due to take part in a religious ceremony, the reports said.

Japan okays plan to lift emergency

Tokyo: The Japanese government's expert coronavirus advisory panel Thursday approved a plan to lift the quasi-state of emergency in three prefectures Sunday as scheduled. Public broadcaster NHK said the quasi-state of emergency measures in place for Gunma Ishikawa and Kumamoto prefectures are set to end Sunday, reports Xinhua news agency. The three prefectures have been under the restrictions since May 16.

4-month prison for **slapping Macron**

Valence: A 28-year-old Frenchman who described himself as a right-wing or extreme-right "patriot" was sentenced to four months in prison Thursday for slapping President Emmanuel Macron in the face. Damien Tarel was also banned from ever holding public office in France and from owning weapons for five years over the swipe Tuesday. During Thursday's trial, Tarel testified that the attack was impulsive and unplanned, and prompted by anger at France's "decline."

China sustains 'artificial sun' at record 120mn C

The temperature at the core of the sun is widely believed to be 15 million degrees Celsius, meaning that the plasma at the device's core will be seven times hotter than that of the sun



Beijing, June 10: China's "artificial sun" recently broke the world record as achieved a plasma temperature of 120 million Celsius for 101 seconds and 160 million Celsius for 20 seconds, setting new records in the field of nuclear fusion, media reports said.

The experiment was achieved by Experimental Advanced Superconducting Tokamak (EAST)

Academy of Sciences, the Global Times reported. EAST is part of the International Thermonuclear Experimental Reactor (ITER) facility -- a collaboration of 35 nations, also comprising India

EAST is designed to replicate the nuclear fusion process that occurs naturally in the sun and stars to provide almost infinite clean energy through controlled nuclear fusion, which is often dubbed the "artificial sun."



onds. "The breakthrough is significant progress, and the ultimate goal should be keeping the temperature at a stable level for a long time," Li Miao, director of the Physics Department of the

Southern University of Science and Technology in Shenzhen, was quoted as saying.

The next milestone might be to maintain the stability for a week or more, Li added.

India is one of the seven partners (China, India, Japan, South Korea, Russia, the US, and Europe) both in-kind and in-cash, in a first-of-a-kind collaboration

The project aims to complete through first plasma in 2025, a key milestone toward full fusion power by 2035.

'Suu Kyi charged with corruption'

Nay Pyi Taw, June 10: Myanmar's ousted de facto leader Aung San Suu Kyi has been charged with corruption, the state media reported Thursday.

Suu Kyi's lawyer described the accusations as "absurd" and

Beijing, June 10: China's Parliament Thursday passed the Anti-Foreign Sanctions Law, providing a comprehensive legal cover for blocking foreign sanctions against Chinese officials and entities and protecting them against the long-arm jurisdiction, especially from the US.

The law was passed by the Standing Committee of the National People's Congress (NPC), China's national legislature.

The law was passed in the backdrop of the US and EU countries slapping sanctions against a number of Chinese entities and officials over allegations of human rights violations against Muslim Uyghurs in Xinjiang and the imposition of China's national security law in Hong Kong.

The sanctions were introduced as a coordinated effort by the European Union, UK, US and Canada. China responded with its own sanctions on European officials. Defending the law, Chinese

'Delta variant taking hold in Europe'

Geneva, June 10: The World Health Organisation's Europe director warned that the highly transmissible Covid-19 variant first identified in India is "poised to take hold in the region", as many countries prepare to ease restrictions and allow more social gatherings and travel across borders.

During a press briefing Thursday, WHO's Dr Hans Kluge said the variant also known as the delta variant, has shown signs of being able to evade some vaccines and warned that many vulnerable populations, particularly those over



age 60, remain unprotected. "We have been here before," warned Kluge, WHO's European regional director. "Over the course of last summer, cases gradually rose in vounger age groups and then moved into older age groups, contributing to a devastating resurgence," he said.

Kluge said spike in Covid-19 ultimately led to more lockdowns and deaths in the fall and winter of 2020. "Let's not make that mistake again.

Kluge didn't say people shouldn't travel, but urged any travellers to do so wisely. He also called for vaccination and other public health measures to be stepped up across the continent, saying even immunisation coverage "is far from sufficient to protect the region".

Washington, June 10: A new study has revealed that one in two Indian-Americans have reported being discriminated against in the

past one year. The study titled, 'Social Realities of Indian Americans: Results from the 2020 Indian American Attitudes Survey', was conducted jointly by the Carnegie Endowment for International Peace, Johns Hopkins-SAIS, and the University of

Pennsylvania. Released Wednesday, it is the third in a series on the social, political, and foreign policy attitudes of Indian-Americans.

"One in two Indian Americans reports being discriminated against in the past one year, with discrimination based on skin colour identified as the most common form of bias. Somewhat surprisingly, Indian Americans born in the US are much more likely to report being victims of discrimination than their foreign-born counterparts," the study says.

The findings of the study were based on a nationally representative online survey of 1,200 Indian-American residents in the US. It was conducted between September 1 and September 20, 2020, in partnership with the research and analytics firm YouGov.

The report also found that Indian-Americans exhibit very high rates of marriage within their community. "While eight out of 10 respondents have a spouse or partner of Indian origin, US-born Indian-Americans are four times more likely to have a spouse or partner who is of Indian origin but was born in the US," it said.

The study also revealed that roughly half of all Hindu Indian-Americans identify with a caste

"The overwhelming majority of Hindus with a caste identity, more than eight in 10, self-identify as belonging to the category of General or upper caste."



Meanwhile, partisan polarisation, linked to political preferences both in India and the US, is rife,

within the community "However, this polarisation is asymmetric: Democrats are much

less comfortable having close friends who are Republicans than the converse. The same is true of Congress Party supporters vis-a-vis supporters of the Bharatiya Janata Party (BJP)," says the study.

"Internally, the social networks of Indian-Americans are more homogenous in terms of religion than either Indian region (state) of origin or caste."

The study goes on to say that while only a minority of the respondents were concerned about the importation of political divi-

sions from India to the US. Indian-Americans currently account for the second-largest immigrant group in the US.

As per the latest report, Turkey continues to lead the annual rankings with prices up by 32 per cent year-on-year (YoY), followed by New Zealand (22.1 per cent) and Luxembourg (16.6 per cent).

'Spain was the weakest-performing territory in Q1 2021, where home prices fell by 1.8 per cent YoY, followed by India with -1.6 per cent, Knight Frank said in a statement.

India moved down 12 spots in the global home price index to 55th rank in Q1 2021 against 43rd rank in Q1 2020. Residential prices in India grew 1.4 per cent in January-March 2021 compared with the previous quarter.

The report highlighted that the

United States witnessed the highest annual price growth rate since 2005, with a 13.2 per cent in-

Mainstream residential prices averaged across 56 countries and territories in Q1 2021 grew 7.3 per cent, which records the fastest growth in prices since Q4 2006.

Shishir Baijal, Chairman & Managing Director, Knight Frank India said, "In Q1 2021, India witnessed meaningful recovery in sales volumes, helping housing prices remain stable.

"With the onset of the second wave and the threat of new variants of the virus along with the fluctuation in vaccine rollout there could be a pressure on sales volumes as well as on price growth."

Segment wise, registration of personal vehicles declined by 63.70 per cent on a sequential basis and 58.96 per cent from May 2019 levels to 85,733 units. Similarly, twowheeler registration fell by 52.52 per cent on a sequential basis and 71.08 per cent from May 2019 levels to 4,10,757 units.

Notably, tractor retail sales declined. The segment's off-take fell by 57.85 per cent on a sequential basis and 56.60 per cent from May 2019 levels to 16.616 units.

Agri exports jump

Indian labour market in worst condition since April-May 2020: CMIE

New Delhi, June 10: As employment rate continues to worsen amid the second wave of Covid-19, the Centre for Monitoring Indian Economy (CMIE) has said that the Indian labour market is in its worst condition since April-May last year, when the whole country was under lockdown.

Data published by CMIE showed that the unemployment rate, which reached 11.9 per cent in May 2021, continued to rise during early June. The 30-day moving average unemployment rate as of June 6, 2021, was 13 per cent.

Further, the labour participation rate, that had fallen to 40 per cent, has fallen further to 39.7 per cent and the most important labour market indicator, the employment rate, which had fallen to 35.3 per cent in May, dropped to 34.6 per cent by June 6, 2021. "The Indian labour market is in its worst condition since the nation-wide lockdown months of April and May 2020,

CMIE's CEO Mahesh Vyas said. He noted that the last four weeks have seen a particularly sharp deterioration in labour market conditions.

Vyas, however, said that a quick ecovery of the informal jobs that were lost in the unorganised sectors is expected because of the local lockdowns. But there is also

The total non-farm jobs lost since January 2021 works out to 36.8 million. Of this, daily wage labourers account for 23.1 million. Salaried employees account for 8.5 million and the rest are entrepreneurs, as per CMIE.

It would take a strong recovery of the India economy to recover the remaining jobs or revert to the employment levels of 2019-20, he said.

The unlocking process can be expected to repair about two-thirds of the job losses associated with the lockdown of May 2021," Vyas added.

New Delhi, June 10: India's agriculture exports (including marine_ and plantation products) have beaten the pandemic registering a growth of 17.34 per cent to \$41.25 billion in 2020-21, a top commerce ministry official said Thursday.

Speaking to the media, commerce secretary Anup Wadhawan said that excellent growth of Agri exports in FY21 has come after it remained stagnant for the past three years (\$38.43 billion in 2017-18, \$38.74 billion in 2018-19 and \$35.16 billion 2019-20).

In rupee terms, the increase is 22.62 per cent with exports during 2020-21 amounting to ₹3.05 lakh crore as compared to ₹2.49 lakh crore during 2019-20. India's agricultural and allied imports during 2019-20 were \$20.64 billion, and the corresponding figures for 2020-21 are \$20.67 billion. Despite Covid-19, the balance of trade in agriculture has improved by 42.16% from \$14.51 billion to \$20.58 billion.

For agriculture products (excluding marine and plantation products), the growth is 28.36% with exports of \$29.81 billion in 2020-21 as compared to \$23.23 billion in 2019-20. India has been able to take advantage of the increased demand for staples during the Covid-

Geneva, June 10: A group of 79 company bosses and investors managing \$41 trillion issued separate calls Thursday for world leaders to accelerate action on climate change by enacting more ambitious policies in areas including carbon pricing.

In an open letter to all governments as leaders of the G7 group of industrialised nations meet in Britain, and ahead of a global climate summit in November, the Alliance of CEO Climate Leaders called for "bold action" now to meet

future emissions targets. To force corporate action, governments needed to change the rules of the game, they said, including by developing a market-

based carbon pricing mechanism. Countries should also force all

businesses to establish "credible" decarbonisation targets, plus disclose emissions across all parts of their business, said the CEOs who include Swiss Re's Christian Mumenthaler, Boston Consulting Group's Rich Lesser and Royal DSM's Feike Sijbesma.

The bosses also backed an elimination of fossil fuel subsidies, cuts on tariffs for climate-friendly goods, a boost in research and development funding for green technologies.

A separate statement backed by 457 investors warned governments that those countries to take the lead would become "increasingly attractive" investment destinations, while laggards would find themselves at a competitive disadvantage. Key to that was for countries to
