BHUBANESWAR: Padma Shri awardee environmentalist and Odisha's former information commissioner Professor Radha Mohan died while undergoing treatment at a private hospital here Friday,



family sources said. He was 78 and is survived by three daughters. The Gandhian was in the ICU for the last few days after being diagnosed with pneumonia, hospital sources said. President Ram Nath Kovind, Prime Minister Narendra Modi and Chief Minister Naveen Patnaik were among those who condoled his death. Radha Mohan and his daughter Sabarmatee were conferred the Padma Shri last year for their 30-year-long efforts to transform barren lands into a lush green forests in Nayagarh district. The father-daughter duo had formed a social organisation to create awareness among farmers on sustainable organic farming.

Kochi, June 11: The Kavaratti police have served a notice on leading Lakshadweep film personality Ayesha Sulthana to appear before them June 20, in connection with her remarks made on a Malayalam TV channel about the spread of Covid-19 in the island.

This unfolds amid the already prevailing local sentiments against the new Lakshadweep administrator Praful Khoda Patel. The notice that has been served on Sulthana by Sub Inspector Ameer Bin Mohammed contains charges under 124 A and 153 B of the CrPC, both of which are nonbailable offences. The complaint was registered by Lakshadweep BJP unit president Abdul Khader following the TV channel debate June 7, where she had alleged that the 'Centre used biological weapons for the spread of Covid in Lakshadweep', which according to the complainant

was anti-national.

Sulthana who hails from Chelath Island in Lakshadweep is based here and besides being a model, she has worked in numerous films in Malayalam. Ever since the new administrator took charge, the Congress and the ruling Left, here have been up in arms and have alleged that Patel is trying to implement the Sangh Parivar agenda in the otherwise calm and peace loving island.

Bhubaneswar, June 11: Following the Centre's decision to hike the Minimum Support Price (MSP) for paddy to ₹1940 per quintal, the state government has once again demanded a hike in MSP for paddy to ₹2930 per quintal.

Addressing a press conference here Friday, Agriculture and Farmers **Empowerment Minister** Arun Kumar Sahoo said the Centre has hiked paddy MSP by ₹72 to ₹1,940 per quintal for 2021-22 crop year while the MSP of Grade-A variety has been hiked to ₹1960. This will not help Odisha farmers, especially the marginal and small ones, he said.

Odisha farmers frequently face natural calamities like cyclones, floods, droughts (in some places) and pest attacks. Therefore, it shouldn't be treated like other states. Sahoo said.

Though the state government is taking all welfare measures for the farmers, the Centre is providing the MSP. Therefore, the Centre should increase the MSP of paddy to at least ₹2930 per quintal, the Minister demanded.



Bhubaneswar, June 11: Chief Minister Naveen Patnaik Friday dedicated Covid care equipment worth Rs 25 crore and announced another ₹25 crore package for 11 western Odisha districts.

He dedicated the Covid-19 intervention by Western Odisha Development Council (WODC) and announced another assistance of ₹25 crore to the WODC for Covid-19 management.

The districts to be benefited under this assistance are-Sambalpur, Kalahandi, Bolangir, Bargarh, Nuapada, Jharsuguda, Angul, Boudh, Deogarh, Sonepur and Sundargarh.

Under the ₹25 crore aid that was allocated earlier, various critical care equipment like ventilators, oxygen pipelines, CBC machines, and oximeters have been supplied to the western Odisha districts.

The Chief Minister said this additional financial assistance of ₹25 crore will further strengthen the medical infrastructure in these districts.

Bhubaneswar, June 11: The Higher Education department Friday rejected a request made by the BJB Autonomous College to open a self-financing master's degree course in agri-business management.

The department's Principal Secretary Saswat Mishra in a letter to the college principal said that considering the existing scenario, your proposal for opening a new self-financing (PPP) master's course in agri-business management is hereby rejected. The department advised the college to rather take steps for quality improvement in the existing self-financing courses run by the college with special emphasis on gainful employment of the students completing such courses.

The department also issued directions to other degree colleges in the state to strive for improving the quality of education being imparted in self-financing mode, instead of proposing for introduction of slef-financing courses. Colleges not having any self-financing courses need not open any such courses for now.

In recent times the self-financing courses are not attracting students in a bigger way. Last year, after failing to get the desired response from students and affiliation problems, Sambalpur University

ast year, after failing to get desired response from students and affiliation problems, Sambalpur University had discontinued as many as six self-financing PG courses

had discontinued as many as six selffinancing post-graduate (PG) courses in the academic session 2020-21. The courses are: MBA in Rural Management, MBA in Agri Business, MBA in Financial Management, Nanotechnology, Medical Physics and Sanskrit.

Earlier, the department had asked the principals of all government and aided degree colleges in the state to ensure collection of equal fee for regular subjects. At present, a few colleges have dual mode of fee structure in regular subjects where some seats are filled in self-financing mode. The colleges take normal admission charges as fixed by the government and reserve some seats for self-financing mode to collect more money as admission fee. Sources said huge disparity in fee structure between normal courses and self-financing courses had led to additional burden on some of the students who had to pay more for the same subject in the same college.

Self-financing courses shouldn't be allowed in government and government-aided colleges as it adds burden on the students, said an education activist. The government should regularise all subjects and provide special grant towards remuneration to the faculty to avoid financial burden on students pursuing higher education in these colleges in self-financing mode, sources said.



Cuttack. June 11: The state government has sent 1,569 tankers with 29,158.249 metric tonne (MT) medical oxygen under active surveillance of the state police to at least 17 states facing acute shortage of the life-saving gas in treating Covid-19 patients during the second wave, an official said Friday.

While 125 tankers carrying 2036.562MT oxygen were sent from Angul, 337 tankers carrying 5603.5 MT oxygen left Dhenkanal to states where oxygen is a dire need. As many as 308 tankers were sent from Jajpur with 6285.58 MT of the lifesaving gas and 799 tankers carrying 15232.607 MT of the gas were sent from Rourkela to the needy states.

"Andhra Pradesh received 460 tankers containing 9022.867 MT of oxygen, while 385 tankers reached Telangana with 6850.609 MT of the gas. Tamil Nadu has so far received 239 tankers filled with 4416.418 MT of medical grade oxygen," official sources said.

Haryana, on the other hand, has received 182 tankers filled with 3331.793 MT of oxygen. While Maharashtra received 41 tankers with 660.051 MT of oxygen, 836.711 MT of the life-saving gas filled in 50 tankers have been dispatched to Chhattisgarh.

A special cell, led by ADG (Law & Order) YK Jethwa, has been supervising the transportation of the life-saving gas.

New Delhi, June 11: A team of of ficers from Union Ministry of Rural Development, which visited Odisha in February to inquire about the al legations of irregularities in the implementation of the Pradhan Mantri Aawas Yojana – Gramin (PMAY-G) scheme, observed several instances of indiscretion.

In a letter to the state Chief Secretary, the Union Rural Development Secretary Nagendra Nath Sinha stated that the Central team observed several irregularities during its visit to Odisha and found that PMAY-G logo was missing from houses constructed under the scheme, lack of quality in construction of houses and houses that were shown as completed on AwaasSoft were found to be incomplete during the inspection.

According to the letter, the Central team observed that in some cases houses have been allotted to both father and son. The Union ministry asked the state government to probe such cases and recover the amount released to the beneficiary

The team, which had visited the state from February 9 to 11, also found that some beneficiaries have started construction of houses on government land. The secretary asked the state government to allot suitable land to the beneficiaries and if the state government does not agree to this then it should recover the amount released to the

WOMAN KILLED, 2 CRITICAL IN **ROAD MISHAP**

Youths opting for fish farming amid pandemic

Steep rise in price of iron ore sparks fear of job loss, closure of plants

Jajpur, June 11: Exorbitant rise in price of iron ore six times in a year as well as a drop in the production of the mineral has sparked fears of closure of the steel plants at Kalinganagar in this district and also in some other parts of the state.

According to reports, experts are hopeful that the steel industry will help in recovering the economy which has been hit hard by the Covid-19 pandemic. However, the unusual rise in price of iron ore during last one year and drop in the mineral production has hit the steel plants operating in the state.

The worst hit is the steel plants that do not have their own captive mines. These plants are finding it difficult to purchase iron ore at the enhanced price and run their plants. This has triggered fears of closure of these plants and lay-off among the employees, the report said.

Iron ore production has been 142 million tonnes in the 2019-20 fiscal and it declined to 111 million tonnes in the 2020-21 fiscal. The state has exported 17.4 million tonne of iron in the 2019-20 fiscal while exports increased to 29 million tonnnes in the 2020-21 fiscal. As a result, the shortfall has been 42 million tonnes this year compared to last year. This has led to an exorbitant rise in the price of ores which is now a cause of concern among the steel plants as well as their employees

Reports said that the price of iron ore was Rs 2,200 per tonne in June 2020 while it witnessed a sharp rise next year with the price reaching at Rs 12,000 per tonne in June 2021.



Steel companies like Tata Steel SAIL, JSW Steel, Arcellor Mittal and JSPL who have their own captive mines have produced 65 million tonnes of iron ore out of the total production of 111 million tonnes in the 2020-21 fiscal. The state-owned OMC produced 13 million tonnes, Rungta Mines 10 million tonnes, Essel Mining 6 million tonnes and DR Patnaik 4 million tonnes during the last fiscal. On the other hand, firms like Siraijudin. Foment, Tarna and Vishal LPG. which have acquired mines through auctions, are yet to start produc-

As a result, there has been a shortfall of 44 million tonnes of iron ore sold in the open market through e-auction process. The plants which do have their own captive mines are suffering heavy losses and are buying ores via e-auction process. Recently, steel firms in West Bengal and Chhattisgarh participated in the e-auction floated by the OMC to meet the ore requirement of their plants.

Surprisingly, even the plants having their own captive mines participated in the e-auction. It is alleged that these plants participated in e-auction with an aim to increase the iron ore price. The claim seems to be true as the price of iron ore put up for auction rose to Rs 11,612 per tonne, which is Rs 4,000 more than the price in the last auction.

This has dealt a heavy blow to the steel firms that do not have their own captive mines. In addition, it has severely affected the steel plants like Adhunik Ispat, Concast Ispat and MSP Ispat, NINL, Mesco Steel and Maithan Ispat in the Kalinganagar Industrial Complex. Some of these plants have downed their shutters unable to compete in the market owing to the rise in the price of iron ore.

The members of Kalinganagan Silpa Sangha have demanded before teh Chief Minister, Chief Secreatry and Steel and Mines Secretary to intervene in this matter.

Babus caught in a political bind

he instances of bureaucrats getting caught in the middle of po-litical battles is a growing and dynamic list. Those in the know say that after the Centre recently amended the empanelment policy for IAS officers, young officers fear that their careers will be jeopardized if there is no political consensus between the Centre and the concerned state government.

Under the revised policy, the Centre has made the Central deputation of two years mandatory for IAS officers before they complete the first 16 years of service in their cadre state to be eligible for joint secretary's post in Delhi in the future. This would not be a problem if the Centre and state were ruled by the same party. The problem arises, as in the case of West Bengal, when the Centre and states are ruled by bitter political foes. The babus are caught in a bind. Whether this is an inevitable feature of federalism isn't clear yet, but babu nervousness isn't something that helps with better administration in these perilous times

Home and the world

It's not just the Vice President and the Prime Minister who are getting new residences in Lutyens' Delhi. Though not included in the Central Vista project underway in the heart of the capital, officials, or at least some lucky ones, at the Ministry of External Affairs (MEA) too may get spanking new residences by 2023

The ministry is building 97 stateof-the-art residences in the Gole Market area, known these days mostly for its nondescript and lowcost sarkari housing, into a highpowered diplomatic enclave re-



plete with the modern bells and whistles that matches the lifestyle the IFS mandarins are accustomed to when serving abroad.

Perhaps the residential project is a belated move by the Modi sarkar to signal that it does not ignore the Indian Foreign Service. While in recent years other services have gained ground eroding the exclusivity enjoyed for decades by the IAS club, the IFS is too is now getting its share. A sarkari house in Delhi, as any government babu will tell you, is all about availability and location. The IFS seems to have scored a diplomatic victory on both.

An avoidable fracas

Even as Karnataka grapples with the Covid-19 pandemic, two women IAS officers have stirred up an avoidable controversy, given the current circumstances.

Shilpa Nag, the Mysore corporation commissioner, reportedly resigned from the IAS after accusing her senior, Rohini Sundari Dasari, deputy commissioner of the district, of interfering in her efforts to manage the pandemic. The state government has indicated that Nag's resignation has not been accepted nor will it be. But sources say that Nag has gathered several voices in her support, with other city corporators demanding that Dasari be transferred out. Dasari has denied the allegation and said that she had merely asked Nag to explain the "contradictory data" on Covid-19 from her ward.

It is believed that the root of the dispute between the two senior IAS officers is Dasari's insistence on the deployment of CSR funds for the entire district rather than limiting the funds for managing Covid in the city area only.

Meanwhile, to allow tempers to cool down, the state government has transferred both officers. Dasari will be the new Commissioner of Hindu Religious and Charitable Endowments, while Nag has been named Director of E-governance in Rural Development and Panchayati Raj Department. Sources say that the fracas was wholly avoidable and the disputed issue could have been dealt with within the government without a fuss.

Cryptocurrencies are harmful for the environment because they consume resources like computers and electricity and do not produce tangible goods that could lead to social welfare. They are harmful for the society because they are leading to increase in crime

you too can assemble 100 or 1,000 participants in a hall or a computer network and start your own cryptocurrency. No wonder about 1,500 cryptocurrencies are in existence in the world today. The acceptability of these currencies depends entirely on the number of participants who recognise that currency. Now, if a currency is accepted by sufficiently large numbers of players, then any individual owner is assured that he would be able to sell his Bitcoins and buy, say, a car. In such a situation the banks also recognise these currencies. Many banks across the world accept these currencies though, thankfully, the Reserve Bank of India has not allowed Indian banks to accept them as valid means of payments.

The original idea behind starting cryptocurrencies was that the value of the currencies issued by the governments was controlled by their central banks. You may have hard-earned and deposited ₹1 lakh in a bank. But the government could have increased the inflation and real value of your deposit could be reduced to, say, ₹90,000. Cryptocurrency was made to keep the value of one's money outside the control of the government. Indeed it is true that the value of cryptocurrency is not in the hands of the central banks. However, the computers in which the cryptocurrencies are made and stored are located in some country and are under the control of that government. Most cryptocurrency enthusiasts are located in China. The Chinese government can, therefore, seize the computers and the value of the currency will evaporate in a few minutes.

The intricacy of the Sudoku puzzles increases with every puzzle that is solved. We may now have a Sudoku puzzle of 2,000 lines and 2,000 rows. It would not be possible to solve such puzzles manually. Therefore, Bitcoin enthusiasts have established "factories" to solve these puzzles. Large computers are installed in these factories that try to solve the most complicated Sudoku puzzles set by the master computer. They consume huge amounts of electricity in the process. These "business persons" make investment in computers and electricity and get returns in the Bitcoins that they win. The manufacture of Bitcoins uses electricity just as the Reserve Bank of India uses paper and ink to print notes. The first problem with cryptocurrencies, therefore, is the huge use of electricity – which is a burden on our environment. We are using electricity to solve puzzles that have no tangible use.

The cryptocurrency is only a number though a very complicated one. Incidents have taken place that an owner's computer crashed and the cryptocurrency number stored in it was lost for ever. The Bitcoin was extinguished and the owner was put to loss as if he lost a diamond on the street. Hackers have also entered the owner's computer and stolen the number and became the owner of the Bitcoin.

Most importantly, today criminals are seeking payments in cryptocurrencies. Recently the computers of the United States' Colonial Oil Company were hacked. The hackers introduced a malware in the computer that could only be removed by the hackers.

The company had to pay \$5 million or about ₹40 crores in ransom to keep its pipelines running. Reportedly, the US government has recovered one-half of the ransom. It is not clear how the recovery was made. Be that as it may, in the main, the ransom paid in cryptocurrency does not leave a visible trail of bank transactions or even the numbers printed on the currency notes that could be tracked by the police. It is believed that crime is increasing across the world because it is become easier to receive the ransom anonymously in cryptocurrencies.

These currencies are harm ful for the environment because they consume resources like computers and electricity and do not produce tangible goods that could lead to social welfare. They are harmful for the society because they are leading to increase in crime. Lastly, its value is uncertain and can disappear anytime. Therefore, governments across the world should ban the trade in cryptocurrencies. If banks do not recognise the currencies, then the owners would not be able to use that money for any useful purpose in the economy and this harmful game will die a natural death.

agmag is an intriguing item of British regional dialect that starts to be recorded in the eighteenth century. It has had several senses, all of them disparaging. The oldest references are to geese: Vast numbers are driven annually to London, to supply the markets; among them all the superannuated geese and ganders (called here Cagmags) which serve to fatigue the jaws of the good Citizens, who are so unfortunate as to meet with them. A century later, the English Dialect Dictionary lists a number of meanings, starting with this one and moving on to tough, inferior meat or carrion: unwholesome or bad food: worthless items: inferior or spurious things; an animal that is coarse or mongrel bred; and "a term of opprobrium applied to persons", typically an old woman. Correspondents have told me that elderly relatives have also used it for cheap sugary foods, including sweets and shop-bought cakes, so your father's sense is certainly known. It was widely used in Lincolnshire. Yorkshire and other counties, but nobody has the slightest idea where it is from. First, one can clearly see just how vulnerable many developing countries still are to rapidly escalating outbreaks of the type we are witnessing in India. The results of failing to distribute the most effective vaccines equitably and strategically are being laid bare.

Second, with more dangerous and contagious variants continuing to emerge, we do not have the luxury of delaying work toward a new international system for pandemic preparedness and response. We must start that project immediately. And fortunately, the Independent Panel for Pandemic Preparedness and Response (IPPR), chaired by former New Zealand Prime Minister Helen Clark and former Liberian President Ellen Johnson Sirleaf, has just published a blueprint for how to do it. The question now is whether governments are ready not just to listen but to act. The answer will determine whether we can prevent future epidemics from becoming global catastrophes.

Chief among the panel's proposals is a call for pandemic pre-

vated to the highest level of political leadership through a new Global Health Threats Council, which should be based at the United Nations headquarters in New York. The panel has also proposed an International Financing Facility for Pandemic Preparedness and Response to help share the burden in future global health crises. Either through direct contributions or a kind of assessed contribution, this mechanism would fund both ongoing preparedness and rapid-response measures in low- and middle-income countries.

The IPPR has offered the kind of emphatic, dispassionate, and actionable guidance that governments need and - in this case have demanded through the World Health Organization. Four years ago, the Independent Commission on Multilateralism (ICM, which I chaired) tried to raise the alarm about the growing threat of pandemics in its report Global Pandemics and Global Public Health. We were aghast at the poor state of the global health architecture at a time when cross-border health crises were becoming more frequent and posing unprecedented risks. Those risks have since materialised in the

A smore developed countries paredness and response to be ele- form of the Covid-19 pandemic. national and global economic re In addition to issuing a clear warning, the commission's report made a series of bold recommendations to strengthen the multilateral system in the face of potential global health crises. Its proposals for clearer rules for verification and early-warning mechanisms have now been echoed in the IPPR's recommendations, as has its call for a more empowered independent WHO secretariat. We are still waiting for progress on all of these fronts. We cannot afford to let the IPPR's report fall on the same deaf ears. And yet, that is exactly what seems to be happening. The 74th World Health Assembly just voted to spend six months studying the panel's report before even considering taking any action. Such de-

> lays are simply unacceptable. The Covid-19 crisis has borne out an uncomfortable truth that is emphasised in the IPPR's report: namely, that many of the national and global institutions established to deal with global pandemics are not fit for purpose, or have not been properly activated. From the moment in late 2019 and early 2020 when the existing International Health Regulations failed, the Covid-19 outbreak became a global catastrophe. And since then, our

sponses have been too slow, tepid, and uncoordinated - a failure that the post-2008 G20 architecture was supposed to prevent.

The current crisis could still become much worse before it gets any better. We are already witnessing a breakdown of global supply chains, which will lead to terrible economic, political, and public health outcomes. We need to get back on track now so that we can fight not only future pandemics but also this one

The IPPR"s report could not be timelier. The G7 summit in Cornwall is an opportunity to concentrate our efforts with backing from the highest political levels. Covid-19 has been costly for all of us. The ICM's 2017 report anticipated that we would be here one day and identified the solutions we would need to implement. Let us use the IPPR's findings to enact meaningful reforms and show real leadership, so that this pandemic will be the last one to catch us off guard.

Eradicate child labour

Sir, Schools should be a child's workplace. Unfortunately, children are being forced into labour against their will. Any type of work that prevents a child from going to schools, forces a child to abandon school at an early age or work that requires a child to attend schools with heavy workload is child labour. Since child labour is a fertile breeding ground for social ills like poverty, unemployment, illiteracy and population growth, the governments have stepped in to stem the menace. According to the 2011 census, there were about 10 million child labourers in India in the age group 5 to 14. No government can claim to have perfectly enacted legislation or brought-in an amendment - there are bound to be dissenting voices. In a country like India, which has the highest number of child labourers in the world, the task to eradicate child labour becomes all the more daunting. The Child Labour (Prohibition and Regulation) Act. 1986, amended in 2016 as Child and Adolescent Labour (Prohibition and Regulation) Act, 1986, prohibits employment of a child (below the age of 14) in any employment including domestic work. Adolescent (14 to 18 years) labour was permitted except in hazardous occupations. The government obviously kept the country's socio-economic situation in mind while amending the law. The biggest challenge, however, was to define the employment that fell under the ambit of family-owned enterprise. But the dangerous and risky working conditions are still not too precisely defined. The government should direct all Collectors and the Superintendents of Police to do an extensive study on why the conviction rate is abysmal for child labour offenders. Ganapathi Bhat, AKOLA

DOOR-TO-DOOR VACCINATION

Bombay HC asks Centre to look at Kerala, J&K pattern

Mumbai. June 11: The Bombay High Court Friday said the Union government should look at the door-to-door vaccination programme carried out "successfully" by Kerala and Jammu and Kashmir, and take a "sound decision" on its present policy that states door-todoor vaccination was not possible

A division bench of Chief Justice Dipankar Datta and Justice GS Kulkarni noted that it was unable to understand what the Centre's problem was in starting door-todoor vaccination when states such as Kerala and Jammu and Kashmir were already carrying out such drives.

Responding to a query raised by the court earlier this week, as to how a senior politician got vaccinated at his residence in Mumbai, Anil Sakhare, counsel for the Brihanmumbai Municipal Corporation (BMC), Friday said the jab was not given by the civic body.

The bench then asked additional government pleader Geeta Shastri, appearing for the Maharashtra government, about who administered the vaccine to the politician. Shastri sought a week's time to respond

To this, Chief Justice Datta said, "One week to take information on this? This is alarming. There is an old saying 'You show me the man and I will show you the rule'." The court was hearing a public interest litigation filed by advocates Dhruti Kapadia and Kunal Tiwari, seeking door-to-door vaccination for senior citizens above the age of 75 and persons who are specially abled, wheelchair bound or bed ridden.

The court asked how the Union government policy says door-to-

door vaccination was not possible presently, when individual states such as Kerala and Jammu and Kashmir were carrying out the drive.

"How is it that individual states like Kerala and Jammu and Kashmir have introduced and are successfully doing door-to-door vaccination? What is the Centre's comment on the Kerala and Jammu and Kashmir pattern?" the bench asked

New Delhi, June 11: The Congress Friday demonstrated in several parts of the country against the rising fuel prices, during which over 150 members were detained in Gujarat, Delhi and Uttar Pradesh for allegedly violating Covid protocol and protesting without permission.

The protests, in response to a call given by the Congress leadership, came on a day when another hike - the 22nd since May 4 - pushed the fuel prices across the country to historic heights.

The protesters pulled bullock carts, rode horse carts, staged a street play, pulled a car using a rope and set another on fire to highlight their concerns.

When BMC counsel Anil Sakhare argued that the land in Malvani, Malad west where the tragedy occurred, belongs to the Collector, the Chief Justice asked if a government directive can over-ride a constitutional mandate since it obliges the BMC to work against illegal constructions.

Noting that in the past 25 days alone, there have been four building crashes - two each in Mumbai and Thane, killing a total of 24 and injuring 23 more, the bench asked: "How many more lives will be lost?'



New Delhi, June 11: The ICMR's fourth round of national-level sero survey to assess the intensity of the spread of Covid-19 in India will begin this month, but all states/UTs should also be encouraged to conduct them so that information from all geographies can be collected, the Centre said Friday.

At a press conference, NITI Aayog member (Health) V K Paul said the Covid situation in the country appears to be stabilising with decline in daily and active cases and the positivity rate coming down to almost 5 per cent.

He, however, urged people to continue following the Covid appropriate behaviour and social distancing norms.

"The ICMR will begin work for the next sero survey this month which will help assess the intensity of spread of Covid-19. But if we want to protect our geographies, we cannot depend on one national sero survey alone and will have to encourage states/UTs to do sero surveys at their levels also," Paul said.

Agarwal, Joint Secretary, health ministry said almost 78 per cent decline in daily new Covid-19 cases has been noted in India since the highest reported peak in daily

The official noted that there has been 70 per cent decrease in active cases, by more than 26.2 lakh, since the peak was reported May 10.

Carbis Bay, June 11: British Prime Minister Boris Johnson greeted world leaders on a wooden boardwalk on the freshly raked sand of Carbis Bay to open the Group of Seven summit Friday, offering elbow bumps to dignitaries gathering for the first time since the onset of the Covid-19 pandemic.

The virus was set to dominate their discussions, with leaders of the wealthy democracies club expected to commit to sharing at least 1 billion vaccine shots with struggling countries. A commitment from US President Joe Biden to share 500 million doses and one from Johnson for another 100 million shots set the stage for the G-7 meeting in southwest England, where the focus is "Building Back Better From Covid-19.'

"We're going to help lead the world out of this pandemic working alongside our global partners," Biden said. The G-7 also includes Canada, France, Germany, Italy and Japan. The leaders hope the meeting in the resort of Carbis Bay will also energise the global economy. On Friday, they are set to formally embrace a global minimum tax of at least 15 per cent on corporations, following an agreement reached a week ago by their finance ministers. The minimum is meant to stop companies from using tax havens and other tools to avoid taxes. It represents a poten-

tial win for the Biden administra-

tion to creating an alternative that could remove some European countries' digital services taxes that largely hit U.S. Tech firms. But the endorsement from the G-7 is just one step in the process; the hope is to get many more countries to sign on, and that could be particularly difficult in nations that depend on a low corporate tax base to survive. For Johnson, the first G-7 sum-

mit in two years - last year's was scuttled by the pandemic — is a chance to set out his vision of a post-Brexit "Global Britain" as a midsized country with an outsized role in international problem-solving. It's also an opportunity to un-

derscore the UK-US bond, an alliance often called the "special relationship" — but that Johnson said he prefers to call the "indestructible relationship." Climate change is also a top

issue on the agenda, and hundreds of protesters gathered in Cornwall to urge the leaders to take action. Some activists sent a barge floating off the coast that was carrying large inflatable figures depicting Biden and Johnson. At one protest, demonstrators carried flags that read "G7 drowning in promises" and "Action not words The official summit business

kicked off Friday, with the customary formal greeting and a socially distanced group photo. Later the leaders will meet Queen Elizabeth II and other senior royals at the Eden Project, a lush, domed eco-tourism site built in a former tion, which has proposed a global quarry. Johnson, for his part, said the first 5 million U.K. Doses would be shared in the coming weeks, with the remainder coming over the next year. He said he expected the G-7 to commit to 1 billion doses in all. "At the G-7 Summit I hope my fellow leaders will make sim-

can vaccinate the world by the end of next year and build back better from coronavirus," Johnson said in a statement, referencing a slogan that he and Biden have both used. Biden will be the 13th president to sit with the now-95-year-old monarch. The White House said he previously met the queen in 1982, when he was a US Senator.

Before the two meet again, the leaders are to attend a reception Friday with the queen, her son Prince Charles and his wife, Camilla, and Charles' son Prince William and his wife, Kate. The queen has met every American president since Dwight Eisenhower during her nearly 70-year reign, except for Lyndon Johnson, who didn't visit Britain while he was in office. She was a 25-year-old princess when she came to Washington in 1951 and stayed with President Harry S.

Truman and his family at Blair House, where Truman lived while the White House underwent a major renovation. She met Herbert Hoover in 1957, more than 20 years after he left office.

She came of age during World War II and understands the central role the trans-Atlantic alliance has played in modern British history, said Robert Hardman, author of "Queen of the World," which examines her role representing Britain on the world stage.

India approached the ICJ against Pakistan for denial of consular access to Jadhav and challenging the death sentence. The Hague-based ICJ ruled in July 2019 that Pakistan must undertake an "effective review and reconsideration" of the conviction and sentence of Jadhav and also to grant

consular access to India without fur-

The ICJ, in its 2019 verdict, had asked Pakistan to provide a proper forum for appeal against the sentence given to Jadhav. The bill was among 21 laws passed by the National Assembly on Thursday evening, ignoring protests by the Opposition lawmakers who wanted the proper reading of bills. But the government suspended rules of business regarding legislation to bulldoze 21 laws in a single sitting. Speaking after the passage of the bill, Law Minister Farogh Nasim said had they not passed the bill, India would have gone to the UN Security Council and could have moved contempt proceedings against Pakistan in the ICJ.

ALZHEIMER'S DRUG APPROVAL FDA faces mounting criticism

New York, June 11: In approving the first new Alzheimer's drug in nearly 20 years, the US Food and Drug Administration is taking its biggest risk yet with a strategy that allows new therapies onto the market without strong evidence that they work, regulatory and scientific experts say.

The Biogen Inc (BIIB.O) drug. Aduhelm, was authorised based on evidence that it can reduce brain plaques, a likely contributor to Alzheimer's, rather than proof that it slows progression of the lethal mind-wasting disease

The FDA has granted so-called "accelerated approval" in more than 250 instances since 1992, mainly for rare diseases or small patient populations that have had no effective treatments available to them. In these cases, the agency requires that drugmakers conduct additional clinical trials to prove their therapy works, or face withdrawal from the market.

Aduhelm, however, is in a different league in terms of the number of potential patients and cost



to the healthcare system.

In addition, the FDA approval ignored the recommendation of its outside advisors, who said Biogen did not provide enough evidence of clinical benefit. Three of the advisory panel's members have resigned in protest since the FDA decision was announced on Monday.

"This decision has shaken the foundations of the scientific process and methods," said Dr. Jason Karlawish, co-director of the Penn Memory Center in Philadelphia. Karlawish ran one of the trial sites for the Biogen drug.

He said the FDA made its decision "by fiat," and had not asked its advisors to consider whether the drug's ability to remove a type of brain plaques known as beta amyloid would improve outcomes for patients.

Rover 'Zhurong' leaves 'China's imprint' on Mars

China's Mars rover Zhurong, which touched down in May, has since been studying the topography of a vast Martian lava plain known as the Utopia Planitia

Beijing, June 11: The dusty, rocky Martian surface and a Chinese rover and lander bearing small national flags were seen in photos released Friday that the rover took on the red planet.

The four pictures released by the China National Space Administration also show the upper stage of the Zhurong rover and the view from the rover before it

rolled off its platform. Zhurong placed a remote camera about 10 meters (33 feet) from the landing platform, then withdrew to take a group portrait, the

CNSA said. China landed the Tianwen-1 spacecraft carrying the rover on Mars last month after it spent about three months orbiting the red planet. China is the second country to land and operate a spacecraft on Mars, after the United States. The orbiter and lander both display small Chinese flags and the lander has outlines of the mascots for the 2022 Beijing Winter Olympics and Paralympics.

The six-wheeled rover is surveying an area known as Utopia Planitia, especially searching for signs of water or ice that could lend clues as to whether Mars ever sustained life. At 1.85 meters (6



feet) in height, Zhurong is significantly smaller than the U.S.'s Perseverance rover which is exploring the planet with a tiny hel-

icopter. NASA expects its rover to collect its first sample in July for return to Earth as early as 2031. In addition to the Mars mission,

Subsequent launches are planned to expand the station, send up supplies and exchange crews.

New Delhi, June 11: Capping the trade margin on oxygen concentrators by the government has resulted in ensuring consumer savings as the price of the critical device has come down, the Ministry of Chemicals and Fertilizers said Friday.

On June 3, the National Pharmaceutical Pricing Authority (NPPA) capped the trade margin on oxygen concentrators at 70 per cent on the price to distributor (PTD) level.

In accordance with it, "a total of 104 manufacturers / importers of oxygen concentrators have submitted revised MRP for 252 products/brands," it said.

Downward revision in price by up to 54 per cent has been reported in 70 brands, showing reduction in maximum retail price by up to ₹54,337 per unit. Further, 58 brands have reported price reduction of up to 25 per cent and 11 brands reported price reduction of 26-50 per cent, the statement said.

"Out of 252 products/brands reported, 18 products/brands reported by the domestic manufacturers did not show any decline in prices," it added.



Noting that China is the largest exporter in the world, with 16.1 per cent of global exports, the report said that when Covid-19 hit this global trade powerhouse, many unfortunate events started unfolding for the shipping industry.

"The shipping crisis is a consequence of the uneven post-Covid-19 economic recoveries of the world's largest importing and exporting countries. The novel coronavirus has hit the world with multiple waves and new variants," said the report.

However, the difference in the degree and level of its impact on each country meant everyone around the globe experienced lockdowns and the subsequent easing of restrictions at different points in time, it added.

MOSCOW: Russia winger Andrey Mostovoy was cut from the national team for this year's European Championship Friday after testing positive for the coronavirus. Mostovoy is the first player to be cut from a team at the tournament because of the virus. The team wrote on Twitter that Mostovoy has been replaced by defender Roman Evgeniev 'in connection with an unfavorable result of PCR testing." Sweden and Spain have both reported positive results from coronavirus tests but haven't yet opted to replace the affected players. Spain, however, hope captain Sergio Busquets and Diego Llorente will still have an impact on the competition after both players tested positive. Llorente's positive test Tuesday may have been erroneous after further tests came back negative, coach Luis Enrique said Thursday. The Leeds defender was set to undergo another test Friday, and if that comes back negative again, the team said he can return to the squad before Spain's first match Monday against Sweden. Spain's preparations were thrown off after Busquets tested positive last Sunday. Players who test positive must stay in isolation for at least 10 days, meaning Busquets would miss the opener against Sweden.

India will play three ODIs and as many T20s in Colombo starting July 13. The selectors picked a bunch of fresh faces for the Sri Lanka series Thursday as the main team is in the UK for the World Test Championship final and five Tests against England.

Sao Paulo, June 11: Brazil's Supreme Court gave its go-ahead for Copa America football tournament to kick off here despite the country's alarming COVID-19 figures.

The unanimous vote by the 11 justices provides relief for President Jair Bolsonaro and tournament organizers in Brazil, which is hosting the event after the withdrawal of Colombia and Argentina.

The court rejected two suits against holding the tourney in Brazil, considering that authorization of the games is a decision made by officials in the state where they will be played; all four governors in Copa America locations are Bolsonaro allies.

The court's ruling is a response to challenges made by the Brazilian Socialist Party and a metalworkers union lodged against Brazil hosting the tournament.

Warsaw, June 11: Star Indian wrestler Vinesh Phogat proved that her preparations for the Tokyo Games were on track by winning the 53kg gold at the Poland Open here Friday, giving herself some crucial 'mat-time' ahead of the Olympics.

It is third title of the season for the 26-year-old Vinesh, who claimed gold medals at the Matteo Pellicone event (March) and Asian Championship (April) earlier. The

victory would potentially make Vinesh the top seed at the Tokyo Olympics.

Except for her opening bout against 2019 World bronze (50kg) winner Ekaterina Poleshchuk, Vinesh wasn't troubled by any of her other rivals as she conceded only two points en route the top place on the podium.

She did not concede a single point to Ukraine's Khrystyna Bereza in the final, winning 8-0. Vinesh took most of her points through double-leg attacks while the 2019 European silver medallist Bereza was on the defensive throughout.

The World bronze winner and Asian Games champion had to battle hard against Poleshchuk before prevailing 6-2 but needed only 75 seconds to pin her American rival Amy Ann Fearnside in the semifinals.

Earlier in the day, Anshu Malik pulled out of the 57kg competition due to fever.

Tsitsipas enters his first Slam final

Paris, June 11: Stefanos Tsitsipas went from way ahead to suddenly stuck in a five-set struggle against Alexander Zverev at the French Open Friday before emerging to earn his first berth in a Grand Slam final.

The fifth-seeded Tsitsipas entered with an 0-3 record in major semifinals and it seemed as if he might let this one slip away, too, until a late surge carried him to the 6-3, 6-3, 4-6, 4-6, 6-3 victory after more than three-and-half hours at Court Philippe Chatrier.

Tsitsipas will face the winner from the match between 13-time Roland Garros champion Rafa Nadal or top-seeded Novak Djokovic for the championship on the red clay. Tsitsipas regained control of his



semifinal on a cloudy afternoon in the late going thanks to a combination of more solid returning

from Germany.

The fifth set began with a key service hold after Tsitsipas double-faulted to fall behind love-40. From there, he won five consecutive points, including one with a cross-court forehand passing winner that he celebrated by shaking his racket as the crowd chanted, 'Tsi-tsi-pas! Tsi-tsi-pas! Tsi-tsi-pas!"

Then Tsitsipas broke to go up 3-1. Fifteen minutes later, Tsitsipas earned his first match point, and while he needed five of them to close the proceedings, he eventually did convert one with an ace.

Tsitsipas will be the first player from Greece in a Grand Slam singles final and youngest man to appear in the title match at the French Open since Nadal won the 2008 championship five days after his 22nd birthday.
