

# Centre confirms first death due to Covid vax

New Delhi, June 15: A government panel studying Covid-19 vaccine side effects has confirmed the first death due to anaphylaxis following vaccination.

The causality assessment of 31 reported Serious Adverse Events Following Immunisation (AEFI) cases following Covid-19 vaccination was carried out by the panel. According to a report by the

National AEFI Committee, a 68year-old man died due to anaphylaxis (severe allergic reaction) after being vaccinated March 8, 2021.

"It is the first death linked to Covid-19 vaccination due to anaphylaxis. It re-emphasises the need to wait for 30 minutes at the inoculation centre after receiving the jab. Most of the anaphylactic reactions occur during this period and prompt treatment prevents deaths,' Dr NK Arora, chairperson, National AEFI committee, told PTI.

The Committee examined five such cases that took place February 5, eight cases March 9 and 18 cases March 31. As per data in the first week of April, the reporting rate is 2.7 deaths per million vaccine doses administered and 4.8 hospitalisations per million vaccine doses administered, the report stated.

The panel said mere reporting of deaths and hospitalisations as serious adverse events does not automatically imply that the events were caused due to vaccines.

### A 68-year-old man, fully vaccinated, died March 31 and it has been labelled as "vaccine product related reaction" in a report assessing 31 severe cases

Only properly conducted investigations and causality assessments can help in understanding if any causal relationship exists between the event and the vaccine, the report said, adding for causality assessments, priority has been given to death cases.

Of the 31 causally assessed cases, 18 were classified as having inconsistent causal association to vaccination (coincidental - not linked to vaccination), 7 were classified as indeterminate, 3 cases were found to be vaccine product related, one was anxiety-related reaction and two cases were found to be unclassifiable, the government panel report said. Vaccine product-related reactions are expected reactions that can be attributed to vaccination based on current scientific evidence, it said.

Examples of such reactions are allergic reactions and anaphylaxis, etc. Indeterminate reactions are reactions which have occurred soon after vaccination.

# Armed youth holds family hostage

Bolangir, June 15: High drama unfolded at Shantipada area here Tuesday as an armed youth barged into a house in the locality and allegedly held the family members hostage after locking the doors from inside

The drama came to an end after the armed youth was nabbed following a fivehour-long operation, Bolangir SP Nitin Kusalkar said. The youth, identified as Bikarm Panda, 35, a resident of Talpalipada in the town, is accused of having fired two rounds during the operation.

The youth reportedly committed the act over onesided love affair with a female kin of the family, the SP said. The incident oc-

curred when Bikram barged into the house of Dibvalochan Hota, a resident of Shantipada Tuesday morning. Before the family members could understand what was happening, the youth locked the house from inside and held the family members hostage. He asked them to call their niece and threatened to kill

all of them. Panicked, the family members managed to lock themselves inside, while Dibyalochan alerted the PCR. Soon, a team from Bolangir Town police station and fire personnel rushed to the spot. Fire department personnel entered the building and rescued the family members through a rear window. Thereafter, the police nabbed Bikram.

New Delhi, June 15: In its anxietv to suppress dissent the State has blurred the line between right to protest and terrorist activity and if such a mindset gains traction, it would be a "sad day for democracy", the Delhi High Court said Tuesday while granting bail to three students from JNU and Jamia Millia Islamia (JMI) in a northeast Delhi riots case.

Terming as "somewhat vague" the definition of 'terrorist act' under the stringent UAPA laws and warning against its use in a "cavalier manner", the high court set aside the trial court orders denying bail to JNU students Natasha Narwal and Devangana Kalita and JMI's Asif Iqbal Tanha, allowing their appeals and admitting them to regular bail.

We are of the view that the foundations of our nation stand on surer footing than to be likely to be shaken by a protest, however vicious, organised by a tribe of college students or other persons, operating as a coordination committee from the confines of a University situated in the heart of Delhi," a bench of Justices Siddharth Mridul and Anup Jairam

Bhambhani said In three separate judgements of 113, 83 and 72 pages, the high court said that although the definition of 'terrorist act' in Section 15 of the stringent Unlawful Activities (Prevention) Act (UAPA) is wide and

somewhat vague, it must partake the essential character of terrorism and the phrase 'terrorist act' cannot be permitted to be applied in a "cavalier manner" to criminal acts that squarely fall under the IPC. "We are constrained to express

that it seems, that in its anxiety to suppress dissent, in the mind of the State, the line between the constitutionally guaranteed right to protest and terrorist activity seems to be getting somewhat blurred. If this mindset gains traction, it would be a sad day for democracy" which would be in peril, the bench said, adding there was nothing to show the possible commission of a terrorist act.

The high court directed Pinjra

May last year in connection with alleged larger conspiracy in the riots, to surrender their passports and not to offer any inducement to prosecution witnesses or tamper with the evidence in the case. The order of release from jail of Devangana and Natasha, in the meantime, has been deferred since the High Court has sought verification report by Wednesday. The three accused shall not indulge in any unlawful activities and shall reside at the address as mentioned in records, the high court said.

Kalita, Narwal and Tanha are accused in four, three and two cases respectively relating to communal riots that broke out February 24 last year and will be released from jail now as they have already secured bail in other matters. The bench said there is absolutely

nothing in the charge sheet, by way of any specific allegation to show the possible commission of a 'terrorist act' within Section 15 UAPA, an act of 'raising funds' to commit a terrorist act under Section 17 and an act of 'conspiracy' to commit or an 'act preparatory' to commit, a terrorist act within Section 18 UAPA.

The government is vet to hold the elections to the Urban Local Bodies (ULBs), which are pending for two-and-a-half years back as the government is yet to amend the existing laws to determine the reservation and delimitation of seats.

The State Election Commission (SEC), which is responsible for organising the rural polls, had written to the Panchayati Raj department in January and March asking the latter to complete the delimitation of wards and announce the reservation of seats by April 2021. However, the department has not obliged so far.

"Unless necessary instructions are issued by the government to district Collectors, it may not be possible to complete the delimitation of wards and reservation of seats within the dateline fixed by the Commission," SEC secretary RN Sahu said in a letter to the department.

# Amid unlock, doctors say brace for Covid-19 'explosion'

New Delhi, Jun 15: With close gathering of shoppers in markets and restaurants resuming business amid phased unlock in the national capital, doctors Tuesday cautioned that Delhi could face a "worse than second wave situation" of Covid-19 if people do not adhere to safety norms or lower their guards.

The remarks from many doctors at leading government or private facilities here come after visuals of various crowded markets surfaced in reports and on social media, showing Covid-appropriate behaviour not being followed by



many people, like wearing of masks or maintaining social distance. Dr. Suranjit Chatterjee, a senior consultant at Apollo Hospitals here, warned that if safety norms

are not followed by people and if there is no strict enforcement in case of violations, then "we are in for a trouble again". "The way cases have come down from over 28,000

at peak in April to 131 cases reported yesterday, it is such a dramatic fall in numbers. And, if lockdown was the primary reason for it, then we have to tread very cautiously now with the restrictions being slowly eased," he said.

"But, if people show laxity by not wearing masks or wearing it inappropriately or violate social distancing norms, and if law enforcement agencies do not penalise and ensure violations do not increase in quantum, then we are certainly in for a trouble. And, the next wave could be worse than the second wave situation." he said. Medical experts in mid-May had

concurred that it was lockdown majorly that had brought down the count of daily cases, while cautioning that the severity of cases was still the same.

Dr Richa Sareen, consultant of pulmonology at Fortis hospital here, who recently lost her immediate family member to Covid, said, "The threat of the third wave hitting is quite real and not a hypothesis." "And, we had similar threat in February when everyone had started going on a vacation or doing house parties or socialising in public places. Now, that the second wave has done so much damage and claimed so many lives, we need to realise that we have to be disciplined and tread with caution," she said.

The pulmonologist emphasised that in the second wave, at least one member in every household here was either infected by Covid, or the families knew of someone who had been. "We hoped that people will learn lessons from the second wave. but seems we are not being wise as common people. Situation will be worse than during the second wave if we do not wise up. A government cannot keep a lockdown forever, but, we can choose to be dis-ciplined and go out only when needed," she said.

# Man hacked to death

# **Dependence on Centre for** black fungus drugs reduces

Bhubaneswar, June 15: The absolute dependence on the Union government for supply of mucormycosis (black fungus) drugs has ended as the state government is now directly procuring some of these drugs from the manufacturers. However, major drugs for treat-

ment of black fungus, like Amphotericin B injections, are still being procured through the Ministry of Chemicals and Fertilizers which is allocating the same to the states from time to time.

The Health department Tuesday said that the availability of mucormycosis drugs in the state has improved as the state has started procuring the scarce life-saving drugs from the manufacturers directly which was done after the government had issued tenders for the same.

"The availability of black fungus drugs has improved in the state. While we are still receiving the drugs from the Centre, we have been able to get more supplies through other suppliers although in limited amount," said state

Health Services director Bijay Mohapatra. He also added, "Mucormycosis

health institutions have been spe cially focusing on catering to the needs of the patients."

The Health department has dedicated 30-bed wards for black fungus patients at SCB Medical College and VIMSAR each. Every district headquarters hospital (DHH) has also reserved four beds for treatment of the fungal disease

According to Health department data, the state has reported a total of 82 black fungus cases while seven persons succumbed to the fungal ailment. The department, however, attributed these deaths to reasons other than mucormycosis

The department claimed that one infected person has been cured of the disease. Government statistics claim that most of the mucomycosis patients visit the All India Institute of Medical Sciences (AIIMS), Bhubaneswar, SCB Medical College and Hospital in Cuttack and MKCG Medical College and Hospital at Berhampur.

New Delhi, June 15: Expressing disappointment at the report submitted by a four-member committee regarding illegal mining of laterite stone in Khurda, the National Green Tribunal (NGT) questioned as to how Shree Jagannath Temple Administration (SJTA) could be permitted to extract minerals without obtaining environment clearance.

The NGT observed that the SJTA in its affidavit clearly stated that 26 laterite stone quarries have been detected by the temple administration on the Srimandir land in Khurda district and notice was duly published for auction of these quarries. The green body observed it has been established that it would be SJTA which had auctioned the mines and the mining has also been carried out in an extensive area

"We find this affidavit silent on the question as to whether any environment clearance, consent to establish and consent to operate were obtained from the Odisha State Pollution Control Board or State Environmental Impact Assessment Authority, Odisha.

The weavers of Routapada have made garments like Cheheli Pata, Geetagovinda Pata, Khandua Pata and Gamuchha for this year's Snana Yatra and Rath Yatra, scheduled to be held of June 24 and July 12 respectively.

"We usually weave around 30 varieties of cotton and silk clothes including Netaphuta, Boirani, Patani, Tanakhosa, Malamala, Srimukha Ota and Gadiphuta for Lord Jagannath and other deities of Srimandir. Around 25 weavers' families of Routapada

have been providing service to the Lord," Gopinath said.

Gopinath's nephew Kartikeswar Patra, a differently-abled, is also weaving clothes for Srimandir deities.

"I had started serving the Lord around 20 years ago after finishing my school education. I had never visited Srimandir in Puri but I always feel the presence of Lord Jagannath near me while weaving Geetagovinda Pata. I will continue this service till the last breath," said Kartikeswar.

Bhubaneswar, June 15: Odisha Tuesday registered 3,405 new Covid-19 cases, pushing the tally to 8,59,526, while 42 fresh fatalities raised the toll to 3,388, a Health department official said

This apart, 53 Covid-19 patients in the state have died due to comorbidities.

Of the 3,405 new cases, 1,942 were recorded in quarantine centres, and the remaining during contact tracing.

Khurda district, of which the state capital Bhubaneswar is a part, reported the maximum number of new cases at 500, followed by Jajpur at 391, Balasore at 296 and Cuttack at 230.

As many as 21 districts reported below 100 cases each, the lowest being nine in the Jharsuguda.

As many as 14 districts in the state registered a positivity rate below 5 per cent while eight districts recorded between 5 and 7.5 per cent and the rest eight districts reported over 7.5 per cent.

Accordingly, the number of active cases in the coastal state climbed to 51,104.

The coastal state reported 42 deaths in the past 24 hours of which Khurda, Puri, Jharsuguda and Cuttack districts have accounted for four deaths each. Three each died in four districts, two each in another

this cultivation after their president Hemant Majhi persuaded them to take up cultivation.

The persuasion worked following which the women farmers Saraswati Majhi, Marnabati Majhi, Jashobanti Majhi, Sagi Munda, Nimanti Majhi, Mama Hembram, Phulamani Majhi, Sita Munda and Hemanti Majhi prepared seven acre of fallow land for the cultivation.

The voluntary outfit has supplied them with 4.200kg of seeds for the cultivation. They expect that they will harvest around 49 quintals of finger millet which they will sell at Rs3,377 per quintal to the state government.

When contacted, Debashis Das, coordinator of the outfit said that the women will get ₹200 per acre from the state government after their harvest.

# Free Speech in Peril

fter the Supreme Court iterated in its ruling June 3 that sedition charges can't be slapped on citizens to muzzle free speech that is not Lintended to incite violence or disrupt public order, it was expected the Centre would exercise utmost caution in applying the British era, anti-democratic, colonial law. But it seems not to have paid heed to anything. Journalists and citizens hailed the apex court verdict quashing sedition charges against journalist Vinod Dua by a BJP leader from Himachal Pradesh for making comments critical of Prime Minister Narendra Modi and the Central government. A three-judge Bench gave its ruling in the light of a verdict by a five-judge Bench of the apex court nearly 60 years ago in the Kedar Nath Singh case that "allegedly seditious speech and expression may be punished only if the speech is an incitement to violence or public disorder."

In 1953 Kedar Nath Singh, a member of the Forward Communist Party from Bihar, got into trouble after he took on the ruling Congress during a rally at Begusarai, where he said, "Today, the dogs of CBI are loitering around Barauni [in Begusarai]. Many official dogs are sitting even in this meeting. The people of India drove out the British from the country and elected these Congress goondas to the gaddi. As we drove out the British, we shall strike and drive out these Congress goondas as well." For this he was charged with sedition. However, in 1962 the Supreme Court five-judge bench gave the ruling vindicating the right to criticise government actions for public good.

Instead of cautiously weighing the merit of the case, the Lakshadweep Police booked filmmaker Aisha Sulthana under the sedition law following a complaint by the BJP Lakshdweep unit president C Abdul Khader over her remarks in a television debate against the administrator of the smallest Union Territory. Aisha had criticised the controversial decisions of the administration, cleared at the behest of its acting administrator, Praful Khoda Patel, a former minister of the Narendra Modi cabinet of Gujarat.

She termed Khoda the BJP's 'bio-weapon' to articulate what she said was the anger of the people of the islands at the measures that threaten to undermine their socio-cultural fabric.

The Editors' Guild expressed concern June 14 over the alarming tendency of the Centre and state governments to target journalists critical of government actions and charge them with sedition cases. The Guild expressed shock over the Uttar Pradesh Police's approach in handling the case of TV journalist Sulabh Srivastava who was mysteriously killed after his expose of local liquor mafia. He had informed the administration of his fears of being shadowed by criminals. But, the police did nothing to protect him and passed off his death as the result of an accident. Of course, it is pointless talking about UP Police after what it has done in the case of Kerala journalist Kappan Siddiqui who has been charged and imprisoned since long for his efforts to report on the brutal Hathras rape and murder case.

Time and again the country is witnessing how the dispensation at the Centre and some BJP-ruled states have been framing charges under draconian laws, including the Unlawful Activities Prevention Act (UAPA), against people raising their voices against repressive actions by the government. Unfortunately, in such cases the lower courts are quickly giving orders that the government desires. Many of these decisions of the subordinate judiciary are subsequently getting dismissed by the higher courts as bad in law or not sustainable. Coincidentally, the Delhi High Court granted bail June 15 to student activists Devangana Kalita, Natasha Narwal and Asif Iqbal Tanha in the main northeast Delhi riots conspiracy case filed under the stringent provisions of the UAPA. The order of release from jail of Devangana and Natasha, in the meantime, has been deferred since the High Court has sought verification report by Wednesday. The observation, however, of the Bench of Justices Siddharth Mridul and AJ Bhambhani while granting bail brings out eloquently the shameful and pernicious application of harsh legal provisions by different government agencies. The judges said: "We are constrained to express, that it seems that, in its anxiety to suppress dissent, in the mind of the State, the line between the constitutionally guaranteed right to protest and terrorist activity seems to be getting somewhat blurred. If this mindset gains traction, it would be a sad day for democracy." The Court further stated: "The right to protest is not outlawed and cannot be termed as a 'terrorist act' within the meaning of the UAPA"

Jamia Millia Islamia University student Asif Iqbal Tanha had challenged a trial court's October 26, 2020 order dismissing his bail application on the ground that he allegedly played an active role in the entire conspiracy with reasonable grounds for believing the allegations to be prima facie true. Tanha's lawyers argued in the High Court he had not even been present in Delhi during the riots and hadn't visited any of the protest sites where rioting and violence occurred. There was no physical evidence connecting Tanha to the riots or to allegations of any funds being received by him for terrorist activities Lakshadweep, on the other hand, is in turmoil with protests by the people under the banner of Save Lakshadweep Forum (SLF) observing 'Black Day' June 14 when the administrator arrived there. A group of 93 former civil servants wrote to the Prime Minister urging him not to give effect to the administrator's skewed and communally sensitive plans that will hurt the interests of the islands' population of over 64,000. Nearly, 96 per cent of the people are Moslems and one of the controversial fiats targets eating of beef. The acting administrator's plan of introducing the Lakshadweep Development Authority Regulation (LDAR), the Lakshadweep Prevention of Anti-Social Activities Regulation (commonly known as PASA or the Goonda Act elsewhere), and the Lakshadweep Animal Preservation Regulation (LAPR) and an amendment to the Lakshadweep Panchayat Regulations have generated widespread anxiety on the island. The Centre is maintaining a studied silence on these controversial measures lending credence to the suspicion that those peaceful islands are being transformed into a laboratory of loot of their natural resources by business interests in the name of development.

# **FICKLE GLOBAL CAPITAL**

nce again, emerging markets are on the capitalflows roller coaster - one no less dizzying for being so familiar. And once again, the highs and lows of financial-market swings in these economies are mostly generated by external forces, not national policies. But the possibility that even the smallest domestic mistake could send them into a tailspin still looms large.

The past 18 months have provided ample evidence of this. According to the Institute of International Finance, total capital flows to emerging markets fell by 13 per cent in 2020, to \$313 billion. But this headline figure conceals sharp changes, from a dramatic decline in March 2020 to a recovery in the following month and significant volatility thereafter. These flows have remained strong so far in 2021, at \$45.5 billion

in April and \$13.8 billion in May, mostly to finance the purchase of emerging-market debt securities. While total global debt fell by \$1.7 trillion, to \$289 trillion, in the first quarter of 2021, emerging-market economies' debt increased by \$600 billion, to \$86 trillion.

So, the good times are back for such economies, right? Well, not really. True, rich countries' rapid and massive monetary-policy response to the pandemic-induced downturn certainly played a role in reviving capital flows to the developing world. But as the equally huge fiscal expansion in some advanced economies (especially the United States) takes hold and bolsters the economic recovery, fickle global capital may well look for greener pastures there. That will once again result in financial rationing that penalises economies with higher perceived risk.

Of course, it is misleading to talk of emerging markets as a homogenous group. China is now such an outlier - not only because of its economic size and strength. but also because of its effective control of the pandemic - that it really should be treated separately. While some countries, like Poland and the Philippines, have used their greater fiscal space and stronger balance-of-payments po-

sitions to provide more support to their economies, others, including Argentina, Egypt, and Turkey, face the difficult task of ensuring recovery while dealing with macroeconomic imbalances and a major debt overhang. Then there are countries like India and Mexico, which face no immediate external constraints but whose inexplicable fiscal reticence is hold ing back economic recovery.

Emerging economies regard capital-market integration as a way of obtaining more and cheaper access to private international finance to fund domestic investment and public spending. But this gives rise to a number of contradictions and concerns.

For starters, open capital accounts generate both inflows and outflows, meaning that a country may not always benefit from net inflows. Malaysia's capital outflows have generally exceeded its inflows over the past decade, so savings have migrated abroad in net terms. And the volatility of such flows, combined with policymak ers' obsession with self-insurance through high foreign-exchange

reserves, increasingly means that even net recipients of foreign capital don't really dare to spend it. India, for example, has significantly boosted its forex reserves during the COVID-19 crisis - the volume recently exceeded \$600 bil lion - in the mistaken belief that this is an indication of economic strength.

Large forex reserves are extremely expensive, because countries typically park them in safe as sets like US Treasury bills, which provide low rates of return. This adds to the more general problem of significant wealth transfers between emerging and advanced economies. Moreover, the yield differentials between emerging economies' gross external assets and their higher-yielding external liabilities often generate large outward income transfers. Turkish economist Yılmaz Akvüz, formerly of the UN Conference on Trade and Development, has estimated that in 2000-16, such inadvertent transfers to advanced economies amounted to 2.3 per cent of the combined GDP of the G20 emerging economies each year.

On the other hand, emergingmarket economies' greater engagement with and exposure to global financial markets does not really enable them to undertake such spending. In fact, it can actually act as a damper on necessary fiscal expansion, owing to policymakers' constant (and realistic) fear of credit-rating downgrades and capital flight. Even the need to spend more on mounting climate change threats, for which current adaptation efforts are completely inadequate, is ignored because of such pressures.

The pandemic and the current revival of capital inflows into emerging markets are intensifying the contradictions. Many emerging markets and developing countries already face looming debt problems, which will only worsen as they borrow more during the pandemic. The private sector in lower-income countries has contracted much more debt than the public sector has, but governments rightly worry that they will have to step in and guarantee those loans when the going gets tough. Even when debt held by foreigners is denominated in domestic currency, this does not guarantee stability, because sell-offs and capital-flow reversals driven by changing investor perceptions can lead to currency devaluations and domestic banking crises.

They were often suspected of keeping the savings for themselves: There's Nipcheese, the purser, by grinding and squeezing, First plund'ring, then leaving, the ship like a rat (A Collection of Songs, Selected From the Works of Mr Dibdin, 1796). Charles Dibdin was a famous actor, composer, and writer of the period, whose songs included Tom Bowling.

"t takes five to seven days and costs ₹1.299 for an Indian to get a tourist visa for Bangladesh. But if you don't have the money or

you're in a big hurry, there is another option: wear a tiger costume. Tigers have no trouble crossing the border, as Indian Forestry Services officer Parveen Kaswan noted recently when he shared a photo of a tiger that had crossed the border in the Sundarbans.

"This tiger covered 100 km and reached Bangladesh from India. Without visa though. Crossed creeks, islands & ocean." he tweeted. Forestry officials and wildlife experts in West Bengal had been monitoring the tiger since late December. That's when they captured the tiger in the Sunderban Tiger Reserve, fitted it with a radio collar, and released it, hoping to study its movements and interactions with humans. They wanted to answer questions such as: How far does a tiger travel in a day? Does it follow a particular path?

Does it prefer Uber or Ola? Using satellite data, officials were able to monitor the tiger as it travelled 100 km in four months. a journey that included crossing several rivers and three islands. No

ride-hailing services were involved, as far as officials could tell.

"After initial movements for a few days on the Indian side, it started venturing into the Talpatti island in Bangladesh Sunderbans and crossed rivers such as Choto, Harikhali, Boro Harikhali and even the Raimangal," West Bengal's chief wildlife warden VK Yadav told Times of India.

He added that the tiger may have originally travelled from Bangladesh to India. That may explain why it was able to enter Bangladesh without a visa.

Officials were able to track the tiger only until May 11. The radio collar suddenly stopped producing signals. The tiger was last tracked on Talpatti island in Bangladesh.

According to Yadav, the radio collar has a mortality sensor. It sends a special signal if the tiger has died. Yadav believes that the tiger is safe and that the collar merely slipped off its neck. But perhaps a human was involved. Perhaps the tiger came across a young woman, unbeknownst to forestry officials

Chennai, June 15: Arappor Iyakkam, a non-governmental organisation (NGO), Tuesday alleging huge under-reporting of Covid fatalities, urged the Tamil Nadu government to audit and correctly report the death numbers.

The NGO in its report also called for issue/reissue of medical certificates for cause of death as per the Indian Council of Medical Research (ICMR) guidelines.

Arappor Iyakkam came out with



its study report based on the data released by six government hospitals - Government Rajaji Hospital, Madurai, Coimbatore Medical College Hospital, Mahatma Gandhi Memorial Medical College and Hospital, Trichy, Vellore Medical College, Karur Medical College and **Tirupur Government Headquarters** Hospital-in Tamil Nadu. These hospitals geographically cover the northern, western, central and southern parts of Tamil Nadu.

Data for the number of death certificates issued for male and female were collected for each day of the months of January to May 2021 for each of these six hospitals for the years 2019, 2020 and 2021. The data collected is as of June 13 from the website

According to Arappor Iyakkam, an analysis of death data of six hospitals that is available online revealed that the total number of deaths for which death certificates have been issued in the months of April and May together stand at 4,437 and 3,261 for 2019 and 2020 respectively.

The number has shot up to 11,699 in April and May months of the year 2021

On the other hand, the Arappor Iyakkam's report finds that the total death of patients declared as Covid deaths in the months of April and May 2021 by the media bulletin of the Department of Health and Family Welfare is only 863 in these 6 hospitals, Arappor Ivakkam said.

In its report, the NGO said there is likely underreporting of Covid deaths in these six hospitals is at least 8.4 to 9.8 times more than the declared fatalities in the media bulletin for the months of April and May 2021. As per the report, the pattern of death data is similar in the six hospitals.

Approximating the same underreporting factor of 8.4 to 9.8 times for the entire state, the likely number of deaths due to Covid in Tamil Nadu may be between 108.721 and 126,841 against the reported number of 12,943, the Arappor Iyakkam's report states.

# IICF to get foreign donations for Ayodhya mosque

Lucknow, June 15: The Indo-Islamic Cultural Foundation (IICF) Trust, which is overseeing the construction of the Mosque in Avodhva. has submitted its application for Foreign Contribution (Regulation) Act (FCRA) account at State Bank of India (SBI) in Delhi.

Once approved, the account will pave the way for foreign funding to the project which will also have a 300-bed hospital in the area. The IICF will also not be crowdfunding for the entire project, but will gather funds from identified donors.

IICF spokesperson Athar Husain said, "The 300-bed hospital is IICF's main goal and while we had envi-



sioned the need for it back in 2020 itself, the pandemic has made our resolve stronger. Almost 95 per cent of our project cost and infrastructure paraphernalia is for the hospital alone.

However, officials said that the project will kick off on ground by year end.

The hospital will also come up with a community kitchen to feed around 1,000 people every day, a green patch with exotic trees on the verge of extinction from around the world in Ayodhya, and a museumlibrary highlighting the shared Hindu-Muslim struggle of 1857 in Awadh against the British.

Subsequently, the Mosque that will come up in Dhannipur village as part of the complex, will be almost the same size as that of the Babri Masjid. IICF spokesman further said that, "There will be no crowdfunding. We have donors already waiting.'

Ayodhya, June 15: Champat Rai, the general secretary of the Shri Ram Janambhoomi Teerth Kshetra Trust, has issued another statement amid the allegations of corruption in the purchase of Ram temple land.

He said that the trust is working to provide the Shri Ram Janambhoomi temple a grand look according to Vastu Shastra, to make the complex safe in all respects and convenient for the visitors.

He said that important temples or places falling within the boundary of the construction wall and retaining wall in the east and west parts of this temple have been purchased with mutual consent.

It has been the decision of the pilgrimage area that every institution or person displaced in this process will be rehabilitated.

The selection of land for rehabilitation is being done with the consent of the concerned institutions or individuals.

Under this process 1.20 hectares of land located at Bagh Bijesi, Avodhva has been purchased with complete transparency and with the consent of important temples like Kaushalya Sadan etc.

It is worth noting that the abovementioned land is on a prime location situated on the route near Avodhya Railway Station, the statement said.

In relation to this land, from the year 2011, the contract was executed in favour of the present vendors at different times (2011, 2017 and 2019)

On investigation, these plots were found suitable for use, after which the concerned persons were contacted. The value sought for the land was compared with the current market price and the final due amount was fixed at about Rs 1.423 per square feet, which is much less than the present market value of the nearby area.

He said that after agreeing on the price, the concerned persons were required to complete their earlier contracts, only then the respective land which was in the pilgrimage area, could have been achieved.

As soon as the deed of land was done in favour of the persons contracting with the pilgrimage area, the deal was signed and registered with full readiness and transparency

The microplastics measuring less than 5 mm were found in water sources near the Corporation dumping yards of Perungudi and Kodungaiyur.

The study found that in every litre of the water source within 1 to 2 km of these two dump yards there was the presence of 2 to 80 microplastic particles detected. These microplastics, according to the research team would have made their way into the groundwater after major plastics were broken down due to weathering and would have entered into the aquifers through the waste in the dumping yards.

The microplastics could cause health problems to those who drink water from these aquifers and it will

also make its way to the sea along with the groundwater harming the marine ecosystem and ecology. K Manikanda Bharath, who was the corresponding author of the study, speaking to IANS said, "The maximum microplastic samples we found in 1 litre water in Kodungaiyur was 23 but in Perungudi it was 80. This is owing to the fact that Perungudi vard is on marshland and water is available through the year and these microplastics go down into the groundwater along with the water in the marshland.

He said. "With houses across the city using single use surgical masks and N95 masks, the pro portion of these microplastics entering the water bodies could be much higher in the days to come.

Doctors also warned that drink ing water contaminated with microplastics could lead to skin ailments, ulcers, and serious respiratory illness in some people.

Ramesh Chandradas, a gastroenterologist with a leading private hospital in Chennai, speaking to IANS said, "Regular usage of water with microplastics would lead to the formation of ulcers as well as intestinal issues and can also become cancerous in the long run.'

# Fishing ban ends, but fewer boats to venture into sea

Chennai, June 15: Even as the fishing ban in Tamil Nadu ended Monday midnight, less fishing boats are likely to venture into the sea for deep-sea fishing. Around 1.200 fishing boats are attached to the Kasimedu fishing harbour and

only about 350 of these are likely to venture into the sea Tuesday. Officials with the fishing har-

bour said that most of the fishing boats require maintenance and re pair and hence these cannot go

into to sea. Most of the boats will complete the maintenance work and take to the sea in a fortnight, officials said.

Another issue faced by the fishing harbour and fishermen is that

there is no money for maintenance as most of the fishermen have not been working since lockdown commenced.

Most of the fishermen who frequent Kasimedu market are from Andhra Pradesh and Odisha and a large number of these fishermen have left for their home states following lockdown and lack of jobs.

At present the wholesale fish stalls of the Kasimedu market are functioning and with the lockdown getting lifted the retail market will also be opened as the fishermen community is expecting a government announcement on the opening of the retail market soon.

Rajesh Thomas, a software engineer with an MNC while speaking to IANS said, "We were regulars at the Kasimedu market where most of the Chennai populace go to purchase fish. However, the market was shut down and fish was a rarity and we expect things to be normal, maybe in a week's time."

The market will be abuzz once the number of fishing boats ventures into the sea increases and even if a boat goes into the deep sea, it will return back in more than a –( week's time and only then the market will normalise.

# LJP FIGHT **'SACKED' CHIRAG EXPELS 5 REBEL MPs** SC CLOSES ALL

EARLIER IN THE DAY, CHIRAG PASWAN LIKENED THE PARTY TO A MOTHER WHO SHOULD NOT BE 'BETRAYED'

New Delhi, June 15: Hours after Chirag Paswan, son of late Union Minister and party founder Ram Vilas Paswan, was removed as LJP President in an emergency meeting Tuesday by the five rebel MPs, he held a parallel executive committee meeting virtually where it was decided to expel the five MPs for anti-party activities.

Earlier in the day Chirag Paswan was removed from the post of LJP President in an emergency meeting, party sources said.

The principle of "One Man, One Post" was invoked by the rebels, led by his uncle Pashupati Kumar Paras, to remove him from the post, the sources said.

The removal of Chirag Paswan from the top party post came a day after five of six party MPs -- Paras, Chandan Singh, Chaudhury Mehboob Ali Kaiser. Beena Devi. and Prince Raj -- undertook a coup and removed him as the LJP leader in the Lok Sabha.

Sources said that Suraj Bhan will function as working President until a new President is elected in a national executive meeting, which is expected soon in the com-



ing days. The parallel executive, chaired by Chirag Paswan, passed a resolution expelling the five MPs. "The National Executive Committee has unanimously decided to remove Pashupati Kumar Paras, Beena Devi, Chandan Singh, Chaudhary Mehboob Ali Kaiser and Prince Raj from the primary membership of LJP with immediate effect," said the resolution, according to a release by LJP General Secretary Abdul Khaliq said. "The National Oresident of LJP Chirag Paswan is authorised

to take all decisions in the coming assembly elections on behalf of the party,"it said. Earlier in the day, Chirag Paswan likened the party to a mother who should not be "betrayed".

In an emotional tweet in Hindi, he said, "I made efforts to keep the party founded by my father Ram Vilas Paswan and my family together but failed. People are above all else in a democracy. I thank those who had faith in the party." Paswan also shared a six page letter he had written to Paras,

**ITALIAN MARINES CASE**

New Delhi, June 15: The Supreme Court Tuesday closed all criminal proceedings pending in India against two Italian marines, accused of killing of two Indian fishermen off Kerala coast in 2012, after payment of Rs 10 crore compensation by Italy.

A bench comprising Justices Indira Banerjee and M.R. Shah said considering the international tribunal order, India has agreed to the compensation of Rs 10 crore and Republic of Italy has deposited it, which has been transferred to the top court's registry. "We are satisfied with the compensation and the ex-gratia paid over and above earlier. This is a fit case to close all proceedings in India under Article 142 of the Constitution," said the bench.

The bench noted as per the tribunal order. Italy will resume the criminal proceedings against the marines. The top court ordered transfer of Rs 10 crore to Kerala High Court registry out of which Rs 4 crore each should be paid to the two victims' families and  $\operatorname{Rs} 2$ crore to the boat owner. The bench added the High Court should ap-



point a judge to ensure the compensation is paid to the victims' legal heirs.

Citing the tribunal order, the top court noted that Italy can begin criminal proceedings against the two marines, and case details along with evidence will be provided by the Centre and the Kerala government to it.

In February 2012, India had accused two Italian marines, Salvatore Girone and Massimiliano Latorre, on board the MV Enrica Lexie - an Italian flagged oil tanker -- of killing two Indian fishermen who were on a fishing vessel in India's Exclusive Economic Zone (EEZ). The top court in August last year had told the Centre that it would not pass any on closure of cases against the two marines without hearing the victims' families.

# All applications for Haj 2021 cancelled

# '₹150 per Covaxin dose unsustainable'

New Delhi, June 15: The supply price of Covaxin to the government of India at Rs 150 a dose is a non-competitive price and clearly not sustainable in the long run. Hence a higher price in private markets is required to offset part of the costs, Bharat Biotech said

Tuesday. It said there are live examples of such pricing policies where Human Papilloma virus vaccine is priced for GAVI supplies at \$4.5/dose (Rs 320), but is also available in the private market at Rs 3,500.

Rotavirus vaccines are supplied to the Govt of India at Rs 60/dose, but is also available in the private market at Rs 1,700/dose. The prices for COVID-19 vaccines internationally have varied between \$10 to \$37/dose, (Rs 730 - Rs 2,700/dose). On why Coaxin is more expensive for the private sector, Bharat Biotech said another key point of discussion has been about pricing our vaccines for private sector players which is significantly higher than that given to governments and large procurement agencies.

Unlike most medicines

and therapeutics, vax are provided free of cost by the Govt of India to all eligible Indian citizens

This is purely due to fundamental business reasons, ranging from low procurement volumes, high distribution costs and retail margins among few others

# Kashmiri political activist held

Ganderbal (J&K), June 15: A political activist has been jailed after he told an advisor of the Lt governor that he has hopes from a Kashmiri official like him rather than bureaucrats from outside, remarks which offended the Ganderbal deputy commissioner who is an IAS officer from Uttar Pradesh.

After being arrested under Section 153 (promoting enmity between different groups) of the Indian Penal Code, Sajad Sofi (50), a resident of Wani Mohalla in Safapora area of Ganderbal district, was granted bail by a court. However, he was kept under preventive detention for allegedly being a "threat to peace'

CPI(M) leader Mohammad Yousuf Tarigami on Tuesday termed Sofi's arrest "unwarranted" and "a brazen violation of fundamental rights". Sofi made the remarks at a 'Janta Darbar' of LG advisor Baseer Khan at Mansbal on June 10.

Speaking about the problems faced by the people of his area, Sofi told Khan that he can understand the issues better as compared to officers from outside the union territory because he is a local, according to the police report. He said, "I can have expectations from you because you are a Kashmiri and you can understand us. I can grab you by the collar and seek answers. But what expectations can I have from officers who are outsiders?'

This comment did not go down well with Ganderbal Deputy Commissioner Krittika Jyotsna, a 2014 IAS officer and wife of Rahul Pandey, who is posted with the Raj Bhavan as the director of information Jyotsna and Pandey came to Jammu and Kashmir in February this year on inter-cadre deputation. The police report said that Jyotsna stood up from her seat and "strongly objected" to Sofi's comments.



"Hence it has been decided by the Haj Committee of India that all the applications for Haj-2021 stands cancelled," the circular signed by Haj Committee of India's Chief Executive Officer Magsood Ahmed Khan read. Lauding Saudi Arabia's decision in the wake of the Covid-19 pandemic, Minority Affairs Minister Mukhtar Abbas Naqvi told reporters, "We had made all the preparations for Haj. However, Saudi Arabia has not allowed people from outside the country to perform Haj in view of the coronavirus pandemic. This is a good decision.'

# 'Imaging objects through fog may now be more clear'

New Delhi, June 15: Imaging of objects in foggy weather conditions may now be clearer as researchers have now found a method that can improve the images captured on such days

The technique involves modulating the light source and demodulating them at the observer's end. Research by a team has offered a solution for improving the image quality without heavy computations.

The team from the Raman Research Institute (RRI), Bangalore, an autonomous institute of the Department of Science and Technology; Space Applications Centre, Indian Space Research Organisation, Ahmedabad; Shiv Nadar University, Gautam Buddha Nagar; and Universite Rennes and Universite Paris-Saclay, CNRS, France, modulated the light source and demodulated it at the observer's

end to achieve sharper images.

The research was published in the journal 'OSA Continuum', said the Ministry of Science and Technology in a statement. The researchers have demonstrated the technique by conducting extensive experiments on foggy winter mornings at Shiv Nadar University. They chose ten red LED lights as the source of light. Then, they modulated this source of light by varying the current flowing through the LEDs at a rate of about 15 cycles per second.

The researchers kept a camera at a distance of 150 metres from the LEDs. The camera captured the image and transmitted it to a desktop computer. Then, computer algorithms used the knowledge of the modulation frequency to extract the characteristics of the source. "This process is called 'demod-

ulation'. The demodulation of the image had to be done at a rate that



was equal to the rate of modulation of the source of light to get a clear image," said the statement. The team saw a marked improvement in the image quality using the modulation-demodulation technique. The time the computer takes to execute the process depends on the image's size.

"For a 2160 X 2160 image, the

computational time is about 20 milliseconds," shares Bapan Debnath. PhD scholar at RRI and a co-author of the study, adding that is roughly the size of the image containing the LEDs.

Debanath's colleagues had estimated the rate in 2016. The team repeated the experiment a few times and observed the improvement

each time. Once, when the fog varied in intensity during the observation, they did not record a marked improvement in the image quality. In this case, there was a strong wind, and they observed fog trails across the scene. The density of the water droplets in the air changed as time passed, which rendered the modulation-demodulation technique less effective. Next, the researchers changed the experimental setup. They made an external material, a piece of cardboard kept at a distance of 20 centimetres from the LEDs, to reflect the light to the camera. The distance between the cardboard and the camera was 75 metres. The modulated light reflected from the cardboard travelled through the fog and was then captured by the camera. They demonstrated how their technique still significantly improved the quality of the resulting image. Repeating the experiment under

sunny conditions, they found that after performing the demodulation of the source, the image quality was high enough to distinguish the LEDs from the strongly reflected sunlight.

The study was partially funded by the Ministry of Science and Technology, Government of India. The cost of the technique is low, requiring only a few LEDs and an ordinary desktop computer, which can execute the technique within a second.

New Delhi, June 15: Chief of Army Staff Gen MM Naravane Tuesday led the force in hailing the valour of the 20 soldiers who laid down their lives while defending the country's territorial integrity in the face of "unprecedented" Chinese aggression at the Galwan Valley in eastern Ladakh a year ago.

On the first anniversary of the deadly clashes, the Army said the supreme sacrifice of the soldiers while fighting the adversary in the "most difficult" high altitude terrain will be "eternally etched" in the memory of the nation.

"General MM Naravane #COAS & All Ranks of #IndianArmy pay homage to the #Bravehearts who made supreme sacrifice in Galwan Valley #Ladakh while defending the territorial integrity and sovereignty of the country. Their valour will be eternally etched in the memory of the #Nation," the Army tweeted. In the first deadly clash in the border area in nearly five decades, 20 Indian soldiers were killed June 15 last year in the Galwan Vallev in fierce hand-to-hand combat with Chinese troops, triggering a large deployment of troops and heavy weaponry by both armies at the friction points in eastern Ladakh. In February, China officially acknowledged that five Chinese military officers and soldiers were killed in the clashes with the Indian

New Delhi, June 15: Pakistan is increasing its capacity to produce plutonium for use in nuclear weapons in tune with an increase in global stockpiles of atomic weapons, missiles and aircraft delivery systems, led by the United



States and Russia who appear locked in competition to modernise their nuclear warheads The raw material for nuclear

weapons is fissile material, either highly enriched uranium (HEU) or separated plutonium. China, France, Russia, the United Kingdom

and the USA have produced both HEU and plutonium for use in their nuclear weapons. The Indian and Israeli arsenal is mainly plutonium based.

So far, Pakistan has mainly relied on HEU for its stockpile of around 165 nuclear weapons as per the latest estimates. But Islamabad appears to be diversifving, by enhancing its ability to produce weapon-grade plutonium, according to the findings of the Stockholm International Peace Research Institute (SIPRI)

Released Monday, the SIPRI Yearbook 2021 assesses the current state of armaments, disarmament and international security. A key finding is that despite an overall decrease in the number of nuclear warheads in 2020, more have been deployed with operational forces.

While the US and Russia continued to reduce their overall nuclear weapon inventories by dismantling retired warheads in 2020, both are estimated to have had around 50 more nuclear warheads in operational deployment at the start of 2021 than a year earlier. says the report.

The report said that at the start of 2021, the United States, Russia, the United Kingdom, France, China, India, Pakistan, Israel and the Democratic People's Republic of Korea (DPRK, or North Korea) possessed approximately 13,080 nuclear weapons, of which 3825 were deployed with operational forces. Approximately 2000 of these are kept in a state of high operational alert.

Uncertainty about Pakistan's uranium resources, and the operating history and enrichment capacity of its centrifuge plant at Kahuta and a possible second plant at Gadwal (which may be dedicated to HEU production) limits the reliability of the estimate, the panel says in its country report on Pakistan.

Assailing the march as a "provocation", Palestinians called for "Day of Rage" protests in Gaza and the Israeli-occupied West Bank, with memories still fresh of confrontations between Israeli police and Palestinians during the Muslim holy month of Ramadan.

The march was originally scheduled for May 10 as part of "Jerusalem Day" festivities that celebrate Israel's capture of East Jerusalem in the 1967 Middle East war.

"While more research is needed to determine whether targets aimed

successful therapeutic intervention, it is important that we continue to develop therapies for patients with Covid-19. Covid-19 vaccines will continue to be unavailable to many people throughout the world, and it is important that we provide effective treatments to them and to those with breakthrough infections," he said.

To understand why that clotting happens, the researchers analysed blood samples that were taken from patients with Covid-19 in the Beaumont Hospital Intensive Care Unit in Dublin.

When compared to control

groups, the blood of Covid-19 patients had higher levels of the proclotting VWF molecules and lower levels of the anti-clotting ADAMTS13. Furthermore, the researchers identified other changes in proteins that caused the reduction of ADAMTS13.

The comments come as major U.S. technology firms including Twitter Inc and Facebook Inc are at loggerheads with the government over issues such as data privacy bills and policies some industry executives have called protectionist.

The Competition Commission of India (CCI) initiated a probe in January last year on the basis of a complaint alleging Amazon and Flipkart promoted select sellers on their e-commerce platforms and that deep discounts stifled competition. The companies have denied wrongdoing.

Near-immediate legal challenges from the pair stalled the probe for over a year until a court last week allowed it to resume, having dismissed arguments that the CCI lacked evi-

dence. Though Amazon and Flipkart are likely to appeal, the CCI plans to demand information from them related to the allegations "as quickly as possible", said one of the people, who declined to be identified due to the sensitivity of the matter.

# Big Tech faces EU blow in national data watchdogs ruling REUTERS

Brussels, June 15: Facebook and other Silicon Valley giants could face more scrutiny and sanctions in the European Union after the bloc's top court backed national privacy watchdogs to pursue them, even when they are not their lead regulators. Consumer lobbying group BEUC welcomed Tuesday's ruling by the EU Court of Justice (CJEU), which backed the right of national agencies to act, citing enforcement bottlenecks

Along with Google, Twitter and Apple, Facebook has its EU headquarters in Ireland, putting it under the oversight of the Irish data protection regulator under privacy rules known as GDPR, which allow

global turnover for breaches. The CJEU got involved after a Belgian court sought guidance on Facebook's challenge to the territorial competence of the Belgian data watchdog, which was trying to stop it from tracking users in Belgium through cookies stored in the company's social plug-ins, regardless of whether they have an account or not. "Most Big Tech companies are based in Ireland, and it should not be up to that country's authority alone to protect 500 million consumers in the EU, especially if it

does not rise to the challenge," **BEUC Director General Monique** Govens said. Several national watchdogs in the 27-member EU have long complained about their Irish



counterpart, saying that it takes too long to decide on cases. Ireland has dismissed this, saving it has to be extra meticulous in dealing with powerful and well-funded tech gi-

ants. Ireland's cases in the pipeline include Facebook-owned Instagram and WhatsApp as well as Twitter, Apple, Verizon Media, Microsoftowned LinkedIn and U.S. digital

advertiser Quantcast. "Under certain conditions, a national supervisory authority may exercise its power to bring any alleged infringement of the GDPR before a court of a member state, even though that authority is not the lead supervisory authority," the CJEU said.

Judges said these conditions include regulators following cooperation and consistency procedures set out in the GDPR and that the violations occurred in the relevant EU country. "We are pleased that the CJEU has upheld the value and principles of the one-stop-shop mechanism, and highlighted its importance in ensuring the efficient and consistent application of GDPR across the EU," Jack Gilbert, Facebook's associate gen-

eral counsel, said.

Tech lobbying group CCIA said the ruling could lead to inconsistent and uncertain enforcement and jack up costs. "It has also opened the back door for all national data protection enforcers to start multiple proceedings against companies," CCIA Europe senior policy manager Alex Roure said.

"Data protection compliance in the EU risks becoming more inconsistent, fragmented, and uncertain. We urge national authorities to be cautious about launching multiple proceedings that would weaken legal certainty and further complicate data protection compliance in the EU," he said.-The case is C-645/19 Facebook Ireland & Others.

Records for Ronaldo as Portugal score thrice in eight minutes against Hungary to begin their title defense at Euro with win

Budapest, June 15: Cristiano Ronaldo scripted a few records to his name at European Championships as he now stands alone as the all-time record goal scorer in the competition's history as well as becoming the first player to feature at five finals tournaments in Portugal's 3-0 win over Hungary here in front of more than 60,000 fans, Tuesday. Ronaldo converted an 87th-

minute penalty for his 10th goal in the competition, overtaking France's Michel Platini's nine goals His 11th came only a few minutes

later when he took the ball around goalkeeper Peter Gulacsi for Portugal's third.

At 36 years, 130 days, Ronaldo became oldest player to score for Portugal at a major tournament, breaking the record set by Pepe at World Cup 2018 (35 years, 124 days). The Juventus star also become

the oldest player to score at least two goals in a European Championship match, breaking the record set by Andriy Schevchenko when he was 35 years, 256 days.

Hungary had looked on course for an unlikely draw until they conceded three times late on - in eight minutes. The deadlock was broken in the 84th minute when Raphael Guerreiro's shot with the outside of the foot took a massive deflection off defender Willi Orban to break Hungary's brave resistance. The result looked comprehensive, but Portugal had to work hard

to defeat their opponents in front of the biggest attendance of the tournament so far. Hungary were mostly restricted

to long-range shots straight at goalkeeper Rui Patricio. However, home substitute Szabolcs Schon thought he had scored when he squeezed a shot in at the near post, but the goal was correctly ruled out for offside.

Portugal got their fortunate opener soon afterwards before Ronaldo's penalty after Orban had fouled Rafa Silva. Ronaldo then had the final say in injury time as he showed great skill to round Gulacasi for his second and Portugal's third

**Resilient Sweden hold** misfiring Spain at Euro

Seville, June 15: The chances came and went but neither Spain nor Sweden managed to put any of them in the net. Spain dominated possession and kept the pressure on the opposing area for most of the match but the Swedes held on for a 0-0 draw Monday at the UEFA Euro 2020.

Sweden managed only a few chances at La Cartuja Stadium, but they were some of the most dangerous ones. Alexander Isak who plays for Spanish club Real Sociedad, had a shot from inside the area hit the post after deflecting off Spain defender Marcos Llorente in front of the goal line.

Early in the second half, Marcus Berg was inside the area with the ball coming his way, but he mishit his shot. Alvaro Morata had Spain's best chance just a few minutes before Isak but his shot missed wide with goalkeeper Robin Olsen the only opponent to beat.

Morata had already missed some chances and been jeered in Spain's final warm-up match against Portugal, also a 0-0 draw. Spain pressed until the end Monday but kept misfiring. Olsen

made a 90th-minute save off a header by substitute Gerard Moreno, and he had already stopped another close-range header by Dani Olmo in the first half.

Spain ended with 75 per cent of possession and had 17 total attempts, with five on target. Sweden missed the target on their four attempts.

Spain had failed to score in only one of their last 14 group matches at Euro. Sweden hadn't drawn any of their last 17 international matches, since a tie against Spain in qualifying for Euro 2020.

The entire Spanish team was vaccinated just days before its opening match. Luis Enrique started with Rodri in Busquets' position. with youngster Pedri and Koke alongside him in the midfield. The 18-year-old Pedri became Spain's youngest ever player at the meet.

### 2022 CWG: EVES' T20 **EVENT JULY 29-AUG 7**

NEW DELHI: The Commonwealth Games' (CWG) women's T20 competition, which will make its debut at the quadrennial showpiece next year, will be played from July 29 to August 7 at the Edgbaston Stadium, the organisers announced Tuesday. The group stage matches of the eight-team competition are slated to be held till August 4 and the semifinals are scheduled for August 6. The bronze medal match will be played August 7 followed by the summit clash on the same day. "With 11 days of swimming and diving, 8 days of cricket, 8 days of gymnastics and 7 days of athletics, including the marathon, the summer of 2022 is set for a spectacular home Games," the official website stated. It will only be the second time that cricket will feature in the event after a men's 50-over competition was part of the Games in Kuala Lumpur in 1998.

Rio de Janeiro, June 15: Lionel Messi scored a stunning free-kick, repeatedly dribbled through the Chilean defense and created opportunities regularly for his Argentina teammates.

Despite Messi's intense performance, Argentina was held 1-1 by Chile in their Copa America opener. The game at the Nilton Santos stadium here was also marked by a tribute to Argentine football great Diego Maradona, who died in November at age 60.

Messi, who turns 34 this month, might have one of his final chances of winning a title with Argentina at the Copa America. He said ahead of opening game that winning with his national team is "the biggest dream" of

his decorated career, despite all the individual success and club titles with Barcelona.

Argentina appeared to be ready to start giving Messi what he craves. Coach Lionel Scaloni's line-up wasted three clear opportunities between the 16th and 18th minutes, one from Lautaro Martinez and two for Nicolas Gonzalez.

And then Messi opened the scoring in the 33rd after a free-kick that Chilean goalkeeper Claudio Bravo couldn't stop despite getting a touch on the ball to his left. Argentina continued to pressure Chile, which was missing injured striker Alexis Sanchez.

But Chile transformed into a more attacking team in the second half and earned a penalty after video review. Arturo Vidal's shot from the spot was stopped, but Eduardo Vargas

nodded into the empty goal to level the scoring in the 57th.

Messi continued to create opportunities until the end of the match, but his teammates showed the same difficulty to deliver goals as they did in the 2-2 draw at Colombia in a World Cup qualifier in Barranquilla last week. The superstar also complained about the apparently irregular pitch at the stadium.

"This match got complicated to us," an exhausted Messi said after the draw. "We needed to be calm, have the control of the possession and play more quickly. The penalty changed the match, too."

Paraguay lead group A after a 3-1 win over Bolivia at the Olimpico stadium in Goiania. Bolivia scored first via Erwin Saavedra's firsthalf penalty, but Paraguay changed their fortunes after the break with goals by Alejandro Romero and a brace by Angel Romero.

Argentina's next match is against Uruguay Friday. Chile will face Bolivia on the same day. Paraguay return to action next Monday against Messi's team.

# TRIBUTE TO DIEGO MARADONA

RIO DE JANEIRO: Diego Maradona's life was honored in a tribute featuring lights and projections onto the pitch before Argentina's Copa America opener against Chile. No fans were present at the Nilton Santos stadium for the latest tribute to the Argentine football great, this one organized by South American football body CON-

MEBOL. Maradona died at age 60 last November. The 3-minute video, which was shared by CONMEBOL's social media channels, had "Live is Life" by Opus as its soundtrack. It's the same song that was on as Maradona famously warmed up with Napoli ahead of a UEFA Cup semifinal against Bayern Munich in 1989. The tribute video featured a holographic of Maradona doing kick-ups while his shirt changed colors to represent all the teams he played for: Argentinos Juniors, Boca Juniors, Barcelona, Napoli, Sevilla, Newell's Old Boys and Argentina. It also featured images of some of Maradona's most representative moments; as a kid talking about his desire to play in the World Cup; receiving the trophy from Mexico's president in 1986; and his goals against England in that World Cup. The tribute ends with Maradona's speech during his goodbye to Boca Juniors in 2001 at the La Bombonera stadium. "May this party never end. May this love you have for me never end," Maradona said then. The projection ends with his year of birth and the infinity symbol.

### **MITHALI & CO BACK IN WHITES AFTER NEARLY** SEVEN YEARS AS THEY FACE ENGLAND TODAY

Bristol, June 15: A favourable record in England and 'positive mindset' despite inadequate preparation time will spur the Indian women's cricket team when they take on the seasoned hosts in their first Test engagement in nearly seven years here from Wednesday. After multiple quarantines in

India and UK, the Mithali Raj-led squad got little over a week to prepare for their first red ball game since November 2014. Mithali was among the seven current players, who were a part of that victorious eleven against South Africa in Mysuru.

While experienced players like the skipper, her deputy Harmanpreet Kaur, Smriti Mandhana and Jhulan Goswami have not played red ball cricket at all in recent times, it will be an even tougher test for the younger lot who don't get to play first-class matches in domestic cricket.

The women prepared only in the nets, which might hurt them in the four-day game. Harmanpreet has already conceded they got limited time to get ready for the one-off Test but said India go into the game 'mentally prepared', having got some valuable advice from men's team vice-captain Ajinkya Rahane.

There is a good chance that 17year-old batting sensation Shafali Verma opens in the game alongside Mandhana. The experienced trio of Mithali, Harmanpreet and Punam Raut will be expected to do the job in what will be challenging conditions for them also.

There could be some respite in store for the batters with England choosing Kookaburra over Dukes ball, which does more, for the game as the home team builds up to the Ashes Test against Australia later in the year.

It also remains to be seen if veteran pacers Jhulan Goswami and Shikha Pandey would be able to bowl long spells, having not done so for a long time. The spinners, who had a forgettable time at home in the limited overs series against South Africa, would be be itching to make amends.

The visitors can surely take heart from their past record in England where they have not lost in eight games, having won two out of them.
