**SWEET SHOPS, CONFECTIONARIES CAN OPEN AS PER NEW TIMINGS**

Bhubaneswar, June 16: In spite of the decrease in Covid-19 cases in the state, the Odisha government said Wednesday that partial lockdown will continue till July 1, but with some relaxations. The Odisha government had imposed lockdown from May 5 to 14, which was first extended to June 1 and sub-

sequently to June 17 (5.00am). Briefing mediapersons here, Chief Secretary Suresh Chandra Mahapatra said, 'To break the chain of

Covid-19 infection, the government had imposed lockdown in three phases beginning May 5. With the support and cooperation of people and Covid warriors, the state has managed to overcome the peak of infections. Test positivity rate (TPR) which a week ago was

around 15% has come down to six per cent," he said. The chief secretary said that the 30 districts of Odisha have been divided into two groups on the basis of active caseload. The 17 southern and western districts have been marked as Category A, where the TPR has come down below five per cent. The remaining 13 where TPR is high have

been put in Category B The Category A districts are Sundargarh, Jharsuguda, Sambalpur, Deogarh, Bargarh, Subarnapur, Kandhamal, Boudh, Koraput, Malkangiri, Nabarangpur, Rayagada, Ganjam, Sonepur, Gajapati, Kalahandi and Nuapada. As the TPR in these districts are below five per cent, some relaxations like opening of shops from 6.00am to 5.00pm have been allowed. Street vendors have

also been allowed to oper-

Bhubaneswar, June 16: The Jagannath Temple in Puri will remain closed for devotees till July 25, chief administrator of the Shree Jagannath Temple Administration (SJTA), Krishan Kumar said Wednesday. The decision was taken during a meeting Wednesday with servitors' body, 'Chhatisha Nijog'

in Puri. As per instructions of Odisha government, the annual Rath Yatra festival will be held without devotees from July 12 to July 23. Two days have been kept in hand, so that the decision to open the temple can be taken after reviewing the situation, post

the chariot festival. The SJTA has also decided that the upcoming Deba Snana Purnima, the day which marks the grand bathing rituals of the Lords will be held June 24. This

will also be done sans devotees. All the rituals will be conducted by the servitors and SJTA officials. The temple has remained closed for devotees from

May 5 to till date and now it has been extended to July 25. In view of the Covid-19 situation. a bio-bubble has

been created at 'Rath Yard', the workplace where construction of the chariots is currently on. This is to ensure a Covid-free environment for those involved in the building of the chariots.

It should also be stated here that the Puri district administration has imposed curfew during the entire duration of the festival like it did last year.



# Covishield dosage gap may be changed again

New Delhi. June 16: India will revisit the dosage interval for Covishield vaccine and take appropriate action based on emerging data, NK Arora, chairperson of the working group of immunisation advisory body NTAGI, said Wednesday. Describing the Covid-19 and vac-

cination situation as 'very dynamic', Arora said in a statement that emerging evidence and reports regarding efficacy of partial versus full immunisation are also under consideration. On the decision to increase the gap

between two doses of Covishield from four-six weeks to 12-16 weeks, Arora said the move was based on scientific decision and there was no dissenting voice among the National Technical Advisory Group on Immunisation (NTAGI) members.

"Covid-19 and vaccination are very dynamic. Tomorrow, if the vaccine platform tells us that a narrower interval is better for our people, even if the benefit is 5-10%, the committee will take the decision on the basis of merit and its wisdom. On the other hand, if it turns out that the current decision is fine, we will continue with it," a Union Health Ministry statement quoting Arora said.

The NTAGI chairman also explained the reason behind widening the gap

NEW DELHI: Facts have been 'twisted and mis-

vhich suggested that indigenously developed Covaxin contains newborn calf serum, the Union Health Ministry said in a statement Wednesday. Newborn calf serum is used only for the preparation and growth of vero cells that have been used for decades in developing vaccines against polio, rabies and influenza. The vero cells are completely destroyed in the process of viral growth. Thereafter, the grown virus is also killed (inactivated) and purified. The inactivated virus is then used to make the final vaccine. No calf serum is used in the ormulation of the final vaccine, the statement

vaccines," he said. In the last week of April, the data released by Public Health England, United Kingdom's executive agency of the Department of Health, showed that vaccine efficacy varied between 65 and 88 per cent when interval is 12 weeks. "This was the basis on which they overcame their epidemic outbreak due to the Alpha variant. We also thought that this is a good idea, since

there are fundamental scientific reasons to show that when interval is increased, adenovector vaccines give better response. Hence the decision was taken May 13, to increase the interval

to 12-16 weeks," informed Arora. 12-16 weeks," Arora added.

"We have a very open and transpar ent system where decisions are taken on scientific basis. The Covid-19 group took that decision, with no dissenting voice. ## **FUEL PRICES HIKED AGAIN**

New Delhi, June 16: Fuel rates increased again Wednesday across India adding more misery for the common man already grappling with rising food prices amidst shrinking incomes. With the latest hike Wednesday, petrol prices have reached very close to hitting the century-mark all across India. Petrol prices have already crossed the ₹100-mark in certain cities and towns of Maharashtra, Madhya Pradesh, Rajasthan, Telangana, Andhra Pradesh.

Petrol price was hiked by 26 paise per litre while diesel prices rose by

13 paise for the same quantity on the day all across India.

Petrol in the national capital now costs ₹96.66 per litre while the rate of diesel is ₹87.41 per litre. In Mumbai, where petrol prices crossed ₹100 mark for the first time ever May 29, the fuel rate reached a new high of ₹102.82 per litre Wednesday. Diesel prices also went up to ₹94.84 a litre, the high-

est among all metros. With Wednesday's price hike, fuel prices have now increased on 25 days and remained unchanged on 22 days since May 1. The 25 increases have hiked petrol prices by ₹6.26 per litre. Similarly, diesel prices have increased by ₹6.68 per litre across India.

# Coke tanks USD 4bn after Ronaldo act

#### RONALDO PROMOTES WATER AS HEALTHIEST DRINK DURING EURO 2020 PRESSER

Budapest, June 16: Irrespective of where he plays and how he plays Cristiano Ronaldo (also called CR7) commands a huge fan following. Every action he commits has a cascading effect. Soft drink giants Coca-Cola will be the first to verify the fact. One act of Ronaldo during the press conference ahead of the Portugal-Hungary game played Tuesday was enough for Coca-Cola to lose a whopping USD 4 billion.

Just before the press conference was about to begin, Ronaldo picked up two bottles of the soft drink kept on the table and moved them afar. He then picked up a bottle of 'Agua' (water in

Portuguese) and displayed it. The Portuguese legend, it was clear, was encouraging people to drink water instead of any carbonated drink. While doing so, Ronaldo wore a deadpan face with a tinge of derision.

As the video of the event went viral, it was enough for Coke, one of the Euro 2020 sponsors, to see its market value drop by USD 4 billion. Coca-Cola's share price dropped from USD56.10 to USD55.22 by the end of the press conference – a 1.6 per cent decrease. The market valuation of Coca-Cola went down from USD 242 billion to USD 238 billion in a matter of few hours.

Coca-Cola is one of the official sponsors of Euro 2020 because of which the bottles were placed for marketing on the table.

Ronaldo, one of the most famous and top footballers of the world, is a fitness fanatic. It is a fact wellknown by his nearly 300 million Instagram followers.

To make matters worse for the soft drink company, Ronaldo scored twice during the 3-0 win against Hungary setting a record at the European Championship finals with 11 goals as he went past Michel Platini. As a result he became one of the most trending topics on various social media platforms after the game.

Coca-Cola also decided to put in a statement after Ronaldo's act. It said 'everyone is entitled to their drink

Bhubaneswar, June 16: Several health experts Wednesday threw light on the post Covid health issues and tried to allay the fears of

Jayant Panda from the department of medicines at SCB Medical College and Hospital in Cuttack said the post Covid health issues, referred as 'Long Covid', could persist up to three months.

"We have seen symptoms like insomnia, lack of hunger, diarrhoea, headache, nausea, cough and chest pain in people who have recovered from Covid. We call them post Covid issues. In some cases, we have seen health issues in patients even after three months of their recovery from Covid,' Panda added.

He also said, "There are also cases of neuro psychiatric issues, increased heartbeat and loss of memory. Women, elderly people and those who had been hospitalised for longer period due to Covid infection are more vulnerable to post Covid issues. People with co-morbidities also suffer from such issues.3

in kids. "We do not see prolonged post Covid health issues in Children. However, cases of loss of smell and taste could be seen among them for four to six weeks,' he said.

Banambar Ray, Critical Care Unit chief of SUM Ultimate Hospital, briefed the people about use of ECMO machine in Covid patients.

"Through ECMO machine, we purify the blood which is usually done by lungs in a human body. The machine is used in Covid patients whose lungs have been com-

promised. In the past, we had seen its utility in cases of swine flu. In cases of pneumonia or acute distress syndrome and lung fibrosis, the machine is also being used." he said

He also added, "Doctors were using ECMO in lungs transplant process much before Covid-19 pandemic. We can use ECMO machine on Covid patients for several months. But, it is not a treatment. It is just a support system. There are also side effects of ECMO use, including bleeding and infec-



## Panel soon for shifting of iconic warrior-horse replica

Bhubaneswar, June 16: The Bhubaneswar Development Authority (BDA) will soon constitute an expert committee that will prepare a detailed strategy to relocate the iconic warriorhorse statue at Master Canteen Square for the Smart Janpath project.

Erected in 1988 by the BDA itself, the ancient replica of the famous sculpture of Sun Temple showcasing a warrior with the horse, will make way for the proposed multi-modal hub project at city railway station. While the Culture department has given approval for relocation of the statue, BDA has been entrusted with shifting of the structure and will bear expenses involved in it.

"The replica along with other statues placed at the Master Canteen Square will be shifted to the roundabout at Governor House Square in front of Raj Bhawan and will be placed adjacent to the statue of Utkal Gourab Madhusudan Das. As it is an important landmark of the city, we will form an expert committee which will ensure that no harm is caused to the sculpture during its relocation," a BDA official said.

Although the statue is also an emblem adopted by the state government, the structure is set to lose its place to the ambitious multi-modal hub project which was proposed by the Odisha government in September 2019. An MoU signed between the BDA and East Coast Railway had planned

to develop a state-of-the-art railway station, coupled with city bus terminal, multi-level car parking among others, spread over an area of a whopping 1.74 lakh sq ft.

While the idea of relocation was proposed by the Bhubaneswar Smart City Limited (BSCL), the approval for the same was given by the Culture department after it was decided that the statue did not have 'ancient' status. As per the Ministry of Culture, any structure is considered ancient which is of historical, archaeological or artistic interest and has been in existence

for not less than 100 years. Moreover, sources said that the relocation was also given approval as the department felt that the structure will lose visibility as widening of roads for Smart Janpath and multimodal hub is set to begin. With ample space left at Governor's House roundabout, the structure will be safely placed in order not to lose the city's unique identity.

Addressing a presser, BJP leader and Opposition Chief Whip Mohan Majhi said 16.5 MMT of iron ore worth around Rs 10,000 crore is lying unsold at different iron ore blocks of the state.

He said the minerals should be sold as per the Mines and Minerals Development and Regulation (MIMDR) Act to increase the revenue of both the state and Union governments, create employment opportunities and maintain a balance in the competition in the steel industry sector.

The BJP leader said, "Prior to the outbreak of Covid-19 pandemic, 17 mining leases with a total capacity

of approximately 58 to 60 MMT of iron ore were auctioned in March 2020 in Odisha. Out of this, 16.5 MMT ore, including 8.5 MMT in Nuagaon iron ore block of Keonjhar district, worth around Rs 10,000 crore was available as on November 1, 2020, and could not be lifted within the prescribed seven months period as per the MMDR Act."

Majhi said the leaseholders had

moved the High Court for the extension of their lease period. But the High Court stated that the Principal Mines Secretary would take a decision on the issue and the decision would be binding on all parties.

Later, the Mines Secretary denied the extension and held that the minerals not lifted are deemed to be the property of the state gov-

"I would, however, request you to kindly consider giving free admission beyond any quota whatsoever and beyond any sanctioned number of seats in any Kendriva Vidyalayas in the country in any class to these orphaned children,' the MP said.

Since the session is about to begin and admissions are on, the usual process of government collecting the names from districts and states and then allocating them seats in various schools may not be a smart move at this point of time as it would be time consuming, Patnaik pointed out.

The MP added, "A much more humane approach would be to allow these children to walk in to any KVs of their choice and take admission based on certificates of death of their parents due to Covid-19.

## Link between nCoV & delivery modes ruled out

#### PREGNANT WOMEN URGED TO AVOID VACCINATION AGAINST COVID-19 DURING THE FIRST TRIMESTER

Bhubaneswar. June 16: Modes of childbirth are in no way linked to chances of transmission of novel coronavirus from pregnant women to children.

Gynaecologists from the city said that in most cases of pregnancy, Covid does not have much impact on the foetus and there is lack of any study indicating vertical transmission of Covid (transmission from mother to child).

"There is no need to induce labour or deliver by Caesarean section early because of Covid-19 infection. Decisions regarding mode of delivery should be taken as per



standard obstetric practice in most situations. C-section could be considered for women with respiratory problems," said Abhipsa Mishra, senior consultant at Utkal

Hospital here.

She also urged the pregnant women to avoid vaccination in the first three months of pregnancy but urged others to go ahead.

"Vaccination could be done in menstruating women. Females planning pregnancy can also take it. However, if vaccine is given inad-

vertently in a pregnant lady, termination of pregnancy is not needed," she said.

Others claimed that there has not been any concrete study to prove link between foetal abnormalities and Covid-infected pregnant women. However, experts warn of special care during the first and last three months of pregnancy.

"The first trimester and last trimester in pregnancy cases are crucial. Pregnant women should try to ward off the threat of exposure to the virus by adhering to Covid-appropriate behaviour like social distancing, wearing masks and staying indoors," said Veena Panda, another gynaecologist from the city.

The state government has made special arrangements and wards in government hospitals like SCB Medical College & Hospital and others for delivery care of Covidinfected women while some private hospitals too have started offering such services.

Although norms bar pregnant women from anti-Covid vaccinations, recently lactating mothers have been allowed to take the pro-

phylactic measures. The state government has recently denied transmission of Covid from lactating mothers to newborns if Covid-appropriate behaviour is followed.

Construction works are going on for last six years and there is no sign the bridges will get completed anytime soon. Moreover, the works are only halfway through despite funds worth ₹35,77,44,000 have already been spent in the projects.

The bridges are being constructed on Brahmani and Kharasrota rivers as well as Kani and Bhatia nullah in Bari, Jajpur, Rasulpur and Binjharpur blocks

The bridges under the jurisdiction of the Rural Works Division-1 in Jajpur are being constructed with the financial assistance provided by National Bank for Agriculture and Rural Development (NABARD).

The incomplete bridge has left the residents worried with monsoon making its arrival in the state. Residents apprehend that they will get cut off from the rest of the world if floods occur in the rivers during the rainy season.



They alleged funds worth ₹35 crore from Nabard has gone down the drain due to the non-completion of bridge works which has happened due to the apathetic and whimsical attitude of departmental

This has sparked resentment among the public as they demanded stringent action against the concerned engineers and contractors for the inordinate delay in construction of the bridge.

Reports said that Nabard as the financier has failed to achieve its target as the bridge works are moving at a snail's pace in Jajpur district. It is alleged that frequent political interference and kickbacks made in the projects are delaying their timely completion.

Reports available from the rural

works department said that the construction of a bridge in Kharasrota river under Bari block was started January 2, 2015. A plan outlay of ₹20.43 crore was made for the project out of which Nabard

It was targeted to complete the bridge by May 1, 2015. Funds worth ₹21.52 crore have been spent and more than three years have passed since the expiry of the deadline for the project but the bridge work is still incomplete.

sanctioned ₹15.35 crore

A plan outlay of ₹10.42 crore was made for construction of Jhalpada-Brahmabarada bridge on Brahmani river. The work for the bridge started December 16, 2016 and the deadline was scheduled for April 15, 2019. Meanwhile, funds worth ₹6.27 crore have been spent

₹2.67 crore was sanctioned for the twin projects. Works on the twin projects were started February 19.

2018 and were scheduled for com-

pletion by August 18, 2019. Meanwhile, funds worth ₹49.29 lakh have already been spent. While work on Bhatia nullah is yet to begin, the work on the bridge in Kani nullah is only halfway

Similarly, a plan outlay of ₹9.59 crore was made for the construction of a bridge on Brahmani river at Anikana village under Bari block. The bridge work was started July 10, 2018 and was scheduled to end by July 9, 2020. Funds worth ₹7.47 crore were spent on the project but it failed to get completed

When contacted, Bijay Kumar Moharana, executive engineer said that a fresh deadline has been made and the consultancy agencies have been asked to complete the bridge works by December, this year. He, however, said in a report that a change in design of the bridges under-construction has resulted in delay in their completion.

## Admin bars shopkeepers from opening shop without vaccination

Sundargarh, June 16: In a bid to motivate more and more people to take part in the vaccination drive to defeat the Covid pandemic, the district administration announced Wednesday that owners of business establishments who have not taken vaccines will not be allowed to open shops now.

On being directed, the Sundagarh municipality informed them about the new norms set by the district administration.

Meanwhile, the state government has announced partial relaxations to businesses to resume operations from 6am to 5pm daily except the weekends in as many as 17 districts.

Sub Collector Abhimanyu Behera informed the media persons about this Wednesday. He said, "As per the order issued by Sundargarh Collector-cum-administrator of Sundargarh municipality, the owners of businesses and shops of the town who have not taken vaccines may not be allowed

to open their establishments now."

the Covid management protocol is that it is executed for the welfare of the public, so people need to be come aware and cooperate with the authorities for enforcement of the guidelines for vaccination.

The initiative is aimed at motivating people to align with the norms of the government as a section of people are hesitant to the inoculation drive, he said

## Hostage drama: Youth denies any shame or guilt

Bolangir, June 16: A youth, who held three members of a family hostage at gunpoint in Shantipada area in this town the previous day, justified his act Wednesday.

the three hostages with the help of fire personnel. The girl he was in love with, happens to be the owner's niece and was not present at home.

Panda was nabbed in an operation which lasted for around five hours. Police also claimed that the youth fired a few rounds before he was nabbed.

Panda also admitted of having a firearm with him for the past two years which he had procured from Boudh.

Meanwhile, police registered two cases against Panda under various sections of Indian Penal Code and Arms Act and produced him in a court. A country made gun, two catridges and sharp-edged weapons were recovered from his possession. Further investigation into the purchase of the gun is underway, SDPO Tophan Bag said at a presser held in the town police station premises, Wednesday.

## Mitigate global threats

oth the COVID-19 pandemic and global warming are about survival, and are health crises at their core. But typology is not their only common feature. We can also expenses: mon feature. We can also overcome them in a similar way - by working with, rather than against, our human nature.

The alpha and omega of climate policy is reducing greenhouse-gas (GHG) emissions: the European Union aims to cut them by 55 per cent by 2030, and to achieve net-zero emissions by 2050. Our first reaction to these ambitious goals frequently is that we ought to eat less meat, fly less often, reuse what we use, and question our assumption that GDP must increase constantly. From this perspective, cutting GHG emissions seemingly entails a reduction of our current living standards.

Likewise, we initially tackled COVID-19 by curtailing social life, closing shops and businesses, and reducing civil liberties. That meant fewer contacts and fewer contracts. But it soon became clear that these measures were no more than a temporary quick fix. In our liberal Western societies, it is – fortunately – impossible to keep people locked up at home.

The fact that almost all countries have struggled through a second or even a third wave of infection shows that a strategy of 'less' cannot bring a durable victory over the pandemic. Humans are not built for 'less.' Although

people often are wrongly portrayed as being mere profit maximisers, we are without doubt born competitors. We love wheeling and dealing and making big plans to leave behind a better world for our children. But, as Aristotle observed we are also social animals par excellence.

Any climate-change policy that denies or ignores these fundamental traits is doomed to fail. After all, what initially slowed down the coronavirus was not brutal rule enforcement, but our sociability: the collective acknowledgement that every individual effort mattered and our willingness to shield others from harm by keeping our distance.

But what the pandemic showed, above all, was the power of human curiosity, which enabled us to develop COVID-19 vaccines in less than a year. The very concept of a vaccine – inject ing a weakened version of an actual virus into someone's bloodstream – is as daring as it is ingenious. Ever since Edward Jenner developed the first vaccine, against smallpox, in 1796, scientists have constantly modified and improved the technique. By the end of the twentieth century, vaccines were protecting billions from myriad diseases, including polio, diphtheria, yellow fever, typhoid fever, tuberculosis, hepatitis, rabies, and tetanus. Partly as

a result, average life expectancy in Europe has increased from under 40 years in the 1800s to about 80 today.

In the twenty-first century, this combination of incremental improvement and innovative breakthroughs resulted in the new mRNA technology that makes vaccine production more stable, and therefore faster and more predictable. Because of mRNA platforms, some COVID-19 vaccines can be adapted to coronavirus mutations almost overnight.

We should tackle the climate crisis in the same way. The strategy we need is not 'less'; it is 'more, but different.' That means reorganising our economy and investing in new technologies, while recognising that there is no silver bullet or miracle solution. Science and entrepreneurship are piecemeal: two steps forward, one step back, and then another two sideways before we progress again. Moreover, human creativity cross-pollinates economic activity. Today, electric vehicles still emit a significant amount of carbon dioxide indirectly. But in another decade or so, EVs will be close to zero-emission, and we will also fly carbon-free.

Innovation and competition are the flywheels that drive knowledge and innovation. The wind turbines of the 1980s and 1990s had steel rotor blades with a diameter of 17 meters (56 feet) and produced an average of 75 kilowatt-hours of electricity. Today's turbines have carbon rotor blades with an average diameter of 126 meters – bigger than an Airbus A380 – and produce 7,500 kilowatt-hours on average. That represents a 100-fold increase in production capacity in a little over 20 years.

Battery capacity has increased rapidly, too. The nickel-iron batteries of the 1970s were still pretty much the same as those Henry Ford used for his Model T. They pale in comparison to the lithium-ion batteries that today power whole cities such as Zhangbei, China. These leaps in innovation often do not appear fundamental to the public, but they constitute the very essence of human progress. Our impending victory over COVID-19 shows the way forward for limiting global warming. We will conquer the virus by focusing on a common goal, cooperating, and allowing people the freedom to innovate. Furthermore, governments worldwide have recognised when to step in to encourage innovation and when to take a step back.

Today, many countries have developed post-crisis recovery plans. Governments should use stimulus spending to turbocharge private investments and reduce private risk. Every climate-friendly project – whether new hydrogen technology, trains, or offshore wind farms – both embodies previous innovations and drives future breakthroughs. The result is a virtuous cycle of change, with each revolution bringing into being a world that is a little different, a little more efficient, and a little better.

We will overcome the pandemic by channeling our human nature. And we will overcome the threat of climate change the same way. By adding every individual contribution to the collective effort, we can and will make a huge difference. That is how humanity moves forward together and mitigates global threats.

have vaccinated 80 the level presumed by scientists to produce herd immunity against COVID-19? Most people's answer is 2023 or 2024. which suggests deep pessimism about the progress of vaccinations outside the rich world. That is also why pledges at the recent G7 summit to donate one billion doses to poor countries during this year and in 2022 look to some like generous game-changers.

But despair is the wrong sentiment and self-congratulation by the G7 is the wrong reaction. If the current daily rate of vaccinations can be maintained, the world can reach its vaccination goal by January 2022. The first step toward effective action is to convince oneself that a problem is solvable. To that end, the Global Commission for Post-Pandemic Policy, an independent, non-partisan group of 34 high-level doers and thinkers from around the globe, has done the math to come up with a global vaccine countdown. Surprisingly, we found that the challenge is much more manageable than we imagined, and on a timetable much faster than that assumed by the G7 govern-

The arithmetic is simple, but first you have to decide whether to regard China, the world's most populous country as an inspiration or an exception. According to Our World in Data, China now accounts for 17-20 million of the 33-36 million doses being administered worldwide every day. With China included, the countdown reaches zero in just over 200 days; without China, the time increases to 370 days. That is an important difference, but it amounts to reaching the finish line in July 2022, rather than in January. Even if a higher threshold of 90 per cent becomes necessary, owing to the lower efficacy of Chinese vaccines, we are still nearly there.

Let's look at the numbers. The world's population is 7.9 billion, an estimated 5.85 billion of whom are adults (74 per cent). If the goal

is an immunisation rate of 80 per cent. 4.7 billion will need shots. which on a two-dose vaccine regimen means 9.4 billion doses. As of June 11, 2021, Our World in Data reports that more than 2.3 billion doses have already been administered worldwide, leaving just over seven billion doses. Divide that by a mid-range daily figure (34 million) and you get roughly 211 days - January 2022.

Yes, seven billion is a very large number. But look at what is happening: every day, China is administering 17-20 million doses; India is administering just over three million; and even Africa is administering nearly 900,000 – a 37 per cent increase since the start of the month. Moreover, these numbers are still rising in most countries. Though not every middleincome country will be able to match China's pace, that at least should be the motivating goal.

Until recently, the main constraint and source of frustration was the limited supply of vaccines. But production is rising sharply, with the global monthly output of vaccines approved by at least one major regulatory body increasing from 420 million doses in April to

822 million doses in May.

China's two vaccine makers. Sinovac and Sinopharm, accounted for more than half of this total (nearly tripling output from 164 million doses in April to 454 million in May). Output of Pfizer-BioNTech and Oxford-AstraZeneca vaccine doses in the European Union doubled, from 69 million to 140 million, while the number of Pfizer-BioNTech, Moderna, and Johnson & Johnson doses in the United States rose from 71 million to 105 million. The only disappointing production figures were in India, where output slipped from 76 million doses in April to 62.6 million in May.

In the coming months, the key constraint will no longer be supply shortages but rather financing and logistical challenges, particularly in poorer countries with limited infrastructure and healthcare coverage. These hurdles can be lowered if rich countries release their production more quickly for others to buy, and if more bilateral and multilateral aid funding is made available to support public-health systems and vaccine purchases

Make no mistake: China will

likely play a large and perhaps leading role in this process. As the world's biggest producer of COVID-19 vaccines (albeit of a less sophisticated variety than the Western ones), China will have immunised its own population by September or thereabouts, giving it abundant spare production capacity to supply the world (along with funding).

That is why the Western pledges at the G7, welcome as they are, are in reality somewhat behind the curve. The G7 countries are offering their billion doses on a timetable convenient to them, divided between late 2021 and 2022 but actual demand from poor and middle-income countries is coming much sooner than that. This means that China is being given a huge market and diplomatic opportunity of stepping into the breach with perhaps 500 million doses every month during the last four months of 2021.

If that happens, the surprisingly short timescale indicated by our vaccine countdown can ac tually be shortened further. Rural parts of Africa and unstable parts of Latin America will face the biggest challenges, but these can be overcome with aid from richcountry governments, including China's, and from big philanthropic foundations. Mass vaccination campaigns in the developing world are nothing new. Success depends on generosity, political will, and a belief that the solution is both

necessary and achievable. With new variants emerging rapidly and new outbreaks in places that had seemed to have the virus under control, COVID-19 remains a global problem. We should know by now that it demands a global solution. The recent increase in supplies and the Global Commission's vaccine countdown indicate that what we need is well within reach.

niversary of Taliban facilitated al-Qaeda terror attack on US in 2001. And this is about to happen without accomplishing the forces' much tom-tommed assignment of releasing the landlocked nation from the clutches of dreaded Islamic terror.

It isn't that during their long two decades of presence in the civil war ravaged country, no attempt has been made to bring in normalcy. They located and killed al-Qaeda's head Osama bin Laden in Pakistan's Abbottabad, and revamped Afghanistan security set up and helped set up democratic governance mechanism apart from build-

ing development infrastructure. Western forces have tried their best to remove and destroy the terror elements and terror infrastructure, which caused deaths to around 2500 of their soldiers and cost more than \$800 billion, but failed to bring the much-shouted normalcy mostly due to (i) uncompromising commitment of Sunni Islamic terrorists to Islamic religious doctrines, (ii) land-locked uneven terrain which greatly supports Islamic guerrilla warfare, and (iii) continued political, diplomatic, financial, logistic, intelligence and military

yow, US forces are leaving support to Taliban from vested in-rity provisioning to fight terror-with China and Pakistan to get

As a last ditch effort, the Trump Administration had initiated negotiation with Taliban ignoring Afghanistan's elected government's objection. Even during last months of his tenure, Trump had pressurised an unwilling Afghan government to free hundreds of dreaded terrorists under its captivity, though the terror attacks had not been eased, in order to motivate Taliban.

In the meanwhile, India invested approximately \$3 billion building the Afghan Republic's Parliament, economic and social infrastructure such as dams, hospitals, roads, schools, facilitating livelihood projects, and even sponsoring the nation's cricket teams, training the country's sports enthusiasts and organising their matches back in India ignoring taunt from Trump who had gone to the extent of saying, "You know what that is? That's like five hours of what we spend. And we're supposed to say, 'Oh, thank you for the library.' I don't know who's using it in Afghanistan." It isn't that India's achievements were possible without security. But this author thinks: had the Western powers followed India's policies along with secusituation might have improved if not fully normal by now.

Now, the US forces withdrawal will create a vacuum only to be filled by Taliban supported by the latter's mentor -- Pakistan Army -as seen in mid 1990s within a few years of the Red Army's departure from its one and a half decades' occupation that founded the nation's civil war which is yet to cool down despite more than four decades of rampage.

But, unlike 1990s, Communist China is about to join Taliban and Pakistan. Lately, China is found much interested in the crisis as it looks for a land transit to Iran on the western border of Afghanistan where it has under its Belt and Road Initiative an investment plan of \$400 billion. But, will Islamist Taliban and highly Islamised Pakistan population appreciate China having control over infrastructure in Afghanistan and Pakistan. It is a known fact that the influential Islamists in Pakistan oppose Chinese projects in their country accusing China of de-radicalisation of Muslims in the Xinjiang province. For the time being, Taliban and its sympathisers in Pakistan may join hands

gion. After that, the fight among them may not be ruled out resulting in expansion of the civil war not only in Afghanistan but also in additional geography in Pakistan. Going by the Soviet Union occupation history in Afghanistan, it's difficult to predict Chinese success in fighting against Islamists in the rugged territory of Afghanistan and in Western provinces of Pakistan through which much of Chinese BRI project will pass. And, again, will the US and its allies, which entered the region in early 1980s to stop Soviet Russia's march towards strategically significant Indian Ocean via Afghanistan, remain silent when Communist China marches to the same region via Afghanistan, Pakistan and Iran?

In view of this, how long peace and tranquility of the region will continue to remain elusive nobody can say now for sure. Therefore, it's suggested to solve Afghanistan crisis why not try India shown path halting the Western troops' withdrawal for a few more years?

**Lessons from Galwan** 

Sir, This is in reference to the news item "Indian army deploys around 60,000 troops" Orissa POST, June 15. The day marks a year of the Galwan clash in which 20 Indian armed forces personnel, and an unknown number of People's Liberation Army (PLA) personnel were killed as India bravely sought to repel Chinese encroachment. In fact, Galwan introduced strategic clarity in India. It wants friendly relations with China, not a conflict. And New Delhi's establishment is acutely conscious of the power asymmetry that exists between the two countries and has no desire to be a frontline State in a new geopolitical battle. In all-out effort, India attempted a mix of measures — economic restrictions on Chinese companies; international opinion-building and diplomatic mobilisation about China's actions, including giving momentum to Quad; acquiring a military edge by occupying the Kailash heights (in August 2020); and constant bilateral negotiations with Beijing across the military and diplomatic domain — to drive home the message that restoring status quo ante was essential. This strategy partially succeeded. Furthermore, India lost strategic advantage in Kailash range in exchange for concessions at Pangong Tso. Now, has India been left with no leverage to push the Chinese back from other areas such as Gogra, Hot Springs and Despang? However, Galwan is a reminder that India cannot let its guard down on its northern borders.

Kolkata, June 16: Mukul Roy was the first one to leave the BJP and rejoin the Trinamool Congress but he is not the last because several frontline leaders who had joined the B.IP before the election are re-establishing contact with the Trinamool top brass, clearly indicating their disillusionment about the saffron brigade and giving it a tough time to stem the impending

In the last few days, after Roy's switchback, several high-profile leaders including Rajib Banerjee and Sovan Chatterjee, along with Baisakhi Banerjee, have met Trinamool secretary general Partha Chatterjee whose mother died a few days back. Though both of them termed it to be a courtesy visit, insiders in the party indicated that the return of Rajib Banerjee or Sovan Chatterjee is only a matter of time.

Asked about it, Chatterjee said: "Today I came here to express my solidarity with Partha Chatterjee. I came when his wife died. So don't mix it up with politics.

However, he added: "The day I was arrested by CBI... it was black day for me but our Chief Minister despite all the differences called me and stood firmly behind me along with the other three who were also arrested by CBI. I am grateful to her from the core of my heart.'

"Our Chief Minister considers him (Sovan) to be a part of her family and so it is hard to understand their relationship. We are grateful to her for her kindness," Baisakhi Banerjee said. "We have any election nor we were a part of the election campaign," she added.

Interestingly enough a day before the duo met Partha Chatterjee, former Trinamool minister Rajib Baneriee, who had joined the BJP before the election, met Partha Chatterjee. However, both of them were tight-lipped about the meeting but quite some time, Rajib Banerjee came in open protest against BJP's criticism of Chief Minister Mamata Banerjee and said that the party should accept the mandate and work for the people of the state.

Another turncoat Prabir Ghosal, who went to the BJP along with Rajib Banerjee was in high praise for party supremo Mamata Baneriee and her nephew and new national General Secretary Abhishek Banerjee.

Similarly, several former Trinamool MLAs like Sonali Guha and others have expressed their willingness to return back to the Trinamool. The situation is such that state BJP President Dilip Ghosh had to come out with an open statement. "BJP is the largest party in the world and we have accepted the people who wanted to come to our party. We never insisted them to join and now if they feel that they will leave the party, it is their choice. But one thing everyone should understand, that if you want to stay in this party, you will have to sacrifice. If someone comes only for post and power, they cannot stay," Ghosh said.

But it is true that the long queue in the BJP to rejoin the Trinamool is worrying the state BJP leaders.

"Our party should have been more careful in accepting people from other parties. We don't belong to the same culture. Our ethics and ideology are completely different from other political parties and so it was a mistake to accept them without any kind of orientation. It will create a bad impression on the people. Meanwhile, there have also been protests in several areas against taking back these "traitors" back into

## Mithun quizzed by cops for 'inciting violence'

Kolkata, June 16: Kolkata Police virtually questioned BJP leader and Mithun Chakraborty on a complaint lodged against him alleging that the actor was responsible for inciting violence through one of his speeches made during a BJP campaign.

A complaint filed in Maniktala police station against him, has accused the actor of inciting postpoll violence in West Bengal through his speeches. Chakraborty moved the Calcutta High Court for quashing the case against him.

But the court asked him to appear for questioning through video conferencing. In the complaint it has been mentioned that the popular actor has used phrases like "marbo ekhane lash porbe shoshane (Will hit you here and the body will land in the crematorium)" and "ek chobole chobi (one snake bite and you will turn into a photograph)" at a rally in Kolkata after he joined the BJP March 7. The complaint also mentioned that these dialogues were enough to incite violence.

The national award-winning actor, however, told the court that he had just uttered popular dialogues from his films. The actor claimed that the utterances of such film dialogues were only recreational and that he is innocent and in no way connected with any offence as alleged by the complainant.

After the hearing the Calcutta High Court directed Chakraborty to provide his e-mail address to the state so that he can make himself available for questioning through video conferencing. Kolkata police following the direction of the court have started questioning Chakraborty.

Gaurav Awasthi even travelled hundreds of kilometres from his home on the outskirts of Delhi to get his ailing wife a hospital bed there, paying an ambulance more than a thousand dollars to drive 24 hours straight. "I cannot ever repay my debt to this city" the 29-year-old told AFP. recounting an ordeal that saw him spend five days fruitlessly searching for a bed across several cities, including Delhi. "I don't know if my wife would be alive today if it weren't for Mumbai's health facilities.

#### **BODIES IN WARDS**

The bodies began turning up early in India's financial capital during the first wave of infections last year -- a man collapsing on a busy road, a rickshaw driver slumped over the wheel, a corpse lying in the street -- in a grim echo of the 1918 flu pandemic.

By May 2020, Abhignya Patra

was working 18-hour days at the massive Lokmanya Tilak Municipal General Hospital, better known as Sion. "It was non-stop," the 27-yearold anaesthesiologist told AFP.

Patients' relatives described distressing scenes inside packed wards, with one man telling AFP he had to change his sick mother's diapers himself because staff were too overworked. A video shot inside Sion and widely shared on social media showed corpses wrapped in black plastic left on beds in a ward where patients were being treated.

Every night, the city helpline fielded thousands of calls from desperate citizens, many with no chance of getting admitted to a publicly-funded hospital: Mumbai had just 80 ambulances and 425 intensive care units for a population of 20 million.

#### 'CHASE THE VIRUS'

Something had to change fast, said Iqbal Chahal, a no-nonsense bureaucrat who took over as Mumbai's municipal commissioner last May. New field hospitals added thousands of beds, private facilities handed over their Covid-19 wards to the government and 800 vehicles were turned into ambulances.



But these efforts could not comat the swift rise in infections.

"We needed to chase the virus," Chahal told AFP. A proactive approach focused on 55 slums including India's largest, Dharavi, where a strict lockdown was accompanied by aggressive sanitisation of public toilets, mass coronavirus screening and a huge volunteer effort to ensure that no-

body went hungry. All positive test reports in Mumbai were routed through "war rooms" manned by doctors who would triage cases and decide where to send the

patient, irrespective of "whether he is a minister, a big shot or a slum dweller", Chahal said.

#### **FORWARD THINKING**

As 2020 wore on, it looked like India might have miraculously beaten the pandemic and lockdown restrictions were eased.

But in Mumbai, authorities didn't dismantle a single bed in the nowdeserted field hospitals.

This meant that when cases surged in March, the metropolis was much better prepared than many other Indian cities, where the health

care system came close to collapse.

Despite having a much higher population density than many other cities, Mumbai has seen significantly lower mortality rates.

The city still suffered close calls, Chahal said, recalling one night in April when six hospitals faced dire oxygen shortages, putting 168 patients at serious risk unless they were shifted to other facilities. Everyone survived. "We always expected a second wave." Chahal said.

#### **'WAKE-UP CALL'**

Patra recalls getting calls from colleagues in Delhi desperately searching for medical equipment. "As doctors, there is very little

we can do in the absence of infrastructure," she said. Ruben Mascarenhas, co-founder of Mumbai-based non-profit

Khaana Chahiye, said he would get dozens of messages every morning from people begging for oxygen and drugs -- but as the pandemic wore on, the requests mostly came from outside the city. "This has been a wake-up call for us." he said.

## Probe begins into housing society 'vaccination fraud'

Mumbai, June 16: Mumbai Police launched an investigation after a housing society in suburban Kandivali suspected "fraud" by some persons who had organised a COVID-19 vaccination camp for its members by claiming to represent a private hospital and also expressed apprehensions that the vaccine that was administered could be spurious.

A senior officer said Wednesday no FIR has been registered so far but the police will probe the case from different angles

"We have not registered an FIR in this case and not arrested anvbody. We have also not detained anybody. We are just investigat-

ing," Deputy Commissioner of Police, zone 11, Vishal Thakur told PTI. In a complaint submitted to the police, the Hiranandani Heritage Residents Welfare Association (HHRWA) had said that a vaccination camp was arranged by the residential complex on May 30. But later it found that the Co-WIN portal did not have any record of the people who participated and they received certificates in the name of different hospitals.

"If the vaccine is found to be spurious, the people who got vaccinated will have a medical emergency to deal with. Therefore, there is an urgent need to investigate the whole episode so that such fraudulent activities are not repeated at other places," the

complaint said. The HHRWA had organised the camp through a person who claimed to be a sales representative of a reputed private hospital in suburban Andheri. As many as 390 members received the jabs at the camp at Rs 1,260 per person, it had said in the complaint which stated that some unscrupulous elements have taken the society for a ride.

They were shocked to receive vaccination certificates in the name of Nanavati Hospital, Lifeline Hospital and NESCO Covid Camp, among others, it said.

Nanavati Hospital had said in a statement that it had not conducted any such vaccination camp. "We have informed the authorities and are lodging a formal complaint," said its spokesperson Tuesday. The HHRWA also said that none

had the usual after-effects like fever or body ache. According to the complaint, one Sanjay Gupta was the coordinator for the camp, but he did not give receipts for the payment for vaccines. He had asked the associa-

### Sena, BJP workers come to blows over Saamana remarks

Mumbai, June 16: Clashes broke out between Shiv Sena and BJP workers in Dadar area here Wednesday after the youth wing of the BJP took out a protest march against 'offensive' remarks in the Sena mouthpiece Saamana about the land deal controversy in Ayodhya.

The police used force to disperse the supporters of the two parties which were once allies. Sena workers assaulted a woman member of the BJP, the latter alleged.

The trouble started after the Bhartiya Janata Yuva Morcha took out a protest march towards Shiv Sena Bhavan in Dadar, the Sena's headquarters, over a Saamana editorial which demanded probe of a "suspicious" land purchase deal by the Ram Mandir trust in Ayodhya.

The trust has denied the allegations. Following the fisticuffs, police took several persons in custody.

An FIR was being registered, said an officer of Mahim police station. BJP leaders Ashish Shelar, Mangal Prabhat Lodha, Pravin police station and demanded action against Shiv Sena activists.

Darekar and others reached the

Shelar, an MLA and former Maharashtra minister, warned of strong retaliation in future.

"I warn Shiv Sena workers of retaliation if they again attacked our workers," he said. "The Sena was once proud of the demolition of the Babri mosque, but now for political reasons it is defaming Lord Ram. Sonia or Vadra (Congress leaders Sonia Gandhi and Priyanka Gandhi-Vadra) have now become the Sena's deities,


he said, in a swipe at the Sena's alliance with the Congress in Maharashtra.

#### Nine killed in road mishap

Anand: Two children and seven adults were killed in a road accident after the car in which they were travelling collided with a goods-carrying truck near Indranaj village in Gujarat's Anand district Wednesday morning, police said. #### Elephant rescued

Kochi: A wild elephant that had fallen into an open well in a tribal settlement under Neriamangalam forest limit was rescued Wednesday. forest officials said. The incident was reported from Pinavoorkudy tribal settlement under Valara forest station this morning, they said. According to the officials, the 18-year-old female elephant was rescued from the 12-foot well after a three-hour -long operation, they said, A pathway was created by breaking the side of the well using an earthmover and after coming out of the well, the jumbo went into the forest, the officials said. 

#### Farmer kills self

Chandigarh: A 58-year-old farmer died allegedly after consuming poison at a site of protest against the Centre's three farm laws in Jind district in Haryana, police said Wednesday. The deceased farmer has been identified as Pala Ram, Uchana Police Station SHO Ravinder Singh said over the phone. "He consumed poison late Tuesday night and Wednesday morning we received information that a farmer has died," he said, adding that no suicide note has been found from the spot. At the protest site at Khatkar toll plaza, 500-700 protesters usually gather during the day, while only a few stay there overnight, according to the police.

New Delhi, June 16: Delhi Police have filed an appeal in the Supreme Court challenging the bail granted by Delhi High Court to activists Asif Igbal Tanha, Devangana Kalita and Natasha Narwal in a case of the "larger conspiracy" related to the northeast Delhi riots last year, in which 53 people were killed and more than 400 injured.

Questioning the approach adopted by High Court, the police said the three judgments granting bail to three students, Tanha, Kalita and Narwal were "without any foundation and appears to be based more on the social media narrative than the evidence gathered and elaborated in the charge sheet".

"Unfortunately, contrary to the evidence on record and the detailed oral and written submission made/filed, the High Court has decided the case in hand on a pre-conceived and a completely erroneous illusion, as if, the present case was a simply a case of protest by students," it argued.

## Chirag vows to fight back

In his first interaction with media after the split in the party, he struck a combative note by describing himself as "sher ka beta" (lion's son) and asserted that he will fight for the cause of the party founded by his father Ram Vilas Paswan. While blaming the JD(U) for the split, he steered clear of questions regarding the role of the BJP in the development and added that what has happened is also an internal matter of his party for which he will not target others. He, however, replied wryly when asked if "Hanuman" who is in trouble now will seek help from "Ram", a reference to his projection of his relationship with Prime Minister



Narendra Modi during the Bihar assembly polls as that between the two famous characters of epic Ramayan. "If Hanuman has to seek help from Ram, then what good is Hanuman and what good is Ram, he said in Hindi.

It is going to be a long battle, Paswan said, as the group headed by him fights the faction of five other party MPs, led by Paras, to claim ownership of the LJP. The JD(U), he alleged, had been working to cause a split in the party even when his father was alive. Targeting the party, he said it has always worked to divide Dalits and weaken its leaders. The LJP draws its support from Paswans, the largest Dalit caste in Bihar. "A conspiracy was hatched behind my back while I was ill, Paswan said. He had recently suffered from typhoid.

The 38-year-old MP from Jamui expressed determination to take on the rival group while also taking swipe at his paternal uncle without using any strong words to attack him. Though the LJP played the role of spoiler for the JD(U) in the assembly polls in over 35 seats, it itself won only one seat and the lone MLA later defected to Kumar's party. Paswas, however, asserted that the polls were a "big win" for his party as it got nearly six per cent votes.

#### Six Maoists gunned down

Visakhapatnam, June 16: A senior Maoist leader is among 6 naxals killed in an encounter that took place in Wednesday morning in Visakhapatnam district, while some more leaders are believed to have escaped from the spot, sources

Police are continuing search operations in the area where encounter took place. Six Maoists were gunned down by Andhra Pradesh Greyhounds police on Wednesday morning at Theegalametta forest area in Visakhapatnam district.



"Today (Wednesday) in the morning hours, an exchange of fire took place between CPI (Maoist) and Greyhounds parties at Theegalametta forest areas (Koyyru surrounding areas)," said an official statement. The encounter occurred under the police station limits of Mampa, surrounding the Koyyuru area, even as a search operation is underway.

Among the six dead, police said there were female corpses as well. Andhra Pradesh DGP, Gautam Sawant said that police had launched combing operations in the area after receiving reliable inputs. The Greyhounds police recovered an AK-47 rifle, a self-loading rifle, one carbine and two more guns from the spot.

#### Drone survey mandatory for all NH projects

New Delhi, June 16: In order to enhance transparency, uniformity and leverage latest technology, the National Highways Authority of India (NHAI) on Wednesday made use of drones for monthly video recording of national highway projects mandatory during all stages of development, construction, operation and maintenance work.

As per the order, contractors and concessionaires will carry out drone video recording in the presence of the team leader of the supervision consultant and upload comparative project videos on NHAI's portal 'Data Lake', capturing various project related developments during the month.

The supervision consultants will also analyse these videos and provide their comments on the digital monthly progress reports covering various aspects of project development.

These videos will also be used by the NHAI officials during the physical inspection of the projects to check the discrepancies and rectifications made on the basis of the earlier observations. Additionally, the project directors of NHAI will undertake monthly drone survey from the date of signing of contract agreement till the start of construction of the project at site and also on completion of the project.

#### Fatality rate for pregnant women '730 docs died of Covid in 2nd wave' higher in 2nd wave: ICMR study

New Delhi, Jun 16: Pregnant and postpartum women were more severely affected during the second wave of Covid-19 as compared to the first with symptomatic cases and the case fatality rate being significantly higher among this category this year, according to a study by ICMR.

The Indian Council of Medical Research (ICMR) on Wednesday said cases related to pregnant and postpartum women during the first wave (April 1, 2020 - January 31, 2021) and during the second wave (February 1, 2021 to May 14) of the pandemic in India were compared.

'Symptomatic cases were significantly higher at 28.7 per cent in the second wave (111/387), compared to the first wave (162/1143)when the proportion was 14.2 per



cent," the apex research body said. "The case fatality rate (CFR) among pregnant women and post-

partum women was 5.7 per cent (22/387) during the second wave, which was significantly higher compared to the scenario encounter in the first wave with CFR 0.7 per

Total number of maternal deaths during both the waves of pandemic were 2 per cent (30/1530), of which the majority (28/30) were due to COVID-19 pneumonia and respiratory failure. "The study underlines the importance of vaccination of pregnant and lactating women against COVID-19," the ICMR said.

The COVID-19 vaccination is recommended for all lactating women in India. However, the government has still not allowed vaccinating pregnant women citing lack of clinical trial data and the matter is under discussion by the National Technical Advisory Group on Immunization (NTAGI).

The WHO last week had recommended vaccinating pregnant women if they face high risk of exposure to Covid, and if they have co-morbid conditions

New Delhi, Jun 16: As many as 730 doctors died during the second wave of the COVID pandemic. said the Indian Medical Association (IMA) on Wednesday, adding that the maximum fatalities have been reported in Bihar.

Bihar reported 115 doctor deaths. followed by Delhi which recorded 109 fatalities, and Uttar Pradesh with 79. In southern states, Andhra Pradesh reported 38, Telangana 37, Karnataka 9, Kerala 24, and Odisha 31.

Twenty-three doctors died in Maharashtra. Today, India reported 62,224 fresh COVID-19 cases in the last 24 hours, while the daily positivity rate further dropped to 3.22 per cent, according to the Ministry of Health and Family Welfare (MoFHW). The daily positivity rate has been below 5 per cent for



nine consecutive days. The active cases have further declined to 8,65,432. They have gone down to less than 9 lakh for the first time in 70 days. According to the Health Ministry, the national COVID-19 recovery rate has improved to 95.80 per cent. With the new cases, the country's tally has climbed to 2.96.33.105.

The COVID-19 death toll climbed to 3,79,573 with 2,542 fresh fatalities in the last 24 hours. The recoveries continued to outnumber daily new cases for the 34th consecutive day. India witnessed 1.07.628 recoveries in the last 24 hours, taking the recovery tally to 2,83,88,100.

## Centre approves project to explore deep ocean for resources

#### THE PROPOSAL FOR LAUNCHING THE 'DEEP SEA MISSION' CAME FROM THE MINISTRY OF EARTH SCIENCES

New Delhi, June 16: The Centre Wednesday approved a proposal to roll out a "Deep Ocean Mission" to explore the deep ocean for resources and develop deep-sea technologies for sustainable use of marine resources.

The decision was taken by the Union Cabinet at its meeting chaired by Prime Minister Narendra Modi, minister Prakash Javadekar told a press conference. "This will support the blue economy and take India into a new era," he said. The proposal for launching the "Deep Ocean mission" came from

the Ministry of Earth Sciences.

Javadekar said under the mis-

sion, a mineral study will be conducted 6,000 metres deep in the ocean. The mission will also study the changes, if any, noticed due to climate change. Under the mission, he said, a study will be conducted on more deep-sea biodi-

The minister said an advanced marine station will be set up for ocean biology under the mission. There will also be an offshore thermal energy centre, which will help new emerging sectors.

After the US, Russia, France, Japan and China, India will be the sixth country to have this kind of technology, Javadekar said. "There will be good opportunities for our MSMEs and research. This will



also help in our endeavour and vision towards an Aatmanirbhar

Bharat (self-reliant India)," he

The estimated cost of the mission for a period of five years will be ₹4,077 crore and it will be implemented in a phase-wise manner, according to an official statement.


'The estimated cost for the first phase for the three years (2021-2024) would be ₹2,823.4 crore. The Deep Ocean Mission will be a mission-mode project to support the blue economy initiatives of the government. The Ministry of Earth Sciences (MoES) will be the nodal ministry implementing this multiinstitutional ambitious mission," the statement said

The mission consists of six major components -- development of technologies for deep-sea mining and manned submersible, development of ocean climate change advisory services, technological innovations for exploration and conservation of deep-sea biodiversity, a deepocean survey and exploration, energy and freshwater from the ocean and an advanced marine station for ocean biology.

"The technologies required for deep-sea mining have strategic implications and are not commercially available. Hence, attempts will be made to indigenise technologies by collaborating with leading institutes and private industries. A research vessel for deep-ocean exploration would be built in an Indian shipyard, which would create employment opportunities," the statement said.

#### **Terrorist killed** in encounter

Srinagar: The Lashkar-e-Taiba (LeT) terrorist killed in an encounter in the Wagoora area of Nowgam in Srinagai Wednesday had refused to surrender and fired indiscriminately at the security forces, drawing retaliation that led to the encounter, officials said. The police said that on the intervening night of June 15-16, a joint cordon and search operation was launched by the Srinagar police, the army and the CRPF after receiving specific information about the presence of a terrorist in the Wagoora area.

#### **Heavy rains** pound K'taka

According to the Meteorological Department, highest rainfall of 20 cm was recorded at Agumbe in Shivamogga district, followed by 15 cm at Kollur in Udupi district, 14 cm each at Kadra in Uttara Kannada and Kottigehara in Chikkamagalur districts and 13 cm at Bhagamandala in Kodagu district, where the Cauvery originates.

## **Twitter, others booked** for 'communal' video

A DAY AFTER LOSING 'SAFE HARBOUR SHIELD, THE TECH GIANT BOOKED



Ghaziabad, June 16: It did not take long for the law to initiate action against micro-blogging site Twitter. A day after Twitter lost its 'safe harbour' shield, the UP booked it, a news portal and six persons in connection with the circulation of a video in which an elderly Muslim man narrates his ordeal after he was allegedly attacked by some people in Ghaziabad.

The FIR was lodged at the Loni Border police station here around 11.30pm Tuesday on the basis of a complaint lodged by a local policeman. It alleges that the video was shared with an intention to provoke communal unrest.

In the video clip, which surfaced on social media June 14, the elderly Muslim man, Abdul Shamad Saifi, alleges he was thrashed by some young men and asked to chant 'Jai Shri Ram'.

However, the Ghaziabad police, who have arrested three people for assaulting Saifi, have ruled out a communal angle. They said the accused were unhappy about a 'tabeez' (amulet) he sold to them. A police official said however, informed Wednesday that an FIR was lodged against Twitter Inc. Twitter Communications India news website 'The Wire', journalists Mohammad Zubair and Rana Ayyub, Congress politicians Salman Nizami, Masqoor Usmani, Dr Sama Mohammad

"These people did not verify the truth of the matter and shared it online with a communal angle with an intention to disrupt public peace and create a divide between religious groups," the FIR states. "Besides this, Twitter Inc and Twitter Communications India also did not take any meas-

#### IT Minister slams social media site

Shankar Prasad said Wednesday that Twitter failed to comply with intermediary guidelines and has 'deliberately' chosen the path of non-compliance despite being granted multiple opportunities. "There are numerous gueries arising as to whether Twitter is entitled to safe harbour provision. However, the simple fact of the matter is that Twitter has failed to comply with the Intermediary Guidelines that came into effect from the May 26," Prasad said in a series of posts on homegrown microblogging platform Koo. ## FB begins 3rd-party health fact checks

New Delhi, June 16: Facebook Wednesday joined hands with The Healthy Indian Project (THIP) - a health specialised fact-checking site -- as part of its third-party factchecking programme in India to combat Covid-19 and all other health related misinformation on the social media platform.

During the pandemic, Facebook removed more than 18 million pieces of harmful misinformation across its platform and Instagram and labelled over 167 million fake news posts on Covid-19 with the help of third-party fact-checkers.

The partnership with THIP "will enhance its capabilities to understand and curb health-related misinformation on the platform", the social media giant said in a state-

THIP Media works with verified medical professionals to fact check misleading news and claims about health, medicines, diet and treatment in English, Hindi, Bengali, Punjabi and Gujarati. Globally, Facebook is working

with 80 fact-checking partners that help in content monitoring in more than 60 languages. Facebook's factchecking partners have been certified through the independent, non-partisan International Fact-Checking Network.

In India, Facebook has 10 factchecking partners, one of the largest after the US. This includes India Today Group, Vishvas News (Dainik Jagran), Factly, Newsmobile, Fact Crescendo,

BOOM Live, AFP, NewsChecker and Quint who fact-check in 11 Indian languages along with English.

The Indian languages include Hindi, Bengali, Telugu, Malayalam, Tamil, Marathi, Punjabi, Urdu, Gujarati, Assamese and Kannada. "Third-party fact-checkers evaluate stories, check if the stories are factual, and rate their accuracy When a fact-checker rates a story as false, Facebook shows it lower in News Feed, significantly reducing its dissemination and reducing the number of people who view it," the company said.

Pages and domains that repeatedly share false news will also see their distribution reduced and their ability to monetise and advertise temporarily removed.

## 'Covishield dose 61% effective against Delta'

New Delhi. June 16: Amid a heated debate on the wide gap India is taking between the first and second dosages of the Covishield vaccine, it has been revealed that data from Indian trials suggest the 12-16 weeks interval was medically sound. In comparison, data from the UK, which has been used to suggest otherwise was statistically less relevant to India, according to Dr NK Arora, Chairperson of the Centre's Covid Working Group.

"When we started with the national Covid immunisation programme...we had an interval of four weeks. That was based on the trial showed that, at a four-week interval, the immune response is very good. Although the UK, at that time, had already increased the interval to 12 weeks. That was when they were facing the challenge of the Alpha variant outbreak in December-January," Dr Arora said.

"But we were not convinced and we went ahead with four weeks. Six weeks later the WHO also suggested that 6-8 weeks may be a good idea. We reviewed the data and we had initial experience from the



UK and we thought that it may worthwhile to increase it to 6-8 weeks." he said. However, the working group decided to look at the real-life data coming in from the UK, since that country and India are the largest consumers of the AstraZeneca vaccine -- Covishield in India. In April, he said, Public Health England suggested that with a 12-week interval the vaccine efficacy was varying between 65 per cent and 80 per cent. Later, however, statistically significant data from Christian Medical College Vellore's research -- based on a sample size of several thousand -- amid the Delta surge showed that a single dose had a 61 per cent vaccine effectiveness which increased to 65 per cent with two, he said.

## 'Firms owned by Choksi siphoned off over ₹6,344.96 cr from PNB'

New Delhi, Junu 16: Companies owned by fugitive diamantaire Mehul Choksi have allegedly siphoned off over Rs 6.344.96 crore from the Punjab National Bank (PNB) using fraudulent letters of undertaking and foreign letters of credit, the CBI has alleged in its supplementary chargesheet, detailing the agency's three-year-long investigation.

The findings were submitted by the CBI in a supplementary chargesheet filed before a special court in Mumbai last week, where it alleged that the PNB was conned by its employees who were hand in gloves with Choksi and his company executives and who facilitated the scam as part of a criminal conspiracy. The PNB officials at the bank's Brady House branch in Mumbai issued 165 letters of undertaking (LoUs) and 58 foreign letters of credit (FLCs) during March-April 2017, against which 311 bills were discounted. These LoUs and FLCs were allegedly issued to Choksi's firms without any sanctioned limit or cash margin and without making entries in the bank's



central banking system to evade any scrutiny in case of a default.

LoUs are a guarantee given by a bank on behalf of its client to a foreign bank. If the client does not repay to the foreign bank, the liability falls on the guarantor bank. Based on these LoUs, SBI-Mauritius, Allahabad Bank-Hong Kong, Axis Bank-Hong Kong, Bank of India-Antwerp, Canara Bank-Mamana

and SBI-Frankfurt lent money. "Since the accused companies did not repay the amount availed against the said fraudulent LoUs and FLCs, the PNB made the payment of Rs 6,344.97 crore (\$ 965.18 million), including the overdue interest, to the overseas banks, which had advanced buyer's credit and discounted the bills against the fraudulent LoUs and FLCs issued by the PNB," the supplementary chargesheet alleges

According to the CBI, LoUs worth over Rs 3,154.31 crore and the 311 bills worth over Rs 3.086.24, which were discounted against the 58 FLCs, remain outstanding. The PNB had accused Choksi of duping it to the tune of Rs 7,080 crore. CBI officials said the matter is still under probe and the final figures of loss suffered by the bank can only be determined once all the LoUs are examined. The CBI is continuing its probe into the LoUs issued in 2015 and 2016 and the fraudulent amendments made in FLCs in 2014, 2015 and 2016 by bank officials.

#### 'Monsoon in northern states to be delayed'

New Delhi, June 16: Atmospheric conditions are still not favourable for further advance of monsoon into Rajasthan, remaining parts of Guiarat, Punjab, Harvana and Delhi, the India Meteorological Department (IMD) said Wednesday.

It said a cyclonic circulation lies over east Uttar Pradesh and neighbourhood and there is also a western disturbance. These conditions are not favourable for the advance of monsoon, IMD Director General M Mohapatra said.

"Large-scale atmospheric conditions are not favourable for further advance of monsoon into Rajasthan, remaining parts of Gujarat, Punjab, Haryana and Delhi," the IMD said. However, there could be a slow progress of monsoon into some more parts of Uttar Pradesh during the next five days in association with the existing cyclonic circulation over east Uttar Pradesh, the IMD added.

The Northern Limit of Monsoon (NLM) continues to pass through Diu, Surat, Nandurbar, Bhopal, Nowgong, Hamirpur, Barabanki, Bareilly, Saharanpur, Ambala and Amritsar, it added.

#### UK lawyer new **ICC** prosecutor

The Hague: British lawyer Karim Khan was sworn in Wednesday as the new chief prosecutor for the International Criminal Court, pledging to reach out to nations that are not members of the court and to try to holo trials in countries where crimes are committed. Khan, a 51-year-old English lawyer, has years of experience in international lawyer as a prosecutor, investigator and defense attorney. He takes over from Fatou Bensouda of Gambia, whose nine-year term ended Tuesday.

#### **Bomb blast at** military base

Bogota: A car bomb explosion at a military base in the Colombian border city of Cucuta injured 36 people Tuesday, the defense minister said, casting blame for the attack on leftist rebels. The explosion took place at a base used by the 30th Army Brigade in the northeastern city near the border with Venezuela. "We reject and repudiate this vile and terrorist act which sought to attack the soldiers of Colombia." Defence Minister Diego Molano told iournalists.

#### Pak court delays Jadhav's case

Islamabad: A Pakistani court has adjourned till October 5 the hearing of a government's plea to appoint a counsel for Indian death-row prisoner Kulbhushan Jadhav on request of the country's top law officer, according to a media report. India approached the International Court of Justice against Pakistan for denial of consular access to Jadhav and challenging the death sentence. The Hague-based ICJ ruled in July 2019 that Pakistan must undertake an "effective review and reconsideration" of the conviction and sentence of Jadhav and also to grant consular access to India without further delay.

## **PUTIN, BIDEN MEET AMID TENSIONS**

Geneva, June 16: With stern expressions and polite words before the cameras, President Joe Biden and Russia's Vladimir Putin plunged into hours of face-to-face talks Wednesday at a lush lakeside Swiss mansion, a highly anticipated summit at a time when both leaders agree that relations between their countries are at an all-time low.

Biden called it a discussion between "two great powers" and said it was "always better to meet face to face." Putin, for his part, said he hoped the talks would be "productive."

The meeting in a book-lined room had a somewhat awkward beginning — both men appeared to avoid looking directly at each other during a brief and chaotic photo opportunity before a scrum of jostling reporters.

Jerusalem, June 16: Israeli aircraft carried out a series of airstrikes at militant sites in the Gaza Strip early Wednesday, the first such raids since a shaky ceasefire ended the war with Hamas last month.

The airstrikes targeted facilities used by Hamas militants for meetings to plan attacks, the Israeli military said, blaming the group for any act of violence emanating from Gaza. There were no immediate reports of casualties.

27 cows to award, authorities say

the campaign has prompted more than 50% of the 1,400 residents in the district - many elderly and in high-risk groups - to register for their vaccines.

Cipanas authorities say it has been especially difficult to persuade the elderly that the vaccines are safe and halal. As in Thailand, they have also turned to livestock incentives, offering live chickens

## India may have 330mn 5G subscribers by 2026: Report

New Delhi, June 16: India is likely to have 330 million 5G subscribers by 2026 and the monthly data consumption per smartphone is expected to grow over 3-fold to 40 gigabyte per smartphone, telecom gear maker Ericsson said in a report Wednesday.

Average data consumption per smartphone at 14.6 GB per month in India continues to be the secondhighest in the world, according to the Ericsson Mobility Report 2021.

"In the India region, 4G subscriptions are forecast to rise from 680 million in 2020 to 830 million in 2026. 5G will represent around 26 per cent of mobile subscriptions in India at the end of 2026, estimated at about 330 million subscriptions," it added.

The report projects that 5G sub-

scriptions to reach 3.5 billion, accounting for around 40 per cent of all mobile subscriptions by 2026.

The company in a survey in India found that 42 per cent of users living in mega or metro cities of India who use 4G as the only home internet connection are interested in using 5G fixed wireless access connection, Ericsson India head and chief of Network Solutions for Market Area South East Asia Oceania and India Nitin Bansal said.

"50 per cent consumers in India are willing to pay 50 per cent more for 5G with bundled digital services compared to just 10 per cent premium for 5G connectivity. 40 million users could take up 5G in the first year when it is made available," Bansal noted.

Ericsson mobility report said the number of smartphone subscriptions was 810 million in 2020



and is expected to grow at a compounded annual growth rate (CAGR) of 7 per cent, reaching over 1.2 billion by 2026

Smartphone subscriptions accounted for 72 per cent of total mobile subscriptions in 2020 and are projected to constitute over 98 per cent in 2026, driven by rapid smartphone adoption in the country.

Ericsson Mobility Report (EMR) Editor Patrik Cerwall said that

traffic growth can be very volatile between years and can also vary significantly between countries, depending on local market dynamics.

"Data consumption in India is very high because people are using smartphone to work from home and also the penetration of smartphone is high in India," Cerwall said.

The report has increased forecasts for South East Asia and Oceania, as well as for India, with India remaining a region with one of the highest monthly usage per smartphone rates, at around 15 GB at the end of 2020.

'The average traffic per smartphone in the India region stands second-highest globally and is projected to grow to around 40 GB per month in 2026.

"Competitive pricing by service providers for subscription packages, affordable smartphones and increased time spent online all contribute to monthly usage growth in the region," the report said.

Total mobile data traffic in India has grown from 6.9 exabytes (EB) per month to 9.5 EB per month in 2020 and is projected to increase by more than 4 times to reach 41 EB per month in 2026.

'We have to look forward,' Germany midfielder Toni Kroos said. "When you lose the first game and you have three group games, there's a lot of pressure. We don't need to talk about it.'

Russia edge past 1-0 Finland at Euro 2020

St. Petersburg, June 16: With a slick one-two and a beautiful curling shot, Aleksei Miranchuk finally gave Russia something to smile about at the European Championship.

The left-footed playmaker produced the one moment of class in a chaotic game Wednesday to give Russia a 1-0 win over Finland and their first points at Euro 2020.

The pessimism that followed the Russians' 0-3 loss to Belgium in their opening Group B game was replaced by loud cheers and jubilant chants of "ROSS-I-YA" at the final whistle at Saint Petersburg Stadium.

Now Russia are tied on points with the Finns, who missed the chance to reach the last 16 with a game to spare with a second straight victory in their first major football tournament. Their first victory was 1-0 over Denmark in a match marked by Christian Eriksen's collapse.

It came as no surprise that Artem Dzyuba was involved in Miranchuk's superbly taken goal, which wasn't in keeping with the overall standard of a game.

## India advance despite draw with Afghanistan

Doha, June 16: India were lucky Afghanistan without actually scoring in a Group E match of the World Cup 2022 and Asian Cup China 2023 Qualifiers here Tuesday, and still advanced to the third and final round. The Afghan goalkeeper scored the goal in India's account.

Ovavs Azizi scored the own-goal in the 75th minute and Hossein Zamani's 82nd minute strike drew parity at the Jassim Bin Hamad Stadium here.

Importantly for Sunil Chhetri's team, India entered the third and final round of the qualifiers, along with Afghanistan. Although this is a combined qualification tournament, India are out of contention for the 2022 World Cup.

India finished at the third position in Group E with seven points from eight matches. They won only one match, lost three, and drew four games. They scored six goals and conceded seven to end up with

a negative goal difference. Afghanistan finished fourth with six points from eight matches. Qatar topped the group with 22 points from eight matches. Oman finished second with 15 points from 7 matches played and one game in hand.

Going into the game against Afghanistan, India needed just a draw to advance to the final round of qualification for the Asian Cup.

India missed a few opportunities to score. They finally got a goal on the scoreboard in the 75th minute when Manvir Singh and Ashique Kuruniyan combined well. Kuruniyan sent a looping cross towards the far post, and a desperate Afghanistan goalkeeper Azizi could only send the ball into his own goal.

However, Afghanistan made amends and drew parity in the 82nd minute when midfielder Noor Husin, on the left flank, did well to find teenager Hossein Zamani, who curled his shot into the far post to beat Gurpreet Singh Sandhu.

## Dutee still hopeful for Tokyo berth

New Delhi, June 16: An Olympic qualifying spot within her grasp, national record-holding sprinter Dutee Chand on Wednesday said her target in the upcoming Tokyo Games is to reach the 100m final with an improved timing.

The Odisha sprint queen is yet to breach the qualification timing of 11.15 seconds but is expected to make it to the Tokyo Games on the basis of world rankings. Out of the 56 athletes to compete, 33 will be those who touch qualification timing and the remaining will be picked on the basis of rankings.

The 25-year-old, who has a personal best of 11.22 sec, is currently 42nd in the World Athletics' Road to Tokyo list, which also includes those who have already qualified on the basis of entry standard timing. The qualification deadline is June 29 and the final list of entries will be published July 1.



"I will try my best to touch the 11.15 sec standard during the Indian Grand Prix 4 June 21 and the National Inter-State Championships (June 25-29). If not, I am expecting qualification on the basis of rankings," Dutee said in a virtual press conference.

"My aim in Tokyo is to run below 11.10 seconds and qualify for the final round. Olympics is the biggest event, there will be a lot of athletes who run around 11 seconds and below that," said the runner who was roped in as brand ambassador of Senco Gold and Diamonds company as part of its initiatives for the LGBTQ community.

Dutee rued missing the World Relay Championships in Poland in May and two competitions in Kyrgyzstan and Kazakhstan this month due to travel restrictions on the Indians in view of the COVID-19 situation in the country.
