Statewide protests over Class X marks

STUDENTS, PARENTS RISE IN PROTEST ALLEGING DISCREPANCY IN CLASS X RESULTS

Bhubaneswar, June 28: Parents and students across the state Monday rose in protest against the alleged indiscretions and discrepancies in evaluation of HSC matriculation exam papers and the marks given to students by the Board of Secondary Education (BSE).

Exam results were published through special evaluation criteria under which students were given marks based on their Class IX exam results and pre-board tests in Class X.

Forty per cent weightage was given to highest marks secured in Class IX examinations in each subject, while 60 per cent weightage was given to Class X pre-board performance. Two highest marks in all subjects out of three practice tests conducted in Class X were given weightatge of 30 per cent each, sources said

Parents alleged that schoolteachers had messed up with the marks even as students pointed out that they had done very well in Class IX exams but still got less marks in Class X final results that were declared recently. Many students alleged that they were declared absent in exams even when they wrote the tests. The school authorities had failed to answer why these students were declared absent when they had already given the exams.

Basudev Bhatt, chairman of Odisha Parents' Federation, said matricula-

tion results were important for students as they will decide students' admission in colleges. "We demand a separate complaint cell for matric students and the complaints must be solved in 24 hours," Bhatt said. Meanwhile, the Board of Secondary Education Monday clarified that there had been no discrepancy in the marking.

President, BSE, Ramashis Hazra said the marking system is scientific and was based on a mathematical calculation. "The assessment was done on the basis of an analysis of four years. Following this, the marking was done in a graded manner. The 9th Std and pre-board marks were considered for preparation of the merit list," the BSE president clarified. "We got consistency in marks and adopted a standard. We decided to go for the moderation principle. All this was in the public domain and was

properly communicated," Hazra added. Vice President, BSE, Nihar Ranjan Mohanty, said, "Marks of students have not been reduced. We have done this marking on the basis of a principle - alternative mode of assessment and the moderation policy in it." The same principle has been applied to each candidate. Anyone who is not satisfied with the results can opt for the offline exam which will be held soon, he added. A record 97.98 per

The state GST enforcement wing has so far arrested 18 fraudsters for their involvement in issuance of fake invoices. Registration of 19,539 dealers have been cancelled in 2019-20 and 2020-21 fiscal years so far by the state GST officers on the ground of their non-existence after field inquiry or due to non-filing of returns.

Twitter needles India again

Iew Delhi, June 28: Amid a standoff with the Indian government over compliance with new IT rules, the Twitter website is displaying a wrong map of the country that shows Jammu and Kashmir, and Ladakh as separate country The glaring distortion, which ap-

pears on the career section of Twitter

website under the header 'Tween Life', has triggered a heavy backlash from netizens who are demanding strict action against the microblogging platform. This is not the first time that Twitter has misrepresented India's map. Earlier, it had shown Leh as part of China. A mail sent to Twitter on the issue did not elicit a response. The US digital giant has been en-

gaged in a tussle with the Indian government over the new social media rules. The government has confronted Twitter for deliberate defiance and failure to comply with the country's new IT rules, despite repeated reminders.

Notably, the microblogging platform has lost its legal shield as an intermediary in India, becoming liable for users posting any unlawful content. On Monday, social media users

slammed Twitter's gross misrepresentation of India's map, that appears on its career section. The global map, showing Jammu and Kashmir, and Ladakh outside India, triggered angry responses from netizens who are demanding stringent action be initiated against the microblogging platform that has flouted rules on multiple

occasions in the past. In October last year, Twitter came under heavy criticism and faced backlash after its geotagging feature displayed "Jammu & Kashmir, People's Republic of China" in a live broadcast from Leh's Hall of Fame, a war memorial for fallen soldiers in the Union Territory of Ladakh. India has issued a stern warning to Twitter that time, making it clear that any disrespect of the country's sovereignty and integrity is totally unacceptable.

In November, government issued a notice to Twitter for showing Leh as part of J&K instead of the UT of Ladakh, as Centre lambasted the platform for disrespecting the territorial integrity of India by showing an incorrect map. Twitter's apparent heavyhandedness has come under government scrutiny when the former did not fully comply with the new rules.





42 SHOPS SEALED FOR VIOLATION OF COVID-19 NORMS

Bhubaneswar, June 28: More than 40 shops in the Capital city were sealed and their owners penalised Monday for gross violation of Covid norms during a joint raid conducted by Bhubaneswar Municipal Corporation (BMC) and Commissionerate Police.

As per sources, a team comprising officials from the BMC and city police conducted surprise raids in six zones and sealed 42 shops While several mobile shops at Bapuji Nagar were sealed, about 18 automobile shops along Cuttack-Puri Road were also penalised and sealed

"During the raid today, we found many mobile phone shops opened at Bapuji Nagar in violation of lockdown norms and sealed them. A liquor shop was also sealed at Ashok Nagar and strict action will be taken against the owner. Police will continue to take action against the violators," said Manas Ranjan Garnaik, Zone-1 ACP

Popular garment shop Maa Tarini Bastralaya at Kalpana Square was also sealed and fined Rs 75,000. Sources said the shop was found operating behind closed doors during the raid. While the shop was ordered to shut down till June 30, all customers in the shop were also booked for violating Covid-appropriate behaviour.

Sources at the BMC said that $\,$ the civic body has decided to intensify its enforcement drive after several Covid-19 cases emerged in some particular areas this week.

Supply 6 lakh Covishield doses pronto, Centre told

Bhubaneswar, June 28: The state government Monday urged the Centre to immediately supply at least 6 lakh doses of Covishield vaccine in order to ensure an uninterrupted inoculation drive in the month of June.

Health and Family Welfare Minister Naba Kishore Das has written to the Union Health Minister Harsh Vardhan, in this regard.

The state has administered 1.14 crore doses of Covid-19 vaccines and saved 2.9 lakh doses since **January 16, 2021**

As per allocation for June (2nd fortnight), the state has received 13.78.310 doses of Covishield which have been sent to all the districts.

"As of today we have a stock of 3.38 lakh Covishield doses, which will last for two days. Thus, Covishield doses will be out of stock in the state from Tuesday onwards. In this situation, it will not be possible to conduct sessions in the state after Tuesday," Das said in his letter.

Therefore, Das urged Vardhan to allocate additional 6 lakh doses of Covishield to the state for the month

The districts where these nursing colleges would be set up are: Mayurbhanj, Bolangir, Koraput, Balasore, Jharsuguda, Puri, Sundargarh, Angul, Keonjhar and Jajpur. Besides, a pharmacy college will be attached to each of the three existing medical colleges and hospitals in the state, Das said.

New Delhi, June 28: Citing that the Kendrapara chariot festival brings different communities together, a petition has been filed in the Supreme Court seeking directions to the state government to permit the annual Rath Yatra of Lord Baladev Jew in Kendrapara district.

The petitioners challenged the June $2\bar{3}$ order of the Orissa High Court that refused to stay the order of the Odisha government restraining the annual chariot festival in the state, except in Puri.

"Undoubtedly, the Puri Rath Yatra is a global event drawing lakhs of devotees, but what the High Court has failed to appreciate is that the annual car festival of Lord Baldev Jew in Kendrapara also has a special spiritual and religious significance. Shree Gundicha Rath Yatra is usually observed for two days in Kendrapara, widely known as Tulasi Kshetra, while elsewhere it's a oneday festivity. Many Muslim devotees also take part in the Rath Yatra," the petition reads.

The petitioners contended that the Orissa High Court and the state government failed to assign any reason behind its decision of not allowing the chariot festival in Kendrapara. The petitioner said there are very less Covid cases in the district and Kendrapara is in green zone. The petitioner pleaded the apex court to permit chariot festival in Tulasi Kshetra at par with di-

Centre to provide free visas to 5 lakh tourists

New Delhi, June 28: In order to revive the tourism sector that has been ravaged by the outbreak of Covid-19, the Union government Monday announced that it would provide financial support to tourist guides and travel & tourism stakeholders. The Centre has decided to provide free visas to the first 5 lakh tourists once the international travel resumes.

During a press briefing in the national capital, Union Finance Minister Nirmala Sitharaman said that the government will provide loans to people in the tourism sector to discharge liabilities and restart businesses impacted due to Covid-19. The Union minister said that over 11,000 registered tourist guides and tourism stakeholders will be provided the financial support.

The Union government will provide loans up to Rs 10 lakh for travel and tourism stakeholders and up to Rs 1 lakh for tourist guides licensed at regional or state level with 100 per cent guarantee.

The Finance minister said that there would be no processing charges and foreclosure charges would also be waived. According to the Centre, as many

as 10,700 tourist guides recognised by the Ministry of Tourism and state governments will be covered under the scheme. Similarly, around 904 travel and tourism stakeholders recognised by the Ministry of Tourism will also be benefitted under the scheme. Significantly, the Union gov-

ernment has decided to provide free visas to the first 5 lakh tourists, once the international travel resumes, with an aim to increase the footfall of tourists from abroad. "Once visa issuance is

restarted, the first 5 lakh tourist visas will be issued free of charge. The benefit will be available only once per tourist," the Finance minister said.

The Centre said that the scheme will be applicable till March 31, 2022 or till 5,00,000 visas are issued. The scheme will have a financial implication of ₹100 crore.

BJP slams govt over Covid-19 mgmt 'Courts' role pivotal in making healthcare a fundamental right'

Bhubaneswar, June 28: The Odisha unit of Bharatiya Janata Party (BJP) criticised the state government alleging that the latter has failed to manage the Covid-19 crisis properly. This was revealed at the party's executive body meeting held virtually, Monday.

During the meeting, the party has passed various resolutions on political and social issues related to Odisha.

The meeting was held under the chairmanship of state BJP president Samir Mohanty while senior leaders including state-in-charge D Purandeswari, Union ministers Dharmendra Pradhan & Pratap Sarangi and party national vice president Baijayant Panda along with party MPs and MLAs attended the meeting.

The party has prepared the roadmap including strategy to counter the BJD-led state government during the next three months.

During the meeting, Union Petroleum Minister Dharmendra Pradhan urged all his colleagues to work as a soldier to bring real changes in the lives of 4.5 crore people of Odisha.



After the meeting, BJP leader Bhrugu Buxipatra said the government has failed in 'testing, tracking and treatment' to combat Covid. Despite severity of the Covid-19 situation in the state, testing has not been enhanced. The government has also suppressed the actual number of fatalities due to the virus, he alleged.

The state government has opened temporary medical centres (TMCs) utilsing the Central grant during the first wave of the pandemic. However, no such centre has opened again during the second wave and the government is yet to disclose the money spent for this purpose, Buxipatra alleged.

Apart from Covid mismanagement, the party has passed resolutions for state government's failure in allotment of houses under Pradhan Mantri Awas Yojana (PMAY). The PMAY houses are being allotted to BJD workers while the real beneficiaries are deprived of the Central scheme, they alleged. To provide livelihood support to the poor during this pandemic, the Centre is allocating thousands of crores under MGNREGA. But, the state government is using machines in the works which has created joblessness in rural areas, the BJP lead-

ers further alleged. The government has shown golden dreams to the migrant labourers, who suffered a lot due the pandemic. But, nothing has been done for them till now, they alleged.

The party unanimously passed a motion of thanks for Prime Minister Narendra Modi and Pradhan for providing free vaccines, free ration and assistance to farmers.

Reacting on this, BJD spokesperson Elina Das said the BJP leaders are making such false statements to encourage their party workers, who are in distress following BJP's defeat in West Bengal.

Odisha has successfully managed Covid-19 as compared to BJPruled states like Uttar Pradesh, Haryana and Madhya Pradesh, she said, adding, the state government was also awarded by the Centre for its work in MGNREGA and rural housing schemes.

Making a mockery of the BJP leaders, the BJD spokesperson said the saffron leaders should be appointed as advisors to the Union government on Covid-19 management.

We have to work towards a fairer health system that has explicit intentions to work towards a more inclusive and equitable healthcare system without any barrier of access due to cost, distance etc," Justice Panigrahi said.

Minor rape victim yet to get compensation

Bhubaneswar, June 28: The district administration in Kendrapara seems reluctant to pay compensation to a minor rape victim despite repeated instructions by the National Human Rights Commission. Hearing a plea filed by rights activist, Sagar Jena, a livid NHRC Monday again issued a reminder to the administration to pay the financial aid to the minor victim within four weeks.

The panel has warned the District Collector of personal appearance before the commission in case he fails to comply by next date. The 13-year-old girl was sexually abused by a 28-year-old youth as the victim's parents were away in Pattamundai area of Kendrapara in 2016. The accused allegedly posted the video of the incident on social media.

Bhubaneswar, June 28: Care Hospital in the city is coming up with an integrated headache clinic. Dr Mitalee Kar, a neurologist at Care Hospital in the city highlighted the causes and problems associated with different types of headache which has been a very common issue among people.

"Headaches can be of two types, mainly primary and secondary. A primary headache is not a symptom of an underlying disease. One common type of primary headache is migraine. The secondary causes of headache often have features that resemble migraine, tension-type headache, or a trigeminal autonomic cephalalgia. Caution must be exercised and warning signs and symptoms of secondary headache must be evaluated," Kar said.

According to Kar, the hemicranial headache which is often of throbbing quality and can be

associated with nausea, upset abdomen, vomiting with irritation to sound, light and strong smells. These often have identifiable stressors or triggers which we call as migraine triggers. It is more common in women and in urban population. It often causes considerable harm in quality of life due to the immediate effect of loss of concentration in the work at hand.

A headache history is the most important aspect of the evaluation of a patient presenting with headache, and eliciting worrisome features with directed questioning is necessary. The history must be taken without assuming that key features will be volunteered by the patient.

Since the headache needs multidisciplinary approach, the Care Hospital is coming up with an integrated headache clinic at Bhubaneswar to address the issue and it will involve the neurologist, an ENT specialist and an opthalmologist.

The fact that over 50 trucks car rying iron ore mined illegally have been seized so far jointly by the police and Forest department in June this year alone has laid bare the volume of illegal iron ore transported from the region. All these trucks were seized from the areas that were leased for mining. With the seizure, it came to the fore that the transportation of iron ore was being carried out without approval of the Directorate of Mines, resulting in revenue losses of lakhs of rupees

Balasore, June 28: India Monday successfully test-fired its new generation nuclear-capable Agni Prime missile from a defence base off Odisha coast, an official statement by DRDO said.



The surface-to-surface ballistic missile has a range of 1000 to 2000 km, it said. The sleek missile, an advanced variant in the Agni series, was test-fired from a mobile launcher off the Abdul Kalam Island in Odisha at 10.55 am, said a DRDO source.

Its trajectory was monitored by sophisticated tracking radars and telemetry along the coast line.

Rajkanika, June 28: A sculptor for 18 years, 37-year-old Trilochan Behera from Kendrapara district is on cloud nine ever since he received an order for making 25 statues of soldiers, which are to be installed at the National Defence Academy in Dehradun.

These 25 statues will be displayed in such a way that they will speak the bravery of Indian soldiers, informed Behera, a resident of nondescript Nuagaon village of Nahuni panchayat under Rajkanika block.

He said he has been outing his heart and soul into it as this is going to be his first work to be displayed at a place like the NDA.

"Born in a potter (Kumbhar) family, I have grown up playing with clay and making idols. Initially I tried my hand at making idols and dolls of clay. My parents -Brundaban and Jyoti - never discouraged me. Rather they helped me



improve my skill," he said while working on a statue.

completing his After Matriculation from Shri Ramchandra High School at nearby Sapalang village, he did his graduation from Olaver College. After the 1999 Super Cyclone ravaged Odisha he had to step out of his village to help his poor father run the family.

"Nanda Mausa, a known cement artist in the locality, of nearby Pegarpada village offered me an opportunity to work for him. I learnt a lot of things from him. My family's financial condition forced me to leave for Puri to earn more. After having a darshan of Lord Jagannath, I started searching for work and got an engagement with the Universal Art and Craft at Atharanala," he remembered

From thereon, he travelled to Berhampur and worked for some days there staying at a friend's house. He then visited several places including Mumbai, Delhi, and Mathura etc. and kept on honing his skill all the while.

He said his work was being appreciated by his employers as well as the visitors and the words of appreciation encouraged him. During this period, an opportunity came his way to work at the ashram of Jagatguru Kripaluji Maharaj in Uttar Pradesh and he worked there for 15 years

"As days passed by, my popularity as a sculptor increased. In 2020 when I was staying in New Delhi, a contractor known to me offered me a job to make statues for the National Defence Academy. Without giving a second thought Laccepted it. The offer came at a time when I was wondering how to proceed with the project during the Covid-19 pandemic broke out. I followed my parents' advice and returned home,"

CPC at 100

he Communist Party of China (CPC) will turn 100 July 1. When the party was founded in 1921, the CPC had only about 50 members and China was then an impoverished and weak country being bullied by foreign powers. Hundred years later, the CPC today has over 90 million members and China occupies the position of the second largest economy of the world. After having created and distributed COVID-19 world over, China is ready to celebrate the party's centenary with fanfare for which elaborate arrangements have been made. It has become such an economic power house that while developed countries such as the USA, Europe and Japan are reeling under the COVID-induced economic slowdown, China has emerged as the sole winner. It has achieved an economic expansion of around 2% in 2020 and is preparing to set a growth target of around 8% for 2021. The way it is progressing, China is going to overtake the US to become the world's largest economy by 2028, five years earlier than previously predicted. This is the latest estimate made by the UK-based Centre for Economics and Business Research (CEBR).

The CPC has planned the celebration in such a manner that it is using all its agencies to send the message across the globe that its political system of one-party rule is the best despite Western democracies' 'slander campaign' of serious human rights violation and repression of minority population in China. The CPC claims credit for what it calls 70 years' struggle since 1949 to establish a relatively complete and independent industrial and national economic development to significantly improve people's livelihood and boost comprehensive national power. Since the end of World War II, more than 100 economies have achieved national independence. However, only two economies grew from the low-income stage to the high-income stage from 1950 to 2008. They are South Korea and Taiwan. CPC asserts China can rightfully claim to be the third one by 2025.

It also believes developing countries can learn from it on how to run a party system as political parties in other countries have over the years been either fragmented, reorganised or withered away. But, CPC claims it has grown from strength to strength as it has its roots in the people. However, China's per capita income - about \$11,900 - is way behind that of developed countries such

China's State Council Information Office issued a white paper titled "China's Political Party System: Cooperation and Consultation," elaborating on the distinctive characteristics and strength of the country's political party system. The white paper explains the system is the product of a combination of Marxist political party theory and China's reality best described by President and CPC General Secretary Xi Jinping as socialism with Chinese characteristics.

The 19th CPC Central Committee adopted a new strategy late last year formulated by Xi to make domestic consumption in China the main pillar of the economy so as to reduce reliance on external demand. The strategy envisions a future global economy in which China does not rely on the world but the world cannot stand without China. The strategy's purpose, as summed up by Xi, is to increase the dependence of international supply chains on China and establish powerful retaliatory capabilities against foreign powers that would try to cut supplies.

The new strategy was adopted as Xi seems to be convinced that the US under Joe Biden would decouple its economy from China's. At any rate, the world powers are eyeing with suspicion China's expansion in the South China Sea and the Asia-Pacific region.

f ever any person justified this epithet for a man who behaves dishonourably, especially towards a woman, it was Major-General Sir Harry Paget Flashman, VC, KCB, KCIE. George MacDonald Fraser, who died in January 2008, borrowed the fictional bully of Tom Brown's Schooldays and made him the hero of a series of novels. Their conceit was that Flashman ended his life as a famous and highly decorated soldier, though by his own admission he had throughout been a scoundrel, cheat, lecher, poltroon and cad. Cad is the classic British contemptuous epithet of the nineteenth century. It appears, for example, in Jerome K Jerome's Passing of the Third Floor Back: "That you and your wife lead a cat and dog existence is a disgrace to both of you. At least you might have the decency to try and hide it from the world - not make a jest of your shame to every passing stranger. You are a cad, sir, a cad!" Its history is as weird as one might like. The word started life as cadet, either a military trainee or a member of a younger branch of a family. That developed into caddie, now solely a golfer's bag carrier, but in the eighteenth century any lad or man who hung about in the hope of getting casual work as an errand-boy, messenger or odd-job man. Both cadet and caddie were shortened to cad. Early on - for reasons unknown - it had the sense of an unbooked passenger who had been picked up by the driver of a horse-drawn coach for personal profit. By the early 1830s, it had come to mean the conductor of one of those newfangled London omnibuses, the man who rode inside to take the fares. Might the job have been one that was taken as casual employment by caddies? My references don't say. In 1895, George Augustus Sala commented in London Up to Date: "An omnibus conductor, nowadays, would, I suppose, were the epithet of 'cad' applied to him, resent the appellation as a scandalous insult; and, indeed, 'cad' has come to be considered a term of contempt, now extended to any mean, vulgar fellow of whatever social rank he may be."

IN BITCOIN WE TRUST?

Earlier this month, El Salvador became the first country to adopt Bitcoin as legal tender, enacting legislation that will take effect in September. This means that Bitcoin can be used to pay for goods and services throughout the country, and recipients are legally obliged to accept it.

Salvadorans are not new to this type of monetary experiment. The US dollar became legal tender in El Salvador in 2001 and is the currency used in domestic transactions. At that time, the government of President Francisco Flores allowed the dollar to circulate freely alongside the national currency, the colón, at a fixed exchange rate.

Dollar advocates argued that the expected benefits of macroeconomic stability would outweigh El Salvador's loss of economic sovereignty, monetary independence, and even seigniorage – the difference between the cost of producing coins and banknotes and their face value. But purchasing power suddenly plummeted and left the economy even more dependent on remittances, which have averaged about 20% of GDP per year over the past two decades.

Using Bitcoin as legal tender will exacerbate the monetary constraints that dollarisation revealed - notably, the lack of an independent macroeconomic-institu-

tional framework around which to shape domestic policies. Moreover, Bitcoin is much more volatile than the dollar. Between June 8 and 15, its value swung between \$32,462 and \$40.993, and in the period from May 15 to June 15, it ranged from \$34,259 to \$49,304. Such wide fluctuations - and the fact that they are entirely market-driven, with no scope for policymakers to manage the swings - make Bitcoin an unsuitable instrument for macroeconomic stabilisation.

El Salvador's president, Nayib Bukele, tweeted that Bitcoin will facilitate remittance transfers and considerably reduce transaction costs. The fees that migrants must pay to send their money home are scandalously high, despite many calls by the United Nations and the G20 to reduce them. According to the World Bank, the average global cost of sending \$200 internationally is approximately \$13, or 6.5%, well above the Sustainable Development Goal target of 3%.

Nonetheless, in 2020, low- and middle-income countries received remittances of \$540 billion - only slightly less than the 2019 total of \$548 billion, and much larger than these countries' inflows of foreign direct investment (\$259 billion in 2020) and overseas development assistance (\$179 billion in 2020). Reducing the fees to 2% could increase remittances by as much as \$16 billion per year.

The large but globally fragmented remittance business relies on electronic transfers via commercial banks' payment systems, and banks charge hefty fees for the use of this infrastructure and the benefit of a safe and reliable international network. But high fees are not the only issue. Many migrants don't have a bank account in the country where they work, and their families back home may also be among the 1.7 billion unbanked people worldwide. Furthermore, some migrants may need to transfer money to countries that either are not integrated into the international payment system or are restricted in their ability to receive cross-border transfers – for example, Syria or Cuba.

Bukele is right about the need to challenge this system, including by providing low-cost and low-risk alternatives. But Bitcoin is the wrong tool. Yes, it allows people to transfer value directly and globally, without the costly thirdparty intermediation. But its volatility makes it at best an asset - and an extremely risky store of value - rather than a means of exchange. The risk of a sudden drop in its price means that migrants and their families back home can never be sure about the amount transferred.

Rather than dismiss El Salvador's Bitcoin adoption as just another example of the crypto craze, we should reflect on why many people around the world are willing to embrace cryptocurrencies for non-speculative purposes. Perhaps the answer lies in the fact that the current international financial system serves them either poorly or not at all.

Innovations in digital money, such as the M-Pesa mobile money service in Africa, have made significant inroads into many developing countries' payment systems. But more needs to be done to provide the infrastructure and regulatory frameworks to support digital money. For now, the terrain remains patchy.

Coordinated cross-border policies are urgently needed to ensure that Bitcoin and its variants don't do more harm than good in developing countries. Unless both the public and private sectors embrace critical reforms and make basic banking services available to all at low costs, people and governments will increasingly be attracted by Bitcoin and other low-cost, high-risk, and murky alternatives to traditional banking.

Until now, all twenty, those who were the victims of vaccine mix and matching are healthy and have not reported any side effects, though they are scared, lest it precipitated any future bad results. This incident might be a mistake, but has evidently become an advent of intense debate amongst doctors and scientists; posing the question whether the mix and matching of vaccines is viable. n unprecedented incident munisation programmes against ebola, hepatitis, polio and many other diseases used different vacof Uttar Pradesh, around the third cinations to improve compatibility. It's not a new thing we are discussing, but yes, in the germane of Covid-19, it's a new thing. Let's know and get an insight into what is 'vaccine cocktail'. It's a process of interchangeability of different vaccines. Not necessarily taking the subsequent dose of same vaccine as the initial dose. Studies on it have found that mixing and matching could potentially lead to a roboust immune response against the virus, compared to the two doses of the same vaccine, by strengthening the antibodies in our body.

Studies are underway around the world in full swing to determine whether mixing doses of different vaccines are compatible or not. Experts believe that mixing of vaccines prepares the immune system against a wider range of threats including new variants. We have accounts of many countries giving its nod to the vaccine cocktail approach. For example, countries like Canada, France, Spain and many others have the nod for using a different vaccine for second dose if the first dose inoculated is AstraZeneca vaccine. Oxford found in an experiment on mix and match of vaccines conducted in UK last month, that taking AstraZeneca vaccines followed by a Pfizer shows mild to moderate post-vaccination symptoms. Also, another study is on roll in the UK, monitoring the effects of different combinations of Pfizer, Moderna, AstraZeneca and Novavax vaccines on volunteers to check the compatibility. A Spanish study had conducted an experiment involving 600 volunteers, from which 400 were administered with 1st dose of Covishield and second dose of Pfizer in 8 weeks gap. The result showed that the volunteers produced higher levels of antibodies compared to others. Russian vaccine Sputnik V is a combination vaccine by its design and, therefore, it has one of the highest efficacies - i.e. 91.6%

Several European countries are now advising its younger group of people to take up AstraZeneca vaccines as the first dose and an mRNA vaccine, mostly of Pfizer's as the second dose. However, the UK and the US have hitherto warned against mixing and matching unless it's unavoidable. As seen, they are sitting on surplus doses of vaccines; therefore it's not a worry for them. But low-mid income countries are facing the worst. The scarcity of vaccines and delayed vaccination may lead the

whole effort to futility. Because. experts have warned that if vaccination is not done within speculated time, there's high probability that the new variants would not be neutralised by the contemporary vaccines.

India however, like always, has played the safe side. The government has made it clear that it won't change its vaccine protocol until solid results of scientific studies come up. But India is not far behind. Dr NK Arora, chairman of Covid-19 Task Force under NTAGI, has told the media that India is soon likely to start experiment and monitor the feasibility of interchangeability of different Covid-19 vaccines. The experiment will be conducted on a trial basis and if the results are positive, we can expect the Health Ministry to possibly consider taking vaccine cocktail into its vaccine protocol. Personally, I'm neither in support nor do oppose the approach but totally with the scientific approach. But since our country has a gigantic obstacle to vaccinate its population in lesser time, it is necessary that the study bear fruitful results so that we can maximise our inoculation.

Balasore residents want border routes sealed

Jaleswar, June 28: The porous village routes in Balasore district connecting West Bengal were sealed off during the second wave of Covid-19. However, the areas where barricades and check posts had been put up are lying unguarded now. This has created apprehension among the local residents here. They are unhappy that the local administration has let its guard down now even as discussions about the third wave grow.

The routes connecting Balasore district to different parts of West Bengal had been sealed during the early stages of the second wave of the Covid-19 pandemic. The number of new infections had started going up drastically which prompted the district administration to implement strict measures. Checking at the Laxmannath toll plaza on National Highway-60 was also intensified. However, all that has considerably eased

Even though the number of daily new infections have started decreasing, the pandemic situation in the district is still grim. So lo-

cals said that restrictions are still needed.

Sources said that taking advantage of the relaxations infected persons from the neighbouring state are slipping into the district.

The barricades put up at Hatapada on Jagannath Sarak, at the toll plaza on NH-60, Ambaliatha-Solpata Road and Sugo-Matipura Road are currently not manned by police personnel. So vehicles from West Bengal are easily entering Odisha, locals said.

Besides, people from both sides are attending weekly markets held at places close to the border areas.

They are also taking part in social functions. In most cases Covid-19 protocols like wearing masks and maintaining social distancing are

not being followed. "Because of these factors, the number of Covid-19 cases in Jaleswar town is increasing," worried local residents alleged.

Dongrias get crumbs as AP traders reap profits

Bissamcuttack, June 28: The bumper harvest of pineapple in the Niyamgiri hill in Rayagada district is no longer a cause of joy for the Dongria Kondhs. With lockdown and shutdown restrictions in place and no cold storage facility or food processing unit nearby, they are ending up getting the crumbs, while the traders and middlemen from neighbouring Andhra Pradesh are laughing all the way to the banks.

There are 65 villages with a population of over 6,000 under Bissamcuttack block in Rayagada district. Of them, over 700 families earn their livelihood by selling duces. Most of the inhabitants are Dongria Kondhs living in 23 villages of Kurli panchayat, Kinjamjodi village of Chanchadaguda panchayat, some villages of Daliakuji panchayat in Bissamcuttack block and some villages of Munikhole panchayat in Muniguda block.

During this time of the year, huge quantities of pineapples are harvested here. Since the climate here is conducive for farming pineapples, on an average around

28,00,000 pieces of pineapple are

harvested from 2,000 acres of land. Besides pineapples, they also cultivate and sell turmeric, ginger, arrowroot, plantain, jackfruit and tamarind. In addition they also manufacture brooms from forest grass. According to information shared by Dongria Kondh Development Agency (DKDA) at Chatikana, over 300 MTs of mangoes, over 200 MTs of oranges and over 28,00,000 pineapples are harvested in Nivamgiri

areas every year.

Owing to the restrictions, neither are the regular traders from outside the state able to come to the area to buy their produces nor are they able to sell them in the local markets.

Meanwhile, the traders from Andhra Pradesh are cashing in on the situation. They are procuring the pineapples and other produces at throwaway prices and selling those in their state, earning huge profits in the process.

The Dongria Kondhs said they are forced to sell their produces at the price offered by the traders from Andhra to earn at least something than nothing because the shelf-life of pineapples is just one week and there is no cold storage facility in the region.

When contacted, deputy head, Odisha Rural Development and Marketing Society (ORMAS), Manoj Kumar Patra said some traders from Delhi recently visited the area and examined the quality of the pineapples grown by the Dongria Kondhs. "At present. pineapple is sold for ₹25 a piece here. The traders have asked for ₹18 a piece. Efforts are on to send the pineapples to Delhi after the price of the fruit drops here.'

Notably, SC and ST Development Minister Jagannath Saraka, during his recent visit to Bissamcuttack, held a discussion with Dongria Kondhs to take stock of the problems faced by them.

Problems plague Jagatsinghpur sub-jail

Jagatsinghpur, June 28: The Jagatsinghpur sub-jail at Alipingal in the district is suffering from serious security lapses and is open to influence from outside, a report said

There is road passing next to the south boundary wall of the prison. It has turned out to be quite useful for the prisoners to connect to the outside world. Associates of the convicts regularly come close to the wall and throw inside all types of material and contraband items like mobile phones,

This has been going on for many vears now. With the help of mobile phones, prisoners are able to keep in touch with the outside world and carry on their criminal ac-

There are a number of reasons why such activities are continuing. Prison authorities are yet to install mobile phone jammers within the premises. The prison also lacks watch towers to keep a proper watch on the inmates who carry out their criminal activities with impunity. Sources said the Jagatsinghpur sub-jail is spread over five acre of land and has the capacity to house 176 prisoners including 167 males and nine females. Currently, 161 prisoners

are lodged in the jail. The jail has seven male and one female ward and four male and one female cell. Some of the in-

mates have been convicted of heinous crimes. Yet their activities are not monitored in a proper manner by the authorities.

The road to the south of the jail is used by the residents of Naugaon block as well as 50 other villages to commute to their destinations.

the criminals come to side of the road when it gets deserted. They throw various items over the wall for their associates. Even though at times, these are confiscated by the authorities, on most occasions they find their way into the hand of the inmates. Local intelligentsia has demanded for a permanent solution to the problems. They claimed that the compound wall is only seven feet high. They feel if the height is increased substantially, it will prevent the supply of materials into the jail. Also the presence of a jammer will prevent mobile connection. Two watch towers should be constructed for keeping a watch on the prisoners. Some of them also suggested that CCTV cameras should be installed within the prison premises to watch the activities of the inmates

The lone dispensary in the jail premises providing healthcare to the inmates should be upgraded, former jailor Rabindranath Behera said. When contacted, jailor Ratikant Shukla admitted to the charges and assured to draw theattention of the higher authorities to resolve these problems.

Vax hesitancy high among J&K women



Very few women in the villages of Kashmir are getting themselves vaccinated against Covid-19 as many believe it can cause problems in menstruation, pregnancy and fertility

Pulwama (J&K), June 28: India started its vaccination drive against Covid-19 almost six months back and consistently, a lot more men have been vaccinated as compared

In fact, government vaccination data has revealed that nearly 17 per cent more men are partially or completely vaccinated than women. And this gender disparity is almost double in the region of Jammu and Kashmir. This is mainly because myths and suspicions about the safety of the vaccine abound in the region. Shameema, a 35-yearold woman, who lives in Balpora vil-

lage in south Kashmir's Shopian district has been consistently hearing negative comments regarding the Covid vaccine, especially from other married women. "They say if women take a dose of the vaccine, it will create problems in pregnancy. Women won't conceive then," she said, sounding concerned.

Such comments have prevented her from taking the jab so far. Talk about the multiple benefits of the vaccine, and she still isn't sure. "But who can guarantee our safety?" she questioned.

According to the data available on the Covid-19 Vaccine Intelligence Network (Co-WIN) portal, which tracks the beneficiaries on a realtime basis, the highest gendered difference among vaccinated individuals is from Srinagar. The data available shows that four out of ten districts have fewer women getting vaccinated as compared to men. The fact there is limited information/data available about certain aspects of the vaccine's effect on menstrual health is also problematic. The US-based Centers regarding pregnant women in which they said that pregnant women are at a higher risk of Covid-19 infection and one way to avoid serious implications of Covid-19 is to take the vaccine. The CDC also states that 'Based on how these vaccines work in the body, experts believe they are unlikely to pose a risk for people who are pregnant. However, there is currently limited data on the safety of Covid-19 vaccines in pregnant people.'

Experts believe that rumours have played a crucial role in the behaviour of women and men in Kashmir towards vaccination. There are concerns of menstrual problems, infertility and high risk in pregnancy post-vaccination.

In the villages of Pulwama, about 21 km from Shopian, vaccination drives have been going on for nearly two months now. People are being vaccinated in many villages like Palpora, Chatripora and Trichal.

Najma Parvaiz, a 25-year-old field worker from Trichal village, who is part of the drive, has been going door to door to motivate people to take the vaccines. But this has not been an easy task as she has faced a lot of opposition from women, who believe vaccinations can cause them harm. One way in which she has encouraged others to get vaccinated is by telling them that she is herself vaccinated. "This encourages a few." she said.

But local myths are not the only reason for vaccine hesitancy here. A few weeks ago, a message was widely circulated on social media regarding French Nobel laureate. Luc Montagnier, who claimed that everyone who has taken the vaccines will die in two years.

The message created chaos among people and even reached the villages where Parvaiz was working. It caused massive vaccine hesitancy, especially among

cial distance. The government also allowed vegetable markets to remain open from 6 am to 12 pm. The restrictions, imposed on May 16, were last extended till June 30.

Pakistani flag amid chanting of slogans in protest against the lat-

The protesters, who were carrying the national flag in their hands, later dispersed off peacefully, officials said. "We have organized this protest to condemn the killing of an SPO and his family and the first-of-its-kind attack on an IAF base in Jammu and Kashmir and demand appropriate measures to counter such attacks and a befitting response to Pakistan for this shameful action," Gupta

told reporters. Without naming any political party but apparently referring to PDP chief Mehbooba Mufti, he said such incidents should serve as an eye-opener for those who are seeking dialogue with Pakistan which wants to "destroy our country".

"Pakistan is not going to mend its ways and the only solution to end this conflict is to unfurl the Indian flag across the border," Gupta said, adding "there is a need to wage a war against Pakistan and its supporters in Jammu and Kashmir after this heinous act (drone attack on IAF base).

WB Assembly: No disqualification in a decade

Kolkata, June 28: Once a reviled practice in West Bengal, the "Aaya Ram Gaya Ram" culture has made deep inroads into the state as several MLAs, in the past decade, were seen frequently crossing the floor, with none facing any action under the anti-defection law.

Speaker Biman Banerjee agreed that there was no instance of MLA disqualification in the last ten years on the ground of defection, but did not elaborate further.

"It is true that the Assembly has not recorded any case of disqualification since 2011. But I would not get into details," the three-time speaker told PTI.

The latest flashpoint is the defection of veteran leader Mukul Roy, who won the March-April Assembly polls on a BJP ticket but switched over to the TMC earlier this month.

The saffron party, on its part, has filed a plea before the Speaker seeking Roy's disqualification, only to receive flak from the ruling TMC, which said that MPs Sisir Adhikari and Sunil Mondal, who had joined the BJP ahead of assembly polls, should first quit the



membership of Lok Sabha.

Since the ascendance of the TMC in Bengal, switching parties, a practice looked down upon prior to 2010, has almost become commonplace, according to political

Over four dozen legislators from the Congress, Left Front and the TMC switched sides in the 15th and 16th Legislative Assembly -

In the 16th Assembly alone, around 25 of 44 Congress MLAs and eight of 32 Left MLAs had crossed over to either the TMC or the BJP.

However, only 12 disqualification pleas were filed by the Congress and one by the CPI(M). Also, since 2019, at least 22 TMC MLAs had switched over to the BJP, but none barring Suvendu Adhikari and Rajib Banerjee resigned from the membership of the Assembly.

In many cases, parties have refrained from filing disqualification pleas for "fear of losing the main opposition party status in the assembly". Former Leader of the Opposition Abdul Mannan told PTI that the anti-defection law "has turned into a joke" under the BJP rule at the Centre and the TMC in the state. "Sadly, no action was taken by the speaker in the dis-

qualification cases that we filed

over the years. We stopped doing that after a while as it would have harmed our party's strength in the House. We could have lost the opposition party status," Mannan

Giving an example, former Left Front Legislative party leader Sujan Chakraborty said Left MLA Dipali Biswas, who had switched over to the TMC just after the 2016 assembly polls only to dump the party for the saffron camp last year, continued as a member of the House, despite 26 hearings on her disqualification case.

"When no action was taken against her, we understood that the speaker wasn't willing to initiate any. We stopped filing such application. End of the day, it is a matter of political will," he said.

The Anti-Defection Law, 1985, states that a member of a House belonging to any political party shall be disqualified if he or she has voluntarily given up the membership of a political party, votes or abstains from voting in the House contrary to any direction issued by the party he represents, and if a representative of a certain politicalparty joins another outfit after the

New Delhi, June 28: For the first time in 70 years, India has changed its posture towards China, unlike its previous defensive approach that placed a premium on fending on Chinese aggression, India is now catering military options to strike back and has reoriented its military accordingly.

India has reoriented around 50,000 troops whose main focus will be the disputed border with China. Sources said that the Mathura-based 1 strike Corp, earlier tasked to cross the western borders into Pakistan, has been reoriented from its position to disputed border areas with China.

In addition to this, in the Central Sector - the least disputed portion of the border running along with Himachal Pradesh, Uttarakhand to Nepal, deployment has also been strengthened with at least division level troops. A Division of the Indian Army has at least 10,000

The Panagarh based Mountain Strike Corps has been assigned to the Eastern sector of the border. The XVII Mountain Strike Corps, also called the Brahmastra Corps,

has been assigned to hit back along with the eastern sector when the need arises. The Mountain Strike Corps was cleared by the Centre about a decade ago but it had only one Division attached to it so far. The government is taking all requisite steps for strengthening of the Mountain Strike Corps. This reorientation of the troops will lessen the soldiers dedicated solely to Pakistan but at the same time, more acclimatized troops who can shift from the northern border to the western border with Pakistan will be available to Indian military planners. This gives the Indian defence establishment a higher level of maneuverability and flexibility vis-avis its neighbours.

The reorientation comes when China is refurbishing its existing air-fields in Tibetan Plateau that will allow twin-engines fighter aircraft to be stationed, sources said. In addition, China has also brought troops from the Tibet Military region to the Xinjiang region - which largely extends from Karakoram pass to down south Uttarakhand. Further, they have deployed larger numbers of long range artillery and are rapidly building infrastructure in the Tibetan Plateau.

'Army capable of giving befitting reply if provoked'

New Delhi, June 28: India believes in resolving disputes with neighbours through dialogue but it will not tolerate if provoked or threatened, Defence Minister Rajnath Singh said while addressing soldiers in Ladakh on Monday, in a clear message to China amid a stalemate in the disengagement process in remaining friction points in eastern Ladakh.

Speaking at an event in a forward location on the second day of his visit to the region, Singh said India is a peace-loving nation that never resorts to any kind of aggression but its armed forces are always prepared to give a befitting reply to those who "show their eyes" to

Asserting that the nation's safety and security will not be compromised at any cost, Singh said the solution to any dispute can be found if there is a clear intent. The defence minister also paid glowing tributes to the 20 soldiers killed in the Galwan Valley clashes



in June last year, and said the country will never forget their sacrifices. "India is a peace-loving nation which does not believe in aggression, however, if provoked, we will give a befitting reply," he said. Singh's three-day visit to the region comes in the midst of a stalemate in resolving over a yearlong standoff between Indian and Chinese troops in several friction points in eastern Ladakh though they withdrew troops and weapons from Pangong lake areas in February. "We had to face a big challenge along the Northern border last vear. But our armed forces displayed their courage and dedication to deal with it...Our Army has the capability to give a befitting reply to every challenge," he said. The defence minister assured the nation that the armed forces are fully prepared to deal with any situation. "We have always worked for world peace. We never attack anyone. Our objective has never been to achieve victory against anyone. India has neither attacked any country nor occupied an inch. Our intention is very

Preliminary analysis shows use of RDX in explosives: Officials

Jammu, June 28: A preliminary analysis of the payload carried by the two drones used in attacking the IAF station here Sunday indicates that a cocktail of chemicals including RDX may have been used, officials said Monday, with investigators vet to establish the flight path of the unmanned aerial vehicles.

The IAF station located at Jammu airport continued to remain out of bounds for everyone with probe teams, which included one from the National Investigation Agency, picking up every bit of evidence available on the ground.

The officials said the explosive material dropped by the drones might have been manufactured using a cocktail consisting of RDX but a final confirmation was still awaited.

They said an NSG post-blast analysis team has been sent to the IAF station to study the material. This team will share its findings with the Jammu and Kashmir police and the NIA after completing

BATTLE AGAINST COVID-19

India overtakes US in vaccinations

New Delhi, June 28: India has overtaken the US in the total number of Covid-19 vaccine doses administered so far the Union Health Ministry said Monday.

While India launched the Covid-19 vaccination drive on January 16, and has administered over 32.36 crore doses till date, the US which started its inoculation drive December 14, 2020 has given over 32.33 crore doses.

"India achieves another milestone in COVID-19 vaccination and overtakes USA in total number of COVID-19 vaccine doses administered," the ministry said.

India's cumulative vaccination coverage exceeded 32.36 crores on Sunday. A total of 32,36,63,297 vaccine doses have been administered through 43,21,898 sessions, as per the provisional report till 7 am on Monday, the ministry said.



It said 17,21,268 vaccine doses were administered in the last 24 hours. According to the data, so far 1,01,98,257 healthcare workers have taken the first dose while 72,07,617 have taken the second dose. As many as 1,74,42,767 frontline workers have received the first dose while 93.99.319 have taken the second dose. In the 18-44 age group, 8,46,51,696 individuals have taken

Take up inclusion of Covishield in EU vax passport: Serum Institute

Serum Institute of India (SII) has urged the government to take up inclusion of Covishield in the EU Covid-19 Vaccination Passport with the European Union and other countries, saying if not done it will affect students and business travellers, and disrupt the Indian and global economy. Only four vaccines -- Comirnaty of Pfizer/BioNTech, Moderna, Vaxzervria by AstraZeneca-Oxford and, Johnson & Johnson's Janssen -- have been approved by the European Medicines Agency (EMA). Only those inoculated with these vaccines will be given vaccination passports and allowed to travel within the EU during the pandemic. "India has a large population. However, not including Covishield in the EU Covid-19 Vaccination Passport will not allow Covishield vaccinated people to travel to European countries and this will affect students, business travellers back and forth, and cause severe disruptions to our economy and to the global economy," a source quoted Adar C Poonawalla, CEO of SII, as having communicated in a letter to External Affairs Minister S Jaishankar.

Pvt schools in Delhi can collect annual fee

New Delhi, June 28: The Supreme Court Monday refused to stay the Delhi High Court order allowing private unaided schools to collect annual and development charges from students for the period after the lockdown ended in the national capital last year.

A bench comprising Justices A M Khanwilkar, Dinesh Maheshwari and Aniruddha Bose did not agree with the submission of the Directorate of Education (DoE) of Delhi government that it has the power to regulate the levy of fees by private unaided schools and as an interim order, the high court judgement permitting such a levy of annual and development charges be stayed.

The bench, however, said although it was dismissing the appeal of the Delhi government, this would not come in the adjudication of its



plea by a division bench of the high court as nothing on merits have been recorded by it.

Senior advocate Vikas Singh, appearing for Delhi government, vehemently sought the stay of the high court's judgement saying, "lakhs and lakhs of parents will be affected. Please don't shut us out".

On May 31, a single-judge bench of the high court had quashed the office orders of April and August 2020 issued by DoE of the Delhi government forbidding and postponing collection of annual charges and development fees.

FAKE APPS TARGETING VAX REGISTRATION PLANS

TROJANS POSE ONE OF THE BIGGEST THREATS TO CONSUMERS THIS YEAR, ACCOUNTING FOR 90 PER CENT OF ALL PANDEMIC-RELATED MALWARE

New Delhi, June 28: Cybersecurity company McAfee has said that following a year of lockdowns and a surge in time spent online and on devices, fraudsters are capitalising on the situation with more approaches, with 2021 shaping up to be a year of 'malware misinformation and sneak attacks'.

McAfee's latest Mobile Threat Report finds hackers capitalising on the pandemic to target unsus-

pecting consumers. These include fake apps targeting vaccine registration programmes and India and Chile have been most attacked with these campaigns. They also include billing fraud malware that makes purchases behind the backs of consumers. Hackers are also using banking Trojans to target hundreds of financial institutions around the world.

As per the report, more than 90 per cent of all pandemic-related malware took the form of Trojans. McAfee researchers found evidence of an SMS worm targeting Indian consumers, forming one of the earliest vaccine fraud cam-

Both SMS and WhatsApp messages encouraged users to download a vaccine app and once downloaded, the malware is sent itself to everyone in the user's contact list via SMS or WhatsApp. The malware be-



hind this is the same family that was involved in India's ban on the TikTok app in July last year. Researchers have also uncovered new information on a mobile malware dubbed Etinu. Targeting users in Southwest Asia and the Middle East predominately, Etinu was found being distributed via Google Play, with more than 700K downloads before being detected and removed.

Once an app harbouring this malware is installed via the Google Play Store, the malware steals incoming SMS messages using a Notification Listener function. It can then make purchases and sign up for premium services and subscriptions that get charged to the user's account.

McAfee's new Mobile Threat Report reveals that 2021 is shaping up to be a year of malware misinformation and sneak attacks At the end of 2020 (Q4), total mobile malware detected by McAfee reached 43 million, with over three million of these detections being new hackers are using mobile malware dubbed Etinu to read SMS messages and extract the information needed to confirm subscriptions to premium-rate services, unbeknown to the user. Over 700K downloads were reported before being detected and removed.

With most of the world still anxious about COVID-19 and demand for vaccines high, McAfee's research sheds light on how hackers are targeting these fears withbogus apps, text messages, and social media invitations.

Malaysia announces \$36bn Covid package

Kuala Lumpur: Malaysia's leader announced a 150 billion ringgit (\$36.2bn) financial package Monday to help needy households and businesses and bolster vaccination efforts after a national coronavirus lockdown was extended indefinitely. Washington, June 28: US Secretary of State Antony Blinken said Monday that 10,000 Islamic State fighters continue to be held in detention in camps run by the Kurdish-led Syrian Democratic Forces (SDF), and that this situa-



Speaking at the opening of a meeting in Rome to renew international efforts to combat the Islamist militia, Blinken said Washington continued to urge countries, including the 78 member countries of the coalition against Islamic State, to take back their citizens who had joined the group.

"This situation is simply untenable. It just can't persist indefinitely. The United States continues to urge countries of origin, including coalition partners, to repatriate, rehabilitate, and where applicable, prosecute their citizens, Blinken said in his opening re-

Another key element of defeating Islamic State on a permanent basis required addressing the threats from the group outside Iraq and Syria, and namely in Africa, Blinken said.

Originally an offshoot of al Qaeda, Islamic State seized large swathes of Iraq and Svria from 2014, imposing a reign of terror with public beheadings and attacks by supporters abroad. Islamic State was declared mil-

itarily defeated in 2017 but has since waged a steady insurgency across parts of northern Iraq and a porous border with neigh-

Washington, June 28: The US is set to witness an explosive outbreak of the Delta Covid variant in a month's time, if people are not fully vaccinated, warned Eric Feigl Ding, an epidemiologist and a public health scientist.

"The US has just one month to act before it becomes full blown Delta variant dominant. One month to slow it down. One month to fully vaccinate," Feigl-Ding said in a series of tweets. He urged the US Centers for Disease Control and Prevention (CDC) and the World Health Organization (WHO) to take urgent steps to vaccinate people in the US.

"But we likely have even less



time than that if CDC doesn't act soon," Feigl-Ding said.

"If the CDC doesn't issue new guidelines to stem the growth of #DeltaVariant, which can transmit via merely 5-10 seconds of passive breathing exposure, it will be extremely derelict," he said.

"The Delta variant is leaps and bounds faster than any other variant known to date. It represents a clear and present danger to the world. This Delta variant surge will not end well for low vaccination areas," he noted.

FM announces ₹50,000 crore loan guarantee scheme for health infra

New Delhi, June 28: Finance Minister Nirmala Sitharaman Monday announced additional funding of ₹23,220 crore for setting up paediatric beds and facilities in hospitals. Announcing a set of measures for reviving the economy battered by a severe second wave of Covid-19, Sitharaman also announced a ₹50,000 crore credit guarantee scheme for setting up of medical or health infrastructure by private hospitals in cities other than eight metropolitan cities.

'We are now providing ₹23,220 crore more primarily focussing on children and paediatric care. This ₹23,220 crore will be spent this financial year itself.

"It will also focus on funding of HR augmentation so that medical students, interns, nurses can also be brought in for helping in such emergencies. ICU beds will be made available, oxygen supply at central, district and subdistrict level will be ensured and also making sure that equipments and medicines, tele-consultation and ambulance service... All of that will be taken care of with primary focus on children. So paediatric care is the emphasis," Sitharaman said at a press conference.

She said last year a ₹15,000 crore emergency health systems project was implemented. Using that ₹15,000 crore, there was a 25-fold increase in COVID dedicated hospitals.

UK watchdog bans cryptocurrency exchange Binance

London, June 28: The UK's Financial Conduct Authority has banned the major crypto exchange Binance from conducting regulated activity in the country, including Binance Markets Limited and its parent Binance Group, the media reported.

The watchdog didn't say just why it blocked Binance but noted that an "imposition of requirements" kept Binance from

Binance has until June 30 to confirm that it's honoring the FCA's demands, citing Financial Times, Engadget reported.

According to the report, in the past, it said it took regulatory obligations "very seriously" and was "committed" to honouring the rules wherever it operated



Binance is one of the largest crypto exchanges on the planet, with locations around the world and an industry-leading trading volume of about \$2.46 trillion as of May 2021.

The FCA's crackdown could not only limit trading in a major market but hurt the company's reputation. It's not clear how easily Binance can address its situation. but it's under more than a little pressure to act quickly.

'Co-op banks shall not outsource core management functions'

Mumbai, June 28: The Reserve Bank of India (RBI) Monday directed cooperative banks not to outsource core management functions such as policy formulation, internal audit and compliance, compliance with KYC norms, credit sanction and management of investment portfolio.

Issuing guidelines for managing risk in outsourcing of financial services by cooperative banks, the central bank said the lenders can hire experts, including former employees, on a contractual basis subject to certain conditions Outsourcing is defined as use

of a third-party to perform activities on a continuing basis that would normally be undertaken by a cooperative bank itself, now or in the future. 'Continuing basis' would include agreements for a limited period.

Cooperative banks are increasingly using outsourcing as a means for reducing costs as well as for availing specialist expertise, where these are not available

While it is entirely the banks' prerogative to take a view on the desirability of outsourcing a permissible activity having regard to all relevant factors, including the commercial aspects of the decision, such outsourcing results in banks being exposed to various risks, the RBI said

"Cooperative banks which choose

however, shall not outsource core management functions including policy formulation, internal audit and compliance, compliance with KYC norms, credit sanction and management of investment portfolio," the guidelines said.

The guidelines, the RBI said, have been issued to enable the cooperative banks to put in place necessary safeguards for addressing the risks inherent in outsourcing of activities.

They have been asked to conduct a self-assessment of their existing outsourcing arrangements and bring the same in line with these guidelines within a period of six months.

As per the guidelines, outsourcing of any activity by a cooperative bank does not diminish its obligations and those of its Board and CEO along with the management, who have the ultimate responsibility for the outsourced activity.

A cooperative bank intending to outsource any of its financial activities will have to put in place a comprehensive outsourcing policy, approved by its Board, in line with the criteria indicated in the guidelines.

The indicative key risks in outsourcing that need to be evaluated by the co-operative banks, include, strategic risk, reputation risk, compliance risk, operational risk. legal risk, exit strategy risk, and country risk.



World No.1 Belgium ride on Thorgan Hazard's screamer to drop the Euro 2020 curtains for defending champions Portugal, setting up their quarterfinal face-off with Italy

Seville, June 28: Belgium stopped Cristiano Ronaldo on one end, and had just enough attacking power

The top-ranked Belgians held Ronaldo scoreless Sunday and held onto a first-half lead to beat Portugal 1-0 and advance to the quarterfinals of the Euro 2020.

Ronaldo, who threw his captain's armband to the ground in despair after the final whistle, is still one goal shy of becoming the all-time men's top scorer in international soccer. He came into the match tied with former Iran striker Ali Daei at 109 goals. Belgium, which has never before won a major soccer title, will next face Italy Friday in Munich.

Belgium's potent attack, led by Kevin De Bruyne, Eden Hazard and Romelu Lukaku, also strug-

gled, but Thorgan Hazard scored the winning goal in the 42nd minute with a swerving shot from outside the area. Portugal goalkeeper Rui Patrício was left wrong-footed and was late to swat the ball away.

Belgium played most of the second half without De Bruvne, who had to be substituted after being tackled from behind and injuring his left ankle. De Bruyne missed the team's first game at Euro 2020 while recovering from a facial injury sustained in the Champions League final.

Portugal had several good chances to equalize late in the match, including a header by Ruben Dias saved by Belgium goalkeeper Thibaut Courtois and a shot by Raphael Guerreiro that hit the post.



While Portugal's run for a second consecutive European title ended, Belgium stayed on track to end its title drought. The Belgians lost in the European Championship final in 1980 and finished third three years ago at the World Cup for their best finish at that tournament.

The game grew heated at times. with a small altercation starting in the 76th after Portugal defender Pepe came in hard on Thorgan Hazard while play was stopped as Lukaku waited to be attended by doctors after being hit on the head by an opponent's foot.

Euro exit caps CR7's poor season ASSOCIATED PRESS

Seville, June 28: Cristiano Ronaldo was slowly walking off the field when Romelu Lulaku came over to give him a hug. The two embraced for a few moments, with Lukaku speaking into the Portugal great's ear. Ronaldo politely thanked him, but quickly made his way back to the tunnel.

He wasn't in much of a chatting mood. While Lukaku was moving on to the European Championship quarterfinals with Belgium, Ronaldo was heading home after a disappointing end to his tournament - and to his sea-

There was no repeat European title. There was no world scoring record. And there probably won't be a player of the year award, ei-

The 36-year-old Ronaldo capped a lackluster season in Portugal's 0-1 loss to Belgium in the round of 16 at Euro 2020 Sunday.

Even though he scored more than 40 goals with his club and his country, his numbers were far from impressive by his standards. He failed to win the Italian league with Juventus, where his future remains uncertain with his contract ending next year. His only titles in 2021 came in the Italian Cup and the Italian Super Cup.

Ronaldo got off to a fantastic start at Euro 2020, though, scoring five goals in the first three matches to move level with former Iran striker Ali Daei as the

men's all-time top scorer with 109 goals.

Portugal had several chances throughout the match at La Cartuja Stadium in Seville, but Ronaldo himself wasn't much of a threat. He had a few chances off free kicks in each half, and with a shot from inside the area near the end of the

Ronaldo was backed by a talented Portugal squad that included Bernardo Silva, Bruno Fernandes and Diogo Jota, among others. But they also faltered in attack Sunday, and Thorgan Hazard's first-half goal ended up being enough to send Belgium to the quarterfinals.

Portugal lost at the same stage at the 2018 World Cup, two years after winning their first major title at Euro 2016. The team's other triumph was winning the inaugural Nations League in 2019.

"It's a big disappointment for us because we believed we could win, like we did in 2016," Portugal coach Fernando Santos said. "But there are things to look forward to. In 2018, we were eliminated as well but then in 2019 we won the Nations League. Now we will try to win the World Cup (in 2022).

Ecuador hold Brazil at Copa

Sao Paulo, June 28: Ecuador held a below-strength Brazil to a 1-1 draw to secure a spot in the Copa America quarterfinals. Neymar, defender Thiago Silva and striker Gabriel Jesus didn't play against Ecuador at the Olimpico Stadium in Goiania.

Anguished England face Germany test

London, June 28: When you train on the Sir Bobby Charlton Pitch, it's hard escape the burden of past glory. And when Gareth Southgate is your coach, it's even harder for the England players to escape the anguish that can come from playing Germany at a tournament.

It was Southgate's penalty miss in a shootout against Germany that prevented England from reaching the 1996 European Championship final at the old Wembley Stadium.

There had already been the loss to Germany on penalties at the 1990 World Cup. Twenty years later came more World Cup agony against Germany, laced with the injustice of a wrongly disallowed

No wonder the renewal of the rivalry with Germany Tuesday in the round of 16 at this year's European Championship is rousing so many memories of past meetings in England. But it can seem to be a lopsided rivalry

There's little sense in Germany about righting any wrongs of the past, despite the still inconclusive debate over whether Geoff Hurst's decisive goal really did cross the line before Charlton and Co. Lifted the World Cup in 1966 at Wembley. Even though Uwe Seeler did say ahead of Tuesday's 33rd England-Germany match "this wound will always be there" from the 1966 team he captained.

That final produced what re-



mains England's only major international trophy and a reference point in the history of the nation, beyond sports. Germany had already won the World Cup by that point – in 1954 — and has won another three titles since then pre

and post-unification. Add a trio of European Championship wins on top of that and you see that Germany has many glory-filled memories, while England clings to the nostalgia of 1966 and the subsequent heartache

WT20 TO BE SHIFTED TO UAE

New Delhi, June 28: The T20 World Cup scheduled to be held in India is being shifted to the UAE owing to the health safety concerns posed by COVID-19, BCCI President Sourav Ganguly told this agency Monday, ending weeks of speculation surrounding the mega-event in October-November.

"We have officially intimated the ICC that the T20 World Cup can be shifted to the United Arab Emirates. The details are being chalked out," Ganguly said. "The decision was taken keeping health safety concerns of all stakeholders in mind," he added. The BCCI will, however, remain the hosts of the showpiece.

nalised as the start date of the tournament, Ganguly said: "We will be able to finalise itinerary details in some days. October 17 start

hasn't yet been finalised.' Even an ICC spokesperson confirmed that the global body is yet to zero in on a final schedule. The ICC, at the start of the month. had given BCCI a four-week window to decide and inform whether India could host the marquee event considering the COVID-19 situa-

tion in the country. The news agency was first to report May 4 that the tournament was being shifted to the UAE. This was after the pandemic forced the postponement of IPL, the second part of which is also being held in the UAE in September-October.

It was a foregone conclusion that India will find it difficult to host a 16-country tournament across nine cities with so many layers of health security concerns being there. In fact, the ICC had already started its preparations and logistics for the tournament which will be held in Dubai, Shariah and Abu Dhabi,

The qualifying round could be played in Muscat, which will give ideal time to the pitches in UAE to freshen up after 31 remaining games of IPL are held till October 15.

Once the IPL was shifted to the UAE, it was a foregone conclusion that the World T20 will move too given the looming concerns about a possible third wave of COVID-19 infection around that time.

Shooter Rahi bags gold at World Cup

Osijek, June 28: Olympic-bound Rahi Sarnobat displayed sensational form to clinch the women's 25m pistol gold medal at the ISSF shooting World Cup here Monday but teen sensation Manu Bhaker ended seventh in the same event.

Sarnobat's gold is India's first in the ongoing edition after the country secured one silver and two bronze medals earlier in the tournament.

The 30-year-old Sarnobat fired a final score of 39 after qualifying second with a total of 591. Her stupendous performance in the final included perfect scores in the third, fourth, fifth and the sixth series. The silver went to France's Mathilde Lamolle, who scored 31 in the final.

In the qualification, Sarnobat fired a brilliant 296 in the rapid fire round Monday. Her precision score was an equally impressive 295

Bhaker recorded a total of 588 to qualify third after firing a 296 in the rapid fire round on Monday following an impressive 292 in the precision round Sunday.

However, she was eliminated early in the final with a disappointing score of 11, losing a shootoff to Bulgaria's Viktoria Chaika. Bhaker had teamed up with Saurabh Chaudhary for the 10m air pistol mixed team silver.

She had earlier clinched the women's 10m air pistol team bronze with Sarnobat and Yashaswini Deswal. Before that, Chaudhary



had won the men's 10m air pistol individual bronze medal.

This is the last competitive outing for the Olympic-bound shooters, who will go to Tokyo after their stint here.

PARIS: Star Indian archer Deepika Kumari Monday regained the No.1 position in global rankings following her hat-trick of gold medals at the World Cup Stage 3 here. "This is going to take Deepika to the No.1 spot in the world rankings Monday," World Archery had tweeted after Deepika's gold rush.
