France begins judicial probe into Rafale deal

CONGRESS SATURDAY URGED PM NARENDRA MODI TO ORDER A JPC PROBE

New Delhi, July 3: A French judge has been appointed to lead a "highly sensitive" judicial inves-tigation into alleged "corruption and favouritism" in the ₹59,000 crore Rafale fighter jet deal with India, French investigative website Mediapart reported.

Following the development, Congress chief spokesperson Randeep Surjewala Saturday urged Prime Minister Narendra Modi to come forward and order a Joint Parliamentary Committee (JPC) probe into the Rafale deal.

"Corruption in the Rafale deal has come out clearly now. The stand of the Congress party and Rahul Gandhi has been vindicated today after the French government has ordered a probe," he told reporters at a press conference. However, there was no immediate reaction

from the Indian government. The Mediapart said the probe into the inter-governmental deal signed in 2016 was formally opened June 14. "A judicial probe into suspected corruption has been opened in France over the 7.8-billion-euro

State will not procure any more paddy this season

Bhubaneswar, July 3: Odisha Food Supplies and Consumer Welfare Minister Ranendra Pratap Swain Saturday made it clear that the state government will not procure any paddy beyond the deadline, which ended June 30.

Swain said this while reacting to the protests by the state unit of BJP at various places, especially in western Odisha, demanding procurement of paddy from farmers who have received tokens.

The minister said that the state government would not purchase paddy from the farmers now as the stipulated time fixed by the Centre has already lapsed June 30.

The state government has already procured 91 per cent (of the target) paddy from the farmers during this Rabi season. Last year, only 83 per cent of the paddy procurement target could be achieved, Swain said.

'The protests by the BJP are nothing but a political compulsion. They are a frustrated lot. Rabi crops are grown in 17 districts of Odisha. Then why is the BJP taking to the streets in all the 30 districts," Swain asked.

He invited the Opposition leaders to come up with suggestions to further strengthen the paddy procurement system.

Meanwhile, state BJP Krushak Morcha president Pradeep Purohit said, "We are demanding procurement of paddy from the farmers who have already received tokens. Since the government is not procuring paddy any more, their tokens have lapsed."

"Is Swain aware of the duration of the tokens? It is only 12 days. Why has the duration been reduced from 30 days to 12 only?" Purohit asked, adding, "The government has failed to pur-

Flights from Jeypore, Utkela likely by March

Bhubaneswar, July 3: The state government in collaboration with the Ministry of Civil Aviation (MoCA) has planned to start flight operations from Jeypore and Utkela (in Kalahandi) airports by the end of this financial year.

The decks are being cleared to make the two airports in the state operational, revealed a meeting held between the officials of state Transport and Commerce department and MoCA here Saturday, Transport secretary Madhusudan Padhi and MoCA joint secretary Usha Padhee attended the meeting. "Development of airports at

Puri, Rourkela, Utkela and Jeypore was discussed. Air connectivity under UDAN for Jeypore and Utkela will be finalised by @MoCA_GoI and State Govt shortly," Transport

department said in a tweet.

The airports at Jeypore and Utkela are being supported under UDAN (Ude Desh ka Aam Nagrik) scheme. Formal application to get licence to make these two airports functional will be submitted to the Director General of Civil Aviation

(DGCA) this month, said a senior officer, who was present at the meeting Air Odisha was the first to start

NGT seeks probe into Ganjam stone quarry

Bhubaneswar, July 3: The eastern bench of National Green Tribunal (NGT) has issued notice to the state government and other stakeholders in connection with alleged illegal stone quarry under Sanakhemundi tehsil of Ganjam district.

Earlier, a petition was filed by one Satrughana Jena before the NGT alleging that the stone quarry operations at Sata Dhangudi Hill were in contravention of the conditions set while granting environmental clearance to the project.

The petitioner had alleged that the quarry was being undertaken beyond the permissible areas without any approval of mining plan and without environmental clearance and consent to operate. The petitioner also alleged threat to local biodiversity due to the quarry activities in the area.

The tribunal has admitted the case for hearing and issued notices to the state government, the miner and other stakeholders concerned. "The matter requires con-



sideration. Issue notice to the state respondents, returnable within four weeks," the order said.

The NGT also directed for formation of a committee to look into the matter and inform the tribunal after conducting an inspection at the site. "We are also of the view that it will be necessary to constitute a committee comprising the Ganjam Collector, senior scientist from Odisha State Pollution Control Board, senior scientist from State Environment Impact Assessment Authority (SEIAA), senior scientist from Integrated Regional Office of Ministry of Environment and Forests, Bhubaneswar," the order said.

The Odisha State Environment Impact Assessment Authority would be the nodal authority for all logistic purposes, the tribunal ordered.

The committee has been entrusted with the task of enquiring into the allegations of excessive mining, mining beyond permissible limits, environmental degradation on account of alleged illegal stone mining and also estimation of environmental compensation

27 python hatchlings released into Chandaka

Khurda, July 3: The Forest department officials recently released 27 baby pythons into Chandaka sanctuary after ensuring safe hatching of eggs collected from Gadaniala village of Mallipur panchavat under Khurda block.

The snakes were released near two ponds located in two separate places under Haladia range of Chandaka sanctuary, Forest department sources said

Chandaka Divisional Forest Officer (DFO) Ramakanta Nayak, Assistant Conservator of Forest (ACF) Girish Satpathy, Haladia Range officer Jaykrushna Panda and Forester Soumya Ranjan Behera among others were present during the release of baby pythons into the sanctuary.

'The baby pythons were released at two separate places in Chandaka. We hope that the snakes would soon get accustomed with their new habitats. We used a drone to monitor their movements after releasing them into the forests," said an official of the Forest department.

It is worth mentioning here that a mother python had laid eggs in a pit inside the forests near Gadaniala village in the first half



of May this year. The Forest department officials along with the villagers had erected barricades around the pit and covered the place with nets to ensure safety for the python and its eggs. The villagers and Forest department officials were guarding the place round-the-clock for safe hatching of the eggs.

As many as 30 eggs were relocated to the Forest department range office May 22 to save them from heavy rains triggered by the cyclonic storm Yaas. Altogether 27 baby pythons hatched out from the eggs June 30, sources said.

"The villagers of Gadaniala did a commendable job by protecting the mother python and its eggs. This episode has set an example for conservation of wildlife," said Mallipur Sarpanch Bijay Das.

Ajit Singh April 12, 2021 had ordered a Vigilance investigation of the loot of black stones and minor minerals from the Bicchakhandi hills and its adjoining forest land. The vigilance began its inquiry May 13, 2021 and sought details of the minerals loot including excavation of black stones at the

portation of the minor minerals That apart, it was ordered that all illegal crushers operating in the area will be immediately shut. The ones that have licenses will compulsorily install CCTV cameras and maintain a register. There will be entries in the register on the inward and outward movement of the minerals in premises of the crusher.

The concerned tehsildar was directed to verify the entries in the register and the CCTV footage and based on them will submit a report every 15 days. In case there is mismatch of data in the register and the camera footage, strict actions will be taken against the concerned crusher owners.

To ensure foolproof monitoring of the work, sub-collector, tehsildar, Dharmasala and Darpana, SPCB regional officer of Kalinganagar, DDAM Jajpur Road, forest ranger of Dalijoda were directed to assist the armed security guards. IICs of Dharmasala, Jenapur and Badchana were included in the team.

One month has since passed but no remarkable results or actions have been heard from the works of the armed security guards. On the contrary, mindless loot of minerals from the Bichhakhandi hills is continuing.

In-charge tehsildar, Dharmasala, Debi Prasanna Mohanty said there have been raids by the armed security guards on the stone mafia. Raids were also conducted on Barada hill in the night of June 30. He said nobody will dare to enter the Bichhakhandi hills and the illegal mining activities have completely stopped now.

Berhampur, July 3: Residents of Patrapeta area under ward no-16 of Berhampur Municipality Corporation (BeMC) have been beset with several problems, including drainage.

A visitor to Patrapeta Sahi is welcomed by standing drainage water at the very entrance of the village. In rainy season, the drainage water submerges the village road, making it difficult for the villagers to go out of the village.

The residents alleged that the sanitation workers of BeMC engaged in cleaning drains were only going through the motions. As a result, knee-deep drainage water stands on the road for days together. Wallow In Pettiness

olumn writing is referred to as 'punditry' in America. Their definition of a pundit is "an expert in a particular subject or field who is / frequently called upon to give their opinions to the public." However this is not how punditry usually expresses itself. Newspaper column writers are not experts in any particular subject or field. Almost all of them are drawn from the pool of journalists and used to be reporters or editors earlier. If they are experts at anything (and this is highly disputable) it would be in the narrow reporting space that they worked in. But how much expertise in medicine and surgery does a reporter on the healthcare beat have? None. Editors, and I have been one of four newspapers, are not experts at anything. Column writers are post facto commentators. They write about what has already happened. We have no idea what is to happen. How many Indian columnists predicted the recession, the second wave, the Chinese intrusion into Ladakh, the farm laws, the highest unemployment in history, the public's response to CAA, demonetisation and three years of declining GDP growth, the failure of GST or the dismembering of Kashmir? None.

Forget that, how many even predicted the landslide election result in West Bengal? We are not even experts in the political field and shouldn't be taken seriously. To be fair to us it is not our fault. The near future is hard to predict because it involves human agency. The

government chooses to do something or not do something and this produces effects. None of us can tell how it will end, including often even the government.

But the longer term is easier to predict because it is not based on human agency but on technology and science. Some things are bound to happen because technology and its rate of improvement are predictable. Computers will get faster, petroleum will finish, manufacturing will require fewer people, robots will get better. All of these things are already happening and will continue to happen. To foresee the future is only to be able to examine the rate of progress

The climate will change because science tells us that it is changing. Inequality will increase because companies are getting larger. Foreign influence will increase in the politics and economies of countries like India because they are technologically dependent. Warfare will become less violent but more decisive because military power is linked to technological power. The question is what all of this will ultimately mean for us. For cen-

turies, this sort of thing did not matter because progress was slow compared to today. For a period in the 19th century, when electricity and mechanised locomotion were discovered and invented, the change was dramatic. The first man flew in December 1903 on a plane that could go a few metres. Within 66 years, one lifetime, Americans put men on the moon. That is change of a pace not seen before, but change has accelerated since then because of increasing power in computing.

Today's supercomputers have far more capacity at computation than the human brain. It is only a particular software or algorithm that requires to be developed to make them like us, which means for a computer to have general intelligence. Already at narrow intelligence a computer is much better than us, from flying airplanes to playing chess to scanning Xrays. But a computer cannot read a book like we can and does not know the difference between a dog and a sitar. It has no ability to think and people are currently working (most notable at companies owned by Google) on training computers to be like us.

What happens when such general intelligence is developed, as is being predicted will happen in the next few years? That machine will be able to improve itself rapidly through instant evolution. A being smarter than us will be able to make itself better and more intelligent to the point that we would think of it as a god. Again, many books have been written on this and in some of the most intelligent circles in America, including people like Bill Gates and Elon Musk, these things are being discussed seriously. They are doing so because artificial intelligence of that sort is perhaps only 20 years away and may prove to be a threat to mankind.

What is the future of nations which, like India, are still poor and have not transitioned to becoming developed?

ON LIBERTY & CONSPIRACY lthough countries like Israel, the United (Wash Hands 🗸 Kingdom, and the United 5G States have done par-

ticularly well getting Covid-19 vaccines into arms as fast as possible, vaccine hesitancy remains a serious hurdle. In the US, it has already derailed President Joe Biden's goal of administering at least one vaccine dose to 70 per cent of the US population by July 4.

In a CNN poll in April, about 26 per cent of US respondents said they do not intend to get vaccinated at all. That is a big problem, given that near-universal vaccination is the only reliable way to end the pandemic. Assuming, for example, that Covid-19 variants as contagious as measles become dominant, achieving herd immunity could require that 94 per cent of

the population is immune. In these circumstances, policymakers might be tempted to try to suppress vaccine hesitancy - much of it fuelled by conspiracy theories. To believers, the real danger is not Covid-19, but that Bill Gates is using vaccines to implant microchips in our brains. But aren't conspiracy theories just another form of free speech? In his classic defense of that principle. On Liberty. John Stuart Mill offers two arguments: those who hold erroneous beliefs are more likely to abandon them in a free exchange of ideas, while vig-

orously contesting a true belief

prevents it from becoming an unexamined prejudice or dogma. In fact, conspiracy theorists rarely abandon their beliefs through a free exchange of ideas. Conspiracy theories have a "selfsealing" property, whereby new information that challenges the belief comes to be seen as further proof of it. If you try to convince a "9/11 truther" that the September 11, 2001, terrorist attacks were not, in fact, an inside job, they will probably lament that you have been brainwashed, too, and urge you to read a report or watch a documentary showing that the official version of history is a lie.

The point to remember is that conspiracy theorists genuinely believe that a small secret group of people – a cabal – controls the world. With this as one's premise,



Now that vaccine hesitancy has emerged as a major threat to achieving herd immunity. public authorities might be tempted to crack down on conspiracy theories that are fuelling it. But before they do, they should revisit John Stuart Mill's famous defense of free speech

it makes sense to interpret all new information as validation of it.

Should we therefore stifle conspiracy theorists in the interest of facilitating a rational exchange of ideas? Mill, who opposed all forms of censorship, argued that such a public intervention is justified only on the basis of the "harm principle." As he famously put it in On Liberty: "The only purpose for which power can be rightfully exercised over any member of a civilized community, against his will, is to prevent harm to others."

Considered in isolation, many conspiracy theories do not fall afoul of Mill's principle. Simply believing that aliens have landed at Roswell, New Mexico, or that no one landed on the moon doesn't hurt anyone, though otherwise harmless conspiracy theories can of course encourage harmful acts. For example, the belief that 5G technologies help to propagate Covid-19 has led people in the UK to burn down cell towers.

Moreover, conspiracy theories sometimes do inflict direct harm, as is often the case when they are linked to anti-Semitism. It might

not matter that the British conspiracy theorist David Icke believes lizards are ruling the world: but it does when he lashes out against "Rothschild Zionists." Going back at least as far as the notorious Czarist secret police fabrication, The Protocols of the Elders of Zion, Jews have been the conspiracy theorist's cabal par excellence, which helps to explain why figures such as George Soros remain the subject of conspiracy theories-and the target of threats and defamation – to this day.

Similarly, many of those who violently attacked the US Capitol January 6, 2021, subscribe to the QAnon conspiracy theory, which holds that Barack Obama, Hillary Clinton, and Soros are part of a Satanist, pedophilic child sextrafficking ring. In this case, the US has a number of legal measures designed to encompass the negative effects of conspiracy theories, such as "breach of peace" ordinances and laws against dis-

orderly conduct or "hate speech." But, again, these statutes address individual actions, not the beliefs themselves. The problem

with vaccine hesitancy is not the belief that Gates is trying to implant a microchip into your brain; it is the act of not getting vaccinated. What, if anything, can the state do about that?

Evidence from the UK suggests that as more people get vaccinated, vaccine hesitancy declines. The UK and the US both started with similar levels of "anti-vax" sentiment last summer, but such views have plummeted in the UK, and the country is now outpacing the US in vaccinations. This suggests that as more people get vaccinated and see that everything is okay, others may be more likely to follow suit. The best way to create this virtuous cycle is not to censor conspiracy theories but rather to vaccinate more people and spread the message that vaccines are indeed safe and effective Seeking to prevent false beliefs from being aired simply gives ammunition to those claiming that the state is out to get them.

For the final holdouts, vaccine mandates might be the only solution, particularly if countries remain far short of herd immunity. With the highly contagious Delta variant ravaging communities with lower rates of vaccination. this would be a true application of Mill's "harm principle": to prevent harm to others

As Mill observed, all beliefs are either wholly false, partly true, or wholly true. In the case of conspiracy theories, we should remember that many are often based on some grain of truth, or at least on a legitimate impulse to challenge the elite consensus. No, Gates doesn't want to control our minds with microchips; but it is perfectly reasonable to worry that today's tech giants have too much influence over the

way we think. Exploring these nuances is what Mill meant when he advocated for the vigorous public contestation of true beliefs. Though we might beat the pandemic eventually, the battle for critical thinking will go on.

Nutrigenomics

Vet another term in -genomics for us to add to pharmacogenomics. toxicogenomics, chemogenomics and even aromagenomics. Our current obsession with genes is reflected in this growing list of words that borrow the word genomics, the study of the human genome, to create fashionable but often unlovely neologisms. This term refers to the study of our food and how it influences our health through interactions with our personal genetic make-up. It is suggested, in the hand-waving wav of futurist commentators in this field, that one day many of our ailments might be treated not with drugs but with special diets. However, the complexity of the factors influencing health - not merely diet and heredity, but also economic and social conditions, culture and behaviour - are likely to make it difficult to isolate the influences of food from all the others. Though it is often confused with nutritional genomics, from which the name seems to be derived. the latter speciality usually refers instead to the genetic manipulation of plants so that they generate valuable vitamins and minerals to improve diet. "Nutrigenomics" researchers hope to do away with such blanket generalizations and instead target diets to specific people (Newsweek, September 2002). Nutrigenomics is the study of how different foods can interact with particular genes to increase the risk of diseases such as type 2 diabetes, obesity, heart disease and some cancers (United Press International, January 2003).

t a time when the Congress along with the entire Opposition should have been active in the field, exposing the massive failure of the Modi government in handling the Covid crisis, the party itself is facing an unprecedented crisis. Rahul Gandhi, who is the de facto Congress president, is still indecisive on taking up the reins of the party, even as top leaders are perplexed about their next course of action, while party workers are sitting idle, not knowing which way to tread.

The foundations of the 135-year 'Grand Old Party' are shaking as never before and unless the Nehru-Gandhi family comes forward to save the Congress nothing can be achieved. The realisation of 'better late than never' had forced the G-23 leaders, led by Ghulam Nabi Azad, to raise the issue of party leadership in the open. However, except for them, no one in the party came forward to join the group.

It took seven years for the party to persuade Sonia Gandhi to take up the Congress president's post in 1998 ever since the assassination of Rajiv Gandhi in 1991. The party is again willing to wait for Rahul to make up his mind. Even in the past, it has waited for Rahul who agreed to become Congress vicepresident in 2013 and finally consented to become Congress president only in 2017. He resigned in 2019, taking up the responsibility for the party's debacle in the Lok Sabha elections, and is now again being persuaded to energise the Congress.

The Congress, therefore, is totally dependent on Rahul, who the BJP tags as 'Pappu.' In retrospect, one wonders, whether he could have handled the Covid situation better than those who are running the country. People would rather have 'Pappus' at the helm than those strategists who vanish when in need and come to the forefront only when the crisis blows over.

Having come to terms that the Congress cannot survive without the Nehru-Gandhi family, it would be better for the party leaders to come together. First and foremost, Rahul should be convinced to take up the reins of the party by getting himself elected as the Congress president. The dilly-dallying attitude of Rahul will

sharpens the anxiety of the people, who are hopeful of seeing the downfall of the Modi government. The Congress needs to firm up its act together, particularly when Assembly elections in Punjab, Uttar Pradesh, Uttarakhand, Manipur, Goa, Gujarat and Himachal Pradesh are approaching.

The BJP's sole agenda has been to downgrade Rahul to a level where no one dares to side with him By incessantly running the 'Pappu' campaign against him, they have succeeded in lowering the credibility of the Gandhi scion. Leave aside his own partymen, who are desperate to jump out of the sinking ship, even his own allies are in double-mind whether or not to join hands with him for alliance in the upcoming Assembly polls.

Here again, the urgency to revive the Congress becomes imminent for which Rahul alone can inject the required adrenaline to the party cadres. Unless the Congress is rejuvenated and is successful in dethroning the BJP in some of the states, the goal of defeating the saffron party at the national level would never be

achieved. Take the example of Punjab, Himachal Pradesh, Gujarat and Uttarakhand where elections are due next year. In all these states it is a straight fight between the Congress and the BJP. It's only in Uttar Pradesh that there are other players like the Samajwadi Party and the Bahujan Samaj Party, which too have set their sights on forming the government in the state.

It is Rahul Gandhi on whose shoulders the future of the Congress, the prospects of the UPA and the hopes of millions of Indians are pinned upon. India being a democratic country, people would like to vote according to their wishes. But if there is no alternative to the BJP, they will be forced to vote for the same party. For that matter, even the BJP vouches for a good Opposition. though it is a different thing altogether that whenever Rahul Gandhi opens his mouth, the entire Modi Cabinet comes forward to attack him. Is he really a 'Pappu,' then?

Gunupur/Kashinagar, July 3: Days after the Vamshadhara Water Disputes Tribunal passed an order in favour of Andhra Pradesh for construction of a barrage on the river at Neredi, the Deputy Chief Minister of the neighbouring state visited the work site Friday and reviewed the project work, a report said.

The tribunal passed its order June 21, sparking sharp resentment among the residents of Gunupur in Rayagada district as well in Kashinagar of Gajapati district. This is because the construction of the barrage at Neredi will lead to severe water scarcity in the affected areas of Rayagada and Gajapati districts during summer. The barrage will also damage large tracts of farmlands in these areas of both the districts in the river basins.

The residents are up in arms over the inability of the state government in protecting the interest of the residents of its own state. As if this was not enough, the visit of the Deputy Chief Minister Dharmana Krishna Das has only added salt to the injuries of the residents.

Berhampur, July 3: Police have seized over 10.97 quintals of cannabis from three different places in Ganjam district in the last two days and arrested four persons, an officer said Saturday.

New Delhi, July 3: Planners in Delhi have set out a vision for a "sustainable, liveable and vibrant" future city in a master plan that experts say ignores its informal workers and bypasses its many poor.

The draft Delhi Master Plan 2041, open for public feedback until July 24, aims to cater to a population of about 29mn - up from 19mn now - with better public transport and mobility, wider housing options and more green space.

But the draft ignores deeplyheld concerns over fair land use, lacks affordable housing and shortchanges marginalised groups to benefit business, said Manju Menon, an urban expert.

New Delhi, July 3: Tens of millions of people in India were suffering Friday under a severe heatwave that has pushed the temperature to a nine-year high in Delhi as monsoon rains run behind schedule.

Heatwaves have killed over 6,500 people in the world's second-most populous nation since 2010, and

scientists say climate change is making them harsher and more frequent.

Delhi saw 43.1 degrees Celsius Thursday, the hottest July day in the city since 2012 when the capital sweltered under 43.5 degrees Celsius. Friday, the temperature again shot up to 41 degree Celsius in the city of 20 million. Temperatures have remained more than seven degrees Celsius above normal for this time of the year, prompting India's weather office to classify it as "severe extreme heat"

India Meteorological Department said the mercury will stay above 40 degrees for the coming week because of the late arrival of the southwest monsoon and a hot wind known as the Loo blowing in from the desert state of Rajasthan. The weather department has is-

sued a heatwave alert for the region, with forecasters also saving some isolated places will witness thunderstorms. The intense heat has

driven up power consumption as more and more people turned to airconditioners and air coolers.

Delhi's power consumption peaked to nearly 7,000 megawatts (MW) this week, 10 to 15 per cent higher than the average demand at this time of the year. Forecasters predict that the an-

nual rains will not hit Delhi before July 7, making it the most delayed monsoon in the national capital since 2006. The deadliest vear for India was 2015 when over 2.000 were killed by intense heat.

Currently just five per cent of Indian households have air conditioning compared to 90 per cent in the United States and 60 per cent in China. But the market is forecast to boom in the coming years driving up energy consumption in what is already the world's thirdlargest emitter of carbon dioxide. Parts of Delhi and elsewhere

New Delhi, July 3: Cases of COVID-19 might be declining steadily but as the virus is mutating, attaining that magical zero figure in Delhi is unlikely, experts have said, and predicted that coronavirus will be reduced to an endemic in the future

The Centre, Delhi Chief Minister Arvind Kejriwal and his cabinet colleague Satyendar Jain had said last year that one will have to learn with coronavirus and make its prevention norms a part of our lives.

Dr Suresh Kumar, medical director of Delhi government-run LNJP Hospital said there will always be a few cases of the virus.

"Zero is an unlikely figure. The virus is mutating and it is difficult to predict it's future behav iour," he said

Explaining why the virus has posed such a challenge, Dr Sanjeev K. Singh. Resident Medical Director. Amrita Hospitals in Faridabad said it is an mRNA virus which keeps changing its structure.

"These virus is smart and just for the sake of living, it will keep mutating. Covid will be there and may not be affecting all 193 countries but it will be there. Coming down to zero won't be achievable. In hospitals for getting surgeries, one has to get tested for Hepatitis and HIV. Eventually, you will be tested for Covid too," he said.

Dr Gauri Agarwal, IVF expert and founder of Seeds of Innocence said keeping the 1918 pandemic as

Agreeing with Chawla, Dr. Rommel Tickoo, Director, Internal Medicine, Max Healthcare, said we are still in the second Covid wave. "Seventy per cent of the cases are limited to Maharashtra. and southern states. In north Indian states, there was a sudden exponential increase and the virus infected a large number of people together which is why the steady decline. The effect of the virus will be blunted because of the majority of people being exposed to the

Radio station helps educate kids sans smartphones

Nashik, July 3: A community radio station that is helping educate poor students - who can ill-afford expensive smartphones - is earning laurels for helping bridge the digital divide during the Covid-19 pandemic lockdown.

"Radio Vishwas 90.8," run by the Vishwas Dhyan Prabodhini & Research Institute (VDPRI), also bagged two awards at the recent 8th National Community Radio Awards, instituted by the Information & Broadcasting Ministry.

It won the first prize in the 'Sustainability Model Awards' and the second prize in the 'Thematic Awards' category for its radio programme, "Education For All" during the pandemic.

Launched in June 2020, the programme aimed at providing free education, especially for the poor students from Class 3 to Class 10, studying in Zilla Parishad and Nashik Municipal Schools, benefitting around 60,000.



Daily for 14 hours, it broadcast lectures in Hindi, Marathi, English and Sanskrit - recorded by 150 teachers in a studio - which all could access and gain education, said Radio Vishwas 90.8 Station Director Dr. H.V. Kulkarni.

According to Kulkarni, a group of teachers from Igatpuri taluka in Nashik distributed 451 FM devices comprising an USB, Bluetooth and high-end speakers to students to ensure they didn't miss out any lectures on the current syllabus.

Now, the plan is to upload these lectures on YouTube which can be used to teach the students when normal schooling resumes post-lockdown. "The programme received a very positive response... There are students trapped in poverty and cannot afford smartphones for digital education," Kulkarni said.

The lectures were aired according to slots allocated for each subject, akin to school periods for the benefit of the students.

Buoyed with the success, the lectures were shared with 6 other CRSs in Maharashtra and the content was broadcast through their radio channels to benefit their student-listeners

The CRS' innovative sustainability model enabled the radio station to sustain itself in four key areas - financial, human, technical and content.

Over the past 10 years, the radio station has developed a listener base of around 300,000, spread across a radius of 10-15 km, said Kulkarni.

The CRS focusses on topics of local and community interests ranging from kitchen gardens to favourite reading to issues that confront senior citizens, and is run by the locals who host talkshows, sing or play local songs and music for the keen audiences.

Customs deport spiders sent by post from Poland

Chennai, July 3: Seizing a parcel containing 107 plastic vials containing foreign spiders, Chennai Air Customs have asked the postal authorities to deport them back to Poland.

According to the Commissioner of Customs, Chennai International Airport, officials intercepted a postal parcel that arrived from Poland at the Foreign Post Office here. The parcel was addressed to an Arupukotai (Tamil Nadu) based person.

On opening the parcel, a thermocol box was found in which 107 small plastic vials wrapped in silver foil and cotton were found. On examination live spiders

were found inside each vial.

WildLife Crime Control Bureau (WCCB) officials and scientists of the Zoological Survey of India were called to identify the species.

Based on morphological examination they suspected the spiders to be of a genus Phonopelma and Brachypelma which are CITES (Convention on International Trade in Endangered Species of Wild Fauna and Flora) listed Tarantulas. native of South, Central America and Mexico.

The Animal Quarantine Officials recommended deporting the spiders in the parcel to the country of origin as the said import is illegal as there were no proper documents.

Kabul, July 3: Hundreds of Taliban fighters were killed in fierce battles with government forces across several provinces of Afghanistan, officials said Saturday, as Washington announced it would finish withdrawing its troops from the country by the end of August.

Washington's announcement came after all US and NATO troops vacated their main Bagram Air Base, from where the coalition forces led operations for two decades against the Taliban and their Al-Qaeda allies.

Scores were killed in air strikes, including a pre-dawn assault Saturday, in the southern province of Helmand, where the insurgents and government troops have regularly clashed. There have been fears that Afghan forces would



struggle without the air support that the United States has provided. 'In recent days, the Afghan air

force has intensified its air strikes against the Taliban hideouts and the insurgents have suffered casualties," Attaullah Afghan, a member of Helmand provincial council, told AFP. Both sides often exaggerate each other's casualties and their claims are difficult to in-

Studies show that the immune response is "clearly superior" when an AstraZeneca shot is combined with a second mRNA vaccine, compared with double AstraZeneca jabs, said STIKO. Chancellor Angela Merkel had received a Moderna second jab after getting an AstraZeneca injection for her first.

Washington, July 3: A ransomware attack paralyzed the networks of at least 200 US companies Friday, according to a cybersecurity researcher whose company was responding to the incident.

The REvil gang, a major Russianspeaking ransomware syndicate, appears to be behind the attack, said John Hammond of the security firm Huntress Labs. He said the criminals targeted a software supplier called Kaseya, using its network-management package as a conduit to spread the ransomware through cloud-service providers. Other researchers agreed with Hammond's assessment.

"Kaseya handles large enterprise all the way to small businesses globally, so ultimately, (this) has the potential to spread to any size or scale business," Hammond said in a direct message on Twitter. "This is a colossal and devastating supply chain attack."



Such cyberattacks typically infiltrate widely used software and spread malware as it updates automatically

Brett Callow, a ransomware expert at the cybersecurity firm Emsisoft, said he was unaware of any previous ransomware supplychain attack on this scale. There have been others, but they were fairly minor, he said.

"This is SolarWinds with ransomware," he said. He was referring to a Russian cyberespionage hacking campaign discovered in December that spread by infecting network management software to infiltrate US federal agencies and scores of corporations.

New Delhi, July 3: Turning adversity into opportunity, India has recorded highest-ever merchandise exports of \$95 billion in the April-June quarter of current fiscal year (FY22).

This is 85 per cent higher than exports of Q1 of 2020-21 and 18 per cent higher than the exports of Q1 of 2019-20. It is also 16 per cent more than the previous highest Q1 exports of 2018-19 (\$82 billion) and is higher than the earlier peak of exports in Q4 of 2020-21 (\$90 billion).

Commerce and Industry Ministry Pivush Goval said that sector specific interventions, involvement of all the stakeholders and functioning of the government as a whole helped in achieving the growth Simplification of procedures, and extension of timelines and licences has also resulted in the record performance of exports, he added.

The minister also said that going by the performance in first quarter of the fiscal, an ambitious target of \$400 billion ex-

ports has been set for 2021-22. In the first quarter period, several labour intensive sectors have seen a rapid export growth. The exports in the engineering goods sector has increased by \$5.2 billion over Q1 of 2019-20. Likewise, rice exports growth has remained positive since May 2020 and rose by 37 per cent in Q1 of 2021-22 compared to Q1 of 2019-20.

Inclusion of retailers and wholesalers will only increase the volume of MSME and enable the government to showcase the increase in the number of MSMEs.

This move of the government will make it difficult for them to carry out a realistic census of different sectors under MSME and identify



the issues of different sectors and frame a common policy for the sector.

The association claimed that the decision was an unwarranted move by the central government. "The government has clarified

that registration under Udyam and

coming under the banner of MSME, retailers and wholesalers will be entitled and restricted to priority lending by financial institutions only, which will enable their revival

But from our past experience what we have observed is that when manufacturing and service sector were clubbed together under the banner of MSME, banks preferred to finance service providers (specially vehicle financing) than financing manufacturing sector as the felt it to be more secure lending and by financing the service sector," Mohanty said.

"We cannot rule out the possibility of manufacturing sector being neglected in matter of extending institutional financing; as in banking sector it is safer to finance retailers, wholesalers than financing a manufacturing unit. This will result in the manufacturing sector losing its sheen and importance," he added. The association also appealed Chief Minister Naveen Patnaik to understand this sinister design behind this move by the central government and use his good office to get this decision reversed.



Creators smile as Indians warm up to new crypto form

New Delhi, July 3: As high-networth individuals (HNWIs) continue to invest in cryptocurrencies and seek to diversify their portfolio, non-fungible tokens (NFTs) are slowly gaining asset-

class credibility. Indians are also warming up to this new digital asset that has given creators and collaborators a fresh platform to earn better moolah while generating more value for their work. NFTs allow people to buy and sell

ownership of unique digital items in cryptocurrencies, and keep track of who owns them using the Blockchain. NFTs can technically contain anything digital, including drawings, artworks, tweets, animated GIFs, songs or even video games

TV host and actor Vishal Malhotra collaborated with artist Ishita Banerjee to release an NFT which was sold last week for 2.5 Ethereum (\$5,500) -- five times the listed price.

On the NFT marketplace by WazirX, India's biggest cryptocurrency exchange in terms of trading volume, a unique NFT, which was a collaborative artwork between pop icon Ritviz and visual artist Santanu Hazarika, was sold for \$391.8 within 10 seconds of going live. WazirX has sold more than 160 pieces of digital art on

its platform for NFTs within month of its launch. The crypto company June 1 rolled out South Asia's first NFT

Marketplace with 15 creators hailing from diverse categories such as space 3D artists, digital artists, muralist photographers, canvas

artists, street artists and visual artists. The platform came without any listing price and extended 50.000 WRX (WazirX tokens) as bonuses for the community.

"More artists and collectors across the globe are today tapping the power of NFTs. NFTs ensure the exclusivity of ownership and can be seen as a way to digitise artwork and other collectible items." said Sandesh B Suvarna, VP, WazirX



NFT Marketplace. According to Hazarika, the global NFT market is slowly becoming a crucial promotional tool for all artists to monetise their work and uniquely engage with their community of collectors and fans who value art. "With NFTs, artists are now open

to working with anyone," he said. The WazirX NFT Marketplace is powered by the Binance Smart Chain, which brings the gas fee -a sum required to mint the NFT via a blockchain -- down from \$60-\$100 to about \$1. Since the NFTs are in-

teroperable, anyone can later trans-

fer the NFT to a different cryptocurrency such as Ethereum.

An exhibition featuring the artworks of Bengal-born artist, Lalu Prasad Shaw, certified using NFTs is on view at Terrain.art till July

"Terrain.art is delighted to be one of the first blockchain powered platforms in India to register artworks using NFTs, presenting new works and those with prior histories through curated exhibitions," said its founder Aparajita Jain.

On the global stage, digital artist Michael Winkelmann or Beeple sold one of his NFT arts for nearly \$70 million earlier this year.

An NFT artwork by NSA whistleblower Edward Snowden was sold for more than \$5.4 million in April. Twitter CEO Jack Dorsey evensold his first tweet as an NFT for over \$2.9 million.

For a team that had squandered chance after chance in extra time as Switzerland's energy-sapped players hung on for a 1-1 draw through extra time. For a team that had come into the match as the favorite and had taken an eighthminute lead, only to see that wiped out by a defensive mistake.

So imagine the relief when Mikel Oyarzabal stepped up to convert the decisive spot kick past goalkeeper Yann Sommer, whose save on Kylian Mbappe's shot in a 🍧 shootout win over France

got Switzerland to the tournament's quarterfinals for the first time. After seeing the ball hit the back of the net, Oyarzabal headed

straight to Spain goalkeeper Unai Simon, who had made two saves in the shootout. They were soon consumed by their teammates as "Y Viva Espana" blasted out from the stadium's loudspeakers

Of course, the Swiss know that feeling. But unlike against France, when they scored all five of their penalties in the shootout, they failed with three of their four attempts this time. Fabian Schar and Manuel Akanji had shots saved by Simon, while Ruben Vargas fired the ball over the crossbar.

Last season, the BCCI couldn't conduct any age-group tournament and was forced to cancel the Ranji Trophy due to COVID-19 pandemic.

However, a full-fledged domestic season will take place this year with Syed Mushtaq Ali T20 being held from October 20 and the National One-Day Championship for Vijay Hazare Trophy being scheduled from February 23, 2022.

"The season will commence on September 21, 2021, with the Senior Women's One Day League and will be followed by the Senior Women's One Day Challenger Trophy, which will take place from October 27, 2021," BCCI secretary Jay Shah said in a media release. The final of the Syed Mushtaq Ali Trophy will be played November 12, 2021.

The coveted Ranji Trophy will be played in a three-month window from November 16, 2021 to February 19, 2022. The Vijay Hazare Trophy final will take place March 26, 2022.

"The BCCI is confident of hosting the domestic season with health and safety of players and all people involved being paramount,' the statement further read.
