PETROL PRICE **SOARS AGAIN**

New Delhi, July 5: The price of petrol continued its upward march Monday, the second day running, taking its price closer to century mark in Delhi and Kolkata, the only two metro cities where the fuel is still below ₹100 a litre.

In Delhi, price of the fuel increased by 35 paise from ₹99.51 Sunday to ₹99.86 a litre Monday. In Kolkata, Petrol prices moved up from ₹99.45 a litre to ₹99.84 a litre

CITY FUEL PRICES PETROL ₹100.72 (+0.36) ₹97.45 (+0.00) DIESEL

With the increase, petrol prices are expected to cross the century mark in these two cities at next revision. With this the fuel will be over ₹100 a litre in all four metros and other major cities across the country.

In the financial capital Mumbai, petrol price now stands at ₹105.92 while diesel costs ₹96.91, data available on Indian Oil Corporation's website showed. In Chennai too, petrol has hit century with pump prices being ₹100.75 a litre. Like last week, OMCs kept diesel prices unchanged on Monday to provide relief to the transport sector that runs

largely on this fuel. The price of diesel in Delhi remains booked under Section 66A of the t ₹89.36 per litre, while in Mumbai.

The NGO said, "That in spite of the order passed by this court February 15, 2019, directing that copies of the judgment of this court in Shreya Singhal should remain available with every High Court as well as all the district courts and that the police departments in the entire country i.E. All states and UTs be sensitized about the said judgment, the facts mentioned above show that not only the investigations under Section 66A by the police are continuing but even in the trial courts" It sought direction to the Centre to collect all data/ information regarding FIRs/ investigations where Section 66A has been invoked as well as pendency of cases in the courts throughout the country where proceedings under the provision are continuing in violation of the 2015 judgment. The PUCL also sought direction to top court registry to communicate to all the District Courts throughout the country (through respective High Courts) to take cognizance of the 2015 judgment, so that no person should suffer or face any adverse consequences which violate his fundamental rights under Article 21 of the Constitution. The NGO said the Centre be directed to issue an advisory to all police stations not to register cases under the repealed Section 66A. On February 15, 2019, the SC had directed all state governments to sensitise their police personnel about its March 24, 2015 verdict.

Woman brutally murdered in City

Bhubaneswar, July 5: The capital city Monday woke up to the brutal murder of a 26-year-old married woman at Bhimtangi area under Airfield police limits here. The three-year-old son of the deceased escaped the killer's knife.

The deceased, Priyanka Priyadarshini Sahu, along with her husband, Rakesh and son, had been staying on rent in the house of a banker; Sudhakar Maharana, at plot no A/L-1 of Housing Board Colony in Bhimtangi. Rakesh works as the area manager in Eureka Forbes.

Sources claimed Rakesh was in his office when he received a Whatsapp video call from an unknown caller which he didn't receive. However, after a few minutes, he received the photo of his wife with blood stains on her head. A perturbed

Rakesh immediately called up his landlord to inquire about the incident. Subsequently, the landowner came downstairs and found the room locked from inside.

Under the scrapped section, a person posting offensive messages could be imprisoned for up to three years as also fined. A bench of Justices RF Nariman, KM Joseph and BR Gavai issued notice to the Centre on an application filed by an NGO, 'People's Union for Civil Liberties' (PUCL).

"Don't you think this is amazing and shocking? Shreya Singhal judgement is of 2015. It's really shocking. What is going on is terrible," the bench told senior advocate Sanjay Parikh, appearing for PUCL.

Parikh said that despite express directions of the court in 2019 that all state governments should sensitise police personnel about the March 24, 2015 judgement, thousands of cases have been registered under the section. The bench said, "Yes, we have seen those figures. Don't worry we will do something". Parikh said there has to be some kind of method to handle the matter as people are suffering. Attorney General KK Venugopal, appearing for the Centre, said that on perusal of the IT Act it can be seen that section 66A features in it, but in the footnote it is written that the pro-

In crosshairs of malware crooks, cyber insurers fret

Boston, July 5: In the past few weeks, ransomware criminals claimed as trophies at least three North American insurance brokerages that offer policies to help others survive the very network-paralyzing, data-pilfering extortion attacks they themselves apparently suffered.

Cybercriminals who hack into corporate and government networks to steal sensitive data for extortion routinely try to learn how much cyber insurance coverage the victims have. Knowing what victims can afford to pay can give them an edge in ransom negotiations. The cyber insurance industry, too, is a prime target for crooks seeking its customers' identities



and scope of coverage. Before ransomware evolved into a full-scale global epidemic plaguing businesses, hospitals, schools and local governments, cyber insurance was a profitable niche industry. It

was accused of fueling the criminal feeding frenzy by routinely recommending that victims pay up, but kept many from going bankrupt.

Now, the sector isn't just in the criminals' crosshairs. It's teetering

on the edge of profitability, upended by a more than 400% rise last year in ransomware cases and skyrocketing extortion demands. As a percentage of premiums collected, cyber insurance payouts now top 70%, the break-even point. Fabian Wosar, chief technical officer of Emsisoft, a cybersecurity firm specializing in ransomware, said the prevailing attitude among insurers is no longer: Pay the criminals. It's likely to be cheaper for all involved.

"The ransomware groups got way too greedy too quickly. So the costbenefit equation the insurers initially used to figure out whether or not they should pay a ransom — it's just not there anymore," he said. It's not clear how the single biggest ransomware attack on record, which began Friday, will impact insurers. But it can't be good. Pressure is building on the industry to stop reimbursing for ransoms. In May, the major cyber insurer AXA decided to do so with all new policies in France. But it is so far apparently alone in the industry, and governments are not moving to outlaw reimbursement. AXA is among major insurers that have suffered ransomware attacks, with operations in Thailand hard-hit. Chicago-based CNA Financial Corp., the seventh-ranked US. cybersecurity underwriter last year, saw its network crippled in March. Less than a week earlier, the cybersecurity firm Recorded Future published an interview with a member of the Russian-speaking ransomware gang, REvil.





Bhubaneswar, July 5: Even as the gruesome murder of a married woman in broad daylight in Bhimtangi area of Capital city Monday shook the conscience of cit izens, grapevines have it that the ghastly act is fallout of a failed love affair.

If sources are to be believed, a failed love affair between the accused Jagannath Pradhan and the victim Priyanka Priaydarshini alias Rinki resulted in the heartrending incident that shocked the city Monday. Some claimed that both the accused and the deceased were in a relationship since their college days.

However, fate had other plans as Rinki married Rakesh Kumar Sahu in 2015. Pradhan had also tried to meet Privanka after her marriage despite strong objections from the lady, sources claimed.

Recently, Rinki had gone to her paternal village to attend one of her relatives' funeral ceremony. She reportedly had a fight with Pradhan during her stay in the village



5 kg of food grains per person per month will be provided to all eligible beneficiaries over and above regular monthly entitlements under NFSA

Speaking to reporters here Monday, Food Corporation of India (FCI), Odisha region general manager Nishith Kumar Pradhan said food grains at a scale of 5 kg per person per month will be provided to all the eligible beneficiaries over and above the regular monthly entitlements under the National Food Security Act (NFSA). The food grains will be distributed for five months from July to November 2021, he said.

The Centre will spend ₹39 per kg for rice and ₹28 per kg for wheat. In total, food grains to the tune of ₹3,044 crore will be distributed in the state, said the FCI official.

Pradhan further said that lifting of food grains under the scheme has already been started in Odisha. Approximately 1.08 lakh tonne wheat and 7.03 lakh tonne rice have been allotted for the state under the scheme.

The Odisha State Civil Supplies Corporation (OSCSC) Ltd has been asked to lift the food grains from the Central pool and FCI depots by October 31, 2021, he added.

Under PMGKAY-III, which was announced by the Centre for two months during May-June 2021, 43,000 tonne wheat and 2.82 lakh tonne rice was allotted for Odisha. The entire cost of the food grains was about ₹1.220 crore

Bhubaneswar, July 5: Chief Minister Naveen Patnaik Monday requested Prime Minister Narendra Modi to open the window of Aawaas+ mobile app for one month to migrate the data of PMAY-Gramin.

In a letter to the Prime Minister. Patnaik said he, in December last year, had requested to include about 6 lakh identified eligible households of the districts not affected by Cyclone Fani, under the Pradhan Mantri Awas Yojana-Grameen (PMAY-G).

Patnaik said in his letter.

Bhubaneswar, July 5: Upping the ante against BJP-led Central government, the Odisha Pradesh Congress Committee (PCC) has decided to launch a statewide agitation from July 7 to 17 in protest against the hike in prices of petrol, diesel and cooking gas. The party appealed to the people of the state not to buy petrol, diesel and cooking gas for one day - July 15 - as a mark of protest.

Speaking to reporters, OPCC president Niranjan Patnaik said, "The Covid-19 pandemic has broken the backbone of the people. During this pandemic, fuel prices have increased manifold which has hit the common man hard. Oil prices have also crossed ₹100-mark in the state"

Due to fuel price hike, the prices of essential commodities have also



skyrocketed, Patnaik said.

He said in July 2013, during the UPA regime, the price of petrol per litre was ₹74.24 and diesel at ₹67.57 while the price of crude oil per barrel was \$102.92. Although the crude oil price per barrel was now \$75 the prices of oil and cooking gas had gone up due to the anti-people policy of both the state and the Union governments, the Congress leader said.

Therefore, the party activists would launch a protest in front of all block offices July 7 while demonstration will be organised before all

As per the scheme, ₹1.20 lakh has been provided for construction of each house and irregularities in allotment of 1 lakh houses have come to the fore. So, it is a scam of ₹1,000 crore, the BJP president alleged. The saffron party will take this issue to the public and hold statewide protests on this issue, he added.

ODISHA REGISTERS 52 FRESH COVID-19 FATALITIES AND 2,803 CASES IN A DAY State records biggest 1-day nCoV deaths

Bhubaneswar, July 5: Odisha Monday registered 52 Covid-19 fatalities, the highest-ever in a single day, pushing the toll to 4,248, while 2,803 new cases raised the tally to 9.24.699. a Health department official said.

Nine fatalities were reported from Khurda district, of which state capital Bhubaneswar is a part, five each from Ganjam, Kalahandi and Puri, four from Kendrapara and two each from Kandhamal and Mayurbhanj. One person each succumbed to the infection in Bhadrak, Boudh, Dhenkanal, Jharsuguda, Keonjhar, Nayagarh, Nuapada and Sambalpur.

Taking to Twitter, the health department said, "Regret to inform the demise of fifty two Covid positive patients while under treatment in hospitals.'

This apart, 53 other Covid-19 patients in the state have also died due to comorbidities.

As many as 8,90,778 patients have recovered in the coastal state,

OSCPCR demands admission of EWS children in øvt schools

Bhubaneswar, July 5: The Odisha State Commission for Protection of Child Rights (OS-CPCR), in its letter to School and Mass Education Department Principal Secretary Satyabrata Sahu, demanded admission of children from socio economic weaker groups in private educational institution.

In the letter, OSCPCR chairperson Sandhyabati Pradhan said that the commission observed that the admission of children from socio economic weaker section under the 25 per cent reservation in the entry class of private educational institutions has not been taken seriously

Pradhan said that as per report, the government had opened a dedicated portal 'RTE Paradarshi' for the admission of underprivileged students to private schools.

Apparently, this move has only widened the gap with only around 5,000 students registering for admission so far which is a little over 12 per cent of the enrolment achieved in the last academic session.

Bhubaneswar, July 5: Civic and health authorities of the state capital are in a state of bother as about 17 cases of Dengue have been reported from different parts of the city. As per sources, about six new

cases of Dengue were reported from Sailashree Vihar and Kalpana, Monday. With this, the total cases have reached 17 within a span of 10 days with about 12 of these being reported from slums of Chandrase kharpur and Niladri Vihar.

The Bhubaneswar Municipal Corporation (BMC) sent a team of entomology experts and senior officials of the Health and Family Welfare (H&FW) Department, Monday, to visit the affected areas. The team held discussions with community members and found that lack of awareness regarding the disease was prevalent among people.

We observed that mosquito larvae were found in some of the water pots meant for cattle. Dengue mosquitoes, Aedes Aegypti, lay their eggs in unclean water which are found in discarded paper cups, coconut shells, tyres, and other such items. However, unless the

The area where the road has been constructed is within Odisha border, while the forest land of Akarpali village also lies in the same area.

Binavak Madkami, sarpanch of Matapaka panchayat, Akarpali village head Dula Madkami, ward member Aita Padiami and villagers Adma Kartami and Irma Madkami said that the roads in Akarpali village are in bad shape and the villagers there depend on the Sukma market for their daily provisions as well as sale of forest produce since it is closer to their village.

They admitted that the area where Chhattisgarh has constructed the road is in Akarpali village of Odisha. They also claimed that the forest, forest lands and their recorded lands all are located close to the area where Chhattisgarh

has constructed the road. Locals alleged that this has happened as the revenue officials of both the states have failed in their duty to repair the pillars once every two years by clearing the vegeta-

tion overgrowth. Taking advantage of such inactivity of the Malkangiri revenue officials, Chhattisgarh government has constructed a road that leads to Akarpali village. The villagers further alleged that the neighbouring state has constructed the road to loot minerals and forest produce available in the area.

When contacted, Gunanidhi Nayak, Malkangiri tehsildar, said no villager has informed him about the development. He said he would soon visit the spot and take stock of the situation.

Ajay Kumar Pradhan, BDO, Malkangiri, said he had visited the spot last week after being apprised of the development. Pradhan added that he will submit a report to the project director of DRDA for action at his end. Subsequently, the revenue officials will visit the spot and demarcate the border and take necessary steps, he added.

Woe of Rasalpur gram panchayat TULASI RIVER

Balasore, June 5: Flowing through Rasalpur panchayat under Sadar block limits in this district, the Tulasi river, a distributary of the Jalaka river, has bifurcated the Rasalpur panchayat.

While many schools, colleges, hospitals, banks, ration distribution centres and the panchayat office are one side of the river, hundreds of acres of farmlands including three tribal villages are situated on the opposite side. More than 70 families inhabit this tribal village, bereft of essential services like heath and education.

Moreover, no MLA or MP has ever set foot in Gobindpur and Narani villages under ward No. 7 and Tulakadihar under ward No. 5 of Rasulpur gram panchyat. People residing along both sides of the river have been repeatedly writing to the Rural Development department, Irrigation department, District Collector and even to the Chief



Minister demanding construction of a bridge across the Tulasi river, but to no avail. The residents of Oladi, Bada dhanadi and Sana dhanadi, including people from Nalabahara gram panchayat have been facing a number of inconveniences in farming.

The residents of this panchayat have to cover a distance of 17 kilometres through Nalabahara to reach the district headquarters. A bridge over the river would reduce the distance to only 5 kilometeres. If along with the bridge, a proper road is built from Oladi to Mirigimundi via

Gobindpur: the distance to the National Highway (NH-60) will be only 3 kilometres. Although construction of half the length of this road has already been completed, nobody seems to care about completing the rest of the road, complained the villagers.

On the other hand, most villages under this panchayat get inundated during the rainy season. On top of that, tidal water in the river enters the farmlands directly breaching the embankment. Due to tidal ingress, hundreds of acres of farmlands are rendered unfit for cultivation for years.

As a result of the efforts of the late MLA Madanmohan Dutta, Pradhan Mantri Gram Sadak Yojana (PMGSY) was about to see the light of the day in this region, but a precious little has been done after his demise. After plaints were made before the serving MLA of this region, Swarup Kumar Das, upped his efforts to take necessary steps in this regard.

Naib sarpanch Shrikant Pani, ward member Sunita Majhi and many villagers, including Bhagaban Nayak, Makaranda Dalai, Laxmikant Soren, Satyananda Mohanty, Murali Soren, Manmath Soren, Harekrushna Dalai, Surjyakanta Marandi, Umakanta Soren. Kata Dalai and Banshidhar Dalai have demanded the construction of an all-weather bridge over the Tulasi river and a road connecting Oladi with the NH-60 via Gobindpur for the convenience of the residents of ten moujas along with Manudiha, Kushudiha, Oladi, Bada Dhanadi, Sana Dhanadi in the coming days.

Rafale Riddle

t reflects poorly on the Indian government that it is not prepared to reopen the case of alleged corruption in the controversial Rafale fighter air-Craft deal following fresh revelations. In the meanwhile, France has commenced an investigation into the case and a judge has been appointed to lead an investigation into the alleged graft and favouritism in the 7.8 billion Euro sale to India of 36 fighter aircraft. On the contrary, a puerile and preposterous argument has been put forward by a BJP national spokesman contending why the government should order a probe simply because the French government has done so. It is precisely for this reason that the serious allegation of blatant corruption involving men in the highest offices for one of the country's biggest defence deals needs to be investigated. BJP's logic puts the Indian government's credentials for probity and transparency under a cloud. For, it tends to create the impression that the French government values integrity in public affairs and it doesn't hesitate to probe grave allegations. On the other hand, the government of India - the source of the deal that spawned the alleged corruption - is stonewalling even demands for a probe. It certainly goes to the credit of the French government that it did not shy away from investigation simply because the allegations are directed against the country's former President François Hollande whose finance and economy minister, Emmanuel Macron, is now the country's President.

A key minister of the Narendra Modi Cabinet has even tried to belittle the Opposition's demand for a probe on the ground that the Supreme Court had earlier dismissed petitions for such a probe. As is the tendency of government functionaries, the minister dished out half truths about the apex court verdict. Justice KM Joseph, one of the three judges of the bench constituted to deal with review petitions, ruled the main verdict would not impact any independent inquiry into the allegations of corruption after approval is taken under Section 17A of the Prevention of Corruption Act. But, the Central Bureau of Investigation (CBI) has not yet registered any FIR. It is not very difficult to understand the reasons behind the hesitation of the CBI to act in this case. The apex court once quite rightly dubbed the CBI a 'caged parrot' for working in many cases as a puppet in the government's hand. Then Chief Justice of India Ranjan Gogoi, who headed the bench, recently declined to comment on the French government's latest order on the probe. He is now a Rajya Sabha MP, made on the recommendation of the BJP soon after his retirement. His appointment had jolted people's faith in the sanctity of the constitutionally-approved separation of powers between the judiciary and the executive

The French government has ordered the probe in the wake of a series of investigative reports published by Mediapart in April about the deal, including the role of a middleman whose disclosures India's Enforcement Directorate is reportedly aware of but has not, so far, investigated. Following the reports, the French anti-corruption NGO Sherpa filed a complaint with the tribunal of Paris, citing 'corruption,' 'influence peddling,' 'money laundering,' 'favouritism' and 'undue tax waivers' surrounding the deal. Interestingly, the former head of the French tribunal had gone against the advice of one of her staff in 2019 and dismissed an initial complaint filed by Sherpa. The reason she cited to justify her decision was "to preserve the interests of France." Besides other aspects, the criminal investigation will examine questions surrounding the actions of former French President Hollande, who was in office when the Rafale deal was signed, his economy and finance minister Macron and then defence minister, Jean-Yves Le Drian, now Macron's minister of foreign affairs. The investigation will be led by an independent judge.

It is only natural that the Opposition, Congress and the CPI-M, have once again demanded a Joint Parliamentary Committee (JPC) probe to unravel the truth about the deal. Even when the government was touting the apex court verdict dismissing the petitions for probe as vindication of its claim that there was no wrongdoing, the Opposition stated that only a JPC probe can unearth facts and that it is beyond the purview of the Supreme Court to go into various aspects, including pricing of the aircraft.

The government's argument that the Opposition with its probe demand is only playing into the hands of corporate rivalry in France is ludicrous, to say the least. The BJP spokesman could not even name one such rival. It is time the government cleared the air without delay since the Prime Minister's name has been dragged into the controversy. The fact that the Congress had made this issue its major poll plank and lost the elections in 2019, as has been stated by a Union minister, is no proof that the allegations are unfounded.

IDENTITY & TOLERANCE

The first Parliament of the World's Religions was held in Chicago between September 11 and 27, 1893. Swami Vivekananda attended the event as a representative of Hinduism. His first speech lasted for barely three or four minutes, and was delivered on the first day itself, sometime in the afternoon. That speech began with the booming words, "Sisters and brothers of America!" to which he got a standing ovation and a thunderous applause which lasted for two minutes, from a crowd of nearly seven thousand. Press reports of the conference corroborate this phenomenal response. It is not clear, why a monk clad in an unfamiliar robe, from a distant alien land, speaking in a different accent, had such a remarkable effect with just his opening salutation. Much scholarly analysis is available on this perplexing question. His short speech was on the essential unity and harmony of religions. He said, "I am proud to belong to a religion which has taught the world both tolerance and universal acceptance. We believe not only in universal toleration, but we accept all religions as true." Not just tolerance, but acceptance. Treating different faiths as equally valid. In his closing lines he said, "I fervently hope that the bell that tolled this morning in honour of this convention may be the death-knell of all fanaticism ... " The great reception that the Swami received was undoubtedly because of his spellbinding presence and personality, but perhaps also because the audience was parched and thirsty for a message of unity and harmony.



The great Swami's historic speech and life's message are worth recounting in light of the latest survey report from the Pew Research Centre of America. The report is based on a face-to-face survey of nearly 30,000 Indian adults conducted between late 2019 and early 2020. The survey takes a look at religious identity, nationalism and tolerance in Indian so

ciety. It was conducted by local interviews in 17 different languages and covers nearly all the Indian states and union territories. It is based on statistically sound sampling techniques.

The Pew Research Centre is an organisation which is 30 years old, and conducts public opinion polls, demographic research and does content analysis and other data-driven social science research. So, its survey findings are reasonably robust. One of the key findings of this survey is that Indians value religious tolerance and accept all faiths as belonging to India. About 85 per cent of Hindus and 78 per cent of Muslims believe that respecting all religions is important to being truly Indian. Importantly, an overwhelming percentage of the respondents (80 per cent for Hindus, and 79 per cent for Muslims) believe that respecting other religions is a very important part of their own religious identity. Presumably this is the influence of scriptural injunctions, and teachings of saints and sages over the ages of respecting and accepting all religions as true. As per the survey findings, 97 per cent of all Indians believe in God, though they may differ about the nature of God.

An interesting finding is that religious conversion is rare. This finding is based on the question, which asked the respondents whether they were raised as something else and then acquired a new identity that is by conversion. The percentage of Hindus or Muslims who have converted is minuscule. It is Christians who had the maximum gain, i.e. there were 0.4 per cent respondents who claimed that they had changed their faith to Christianity. Even that number is small. This finding on the rarity of conversions is important in light of the spate of anti-conversion laws and prohibition against interfaith marriages that have been passed recently by several state governments. The Pew survey also found that most Indians were against interfaith marriages. This is peculiar when considering the Indian notion of syncretic co-existence, respect for other religions, and yet maintaining strictly segregated identities. For ages, Indians have demonstrated the capacity to hold strong and multiple identities based on religion, language, region and ethnicity, simultaneously. The Pew finding

simply confirms this trait. Another interesting finding is that for Hindus, national identity, religion and language are closely connected. This link between Hindu identity and nationalism is particularly strong in the north (69 per cent) and central India (83 per

cent) and weaker in the south (42 per cent). Thus, for a majority of Hindus, national identity goes hand-in-hand with politics. This fact perhaps explains the elec toral and voting patterns of the last two national elections, which exploited the theme of Hindi, Hindu and Hindutva. And yet remarkably both Hindus and Muslims overwhelmingly said that they were proud to be Indian. For Muslims this was 95 per cent of the respondents.

The research report based on the Pew survey is rich in insight since it also covers many other aspects such as dietary habits, perception of personal laws and memories of partition. Importantly, it demolishes certain myths that may have emerged, thanks to amplification of certain narratives in the mainstream media and so cial media. This is not to deny that there are fault-lines in Indian society along religion, caste and linguistic identities. There is now also a palpable north-south divide, aggravated by issues surrounding federalism.

A nation's material progress depends not just on a solid foundation of human and physical capital, but more crucially also on trust capital. By 2050, India will have the highest number of Hindus and Muslims in the world. It will remain, as is now, one of the most incredibly diverse nations measured along dimensions of religion and other aspects of identity. Thus, as was affirmed by Swami Vivekananda more than a century ago, or by saints and sages all along, the essential maxim to practice is the recognition of unity and harmony of all religions. The latest survey indicates that such conviction is ingrained in Indians, and it is for us to reinforce, and harness that conviction, and not magnify or exploit the fault-lines.

Preserving women's bodily autonomy

B had borne four children, and she and her husband decided areas of their lives, whether that means going to school, caring for that their family was large enough. For nine years thereafter, despite living in a poor region of Nepal, she could rely on a local health clinic for injectable contraceptives. But then came Covid-19, which disrupted medical supply chains and health budgets around the world. Although the new baby is deeply loved, a vulnerable family has now been put in an even more precarious position. They are hardly alone. For women around the world, one of the most serious costs of the pandemic - beyond the direct toll in lives and livelihoods - has been loss of reproductive choice. These are lifetime costs that might be borne even by generations to come. This April, the United Nations Population Fund (UNFPA), the UN sexual and reproductive health agency, published My Body Is My Own, a groundbreaking edition of our annual State of World Population report. In it, we trace the link between sexual and reproductive health and bodily autonomy, a principle that is absolutely fundamental to women's self-determination and empowerment. Only when women have control over their bodies can they benefit from

Obnubilate

his is as high-flown a Latinate word as the clouds it figuratively evokes (it comes from nubes, a cloud). It means to darken, dim, cloud over, or obscure. It's not a word to be wasted on everyday conversation, but on its rare outings seems to be the special province of the more ponderous political speeches and newspaper editorials. Nineteenth-century reviewers used it to suggest that a writer had been less than transparently clear in his exposition, as here in a squib in The Princeton review in 1832 about a book by Samuel Taylor Coleridge: "There is here fine criticism, classic wit, poetic dreaming, and some grains of sound doctrine, but so obnubilated with the fumes of German metaphysics, that we become giddy, and lose all power of comprehension". And here it appears as an adjective in a put-down of Walt Whitman in the Southern Literary Messenger in 1860: "Here is the sample of his obnubilate, incoherent, convulsive, flub-drub". They don't write criticism like that any more (and they don't spell that last word that way, either, but as flubdub). Some modern writers have found it useful to suggest the ponderous wordsmithery of previous generations. Neal Stephenson, for example, in his novel Quicksilver set in the seventeenth century: This was a wonder all by itself, with its ropewalks - skinny buildings a third of a mile long - windmills grinding lead and boring gun-barrels, a steam-house, perpetually obnubilated, for bending wood, dozens of smoking and clanging smithys including two mighty ones where anchors were made ... And Patrick O'Brian had Dr Maturin say it in The Mauritius Command: "It is the pity of the world, Dr McAdam, to see a man of your parts obnubilate his mind with the juice of the grape."

By the same token, any loss of bodily autonomy quickly multiplies. According to recent estimates by UNFPA and Avenir Health, an estimated 12 million women in 115 low and middle income countries faced disruptions in family-planning services during the first year of the pandemic, leading to around 1.4 million unintended pregnancies. Such outcomes - a cause of increased maternal deaths and unsafe abortions - are one of the starkest manifestations of lost bodily autonomy.

If there is one bright spot in these figures, it is that the most severe disruptions to family planning occurred early in the pandemic and were for the most part short-lived. For its part, UNFPA stepped in to provide contraceptives and other reproductive-health supplies to countries in need.

Globally, the percentage of countries reporting pandemic-related disruptions to family-planning and contraception services has fallen from 66 per cent in 2020 to 44 per cent in 2021. Concerted efforts by health officials, governments, and donors have greatly mitigated a catastrophe for women. In some cases, solutions were implemented so quickly that women

on Population and Development established a common agenda for sexual and reproductive health. And at a summit in Nairobi 25 years later, governments, businesses, youth and women's activists, philanthropies, and others made bold commitments to end family-planning shortfalls, preventable maternal deaths, and gender-based violence and other harmful practices against women and girls.

This international support has enabled UNFPA to operate sexual- and reproductive-health programmes in more than 150 countries. Since 2008, medicines and contraceptives delivered through our Supplies Partnership have saved countless lives and prevented almost 90 million unintended pregnancies.

But we cannot be complacent. These gains are fragile, and funding continues to be threatened by the pandemic's economic fallout. Many countries have altered their spending and service priorities; some of the UNFPA's own programmes have been affected by major spending cuts in the United Kingdom - one of the organisation's oldest and strongest partners.

A second priority is to ensure that services actually reach all women and girls. This requires overcoming complex barriers related to location, education, age, and other factors that can impede access to care.

All women have the right to live in safety, with easy access to the medicines that they need to make empowered, autonomous decisions about their own bodies and their lives.

Fear of seedling death looms large in Nuapada

BELOW NORMAL RAINFALL

Nuapada, July 5: With Nuapada district receiving less than normal rainfall this monsoon, the fear of seedling death (Gaja Marudi) has started gripping the famers

Nuapada is a tribal-dominated district with 131 gram panchayats, three NACs and five blocks. Its population is over 6,00,000 and 80 per cent of them earn their livelihood from agriculture.

The farmers in the district generally start sowing paddy seeds from the first week of June. This year, buoyed by good rains in the last week of May and first week of June, the farmers felt encouraged and sowed seeds. While the seeds in the fields that had received rain water have started germinating the seeds in the fields that are still waiting for rain water are yet to germinate.

Meanwhile, around two weeks have passed since it rained last in the district. Staring at a seedling death-like situation, the framers who are already under tremendous mental stress due to Covid-19 situation are in a fix.

At places, the paddy seedlings



have started withering and at some other places, the fields have developed cracks. "We are at loss thinking about what to do in such a situation. We have already invested the money we had saved. Now we don't have money to buy seeds. During this pandemic, we are not even getting enough works," alleged some farmers.

Less than normal rain and the

rain being elusive have left the farmers in a quandary. The district received 906.7mm rainfall by June end this year and this is 40 per cent less than the normal rainfall. Among the blocks, Nuapada block received 225.00mm rainfall, followed by Boden block (185.80mm), Komana block (183.10mm), Sinapali block (183.00mm) and Khariar block (129.80mm).

(129.80MM).

This year, out of 1,51,760 hectares of farmland, 87,600 hectares have been under paddy cultivation and 64,160 hectares have been set aside for non-paddy cultivation.

Referring to the fear of seedling death like situation, Birendra Pradhan, a Komana based farmer leader, said the district administration should take stock of the situation and announce 'Gaja

Marudi'

Another farmer, Akhila Chandra Joshi of Tarapur area under Boden block said since they don't have money to buy seeds, the government should consider the case and provide seeds to them.

Echoing the same, B Krishna Rao, a farmer from Khariar block alleged that undeclared power cuts have added to their woes. Due to frequent power cuts, the lift irrigation points are not working properly. In this situation, the government should consider providing each farmer solar pumps on subsidy.

Mentioning about the problems the farmers face such as distress sale, Arun Kumar Biswal, a social activist of Khariar area urged the government to take steps for the betterment of the farmers.

When contacted, Nuapada district agriculture officer Samarendra Chandra Behera admitted that the rainfall the district received by June end (906.7mm) is not enough for agriculture. "However, we are yet to receive any news from any of the districts regarding 'seedling death'. Agricultural activities are underway in the district," he said.

Dismantled dividers on NH-53 turn into death traps

Derabisi, July 5: The road dividers that were dismantled at several places allegedly by some local businessmen on the Chandikhol-Paradip national highway (NH-53) in Kendrapara district have turned into death-traps

for commuters. The dismantling

took place on the stretch from Panchupandav to Anlabanka under Derabisi block in the district.

One such breach of the divider is quite visible as it is 30 feet wide and lies just opposite a petrol pump at Chhata. The divider was broken so that vehicles from the wrong side could easily approach the petrol pump. However, it leads to fre-

quent accidents and traffic snarls. Despite repeated complaints by

the locals, officials of the National Highways Authority of India (NHAI) have not reacted or made an effort to repair the divider. Senior lawyer Bidhubhusan Mohapatra stated that the entire portions that have been dismantled should be repaired as quickly as possible to prevent accidents and loss of lives.

On being contacted, regional transport officer (RTO) in Kendrapara Nikhil Pattanayak said, "We have informed about the breaches to the NHAI authorities in writing. Legal action will be taken against the wrongdoers from our side in case the NHAI fails to do anything.'

Notably, NH-53 has been converted into a double lane road running from Chandikhol to Paradip. Hundreds of iron oreladen trucks pass through this route on a daily basis.

Bhubaneswar, July 5: Speaking on the occasion of the 72nd Van Mahotsav programme at Badagada High School in the City Monday. Forest and Environment Minister Bikram Keshari Arukha said that the government aims to undertake afforestation programme on around 1.50 lakh hectares in 2021 22 by spending ₹599 crore under different schemes. The government will plant 6.67 crore saplings on the land and also distribute 3.21 crore saplings.

This afforesation will be undertaken under different schemes such as Compensatory Afforestation Fund Management and Planning Authority (CAMPA), Odisha Forestry Sector Development Project, Ama Jangala Yojanam. Green India Mission and others.

The government will plant 6.67 crore saplings on the land and also distribute 3.21 crore saplings

Minister Arukha said that during the cyclone Yaas several areas of the state, especially the northern parts, suffered severe damages, as large number of trees was uprooted or broken. To replenish the damage, plantation of large number of trees is the only option. "We are working in that direction with all our strength," he said.

Additional Chief Secretary Mona Sharma said that the forest cover in Odisha has increased by 274 sq km in the last two years. The forest area of Odisha, known for its rich biodiversity, wildlife sanctuaries and wetland, has increased from 51,345 sq km in 2017 to 51,619 sq km in 2019. Odisha also secured the fourth rank in Total Forest Cover.

Ranchi, July 5: The words "I have fought the good fight, I have finished the race," from the Bible seems to sum up the life of Stanislaus Lourdusamy, 84 or 'Stan Swamy' as he was known.

Swamy, a Jesuit priest, who spent long years working among his beloved Advasis in this eastern Indian tribal state, died Monday in Mumbai, hours before his appeal for bail in a case where he is ironically accused of being an 'Urban Naxal' was to be heard.

In 2016, moved by the plight of Adivasi prisoners in Jharkhand, many of whom were falsely branded as Naxalites, Swamy did a research on them titled 'Deprived of rights over natural resources, impoverished Adivasis get prison: a study of Undertrials in Jharkhand.'

His study found that 97 per cent of undertrials interviewed said that allegations that they were linked to Maoists were false, and 96 per cent of them earned less than Rs 5,000 a month, underlining the fact the poorest and the most vulnerable in the state were the among the ones arrested under stringent anti-terror laws

It also found that 31 per cent of undertrials and a little over a third of the convicts were tribals. The percentage of tribals in jail was far higher than their proportion of the population

His study coming after three decades of work among the tribals which focussed on their community, land and forest rights, was considered authoritative but also discomfited the powers that be.

Swamy who was born in Tiruchirapalli in Tamil Nadu according to his friends, studied theology and did a Masters in Sociology at the University of Manila in the 1970s. Later he studied at Brussels where he struck up a friendship

with Archbishop Holder Camara whose work among Brazils poor influenced him.

He later worked as Director of the Jesuit-run Indian Social Institute at Bangalore from 1975 to 1986.

He came to Jharkhand some 30 years ago and took up work among the tribals. Among other issues he took up the causes of tribals marginalised after their lands had been taken over for dams, mines and townships, often without their consent. He also worked for the release of tribal youths from prison, often in cases where they were falsely

accused. Two days before NIA took him into custody in connection with the Bhima Koregaon case, the Jesuit priest claimed stringent laws such as UAPA were being misused to arrest tribals "indiscriminately" in a video message.

The National Investigation Agency (NIA) October 9, last year had filed a charge-sheet against eight people, including Father Stan Swamy, for their alleged involvement in inciting a mob to violence in Bhima Koregaon near Pune January 1, 2018. Swamy, a cancer patient who also has Parkisons disease,



was arrested from his home in Ranchi October 8, 2020. Despite protestations that he had never been to Bhima Koregaon, he was still taken to Mumbai where he was session produced before a court and re-

manded to judicial custody. He is possibly the oldest person to be charged under the Unlawful Activities (Prevention) Act (UAPA), officials had then said.

NIA officials had said investigations established he was actively involved with the CPI (Maoist).

The NIA also alleged that he was in contact with "conspirators" -Sudhir Dhawale, Rona Wilson, Surendra Gadling, Arun Ferreira, Vernon Gonsalves, Hany Babu, Shoma Sen, Mahesh Raut, Varavara Rao, Sudha Bharadwaj, Gautam Navlakha and Anand Teltumbdeto further the group's activities.

The agency alleged that Swamy had also received funds through an associate for furthering their ideological agenda. Besides, he was convenor of the Persecuted Prisoners Solidarity Committee (PPSC), which the authorities dubbed a frontal organisation of the CPI(Maoist).

They said literature, propaganda

material of the CPI (Maoist) and documents related to communications for furthering the group's programmes were seized from his pos

Swamy on his part had alleged that material had been planted on his computer and he was being falsely accused.

Ahead of his arrest, Swamy had posted a video saying the NIA had been interrogating him and had questioned him for 15 hours during a span of five days.

'Now they want me to go to Mumbai, which I have said that I won't go," he had said, citing the pandemic. The video, posted on YouTube, was recorded two days before his arrest.

"I have never been to Bhima Koregaon for which I am being accused," he had said. He had added that he had sought to be questioned through video conference and hoped that better "human sense" would prevail.

"...What is happening to me is not something unique or happening to me alone, it is a broader process taking place all over the country. We all are aware how prominent intellectuals, lawyers, writers, poets, activists, student leaders are all put in jail because they have expressed their dissent or raised questions about the ruling powers of India," Swamy had said in the video.

He had said he is part of "the process" and in a way happy to be so because he was not a silent spectator and is part of the game.

"I am ready to pay the price whatever be it," Swamy had said.

The Bhima Koregaon case was taken over by the NIA January 24 last year: Pune Police has alleged that the violence was caused following speeches given by members of the group Elgar Parishad December 31, 2017. Violence broke out the next day.

During interrogation, the accused confessed to have entered the sanctum sanctorum of the temple by breaking open the main door, the police officer claimed.


Bangalore, July 5: With the Karnataka government further easing restrictions under "Unlock 3.0" effective from Monday, life seems to have returned to normalcy as shops, restaurants, malls, private offices and religious places began their operations in full swing.

Also, all public transport-buses and metro- were seen operating up to its seating capacity. These services will be available for the public till 9 PM, as the government is imposing night curfew till 5 AM.

With the government allowing places of worship to open only for darshan, people, though fewer in number, were seen visiting temples following Covid precautionary measures at sev eral places in the city.

Similar reports are emerging from across the state. As offices and business establishments have been allowed to function at full working strength, traffic congestion was seen on streets in Bengaluru and other cities with office-goers getting back to work.

Bangalore Metropolitan Transport Corporation has said that bus services will be operated between 5 AM and 9 PM with all pre-



cautionary measures, and 4,500 buses will operate in the city and suburban area.

The corporation said based on passenger volume, services will be increased. Officials were seen ensuring that there is no overcrowding in buses and passengers don't travel

by standing. Bangalore Metro has said, Metros will operate from 7 AM to 8 PM from Monday to Friday, with fre-

quency of 5-15 minutes in peak and non-peak hours, and Saturday, Sunday and general holidays it will be with increased or decreased fre-

quency, depending on the situation. Customers were seen in good numbers at hotels and restaurants across the city. Also, bars will be open from Monday, but pubs will not. The new guidelines that were

announced by Chief Minister BS Yediyurappa Saturday, have come into effect from 6 AM July 5 and will be in force up to 6 AM July 19.

Bangalore Police Commissioner Kamal Pant has said that a total of 54 special teams comprising Bruhat Bengaluru Mahanagara Palike (BBMP) marshals and city police personnel will be deployed across the city to impose fines and register cases on individuals and commercial establishments that violate Covid-19 norms.

"I urge everyone to strictly follow Covid-19 appropriate behaviour for our own safety. Remember, the cases have decreased, but the virus is still around," he has tweeted.

In the guidelines, all shops, restaurants, malls, private offices and closed places have been asked to strictly enforce Covid appropriate behaviour failing which action will be initiated under the Disaster Management Act, 2005.

While, marriages and family functions are permitted to be conducted involving not more than 100 people and strictly adhering to Covid-19 appropriate behaviour and prevailing guidelines, cremation and funerals to be allowed with maximum of 20 people.

While night curfew will continue between 9 PM and 5 AM, the weekend curfew has been lifted.

Theatres, cinema halls and pubs will remain closed, while swimming pools, sports complexes and stadia are permitted for competitive training and practice purposes by strictly adhering to Covid appropriate behaviour.

All social, political, sports, entertainment, academic, cultural, religious functions, other gatherings and large congregations, continue to be prohibited.

The application will be available on Apple and android devices where the public can upload photos of the trees, GPS coordinates and other details in the application. Once these details are uploaded by citizens, the same will be verified by the forest officials. BBMP



deputy conservator of forests H C Ranganathaswamy said, "The application is developed in a unique way where the citizens can upload information easily, which include GPS readings, tree measurement,

species and other details. The app has a feature that will allow citizens to input details of trees on their premises, which will later be verified by forest officials." The tree census that was to begin in 2019 by the civic body and forest department has been delayed, despite repeated raps from the High Court of Karnataka. On Saturday, the forest department and BBMP demonstrated the app before chief justice of Karnataka Abhay Shreeniwas Oka. According to Ranganathaswamy, they have already counted 70,000 trees in the city. "We are hoping that the census will be done at a fast pace as the public will be involved in the process," he added.

Shimla, July 5: Tourists have been thronging Himachal Pradesh as the heatwave has hit the plains and the second wave of Covid-19 seeing a significant decline in the country.

The occupancy in the hotels has increased in the past few days but it has yet to reach its peak, said Mohinder Seth, president of Tourism Industry Stakeholder Association. "The occupancy in the hotels remains between 60 and 90 percent during weekends, while on other days it remains around 40-45 percent," Seth said

Shimla Hotel and Restaurant Association president Sanjay Sood said the withdrawal of the condition of negative RTPCR report and e-Covid pass to enter Himachal Pradesh recently has given a boost to the tourism industry of the state.

However, the increase in the number of tourists has posed a challenge to the state government to ensure adhering of Covid protocol by the visitors amid fears of an impending third wave of coronavirus infections.

Asserting that the hoteliers have been following Covid protocol in their premises for over a year, Sood hoped that the number of tourists would further increase in the coming days.

A tourist, Nikita Kukreja, said the majority of the visitors were seen following Covid protocol. She along with her family members has come from Gurgaon to visit various tourist places in and around Shimla

Another tourist from Delhi Sanjana said the oppressive heatwave in the national capital forced her to visit the state.

Mohinder Seth said the state government has not provided any relief in the shape of financial aid or waiver of taxes to the tourism industry hit hard by the Covid-19 pandemic. While the Gujarat government has provided a hundred percent relief to hoteliers by waiving of property tax and garbage collection fees, Maharashtra and Odisha governments have given fifty percent relief, he claimed seeking relief on the same pattern in

Shimla, July 5: State-run Dr YS Parmar University of Horticulture and Forestry in Nauni in Himachal Pradesh has developed a technology to make use of low-grade and deformed apples for the production of vinegar as well as base wine, officials said.

The latest technology will overcome the problems of the traditional methods, which are slow and result in poor quality vinegar, Vice-Chancellor Parvinder Kaushal said.

The university on Saturday signed a memorandum of understanding with a Shimla-based food processing company for the production of apple cider vinegar, based on the technology developed by scientists of the university's Department of Food Science and Technology under a DST project.

This is the second startup that has signed a non-exclusive license agreement with the university for the transfer of this technology by paying Rs 40,000 as technology fee, said the university in a statement.

Under this agreement, the company will use the university's tech to manufacture and sell the cider vinegar and will also acknowledge it on the product label.

Explaining the technology, Department of Food Science and Technology head KD Sharma said the technology is an alternative to the traditional methods of making apple cider vinegar and can also be taken as an alternative approach for complete utilization of culled apples along with improving the farm income.

He complimented the entrepreneurs -- Nanda Chhajta and Yashwant Chhajta -- for putting faith in the university technology and apprised them of several other technologies and processes developed by the university, which can be beneficial to the enterprise.

The Vice-Chancellor said the demand for apple cider vinegar has increased manifold in thepast few years due to its several health benefits.

Shimla, July 5: While most north Indian states suffer power outages, Himachal Pradesh is generating optimum electricity, mainly from hydropower, despite delay in monsoon rains so far, but finding lack of buyers is leaving the state virtually 'powerless' -- financially.

Officials said that besides the hydroelectric power generation from all state-run projects reached the optimum level of 550 lakh units per day, the cash-starved distribution companies of other states, which were



North India power starved, but HP has 'excess'

earlier procuring electricity in bulk, are opting for power cuts.

'The hydropower generation in some 70 state-owned projects, all over 25 MW, is between 500 and 550 lakh units per day. Despite scanty monsoon rains, the daily generation is optimum due to sufficient flow of water in rivers owing to the melting of glaciers," an official with state's directorate of energy said.

He said the state's demand is 300 lakh units daily, while the rest is supplied to Punjab, Delhi, Goa, among others, as per their demand. The daily per unit rate to these states varies from Rs 2.50 to Rs 5, which is quite low. "Even the distribution companies are shirking to enter into long-term purchase

there are nearly 20 major hydropower plants that are run either by the central government, private players or joint venture companies. All these are operating at full capacity now.

Chairman and Managing Director Nand Lal of public sector SJVN Ltd that owns the 1,500 MW Nathpa-Jhakri project, in Kinnaur district, the biggest operating hydroelectric plant in India, said the current generation at the plant is 39 million units per day.

He attributed the increase in power generation to the increased flow in the Satlui river.

SJVNL's current installed capacity is 2,016.51 MW and it aims to be a 5,000 MW company by 2023. Besides hydropower, the SJVNL has presence in wind, solar and thermal generation.

Officials admit that while most states suffer from acute power shortage in this peak season when the monsoon is deficit or delayed, Himachal Pradesh is facing challenge in disposing of its electricity in the country's two operational power bourses.

The reason: a majority of state electricity boards are cash-strapped and prefer to resort to outages rather than buying electricity to meet the peak demands.


New Delhi, July 5: The muchfeared third wave of coronavirus is likely to hit India by mid-August, while cases may peak in September, a report said Monday, even as the second wave is not yet over in the country.

The report titled 'Covid-19: The race to finishing line', published by SBI Research, stated that vaccination is the only saviour as global data shows that, on an average, the third wave peak cases are around 1.7 times the peak cases at

the time of second wave. Only 4.6 per cent of the population in India is fully vaccinated, while 20.8 per cent have received one dose, much lower compared to other countries including the US (47.1 per cent), the UK (48.7 per cent), Israel (59.8 per cent), Spain (38.5 per cent), France (31.2), among others. "India has achieved its second

wave peak May 7 and going by the current data, the country can experience around 10,000 cases somewhere around the second week of July," State Bank of India's Group Chief Economic Adviser, Soumya Kanti Ghosh, said in the report.

"However, based on historical trends, the cases can start rising by the second fortnight of Aug' 21 with peak cases at least a month later," he added. Current cases are now hovering around 45,000 since the past week, indicating that the devastating second wave is "not yet over in the country and is ex-



ndia saw a single-day rise of 39,796 new Covid infections, which took the tally of cases to 3,05,85,229, while the death toll climbed to 4,02,728 with 723 more fatalities, the lowest in around 88 days, according to Union Health Ministry data updated Monday. New Delhi, July 5: More than 1 in 10, or nearly 3.2 crore women in India "limited their food intake or ran out of food" during the Covidinduced lockdown last year, finds

a report. The report, titled 'Impacts of Covid-19 on women in low-income households in India' conducted by social impact advisory group Dalberg, captures the experiences and perspectives of nearly 15,000 women and 2,300 men across the 10 states of Bihar, Gujarat, Karnataka, Kerala, Madhya Pradesh, Maharashtra, Odisha, Telangana, Uttar Pradesh, and West Bengal from March 24 to May 31, 2020, and the following months from June

till October 2020. The pandemic exacerbated women's nutritional challenges, as an additional 3.2 crore reported being worried about food sufficiency in their households, the report showed.

About 16 per cent of women, who used menstrual pads before the pandemic, had no or limited access to menstrual pads, primarily because they could no longer afford these items.

In addition, more than one in three married women were unable to access contraceptives or 15 per cent of married women could not access contraceptives, primarily due to concerns about accessing a healthcare facility during the pandemic. While Kerala, Telangana and Uttar Pradesh did



well on providing women with both pads and contraceptives, Bihar

access, the report low showed.Meanwhile the report showed that government schemes such as MGNREGA (1.2 crore), Jan Dhan (10 crore), and PDS (18 crore) supported women during the crisis. About 70 per cent of women in the study depended on PDS for food and nutrition during the crisis than on any other channel.

Moreover, women experienced a deeper loss and a slower recovery in paid work compared to men -- women made up just 24 per cent of those working before the pandemic and yet, they accounted for 28 per cent of all those who lost jobs, and 43 per cent of those yet to re-cover their paid work compared to 35 per cent men.

Washington, July 5: China's propaganda outlet China Daily allegedly paid millions to prominent US newspapers and magazines in the last six months to buy media influence, an independent analyst reported citing documents filed with the US Justice Department.

According to disclosures made by the Justice Department, the staterun English-language newspaper China Daily paid several hundred thousand dollars to prominent American publications like Time magazine and Foreign Policy magazine in a span of six-month. As many as \$700,000 was paid to Time magazine; \$371,577 to the Financial Times; \$291,000 to Foreign Policy magazine; \$272,000 to Los Angeles Times; and over \$1 million to others.

Last month, The Daily Caller had reported China Daily, controlled by the Chinese Communist Party, paid more than \$4.6 million to The Washington Post and nearly \$6 million to The Wall Street Journal since November 2016. Both newspapers reportedly published paid supplements that China Daily produces called "China Watch." The inserts are designed to look like real news articles, though they often contain a pro-Beijing spin on contemporary news events.

25 KILLED IN FRESH MYANMAR CLASHES

Kolkata, July 5: (IANS) Fresh clashes erupted over the weekend in a Myanmar town located at a border region with India, leading to at least 25 fatalities, sources from the area told this news agency.

On July 2. Myanmar troops encircled the Satpyarkyin village, west of the Tabayin township in Sagaing province.

Civilian resistance fighters of the People's Defense Force (PDF) defended the village against nearly 200 troops supported by artillery.

The resistance finally died down on Sunday when PDF fighters ran out of bullets on their hunting rifles and arrows for their bows, PDF commander in Tabayin Si Aung told IANS on Facebook Messenger. He admitted that during the long fighting for nearly 48 hours, at least 18 PDF members were killed and more than 10 injured. Aung said said four junta soldiers were killed, along with three villagers who were caught in the crossfire.

New York, July 5: The FBI said Sunday the "scale" of a major ransomware attack against a US IT company could mean investigators won't be able to work with every victim individually.

Hackers hit Kaseya, a firm that provides IT services to other companies, with a ransomware attack that could have targeted as many as 1,000 other businesses on Friday, just before the long holiday July 4 weekend in the United States.

The FBI said it had opened an investigation along with the Cybersecurity and Infrastructure Security Agency and other US federal agencies "to understand the scope of the threat.

"If you believe your systems have been compromised, we encourage you to employ all recommended mitigations, follow Kaseya's guidance to shut down your VSA servers immediately and report to the FBI," the bureau said in a statement Sunday, referencing the signature networking software that was attacked.

"Although the scale of this incident may make it so that we are unable to respond to each victim individually, all information we receive will be useful in countering this threat," the FBI statement said. President Joe Biden said

Saturday that he had ordered an investigation, in particular to find out whether the assault had come from Russia. "We're not sure yet," he said Saturday.

Russian-based hackers have been blamed for a string of ransomware attacks, and Biden recently raised the threat in talks with Russian counterpart Vladimir Putin.

Ransomware attacks typically involve locking away data in systems using encryption, making companies pay to regain access.

Kaseya describes itself as a leading provider of IT and security management services to small and medium-sized businesses. VSA is designed to let companies manage networks of computers and printers from a single point.

The company said in a new statement Sunday that they were working "around the clock in all geographies" to get their systems working again.

They said they hoped to get a restricted version of their platform running again within days. The disruption forced Swedish

supermarket chain Coop Sweden to close on Saturday because their cash register system had been taken down in the attack.

"The highest levels of volcanic sulfur dioxide gas emission were recorded today at an average of 22,628 tonnes a day, the highest ever recorded in Taal volcano," the Philippine Institute of Volcanology and Seismology said in an update Sunday. The Institute said the "current sulfur dioxide parameters indicate ongoing magma extrusion at the main crater that may further drive succeeding explosions".

Massive forest fire kills 4 in Cyprus

Nicosia: Four people were killed in a massive forest fire which has been raging for almost 24 hours in a mountainous area of Cyprus, police said. Charalambos Alexandrou, director of the Department of Forests, said on Sunday that the fire was the worst ever in the history of Cyprus, reports Xinhua news agency. The police said that the victims were four Egyptian nationals, aged 25 to 30, who were deployed as agricultural workers at Odou village

He said at least 40 artillery shells were fired into the village before the soldiers charged "They had to retreat many times

because of our resistance, but finally we moved out of Satpyarkyin to avoid more casualties and because we had no more bullets left," Aung said. Villagers at Satpyarkyin told Burmese media groups the final toll could cross 30 because bodies of more PDF fighters and villagers were found after the soldiers occupied Satpyarkyin, a PDF stronghold

"We can't retrieve all the bodies as regime raids continue," a villager was quoted as saying.

Mumbai, July 5: Household debt has sharply jumped to 37.3 per cent of the GDP in the pandemic year from 32.5 per cent in FY20, says a report, confirming the deeper financial impact of COVID-19.

It also warned that the ratio may rise further this fiscal due to the second wave of the pandemic.

In fact, household debt has been steadily increasing ever since the GST implementation in July 2017, which was preceded by demonetisation in November 2016.

In four years since FY18, the household debt has jumped by 720 bps -- from 30.1 per cent in FY18 which was the year of GST implementation, to 31.7 per cent in FY19, 32.5 per cent in FY20 and to a massive 37.3 per cent in FY21, according to the report by SBI Research Monday.

Household debt includes retail loans, crop loans and business loans from financial institutions like banks, credit societies, non-banks and housing finance companies.

The decline in bank deposits in FY21 and the concomitant increase in health expenditure may result in further increase in household debt to GDP ratio in FY22, as per the report, pencilled by Soumya Kanti Ghosh, the group chief economic adviser at State Bank of India (SBI). However, even at over 37 per cent, the household debt to GDP ratio is still lower than most other countries. he said.

During the initial lockdowns in 2020, deposits of all commercial banks increased due to less avenues to spend. However, subsequently they declined marginally

Services activity slumps at fastest rate in 11 months

Bangalore, July 5: Activity in India's dominant services sector contracted sharply in June as tighter restrictions to contain a resurgence of coronavirus cases hammered demand and forced firms to shed jobs at a rapid clip, a survey showed Monday.

Asia's third largest economy, which has already recorded more than 400.000 COVID-19 deaths, is still reporting over 40,000 coronavirus cases per day, taking the total number of infections to over 30.5 million.

IHS Markit's Services Purchasing Managers' Index plunged to 41.2 last month from an already depressed 46.4 in May. That was its lowest reading since July 2020 and well below the 50-level separating growth from contraction.

"Given the current COVID-19 situation in India, it was expected that the service sector would take a hit," said Pollyanna De Lima, economics associate director at IHS Markit.

"PMI data for June showed quicker declines in new business. output and employment that were sharp but much softer than those



recorded in the first lockdown." Muted demand sank the new business sub-index to its lowest

since July 2020. As a result, firms shed headcount for a seventh straight month, with the fastest reduction rate recorded in June. A Reuters poll taken around a month ago showed

the job crisis may worsen over the coming year. The depressed services sector results are in line with the

overall downturn in business activity, underscored by a sister survey on Thursday which showed manufacturing activity contracted for the first time in

Input prices rose again last month on high raw material and transportation costs, indicating inflation could stay above the Reserve Bank of India's comfort range of 2-6% in coming months.

India's retail inflation rose above 6% in May to a six-month high. Yet the RBI is not expected to tighten monetary policy this fiscal year as it looks to support economic growth.

The contraction in both manufacturing and services activity sent the overall composite index plunging to 43.1 in June from 48.1 in May.

Residential sales surge by 83% YoY in Q2: JLL

Mumbai, July 5: Residential sales in Q2 (April-June) 2021 increased by 83 per cent as compared to Q2 2020, across the top seven cities.

According to JLL's Residential Market Update - Q2 2021, released Tuesday, sales were driven by the low base effect, less stringent lockdowns, and accelerating vaccination drives during Q2 2021, demonstrating improved resilience in the market. By comparison, in Q1 2021, sales of residential units continued an upward trajectory, increasing by 17 per cent on a sequential basis.

During the first wave of Covid-19, residential sales dropped by a record 61 per cent quarter-on-quarter to 10,753 units in Q2 2020. However, the impact of the second wave has been limited with sales in Q2 2021 dipping by 23 per cent to 19,635 units. Sales of more than 45,000 residential units were recorded in H1 2021 as against 38,204 units in H1 2020, an increase of 18 per cent YoY. The sustained levels of residential sales present clear signs of demand and buyer confidence coming back to the market.

The need for secured tangible assets and aspirations to own larger homes as remote working becomes the new norm is driving sales of residential properties across the country. Siva Krishnan, Head - Residential,

India, JLL said: "Development focus on mid and affordable segments continued in H1 2021 with 72 per cent of the new launches in the sub ₹10 million category. Moving ahead, while the focus on these price segments is expected to continue, developers are likely to consider new launches of larger-sized apartments in order to capture changing consumer preferences.

Mumbai has consistently been the largest contributor to sales over the past five quarters. In H1 2021, Mumbai accounted for 26 per cent of the total sales. Furthermore, Delhi NCR, Pune, and Hyderabad followed, each contributing 15 per cent or more.

New Delhi, July 5: One97 Communications Ltd, the parent of Indian payments firm Paytm, will file a draft prospectus as early as July 12 for a domestic initial public offering (IPO) that seeks to raise \$2.3 billion, two sources close to the matter said Monday.

The money will be raised via sale of new Paytm stock as well as a secondary offering of shares at an expected valuation of \$24 billion to \$25 billion with an option to raise the amount at a later stage if required, the sources said, declining to be named as the matter is not public. Paytm's proposed \$2.3 billion IPO will make it India's third-biggest public listing in dollar terms after state-run miner Coal India in 2010 and Reliance Power in 2008.

The prospectus will be filed



shortly after Paytm's extraordinary general meeting (EGM) of shareholders in Delhi July 12, possibly on the same day, the sources added. Paytm declined to comment.

Paytm, which counts China's Alibaba and Japan's SoftBank as backers, is seeking shareholder approval at the EGM to sell up to

120 billion rupees (\$1.61 billion) in new stock and have an option to retain an over-subscription of up to 1 per cent, Reuters reported previously. There were \$3.6 billion worth of IPOs in India in the first half of 2021, up from \$1.1 billion at the same time last year, according to Refinitiv.

The funding round also saw participation from other investors, including AdvantEdge, Fowler Wesrup and Vimson Group, the company said in a statement.

Founded in 2015 by engineering graduates Mughilan Thiru Ramasamy and Mrinal G Pai, Skylark Drones aims to utilise the funding towards product enhancement, expand its presence in overseas markets and strengthen business development.

Here's a look at the business Jassy is taking over and the challenges that await him on the job.

MORE THAN 'EVERYTHING STORE'

Bezos incorporated Amazon exactly 27 years ago. The internet bookseller he founded out of a garage has morphed into a purveyor of virtually any consumer good, online and in physical stores. It has grown far beyond even that: Jassy built an enormously profitable and market-leading business, Amazon Web Services, that

runs data centers serving a wide range of corporate computing needs. Amazon is also expanding further afield into Hollywood and healthcare

Amazon's stock started out at \$1.50 per share, when adjusting for future equity splits. It now trades at more than \$3,500 per share and is worth over \$1.7 trillion total, making it one of the most valuable companies

in the world. Amazon's annual profit almost doubled in 2020 to \$21.3 billion. That's partly because the COVID-19 pandemic encouraged more consumers to shop online, helping the company grow revenue 38% to \$386.1 billion.

REGULATORY PUSHBACK

With size has come greater scrutiny. Long chased by global regulators on issues such as taxation and data collection, Amazon now is fending off antitrust complaints that could lead to big fines. US President Joe Biden recently appointed a prominent tech critic, Lina Khan, to run the Federal Trade Commission, which is in-

vestigating Amazon. Though the details of the probe aren't public, it is expected to involve Amazon's conflict of interest as a retailer of its own products that compete with third-party merchants on its platform. Amazon has been accused of using the proprietary data of thirdparty vendors to make cheaper, private-label versions of their products. Amazon contests these claims. Meanwhile, Congress is considering new antitrust laws that could alter Amazon's business.

CHALLENGES CLOSER TO HOME

Amazon also faces challenges from some of the biggest U.S. companies. Walmart Inc, for instance, is chasing after Amazon's home turf with a package delivery club of its own, while Microsoft Corp has signed deals in the cloud with top enterprises -Walmart included - to narrow the lead of Jassy's AWS.

Jassy also faces potential disruption from within. Amazon is grappling with unionization interest among warehouse employees and potentially other workers. Although it handily beat back an organizing effort at its Bessemer. Alabama, fulfillment center, labor groups including the Teamsters vow that the fight is only beginning.

The company likewise is hoping to maintain its allure among office staff, as some startups offer tech jobs with more flexible work schedules. The company initially said it planned an "office-centric culture," but it soon updated guidance to requiring in-person work three days a week, in line with industry peers.

Football powerhouses Spain, Italy take their respective unbeaten runs into the semifinals at the Euro 2020

Perhaps. Or was it the fact that Spain was the leading scorer at Euro 2020? Maybe. Or the fact that La Roja is on an unbeaten streak stretching back to October, a run of 13 games? Quite possibly.

Spain's opponent in the European Championship semifinals Tuesday might have something to say about all that.

> Italy, another of the continent's traditional powers, brings an even better run of form to Wembley Stadium а na

tional-record 32 matches unbeaten, going all the way back to September 2018. From the moment tenor Andrea Bocelli cleared the field at Stadio Olimpico after his stirring rendition of "Nessun Dorma" at the opening ceremony, making way for the start of the tournament, the Italians have been right on the money.

Three impressive wins in the group stage, without conceding. A gutsy victory over a better-than-expected Austria in the round of 16. The elimination of watch duel all top-ranked Belgium in the quarterfinals. Maybe Enrique isn't aware, but Italy is rolling at the moment.

This might be a match between teams who have almost forgotten what it feels like to lose — Spain has only one defeat in its last 29 games — but Italy looks to have the edge, at both ends of the field. Much has changed since Roberto

Mancini took charge in May 2018, with the team having evolved into a high-energy unit that presses hard and attacks at pace. But the Azzurri's defense needs little introduction.

Formidable center backs Leonardo Bonucci and Giorgio Chiellini are still holding the fort, like they have been for more than a decade, and Italy has conceded only two goals so far.

Spain's defense, on the other hand, is a work in progress while center back Aymeric Laporte integrates following his switch of nationality from France.

In attack, striker Alvaro Morata continues to frustrate for Spain and Luis Enrique has seemingly yet to settle on his preferred wingers. Italy, though, has had strong and reliable performances from striker Ciro Immobile and wide forward Lorenzo Insigne, the scorer of the decisive second goal against Belgium.

It's in midfield where Spain can seriously challenge Italy, potentially making it the department where the match could be won or lost. Jorginho, Nicola Barella and probably Marco Verratti for Italy versus Sergio Busquets, Pedri Gonzalez and Koke for Spain is a must-

by itself. Neither team has made it this far in a major international

> competition since 2012, when they met in the European Championship final in Kyiv. Spain won that match 4-0. Two players remain from each country: Bonucci and Chiellini for Italy, and Jordi Alba and Busguets for Spain. So while this is far from uncharted territory for two countries with nine

European Championship or World Cup titles be-

tween them, it is for most of the players involved.

Expect the Spanish to have the majority of possession, but maybe by not as much as they are accustomed. And expect the Italians to launch quick counterattacks from turnover balls, seeking to get behind the aging Busquets and attack the soft center of Spain's defense

A win for Spain, which has the

youngest squad at the tournament. sets up the prospect of a third European Championship title in four editions and potentially the start of new period of success for a nation that dominated world soccer from 2008-12.

PEDRI

A win for Italy surely means Mancini's team would enter the final as the favourites, no matter who wins the second semifinal match between England and Denmark.

TALKING POINTS

FORM

- The first Euro 2020 semifinal matchup was determined Friday after Italy beat top-ranked Belgium 2-1 in Munich and Spain defeated Switzerland in a penalty shootout in St. Petersburg.
- Italy are Europe's hottest team, extending their unbeaten run to 32 matches and its winning streak to 13 with Friday's result. By contrast, Spain is on a 12-match unbeaten run and drew their opening two group matches.

GOAL THREAT

- The match will be a face-off between the tournament's top-scoring teams, as it stands. Spain has found the net 12 times after opening with a scoreless draw against Sweden, while Italy has 11 goals.
- The goals have been shared throughout the teams with neither having a player who has scored more than two. Ciro Immobile, Matteo Pessina, Manuel Locatelli and Lorenzo Insigne have two each for Italy, and Pablo Sarabia, Ferran Torres and Alvaro Morata have the same amount for Spain.

HISTORY

- Their most recent meetings came in qualifying for the 2018 World Cup. Italy's loss and draw against Spain contributed to the team failing to qualify for the tournament for only the second time.
- The last time either team reached a major tournament final was in 2012, when Spain beat Italy 4-0 to defend their European title.
- Italy prevented Spain from winning a third consecutive European Championship by beating the defending champions 2-0 in the round of 16 at Euro 2016.
- The Spanish beat Italy on penalties in the Euro 2008 quarterfinals before ending their 44-year trophy drought.

COACHES

Spain coach Luis Enrique was playing for his country at the 1994 World Cup when his nose was broken in the quarterfinals by Italy defender Mauro Tassotti. Italy went on to reach the final that year, losing to Brazil on penalties.

Italy coach Roberto Mancini wasn't part of his country's squad at the 1994 World Cup because he opted out of international duty after not being sure of playing time. His return to the Italian national team only came in 2018, when he was hired as coach.

Rio de Janeiro, July 5: Defending Copa America champion Brazil is still regarded as the team to beat - not bad for a tournament some of their players didn't even want to be in.

Few expect that favorite tag to change as Brazil gets ready for Monday's semifinal against Peru, a team that the Selecao thrashed 4-0 two weeks ago in the group stage.

The winner at the Nilton Santos Stadium here will play Saturday's final at the historic Maracana Stadium against Argentina or Colombia, which play Tuesday.

"It is obvious we are favorites for being at home, but we need to know how to deal with that," Brazil midfielder Fred said at a news conference Sunday. "Players want to have the match of their lives against Brazil. The last one (beating Chile 1-0 in the quarterfinals) was tough, but the next will be tougher. Peru will be motivated, trying to win, it will be the match of their lives.'

Brazil and Peru played in the 2019 Copa America final, with host Brazil winning 3-1 before nearly 70,000 fans. Monday's match will be played without fans due to the COVID-19 pandemic.

Two key strikers won't be playing in the semifinal. Brazil's Gabriel

Jesus and Peru's Andre Carrillo (against Paraguay) were sent off during the quarterfinals. Brazil's Everton, one of the top scorers at the 2019 Copa America edition, and veteran Christian Cueva are set to take their places.

Brazil advanced to the semifinals after a hard-fought win with 10 men for almost all of the second half against Chile.

Peru recovered from their 0-4 defeat against the hosts by beating Colombia and Venezuela and securing a draw with Ecuador. It reached the semifinals on penalties after a 3-3 draw with Paraguay.

"We will have the chance to face Brazil and correct all the things that went wrong in the first match,' Peru coach Ricardo Gareca said. "Brazil continues to be a very powerful team, this Brazil is very good. Our team is also improving.'

Alex Sandro, Neymar, Everton Ribeiro and Richarlison scored for Brazil against Peru. Peru will look to striker Gianluca Lapadula, replacing their all-time top scorer Paolo Guerrero who missed the tournament due to a knee injury. Brazil will once again count on Neymar, their best player in the

tournament so far, who finished the clash against Chile in a state of exhaustion, along with many of his teammates

New Delhi, July 5: The Indian team management in England wants young openers Prithvi Shaw and Devdutt Padikkal to join the side but questions are being raised about whether chairman of selectors Chetan Sharma is on the same page as the think-tank.

There are big questions in the corridors of Indian cricket as to how Bengal opener Abhimanyu Easwaran made it to the Englandbound team as a stand-by after a disastrous 2019-20 Ranji season and an equally dismal A tour of New Zealand.

It can be concluded that Easwaran is not believed to be technically ready for top quality Test cricket and his selection ahead of two form players like Shaw and Padikkal is bound to raise a few eyebrows.

"Shubman Gill has been ruled out of the entire Test series in the UK with shin splints that will take

ager, at the end of last month, had sent an e-mailed requisition to former pacer Sharma asking for two more openers to be sent to the UK," a senior BCCI source privy to developments told this agency on the condition of anonymity.

However, despite being aware of the magnitude of Gill's injury, Sharma is believed to have not paid much heed to team management's requests.

It now remains to be seen if they put in a formal request for sending Shaw and Paddikal, to BCCI president Sourav Ganguly and secretary Jay Shah. Shah is also the convenor of senior selection committee.

"The BCCI president hasn't vet received any formal request about sending Shaw and Padikkal to the United Kingdom. They are in Sri Lanka for the white ball series but obviously after it ends July 26, both can be flown in. But I think, team management wants them to join be-



fore entering the bio-bubble in Durham," the source said.

In fact, had Sharma paid heed to the requisition of the team management from last month, Shaw and Padikkal could have reached England on time for the practice game.

When asked what if the team management specifically asks for Shaw, the official said: "Let them put forth an official mail and then it can be taken forward. Also Prithvi

Olympic gold-medallist Abhinav Bindra was the flag-bearer at the opening ceremony of the 2016 Games in Rio de Janeiro.

Wimbledon, July 5: Novak Djokovic reached his 12th Wimbledon quarterfinal Monday to pull even with Arthur Gore, who had a 117-year head start, while a parade of newcomers also made the final eight.

First-timers on the men's side included Canadian Denis Shapovalov. Italian Matteo Berrettini, Marton Fucsovics of Hungary and Russian Karen Khachanov, who won a bizarre fifth set to beat American Sebastian Korda on his 21st birthday.

Women advancing to their first

Wimbledon quarterfinal included No.1-seeded Ash Barty, No.2 Aryna Sabalenka of Belarus, Tunisian Ons Jabeur and Karolina Pliskova of the Czech Republic. Djokovic, the two-time defending

champion, held every service game to tie Gore and beat No.17 Cristian Garin, 6-2, 6-4, 6-2.

Khachanov outlasted Korda 3-6, 6-4, 6-3, 5-7, 10-8. Khachanov will next face the No.10-seeded Shapovalov, who beat Roberto Bautista Agut 6-1, 6-3, 7-5. Berrettini became the first Italian man in 23 years to reach the Wimbledon quarterfinals by ousting Ilya Ivashka 6-4, 6-3, 6-1.

29-year-old Fucsovics became the first Hungarian to reach the Wimbledon men's quarterfinals since 1948 by upsetting No.5 Andrey Rublev 6-3, 4-6, 4-6, 6-0, 6-3.

Jabeur became the first Arab woman to reach the quarters by rallying past Iga Swiatek 5-7, 6-1, 6-1. Barty ended French Open champion Barbora Krejcikova's 15-match win streak, 7-5, 6-3.
