### GI tags for 3 state handicrafts sought

Bhubaneswar, July 6: The department of handloom, textile and handicraft has filed an application seeking Geographical Indication (GI) tags for famous state handicrafts such as Konark stone carving , Odisha pattachitra and Pipili chandua.

Earlier, an application seeking GI tag for Cuttack silver filigree (Chandi Tarakasi) has been filed by the Odisha State Co-operative Handicrafts Corporation Ltd.

Stone carving is an excellent craftsmanship of Odisha which has been prevailing here over centuries. The crafts and the art form primarily consist of custom and carved works. Many temples' intricate sculptures and delicate carvings exemplify the practice Similarly, filigree has been traditionally associated with fine craftsmanship and luxurious design in classical jewellery. Silver bricks are transformed into thin fine wires or foils and used to create jewellerv or show-pieces. "This is good news for the handicraft artists of the state. GI tag for the three crafts will act as a universal mark to establish the presence of the craft in national and international level," said Sanatan Nayak, director of handicrafts and cottage industries.

New Delhi, July 6: Declining permission to a statewide celebration of Rath Yatra of Lord Jagannath in Odisha, with only exception to the Puri Jagannath temple, the Chief Justice of India Tuesday revealed that he too has been waiting fervently to be part of the annual ritual, however, Covid-19 was still playing spoilsport.

In June, the Odisha government had said the Rath Yatra will be held July 12 only in Puri following the guidelines issued by the top court, while banning it in all other places of



the state. A counsel appearing for a petitioner seeking the Rath Yatra at other places argued that Covid-19 situation is different now (number of cases has decreased).

The Chief Justice responded, nobody knows how Covid situation will be (in the future). The Chief Justice told petitioners, seeking the Rath Yatra in other places alongside Puri: "You want to pray to the God. You can do it from home. I also wanted to go to Puri but I couldn't in the last one and half years. This isn't the time". Dismissing the petitions, Chief

Justice NV Ramana observed: "Last year few people died, this year many people died (due to Covid). We hope God will allow us these rituals next year." A bench headed by the Chief Justice said the court agrees with the Odisha government's order in the backdrop of the ongoing pandemic.

The Naveen Patnaik government submitted before the top court that it would be impossible for it to ensure

thousands of devotees at temples across the state if the annual ritual was given the go-ahead.

The bench also comprising Justices AS Bopanna and Hrishikesh Roy refused to allow the Rath Yatras in Baripada, Sasang and in other cities of Odisha. On June 23, the Orissa High Court declined to entertain five petitions seeking permission to hold the festival of Rath Yatra in Kendrapara and Bargarh districts.

Last year, the top court had permitted the Rath Yatra on the condition that there would not be any public attendance and all entry points into Puri would remain closed

The court had ordered that each of the three chariots would be pulled by not more than 500 people who were required to test negative for Covid-19. The Odisha government submit-

ted before the top court it was practically impossible to impose condisecond wave continues. The counsel argued that this was the only yatra in the whole world

where 149 countries participate. "I don't want to say more," the Chief Justice said, adding, "What can we do? I myself wanted to go...I cannot entertain. I also feel bad. I can't help. I also want to see." Earlier, the Orissa High Court had declined permission for holding Rath Yatras at other places saying that Puri "constitutes a class apart". "These are extraordinary times in which not just Odisha but the entire country is barely recovering from the second wave of the deadly Covid pandemic. The measures and precautions taken by Odisha have to be viewed in the said context. Consequently, this court is not inclined to entertain any of the prayers in any of the above writ petitions, praying for permission to hold their Rath Yatras/festivals on parity with the temple of Lord tal partners and funded by corporate partners or District Mineral Foundation (DMF) shall continue to function till the end of the approval period.

## **Proposals worth** ₹1.46L cr get nod

Bhubaneswar, July 6: The state government Tuesday approved five major industrial projects worth ₹1.46 lakh crore in metal and metal downstream sectors. These proposals will create employment for 26,959 persons in the state.

A meeting of the 26th High-Level Clearance Authority (HLCA) held under the chairmanship of Chief Minister Naveen Patnaik approved the projects. In spite of the pandemic, Odisha has been able to attract investments worth ₹2.96 lakh crore during the financial year 2020-21.

The HLCA has okayed the expansion of Bhushan Power and Steel Limited's integrated steel plant at Rengali in Sambalpur district. The company has decided to enhance its capacity from 5 million MT per annum (MMTPA) to 15 MMTPA with an investment of ₹55,000 crore. This project will generate employment for over 10,000 persons.

The panel also approved the expansion of Tata Steel's crude steel production from 3 MTPA to 8 MTPA, hot rolled coil from 3 MTPA to 7 MTPA, 2.2 MTPA coldrolled products and 2 MTPA long products. The com-

### AGENCIES

New Delhi, July 6: Prime Minister Narendra Modi is likely to effect the first reshuffle in his Council of Ministers on Wednesday since he assumed the charge for a second term, in what is tipped to be a "major shakeup" of the government as he looks to make it more representative with an eye on political and governance challenges.

BJP leaders Sarbananda Sonowal, Jyotiraditya Scindia and Narayan Rane, all of whom are being seen as probables for induction as ministers in the Modi government, arrived in the national capital Tuesday.

In another pointer to the imminent Cabinet reshuffle, Social Justice and Empowerment Minister Thaawarchand Gehlot was appointed as Karnataka governor, causing yet another ministerial vacancy.

JD(U) leader RC P Singh and LJP's



Pashupati Kumar Paras, both of whom are expected to represent the BJP's allies in the government, also reached here from Bihar. All of them remained tight-lipped to queries about their possibility of joining the government. Rane told reporters that he had not received any call about his joining the government.

Leaders of the LJP faction headed by Paras said he had received a call

from Home Minister Amit Shah on Monday but claimed that it was related to the birth anniversary of party founder Ram Vilas Paswan.

Multiple sources said the reshuffle is likely to take place Wednesday evening. There has been no official word on the Cabinet reshuffle. The exercise comes against the backdrop of a massive review, which has stretched for weeks, undertaken by the BJP.

### **New Governors** in eight states

NEW DELHI: In a major reshuffle, President Ram Nath Kovind Tuesday appointed eight new Governors giving them charge of administration of new states. While many were transferred, others were new appointments. PS Sreedharan Pillai, Governor of Mizoram, was transferred and appointed as Governor of Goa; Satyadev Narayan Arya, Governor of Haryana was transferred and appointed as Governor of Tripura; Ramesh Bais, Governor of Tripura was transferred and appointed as Governor of Jharkhand; Bandaru Dattatraya, Governor of HP was transferred and appointed as Governor of Haryana. However, Thaawarchand Gehlot, who currently serves as a cabinet minister, was appointed as Governor of Karnataka. Besides, LS MP from Visakhapatnam Hari Babu Kambhampati has been appointed as Governor of Mizoram.

With the two pending SLPs in the Supreme Court, the order of the tribunal cannot be published in the official gazette under Section 6(1) of the Inter-State River Water Dispute Act, 1956, which is essential for operationalisation of the order of the tribunal.

Earlier, the state had also filed an application for clarification before the Vansadhara tribunal against its final order. The tribunal pronounced its further report June 21 this year wherein it has kept

its final order (dated 13.09.2017) intact, but subject to the finalisation of SLP in the Supreme Court.

## **Illegal quarries destroy Khurda hills**

COST OF ENVIRONMENTAL DAMAGE DUE TO RAMPANT OUARRYING PEGGED AT AROUND ₹1.80 CRORE

Bhubaneswar, July 6: The lush green hills of Khurda are slowly getting stripped of their virtues owing to rampant illegal stone quarries operating right under the nose of the district administration.

Of late, the pace of illegal quarrying has gained momentum leading to denudation of several hills covered with green vegetation, thereby posing grave threat to the environment.

The hills are fast losing their existence owing to construction and expansion of highways. Barring a few quarries, several others are operating without environmental clearance and consent to operate.

This comes around a year after the National Green Tribunal (NGT), while hearing the case of illegal stone quarry in villages like Jhinkijhari, Tapang and Anda under Nijigarh Tapang gram panchavat, had lambasted the district administration for illegal stone quarries and its gross negligence in complying with the NGT order.

A joint committee comprising members from Forest and Environment Ministry, Central Pollution Control Board and State Pollution Control Board among others, had brought the illegalities to NGT's notice. The committee said that the quarries were operating in violation of mining laws and standard operating procedure, posing threat to the local community and the environment as well. The panel had also pegged the cost of environmental damage at around ₹1.80 crore

**ODISHA HAS CONDUCTED OVER 1.41 CRORE SAMPLE TESTS FOR COVID-19, INCLUDING 63,184 MONDAY**

Bhubaneswar, July 6: Odisha's Covid-19 tally mounted to 9,27,186 Tuesday as 2,487 more people tested positive for the infection, while 51 fresh fatalities pushed the death toll to 4,299, a Health department official said.

Of the new cases, 1,428 were reported from quarantine centres and the remaining 1,059 during contact tracing.

Cuttack district registered the highest number of fresh cases at 422, followed by Khurda (407), Jajpur (202), Balasore (157) and Puri (154).

Of the 51 fatalities, nine were registered in Khurda, five each in Bargarh, Mayurbhanj and Dhenkanal, three each in Cuttack Jagatsinghpur, Puri, Sundargarh and Jajpur districts. Similarly, two deaths each were reported from Bhadrak, Deogarh, Ĝanjam and Navagarh, and one patient each succumbed to the infection in Kandhamal, Kendrapara, Keonjhar and Nabarangpur.

## City social worker duped of ₹40 lakh

Bhubaneswar, July 6: A social worker in Capital city accused an associate of cheating him of around Rs 40 lakh on various pretexts between 2020 and 2021.

A case has been registered with Bharatpur police on the basis of a complaint lodged by the victim, Ramakanta Mishra of Kalinga Nagar area in Ghatikia. Mishra alleged that in March

last year during the Covid outbreak, he had come into contact with one Rajesh Kumar Sethi of Patkura, pretending to be an RI, Rajesh Kumar Mohapatra.

Mishra was engaged in providing food packets, dresses and financial aid to the poor and slum dwellers who were hit hard by the pandemic and lockdown. The accused reportedly assured

the victim of helping him get all the help from government sources using his contact. Meanwhile, Mishra sought the help of Sethi to

settle some problems faced by his brother-in-law at Rayagada. Sethi offered help through one Swarnalata Mohapatra, a government of India employee at Rayagada. Sethi allegedly received Rs 4 lakh from Mishra in this regard.

Similarly, he again took 30 lakhs from the complainant promising to facilitate a BDA plot at Kalinga Nagar between May 22, 2020 and March 13, 2021. However, he did not hand over the promised plot to

Mishra despite repeated requests. Mishra claimed that he gave another 8 lakhs to Sethi who promised him another plot registered in the name of his uncle.

This apart, Sethi has reportedly taken around 10 lakhs from the complainant under various pretexts. Sethi's friend Kailash Mishra had allegedly taken around 4 lakhs from Mishra to get his two daughters admitted Kendriya Vidyalaya.

Police have started investigation into the matter after registering a case in this regard.

**Bolangir, July 6:** In an act of extreme brutality, a 60-year-old man was brutally assaulted and forced to drink urine and eat human faeces by a group of villagers suspecting that he practiced witchcraft and sorcery. The incident took place at a kangaroo court at Paruabhadi village under Sindhekela police limits in this district, a report said.

The victim was identified as Haribandhu Bagarty, 60, a native of Paruabhadi village under Sindhekela police limits in the district.

The incident occurred July 3, Saturday, but came to light after a video footage of the brutality went viral on social media. On being informed, police rescued Haribandhu the next day and admitted him to the Titlagarh hospital.

There, the doctors administered him primary treatment and later he was shifted to Bhima Bhoi Medical College and Hospital in Bolangir as his condition deteriorated, police the villagers suspected Haribandhu of practicing witchcraft and sorcery on the locals. The villagers then decided to hold an unofficial court and punish him.

Accordingly, July 3, some villagers went to Haribandhu's house, dragged him out and thrashed him badly. A group of youths held Haribandhu, while some others forced him to drink urine and eat human faeces.

They also shaved his head and paraded him through the village, said Bhubana Bagarti, who was present at the spot during the incident. The youths as well as the onlookers also recorded the act on their mobile phones and made it

viral on social media. "Though we tried to stop the villagers while they were dragging Haribandhu, they did not budge. Instead, they threatened us of dire consequences. Later, they took Haribandhu outside his house and thrashed him," Bhubana said. When contacted by the media, Haribandhu said he does not know

anything about witchcraft and sorcery and has been wrongly framed. Three persons have been ar-

rested in this connection and produced in the court, Titlagarh Sub-Divisional Police Officer (SDPO) Surendra Nath Satpathy said. The victim is stable now, he added.

Bolangir SP Nitin Kausalkar has appealed to the people to report all such incidents to the police and not take the law in their hands. Notably, Sindhekela is infamous for killings and assaults of people over suspected witchcraft and sorcery practices.

**Malkangiri, July 6:** The Malkangiri district administration has initiated an investigation into the alleged construction of a road in Akarpali village of the district by the Chhattisgarh government, a report said.

The action came following publication of media reports, including in **Orissa POST**.

A team of district officials comprising tehsildar Gunanidhi Nayak, BDO Ajay Kumar Pradhan, the local revenue inspector and the local public representatives visited Akarpali village Monday and took stock of the development.

The team members also verified the stone pillars that have been used as demarcating lines between the two states. During verification, it was found that the neighbouring state has trespassed into Akarpali village in Malkangiri district and constructed a 500-metre-long road there.

However, the actual reason behind the construction of the road is yet to be ascertained. When contacted, tehsildar Nayak said that a report on the issue will be prepared and submitted to the DRDA project director for action. BDO Pradhan said that subsequent action will be taken by the Revenue department officials.

## Woman suffers rib fractures in stampede at vax centre

**Polsara, July 6:** A woman who visited a vaccination centre in Ranipada village here in Ganjam district to receive her dose of anti-Covid shot had to be admitted to a hospital as she suffered rib fractures in a stampede at the centre Tuesday.

According to a source, a Covid-19 vaccination centre has been set up at a kalyan mandap in Ranipada village. Bhanumati Sahu, a resident of Laxmanpali village near Polsara police station, had gone to the centre to receive her shot.

With no proper arrangement in place for smooth conduct of vaccination and no deployment of police to maintain law and order situation, people were shoving each other while trying to enter the centre. Bhanumati was caught in the crowd.

Suddenly the scene turned ugly with people going berserk. Before she could understand anything, Bhanumati felt a push and subsequently fell on the ground. As she was trying to stand up, people trampled her and some even fell on her.

The family members immediately rescued a seriously injured Bhanumati and rushed

On being informed, Polsara police station IIC Jitendra Kumar Mallick; tehsildar Pradeep Kumar Nayak and executive officer, NAC, Prasanna Kumar Das reached the spot and brought the situation under control.

## Albino palm civets seen in Satkosia Tiger Reserve

FINDINGS OF A STUDY PUBLISHED IN THE JOURNAL SAID THE COAT COLOUR VARIATION IN INDIAN PALM CIVET WAS REPORTED CENTURIES BACK IN KANDHAMAL

**Angul/Bantala, July 6:** Indian palm civets with colour variation in their furs have been caught by cameras at Satkosia Tiger Reserve near here in Angul district, a report said.

Pleasantly surprised over the development, wildlife experts conducted a research into the taxonomic and distribution status of the mammal which has thrown up interesting findings on the existence of its sub-species in the region.

The findings have been published in a research paper – the June edition of the journal Zoo. According to the research paper, the coat colour variation in Indian pal civet was reported centuries back in Kandhamal and in southern Rajasthan in 2004.

This time, the colour variation has been reported in civets that were photographed with the help of camera traps installed in the western part of the tiger reserve. The camera traps have been installed in the tiger reserve to monitor the movement of big cats and prey distribution in the Satkosia region. The civets found in Satkosia were partially albinistic.

The first photograph of a partial albino palm civet was captured at two places in Majhipada reserve forest of Satkosia wildlife division in March last year.

The photograph showed that the body of the mammal below its shoulders had creamy and whitish fur without any marks or spots on it. However, no pigmentation or pattern was visible on its legs and tail. Pigmentation

on the fur was visible only behind the ears, near the eyes and close to their muzzle. On the other hand, patches on the head below the eyes were distinctly visible.

Later, another civet with normal colour coat was captured by a camera trap in April with distinct markings. Researchers also recorded a civet having a creamy band of fur near the abdomen and the mid-section of the tail in the same area in May.

Researchers engaged in the study in the western part of Satkosia since 2018 claimed that only the head and shoulders of some rare specimens collected in Kandhamal in the pre-Independence era were of normal colour, while their remaining body was white. In 1891, they were described as partially albinistic and termed as sub-species nictitatans.

Researchers confirmed that two other specimens from this region having a broad band of white fur and some parts of the tail as white were of a potentially different species. This apart, the specimens collected near the tiger reserve in 1988 with different patterns were described as a new species, Paradoxurus jorandensis.

In the fresh survey, researchers said that though there is no molecular evidence available to support the splitting of the species, the findings suggest the distribution of the coat pattern beyond the Similipal region. These specimens were photographed in May 2020.

The study suggested that since the colour variations in furs of pal civet are often influenced by climate and geography, further investigation into their taxonomic and distribution status is required. Both morphologic and pelagic characteristics besides molecular data will be helpful in the study.

According to the researchers, a study that incorporates samples/specimens from the Indian region, especially from eastern India, is required to validate the existence of sub-species within Paradoxurus hermaphroditus, which has been lacking in the earlier studies.

The study was conducted by a team comprising IFS officers Pradeep Raj Karat and P Ramasamy, OFS officers Saroj Panda, Subhendu Behera and researchers from Wildlife Institute of India Vaishali Vasudeva, Gatikrishna Behera, Sandeep Gupta and K Ramesh.

Earlier, wildlife researchers had spotted an alibino chital among a herd in Satakosia tiger reserve in 2014. The body colour of the animal was white with few tainted spots. The eyes, nasal tips and lips of the animal were pink, while its eyebrows were white.

## Merciless

"t is a sad commentary on the country's system of justice and investigation that Father Stan Swamy, a Jesuit priest and tribal rights activist, has L died. He underwent inhuman treatment behind the bars after his arrest in the Bhima Koregaon case in October 2020. The treatment meted out to him was horrific, to say the least. Father Swamy was suffering from multiple physical ailments such as Parkinson's. Yet he had to fight for even simple things like permission from Court to obtain a straw or sipper to drink water since his facial muscles were growing weak. The case of Swamy is illogically interesting to note. When the Bombay High Court said at 2.30 pm July 5 that it would hear his appeal for bail as the first item the next day, the Division Bench of Justices SS Shinde and NJ Jamadar were informed at that point that Father Stan Swamy had passed away an hour back.

Till he breathed his last, Fr. Swamy did not know what his crime was for which he had been arrested October 8, 2020 on charges under the dreaded Unlawful Activities (Prevention) Act (UAPA) of having links with Maoists in the Bhima Koregaon-Elgar Parishad case of 2018. It is interesting to note that Swamy was in no way involved with the events of January 1, 2018 at Bhima Koregaon. He had never been to Koregaon in his life, the scene of violence. he once pleaded. He had, for decades, fought for the rights of tribals and 'moolavasis' in Jharkhand. This was a fight against the rapacity of big business to plunder the natural resources with the help of friendly governments, while tribals lived in the mineral rich land in abject poverty. Fr. Swamy had filed a PIL in Jharkhand High Court in 2017 against prolonged detention of 72 prisoners belonging to SC/ST and backward castes for alleged Left-wing extremist activities - and charged under UAPA provisions - in just one district, West Singhbhum. Invoking Article 21, he questioned the protracted pre-trial and asked for a court-monitored inquiry in all the 24 districts of Jharkhand. Ironically, three years later, even as his PIL was pending in the court, he was arrested under the same UAPA and denied bail sought on medical grounds.

Fr. Swamy's repeated pleas that he might contract Covid-19 while in judicial custody did not get response from the judiciary. It was only June 28 that the Bombay High Court allowed him the facilities of a private hospital till his bail plea was taken up. The JJ Hospital in Mumbai, where the jail authorities had admitted him before, did not even care to conduct a Covid test. His death certificate revealed "there were post-Covid effects on his lungs."

It won't be an exaggeration to call the death of Swamy an act of murder by a ruthless, autocratic administration that won't brook challenge to its antipeople decisions and measures, while the judiciary meekly watched the butchery of justice by the state machinery. The fact that the National Investigation Agency, probing the case, had never for once sought Fr. Swamy's custody, but persistently opposed his bail pleas says it all about the government's intent. It has been seen in several cases how the government has been using the draconian UAPA and the harsh provisions of the sedition law to silence its critics by forcing incarceration without trial

Recent pronouncements by the Delhi High Court and the Supreme Court have laid bare the growing tendency of the government to use the harsh laws to deny bail since most of these cases have insufficient evidence to prove the charges. The Delhi High Court has even questioned how the term of terrorist acts can be used so indiscriminately as the investigating agencies seem to be applying. The apex court, however, could not see eye to eye with the Delhi High Court's courageous interpretation of the UAPA.

Now comes more shocking news that the law enforcement agencies have been using the punitive Section 66A of the Information Technology Act even after the provision having been struck down by the court in 2015. This section empowered the police to make arrests over what was construed as 'offensive' or 'menacing' or for the purposes of causing annoyance and inconvenience by sending messages through computer, mobile phone or other devices. In 2015, the Supreme Court struck down the Section calling it "openended and unconstitutionally vague.'

When told how the defunct law is still being used to coerce people, Justice RF Nariman exclaimed July 5: "Amazing. What is going on is terrible." Hearing a plea by the NGO People's Union for Civil Liberties (PUCL), a Bench of Justices Nariman, KM Joseph and BR Gavai of the apex court issued notice and directed the Centre to make a written submission. The government argued the annulled Section is still being used because the ruling on the cancellation is put as a footnote only.

Such events demonstrate that the state, indeed, has become rotten.

people, to browbeat them with the might of the State and to try and break them into submission. The nation can never forget that an octogenarian, peace-loving activist, who devoted years working for tribals in Jharkhand, who lived a simple life and stood up for what he thought was right, has died after spending nine months in jail as an undertrial, with poor medical attention that led him to suffer from Covid-19 and brought on a deterioration in his health. He was later shifted to the Holv Family Hospital in Mumbai from the Taloja Central Jail and died on a ventilator at the hospital July 5, only hours before another hearing on his bail application was scheduled to come up in the Bombay High Court.

This is a case that will remain a blot on the police team that investigated it, the political masters who undoubtedly thought it fit for this kind of harassment of an 84-year-old to continue for so long and the judiciary which in a glaring instance of insensitivity did not routinely and immediately direct that a sipper be provided to a man suffering from Parkinson's disease so that he could drink water without spilling it; the National Investigation Agency instead asked and got 20 days to reply to the demand for a sipper. The legal back-and-forth on a request of an ailing senior citizen whose hands would shake because of Parkinson's underlined that pain, suffering, humiliation and disregard for minimum courtesies are a part of the Indian system where punishment is meted out long before the trial. In the India of today, this is heaped on activists, never mind if the activist is elderly, ailing and fighting it by himself in the midst of a pandemic. In fact, the trial may fail but the sentence is already served as an undertrial.

The predicament of Father Stan Swamy is a fit case for a full-

> all that the nation stood for democracy, secularism, a free press and space for diverse and dissenting voices.

In other ways, Father Stan Swamy by going through the suffering he did may have even served us in his last days. For one, his case will never be forgotten. It must be and will be studied, recounted and discussed again and again across schools and colleges, civil society institutions, in our courses on law and politics, in our training manuals for the police and the judiciary. It must stand out as the case that lowered India like never before. It will keep telling us that 'emergency' was not a one-off - that this danger and the danger of it getting worse is ever present, only on the edge, waiting to snatch away a young nation

and its aspirations to standing

tall for its values and its constitutional guarantees in the comity of nations.

The case also highlights the tyranny of the Unlawful Activities (Prevention) Act (UAPA), and the way the law is being applied in cases that are related to anything but terrorism. As has been well reported, Swamy's arrest was based on seizure of electronic records from his computer. Swamy himself asked many questions on the seized material. He never received any replies to those simple questions. He was never present at the site that led to what has come to be called the Elgar Parishad case. Yet, he became the 16th activist to be arrested in the case, and was accused by the NIA of being involved in the activities of the banned CPI (Maoist).

But for so many who knew the person and his work, Father Swamy stood out as a picture of service. Even if we take the extreme prosecution case and assume that the charges carried any merit, there was no justification for keeping an ailing grandfatherly figure behind bars for so long; there was nowhere he would run or escape. There was nothing he could keep or hide. Father Swamy could not walk well; he could not hear; he reportedly fell in jail. His condition deteriorated while he was behind bars

A case as shameful as this may yet become a lightning rod and allow the nation to see where we have landed. There are many who will still not be able to see this fall. In India today, every attempt is being made to break the nation, to divide between 'them' and 'us'. More such attempts may follow the death of Father Stan Swamy. It is becoming easier to see these at tempts. Yet, these divisions will continue to take their toll before they halt. Till these prejudices are not seen and called out, and brought to a halt and the guilty brought to book, India will continue to bleed

he classic pub game, darts is the ultimate non-sportsman's sport — you don't need any special clothing and little equipment (a set of darts is a good idea, but pubs lend those out), and you don't need to be fit (the aptitude of players often appears to be in direct proportion to the size of their beer guts). All you have to remember is to count back from 501, end on a double, and avoid putting your toes over the oche. Oche, for the line behind which darts players stand when throwing, is the classic bit of darts jargon, even more obscure and basic than double top for a double twenty, bag o' nuts for a score of 45, Shanghai for a score made up of a single, treble and double in that order of the same number, usually 20 when you need 120 to end a game (ditto), mugs away as an invitation to the losing player to start the next round, or mad house for a double one (because getting it can drive you crazy). Oche is pronounced like hockey without the initial h. Attempts are sometimes made to derive it from an obsolete word meaning to chop off, from Old French ochen to cut a deep notch in something, though the link with darts is obscure. Eric Partridge preferred an origin in hoggins line, for no good reason that one may discern. However, the earliest written examples - from the 1930s - are all spelled hockey and the oche form didn't become standard until the late 1970s. But why hockey? One story holds that it's from the name of a West Country brewery, S Hockey and Sons, whose crates were just the right size with which to mark out the throwing distance. That's so unlikely as to be merely funny. After this piece first appeared, Peter Brooke e-mailed to suggest that the word might well come from the Victorian hockey-dockies for shoes. This is an elaboration of hock-dock, using hock as a slang term for the foot. A hockdock might be a place where one docks one's hocks, that is, places one's feet, but is probably a nonsense reduplication.

Thanks to such people, Fourth of July celebrations in America begin around Fourth of June. For an entire month, in many parts of the country, the sounds of firecrackers can be heard at night, sometimes an hour or two after midnight.

This is a boon for all the companies that make firecrackers and fireworks, but it's a headache for all the people who enjoy sleeping at night. They keep getting woken up.

Not surprisingly, animal activists in India are just as concerned as those in America about the impact of firecrackers on dogs, cats and other animals. If people really need to create mini-explosions to celebrate Diwali. Independence Month and other occasions, can't they at least provide ear plugs to all the animals?



### Angul's forest cover declines despite annual afforestation drives Gajapati student wins int'l laurels 🕇

Angul, July 6: Every year lakhs of saplings are planted on thousands of hectares in Angul district. The Forest department has been undertaking the plantation drive for a long time now. If the department has been planting saplings vear after year. it stands to reason that there would have been dense forest in the district. But that is not the case. Let alone a dense forest, the district's green cover is decreasing slowly but steadily.

The Forest department is plant-ing saplings every year only because there is a directive from the government in this regard. However. if the present forest cover in the district is any indication, the exercise has been futile so far.

Local environmentalists, green lovers and intelligentsia allege that the Forest department is not taking proper care of planted saplings and this is the reason why most saplings are destined to wither and die within few days of plantation.

Expressing his concern over the

manner in which the afforestation drive is being undertaken in the district, environmentalist Swapna Sarangi said that in this mineralrich district trees are being felled mindlessly for mining activities. They should be compensated by planting saplings. But it is not the

practice here. If the number of saplings planted every year is taken into consideration, there would have been dense forest across the district. But the ground reality is different

"This is because the forest department is not maintaining the

planted saplings properly. Its time all of us should think seriously and take action to make up the loss," she observed.

Echoing Sarangi's views, Ashok Satpathy, an environmentalist, said that the trees planted by spending lakhs of rupees under the Compensatory Afforestation and Management and Planning (CAMPA) are not being taken care of properly. He alleged the avenue plantation is of no help in increasing the green coverage.

"The total forest cover in the district will increase only when the natural forests are saved from being sacrificed at the altar of development." he opined

According to information shared by the Angul Forest Division office, afforestation was undertaken in the district on 367.53 hectares in 2017-18 fiscal under eight different yojanas. Of them, saplings were planted on 32 hectares of open space and 335.530 hectares in forest areas to increase the density of the greenery. Similarly, saplings were planted along the sides of an eight-kilometre-long road. The Forest department also planted 1,33,596 saplings, and sold and distributed 33,000 saplings.

Similarly, to increase greenery and forest density, saplings were planted on 51,682 hectares and 1701.25 hectares of forest land respectively in 2018-19. Sapling plantation was carried out along the sides of a 37-kilometre-long road. The Forest department had planted and distributed 4,46,851 and 3,00,430 saplings respectively.

In 2019-20, the department had planted 4,32,458 saplings. It had sold and distributed 8,66,490 saplings. Then, plantation was undertaken on 71.23 hectares of open space and 1686.2 hectares to increase forest density

The department had carried out

plantation in 95 hectares of open space and 1120 hectares of forest land in the year 2020-21. This apart, saplings were planted along the sides of roads measuring 68 kilometres. While the Forest department planted 4,32,160 saplings, it had saplings

sold and distributed 15,28,000 This year, a total of 12,09,914 saplings have been grown. Of them, 4,49,914 saplings are kept aside for afforestation purpose, the re-

maining 7,60,000 saplings are to be sold and distributed. The department is yet to inform what number of saplings has been set aside for avenue plantation. When contacted, Angul, DFO, Prasanna Kumar Behera admit-

ted that the district is losing its green cover to mines and industries. So it is not the responsibility of the Forest department alone to plant trees. Industrial houses, mine owners and even common people should come forward to plant trees to increase the district's green cover. And this will go a long way in bringing down the pollution level in the district

A single OSD project is being undertaken at an expense of anything between ₹1,00,000 and ₹2,00,000. Executive officer of the Balasore

Municipality, Ashish Ishwar Pati talked about their future plans re-

garding such projects. "There are 41 slums under the municipality. Among them 21 are on government land. The remaining slums have come up on lands owned either by the Railways or individuals. We are facing problems in undertaking OSD projects on private lands," informed Pati.

"In some slums, people are objecting to the construction of parks. Hopefully, people will realise the importance of OSD and cooperate with us for such beautification projects in future," Pati added.

## Honey bee farming project a non-starter

Keonjhar, July 6: Lakhs of rupees spent by the Horticulture department here to start a honey bee farming project at its Kuanr farm three years ago have gone down the drains as the project has proved to be a non-starter. Lack of proper maintenance is said to be the reason behind the failure of the ambitious project.

There was a time when people would buy honey collected in Keonjhar and Mayurbhanj on good faith. The quality of Koenjhar honey used to be its unique selling point. Then, honey bees used to build hives on trees in the forests of the district. They would collect nectar from different flowers in the jungles and fill their hives. Tribal people living in forests would collect this honey and sell it in markets. Their honey was in great demand then.

However, with the passage of time, the jungles were destroyed and they gave way to various developmental and mining activities. The role of timber mafia in destroying jungles also can't be ignored.

All these adversely impacted the production of natural honey. In the absence of natural honey, people

started using packaged honey bought from markets. Even the traditional ayurvedic practitioners couldn't get pure honey to prepare medicines.

Realising the demand for Keonjhar honey and shortage of its supply, the Horticulture department decided to start honey bee farming at its Kuanr nursery. The project was started with 120 boxes three years ago.

However, these boxes have been lying unused for the last two years.

Lying in the open, they are now damaged. As a result, the money spent on the project has gone waste. Subsequently, the department bought boxes with bees, each costing ₹4,500. Thus, the department had spent around ₹5,50,000 so far just for purchasing boxes

While no enquiry has been ordered to find who is responsible for the failure of project, the department is now planning to restart the project. "And efforts are already underway," some sources said.

Meanwhile, it has been widely discussed that appointments should be made to fill up the vacant posts in the department to look after the project. Unless new appointments are made, it would be case of throwing good money after the bad.

When contacted, deputy director of Horticulture, Sukant Nayak said that he was unable to say who were responsible for the failure of the project and the reasons that led to mismanagement because it happened prior to his posting. "Lying in the open, all the boxes are damaged. The departmental ef-forts are on to revive the project," he informed.

New Delhi, July 6: Groundwater level in northwest India has dipped to alarming levels, especially in Punjab and neighbouring Haryana, according to a new study

The research paper published by IIT Kanpur has used more than 4,000 groundwater well data from northwest India to demonstrate that groundwater levels in the states of Punjab and Haryana have fallen to alarming levels in the last four-five decades.

Several parts of the Ganga plains are currently suffering from similar over exploitation of groundwater and it may still be time to arrest the situation if proper strategies can be designed for groundwater management, it said.

The states of Punjab and Haryana are the worst affected region and the study led by Prof. Rajiv Sinha and his PhD student, Suneel Kumar Joshi, at IIT Kanpur shows that shallow groundwater fell from 2 metres below ground level (bgl) during 1974, to about 30 metres bgl in 2010

This translates to an average loss of groundwater of more than 50 km3 (1.0 km3/vr) particularly after 2002. "The situation is equally bad for states like UP and Bihar which are agriculture dominated states and where the groundwater management strategies are still quite primitive," the study said. The study reveals that the rice cultivation area increased from 1,92,000 to 14,22,000 hectares between 1966-67 and 2017-18 for Haryana and from 2,27,000 to 30,64,000 hectares between 1960-

Srinagar, July 6: The historic Mughal and Sinthan roads, connecting Kashmir valley to Poonch-Rajouri and Chenab Valley regions respectively, were thrown open for vehicular traffic Monday after remaining closed for nearly two years following the abrogation of Jammu and Kashmir's special status in August 2019.

"Light motor vehicles as well as heavy motor vehicles were allowed to ply on Mughal road Monday. The road was reopened for civilian movement after two years," an official said. The historic Mughal road connects Shopian in south Kashmir to Poonch and was the route used by the Mughal kings to reach Kashmir.

The Sinthan-Kokernag road, which connects Anantnag district to Kishtwar, was also opened for civilian traffic. The roads were closed August 4, 2019 as a precautionary measure as the Centre abrogated Article 370 that provided special status to Jammu and Kashmir while bifurcating the then state into two union territories.

The opening of the roads comes four days after Lieutenant Governor Manoj Sinha made an announce-



ment to this effect. "In the past few days, many delegations from Rajouri, Poonch, Kishtwar, Doda met me. Today, we've decided that Mughal Road and Sinthan Road will be opened for the common public from July 5," Sinha said. "Opening these will not only fa-

cilitate movement for people but also improve J&K's overall economy. I've issued orders. People of Rajouri

& Poonch can now come to Srinagar easily. People of Kishtwar & Doda will be able to come to Kashmir division easily," he added.

Mughal Road is the road be tween Bufliaz, a town in Poonch district, and the Shopian district. The 84 km road traces a historic route used in the Mughal period over the Pir Panial Pass. It connects Poonch and Rajouri to Srinagar in the Valley, reducing the distance between Shopian and Poonch from 588 km to 126 km.

The Sinthan Road connecting Kishtwar in Jammu region with Anantnag in Kashmir Division goes through the Sinthan pass located at 3,800m above sea-level. It reduces the distance for the people who otherwise need to go via Jammu to reach Kashmir.



Lav Agarwal. Joint Secretary, Health Ministry, also sounded alarm on the situation saying that people travelling to hill stations are not following Covid-appropriate behaviour. "We can nullify the ease in restrictions again if protocols not complied with,"

"People need to understand that the virus and the disease is still here. People roaming in hill stations and markets without maintaining physical distance and not wearing masks can nullify the gains made in the management of the pandemic so far," joint secretary in the health ministry Lav Agarwal said as he stressed on following Covid-appropriate behaviour and vaccination.

Stating that the pictures from hill stations and markets are "frightening", ICMR Director General Balram Bhargava said some states in the country are still struggling with the second wave of Covid-19. "The second wave of COVID-19

has come down in most states. However, some states are still in the midst of the second wave." "The areas reporting a test positivity rate of over 10 per cent have to impose/ reinstate certain restrictive measures which have shown to be time tested and found to be effective because the virus is still lurking around," he said.

If the test positivity rate is below

5 per cent then it is a good sign and some of the restrictions can be eased. And the same momentum of high-level testing needs to be maintained, he underlined.

Agarwal said as many as 73 districts across 17 states and union territories, including Arunachal Pradesh (18 districts), Rajasthan (10), Manipur (9), Kerala (7), Meghalaya (6), Tripura (4), Sikkim (4), Odisha (3) and Nagaland (3), reported more than 10 per cent Covid positivity rate in the week from June 29 to July 5.

Eighty per cent of the new Covid cases in India are being reported from 90 districts across 14 states and union territories, including Maharashtra, Tamil Nadu, Kerala, Odisha, Andhra Pradesh, Assam. Karnataka, indicating the need for focused attention in these areas, he said.

According to sources, the health ministry is writing to these 14 states and union territories that are reporting high positivity in India.

The ministry is also likely to write to the Himachal Pradesh government over rampant flouting of Covid-appropriate behaviour and social distancing norms in Shimla and Manali, a source said.

A small funeral service, which was joined by many online, was held at the St. Peter's church in suburban Bandra in Maharashtra under the COVID-19 protocol for the 84-year-old Jesuit priest, who was arrested in October under the antiterror law Unlawful Activities (Prevention) Act in the Elgar Parishad case and died at a Mumbai hospital Monday in the middle of his fight for bail on health grounds. Opposition leaders and activists had lashed out at the Centre after Swamy's death, calling it "custodial murder" and alleging that those who repeatedly denied bail to the ailing activist had "blood on their hands". On Tuesday, leaders of 10 parties including Congress chief Sonia Gandhi, NCP chief Sharad Pawar and former prime minister H D Deve Gowda wrote to the President Kovind urging him to



New Delhi, July 6: The Supreme Court Tuesday directed the Centre to ensure that people lodged in mental health establishments are tested for Covid-19 and fully vaccinated at the earliest.

A bench of Justices D Y Chandrachud and M R Shah took serious note of Maharashtra government's shifting patients lodged in mental health institutes to homes for beggars and asked it to discontinue the practice immediately saving it is counter-productive and runs against the provisions of Mental Health Act.

It noted that Additional Solicitor General Madhavi Divan, appearing for the Centre, has assured the Court that this matter (of vaccination) would be taken up with utmost priority. "The Department of Social Justice shall take it up immediately with the Ministry of Health and Family Welfare so that suitable instructions are given and a plan is chalked out for all the States/Union Territories for ensuring the vaccination of persons who are institutionalized in mental health establishments," the bench said.

The bench said it agreed with the submission of petitioner-advocate Gaurav Kumar Bansal that the issue of testing, tracing and vaccinating those suffering from mental illness must be taken up on priority "Persons who are institutionalized in mental health establishments need to be vaccinated so as to protect them," it said. The bench also asked standing counsel for Maharashtra. Sachin Patil. to take instructions with regard to shifting of persons, who are institutionalized in mental health establishments to beggar

homes/custodial institutions. 'While the Standing Counsel

may do so, we are categorically of the view that any such action to shift such persons to 'beggar homes'/custodial institutions would be counterproductive and contrary to the letter and spirit of the Mental Healthcare Act 2017. We accordingly direct the State of Maharashtra to look into this aspect immediately and ensure that this practice is discontinued," it said.

The bench directed all states and UTs to extend cooperation in complying with the directions and said they ensure before the meeting that the discrepancies in the data, as noticed in the earlier order of this Court, are resolved and a status report on the implementation of the directions in regard to the establishment of Halfway Homes is filed.

### Citing Britney case, SC nixes guru's plea for woman

New Delhi, July 6: The Supreme Court Tuesday refused to entertain a plea by a 42-year-old spiritual guru from Kerala seeking release of his 21-year-old live-in partner from her parents' alleged illegal custody.

A bench headed by Chief Justice NV Ramana cited the case of pop star Britney Spears, who has been fighting a legal battle in the US to free herself from the conservatorship of her father.

Refusing to entertain the plea, the bench also comprising Justices AS Bopanna and Hrishikesh Roy noted that the petitioner's credentials were suspect. The Chief Justice said: "The girl is in a fragile state of mind. She is 21 and does not

know what she is doing. The man (petitioner) is married with two children." Additionally, Justice Roy noted the facts are such and the antecedents of the petitioner are such, that it does not inspire confidence.

Citing the Spears case, the bench observed that in the US unless an adult gives consent, he or she cannot be given any form of medical or psychiatric treatment. "Now, the entire family is on the road because of that, since a mentally unstable person cannot give consent," the Chief Justice said.

Spears has been under the comprehensive conservatorship of her father, Jamie Spears, following her breakdown around 12 years ago. Recently, billionaire and Tesla CEO Elon Musk had spoken up in sup-



port of the pop icon.

In the spiritual guru's case, he had moved the top court challenging a Kerala High Court's judgment that had dismissed his habeas corpus plea seeking the release of his 21year-old partner. Senior Advocate Gopal Sankaranarayanan, representing the petitioner, submitted that the woman is an adult who is being illegally detained by her parents. The bench responded by saying, "There is nothing illegal. She is with her parents.

Citing a plea on parents' con-

cern about such spiritual gurus, the bench asked Sankaranarayanan, "You also know about some of these gurujis." With this observation, it refused to interfere in the matter.

The bench noted that the petitioner was married with two children, and his mother had also said she did not trust her son. "He is also involved in a POCSO case," the bench added. POCSO is an abbreviation of the Protection of Children from Sexual Offences Act, which was enacted in 2012. The apex court asked Sankaranarayanan, "How can we give this girl to this man?'

Sankaranarayanan argued that the High Court had adopted a "paternalistic approach" as it denied an adult woman the right to take independent decisions for herself.

### He clarified that his client did not seek that the woman be allowed to join him, but was only asking for her freedom from the "illegal detention" of her parents.

The counsel added that it was a question of the liberty of the woman. The High Court, he said. had erred in making an assessment of the mental capacity of the woman after interacting with her, although under the provision of the Mental Healthcare Act, it was expected to refer the woman for a  $\rightarrow$ medical examination.

The bench replied, "No parent will say that a 21-year-old has a mental health issue. In India people cover up mental health issues. This is a case where we are clearthat the woman should not go with the petitioner."


### 'Dalai Lama key to resolving conflict'

He asked China to utilise the opportunity offered by the "mutually beneficial Middle Way Approach" to foster a harmonious environment where Tibetans and Chinese can co-exist amicably.

"Therefore, we appeal to the Chinese government to earnestly invite His Holiness the Dalai Lama to Tibet and China on pilgrimage without any precondition," Penpa Tsering said

Cairo, July 6: Egypt said Monday that Ethiopia has reported it is starting to fill the reservoir of a controversial dam on the Nile River's main tributary, a move likely to increase tensions ahead of a UN Security Council meeting on the dispute, which also includes Sudan.

A letter sent by an industry group that includes the Internet firms said companies are concerned that the planned rules to address doxing could put their staff at risk of criminal investigations

or prosecutions related to what the firms' users post online. Doxing refers to the practice of

putting people's personal information online so they can be harassed by others, the report said. Hong Kong's Constitutional and

Mainland Affairs Bureau proposed amendments to the city's data-protection laws in May that it said were needed to combat doxing, a practice that was prevalent during 2019 protests in the city.

The proposals call for punishments of up to 1 million Hong Kong dollars, the equivalent of about \$128,800 and up to five years' imprisonment.

"The only way to avoid these sanctions for technology companies would be to refrain from investing and offering the services in Hong Kong," said the previously unreported June 25 letter from the Singapore-based Asia Internet Coalition, which was reviewed by The Wall Street Journal.

Tensions have emerged between some of the US's most powerful firms and Hong Kong authorities as Beijing exerts increasing control over the city and clamps down on political dissent.

The US firms and other tech companies last year said they were suspending the processing of requests from Hong Kong law-enforcement agencies following China's imposition of a national security law on the city.

"This is an historic moment for Nepal. This makes Nepal

a power surplus country capable of exporting electricity," said Nepal **Electricity Authority Managing** Director Hitendra Dev Shakya.

With its inauguration, the first unit (76 MW) of the project came into operation, officials said.

Though the primary estimated cost for the project was Rs 3,500 crore, it surged to nearly Rs 8,000 crore.

## **No deal at OPEC to hit** fuel consumers badly

With expectation that global oil price may rise further in coming days, consumers would have to brace for buying fuel at new record prices everyday

New Delhi, July 6: There may be no respite for fuel consumers in the country facing high prices of petrol and diesel for the past couple of months as global oil scenario is expected to remain firm with oil cartel OPEC failing to reach an agreement on gradual raising of oil production to meet the growing demand.

At a meeting of OPEC plus (including Russia) differences surfaced between the world's largest oil producer Saudi Arabia and United Arab Emirates (UAE) over raising oil production marginally in August while maintaining pro-

duction level at the same till 2022. This prevented a deal that would have helped to soften crude prices a bit next month on the back of increased oil production of 2 million

barrels a day With no deal among prime oil producers, analysts expect oil prices to remain firm and may hit even \$80 a barrel over the next few days. At intercontinental exchange benchmark, Brent crude is currently hovering at \$77.5 a barrel, up over 1 per cent from the previous day. This is the highest crude level since 2018. In fact,



in the month of July itself crude prices have risen by over \$7 a barrel.

The situation in global oil markets is not good news for fuel consumers in India. Unless government intervenes by lowering taxes on the two fuels, petrol and diesel retail rates could touch new highs over successive days this month," said an oil sector expert not willing to be named.

Petrol and diesel prices have been raised on 35 days since May 1. This has increased retail petrol prices by ₹9.46 a litre in the last two months while diesel has also increased by ₹8.63 per litre during the same time span.

Also, the Centre had raised excise duty by ₹13 on petrol and ₹16 on diesel between March and May last year when oil prices collapsed due to the pandemic. The two hikes raised excise duty by 65 per cent on petrol from ₹19.98 to ₹32.98 a litre and 79 per cent on diesel from ₹15.83 to ₹28.35 a litre. These high taxes are amplifying the impact of rise in crude prices, sending petrol price above ₹100 a litre and diesel above ₹90 in most parts of the country.


At ₹92,849 crore, the Goods and Services Tax (GST) collection is the lowest in 10 months since August 2020, when it was ₹86,449 crore, official numbers released Tuesday showed


The GST collections in June 2021 are primarily for supplies made in May -- a month when most states were under different levels of lockdown, reducing business activity. With significant relaxations in lockdown and business supplies picking up, the collections should see a definite uptick in the coming months, experts said. The gross GST revenue collected in the month of June 2021 is ₹92,849 crore, of which Central GST is ₹ 16.424 crore. State GST is ₹20.397. Integrated GST is ₹49,079 crore (including ₹25,762 crore collected on import of goods) and Cess is ₹6,949 crore (including ₹809 crore collected on import of goods), the finance ministry said. The mop-up in June 2021 is 2 per cent higher than ₹90,917 crore collected in June 2020 GST collection had remained above the ₹1 lakh crore mark for eight months in a row and was ₹ 1.02 lakh crore in May. ## Rural India sinks deeper into debt as Covid wipes out work

Lucknow, July 6: Asha Devi doesn't remember how many meals she has skipped as she struggles to feed her family of seven in a remote corner of northern India where the novel coronavirus is compounding old problems of rural debt and poverty.

Devi, 35, had to mortgage her land for a 20,000 rupee (\$270) loan and six month on, as the money runs out, she has stopped buying milk, halved her use of cooking oil and can afford lentils only about once every 10 days. With her construction worker husband jobless, she's facing going

deeper into debt to get by. "Sometimes I go to sleep hungry. Last week, I think I went to bed hungry at least twice but I can't remember," Devi told as she wiped away tears with her threadbare sari outside her mud house in her village in Uttar Pradesh state.

Prime Minister Narendra Modi's government has promised free foodgrains for the poor but the rations are limited and not enough for the family, Devi said.

The coronavirus and a lockdown aimed at stopping it last year saw millions of people thrown out of jobs in cities and towns and forced back to their villages, and ever higher levels of debt. Interviews with 75 households in

a cluster of eight villages in India's most populous state showed household incomes have slumped nearly 75% on average. Almost two thirds of the households have taken on debt. Devi's husband used to have a job in construction in the more prosperous state of Punjab to the northwest, which kept the family going. Now the job has gone and he's back home and struggling to find work.

Others like him who have lost jobs crowd around a brick kiln near their village every day hoping for work.

### HOLDING BACK RECOVERY

Big debt and low income in the countryside will hold back any economic recovery the government is trying to generate and also



dent private savings and investment for longer than expected, economists say.

"It will have a huge impact and prolong the recovery process. Private consumption and investments both will be hurt. There is merit in finding ways to put money in the hands of the people," said N.R. Bhanumurthy, economist and vice chancellor at Bengaluru-based B.R Ambedkar School of Economics. India's gross domestic product fell by a record 7.3% in the year that ended on March 31. The government has forecast 10.5% growth for 2021/2022 but a second wave of the pandemic has dented expectations and several economists have cut their forecasts. The poor have especially been hit hard.

The Reuters investigation showed most of the 75 households in the Uttar Pradesh cluster, a combined 518 people, have taken out total debt of 6.12 million rupees (\$82,250),

more than 80% of which remains unserviced, the householders said.

Borrowing has risen by three times since the pandemic hit in March 2020 and about half of that was taken out the past six months, the survey found.

With no jobs or with bread-winners sick, the cumulative monthly income of the 75 households has dropped to about 220,000 rupees (\$2,960) from 815,000 rupees (\$10,960) before the pandemic.

"Almost everyone is in debt in this village ... unemployment is the biggest problem," said 55-year Komal Prasad, a former headman of Gauriya, a hamlet in the cluster with a population of just over 2,000 people. Only about 30% of the people in Gauriya had a job or were looking for work, many fewer than before, villagers said.

Juggi Lal, a 35-year-old farmhand, said she was struggling to buy medicine for her disabled husband because there was no work and she owed 60,000 rupees (\$806) to a moneylender. "Every morning I wake

up thinking what work will I get, how will I get through the day?" Rural unemployment rate, which used to hover around 6% before the pandemic, rose to 8.75% in June, according to the Mumbai-based Centre for Monitoring Indian Economy.

### **RIPPLE EFFECT**

The mix of lower incomes, higher debt and rising prices of staples is dampening demand in the countryside where two-thirds of Indians live. Sales of everything from biscuits, tea and lentils to auto parts have taken a hit, vendors say. Some have shut down shops that their families have run for generations.

Gosh Mohammed, 43, used to sell up to 8,000 rupees (\$107) of groceries a day before the pandemic. Now it's down to 1,000 rupees (\$13.5) a day. He has taken 60,000 rupees worth of goods from a wholesaler on credit but hasn't been able to pay it off for six months. "I never used to take goods on credit becausebuying with cash gets us more of a discount," Mohammed said.

## Barcelona 'can't register signings'

Barcelona, July 6: Barcelona's problems seem to be unending as they are reportedly unable to register their new signings - Memphis Depay, Eric Garcia, Sergio Aguero, and Emerson - due to the financial mess they are in. The same goes for Lionel Messi and his new two-year contract.

The latest update came from Ruben Uria and Adria Soldevila at Goal Espana who've had an indepth look at Barca's finances and found some "disturbing" results. The report even describes the club's finances as "a horror movie."

Barca now need to cut the wage bill by 200 million euros to comply with La Liga's salary cap and be able to register the new signings. Konrad de la Fuente, Jean-Clair Todibo, Francisco Trincao have all gone. Junior Firpo's move to Premier League side Leeds United was also made official Tuesday.

However, more departures are needed with "extreme urgency." Three players that the Catalans are desperate to get rid of are Samuel Umtiti, Miralem Pjanic, and Philippe Coutinho. However, the club is struggling to find any takers because of their huge wages. There's also another problem

too. Offloading the trio would also only cut 64 million euros off the wage bill which, added to the recent departures of Konrad, Todibo, Trincao, Junior & Matheus, would only make a total of saving of 89.7m euros. That would still not be enough, as only 25 per cent could be reinvested in new signings and registrations to comply with La

Liga rules. All of which means more players may need to go. There are already whispers that Barca are willing to sell Antoine Griezmann, while those rumors about PSG and Manchester City being keen on Messi seem to be on the way back.

Dubai, July 6: India skipper Mithali Raj Tuesday reclaimed the number one spot in the women's ODI rankings after more than three years following a stellar show in the three-match series against England.

India lost the series 1-2 but the 38-year-old Raj hit a half-century in each of the contest. She struck 72 and 59 in the first two ODIs and then guided India to a four-wicket victory in the final match of the series with an unbeaten 75, gaining four spots to reach the top of the ladder. She last occupied the top spot in

February 2018. The first time she reached No.1 position was in April 2005 after scoring an unbeaten 91 against New Zealand at the World Cup in Potchefstroom and the difference of more than 16 years at No.1 is the largest for any woman batter.

England's Janette Brittin was No.1 for the first time in 1984 and the last time in 1995, while New Zealand's Debbie Hockley is the only other female batter to have been No.1 more than 10 years apart – first achieving the feat in 1987 and for the final time in 1997. Deepti Sharma is up one place to 12th after finishing with figures of three for 47 in the final match.

Virus outbreak forces England to select new team for Pak ODIs

London, July 6: England was forced to select a completely new group of players and management Tuesday for the ODI series against Pakistan after the coronavirus infected three players and four members of staff.

The initially selected squad went into isolation following the results of tests taken Monday, a day after the team's last ODI against Sri Lanka in Bristol. The names of those who tested positive have not been disclosed. The remainder of the group were identified as close contacts.

The three ODIs and three T20Is against Pakistan, starting Thursday with the first ODI in Cardiff, were still going ahead and at the same venues.

Ashley Giles, director of England's men's cricket, said he was confident there had not been a breach of coronavirus protocols in the squad but that it was a natural consequence of restrictions being slightly eased around the squad in line with general society, despite cases rising in England because of the delta variant.

The players, for example, have been staying in shared hotels as op-

posed to living in strict bio-secure bubbles like last summer.

"Given this variant, which is clearly more infectious, the risks of us catching an infection was going to go up," Giles said on a video call.

"It's a reminder of what this can do a team, and a sports team in particular, right now when we are sort of living at a different rate to society. We are almost misaligned, or at odds, with how society is operating. And that is particularly dif-

### ficult when you know one case can shut you down, let alone seven.'

England's revised, hastily assembled ODI squad includes nine new caps and will be captained for the first time by Ben Stokes and coached by Chris Silverwood, who had been due to take some time off during the white-ball series but has been pressed back into action. After 10 days of isolation, the initial squad will be back in time to play the T20 series, which starts Julv 16.

Most of those who tested positive are without symptoms, Giles said, but some have minor; flu-like symptoms. All players in the initial squad received at least one vaccine jab, but not everyone was fully vaccinated.

The new 18-man squad and staff drafted in will need to submit negative tests and complete "bridging protocols" before joining the squad in Cardiff.

New Delhi, July 6: Bhubaneswar has been dropped as venue for the 2022 Women's Asian Cup football tournament along with Ahmedabad as Mumbai and Pune will host the entire event. Asian Football Confederation (AFC) took the decision to minimise the travelling time for participants and ensure an 'optimum environment' for a biosecure bubble.

The Mumbai Football Arena at the Andheri Sports Complex and the Shiv Chhatrapati Sports Complex in Balewadi, Pune have been chosen as the new venues.

"The decision was confirmed taking into careful consideration the existing challenges caused by the COVID-19 pandemic," the AFC stated in a press release.

The body said it was part of "efforts to minimise the travelling time for teams and officials between the venues, whilst ensuring the optimum environment to implement the Bio Medical Bubble for the benefit of all stakeholders.'

"The 37,900-capacity DY Patil Stadium in Navi Mumbai will remain as one of the three stadiums that will stage the AFC Women's Asian Cup India 2022 which is on schedule to take place from January 20 to February 6, 2022," the AFC said.

Speaking about the change in venue, President of the All India Football Federation (AIFF) and Chairman of the Local Organising Committee, Praful Patel said. "As the situation evolved, we had to adapt and the need was to create a bio-secure bubble."

"Hence, we chose Mumbai, Navi Mumbai and Pune, venues in close 🛁 geographical proximity with stadiums that have previously hosted major football competitions.'

Patel also thanked the governments of Odisha and Gujarat, states that were slated to host the tournament previously.
