2 injured jawans airlifted to AIIMS

Bhubaneswar, July 10: Two security personnel of Special Operation Group (SOG), the elite paramilitary unit of the state police, Saturday sustained severe injuries during an exchange of fire with the Left Wing Extremists in Uma forest near Boudh-Kandhamal border. According to sources, the condition of both the jawan is stable. A special team of doctors has been formed to treat the injured jawans at

The gun battle broke out early in Saturday morning when the security forces, including the SOG and District Voluntary Force (DVF), launched a combing operation in the area on the basis of specific information about the presence of top Maoists.

The personnel from the Central Reserve Police Force whisked away the injured jawans from the spot where the operation was going on to a safer place. Later, Director General of Police, Abhay who was on his way to undivided Koraput district to review anti-Naxal operations airlifted the iniured iawans to AIIMS Bhubaneswar. Abhay cancelled his visit midway and went Kandhamal to rescue the jawans

The IAF helicopter called to airlift the jawans returned from Mahasamund in Chhattisgarh due to inclement weather.

Speaking on the media, DGP said, "Today morning, there was an exchange of fire between the Odisha police's SOG jawans and Maoists under Gochapada PS of Kandhamal district. Two of our jawans have been injured and we received information that some Maoists were also injured.'

Abhay thanked the BSF pilot, the medical officer of Kantamal PHC and CRPF jawans for their services to

save the jawans. "I want to thank the BSF and their pilot. The chopper was not on duty for this service, it was engaged for a tour programme of Odisha Police to Malkangiri and Koraput," he said.

An Indian Air Force helicopter was also requisitioned but could not make it because of bad weather. However, the BSF pilot immediately took an alternative route and landed at a very small place named Padelpada and successfully airlifted the injured jawans,"

the DGP informed.

On the other hand, top police sources told **Orissa POST** that the security forces suspect the presence of more than 15 ultras, including some top Maoist cadres, at the spot during the exchange of fire. The actual casualties among the ultras could be established only after the end of the gun battle which is still on till the last news

Lucknow, July 10: According to a draft of the proposed population control Bill, anyone violating two-child policy in Uttar Pradesh will be debarred from contesting local bodies elections, from applying for or getting promotion in government jobs, and receiving any kind of government subsidy. The Uttar Pradesh State Law

Commission (UPSLC) states that the provisions are part of the draft titled The Uttar Pradesh Population (Control, Stabilisation and Welfare) Bill, 2021. The UPSLC website says, "The

State Law Commission, UP is working on control, stabilisation and welfare of the population of the state and has prepared a draft Bill."

Suggestions have been invited from the public to improve the draft Bill and July 19 is the last date for it.

Listing incentives for public servants who adopt the two-child norm, the draft Bill says, "Public servants who adopt the two-child norm will get two additional increments during the entire service, maternity or as the case may be, paternity leave of 12 months, with full salary and allowances and three per cent increase in the employer's contribution fund under national pension scheme.



A State Population Fund will be constituted for the purpose of implementation of the Act.

Listing the government's duties, the draft Bill says that maternity centres will be established at all primary health centres. The centres and NGOs will distribute contraceptive pills. condoms, etc, spread awareness about family planning methods through community health workers and ensure mandatory registration of pregnancies, deliveries, births and deaths

It seems that the two-child policy has become the norm with the BJP. A few days back, the Assam government had also announced the two-child policy for the state saving that anyone violating the norm would not be entitled to government jobs or promotions, taking part in local elections and government subsidies. Political observers are of the view that gradually this policy may be implemented in all the BJP-ruled states.

Speaking at a webinar organised by the Centre for Science and Environment (CSE) Friday, Swaminathan said the WHO is reviewing Covaxin as its manufacturer Bharat Biotech is now uploading its entire data on the health body's portal. According to WHO guidelines, EUL is a procedure to streamline the process by which new or unlicensed products can be used during public health emergencies.

'There is a process to be followed for EUL and pre-qualification of vaccines under which a company has to complete phase 3 trials and submit the whole data to the regulatory department of WHO which is examined by an expert advisory group, Swaminathan said. "The completeness of the data,

which includes safety and efficacy



and also the manufacturing quality, standard is provided. So, I expect that Bharat Biotech has already submitted data and in four to six weeks there will be a decision on its inclusion," Swaminathan added. At present, the WHO has approved vaccines by Pfizer/BioNTech, Astrazeneca-SK Bio/Serum Institute of India, AstraZeneca EU, Janssen, Moderna and Sinopharm for emergency use.

"We currently have six vaccines approved with EUL and have recommendations from our Strategic



Advisory Group of Experts (SAGE). We continue to look at Covaxin. Bharat Biotech has now started uploading their data on our portal and that is the next vaccine that will be reviewed by our experts committee." the chief scientist said. She also mentioned the WHO Research and Development Blueprint prepared in 2016, shortly after the Ebola outbreak, in which a research roadmap for diseases with pandemic potential was laid out.

"I want to mention the Research and Development (R&D) Blueprint. I

think we need to think about how we can do better in the future in terms of development of not just vaccines but drugs, diagnostics and ensuring equitable access. This blueprint was developed after the Ebola outbreak and essentially it laid out a research roadmap for diseases which have pandemic potential," she said. "So, when the roadmap was developed in 2016, it mentioned 'Pathogen X' in it which showed that we were anticipating a pandemic, which is now COVID-19," she added. Swaminathan also said the roadmap

essentially laid out the steps in terms of developing target product profiles like standards for vaccines, diagnostics regulatory standards, trial designs, and trial simulators.

"This pre-thinking helped because WHO was able to bring together scientists, researchers, academics and companies at the beginning of last year to develop a research roadmap for COVID," she said. At present, there are 105 candidate vaccines in clinical evaluation out of which 27 are in phase three or four, she said.

There are another 184 candidate vaccines in preclinical evaluation. Most of the vaccines are designed for a two-dose schedule, she added.

New Delhi, July 10: Petrol price Saturday crossed the Rs 100-per-litre mark in some places in Uttar Pradesh, Chhattisgarh and Nagaland after fuel prices were hiked yet again.

Petrol price was hiked by 35 paise per litre and diesel by 26 paise, according to a price notification of stateowned fuel retailers. This took fuel prices across the country to a fresh high.

In Delhi, petrol price rose to ₹100.91 a litre and diesel to ₹89.88 per litre.

For the second consecutive year, the state government has restricted people's participation and large gathering in the Rath Yatra (chariot festival) in the interest of public health due to the prevailing Covid-19 pandemic.

The administration has also announced a 48-hour curfew to stop any congregation. The restrictive measure will be imposed at 8 pm July 11, a day before the Rath Yatra, and continue till 8 pm July 13.

Puri Collector Samarth Verma on Saturday said that the owners of hotels and lodgings have been asked to ensure that no tourists stay put in the town during the Rath Yatra. Private guest houses of various companies and corporate houses have also been given similar instructions, he said.





Shacks at 6 beaches on the anvil



Bhubaneswar, July 10: Like Goa, tourists visiting Odisha beaches will very soon enjoy the best of food, chilled beverages, music and sea, all at one place.

Accordingly, the state government has decided to introduce the facility of beach shacks at six beaches. The Odisha Tourism Development Corporation (OTDC) has invited applications for the operation of shacks in six major beaches of the state, official sources said Saturday.

This will not only attract tourists from outside Odisha, but the local tourists visiting the beaches will also have fun there. The beach and gushing waves This will not only attract tourists from outside Odisha, but the local tourists visiting the beaches will also

shacks will have a refreshing ambience along with delectable food, and gushing waves, state tourism secretary Vishal Dev told IANS. Initially, shacks have been planned in six locations, which

will be increased later, he said. The government has decided to allow five shacks on the Puri-Konark marine drive in Puri district and five others in Gopalpur

beach in Ganjam district. Similarly, three shacks will be opened on the Talsari-Udaipur beach front in Balasore district while the same number of shacks will come up on the Paradip sea

beach in Jagatsinghpur district. The Chandipur beach in Balasore district and Pati Sonapur

least two shacks each.

The Tourism department, in consultation with the Revenue and Forest departments, is identifying suitable land for the shacks, which will be allotted on lease basis for a period of three years.

The state government will provide common infrastructure such as power, water and sewerage facilities to the beach shacks which are proposed to be developed in a cluster in each of the locations.

For tourism promotion, serving liquor in beach shacks is now allowed under the Excise Policy, 2021. The OTDC will obtain a licence from the Excise department for the selected operators for each location, subject to payment of annual fee, licence fee and other rentals.

The selected operators will have to develop the beach shacks at their own cost. They have to ensure that the staffers engaged for the purpose are well trained, polite and free from communicable diseases. The operators have been asked to engage at least 75 per cent manpower from the local community so that locals can get employment.

If the quality of service is found unsatisfactory, the operator will be instructed to take corrective measures. Further, if the service quality is found to be unsatisfactory repeatedly, the operator will not be allowed to operate, the sources said.

Male sterilisation in state abysmally low at 0.2 pc

ONUS OF CONTRACEPTION MORE ON WOMEN AS FEMALE STERILISATION AND PILLS OCCUPY A LION'S SHARE OF FAMILY PLANNING PROCEDURES

Bhubaneswar, July 10: Family planning in India has always been a major concern for female health which the government and development agencies have tried to work on. Data shows that male sterilisation in the state account for a meagre 0.2 per cent which is a cause of concern.

When it comes to Odisha, the government data on family planning and contraceptives claim that the onus on family planning had always been more on women than on men.

According to the latest data from the state government, 28.2 per cent of contraception share is from female sterilisation while 12 per cent is from the consumption of oral pills. Usage of intra-uterine devices (IUDs) among women also accounted for around 1.1 per cent of the contraception techniques. Moreover, 3.4 per cent of the total studied contraception interventions included use of condoms.

What is more significant is that male sterilisation in the state stood at a meagre 0.2 per cent. According to experts, sterlisation of women

is more complex than that of males. "In government setups, surgeries are conducted free of cost in government hospitals. We also provide incentives to persons coming for such surgeries. Males get Rs 2,000 while females get Rs 1,400 as incentives. Grassroots workers who encourage people to go for the surgery also get incentives. However, male sterlisation is simpler while female sterlisation is more complex and involves more incision, said Dr Muralidhar Padhy, additional director (Maternal Health)

of the state Health department. With passage of time and advancement of technology, sterilisation techniques have also improved. Under the female sterilisation surgeries, their fallopian tubes (where fertilisation takes place) are clipped to check pregnancies.

"There are several contracep-

tion methods for women. Female sterlisation (vasectomy) is a permanent solution wherein the fallopian tubes are clipped through surgeries. With the advent of laparoscopic surgeries, these have also become minimally invasive wherein a patient undertakes the procedure and goes home the same day with minimum cuts and faster recovery," Dr Abhipsa Mishra, a gynaecologist from the city, said.

Studies said besides contraception methods, several couples refrain from family planning. A study on contraceptive use among postpartum women in parts of Odisha conducted by scholars of All India Institute of Medical Sciences (AIIMS), Bhubaneswar and Kalinga Institute of Medical Sciences (KIMS) was published in International Journal of Recent Scientific Research. It claimed that merely 20.4 per cent of studied 12,500 population used contraceptives for birth control.

The Health department said that all the stertilisation surgeries like vasectomy (males) and tubectomy (females) are done free of cost at government hospitals in the state.

ILS decodes genome of salt-secreting mangrove

New Delhi/Bhubaneswar, July 10: Scientists have reported, for the first time, a reference-grade whole genome sequence of a highly salt-tolerant and salt-secreting truemangrove species 'Avicennia Marina', the Department of Biotechnology said Saturday.

The genomic resources generated will pave the way for researchers to study the potential of the identified genes for developing drought and salinity tolerant varieties of important crop species of the coastal region that is significant for India with 7,500 kilometres of coastline and two major island systems, it

Mangroves are a unique group of species found in marshy intertidal estuarine regions and survive a high degree of salinity through several adaptive mechanisms. They are a critical resource for the coastal region and are of great ecological and economic value.

They also form a link between marine and terrestrial ecosystems. protect shorelines, and provide habitat for a diverse array of ter-



restrial organisms.

Avicennia Marina is one of the most prominent mangrove species found in all mangrove formations in India. It is a salt-secreting and extraordinarily salt-tolerant mangrove species that grows optimally in 75 per cent seawater.

It is among the rare plant species which can excrete 40 per cent of the salt through salt glands in the leaves, besides its extraordinary capacity to exclude salt entry to

This study, conducted by Department of Biotechnology (DBT), Institute of Life Sciences, Bhubaneswar in collaboration with SRM Institute of Science and Technology, Tamil Nadu has been published in the recent issue of the Nature Communications Biology. It reports the assemblage of a 456.6 Mb (megabase) of the estimated 462.7 Mb Avicennia Marina genome (98.7 per cent

This study employed the latest genome sequencing and assembling technologies, and identified 31,477 protein-coding genes and a "salinome" consisting of 3,246 salinity-responsive genes and homologs of 614 experimentally validated salinity tolerance genes. The study reported identification of 614 genes, including 159 transcription factors, which are homologous to the genes that were functionally validated for salinity tolerance in transgenic systems.

Puri, July 10: Parasmani Devi, the last surviving 'devadasi' of the Srimandir, died due to old-age related ailments Saturday, temple sources said. She was 90.

Parasmani lived in a rented house in Balisahi area of the temple town with people's support as the Devadasi system had ended at the 12th-century shrine decades ago.

Devadasis were married to Lord Jagannath and accepted him as the "divine husband", and they remained spinsters throughout their lives. The Devadasi system at the temple gradually ended after the Odisha government took over the administration of the shrine from the Puri royal family in 1955 through an Act. There were two types of devadasis in the temple - dancers and singers.



devotional songs like Geeta Govinda during the bed-time of the presiding deities. Parasmani was adopted by Kundamani Devadasi and she began her training as a devadasi at the age of seven.

According to the temple's Record of Rights (RoR), there were about 25 devadasis in Puri about 100 years ago. while the Orissa Gazette of 1956 lists nine devadasis and 11 musicians at the temple. Till 1980, only four deHarapriya, Kokilaprava, Parasmani and Sashimani. While the others had died, Parasmani, who had worked for around eight decades, continued to sing devotional songs at the temple despite derecognition of the devadasis. Earlier, devadasis had specific

roles during the Nabakalebara festival (rituals associated with the change of wooden bodies of deities). They became widows as per tradition and again wore vermilion after the new idols were worshipped.

Ahead of Lord Jagannath's Nabakalebara in 2015, Sashimani died at 92. She had served as a devadasi since the age of seven and performed her role during the Nabakalebara festivals held in 1977 and 1996. Parasmani's adopted son Prasanna Kumar Das lit her funeral pyre at Swargadawar crematorium here.

58 FRESH DEATHS TAKE COVID TOLL TO 4,534

Bhubaneswar. July 10: Odisha's Covid-19 tally Saturday surged to 9,37,470 after 2,334 more people tested positive for the infection, while 58 fresh fatalities pushed the toll to 4,534, a Health department official said.

Of the 2,334 new cases, 1,342 were recorded in quarantine centres and 992 during contact tracing, the official said. Khurda district, of which Bhubaneswar is a part, reported the maximum number of new cases at 380, followed by Cuttack at 371, and Kendrapara at 196. Eight of the state's 30 districts reported new cases each in triple

Eleven fresh fatalities were reported from Khurda, seven each from Bargarh and Puri, six each from Ganjam and Sundargarh, four from Sambalpur, three from Kendrapara and two each from Cuttack, Dhenkanal, Keonjhar and Naygarh.

One each succumbed to the infection in Angul, Gajapati, Jajpur, Jharsuguda, Kalahandi and Mayurbhanj. This apart, 53 Covid-19 patients in the state have died due to comorbidities.

Amid allegations that the state government was suppressing casualty figures, the Health department, in a statement, said, "The list does not reflect deaths that have occurred on a particular day. It gives details of past deaths for which the audit process has been duly completed and the cause identified as Covid-19."

The Health department has written to all district Collectors and municipal commissioners, asking them to personally monitor and ensure vaccination of inmates at mental health institutions.

'Odisha to become a surplus state in fish production'

Pradhan said steps are being taken to help fish farmers harvest fish twice a year from their ponds like farmers cultivating paddy on their farmlands. He said that youths are being particularly motivated to take up fish farming which is going to help in raising fish production.

Incentives and subsidies are being given under various schemes to help farmers carry out fish farming and help in increase in fish

production in the state. Elaborating,

he said 50 per cent subsidy is being

given on fish food for production of

high quality fingerlings per hectare. Moreover, 50 per cent subsidy is also given on fish food and on infrastructure development to farmers buying fish from CIFA and NFDB for production of fish. This apart, the government is also providing various facilities to the fish farmers under various schemes.

He said the state government aims to increase the per hectare fish productivity in the state to 15 tonne which currently lies at only 4 tonne. The state government has taken up various schemes with the help of World Fish Centre in Malaysia to help increase fish production in the state

JEERA BRIDGE MISSES DEADLINE, STOKES ANGER

Bargarh, July 10: The construction of Bargarh-Ambapali Jeera bridge, which has already jumped its deadline, is yet to be completed, triggering dissatisfaction among the

The Jeera river separates Bargarh town from Ambapali. There used to be a British era bridge over the river connecting Bargarh town and Ambapali. However, the bridge had to be pulled down as it lay in a deplorable state. In its place, a new bridge was announced. At a budget of ₹14 crore, the construction of the bridge was started in 2018 and a deadline of 36 months was fixed for its completion.

The set time frame has already expired but the construction has not completed vet. In order to facilitate communication between Bargarh town and Ambapali, a temporary fair weather road has been laid out. But this road is washed away every rainy season. The time of when it was washed away and constructed again, the connection between Bargarh town and Ambapali remains suspended. The residents of both the sides of the river apprehend that this rainy season, the road will again be destroyed in flood water, snapping the

connection. "Due to the lack of will power on the part of the administration, the construction of the bridge is get-



ting delayed. It was when the British era bridge was there many auto drivers used to earn their livelihood carrying passengers on it. With the construction work moving on at a snail's space, resentment is brewing among the local people. The administration should intervene and make sure of its early completion.

Alleging that the fair weather road is of no use, Rabindra Pujari of Ambapali said the road once gets destroyed, the connection between Bargarh and Ambapali remains suspended for three to four months. The same situation will happen this season as well. So besides taking steps for completion of the construction work, steps should also be taken for strength-

ening the temporary road. Echoing the same problem, Sibananda Matari, a Bargarh town resident, said since the day

one of the construction, people of both sides depend on the temporary road. During the period when the connection between Bargarh town and Ambapali remains snapped, people have to make a detour, travelling an extra five to seven kilometers to reach the other side. So. administrative officials and people's representatives should give priority to the

completion of the bridge. When contacted. Debesh Acharya, Bargarh MLA, said there have been some technical faults affecting the construction work. With the faults being brought to the notice of the concerned engineer, steps are being taken to rectify those. "I feel the problems of the people. This is why I have already taken the matter up with the secretary, requesting him to take steps for early completion of the bridge," he added.

UTs allege brutal torture inside Bargarh sub-jail

Bargarh, July 10: Two undertrial prisoners (UTPs) lodged in the Baragarh sub-jail sustained injury after jail officials allegedly brutally assaulted them on opposing the sub-standard food being served to them, a report said. Mother of one of the accused, Sunita Gupta, has alleged that her son was beaten so severely that he fainted inside

She has alleged that the jail authorities are serving sub-standard food. Her son lost his sense after being brutally assaulted by nine jail officials when he opposed serving of sub-standard food to him. When her son fainted, they examined him using a machine to find out whether he was dead or alive. She alleged that her son is now in a critical condition.

She claimed that her son would be punished as per law if he has committed any offence. However, jail authorities have no rights to torture him inside the prison, she said. However, jail officials straightaway rejected the allegation leveled by the mother of the undertrial prisoner. They rather accused the prisoners of getting involved in nuisance and causing damage to jail properties.

They alleged that both the accused misbehaved with jail staff and guarreled with other inmates. They have also beaten up other inmates and left them injured without any reason. The allegation of sub-standard food is completely false as the two have been caught earlier stealing snacks stored for other inmates while the food provided to prisoners may be examined to assess quality, a jail official said.

Woman jumps to death from 3rd floor of Rayagada DHH

Rayagada, July 10: A 28-year-old woman undergoing treatment at the district headquarters hospital here allegedly committed suicide by jumping off from the 3rd floor of the hospital building Saturday morning.

The deceased was identified as Rajani Meleka, 28, a native of Tumbiguda village under Town police station in Rayagada.

According to reports, the deceased was admitted to the hospital July 7. Rajani was undergoing treatment on bed no-35 at the Medicine ward on the third floor of the hospital. She was suffering from high fever and mouth ulcer.

Rajani took the extreme step when she went to the toilet at around 4 am on the same floor and



breaking open the glass panes of the window in toilet.

She dropped on the ground with a thud when security personnel and some hospital staff

rushed in and found her lying dead in a pool of blood. The exact cause behind the in-

cident is yet to be ascertained while it is suspected that the woman took the extreme step as she was mentally disturbed. On being informed, ADMO Dr

Baradakanta Mishra reached the spot and informed the police. Police along with a scientific team reached the spot and began a probe into the incident. The body was sent for post-mortem and further probe is on.

An accidental death case has been registered and an investigation is underway, police said.

When contacted, the ADMO said that the actual reason behind the woman's death could be ascertained after police complete the probe.

Attack on activists

Itan Swamy, who died a few days ago after being denied bail in the Bhima Koregaon case, was a Tamilian priest who spent decades working with the Adivasis in Jharkhand. Before that he was director of the Indian Social Institute in Bangalore. So why was he in jail for an event in Pune? The Bhima Koregaon case is five separate and unrelated things. The first was an event called Elgar (or Yalgar, meaning battle cry) Parishad held December 31, 2017 in Pune. Speakers at the gathering included former high court judge BG Kolse-Patil and PB Sawant, a former Supreme Court judge. Jignesh Mewani, the independent MLA from Gujarat and Umar Khalid, the activist from JNU also spoke. Members of Kabir Kala Manch, who are artistes-activists, also participated.

The second event was the following day, January 1, 2018. This was the 200th anniversary of the Battle of Koregaon Bhima, a suburb of Pune on the Bhima river where January 1, 1818, the British defeated the remnant of the Maratha Empire. The British side had many Dalit Mahar soldiers who overpowered a larger army led by the Brahmin Peshwa.

Since 1927 when BR Ambedkar visited the village to speak of the victory, hundreds of thousands of Dalits came to Koregaon Bhima each year to gather at the obelisk raised to mark the battle. But in 2018 there had been tension because of events in the neighbouring village of Vadhu Budruk. This had to do with who had cremated Sambhaji, the son of Shivaji who was executed by Aurangzeb in 1689 near Koregaon Bhima. The Mahars claimed it was one of them, Gopal Govind, who had cremated the Maratha in defiance of Aurangzeb's orders. This offended the Marathas, who claimed two of their community had performed the rituals. Govind's tomb in Vadhu Budruk, was in the same village square as Sambhaji's. December 28 a board was placed over Govind's tomb, claiming the feat of his cremation of Sambhaji. The next day Govind's tomb was desecrated: the board was removed and the umbrella structure over the tomb was damaged. A complaint was filed by the Dalits under the Scheduled Castes/Scheduled Tribes Prevention of Atrocities Act against individuals. The Koregaon Bhima panchayat asked its residents to boycott the event of January 1 and called for shops to remain shut. That morning violence broke out between Dalits, who said they were attacked by

a group carrying saffron flags and the local Marathas, who said they had been attacked by the Dalits. One Maratha was killed. The violence spread to other towns in western Maharashtra and 300 Dalits, including some children, were held by Mumbai police.

The third event was a police complaint, filed a few days later, by a man who said the agenda of the Elgar Parishad event was "to mislead the Dalit community, to convert them to Maoist thought...and adopt the path of violence' and that "through their publications, books and speeches, they want to increase enmity in society." The man who filed the complaint, Tushar Damgude, said he followed a 'simple' rule for his Hindutva: "We should keep things which are helpful for Hindus; rest should be aban-

It was on the basis of this complaint that the police began arresting the activists, who had nothing to do with, and were not present at, the Bhima Koregaon. The fourth event was a report produced by an RSS organisation called the Forum for Integrated National Security, whose secretary general, Seshadri Chari, was on the BJP's national executive committee.

This report said there was a Maoist strategy to lure people into joining 'mass organisations' concerned about such issues as caste, justice and equality. Such organisations would then help Maoists recruit for the final armed struggle against the State, the report, released March 9, 2018 said.

Another report by the same author was submitted to then Maharashtra Chief Minister Devendra Fadnavis in April. In May, the UAPA law was added to the Bhima Koregaon case. June 6, the Maharashtra police arrested five people including Dhawale of the Republican Panthers, lawyer and Dalit activist Surendra Gadling, scholar Mahesh Raut, who worked for Adivasi rights, assistant professor of English at Nagpur University Shoma Sen and Rona Wilson of JNU who worked with the Committee to Release Political Prisoners. They were described by the police as the "top brass of the urban Maoists.

The police say they found a letter in Wilson's house dated July 2017 which said: "Comrade Kisan and few other senior comrades have proposed concrete steps to end Modi-Raj. We are thinking along the line of another Rajiv Gandhi type incident.

On the basis of this material the police arrested Sudha Bharadwaj, who studied mathematics at IIT Kanpur and gave up her US citizenship at age 18, Gautam Navlakha an author who also wrote for the Economic and Political Weekly, Anand Teltumbde, assistant professor at the Goa Institute of Management and married to a granddaughter of Ambedkar, Arun Ferreira, a lawver who was defending the accused in this case. Vernon Gonsalves, a professor of business management and economics at Ruparel College and HR College of Commerce and Economics, Varavara Rao, an author and poet who had been a lecturer of Telugu literature, Hany Babu, a professor of linguistics at Delhi University, three members of the Kabir Kala Manch, Sagar Gorkhe, Jyoti Jagtap and Ramesh Gaichor, and Stan Swamy, the 83-year-old Jesuit and theologian.

None of them had anything to do with the violence at Bhima Koregaon, where they were not even present. The case is said to be sensitive because of the allegation of the assassination plot, but trial has not started. Last year, the BBC carried a report on Stan Swamy under the headline "The oldest person to be accused of terrorism in India.'

PROMOTING HEALTHY AGEING

he proposal of observing a healthy ageing decade from 2021 to 2030 was endorsed by the 73rd World Health Assembly August 3, 2020. It was also welcomed by the UN General Assembly December 14, 2020 through a resolution, leading to the proclamation of a UN Decade of Healthy Ageing (2021-2030).

Population ageing and consequent demographic transition are complex realities. As per estimates, the global population of people over 60 years of age which is currently around 1.1 billion will grow to around 1.4 billion by 2030, and to about two billion by 2050. Between 2015 and 2050, the proportion of 60+ population is expected to rise from 12 per cent to a staggering 22 per cent. Also by 2050, people above 60 years will outnumber those below the age of 15, which will happen for the first time in history.

In India, the transition has been taking place at a much rapid pace. The 104 million-population of older people from the 2011 Census is estimated to triple by 2050. While for a county like France, it took about 150 years for the aged population's proportion to rise from 10 per cent to 20 per cent, a similar rise in India would occur in about 20 years

Out of those older people, large numbers, particularly in lower and middle income countries live under severe poverty and with no or limited access to basic health services and social protection benefits. While older people living longer is an opportunity for themselves and for society, there is not much evidence suggesting older people are currently living healthier lives than their previous generations did.

Inequity of access to healthcare for older people is mainly caused by attitudinal and behavioural reasons such as ageism and stigma, as well as by physical factors such as the remoteness of rural population settlements and limited outreach of services in those areas. These pre-existing inequities have been growing rapidly and widely as the Covid-19 pandemic continues to spread across the world,

and are clearly stark in older women, in older people with disabilities and in older people living in remote and rural areas. This significant demographic transition calls for an unprecedented need of an age-friendly and responsive healthcare system and a range of coordinated services to address the complex needs of an ageing population. The UN decade of healthy ageing is an initiative led by the World Health Organisation (WHO) and is a global collaboration that will bring together governments, civil society organisations (CSOs), international agencies, professionals, academia, the media, and the private sector, and will continue its interventions in alignment with the last 10 years of Sustainable Development Goals (SDGs).

To foster healthy ageing and improve the lives of older people, the decade of healthy ageing will focus on four action areas. The first is to create and strengthen agefriendly environments by removing physical and social barriers and by converting environments into better places to live and to age. The second is to combat ageism. Older people, despite their significant contributions to society, are overlooked and neglected with an 'ageism' bias. There is a need of addressing issues of stereotyping, prejudice and discrimination related to old age.

The third is to provide inte-

grated care. All older people should have non-discriminatory access to integrated care which should include, but is not limited to, preventive, promotive, curative, rehabilitative, palliative, and 'end of life' care - which must be safe, affordable and of good quality.

The fourth is to support longterm care. With a significant decline in mental and physical capacities, many older people are unable to live an independent life or to actively participate in society. Hence, access to good long-term care service is essential to maintain their functional ability, to ensure that they enjoy basic human rights and live a life of dignity.

The decade of healthy ageing action plan has been drafted by the WHO which has 10 years of concerted, catalytic and sustained collaboration. Older people themselves will be at the centre of this plan, and it will bring together governments and all other stakeholders together to improve the lives of older people, their families and their communities. It is the second action plan of the WHO global strategy on ageing and health, building on the United Nations Madrid International Plan of Action on Ageing (2002), and is strongly aligned with the timing of the United Nations Agenda 2030 on Sustainable Development and the SDGs.

With a global framework for the decade of healthy ageing, country-level mechanisms are being

formed for direct implementation of planned interventions. The WHO is working in that direction with global experts and countrylevel stakeholders. It is recognised that a focus on some key areas would enable the progress of the healthy ageing decade. These include - engaging older people and bringing out their voices, leadership development and capacity building among stakeholders across all sectors, connecting stakeholders, and strengthening research, data collection and innovation.

In India, several key initiatives have been taken up in the last couple of decades or so to address the challenges of population ageingdrafting a National Policy for Older Persons, introduction and adoption of the Maintenance and Welfare of Parents and Senior Citizens Act of 2007, and formulation of National Programme for Health and Care of the Elderly (NPHCE) and National Old Age Pension Programme. These national-level initiatives will need to be scaled up across the country in the decade of healthy ageing, in partnership with various stakeholders.

CSOs are well placed to play an important role in the decade of healthy ageing action in India. There is a need for forming and strengthening multi-sectoral partnerships in which CSOs can play the last mile delivery role. Initiatives of CSOs targeted at older people in the spheres of community-based groups' formation and capacity building, promotion of self-care and home-based care, and on enhancing food, nutrition and water security may be scaled up. Civil society has both the credibility and capacity of bridging the inequities and ensuring that older people are not left behind in health and social protection services.

SDG3 intends to ensure healthy lives and to promote well-being for 'all' at 'all ages', and to realise the progress on this goal; older people's health needs must be addressed comprehensively. The decade of healthy ageing is a great opportunity

Statelessness in a pandemic

TODAY, AN ESTIMATED 15 MILLION PEOPLE ARE STATELESS, **AND TENS OF MILLIONS MORE ARE AT RISK OF LOSING THEIR NATIONALITY**

Muslim woman, was born in India to Indian parents. She has lived in the state of Assam all her life. But, seven years ago, she was declared a foreigner, arrested, and detained. While she languished in detention, her distraught eldest son died by suicide. Despite this devastating personal tragedy, and the barriers created by poverty and illiteracy, her Bengali Muslim husband and the rest of her family continued to fight for her release until, almost five years after she was first detained, Maijaan was freed. But her status is far from secure.

Maijaan is a victim of a multiyear, politically motivated project to update the National Register of Citizens in Assam in a way that excludes huge swaths of the population, mostly Muslims and people of Bengali origin. In 2019, when the NRC was 'finalised,' 1.9 million people were officially declared to be non-citizens, as Maijaan had been. Suddenly, they were on the brink of statelessness.

Such 'bureaucratic violence' is nothing new. From the Kurds in Syria in the 1960s to the Rohingyas in Myanmar in the 1980s, minority groups have often been targeted by ethnicity-based citizenship laws. nities probably cannot imagine having to prove their nationality to suspicious and hostile agents of the state in the country where they were born and raised. They take for granted basic documentation like birth certificates and identification cards, which can easily be presented to a questioning official.

And yet, for members of minority communities and those of migrant heritage, nationality is often tenuous, at best. Without documentation, citizenship can be nearly impossible to prove. And, as we have seen in Assam and elsewhere, it can simply be rescinded by discriminatory laws and practices.

Today, an estimated 15 million people are stateless, and tens of millions more are at risk of losing their nationality. While minorities are disproportionately affected, citizenship laws also often target women by preventing them from passing their nationality on to their children on equal terms with men; limiting their right to acquire, change, or retain their nationality; or limiting their ability to confer nationality on non-citizen spouses.

Moreover, the stateless - who already endure endemic structural discrimination - were often scapearbitrary detention and even expulsion from their own countries.

More than a year after the pandemic began, little has changed. In fact, institutional and public indifference to the exclusion of the stateless, together with structural violence toward them. continues unabated. And new challenges are emerging, such as ensuring equitable access to Covid-19 vaccines.

Again, Maijaan is a case in point. She was freed because of the pandemic, which prompted the Supreme Court of India to order the release of 'foreigners' who had been detained for two or more years. But her family's meagre resources had already been depleted by costly legal fees. And, as a 'foreigner.' she was not entitled to the modest support that the Indian government provided for citizens.

Furthermore, as a condition of release. Maijaan must report weekly to the local police, so she cannot earn a living as a migrant worker like her husband. If structural discrimination pushed Maijaan to the brink of poverty, the pandemic threatens to push her over the edge - all under the looming spectre of statelessness. Maijaan's story is one of many documented in a ground-

Taijaan Nessa, a 38-year-old Members of majority commugoated, vilified, and targeted for breaking new report, "Together We Can: The Covid-19 Impact on Stateless People & a Roadmap for Change." The report is the work of a unique collaboration among a consortium of stateless activists, grassroots groups, and NGOs currently operating in 13 countries.

Grounded in the consortium members' experiences and expertise. the report highlights the pandemic's impact on stateless people's rights -including the right to nationality, documentation, and legal status: the right to non-discrimination; the right to health; and civil rights - in countries from Bangladesh to Malaysia to Montenegro.

The pandemic should spur governments, UN agencies, and international organisations to work directly with stateless people, respect their rights and be accountable to them, address the structural causes of statelessness, and ensure lasting change. The stateless people of the consortium, together with their partners, have shown how to do it. But they cannot carry the world down the right path alone.

Scientific vax policy needed

Sir, Covaxin has been found to be 77.8 per cent effective against symptomatic Covid-19 infections. The vaccine has also shown 65.2 per cent efficacy against the Delta variant of the coronavirus. Researchers said a higher vaccine efficacy against severe Covid-19 indicates that cases, which require hospitalisation and threaten to overwhelm healthcare facilities. will be markedly decreased among fully vaccinated people. But the question is can the government's immunisation policy meet the needs of the people? We need a scientific vaccine policy that is still awaited. The government relies on only two private companies -- Bharat Biotech and Serum Institute of India - which have not yet provided the government with information on their production. These two companies are unable to provide the required vaccines to India in the short-term. They also have international commitments as they have signed agreements with other countries. If the Delta Plus variant spreads in the next two months, it will become necessary to vaccinate 100 per cent of India's population which is impossible.

Sir, This is in reference to "India needs uniform civil code, says HC," **Orissa POST**, July 10. The Delhi High Court's contention stressing the need for a uniform civil code is most welcome. 

There are 34 panchayats in Chhendipada block. While Swachh Bharat Mission is yet to be implemented in four panchayats due to coal mines problems, each house hold in the rest 30 panchayats has a toilet. The District Water and Sanitation Mission (DWSM) has declared 25 panchayats as 'open-defecation-free' panchayats.

But there are many such beneficiaries in as many as 120 villages that are yet to get any benefit from the Swachh Bharat Mission. And those who have toilets under the mission alleged that their toilets are of extremely low quality. Going to describe about the condition of their toilets, these beneficiaries alleged that their toilets are in dilapidated condition, with walls of many already caved in. Due to low quality construction work, their walls collapsed within one month of their construction. They ascribed the failure of the mission to the unholy nexus between the contractors and the employees.

of these villages announcing that the villages are ODF villages. "The residents of Bahalsahi pan-

chayat have toilets under Swachh Bharat Mission. But the toilets of over 30 beneficiaries are lying halfconstructed for six months now. So they are forced to go outside for defecation," rued Durgacharan Mohapatra, a Bahalsahi resident.

Informing about the situation of his village, Mukli Pradhan, a resident of Shimilipal village, said, "Swachh Bharat Mission has not been implemented in Shimilipal village. So, they don't have the facility of using toilets in their households. To defecate, they go to open fields or farmlands, covering a distance of at least one kilometre."

the condition of Swachh Bharat Mission, general secretary, district B.IP unit, Sudeep Kumar Gadnayak said District Water and Sanitation Mission has appointed motivators to implement Swachh Bharat Mission in the villages. What makes the matters worse is that many of these motivators double up as contractors, leaving the quality of the work a lot to be desired.

Pointing out the reason why the contractors are getting away with the murder, a resident of Kathapal village, Karunakar Biswal said, "The beneficiaries are not being made aware of what should be the quality of the toilets they are getting under Swachh Bharat Mission.

The contractors are cashing in on it. Since these ignorant beneficiaries are not monitoring the construction work, it becomes easier for the contractors to take a cut of the sanctioned money.

When contacted, block development officer (BDO), Chhendipada, Sanjay Kumar Acharya said the left out beneficiaries will be included in the fresh survey. "And the people who use their toilets for different purposes and going outside for defecation are to be made aware of the benefits of using toilets," he added.

Keonjhar DD College cries for attention

Keonjhar, July 10: Once one of the most preferred institutions of the state, Dharanidhar (Autonomous) College, popularly known as DD College, has become a shadow of its past. The problem of teaching staff shortage is taking its toll on the college.

Established in 1957 as Keonjhar Science College, the college was later rechristened as Dharanidhar College after Dharanidhar Naik, a tribal leader. Standing as a mute spectator to several remarkable incidents in its journey from Keonjhar Science College to Dharanidhar (Autonomous) College, it has played a great role in shaping the future of numerous students.

For some years now, a shortage of teaching staff has been taking its toll on the institution's quality of education. The college is under Shriram Chandra Bhanj Deo University in Baripada of Mayurbhani district.

 $Investigation\,reveals\,that\,around$ 1,500 students read in Plus II Science, Arts and Commerce while around 2,000 students study in Plus III and PG courses. The college offers PG courses in Political Science, Geology, Chemistry and Commerce.

While there are four lecturers for Geology, two for Chemistry and four for Commerce, there is no permanent lecturer for Political Established in 1957 as **Keonjhar Science** College, the college was later rechristened as **Dharanidhar College** after Dharanidhar Naik, a tribal leader

Science. Guest lecturers are managing the show.

Informing about the teaching staff's strength, principal in-charge Narendra Sahu said, "There are 28 permanent lecturers against 53 posts for Plus III Science, Commerce and Arts. In place of 49 permanent lecturers for Plus II, only 22 are there. We are managing with guest faculties.

Besides the shortage of teaching staff, many posts of non-teaching staff are also lying vacant. Out of 82 posts of administrative and other employees, only 29 are there.

Moreover, the college doesn't have a permanent principal in last 10 years, except for a year in between when it had a permanent principal. It has been widely discussed

here that the college is at the mercy of guest lecturers and in-charge principals. Students' sits-in, strikes and demonstrations demanding steps to address the problems notwithstanding, the deplorable situation is still prevailing.

Man beaten to death by security guards inside RSP; video viral

Rourkela, July 10: A man was allegedly beaten to death by security personnel engaged by a private company on the premises of the Rourkela Steel Plant (RSP) in Sundargarh district, a source Saturday said.

However, the inhuman act came to the fore after a video purportedly showing some security guards mercilessly beating the youth in presence of the Central Industrial Security Force (CISF) personnel

went viral on social media Friday. The man is said to be in an inebriated condition while entering the plant.

On the other hand, Tangaripalli police have registered an unnatural death case in this connection and launched a probe. GORKHAS WELCOME GOVT'S MOVE TO CALL COMMUNITY BY PREFERRED NAME

The community also expressed satisfaction at the Cabinet decision to declare Gorkhas a 'protected class' as it will give the community members land rights, among other benefits, in tribal belts of the Bodoland Territorial Region (BTR)

Guwahati, July 10: The indige nous Gorkha community of Assam welcomed the state Cabinet's recent decision to describe its members as 'Gorkhas', saying that identifying them as Nepalis, as they had been called for many years, had made them feel like citizens of an-

The community also expressed satisfaction at the Cabinet decision to declare Gorkhas a 'protected class' as it will give the community members land rights, among other benefits, in tribal belts of the Bodoland Territorial Region (BTR).

This 'protected class' status should also be extended to areas outside the BTR, community

For years we have been demanding that our community be identified as Gorkha, Referring to us as Nepali creates a sense of alienation, as if we are from Nepal and not Indians, Harka Bahadur Chetry, chairman of the Gorkha Autonomous Council Demand Committee (GACDC), told PTI.

The demand was placed before the previous government also, during a meeting between the GACDC and then chief minister Sarbananda Sonowal, September

Among the demands we had placed before the chief minister. one was that the term Nepali be substituted with the Gorkha in all existing gazette notifications, Chetry said. The move is a welcome step in that direction, he said.

The state Cabinet meeting July 7 decided to notify Nepali Graziers and Cultivators of Assam Land and Revenue Regulation, 1886, as



Gorkha community and include it, along with some other communities, as a 'protected class' in the tribal belts and blocks in Kokrajhar, Chirang, Baksa and Udalguri districts comprising the BTR.

The community members residing there from before 2003, when the districts came under the Sixth Schedule of the Constitution, will get the benefits. Gorkhas had ceased to enjoy the benefits of the 'protected class' when these four districts came under the Sixth

The Gorkhas have also been demanding the 'protected class' status in all tribal belts and blocks created post- Independence, as they currently enjoy it only in the areas thus demarcated prior to 1947.

This notification of protection of Gorkhas should be extended to other existing tribal belts and blocks being reviewed by the government, and also to those which the government is proposing to create, Bharatiya Gorkha Parisangh (BGP) national vice-president Yam Prasad Ghimire said.

BGP Assam unit president Prakash Dahal said, It (the decision) is historic for the Gorkhas battling identity crisis for years as we were being seen as foreigners due to the use of the word Nepali.

Our forefathers were inhabitants of this land as much as were those of the other indigenous tribes and communities. But during the course of history, misguided by the governments, we came to call ourselves Nepalis, which assumed a different connotation once different countries were formed,

He claimed that the Gorkhas are a heterogeneous community formed by different tribes, many of whom have been living in Assam since, or even before, the Ahom rule started in the 13th century.

Getting the name right is a major step for ensuring the inclusion of the Gorkhas as a part of Assam, BGP state secretary and spokesper son Nanda Kirati Dewan said.

The population of the Gorkhas is about 6 lakh in the state as per the 2011 Census but the figure actually is much higher, he claimed.

These 6 lakh people are those who are enlisted as Nepali-language speakers. But the Gorkha is a heterogeneous community and formed of many tribes and subtribes, who have their own languages, like the Limbus or

Mumbai, July 10: The Maharashtra government has appointed a high-level committee under state DGP Sanjay Pandey to probe state Congress chief Nana Patole's allegation that his phone was tapped when he was MP in 2016-17 under the watch of the then BJP government led by Devendra

State intelligence department commissioner and additional police commissioner (special branch) will be part of this three-member panel, as per the order issued by the state government Friday night.

During the two-day monsoon session of the Maharashtra legislature held earlier this week, Home Minister Dilip Walse Patil had made the announcement about setting up a high-level inquiry while speaking in the Legislative

Patole had claimed that his phone was tapped during 2016-17 when he was a Member of Parliament (MP) and when the state government was headed by Devendra Fadnavis. He said his phone was tapped on the pretext that it belonged to drug-peddler Amjad Khan.

The committee would probe the case and submit its report to the legislature in three months, the order said. The terms and references for the committee are to scrutinise the cases of phone-tapping between 2015 and 2019 and find out whether there was any political motive.

If the phone surveillance was politically motivated, action will be taken, the order said.

When Patole raised the issue in the House, several members supported the need for a high-level

Patole represents the Sakoli Assembly segment in the Bhandara district of the Vidarbha region. He had earlier quit the Congress and won the 2014 Lok Sabha election on the BJP's ticket. However, he left the saffron party in 2017 citing differences with Prime Minister Narendra Modi and Fadnavis, and returned to the Congress.

Saturday, BJP MLA and former minister Ashish Shelar questioned Patole's silence for two years before raising the phone-tapping allegation against the erstwhile Fadnavis government, even as the Maha Vikas Aghadi (MVA) dispensation in the state was formed in November 2019.

The Shiv Sena, NCP and Congress and NCP are the constituents of the MVA government.

Speaking to a regional news channel, Shelar said, "Patole has levelled the allegation that his phone calls were tapped by the previous Fadnavis government. However, he has made the allegation two years after the formation of the MVA government. What was he doing in the last two years'

The BJP leader quipped that Patole keeps passing amusing com-

Guwahati, July 10: Amid opposition parties decrying the rising number of police encounters under the Himanta Biswa Sarma government, one more murder accused was killed and two alleged gania smugglers were injured as they attempted to escape from custody in separate incidents in Assam

With the fresh casualties, at least 13 suspected insurgents and criminals have been killed and dozens, including rape accused and cattle smugglers, injured in police encounters in the northeastern state since the second BJP-led government assumed power two months ago

The latest incidents took place in Chirang and Kokrajhar districts, both part of the Bodoland Territorial Region (BTR).

A person accused of the murder of a home guard was killed while attempting to escape from police custody in Chirang district.

Within 24 hrs Chirang Police cracked the case of brutal murder of Home Guard Eyad Ali. 3 persons arrested & the murder weapons were recovered

In an attempt to flee from Police custody, escaping accused Abdul Khalek sustained bullet injuries and later succumbed to his injuries, Chirang district police

In another incident, Kokrajhar district police intercepted a truck allegedly smuggling 840 kg of gania worth over Rs 2 crore, at Srirampur near the Assam-West Bengal inter-

While recovering another 10 kg of ganja, which the accused had hidden along the highway, the duo attacked the police personnel & tried to escape from the custody.

In order to prevent it, Police team resorted to control firing, in which both the accused were grievously injured, the Kokrajhar district police said in a Twitter post.

July 6, a suspected drug peddler from Manipur was critically injured when he had allegedly tried to escape from police custody near Rani in Kamrup district.

The rising number of shootout encounters in the last two months has whipped up a political furore in Assam with the opposition alleging that the police has turned trigger-happy under the Chief Minister Himanta Biswa Sarma-led regime, which assumed charge May 10.

A closure report is filed when an investigating agency believes that it does not have enough evidence to proceed against an accused.

Special Judge A T Wankhede accepted the report and directed that Rajan be 'released' as per section 169 of the Code of Criminal Procedure (release of accused when evidence is deficient).

The court also asked Rajan to furnish a personal bond of Rs 50,000. However, the gangster would not walk out of jail as he is facing numerous other cases

Special Public Prosecutor Pradeep Gharat said the Central Bureau of Investigation had filed the closure report about three months ago. Appearing through video link, 76-year-old Lakdawala told the court that he had no objection if the closure report was accepted, Gharat said, Raian's lawyer



advocate Tushar Khandare said the incident of firing on Lakdawala had taken place in suburban Bandra in 2001.

Rajan and some others were named in the case for alleged attempt to murder and also under the Maharashtra Control of Organized

card details. I tried to register his name for Aadhaar, but it used to get rejected due to the biometric issues. us in tracing his family," he added.



Delta+ Covid variant detected in Tripura, for first time in NE

Agartala, July 10: The highly infectious Delta plus variant of coronavirus has been found for the first time in Tripura after the Delta strain was detected in three northeastern states -- Assam, Manipur and Mizoram, doctors said here Saturday

Agartala Government Medical College (AGMC) Microbiology department head Tapan Mazumder said that after the samples of Tripura were tested in the National Institute of Biomedical Genomics (NIBMG) at Kalvani in West Bengal. 138 cases of Delta plus, 10 cases of Delta (plain) and three cases of UK variant were found in the northeastern state.

Majumder, who was present along with Director of Health and Family Welfare Radha Debbarma and Covid-19 Surveillance Officer Deep Kumar Debbarma said that the Delta plus strain is more transmissible and evades the body's immunity. It is a cause of concern that the Delta plus variants were found in all the eight districts of Tripura and the Delta (plain) and UK variants found in few districts, he told the media.

Majumder, who is also the Professor of AGMC, said that Delta

New Delhi, July 10: To curb noise pollution in the national capital. Delhi Pollution Control Committee (DPCC) Saturday revised the penalty for violation of noise pollution rules. It has directed the authorities to impose hefty fines for noise pollution caused by loudspeakers and public address systems.

As per a notification by DPCC, Rs 1 lakh fine will be imposed for diesel generator sets of more than 1,000 kilovolt-ampere (KVA) and Rs 50,000 for sound-emitting construction equipment without prior permission.

According to new guidelines framed the plant causing noise pollution will be confiscated.

Now if any construction equip-



ment makes noise more than the prescribed standards, fines up to Rs 50,000 will be imposed and equipment causing noise would also be seized, said the guidelines

It also recommended that people found bursting firecrackers in residential or commercial areas will be fined up to Rs 1.000. However, if the firecracker is being lit in silent zone, the fine levied will be Rs 3,000. If firecrackers are being used in

public rallies, marriage ceremonies and other religious events, a fine of up to Rs 10,000 will be imposed in residential and commercial zones and Rs 30,000 in silent zones. On August 13, 2020, the National

Green Tribunal (NGT) directed the Delhi government, Delhi Police, Delhi Pollution Control Committee (DPCC) and the Central Pollution Control Board (CPCB) to take further steps to ensure that noise pollution norms are enforced at the ground level for protection of public health and the environment.

ISRO swinging back in full action to launch GISAT-1

Bangalore, July 10: The Indian Space Research Organisation (ISRO) is getting back into launch activity fully at Sriharikota spaceport with the planned orbiting of geo imaging satellite GISAT-1 on board GSLV-F10 rocket August 12.

It's going to be only the second launch of the Bengaluru-headquartered space agency in the Covid-19-hit 2021. ISRO successfully launched PSLV-C51 mission February 28 with Brazil's earth observation satellite Amazonia-1 and 18 co-passengers, including some built by students, on board.

The 2,268-kg GISAT-1 was originally slated to be launched from Sriharikota in Andhra Pradesh's Nellore district, about 100 kms north of Chennai, March 5 last year but was postponed a day before



Thereafter the launch was delayed due to Covid-19 induced lock-

down which affected normal work. It was scheduled for March 28 this vear but a minor issue with the satellite forced its postponement.

The launch was later expected in April and then in May but the campaign could not be taken up due to lockdown in parts of the country triggered by the second wave of the pandemic.

GISAT-1 was originally slated to be launched from Sriharikota March 5 last year but was postponed due to technical reasons. Thereafter the launch was delayed due to Covid-19 induced lockdown

We have tentatively planned the GSLV-F10 launch August 12, at 05.43 am, subject to weather conditions, an ISRO official told PTI Saturday.

According to ISRO, GISAT-1 will facilitate near real-time observation of the Indian sub-continent, under cloud free conditions, at fre-

quent intervals. GISAT-1 will be placed in a Geosynchronous Transfer Orbit

by GSLV-F10 and, subsequently, it will be positioned in the final geostationary orbit, about 36,000 km above earth's equator, using its on board propulsion system.

The earth observation satellite will provide the country near realtime images of its borders and also enable quick monitoring of natural disasters.

Experts said positioning the state-of-the-art agile earth observation satellite in geostationary orbit has key advantages.




With onboard high resolution cameras, the satellite will allow the country to monitor the Indian land mass and the oceans, particularly its borders, continuously, the official said.

The third objective is to obtain spectral signatures of agriculture, forestry, mineralogy, disaster warning, cloud properties, snow and glacier and oceanography.

Beijing, July 10: The Taliban has said it sees China as a friend of Afghanistan and assured Beijing that it would not host Uyghur Islamic militants from the volatile Xinjiang province, which is a major worry for the Chinese government. according to a media report.

Beijing is concerned that under Taliban rule, Afghanistan will become a hub for the East Turkistan Islamic Movement (ETIM), a separatist outfit aligned to Al-Qaeda

which is waging an insurgency in Xinjiang. The resource-rich Xinjiang shares about 8- km-long border with Afghanistan.

Playing down China's concerns, the Taliban spokesman Suhail Shaheen said they see China as a "friend" to Afghanistan and is hoping to talk to Beijing about investing in reconstruction work "as soon as possible".

"China is a friendly country and we welcome it for reconstruction and developing Afghanistan," he said adding that If (the Chinese)



have investments, of course, we will ensure their safety, Shaheen said. Suhail also said the Taliban would no longer allow China's Uyghur separatist fighters from Xinjiang, some of whom had previously sought refuge in Afghanistan, to enter the country.

The Taliban would also prevent al-Qaeda or any other terrorist group from operating there, he said. "We have been to China many times and we have good relations with them," Suhail told Hong Kongrecalling the few meetings hosted by China in the past for Taliban delegations. China has been eying big scale investments in Afghanistan as the country has the world's largest unexploited reserves of copper, coal, iron, gas, cobalt, mercury, gold, lithium and thorium, valued at over USD one trillion. In 2011, the China National

Petroleum Corporation (CNPC) won a USD 400 million bid to drill three oil fields for 25 years, containing roughly 87 million barrels of oil.

Biden warns Putin over cyber attack from Russia

Biden reiterated that the US will take any necessary action to defend its people and its critical infrastructure in the face of this continuing challenge

Washington, July 10: US President Joe Biden has warned Russia of consequences for the ransomware attacks emanating from the country, underscoring the need for Moscow to take action against groups engaged in the crime.

Biden spoke with Russian President Vladimir Putin Friday about the ongoing ransomware attacks by criminals based in Russia that have impacted the US and other countries around the world, the White House said in a readout of the call.

"I made it very clear to him that the United States expects, when a ransomware operation is coming from his soil, even though it's not sponsored by the state, we expect them to act if we give them enough information to act on who that is,

he said. "And, secondly, that we have set up a means of communications now, on a regular basis, to be able to communicate to one another when each of us thinks something is happening in another country that affects the home country. Biden said.

During the call, the White House said, Biden underscored the need for Russia to take action to disrupt ransomware groups operating in Russia and emphasised that he is committed to continued engagement on the broader threat posed by ransomware.

"The President has also called on governments and agencies to modernise their defences to meet this threat, building on the President's executive order on cybersecurity that was released in May," a senior administration official told reporters

HAITI REQUESTS US TO DEPLOY TROOPS AFTER PREZ'S MURDER

Colombians implicated in Moïse's assassination were recruited by four companies

Port-Au-Prince, July 10: Haiti's interim government said Friday that it asked the US to deploy troops to protect key infrastructure as it tries to stabilize the country and prepare the way for elections in the aftermath of the assassination of President Jovenel Mose.

'We definitely need assistance and we've asked our international partners for help," Interim Prime Minister Claude Joseph told The Associated Press in an interview, declining to provide further details. "We believe our partners can assist the national police in resolving the situation.'

Joseph said that he was dismayed by opponents who've tried to take advantage of Moïse's murder to seize political power — an indirect reference to a group of lawmakers have declared their loyalty and recognized Joseph Lambert, the head of Haiti's dismantled senate, as provisional president and Ariel Henry, whom Moïse designated as prime minister a day before he was killed, as prime minister.

"I'm not interested in a power struggle," Joseph said in the brief phone interview, without mentioning Lambert by name. "There's



US REBUFFS REQUEST

London, July 10: UK health officials said the Delta variant of Covid-19 continues as the dominant strain of Coronavirus and marked a sharp increase in the UK with 54.268 more cases logged Friday, which marks a 32 per cent increase over the pre-

Public Health England (PHE) said its weekly analysis shows the continued rise in infections is not followed by a similar increase in hospitalisations and deaths, which reflects a high protection offered by both doses of a Coronavirus vaccine. In a separate study, PHE also found that all the vaccines being administered are as effective at preventing symptomatic disease in the majority of people with underlying health conditions as the rest of the population.

"The data continues to show that the sharp increase in cases that we are seeing is not being followed by a similar increase in hospitalisation and death," said Dr Jenny Harries, Chief Executive of the UK Health Security Agency.

"This is because two doses of the available vaccines offer a high level of protection against the Delta variant. Getting both jabs is the best way to ensure you and the people vou love remain safe, so we once again urge everyone to come forward as soon as they are eligible," she said.

"As we approach the planned end of restrictions, we must remain cautious and careful. Cases are rising across the country, and whilst the vaccines offer excellent protection, they do not offer 100 per cent protection," she added.

B'desh factory owner charged with murder after 52 die in blaze

Dhaka, July 10: Bangladesh police Saturday arrested eight people, including the owner of a factory and his sons, in connection with the fire in their food processing unit which killed at least 52 people, according to media reports.

Forty-nine workers died after being trapped on the third floor with its only exit locked. Three others also died after jumping off the six-storey factory.

Home Minister Asaduzzaman Khan Kamal said the owner, several directors and managers of the Sajeeb Group and its sister concern Hashem Food Ltd were among those taken into custody by police.

Police are seeking a 10-day remand order from a court to question Hashem and others over the deadly blaze, according to Rupganj Police Inspector Humayun Kabir Molla. Apart from Sajeeb Group Chairman and Managing Director Md Abul Hashem, his four sons, including Deputy Managing Director Hasib Bin Hashem and Director Tareg Ibrahim were also named in the case, according to Narayanganj's Superintendent of Police Zaidul Alam.

The Home Ministry formed a committee to look into the fire incident. Apart from the Home Ministry probe team, several other agencies and the local administration have also started investigations into the incident.

According to the Fire Service, a huge amount of plastic and packaging materials in the building had fueled the fire in just a few minutes. They said the blocked door at the factory's staircase hascaused so many deaths that could

Jakarta, July 10: Just two months ago, Indonesia was coming to a gasping India's aid with thousands tanks of oxygen.

Today, the Southeast Asia country is running out of oxygen as it endures a devastating wave of coronavirus cases and the government is seeking emergency supplies from other countries, including Singapore and China.

A shipment of more than 1,000 oxygen cylinders, concentrators, ventilators and other health devices arrived from Singapore on Friday, followed by another 1,000 ventilators from Australia, said Luhut Binsar Pandiaitan, the govIndonesia's pandemic response. Beside those donations, Indonesia

plans to buy 36,000 tons of oxygen and 10,000 concentrators — devices that generate oxygen — from neighbouring Singapore, Pandjaitan said. He said he is in touch with China

and other potential oxygen sources. The US and the United Arab Emirates also have offered help. Indonesia's hospitals are swamped,

with growing numbers of the ill dying in isolation at home or while waiting to receive emergency care.

The government has redirected oxygen supplies from industrial plants in Morowali in Central Sulawesi, Balikpapan on Borneo island, and Belawan.

Branson-Bezos space tourism rivalry gets nastier before flight

Washington, July 10: Before they open the lucrative space tourism business to the public, Richard Branson-owned Virgin Atlantic and Jeff Bezos-led Blue origin are fighting and the online feud has only turned ugly this time.

While billionaire Branson is set to fly to space aboard his Virgin Galactic's VSS Unity space plane July 11, Amazon Founder Bezos is expected to take off in his own space tourism rocket July 20.

Blue Origin's New Shepard rocket aims to launch its crew capsule just beyond the Karman line for a few minutes of weightlessness, while Virgin Galactic's SpaceShipTwo space plane flies 89 kms high - just over the boundary of space defined by the US government, reports The Verge.

Blue Origin further tweeted: "For 96 per cent of the world's population, space begins 100 km up at the internationally recognised Karman line.'

Reacting to the tweet, Nicola Pecile, a Virgin Galactic test pilot, posted: "This pissing contest about the Karman line is so childish that is getting really embarrassing to watch'

"Flying above 100K ft is already so complicated that anyone doing so should deserve a special recognition," Pecile tweeted. The tweet was later deleted.

In another tweet, he cited Virgin



Galactic's first spaceflight with humans in 2018 and added that Blue Origin "has flown only mannequins so far."

Éarlier, Blue Origin's CEO Bob Smith wished Branson well after Virgin's announcement, but said that "they're not flying above the Karman line and it's a very different experience. Virgin Galactic has confirmed

G20 signs off on tax crackdown

Venice, July 10: Finance chiefs of the G20 major economies backed a historic move to prevent multinationals from shifting to low-tax profits in talks Saturday, where they would also warn that coronavirus variants are a threat to global economic recovery

They also acknowledged the need to ensure proper access to vaccines in poor countries. But a draft communiqué for rubberstamping at a meeting in the Italian city of Venice did not include specific new proposals to do so.

The tax deal was the biggest recent policy initiative to emerge from their talks. It follows eight years of wrangling over the tax issue and aims for national leaders to give it their final blessing at the October G20 summit in Rome.

German Finance Minister Olaf Scholz confirmed to reporters that all G20 economies were on board for the agreement, while US Treasury Secretary Janet Yellen said some smaller countries still opposed it, such as the low-tax Ireland and Hungary. Signing will be encouraged until October.

Bhubaneswar, July 10: Private telecom operator Reliance Jio topped while Airtel registered lowest in the 4G speed chart for the month of June in Odisha, as per the latest data published by Telecom Regulatory Authority of India (TRAI).

Jio topped the 4G speed chart with 21.9 megabit per second (Mbps) average 4G download speed in the month of June 2021. On other hand Bharti Airtel registered the lowest average 4G download speed of 5 Mbps in the month. As per TRAI data, Vodafone Idea showed an average download speed of 6.5Mbps in the same month.



In average 4G upload speed, Vodafone Idea had an average 4G upload speed of 6.2Mbps in June, which was followed by Reliance Jio with an upload speed of 4.8Mbps and Bharti Airtel with 3.9Mbps.

In Odisha, Jio also continued its leadership with highest average 4G download speed of 33 Mbps. followed by Vodafone Idea which registered an average download speed of 5.7 Mbps and Airtel which showed an average 4G download speed of 4.5 Mbps, TRAI's report said. Similarly, Vodafone Idea had 7.9 Mbps average 4G upload speed followed by 5.4 Mbps average upload speed of Jio and 3.2 Mbps average 4G upload speed by Airtel, in Odisha.

The download speed helps consumers in accessing content from the internet, while upload speed helps them in sending or sharing pictures or video to their contacts. The average speed is computed by TRAI based on the data it collects across India with the help of its MySpeed application on a real-time basis.

Covid 2.0 unleashes credit stress for MFIs, small NBFCs

New Delhi, July 10: The impact concerns over the recovery of the microfinance (MFIs) and the small NBFC sector, which was already battling the elevated credit stress and declining AUM in FY21.

Accordingly, out of thirteen issuer downgrades by credit rating agencies during Q1FY22 in the financial sector, ten issuers are smaller MFI and NBFCs engaged in providing unsecured MSME loans, personal and vehicle loans.

A report by Acuite Ratings said that collection efficiencies which were seen recovering above 90 per cent in Mar-21 have dropped to between 65-85 per cent levels during

"Besides the lower collections, the debt raising ability of these smaller players has been impacted with an estimated 50 per cent of players (having a loan portfolio of more than 500 crore) having received adequate funds.

'Relief measures provided by the government and RBI recently is expected to support the continuity of credit flow to microfinance and MSME borrowers while also enhance liquidity relief to the smaller lenders.'

Furthermore, it said that impact of second wave of Covid has been more pronounced on collections in the asset classes of microfinance and two-wheeler loans as compared to the first cycle.

"Even as two-wheeler as an asset class fared better during the first wave of lockdowns, the impact has been greater during the second cycle on account of the spread of the pandemic in rural areas and the stress on the borrowers' cash flows due to loss of income as well as high medical expenses," said Suman Chowdhury, Chief Analytical Officer, Acuite Ratings & Research.

"Given the intermittent nature of economic activities in the wake of Covid spread in Q1FY22, the borrower income streams, particularly of those serviced by smaller NBFCs or MFIs have been severely impacted, thereby exacerbatingthe asset quality stress for these lenders.'

San Francisco, July 10: The US Federal Trade Commission (FTC), headed by Lina Khan who is known as antitrust advocate and an Amazon critic, has opened a probe into Amazon's \$8.45 billion acquisition of movie and TV studio giant MGM

According to a report in The Information Friday citing sources, the FTC probe is an "in-depth investigation into the deal.

The investigation sets the stage for a lengthy probe that could last six months or more.

"It signals that the FTC, under the new leadership of Amazon critic Lina Khan, will take a hard line on even relatively small acquisitions by the e-commerce giant in industries where Amazon does not have a strong position," the

report emphasised. Amazon was yet to react to the

Khan, the newly appointed chief



of the FTC, is a strident Big Tech critic. "Amazon's business strategies and current market dominance pose anti-competitive concerns that the consumer welfare

framework in antitrust fails to

recognise," wrote Lina Khan in the Yale Law School Journal.

The probe is part of an increased antitrust scrutiny from the Joe Biden administration. Earlier Friday, Biden signed the Executive Order on Promoting Competition in the American Economy,' with several provisions relating to net neutrality. Amazon May 26 announced to acquire movie giant MGM for \$8.45 billion, at a time when the world's largest telecommunication company AT&T has announced to merge WarnerMedia with Discovery to create a new media giant that will compete with leading streaming players like Netflix.

The report mentioned that the FTC is focused on "the larger implications of the deal for Amazon's market power.'

"The FTC is wary of whether the deal will illegally boost Amazon's ability to offer a wide array of goods and services, and is not just limited to content production and distribution," it added.

"It's just a really joyous song, I think, that brings people together," the England manager had added.

The song 'Three Lions', commonly known by its lyrics 'football's coming home' has been the soundtrack to England success, and more commonly failure, for the last 25 years

'Sweet Caroline' first hit the charts in 1969 just three years after England achieved their last success at a major tournament. And if England win Sunday, there can be no doubt that it will again be a rebirth for 'Sweet Caroline'. "I felt like we'd beat Germany and lost to Neil Diamond in extra time," an England footballer said recently.

The report further stated that Weerakkodi, along with Bhanuka Rajapaksa and several other cricketers, were sent Friday night to Dambulla night to play practice matches ahead of the India series.

Sources also indicated that the BCCI is also keeping a close watch on the developments. As of now, the cricket body has not decided in calling off the tour, but may do so if more Sri Lankan cricketers test positive in the coming days. The Indians are being tested at a gap of three days
