Bhubaneswar, July 14: Congress workers in the state Capital took to the streets Wednesday to protest against the steep hike in fuel and LPG prices. They blamed the Centre for increasing the misery of the people during the pandemic with the almost-daily increase in petrol and diesel rates. Women members of the party also joined in the demonstrations. Several women leaders of the party were seen demonstrating on the road near the Congress Bhawan here with LPG cylinders to express the plight of housewives and the middle class who have been the most severely affected by the exorbitant hikes.

Huge quantity of drugs seized, 5 dealers arrested

Bhubaneswar, July 14: Police seized Wednesday 550 gm of brown sugar and ₹34 lakh in cash from a house in this city, a senior officer informed. Two persons including a woman were arrested in this connection, Commissioner of Police (CP) Soumendra Priyadarshi told reporters. He said the value of the seized brown sugar is ₹55 lakh. This is the first time that such a large quantity of heroin has been seized in the Odisha capital, Priyadarshi informed.

Following a tip-off, the narcotics wing of the Commissionerate of Police along with the personnel of Sahid Nagar police station raided a house at Kesura and seized the brown sugar packets and ₹34,80,000 in cash. However, the arrested woman's husband managed to give the police a slip. Police said that the husband of the woman is a notorious drugs peddler in the area and a manhunt has been launched to nab him.

The CP said that preliminary investigation has revealed that the arrested duo and the absconding man are linked to a racket in Balasore district's Jaleswar locality.

Priyadarshi informed that the police will intensify investigation and raids under the Narcotic Drugs and Psychotropic Substances (NDPS) Act. He said the investigation will also include the financial aspects of the drug trade in the state.

In another separate development police also seized a huge cache of cannabis worth ₹5,00,000 which was being smuggled in a car in Tamando area in the city. The cannabis was hidden in the dicky of the car. Three persons travelling in the vehilce have been arrested, police said. During interrogation, it was revealed that the contraband item was being smuggled from Phulbani to Salia Sahi Basti locality in this city.

GOVT WORKERS AGENCIES New Delhi, July 14: The Union

Cabinet decided Wednesday to restore Dearness Allowance (DA) and Dearness Relief (DR) for central government employees and pensioners from July 1, 2021. In another significant development the rate of allowance was increased to 28 per cent from the existing 17 per cent. The increase in the DA and DR will impose an additional annual burden of ₹34,401 crore on the exchequer. This information was provided Wednesday by Information and Broadcasting Minister Anurag Thakur after the first physical Cabinet meeting for more than a year ended. In view of the Covid-19 pandemic, the Union Government had frozen the three additional instalments of the DA and DR which were due from January 1, 2020, July 1, 2020 and January 1, 2021. The move which will come into effect July 1, 2021 onwards will benefit about 48.34 lakh

Naveen launches free **MRI, CT** scan services

Bhubaneswar, July 14: Odisha Chief Minister Naveen Patnaik launched Wednesday free MRI and CT scan services for cancer patients at the Acharya Harihar Post Graduate Institute of Cancer (AH-PGIC) in Cuttack. It will certainly help those patients who cannot afford high-end treatment facilities. Cancer patients are usually charged ₹2,500 to ₹5,000 for availing of such services.

While launching the services virtually, the Chief Minister said that in the next three years the state government will develop adequate cancer care centres. Then people will not have to visit other states for treatment of the



Govt to table 17 bills in Monsoon Session

New Delhi: The government has listed 17 new bills for introduction in the Monsoon Session of Parliament beginning July 19. Three of the bills seek to replace ordinances issued recently. Once a session starts an ordinance has to be passed as a bill within 42 days or six weeks, else it lapses. One of the ordinances was issued on June 30 prohibiting any agitation and strike by anyone engaged in the essential defence services. The Essential Defence Service Bill, 2021 has been listed to replace the ordinance, according to a Lok Sabha bulletin issued July 12.

BJP FLAYS STATE OVER POWER RATES

The plea, filed by Major-General SG Vombatkere (Retd) submitted that Section 124-A of the Indian Penal Code (IPC), which deals with the offence of sedition, is wholly unconstitutional and should be 'unequivocally and unambiguously struck down'

"The petitioner contends that a statute criminalising expression based on unconstitutionally vague definitions of 'disaffection towards Government' etc is an unreasonable restriction on the fundamental right to free expression guaranteed under Article 19(1)(a) and causes constitutionally impermissible 'Chilling Effect' on speech'," the plea said. The

NEW DELHI: The Delhi High Court directed Wednesday the CBSE to decide within eight weeks if it would refund the examination fees taken for Class X and Class XII board examinations as they have been cancelled due to the Covid-19 pandemic. Justice Prateek Jalan ordered CBSE to consider as representation a petition by Deepa Joseph, mother of a Class X student studying in a CBSE affiliated school here, who had paid ₹2,100 as examination fee. CBSE's decision would be open to challenge if Joseph is not satisfied, the court clarified as it disposed of the petition. There has to be reasonableness on both sides, the judge added.

New Delhi, July 14: From olive wreaths to recycled metals sourced from old cell phones and electronics, the reward for winning at the Olympics, the most sought-after achievement in an athlete's life. has come a long way, much like

the Games itself Made of recycled electronic devices and pebble-like in appearance, the medals in the upcoming Tokyo Games will measure 8.5 centimetres in diameter, featuring the flying image of 'Nike', the Greek goddess of victory. But, unlike previous years, these will be produced from gold, silver and bronze (in this case, copper and zinc) that has been stripped from over 79,000 tons of used cell phones and other small electronic devices collected from all over the world.

During the ancient Olympic Games, athletes who emerged victorious were awarded 'Kotinos' or olive wreaths. Those were considered a sacred prize in Greece, representing the highest honour.

In 1896, the long-lost tradition of ancient Greece, the Olympic Games was reborn in Athens. New practices made way for older ones and thus the custom of awarding medals began. Initially it was silver for the winners while the runners-up received a copper or bronze medal. It wasn't until eight years later in the 1904 St Louis Games, where the now standard gold, silver, and bronze medals, were first used. However, sizes and shapes of the medals varied among the host countries.



In 1923, the International Olympic Committee (IOC) launched a competition for sculptors to design the medals for the Summer Games. The Italian artist Giuseppe Cassioli's design was chosen as the winner in 1928.

At a time when environmental consciousness was on the rise, the 2016 Rio Games scripted history by becoming the most sustainable edition in Olympic history. The organisers opted for more usage of recycled material. The medals were made of 30 per cent recycled material while the ribbons they were attached to, were made of 50 per cent recycled plastic bottles. The gold was mercury-free.

Following in Rio's footsteps, the Tokyo Games' organisers have opted for medals made of recycled electronic devices, including discarded laptops and smartphones phone, a proposal that won the 'Everyone's Medal' campaign launched by the Tokyo 2020 organising committee in 2017.

"I never dreamed that the design I submitted, only as a memorial to this lifetime event, would be actually selected," winner of the design, Junichi Kawanishi, had told media when the medals were launched.

Ceremony tweaked for gender parity

TOKYO: The number of oath-takers at

the Olympics opening ceremony has

been doubled from three to six for the Tokyo Games to ensure gender parity. Giving this information Wednesday, the IOC said that the oath has also been reworked slightly to incorporate 'inclusion and equality' in it. The Olympic oath is taken by an athlete from the host county, on behalf of all the competitors and the ceremony also includes one coach and a judge. This time, Japan will pick two - one male and one female from each group for the event. "This has been done to maintain the gender balance of the oath-takers," the IOC said. "Also 'inclusion' and 'equality' have been added to the opening line of the Oath.



WAIVER OF TAXES ON **PVT BUSES LIKELY**

Bhubaneswar, July 14: In a relief to the private bus owners, the state Transport and Commerce Minister Padmanabha Behera Wednesday hinted at waiver of various taxes being paid by the bus owners, in view of Covid-19 pandemic.

Due to the outbreak of the second wave of Covid-19, the state government has imposed lockdown and shutdown measures and accordingly, the bus services were also suspended. As a result, the bus operators are facing a lot of hardship.

"Various relaxations on taxes have been extended to the bus owners and we will continue to provide them tax exemptions," Behera told reporters here.

Currently, private buses are plying in as many as 20 Category-A districts. A decision regarding plying of buses in 10 Category-B districts will be taken soon, he said. Last week, the private bus owners' association had urged the state government to waive the taxes in view of the losses incurred on account of the protracted lockdowns.

The ongoing partial lockdown restrictions imposed in the state will end Thursday. The state government will come up with its new guidelines Thursday. All eves are on the guidelines as to whether more relaxations will be allowed or not.

Meanwhile, the Health Services director Bijay Mohapatra said that the state government will take a decision for the next unlocking process after a review of the present pandemic situation. The government is taking necessarv steps to bring down the infection rate in Cuttack and Bhubaneswar, he said.

MARITAL DISCORD Anubhav files contempt plea against Varsha

Cuttack, July 14: Actor-turned-parliamentarian Anubhav Mohanty Wednesday lodged a contempt of court petition against his actress wife Varsha Priyadarshini in connection with a case pertaining to their marital discord.

The couple appeared at the mediation centre of the family court. The conciliator counselled the couple over two hours to settle the discord through mutual consultation.

"I do not want to discuss issues related to my personal life in public. If you have any queries, you can ask my lawyer," Mohanty told media persons while returning from the court.

Talking to media, Mohanty's lawyer said, "Today, Varsha refused to sign on the counselling report saying that she did not have faith in the counseling process. So, we have lodged a contempt plea in



Bhubaneswar, July 14: The National Human Rights Commission (NHRC) has issued a conditional summon to the superintendent of police (SP) of Bhadrak to appear before it August 31, 2021 in connection with the alleged rape of a five-year-old girl by her neighbour in June last year.

The commission pronounced the order July 13 while hearing a plea filed by rights activist Himanshu Sekhar Nayak June 17, 2020. The petitioner had informed the commission that the heinous incident took place at Chadia under Chandbali block in Bhadrak June 13.

"It was around 7 pm when Babu Mahalik, 32, found the girl playing near her house and lured the minor to his house by offering her chocolates. Later, he took her to a nearby deserted place where he forced himself on her. As the victim screamed,



locals rushed to the spot and captured Mahalik," Nayak told the apex rights body, pointing out that the incident saw widespread resentment in the locality.

The commission took cognisance of the issue June 26, 2020 and sought



"The DBT mode of money transfer will maintain transparency in the distribution process so that none of the deserving beneficiaries are deprived of the relief measure. In the first wave of the pan-



demic last year too, the BMC had extended helping hands to small time traders and street vendors.

About 28,000 roadside vendors within the BMC jurisdiction have been shortlisted for the payment, of which, around 14,000 have been identified for receiving funds

under the two phases," said a

BMC official. It can be mentioned that street vendors are given assistance under

Pradhan Mantri Street Vendor's Atmanirbhar Nidhi (PM SVANidhi) launched earlier in August, 2020. Street vendors, who

don't have identity cards or certificates of vending, can avail benefits under the PM SVANidhi scheme through LOR.

Vendors can apply for LOR with any urban local body. They can avail a working capital loan of up to Rs 10,000 which is repayable in monthly instalments in the tenure of one year.

The BMC officials mentioned that Rs 3.57 crore has been earmarked for this purpose. Last year, the state government had also announced financial assistance worth Rs 3.000 each to over 65.000 street vendors across 114 urban local bodies (ULBs)

Welcoming the decision, secretary of Nikhila Odisha Street Vendors' Association Manoi Swain said the assistance will be of immense support to small vendors as the pandemic has ruined their livelihood.

Cards for kendu leaf pluckers up for sale

Bolangir, July 14: The kendu leaf department, allegedly a den of corruption and exploitation of work ers, has hit the headlines for all the wrong reasons again, a report said.

The state government provides cards (pass books) meant for free distribution among kendu leaf pluckers, but the forest officials allegedly demand ₹500 to ₹1000 per card, the report said.

The cards issued to pluckers contain the details of leaves collected by the pluckers and the volume of leaves deposited by them at the stock points (Phadi). However, the alleged collection of money from the pluckers by the forest officials has blown the lid off the exploitation of pluckers in the hands of forest officials.

The matter came to the fore after Pradip Purohit, former MLA and leader of Kendu Patra Shramik Sangha, lodged a complaint with the state forest secretary Mona Sharma. Purohit lodged a complaint after receiving complaints of money collection from the pluckers under Patnagarh kendu leaf division and Bolangir forest circle. Purohit has termed the development unfortunate and demanded a thorough probe into the charges.

Acting on the complaint, Sharma has directed the principal chief conservator of forests (PCCF). kendu leaf, to conduct a probe and

Kulabati Deep, Haramani Sahu, Belmati Budek and Ashtamai Putel alleged that they were forced to pay ₹500- ₹1000 to foresters and circle checkers in lieu of the cards. They also alleged that lakhs of rupees had been misappropriated

on the pretext of repair and renovations of the stock points, kendu leaf binding and transportation. The money has been misappropriated by preparing false bills and vouchers

Notably, kendu leaf, known as the green gold of Odisha, is one of the most important non-timber forest products of the state. The kendu leaf is also called silver leaf for its greater economic value and its contribution to the state exchequer. They provide livelihood opportunities for the poor during lean seasons. The kendu leaf business is a pride for the state because of its specialized operations.

More than 8000 stock points (phadis) operate in the state where the procurement and processing of leaves takes place. The net profit goes to the state exchequer 50% of which is ploughed back as kendu leaf grant in the development activities in the leaf growing areas. According to a government report, it creates 30 million man-days within three to four months and plays an important role in the socioeconomic development of tribal people, dalits and marginalized communities in the state.

When contacted, Ranjit Mallick, divisional forest officer of Bolangir kendu leaf division and in-charge of Patnagarh division said he is aware of the complaints and will visit Patnagarh soon to conduct a probe.

Solar-charged drinking water projects defunct in hilly areas

POST NEWS NETWORK

Keonjhar, July 14: As electricity is unavailable in hilly, forested and remote pockets of Keonjhar district, the government has made the provision of solarpowered pumping systems to ensure safe drinking water in its various parts.

Sadly most of these systems are lying defunct for lack of repair and routine maintenance. Distressed by want of drinking water, people meet their water needs from rivers and streams in many cases.

It was alleged that the company which installed the solar system is not setting things right despite signing an agreement with the government for its maintenance for five years.

A case in point is Purunajoda panchayat under Telkoi block in Keonjhar district where 40 families depend on river water since the day their solar energy-based drinking water project became defunct

Over 150 solar-powered pump sets are defunct in Anandapur sub-division, leaving people to face drinking water crisis. In such cases, people feed on water from rivers, rivulets and streams in their localities.

A case in point is Purunajoda panchayat under Telkoi block where 40 families depend on river water since the day their solar energy-based drinking water project became defunct.

Hundreds of people living in

Ramchandrapur and Tigiria villages under Kaliahata panchayat have been suffering a lot for the same reason.

The villagers pleaded for quick repair of these drinking water projects which are being executed by Rural Water Supply and Sanitation (RWSS) department.

People in the tribal pockets lamented that they are being deprived of basic drinking water. Locals observed that drinking unhygienic water is causing sickness and diseases.

They pointed out that lakhs of rupees are spent on drinking water projects, but the department has failed to discharge its responsibility to maintain these in hilly and remote areas.

They added that the company is bound by an agreement with the RWSS department to repair these projects wherever necessary till five years after their installation, but nothing is being done.

Though affected villagers apprised the RWSS authorities about their miseries due to shortage of water, no steps have been taken to set these projects right. Locals have been demanding immediate repair of solar-powered drinking water projects to alleviate their sufferings.

Build Forward Better

The Covid-19 pandemic has recast the world for millions of people. Or, more correctly, the pandemic has exposed and aggravated deep inequalities of race, gender, and class across societies, and highlighted the inability of many political systems to respond in ways that protect individual human rights and dignity. The world will neither rebuild from this crisis, nor have any chance of tackling wider existential threats such as climate change, until we can once more instill a sense of hope in political and civic life

Fortunately, in the Universal Declaration of Human Rights, a roadmap already exists to help humanity chart a path forward. The declaration, adopted by the United Nations General Assembly in 1948, is as relevant today as it was amid the physical and moral devastation caused by World War II.

Article 1 of the declaration states an abiding truth with resounding clarity: "All human beings are born free and equal in dignity and rights." To realise this vision today, we must push leaders to go beyond warm words and commit to meaningful, feasible, and measurable actions. In particular, they need to ensure equitable global distribution of Covid-19 vaccines and provide adequate financial support to countries most vulnerable to the ravages of climate change.

For starters, high-income countries must take steps to achieve the Gavi COVAX Advance Market Commitment target of providing at least one billion vaccine doses to the world's poorest countries no later than September 1, 2021, and more than two billion doses by mid-2022.

It is both morally unjust and - in health and economic terms - myopic for rich countries to hoard Covid-19 vaccines for their own populations. The longer the coronavirus persists and mutates in poorer countries with fewer resources, the further away humanity as a whole will be from fully vanquishing the threat to lives and livelihoods

In the same spirit, G7 and G20 leaders should support calls at the World Health Organisation and the World Trade Organisation for voluntary licensing and technology transfer for production of vaccines. Failing that, they should back an immediate waiver of certain intellectual-property rights under WTO rules -a move that US President Joe Biden recently supported

Sadly, at their recent summit in the United Kingdom, G7 leaders failed to show an understanding of the scale of their responsibility to address the inequalities exacerbated by the pandemic. More broadly, Covid-19 has exposed the shortcomings of narrow nationalism and populist policies that disdain scientific evidence and empathy. No country, regard less of its power or size, can tackle the publichealth threat effectively on its own.

It is essential that leaders learn from their mistakes and heed the recommendations of the expert Independent Panel for Pandemic Preparedness and Response. Only properly financed, integrated, and organised health systems will be able to withstand future pandemics and health emergencies.

As matters stand, however, the rich world's failures in tackling Covid-19 have increased the trust deficit between the Global North and South. This in turn will make it more difficult to reach an agreement at the next critical international diplomatic gathering: the COP26 climate summit in Glasgow in November

All countries need to ratchet up their near-term emissions-reduction targets ahead of COP26, and we are still waiting for the major emitters to do so. In addition, rich countries must rebuild trust by showing how they will increase their climate finance contributions - including a greater share for adaptation - to deliver the long-pledged \$100 billion per year to help developing countries combat global warming and its effects.

Two common threads run through the shared challenges we face in defending human rights, overcoming the pandemic, and tackling the climate crisis: the need for vigilance against complacency, and the responsibility to act for the greater good. In these testing times, we can all draw inspiration from a leader who never wavered in his commitment to human rights and justice: Nelson Mandela. It is a historical irony that the Universal Declaration of Human Rights was adopted in the same year that South Africa established its apartheid regime. But Mandela immediately saw the declaration's power and potential. Speaking in 1997 as President of South Africa, he reflected that, "For all the opponents of this pernicious system, the simple and noble words of the Universal Declaration were a sudden ray of hope at one of our darkest moments. Today more than ever, we need to rediscover and reassert the declaration's principles of solidarity and common endeavour that Mandela so powerfully articulated throughout his life. Our task now is not to "build back better," because we cannot build back from a status quo ante that produced inequitable and dysfunctional systems. Rather, we must "build forward better," marshaling our efforts with hope, discipline, and determination to build a sustainable, peaceful, and just world for future generations.

Joe Biden's fault. By overruling America's top generals and ordering the hasty withdrawal of US troops, Biden opened the way for Taliban terrorists to capture more than a quarter of Afghanistan's districts. Now, the Taliban is pushing toward Kabul, and the United States is looking weaker than ever.

The US effectively ended its military operations in Afghanistan July 1, when it handed over to the Afghan government the sprawling Bagram Air Base, which long served as the staging ground for US operations in the country. In fact, 'handover' is too generous a description. In a sign of what is to come, US forces quietly slipped out of the base overnight after shutting off the electricity. The resulting security lapse allowed looters to scavenge the facilities before Afghan troops arrived and gained control.

Biden has vehemently defended his decision to withdraw, arguing that the US "did not go to Afghanistan to nation-build" and that "staying would have meant US troops taking casualties." He has also stood by his rushed approach, insisting that "speed is safety" in this context. "How many thousands more of America's daughters and sons are you willing to risk?"

The implication was clear: Questioning the wisdom of the US withdrawal is tantamount to supporting the endangerment of Americans. But it is Afghans who are really in jeopardy.

Recall the last time the US left a war unfinished: In 1973, it hastily abandoned its allies in South Vietnam. The next year, 80,000 South Vietnamese soldiers and civilians were reportedly killed as a result of the conflict, making it the deadliest year of the entire Vietnam War. It is also worth noting that in 1975, the US effectively handed Cambodia to the Chinabacked ultra-communist Khmer Rouge, who went on to carry out unimaginable horrors.

Among those facing the most acute risks is India. When the Taliban was last in power, from 1996 to 2001, it allowed Pakistan to use Afghan territory to train terrorists for missions in India. Omnishambles

rather splendid word entered the UK political lexicon in 2012. It was Authered in the House of Commons during Prime Minister's Questions April 18 by the Labour leader of the Opposition, Ed Miliband. He called the coalition government of the Conservatives and Liberal Democrats an omnishambles because of several serious policy and public-relations blunders, including some unexpected consequences of the Chancellor's budget of the previous month. The Daily Mail commented that omnishambles "described the combination of tragedy and farce that characterises modern politics" and the word has been gleefully taken up by many commentators, some even in the Conservative press. It began life in The Thick of It. a satirical BBC TV series about Westminster politics created by Armando Iannucci. It was said in an episode in October 2009 by the foul-mouthed government head of communications Malcolm Tucker, played by Peter Capaldi, though he meant by it one particular person's incompetence in everything she did. The word appeared a few times following the broadcast but Ed Miliband's use set it trending, as they say over on Twitter. Its instant popularity was indicated through a number of compounds that were soon coined. including omnishambolism and omnishambolic.

Law which says: "In pursuance of the goal of secularism, the State must stop administration of religion-based personal laws... Instead of wasting energies in exerting political and theological pressure... the Muslims will do well to begin exploring and demonstrating how the true Islamic laws, purged of their time-worn and anachronistic interpretations, can enrich the common civil code of India."

The court has been assiduously following this line of argument in subsequent judgements like the Sarla Mudgal judgement, 1995, where Justice Kuldip Singh had observed: 'When 80 per cent of the citizens have already been brought under the codified personal law there is no iustification to keep in abeyance introduction of a uniform civil code." In Lily Thomas Case, 2000, desirability of a uniform civil code particularly in regard to succession was reiterated. In ADC vs. NCT (2015), the SC lamented the absence of a uniform civil code with regard to guardianship of a Christian child.

Interestingly, the Law Commission of India in its report in August 2018 had stated that a uniform civil code is neither necessary nor desirable at this stage. "Secularism cannot con-

given to religious minorities. The idea of achieving common Indian identity is undesirable because Indian identity is plural and a synthesis of differing views. Detractors believe that instead of a uniform social code, the state should attempt to bring in substantive equality at all levels and promote socio-economic justice for all.

The liquor business in the district generates over 30 crore as revenue per annum. More revenue could be generated from the district, if excise officials succeed to curb illegal liquor trade.

Liquor is sold even at grocery shops, betel shops and road-side eateries in many areas. Spurious liquor business is also run parallel in most pockets.

Commuters suffer as construction of bridges hangs fire in Malkangiri

Malkangiri, July 14: Construction work on two high-level bridges on Balimela-Malkangiri road here are far from over despite four years having lapsed since the projects were launched.

Even a slight drizzle causes the residents to experience a harrowing time commuting on the road as rain water flows about four to five feet above the low-level bridges and culverts

In order to alleviate the sufferings of the people from this perennial problem, the government had started construction of three highlevel bridges at MV-11. Korukonda and MV-37 on Balimela-Malkangiri road over four years ago. At present, there are low level culverts at these places.

As of now, the construction of the high level bridge at MV-11 has been completed and vehicular movement has also been allowed. But the fate of the two other bridges at Korukonda and MV-37 is still hanging in balance.

The Malkangiri-Balimela road is the only path that connects Malkangiri and Balimela. Thousands of people of residing in villages under Korukonda, Tarlakota and Patrol panchayats depend on this road. In order to visit the block and tehsil offices, people have no other alternative. During

the rainy season, these villagers experience immense hardships as they remain cut off from the district headquarters for days together.

Local villagers said they were hopeful that the bridges would be completed at least before this rainy

season. But that did not happen. "We are suffering as the contractor is not earnest in completing the work. During the monsoon when rainwater flows over the culverts, we have no choice but to wait till the water recedes," rued some villagers.

When contacted, Malkangiri Additional District Magistrate Birsen Pradhan said that the contractor has already been directed to complete the remaining work at the earliest. The half-constructed bridges will soon be completed, he added.

Kochi, July 14: In a first of a kind move, a Catholic nun Wednesday appeared as 'party in person' in the Kerala High Court to fight her own case.

Sister Lucy Kalapurakkal was dismissed from the church at Kerala's Manathavady in August 2019 by the Franciscan Clarist Congregation, after getting the Vatican's clearance, for disobeying church authorities.

Since then, she has been fighting her case and she refused to move out from the convent in Wayanad district that she is residing in

Wednesday after her counsel withdrew for personal reasons, the nun herself appeared as party in person and said that since she already has the case against her congregation in another court, she should be allowed to reside at her convent, till its verdict comes.

She also wanted a review of an earlier directive of the High Court, which, in the course of the proceedings in the case, expressed doubts if she can continue to reside in the convent.

Making a passionate plea. Sister



Lucy, noting that she has completed 25 years of service as a nun and wish to continue the same way, said she has nowhere to go and should not be driven on to the

streets. She requested police protection at the place where she resides in the convent But the counsel for the congregation contended that as a rule, a nun, when she moves from one place to another place, should only

stay in a convent and Sister Lucy,

in the course of conducting the

case, has violated all this.

The court, however, pointed out that they are prepared to ensure that she gets protection to her life and property, wherever she stays. The court later posted the case for giving its final verdict.

Sister Lucy had supported the nuns' strike in the state demanding the arrest of rape-accused Bishop Franco Mulakkal, who headed the Roman Catholic Diocese in Jalandhar.

However, she became a target of the Church authorities after she joined the nuns' protest against the delay in Mulakkal's arrest despite the FIR against him. But even though she was asked

to move out from the convent then. she got an order from a court that she should not be forced out and has been staying there since then. Since then she had been receiv-

ing notices from the church on charges such as airing her opinion about the bishop on TV channels. owning a car, and writing a book. Incidentally, the Kerala High

Court, in December 2019 declined to ban the nun's autobiography titled "Karthavinte Namethil (In the name of Christ)" and it was released later

Kolkata, July 14: Admitting West Bengal Chief Minister Mamata Banerjee's petition for hearing, the Calcutta High Court Wednesday directed that notice be served upon Leader of Opposition Suvendu Adhikari, whose victory from Nandigram in the Assembly elections was challenged by her.

Justice Shampa Sarkar directed that Banerjee's election petition will be taken up for hearing August 12.

The matter was reassigned to the bench of Justice Sarkar by Acting Chief Justice Rajesh Bindal after Justice Kausik Chanda recused himself from hearing the Trinamool Congress chiefs petition.

As per the result declared by the Election Commission, Adhikari defeated Banerjee by a margin of 1956 votes



TMC raps EC over 'delay' in holding Bengal bypolls

Kolkata: Voicing displeasure over the 'delay' in holding elections to seven West Bengal Assembly seats, crucial for Mamata Banerjee's uninterrupted continuance as the chief minister, the TMC said Wednesday a party delegation will meet the Election Commission July 15 to press for it. Sukhendu Shekhar Ray, a senior leader of the state's ruling party, also taunted the poll panel, wondering whether it was 'waiting for a third Covid wave"

to conduct the elections. Maintaining that the pandemic has eased considerably, Ray said the situation was conducive for holding the polls. Bypolls are to be held for five vacant seats, and fresh elections to two others where polling was countermanded following the death of candidates. The byelections are of critical importance to Chief Minister Mamata Banerjee, who lost the assembly poll to BJP's Suvendu Adhikari in Nandigram.

The Constitution allows a person to occupy a ministerial position only up to six months without getting elected to a state legislature or the two Houses of Parliament. It mandates that a minister who is not a member of legislature for six consecutive months shall cease to occupy the position at the expiration of that period. Banerjee needs to get elected to the assembly by November 4 to continue as the chief minister.

Kolkata, July 14: West Bengal managed to extract 13 lakh extra doses of vaccine in the last two months from its stipulated quota only by saving the extra dose given in a vial to compensate for the wastage. Kerala is the only state after West Bengal that has recorded a negative wastage by skilfully administering the vaccine and has earned accolades from the central government.

Technically the process is called 'negative wastage' which means not only ensuring zero wastage but actually eking out and administering an extra dose from each vial. State health department records said that in the last two months the state has recorded minus seven per cent wastage of Covishield doses, an impressive feat considering the low supply of vaccines.

"A vial of vaccine contains enough doses to administer 10 shots. But manufacturers add an extra dose in each vial as a wastage factor. In most cases, a tiny amount of the vaccine gets wasted each time the vaccine is drawn into the syringe. The extra dose is added in the vial to compensate for this loss. But if the vaccinator is skilful. it is possible to save this extra dose to vaccinate 11 persons from many vials," a senior official of the

health department said.

"The negative vaccine wastage in Bengal is now around -7 per cent, and the quantity saved will go up further as we go on saving more doses as the inoculation drive progresses," a state family welfare officer said.

In other words, for every 1 lakh doses, the state is managing 7,000 extra doses. Such efficiency was also recorded by Kerala, a feat that came in for appreciation from central government officials.

In Covaxin's case, Bengal initially had 1 per cent wastage, the optimal wastage limit suggested by the Centre. This has been reduced to zero. The initial wastage was due to public inhibitions about the vaccine, sources said.

A vial containing 10 doses has to be utilised within four hours of opening. There were several cases of insufficient recipients turning up during this window, leading to wastage.

Official data for May show Kerala and West Bengal standing in sharp contrast to states like Jharkhand and Chhattisgarh which recorded a high 33.9 per cent and 15.7 per cent wastage respectively. The wastage for other states is lower, but still on the higher side like in Madhya Pradesh (7.3 per cent), Delhi (3.9 per cent), Gujarat (3.6 per cent) and UP (3.7 per cent).

Till Tuesday evening, Bengal had administered a total of around 2.45,29,000 doses approximately, about 28 lakh doses of which were done by private vaccination centres. So far, the state has received a total of about 1.93 crore Covishield doses and 32 lakh Covaxin doses for government centres since the inoculation drive

began, apart from 25 lakh doses for the private sector since May.

The extra vaccination comes at a time the scanty vaccine supply to Bengal has slowed the pace of vaccination in the state. More than 3 lakh doses were being administered daily around the third week of June; the figure now is 2 lakh plus.

Terrorists arrested in Kolkata Not in Presidential race: Pawar may have Al-Qaeda links: Police or the Presidential polls. He also in-

> Kolkata, July 14: The three neo-Jamaat-ul-Mujahideen Bangladesh (JMB) terrorists, arrested in Kolkata, were setting up terror modules in West Bengal and may have links with Al-Qaeda and Harkat-ul-Jihad al-Islami (HuJI), police said.

> It is suspected that they have associates in some districts of the state. a senior officer of the Special Task Force (STF) of the Kolkata Police said Tuesday.

"Initial interrogation revealed that the JMB operatives were trying to build modules in West Bengal. These terrorists may have links with terror groups Al-Qaeda and Harkat-ul-Jihad al-Islami (HuJI).

The documents seized from them indicate this," the officer said. The STF arrested JMB operatives Najiur Rahman, Rabiul Islam and Sabir from Haridevpur area in south Kolkata Sunday. They are Bangladeshi nationals who had used forged documents to get a room on rent.

Their linkman, identified as Salim Munshi, had used the identity card of an unsuspecting elderly man to prepare a fake identity card for Najiur, the officer said. Najiur became Jayram Byapari in the fake identity card and the elderly man his father.

A number of JMB operatives, including Indians, were arrested in West Bengal in the past few years.





US overdose deaths hit 93,000 in 2020

New York, July 14: Overdose deaths soared to a record 93,000 last year in the midst of the Covid-19 pandemic, the US government reported Wednesday.

That estimate far eclipses the high of about 72,000 drug overdose deaths reached the previous year and amounts to a 29% increase.

'This is a staggering loss of human life," said Brandon Marshall, a Brown University public health researcher who tracks overdose trends.

The nation was already struggling with its worst overdose epidemic but clearly "COVID has greatly exacerbated the crisis," he added.

Lockdowns and other pandemic restrictions isolated those with drug addictions and made treatment harder to get, experts said.

Overdose deaths are just one facet of what was overall the deadliest year in US history. With about 378,000 deaths attributed to COVID-19, the nation saw more than 3.3 million deaths.

The 21,000 increase is the biggest year-to-year jump since the count rose by 11,000 in 2016.

4 Iranians charged in plot to abduct iourno in New York

New York, July 14: An Iranian intelligence officer and three alleged members of an Iranian intelligence network have been charged in Manhattan with plotting to kidnap a prominent Iranian opposition activist and writer in exile and take her back to Tehran, authorities said Tuesday.

An indictment in Manhattan federal court alleges that the plot was part of a wider plan to lure three individuals in Canada and a fifth person in the United Kingdom to Iran. Victims were also targeted in the United Arab Emirates, authorities said.

The identities of the alleged victims were not released but Brooklyn-based Masih Alinejad confirmed that authorities had told her she was among the targeted victims. "I knew that this is the nature of the Islamic Republic, you know, kidnapping people, arresting people, torturing people, killing people. But I couldn't believe it that this is going to happen to me in United States of America,' Alineiad told The Associated Press.

The indictment acknowledges that, naming an exiled Paris-based journalist later seized by Iran and executed. Also named was a California-based member of an Iranian militant opposition group in exile whose family says he was abducted by Iran while staying in Dubai in 2020. Prosecutors alleged the Iranian intelligence officer had an electronic device containing a graphic of Alinejad alongside those two men, prosecutors said.

Alinejad, who worked for years as a journalist in Iran, long has been targeted by its theocracy after fleeing the country following its -(disputed 2009 presidential election and crackdown.

New Delhi: IT services major Infosys Wednesday posted a 22.7 per cent rise in net profit to Rs 5,195 crore for the April-June quarter of 2021-22, and raised its revenue growth outlook for the full fiscal. New Delhi, July 14: The wholesale price-based inflation eased marginally to 12.07 per cent in June as crude oil and food items witnessed some softening in prices. However, WPI inflation remained in double-digit for the third consecutive month in June, mainly due to a low base of last year. WPI inflation was at (-) 1.81 per cent, in June 2020. In May 2021, the inflation was at a record high of 12.94

Inflation in fuel and power basket eased to 32.83 per cent during June, against 37.61 per cent in May. Inflation in food articles too eased to 3.09 per cent in June, from 4.31 per cent May, even as onion prices spiked.

In manufactured products, inflation stood at 10.88 per cent in June, as against 10.83 per cent in the previous month.

"The high rate of inflation in The Reserve Bank of India in its monetary policy last month kept June 2021, is primarily due to low base effect and rise in prices of interest rates unchanged at record mineral oils viz petrol, diesel (HSD), lows and committed to maintain naphtha, ATF, furnace oil etc, and an accommodative policy stance to manufactured products like basic support growth.

Retail inflation remained above the RBI's comfort level of 6 per cent for two straight months at 6.26 per cent in June, data released earlier this week showed.

ICRA Chief Economist Aditi Nayar said the headline WPI inflation is expected to continue to soften, while remaining in doubledigits in the September quarter.

"With the CPI inflation likely to have peaked, we expect policy normalisation to commence in Q4 FY2022, after the growth revival so lidifies," Nayar said.

Industry chamber PHDCCI President Sanjay Aggarwal said significantly high fuel and power inflation is escalating the input costs of the industry and its competitiveness in the domestic and international markets.

RBI imposes curbs on Mastercard over data storage

Mumbai, July 14: The Reserve Bank of India (RBI) Wednesday barred Mastercard Asia Pacific from onboarding new credit, debit and prepaid card customers with effect from July 22 as it failed to comply with data storage norms. The supervisory action will not impact existing customers of Mastercard, the RBI said.

Taking action against Mastercard, RBI said, "notwithstanding lapse of considerable time and adequate opportunities being given, the entity has been found to be non-compliant with the directions on Storage of Payment System Data"

According to RBI, the directions will not impact existing customers of Mastercard. "Mastercard shall advise all card issuing banks and non-banks to conform to these directions"



In terms of its circular on Storage of Payment System Data on April 6. 2018, all system providers were directed to ensure that within a period of six months the entire data relating to payment systems is stored only in India, as per the central bank. Mastercards becomes the third major Payment System Operator on which restrictions have been imposed for non-compliance with RBI's direction on Storage of Payment System Data.



Fuel prices rose over ₹20/litre in FY21, by ₹10 this year

New Delhi, July 14: You must be feeling the pain of rising fuel prices after it hit the century mark across the country last month. But, the rise has not been sudden and the pain has been consistent throughout the last financial year and this year too, taking the pump prices of petrol and diesel to unprecedented levels not seen before, even during the big surge in global oil during 2010-14 period when crude prices remained largely above \$100 a barrel.

A close look at the official data provided by Petroleum Planning and Analyses Cell reveals that petrol prices (in the national capital) rose by a whopping Rs 20.97 per litre between April 1, 2020 and



March 31, 2021 in FY21, the highest ever levels to be recorded so far.

Petrol was priced at Rs 69.59 a litre at the beginning of FY21 on April 1 last year and it was priced at Rs 90.56 a litre on March 31 year. This



is a growth of 30.13 per cent in FY21.



previous editions. Part of a series that starts Wednesday, here are some highlights and fun facts from the first two editions of the modern Olympics held in 1896 and 1900

GREECE OLYMPICS, 1896

A long-lost tradition of ancient Greece, the Olympic Games stood revived in Athens 1,500 years after being banned by Roman Emperor Theodosius I

Like their ancient counterpart, the 1896 Athens Games were an all-male affair. It was the only time in the history of modern Olympics that there were no women competitors

There were 241 athletes from 14 countries who competed in the Games, held from April 6 to 15

The athletes competed in 43 events covering athletics (track and field), cycling, swimming, gymnastics, weightlifting, wrestling, fencing, shooting, and tennis

Medals were awarded to the winners for the first time. However, none



In previous Olympics, stand-by players used to travel with hockey teams but could only take part in the Games in case a player in the 16-member squad suffers an injury or is out of the Games permanently.

Despite the additions, only 16 players will be able to play in a match and the teams will have to submit their list a day before their

Dubai, July 14: The ICC Wednesday officially confirmed that teams will be awarded standardised 12 points for a win, four for a draw and six for a tie during the second World Test Championship cycle which kicks off with the five-match series between India and England in August.

The ICC further said that percentage of points won will be used to determine standings in the 2021-23 cycle. Earlier, each Test series carried a value of 120 points which led to certain inequality in the table as a team winning a Test in a twomatch series got 60 points compared to five-game series where a Test win is valued at 24 points.

ICC Acting Chief Executive Geoff Allardice said the changes were made to simplify the points system while taking learning from the disruption last year.

The nine Test teams will play a total of six series - three home and as many away-just like the previous edition.

Pogacar tried and tried again to get clear inside the last 2 km, but he was unable to open a gap. Then Carapaz struck. The move initially dropped Vingegaard, but Pogacar held on, and Vingegaard ultimately clawed his way back up inside the last few hundred meters.

Finally, with 200 meters to go, Pogacar put in another big acceleration and pulled away from his rivals, taking his fifth career Tour stage victory at the line. Vingegaard took runner-up honors after his impressive recovery, with Carapaz finishing third on the day.

UEFA inspects fan stampede at Wembley

London, July 14: Hundreds of fans without tickets broke through security barriers to get into Wembley Stadium in a bid to watch Sunday's European Championship final against Italy. UEFA Tuesday asked an investigator to study violence by England supporters at the game.

The English Football Association has been separately charged with multiple offences by fans before and during their team's loss to Italy in a penalty shootout after a 1-1 draw.

UEFA's charges against England's FA also relate to booing Italy's national anthem, a fan who stopped play by running on the pitch, throwing objects, and lighting fireworks.

The official attendance was around 67,000 of the stadium's 90,000 capacity, with many seats intended to be left empty to distance fans.

But there was extremely high demand for tickets for England's first major tournament final in 55 years.


Swimming events were held in the Bay of Zea. Competitors were ferried out to a wooden raft and from there, they raced towards the shore with a string of floating, hollowed-out pumpkins as lane markers

Germany's Carl Schuhmann emerged as the most successful athlete of the first Olympic Games of the modern era, finishing top in four events in gymnastics and wrestling. He also competed in the weightlifting event

Greek gymnast Dimitrios Loundras became the youngest documented Olympian. At 10 years and 218 days old, Loundras competed in the team parallel bars event. His team finished third

No weight classes existed for the wrestling competition, held in the Panathenaic Stadium. This meant that there was only one winner among competitors of all sizes. The rules used were similar to modern Greco-Roman wrestling, although there was no time limit

Jeux Olympiques PARIS OLYMPICS, 1900



Unlike the 1896 Athens Games, no opening or closing ceremonies were held

It was the first time that women featured in the Games

American-born Helene de Pourtales became the first female Olympic champion as part of the Swiss winning team in the 1-2 ton sailing event

UK's Charlotte Cooper became the first female to win an individual Olympic event - the women's singles tennis competition.

The track-and-field events were held on a grass field that was uneven and often wet. Broken telephone poles were used to make hurdles, and hammer throwers occasionally found their efforts stuck in a tree

Weightlifting and wrestling were dropped and 13 new sports were added

It was the only time cricket featured in the Olympics. Only two countries competed, Great Britain and hosts France

Athletes from different nations competed on the same team in tennis, football, polo, rowing and tug of war

Live pigeons were used as targets in the shooting events. It was the first and only time in Olympic history when animals were killed on purpose. Birds were released one at a time from 'traps' in front of the shooters. Winners were determined by whoever shot the most birds out of the sky

Franco-Haitian rugby player Constantin Henriquez became the first black athlete to win gold when France beat Great Britain and Germany to victory. He is also believed to be the first black competitor at the Olympics
