Mallya declared bankrupt


LONDON: Businessman Vijay Mallya was declared bankrupt by the London High Court Monday, with a consortium of Indian banks led by the State Bank of India winning the case related to recovering debt from loans paid out to Mallya's now-defunct Kingfisher Airlines. The verdict opens the doors for Mallya's assets to be seized. Mallya said he would appeal against the HC order, but he was refused permission for the same. "As at 15.42 [UK time], I adjudicate Dr Mallya bankrupt," Chief Insolvencies and Companies Court, Judge Michael Bringe said in bis Insolvencies and Companies Court Judge Michael Briggs said in his ruling during a virtual hearing of the Chancery Division of the HC here.

6 Assam cops die in clash with Mizo

Guwahati/ Silchar, July 26: At least six personnel of the Assam Police were killed in firing by miscreants from neighbouring Mizoram on Monday as violence escalated along the inter-state border in Cachar district, Chief Minister Himanta Biswa Sarma said.

A senior Assam Police officer, who is still inside the forest amid continuous firing from across the border, told PTI that at least 50 personnel, including Cachar Superintendent of Police Nimbalkar Vaibhav Chandrakant, were injured in firing and stone-pelting.

"I am deeply pained to inform that six brave jawans of @assampolice have sacrificed their lives while defending constitutional boundary of our state at the Assam-Mizoram border. My heartfelt condolences to the bereaved families,"

Sarma tweeted. The senior police officer said miscreants from across the border suddenly started firing when civil officials of both sides were holding a dialogue to sort out the differences. "I immediately cannot say how many people have been injured, but my guess is at least 50 personnel. Our SP was also in-

Shah asks CMs to ensure peace

NEW DELHI: Union Home Minister Amit Shah Monday spoke to the chief ministers of Assam and Mizoram over the ongoing border row between the two states and asked them to ensure peaceful resolution of the dispute, sources said. During his separate telephonic conversations with Assam CM Himanta Biswa Sarma and his Mizoram counterpart Zoramthanga, Shah asked them to maintain peace along the inter-state border where tension prevails, the sources said. The home minister asked the chief ministers to resolve the border issue mutually. Both CMs have assured the home minister that

"We did not allow our public to go there, but their people were constantly throwing stones. Many were injured. They were also hitting us with marbles using catapults. As we were talking, suddenly they opened fire from the hilltop. They fired aiming at us while we were having the meeting," he said.

The officer said that the Assam Police team "somehow" managed to take position and start retaliatory firing. Silchar Medical College and Hospital (SMCH) Principal Babul Bezbarua told PTI that at least 50 police personnel were admitted with bullet injuries.

"There is a constant flow of injured personnel. As we are talking, another vehicle with a few more injured persons entered the hospital. All of them have bullet and pellet injuries. We have called in all doctors and formed different teams to treat the injured," he said.

A senior doctor, who wished not to be named, said the Cachar SP's condition was critical with one bullet hitting his thigh, besides he also got injured in the abdomen.

"He lost blood and we have infused him with one unit of blood. I guess more blood will be required," he added.

"I will not make any proposal on who should be the next Chief Minister, it is left for the high command to decide. Whomever they choose, I will cooperate and work with...I don't want to take any names," he said in response to a question.

Monday's developments now shift the focus to the BJP veteran's successor who could lead the partyled government for its remainder of term till 2023.

Among the names that have been doing the rounds as the probable successor to Yediyurappa are that of Union Minister Pralhad Joshi. BJP national General Secretary CT Ravi, its national organising secretary BL Santhosh and State Assembly Speaker Vishveshwar Hegde Kageri.

The gangster had allegedly tried to escape the police custody after snatching a gun from one of the police personnel escorting him at Simulia in Balasore district. Hyder allegedly threatened to shoot the members of the escort party which forced the cops to retaliate. An injured Hyder was rushed to the hospital where he succumbed to his injuries. The deceased gangster's wife, however, has alleged foul play and said that the police have 'murdered' her husband. "If the police officials were chasing Hyder then how could he get shots on front?" questioned Hyder's wife.

On the other hand, police claimed that they had received reliable intelligence on Hyder again starting his criminal activities from Choudwar jail. Subsequently, police sought the court's permis-jail. Accordingly, he was getting transferred to Baripada.

Upping the ante in her tense faceoff with the Centre over the Pegasus controversy, West Bengal Chief Minister Mamata Banerjee Monday announced a two-member inquiry commission to go into the allegations of snooping on politicians, officials and journalists. The surprise development came shortly before the TMC supremo boarded a flight for New Delhi where she will hold parleys with opposition leaders to explore ways to cobble together an alliance of anti-BJP parties ahead of the 2024 Lok Sabha elections. New Delhi, July 26: Two serving colonels who challenged official policy, a retired intelligence officer who took RAW to court, and two serving BSF officers also figure in the Pegasus project database as persons of interest for an unidentified agency, The Wire reported. KK Sharma, who was head of

the Border Security Force (BSF) in 2018, his telephone numbers were added to a list of numbers containing several hundreds from India marked as probable targets for surveillance. These numbers are part of a leaked database containing 50,000 numbers worldwide that an international consortium of media organisations has analysed as part of its Pegasus Project reporting initiative.

The leaked records include three phone numbers used by Sharma, two of which he still uses after his retirement in 2018, indicate he was very much a person of interest to the Indian client of the NSO Group during the time he was in service as the BSF chief.

It is not clear what the purpose of any potential surveillance might have been. Serving officers are not meant to be politically aligned, but if the Indian agency in question was interested in studying the extent to which Sharma actually sympathised with the RSS, whatever it learned about his leanings clearly



did not disqualify him from a key post-retirement assignment, The Wire reported. Soon after Sharma retired. the Election Commission (EC) appointed him special central police observer for the impending Lok Sabha elections in West Bengal and Jharkhand. As per that order Sharma "would oversee the deployment and other security related issues in the said states." A day after Sharma's appointment, the


Trinamool Congress objected to his deployment in the state. Showing a photo of Sharma attending an RSS event in Kolkata in 2018 to local media, West Bengal Chief Minister Mamata Banerjee said that her party would write to the EC. The leaked database also shows that a BSF Inspector General of Police, Jagdish Maithani, was selected as a potential target for surveillance around the same time as Sharma. A BSF commandant posted in

Assam, Maithani appears to have been of considerable interest to an Indian client of NSO between 2017 and 2019. Maithani has been associated with the Ministry of Home Affairs' border management system (CIBMS) project.





Babus' reluctance mars Niramaya

CAG REPORT BLAMED UNDERUTILISATION OF 'E-NIRAMAYA' APPLICATION FOR DELAY IN SUPPLY OF DRUGS AND MEDICAL EQUIPMENT

Bhubaneswar, July 26: Even though the Health department has allocated ₹1.42 crore for development of 'e-Niramaya' application, the reluctance of the officials to use it has put the Niramaya scheme on the back burner. The application was developed for better management of the health scheme which ensures free as well as affordable essential medicines in hospitals.

The Odisha State Medical Corporation Limited (OSMCL) is the nodal agency for procurement of drugs, equipment and other health related infrastructure.

The application was envisioned to automate supply chain management of medical consumables. The functionalities include management of the procurement, distribution and quality control of the drugs. Its use began April 1, 2017.

Much of the delay in the supply of essentials was attributed to the OSMCL officials preferring manual methods to e-Niramaya. The of-



ficials allegedly continued to delay in putting forth the Annual Procurement Plan (APP) before the concerned committees. OSMCL was mandated to submit their APP by December 15 but it delayed the submission by five to seven months.

The report of the Comptroller and Auditor General (CAG) of India tabled in the last Budget session of Odisha Assembly revealed the massive under-utilisation of 'e-Niramaya'. "The state/districtwise consolidated annual demand

was not forecast/generated through the e-Niramaya application, despite having a provision for the same in the system. Instead, APPs were prepared manually after consolidating the annual requirement/indents received from field functionaries outside the e-Niramaya application. Thus, the e-Niramaya application was not utilised optimally and could not be used to mitigate the delays in finalisation of the APP," read the

CAG report released in April 2021.


The report, responsible for auditing the Niramaya scheme management by OSMCL, also cited the response from the Health department which had claimed in August 2020 that irrational indents or indents in improper format, received from concerned officers, contributed to the delay in the approval of APP.

"The fact, however, remained that these delays impacted the supply of essential drugs and equipment to health institutions. Further. non-utilisation of the e-Niramava application for generating accurate indents also contributed to delays in preparation and approval of APP," the CAG report said.

OSMCL was also accused of showing undue favours to suppliers and failing in maintaining minimum stocks of medicines. CAG accused OSMCL of not abiding by the prescribed norms.

"Monitoring of inventory management through e-Niramava software application was ineffective leading to shortage of drugs in health institutions and expiry of drugs as well. Government was unsuccessful in providing an unbroken supply of essential drugs to the patients in public health institutions as per its own prescribed Essential Drug List," the CAG report said.

OSMCL authorities, however, were not available for the queries when contacted over phone.

1,450 govt schools have internet facility: Pradhan

New Delhi, July 26: As many as 1,450 government schools in Odisha have internet connection through broadband services, Union Education Minister Dharmendra Pradhan informed the Lok Sabha.

Responding to a written question regarding internet connectivity in government-run schools across the country, the Union Minister informed the Lower House that under the BharatNet programme, the CSC e-Governance Services India Ltd, a Special Purpose Vehicle (SPV) set up by the Ministry of Electronics & IT, has been assigned the task of providing Fibre To The Home (FTTH) connectivity to government institutions including schools. Pradhan said that 1,19,581 government schools have been connected with internet across the country

"This project is for providing internet connection to government schools in respective gram panchayats (GPs). The School Education departments of the respective state governments have appointed district-wise nodal officers for effective implementation of the project," the Union Minister said.

He said that out of the targeted 1,20,392 gram panchayats in this phase, a total of 1,18,649 have been made service ready.

"As part of the BharatNet project, the last mile connectivity, through Wi-Fi or any other suitable broadband technology, internet services are to be provided in a phased manner in the gram panchavats in the country. Pradhan said

Bhubaneswar, July 26: Rampant criminal activities in the Capital city have exposed the tall claims of the Commissionerate Police about the maintenance of law and order, if a violent group clash in broad day light here Monday is any indication.

Two groups wielding sharp weapons and iron rods Monday clashed at busy Master Canteen Square here in broad daylight. Past enmity is stated to be the reason behind the incident.

According to sources, the prime accused, Raja Behera, who has a tea stall in Master Canteen area had engaged in a heated argument with some vouths of Masiid Colonv that later turned violent around eight days ago. Sources claimed that the



miscreants from Masjid Colony brutally assaulted Behera for allegedly overpricing some paan masala products.

Behera had reportedly lodged a complaint with Capital police in this regard. Police had subsequently left the accused persons by serving notice under Section 41(a) of the CrPC last week.

However, Behera, his brother and other associates harboured a grudge against the rival group over the issue. Both the groups had reportedly entered into a heated argument over the issue Sunday night too.

Master Canteen. Four persons including Sayeed sustained severe injuries in the clash.

On being informed, police officials from Kharavel Nagar and Capital police reached the spot. Sayeed and other injured persons were later rushed to the Capital hospital.

On the other hand, speaking to media persons, relatives of Sayeed accused Behera of selling drugs. Behera allegedly attacked Sayeed as they were opposing him and his brothers.

Bhubaneswar; July 26: The Odisha Human Rights Commission (OHRC) Monday directed the Board of Secondary Education (BSE) not to conduct the offline High School Certificate (HSC) examination for 139 differently-abled students of nine special schools in the state. The commission's direction came

in response to a petition filed by rights activist Manoj Jena over non-declaration of results of 139 differently-abled students.

The Commission stated that in his application, Jena stated that the BSE, without waiting for the final orders of this Commission in the matter, had decided to conduct the High School Certificate examination of the differentlyabled students in offline mode from July 30.

Jena contended that such a decision of the BSE is 'not only arbitrary but also it is intended to put the differently-abled students in utter difficulty during such Covid-19 pandemic situation.'

Taking serious note of the matter, the rights body said it does not find any justification on part of the BSE for such a decision. The OHRC expressed its surprise that dents of general schools have been published without any examination on the basis of marks secured in Class IX and Class X, why the Board is insisting on offline mode examination for the differently-abled students.

In its interim order, the Commission said, "The Board of Secondary Education, Odisha, Cuttack is hereby called up not to proceed with the offline examination of the differently-abled students stated to be commenced from 30.07.2021 till the next date of hearing. It is made clear that if anything untoward happens in the matter affecting the interest of the differentlyabled students it shall be at the sole risk of BSE Odisha and the officer concerned.'

The next hearing has been scheduled for August 6.

Kolkata-based ponzi firm MD held for fraud

Bhubaneswar, July 26: The Economic Offences Wing (EOW) of the state Crime Branch has arrested the top executive of a company from Kolkata in connection with a chit fund fraud case in Balasore, an official said Monday.

According to the EOW, Pratap Kumar Biswal, the chairman-cummanaging director of M/s Mass Infra Realty Limited and president of Human Welfare Credit and Thrift Co-operative Society Limited, has been arrested from New Garia, a posh location in Kolkata, Saturday, Biswal lured people, especially in Balasore, for investing in his chit fund scheme by offering handsome returns and liquid funds.

The arrest was made on the basis of a case registered with the agency July 25, 2021 under Sections 406, 420, 467, 468, 471 and 120B of IPC and Section 6 of the Odisha Protection of Interests of Depositors (in Financial Establishments) Act, 2011.

Hota alleged that Biswal, along with six top executives of the firm, had collected crores of rupees from various depositors by illegally issuing redeemable debentures in his company name. Hota had personally bought debentures with face value of ₹100 to tune of

crores on the pretext of providing high returns on the deposits through their offices at different places in Bhadrak, Kendrapara and Balasore.

"It was found that M/s Mass Infra Realty Limited is registered with ROC in Kolkata during September 2010 under the Companies Act, 1956 having its registered office under Barasat police station at 24 Parganas in West Bengal. Biswal was its chairmancum-managing director and six others were its directors. However, in 2012, it changed its name to Human Welfare Credit and Thrift Co-operative Society Limited registered under Multistate Co- operative Societies Act, 2012 having its registered office in Laxmi Nagar, New Delhi and Biswal was its president," the agency said about the investigation.

The company had lured the general public with false promises of returning high rate of interest on deposits under different schemes of the company and unauthorisedly collected huge sum of money from several investors and absconded from the locality after closing their offices, the EOW said in a statement.

Justifying his claim of "significant improvement in the situation", the official said the daily test positivity rate (TPR) in the state has dropped to 2.19 per cent

from 5.17 per cent June 26. Of the 1,637 new positive cases, 949 were recorded in quarantine centres and the rest detected during contact tracing.

No canal, farmers forced to pay water cess

Kendrapara, July 26: Resentment prevails among the villagers of Kendrapara and Pattamundai tehsils as the revenue department has levied water cess on the farmers in the area despite the fact that there is no canal there, a report said.

According to reports, Dobandha and Sobala villages in Kendrapara tehsil as well as Chandanpur, Nilakanthapur, Tamalasasan, Arua, Keshpur in Pattamundai tehsil do not have a canal to irrigate the agricultural lands of the local farmers.

However, the Revenue department has imposed water cess on the farmers and is asking for payment. This has sparked resentment among the villagers who earn their livelihood from agricultural activities. The villagers have opposed the arbitrary imposition of water cess and demanded its immediate withdrawal.

The villagers have also de-



manded irrigation facilities for their farmlands by digging up a canal and abolition of water cess. Villagers Ranjan Kumar Sahu, Pareswar Samal, Chhatish Kumar Parida and Prafulla Kumar Parida have warned of an agitation by farmers in coming days if the authorities did not begin a proper investigation into the irregularities and took action against those responsible for im-

posing the water cess. They villagers alleged that the Revenue department has imposed water cess on them since long despite absence of a canal in the area. They opposed such an arbitrary move of the Revenue department and have already lodged a complaint in this connection.

Meanwhile, taking note of the complaint, the district Collector had directed for a probe (letter No-33284, dated July 22, 1997) into the charges. In another letter (No. 9354, dated August 4, 1997), the then Collector again directed the Pattamundai tehsildar to conduct a probe and submit a report to him. Later, the villagers filed a petition in the consumer forum in 1998 as the matter was not properly investigated.

The consumer forum heard the matter and directed the tehsildar not to collect water cess from the villagers till irrigation facilities are made available to the farmlands.

However, the tehsil officials refused to abide by the order and went on collecting water cess from the villagers. Since then, the villagers have been paying water cess to the Revenue officials despite the absence of a canal in the area.

The villagers alleged that they are being unnecessarily harassed by the Revenue and tehsil officials on the pretext of water cess. Every time the villagers visit the tehsil office to get any work done, for instance to collect necessary certificates for their children's higher education, the tehsil officials demand that they clear their pending water cess payments.

When contacted, Sub-Collector Niranjan Behera said that the allegations would be probed into. The villagers will be provided with necessary certificates for the higher education of their children after completion of the probe. Moreover, steps will be taken to provide irrigation facilities to the farmlands.

Rape, murder cases on rise in Angul district

Angul, July 26: Incidents of rape and murder are on the rise in Angul district. Such cases are increasing because, as the locals alleged, exemplary punishment is not being given to the accused and the police are not creating awareness about such crimes and the punishment involved

The latest incident that shocked the residents of the district to the core took place July 24, 2021. The victim was a Plus III final year student at Angul College. She had gone to the rivulet near their village to bathe around 8:00 am on the fateful day.

When she did not return home for a long time, her family members launched a frantic search for her. Later, they found her nude body near the rivulet, hidden under leaves and twigs.

The incident enraged the villagers, who along with the victim's family members had staged a road blockade on Angul-Athgarh state highway demanding action against the accused.

Other two sensational cases are the Kangula rape and murder case and the Angul busstand case of 2019. In the first case, a Class VIII girl

was raped and murdered January 20, 2019. She was carrying food for her father, who was working in their farmland. Finding her alone, an accused, later identified as Anam

Dehury, a resident of Kangula village, overpowered her. He not only raped her but also murdered her by hitting on her head with a stone. Far from feeling remorse for what he had done, he turned out to be a necrophiliac and had sex with the body.

The incident had then hugged headlines. Four days after the incident, the police arrested Dehury from Kolkata. But exemplary punishment is yet to be handed out to the accused

The POCSO court had awarded capital punishment to the accused while adjudging it as a rarest of rare case. However, the Orissa High Court had set aside the death sentence.

In the July 21, 2019 incident, an eight-year-old girl was sleeping with her family members on the verandah of a shop in Angul busstand. Shibu Patnaik, a middle-aged man of Amlapada area, who got out of his house between 2:00 am and 4:00 am, saw the girl. He allegedly abducted her and took her behind a nearby Aahaar centre. There he threatened to kill her if she tried to cry for help. Subsequently, he then raped her and left the spot after dumping her in a drain. Later, the victim was rescued in a critical condition and

the accused was arrested. The case is still pending for judgment.According to some intellectuals, in most cases the perpetrators are sort of patients suffering from mental illness. There should be provisions for stringent action against them.

'Many people are losing their thinking capacity due to drug and alcohol addiction. They are no longer able to differentiate between what is right and what is wrong. Watching porn videos is also leading many youths to astray, making them commit such crimes. A stringent law can only make some difference in checking such crimes," observed Dr Rashmita Bhanjdeo, a psychologist.

Expressing her concern over the increasing incidents of rape and murder, a housewife. Sushree Sangeeta Mohanty said, "These cases are increasing because the police are not in touch with the common people and not keeping tabs on criminals. Women and girls are not feeling safe anymore. They are afraid to go out. The police department should be more watchful to put a check on such cases.

When contacted, Anjali Tripathy, a lecturer of Psychology department, Angul College, said there are still some loopholes in the law that help such criminals go scot-free. So the law should be made stringent.

In this regard, Angul SP, Jagmohan Meena said, "We are taking all the rape cases reported at different police stations in the district seriously. After registering cases, we taking actions against the accused. But we have no information regarding several cases that are not being reported. Several cases are coming to the fore after the launch of 'Pink Patrolling'. If the police receive complaints about people having some psycho problems, it will be easy for them to keep tabs on them."

WHO-China Entente

(WHO) he credibility and sanctity of the World Health Organisation - the global body working for the protection of world population against diseases - have never before been dented the way they are now over the origin and control of Covid-19. It is perceived to have aided China in the latter's alleged cover-up of the origin and suppression of facts relating to the spread of the deadly virus. There is even suspicion whether it has from the beginning of the outbreak been dancing to the tune of China desperately trying to exonerate itself from the charge that it is solely responsible for the pandemic. The suspicion is now strengthened by China's stiff resistance to the WHO's plan for the second phase of a study into the origins of Covid-19. Zeng Yixin, Vice-Minister of China's National Health Commission, has expressed shock and surprise that the plan includes further investigation of the theory that the virus might have leaked from a Chinese lab. China has been persistently denying that the lethal virus originated from its lab in Wuhan. Another theory floated in early 2020 was that the virus originated in the wet market in Wuhan. China did not allow WHO experts to visit the lab for a year after the outbreak on one pretext or the other. Now, it has started implicating other countries for the spread by suggesting that the virus might have come from places other than China as the wet market in Wuhan gets its supply from several countries.

The search for the answers to the origin of the Covid-19 outbreak has now become a cause for diplomatic row between China on the one hand and the USA and many of its allies on the other. The latter accuse China of not being transparent about the sequence of events from the first detection and spread of the deadly virus from Wuhan. China's position is that it is being falsely blamed for the pandemic and the matter is being politicised instead of being left to scientists to unravel the truth

And here comes the significance of the role of the WHO. Many questions are being raised about the methods followed by the WHO in declaring the pandemic. It was first in a denial mode over whether the virus spread through human-to-human contact. Then it equivocated on the question of whether the virus got leaked from a Chinese lab or it was a creation of nature jumping from bat to man. It is alleged that Tedros Adhanom Ghebreyesus, the director-general of WHO, was aided in getting elected to this top post by the Chinese vote. The then President of the United States, Donald Trump withdrew funding to WHO on the grounds that it was dithering in exposing the truth and protecting China. Trump had stated that while the USA contributed \$853 million in 2018-19, China put in \$89 million. Now that President Joe Biden has reversed Trump's decision and pledged \$4 billion to WHO, fresh attempts are being made to press China for further investigation into the origin of the virus.

Tedros Adhanom Ghebreyesus finally admitted that there had been a 'premature push' after the first phase of the study in China by WHO experts to rule out the theory that the virus might have escaped from a Chinese government lab in Wuhan. His desperation to save the WHO's reputation is obvious.

The first team of WHO scientists conducted a study in Wuhan earlier this year along with their Chinese counterparts. The team was accused of wilting under Chinese pressure after it suggested further study wasn't necessary. The experts visited markets in Wuhan that sold live animals and recommended further study of the farms that supplied the market. This prompted China to clamour for examining the meat supply chain located in other countries as possible source of the virus.

WHO stated January 14, 2020 that Chinese authorities did not find any clear evidence of human-to-human transmission of the coronavirus. It accepted the Chinese version on the plea that as per procedure, it has to go by the report given by the country first affected. Tedros refused to declare Public Health Emergency of International Concern on the ground that the Emergency Committee was divided on the issue. He declared coronavirus as a pandemic later in March 2020.

Statistics emanating from China continue to fuel suspicion. Only 12 new domestically spread cases were reported last week and China's death toll from the virus has remained unchanged for months at 4,636, although China's statistics are always suspect. It claims to have largely ended local transmission of Covid and has now administered over 1.4 billion doses of Chinese vaccines. The question is whether this proves China's efficiency in tackling Covid-19 or whether it is a typical propaganda to capture the world health market and deflect blame.

By the end of 2021, the pandemic will have pushed approximately 150 million people back into extreme poverty. Even before Covid-19, however, the world was not on track to end extreme poverty in the next decade. Progress on poverty reduction had been slowing long before the pandemic hit, with global poverty rates falling by less than half a percentage point per year between 2015 and 2019. At that pace, even without Covid-19, 537 million people would have still been living in extreme poverty in 2030, implying failure to meet the United Nations Sustainable Development Goals, in particular SDG 1. At BRAC, the world's largest Global South-led NGO, decades of designing, implementing, advising on, and adapting poverty reduction interventions have given us insights into how to make anti-poverty programmes and policies more effective. First, programmes need to reach people in the most extreme states of poverty. People living in extreme poverty face hurdles to accessing social programmes and services. They are less likely to have bank accounts, permanent addresses,

which may be required for regisassociated with receiving public services, and often lack sufficient in-

and training they needed to establish multiple sources of income. As a result, 76 per cent of participants were able to continue earning income even during strict lockdowns.

This must be a collaborative effort. If the international community adopts these steps, anti-poverty programmes and policies can become more inclusive, adaptive, and comprehensive. Beyond engaging civil society and academia, governments need development actors, including multilateral institutions and donor countries, to help close resource gaps until they can independently mobilise sufficient domestic resources. Many low- and middle-income countries simply lack the fiscal space and state capacity to pursue large-scale poverty reduction measures on their own. SDG 1 is deeply connected to the other SDGs, from ensuring gender equality to advancing sustainability to improving nutrition. Covid-19 has reversed decades of progress in these areas, and we need cross-cutting interventions that support multiple areas of development simultaneously if we are to recover. The only way to prevent leaving many people behind is to ensure that anti-poverty interventions are better funded, more holistic, and more effective at scale.

One-off

t comes out of manufacturing, in which off has long been used to mark a number of items to be produced of one kind: 20-off, 500-off. This seems to have begun in foundry work, or a similar trade, in which items were cast off a mould or from a pattern ("We'll have 20 off that pattern and 500 off that other one".) An example is in a book of 1947 by James Crowther and Richard Whiddington, Science at War: "Manufacturers found it very difficult to give up mass production, in order to make the 200 or so sets 'off'." A one-off was just a single item, used in particular to refer to a prototype. The first known example appeared in the Proceedings of the Institute of British Foundrymen in 1934: "A splendid one-off pattern can be swept up in very little time." (The reference is to a casting mould formed in sand.) Out of this came our current figurative sense of something that is done, made, or happens only once - as you say, one of a kind. An example appeared in the Coventry Evening Telegraph in February 2006: "Anyone who would like to donate in Mo's memory is welcome to make a one-off donation or more long-term contributions." It can also be used of a special person, someone for whom it might be said "After they made him, they broke the mould". Here's an example from the Daily Telegraph of 13 April 2006, about Michael Eavis, who runs the Glastonbury Festival: "I have great respect for him. He's a fantastic eccentric, really, a one-off."

Onomasticon

Yediyurappa's exit

The BJP's share of votes was divided, and consequently the Congress government headed by Siddaramaiah came to power. The formation of the KJP also marred Yediyurappa's chances of coming to power. Yediyurappa was implicated in a denotification case and lost ground to Sadananda Gowda who succeeded him. Gowda was later succeeded by Jagadeesh Shettar. This time, pressures from within the party triggered a condition for Yediyurappa to submit his resignation. Yediyurappa should be credited for increasing the age of superannuation for government employees from 58 years to 60 years. He also must be credited for reducing the age of senior citizens from 65 years to 60 years to travel in buses with concession in bus fare by 25 per cent.

Angul, July 26: The district headquarters hospital (DHH) here has received equipment worth crores of rupees under the Odisha government's 'Nirmal Scheme'. These have been given to maintain cleanliness on the hospital premises and also to carry out sanitation on a regular basis. However, the machines have never been used even once.

The 'Nirmal Scheme' launched in 2018-19 aimed to give the staterun hospitals the look and cleanliness of the private medical facilities and to provide patients and their families with a clean and hygienic environment. The scheme was launched with the aim of drawing more people to the government-run hospitals and to provide them with medical facilities at a cheaper rate. However, it seems that the effort has failed at the DHH here.

Under this scheme, a hospital is provided with funds and equipment to keep the floor and window panes clean, repair broken furniture and electrical equipment and to maintain drains and gardens. There are even provisions in the scheme to appoint carpenters and electricians.

So how did the equipment develop problems when they have not been used on a single occasion," Mishra asked. "It may be the firm is trying to wriggle away from its responsibilities to avoid being punished. Overall, it just goes to show how inept the hospital management is," he added.

Angul DHH manager Debashis Das blamed the firm for the present situation. He said in spite of repeated requests, it is not carrying out its responsibilities properly. He said a report on the issue has been sent to the higher ups. When contacted, ADMO

(Medical) Dr Manas Ranjan Biswal admitted that the machines have not been used even once since their procurement. He termed the performance of the contractual firm as 'pathetic'. "The contractor has been asked to file a report in this regard within 15 days. If they fail to do so, stringent action will be taken against it," he asserted.

Jagatsinghpur, July 26: Jagatsighpur district headquarters hospital (DHH) is in the running for 'LaQshva' certificate.

LaQshya is a National Labour Room and Maternity Operation Theatre quality improvement initiative launched by the Ministry of Health and Family Welfare, Government of India.

The final round of assessment to decide whether the DHH is eligible for the 'LaQshya' certificate or not, two national-level assessors – Dr Mrinalini Mani and Dr JL Meena – recently undertook the final assessment virtually.

At the outset, chief district medical and public health officer Dr Bijay Panda welcomed the two assessors and then ADMO (Medical) Dr Ajay Kumar Swain presented the facts and figures of the current year as well as the previous year. Basically he informed them that the maternity mortality rate, child mortality rate and infection rate are lower at the DHH compared to that of the state.



Thereafter, Dr Mrinalini Mani and Dr JL Meena were taken on a virtual visit of the DHH beginning from the facility's entrance to its campus, covering all the sections and wards. They were also informed about the facilities at OT and labour rooms. On this occasion, the assessors interacted with the staff nurses, the gynaecologist, sweepers, attendants and security guards. Dr Rabindranath Pal, Dr Pramod Kumar Nayak, staff nurse in-charge Khulana Barik and Sudhanshu Malini Das were at the labour room Assessors interacted with the staff nurses, the gynaecologist, sweepers, attendants and security guards during a virtual visit

Gujarat 'most favoured state' in 'UP next stop for farmers' stir' **Centre's health allocation: RTI**

Mumbai, July 26: The Centre's National Health Authority (NHA) - has allocated the maximum funds to Guiarat as grant-in-aid for various government schemes under the Avushman Bharat-Pradhan Mantri Jan Arogya Yojana, as per the latest details provided in RTI replies.

The RTI query was filed by Punebased activist Prafful Sarda seeking details of the budget allocated to the overall health sector including the flagship AB-PMJAY. The NHA's replies were star-

tling -- for the current year 2021-2022 (till July 17, 2021) - it said the Centre has released a staggering Rs 330.55 crore as grant-in-aid (GIA) for implementation purpose to Gujarat or the lion's share.

The next on the list is Kerala at Rs 128.62 crore. Maharashtra with Rs 117.43 crore, Andhra Pradesh got Rs 110.95 crore and Madhya Pradesh secured Rs 104.79 crore as GIA.

Among the double-digit states under GIA, Uttar Pradesh was given Rs 75.07 crore. Assam Rs 31.62 crore, Haryana Rs 25.16 crore, Punjab Rs 23.07 crore, Uttarakhand Rs 21.81 crore, Jammu & Kashmir Rs 19.87 crore and Himachal Pradesh Rs 15.09 crore.

Seven states -- Jharkhand. Manipur, Tripura, Nagaland,



Mizoram, Chandigarh and Meghalaya -- were given GIA of less than Rs 10 crore.

Andaman & Nicobar Islands, Dadra & Nagar Haveli, and Puducherry got less than one crore rupees, while Arunachal Pradesh, Bihar, Chhattigarh, Daman & Diu, Goa, Karnataka, Ladakh, Lakshadweep Isles, Rajasthan, Sikkim and Tamil Nadu did not get a single rupee under GIA.

He said that the NHA's official data reveals how -- compared with 2019-2020 (Rs 2,992.94-crore) - the health budget fell steeply for 2020-2021 (Rs.2544.12-crore), when it was required to be enpeared to focus only on Gujarat," said Sarda. Moreover, the activist rued that the RTI reply by NHA's Director & CPIO Pankaj Kumar Arora sheds no light on what exactly is the 'grant-in-aid for implementation

purpose'. "What is the basis for the allocation of these critical funds to different states, especially considering the Covid situation in which Maharashtra is the worst-hit state in terms of total cases and fatalities, but it is always Gujarat which is the 'most favoured state for the Centre," Sarda pointed out.

Lucknow, July 26: After the Bahujan Samaj Party (BSP), more and more political parties are taking to what is now being termed as the 'Parshuram Path' in Uttar Pradesh to woo Brahmins.

The Samajwadi Party and the Congress have also hitched on to the Brahmin bandwagon, making the upper caste community a much sought after vote bank.

Samajwadi Party president Akhilesh Yadav held a meeting with five senior Brahmin leaders of his party -- former UP Assembly Speaker Mata Prasad Pandey, Manoj Pandey, Abhishek Mishra, Sanatan Pandey and Pawan Pandey.

During the three-hour long meeting, it was decided that the party will hold 'Prabuddh Varg Sammelans' from next month to establish a contact with the Brahmin community.

The first sammelan will be held in Siddharth Nagar August 22, Ballia August 24 followed by similar events in Mau and Aurraiya August 25 and 26

Akhilesh Yadav also formed a core committee of the five leaders to plan the Brahmin outreach, issues and strategy.

SP's effort to woo Brahmins comes at a time when the BSP is also holding Prabuddh Varg Sammelans to win over Brahmins.

However, SP president has specifically asked his leaders not to go overboard or play the Hindutva card which may jeopardise the party's Muslim outreach. Muslims form the core base vote of the Samajwadi Party in UP.

RFQ sought for makeover of Surat, Udhna 'Railpolis'

Ahmedabad, July 26: The Indian **Railway Stations Development** Corporation has invited Request for Qualification (RFQ) for the transformation of Surat and Udhna stations in Gujarat into what the nodal agency called 'Railpolis', or a mini smart city where one can "Live. Work. Play and Ride".

The IRSDC, in a release, said the aim was to redevelop them as "integrated railway stations and subcentral business districts to transform station estate and surroundings using Transit-**Oriented Development and Smart** City principles.³

Redeveloped Surat railway station will have provision of central concourse and walkways as passenger interchange plaza to provide seamless inter-connectivity to railway platforms, state and city bus terminals, proposed metro rail, parking and other recreational zones, the release added.

Similarly, Udhna railway station will be redeveloped with better connectivity and a circulation plan for hassle-free approach, concourse for departing passengers, as well as segregation of departing and arriving passengers, the IRSDC said.



The indicative cost of the redevelopment of the two stations is Rs 1,285 crore over a four-year timeframe, with the pre-bid meeting scheduled to be held August 6 and the deadline for submissions being August 31.

"The stations will be redevel oped in line with global standards to transform them at par with international airports and provide world-class amenities to travellers. The Surat railway station is envisaged to be redeveloped into a multi-modal transport hub (MMTH), thus providing a hasslefree and comfortable travel experience to the commuters," said SK Lohia, MD and CEO, IRSDC. The redevelopment of the sta-

tions will be carried out by IRSDC

Redeveloped Surat railway station will have provision of central concourse and walkways as passenger interchange plaza to provide seamless inter-connectivity to railway platforms, state and city bus terminals, proposed metro rail, parking and other recreational zones

on behalf of a special purpose vehicle, Surat Integrated Transportation Development Corporation Limited (SITCO), a joint venture between IRSDC, Gujarat State Road Transport Corporation (GSRTC) and Surat Municipal Corporation (SMC).

Work on the redevelopment of 125 stations across the country is currently in progress, with the total investment required beingin the range of Rs 50,000 crore, the IRSDC said.

Snooping scandal rocks Parl for 5th day



Kolkata/New Delhi, July 26: West Bengal Monday set up a Commission of Inquiry to probe allegations of snooping on politicians, officials and journalists in the first move by a state seen as an attempt by Chief Minister Mamata Banerjee to put pressure on the Centre over the Pegasus phonehacking scandal which rocked Parliament for the fifth day.

As Banerjee made the announcement to up the ante over the Pegasus spyware row in a surprise development that came shortly Trinamool before the Congress(TMC) supremo headed to New Delhi, the Congress claimed that the entire opposition is "united" in demanding a discussion on the snooping row in Parliament. The Congress also said the op-

position wants a Supreme Courtmonitored inquiry into the entire scandal while a party leader Shashi Tharoor indicated that opposition



parties would continue to disrupt Parliament's proceedings until the government agrees to a debate. Former chief justice of Calcutta High Court Jyotirmay Bhattacharya and ex-Supreme Court judge Madan

Bhimrao Lokur will be the two members of the Commission of Inquiry(CoI) announced by the West Bengal government. "Sometimes, you need to wake up some people when they are sleep-

ing. I believe that this small step taken by us (West Bengal government) will awaken others ... I will request Justice Bhattacharya and Lokur saheb to immediately start the investigation," said Banerjee, who had last week accused the Modi government of trying to establish a "surveillance state".

The chief minister said West Bengal had hoped that the Centre would form an inquiry commission or a court-monitored probe would be ordered to look into the phone-hacking incident.

"But the Centre is sitting idle... So we decided to form a Commission of Inquiry to look into the matter. West Bengal is the first state to take a step in this matter.'

Banerjee said the state Cabinet approved the appointment of a Commission of Inquiry in exercise of power conferred by Section 3 of the Commission of Inquiry Act of 1952 in the matter of widely reported illegal hacking, monitoring, putting under surveillance, tracking and recording of mobile phones of various persons in West Bengal.

Banerjee said the panel will try to find out who all are involved in hacking the phones and how are they doing it. Also, it is important to look into the steps that have been taken to stop this illegal activity, she told a press conference in Kolkata before leaving for New Delhi, where she is also scheduled to meet Prime Minister Narendra Modi.

Under the Commission of Inquiry Act, both the Centre and states can institute a probe.

Mumbai/Pune, July 26: The death toll in rain-related incidents in Maharashtra rose to 192 Monday after the recovery of 28 more bodies, most of them in Raigad, the state government said, while Deputy Chief Minister Ajit Pawar toured flood-hit villages in Sangli district and said a decision on providing financial relief will be taken in a couple of days.

As many as 48 persons were injured in these incidents and 25 still missing, while so far, 2,29,074 perflood and rain-affected affected areas and moved to safer places, the government said in a statement in Mumbai.

Giving the district-wise break up of fatalities in heavy rains and floods since last week, the official statement said Raigad has reported 95 deaths, Satara 45, Ratnagiri 21, Thane 12, Kolhapur 7, Sindhudurg, Akola, Pune and Wardha 2 each, and Mumbai 4 (total 192).

The administration of Raigad. the worst-hit district located in the coastal Konkan region, earlier Monday called off the search operations for 31 missing people in Taliye village which was ravaged by a massive landslide after heavy rains last week, Collector Nidhi Chaudhari said.

The village, located in Mahad taluka of Raigad, witnessed the deadly landslide last Thursday after heavy rains, flattening several houses in the area. The collector said the decision to call of the search operations was taken after

Disaster Response Force (NDRF) and the disaster response forces of the state and neighbouring Thane district.

'The rescue operations have ended officially. We have withdrawn our teams from Taliye. The 31 missing will be declared dead following the due process. Relatives of the missing people demanded closure of the operations since yesterday," the collector said earlier in the day.

Chief Minister Uddhav Thackeray visited the village Saturday and said as landslides proved fatal in many parts of the state, the government would come up with a plan to permanently relocate people living in hilly areas. A decision on providing relief to the people affected by floods will be taken in the next couple of days, Deputy CM Ajit Pawar said after he toured various rain-hit villages in Sangli district and used a rescue boat to reach out to victims in some areas Monday

Amid worsening relations between the world's two largest economies, Deputy Secretary of State Wendy Sherman, the secondranking US diplomat, arrived Sunday for face-to-face meetings in the northern city of Tianjin that the US State Department described as frank and open.

No specific outcomes were agreed and the prospect of a meeting between US President Joe Biden and Chinese President Xi Jinping was not discussed, senior US administration officials said following talks that lasted about four hours. China seized the early narrative, with state media reporting

on confrontational remarks by Vice Foreign Minister Xie Feng soon after the session began, in echoes of a similarly combative opening by senior Chinese officials during high-level talks in March in Alaska. Foreign media were kept at a distance from the site of the talks,

'Covid substantially impacts patients' intelligence'

London, July 26: A severe coronavirus infection, involving hospitalisation and ventilator support, has a substantial impact on a recovered patient's intelligence as part of wider Long-Covid symptoms, a UK study has found.

Scientists tested 81,337 participants between January and December 2020 with a clinically validated web-optimised assessment as part of the Great British Intelligence Test. The questionnaire items captured self-report of suspected and confirmed Covid-19 infection and Scientists say the findings should act as a "clarion call" for further research with longitudinal and neuroimaging cohorts to plot recovery trajectories and identify the biological basis of cognitive deficits in SARS-COV-2 or Covid-19 survivors

respiratory symptoms.

"These results accord with reports of long-Covid, where 'brain fog', trouble concentrating and difficulty finding the correct words are common," notes the study published in 'The Lancet -EclinicalMedicine' journal last week

"The scale of the observed deficit was not insubstantial ... When examining the entire population, the deficits were most pronounced for paradigms that tapped cognitive functions such as reasoning, problem solving, spatial planning and target detection whilst sparing tests of simpler functions such as

working-memory span as well as emotional processing," it said.

One possibility was the observed cognitive deficits related to ongoing symptoms of the deadly virus, such as a high temperature or respiratory problems, with 4.8 per cent of participants who were ill reporting residual symptoms.

People who had recovered from Covid-19, including those no longer reporting symptoms, exhibited significant cognitive deficits versus controls when controlling for age, gender, education level, income, racial-ethnic group, pre-existing medical disorders, tiredness, depression and anxiety.

Vatican's once-secret financial dealings and its structural dysfunction, which allowed just a few people to do so much damage to the Vatican's finances and reputation. with little expertise or oversight.



But the prosecutors' case also suggests that Pope Francis and his top lieutenants were not only aware of some of the key transactions, but in some cases explicitly authorised them, even without full documentation or understanding the details. Given the hierarchical nature of the Holy See and the obedience required of underlings to their religious superiors, questions also remain about why some people were charged and others not.

One Vatican monsignor who until recently was considered by prosecutors to be a key suspect, Monsignor Alberto Perlasca, managed to avoid indictment.

Perlasca's office handled the London investment from start to finish and his boss had identified him as the main in-house culprit in obscuring the deal's costly outcome. But prosecutors suggested that Perlasca flipped and became an important witness, in part after coming under pressure to recant his testimony by the lone cardinal on trial, Angelo Becciu.

Francis, who as absolute monarch wields supreme legislative, executive and judicial power in Vatican City, has in many ways already convicted Becciu.

Last year, Francis presented Becciu with evidence that he had sent 100,000 euros in Vatican funds to a Sardinian charity run by Becciu's brother. Francis secured Becciu's resignation as head of the Vatican's saint-making office and then stripped him of his rights as cardinal, a sanction that was announced immediately by the Vatican press office.

Becciu, who is charged with embezzlement and pressuring-Perlasca to recant, has denied any wrongdoing.

New Delhi, July 26: The government has no plan to print currency notes to tide over the current economic crisis triggered by the outbreak of Covid-19 pandemic, Finance Minister Nirmala Sitharaman informed Parliament Monday. To a question on whether there is any plan to print currency to tide over the crisis, the Finance

Minister said, "No Sir' Many economists and experts have suggested to the government to print more currency notes to tide over the difficult economic situation with a view to support the economy ravaged by the spread of Covid-19, and protect jobs.

In economic parlance, printing of money is called monetisation of the deficit. In other words, monetisation of the deficit happens when the Reserve Bank of India (RBI) buys government securities directly from the primary market to fund the government's expenses.

India's real Gross Domestic Product (GDP) is estimated to have contracted by 7.3% during 2020-21, Sitharaman said in a written reply to Lok Sabha. This contraction reflects the unparalleled effect of the pandemic and the containment measures that were taken to control the pandemic, she said. "The fundamentals of the econeconomy firmly on the path of recovery from the second half of FY 2020-21," she said.

The government had announced a special economic and comprehensive package of ₹29.87 lakh crore under 'AtmaNirbhar Bharat' to combat the impact of the pandemic, to revive economic growth and to bolster employment during 2020-21, she said.

The Union Budget 2021-22 announced a number of measures to support broad-based and inclusive economic development including a 34.5% increase in capital expenditure and 137% increase in health expenditure, she said, adding, the government announced a relief package of ₹6.29 lakh crore in June 2021, to strengthen public health and provide impetus for growth and

employment measures. Replying to another question, Sitharaman said, the impact of the second Covid-19 wave is expected to be muted given localised containment measures and rapid upscaling of the vaccination drive. The Union Budget 2021-22, estimates India's nominal GDP growth at 14.4% during the current financial year ending March 2022.

The RBI, in its latest Monetary Policy Committee (MPC) resolution of June 4, 2021, has projected India's real GDP to grow at 9.5% in 2021-22, after accounting for the impact of the second wave as compared to its earlier projection of 10.5%, she said.

Enterprises (MSMEs). Generally, under a pre-packaged process, main stakeholders such as creditors and shareholders come together to identify a prospective buyer and negotiate a resolution plan before approaching the National Company Law Tribunal (NCLT). All resolution plans under IBC need to be approved by NCLT.

As per the Statement of Objects and Reasons of the bill, it seeks to specify a minimum threshold of not more than ₹1 crore for initiating pre-packaged insolvency resolution process as well as provisions for disposal of simultaneous applications for initiation of insolvency resolution process and pre-packaged insolvency resolution process, pending against the same corporate debtor.

There would be a penalty for fraudulent or malicious initiation of pre-packaged insolvency resolution process or with intent to defraud persons.



After the 1-5 drubbing at the hands of World No.1 Netherlands, the Indians lifted their game but it was not enough to get past World

No.3 and Rio Games bronze-medallists Germany in their second Pool A match at the Oi Hockey Stadium. Indian will play Great Britain in their next pool match Wednesday.

The team was guilty of wasting a lot of opportunities, including a penalty stroke by Gurjit Kaur in the third quarter while luck also didn't favour the Rani Rampal-led side. Skipper Nike Lorenz (12th minute) and Anna Schroder (35th) were the goal scorers for Germany, who registered their second win on

-medalnd Pool 2-1 in their first match.

The Germans started on a bright note and had most of the possession early on but India slowly and steadily made their presence felt in the match. Germany had the first shot at the goal but India goalkeeper Savita was at the right place to deny Franzisca Hauke in the ninth minute.

But three minutes later the Germans were not to be stopped as skipper Nike Lorenz flicked the ball past Savita from their first penalty corner. The Germans were more aggressive in the first half and got another penalty corner in the 21st minute but India this time defended stoutly. The Rani Rampal-led side upped

its game by a notch compared to the first game against Netherlands and penetrated the German circle on a quite a few occasions. But what let them down was finishing and a brave and strong German defence as India went into half time trailing by a goal.

The Indians came out with purpose after the change of ends and looked threatening, mounting attacks as the Germans got busy in defending their citadel. Vanadana Katariya had an excellent game as she created numerous chances for her side but the forward-line erred in the final touch.

Two minutes into the third quarter, it was Vandana who helped India secure its first penalty corner of the Games. Skipper Rani stepped up and her goalmouth strike hit the body of a German defender. India straight sought referral for a penalty stroke and duly got one but Gurjit failed to find the back of the net as her effort struck the side post.

The Germans punished India three minutes later when Schroder scored with a fierce hit from top right corner of the circle to double her side's lead. The Indians didn't lose hope and continued their attacking play but they failed to penetrate the German defence.

On two occasions, Vandana came close to scoring – first she was denied by the German keeper from a one-on-one situation with a brilliant save and then her deflection from Navneet Kaur's pass hit the top of the post in the 46th minute.

The Germans secured another penalty corner soon but faltered in execution. Thereafter, the Germans mostly tried to keep the possession, denying India any inroads.

Tokyo: India's first ever fencer in the Olympics, CA Bhavani Devi, lasted two rounds at the Games, her historic maiden appearance ending with a loss to world number three Manon Brunet in the women's individual sabre event here Monday. The 27-year-old began her campaign with a confident 15-3 win against Tunisia's Nadia Ben Azizi but bumped into Rio Olympics semifinalist Frenchwoman Brunet in the next round, which she lost 7-15. The sabre is the fastest of the fencing competitions in which opponents can slash anywhere above the waist. The fencer who touches the 15 point-mark first is declared the winner. In the other two events – foil and epee – only the tip of the sword can be used to target the opponent.

ANGAD FINISHES 18TH IN SKEET

TOKYO: India's Angad Vir Singh Bajwa finished 18th while his senior compatriot Mairaj Ahmad Khan ended 25th in the men's skeet event of the Tokyo Olympics here Monday. The 25-year-old Angad shot 120 across five series and Mairaj could manage only 117 at the Asaka Range. Placed a creditable 11th overnight and eyeing a finals berth at the end of the first three rounds, Angad missed his target thrice on the second day of the qualifying to bow out of contention without a fight. His sequence of scores read 24, 25, 24, 23, 24. On the other hand, Mairaj was could not improve on his overnight position and ended the competition with scores of 25, 24, 22, 23, 23 for a total of 117.

Satwik–Chirag overpowered

Tokyo, July 26: India's leading player Sharath Kamal overcame a sluggish start to beat Portugal's Tiago Apolonia in the men's singles second round while the women challenge ended with Manika Batra and Sutirtha Mukherjee losing to their superior opponents at the Olympics here Monday.

The 39-year-old Sharath struggled in the first game but pulled himself up just in time to win 2-11, 11-8, 11-5, 9-11, 11-6, 11-9 in 49 minutes to set up a clash with defending champion Ma Long from China.

Later in the day, Manika's impressive campaign in the women's singles came to an end with a 0-4 loss to 10th seed Sofia Polcanova in the third round.

The star Indian player, who had

stunned World No.32 Sunday, did not have the game to challenge the attacking left-hander from Austria. The only Indian left in the fray, Sharath, faces reigning Olympic champion Ma Long of China in the third round Tuesday. Arguably the greatest player of all time, Long has won every singles title in the sport, and is the reigning World Champion as well.

However, with the way the 32ranked Sharath played against his 59th-ranked opponent, it has given him immense confidence going into the round of 32 match against the mighty Chinese.

Sharath is known for his booming forehand winners but an improved backhand allowed him to finish from both flanks. Since Ma Long will be playing his first match, Sharath sees an opening there.

Mukherjee was no challenge to 42-year-old Yu Fu as the Chinaborn bested her in straight sets in the women's singles second round. Earlier, Sutirtha lost her second round match to Portugal's Yu Fu in straight games to crash out of her maiden Olympics.

Archers fail to get past Korean hurdle

TOKYO: Indian archers bowed out of the team events after failing to get past the mighty Koreans for a second time in the Tokyo Olympics here Monday.

Two days after the mixed team was knocked out by Korea in the quarterfinals, the men's trio of Pravin Jadhav, Atanu Das and Tarundeep Rai succumbed in straight sets against their formidable opponents in the same round of eight stage. South Korea went on to win the title by smashing Chinese Taipei 6-0.

The twin blow exposed their pathetic shooting in the ranking round Friday when all the male archers finished outside top-30, handing them tough draws.

Their first-ever Olympic medal hope in archery is fading fast as they will brace for a tougher road ahead in their respective round of 64 individual matches beginning

Wednesday. The Indian men's team, which

won a silver at the last World Championships in 2019, started the day at the Yumenoshima Park with a lot of promise, downing Kazakhstan 6-2.

But the Korean team of London 2012 champion Oh Jin Hyek, Kim Woojin and 17-year-old Kim Je Deok – the youngest archer at Tokyo Olympics – proved to be too strong against for the Indians.

In pursuit of a sixth men's team title from nine Olympics, the Korean men's team enjoyed a flying start, shooting 10 perfect 10s from 12 arrows while missing only two in the first two sets to apply early pressure. India were let down by Guatemala

City World Cup gold medallist Das who failed to repeat his brilliant show earlier against Kazakhstan. He could not find a single 10 in the three sets. Nagal had earned his moment under spotlight when he took a set off Swiss great Roger Federer at the 2019 US Open on his Grand Slam debut.

Nagal began by dropping his serve in the very first game of the match when he netted a backhand and match ended when his forehand sailed over the baseline on match point while serving to stay in the contest.

Medvedev's powerful strokes from the baseline overwhelmed Nagal, whose game was not enough to trouble a much superior opponent.

The Indian managed to hit a few winners but they were very few. The match ended when Nagal dropped his serve in the seventh by hitting a forehand long.

Nagal had won his first round against Uzbekistan Denis Istomin for India's first men's singles win at Olympics in 25 years.


