Bhubaneswar, July 31: The Bhubaneswar Municipal Corporation (BMC) Saturday claimed to have achieved 100 per cent vaccination against Covid-19 in the state capital making Bhubaneswar first city in the country of the coun

Sethi, said that the civic body had targeted about 18.14 lakh beneficiaries with either first or second dose in all age groups. Out of this, 18.35 lakh doses have been administered till Friday, thereby 100% achieving vaccination in the city.

"Out of the 18.35 lakh doses, 10.59 lakh people have taken their first dose of the vaccine. Similarly, 7.7 lakh beneficiaries in the city have already received their final shots. We have covered a wide range of beneficiaries including those from rural areas on the outskirts of the town. A huge number of outsiders keep commuting to the city for doses regularly and no one has been ignored," Sethi said.

He added that observing the drop in demand for vaccination, they have now decided to close the drivein centers in the city. It may be mentioned here that the BMC had earlier opened more than 10 drivein centers across the city.

The rush of beneficiaries has declined substantially. Currently, only people who have missed their dose or who are due for second shot are visiting the centres. The inoculation centres at UPHCs and mobilised centres will remain functional as vaccination of pregnant women in the city is still in progress," he added.


### **PS of OSSC member** arrested in DA case

### **India, China hold 12th** round of military talks

The 12th round of Corps Commander-level talks are taking place at the Moldo border point on the Chinese side of the Line of Actual Control (LAC) in eastern Ladakh, they said. The talks started at 10:30 am as scheduled, said a source.



### MALLS, CINEMAS, PARKS TO REOPEN

government Saturday announced to furnish certificates of their secfresh Covid-19 unlock guidelines for the month of August. The new norms will be effective from 6 am of August 1 and continue till 6 am of September 1.

According to the new norms, weekend shutdown will be in force only in three cities - Bhubaneswar, Cuttack and Puri where the Covid-19 caseload is higher compared to the rest of the state.

The SRC also said that henceforth all shops and malls would be allowed to keep their premises open from 6am to 8pm every day except during the weekend shutdowns in the above three cities. The mall authorities and shopkeepers have now been asked to take special measures to ensure social distancing and follow the Covid-19 appropriate behaviour on their premises.

On the other hand, prohibition on all religious, political and cultural gatherings besides exhibitions, trade fairs, and melas will continue across the state.

Jena further said that sea beaches, parks, malls, restaurants and dhabas will be allowed to open, but with compliance with Covid guidelines. Restaurants, bars and dhabas too have been allowed to operate with

50 per cent of their seating capacity. In a major development, cinema halls have also been granted per-

mission to open with 50 per cent seating capacity. However, people going Bhubaneswar, July 31: The state to cinema halls would be required ond dose of vaccination

> Street food vendors have alsobeen allowed spot eating in accordance with Covid guidelines. Daily and weekly haats have also been allowed to open but the local authorities have been asked to ensure social distancing in such places. All inter-state and intrastate buses have been allowed to operate but with only as per as their seating capacity.

The government has, meanwhile, asked the administrations of Srimandir and Lingaraj temple to decide on the opening of their premises. However, devotees will not be allowed to offer prasad or bhoga. Jatra, operas and open air theatres have also been permitted to operate with 50 per cent of their capacity.

Marriage ceremonies with 25 guests have also been allowed but community feasts are banned. Funeral activities are allowed with not more than 20 persons. Museums, zoos, archeological monuments have also been allowed to open in

the state. Meanwhile, according to an analysis of ICMR's fourth sero-survey by independent epidemiologist Dr Chandrakant Lahariya, for every single Covid-19 case reported in India, there were 30 cases that remained undetected or were missed.

## Girls outshine boys in CHSE +2 exams

Students dissatisfied with their marks can sit for offline exams

Bhubaneswar, July 31: Results of the Plus II Science and Commerce examinations assessed by the Council of Higher Secondary Education (CHSE), Odisha, were declared by the School and Mass Education Minister, Samir Ranjan Das, Saturday evening.

While 95.15 per cent examinees secured pass marks in Plus II (Science), the pass percentage in Plus II (Commerce) is 94.96. Last year, the pass percentage of Plus II (Science) was 70.21, while 74.95 per cent students cleared the examination in the Commerce stream.

In Science stream, 89,951 students of the total of 94,532 who appeared for the examination secured pass marks While 55,468 examinees secured 1st division, 16,943 got 2nd division, 14,631 passed in 3rd division. Overall, 2,278 students got more than 90 per cent in

A total of 50,198 boys and 39,753 girls were assessed for the Plus II (Science) examination this year.

This year too, girl students outshone the boys in the Science stream. The total pass percentage of girl students stands at 96.03 per cent, while 94.46 per cent boys cleared the Plus II (Science) examination.

In the Commerce stream, 24, 526 students were assessed for the examination and 23,292 secured pass marks. Of them, 8,355 students got 1st division, 5.692 2nd division and 9.066 secured 3rd division. Overall. 149 students got more than 90 per

Meanwhile, School and Mass dents who are dissatisfied with their marks can file complaints with the principals of their respective schools and colleges along with their marksheets and they will be sent it to Controller of Examination on-line for re-valuation. He added that students who want to sit for offline exams can do so after a notification is issued in this regard.


### Pulwama attack conspirator killed in J&K encounter

Srinagar, July 31: A top Jaish-e-Mohammad (JeM) commander and another militant were killed in a gunfight in south Kashmir's Pulwama Saturday morning. Police claimed the commander hailed from Masood Azhar's family and was behind the 2019 Lethpora car bomb blast.

Mohammad Ismail Alvi, also known by his code names Adnan and Lamboo, was killed in a gunfight when a joint team of forces cordoned off Nagberan Tarsar village in the forest area falling under the Dachigam of south Kashmir's Pulwama after inputs about their

The militants opened indiscriminate fire and tried to break the security cordon. The joint team of forces retaliated, leading to an encounter in which the two were killed. Police said the identity of the second militant is being ascertained.



"Mohd Ismail Alvi was from the family of Masood Azhar. He was involved in conspiracy and planning of the Lethpora Pulwama attack and figured in the charge-sheet produced by the NIA," police quoted Kashmir Inspector General of Police (IGP) Vijay Kumar in a tweet.

## Sindhu loses to Tai Tzu, to fight for bronze

Tokyo, July 31: Reigning world champion PV Sindhu's hopes of securing India's first ever Olympic gold in badminton came crashing down as she slumped to a straightgame defeat against world No.1 Tai Tzu Ying of Chinese Taipei in the women's singles semifinals here Saturday.

The 26-year-old silvermedallist from the Rio Games, however, remained in the hunt for a bronze and

One of the most consistent players, who have claimed medals in all big-ticket events in the last five years, Sindhu couldn't counter Tai Tzu's deception with her aggressive game, going down 18-21 12-21 here.

Tai Tzu tried to play an aggressive game, cramping Sindhu with her sharp returns from near the net.

The two played some exquisite rallies with Sindhu equalling her opponent and also unleashing a few smashes to lead the opening game for most parts.

She was up 7-3 with Tai Tzu com-

mitting a few unforced errors and entered the interval with a healthy 11-8 lead. Tai Tzu, however, quickly erased the deficit after the break. She started putting doubts in her opponent's mind with her deceptive

## NSO blocks Pegasus use by some govts

Washington, July 31: Israeli cybersecurity company NSO Group, which is at the centre of the Pegasus snooping scandal, has temporarily blocked several government clients around the world from using its spyware technology as the firm probes its alleged abuses, according

to a US media report. The alleged use of the Pegasus software to spy on journalists, human rights defenders, politicians and others in a number of countries. including India, triggered concerns over issues relating to privacy.

The suspensions are in response to an investigation by the Pegasus Project, a consortium of media outlets that reported the company's Pegasus spyware was linked to hacks and potential surveillance.

"There is an investigation into some clients. Some of those clients have been temporarily suspended,' National Public Radio (NPR) quoted a source in the Israeli company as saying. The source, a company employee, did not name or quantify the government agencies – or their countries - which NSO has recently

suspended from using its spyware, asserting that Israeli defence regulations prohibit the company from identifying its clients, the report by NPR, an independent, nonprofit media organisation, said.

NSO's ongoing internal investigation checked some of the telephone numbers of people that NSO's clients reportedly marked as potential targets. "Almost everything we checked, we found no connection to Pegasus," the employee said, declining to elaborate on potential misuse NSO may have uncovered.

NSO "will no longer be re-

sponding to media inquiries on this matter and it will not play along with the vicious and slanderous campaign," the employee, who spoke

on condition of anonymity because of company policy, said. The Israeli government has also

faced pressure since it regulates the sale of spyware technology to other countries. It has launched a probe into allegations against NSO.

Israeli officials inspected NSO's office in Herzliya, near Tel Aviv, Wednesday "to assess the allegations raised in regards to the company," the Defence Ministry said in a statement. The NSO employee said the company was cooperating fully with the probe and sought to prove to Israeli officials that the people named in the media reports were not Pegasus targets

Mercury Public Affairs, which represents NSO Group, Thursday said in a statement: "The company is working in full transparency with the Israeli authorities. We are confident that this inspection will prove the facts are as declared repeatedly by the Company against the false allegations made against us in the recent media attacks." NSO says it has 60 customers in 40 countries, all of them intelligence agencies, law enforcement bodies and militaries, the reports said.







## **CM** writes to Centre over fert crunch

Bhubaneswar, July 31: Chief Minister Naveen Patnaik Saturday urged the Centre to supply adequate fertilisers to the state as the farmers were facing shortages during the peak of the Kharif cultivation season.

Naveen said a short supply of fertilisers may 'unnecessarily invite law and order situation in most of the districts'

In a letter to Union Chemicals and Fertilisers Minister Mansukh Mandaviya, Patnaik said a short supply of fertilisers may "unnecessarily invite law and order situation in most of the districts".

"I, therefore, request your personal intervention in the matter for supply of fertilisers to the state as per the monthly agreed supply plan including the backlog of the previous months for smooth distribution in the greater interest of farmers," he wrote.

Patnaik pointed out that the allocation declined during the peak demand period of May, June

"During May, June and July



there has been severe short supply of different fertilisers. During current Kharif till date, the state has received only 1,45,145 MT of urea against the allocation of 2,31,530 MT and agreed supply plan of 2,10,000

The Chief Minister noted that during the period the state received 97,763 MT of DAP against the allocation of 1,52,000 MT and agreed supply plan of 1,45,000 MT.

Overall, the supply of fertilisers was 60-74 per cent against the agreed supply, he mentioned in the letter

Stating that farmers in the state suffered severe crop loss due to cyclone Yaas, Patnaik said that to optimise their production, the supply of the most critical input like fertiliser should be as per requirement.

### BJD MPs' memo to Mandaviya


BHUBANESWAR: A delegation of BJD MPs Saturday met Union Chemicals and Fertilisers Minister Mansukh Mandaviya and drew his attention towards the shortage of fertilisers in the state.

The MPs told Mandaviya that the state is facing a shortage of fertiliser supply for Kharif 2021. While the requirement for urea is 2.1 lakh metric tonne (MT), the state has got only 1.45 lakh MT. Similarly, there are short supplies of Di-ammonium Phosphate (DAP) and Muriate of Potash (MOP).

The delegation also cited the letter by Chief Minister Naveen Patnaik to the Union Minister on the issue and demanded his personal intervention for ensuring welfare of the farmers of Odisha.

Meanwhile, the BJP refuted the claims and alleged that the Chief Minister and the BJD MPs are politicising the issue. Party leader Pradeep Purohit said, "Such steps will only lead to black-marketing of fertilisers and create an artificial

shortage of the product. It is not the Union government who will tackle the issue, it is the duty of the state government to monitor it at local level," he said. He also added, "Every year the state received fertilizers more than it demanded. There is no truth about less allocation of the same. In July the state needed 0.90 MT of urea whereas it has a total of 2.20 MT of urea available by July 30. Already, 0.90 MT of urea was sold during the month. The state has a surplus urea now," he said.

### Tighten norms in districts with above 10% TPR, states told

New Delhi, July 31: Amidst threat of a third wave of Covid-19 in the country, Union Health Secretary Rajesh Bhushan Saturday chaired a high-level meeting to review the pandemic situation in Odisha and nine other states. The Health Ministry reviewed the

public health measures introduced for surveillance, containment and management of Covid-19 pandemic by the health authorities in Kerala, Maharashtra, Karnataka, Tamil Nadu, Odisha, Assam, Mizoram, Meghalaya, AP and Manipur.

In order to contain the spread of the virus, the Health Ministry advised the states to clamp strict restrictions in the districts reporting test positivity rate (TPR) more than 10 per cent. It asked the states to curtail movement of people, formation of crowds and intermingling of people to check the infection.

"More than 80 per cent active cases in these states are reported to be in home isolation. There is need to effectively and strictly monitor these cases so that they are not intermingling and circulating in their neighbourhoods, community, village, mohalla and ward, and spreading the infection," he said.

The ministry also asked the states to keep tabs on those districts where the positivity rate is less than 10 per cent. The health authorities of the states were advised to protect the people of these districts through vaccination.

"The people in home isolation should be effectively monitored while those requiring hospitalisation should be shifted seamlessly and provided with clinical treatment. Detailed SOPs covering various facets of effective clinical management of Covid patients in hospitals have been earlier shared with the states," the Health Secretary said.

## OSSC member PS's wealth 268% more than his income

Bank officials were asked to share account statements of Sahoo to know whether any applicant had transferred money to his account

Bhubaneswar, July 31: Biranchi Narayan Sahoo, personal secretary to the member of Odisha Staff Selection Commission (OSSC), who was arrested by the Vigilance Saturday, was found to be possessing disproportionate assets of 268 per cent of his known sources of income.

The anti-corruption sleuths have started the process to find out how Sahoo amassed such huge amount of wealth. The Vigilance department has asked the bank officials to share the account statements of Sahoo to know whether any applicant had transferred money to his account. Vigilance sources claimed that the seizure of admits cards of applicants from Sahoo's residence indicated towards possible recruitment scam in OSSC.

Sahoo could be brought on remand as well for further enquiry. The Vigilance officials will try to find out if there is any involvement of other OSSC staffers/staffer in the alleged examination scam.

Speaking on the issue, Vigilance director YK Jethwa Saturday said that further action would be taken in this regard as per law after verification of seized items.

On the other hand, OSSC chair-



man Nirmala Chnadra Mishra denied any wrongdoing in the recruitment processes. He also claimed that action will be taken against Sahoo following an internal enquiry in the matter.

Meanwhile, Sahoo told media that he has no role in examination process and none has taken money for it. He claimed the raid and his arrest were deliberate attempts to harass him.

The officials arrested Sahoo by registering a case (16/21) Saturday. Earlier, the officials of anti-corruption wing Friday carried out simultaneous raids on houses of Sahoo and his relatives at six places in Bhubaneswar and Cuttack. They unearthed properties worth over ₹3.79 crore that includes ₹25 lakh

in cash, 1.5 kg gold ornaments worth over ₹60 lakh and 14 landed plots in Bhubaneswar, Khurda and Puri possessed by Sahoo.

"He(Sahoo) was found in sion of assets disproportionate to the known sources of income to the tune of ₹.3,51,51,921 which constitutes 268% of his known sources of income," claimed Vigilance sources.

Interestingly, the officials also recovered admit cards of various applicants in connection with different recruitment tests under OSSC. The seizure of admit cards of applicants and bank slips revealing huge deposits indicate towards his active involvement in some foul practices in the recruitment processes at OSSC, said Vigilance sources.

### City dengue cases surpass last year's state tally

Bhubaneswar, July 31: With more than 500 dengue cases recorded in Capital city till Saturday, the count surpassed the total number of cases recorded in the entire state during the season in 2020. As per sources, Bhubaneswar

has reported a total 563 dengue cases as 58 more cases of the vectorborne disease were added to the caseload Saturday. With this, the state capital has become the highest carrier of dengue as the state has so far reported around 600 cases. The dengue cases have surpassed last year's tally which stood at 496.

"Last year, restrictions on movement of people owing to Covid have helped contained the dengue cases. However, we are carefully monitoring the situation and have deployed specialised teams of health workers, sanitation workers and others in affected areas to control the spread of the vector-borne disease. Most of the patients have recovered," said an official of Bhubaneswar Municipal Corporation (BMC).

The civic authority Saturday launched a dengue prevention awareness rally here. The drive includes home visits, counselling, source reduction, slogan and public address system to sensitise community members. Moreover, source reduction activities like taking out tyres dumped by the people, drain-



ing out of water sources that are breeding places of aedes mosquito and on-spot demonstration of regular cleaning of water containers were also carried out

### **Citizens urged to donate blood**

With an unprecedented rise in dengue cases in the city, the Red Cross Society has urged people to come forward and donate blood to blood banks which are facing an acute shortage of platelet components. "Lack of blood donations owing to lockdowns is one of the major causes for the shortage. Moreover, many people who are getting vaccinated and are refraining from blood donations due to 14-day restriction as per the instructions. Dengue patients are facing difficulties in getting platelets. This shortage could prove serious if dengue cases continue to increase at the present pandemic period," said Red Cross Officer, Laxman Swain.

## Mo Bus services on all routes to resume Monday: CRUT

Bhubaneswar, July 31: With the state government allowing further relaxations in lockdown norms, the Capital Region Urban Transport (CRUT) Saturday said it would resume Mo Bus services on all routes from August 2.

Detailing about the decision, CRUT's General Manager Dipti Mahapatro said that 194 buses will operate on 25 routes from 7am to 7pm on the weekdays (Monday-Friday). However, regular Mo Bus services will remain suspended Saturday and Sunday due to weekend shutdowns.

"All services will remain un-operational during weekends. However, bus service for incoming passengers will continue from city railway station to Cuttack and Khurda and shuttle service will be available from Airport to railway station," she added.

The CRUT authorities further said that no standing passenger will be allowed to travel in the buses while wearing of mask has been made mandatory for all travellers. "No mask, no entry. We ap-

Bhubaneswar, July 31: Odisha Saturday reported 1,578 fresh Covid-19 cases, pushing the tally to 9,77,268, while the death toll mounted to 5.902 with 68 more fatalities, a Health department official said.

After almost four months, all the 30 districts of the state registered daily test positivity rate (TPR) below 5 per cent. "This is for the first time that the daily TPR has gone

down below 5 per cent in all the districts. Altogether, 16 districts recorded TPR below 1 per cent," the official said.

The state now has 16,384 active cases, and as many as 9,54,929 patients have recovered from the disease, including 1,841 since Friday.

Deogarh, Khurda, Balasore, Kendrapara, Puri and Cuttack are now in the green zone based on the TPR, he said. However, in terms of active cases, only Khurda district

is under the red zone with 4,614


Of the new cases, 915 were reported from the different quarantine centres and the rest from contact tracing. Khurda topped the list of fresh infections with 436 de tections, followed by Cuttack (212), Jagatsinghpur (113) and Puri (109). The remaining 27 districts logged below 100 new cases, the official said.

Eight fatalities were reported from Angul, seven each from Khurda and Ganjam, and five each from Balasore and Puri. A total of 53 other Covid-19 patients have also died due to comorbidities.

The coastal state has thus far conducted over 1.60 crore sample tests for Covid-19, including 72,233 Friday, the official said, adding, the cumulative positivity rate stands at 6.09 per cent.

The state has inoculated 1,62,99,529 people so far, out of which, as many as 1,24,32,071 people have received the first dose and 38,67,458 have received both the doses.

## BMC's 'Mo Khata' SOG trains commandos in guerilla warfare sells like hot cakes

Bhubaneswar, July 31: The Corporation's 'Mo Khata', an initiative to convert waste into organic compost, has seen a substantial increase in demand with all government departments set to procure the same from the civic body.

The 'Mo Khata' initiative was launched earlier in January this year. It aimed at managing City's waste by producing organic compost out of it at different micro composting centres (MCCs). As per sources, while 80-100 kg of Mo Khata used to be sold daily at only one outlet near Rajmahal Square, the figures rose to 150-200 kg and three outlets.

"As of now, 11 metric tonnes of 'Mo Khata' have been purchased by the customers. The increase in production is also due to the introduction of new MCCs. As of now, 18 MCCs are functional in City as against just eight until February. Moreover, we have also started receiving orders off the counter which mark 40 per cent of the total sales," said a BMC official.

The official also stated that the range office here had procured two metric tonne of the compost Thursday. Similarly, the office of the project director, Watershed, Khurda has placed an order of 40 metric tonne of 'Mo Khata'. Meanwhile, Bhubaneswar Development Authority (BDA) and Odisha University of Agriculture and Technology



(OUAT) have also been supplied the compost through the counter.

However, sources said that the demand for the compost from public departments increased after the state government, in March this year, asked all government organisations to procure compost from their respective urban local bodies (ULBs). This was done to support the initiative and enhance revenue earnings which would flow back in form of wages and

"Further, increase in demand will be met as more MCCs will become functional. The Swachha Sathis engaged in these units have been trained about quality control, sale and popularity of the

product by BMC," the official added. The BMC has fixed the price at ₹125 for 5 kg and ₹445 for 20 kg of Mo Khata. Upon the fixed prices, discounts of ₹25 and ₹45 are given on the 5 kg and 20 kg bags respectively. The price is intended to manage the operational costs only and it will remain unaffected, as per the **BMC** official

Bhubaneswar, July 31: A commando undergoing training for guerilla warfare in Odisha Police's elite Special Operations Group (SOG) has to remain hungry for the entire day and stay awake the whole night, a senior police officer said.

This helps the commando to prepare for the arduous task, stay in the jungle and effectively tackle the Maoists and beat them in guerilla warfare, the officer said.

The SOG, established in Odisha in 2004, has not only helped the state in various anti-Maoist operations, but also provided rigorous training and skills to police personnel from other states and Central police force.

As many as 924 personnel from different states including 600 jawans of CRPF have so far been trained by the SOG of Odisha Police so



This came to the fore when Director General of Police (DGP) Abhay reviewed SOG related activities along with senior officers of the State Police recently.

IGP (Operations) Amitabh

Thakur said the SOG has so far trained personnel from West Bengal (202), Jharkhand (40), Kerala (1st batch 50), Maharashtra (32) and CRPF (600), Kerala Police has now sent another batch of 33 com-

mandos of "Thunderbolt", which is their Special Force for tackling LWE. The batch will undergo intensive and rigorous training for eight weeks, Thakur said, adding that the main focus is given to the improvement of physical fitness and skills in firing in difficult jungle conditions.

The commandos will also be given training on map reading, weapon handling and firing, fieldcraft, tactics and other allied subjects like explosives, communication and first aid, he said.

"After completion of training, each commando will be able to go from one unknown place to another, even at night. He will be a marksman in firing and will be able to handle explosives confidently," he said.

The personnel trained at SOG will also be able to remain in a jungle without outside support for five days and march a distance of

sonal equipment. "Keeping the trainee hungry for an entire day or keeping him awake for the entire night also helps him prepare for the arduous task and keep him focused on the given task," the IGP said.

The SOG is an elite armed force of the state for counter terrorist/extremist operations. Amongst the mandate of SOG, one is also to develop training curriculum and train its own personnel and those of other units of the state police as well.

It provides training to Odisha Police personnel in anti-terrorist and anti-extremist fieldcraft, nonconventional jungle warfare, storming of hideouts of extremists/terrorists, storming of buildings, installations, aircraft taken hostage by the terrorists and the like, he said.

As the SOG has acquired expertise in training and achieved results on ground, many states are sending their personnel for train-

### Cyber crooks dupe BSF jawan of ₹20L

**Bhubaneswar:** Cyber fraudsters have duped a Border Security Force (BSF) jawan of ₹20 lakh on the pretext of providing maturity benefits on insurance deposits. Cybercrime cell of state Crime Branch has registered a case on the basis of a complaint lodged by the victim, Gangadhara Tuddu, of Mayurbhanj. According to sources, Tuddu received a phone call from a fraudster in the first week of March. The accused cyber criminal identified himself as an official of Insurance department. He told Tuddu that the insurance plans of different companies in which he had invested money have matured and his deposits were invested in Bitcoin and share market. He told him that he was eligible to get maturity benefits to the tune of ₹56 lakh. The cyber criminals also emailed various fake documents in the name of RBI, Income Tax, and Finance Ministry. Tuddu fell into the their trap and started depositing money into the account of the accused persons who demanded money on pretexts like income tax, FDR charges, FDC charges, RBI charges. Speaking to Orissa Post, Tuddu said that he had given ₹30.000 to one Manmohan Pattnaik, an aide of the fraudster in Bhubaneswar.


### Cong alleges ₹300Cr scam in ration scheme, seeks CBI probe

Bhubaneswar, July 31: Odisha Congress Saturday alleged a scam of over ₹300 crore by the state government in distribution of ration during Covid-19 pandemic and demanded a CBI inquiry into the corruption.

Odisha Pradesh Congress Committee Media Communication department Convener, Satya Prakash Nayak told media in a press conference at Congress Bhavan here that the state government was running the scam through ration cards issued to lakhs of ghost beneficiaries for availing food grains under the

National Food Security Act (NFSA). He said, "Though the state has 93.06.202 beneficiaries under the NFSA, ration rice has not been distributed to them in any month. Every month, thousands of metric tonnes (MT) of undistributed rice are lying in stock, but the full quota of rice is being lifted from the centre in the subsequent months. The Congress wants to know the whereabouts of the undistributed rice and described it as a monthly scam programme

of the BJD government. Nayak said that two days back, the Chief Minister, while launching the 'One Nation One Ration' programme, announced to distribute fortified rice in Malkangiri district to eliminate malnutrition. He said it is a Central government programme and has already been started in 15 districts in 15 states of the country two years back. But

the BJD government delayed launching the programme keeping the coming Panchayat and urban bodies' elections in view.

The leader also said while every state was updating the data about the ineligible beneficiaries under the NFSA, the Odisha government was not doing it for the last three years despite repeated reminders from the Union government. The state government, he said, sanctioned ₹955 crore to be provided to ration card holders at the rate of ₹1,000 per card as assistance during the pandemic. But ₹20.07 crore was returned to the state exchequer as more than two lakh beneficiaries were not found. This proves that a recycling scam of hundreds of crores worth ration rice was going on in the name of ghost beneficiaries

He also questioned the silence of the BJP government at the Centre on this issue and demanded a CBI probe into the scam.

been repaired or excess rainwater released to ensure safety of the embankment. The weak embankment could not withstand the high pressure of water leading to the wide breach in the canal," a local resident said.

### Olympics & Audience

The current Olympics have the lowest viewership in the last three decades, a news report said the other day. Not the physical audience at the stadia of course, because that is absent given the pandemic. It is the global television audience where the lack of interest is showing. Viewers have dropped by a third since just 2016. Remember that this is happening despite far more streaming services and viewing options than there were during the 1988 Games in Seoul, after which the world's population has grown by 50 per cent but viewership has fallen.

It will be interesting to consider why this is the case. The Olympics began in Greece more than 2000 years ago, but these did not extend into the modern era. The modern Olympics began in 1896 and have a different character than the Greek ones. Even the Olympics motto ('citius, altius, fortius', meaning faster, higher, stronger) is in Latin and not in Greek. The Greeks would have been horrified to see women participat-

ing, as has been the case with our Olympics since 1900. To return to the motto, being fastest, highest and strongest is not that big a deal. Men have been running 100 metres under 10 seconds but more than 9.5 seconds since 1968. In that sense not much has changed in this sport in 50 years. The high jump Olympics record of 7 feet and 8 inches was established 25 years ago. In the last Olympics, the gold medal winner jumped one cm less than that. The Olympics record for the long jump has been unbroken for 50 years.

As a race, we are not getting faster, higher and stronger and if we are it is not by much. The human being's physical achievements are less interesting to us at a time when our physical selves are less interesting than the virtual spaces we have access to. Synthetic biology, steroids and prosthetic limbs mean that the idea of a perfect physical specimen is now impossible. The terms 'fastest human' or 'strongest person' do not mean much in our times. It may interest readers to know that the viewership of Miss Universe pageants has also been plummeting over the last few years.

Yet another aspect of the decline of the Olympics is the ending of hostility between nations on a global scale. One of the greatest moments of the Olympics came in Berlin in 1936 when the young African American Jesse Owens won four gold medals including for fastest sprinter and longest jumper in the world. His victory delivered a shattering blow to the Aryan supremacy theory of the Nazis, which said that the white man was the perfect physical specimen of the human race.

After the Second World War, the hostilities between the US and the USSR provided some of the tensions that the Games could feed off.

But since the end of the Cold War even that has gone. The Seoul Olympics came in the same period. Today the world is more at peace than it has ever been in history. Wars between nations are few and outside of the usual violent hotspots in the Middle East, North Africa and South Asia, armed con-Even the US-China rivalry, the most significant in the world, is possibly

the least violent one we have seen. Both nations are each other's largest and strongest trading partners and have been for a long time now.

Of course primitive enmities remain in some parts of the world, and India and Pakistan are archrivals, but we are irrelevant to the others and do not occupy anyone's attentions. In any case, we are not significant at the Olympics. The other thing is that we have international competition that is outside of the Olympics and most world records are not set at the Olympics.

These are the reasons I think that the Olympics are past their peak. We will not return to a time when the stars of the Games are global figures and perhaps in time even the inhabitants of nations will lose interest in the performances of their own individuals on this stage. Popular team sports which involve the audience more viscerally because they respond to our basic tribalism and parochialism, might perhaps have a longer life than events concerning individuals. Football and cricket will not face as sharp a decline in audience and viewership as the Olympics. But that decline is also already happening. I can remember struggling to get a seat at a Ranji Trophy game in Surat 40 years ago. That would never happen now. Our world has changed in our lifetimes. The decline in viewership of athletics might be an insignificant aspect generally speaking but perhaps it says something more deep and profound about the time we live in and how it has shaped us.

### ■ Oojah

66 ass me that oojah," you might once have said. You could have meant some useful little device which doesn't have a name, or something which does have a proper name but which vou've temporarily forgotten. You might instead have called it a thingumabob, doohickey or whatchamacallit. The word is rather old-fashioned British English slang. Its heyday was the First World War, when British soldiers created it as part of a private vocabulary. An eyebrows-raised article about the slang of an Army hospital that was found in the Washington Post of 22 July 1917 provides one of its earliest recorded appearances: "Pass the oojah," says the one-armed man who is playing billiards. What is the oojah? The oojah is any object in Heaven or earth; it is the thing which has no name or the name of which you have temporarily forgotten. The one-armed man, about to make his stroke, requires the little twisted wire bridge, mounted on a lead pedestal, that forms the cue rest which - poor chap! - he ought to have formed with his lost hand. So he demands the oojah, which is army for what-d'ye call-it. It became greatly elaborated, especially after the war ended and the word was transferred with its speakers to civilian life. It's known in many forms, including oojah capivvy, oojahcum-pivvy, ooja-ka-pivi, and oojipoo. Another form is oojah-cum-spiff, which came to mean that something was all right, in order, or OK. This turns up several times in the novels of P G Wodehouse, as here in Right Ho, Jeeves: "Yes, I agree with you, Aunt Dahlia, that things are not looking too oojah-cum-spiff at the moment, but be of good cheer. A Wooster is seldom baffled for more than the nonce." Woosters may not be, but etymologists often are. Though many of these British Army slang terms of the period were imported from India, ooiah has no known origin. If it did come from that country, nobody can tell from what word in which language.

## HOW TO END THE PANDEMIC

▼he United States has now entered its fifth wave of COVID-19 infections. In each one, the country has paid a high price for doing far less than it could. In the first wave, lockdowns and other restrictions were spotty. Then came untested and unproven treatments. With the vaccine rollout, new infections were pushed down substantially, but now the Delta variant has started pushing them back up in unvaccinated populations.

At each stage, the SARS-CoV-2 virus that causes COVID-19 was underestimated. From what we know of its ability to adapt and thrive through random mutations. there is only one viable option for long-term disease control: a strategy that combines a rapidly growing arsenal of vaccines and antiviral drugs with strong public-health measures and deeper global cooperation.

Vaccines comprise the first ring of defense against COVID-19. The first generation vaccines in the US are highly effective, and the second, third, and subsequent generations will be even stronger. But even with booster shots in hand and next-generation vaccines tailored to new variants, vaccination alone is unlikely to end the pandemic.

Vaccines won't work for everybody. In the best-case scenario, against the original wild-type virus, vaccines still fail about 5 per cent of the time. And the Delta variant has proven more adept than previous strains at breaking through vaccine protections. Even if the entire US population was vaccinated, 17.5 million Americans would still be at risk of infection and disease if exposed to the virus.

Moreover, there are substantial populations of people with underlying conditions that diminish vaccine efficacy; these include organ-transplant recipients, people taking immunosuppressant drugs, cancer patients, and a fraction of the elderly population. And like the protection offered by the annual influenza vaccine, early

evidence suggests that vaccineinduced immunity against COVID-19 may fade over time.

Antiviral drugs and prophylactics will be needed to fill the gaps and provide a second ring of defense. The US government recently committed \$3.2 billion to develop antiviral therapies for COVID-19. While most of the focus has been on using these drugs as a treatment, their true potential lies in pandemic control, because administering prophylactics can prevent people who have been exposed to the virus from becoming ill or passing on an infection.

True, the current generation of these drugs cannot be used widely, owing to their high production costs and the need for intravenous infusions in a clinical setting. Nonetheless, we have achieved proof of principle. Ideally, the next generation of antivirals will come in pill form, giving them enormous potential for use in highrisk settings such as long-term care homes, where there are many immunosuppressed individuals who cannot rely on vaccines for protection. The same approach applies to schools, businesses, professional sports teams, and even ships at sea. If one person tests positive for COVID-19, everyone around him could take a pill to help stave off infection.

The next ring of defense will come from public-health measures to contain the spread of the virus. Countries such as Australia, China, New Zealand, Singapore, and Taiwan have made effective use of widespread testing, exhaustive contact tracing, mandatory isolation, tight border controls, and quarantines for new arrivals. Such strategies have been critical methods of protection in the face of nearly every infectious disease in recent history. But in the US and other countries around the world. testing and contact tracing have stalled (or never got off the ground

in the first place). Fortunately, new antiviral prophylactic drugs can help make up for some of these failures. As opposed to "test, trace, and quarantine," the mantra may become "test, trace, and swallow a pill"-a much more attractive alternative. These drugs also may help open new opportunities for travel, eliminating the need for long quarantines.

The first three rings of protection form an excellent defense.

But they will be insufficient unless they are implemented everywhere. To provide the final ring of protection, the international community must work together to improve disease surveillance, and to provide universal access to tests, treatments, and vaccines.

Here, the Access to COVID-19 Tools (ACT) Accelerator and its vaccines pillar, COVAX, were an important first step. But the power of the platform has been diminished by self-interest and vaccine nationalism. Still, there is hope for future now that many high-income countries have a surplus of vaccines. There are also efforts underway to increase local vaccine production in underserved areas.

In addition to these efforts, the international community needs to invest in global disease surveillance to identify new outbreaks especially ones caused by highly infectious variants that can quickly take hold and spread. This requires an enhanced surveillance presence, increased sequencing of the virus across all communities, and a near-real-time method of sharing the data broadly.

With the proper frontline mechanisms in place, the global community of scientists, researchers, and pharmaceutical manufacturers will have to determine how vaccines and treatments fare against each new variant, and what can be done to mitigate their spread and reduce their likelihood of emerging.

Eighteen months into this pandemic, we have what we need to end it. Now, we must apply our knowledge and tools. No single approach will ever be enough. But, together, the four defensive rings - vaccines, antivirals, public-health measures, and international cooperation can help us eliminate COVID-19 as a life-threatening disease and allow for the dawn of a better life than the one we left behind.

## Are salaries of govt employees justified?

THE SALARIES OF **GOVERNMENT SERVANTS IN INDIA ARE DISPROPORTIONALLY HIGH AND ARE GOING UP AND UP** 

The objective of the government is to secure the welfare of its citizens, according to our Constitution. Indeed, government employees are to be appointed to secure the welfare of the citizens. However, the welfare of government employees themselves, and not the citizen, has become the primary objective of the government today.

According to a World Bank study titled "Government Employment and Pay in Global Perspective, the average salary paid to government employees was 0.9 times the per capita GDP of Vietnam. In other words, the average salary paid to government employees was ₹90 if the average income of the Vietnamese citizen was ₹100. By the same reckoning, China paid an average salary of ₹110. The average salary paid to government employees in India, however, was seven times the per capita GDP or ₹700 by the same reckoning. Unsurprisingly, Vietnam and China have both outpaced India in GDP growth rate.

Another study by the World Bank tells that the global tendency for government consumption has been to move downward over the last decade. The share of government consumption in GDP globally was 18.0 per cent in 2009. This reduced to 17.2 per cent in 2014 and 17.1 per cent in 2019. According to the Budget

the share of government con-10.4 per cent in 2014 to 12.6 per cent in 2020. The salaries of government servants in India are disproportionally high and are going up and up. This increase is even more disturbing in view of an International Labour Organisation (ILO) study reporting that the wages of workers in the formal sector in India have declined by 3.6 per cent and in the unorganised sector by 22.6 per cent during the pandemic. Salaries of government employees appointed to secure welfare of citizens are going up; while the salaries of citizens are going down. Is this the Constitutional mandate? The condition of the state gov-

ernments is worse. The government of Kerala spends 70 per cent of its revenue on paying salaries to its employees; while Tamil Nadu spends 71 per cent. A school headmaster gets a monthly salary of ₹103,000 in Tamil Nadu. A headmaster in a private school may be getting ₹15.000—and the latter begets better results. This leaves little money with state governments to spend on welfare of citizens. The government has become a huge vacuum cleaner that is sucking every penny from the hands of the citizens and providing it to government employees.

These high wages have been rec-

papers of the Finance Ministry, ommended by successive pay commissions to attract competent worksumption in India increased from ers. The high salaries paid to highend government employees become applicable across-the-board. All headmasters in Tamil Nadu draw a salary of ₹103,000 per month irrespective of their performance. No wonder another study by the World Bank titled "Are Public Sector Workers in Developing Countries Overpaid?" says that less educated and lower rung government employees are paid much higher salaries in comparison to their counterparts in the private sector.

The high salaries of government

employees in India have actually come along with rampant inefficiency. The Fifth Pay Commission had explicitly said that it was recommending increase in salaries as a combined package that should be implemented along with steps to improve efficiency such as external evaluation of Class 'A' officials every five years. The government, in its wisdom, raised the salaries more than that recommended by the Commission but shoved the accountability measures under the carpet. The Sixth and Seventh Pay Commissions have made similar empty statements about raising efficiency.

The way forward is to make a huge cut in the salaries of government employees to bring them at par with those in the fast-growing economies of Vietnam and China. Economics has a concept of propensity to consume. A government employee may consume an additional ₹20 worth of goods if he gets an additional income of ₹100. This propensity to consume at 20 per cent is low. His stomach is full. He already has a refrigerator and a car. The slum-dweller may consume ₹80 if he gets the same additional income of ₹100. He is hungry This propensity to consume at 80 per cent is high. A number of countries have cut the salaries of government servants during the pandemic. Paraguay, for example, has cut their salaries by 20 per cent, according to an ILO report.

There are 139 government employees per one lakh population in India, much less than 668 per one lakh in the United States. This, if at all, only suggests that a reduction in salary to one-seventh and increasing the numbers employed by seven times would rectify the imbalance. Ultimately, the government must make an 85 per cent cut in the salaries of its employees and redistribute that money among citizens. This will both secure the welfare of our citizens and rev up



## Mayurbhanj farmers turn away from dairy

Absence of a processing plant, refrigeration facilities in the district forcing farmers to shun dairy

Baripada, July 31: Many farmers have become self-sufficient by taking up dairy farming in Mayurbhanj district. However, due to sale of milk at lesser prices and absence of refrigeration facilities, farmers incur heavy losses.

Absence of a processing plant in the district is affecting them. As a result, dairy farming is losing its charm for farmers. Instead, farmers are showing interest to try their hands at poultry, goatery and sheep

Riparian villages in the district have lush pasturelands for dairy farming. Farmers in the blocks of Rasagobindapur, Badasahi and Udala situated on the banks of Budhabalanga, Subarnarekha, Gangahar, Sone and Jambhira rivers produce milk as green surroundings are suitable for live-

stock and cattle. Keeping this in view, 12 milk refrigeration plants were opened by Omfed in the district. While the ones present in Anla, Patalipura,



Bijipur, Badasahi and Baripada are functioning, those opened in Murukandia, Kumbharamundakata, Hatabadada, Badampahar and Karanjia are lying defunct and shut.

Also, owing to the absence of a processing plant, Omfed is transporting the collected milk from the refrigeration centres to the plant in Remuna. The farmers are suffering huge losses as they are not getting proper prices for their produce, said the farmers of Badasahi area Laxmidhar Giri, Sarat Giri and Prakash Barik.

# 50% of Delhi's eligible population DMK pushing for rehabilitation of beggars got at least 1 shot of vaccine: CM | NDO-ASIAN NEWS SERVICE | Chennai, July 31: The DMK government in Tamil Nadu under Chief Minister MK Stalin is in the

New Delhi. July 31: The total num ber of anti-coronavirus vaccine doses administered in Delhi so far crossed the one-crore mark Saturday and of the eligible population in the city, 50 per cent have received at least one jab, Chief Minister Arvind

He hoped that more vaccine doses will be soon available for the city. The national capital has a population of about two crore and among them, about 1.5 crore are eligible for COVID 19 vaccination, the chief minister said "Out of the 1.5 crore eligible pop

ulation, 74 lakh have received vaccine doses. So, about 50 per cent have received at least one dose. Of the 74 lakh. 26 lakh have been administered both the jabs," the chief minister said in an online briefing.

"The number of Covid vaccine doses administered in Delhi since the start of the inoculation drive, crossed the one-crore mark today."

Congratulating the medical staff for administering over one crore doses in the national capital, Kejriwal said there was an acute shortage of vaccines for which inoculation could not be scaled up.

"We have the capacity to vaccinate three lakh people daily. But due to shortage, only 50,000-80,000 people are getting the Covid jabs

every day," he said. The chief minister said the Delhi government is in regular contact with the Centre and hoped the city, along with the rest of the country, will soon have adequate vaccine doses. There are two challenges before the government: to vaccinate those who have not vet taken even the first dose and to administer the the first jab, Kejriwal said.

The state government has been vaccinating the maximum number of people each day with the stock it is receiving, he said while pointing out the enthusiasm among people to get inoculated.

"As per the stock of doses we are receiving, our doctors, nurses and healthcare workers are putting in their best day and night to vaccinate the people of Delhi. The people are also enthusiastic about getting vaccinated and are coming forward to get their shots," the chief minister said.

Delhi has so far received 24,74,850 doses of Covaxin and 73,18,070 doses of Covishield, said the vaccination bulletin of the Delhi government

Chief Minister MK Stalin is in the process of rehabilitating the beggars in the state.

The Supreme Court had stated in a recent verdict that begging cannot be banned through legislation, adding that the court cannot take an 'elitist' view in the matter.

Taking a cue from the Supreme Court observation, the Tamil Nadu government is planning to open rehabilitation centres across districts. According to a study conducted by the state's Social Welfare Department, a large number of people are out on the streets in each and every district of Tamil Nadu.

During a recent meeting of the welfare department, Stalin had stressed the need for rehabilitation of beggars and making them meaningfully employed.

While several social organisa tions working among beggars are divided over banning begging, some groups are vociferously advocating the implementation of the Tamil Nadu Prevention of Begging Act.

M. Swaminathan, Director of the NGO 'Cause and Action', which works among the marginalised and deprived people, including beggars, in Salem, told IANS "There is a need to implement the Tamil Nadu Prevention of Begging Act. However, the gov-

## Air pollution in Delhi-NCR shows decreasing trend

New Delhi, July 31: An early estimate from the Central Pollution Control Board (CPCB) and the Indian Institute of Technology Delhi (IIT-D), has shown a de creasing trend in PM2.5 concentration over Delhi-NCR over the last

"Our data is showing that pollution levels have gone down. In 2020, it had anyways gone down be cause of the lockdown. But data from 2017 to 2018 and 2018 to 2019 has shown a decreasing trend,' said Sagnik Dey, associate professor at the Centre for Atmospheric Sciences, IIT-Delhi

A number of policy measures have been taken in the National Capital Region (NCR) to curb air pollution such as switching to cleaner BSVI fuel, installing CEMS monitoring across industries, cleaner zigzag technology in brick kilns, completion and use of Eastern and Western Peripheral Highways, which bypass heavy traffic away from Delhi limits, and deployment of happy seeders, which address crop residue burning to an extent.

"With all these measures, the data from the government monitoring has shown a decreasing trend in PM2.5 concentration over Delhi-NCR," said SN Tripathy, head of the Civil Engineering Department at IIT Kanpur.

But Tripathy also put an immediate caveat: "The time series is very short, and yet, the data is showing some decreasing trend."

Because of this, both Dey and Tripathi declined to hazard a guess to put a quantum on the levels of pollution, which may be in the range of 10-15 per cent or 15-20

Tripathy is part of the National Knowledge Network, which has been set up to provide scientific guidance to achieve National Clean Air Programme (NCAP) goals and has been pushing for adopting an airshed approach as a provincial management expanding to

The government Saturday introduced a Bill in the Lok Sabha to constitute a commission for air quality management in Delhi-NCR and its surrounding regions based exactly on the airshed approach

"Domestic policies such as the Pradhan Mantri Ujiwala Yojana, which has provided a successful solution in the form of 14 crore LPG connections in India, too has been making a huge difference. Household cooking contributes to one-fourth of the mortality burden due to air pollution in the region. Not just domestic cooking, the street vendors shifting to LPG too may have helped," said Tripathi.

Lead is a carcinogen generated from solid fuels used in household cooking while nitrogen dioxide emissions (NOx) are mostly attributed to transport.

## Wary of BJP, AIADMK cadres push for EPS to head party

There is growing unrest among the party cadres against the style of functioning of Panneerselvam and about his waning clout in his home turf

Chennai, July 31: The AIADMK cadres and leaders are pushing for a strong single leadership in the party after the BJP came out with a statement that the fight in Tamil Nadu is between the BJP and the DMK and that the AIADMK is an alliance partner.

In the recent Assembly elections, the BJP was able to wrest four seats in an alliance with the AIADMK and the PMK. The saffron party now wants to take this forward and become a major political force in the state.

While the AIADMK is presently eing led by former Chief Ministers and senior leaders O. Panneerselvam and Edappadi K Palaniswami, there is growing unrest among the party cadres against the style of functioning of Panneerselvam and about his waning clout in his home turf of Theni district.

In the 2021 assembly elections, the AIADMK could win only the Bodinaikar seat of Panneerselvam in the predominantly Thevar dominated Theni district. In Salem, the home turf of Palaniswami, the party could win all but one assembly seat thus leading to the growing clout of Palaniswami among the cadres and leaders.

The AIADMK cadres were apprehensive about Panneerselvam not coming out strongly against expelled former party interim



general secretary V.K. Sasikala as both are from the powerful Thevar in the southern belts of Tamil Nadu including Theni district. Sasikala has been trying to contact party cadres and lower level functionaries and this has been causing a lot of heartburn within the party.

After the New Delhi visit of EPS and OPS and meeting with Prime Minister Narendra Modi, OPS has come out against Sasikala. A large section of the party is of the opinion that Palaniswami with a clean slate should lead the AIADMK from the front and not a dual leadership

Palaniswami has immense clout in his home turf of Salem and among his Gounder community but the same cannot be said of Panneerselvam as the election results in his home district, Theni

## 66% of TN population has antibodies

Chennai, July 31: The third Tamil Nadu Cross Sectional Serosurvey in July, covering over 26,000 samples revealed that at least 66.2 per cent of the population has developed antibodies to SARS-CoV-2, the virus which causes covid-19.

Among the 26,610 samples tested 17,624 individuals had IgG (Immunoglobulin G) antibodies against SARS-CoV-2 virus.

While the overall seroprevalence was 66.2 percent, the highest seropositivity was observed in Virudhunagar district at 84 per cent while Erode in west Tamil Nadu reported the lowest at 37, according to the latest serosuvrey conducted by the Directorate of Public Health and Preventive Medicine in 888 clusters across

It was released by state Minister for Medical and Family Welfare Ma Subramanian in the presence of Principal Health Secretary Dr J Radhakrishnan and Director of



Public Health (DPH) and Preventive Medicine Dr TS Selvavinayagam, here Saturday.

In the earlier state-wide serosurveys conducted by DPH&PM, the seropositivity was 31 percent in October/November 2020, and 29 percent (in the second conducted in

The overall seropositivity of 66.2 percent detected during the third survey could be attributed to various possible reasons including the timing of serosurvey conducted

during the declining phase of the Covid second wave in Tamil Nadu,

"Intense vaccination drives across the state from January 16, 2021 and inclusion of 18+ age individuals for vaccination would have generated protective antibodies in the population. As on June 10, 2021, 97.6 lakh people got vaccinated (either single or double dose) in Tamil Nadu," the survey

report said. Western districts like Erode, Coimbatore and Tiruppur reported around 45 percent seropositivity which could be attributed to the consistent reporting of new covid-19 cases in these regions, it said.

The serosurvey was successfully completed under the supervision of Selvavinayagam and his team at the state and district level

Each cluster consisted of 30 participants drawn randomly from a village in a rural area or a street in the case of an urban one.

Blood samples were collected from a total of 26,610 participants and tested for the presence of SARS CoV-2 IgG antibodies using Chemiluminescence based Immuno Assay (CLIA).

All the samples were tested at six referral labs of DPH & PM located in Chennai, Tiruchirappalli, Madurai, Coimbatore, Tirunelveli and Salem for the detection of IgG antibodies

Over 2.15 crore persons have taken the jabs through government-run and private hospitals in the state, so far.

### Yamuna flowing below danger mark

New Delhi, July 31: The water level in the Yamuna receded below the danger mark of 205.33 Saturday morning, a day after the Delhi administration sounded a flood alert and expedited efforts to evacuate people living in the river floodplains.

The water level was recorded at 205.01 metres at the Old Railway Bridge at 8 am. It was 205.44 metres at 1 am and 205.20 metres at 6 am, an official said.

Friday, with Haryana discharge ing more water into the river from the Hathnikund Barrage, the Delhi Police and the East Delhi district administration started evacuating people living on the floodplains

of the Yamuna in the capital. The Irrigation and Flood Control Department deployed 13 boats in different areas and put 21 others on standby. A flood alert is declared when the Yamuna crosses the "warning mark" of 204.50 metres. The situation is being monitored round-the-clock, a district administration official said. According to





the Delhi flood control room, the discharge rate at the Hathnikund Barrage peaked to 1.60 lakh cusecs Tuesday afternoon, the highest this year so far.

The water discharged from the barrage normally takes two to

three days to reach the capital. Harvana had been releasing water from the Yumananagar-located barrage at the rate of 37,109 cusecs at 8 pm Friday, it increased to 45,180 at 1 am Saturday, which resulted in the water level reaching 205.44. At 6 am Saturday, the water was released at the rate of 35,109 cusecs. In 2019, the flow rate had peaked to 8.28 lakh cusecs August 18-19, and the water level of the Yamuna had hit the 206.60 metremark, breaching the danger mark of 205.33 metres.

## 'For every single Covid case, 30 cases went undetected'

SERO-SURVEY ANALYSIS

New Delhi, July 31: For every single Covid-19 case reported in India, there were 30 cases that remained undetected or were missed, according to an analysis of ICMR's fourth sero-survey by independent epidemiologist Dr Chandrakant

The public health expert shared his analysis on Twitter in which he showed for every reported Covid-19 case in India, how many cases were missed

He, however, clarified that it does not mean this was deliberate but simply reflects the performance of the disease surveillance system and the response to pandemic in the state in tackling

For every laboratory confirmed Covid-19 cases in India, the number of unreported or undetected cases ranged from 6 to 98, accord-

Among states and union territories, the analysis by Lahariya showed that Uttar Pradesh missed the highest number of cases. With every case reported in that state, 98 cases were missed or remained undetected.

The under-counting factor was lowest for Kerala at 6 which means for every case reported six cases were missed, according to the analysis. The under-counting factor for India was 30 which means for every case reported 30 cases were missed, according to the analysis. For Madhya Pradesh, the under-counting factor was 83 - highest after Uttar Pradesh fol-

lowed by Jharkhand at 63, Rajasthan at 62, Gujarat at 61 and Bihar at 59.

Speaking about the analysis, Lahariya said, What we need to remember is that sampling of sero survey has been done in a scientific manner from 21 states and UTs so we know India has 67.6 per cent seropositivity at national level which is undisputed and the government says it so this essentially means there are 90-95 crore people in India who are sero-positive and a majority after natural infection. So they will come in the same proportion from states through which we have arrived at this conclusion.

### India set to take over as President of UNSC

United Nations, July 31: India will take over the Presidency of the UN Security Council August 1 and is set to host signature events in three major areas of maritime security, peacekeeping and counterterrorism during the month.

"It is a singular honour for us to be presiding over the Security Council the same month when we are celebrating our 75th Independence Day," India's Permanent Representative to the UN Ambassador TS Tirumurti said in a video message on the eve of India assuming the rotating Presidency of the powerful 15-nation UN body.

The first working day of India's Presidency will be Monday, August 2 when Tirumurti will hold a hybrid press briefing in the UN headquarters on the Council's programme of work for the month.

Tirumurti will also provide a briefing for member states of the United Nations which are nonmembers of the Council on its work for the month, according to a schedule released by the UN.

India's two-vear tenure as a nonpermanent member of the Security Council began January 1, 2021 The August presidency will be India's first Presidency during its 2021-22 tenure as a non-permanent member of the Security Council. India will again preside over the



Council in December next year, the last month of its two-year

During its Presidency, India will be organising high-level signature events in three major areas - maritime security, peacekeeping and counterterrorism. In the video message, Tirumurti

said maritime security has a high priority for India "and it is important for the Security Council to take a holistic approach to this issue". Peacekeeping is a topic "close to

our hearts, given our own long and pioneering involvement" with peacekeeping, he said, adding that India will focus on how to ensure the safety of peacekeepers, especially by using better technology and how to bring perpetrators of crimes against peacekeepers to justice.

As a country that has been at the forefront in the fight against terrorism. India will continue to keep the spotlight on counterterrorism.

### Rape victim seeks SC permission to marry tormentor

Thiruvananthapuram, July 31: A victim of rape has approached the Supreme Court seeking permission to marry her 'tormentor', a 53-year-old Kerala Catholic priest Robin Vadakkumchery who has been sentenced to 20 years in jail and was dismissed from priesthood by the Vatican.

The petition filed by the victim will now come up before the apex court Monday and the victim has sought bail for Vadakkumchery so that their marriage can take place. The petitioner says this has been filed according to her wish.

Earlier, Vadakkumchery had approached the Kerala High Court with a petition seeking to marry the victim, but it was turned down.

Vadakkumchery was serving as a parish vicar near Kannur and was the manager of the Church-backed-school, where the victim, a Class 11 student was studying.

It was a Child line agency that works among school children that had registered the complaint against the priest. The priest came under pressure after the girl gave birth to a child February 7, 2017 at a hospital run by the management.

The priest was arrested February 27, 2017 from near Kochi International airport while he was preparing to slip out of the country.

## FB developing AI, new ways to detect users under age 13

Facebook and Instagram weren't designed for people under the age of 13, so the company is now creating new ways to stop those who are underage from signing up

New Delhi, July 31: Admitting that it is not easy to detect and remove accounts belonging to people under the age of 13, Facebook has said that it is looking at ways to convince people under age 13 to not lie about their age, including using the artificial intelligence (AI) technology.

Facebook and Instagram weren't designed for people under the age of 13, so the company is now creating new ways to stop those who

are underage from signing up. We're developing AI to find and remove under-aged accounts, and new solutions to verify people's ages. We're also building new experiences designed specifically for those under 13, said Pavni Diwanji,

VP of Youth Products at Facebook. Facebook is also working with operating system (OS) providers, internet browsers and other providers so they can share information to help apps establish whether someone is of an appropriate age.

Many argue that collecting ID is the answer to this industry problem, but there are significant limitations to this approach many young people don't have an ID. ID collection isn't a fair or equitable solution, nor is it foolproof, the company said.

It said that access to government IDs varies depending on where vou live in the world, as does the information contained in an ID such as a birthday.



Some have access to IDs but don't get them unless they choose to travel, and some simply can't afford one. Indeed, lack of ID access disproportionately impacts un-

the world, particularly young women, Facebook mentioned.

Currently, when people open Facebook apps to sign up for an account, they are asked for their birthday. This is called an age screen. But verifying someone's age is not as simple as it might sound. While age screens are common in our industry, young people can -- and often do -- get around them by misrepresenting their age.

The reality is that they're already online, and with no foolproof way to stop people from misrepresenting their age, we want to build experiences designed specifically for them, managed by parents and guardians, Diwanji said in a statement.

This includes a new Instagram experience for teens.

We believe that encouraging them to use an experience that is age appropriate and managed by parents is the right path. It's going to take a village to make this experience compelling enough so that this age group wants to use it, but we're determined to get it right, the company emphasised.

Facebook has already developed a technology that allows it to estimate people's ages, like if someone is below or above 18.

We look at things like people wishing you a happy birthday and the age written in those messages. We also look at the age you shared with us on Facebook and apply it to our other apps where you have linked your accounts and vice versa. So if you share your birthday with us on Facebook, we'll use the same for your linked account on Instagram, Diwanji ex-

plained.

Some 3,000 security forces deployed around the French capital for a third weekend of protests against the pass that will be needed to enter restaurants and other places. Police took up posts along Paris' Champs-Elysees to guard against an invasion of the famed avenue by violent demonstrators.

Anti-pass marches were being held in scattered cities across France, and four separate protests were held in Paris, the third weekend of anti-health pass protests.

With virus infections spiking and hospitalizations rising, French lawmakers have passed a bill requiring the pass in most places as of Aug 9. Polls show a majority of French support the pass, but some French are adamantly opposed.

The pass requires vaccinations or a quick negative test or proof of a recent recovery from Covid-19 and mandates vaccinations for all health care workers by mid-September.

## Turkey evacuates panicked tourists

Istanbul, July 31: Panicked tourists in Turkey hurried to the seashore to wait for rescue boats Saturday after being told to evacuate some hotels in the Aegean resort of Bodrum due to the dangers posed by nearby

wildfires, Turkish media reported. Coast guard units were leading the operation and authorities asked private boats and yachts to assist in evacuation efforts from the sea as new wildfires erupted. Video showed plumes of smoke and fire enveloping a hill close to the seashore.

The death toll from wildfires raging in Turkey's Mediterranean towns rose to six Saturday after two forest workers were killed, the country's health minister said.

President Recep Tayyip Erdogan visited the area Satu ing the damage from a helicopter.

Speaking from the town of Manavgat, Erdogan announced that the Turkish government would cover the rents for people affected by the fire and rebuild their homes. He said taxes, social security and credit payments would be postponed for those affected and small businesses would be offered credit with zero interest

Erdogan said the number of planes fighting the fires had been increased from six to 13, including planes from Ukraine, Russia, Azerbaijan and Iran, and that thou sands of Turkish personnel as well as dozens of helicopters and drones were assisting the firefighting efforts.



## Pressure on major emitters ahead of climate summit

Brussels, July 31: A group of mostly smaller countries submitted new, more ambitious climate pledges to the United Nations this week, raising pressure on big emitters including China to do the same ahead of a major UN climate summit in November.

UN climate chief Patricia Espinosa said that as of Saturday the United Nations had received new pledges from 110 countries, out of the nearly 200 that signed the 2015 Paris climate accord.

"It is still far from satisfactory, since only a little over half the parties (58%) have met the cut-off deadline," Espinosa said in a statement, urging laggards to "redouble their efforts" and make more ambitious commitments to protect the planet.

The smaller countries include Sri Lanka, Israel, Malawi and Barbados. Malaysia, Nigeria and Namibia were among the larger countries to submit tougher climate targets this week



## 'Globalisation tripled workers left out'

New Delhi, July 31: Globalisation has tripled India's GDP in a generation but workers in the country have been left out, eminent economist and Nobel laureate Eric Maskin said Saturday while observing that the problem of increasing inequality may be harder to solve than the Covid-19 pandemic.

Addressing students of an university virtually, he mentioned that globalisation has brought overall prosperity in emerging economies and has increased wages and income inequality.

"Globalisation has tripled Indian GDP in a generation, an amazing accomplishment. But the workers of India have been left out,' Maskin, a professor of Economics and Mathematics at Harvard University, said.

Noting that the rise of inequality in so many developing countries is surprising, he said inequality cannot be solved by market

"Yet, India will still be facing some huge challenges, challenges that may be even harder to solve than the pandemic....The problem of increasing income inequality," he noted.

Maskin pointed out that even though the world has witnessed enormous economic growth in the last 25 years, the gap between haves and have-nots in developing countries has risen.

"People who support globalisation have predicted that globalisation will bring prosperity to emerging economies. And on that score, they have often been right.

"In India for example, GDP per capita, which is crude but common measure of prosperity, has grown in spectacular fashion since 2000, thanks to global market," he said. However, Maskin said according to its supporters, globalisation was also supposed to reduce income inequality.

'Yet in many such countries, wage inequality has actually increased. And once again, India is a leading example," he said.

The eminent economist noted that eliminating poverty is closely connected to inequality and in developing countries, anti-poverty measures are often anti-inequality

New Delhi, July 31: The National High Speed Rail Corporation Limited (NHSRCL) Saturday said it has cast the first full height pier on the 508-km Mumbai-Ahmedabad High Speed Rail (MAHSR) project, popularly known as the bullet train project.

NHSRCL spokesperson Sushma Gaur said the NHSRCL took a significant step forward in its construction work by casting the first full height pier near Gujarat's Vapi at Chainage 167 on the Mumbai-Ahmedabad High Speed Rail Corridor which will run through 12 stations connecting Maharashtra, Dadar & Nagar Haveli and Gujarat.

The average height of the pier on this corridor is nearly 12-15 metre and exact height of this pier is 13.05 metres, which is almost equivalent to a four-storey building, she added.

She said the pier was cast with 183 cubic metres of concrete quantity and 18.820 MT of steel. The special shuttering arrangement in the lift is one of the major features of the corridor providing better quality in eight hours.

## 70% professionals feel skill gaps hampering productivity: Study

Mumbai, July 31: About 70% of employees feel there is a gap between the skills they have and the skills they actually need to best perform their job, according to a study by job site SCIKEY Market Network. The survey further revealed that 70% professionals interviewed feel that their organisation is either already facing this issue of skill shortage or is expected to encounter this as a major challenge in next 2-3 years.

Only 10% of the respondents felt that the knowledge they acquired in their educational institutions has proved to be useful in what they do today, the study noted.

The study is based on an online survey with over 2.500 respondents from across industries including IT/IT services, finance, FMCG, and others.

According to the study 35% employees felt that the skill shortage can lead to loss of revenue for businesses, while 45% also said it leads to poor quality of work.

Employee growth and productivity has a direct correlation to organisational growth and productivity, it said. Moreover, it found that 70% of the

respondents felt that this can severely hamper the productivity of the business and 40% feel it can stagnate the business expansion. With the transition to the virtual

mode of working, 60% respondents said there is an urgent need to address this issue in the field of IT and 33% for Data Analytics, it stated. The survey also revealed that

The survey revealed that the respondents felt that the skill gap resulted in major loss of productivity (70%) followed by higher rate of staff turnover (33%), lower morale (40%), inferior work quality (45%), inability to expand business (40%) and loss of revenue

Addressing the situation is paramount for organisations and the survey highlighted that companies are taking several steps to curb this situation, including inhouse training academy (45%), frequent workshops and sessions to impart skills (53%) and providing resource library to provide employees with relevant material (23%) and many simply rely on employees self-learning (20%).

'The increased skill gap that plagued the job market has left a huge impact and brought in challenges for employers and employees both. This is a stumbling block that makes it difficult for organisations to run flawlessly and for the talent to grow.

South Africa's goals came from the sticks of Tarryn Glasby (15th), skipper Erin Hunter (30th) and Marizen Marais (39th).

With two wins from their final two pool matches, India have finished the group stages with six points from five games. By virtue of this win, India have jumped to the fourth position in Pool A, but Ireland still have a chance to leapfrog the Indians.

India's fate now depends on the outcome of the last Pool A match between Great Britain and Ireland. The Indians will have to wait to know their fate. An Ireland loss or a draw will be enough for India to seal their place in the quarterfinals. The top four teams from each pool will qualify for the knockout round. Needing a win to stay alive in the competition, the Indians meant business and pressed hard on the South African defence from the start.

TOKYO: Discus thrower Kamalpreet Kaur produced one of the best performances by an Indian in the Olympics, though in a qualifying round, as she made it to the finals of the ongoing Games after finishing second here Saturday.

The 25-year-old Kaur, competing in qualification B, sent the discus to a distance of 64m in her third and final attempt to be one of the only two automatic qualifiers for the final round, the other being American Valarie Allman (66.42m). The final will held August 2.

The Indian ended ahead of defending gold-medallist Sandra Perkovic (63.75m) of Croatia and reigning world champion Yaime Perez (63.18) of Cuba. Perkovic qualified at third and Perez at seventh.

But veteran Seema Punia made an exit after finishing sixth in qualification A and 16th overall with a below-par best throw of 60.57m.

Kaur began with a 60.29m effort and then improved it to 63.97m before her third throw of 64m. Every INDIA

competitor gets three throws. Those who touch 64m or at least 12 best performers in the two qualifying rounds advance to the final.

The Punjab athlete has been in impressive form this year as she breached the 65m mark twice recently. She threw 65.06m during the Federation Cup in March to break the national record and become the first Indian to breach the 65m mark.

Then in June, she bettered her own national record with a throw of 66.59m during the Indian Grand

Prix-4 to sit at world number six.

### **Dressel wins gold with world record**

**TOKYO:** Caeleb Dressel won his third gold medal of the Tokyo Olympics with a world record in the 100-meter butterfly Saturday. Katie Ledecky won gold in the 800-meter freestyle, her second of the Tokyo games. Dressel led right from the start and held off Hungary's Kristof Milak to touch in 49.45 seconds, breaking the mark of 49.50 that the American set at the 2019 world championships in Gwangju. Milak, winner of the 200 fly, earned the silver with a blistering 49.68. The bronze went to Switzerland's Noe Ponti.

### Biles withdraws from vault, uneven bars

TOKYO: USA Gymnastics says Simone Biles has decided to withdraw from

the Olympic event finals in the vault and uneven bars. She continues to be evaluated daily to determine whether she'll compete in the finals for floor exercise and balance beam. Biles said she was putting her mental health first when she withdrew from the gymnastics team



event after one rotation. The US Women won silver there. She also decided not to compete in the allaround. American Sunisa Lee won gold in that event

### Lahiri needs miracle for medal

**TOKYO:** Indian golfer Anirban Lahiri salvaged his third round with a late birdie and an eagle to card a three-under 68 at the Olympics but it may not be enough to give him a chance to make a run for the medal. Lahiri, who returned early this morning to complete his second round had a bogey in one of the two remaining holes for a round of 1-over 72, which placed him T-24th at that stage. He ended Tied-28th after the third round with a total of 6-under 207. Udayan Mane carded a 70 for a share of 55th place on 2-over 215 as the third round was completed with a split start – from first and 10th tees. The leader after the second round is Xander Schauffele (USA), has the 54-hole lead after shooting a 3-under 68 today to move to 14-under overall.

### **Indian sailors languish at bottom**

**ENOSHIMA:** Indian sailing pair of KC Ganapathy and Varun Thakkar continued to languish at 17th overall after the penultimate race in the men's skiff 49er event at the Tokyo Olympics here Saturday. ## Hungarian GP: Hamilton takes pole Pant opens up on his evolution as player

Budapest, July 31: Lewis Hamilton took pole position for the Hungarian Grand Prix ahead of Mercedes teammate Valtteri Bottas, with championship leader Max Verstappen lagging behind them in third place Saturday.

Hamilton's record-extending 101st pole in Formula One puts him in a strong position for a recordextending 100th win on a circuit where he has won the past three races and a record eight times.

Hamilton was 0.315 ahead of Bottas and 0.421 clear of Verstappen. Verstappen was chasing a sixth pole this season for Red Bull. His teammate Sergio Perez placed fourth.

Verstappen led Q1 — the first section of qualifying — from Hamilton and Q2 from Norris. The orange-shirted Dutch fans in one section of the main grandstand roared every time he came past them on the long straight.

But Hamilton and Bottas were quicker than Verstappen on their first runs in Q3. Pole could prove crucial Sunday, given that the



sinewy and tight 4.4-kilometer (2.7-mile) Hungaroring circuit is arguably the hardest track to overtake on after Monaco.

About halfway through Q2, Carlos Sainz Jr. lost the rear of his Ferrari and slid off into a wall. The front wing dropped off the car and slid under the front tires. The Spaniard jogged away and he will start from a lowly 15th Sunday.

Teammate Charles Leclerc, who has two poles this season and nine

in his career, qualified in seventh behind Norris and AlphaTauri driver Pierre Gasly.

In the standings, Verstappen is eight points ahead of seventime champion Hamilton. He leads Hamilton 5-4 for wins and 5-3 for poles.

Mick Schumacher starts from 20th and last place. He sat out qualifying after crashing earlier in the final practice and his Haas team was unable to repair his car in time. PRESS TRUST OF INDIA

Nottingham, July 31: The supremely talented Rishabh Pant is glad that he has seen a lot of "ups and downs" and evolved as a player, having "learnt from his mistakes" in his short but eventful international career.

Pant, who recently recovered from COVID-19, is fighting fit and ready to play his 22nd Test for India at the very same venue (Trent Bridge), where he had announced his arrival in the Test match arena with a huge six in 2018.

"It's been an amazing journey as I have seen lots ups and downs early in my career. As cricketers, you evolve, learn from your mistakes and improve yourself and comeback to the ground and perform well.

"I am glad that I have learnt from my mistakes and I capitalised whatever opportunity I got after that. I am happy," Pant told 'bcci.tv'

Pant said that he is trying to learn from everyone in the leadership group in order to become a

better player. "I talk to Rohit bhai a lot – like talking about the game as what we have done in previous matches and what we could have done. Also what we should look to do and look at possible outcomes in future games. What all I can

add to my game.

"I also take technical inputs from Virat bhai. Especially playing in England, standing up to stumps or going back," said the 23-yearold man from Rourkee.

He wants to pick everyone's brains in order to become better. "I speak to Ravi bhai (Shastri) a lot as he has played enough cricket all over the world. Ash bhai (Ashwin), when he bowls, he has an idea what the batsman's intentions are. "So as a batsman, I can ask the

bowler as to what he is thinking. As a player, I want to learn from each and every person."

With 1400 plus runs at an average of 43 plus and three hundreds with another 83 dismissals with the gloves, Pant's certainly one of world's finest young players, who had singlehandedly won the Test series against Australia earlier this year.

To top it, he also had a stellar role during the home Test series against England, where he played an audacious reverse sweep off Jimmy Anderson. It all boils down to one's "processes".

"I think as a cricketer, I have evolved in the last one year or so, because (even though) you keep doing your processes right, you don't get results but if you have trust your process and keep doing that again and again. I have been trusting my process and I am getting the results and that's the happy part now."
