ARMY COPTER CRASHES INTO LAKE

KATHUA/CHANDIGARH: An Army helicopter crashed into the Ranjit Sagar Dam lake in Jammu and Kashmir's Kathua Tuesday, prompting the authorities to launch a massive search operation to trace the missing, an official said. The dam is located about 30 km from Pathankot in Punjab and the incident took place around 10.30 pm. Kathua Senior Superintendent of Police (SSP) RC Kotwal told reporters that the forces and boats were mobilised for the search operation. after which some pieces of chopper were found.



MUMBAI: The Sensex skyrocketed 873 points to a fresh closing peak while the Nifty finished above the 16,000-mark for the first time Tuesday as economic recovery hopes triggered across-the-board buying. Investors grew richer by ₹2.30 lakh crore, with market capitalisation of all BSE-listed reaching a lifetime high of ₹2,40,04,664.28 crore. Rising for the second straight session, the 30share BSE benchmark Sensex ended 872.73 points or 1.65 per cent higher at its fresh closing record of 53,823.36. India to meet Germany in bronze playoff

Tokyo, August 3: The Indian men's hockey team's dream of an Olympic gold after 41 years remained unfulfilled as it lost 2-5 to world champions Belgium in the last-four stage but the side is still in the hunt for a bronze in the Tokyo Games here on Tuesday.

Alexander Hendrickx (19th, 49th, 53rd minutes), the tournament's highest goal getter, scored a hat-trick while Loick Luypaert (2nd minute) and John-John Dohmen (60th) also struck to hand the reigning silver-medallists their second successive entry into the final of the Olympics.

India's goals came from the sticks of Harmanpreet Singh (7th) and Mandeep Singh (8th). The Indians still have a chance to secure an elusive medal from the Olympics as they will feature in the bronze medal match Thursday against Germany, who lost 1-3 to Australia in their semifinal clash.

India's last appearance in the final of the Olympics came in 1980 Moscow Games where they went on to win their last of the eight gold medals. The Indians had only themselves to blame for Tuesday's disappointment as Belgium's all four goals came from penalty corners. The Indian defence was put under relentless pressure by the Belgians.

Belgium's game plan was clear from the onset as they tried to enter the Indian circle and earn penalty corners with Hendrickx and Luypaert in their ranks. The ploy worked to perfection as the Indian defence wilted under pressure to concede the set pieces. India too earned five penalty corners in the match but could make use of just one. The Indians started slowly as Belgium had the initial burst of the match, controlling the proceedings for the first five minutes which also yielded them a goal.

Land conversion automated

INITIATIVE LAUNCHED ON A PILOT BASIS IN ROURKELA

Bhubaneswar, August 3: As part of its 5T initiatives, the state government Tuesday launched an automated system for conversion of land from lease hold to free hold in Rourkela Municipal Corporation (RMC) on a pilot basis. Chief Secretary Suresh Chandra

Mahapatra launched the service in the presence of Revenue and Disaster Management Secretary Bishnupada Sethi, Sundargarh Collector Nikhil Pavan Kalyan.

Mahapatra asked the RMC and the district administration to make the system more citizen-centric by reducing the burden of document compliances at the time of submission of applications.

He sought exploring possibilities of substituting affidavits and indemnity with self-declaration. He sought to link the system with Jana Seva Kendras and Common Service Centers so that citizens could submit applications from those points. He also advised to make the provision for online submission of applications and fees from individual computers so that people could do it from their homes.

Sethi said operation of the sys-

The District Collector said in the offline system, applicants had to run to government office 5-6 times for submitting physical copies of the documents and meeting various queries. Applications were also to be sent to different sections and offices for verification

Applicants had no way to know the status of their applications without running to offices. The entire process was time-consuming. Now, the whole work will be done through automated software and people do not have to run to offices.

On submission of applications, the office of the ADM would process it through the online system after verification.





The 24-year-old American returned to competition after a week due to mental health

concerns, especially the 'twisties'. Simone, the reigning world champion on the balance beam, had also won the bronze in the event during the 2016 Rio Olympics.

Arriving for the Tokyo Olympics. Simone was looking to defend her four gold medals from the 2016 Rio Olympics. But after being unable to do two-and-a-half twists on vault during the first rotation of the women's team final last week Tuesday, she withdrew from the competition

in order to protect her mental health. In her absence, the USA was unable to defend its gold from the 2016 Olympics and settled for silver behind the gold medal winning team, the Russian Olympic Committee (ROC).

Simone had later said that she would make a decision on her participation in each event by every day. Later, she proceeded to withdraw from the individual all-around, vault, uneven bars and floor exercise fi-

She tried to explain what was happening with her, with regard to the 'twisties', a mental block for gymnasts where the mind and body are not in rhythm.

"For anyone saying I quit, I didn't quit, my mind and body are simply not in sync as you can see here," she wrote on her Instagram stories. "I don't think you realise how dangerous this is on a hard/competition

surface. She added that the twisties used to affect vault and floor exercise routines, but has extended to skills on all ap-

On competition days, she has been cheering her team-mates Sunisa Lee, who won the gold medal in all-around event and MyKayla Skinner, who replaced her in vault and took the sil-





Guard shoots himself dead before police

Bhubaneswar, August 3: A security guard committed suicide by shooting himself before the police at Ganganagar under Airport Police limits here during the wee hours of Tuesday.

The deceased was identified as Krushna Chandra Dash, a native of Sarankul in Nayagarh district, who was staying in Ganganagar area for the past few years. He was working at a security agency.

According to a source, Krushna shot himself dead with his gun around 2am Tuesday.

Krushna had also worked as an attendant at the Capital Hospital. He was allegedly removed for misbehaving with some women staffers at the hospital. The Airport police had also arrested Krushna for inflicting severe injuries on his wife in January this year.

He had been suspecting his wife of having extramarital affairs and the couple would often quarrel over the issue. They both engaged in a heated argument last night too.



The police have started an investigation into the issue after registering a case (19/21) in this regard. Meanwhile, rising suicides in the Capital city has become a major cause of worry for the police.

As per available data, 151 persons have committed suicide in the city between January and June, 2021. There were 310 suicides in the city during 2020 as against 220 in 2019.

State adds 1,129 new cases, 69 deaths

Bhubaneswar, August 3: Odisha Tuesday registered 1,129 new Covid-19 cases, which took the tally to 9,80,866, while 69 fresh fatalities pushed the toll to 6,120, a Health department official said.

The coastal state currently has 14,325 active cases. As many as 9,60,386 patients, including 1,785 Monday, have recovered from the viral disease, the official said. Of the 1,129 new cases, 657 were reported from quarantine centres and rest detected during contact tracing, he said.

Khurda district, which encompasses state capital Bhubaneswar, reported the maximum number of new cases at 388, followed by Cuttack at 135. All 28 other districts recorded less than 100 infections each.

Khurda alone accounted for 23 fresh fatalities followed by nine from Cuttack, seven from Puri, six from Kendrapara and three each from Balasore, Mayurbhanj, Jagatsinghpur and Bhadrak.

1,903 deaths were registered in July, which pushed the case fatality rate to 2.89 per cent.

This apart, 53 other Covid-19 patients have died due to comorbidities in the past.

The Health department, however, explained that the daily fatalities announced in July also included backlog from May and June, the audit process for which took time.

Over 1.62 crore sample tests have

The sleuths are likely to question Sahoo over his alleged involvement in a possible recruitment scam in the OSSC.

On the other hand, two officers of the Vigilance department Tuesday examined various documents related to Sahoo. The seized laptop, mobile phones of Sahoo have also been sent for forensic examination

Meanwhile, job aspirants con-

Notably, the Vigilance sleuths found Sahoo possessing DA valued around 268 per cent more than his known sources of income. Bhubaneswar, August 3: Chief Minister Naveen Patnaik Tuesday directed the authorities to ensure oxygen plants are operational in 20 district headquarters hospitals (DHHs) across the state by the end of August in the wake of a possible third wave of Covid-19.

"Two officers are specially engaged by the state government for inspection of production work in oxygen plants and management," Patnaik was quoted as saying in a release issued by the Information and Public Relations department

The Odisha government has formed a task force headed by the CM's principal advisor A K Tripathy to coordinate movement of supply of liquid medical oxygen (LMO) to other states.

Official sources said steel makers from the state had supplied nearly 47,800 tonne of LMO during the second wave of the pandemic in the country.

The Health department, however, said the impact of the possible third wave would be much less in Odisha compared to other states.

"Health experts have predicted the onset of the third wave in August. Going by the downward trajectory of Covid-19 positive cases in Odisha at present, we can say it will have less impact on our state, Director, Medical Education and Training (DMET), CBK Mohanty, told reporters here

As the next wave is expected to impact children more, the DMET said the Odisha government has made special bed arrangements for them in government hospitals and medical colleges.

In its report submitted to HC March 15, the committee had informed the court that Gahirmatha and Rushikulya mouths should be protected in order to safeguard the Olive Ridley sea turtles. At the same time, it should also be ensured that fishermen do not struggle for a livelihood. The court had asked the Centre and the state to file affidavits in connection with the safety of the Olive Ridley turtles. However, neither of the governments did turn up, sources said.

Coastal erosion may soon wash away Sunei-Rupei forest

Kendrapara, August 3: Coastal erosion has become a bane for Kendrapara district as the sea is constantly eating into the coastlines and wiping out areas from the map, a

The district is situated closed to the sea and has a long coastline. Over 28 km out of 48 km coastline in this district are under serious threat with the tidal waves gobbling up the areas on a regular basis. Things have come to such a pass that tidal waves cross the saline embankments on full moon days and new moon days.

A case in point is the 1,200-yearold Panchubarahi temple at Satabhaya village, a seaside panchayat comprising seven revenue villages in the district.

The temple built by the Bhoumakar dynasty will soon be assigned to the pages of history as the sea has washed away 40 metres of the coast in the area. The temple was initially established at about 5 km from Satabhaya which has now gone into the sea.

Later, the Kanika royals shifted the idol of Devi Panchubarahi to Satabhaya for the second time. This month, tidal waves were again seen inundating the temple. Faced with this threat, the district administration has now shifted the idol to a new temple at Bagapatia,

As the tidal waves are constantly lashing the seaside Satabhaya villages, it is apprehended that the Sunei-Rupei jungle in the area might soon get washed away by the sea. Locals as well as environmentalists said that the only way to save Satabhaya is to create mangrove forests on the existing farmlands in the area. Some villagers have demanded construction of a stone embankment at Agarnasi island to check coastal erosion.

Sudarshan Swain, a native of

Barahipur village in Satabhaya and a new settler at Bagapatia, said many villages in Satabhaya panchayat have been gobbled up by the sea during last five decades. Only a few hamlets like Magarkanda, Adhasal and other villages still exist, but they too are

counting their days. Rapid erosion of the coastline has forced the villagers in the area to shift to Bagapatia. Around 571 families in Satabhaya, after battling with the sea for four decades, shifted to Bagapatia three years back. Swain has demanded a long-term plan to check coastal erosion, failing which the entire coastline will

vanish into the sea.

Karunakar Behera, a boatman in Baunsagadi river, said tourists have stopped visiting the area and there is none to hire his boat after seawater inundated the old Panchubarahi temple in Satabhaya. Left & China

The Left in India is on the firing line for its closeness to China at a time when the Sino-Indian relations are under severe strain due to the escalating border conflict in both the eastern and north-western flanks. The participation of three Left leaders, including CPI-M general secretary Sitaram Yechury, in an online seminar July 27 hosted by the Chinese Embassy in Delhi has drawn sharp criticism. At the same time, a book penned by former foreign secretary Vijay Gokhale has called into question the real motive of the withdrawal of Left support from the Congress-led UPA government on the issue of the Indo-US nuke deal in 2008. Gokhale asserts in his book that the Left's opposition to the nuclear deal was at the behest of China.

The ostensible reason for the online seminar was the centenary celebrations of the Communist Party of China (CPC). The theme was 'Sharing Experience on Party Building, Promoting Exchange, and Cooperation.' There was nothing wrong in holding such an event by the Chinese embassy when China has party-to-party contact with several Left parties. It was only natural that the CPC would like to have an exchange with the Left parties on the Left movement in the world and its challenges. Yet, the Left parties in India have, once again, proven their insensitivity towards national interest. No political ideology should be allowed to clash with the interest of the people of the country. It is this sort of behavior which has distanced the Left parties from the millions of poor and toiling citizens of India. It may be noted that neither the Congress nor the BJP sent any congratulatory letters to the CPC on its centenary in view of the current strife between India and China. However, both the CPI-M and the CPI were prompt in greeting the CPC for the milestone it has reached.

The real intent of the online seminar organized by the Chinese Embassy becomes suspect as the Chinese diplomat raised the issue of border tension and even tried to justify its actions in Galwan Valley in Ladakh last year. The event was addressed by Sun Weidong, Ambassador of China to India and the Left participants were CPI(M) general secretary Sitaram Yechury, CPI general secretary D Raja, All India Forward Bloc secretary G Devarajan and DMK Lok Sabha MP S Senthil Kumar.

The Chinese Ambassador's speech explaining the rise of the CPC and the pace of development in the country under the leadership of President Xi Jinping was on predictable lines. But, questions are being raised about diplomatic propriety and the silence of the Left leaders over Ambassador Sun's reference to the Galwan Valley incident and his assertion that the matter of right and wrong was clear in the incident.

The Left, however, defended the decision to attend the seminar arguing that the government itself is engaged with China on several issues. Yechury was smart enough to deflect criticism by asserting that the programme had nothing to do with India-China relationship.

The charge brought by former foreign secretary Gokhale against the Left is far more serious as he claims in his book that the Left's opposition to the Indo-US nuclear deal between 2007 and 2008 was the "first instance for China to operate politically in Indian domestic politics." As Joint Secretary (East Asia), Gokhale was handling the country's affairs with China in the Ministry of External Affairs when the deal was being negotiated. India got a waiver from the Nuclear Suppliers' Group (NSG) after Beijing relented. During his nearly four-decade-long diplomatic career Gokhale spent over 20 years in China and seven years on the China desk in MEA. He is supposed to be proficient in Mandarin as well and has served as India's Ambassador to China.

As such his charge about the Left's alleged complicity with China in blocking the nuke deal carries weight. In fact, there has always been room for suspicion about then CPI-M general secretary Prakash Karat's adamant attitude in forcing the UPA government to cancel the nuke deal or else the Left would withdraw its support from it. The Bengal unit of the CPI-M was divided on the Left stance as many among the front ranking leaders, including Late Somnath Chatterjee, the then Speaker of Lok Sabha, did not find any justification for pulling out of the government on the nuclear issue. Moreover, the Left then having the highest number of MPs - 60 - in its history was virtually doing back-seat driving of the government.

The worst fallout of the decision was the subsequent decimation of the Left in its bastion in West Bengal and then Tripura. The party has now been reduced to a virtual signboard organisation in Bengal. The entire Left could not win a single seat in the recently held Bengal Assembly polls.

One reason for the obduracy of Karat and his followers in withdrawing Left support from the UPA government could be China's insistence that the deal should be scrapped as it was not in its interest. Even after the publication of Gokhale's book, Karat has justified his decision on the ground that the opposition stemmed from worries that the deal would lead to consolidation of US militarization in the region and the current situation proves the Left stand was right.

But, the question survives how such a decision could be taken when it could be easily understood that the Left in that event would lose its preeminent position in the Parliament, chalking up the highest ever tally. Seemingly, the Left was then more interested in safeguarding China's interest than its own. Subsequent events have shown how suicidal the decision was. It was nothing short of political harakiri. Gokhale may have ample reason for his conclusion on the Left-China nexus.

March 23, 2011 The Guardian noted that the lexicon of politics in Britain had added a new term. It quoted a report that had run on its own front page the day before: "Senior cabinet ministers admitted 'the emotional optics' of cruise missiles raining down, backed by coalition military briefings, had unwelcome echoes of Iraq." It also quoted from another London paper: This UN action, which started on Saturday with French warplanes and American cruise missiles hitting Gadhafi's forces, comes none too soon. U.S. President Barack Obama temporized for weeks, worrying about the optics of waging war in another Arab state after the Iraq fiasco (Daily Star, 19 Mar. 2011). Optics is political shorthand for the public perception of some situation. It's far from new. William Safire had noted it in his last-ever On Language column in the New York Times in September 2009, guoting a reader. Tom Short of California: "It seems that politicians are now working to ensure that their policy positions are stated in a way that's 'optically acceptable' to their constituents." Safire's successor Ben Zimmer wrote about the term in his own On Language column the following year: When politicians fret about the public perception of a decision more than the substance of the decision itself, we're living in a world of optics. Of course, elected officials have worried about outward appearances since time immemorial, but optics puts a new spin on things, giving a scientificsounding gloss to P.R. and image-making (New York Times, 7 Mar. 2010). Ben Zimmer recorded that he had found it from three decades earlier: May 31, 1978, The Wall Street Journal quoted Jimmy Carter's special counselor on inflation, Robert Strauss, as saying that business leaders who went along with Carter's anti-inflation measures might be invited to the White House as a token of appreciation. "It would be a nice optical step," Strauss said.

FAR RIGHT'S WAR ON WOMEN

grim 10-year anniversary last month did not go unmarked. July 22, commentators around the world duly commemorated the 77 victims of a Norwegian far-right terrorist who detonated a bomb outside the prime minister's office in downtown Oslo and then massacred teenagers attending a Labour Party summer camp on the island of Utøya.

Most of these analyses aimed to understand the horror by way of the perpetrator's "closely intertwined anti-Muslim and anti-social democratic sentiment." While some expressed relief that he has not inspired more copycats, others used the occasion to indict 'neoliberalism' and other monocausal abstractions. Strikingly absent from the punditry was the killer's evident misogyny.

After more than a decade of witnessing a global resurgence of the far right, we continue to underestimate the importance of gender – especially defenses of patriarchy – as a bridge between extremists and the mainstream conservatives who are increasingly willing to collaborate with them.

Some worry that interpreting a mass murderer's online manifesto hands him a victory and helps to spread his toxic ideology. But we cannot allow ourselves to be willfully blind to a killer's mindset, nor should we surrender to the unreasonable fear that terrorists' ideas are so seductive that they must be suppressed (an argument occasionally employed to justify banning Mein Kampf).

Of course, many hate manifestos are just cut-and-paste jobs, which means that the dangerous ideas are already available elsewhere. But if one bothers to compare the diatribes published in conjunction with the Utøya mass murder and the one carried out against Muslims in Christchurch, New Zealand, in 2019, the similarities are striking. And so, too, are the parallels between these and far-right populist parties' official programmes.

After all, far-right politicians have been saying for decades that 'our country' is being taken away from 'us.' Here, 'our country' is imagined to be a white, Christian nation that is increasingly threatened by Islam. Muslims, it is said, are immigrating in increasing numbers and having more children, supposedly to 'replace' the

rightful inhabitants of the 'homeland.' Yet alongside these nativist conspiracy theories about the 'Great Replacement,' one also finds an open admiration for the traditional masculinity supposedly promoted by Islam. Hence, white supremacists at the deadly Charlottesville rally in 2017 chanted 'white sharia now!'

Ultimately, the real problem for many on the far right is liberalism, and particularly the liberation of women from laws and social norms enforcing male domination. In the eyes of its enemies, liberalism does not just mean openness (or at least porousness) and flexibility; what they find threatening is ts questioning of traditional authority, especially patriarchal authority to make decisions about women's bodies.

The July 22 killer left no doubt about his desire to reinstate patriarchy. In his ideal world, women would be rigidly controlled to ensure the reproduction of the white Christian Volk. He detailed how this might be achieved by returning to the 1950s, when men were in charge and women submissive; or with a scheme in which surrogate mothers in poorer countries would be paid (minimally) to have European babies; or by developing an artificial uterus that would render

women entirely expendable.

With this fantasy about the complete destruction of females, his plan for July 22, 2011, included the public beheading of Gro Harlem Brundtland, Norway's first female prime minister (who happened to leave the island earlier than expected on the day of the massacre). As astute analysts have pointed

out, the far right oscillates between benevolent and hostile sexism: women are either weak vessels who need to be protected, or sly aggressors destroying Western nation-states in the name of gender equality. The latter depiction makes men into victims, allowing those who turn to terrorism to claim that they did not start the violence. As 'victims,' they are entitled to react to others' aggression, and ultimately have permission to annihilate the enemy. The same logic was also on display in the January 6 attack on the US Capitol, where men carried out most of the violence and targeted prominent women like Speaker of the House Nancy Pelosi (whose office was ransacked).

The far-right Norwegian Progress Party has been at pains to dismiss references to the Utøya murderer's membership in its youth section as a cynical instrumentalisation of the violence. Likewise, Republicans have ac-

cused those who tell the truth about January 6 of 'playing politics'

But those who loudly proclaim that the homeland is under threat – Progress leaders had talked about 'sneak Islamisation' – and incite hatred of unpopular minorities cannot be surprised by what philosopher Kate Manne has termed 'trickle-down aggression.' When Björn Höcke of the far-right Alternative for Germany demands that "we have to rediscover our masculinity, for only then can we become militant," he knows full well how his rhetoric will be re-

Globally, the far right stands to gain from the massive material and financial support enjoyed by those advancing 'family values.' Far-right populists are also trying hard to make themselves appear acceptable to mainstream conservatives by emphasising a seemingly shared social agenda. It is no mystery why they would take this approach: they have only ever come to power when more established center-right forces decided to collaborate with them.

Hungarian Prime Minister Viktor Orbán has long played this game, appealing to center-right parties with the argument that his autocratic and kleptocratic regime constitutes an authentic version of Christian Democracy. Accordingly his government vigorously opposes same-sex mar riage, and works hard to associate homosexuality with pedophilia. In recent anti-LGBTQIA legislation, Orbán has made it all too obvious that incitement of hatred against minorities, rather that fidelity to natural law or supposed 'natural order,' is the real objective.

We must recognise that the ideological and emotional appeal of the far right is not reducible to a single element such as hatred of Islam. Their attempts to jump even higher had failed, so an Olympic official started to tell them their options, including having a 'jumpoff.' But before he could finish, Barshim asked, "Can we have two golds?"

"It's possible ... if you both decide ...," the official started to say, and next thing you know, the two athletes were hugging each other and celebrating. While Barshim threw

his hands in the air and pumped his fists, Tamberi rolled around on the ground, holding his chest like he was having a heart attack.

It would not surprise me to learn that an ambulance had been summoned, and that every losing athlete in Tokyo was breathing a sigh of relief, realising that a gold medal could be hazardous to one's health.

It turns out that high jump is one of the only two Olympic events—pole vault is the other—where a gold medal can be shared, as long as the athletes agree not to break a tie. Rule 26.8.4 of the technical rules for World Athletics, the international governing body for track and field, reads as follows: "If no jump-off is carried out, the tie for first place shall remain, the gold medal will be shared, and the ecstasy, euphoria and jubilation of multiple athletes will be permitted."

While most sports fans appreciated the sportsmanship that the two high jumpers exhibited, some were not thrilled about a shared gold

medal. "Maybe it's just me but I wish the rule wasn't there to 'share' the gold. Surely there needs to be an outright winner?" BBC sports reporter Rob Staton commented on his blog.

Another commenter named Trevor agreed with him, saying, "Imagine training for 4 years to win a gold medal and then deciding you will just share it, instead of trying to win?"

But what's wrong with sharing? The world would be a better place if more people were willing to share: share meals, share rides to work, share everything but germs and viruses.

Does every contest need an outright winner? If two Olympic finalists are so closely matched that you can't separate them without an artificial tiebreaker, perhaps they both deserve to return home as heroes. Of course, the silver and bronze medals are quite prestigious by themselves. Finishing in the top three in the world is a

magnificent achievement, and athletes such as PV Sindhu and Mirabai Chanu deserve the adulation they have received.

In fact, I believe that we should expand the medal podium and honour the top five athletes in every event. The fourth place finisher would receive a tin medal and the fifth place finisher would get aluminum. Perhaps we could also treat the sixth place finisher to zinc.

PT Usha and the late Milkha Singh both deserved Olympic medals in track and field. Usha, one of India's greatest female runners, finished fourth in 400m hurdles at the 1984 Los Angeles Olympics, just 1/100th of a second behind the bronze medallist. Singh finished one-tenth of a second behind the bronze winner in the 400m race at the 1960 Rome Olympics.

Both were a blink of an eye from a medal. They did not get a spot on the medal podium, but they were definitely winners in my book.

Jajpur, August 3: A number of fradulent cases were detected while examining the certificates of Odisha Eligibility Teachers' Test(OTET) in Jajpur, a report said.

According to the report, in the

past, many teachers have been caught furnishing forged BEd and CET certificates in the district. The latest fraud came to the fore through a response to an RTI query. Abhimanyu Barik, an RTI activist

Abhimanyu Barik, an RTI activist of Bhadrak, had drawn the attention of the Jajpur district education officer (DEO) March 19, 2021, towards a teacher serving on the basis of a forged OTET certificate. He had also apprised the Secretary of the School and Mass Education department of this matter, June 9, 2021.

In response, the district Education department started an investigation into the allegation, which led to the detection of two

more cases in Jajpur. During the investigation, it was learnt that three teachers got increments on the basis of their forged OTET certificates.

The district Education office has asked the Barchana block education officer to issue show cause notices to the teachers concerned.

Besides, the Joint Director and nodal officer of the Directorate of Elementary Education, Odisha, (via their letter No. 12225, dated July 29, 2021) directed the district education officer and the Barchana BEO to verify the documents, certificates and marksheets of the concerned teachers.

The officials were also directed to lodge FIRs against the teachers at the local police stations and dismiss them from service under OSC (CCA) Rule-1962 if their documents are found to be forged.

It may be noted here that the Directorate of Elementary Education and the School and Mass Education department in 2015 and 2016 had asked the DEO to look into the cases wherein teachers

The DEE had again ordered for verification of the certificates of teachers in 2019 (twice) and in 2020 (twice). But it is alleged that no

As the officials orders are not carried out properly, detecting fake teachers has been an impossible task. As per the RTI response, OTET results were out November 21, 2019. In all 46,822 teachers were successful. The RTI response stated that candidates with roll numbers like 181002255; 1813010067 and 1811306011 could not succeed. The RTI activists had alleged that an assistant teacher of Barchana block was involved in the fraud. The district Education department had sought documentary data of 10 teachers from the Board of Secondary Education. As per the data provided by the BSE, three teachers had furnished fake OTET

Khallikote College gets unitary varsity status

Berhampur, August 3: The Khallikote Autonomous College, one of the oldest colleges in the state, was given the status of a unitary university, officials said Tuesday.

Chief Minister Naveen Patnaik had announced in May that unitary university status would be granted to the 165-year-old college, located in Berhampur town in Ganjam district.

Some of the university's existing problems, including staff crunch, will be solved gradually, while recruitment of new teachers will be carried out, an official said.

The institution was started as a school in 1856 in Berhampur and became an intermediate college in 1878. The autonomy was



conferred to it in 1990. It got an 'A' grade from the National Assessment and Accreditation Council (NAAC) in 2017, according to the college website.

A unitary university is a varsity that acts as a single unit without any affiliated college under it.

"Unitary university status to this college has fulfilled the aspirations of the people of southern

ne National Sekhar Sahu said.
Accreditation It will usher in a new academic journey, promoting research, he

journey, promoting research, he said. "We hope the new university will provide quality education to the students, along with the research activities in contemporary subjects," he added.

Khallikote College is one of the oldest and famous colleges in the

state, having a rich academic tradition, he said.

Many of its alumni have established themselves in various fields, said Sahu, who is also one of the alumni of the college. The student strength of the college is presently around 5,000. The college offers teaching in 21 different subjects, including six self-financing courses.

Khallikote Cluster University (KCU) Vice-Chancellor PK Mohanty will be acting as the Officer on Special Duty (OSD) of the new university, officials said.

The government has also decided to merge the KCU with Berhampur University. It will come into effect from October, they said.

All the regular employees of the KCU would be absorbed in Berhampur University as regular employees, they said.

Failure of e-auction at Daitari mines sparks fear of job loss, plant closure

Jajpur, August 3: An e-auction of iron ore lump by Odisha Mining Coproration (OMC) held July 31 failed due to the high floor price fixed by the state-owned mining body for Daitari calibrated lumpy ore (CLO), a report said.

As a result, there was no bidding for the entire quantity of 90,000 tonnes of iron ore lump.

It is alleged that OMC arbitrarily fixed the floor price at ₹10,511 per MT knowing well that this is an unviable price for the end-user industries due to the negative factors of Daitari iron ore, such as high phosphate content and high under size.

Reports said that due to this, Daitari iron ore has limited buyers compared to other OMC mines. More than 50 per cent of lifting from Daitari mines is done by Kalinganagar-based industrial firms and nearby industries. Meanwhile, most of the units have shut shop due to such arbitrary pricing by OMC.

Members of Kalinganagar Industries Association (KNIA) and All Odisha Steel Federation (AOSF) had suggested OMC to fix the floor price at ₹7,000 per MT. This would have been a viable price for the Kalinganagar-based industries, but the suggestions fell on deaf ears. Now it is clear that even standalone industries had represented



to OMC to reduce the floor price.

During the last auction held
June 2, the floor price was fixed at
₹11,550 per MT due to bidding by
Jindal Steel and Power Ltd (JSPL)
and Rungta, who have their own
captive mines.

Lifting from Daitari mines in June was only 63,641 MT and in July it was even less at 23,884 MT as against the usual lifting of 2.5 lakh tonnes per month. This has resulted into a sharp increase in OMC's stock of iron ore at Daitari mines to 411,000 MT of CLO as on August 1. As a result, state exchequer and industries are suffering huge losses, primarily owing

to drop in dispatch.

Most of the industries based at
Kalinganagarhaving LTL with OMC
could not lift their quota. Notably, companies like VISA Steel have already
shut down its blast furnace. DRI

and KJ Ispat have also closed their sponge iron units in the area.

Other companies like Mesco Steel, Maithan Ispat and Neelachal Ispat are closed since long due to the unreasonable price of Daitari iron ore, which is fixed by OMC.

There is already a fear among the workers as to whether the industries who have shut their units due to high prices of Daitari iron ore CLO from OMC shall pay wages to them or not. It is learnt that already several contract workers have been retrenched by these industries

dustries.

It is high time that OMC reduces the price of iron ore CLO from Daitari and enable the Kalinganagar-based industries to survive, as the plants without captive mines cannot afford to continue operation in the face of such huge losses, reports added.

Probe starts into MGNREGS irregularities

Three militants of the LeT, including Sharik Altaf, were killed in the Shokbaba encounter.



DELTA PREDOMINANT IN TN COVID-19 CASES



Chennai, August 3: With the Covid-19 cases in Tamil Nadu showing fluctuations with increases in some days and fall in other days, a study on the samples of positive patients have found that the Delta variant is dominant in the majority of samples.

Dr. Selvavinayagam, Director of Public Health and Preventive Medicine, Tamil Nadu government told IANS, "We have so far sent 2,614 Covid-19 samples for genomic sequencing and have received the results for 1,881 and found that a predominantly large number, around 73 per cent are Delta variants."

The Delta variant is the most contagious of all known variants and the original Wuhan strain was overtaken by the more contagious D614G. This variant spreads faster and is able to mutate faster and is able to evade the immunity provided by vaccines.

Dr. Selvavinayagam also said that his department is closely monitoring the situation and each rise in numbers is being critically reviewed. He said, "During the period of recession in any pandemic, cases will not come down that quickly and fluctuations are common. We are closely monitoring the situation.

The state health department is studying all aspects leading to the increase in cases in some districts. The department is of the view that clusters are originating in markets, crowded places, and even from hospitals. The health department is planning for localised mini containments and if there are more than three Covid-19 cases in a locality then contact tracing must be done in that locality.

Dr. Suchitra VMenon, Epidemiologist told IANS, "Government measures are in the right track and when relaxations

Chennai, August 3: For the first time in Tamil Nadu, a captured wild elephant was freed into the forests, an official statement said.

The wild elephant, called Rivaldo by the locals, was caught by the Forest Department personnel May 5, 2021 as it was roaming in Masinagudi in Nilgiri district for a long period.

The locals were afraid of the 30-40 year old wild elephant roaming around freely in their area and hence the Forest Department captured it and put it in a 'kraal' - a enclosure made of wooden logs for keeping captured elephants.

An official group studied in detail the issues involved in letting the elephant back into the forests and brought Rivaldo to the Mudumalai Tiger Reserve. According to the government, the area is rich in green cover and would provide sufficient food for Rivaldo.

In order to monitor its movement, a German-made radio collar has been put on Rivaldo. As per the signals received, the elephant is moving around freely in

New Delhi, August 3: The Kashmir conflict has become a 'family business run by a set of families, and like a family business, it is passed on from one generation to the next, DisinfoLab reported.

The way the conflict is designed, it has generated growing number of stakeholders from set of families to the 'Gora' politicians to the Pakistani establishment in a manner that it would be useful for them to keep the conflict in the perpetual flux, it said. The Kashmir conflict has also cre-

ated an eco-system from which a set of families derive their livelihood and relevance. The Fais, the Thakurs, the Kanjwals, the Ashais, the Fazilis, the Safis, and the Dars, among others, have not only been living their dream lives, they have also come to acquire an aura of 'experts' and 'human rights' activists, an aura that is very useful, particularly in these woke time, DisinfoLab reported.

In a report on 'The Kashmir Conflict Industry Network', DisinfoLab said that the only things



that are missing in this Pakistani orchestrated theatre is Kashmiris themselves. Their role has been reduced to mere objects, in whose name the mercenaries would live a life full of 'activism fun'.

It added that the Kashmir narrative is a globally sponsored narrative, where every so-called humanrights 'concern' on Kashmir is at

However, the story traces its origin back to the key players when the seeds of conflict were sown in Kashmir by Jamaat-e-Islami players; and it has continued to be played by the same set of people through their next generation.

"Hence, it would be criminally naïve for not only Indians but particularly for Kashmiris to assume that Pakistan and the net cast by its establishment would have any interest in resolving Kashmir issue. For the Pak establishment, Kashmir conflict has become a Goose that lays golden eggs, and unlike the stupid old lady, it has no intention of killing the goose," it said.

Oppn targets Shah over law and order

New Delhi, August 3: Opposition parties Tuesday targeted Home Minister Amit Shah over the death of a nine-year-old Dalit girl following an alleged sexual assault, questioning the law and order situation in the national capital, even as the Delhi Police said strict legal action has been taken against the accused

The Delhi Commission for Women launched an inquiry into the incident and summoned the city police after

the girl's parents alleged that she was raped and her body was forcibly cremated by a crematorium priest who had falsely claimed that she was electrocuted.

On Tuesday, the Delhi Police appealed to people not to believe in rumours and said that strict legal action has been taken under IPC, SC/ST Act and POCSO Act.

"We appeal to people not to believe in rumours. Strict legal action has been taken under IPC, SC/ST Act and POCSO Act. An ACP rank officer will be the investigating officer. All the accused have been arrested and sent to jail," the Deputy Commissioner of Police (southwest) said in a tweet.

Delhi Chief Minister Arvind Kejriwal said that there is a need

to improve the law and order situation in the national capital, adding that he will meet the victim's family Wednesday.

Congress leader Priyanka Gandhi Vadra said that Shah went to Uttar Pradesh to "distribute certificates" but was "unable to handle his own responsibility".

TMC national general secretary Abhishek Baneriee also trained his guns on Shah and alleged that the law and order situation in this country is in shambles

Bengal flood: 15 dead, 3L affected

New Delhi, August 3: At least 15 people have died, and lakhs rendered homeless or marooned, as the flood situation in six districts of West Bengal aggravated Tuesday, while torrential rains pummelled the Gwalior-Chambal region in Madhya Pradesh, affecting 1,171

Six people, including three children, died in rain-related incidents across northern states of the country which were lashed by heavy

In Madhya Pradesh, heavy rains were witnessed in Gwalior-Chambal region, especially Sheopur and Shivpuri districts, officials said. adding NDRF and SDRF teams have rescued 1,600 people from flooded areas so far but at least 200 villages are still marooned.

The Army has been called in for rescue operations in Shivpuri, Sheopur, Gwalior and Datia districts, state Additional Chief Secretary (Home) Rajesh Rajora said, adding that despite bad weather, IAF helicopters conducted

the flood-affected areas.

Earlier in the day, three people stranded atop a tree for about 24 hours in Beechi village and five others in Piproudha in flood-hit Shivpuri district, which witnessed "unprecedented heavy rains", were rescued, officials said. "A total of 1,171 villages were af-

fected in the Gwalior-Chambal region due to excessive rainfall, especially Shivpuri and Sheopur, where an unprecedented 800 mm rainfall (in the last 24 hours ending 8 am Tuesday) resulted in flooding," Chief Minister Shivraj Singh Chouhan told reporters.

A 22-year-old UP resident died and two people sustained injuries in a landslide that hit Himachal Pradesh's Solan district, a state disaster management official said.

In Uttarakhand, a stretch of Gangotri national highway caved in following a landslide triggered by heavy rains disrupting vehicular traffic along the route.

The 30-metre stretch fell and slid into Bhagirathi river bringing traffic to a halt, District Disaster Management Officer Devendra

Honey Singh's wife accuses him of domestic violence

New Delhi. August 3: Shalini Talwar, the wife of rapper and music composer Hirdesh Singh, popularly known as Yo Yo Honey Singh, filed a case of domestic violence against him at the Tis Hazari courts here Tuesday.

In her 118-page complaint, Talwar has accused Honey Singh of engaging in extra-marital sex with various women. She has also provided details of the physical, verbal and

emotional abuse that she had allegedly been subjected to by the rapper and his family.

Honey Singh, his wife alleged in her complaint, "began having frequent casual sex with multiple women" when he was travelling and "to further his sexual intents and illicit relationships, never disclosed to the public that he was married". The rapper and Talwar got married at a Delhi gurudwara in 2011. Talwar alleged Honey Singh kept trying to conceal his procliv-



ities from the time they got married

accused him of engaging in substance abuse and even having an affair with a Puniabi movie actress. Taking cognizance of the complaint, Chief Metropolitan Magistrate Tania Singh issued a notice to Honey Singh to appear before her August 28.

The Chief Metropolitan Magistrate passed interim orders restraining the rapper from disposing of the property he jointly owned with his wife as well as her

'Ayyub Thakur channelled ISI funds to Kashmir'

New Delhi, August 3: While on the face of it, Ayyub Thakur was 'lobbying for the Kashmir cause', he allegedly also provided significant support to terror activities against India, channelling ISI funds to Kashmir through various of his fronts and affiliates.

DisinfoLab reported that Thakur was alleged to have funnelled funds to militant organisations in J&K via his charity "Mercy Universal".

In June 2002, J&K police arrested a businessman, Imtiaz Ahmed Bazaz, on charges of funnelling funds sent by Ayyub Thakur from the UK to Kashmiri separatists, including Asiya Andrabi and her organisation Dukhtaran-e-Millat.

During his interrogation, Bazaz confessed to contacting Ayyub Thakur for channelling funds sent by Pakistan's ISI. In response, Ayyub Thakur claimed that he had



sent the money for purchasing sewing machines for the women of

Kashmir. However, while Ayyub Thakur might have denied his role, his son Muzzammil seems to have a different opinion. During an interview with a J&K based media channel, 'Only Kashmir' (in 2015), he admitted that his father "funded terrorism in Kashmir" and that he

also believed it was justified as "Jihad"

Registered in 2000 by Ayyub Thakur, its current board members include Javed Iqbal Aziz, A Hussain, Atif Hussain and Nazir Ahmed. Mercy International was also alleged to be the front used by Ayyub Thakur for funding militants and separatists.

The Justice Foundation was set

up in 2003 by Ayyub Thakur, but within a year he passed away. After his death March 10, 2004, Ghulam Nabi Fai took over the leadership of Justice Foundation alongside his close acquaintance Nazir Ahmad Shawl as Director.

During 2011, when FBI issued an affidavit against Fai, Nazir Ahmad Shawl (Executive Director) was active in the UK circuit and was

attending events with Pak leaders and Kashmiri separatists.

Interestingly, Harsh Mander, former IAS officer and Director of Centre for Equity Studies, was also one of the advisors of The Justice Foundation (details now removed

from website). It is worth noting that Mander's name had also appeared in the earlier story on USCIRF (Un-ending War-II) in the context of fabricated database of minority atrocities in India was being peddled through DOTO and Quill Foundation. Mander was in the Advisory Board of Quill Foundation. DOTO is also partners with Justice For All, DisinfoLab reported.

Ayyub Thakur was dismissed from service at the Kashmir University in August 1980 because of political activism while working in government service, and was imprisoned for five months.

Immediately after his release,

at the invitation of Gulam Nabi Fai, his friend-cum-associate at Kashmir University, Ayyub Thakur moved to Jeddah in 1981 where with Fai's help he became the Faculty of Engineering in the Department of Nuclear Physics.

Subsequently, he shifted to the UK in 1986, on a Fellowship arranged by his friend Fai. Fai and Thakur had started their Kashmir activism during their association with Jamaat-e-Islami. It is not clear whether Fai was already engaged by the ISI during that time, or was he doing it of his own will.

The duo envisaged and strategised to 'internationalise' the Kashmir issue. They decided to target 50 to 60 foreign students who enrolled at the Kashmir University, Regional Engineering College, and Government Medical College. The plan was to convince the foreign students to become 'unpaid ambassadors' of the 'Kashmir cause'.

CDC can't renew ban on eviction

Washington: The White House said that the US Centers for Disease Control and Prevention (CDC) does not have the legal authority to renew an eviction ban to prevent millions of American renters of being forced from their homes during the resurging of the Coronavirus pandemic. Facing growing pressure from Democratic lawmakers over the weekend, the White House said Monday that so far the CDC has been "unable to find legal authority for a new, targeted eviction moratorium". "In the meantime, the President will continue to do everything in his power to help renters from eviction," said White House press secretary Jen Psaki.

N Korea releases army rice stocks

emergency military rice reserves as its food shortage worsens, South Korea's spy agency said Tuesday, with a heat wave and drought reducing the country's supply. NCEMA said on Twitter that passengers travelling from countries where flights had been suspended would be able to transit through its airports from Thursday as long as they present negative RT-PCR tests taken 72 hours prior to departure.

Powerful blast, gunfire hit Kabul

Kabul: A powerful blast followed by sporadic gunfire hit Afghanistan's capital Kabul Tuesday near the city's heavily fortified "Green Zone", an area home to government buildings and foreign embassies, police officials said. At least three people were killed and seven wounded. A senior security official said the blast appeared to have been caused by a car bomb and the apparent target was the residence of a member of parliament.

Tehran, August Ultraconservative Ebrahim Raisi was Tuesday inaugurated as President of Iran, a country whose hopes of shaking off a dire economic crisis hinges on reviving a nuclear deal with world powers.

"Following the people's choice, I task the wise, indefatigable, experienced and popular Hojatoleslam Ebrahim Raisi as President of the Islamic Republic of Iran," Iran's supreme leader Ayatollah Ali Khamenei wrote in a decree read out by his chief of staff.

Raisi replaces moderate President Hassan Rouhani, whose landmark achievement was the 2015 nuclear agreement between Iran and six major powers.

From the outset, Raisi will have to tackle negotiations aimed at reviving the nuclear deal from which the US unilaterally withdrew imposing sweeping sanctions. The 60-year-old also faces the

"But we will not tie the ... economy to the will of foreigners," said Raisi, a protege of Khamenei. Iranian and Western officials have said significant gaps remain to reinstating the pact. A sixth round of indirect talks between Tehran and Washington in Vienna adjourned June 20, and the parties have vet to announce when they will resume.

"I am very hopeful for the country's future and confident that it is possible to overcome difficulties and limitations," he said at the time.

Beijing, August 3: Authorities in Wuhan Tuesday said they would test its entire population for Covid-19 after the central Chinese city where the Coronavirus emerged reported its first local infections in more than a year.

Authorities announced Monday that seven locally transmitted infections had been found among migrant workers in the city, breaking a year-long streak without domestic cases after it squashed an initial outbreak with an unprecedented lockdown in early 2020.

China has confined the residents of entire cities to their homes, cut domestic transport links and rolled out mass testing in recent days as it battles its largest Coronavirus outbreak in months.

China reported 61 domestic cases Tuesday as an outbreak of the fastspreading Delta variant reached

dozens of cities after infections among airport cleaners in Nanjing sparked a chain of cases that have been reported across the country. The eastern city of Yangzhou,

near Nanjing, was the latest local government to order residents to stay home after large-scale testing detected 40 new infections over the past day.

The more than 1.3 million residents of Yangzhou's urban core are now confined to their homes. with each household allowed to send only one person outside per day to shop for necessities, the city government said Tuesday.

New York, August 3: New York governor Andrew Cuomo "sexually harassed multiple women," including employees, the state's attorney general Letitia James said Tuesday as she announced the findings of an independent investigation into allegations against the powerful Democrat. "The independent investigation

has concluded that Governor Andrew Cuomo sexually harassed multiple women and in doing so violated federal and state law," James said at a news conference. She said the investigation found

Washington, August 3: The \$1 trillion bipartisan infrastructure package unveiled by the Senate includes more than \$150 billion to boost clean energy and promote "climate resilience" by making schools, ports and other structures better able to withstand extreme weather events such as storms and

But the bill, headed for a Senate vote this week, falls far short of President Joe Biden's pledge to transform the nation's heavily fossil-fuel powered economy into a clean-burning one and stop climate-damaging emissions from

US power plants by 2035. While the bipartisan plan is "a

good start," lawmakers will "deal with the climate crisis in the magnitude, scope and scale that's required" in the Democratic-only bill, said Sen Ed Markey, D-Mass.

For now, the focus is on the bipartisan deal, which includes \$550 billion in new spending for public works projects, \$73 billion of that to update the electric grid and more than \$50 billion to bolster infrastructure against cyberattacks and climate change. There's also \$7.5 billion for electric charging stations.

Citing the deadly Texas power outages earlier this year, the White House touted spending to upgrade the nation's power grid and boost renewable energy. An Energy Department study found that power



outages cost the US economy up to \$70 billion a year. The bill also invests in demonstration projects wind and hydropower

GST officers detect ₹7,421 crore tax evasion in April-June

New Delhi, August 3: GST officers have detected tax evasion of ₹7,421 crore in the April-June period of the current fiscal, Parliament was informed Tuesday.

In a written reply to the Rajya Sabha, Minister of State for Finance Pankaj Chaudhary gave details of the total tax evasion detected in GST in the last 3 years. In 2019-20, 10,657 cases of evasion, involving ₹40,853.27 crore were detected. Recovery was ₹18,464 crore.

In 2020-21, ₹49.384 crore worth GST evasion was detected in 12,596 cases. Recovery stood at ₹12,235 crore. In the current fiscal up to June, 1,580 cases of Goods and Services Tax evasion involving ₹7,421.27 crore were detected, and ₹1,920 crore recovered in April-June 2021.

Chaudhary said the GST interface for the taxpayers is on a digital platform and softwarebased to be used for payment of tax and to comply with the requirements of law and procedure by taxpayers.

"However, tax evaders are ki to commit fraud even on electronic platforms by way of misrepresentation of facts," he said.

New Delhi, August 3: India's recruitment activity has been recovering steadily as the hiring rate in June 2021 was around 42 per cent above the pre-pandemic levels in 2019, says a report.

According to LinkedIn India -Labour Market Update for June 2021, there was a deepening hiring dip in April 2021, corresponding to a second wave of COVID-19 cases in India. Since then, it has been recovering steadily, compared to the pre-COVID levels in 2019.

Hiring rate was 35 per cent higher at the end of May 2021, and 42 per cent higher at the end of June 2021.

Hiring rate is a measure of hires divided by LinkedIn membership. This analysis looks at the changes in hiring rate between this month and the same month in 2019.

The uptick is possibly due to a release of pent up hiring, as companies took a more cautious stance towards hiring in 2020, the report said. The report further noted that competition for jobs was lower compared to 12 months ago, but applicants are applying more aggressively. "Last year, we saw the applications per job double in the middle of 2020, during the height of global lockdowns. Right now, it is going in the opposite direction - average applications per job is 0.6x compared to the same month last year. Meanwhile, the applications per applicant has been slowly increasing and has reached 1.2x

compared to last year," it said. Taken together, this suggeststhat the supply of jobs has increased in the market.

India's female labour participation rate falls to 16.1%

Mumbai, August 3: Female labour participation rate in India fell to 16.1% during the July-September 2020 quarter, the lowest among the major economies, a government report said, reflecting the impact of pandemic and a widening job crisis.

The percentage of women in the labour force had fallen to a record low of 15.5% during the April-June 2020 quarter, when India imposed strict lockdown to curb the spread of COVID-19 virus, said the report, released late Monday by the Ministry of Statistics.

According to World Bank estimates. India has one of the lowest female labour force participation

rates in the world. Less than a third of women -- defined in the report as 15 or older -- are working or actively looking for a job.

The female labour participation rate in India had fallen to 20.3% in 2019 from more than 26% in 2005. according to World Bank estimates, compared with 30.5% in neighbouring Bangladesh and 33.7% in Sri Lanka

Most employed women in India are in low-skilled work, such as farm and factory labour and domestic help, sectors that have been hit hard by the pandemic. The unemployment rate among

The day turned out to be a disappointing one as men's hockey team also lost their semifinal match against Belgium 2-5. However, they still have a chance to bag a medal when they play for third place to secure a bronze medal.

The 26-year-old Toor, who was expected to at least make the finals, failed to live up to the expectations as he could only manage one legal throw of 19.99m, in his first attempt, to finish 13th out of 16 competitors in qualification A.

Competing with a heavily bandaged shoulder, his next two throws were fouls. Every participant gets only three attempts in the qualification round. The below-par show meant that Toor made an exit even before the start of second qualifi-

Those who cleared 21.20m or at least 12 best performers from the two qualifying rounds made the final cut. Toor had qualified for Olympics with a personal best of 21.49m in the Indian Grand Prix 4 in June. And had he managed to achieve that, he would have been an automatic qualifier to the fi-

Rio Olympics bronze winner Tomas Walsh of New Zealand took the top spot in qualification A with an automatic qualifying mark of

21.49m, which he produced in the third round. His effort was initially ruled as a foul but later restored as valid.

Brazil's Darlan Romani (21.31m) and Egyptian Mostafa Amir Hassan (21.23m) were the other two automatic qualifiers for the final round.

In the women's javelin throw, national record holder Rani was even worse as she finished 14th and last in qualification A with a best third round throw of 54.04m, which was well below her personal best of 63.24m which she had produced in March.

Rani, who qualified for the Olympics on the basis of her world rankings, was unable to breach the automatic entry standard of 64m and eventually ended at 29th and last after the two qualifying rounds. Her two other throws were 50.35m and 53.19m.

Bengal's Abhimanyu Easwaran had last played a first-class game in March, 2020 and that too after enduring a horrendous season. Will the team risk him? It would be a

But where does it leave India's fastest and most in-form bowler Mohammed Siraj, whose raw pace

ousted a concussed Agarwal from this Test match? It would probably require a leap of faith from the skipper to ignore Siraj's calibre.

But if one looks at this team's performance in England, India have lost 11 out of 14 Tests across the last three tours

As the Indian captain walks out with his band of men against a side that has two artists of red Dukes at work in James Anderson and Stuart Broad. The veterans will be complemented by one of the world's fastest bowlers in Mark Wood and a smart apprentice in Ollie Robinson.

The job for Kohli and his seasoned top-order would be easier said than done on a grassy Trent Bridge pitch.

So Cheteshwar Pujara, whose middle-name critics would want to be 'intent', and Ajinkya Rahane, who at times has looked a better Test match captain, would have to do something special.



OFFICIAL THEME SONG FOR INDIAN PARALYMPIC CONTINGENT LAUNCHED


