INDIAN WOMEN TO PLAY FOR BRONZE

TOKYO: A brave Indian women's hockey team put up a gritty performance but it was not enough to secure a maiden Olympic final berth as they lost 1-2 to World No.2 Argentina in a hard-fought semifinal of the ongoing Tokyo Games here Wednesday. They will now fight for the bronze medal against Great Britain in the third-fourth place play-off match Friday. Gurjit Kaur gave India the lead in the second minute, but Argentina hit back through goals in the 18th and 36th minute to emerge winners. MORE P12

however, was left to fight for the bronze medal after he lost his semifinal bout to American David Morris Taylor Dahiya looked down and out in the semifinals against Kazakhstan's Nurislam Sanayev, but turned the bout around in a sensational manner with only a minute remaining. The fourth-seeded Dahiya trailed 2-9 after Sanayev applied a few 'fitley' (leg lace).

However, as the clock ticked away, Dahiya regrouped and got hold of his rival with a double leg attack that resulted in a 'victory by fall'. "I had no business conceding that much lead against Sanayev. I am not happy with it. I have beaten Sanayev twice before, so I knew I could pull it off. I was as-

sured inside, but I made it a close fight. That was pretty bad of me," informed Dahiya. "I still have some unfinished business

to do. I came with a target here

and that is not complete yet (win ning gold)," he added.

to qualify for Olympic finals

It was revealed after the fight that Sanayev had bit Dahiya on his right bicep during the fight. "He is okay, even though it is painful. However, he will be ready for the final tomorrow (Thursday), the official added.

Dahiya however, has a daunting task in hand. In the final, the Indian will face reigning World Champion Russian Zavur Uguev. He had lost to Ugev in the finals of the 2019 World Championships.
Dahiya won both his previous

contests on technical superiority en route to the final. He defeated Colombia's Tigreros Urbano (13-2) and beat Bulgaria's Georgi Valentinov (14-4).

While Dahiya was a live-wire on the mat, Punia (86kg) made good use of a favourable draw to reach the semifinals but lost to the formidable Taylor. He will now fight for bronze Thursday against the winner of the repechage round between Myles Amine and Ali Shabanau.

### Rules relaxed for outsiders

Negative reports, vax certificates not required

Bhubaneswar, August 4: People coming to Odisha from other states will no longer be required to produce Covid-19 negative reports or final vaccination certificates as the state government has removed the restrictions that had been imposed to check the 2nd wave of Covid-19. An order to this effect was announced Wednesday by Special Relief Commissioner (SRC) Pradeep Kumar Jena.

Orders regarding restrictions on entry of people into Odisha from other states by producing Rapid Antigen Test (RAT) or RT-

PCR negative report or final vaccination certificate etc are hereby withdrawn, the SRC order said.

Following the outbreak of the second Covid-19 wave, the Odisha government had made it mandatory for people entering the state to show their Covid-19 negative report or a complete vaccination certificate from April 12.

The restriction was imposed for all modes of travel including trains, roads surface, air and waterways. As per earlier guidelines, a person entering the state without any one of the two would have to undergo a sevenday mandatory institutional

PREPARATIONS IN PLACE TO TACKLE 3RD COVID-19 WAVE, SAYS GOVT

Bhubaneswar, August 4: The Odisha government has decided to set up 14 new RT-PCR laboratories across the state. This information was given by the director of Health Services, Dr Bijay Mohapatra here Wednesday. He said that with the possibility of a third Covid-19 wave still looming large the government has planned for new labs to speed up testing process across the state.

Speaking to reporters, the Director, Health Services, Dr Bijay Mohapatra said that people having covid symptoms won't have to visit far off places to get themselves tested for the infection.

"The government has decided to set up 14 more RT-PCR laboratories in the state. Almost all the districts in Odisha will have dedicated and sophisticated testing centres. This will speed up the testing process. Also people with Covid-19 symptoms will not have travel far if the new laboratories come up," Dr Mohapatra told reporters.

The top health official also stated



**Almost all districts** in Odisha will have dedicated and sophisticated testing centres. This will speed up identifying positive patients

that the government is trying its best to tackle a possible third wave. Tracing, testing and surveillance are the key tools to prevent any wave of a pandemic, he added.

"Proper treatment of critical Covid-19 patients is another method to check the pandemic. The government has made elaborate arrangements for handling



of such patients, before the arrival of the next wave of Covid-19," informed the health official.

The Odisha government is giving priority to vaccination. The pace of inoculation however is dependent on the availability of vaccines." Dr Mohapatra added.

The health official also clarified regarding the large number of fatalities that are being reported daily. He said that the figures being given by the Health department is based on old audited reports. The number of exact deaths can be arrived at only after the pandemic subsides, Dr Mohapatra pointed out. Odisha reported 66 new fatalities Wednesday.

Kumar told reporters that all servitors, officials of the SJTA and district administration who took part in the Rath Yatra festival will have to undergo mandatory Covid-19 testing once more which will begin August 8.

### Lockdown if rules broken: CM

Bhubaneswar, August 4: Odisha Chief Minister Naveen Patnaik warned people that they should continue to remain on guard to prevent the spread of Covid-19 and also to avoid a third wave of the pandemic. The Odisha CM stated that lockdown restrictions were being eased as the number of cases has remained stable for a period now.

Patnaik categorically said that if the number of cases starts shooting up, the administration will not hes-

### **Indigenous Vikrant** ventures into sea

New Delhi. August 4: The muchawaited sea trials of India's first indigenous aircraft carrier (IAC) 'Vikrant', the largest and most complex warship built in the country, began Wednesday. It is a development which was termed 'historic' by the Indian Navy.

With the launch of the sea trials of the aircraft carrier, India has joined a select group of countries having the capability to indigenously design, build and integrate a state-of-the-art aircraft carrier, the Navy said.

The 40,000 tonne aircraft carrier set off on its maiden sea trials, 50 years after its namesake played a major role in the 1971 war.

The aircraft carrier has been built at a cost of around ₹23,000 crore. It is expected to be commissioned into the Indian Navy in the second half of next year after it completes the aviation and other trials.

"It is a proud and historic day for India as the reincarnated Vikrant (IAC) sails for her maiden sea trials today (Wednesday) in the 50th vear of her illustrious predecessor's key role in the victory during the 1971 war," Indian Navy spokesperson Commander Vivek Madhwal told reporters.

The aircraft carrier is around 262 metres long and 62 metres wide, andhas been built by the Cochin Shipyard Limited (CSL)

# India keen to end Chinese supremacy

### **NAVY TO PARTICIPATE IN WAR DRILLS IN SOUTH CHINA SEA** WITH QUAD NATIONS

New Delhi, August 4: India is increasing its presence in the South China Sea. The Indian government will be sending a naval task force to the South China Sea sometime this month to build on security and military ties with friendly countries, officials in the know of things said Wednesday. This move signals India's intention to play a more significant regional role to counter China.

Initially, the Armed Forces were always wary of antagonising China. However, the mood has changed since the Galwan Valley clash in Ladakh last year. The government has since become closer to the United States to nullify the Chinese threat in the South China Sea region.

Four ships including a guided missile destroyer and a missile frigate will be deployed for a twomonth period to South East Asia, the South China Sea and the western Pacific, the Indian Navy said in a statement Wednesday.

"The deployment of the Indian Navy ships seeks to underscore the operational reach, peaceful presence and solidarity with



friendly countries towards ensuring good order in the maritime domain..." the Navy said in the

statement The South China Sea has be-

come one of the many flashpoints in the testy relationship between China and the United States. Washington has time and again rejected what it calls unlawful ter-

counter an assertive China. "These maritime initiatives enhance synergy and coordination between the Indian Navy and friendly countries, based on common maritime interests and commitment towards Freedom of Navigation at sea," the Indian Navy said.



# 51,968 forest infernos in state from Nov to June

New Delhi, August 4: The Union government has informed the Rajya Sabha that Odisha has reported maximum number of forest fire incidents during non-monsoon months - November 2020 to

The Union Minister of State for Environment, Forest and Climate Change Ashwini Kumar Choubey informed the Rajya Sabha that the Forest Survey of India (FSI) had sent 3,45,989 forest fire alerts during November 2020 to June 2021 across the country. As many as 51.968 forest fire alerts were sent to Odisha during the non-monsoon

The ministry further said that the state had received 10,602 forest fire alerts from November 2019 to June 2020 and 19.159 alerts from November 2018 to June 2019. The Union government had released Rs 4.55 crore to Odisha under the Forest Fire Prevention & Management Scheme, the data re-

Choubey also said that the responsibility of forest fire prevention and management lies primarily with the states. The minister, however, said the Union government supports the efforts of the states in prevention and control of forest fire by providing financial assistance.

### ED to investigate money laundering by Biranchi

Bhubaneswar, August 4: The Enforcement Directorate (ED) will probe the involvement of Biranchi Narayan Sahoo, a former private secretary to a member of the Odisha Staff Selection Commission (OSSC) member, in a money laundering case, said an official.

What they have achieved so far will inspire a generation of sportspersons. Wish them all the best for the future, Patnaik tweeted to encourage the men in blue to bag at least a bronze medal, for which India will play Germany.

Patnaik's love for hockey dates back to his childhood days in Doon School where he was the team's goalkeeper or 'goalie'.

### Babus scot-free despite Lokayukta order

### Infra crunch choking fishermen's survival POST NEWS NETWORK

Malkangiri, August 4: Lack of safety gears, fishing equipment and marketing facilities for their produce have posed serious threat to the survival of fishermen in Swabhiman area in this district, a report said. The report said the Balimela

reservoir was constructed on the Sileru river, a tributary of Godavari in Chitrakonda to provide irriga tion facilities to farmlands and power supply to households in the district. Thousands of people were dis-

placed to make space for the reservoir and 151 villages in Kudumulugumma block were cut off from the mainland following the construction of the reservoir. These villages were named as the cut-off region and later, renamed as Swabhiman Anchal in the district.

The state government released varieties of fish seeds into the reservoir so that people in the area could catch fish from the reservoir and eke out their living. The state government's initiative paid

off as people got a scope of earning from fishing in the reservoir.

However, due to lack of safety gears like life jackets and quality fishing boats, many fishermen of Panaspadar and Orapadar villages under Swabhiman Anchal endangered their lives by fishing in small dingy boats. Over the years, several fishermen were drowned while catching fish in the reservoir in small fishing boats.

Earlier, some fishermen were provided with life jackets which is just like a drop in the ocean as compared to scores of fishermen living in the area.

Fishermen like Madhu Sisa, Raghu Golari and Hari Sisa said there are hundreds of fishermen in the area who risk their lives to catch fish from the reservoir in the absence of life jackets and quality boats.

Moreover, they are catching fish in traditional nets and do not have improvised nets. As a result, they do not get enough fish to manage their livelihood, they observed.

This apart, absence of marketing facilities to sell fish has hit them hard. They don't get the right price for their fish catch and often

### China's Coal Relapse

hina is stuck between a fossil fuel-dependent past and a future powered by renewable energy. The country today generates 53 per cent of the world's coal-fired power. At the same time, it is the world's leading manufacturer of, and market for, solar panels, wind turbines, and electric vehicles. Whether China can free itself from its decades-old addiction to coal will determine not just its own environmental future, but also - and more crucially – Earth's prospects in the face of the gathering climate crisis.

China's leaders began to recognise the need for change in the early 2000s The largely coal-fueled "economic growth at all costs" policy had brought great prosperity, but the collateral damage to the country's air and water had grown unacceptably high. Environmental advocates called for "building an ecological civilization," in which nature and humankind would find a harmonious balance. And when President Xi Jinping assumed power in 2012, he immediately took up the cause.

In quick succession, the Chinese government declared a "war on pollution," drew up separate air, water, and soil action plans committing \$1 trillion to environmental cleanup, closed inefficient coal plants, and invested hundreds of billions of dollars in renewable-energy development. It also made domestic manufacture and sales of electric vehicles a high priority, and devised a nationwide carbon-trading system.

Worryingly for China and the planet, that forward momentum now appears to have shifted into reverse. Coal consumption, which had decreased each year between 2014 and 2016, has since risen steadily. The same is true of carbondioxide emissions, which increased by 1.5-1.7 per cent even during the pandemic-induced slow-

China must do better. The 2019 United Nations Emissions Gap Report concluded that limiting global warming to 1.5° Celsius relative to preindustrial levels requires reducing global emissions by 55 per cent from 2018 levels by 2030. But China added 38.4 gigawatts of new coal-fired power capacity in 2020, even as the rest of the world reduced its net capacity by 17.2 GW.

Worse, this increase is only the beginning. The Chinese government has approved construction of an additional 36.9 GW of coal-fired power capacity, bringing the total under construction today to 88 GW. And proposals to build another 158.7 GW are in the pipeline, putting the total new capacity now under consideration at 247 GW - more than the United States' total installed amount of 233.6 GW. There are probably more plants to come. Powerful coal and energy industry groups are pushing the government to increase China's current total coal-power capacity of 1,080 GW to 1,200-1,300 GW over the next five years, and to as much as 1,400 GW by 2035. A Global Energy Monitor (GEM) report concludes that if China continues to expand capacity through 2035 as proposed, "its coal-power generation alone will be more than three times as large as the global  $limit on coal \ power \ use \ determined \ by \ the \ Intergovernmental \ Panel \ on \ Climate$ 

Change to keep global warming well below 2°C.'

What explains China's apparent return to its coal-addicted ways? For starters, the protests in Hong Kong, the trade war with the US, and the coronavirus pandemic have shifted policymakers' focus away from environmental reform. So, too, has the slowdown in China's GDP growth and the rise in unemployment. The government has been more interested in stimulating traditional, energy-intensive industries like steel, iron, and cement, while provincial leaders have embarked on a spree of construction of coal-fired power plants.

Furthermore, the recent US-China trade war has heightened Chinese concerns about energy security, given that the country imports 70 per cent of its oil needs and 40 per cent of its gas requirements. And while China has gone all in on renewable energy, especially solar and wind, it cannot scale up these sources quickly enough to meet anticipated demand. Nor is the current electricity grid capable of transmitting this energy efficiently from China's distant west, where most of it is produced, to high-demand areas, Coal – abundant and relatively inexpensive - seems to many a reliable, tried-and-true

Finally, it is probably not a coincidence that China's 'coal relapse' came at a time when the US was absent from the international climate scene. Whereas former US President Barack Obama and Xi found common ground in the battle against global warming, setting the stage for the 2015 Paris climate agreement, US disengagement from the issue under President Donald Trump probably weakened China's commitment, too.

Which China will the world see in the next several years? That question is more urgent than ever in light of a recent International Energy Agency report warning that all new fossil-fuel development should be halted this year if the world is to achieve net-zero emissions by 2050 and have any hope of limiting the global temperature increase to 1.5°C.

Xi's announcement in September 2020 that China aims to become carbon neutral by 2060 revived optimism. But hopes that the 14th Five-Year Plan (2021-25), released this March, would outline the government's strategy for starting the decarbonisation process were disappointed. And at US President Joe Biden's climate summit in April, Xi announced that during the new Five-Year Plan, China would "strictly control" coal-fired power consumption but allow it to increase, and "phase it down" only from 2026. This is a recklessly unambitious timetable. Climate experts at GEM, TransitionZero, and elsewhere calculate that limiting global warming to well below a "catastrophic" 2°C will require China to close 600 of its 1,082 coal plants by 2030. If they are right, China had better start turning its massive carbon ship around now.

### Optogenetics

News of this field, as yet in its early stages of development — the term optogenetics is first recorded in an article in Nature in April 2008 - has begun to emerge from research laboratories because of its astonishing results. Neuroscientists have inserted genes that code for light-sensitive brain proteins into animal subjects. By firing laser light deep into the animals' brains via fibre-optic cables, they have been able to to turn brain cells on and off at will, like clicking a light switch. It has proved possible to stop the electrical activity of various kinds of neurons, such as those that control movement or the establishment of memories. The technique can also be used as a research tool to monitor when neurons fire. There is some hope that one day a method like this might be used, for example, to control epilepsy and other neurological conditions in humans.

## MANDATING VACCINATION

**WE ARE NOW HEARING DEMANDS FOR** THE FREEDOM TO BE UNVACCINATED **AGAINST** THE VIRUS THAT **CAUSES** COVID-19

'm writing from Victoria, the Australian state that became, in 1970, the first jurisdiction in the world to make it compulsory to wear a seat belt in a car. The legislation was attacked as a violation of individual freedom, but Victorians accepted it because it saved lives. Now most of the world has similar legislation. I can't recall when I last heard someone demanding the freedom to drive without wearing a seat belt.

Instead, we are now hearing demands for the freedom to be unvaccinated against the virus that causes COVID-19. Brady Ellison, a member of the United States Olympic archery team, says his decision not to get vaccinated was "one hundred percent a personal choice," insisting that "anyone that says otherwise is taking away people's freedoms.'

The oddity, here, is that laws requiring us to wear seat belts really are quite straightforwardly infringing on freedom, whereas laws requiring people to be vaccinated if they are going to be in places where they could infect other people are restricting one kind of freedom in order to protect the freedom of others to go about their business safely.

Don't misunderstand me. I strongly support laws requiring drivers and passengers in cars to wear seat belts. In the US, such laws are estimated to have saved approximately 370,000 lives, and to have prevented many more serious injuries. Nevertheless, these laws are paternalistic. They coerce us to do something for our own good. They violate John Stuart Mill's famous principle: "the only purpose for which power can be rightfully exercised over any member of a civilized community, against his will, is to prevent harm to others." The fact that the coercion is for the individual's own good is "not a sufficient warrant.'

There is a lot to be said for this principle, especially when it is used to oppose laws against victimless acts like homosexual relations between consenting adults or voluntary euthanasia. But Mill had more confidence in the abil-

ity of members of "civilized" communities to make rational choices about their own interest than we can justifiably have today.

Before seat belts were made compulsory, governments ran campaigns to educate people about the risks of not wearing them. These campaigns had some effect, but the number of people who wore seat belts came nowhere near the 90 per cent or more who wear them in the US today (with similar or higher figures in many other countries where not wearing them is an offense).

The reason is that we are not good at protecting ourselves against very small risks of disaster. Each time we get into a car, the chance that we will be involved in an accident serious enough to cause injury, if we are not wearing a seat belt, is very small. Nevertheless, given the negligible cost of wearing a belt, a reasonable calculation of one's own interests shows

that it is irrational not to wear one. Car crash survivors who were injured because they were not wearing seat belts recognise and regret their irrationality - but only when it is too late, as it always is for those who were killed while sitting on their belts.

We are now seeing a very similar situation with vaccination. Brytney Cobia recently posted on Facebook the following account of her experiences working as a doctor in Birmingham, Alabama:

"I'm admitting young healthy people to the hospital with very serious COVID infections. One of the last things they do before they're intubated is beg me for the vaccine. I hold their hand and tell them that I'm sorry, but it's too late. A few days later when I call time of death, I hug their family members and I tell them the best way to honour their loved one is to go get vaccinated and encourage everyone they know to do the same. They cry. And they tell me they didn't know. They thought it was a hoax. They thought it was political. They thought because thev had a certain blood type or a certain skin colour they wouldn't get as sick. They thought it was 'just the flu.' But they were wrong. And they wish they could go back. But they can't."

The same reason justifies making vaccination against COVID-19 compulsory: otherwise, too many people make decisions that they later regret. One would have to be monstrously callous to say "It's their own fault, let them die."

In any case, in the COVID era making vaccination compulsory doesn't violate Mill's "harm to others" principle. Unvaccinated Olympic athletes impose risks on others, just as speeding down a busy street does. The only "personal choice" Ellison should have had was to get vaccinated or stay at home. If the International Olympic Committee had said that only vaccinated athletes can compete, that would have freed thousands of athletes from a heightened risk of infection, and would have justified overriding Ellison's desire to compete without being vacci-

For the same reason, rules announced last month in France and Greece requiring that people going to cinemas, bars, or travelling on a train show proof of vac cination are not a violation of anyone's freedom. This past February, when the Indonesian government became the first to make vaccination mandatory for all adults, the real tragedy was not that it was violating the freedom of its citizens, but that richer countries did not donate the vaccines it needed to implement the law. As a result, Indonesia is now the epicenter of the virus and tens of thousands of unvaccinated Indonesians have died.

## Digital financial inclusion in Covid times

ital financial services. Lowincome households and small firms can benefit greatly from advances in mobile money fintech services. and online banking. Financial inclusion as a result of digital financial services can also boost economic growth. While the pandemic is set to increase the use of these services, it has also posed challenges for the growth of the industry's smaller players and highlighted unequal access to digital infrastructure. Several actions will need to be taken to ensure maximum inclusion going forward.

The shift towards digital financial services was already helping societies advance financial inclusion before the pandemic started, benefiting many low-income households and small firms with typically little access to traditional financial institutions. Lockdowns and social distancing norms are accelerating the use of digital financial services, just as the SARS epidemic in 2003 hastened China's launching of digital payments and e-commerce.

Many countries (for example, Liberia, Ghana, Kenya, Kuwait, Myanmar, Paraguay and Portugal) are supporting this shift with meas-

In a new study at the International Monetary Fund (IMF), the authors introduced an index of digital financial inclusion that measures the progress in 52 emerging markets and developing economies. The authors found that digitisation increased financial inclusion between 2014 and 2017, even where financial inclusion through traditional banking services was declining. This is likely to have progressed more since then.

Africa and Asia lead in digital financial inclusion, but with significant variations across countries. In Africa, Ghana, Kenya, and Uganda are frontrunners. In comparison, the Middle East and Latin America tend to use digital financial services more moderately. In some countries, such as Chile and Panama, this reflects a relatively higher level of bank penetration.

In most countries digital payments services are evolving into digital lending, as companies accumulate users' data and develop new ways to use the data for credit worthiness analysis. Marketplace lending, which uses digital plat-

2015 to 2017. While so far concentrated in China, the United Kingdom, and the United States, it appears to be growing in other parts of the world, such as in Kenya and India. With guidelines issued by the Reserve Bank of India (RBI). peer-to-peer (P2P) lending has become a popular vehicle of lending in India.

The RBI has constructed a composite Digital Payments Index (DPI) to capture the extent of digitisation of payments across the country. The RBI-DPI has been constructed with March 2018 as the base period -- DPI score for March 2018 is set at 100.

The RBI-DPI consists of five broad parameters that enable measurement of deepening and penetration of digital payments in the country over different time periods. These parameters are -(i) Payment Enablers (weight 25 per cent), (ii) Payment Infrastructure - Demandside factors (10 per cent), (iii) Payment Infrastructure - Supplyside factors (15 per cent), (iv) Payment Performance (45 per cent) and (v) Consumer Centricity (5 per cent). Each of these parameters has sub-parameters which, in turn, consist of various measurable in-

growth of the DPI in India during the pandemic. DPI for March 2019 and March 2020 work out to 153.47 and 207.84 respectively, indicating appreciable growth. The DPI went up to 217.74 in September 2020 and further to 270.59 in March 2021. This indicates deepening of digital payments in the country during the recent months.

The RBI-DPI shall be published on RBI's website on a semi-annual basis from March 2021 onwards

with a lag of four months. In a significant development on digital financial inclusion front, Prime Minister Narendra Modi launched e-RUPI, a digital direct benefit transfer (DBT) platform August 2, 2021. e-RUPI is a digital voucher which can be transferred directly to mobile phone as an SMS or by QR code to the beneficiary e-RUPI users can redeem the vouchers at the merchant outlets. These youchers are like e-gift cards. which are prepaid in nature. These e-vouchers will be person and purpose-specific. Even if one does not have a bank account or a digital payments app or a smartphone can benefit from these vouchers.

Sambalpur, August 4: The state government had planned to set up a pressure swing absorption oxy gen plant on the premises of the district headquarters hospital in Sambalpur district. Machines and other tools for the plant arrived here in a container Wednesday.

The works department has already put in place the infrastructure for the plant. Installation of machines will be started from Thursday The administration is trying to make it operational within a week. It was learnt that the plant was built with the help of IOCL.

The 200-bed DHH doubles up as

a Covid hospital. The plant is capable of providing oxygen to patients. As the third wave of the pandemic is predicted in September, the plant is expected to meet the oxygen shortage.

When Covid hospital was in operation, 300 to 400 cylinders of oxygen were required for the patients.

This plant will produce 960 litres of oxygen per minute and can provide 15 litres of oxygen each to 65 ventilators. It has facility to provide 5 litres of oxygen per minute to 192 oxygen points directly through pipes.

After this plant is made operational, the DHH will not have to depend on oxygen provided by Jharsuguda plants.

The farmers can grow vegetables as inter-crops for at least two years.

New Delhi, August 4: The National Investigation Agency (NIA) Wednesday said that it is carry ing out searches at five locations in Jammu and Kashmir and Karnataka in Kerala ISIS module case, officials said.

An NIA official related to probe told IANS, "Multiple NIA teams are carrying out searches since morning at three locations in Jammu and Kashmir and one location in Bangalore and Mangalore.

The case pertains to the terrorist activities of a group led by one Mohammed Ameen of Kerala.

The anti-terror probe agency had earlier arrested three people namely Ameen and his associates Mushab Anuvar and Rahees Rashid

The group has been running various ISIS propaganda channels on different social media platforms such as Telegram, Hoop and Instagram for propagating the violent Jihadi ideology of ISIS, and radicalising and recruiting new members to the module.

The NIA had registered a case against seven known and other unnamed persons under relevant sections of the Indian Penal Code and the Unlawful Activities (Prevention) Act March 5, 2021.

The NIA official said the group of radicalised individuals, under the leadership of Ameen and having pledged allegiance to the proscribed terrorist organisation ISIS. had identified certain people in Kerala and Karnataka for

Shimla, August 4: While cloudbursts and flash floods in recent years have become a regular feature in the hill state of Himachal Pradesh, the loss of life caused by natural calamities can be mainly attributed to increasing human interference, particularly in ecosensitive Himalayan zones.

Experts told IANS Wednesday that since mountains in Himachal Pradesh are part of Himalayan range that are young and fragile in nature, creating cracks and fractures in the rock could widen in future and create a rockfall or slope failure zone -- a phenomenon in which a slope collapses abruptly under the influence of rainfall or an earthquake.

They say anthropological intervention along with climate change have worsened it further. Be it development of hydropower projects or tunnels or roads.

Seven people died in the exceptionally high rainfall across the cold desert of Lahaul-Spiti district July 27-28. Keylong and Udaipur subdivision of the district faced 12 incidents of flash flood after a cloudburst in which the Tozing Nallah impact was devastating, says a government report.

Two days before this disaster,

nine people were killed by a landslide in Kinnaur district as boulders fell and hit the vehicle they were travelling in. Both Lahaul-Spiti and Kinnaur fall in the Himalayan ranges, known for geological and ecological vulnerability.

This monsoon the heavy rains also caused major landslides in the state's Kangra district, claiming 10 lives. Terrifying videos capturing massive landslides in Sirmaur district are common these days

Explaining why flooding and landslides are common in the hill states, YP Sundriyal of the Department of Geology with Hemwati Nandan Bahuguna Garhwal University in Uttarakhand said, "Higher Himalayas, both climatically and tectonically, are highly sensitive, so much so, that at first stance the construction of mega hydro-projects should be avoided. Or else they should be of small capacity. Secondly, the construction of roads should be done with all scientific techniques. At present, we just see roads are being made or widened without taking proper measures such as no slope stability, lack of good quality retaining wall and rock bolting. All these measures can restrict the damage done by landslides up to

impact of the projects on the frag-

ile ecology and livelihoods is done. Saying urbanisation has led to decrease in soil infiltration capacity, resulting in floods, Central Water Commission Director (Flood Forecasting and Monitoring) Sharath Chandra said. "Himalayan systems are very young and fragile, making them unstable. The rain which was earlier recorded during the span of days now outpours within a handful of days only. This has led to an increase in incidence of flash flooding and landslides, making the region very vulnerable to natural disasters. If the landslide comes down to the river stream, it increases the



and climate change. According to geologists, the retreating glaciers have left behind unlimited sediments that consist of an unstable mix of earth and rocks in the higher reaches of Himalayas. Shimla, August 4: A total of 218 people have died and 12 are missing in Himachal Pradesh in the last three weeks this monsoon season, Jal Shakti Minister Mahender Singh Thakur informed the state Assembly Wednesday.

Replying to a discussion on climate change on the third day of the ongoing monsoon session. Thakur said the state suffered a total loss of Rs 451.56 crore due to damaged roads, water lines and power transmission since June 13.

A maximum of 34 people died in Shimla, followed by 25 in Kangra, 23 in Sirmaur, 21 in Chamba, 19 in Mandi, 18 in Lahaul-Spiti, 17 in Kullu, 16 in Solan, 14 each in Una and Kinnaur, 12 in Bilaspur and five in Hamirpur from June 13 to July 3, he added.

Several roads, bridges, PWD property, water lines had been fully or partially damaged due to heavy rains, he said.

The state government has so far suffered a loss of Rs 451.56 crore, the minister said.



Kochi, August 4: The Kerala High Court Wednesday extended by a week the interim protection from arrest given to three former Kerala Police officers and a retired IB of-

ficial in the ISRO conspiracy case. Justice Ashok Menon extended the relief for a week after the counsel for CBI told the court that an Additional Solicitor General would be appearing in the matter. The court then listed the matter for

hearing August 5. The high court had on separate dates granted interim protection from arrest to former Kerala Police officers -- R B Sreekumar, S Vijayan and Thampi S Durga Dutt -- and ex- Intelligence Bureau (IB) officer PS Jayaprakash who all have moved pleas for anticipatory bail in the case registered by CBI.

Besides these four, 14 others, are named as accused in the case registered by the agency for various offences, including criminal conspiracy, kidnapping and fabrication of evidence, under the Indian Penal Code, in connection with the arrest and detention of former ISRO scientist Nambi Narayanan in the 1994 espionage case.

Besides Narayanan, two Maldivian women -- Mariyam Rasheeda and Fouzivva Hassan -- were also arrested and detained in the 1994 case.

The two women were jailed for more than three years before they were released.

Advocate Prasad Gandhi, appearing for the two women, contended that the accused should

# 'Too early to declare 3rd wave'

New Delhi, August 4: The rise in fresh Covid cases and the effective reproduction number – indication of how fast an infection spreads -- in many states is worrying but don't panic. Instead, mask up and get vaccinated, say experts, stressing that it is too early to declare the beginning of a new wave.

In fact, it could be that the second wave is not over, said several scientists who have been closely monitoring India's Covid graph and have noted the surge in a few pockets. In the northeast, for instance, cases have certainly not gone down to the low levels that are being seen in Delhi and other northern states, observed Gautam Menon, professor, Departments of Physics and Biology at Ashoka University in Haryana. "In that sense, we are likely seeing a continuation of the second wave rather than the initiation of a new Covid wave distinct from the previous one," he explained

On Wednesday, India recorded 42,625 fresh Covid cases with a daily positivity rate of 2.31 per cent and a weekly one of

2.36 per cent. India's Covid situation is seemingly under control. However, 13 states/union territories recorded a surge in coronavirus infections last week with Kerala reporting half of India's daily new cases. With the government warning that the pandemic is "still raging", there is also an increase in India's effective reproduction number (R) which represents the number of sus-

ceptible people one Covid positive

person may infect. A recent analysis by researchers at the Institute of Mathematical Sciences, Chennai, found that the effective R number in India has crossed 1 for the first time since May 7. The government Tuesday also said the R-value is more than one in eight states and UTs, which is a cause of concern. Meanwhile, the Delhi government Wednesday put a cap on the rate of conventional RT-PCR tests for Covid-19 detection in private hospitals and laboratories at Rs 500, according to an order. Rapid antigen tests at private facilities will cost Rs 300. In a tweet, Chief Minister Arvind Kejriwal said, "Delhi government drastically re-

## CBI takes over probe

New Delhi, August 4: The CBI Wednesday took over the investigation into the death of Dhanbad judge Uttam Anand who was mowed down by a vehicle while on a morning jog July 28, officials said.

A 20-member team has been set by the CBI to probe the matter. It has left for Dhanbad, they said, adding that it will be followed by a Central Forensic Science Laboratory team. Officials said the agency has re-

ceived the Jharkhand government's request, routed through the Centre, to investigate the matter. Sources said according to the

laid down procedure, the agency has taken over Dhanbad police FIR in the matter. Jharkhand Chief Minister

Hemant Soren on last Saturday had decided to hand over the probe into the hit-and-run case of the 49year-old Dhanbad judge to the Central Bureau of Investigation. CCTV footage showed that the

judge was jogging on one side of a fairly wide road at Randhir Verma Chowk when a heavy auto-rickshaw veered towards him, hit him from behind and fled. Doctors at hospital declared him brought dead.

The central probe agency had informed the Jharkhand High Court on Tuesday that it has received the state government's letter to take over the probe a day earlier.



Ravi Ranjan and Justice Sujit Naravan Prasad had directed the CBI to initiate a probe at the earliest. It had also directed the government to hand over all the documents of the case to the CBI.

Taking cognizance of a letter filed before the court by the Dhanbad principal district judge in the case, Justice Ranjan had converted it into a writ petition and ordered the formation of an SIT headed by Additional Director General of Police Sanjay Latkar to look into the matter.

The bench, dissatisfied with the progress report, had questioned why there was a delay in registering an FIR into the case.

The incident occurred at 5.08 am, and the FIR was registered at 12.45 pm when it was clear from CCTV footage that the judge was picked up from the spot and taken

### Bengal flood: 23 dead, PM dials Mamata

Kolkata, August 4: The flood situation in West Bengal worsened Wednesday claiming 8 more lives taking the death toll to 23 as fresh areas went under water, with Chief Minister Mamata Banneriee complaining to Prime Minister Narendra Modi that the Damodar Valley Corporation (DVC) caused the "man-made" deluge by releasing water from its dams in an unprecedented manner.

The DVC, however, said that it discharges water after taking consent of the state government and blaming it for the flood is not justified The Prime Minister tele-

phoned Banerjee in the afternoon to take stock of the flood situation which affected seven districts of the state. During the talks, the CM blamed the DVC for the flood in the state and raised the issue in a letter she wrote to Modi in the evening.

Heavy rain and subsequent discharge of water in the last few days have inundated large parts of Purba and Paschim Bardhaman, Paschim Medinipur, Hooghly, Howrah, South 24 Parganas and Birbhum districts.

The death toll was 15 till Tuesday evening and the number of affected districts was six. A tweet issued by the Prime Minister's Office

(PMO) said that Modi assured Banerjee of all support from the Centre to help mitigate the situation. "PM @narendramodi spoke to WB CM @MamataOfficial on the flood situation caused by water discharge from dams in parts of the state. PM assured all possible support from the Centre to help mitigate the situation. PM Modi prays for the safety and wellbeing of those in affected areas," the PMO tweeted.

Large swathes of Nanoor and Labhpur block in Birbhum districts were flooded since early Wednesday morning, leading to the displacement of more than 3000 people.





#### **Global Covid toll** surpasses 200M

Washington: Coronavirus cases worldwide surpassed 200 million Wednesday, according to a Reuters tally, as the more-infectious Delta variant threatens areas with low vaccination rates and strains healthcare systems. Cases are rising in about one-third of the world's countries, many of which have not even given half their population a first dose. It took over a year for Covid-19 cases to hit 100 million mark, while the next 100 million were reported in just over six months, according to the analysis. The pandemic has left close to 4.4 million people dead.

#### **Indian students** in UK's new plan

London: As many as 40,000 students from the UK will be able to study and work abroad under the British government's new Turing Scheme, with India among 150 international destinations for such placements. The new global scheme, a direct result of Brexit as it replaces the European Union (EU) specific Frasmus scheme, awards universities and schools grants from the 110-million pounds Turing Scheme to fund placements abroad for UK students.

### Three killed in Czech train crash

Prague: Three people died and dozens more were injured Wednesday when two trains collided at a village in the west of the Czech Republic, according to railway officials. "Unfortunately, according to the latest information, a train collision... has killed three and left dozens of people injured," national rail operator Sprava zeleznic said on Twitter. National police said all passengers were accounted for, adding that the accident happened shortly after 8:00 am at Milavce.

#### Khan names next premier of PoK

Islamabad: Pakistan Prime Minister Imran Khan Wednesday nominated his party's lawmaker Abdul Oavvum Niazi as the next premier of Pakistan-occupied . Kashmir after extensive consultations. Niazi won the recent legislative assembly election from Abbaspur-Poonch area. Khan's Pakistan Tehreek-i-Insaf (PTI) party has secured 32 seats in the 53-member House. It is for the first time that the PTI will form a government in PoK. The ruling party's candidates Anwarul Haq and Riaz Gujjar have been elected as Speaker and Deputy Speaker, respectively.

## Mediterranean a 'wildfire hotspot'

In Turkey, a key metric of fire intensity - the "fire radiative power", which measures energy produced from burning

trees and other matter - reached the highest daily values since data records began in 2003

Brussels, August 4: The Mediterranean has become a wildfire hotspot, with Turkey hit by its most intense blazes on record and a heat wave producing a high risk of further fires and smoke pollution around the region, a European Union atmosphere monitor said Wednesday.

Wildfires are raging in countries including Greece and Turkey, where thousands of people have been evacuated from their homes and Tuesday a fire threatened to reach a coal-fired power plant.

The fires have struck as Southern Europe experiences an intense heat wave, with some places in



Greece Tuesday recording temperatures of over 46 Celsius (115 Fahrenheit).

Human-induced climate change is making heat waves more likely and more severe, scientists say. The EU's Copernicus Atmosphere Monitoring Service (CAMS) said the hot and dry conditions had hiked the danger of further fires, although high temperatures alone do not trigger wildfires because they need a source of ignition.

CAMS monitors wildfires through satellites and groundbased observation statements, and said the emissions and intensity of wildfires are rapidly increasing in Turkey and Southern Italy.

Plumes of smoke from fires in southern Turkey were clearly visible in satellite images of the region, and the severe scale of the fires had caused high levels of particulate matter pollution over the Eastern Mediterranean area, CAMS said.

### CDC announces new eviction moratorium

Washington, August 4: Under pressure from progressive Democrats, US health authorities Tuesday declared a new moratorium on tenant evictions until October in much of the country, citing public health risks posed by the Covid-19 pandemic.

"The emergence of the Delta variant has led to a rapid acceleration of community transmission in the United States, putting more Americans at increased risk, especially if they are unvaccinated," Rochelle Walensky, director of the Centers for Disease Control and Prevention, said in a statement.

The moratorium applies to "counties experiencing substantial and high levels of community transmission" of Covid-19, according to a CDC statement, and is set to expire October 3.

"This moratorium is the right thing to do to keep people in their homes and out of ... settings where Covid-19 spreads," Walensky said.

Although likely to be challenged in court, the measure will allow ten-

ants extra time to access funds previously issued by Congress to help people pay rent, President Joe Biden said from the White House.

For bureaucratic reasons, these payments were incredibly slow in reaching the US population -- only \$3 billion has thus far been distributed to households out of \$25 billion allotted to states and localities in early February.

Another \$21.5 billion is available in a second round of funding, but it will not go out until the first tranche is spent.

A previous moratorium put in place in September 2020 by the CDC expired after a Supreme Court ruling in June stipulated that it could not continue beyond July 31 without authorization from

### HIJACKERS LEFT SHIP OFF **UAE COAST: UK AGENCY**



Fujairah, August 4: The hijackers who captured a vessel off the coast of the United Arab Emirates in the Gulf of Oman departed the targeted ship Wednesday, the British navy reported, as recorded radio traffic appeared to reveal a crew member onboard saying Iranian gunmen had stormed the asphalt tanker.

The incident — described by the British military's United Kingdom Maritime Trade Operations the night before as a "potential hi-- revived fears of an escalation in Mideast waters and ended with as much mystery as it began.

Hints of what unfolded on the Panama-flagged asphalt tanker, called Asphalt Princess, began to emerge with the maritime radio recording, obtained by commodities pricing firm Argus Media and shared with The Associated Press.

In the audio a crew member can be heard telling the Emirati coast guard that five or six armed Iranians had boarded the tanker.



Washington, August 4: Law enforcement agencies have arrested an Indian national in New Jersey on charges of fraudulently obtaining at least USD2.3 million from elderly victims by impersonating fraud prevention representatives from the US.

Charged with conspiracy to commit wire fraud, Ashish Bajaj, 28, appeared Tuesday afternoon in federal court in the Middle District of North Carolina. He faces a maximum penalty of 20 years in prison and a USD250,000 fine, or twice the gross gain or loss from the offense.

According to court documents, Bajaj from April 2020 to July 2021, Bajaj along with his co-conspirators received at least USD2.3 million in fraudulently obtained funds by impersonating fraud prevention representatives from banks located in the US.

## Mired in crises, Lebanon marks year since horrific blast

Beirut, August 4: Lebanon Wednesday marks a year since a cataclysmic explosion ravaged Beirut, with a mix of grief over lost lives and rage at the impunity for its worst peacetime disaster at a time when its economy was already

Shortly after 6:00 pm August 4, 2020, a stock of ammonium nitrate fertiliser haphazardly stored at the city's port exploded and left swathes of the Lebanese capital looking like a war zone.

Families of the dead and survivors have planned vigils, prayers, ceremonies and marches to honour those who perished in a blast

whose shockwave was felt as far away as Cyprus.

Port workers were buried under gutted grain silos, firefighters battling the fire that preceded the blast were pulverised, commuters crushed to death and residents lacerated by supersonic shards of glass bled out in their

Many will stay home on what was declared a national day of mourning, but last year's shock soon gave way to an anger that has only grown with every day the crime stays unpunished.

In a press conference Monday, relatives of blast victims called on authorities to lift immunity within three days, warning that they are



willing to "break bones" in upcoming protests.



## Service sector shrinks for third straight month 'India needs 3 private

New Delhi, August 4: India's services sector remained in contraction territory for the third straight month in July, as business activity, new orders and employment declined further largely due to the Covid-19 pandemic and local restrictions, a monthly survey said Wednesday.

The seasonally adjusted India Services Business Activity Index rose from 41.2 in June to 45.4 in July, but was stuck in the red due to subdued demand conditions amid the Covid-19 crisis. In Purchasing Managers' Index (PMI) parlance, a print above 50 means expansion, while a score below 50 denotes contraction.

"The current Covid-19 environment continued to weigh on the performance of the service sector that is so crucial to the Indian economy. July data was somewhat disappointing, with incoming new business and output falling solidly over the month, but there was at least a slowdown in rates of contraction," Pollyanna De Lima, Economics Associate Director at IHS Markit, said.



# players in telecom, hope govt offers support'

New Delhi, August 4: Bharti Airtel CEO Gopal Vittal Wednesday asserted that a large nation like India needs three private players in the telecom sector, and hoped the government would take measures to offer relief to the industry that is facing "serious financial stress". The comments assume significance in the backdrop of Vodafone Idea's desperate struggle to stay afloat.

Aditva Birla Group Chairman Kumar Mangalam Birla had in June this year offered to hand over the group's stake in debt-laden Vodafone Idea Ltd (VIL) to the government or any other entity to ensure that the company remains a going concern.

Speaking at the Q1 earnings' call, Airtel CEO Gopal Vittal said, "I think just from national perspective, it would be appropriate to see an industry structure where three players not just survive, but thrive and of course the government player is always there.

"I feel as a country we do need three players...It is a large enough country with 1.3 billion people, which can easily accommodate three (private) players in this market," Vittal said.

The top boss of Airtel was responding to an analyst query on how the company perceives industry structure to be in the next 1-2 years, and whether the Sunil Mittal-led telco is prepared for a twoplayer market, if the situation arose. "There is clearly a situation of serious financial stress in the industry and we have seen one of the players actually saying to the government that they may not be able to pay their dues coming up in March 2022. We hope that

the government does something to provide some relief to the industry," Vittal said.

Flagging the "extremely low" ARPU (Average Revenue Per User) in the Indian telecom market, Vittal said that the level needs to rise to ₹200 and eventually ₹300.

"As we have always said, ARPU in India is extremely low and at this level, our return on capital is in the low single digit. ARPU must rise first to (Rs) 200 and eventually to (Rs) 300," Vittal said. If ARPU rises, then industry repair can "certainly happen", he noted.

Having three private players in the telecom market would be an "appropriate outcome" for a country as large as India, he said, adding that substantial investments have already been infused by the industry

The Indians fought valiantly and gave Argentina a run for their money by taking the lead in the second minute through a penalty corner conversion by Gurjit Kaur. But the Las Leonas bounced back strongly with skipper Maria Barrionuevo's (18th, 36th minutes) twin strikes from penalty corners to secure the hard-fought win.

The bunch of 18 fearless and de termined Indian women had already done the unthinkable when they stunned three-time champions Australia 1-0 Monday to enter the Olympic semifinals for the first

Coming into the match, the odds were totally against India but the side led by talismanic Rani Rampal and coached by master tactician Sjoerd Marijne exceeded expecta-

India's best performance in the Olympics came way back in the 1980 Moscow Games where they finished fourth out of six teams. In that edition of the Games, women's hockey made its debut in the Olympics and the sport was played in a round-robin format with top two teams qualifying for the final.

Even though Argentina dominated in terms of possession, it was India who got the all-important lead. Despite penetrating their opponent's circle on numerous oc-



casions, Argentina failed to create a clear cut chance in the first quarter as the Indians defended

It was India who grabbed with both hands, the first opportunity that came their way. India secured a penalty corner with their first circle penetration and it was perfectly converted by Gurjit with a powerful drag-flick to hand her side an unexpected lead.

Thereafter it was all Argentina, which exerted tremendous pressure on the Indian defence with relentless attacks. Most of Argentina's attacks came from the left flank and they kept up the pressure on the Indian defence in the second quarter.

Minutes into the second quarter, Argentina secured two penalty corners in quick time, the second of which was converted by skipper Barrionuevo to level the scores.

India got two more penalty corners in the second quarter but wasted both. Three minutes from half time, Argentina earned their fourth penalty corner of the match, again from an attack from the left flank, but this time the Indian defence was up to the task.

Argentina continued in the same vein after the change of ends and attacked the Indian goal, securing two more penalty corners soon and once again Barrionuevo was

bang on target

Barrionuevo's flick crashed into the board after getting a deflection of Sushila Chanu's legs as Argentina took a 2-1 lead. The difference between the two sides was the battle in the mid-field which the Argentines won hands down.

The Indians were also guilty of sitting back and defending and not forcing the pace after taking the

Trailing by a goal, the Indians showed intent in the fourth quarter and put the Argentine defence under pressure in search of the equaliser. This is something which they needed to do after taking the

India put continuous pressure in the last 15 minutes and secured their fourth and final penalty corner in the 51st minute but experienced Argentina goalkeeper Maria Succi made a brilliant save to deny

Seventeen seconds from the final hooter, Succi came to her side's rescue again when she brilliantly kept out Navneet Kaur's deflection from Udita's hit from outside

The Indians immediately asked for a referral for dangerous ball but the TV umpire rejected it, breaking the hearts of the courageous lot, who can hold their heads

### A throw for Neeraj to make into finals

TOKYO: Medal contender Neeraj Chopra became the first Indian iavelin thrower to enter the finals of the Olympic Games with a stunning throw of 86.65m in his opening attempt that put him on top of the qualification round here Wednesday.

The 23-year-old kept India's hopes of an elusive Olympic medal from athletics alive by earning a direct entry into the finals to be held on Saturday as he sent the spear well past the qualifying mark of 83.50m in his first attempt

However, Shivpal Singh, failed to make the final cut with a belowpar best throw of 76.40m, which he came up in his first attempt, to finish a lowly 12th

in the Group B qualification which featured 16 athletes

Competing in his first Olympics, Chopra took just a few seconds to make the final round. He topped the Group A contest as well as the two qualifications rounds.

Chopra is, however, under no illusion that the final will be a totally different contest where the world's best will go for podium finish. "It will be a different feeling

(in the finals), since it is my first time in the Olympics. Physically we (all) train hard, and are ready, but I also need to prepare mentally. I will need to focus on the throw, and try to repeat this (performance) with a higher score," said the youngster who came into the Olympics with the fourth best throw (88.07m) this

Chopra's performance Saturday will go down as one of the best performances by an Indian in the Olympics, as he finished ahead of gold medal favourite and 2017 world champion Johannes Vetter of

Vetter, who had earlier said that Chopra will find it tough to beat him in the Olympics, struggled in his first two throws before crossing the automatic qualification mark with a 85.64m final throw.

The 28-year-old towering German, who came into the Olympics after having seven monster throws of over 90m between April and June, was lying at a dangerous seventh position after his first two throws but eventually qualified for the final at second overall behind

> Pakistan's Arshad Nadeem, who had won a bronze medal when Chopra clinched gold in the 2018 Asian Games in Indonesia, topped Group B to earn an automatic qualification to the finals with a second round throw 85.16m. He qualified for the finals at overall third behind Chopra

### Lovlina settles for bronze

**TOKYO:** Indian boxer Lovlina Borgohain (69kg) signed off with a bronze medal in her debut Olympic Games after a comprehensive 0-5 loss to reigning world champion Busenaz Surmeneli here Wednesday, bringing an end to the country's campaign in the sport here.

Up against quite literally a bully in the ring, Borgohain was completely out-punched by the gold medal favourite Turkish boxer, who produced a thoroughly dominating performance. Borgohain, who hails from

Assam, also coped a one point deduction in the second round for not paying attention to the referee's instructions despite a couple of cautions. "I don't know what to say. I could not execute what I had planned. I could have done better." Borgohain told PTI after the

Hers is also the first Olympic medal in Indian boxing in nine years.

## Solid start by golfer Aditi

TOKYO: Indian golfer Aditi Ashok got off to a brilliant start at the Olympic Games, carding a fourunder 67 in the opening round for a share of the second spot at the Kasumigaseki Country Club here Wednesday.

Aditi, who caught the golfing world's attention five years ago at the Rio Olympics, shared the position with World No.1 Nelly Korda. She was one shot behind the leader, Madalene Sagstrom of Sweden, who shot 66.

Aditi may well have had a share of the lead but for a bogey on the 18th hole. While Sagstrom shot a bogey free five-under 66, Aditi had five birdies against one bogey and that on the closing hole.

She was placed well ahead of some big names in women's golf, including the formidable defending champion, Inbee Park (69).

India's other entrant in the field, Diksha Dagar (76) had a rough start in her maiden Olympics as she had five bogeys and no birdies to lie at the tied 56th spot.

The 60-player field will play 18 holes each day and there will be no cut, so all players get to play 72

Aditi birdied fifth and ninth from 15 feet and seven feet respectively. On the back nine, she



added birdies on the 13th from 15 feet and another from almost 18 feet on 17th.In between, she had another birdie on 14th from under three feet after a superb approach. Placed at 5-under she bogeyed the  $last\,after\,missing\,a\,par\,from\,under$ seven feet.

Among others, South Korea's World No.2 Ko Jin-young, Finland's Matilda Castren and Spaniard Carlota Ciganda were tied fourth after all three carded 3-under 68

The South Korean team also boasts of the reigning Olympic champion Park Inbee (69) and World No.4 Kim Sei-voung (69) who are Tied-7th and sixth-ranked Kim Hyo-joo (70) who is T-16th. New Zealand's former World No.1 Lydia Ko (70) was four behind the leader.

### PACERS' SHOW HELP INDIA TAKE CONTROL OF FIRST TEST

Nottingham, August 4: Indian pacers breathed fire in helpful conditions to dismiss a vulnerable England batting line-up for 183 and put their team in a strong position on day one of the first Test here Wednesday.

Jasprit Bumrah (4/46) was back in his element and ran through the opposition alongside his new ball partner Mohammad Shami (3/28). In fact, all the pacers including Mohammad Siraj (1/48) and Shardul Thakur (2/41) made the ball talk throughout the England innings lasting 65.4 overs, vindicating the team management's decision to go for a four-pronged pace

attack while leaving out premier spinner R Ashwin from the playing XI. Ravindra Jadeja was picked as the sole spinner.

In response, KL Rahul (9 batting) and Rohit Sharma (9 batting), took India to 21 for no loss at stumps, surviving 13 testing overs from England fast bowlers. Skipper Joe Root (64, 108b, 11x4)

was the only batsman who looked comfortable in the middle and Jonny Bairstow (29), to a certain extent, as the duo shared a 72-run stand.

England, who were 138/4 at tea, lost their last six wickets for 45 runs and if it was not for Sam Curran's unbeaten 27 towards the end, they would have struggled to cross 180. In the afternoon session, Root and

Bairstow frustrated the Indian bowlers with solid Test match batting in challenging conditions, before Shami broke their stand by dismissing the latter in the final ball before the tea. India had their tail up early on in the session when Shami had Dom Sibley (18) caught at short mid-wicket in the third over post lunch.

In the morning, the Indian fast bowlers were up to the task, reducing England to 61/2 at lunch. Bumrah dismissed Rory Burns in the very first over before Siraj got rid of dangerous-looking Zak Crawley.

With the sun beating down on Trent Bridge, Root opted to bat on a dry pitch with a decent covering of grass on top.
