Curtains down on Olympics 2020

Tokyo, August 8: It began with a virus and a yearlong pause. It ended with a typhoon blowing through and, still, a virus. In between: just about everything.

The Tokyo Olympic has been historic for India, as the country secured seven medals surpassing the six medals won in London Olympics 2012.

The Tokyo Olympics, christened with "2020" but held in mid-2021 after being interrupted for a year by the coronavirus, glided to their conclusion in a Covid-emptied stadium Sunday night as an often surreal mixed bag for Japan and for the world. A rollicking closing ceremony with the theme "Worlds We Share" - an optimistic but ironic notion at this human moment – featured everything from stunt bikes to intricate light shows as it tried to convey a "celebratory and liberating atmosphere" for athletes after a tense two weeks.

It was set to pivot to a live feed from Paris, host of the 2024 Summer Games. And with that, the strangest Olympic Games on record began closing their books for good.

Held in the middle of a resurging pandemic, rejected by many Japanese and plagued by months of administrative problems, these Games presented logistical and medical obstacles like no other, offered up serious conversations about mental health – and, when it came to sport, delivered both triumphs and a few surprising shortfalls.

From the outset, expectations were middling at best, apocalyptic at worst. Even Thomas Bach, president of the International Olympic Committee,

said he'd worried that these could "become the Olympic Games without a soul." But, he said Friday, "what we have seen here is totally different." At these Games, even the word "to-

gether" was fraught. Spectators were kept at bay. Athletes' perseverance became a central story. Mental health claimed bandwidth as never before, and athletes revealed their stories and struggles in vulnerable, sometimes excruciating fashion. Japan's fourth

Olympics, held 57 years after the 1964 Games reintroduced the country to the world after its World War II defeat, represented a planet trying to come together at a historical moment when disease and circumstance and politics had splintered it apart.

The closing ceremony Sunday reflected that -- and, at times, nudged the proceedings toward a sci-fi flavour. As athletes stood in the arena for the final pomp, digital scoreboards at either end of the stadium featured what organisers called a "fan video matrix," a Zoom call-like screen of videos uploaded by spectators showing them cheering at home. In front of such formidable backdrops, athletic excellence burst through, from the Games' first gold medal (China's Yang Qian in the 10-meter air rifle July 24) to their last (Serbia defeating Greece in men's water polo Sunday afternoon).

While Tokyo is handing off the Summer Games baton to Paris for 2024, the delay has effectively crammed two Olympics together. The next Winter Games convenes in just six months in another major Asian metropolis - Beijing, Japan's rival in East Asia and home to a much more authoritarian government that is expected to administer its Games in a more draconian and restrictive way virus or no virus.

Highest rights violations in police stations: CJI

New Delhi, August 8: Chief Justice NV Ramana Sunday said the threat to human rights and bodily integrity are the highest in police stations and even the privileged are not spared the third-degree treatment.

Justice Ramana was delivering the keynote address at an event organised by the National Legal Services Authority of India (NALSA) to launch the "vision and mission statement" and the mobile app for NALSA.

The Chief Justice said: "The threat to human rights and bodily integrity are the highest in police stations. Custodial torture and other police atrocities are problems which still prevail in our society. Going by the recent reports even the privileged are not spared thirddegree treatment".

He stressed that despite constitutional declarations and guarantees, lack of effective legal representation at the police stations is a huge detriment to arrested or detained persons. He em-

phasised that the decisions taken in these early hours will later determine the ability of the accused to defend him.

Woman Maoist surrenders

Phulbani, August 8: A woman Maoist from Kandhamal-Kalahandi-Boudh-Nayagarh (KKBN) division of the Odisha state committee laid down arms Sunday before the police in Kandhamal district. A senior police official informed that the woman cadre, identified as Kanti Mallick, is a resident of Gangaranga village under Baliguda block in Kandhamal district. She had joined the red rebels in 2018 and had been quite active till the time of her surrender.

"Kanti was a part of the KKBN division of Odisha Maoist state committee since 2018. Now, she has realised that the ideology she was pursuing is futile. She was inspired by various development activities being taken up by the Odisha government. So she decided to surrender. Kandhamal Superintendent of Police Vinit Agrawal told reporters.

"Chief Minister Naveen Patnaik has urged all the active Maoist cadres and militia to surrender and join the mainstream. The Chief Minister's appeal encouraged Kanti to shun violence and leave the organisation," Agrawal added.

New Delhi, August 8: Security has been beefed up at Delhi's Indira Gandhi International (IGI) Airport after a bomb threat email was received by the IGI police station, warning of a possible attack by the terrorist outfit Al Qaeda.

The email was received by the Delhi Police Saturday evening, which warned that a bomb could be used at the airport in the next one to three days. However, the threat was later found to be 'non-specific' and the Bomb Threat Assessment Committee (BTAC) has been terminated from the airport, after a search.

Sources said that the police received an email at around 5.50 pm Saturday, which mentioned "Planned bomb blast by Al Qaeda Sargana at IGI airport stating that Karanbir Suri alias Mohamad Jalal and Karanbir Suri's wife Shaily Sharda alias Haseena are coming to India Sunday from Singapore and plan to put the bomb on IGI in 1-3 days.

On examination of the threat mail, Security Operations Control Centre (SOCC) found that a similar threat message was received in the recent past



with the same names of the couple and on the similar language of the threat.

Immediately, police alerted the airport and the Airport Operations Control Centre (AOCC), with checks carried out on the airport premises. At around 7.18 pm, the BTAC declared the bombthreat as 'non-specific'. However, BTAC asked for heightened security to remain on the premises. CISF officials said that checks by their quick-reaction teams will continue on the premises, with numbers increased, owing to the bomb threat, as well as Independence Day. The Security Operations Control Centre (SOCC) of the airport, on inspection, found that a similar threat message had been received by the airport in March, mentioning similar names and that the same threat, of blowing up the airport within one to three days was mentioned in that mail too. Even in March, the threat was declared 'non-specific' by BTAC, officials said.

Delhi Police has been requested to look into the investigation report of earlier threat message involving the same couple and also check up the email source.

Taliban fighters seized key government buildings in the city of Kunduz, leaving government forces hanging onto control of the airport and their own base, a provincial Assembly lawmaker said Sunday.

The Taliban have also taken government buildings in the northern provincial capital of Sar-e Pul, driving officials out of the main city to a nearby military base, Mohammad Noor Rahmani, a provincial council member of Sar-e Pul province, said.

A Taliban offensive has gathered momentum in recent days, as the insurgents unleashed their forces across Afghanistan after the United States announced it would end its military mission in the country by the end of August.

On Friday, the insurgents captured their first provincial capital in years when they took control of Zaranj, on the border with Iran in Afghanistan's southern Nimroz province

In recent days the Taliban have escalated attacks on northern provinces, which lie outside their traditional strongholds in the south but where the group has been quickly taking ground, often along the border of Afghanistan.



New Delhi, August 8: A study by ICMR involving 98 people, 18 of whom had inadvertently received Covishield as first dose and Covaxin as the second in Uttar Pradesh, showed that combining these two Covaxin-19 vaccines elicited better immunogenicity than two doses of the same vaccine.

The study also found that immunisation with combination of Covishield and Covaxin was safe and the adverse effects were also found to be similar when compared to the same dose regimen. The study titled Serendipitous Covid-19 Vaccine-Mix in Uttar Pradesh, India: Safety and Immunogenicity Assessment of a Heterologous Regime'

has been uploaded on medRxiv, a preprint server and is yet to be peer reviewed.

"To the best of our knowledge, this is the first study which reports the effects of heterologous prime-boost vaccination with an adenovirus vectored vaccine followed by an inactivated whole virus vaccine," the researchers said.

The immunisation programme against Covid-19 in India started with two vaccines-adenovirus vector platform-based vaccine Covishield and inactivated whole virion BBV152 Covaxin-and homologous prime-boost approach was followed. However, 18 individuals, under the national programme, in Siddarth-

TATAS TO SELL KORAPUT COFFEE ALSO Tatas will purchase the coffee from the govt and market it without interfering with the quality and originality

Bhubaneswar, August 8: Tata Coffee plans to market Koraput coffee across the country to boost the presence of the local tribal product pan-India as well as abroad, the office of Chief Minister Naveen Patnaik said Sunday. According to the state government, Tatas would purchase the coffee from the government and market it without interfering with the quality and originality.

Tata Coffee's help in promoting the economic and social development of the coffee cultivators in the state is highly appreciated," Chief Minister Naveen Patnaik said Sunday.



State agencies like the Tribal **Development Cooperative Corporation** of Odisha Limited (TDCCOL), Integrated Tribal Development Agency (ITDA), Centre's Coffee Board and other agencies are now working with the Koraput coffee cultivators to extend a helping hand to them.

While TDCCOL has been playing a key role in procurement of coffee berries from the tribal cultivators in the district, several agencies are helping them in processing and packaging the product as well as training the coffee cultivators. The government has also started providing land on lease to the coffee growers free of cost, besides investing in their training and taking care of their input costs.

As of June 2021, 30,000 families have been granted 46,000 acres of forest land. In 2020-21, TDCCOL collected 28,790 kgs of coffee cherries from 193 tribal coffee cultivators in Laxmipur, Kashipur, Dasmantapur, Nandapur,

Lamtaput, Koraput and Pattangi blocks of the tribal-dominated Koraput district. The target is to grow coffee berries in more than 60 hectares in the next 21-22 years.

According to the agencies involved in coffee production in the district, several blocks of the district are apt for production of coffee due their hilly terrain and low temperature - prerequisites for growing coffee berries.

TDCCOL, meanwhile, has been helping in the marketing of the product online via e-commerce sites like Amazon, while offline Adisha shops situated in different parts of the state are also selling Koraput coffee, which has now become a global brand.

"We compared the safety and immunogenicity profile of them against that of those receiving either Covishield or Covaxin. Lower and similar adverse events following immunisation in all three groups underlined the safety of the combination vaccine-regime.

"Immunogenicity profile against Alpha, Beta and Delta variants in the heterologous group was superior and IgG antibody," the researchers stressed. "The findings suggest that immunisation with a combination of an adenovirus vector platform-based vaccine followed by an inactivated whole virus vac-elicited better immunogenicity," it said.











Bid to shift British-era steam engine stalled

Puri, August 8: Hundreds of youth Congress and Jagannath Sena activists Sunday stalled an attempt to shift a British-era steam engine from the BNR Hotel premises here.

The activists, opposing the shifting of the heritage engine, barged into the BNR Hotel premises when the authorities attempted to dismantle the parts of the engine in order to shift it to somewhere else. Youth Congress activists, led by

Ashutosh Mishra and Jagannath Sena convenor Priyadarshan Pattnaik, reached the hotel and forced the authority to stop the dismantling work. They opposed the shifting of the engine on the ground

that it is a heritage item and an integral part of the history of this place. They vowed not to allow the hotel authorities to shift this heritage item from Puri.

According to sources, the 20tonne steam engine was manufactured by Stewart & Co, England. The then Maharaja of Paralakhemundi had purchased it at a cost of Rs 12,000 in 1898 and in the year 1900 it began its run between Paralakhemundi and Nuapara. The route was later extended to Vijaynagar.

Since steam locomotives were phased out, they became out of service. In 1987, during the centenary celebrations of the South Eastern Railway (SER), it was

brought to Puri and installed in the BNR Hotel complex. The postal department had released a commemorative stamp with the picture of this engine to mark the centenary celebrations of SER. The BNR Hotel, established in

1900 near Puri beach, is also a heritage hotel. The display of this heritage engine at the hotel entrance has enthralled scores of visitors who were privileged to witness these pieces of history.

However, historian Anil Dhir said that the engine, mounted just a hundred metres from the beach, has been being buffeted by the sea wind for decades. "A beautiful artefact of a glorious era left behind is now a rust encrusted and decaving

Cyber crooks dupe City bizman, use his bank a/c to cheat many

Bhubaneswar. August 8: An interesting case has come to fore as some unknown cyber fraudsters have used the bank account of an elderly businessman of the capital city to dupe people from all over the country

The businessman too has personally lost more than Rs 1 lakh to cyber criminals few months back. The Crime Branch of state police has filed a case following an initial probe in this regard.

The complainant, identified as Raj Kumar Joshi, 62, resides at Rabi Talkies Square under Lingaraj police limits. In April, 2020, Joshi came across an advertisement of the Non-Banking Financial Company (NBFC) Bajaj Finance private limited, on popular social media platform Facebook, promising easy loans. Joshi needed money to invest in his business at the time. So he shared all his personal details including his phone number with the advertisers

Subsequently, the fraudsters, identifying themselves as officials of the NBFC, contacted Joshi over phone from various numbers. They



also sent fake ID cards in their names to the WhatsApp account of

Joshi. The cyber criminals asked the victim to share his bank account details, photo copies of the bank passbook, cancelled cheques, Aadhaar card, PAN card and other documents through WhatsApp which he did accordingly. He also deposited Rs 96,000 in the account of the fraudsters

to fetch the loan. Recently, Joshi was shocked to know that the account held at Baramunda branch of SBI had been transferred to the Karimnagar branch in Rampur of Telangana, June 6, 2020. He later found that

The death of a labourer at an illegal crusher unit at Baghua Square adjoining National Highway-53, Friday is a case in this point. Jenapur police arrested Pranaya Kumar Samal alias Tutu, the owner of Samal Crusher in this connection and produced him in court, Saturday. However, the arrest has failed to assuage miseries of scores of labourers working in similar hazardous conditions in other units. It is alleged that the workers work

in hazardous conditions risking their lives for a pittance without any safety gear or equipment. Stone quarrying and crushing units have a considerable impact on environment by polluting air, water and land and biological resources as well as socio-economic settings of the local population. The fine par-

well as the surrounding population, particularly by way of causing various respiratory diseases.

The workers are directly exposed to a large concentration of dust, noise and also prone to accidents. Due to the dust, the people working there as well as those in nearby areas suffer from various eye, skin diseases, apart from fever, silicosis, dyspnea and blood pressure. The crusher owners neither follow any rules and regulations for the safety of the workers nor for keeping the environment clean.

Locals had blamed the district administration for the death of the labourer. They claimed that the labourer died after the crusher unit which had been sealed earlier reopened and resumed work, Friday.

Reports said that a number of crusher units are operating along the National Highway-53 in between the Dak Bungalow square and Chadheidhara Square of the

highway. These crusher units are at Ranibandh, Bhadanga, Aruha, Pakhar, Barada, Baulamala and Baghua mouzas adjoining the highway. The district administration has carried out several raids on these crusher units and sealed a number of them but that has failed to make the crusher units a better work place adhering to safety norms. Earlier, the district administration had issued warning notices against the illegal crusher units under Darpan, Dharmasala and Danagadi tehsils, June 22, 2015. The Orissa High Court (WPC-9101/2009) and National Human Rights Commission (134-18/5/0708/OC)

Glory & Shame

THE MOTHER

s the Tokyo Olympics 2020 came to an end August 8, it has shown the summits of glory that sports can lift the participants to and also the low some of those watching the games or controlling them can stoop to. The latter was clearly visible in the manner Belarusian sprinter Krystsina Tsimanouskaya was humiliated by the Olympic committee of her country. The matter went far enough for the young runner to defect and seek asylum in Poland. For India, while both the women's and men's hockey teams and athletes did exceedingly well, the people at home, unfortunately, behaved in a very condemnable manner. During this subdued sporting event due to the COVID-19 pandemic there was ecstasy on the tracks rarely seen before. But, the world also witnessed blind hatred and divisive social prejudices, fostered by sectarian politics, playing out in India which also had its share of glory in the form of individual feats and state-sponsored patronisation of hockey by the Odisha government.

The most coveted prize is the gold medal which is a singular badge of honour proclaiming to the world that the winner is unparalleled and unrivalled. But, a rare moment may come when a sportsman or sportswoman with a golden heart can decline to be decorated thus so as not to break the heart of a fellow competitor who has all along fought so well and deserved it no less. The world was sent into raptures when such a moment did come at the Tokyo Olympics where Qatar's Mutaz Essa Barshim scripted history along with his friend-cum-rival Gianmarco Tamberi of Italy by sharing the gold medal in the men's high jump event. Both Barshim and Tamberi had perfect jumps till the 2.39m mark. But, the winner could not be decided even after three failed attempts. A 'Jump-off', which is a last decisive attempt, was offered to the duo by the Olympic official. Tamberi was then seen groaning in pain due to exhaustion and injuries. He might lose out to Barshim, still appearing to have a fresh pair of limbs, if the "Jump-off" facility was availed. But, Barshim had other ideas no one had ever before thought of. He and Tamberi had been friends for the past few years training and contesting together in several world events. Both had suffered injuries while giving out their best and had their highs and lows. There were moments when they felt like quitting and sank into depths of despair. But, they survived with grit, encouraging each other to surmount all the difficulties and displayed their indomitable spirit. Tamberi had also attended Barshim's wedding. With such a background of camaraderie and love transcending on-field rivalry, Barshim asked the Olympics official in that defining moment, "Can we have two golds?" The official nodded. For, section 26.8.4 of the sport's Technical Rules, did allow the gold to be shared. The rule says that a jumpoff should be conducted to determine the winner, but "if no jump-off is carried out, including where the relevant athletes at any stage decide not to jump further, the tie for first place shall remain.

Barshim and Tamberi hugged each other, whooped for joy and history was made. It was the first time since the 1912 Stockholm Olympics that a gold medal was shared!

When the scene shifted from Tokyo to Uttarakhand or Delhi, shameful events took place off-field. India saw a hockey renaissance of sorts at the Tokyo Games with the men taking third place, while the women were narrowly beaten by Great Britain in their bronze medal play-off. Indian men won their first medal in 41 years, though they had won a record eight Olympic gold medals earlier. When the women were advancing in the competition reaching the semifinal stage, there were justifiable accolades showered on the contingent from all parts of the country. But, their magnificent performance was tainted by abuse of the family of Vandana Katariya, a distinguished member of the team, belonging to the Dalit community. Once, they narrowly missed the bronze medal, youths taunted Vandana's family at their home in Uttarakhand saying the Dalits in the team were to blame for the defeat. The family reported threats were issued to them too.

India's women hockey captain Rani Rampal condemned it and said: "We put our life and soul into the game. We come from different religions – Hindu, Muslim, Sikh – and from all parts of India. But here we work for India." Nothing can be more eloquent to underscore India's unity in diversity.

When Indian hockey was on its way to regain its glory, Prime Minister Narendra Modi made the surprise announcement that the Rajiv Gandhi Khel Ratna Award has been renamed 'Major Dhyan Chand Khel Ratna Award'. He explained he got so many petitions for naming the highest sports award of the country after a sports personality. PM Modi's decision should be welcomed by all. Politicians must be delinked from all forms of sports, games and related facilities.

The PM should have taken the lead in this endeavour by erasing his name from the world's largest cricket stadium at Motera in Gujarat. Known earlier as Sardar Patel Stadium before the massive redevelopment, it was recently renamed Narendra Modi Cricket Stadium. In 2019, Firoz Shah Kotla Ground of Delhi had been renamed after former BJP Union minister late Arun Jaitley

Orange

Which named which? Did the fruit called an orange give rise to the name of the colour orange, or vice versa? This is an easy one to answer, since a quick look at the big Oxford English Dictionary gives the historical details. The fruit definitely came first - it is recorded in English in the fourteenth century, while the application of its name to the colour only appeared at the beginning of the seventeenth. This raises the question of what people called the colour before they had a word for it: either they didn't (few things in nature are that colour and there was no bright orange pigment available to artists and dyers until the early nineteenth century) or they borrowed terms like yellow, gold, amber, or red to describe various shades. By the way, the word orange is interesting, etymologically speaking, because it's an excellent example of a change called metanalysis in which the first letter of a word shifts to the end of the preceding word. So a numpire became an umpire, a napron became an apron, and so on. In Arabic, the fruit was named naranj (from Persian narang and Sanskrit naranga - the orange may have originated in northern India) and this name came with the fruit into Italian and also into Spanish, in which the fruit is still called naranja. The initial letter dropped off before the word reached English, possibly in Italian but more probably in French.

Even though I have a sense of the reality, I was astonished nevertheless at the way Indian theatre or cinema ignored Enron, a scandal which had its centre of gravity in Maharashtra, home to Bollywood. There was an uproar, with the Shiv Sena and the BJP taking the lead. The opposition to the deal was over high electricity tariffs beyond the reach of the poor. It collapsed. Enron, facing a host of other problems, declared bankruptcy. The CEO, Kenneth Lay, friend of George W Bush, died a broken man.

Lucy Prebble wrote a superb play, Enron, which ran to packed houses at the Noel Coward theatre in London. Reception to the play at its Broadway premiere in 2010 was tepid. The Corporate World smarting under the Lehman Brothers collapse did not accord the

Much of the script for Enron was centred on characters who negotiated the deal with the Dabhol power project. Surely there is a vigorous enough amateur theatre in Mumbai to have picked up the script.

However, even in the West the audacity of screen and stage is singularly missing in mainstream media. This is particularly so since post 9/11 wars for which the media, by and large, became the drum beaters, compromising its own credibility. The adage makes sense. "When wars break out, the first casualty is the truth." This has resulted in the media's declining credibility and, in consequence, a rise of 'illiberal' democracies. When Donald Trump complained that "China is going ahead of us," Jimmy Carter's response was succinct. "China has not been to war since 1978; we have never stopped being at war.'

Bisamkatak, August 8: In a bid to boost tourism, both the Odisha and the central governments jointly initiated a project to build cottages at the base of Nivamgiri hills in Rayagada district. However, the project is yet to take off due to administrative apathy and local op position

According to reports, ₹1 crore has been allocated for the project. As per project guidelines, the management of cottages will be assigned to Gaon Kalvan Samitis in registered villages of the Niyamgiri region. In view of this, the project has good scope of providing livelihood for Dongria tribals. SPECTRE OF DROUGHT LOOMS LARGE Lightning Farmers engage water strikes kill 8 tankers to save crops

Hinjilicut, August 8: Owing to insufficient rainfall, a spectre of drought is looming large in pockets of this block in Ganjam district. Agricultural land is drying up and the farmers are struggling to save their crops. They have engaged tankers to supply water to their farmlands, a report said.

Hinjilicut and its peripheral areas have not received sufficient rainfall for the last two-and-a-half months. Farmers informed that paddy saplings have started wilting due to lack of water. Some of the agricultural lands have dried up so much that cracks have appeared on the surfaces

With no option left, the farmers are now bringing in tankers to water the parched land. This is creating a huge dent in their pockets. Paddy has been grown in over 6,000 hectares of land in this block. Unless the saplings are watered in a proper manner, there is every possibility of them dying.

In non-irrigated areas like Durbandh, Dayapalli and Gandala panchayats, farmers have pinned hope on divine intervention, by organising 'toad marriages', a traditional belief of the local people. Farmers in these three panchayats said that if there is no rain in the next three days, it will be very difficult for them to save the saplings.

Balasore/Bhadrak/Mayurbhanj, August 8: Eight persons were

killed and seven others sustained serious injuries after lightning struck them at different places in Balasore, Bhadrak and Mayurbhanj districts Saturday. Balasore district reported the

maximum number of lightning deaths with six people dying. The districts of Mayurbhanj and Bhadrak reported one death each. All the seven injured are from Balasore district. They are currently undergoing treatment at government hospitals in Basta and Jaleswar.

According to a source, lightning struck when labourers were working on paddy fields at Sasan village under Singla police limits and at Mathani village under Basta police limits killing two and injuring three women on the spot.

The deceased have been identified as Pana Majhi from Talatapanda village under Basta police limits and Chhabi Kalandi from Brahmanamara village under Muruda police limits in Mayurbhanj district. The injured ones -- Sabitri Kisku, Gurubari Kalandi and Barsha Kalandi - are currently undergoing treatment at Basta community health centre (CHC).

In another incident, 16 women were working on a paddy field at Baghabali village under Jaleswar police limits when lightning struck. Three women collapsed after being struck by lightning.

They were rushed to the GK Bhattar Hospital where one was pronounced dead on arrival. The deceased has been identified as Purnima Singh, wife of Badal Singh from Kusumasahi village under Baradia panchayat in Raibania police limits.

In another case, Gajendra Tudu (12), son of Mangal Tudu of Krushnanagar village under Jaleswar police limits and Padan Marandi, son of Mangal Marandi were killed when they had taken shelter near a brick kiln.

Anakar Mallick (42), a farmer was killed at Padhuan village in Balasore district. In Bhadrak district, the person killed by lightning has been identified as Purnachandra Sahu (56).

Dengue cases trigger panic in Aska, Badasahi

The patient is currently undergoing treatment at SCB Medical College and Hospital in Cuttack. A team of health officials visited the locality and collected blood samples from seven people. Health department, ANMs and ASHA workers are trying to make people understand the utility of preventive measures.

Parjang, August 8: Students of Mohanpasi Government Primary School under Parjanga block with their parents staged a sit-in protest for more than two hours on the Kamakhyanagar-Pariang National Highway-149 in Dhenkanal district. They were protesting against the government's decision to merge their educational institution with a neighbouring school. They staged the sit-in with their school bags and eggs and rice. As a result traffic on the national highway was severely disrupted for more than two hours. The students and their parents relented and withdrew their demonstration after Gopabandhu Sahu, cluster resource centre coordinator (CRCC) reached the spot and assured them that their institution will not be merged with nearby Kendumunda School. Parjang police also tried to pacify the students and urged them not

to take law into their own hands. According to reports, more than 50 students are currently studying at the Mohanapasi School. Last vear, the administration had announced that it would merge the school due to low enrolment as per a decision of the Odisha government. However, recently the state government has relaxed the norms for merger of schools in remote regions. It has said that schools situated in remote regions will not be merged with other institutions even if the number of students is less than 20. However, resentment among the students belonging to Mohanapasi School and their parents grew when they learnt that the administration is planning to merge their school with another school. They voiced their protests and asked how their school can be merged with another educational institution when the number of students is more than 50.

Fifteen platoons of police have been deployed in Rajkanika area to prevent the situation from going out of hand. The police have seized a vehicle of the Kharasrota Banchao Sangram Samiti (KBSS), an outfit opposing the project.

Locals opposing the project have got together to prevent the setting up of the drinking water venture. They have conducted a meeting and vowed to oppose any move to divert water from the river.

"We will not let the river dry up The project has been started without assessing its impact on the biodiversity of Bhitarkanika and the agriculture sector. So we will oppose it tooth and nail," people against the project said. They said they will launch an agitation if the government decides to continue with the project. Notably, the mega drink-

also drastically affect environment. Residents of many riverside villages in Aul and Rajkanika blocks will suffer if the project is implemented, they added.

Staff crunch paralyses Baisinga PS

Baisinga, August 8 : The safety and security of lives and properties of around 1,45,000 people in 205 revenue villages of 17 panchayats are dependent on the Baisinga police station under Betnoti block in Mayurbhanj district. However, acute staff shortage at this police station is having a severe impact on its day-to-day operations.

Over 300 cases are registered at this police station every year. Besides, it has to deal with strikes. roadblocks, demonstrations and agitations throughout the year.

According to local residents, the setting up of an outpost at Manitri of Badasahi block has had a visible impact on the law and order situation in the nearby four panchayats.

"We demand two more outposts to be set up at Purunia and Anla Bazaar. These places are 10 and 15 kilometres away from Baisinga police station respectively. It will not only reduce the pressure on



Baisinga police station but also ensure speedy disposal of cases,' a local resident observed

Incumbent DSP Laxmidhar Swain had served this police station as IIC. In 2020, he had written a letter to higher officials, requesting them to appoint some more staff at the police station and establish more outposts.

No action has so far been taken in this regard, it was alleged.

Chennai, August 8: Vaccine hesitancy was prevalent among 27.6 per cent of people aged above 60 years while the same was present in 16.9 per cent between the age group of 18 and 44 years, a study by the Tamil Nadu government revealed Sunday.

As many as 18.2 per cent of people between the age group of 45 and 59 years were also hesitant to receive the jabs, the survey conducted by the Directorate of Public Health and Preventive Medicine, in July across Tamil Nadu, said.

According to the study, vaccine hesitancy was observed in 19.7 per cent men and 18.4 per cent women, while 17.5 per cent people living in urban and 20.3 per cent in rural areas expressed "unwillingness" to get inoculated.

Some of the reasons for the vaccine hesitancy was fear of injec-



while it was 81.8 per cent between 45-59 years and 72.4 per cent above the age of 60 years.

Nearly 82.5 per cent of those residing in urban areas and 79.7 per cent in rural areas were willing to get vaccinated, while 82.8 per cent people said the reason to get vaccinated was to prevent disease while 23.7 people said it prevents spread to others.

Following the results from the study, the department of public health said it would focus on awareness activities to address the misconceptions. "People above 60 years will be given special attention and strategies will be created to counter the barriers and empower everyone to get vaccinated with confidence." the study said. The survey was done across Tamil Nadu in July by the department with a survey team constituted and led by respective deputy director of health services. "In Chennai, the study was done by community medicine postgraduate students of Madras Medical College with support from Greater Chennai Corporation," it said. As many as 95 clusters were chosen randomly in the state and 30 random houses were selected in each of the cluster.

"Raini is vulnerable at present and requires adequate slope stabilisation works to arrest slope failure activities. If appropriate measures are not taken, it may lead to mass movement activities in saturated, dynamic conditions and toe erosion by rivers," geological experts said in a report based on their field study of the affected village in Chamoli district.

'Therefore, the slopes in Raini village located on the confluence point of Rishi Ganga and Dhauli Ganga Initiative (UDRP) said.

"During the field visit, it was observed that the slope forming material is highly saturated due to incessant rainfall. The soil/debris material loses its strength when the slope forming material gets saturated. As a result, there are many slip areas in the village from toe to uphill of the slope," the UDRP report submitted already to the district administration said.

The fear of villagers of an imminent disaster was deepened after a 40-metre stretch of Joshimath-Malari road just 10 metres below the village caved in a couple of months

Chennai, August 8: The spread of Covid-19 across the world has increased the demand for nutrition supplements in Europe and the US which augurs well for us, said manufacturers and exporters of the organic Spirulina which is a blue-green algae and is a nutrition supplement consumed as tablets or in a powder form mixed with juice.

Incidentally, American space agency NASA has recommended Spirulina for its astronauts going into space as it boosts the immune system

Termed as a super food, Spirulina contains around 55 to 70 per cent protein, high levels of gamma-linolenic acid (GLA), beta carotene, several essential and non-essential amino acids, nucleic acids and others.

"The coronavirus spread has accelerated the awareness about Spirulina. Globally, Spirulina is slowly moving into other segments like beverages, bars. Some small companies use it in bak-ery products," S. Srikanthan, Brand Head, Nutraceutical, EID



Parry, told IANS.

The EID Parry part of the Murugappa group last fiscal earned about Rs.254 crore from its nutraceutical division.

In India also, there are some players who make nutri-bars with Spirulina, apart from selling it as tablets, capsules, powder, but the market, though now small, is expected to grow and is attracting newer players.

Based in Tamil Nadu's Karur district, Prolgae Spirulina Supplies Pvt. Ltd is soon to hit the market with its Spirulina protein bar and sweetened Spirulina powder.

'We have been exporting our sun dried organic Spirulina to Europe. After Covid-19 there is increased awareness and demand for nutritional supplement food. In India we want to get into the consumer market launching protein bars and sweetened spirulina powder," S. Akas, Founder CEO, Prolgae, told IANS

According to Akas, an aeronautical engineering graduate, the two products will be launched August 15 and talks are on with gyms to stock the products.

The products developed by Prolgae will be contract manufactured by the Delhi-based Swasthum.

However, the immunity booster product segment is wide including the age-old chyawanprash and new players have to find a positioning niche.

"We are also talking with nutritionists about our product and its health benefits. We will launch the products in the four metro cities first and expand to other markets and also have our own ecommerce site," Akas added.

Tamil Nadu is one of the major producers and exporters of Spirulina with players like EID Parry, Sanat Products part of Schwabe group, Prolgae Spirulina and others. There are several smaller players whose products go to other sectors like fish/poultry feed and others.

"The high-end product will be about 2,000 tpa of which our market share will be about 30 per cent. In India we are the largest player with about 700-800 tpa production.-We produce organic premium Spirulina," Srikanthan said.

Human trafficking case: NIA conducts raids in B'lore

NEW DELHI/BANGALORE: The NIA has carried out searches in Bengaluru at the premises linked to a person suspected to be involved in making fake identity proof documents for Bangladeshi traffickers, the agency said Sunday. The raids were conducted at two locations Saturday in connection with a human trafficking case involving Bangladeshi nationals. "During the searches various incriminating documents, six digital devices including hard disks and mobile phones used for making the forged documents were seized," the investigation agency said in a statement. The case was registered in June at the Ramamurthy Nagar police station in Bengaluru against 13 accused in connection with a raid conducted by the Karnataka police at a rented house from where seven Bangladeshi women and a child were rescued from the custody of human traffickers, an official of the National Investigation Agency said. The women were trafficked from Bangladesh to India by the accused on the pretext of providing them jobs but were forced into prostitution instead. The NIA re-registered the case under sections of the IPC, the Foreigners Act and the Immoral Traffic (Prevention) Act. Further investigation in the case is underway, the official said.

CBI arrests five for posting 'defamatory' content against judges

New Delhi, August 8: The CBI has arrested five people for allegedly posting defamatory content against judges of the Andhra Pradesh High Court and the Supreme Court on social media, officials said Sunday.

The role of a Lok Sabha member Nandigam Suresh, and ex-MLA Amanchi Krishna Mohan, both of the YSR Congress, are under scanner in the case, and both have been examined by the agency in its effort to unearth a larger conspiracy, they said.

"To investigate the larger conspiracy, the CBI has also examined certain persons, including an MP and an ex-MLA, and also continued investigation into the role of other persons who were not mentioned in the FIR," CBI spokesperson R C Joshi said.

The agency had Saturday arrested two people -- Pattapu Aadarsh and Lavanuru Samba Siva Reddy - from Andhra Pradesh.

Earlier, the CBI had arrested Dhami Reddy Konda Reddy and Pamula Sudheer July 28, while Lingareddy Rajasekhar Reddy, who was residing in Kuwait, was arrested July 9 when he landed in India, the officials said.

Terror funding case NIA searches 56 locations in J&K

Srinagar, August 8: The National Investigation Agency (NIA) Sunday raided 56 places in 14 districts in Jammu and Kashmir following registration of an FIR against prominent members of the banned J&K Jamaat-e-Islami in the terror funding case, officials said.

An NIA spokesperson said that the anti-terror probe agency, along with the CRPF and the Jammu and Kashmir Police, carried out searches in Srinagar, Budgam, Ganderbal, Baramulla, Kupwara, Bandipora, Anantnag, Shopian, Pulwama, Kulgam, Ramban, Doda, Kishtwar, and Rajouri districts.

The official said that the agency had registered a case on the orders of the Union Ministry of Home Affairs on February 5 this year relating to separatist and secessionist activities of J&K JeI, an unlawful association under the Unlawful Activities (Prevention) Act, following its proscription on February 28, 2019.

Members of the organisation have been collecting funds domestically and abroad through donations, particularly in the form of "Zakat, Mowda and Bait-ul-Mal" purportedly to further charity and other welfare activities, "but these funds are instead being used for violent and secessionist activities, the official said.

The official said that the funds raised by JeI are also being channelised to proscribed terrorist organisations such as Hizbul-Mujahideen (HM), Lashkar-e-Taiba (LeT) and others through well organised networks of JeI cadres.

for glacial lake outburst floods'

New Delhi, August 8: Concerned with glacier movement in the Himalayan region due to climate change, a Parliamentary Committee has recommended widening the network of high altitude meteorological and discharge stations equipped with modern technology to avoid damage after disasters such as glacial lake outburst floods (GLOF).

Agencies involved, however, have apprehension owing to the high

altitude and inclement weather conditions. "Of late, climate change has had a great impact on glacier movement in the Indian Himalayan region. In general, glaciers have been rapidly melting and retreating resulting in formation of a number of moraine dammed glacial lakes, posing numerous threats, particularly to the population and infrastructure located nearby due to their outbursts.

"Recognising and spotting of dangerous glacial lakes is very important so that all the stakeholders i.e. planners, scientists, academics, and the general public may evolve, adopt, and carry out suitable mitigation steps such as monitoring, early warning, evacuation and relief and rehabilitation," the 12th report of the Parliamentary Standing Committee on Water Resources, headed by Dr Sanjay Jaiswal, tabled August 5 said.

But Pramanik got the shock of his life after assuming charge in the north block when a work allocation order was issued to three MoS by Cabinet Minister Amit Shah. The order was peculiar when work was distributed among Nityanand Rai, Ajay Kumar Mishra and Nisith Pramanik. Nityanand Rai has been allocated 15 departments and divisions including Internal Security, Jammu & Kashmnir, Counter-terrorism, Left Wing Extremism, Foreigners' Division, Border Management Division-I and Border Management Division-II. Ajay Kumar Mishra was given 8 divisions including Freedom Fighters, women safety, department of official languages, cyber Information Security, Judicial, Administrative and Coordination and International Cooperation. But Nishit Pramanik got the worst deal in the allocation of business as the star inductee from West Bengal got only three divisions; Border Management Division-I and Division -II and

Official Languages Division. But the first two divisions have alreadv been allocated to Nitvanand Rai and the Official Languages Division given to Aiav Kumar Mishra. Pramanik's supporters are fuming as the work allocation order also says all files relating to three divisions will be put to Pramanik through Nityanand Rai and Ajay Kumar Mishra. These three divisions are in dual charge now. Thus within the Home Ministry he is not at par with his two other MoS colleagues. Officials in the ministry are tight-lipped.

Watchdog body headless again

HK Secy signals to adopt China anti-sanctions law

Hong Kong, August 8: Hong Kong's justice secretary said Sunday that a mainland Chinese law to counter foreign sanctions could be adopted in the China-ruled city by writing it into Hong Kong's mini-constitution, pending a de-

cision by the Chinese parliament. Justice Secretary Teresa Cheng's comments are the strongest official indication so far that Hong Kong would embrace the mainland law, passed in June to counter foreign sanctions as the US and EU step up pressure over trade, technology, Hong Kong and Xinjiang.

Under the law, individuals or entities involved in making or implementing discriminatory measures against Chinese citizens or entities could be put on an antisanctions list by relevant depart-

Local media have reported that a decision would likely be made during a meeting in Beijing between Aug 17-20

Cheng wrote in an official blog entry that the "most natural and appropriate way" to introduce the anti-sanctions law into Hong Kong would be to add it to an annex of the Basic Law, or HK's mini-constitution. She added that such a move needed first to be approved by the highest



The insurgents have snatched five provincial capitals since Friday in a lightning offensive, almost a month before the 20th anniversary of the September 11 attacks that sparked the American-led invasion.

"A prolonged civil war is a more likely outcome than a swift Taliban takeover of the entire country. They're being very smart about this. They're not launching major strikes into Kabul." said former US ambassador to Afghanistan, Rvan Crocker, Kunduz, Sar-e-Pul and Taloqan in the north fell within hours of each other Sunday, lawmakers, security sources and residents in the cities confirmed. Kunduz is the most significant Taliban gain since the insurgents launched an offensive in May as foreign forces began the final stages of their withdrawal. It has been a perennial target for the Taliban, who briefly overran the city in 2015 and again in 2016 but never managed to hold it for long "They're doing what they're doing in part to create a climate of fear and panic. They are succeeding wonderfully," Crocker added, referring to the Taliban. Paris, August 8: Almost a quarter of a million people took to the streets across France Saturday for the biggest protests yet against a Coronavirus health pass needed to enter a cafe or travel on an inter-city train, two days before the new rules come into force.

Championed by President Emmanuel Macron, the French regulations make it obligatory to have either a full course of vaccination against Covid-19, a negative test or be recently recovered from the virus to enjoy routine activities.

About 237,000 people turned out across France, including 17,000 in Paris, the interior ministry said, exceeding the 204,000 recorded last weekend -- unusual numbers for protests at the height of the summer break.

In one of several protests in Paris, hundreds marched from the western suburbs to the centre, chanting "Freedom!" and "Macron, we don't want your pass!"

'Get vaccinated'

From Monday, the health pass will be needed to eat in a restaurant or enjoy a drink at a cafe -- both indoors and on a terrace. It will be obligatory on inter-city transport including high-speed trains and

domestic flights although will not be needed on metro systems and suburban transport.

The pass has already been required since July 21 to visit cultural venues such as cinemas, theatres and museums. Its extension was approved by France's Constitutional Council Thursday. In a slight easing of rules, Health Minister Oliver Veran said Saturday that the time period over which a recent Covid test would be valid for the pass would be extended to three days instead of two.

Most of the protests were peaceful but there were seven arrests in the southeastern city of Lyon for throwing projectiles while in Dijon a tram line was blocked. There were 35 arrests nationwide, the interior ministry said, adding seven members of the security forces were lightly wounded.

Hezbollah ready for war with Israel

Beirut, August 8: The head of Lebanon's powerful Hezbollah movement, Hassan Nasrallah, Saturday vowed a "suitable and proportionate" response to any Israeli air strikes on Lebanon after a flare-up at the border this week.

"Our response was linked to the Israeli strikes that occurred in south Lebanon for the first time in 15 years," he said in a televised speech. "We wanted to tell the enemy... that any air strike by the Israeli air force on Lebanon will inevitably draw a response, though in a suitable and proportionate way, because we want to serve the purpose of protecting our country," he added.

Nasrallah described the air strikes this week as a "very dangerous development", but said Hezbollah did not want war.

"We are not looking for war and we do not want to head towards war, but we are ready for it" if necessary, he said, echoing similar comments by the Jewish state this week.



Israel PM blames Lebanon for attacks

srael's Prime Minister said Sunday he holds the Lebanese government responsible for rocket fire launched from its territory, whether the Hezbollah militant group launched the weapons or not. Prime Minister Naftali Bennett's comments came days after one of the heaviest flare-ups in violence between Israel and Hezbollah in several years and indicated Israel could expand its response if the rocket fire continues. "The country of Lebanon and the army of Lebanon have to take responsibility (for) what happens in its backyard," Bennett told his Cabinet. "It is less important to us if it's a Palestinian organisation that fired, independent rebels, the state of Israel won't accept shooting on its land," Bennett added.



Delhi-London economy class airfares zoom

New Delhi: Average economy-class fares on international flights operating on key routes connecting India have risen significantly during the last one month due to high demand, according to data from EaseMyTrip.com. The travel website's data shows that average economy class fare on a flight heading from Delhi in India to Newark in the US increased from ₹69.034 in July to ₹87.542 in August. An average economy class ticket on Mumbai-Moscow flight and Mumbai-Doha flight was priced ₹43.132 and ₹11.719, respectively, in July this year, according to the data. This increased to ₹85,024 and ₹18,384, respectively, by August. In a statement, Nishant Pitti, CEO and Cofounder of EaseMyTrip.com, said there has been an increase in the average economy fares of international routes in August compared to July.

90% want govt to frame booking refund policy: Survey

Mumbai, August 8: As many as 90% of people in a survey carried out to assess issues faced in getting refund for cancelled travel bookings, including of flight tickets, in the wake of Covid-19, want the government to formulate a pandemicspecific cancellation refund pol-1CY.

According to the survey by online platform LocalCircles, based over 37,000 responses received from citizens across 359 districts, some travel agents (online and offline), airlines as well as hotels did not initiate any refund with people losing the complete booking amount. As per the platform, only 12-13%

of those who cancelled travel bookings due to the second Covid wave could get timely refunds. "As many as 95% of citizens be-

lieve that the current policies of the

airlines, railways or hotels are not in consumer interest and 90% want the government to come up with a travel booking refund policy till the time the COVID pandemic is on,' LocalCircles said.

The same could be brought by the respective ministries like Civil Aviation, Tourism and Railways or by the Ministry of Home Affairs under the Disaster Management Act 2005, it said, adding that people have also suggested a 3-option traveller-friendly travel booking cancellation and refund policy.

Based on the survey results, the best-case scenario could be giving people the option of either giving a refund within a week and 20% amount to be deducted as processing charges, or a refund within a month and only 10% amount to be deducted as processing charges or no refund but a voucher for full amount issued which can be used



towards future travel within two vears. it said This way, travellers have the confidence that their losses will be limited in case they were faced with a cancellation situation due

According to the platform, while some were able to retrieve a partial amount, others were asked to rebook the flights and hotel stays for a later date

to the pandemic, LocalCircles said. The platform said it will be submitting the findings of this survev with the key stakeholders in the Central Government so the same can be used as an input in decision-making in regard to formulating a uniform policy for travel booking cancellation refunds during the Covid pandemic.

According to LocalCircles, the second wave of the pandemic forced many citizens and families to cancel their travel plans. At the time, many citizens reported on LocalCircles about issues they faced when trying to cancel tickets and hotel stays for their booked summer travel, it stated.

New Delhi, August 8: It started with a bang, tapered off in the middle and then ended spectacularly. India were quite literally on a roller-coaster during the Tokyo Olympics which ended Sunday. So, there was the first medal in

track-and-field which also happened to be the first gold here here a second in 13 years. There was the first medal in hockey in 41 years,

the first silver in weightlifting, the first boxing medal in nine years, the first woman with two Olympic medals, the most number of debutants ending up on the podium, and the most number of medals ever won. It all happened in one single Olympics for India. Mighty impressive? No, it was

way more than that. India's campaign at the Olympic

Games was as much a story of human resilience as of sporting excellence and it came to the fore on the opening day of competitions itself starting with Mirabai Chanu.

The Manipuri weightlifter stands a mere 4'11" but lifted 202kg (87+115) to fetch a silver and put India on the medals tally, showing the world why size doesn't and shouldn't matter.

In her moment of glory, the phenomenal weightlifter was a personification of perseverance. She had left the same stage in tears and dejection five years ago, failing to log a single legal lift. And there she was smiling ear to ear July 24 becoming

"I could not do mat training for nearly 25 days. I was not able to run as well after the injury. Before a tournament like Olympics even missing one day's training is not good," Bajrang said during a media interaction.

The 27-year-old said he will continue to compete in the 65kg category till the Paris Games. "There



is no scope to move to 74kg. Next year we have the CWG and the Asian Games. I have missed the gold medal now but will work on my weaknesses and try to get a

top-finish in Paris," Bajrang said. He informed he will start rehabil-

itation after returning to Haryana. His next target is to do well in the World Championships at Oslo, Norway, October 2-10.

The Haryana wrestler also asserted that a lot of athletes succumb to pressure but he is comfortable carrying the weight of expectations. "I have seen people crumble under pressure. It mostly happens with the new athletes but I feel happy when people tell me that they want to see me win Olympic medal. Pressure gives you nothing, so we must learn to play freely," Bajrang pointed out.

Unlike other wrestlers, weightcut is not an issue that bothers Bajrang much. Now he wants to go home and eat 'Choorma' that his mother Om Pyari prepares for him whenever he gets back home.

New Delhi, August 8: Boxer Vikas Krishan, whose Olympic campaign ended abruptly after a dislocated right shoulder caused an openinground loss, has undergone a surgery to fix the injury which will keep him out of action for the next three months. The 29-year-old, who was competing in his third Olympics in Tokyo, was forced out early after 'fighting with one hand' in the opening clash against Japan's Sewon Okazawa.

The surgery on his dislocated shoulder was performed Thursday at Mumbai's Kokilaben Hospital by renowned surgeon Dr Dinshaw Pardiwala. Incidentally it was the same surgeon who operated and fixed a career-threatening shoulder injury which newly-crowned Olympic gold-winner Neeraj Chopra had suffered in 2019. Vikas is expected to be fit in three weeks.

Rain robs India of victory

Nottingham, August 8: Persistent rain proved to be anti-climactic as India, who had a realistic shot at victory in the series-opener, were forced to share points with England after entire fifth day's play was washed out, at the Trent Bridge here Sunday. India needed to score 157 runs on the final day but the rain did not allow a single ball to be bowled. As part of the new World Test Championship cycle, both India and England got four points each.

Only 250 plus overs out of a maximum 450 were possible due to the inclement weather. India chasing 209 for victory, were well placed at 52 for one after the end of the fourth day's play.

While cricket remains a game of glorious uncertainties, Virat Kohli and his men certainly had a better shot at full 12 points from the match.

It would have taken a special bowling effort from England to

It was more than 80 seconds ahead of runner-up Abdi Nageeye of the Netherlands, Bashir Abdi of Belgium earned bronze to close out the track and field portion of the Tokyo Games. (1960, '64) and Waldemar Cierpinski ('76, '80)

Bitter blow

The Russian rhythmic gymnastics juggernaut collapsed at the Olympics here as they lost to Bulgaria in the gold medal match. This is the first time since 2000 that the Russians have failed to win the rhythmic gymnastics gold at the Games. "It's so unreal, we cannot believe it. I don't know what to say,' Bulgarian gymnast Stefani Kiryakova said. "This is the happiest moment ever."

Sprint gold for Mitchell

elsey Mitchell of Canada won gold in the women's sprint event in track cycling, sweeping past Olena Starikova of Ukraine at the Izu Velodrome here Sunday. Mitchell upset reigning World Champion Emma Hinze of

Germany in the semifinals before facing off with Starikova, who likewise had upset 2019 World Champion Lee Wai Sze of Hong Kong in her last four match.

Sifan had earlier won gold in 5,000 metres and a bronze in the 1.500 metres. Sifan said that her decision to move to the Netherlands from Ethiopia had helped her win a handful of medals at the Tokyo Games.
