

₹19,500crore PM-KISAN given away

New Delhi, August 9: Prime Minister Narendra Modi Monday transferred about ₹19,500 crore to over 9.75 crore beneficiary farmers under the flagship scheme PM-KISAN and said the government is taking several steps to double the income of the farming community.

Under the Pradhan Mantri Kisan Samman Nidhi (PM-KISAN) scheme, the Centre provides an annual financial benefit of ₹6,000 to eligible beneficiary farmers in three equal fourmonthly installments of ₹2,000 each.

The scheme was announced by the government in February 2019 in the Budget. The first installment was released for December 2018-March 2019 period. The fund is transferred directly to the bank accounts of the beneficiaries. On Monday, the prime minister virtually released the ninth installment for the beneficiaries. With this, the government has so far transferred around ₹1.57 lakh crore to farmer

Addressing the virtual event, Modi said the government has transferred over ₹19,500 crore directly to nearly 10 crore farmers and this amount will be useful for them. "Nearly ₹1.6 lakh crore have been transferred so far under PM-KISAN scheme, of which around ₹1 lakh crore has been released dur-

ing the pandemic," he added. Out of this, ₹1 lakh crore was transferred to small farmers during the pandemic, he said. This amount will be useful for small farmers at a time when the sowing of kharif crops is at its peak in the current monsoon season, he added.

Asserting that the government is committed to providing all resources to farmers to boost their income, Modi highlighted the benefits being reaped by farmers taking advantage of several schemes including ₹1 lakh crore agri-infra fund that completed one year Monday.

Modi said farmers are benefitting from the Honey Bee Mission, which has led to huge export of honey resulting in extra income for farmers.

Curbs on festivals

Bhubaneswar, August 9: In view of resurgence in Covid-19 infections, the state government has imposed restrictions on celebrations of Ganesh Puja and other Pujas/festivals in the state. Chief Secretary SC Mahapatra has issued an order to this effect Monday.

All the festivals including Ganesh Puja, Durga Puja, Laxmi Puja, Kali Puja and other Pujas/festivals of other religious communities in August, September, October and November of 2021, will be conducted without congregation of devotees.

"People usually congregate and get in touch with each other to celebrate the festivals/ Pujas during which it is not possible to adhere to Covid-19 appropriate behaviour and such congregations have a potential to cause spread of the virus," Mahapatra said.

However, religious rituals in temples, churches, mosques and other places of worship will continue as usual with a limited number of persons with strict adherence to Covid protocols. People can observe festivals

on their premises without causing congregation at any place and maintaining safety protocols, such as social distancing, wearing masks, proper sanitisation.

The puja committees or organisers in rural and urban areas are allowed to conduct puja in mandaps/pandals with certain restrictions. For conducting Pujas in pandals/mandaps, organisers will have to apply and obtain necessary permission from the Collector, Commissionerate of Police (for Cuttack and Bhubaneswar) or any other authorised officer.

Puja will be conducted in indoor-like conditions only for observance of rituals without public participation, pomp and grandeur. Puja pandals will be covered from all sides and there will be no public darshan.

The size of the idol must be less than 4 feet and there will be no use of any public address system, it said. At any given point in time, maximum seven persons including organisers and priests and support staff present in the Puja Pandal/ Mandap can be present on the Mandap, it said.

Big push to sports infra Blashphemy on 8-yr old Pak Hindu

89 Biju indoor stadiums planned for whole state

POST NEWS NETWORK

Bhubaneswar, August 9: The state government will construct 89 multipurpose indoor stadiums at different urban areas across the state with an investment of ₹693.35 crore. The state cabinet headed by Chief Minister Naveen Patnaik approved this along with 15 other proposals Monday.

Sports and Youth Services Minister Tusharkanti Behera said these stadiums will be taken up in 85 urban local bodies (ULBs) areas including in Bhubaneswar, Cuttack and Rourkela under the state government's 5T initiative to transform the sports scenario in Odisha.

The government has been focusing on development of sports and in recent years, Odisha has been recognised as a leading destination for sports events and promotion of sports

in the country, Behera said, adding ULB areas act as main centres for sports and related activities. The project will ensure development of quality sports infrastructure across ULBs.

These indoor stadiums will be built for multi-purpose utilities. They will have facilities for playing badminton, table tennis, yoga and gymnasium. There will be space for most of the indoor games. The space can be converted for use for various popular local sports. The stadiums will be completed over next 18 months. This will provide a major boost for the de-

velopment of sports in the state, he said. The stadiums to be named as Biju Patnaik Indoor Stadium will come up at three municipal corporations, 30 municipalities and 52 NACs.

The state government will spend Rs10.15 crores on each stadium at municipal corporation towns and municipalities while ₹6.40 crore will be spent for each stadium in NAC. The indoor stadiums are also designed to withstand 200 kmph wind speed. They can be utilised as community shelters during disasters like cyclones, floods and others. In times of pandemics, the stadium can be converted into a 50-bed (NAC model) or 100-bed (municipality model) field hospitals

New Delhi, August 9: An eight-yearold Hindu boy is being held in protective police custody in Pakistan after becoming the youngest person ever to be charged with blasphemy in the country, a media report said.

According to the Guardian news report, the boy's family is in hiding and many of the Hindu community in the conservative district of Rahim Yar Khan in Punjab province, have fled their homes after a Muslim crowd attacked a Hindu temple after the boy's release on bail last week. Troops were deployed to the area to quell any further unrest.

On August 7, 20 people were arrested in connection with the temple attack.

The boy is accused of intentionally urinating on a carpet in the library of a madrassa, where religious books were kept, last month. Blasphemy charges can carry the death penalty, the Guardian report said.

Daily Covid load dips below 1,000

Bhubaneswar, August 9: After a gap of nearly four months, Odisha registered less than 1,000 Covid-19 cases in a single day as 886 more people tested positive for the infection Monday, which pushed the tally to 9,87,956, a health department official said.

Sixty-six deaths, recorded in 10 districts of the coastal state, raised the toll to 6,501, he said. The health and family welfare department, however, clarified that the "list does not reflect deaths occurring on a particular day. It gives details of the past deaths for which the audit process has been duly completed, and the cause

identified as Covid-19"

Khurda district, of which state capital Bhubaneswar is a part, accounted for 29 deaths, Cuttack for 13 and Sambalpur for eight. Of the 886 new cases, 253 were reported from Khurda, 81 from Cuttack and 62 from Balasore. Two districts -Bolangir and Nuapada -- did not report any new case.

Odisha currently has 11,486 active cases, while as many as 9,69,916 patients, including 1,463 Sunday, have recovered from the highly infectious disease. The positivity rate stands at 5.94 per cent. Over 1.66 crore sample tests have been conducted thus far, including 66,063 Sunday. Odisha has so far inoculated 1,78,62,345 people with Covid-19 vaccines

UN climate report sounds 'code red for humanity'

Berlin, August 9: Earth's climate is getting so hot that temperatures in about a decade will probably blow past a level of warming that world leaders have sought to prevent, according to a report released Monday that the United Nations calls a "code

red for humanity." "It's just guaranteed that it's going to get worse," said report co-author Linda Mearns, a senior climate scientist at the U.S. National Center for Atmospheric Research. "I don't see any area that is safe ... Nowhere

to run, nowhere to hide. But scientists also eased back a bit on the likelihood of the absolute worst climate catastrophes. authoritative Intergovernmental Panel on Climate Change (IPCC) report, which calls climate change clearly human-caused and "unequivocal," makes more precise and warmer forecasts for the 21st century



than it did last time it was issued in

Each of five scenarios for the future, based on how much carbon emissions are cut, passes the more stringent of two thresholds set in the

2015 Paris climate agreement. World leaders agreed then to try to limit warming to 1.5 degrees Celsius (2.7 degrees Fahrenheit) since the late 19th century because problems mount quickly after that. The limit is only a few tenths of a degree hotter than now because the world has already warmed nearly 1.1 degrees Celsius (2 degrees Fahrenheit) in the past century and a half.

Under each scenario, the report said, the world will cross the 1.5 degrees Celsius warming mark in the 2030s, earlier than some past predictions. Warming has ramped up in recent years, data shows.

In three scenarios, the world will also likely exceed 2 degrees Celsius (3.6 degrees Fahrenheit) over pre-industrial times — the other, less stringent Paris goal — with far worse heat waves, droughts and flood-inducing downpours "unless deep reductions in carbon dioxide and other greenhouse gas emissions occur in the coming decades," the report

"This report tells us that recent changes in the climate are widespread, rapid and intensifying, unprecedented in thousands of years, said IPCC Vice Chair Ko Barrett, senior climate adviser for the U.S. National Oceanic and Atmospheric Administration. "The changes we experience will increase with further

The 3,000-plus-page report from 234

scientists said warming is already accelerating sea level rise, shrinking ice and worsening extremes such as heat waves, droughts, floods and storms. Tropical cyclones are getting stronger and wetter, while Arctic sea ice is dwindling in the summer and permafrost is thawing. All of these trends will get worse, the report said.

For example, the kind of heat wave that used to happen only once every 50 years now happens once a decade, and if the world warms another degree Celsius (1.8 degrees Fahrenheit), it will happen twice every seven years, the report said.

As the planet warms, places will get hit more not just by extreme weather but by multiple climate disasters that occur simultaneously, the report said. That's like what's now happening in the Western U.S., where heat waves, drought and wildfires compound the damage, Mearns said.







Bhubaneswar, August 9: The state Cabinet under the chairmanship of Chief Minister Naveen Patnaik Monday approved a tender for implementation of Srimandir Parikrama Project in Puri under Augmentation of Basic Amenities and Development of Heritage and Architecture (Abadha) scheme.

The tender was awarded to Tata Projects Limited at a cost of ₹331.28 crore. The work will be completed within 18 months, Chief Secretary Suresh Chandra Mahapatra said at the Cabinet meeting held here

The panel also approved the tender for renovation and restoration of upper Indravati right main canal at a cost of ₹148.12 crore which is planned to be completed in 24 months

Bhubaneswar, August 9: After a gap of more than six months, classroom teaching at technical institutes across the state resumed Monday with strict adherence to the standard operating procedures (SOPs) laid down by the state government.

As per the SOP, physical classes will be held regularly, covering all chapters of the syllabus even though some chapters have been taught through online mode. Classroom teaching will be recorded and shared with the absentees.

Authorities of the institutes have made elaborate arrangements for the commencement of classes in an infection-free environment with proper sanitization of classrooms, laboratories, libraries and offices.

ITI Bhubaneswar Principal Jeetamitra Satpathy said, "After a long gap, students arrived at the institute. For them, we have arranged all safety measures such as hand wash and sanitizer available in the classrooms. We have also divided the students in small groups for different classes in different shifts. On the first day, 60 per cent students attended the classes but we expect more students to show up.'

Students and staffers have expressed pleasure over the resumption of offline classes after a long gap.

Covid threw spanner on routine health check-ups: Study

Bhubaneswar, August 9: People with chronic non-communicable diseases (NCDs) faced multiple challenges in accessing healthcare in Khurda district during the Covid-19 pandemic, a study reveals.

The ICMR-Regional Medical Research Centre (RMRC) and Kalinga Institute of Medical Sciences (KIMS) jointly conducted the mixed-method study in Khurda district during May-June 2020. The report was published Monday.

A total of 491 individuals, having at least one NCD, participated in the study. Among them, 51 per cent (252) were males.

The study revealed that nearly two-thirds of the participants encountered challenges in their routine investigation (69%), while 67 per cent faced trouble in day-care procedures and 61 per cent in reaching hospitals.

Similarly, around 59 per cent participants reported issues in doctor appointments while 56 per cent faced challenges in emergency treatment. Likewise, 47 per cent participants in the survey faced issues in access to the pharmacy while 46 per cent faced delay in availing healthcare services.

Meanwhile, 37 per cent perceived that they could not access healthcare facilities because of social restrictions/lockdowns, 29 per cent attributed arranging finance as a constraint to visiting hospitals and 16 per cent avoided going to the hospital, fearing Covid-19 infection, the study says

"Qualitative findings revealed that before the onset of the pandemic, participants managed their NCD conditions by routinely visiting hospitals or physicians. Almost all considered their routine treatment as a lesser priority during the pandemic as compared to the threat of Covid-19," it said. Those living in urban areas with

multiple non-communicable diseases reported a significantly higher challenge in having doctor's consultation as compared to those living in rural areas with a single NCD condition.

The study also found that fam-

ily networks were the primary source of support among the respondents (96%), while about three per cent relied on their friends and neighbours.

Some of the participating patients also tried to avail teleconsultation or consulted their physicians through telephone or Internet-based platforms. However, non-availability of their health records and background information on treatment was the major challenge while approaching a new physician on a telemedicine platform.

FILL VACANCIES IN TRIBUNALS: TO CENTRE

New Delhi, August 9: The Biju Janata Dal (BJD) Monday supported the Tribunals Reforms Bill 2021 which seeks to abolish several appellate tribunals and transfer their functions, such as adjudication of appeals, to other existing judicial bodies. The party, however, demanded filling up of vacancies in several tribunals.

Speaking on the Bill on behalf of the party in the Upper House, BJD MP Sujeet Kumar said that the tribunal system needs reforms and this Bill will fast-

track justice by reducing an extra layer of litigation. He said that the two main reasons to establish the tribunals were to unclog the courts, and the lack of spe cialised skills in

courts' part. It was expected that the tribunals would provide specialised skills to deal with the matters.

ODISHA IN

The BJD MP raised apprehension about the short tenure of members as stated in the Bill. He said that the four-year term of office is lower than the minimum term of five years as directed by the Supreme Court.

Kumar also raised concern over executive hold on the judiciary. "I share the concern that the short tenure of members along with eligibility of re-appointment ensures executive hold on the tribunals," he said.

Party MP Sujeet Kumar raised apprehension about the short tenure of members as stated in the Tribunals Reforms Bill, 2021

The BJD MP urged the Union government to consider the issue of vacancies in tribunals with utmost seriousness. There are many vacancies in the tribunals and

these should be filled up in a time-bound manner.

> Stating that there is huge pendency of cases in the high courts, Kumar said the abolishment of these tribunals will further increase the pending

Significantly, the Rajya Sabha passed the Bill by voice vote while a statutory motion moved by the Opposition members to send it to a select committee was negated by a division vote. The Bill was passed by Lok Sabha August 3.

Tribunals that the Bill seeks to abolish include Film Certification Appellate Tribunal, Airports Appellate Tribunal, Authority for Advance Rulings, Intellectual Property Appellate Board and Plant Varieties Protection Appellate Tribunal. The functions of these will be transferred to the existing judicial bodies.

Shrines in Capital city to reopen August 23

Bhubaneswar, August 9: After conducting several rounds of talks with relevant stakeholders, the Bhubaneswar Municipal Corporation (BMC) Monday decided to allow reopening of all religious institutions in the Capital city from August 23.

Following a virtual meet with all religious heads of the city, the BMC issued an order on reopening of the institutions amid strict adherence to Covid-19 protocols. The civic authority clarified that only 100 devotees will be allowed entry to Lingaraj Temple while 25 will be allowed to other temples, mosques, gurudwaras and church.

"Only 100 devotees will be allowed from Singhadwar to Ada-Katha. Sahana darshan/Garvagruha darshan will



be completely prohibited at Lingaraj Temple. The BMC will do the necessary barricading outside the temple to ensure this. No devotee will

be allowed inside the 'Garvagruha' or sanctum santorum of any temple area and will be allowed 'darshan' from a safe distance only. There

ONLY 100 DEVOTEES WILL BE ALLOWED ENTRY TO LINGARAJ TEMPLE WHILE 25 WILL BE ALLOWED TO OTHER TEMPLES, MOSQUES, **GURUDWARAS AND** CHURCH

NO DEVOTEE WILL BE ALLOWED INSIDE THE 'GARVAGRUHA' OR SANCTUM SANTORUM OF ANY TEMPLE AREA AND WILL BE ALLOWED 'DARSHAN' FROM A SAFE DISTANCE ONLY

shall be no food offerings in the temple. Temple authorities should ensure that all instructions are strictly adhered to," the order read.

It also stated that the authorities shall ensure RT-PCR testing of their priests/servitors and only getting a negative report along with final Covid vaccination

certificate, be allowed to perform

The BMC notification said religious institution authorities shall ensure maintenance of social distancing of 6 feet among visitors.

"All priests/sebayats and devotees have to wear masks all the time. The religious institutions shall make provision for hand washing and hand sanitiser for the devotees at the entry and exit points. Spitting inside and outside premises is strictly prohibited. Moreover individuals with SARI/Ill like symptoms shall not be allowed inside. Other vulnerable groups including those with co-morbidities, elderly age persons, pregnant women or children below eight years of age are advised not to visit religious institutions," the order added.

Brown sugar worth ₹1.1 crore seized in Cuttack; 6 arrested

Cuttack, August 9: The Commissionerate Police Monday claimed to have arrested six persons after recovering over 1 kg of brown sugar from their possession here.

commissioner Saumendra Priyadarshi told newsmen that acting on a tip-off, a joint team of Lalbag police and special squad, led by additional commissioner of police (ACP) Ajay Das, arrested the drug peddlers during a raid near RNT College here late Sunday night.

"Around 1.159 kilogram of brown sugar packed in six sachets has been recovered from their possession. The contraband would fetch

more than ₹1.10 crore," the police top brass said.

According to Priyadarshi, all

the six were booked under Section 21C of the Narcotic Drugs and Psychotropic Substances Act. A case (206/2021) has been registered with Lalbag police in connection with the haul.

"Multiple criminal cases have been pending against the accused in various police stations in Bhubaneswar, Cuttack and in some other places. Of the six, four are from Jagatsinghpur, one is from Cuttack and the other is from Puri," Priyadarshi

During interrogation, the accused confessed to have been procuring brown sugar from Balasore and disposing of the contraband after finding prospective buyers at Cuttack, Khurda, Puri and Jagatsinghpur districts

A special team, under the guidance of Cuttack deputy commissioner of police (DCP), has been investigating the case.

Sources said Commissionerate Police has recovered around 4.2 kg of brown sugar and 677 kg of ganja from the twin cities and arrested 39 persons in connection with the cases since January 2021.

The police, Priyadarshi said, have been working on a mission to make the twin city drug free.



Bhubaneswar, August 9: The state Congress Monday demanded an audit by the Accountant General (AG) on utilization of funds collected from the contractors by the state government during the last

Odisha Pradesh Congress spokesperson and Chairman of the State Seva Dal. Arva Kumar Gyanendra alleged large scale corruption in the utilisation of fund collected from contractors for welfare of the workers

Gvanendra said that the government had collected over Rs30,000 crore as cess and used the fund for procuring bicycles, shoes, umbrellas and other materials for the workers during the last ten years. He demanded a white paper on the utilisation of the fund.

He alleged that the government paid ₹1,500 each as covid assistance to the construction workers. But the money was not paid from the government's own resources but from the fund collected from contractors. However, the government took credit citing the former.

The Odisha unit of the All India Unorganised Workers Congress, led by Bidyadhar Mohanty, demonstrated before the state Assembly and demanded the fulfilment of its nine point charter of demands.

Fake crop insurance racket unearthed, 10 arrested

Kantabanji, August 9: Amid allegations of gross irregularities in registration of farmers' names for crop insurance, police Monday arrested six persons, including four operators of common service centres (CSC) and two fake farmers, for their alleged involvement in crop insurance irregularities in Bolangir district.

Three CSCs operators – Sanjay Kumar Panda of Kantabanji Road, Niranjan Meher of Badasaimara village under Muribahal block and Jeetendra Behera of Belpada under Bongomunda block were arrested and produced in the court, Sunday. They were remanded to judicial custody after the court rejected their bail pleas.

The crackdown has sparked panic among the fake farmers and CSC operators involved in crop insurance irregularities in the district

Later, acting on a complaint of Chhabimanyu Putel of Dangamara village, police arrested two fake farmers Jadupati Meher and Prahallad Meher of Chaulasukha village and a CSC operator Bailochan Meher of the same village, Monday. They were produced in the court and remanded to judicial custody.

According to sources, the CSC operators in connivance with fake farmers were involved in issuing fake crop insurance policies against

land belonging to genuine farmers in and around Turekela, Bongomunda, Muribahal and Kantabanji areas in the district.

During the course of investigation, the police have also exposed the involvement of several other CSCs in such corrupt practices, sources said.

The police action was subsequent to an expose by one Dhanurjay Meher of Chaulasukha village who filed a written complaint in this regard with the Kantabanji police. Earlier, police had arrested three fake farmers Debendra Meher, Bishikesan Meher and Arjun Meher in this connection and produced them in court, last Wednesday.

Reports said that some fake farmers connived with the CSC operators to grab the benefits of crop insurance by forging papers of the farmlands belonging to genuine farmers in their name while registering for crop insurance, this year.

Later, when the genuine farmers tried to buy a crop insurance policy, the computers declined the registration. This gave rise to suspicion and the victimised farmers lodged complaints in this regard with their respective tehsildars, agricultural officers as well as at the local police stations. Further investigation into the matter is on even as the police are trying to bring the accused on remand and question them regarding the irregularities.

Notably, the Jajpur district Collector Sunday suspended three officials, including a junior engineer, for their alleged involvement in irregularities in various developmental projects of Jari panchayat under Binjharpur block in the district.

The suspension of the officials by the Collector came days after villagers staged a protest in front of the panchayat office alleging large-scale irregularities in several projects implemented under MGNREGS scheme in the village.

Police Menace

hief Justice of India NV Ramana hit the bull's eye August 8 when he came down heavily on the incidence of custodial torture and other atrocities committed regularly in police stations across the country. He termed the barbarity as a "threat to human rights and bodily integrity," saying human rights and bodily integrity are 'sacrosanct'. The remarks were made at an event organised by the National Legal Services Authority (NLSA). A couple of days back, heading a two-judge bench, the CJI had castigated the two top Central investigating agencies - CBI and IB - for "not helping the judiciary at all" in matters relating to security of judges. The CBI and the police, he categorically said, don't respond to complaints from judges.

His observations are a sad commentary on the crime and punishment scenario of the country. He pointed out there are several cases in the country in which gangsters and high profile people are accused and judges are sometimes threatened physically and mentally through messages on WhatsApp and SMS or harassed through social media posts. The CJI's observation is a reminder of the death of Justice Loya some years ago and recently the Additional District and Sessions Judge Uttam Anand in Dhanbad July 28 under mysterious circumstances. ADJ Anand was killed after being hit by an autorickshaw when he was on morning walk. The murder of Judge Loya had deep shades of political interests and interference.

Things have come to such a pass that the CJI had to tell Attorney General KK Venugopal, who had been asked by the court to assist in the matter, that in some places the courts ordered CBI inquiry, but the agency did nothing. The CJI bemoaned a new trend has started in the country to malign the judiciary when adverse orders are passed and the CBI doesn't respond. The apex court squarely held the state responsible for the death of the young judge in Dhanbad as the area is known to be a virtual fiefdom of the 'coal mafia'. A curious plea was made by Jharkhand Advocate General Rajiv Ranjan who said the state had enhanced security for judges and built boundary walls where none existed. At this, Justice Surya Kant exposed the naive assertion of the Advocate General with the observation that boundary walls are no barriers for hardened criminals.

While delay in justice delivery has damaged the image of the judiciary, the executive too is being faulted for not responding to judicial requirements. If the judiciary is cowed down by criminals with political nexus, one can well imagine the plight of the common man.

The CJI's observations regarding human rights violations by the police bring to light incidents like the death of a fruit stall owner, 47-year-old A Murugesan, allegedly due to brutal thrashing by a special sub-inspector of Tamil Nadu police in Vazhapadi in Salem district June 22. Two other policemen watched the crime by their colleague, while Murugesan's friends pleaded for him to be spared. But, the SSI didn't relent. Such cases are galore and the National Crime Records Bureau (NCRB) reeks of sickening tales of police

Union Home Minister Amit Shah took a curious position July 12 when he rather helplessly pleaded at a programme in Ahmedabad that the police in the country are accused of either 'no action' or 'extreme action'. Official statistics, whatever available, show the matter can't be glossed over with such casual remarks. According to the NCRB, 85 cases of custodial deaths were reported in 2019 with Tamil Nadu registering the highest number of such cases followed by Gujarat, Punjab, Rajasthan and Odisha. No policeman was convicted, though 14 personnel of Gujarat were arrested and charge-sheeted. For six custodial deaths in Rajasthan, three magisterial inquiries and two judicial inquiries were initiated against erring policemen. In Odisha the police personnel involved in violations of human rights went scot free.

The grim reality is that though several policemen do get convicted, many are believed to get away by manipulating records, intimidating complainants or enjoying patronage from their higher-ups. Those police personnel who passively watch custodial torture taking place in their presence should be held equally guilty. Senior officers are expected to ensure that prompt actions are taken against policemen resorting to brutal torture. However, that is never happening. Once if such a message is sent loud and clear that the erring personnel would be promptly punished, the system can be cleansed. But, what the police lack most is a regular sensitisation and refresher course which should be made an indelible part of the job. Interaction with senior officers and socially prominent citizens from different walks of life on a regular basis would heighten the sense and sensibilities of the cop on the street. That is never done by the Indian police. The system still functions as a machine of colonial repression. That atmosphere makes police personnel suspicious of every citizen. Since heinous crimes committed by policemen go totally unpunished, it is imperative that police personnel realise they are not above the law and that their salary, however unimportant for them, is paid for by



■ Organic

he word organic has been applied to crops grown without the aid of chemical fertilisers or pesticides at least since the early 1940s. Though in the developed world it still only produces a tiny proportion of the food we eat, many countries have regulations defining what can be described as organic produce. The word has become so established that it has almost come to mean "natural; unadulturated", a significant development in its history. Its source is the Greek organon, which comes from the same root as erg, "work", and which had the linked meaning of "implement, instrument, tool", that is, something one works with. It could also refer to a part of the body in the restricted sense of one that's an instrument to do something with. It's the name given to Aristotle's treatise on logic (in the sense of the instrument of all reasoning). The word was used in its Latin form by Francis Bacon in 1620 as the title of his philosophical treatise Novum Organun, "new instrument", which set out a new set of principles for scientific investigation. In late Latin and in French organ could mean a wind instrument, perhaps because the larynx, being the source of human speech, had a special status as one of the functional parts of the body. For example, where in the King James bible of 1611, Psalm 150 says "Praise him with stringed instruments and organs", organ meant a wind instrument. But by the 1660s it had come to mean particularly the wind-driven instrument made of a complex set of pipes which is what we now understand by the word organ. From its application in Greek to any of the specialised functional parts of living things, our word organism was coined for the whole body, seen as an assemblage of organs (a closely-related word is organisation, originally "the condition of being ordered as a living being").

India has seen its own explosive rise of business conglomerates, and the attendant suspicions that they inevitably evoke among the ordinary people. The Ambanis in general and Mukesh Ambani as the head of the Reliance Industries group in particular are among the top houses that get named often, either as examples of high achievement or as a class that controls more than it should. Now, even Ambani has spoken of the uneven benefits of economic reforms, saying that "the disparity is neither acceptable nor sustainable.' While celebrating growth and announcing that "India's time has come," the business leader wrote recently of the "common goal" of Mahatma Gandhi's Antyodaya or the idea of welfare and well-being

reaching the last person. Gandhi and unbridled GDP growth appear to meet in this vision, offering a unique combination of Antyodaya and Antilia, the famously chronicled \$2bln family skyrise where the Ambanis stay in luxurious opulence.

There is of course a fundamental clash between the two but can the gulf be bridged by the "Ambani thinking," loosely a metaphor for development models that have reached us where we stand today and are being pushed on a faster track? Or is Gandhi being appropriated, his commanding ideas and powerful lexicon subsumed by the offer of delivering on the ends if you allow the business class the luxury of using any means? The

questions have to be seen in the light of the nexus between the State and big business, each protecting, supporting and enabling the other, all of it entrenched and regularised within the democratic framework.

Gandhi of course was not against wealth creation. Yet, he would use the word "thieves" for those keeping anything more than their need. In Gandhi's words: "I am no socialist and I do not want to dispossess those who have got possessions: but I do say that, personally, those of us who want to see light out of darkness have to follow this rule ... If somebody else possesses more than I do, let him. But so far as my own life has to be regulated, I do say that I dare not possess anything which I do not want." (Selections from Gandhi by Nirmal Kumar Bose)

In this approach, Antilia and Antyodaya cannot go together. Yet, damning the former cannot create space for the latter. In a complex subject that spans the moral, the material and indeed the spiritual, it is best to steer clear of mixing two ingredients that are inherently unmixable. The cocktail that emerges will please no one, however enticing the colour or the promise. In fact, each standing on its own is heady stuff – one a model of instant gratification focused on the outer and the other a model of long-term fulfilment for

The thrills of modernity, the promise of a GDP-delivered nirvana, and an economy built on endless consumption makes for a captivating ride. It has given us jobs (for a few) and selective infrastructure upgrades on which ride fast cars, instant cash and super AMOLED screens full of AI-driven ads. It comes with its side effects - anxiety, stress, frequent crashes, plunder of the environment, rising inequality and violence embedded in every aspect of living. This is heady alright, if the nation were to argue that we never had enough and now we get all the stuff at home, ordered on Amazon

On the other hand, stands the combination of a bania and a sage in the personality of Mahatma Gandhi, resolute in his thinking that the above is a path to doom. This is the path of self-emancipation, of inner growth, of character that lives with the ideals of Narsinh Mehta's eternal song, 'Vaishnava jana to tene kahiye, je peed parayi jaane re" (Only that person is the lover of the Lord, who understands the pain of another). Here is the original minimalist, long before a movement by that name began anywhere. This is heady in a deeper sense, and meant only for the true seekers, not for the faint hearted

Across the world, the perils of the GDP ride are becoming clearer

even to those uninitiated in the lessons of Mahatma Gandhi. Climate change, the pollution in our oceans, the rising frequency of pandemics and growing inequality seen even in the most 'de veloped' of nations mark the bitter harvest of which Gandhi had warned long, long ago.

The truth is that India turned away from the path of Mahatma Gandhi not today but long, long ago. The policies of privatisation and liberalisation in the 1990s meant a sharper turn in that original direction that we set for ourselves. With a new party at the helm, even as the original policies of the Congress come in for criticism, the turn in the direction is the same - sharper, faster and further away from Mahatma Gandhi, now overtly so.

There was a time it was said that the policies of liberalisation were dictated by the IMF and the World Bank. Then, what was dictated became the native language and we immersed ourselves in it and took to it seamlessly. In that sense, Dhirubhai Ambani's original words: "To think small is unbecoming of an Indian" celebrated material dreams that were always there but never came to be articulated in those words.

Now, as the Western model totters, as the world searches for a new path, it is India that is caught in a dark alley from which it will find it hard to come out unscathed

Across the globe, the turn against the way the modern-day growth model works is gaining momentum. As the Nobel laureate Joseph Stiglitz wrote in the IMF's Finance & Development issue just when the pandemic struck: "We have an economy rife with market power and exploitation...We need a comprehensive rewriting of the rules of the economy."

For starters, 2050 sector, the transition away from creasingly embracing the effort to achieve net-zero greenhousegas (GHG) emissions by 2050. Some are already implementing portfolio measures and incorporating climate factors into their decisionmaking. The United Nations-convened Net-Zero Asset Owner Alliance has already welcomed 46 members, comprising pension funds and insurance companies representing some \$6.7 trillion in assets under management (AUM).

The steps taken this decade will be decisive as regards hitting the mid-century target. Of the Alliance's members, 23 have publicly issued GHG-reduction targets for 2025, which means they are committed to acting immediately. The remaining five members that are required to set targets this year will declare similar interim goals soon. Net-zero initiatives are also being established in the investment-management and banking industries. representing \$43 trillion and \$37 trillion in AUM, respectively. And yet, sovereign wealth funds (SWFs) -representing AUM totaling around \$10 trillion - are conspicuously absent, even though some are owned by governments that have adopted ambitious climate objectives.

agreements, GHG emissions are measured at the country level. which understates the potential climate impact of countries with large foreign-asset holdings. For example, the Norwegian SWF's total asset holdings are three times the size of Norway's economy, and its equity-portfolio carbon emissions are around twice the country's own total emissions. Norway is not alone. A recent re-

port by the International Forum of Sovereign Wealth Funds (IFSWF) shows that SWFs around the world are lagging behind. About threequarters report having less than 10 per cent of their holdings in climaterelated strategies, while only 14 per cent have made divestment decisions related to climate or environmental targets. While 24 per cent of SWFs consider climate action part of a broader ESG (environmental, social, and governance) framework, only 12 per cent have an explicit climate-change policy.

The governments of countries that have SWFs should view the UN Climate Change Conference in Glasgow (COP26) in November as an opportunity to commit fully to the net-zero programme.

There are several reasons why

net-zero targets are becoming a mainstream expectation for all large institutional investors. If a government chooses not to commit its SWF to this goal, it will be free riding on the growing share of the private financial sector that is already going green – a paradox of climate finance if there ever was one.

Moreover, it makes little sense for governments seeking to be consistent in their climate commitments to separate SWF portfolio emissions from overall climate obiectives. The domestic focus of international climate agreements should not be interpreted as a free pass for emissions associated with foreign investments. Instead, governments should be using their SWFs' financial weight to drive climate action internationally.

Last but not least, the transition $% \left(-\frac{1}{2}\right) =-\frac{1}{2}\left(-\frac{$ to a low-carbon economy represents the biggest investment opportunity in decades. Shifting from 'brown' to 'green' will require changes on the scale of another industrial revolution; those who create new markets or enter them early stand to reap massive returns.

Because many countries with SWFs have historically been heavily dependent on their oil and gas fossil fuels exposes them to larger economic risks. But governments can mitigate these risks by aligning their SWFs with climate targets. A total portfolio approach would enable these governments to start delinking domestic economic growth from SWF returns, thereby enhancing the robustness of the economy as a whole. For SWFs, as for other institutional investors, staying on the sidelines of the global climate-mitigation effort is no longer an option. But nor is it enough to focus solely on climate-related portfolio risk while ignoring a fund's broader climate impact.

Countries like France, Ireland, New Zealand, Norway, Singapore, and the United Arab Emirates are well placed to lead a global SWF movement toward net-zero commitments at COP26. If they do, other funds with large investment teams and sophisticated operations may soon follow, and those with fewer resources would, one hopes, be close behind them.

Sir, The disengagement of Indian and Chinese troops at Gogra in eastern Ladakh is a welcome step. The disengagement is indicative of the fact that both countries are determined to reduce tension along the border. It is a fact that antagonism between the two countries has not produced anything positive for either of the two. By encroaching on Indian territory China could irritate New Delhi but could not achieve anything more

Taking advantage of these, drug ddicts, alcoholics and criminals have made the site as their meeting place. It is alleged that criminals chose this spot to prepare blueprints for their activities. Peddlers carry out their trade from here. All such activities often end up in group clashes.

Yet, police have been allegedly looking the other way. "There is hardly any police patrolling in the area. As a result, all sorts of criminal activities, including snatching, loot and even rape are increasing there," observed some locals.

It is worth mentioning here that a gun fight took place between miscreants and the police in 2018. Acting on a tip-off that miscreants had congregated at the spot to prepare a blueprint to loot a petrol pump, the police conducted raid, leading to an exchange of fire. Notorious criminal Bilu Khan suffered injuries in the encounter.

In a recent case, miscreants robbed two youths of their mobile phones and cash, August 6. Two days later, August 8, some youths in inebriated state were responsible for a series of accidents near the spot. Locals overpowered the youths and later handed them over to police.

With such incidents taking place regularly, local residents have urged the administration to take steps to make the spot tourist-friendly.

They demanded tight security and complete ban on tourists' entry into the reservoir site. Or else, local residents and tourists would stop visiting the spot, they said.

A senior police officer refuted allegations that there is no patrolling at the site. "Police patrolling is there at the dam site. Police rush to the spot whenever they receive any complaint from the area. But, it is not our lookout to see who are going into the restricted area and what they are doing there," the officer said on the condition of

Uttar Pradesh who worked as project manager at an under-construction site in Angul town, and his three friends visited the reservoir site, August 8.

There they took bath and while taking selfies, Avinash' feet slipped and he went missing in the reservoir. On receiving information about the incident, Fire personnel reached the spot and rescued him. He was rushed to Angul DHH, but the doctors there declared him "brought dead".

Farmers here rely on rituals for rain forecast

Chhendipada, August 9: India Meteorological Department's forecast regarding rain always holds great significance for the farmers. But, not for many farmers in Bagadia village of Chhendipada block in Angul district. They have their own tradition to forecast the amount of rainfall they would receive.

Strong believers in their 200year-old tradition, the villager here say that they get accurate information about rainfall from a small earthen pot, which they call 'Kandi' after their village deity. They start their agricultural activities following their deity's divination. 'There are cases of farmers fac-

ing problems after relying on the IMD's weather forecast. But, the information received from the pot has never deceived us. This is why we contact our relatives in Bagadia village every year at the onset of Shravan month to know about the amount of rainfall for the entire season," claimed Subash Majhi, a farmer from Kanalei village.

According to the farmers of Bagadia village, they perform a ritual on the second day of Krushna Paksha (waning phase of a lunar month) of *Shravan* month every year. There is dense jungle of 'ankul', 'peepal' trees and 'bamboo' to the north of Budhadhipa



Sahi, where they perform the ritual. The priest is a member of the 'Kandha['] community. After putting ghee, honey and jaggery together in an earthen pot, they cover it securely and bury it under the ground.

At the same time, the pot buried last year is dug out with the help of a wooden crowbar. They untie the cover and look into it. If the pot is full of water, it indicates they will get enough rain that year. But if the pot is found filled with sand, they understand that harvest will be good from low lands. If the pot has something in semi-muddy form, they believe paddy in half of fields will destroy. They know they will

have drought if the pot contains dry sand and dust.

Sometimes, roots are seen inside the pot. It says they will experience seedling death (Gaja Marudi). If insects are found, it means their paddy plants will suffer pest attack. If the pot contains only ghee, they assume there will be delay in getting rains and consequently delay in starting agricultural activities.

People fearing that bad omen may visit upon don't go near the jungle, let alone the place of worship. They believe that the changes that occur inside the pot are due to the

intervention of 'Kandi' deity. In addition to farmers from sev-

eral villages under Chhendipada block, people from different areas in neighbouring Redhakhol and Naktideul blocks swear by this tradition even in this age of science. Some call this 'Kaduali Puja' as

This year, there only ghee was found in the pot. It foretells agricultural activities will get delayed in the area due to delay in rains.

"It is Shravan month now. During this time, the fields should have had enough water to start agricultural activities. But the situation is just the opposite. The fields do not have water. This year, there was ghee only in the pot. So we have already got the message that there will be delay in getting adequate rain this year. However, we have started plantation in some fields," said Dushmant Behera, a farmer from Bagadia village.

Echoing the same belief, Ramesh Tripathy, another villager from Bagadia village said, "The tradition is 200 years old. The farmers have deep faith in this tradition even in this age of science because they get accurate information.'

When contacted, Khirod Dehury of Bagadia village said, 'We have been worshipping the deity for generations. 'Kandi' worship is performed to know about the weather conditions for agriculture."

Terrorists kill BJP sarpanch, his wife in Valley

Srinagar, August 9: Two Lashkare-Taiba terrorists Monday barged into the house of a BJP sarpanch in Jammu and Kashmir's Anantnag district and sprayed him and his wife with bullets, taking the number of saffron party workers killed in the valley this year to four.


The incident, according to the police, took place at 4 pm in Lal Chowk area as the two terrorists entered the rented accommodation of Ghulam Rasool Dar and fired indiscriminately at him and his wife Jawhara Begum, officials said.

The BJP leader and his wife received critical gunshot injuries and were immediately shifted to a hospital, where they were declared brought dead, police said.

Immediately after the incident, Inspector General of Police (Kashmir range) Vijay Kumar reached the spot to have a firsthand assessment of the situation. The IGP said that "two motor-

cycle-borne terrorists of banned LeT outfit were involved in this barbaric terror incident.'

The couple were provided a secured accommodation at the Snow



Cap Hotel, Kulgam, and both stayed there for a short period, but they had been continuously insisting to move to their house at Anantnag Town and also submitted an undertaking in this regard, police

"On their request, they were al-

lowed to stay at the house in Anantnag. He was also provided with one PSO who, however, was found absent from duty at the time of incident. The said PSO has been placed under suspension," a statement from the police said.

Renaming Khel Ratna is a political game: Sena

Mumbai, August 9: The Shiv Sena Monday claimed the Centre's decision to rename the Rajiv Gandhi Khel Ratna Award after hockey legend Dhyan Chand was not the people's wish, but a 'political game'.

An editorial in the Sena mouthpiece 'Saamana' also asked what was Prime Minister Narendra Modi's contribution to cricket that a stadium (in Ahmedabad) was named after him.

Monday, the editorial in 'Saamana' said late Prime Ministers Indira Gandhi and Rajiv Gandhi were victims of terror acts. There could be political differences with leaders like them, but their sacrifices towards the country's development cannot be mocked, it opined.

"Changing the name of the Rajiv Gandhi Khel Ratna Award to Major Dhyan Chand Khel Ratna Award is not the people's wish, but a political game," it claimed.

"Major Dhyan Chand could have been honoured without insulting Rajiv Gandhi's sacrifice. But, the country has lost such tradition and culture. It would have made Dhyan Chand sad in heaven," the

NIA keeps up raids against Jamaat-e-Islami

Srinagar, August 9: The National Investigation Agency (NIA) conducted raids against members of the banned Jamaat-e-Islami (JeI) in the Kashmir valley for a second day Monday in connection with a terror-funding case, officials said. NIA sleuths, along with police

and the CRPF personnel, Monday carried out searches at five places in north Kashmir's Bandipora, a day after raids at 56 locations across the 10 districts of Kashmir and four -Ramban, Kishtwar, Doda and Rajouri -- of the Jammu province.

"During the searches, various incriminating documents and electronic devices were seized from the premises of the suspects," an NIA spokesperson said.

The raids on the premises of office-bearers of the proscribed outfit, its members and also the offices of trusts purportedly run by the JeI were conducted more than two years after the sociopolitical and religious group was banned by the Centre under anti-terror law, the



Unlawful Activities (Prevention) Act. In February 2019, the Centre announced to ban the JeI for five years on the grounds that it was 'in close touch' with militant outfits and was expected to 'escalate secessionist movement' in the erstwhile

A notification banning the group under the UAPA was issued by the Ministry of Home Affairs after a high-level meeting on security chaired by Prime Minister Narendra Modi.

Hundreds of JeI activists were arrested in a major crackdown across Jammu and Kashmir following the ban, which came just months ahead of the abrogation of the special status of Jammu and Kashmir, and its division into two union territories in August 2019.

The NIA said a case was registered February 5, 2021 in pursuance of an order from the Ministry of Home Affairs relating to separatist and secessionist activities of the JeI despite its proscription February

It said the members of the organisation have been collecting funds domestically and from abroad through donations particularly in the form of 'Zakat, Mowda and Bait-ul-Mal' purportedly to further charity and other welfare activities but these funds are instead being used for violent and secessionist ac-

"The funds raised by the JeI are also being channelised to proscribed terrorist organisations such as Hizb-ul-Mujahideen (HM), Lashkar-e-Taiba (LeT) and others through well organised networks of JeI cadres. The JeI has also been motivating impressionable youths of Kashmir and recruiting new members (Rukuns) in J&K to participate in disruptive secessionist activities," an NIA spokesperson said Sunday

Mehbooba bats for 'self-rule' formula to solve Kashmir issue

Mumbai's ugly duckling Hip-hop making waves at India's largest slum will soon soar to skies

Mumbai, August 9: The ugly duckling of Mumbai's underbelly -- century-old clusters of BDD Chawls -- where Mahatma Gandhi spent a night among the 'Mehtar Samaj (sweepers) 84-years ago -- is all set to don a new 'avatar' with Asia's biggest redevelopment finally kicking off, officials said.

After three decades of hiccups, delays, litigation, political upmanship and other speedbreakers, Chief Minister Uddhav Thackeray performed the groundbreaking ceremony last week for the mega-redevelopment project estimated to cost around Rs 20,000-crore.

The first bulldozers started razing the historic but crumbling eyesores, built (1921-1924) by the erstwhile 'British Development Department' (BDD), conceptualised by the then Governor of Bombay, Sir George Lloyd, for middle-class mass-housing - identical, matchbox structures, similar to those built by erstwhile Communist countries.

"A total of 207 old buildings with

160-sq.feet facing chawls (tenements) a passage of upto 20-feet width, common water supply, bathing and toilet areas, spread across 93 acres in Worli, Naigaum, NM Joshi Marg and later, Sewri, shall be rebuilt," an excited Akhil BDD Chawl Bhadekaru Hakk Sanrakshan Samiti (ABCBHSS) General Secretary Kiran Mane who was born and spent his entire life here - told IANS.

Each of the 17,000 families, mostly mill-workers, eked out a miserable existence - some cramped as many as 15-20 people per tenement in the ground-plus-3-storied buildings with 20 chawls on each floor.

Over the next few years, they will move to some 32 swank towers in 500-sq.feet 2-BHK ultra-modern flats with top amenities, bringing a sea-change to their lives.

Ex-Shiv Sena legislator Sunil Shinde, who spent years on the project groundwork, said it will be supervised by Maharashtra Housing & Area Development Authority (MHADA), and shall be completed in eight years, and the first phase expected to be ready within three years.

Mumbai, August 9: After India's largest slum defeated the pandemic, some of its young residents pulled out their phones to write, shoot and release a triumphant rap video. "At first we were afraid, what

would happen to us? But we stood with the doctors... now it's your turn," rapped the young men in the video. "We Did It" - "Kar Dikhaya" in

Hindi-showcased new talent and won acclaim from celebrities, but its creators' abiding goal was to fight the stigma dogging this densely populated corner of Mumbai.

The Dharavi slum is home to about one million people, many of whom live in single-room shanties and share communal toilets.

Its alleys have long been associated with filth and disease despite its remarkable success in the battle against COVID-19, and its residents battle constant discrim-

But Ayush Tegar Renuka, one of the star students of the Dharavi Dream Project hip-hop academy, told AFP he feels "so proud" of belonging to the community.

The Dharavi shown on TV channels and the real Dharavi are very different places," the 16-yearold said. Ayush began breakdancing three

ears ago, persevering in spite of his widowed mother's pleas to give up a pursuit she feared would result in a trip to the hospital. She was not alone. Many par-

ents were initially reluctant to enrol their children in the school's free classes, dismissing hip-hop as dangerous, a distraction from homework or simply a waste of time.

The Dharavi Dream Project's co-founder Dolly Rateshwar was determined to change their minds.

The daughter of a Hindu priest, Rateshwar was nervous about venturing into the neighbourhood, but the teenagers she met struck a chord with her.



"I was raised in a very conservative family... I never knew there was a bigger world out there," said the 38-vear-old. "And I was worried that these kids might lose out on life because they didn't know the

possibilities open to them." The school opened its doors in 2015, offering free classes in breakdancing, beatboxing and rapping to approximately 20 students, with digital media start-up Qyuki -Rateshwar's employer - and US entertainment titan Universal Music Group footing the bill.

As the project won praise from musical icons such as Oscar-winning composer AR Rahman, it rapidly expanded, with young students like Joshua Joseph - now better known as MC Josh – using

hip-hop to tell their stories. If Black rappers in the United States could shine a light on racism,

he reasoned, hip-hop could do the same for India's glaring inequality and mistreatment of marginalised communities. "My confidence level was zero before I started to rap," the 21-year-old told AFP. "The school changed my life."

When COVID-19 arrived, the rapper's income collapsed overnight as Dharavi was put under a stringent months-long lockdown.

Mumbai authorities quickly realised that the slum held the key to defeating the pandemic and launched "Mission Dharavi" - aggressively sanitising communal toilets, running daily "fever camps" to check for symptoms, repurposing wedding halls as quarantine facilities, and asking residents to stay home. By the end of June 2020, Dharavi had recorded just 82 deaths, a fraction of Mumbai's more than 4,500 fatalities. Like the slum, the

school's staff also refused to be cowed by the virus, switching to online classes soon after the first wave of infections hit last year.

As the pandemic ground on, Rateshwar realised that the academy could expand its reach even further, and broadcast an invitation on Instagram for anyone, anywhere, to join their classes.

They received 800 responses in the first 24 hours.

A year on, the school hosts 100 students who attend every online session - half from Dharavi itself - and 300 others who pop in occa-

sionally, including from overseas. But Rateshwar's focus remains firmly on students from the Mumbai slum, on making sure their voices are heard and their future prospects secured.

"Obviously everyone wants to become a superstar but... I also try to tell them about alternative careers in the music industry, as artists' managers, or jobs in social media," she said.

"Most of all, I want them to stand


For 21-year-old teacher Vikram Gaja Godakiya, who learned breakdancing from YouTube videos, the school means much more than a steady paycheque.

"People have always been unfair to Dharavi," he told AFP, describing how the pandemic had made employers increasingly reluctant to hire slum-dwellers.

When Godakiya started breakdancing in secret nine years ago, he never imagined he would be able to do it for a living. "Breaking has given my life purpose," he said. "I want my students to know that $\overline{}$ they can do anything if they give it their 100 percent.'



New Delhi, August 9: The defence ministry Monday said it did not have any transaction with the NSO Group, the developer of military-grade spy software Pegasus that is in the eye of a huge political firestorm following the snooping controversy allegedly involving the programme.

The brief written statement on the NSO Group came from Minister of State for Defence Ajay Bhatt in response to a question in Rajya Sabha by CPI(M) member V Sivadasan.

"Ministry of Defence has not had any transaction with NSO Group Technologies," the minis-Sivadasan, as part of a num-

ber of questions on expenditure by the defence ministry, also asked whether the government had carried out any transaction with the NSO Group Technologies.

The opposition parties have been demanding a discussion on

the Pegasus issue in parliament, claiming it has national security implications.

IT and Communications Minister Ashwini Vaishnaw had dismissed media reports on the use of Pegasus software to snoop on Indians, saying the allegations levelled just ahead of the Monsoon session of Parliament were aimed at maligning Indian democracy.

In a suo motu statement in Lok Sabha, Vaishnaw had said that with several checks and balances being in place, "any sort of illegal surveillance" by unauthorised persons is not possible in India.

The controversy erupted after an investigation by a global media consortium based on leaked targeting data claimed evidence that the military-grade malware from the NSO Group was being used to spy on politicians, journalists, human rights activists and others.

In his reply, Bhatt also said that an allocation of ₹4,04,364 crore was made to the defence ministry in the budget estimate (BE) stage in 2018-19 and the expenditure made during that fiscal by the ministry was ₹ 4,03,459

The minister said that an outlay of ₹4,31,010 crore was made at the BE stage in 2019-20 while expenditure against the allocation was ₹4,51,902 crore.

In 2020-21, the defence ministry incurred an expenditure of ₹4,85,726 crore as against an allocation of ₹4,71,378 crore at the BE stage, he said. The percentage of allocation

to the defence ministry out of the total budget of the central government for 2018-19 was 16.56 percent while it was 15.47 percent in 2019-20 and 15.49 percent in 2020-21, according to the minister. Bhatt said an amount of ₹45,705

crore was spent in 2018-19 on procurement from foreign sources while the figure for 2019-20 was 47,961.47 crore.

The ministry spent ₹53,118 crore in procurement from foreign countries in 2020-21.

Amid ruckus, 3 Bills passed in LS

New Delhi, August 9: The government Monday pushed through six bills, three of which were passed, in Lok Sabha despite the unrelenting Opposition protests over Pegasus snooping row and other issues, prompting the Congress to hit out at the treasury members for "violating" constitutional and democratic norms.

However, Lok Sabha also witnessed some rare moments of opposition members withdrawing their protests, which have been continuing since the beginning of the Monsoon Session, and returning to their seats when the Constitution (One Hundred and Twenty-Seventh Amendment) Bill, 2021 to restore the states' right to identify Other Backward Classes was introduced.

Members of the Congress, DMK and the BSP among others supported the bill even as they slammed the government over the manner in which it has pushed forth its



legislative agenda amid disruptions and ruckus. The House should be in order during the passage of a constitutional amendment bill as it requires mandatory division of votes, and no party will like to be seen opposing a bill that seeks to protect the interests of the OBCs.

However, all other bills were introduced and passed amid noisy protests from opposition members. The bills that were passed amid the din were -- The Limited Liability Partnership (Amendment) Bill 2021, The Insurance and Credit

Corporation Guarantee (Amendment) Bill 2021 and The Constitution (Scheduled Tribes) Order (Amendment) Bill 2021. RSP's NK Premachandran said

The bench, also comprising justices Vineet Saran and Surya Kant, further said: "Apart from the specific incident in question, this Court had also taken up this matter to take note of attempt(s) to resolve the alarming situation in the country where judicial officers and lawyers are being pressurized and intimidated by threats of, and/or actual violence.

"There is, therefore, an institutional need to create an environment where judicial officers feel safe and secure". The larger aspect, related to threats to judicial officers and lawyers, would be taken up with a pending plea of 2019 on the issue and ordered that the replies be placed on record, the top court said.

On August 6, the CJI-led bench had expressed concern over the incidents of judges getting threats and abusive messages and had said that Intelligence Bureau (IB) and the CBI are "not helping" the judiciary at all and there is no freedom to a judicial officer to even make such complaints.

It had said there are several criminal cases involving gangsters and high-profile persons and at some places, judges of the trial courts as well as high courts are being threatened not only physically but also mentally through abusive messages on Whatsapp or Facebook.

Prior to this, the top court had July 30 taken suo motu cognizance of the unfortunate sad demise of the judge in gruesome incident and had sought a status report within a week from Jharkhand's Chief Secretary and the DGP on probe.

The Jharkhand police had arrested two persons, auto driver Lakhan Verma and his helper-Rahul Verma, in connection with the case.

Tehran, August 9: Iran's new President Ebrahim Raisi Monday told his French counterpart Emmanuel Macron that negotiations with world powers to revive the 2015 nuclear deal must guarantee Tehran's "rights"

"In any negotiation, the rights of the Iranian people must be upheld and the interests of our nation ensured," Raisi said in an hour-long phone call, according to the Iranian presidency's website. This is Raisi's first reported call with a western leader since taking office last week.

Raisi took over from Hassan Rouhani, a moderate whose landmark achievement during his twoterm presidency was the 2015 nuclear agreement, which provided international sanctions relief in exchange for limitations on Tehran's nuclear programme.

With the new terminal, the airport is expected to meet an annual handling capacity of nine million passengers and 80,000 metric tonnes of cargo, handling more than 75 per cent of the passenger flow of all airports in Tibet, the report said.

Once-in-50-yr heat waves now happening every decade: UN Report

New York, August 9: Extreme heat waves that previously only struck once every 50 years are now expected to happen once per decade because of global warming, while downpours and droughts have also become more frequent, a UN climate science report said Monday.

The report found that we are already experiencing those effects of climate change, as the planet has surpassed more than 1 degree Celsius in average warming. Heat waves, droughts and torrential rains are only set to become more frequent and extreme as the earth warms further.

It is the first time that the UN Intergovernmental Panel on Climate Change (IPCC) has quantified the likelihood of these extreme events in a wide variety of scenarios.



The report found that once-ina-decade heavy rain events are now 1.3 times more likely and

6.7% wetter, compared with the 50 years up to 1900 when major human-driven warming started

Previously once-in-a-decade droughts could happen every five

Scientists emphasised that these effects of climate change are already here, with events like the heat wave in the US Pacific Northwest killing hundreds in June and Brazil currently experiencing its worst drought in 91 years.

"The heat wave in Canada, fires in California, floods in Germany. floods in China, droughts in central Brazil make it very, very clear that climate extremes are having a very heavy toll," said Paulo Artaxo, a lead author of the report and an environmental physicist and the University of Sao Paulo.

The future looks even grimmer, with more warming meaning more frequent extreme events.

Heat waves show stronger increases in frequency with warming than all other extreme events.

Twice in a century heat waves could happen roughly every six years with 1.5 degrees Celsius of warming, a level which the report says could be surpassed within two decades.

Should the world become 4 degrees Celsius hotter, as could happen in a high-emissions scenario, those heat waves would happen every one to two years.

Carolina Vera, another report author and a physical climate scientist at University of Buenos Aires and Argentina's main agency for science research (CONICET), said there is also an increasing likelihood that multiple extreme weather events could happen at the same time.

For example, extreme heat, drought and high winds - conditions that could feed wildfires are more likely to happen at the same time.

The IPCC has a medium or high-

level confidence that many important agricultural regions around the world will see more droughts or extreme rain. That includes parts of Argentina, Paraguay, Bolivia and Brazil that are major growers of soybeans

and other global commodities. "It is scary, sure, with the risk that fires, heat waves, droughts will affect humans in the form of weather and food insecurity, energy insecurity, water quality and health mainly in poor regions," said Jose Marengo, a climatologist at the Brazilian Science Ministry's disaster monitoring center. Marengo

was not involved in the IPCC report. For example, regions that are already prone to drought are likely to experience them more frequently, including in the Mediterranean, southern Australia, and western North America, said Friederike-Otto, IPCC author and climatologist at University of Oxford.



India may slash import tax on EVs after Tesla lobbying

New Delhi, August 9: India is considering slashing import duties on electric cars to as low as 40%, two senior government officials told Reuters, days after Tesla Inc's appeals for a cut polarised the country's auto industry. For imported electric vehicles (EVs) with a value of less than \$40,000 - including the car's cost, insurance and freight the government is discussing slashing the tax rate to 40% from 60% presently, the officials told Reuters.

For EVs valued at more than \$40,000, it is looking at cutting the rate to 60% from 100%, they said. "We haven't firmed up the reduction in duties yet, but there are discussions that are ongoing," one of the officials said.

India is the world's fifth-largest car market with annual sales of



about 3 million vehicles but the majority of cars sold are priced below \$20,000. EVs make up a fraction of the total and luxury EV sales are negligible, according to industry estimates.

Tesla, in its pitch to the government - first reported by Reuters

in July, argued that lowering import duties on EVs to 40% would make them more affordable and boost sales. This triggered a rare public debate among automakers over whether such a move would contradict India's push to increase do-

Even so, the government is in favour of a cut if it can see companies such as Tesla providing some benefit to the domestic economy - manufacture locally, for example, or give a firm timeline on when it would be able to, one of the officials said.

"Reducing import duties is not a problem as not many EVs are imported in the country. But we need some economic gain out of

that. We also have to balance the concerns of the domestic players," the official said.

Tesla CEO Elon Musk said on Twitter last month that a local factory in India was "quite likely" if the company was successful with vehicle imports but taxes on them are high. The second official said that since the duty cut is being considered only for EVs and not other categories of imported cars, it should not be a concern for domestic automakers - that mainly manufacture affordable gasoline-powered cars.

India's finance and commerce ministries, as well as its federal think tank Niti Aayog, chaired by Prime Minister Narendra Modi, are discussing the proposal and all stakeholders will be consulted. the person added. Both sources did not want to be identified as the

New Delhi, August 9: The Supreme Court Monday declined to entertain a plea by e-commerce giants Amazon and Flipkart, saying they must face an inquiry by Competition Commission of India (CCI) for anti-competitive prac-A bench headed by Chief Justice

NV Ramana and comprising justices Vineet Saran and Surya Kant said: "Big organisations like you (Flipkart and Amazon) should volunteer for inquiry... Inquiry has to be conducted.

The bench declined to interfere with the orders of the Karnataka High Court, which refused to interfere with the preliminary enguiry ordered by the CCI into their alleged anti-competitive practices.

"Carefully perusing the material available on record, we see no reason to interfere with the impugned orders passed by the High Court of Karnataka dismissing the Writ Appeals of the petitioners. The Special Leave Petitions are. accordingly, dismissed," said the top court in its order.



Senior advocate AM Singhvi, appearing for a petitioner, submitted that time to reply to the notice issued by the Office of the Director General, CCI is going to expire August 9 and sought extension of time.

The top court, in its order, said, "Taking into consideration the request made by the learned senior counsel, time to reply to the notice is extended by a further period of four weeks from today. It is made clear that no further extension of time would be granted for the purpose. Consequent upon dismissal of the Special Leave Petitions, all the pending applica-

The e-commerce companies had moved the apex court challenging the Karnataka High Court order. The Karnataka High Court, July 23, dismissed the plea by Amazon and Flipkart against a probe initiated by the CCI for the alleged violation of competition law.

A division bench of Justices Satish Chandra Sharma and Natraj Rangaswamy passed the order on a batch of appeals moved by the ecommerce companies challenging a June 11 order passed by a single judge of the high court.

The bench noted that by no stretch of imagination, can the inquiry can be quashed at this stage and the appellants shouldn't be afraid of investigation by the CCI. The bench said: "In the considered opinion of the court, appeals filed by appellants are devoid of merit and deserved to be dismissed..."

Amazon had moved Karnataka High Court against a CCI order which had called for a Director General level investigation into allegations of anti-competitive conduct in the online sale of smartphones on its platform.

China's economic risks build as delta cases spread

Beijing, August 9: China's economic risks are building in the second half of the year, with growth set to slow while inflation pressures are picking up, clouding the outlook for central bank support.

A report Monday showed factory-gate inflation surging again to 9% in July as commodity prices climbed, while core consumer prices -- which strip out volatile food and fuel costs -- rose the most

At the same time, the spread of the delta variant is threatening China's outlook, with Goldman Sachs Group Inc. and JPMorgan Chase & Co. downgrading growth forecasts for the third quarter and full year, and predicting more central bank easing. The latest developments are another complication for policy makers, who have already pledged fiscal and monetary support for the economy in the second half of the year. While some economists see inflation risks limiting the room for central bank action, many see the uncertain growth environment as a bigger worry, with more easing likely to come.

"As the outbreak unfolds, China's domestic demand will weaken, and

the overall inflation pressure will decline," said Xing Zhaopeng, senior China strategist at Australia & New Zealand Banking Group Ltd. "Even though prices are still high, they won't have much momentum to rise further, so it won't create a huge constraint on monetary policy."

Chinese government bonds extended losses after the data, with the yield on the 10-year security rising 4 basis points, the most since January, to 2.85%.

Inflation, though, is unlikely to be a key consideration for monetary policy in the near term. The growth outlook -- under pressure from new outbreaks of the Covid-19 variant - will be a bigger concern that could prompt the People's Bank of China to do more to support the economy, following a cut in the required reserve ratio in mid-July.

The jump in factory-gate inflation was largely due to higher commodity prices, in particular oil and coal. Beijing has been trying to quell the surge in commodity prices by releasing inventory from the nation's strategic reserves, cracking down on hoarding and speculation, and ordering state-owned enterprises to limit their exposure to AGENCIES

VEHICLE RETAIL SALES BOOM YoY, SEQUENTIALLY IN JULY'

New Delhi, August 9: Low base, along with rising demand, pushed up India's overall vehicle retail sales on both sequential and yearon-year basis in July 2021. The data released by the Federation of Automobile Dealers Associations (FADA) showed a rise of 34.12 per cent during the month under review from the level of July 2020.

Vehicle retail sales rose to 15,56,777 units last month from 11,60,721 units sold during July 2020. On sequential basis, the FADA had reported an overall vehicle retail sales figure of 12,17,151 units for June 2021. However, last month's overall retail sales figure, when compared to July 2019 (per-pandemic) period, showed a decline of 13.22 per cent.

In July 2019, the overall vehicle retail sales stood at 17.93.882 units. On YoY basis, segment wise, registration of personal vehicles increased by 62.90 per cent to 2,61,744 units. Similarly, two-wheeler registration gained by 27.56 per cent to 11,32,611 units. Besides, tractor retail sales rose by 6.64 per cent to 82,388 units.

FADA President Vinkesh Gulati said: "With the entire country now open. July continues to see robust recovery in auto retails as demand across all categories remain high. The low base effect also continues

India witnesses addition of 16mn jobs in July: CMIE

Mumbai, August 9: India saw an addition of 16 million jobs in July mainly in the agriculture and construction sectors, however, the number of salaried jobs fell by 3.2 million in the same month, according to the Centre for Monitoring Indian Economy (CMIE).

"India saw an addition of a massive 16 million jobs in July 2021. But, all the additional employment provided by India in July was of poor quality. 18.6 million additional people were employed as small traders and daily wage labourers," CMIE's MD and CEO Mahesh Vyas said



in his analysis.

He said most of these were engaged in agriculture where 11.2 million additional people were employed. The number of salaried jobs, which are mostly better quality jobs, fell by 3.2 million in the same month, Vyas said.

"The big jump in employment seen in agriculture in July is a reflection of the increase in sowing activities. Monsoon has been playing truant this year. This has delayed kharif sowing activities. By the end of June 2021, kharif sowing was more than 20 per cent lower than it was in the corresponding period of 2020," Vyas observed.

By the end of July, he said, the sowing was less than 5 per cent lower than a year ago, that is 65.3 million hectares were sown during July compared to 19.5 million hectares in June.

This could be the reason why the sharp increase in employment in agriculture is seen, he for the first time ever. Furthermore. the MF industry added a whopping 50 lakh folios to reach 10.54

HOW SLEEPY SILIGURI IS TURNING INTO INT'L TRADE HUB

New Delhi, August 9: The sleepy town of Siliguri -- in the foothills of the Himalayas, which has typically served as a connecting junction for people of West Bengal travelling to their favourite hill station Darjeeling or Sikkim, is quietly getting a makeover. This town is soon going to become an international trade hub.

Siliguri is strategically located with easy access to Nepal, Bangladesh and China. That is not all. The critical Siliguri Corridor marks the 60 km long and 22 km "Chicken Neck" connecting the rest of India with the north eastern states.

"The chicken's neck is critical as it is not very far off from the Tibet

border. Therefore, security is a major concern," Bipul Chatterjee, executive director CUTS International said at a webinar on multi-modal transport organised by Atal Bihari Vajpayee Institute of Policy Research and International Studies.

Not only is the Siliguri corridor important for an inclusive transport-led growth for India's northeastern region, from the security paradigm, it is even more cru-

Security issues:

"Wedged between Bangladesh to the south and the west and China to the north, the Siliguri Corridor also links India to neighbouring Nepal, Bangladesh and Bhutan. By an advance of just 130 kilometres, the Chinese military could



cut off Bhutan, west Bengal and the north-eastern states of India. About 50 million people in north-east India would be separated from the country," the Lowy Institute in a

study said. The study noted that China, which already claims 90,000 square kilometres of territory in India's north-east, has been a perennial threat to the Siliguri Corridor.

"Last year's Chinese aggression and the Galwan Valley military standoff between India and China

is an immediate wake up call for New Delhi. This is a very critical stretch that needs focus -- it is important for connectivity which is related our northeast as well as the international borders," an analyst told India Narrative.

The Lowy Institute study added that strategically, the Siliguri Corridor is precisely the point where China could hit in case of escalating conflict between the two Asian giants. With such a twist, China could change the entire status quo along the Line of Actual Control (LAC) and put India under even greater pressure.

Siliguri's importance for trade and economic activities

The corridor is crucial -- as a gateway to the northeast. A report published by Dhaka Tribune pointed out that under the Bangladesh-Bhutan-India-Nepal Motor Vehicles Agreement (BBÎN-MVA), Siliguri will be a key point of the South Asian road network. Siliguri is also part of the Asian Highway Network, which is supposed to connect the BBIN countries with Thailand and Myanmar through Bangladesh. However, the rapid development

on this little stretch has made Bangladesh wary. "This network will connect Myanmar and Thailand to Northeast India [Assam, Meghalaya, Tripura and Mizoram] through Siliguri, circumventing Bangladesh." The newspaper quoted Khondaker Golam Moazzem, regional connectivity expert and research director at the Centre for Policy Dialogue (CPD) as saying.

RED CARPET FOR OLYMPIC HEROES

Gold medal winning javelin thrower Neeraj Chopra was the cynosure of all eyes in the ceremony at a five star hotel here, held a couple of hours after the seven podium finishers made their way out of the airport amid utter chaos.

At the felicitation ceremony, they were presented mementos and shawls by the minister. Both the bronzewinning men's hockey team and fourth-place finishing women's team cut cakes after arriving at the hotel.

While Chopra added the golden sheen to the campaign, the silver

medals came from weightlifter Mirabai Chanu and wrestler Ravi Kumar Dahiya.

The bronze medals, apart from the men's hockey team, were claimed by boxer Lovlina Borgohain, shuttler P V Sindhu, and wrestler Bajrang Punia.

"I am very happy to be back home. I knew India is very happy but after coming back here, to get this love first hand, it feels really nice. I would try to do my best for more such medals," Borgohain said.

Sindhu and Chanu did not attend the ceremony as they had arrived earlier and are currently at their home bases. "I only tried to give my best," said Punia, who fought through his semifinals without any protective gear on his injured knee.

Among those present on the occasion to felicitate the medal winners also included Union Minister of Law and Justice Kiren Rijiju,

Secretary (Sports) Ravi Mittal and Director-General of Sports Authority of India Sandip Pradhan.

"Tokyo 2020 was an Olympic Games of many firsts for India. The success of Team India at the Olympics is a reflection of how New India desires and aspires to dominate the world...even in sports," Thakur said.

"The Olympic Games showed us that with self-discipline and dedication we can be champions. Team India excelled and inspired while Indians cheered and celebrated all around.

"Truly sports is a great unifier as our athletes come from villages and cities, north to south, from east to west. Their journey is an incredible story of resilience and sporting excellence," he added.

There were many firsts in India's campaign, including the biggest ever 128-member athlete contingent, seven Olympic Medals, first

Olympic gold medal in an athletics event, two successive medals in consecutive Games by Sindhu, and a medal(bronze) by the Indian men's team in hockey after a gap of 41 years. Also, the women's hockey team achieved its best ever fourth place finish in the Games. "We will continue to support our sports persons and we endeavour to make India a sporting powerhouse." 

Lovlina eyes fresh start for Paris 2024



New Delhi, August 9: She had the time of her life in Tokyo with a medal on Olympic debut being the icing on the cake but Indian boxer Lovlina Borgohain says all of it is "done and dusted now" and she will start afresh in every aspect of her game for the Paris edition in 2024.

In an exclusive interview to this agency, Borgohain, who clinched the welterweight (69kg) bronze, spoke about the hardships she endured to get where she is, the joy of watching the triumph of human spirit at the Games and how her regular life now becomes much more eventful thanks to overnight fame.

The 23-year-old from the tiny Baro Mukhia village of Assam's Golaghat district became only the third Indian boxer to finish on the Olympic podium, joining two of the biggest icons in Indian boxing - six-time World Champion MC Mary Kom and the very decorated Vijender Singh.

She had vowed to touch upon her sacrifices only after her campaign was over and she did exactly that. "My first sacrifice was to stay away from my home for the past eight years and not being there for my family in times of their problems and watching from a distance. This is the biggest sacrifice," she said.

"Personally, I have sacrificed some desires that youngsters like me would have. For example not eating things that so many others of leave from training to concentrate on the game. And this continued for eight years," she revealed.

She does plan to take a holiday now that the job is done before getting down to prepare herself for a better medal in Paris in three years

'This Olympics is done and dusted. I will have to start afresh in every aspect, not just one," she said, when asked what changes she would make to her technique after the Tokyo campaign.

Would those changes include additional strength in her punches, which despite being accurate, seemed to be slightly low on power, especially in the semifinal loss to reigning world and now Olympic champion Busenaz Surmeneli of

"It is not like strength and conditioning hasn't been worked on. It was being done. You can say it was not up to the level of what it should have been ideally. I could work on my strength and conditioning only in the last four months of what was a four-year cycle.

"I was benefitted by the work but for something as big as Olympics, four months is not enough. Uss se kuch nahi hota, you need such work in a four-year cycle," she explained.

Indian team off to London

London, August 9: The Indian contingent Monday were off to London for the second Test against England at Lord's though replacement players, Suryakumar Yadav and Prithvi Shaw, remained in Nottingham to complete their quarantine.

It is learnt that the entire Indian contingent left for London at around 11 am local time after every member tested negative for RT-PCR. The second Test begins August 12.

Shaw and Suryakumar, who linked up with the squad in Nottingham August 3, will only complete their 10-day quarantine August 13, which means that they can only train from August 14 and will be available for selection from the third Test, starting August 25 at Leeds.

The nine-day gap between second and third Test will certainly give the duo ample chance to train and get match ready in case the team management feels the necessity of playing either of the two. **GANGULY IN ATTENDANCE**

With United Kingdom moving Indian travellers from red to amber list from last Sunday (August 8), **BCCI** president Sourav Ganguly is set to leave for London Tuesday to watch the second Test at Lord's

starting August 12. The move from red to amber list

means that any person who is fully vaccinated as per UK health authorities protocol will not need to serve the mandatory 10-day hard quarantine period which the likes of Shaw and Surva are currently serving, having arrived in a commercial flight from Colombo.

It is also expected that secretary Jay Shah, vice-president Rajiv Shukla. treasurer Arun Dhumal

might be in the UK to watch the Indian team play at some point during the series. "For any of the office bearers, it

was very difficult with 10-day hard quarantine in place as everyone's busy schedule goes for a toss. Since some of the travel protocols have been relaxed, especially the quarantine, our office bearers if they want can now attend.

Football team's camp in Kolkata after 15 years

New Delhi, August 9: The national football team's camp will be held in Kolkata after 15 years when initial 23 probables assemble at the 'City of Joy' August 15 to prepare for next month's international friendlies

The training sessions will start from August 16, the AIFF said in a statement. This will be the first time Blue Tigers' camp will be held in Kolkata as they assembled here for training way back in 2006 ahead of the FIFA World Cup Qualifier against Saudi Arabia.

The camp will be conducted under a secured bio-bubble adhering to the laid-down health parameters in wake of the current COVID-19 pandemic situation. The contingent will also be undergoing regular testing.

Tokyo, August 9: They'll always have Paris. That thought, full of promise, has been a lifebuoy for athletes to cling to as they coped, as best they could, with thickets of restrictions at the pandemic-hit Tokyo Games that severely crimped their Olympic experience — and left some hungry for more.

Barred from bringing family and friends with them to Japan, playing in empty arenas and not allowed to sightsee in Tokyo, some athletes found themselves daydreaming about the French capital's Olympic rendezvous in 2024.

If the coronavirus is tamed by then, the Paris Games could quickly become the party games. Already, there is palpable pent-up eagerness among athletes to make up for Tokyo and its disappointments. 'When Paris happens, I'll be

like, 'OK, wow, like this is a whole new energy. This is it," said U.S. Skateboarder Mariah Duran. "Maybe I had to have the appetizer before the whole meal.'

For now, Paris officials say they're betting that the pandemic will be over when their turn comes. "Normally, we'll be able to party," the city's mayor, Anne Hidalgo, said Sunday on French TV when Tokyo passed the baton.

But if the coronavirus is still ruining the best-laid plans, then Tokyo has served up a model of how to hold an Olympics even as infections are surging.

It pared the games down to their most essential ingredient: competition. No spectators. No city-wide partying. Very little mingling between Olympians and their hosts. Paris officials were watching closely and say that while they hope for the best, they'll also plan for the worst.

Toughest for many Tokyo Olympians was not being accompanied to Japan by loved ones who had no choice but to watch them compete on TV. American surfer Carissa Moore said it was "a huge challenge" being separated from her husband and his "strong constant

Moore ultimately found her foot-

ing to win gold in surfing's debut as an Olympic sport. As painful as separation was, Tokyo was also a learning experience for the Hawaiian. "I'm very proud of myself, to be here and stand on my own two feet." she said.

Traveling without her parents for the first time at age 17, US Skateboarder Brighton Zeuner compensated by staying closely connected even during her competition, video-calling her father from the Olympic skate bowl "between every single run I did."

To limit infection risks, organizers also asked athletes to arrive in Tokyo no earlier than five days before competing and leave within 48 hours of being done — a rapid turnaround that further truncated the Olympic experience.

Belgian skateboarder Axel Cruysberghs, who competed in week one, and his skateboarding

wife Lizzie Armanto, who competed in week two, passed each other like ships in the night. As she took off for Tokyo, his flight back to their home was 20 minutes from landing.

"It worked out for our puppy," she joked. But it wasn't the fairy-tale Olympics they'd planned before the pandemic. "We'd hoped to like be here for a month together and, you know, I could see his event and he could stay for mine," Armanto said. "But because of COVID and everything ... '

Armanto came away from Tokyo having not made up her mind about whether she wants to go again in Paris. In an Instagram livestream from the Olympic residential compound where athletes were largely confined when not training or competing, she was wrestling with cabin fever, complaining of rooms that "feel a little prison-like" and wishing that organizers hadn't barred athletes from going to watch sports other than their own in their

"I've circled the perimeter quite a few times because what else do you do here?" Armanto asked. Not being able to pass the time at sports

venues was a common complaint. "That's something I would have liked to have experienced as an Olympian, to go watch my other teammates, other than wrestlers, compete," said Elias Kuosmanen of Finland, who wrestled in the Greco-

Roman heavyweight class. But because the pandemic delayed Tokvo by a year, Paris is now only a three-year waitinstead of the usual four. "That is exciting, yes, to think about being able to do this again,' Sclater said. "To see even more of the beauty and coolness of people coming together and being able to really connect to the Olympics.
