#### MIXING OF VAX TRIALS APPROVED

**New Delhi:** India's drug regulator, Central Drugs Standard Control Organisation (CDSCO) has given approval for a study to be conducted by the Christian Medical College (CMC), Vellore on mixing of Covid-19 vaccines Covaxin and Covishield, official sources said Wednesday. The trial will involve 300 healthy volunteers. "The aim of the study is to assess the feasibility on whether a person can be given two different vaccine shots - one each of Covishield and Covaxin to complete the inoculation course," a source said.



#### TENDER FLOATED FOR RT-PCR LABS

BHUBANESWAR: All districts of Odisha will have RT-PCR labs by August 15, Director of Public Health Niranjan Mishra stated Wednesday. Tenders have already been floated for the purpose, he added. So far RT-PCR labs are operational in 14 districts. "Steps are being taken to start the labs as soon as possible in the districts of Bhadrak, Boudh, Dhenkanal, Gajapati, Khurda, Jagatsinghpur, Jajpur, Kendrapara, Nabarangpur, Malkangiri, Nuapada, Sonepur, Kandhamal, Sundargarh, Rayagada and Bargarh," Mishra informed. "We are confident that RT-PCR labs in all districts of Odisha will function from August 15," he added.

## BJD bats for caste census

New Delhi, August 11: A delegation of BJD MPs met Union Home Minister Amit Shah here Wednesday and urged him to consider the proposal to undertake caste-based census for enumeration of Socially and Educationally Backward Classes and Other Backward Classes (SEBC/OBC) people in Census 2021. They also demanded that the reservation be raised beyond 50 per cent ceiling.

The BJD MPs urged Shah to pass a central legislation empowering the states to identify and publish their SEBC/OBC lists and formulate their rational reservation policy by enhancing the percentage of total reservation bevond the existing 50 per cent ceiling

In a memorandum submitted to the home minister, the BJD contended that the legislations of most of the states on reservation policies for SEBC and OBCs had been struck down by the Supreme Court and High Courts on the ground that the policies on reservation are made without any scientific database of the SEBC/OBC population.

"It is imperative that detailed enumeration of SEBC/OBC/other Caste/Class is to be made by the government of India by inserting appropriate columns in the Census Format 2021 for identification of socio-economic and educational status of these categories of population," the BJD said in the memorandum.

"It is the appropriate time to make provision in the reservation policy to accommodate SEBC communities considering their proportionate share in the total population for inclusive growth of the society," it added.

The BJD said that the census will benefit the backward classes

Shimla, August 11: Ten people were killed Wednesday, 13 rescued and more than 50 are feared buried under debris after a landslide trapped a bus and other vehicles in Himachal Pradesh's Kinnaur district, officials said.

Fighting to complete the operation before nightfall, rescue workers struggled to pull out survivors to Haridwar via Shimla, was still buried under the debris, Mokhta said. Sources said that the bus was carrying approximately 40 people. However, there was no official confirmation regarding the figure. When the initial reports of the landslide came, HP Chief Minister

Jai Ram Thakur told the state Assembly that more than 50 people were feared trapped under the debris but the exact number was not known. It will be difficult to ascertain till the debris are cleared, he added.

However, the chances of survival of those still trapped under

the debris are dim. sources said. Earlier, officials said two cars were damaged and rescue teams are trying to pull them out from the debris with the help of a crane. A truck rolled down towards a riverside due to the shooting stones and the driver's body has been recovered, they added. Among the dead also are a two-year-old girl and five women, a state official spokesperson said.

## No user gains even if ATMs go cashless

New Delhi, August 11: The Reserve Bank of India (RBI) announced Wednesday that private and government banks will be fined ₹10.000 if the ATMs are without cash for 10 or more hours in a month. This new rule will certainly come as a relief for the common man. However. the customer will not get any benefit. The fines will be issued by the regional office of the RBI where the ATMs are located and the

amount will go to Central Bank. RBI has directed all banks and White Label ATM operators to ensure timely replenishment of ATMs to avoid cash-outs or face penalties in a notification. The new rule will come in effect from October 1, 2021. The step has been taken to strengthen the systems/mechanisms of banks so that any kind of inconvenience to the public can be avoided. Noncompliance in this regard shall be viewed seriously, the RBI said.

# **State capital hit** hard by dengue

The increase in vector-borne disease cases, on top of Covid-19, has been alarming

Bhubaneswar, August 11: The state capital is reeling under the effects of high rate of Covid-19 infections on a daily basis. To compound the problems of the healthcare and administrative officials, dengue cases are also becoming a cause of headache. The total tally of dengue cases reached 1,058, Wednesday, thereby registering approximately an 86-time jump within a month. A total of 49 new cases were reported Wednesday. The current number of cases in the city is at an all-time high in the last five years.

Bhubaneswar Municipal Corporation (BMC) sources informed that the rate of increase is alarming as the city had reported only 12 cases till the end of June.

It should be stated here that Odisha had registered only 496 dengue cases in 2020, 3,758 in 2019, 5,198 in 2018 and 4,158 in 2017.

"We have been getting close to 40 new cases on a daily basis. Earlier

huge pressure on the already stretched health infrastructure in

"We are admitting 15-20 dengue patients daily. There are two dengue wards with a capacity of 60 beds. The demand for blood platelets has also increased. However, as of now we are not facing any shortage of beds or platelets for dengue patients," a Capital Hospital source said.

Experts at the Regional Medical Research Centre (RMRC) of ICMR here have said that the rise is due to dengue virus serotype-2 (DENV-2 or D2), the most virulent strain. It increases severity of the attack and has been found in a large number of samples collected from Rayagada, Koraput and this city.

Meanwhile, sources at the BMC said that they have surveyed over 11,564 households and have destroyed over 34,707 mosquito breeding sites, including 35,225 sites with larvae so far, to contain spread of the disease.

it was around 15-20 cases daily. Even though most of the patients are recovering, the rate of infection is a matter of concern," said a BMC official.

The rise has been mainly due to lack of awareness among people. We have initiated an awareness and sanitation campaign," the official added

Sources revealed that the city reported more than 550 cases of dengue in July. The upward trend in the vector-borne disease has been the highest in the last 10 days with 446 new infections. Two deaths have also been reported due to suspected dengue attacks. The rising number of dengue cases has put

far reported in the last 41 days in the city stands at 997. It is more than double than the total number of cases reported in the entire state in the previous year. The good sign however, is that 748 persons have recovered until now. The rest are undergoing treatment.

"Most cases have been observed in slums of Sailashree Vihar and Niladri Vihar. ORS tablets have been distributed in most of the affected areas and constant awareness drives are being conducted. Special teams including doctors, health and sanitationworkers and entomologists have been deployed in these areas to contain the spread of dengue," informed a BMC official.

## Paradip may be underwater by 2100: NASA report

Bhubaneswar/New Delhi, August 11: The town of Paradip, which has one of the most prominent ports in India, may not exist at all by the end of the 21st century according to the National Aeronautics and Space Administration (NASA). A new report by the Intergovernmental Panel on Climate Change (IPCC) has warned that 12 Indian cities including Paradip may be submerged by 2100 due to drastic climate changes

NASA has analysed the report and said that drastic measures are needed if India is to avoid such a calamity. Most cities that face extinction are coastal towns. Among the towns that may go three feet

below the water are Kandla, Okha, Bhavnagar, Mumbai, Mormugao, Mangalore, Cochin, Paradip, Kolkata, Visakhapatnam, Chennai and Tuticorin. "Coastal areas will see continued sea-level rise throughout the 21st century, contributing to more frequent and severe coastal flooding in low-lying areas and coastal erosion with extreme sealevel events that previously occurred once in 100 years could happen every year by the end of this century," the IPCC said in its report.

The UN's climate report was made public a few days back. It says continuous reliance on fossil fuels is warming the world at an unprecedented rate in the last 500 years. The effects are already vis-



ible as droughts, wildfires and floods rage around the world. The average global surface temperature has risen by about 1.1 degree

the last decade leading to

Celsius between 1850-2000, a level not seen since 1,25,000 years ago, before the most recent Ice Age.

According to the UN report, in

India, almost 40 million people will be at risk from sea-level rise by 2050. However, densely populated cities such as Mumbai and Kolkata will be at a higher risk. The population in these cities will also increase sub-

stantially in the next 20-30 years. The IPCC report also states that global mean sea level is increasing annually at the rate of approximately 3.7mm as per records accumulated from 2006 to 2018. Along with it the glaciers in the Hindu Kush Himalayan region are also shrinking in size due to global warming. This melting of the glaciers will result in release of huge quantities of water which in turn will be enough to submerge a large number of coastal Indian towns.

## PREVENTIVE **STEPS**

**BHUBANESWAR:** The

government has asked the Water Resources department to prepare an action plan for strengthening saline and flood embankments along the coast within one month. Chief Secretary Suresh Chandra Mahapatra issued this direction while holding a high-level meeting on changing coastal characteristics and existing infrastructure to combat tidal surge. He directed officials to identify the vulnerable locations and tracks where there would be probability of tidal ingress into the land mass.

## **Odisha MPs posed 528 questions** during truncated Monsoon Session



New Delhi, August 11: The Monsoon Session of Parliament which witnessed continuous pandemonium over Pegasus snooping row, farm laws and other issues, ended Wednesday - two days before the schedule. The Odisha MPs posed as many as 528 questions in both houses during the session.

During the session, as many as 20 Bills were passed in Lok Sabha including the Constitutional (One Hundred and Twenty Seventh Amendment) Bill, 2021 that will allow the states to make their own list of SEBCs. Out of the allotted 96 hours, Lok Sabha functioned only for 21 hours and 14 minutes. The Lower House recorded 22 per cent productivity dur-

hoax calls are repeated offenders. They usually hurl abuses at the doctors and use sexual slurs against female tele-callers. As a result, the emergency services get affected. Besides, this hoax calls affect the morale of female staffers," said the service provider of 104 helpline number. Irked over the prank calls, the helpline, managed by Ziqitza Health Care Limited, has approached Sahid Nagar police station for help. An FIR has also

been filed in this connection. The service provider has submitted the numbers of 30 people who regularly make prank calls,

According to the service provider, there are persons who have made around 500 calls to the helpline for harassing the call cen-

Ziqitza Health Care Limited Odisha chief Sabyasachi Biswal said, "Due to these fake calls to 104 helpline number, many genuine cases are facing difficulties to get service. The state government had launched the 104 helpline number in 2020 to provide Covid-19 related services including counselling and other information. The helpline also assist people to reach the nearest hospitals during emergency.'

Biswal claimed that several antisocial elements often use the helpline for fun.

Ziqitza Healthcare, which also manages 108 ambulance service, claimed that some people also make hoax calls for emergency ambu-

## From bamboo sticks to Tokyo glory

LAKRA AND OTHER PLAYERS ARE LOOKING FORWARD TO THE HOCKEY WORLD CUP TO BE PLAYED AT ROURKELA

Bhubaneswar, August 11: He had started playing the game with a bamboo stick as a boy, walked miles and sometimes hitchhiked to a playground. Now, he has a cheque of ₹2.5 crore in his hands, and it's hockey that has made the change possible.

This is the story of Birendra Lakra, the vice-captain of the Indian men's hockey team which bagged bronze in the recently concluded Tokyo Olympics, as the country won a medal in the Games after 41 years. The scenario is not much different

for the other three Olympian hockey players of Odisha who had toiled hard and played sometimes on empty stomach but never lost the dream of representing the country at the highest level of the game one day.

Lakra and Amit Rohidas of the Indian men's team and Deep Grace Ekka and Namita Toppo of the national women's side were emotional after Chief Minister Naveen Patnaik Wednesday felicitated them at Kalinga Stadium here with cash awards and government jobs.

All four players hailed from Sundergarh district, which is known as the cradle of hockey in the state.

While Rohidas broke down while recalling his late father's encouragement behind his success, Lakra nar-



rated how he used to walk miles to play hockey in his childhood.

"In my childhood, I used to see Dilip Tirkey and other players on television. From that day, I had a dream that people would see me on TV. And this has been possible only for hockey," Ekka said, adding that she too struggled a lot to achieve this position.

Toppo also said she too had undergone a lot of problems before coming to a stage and becoming part of the national team. All the four hailed from poor family backgrounds and even could not afford to purchase a hockey stick to start their games which fetched crores of rupees today as cash awards after Olympic success.

Speaking to reporters on the sideline of the felicitation programme here, Lakra said, "When I started playing hockey, it began with a bamboo stick. Not me alone, all the children of our area used to play hockey with the help of bamboo sticks as none of them had money to purchase a formal hockey stick.

Stating that today he has a hockey stick costing ₹25,000, Lakra, a twotime Olympian, recalled how he walked miles, used bicycles or even travelled in tractors, to reach the playground.

We had no support. We struggled hard to come up to a level before attracting the attention of the government and the sports hostel." Lakra said. That was not enough, even after

getting recognition as a national team player, Team India players had faced problems ahead of Tokyo Olympics because of Covid-19 pandemic. 'We could not undertake group

practice properly before the Olympics.

Rohidas, the ace defender, became emotional while showing the bronze medal which he dedicated to his late

"My father left for the heavenly abode last year. He had a dream of me playing in the Olympics. He would have been very happy today. My family has sacrificed a lot for my success," he said. Like Lakra, Rohidas also revealed that he started the game with a bamboo stick.

"Many times I had practised the game on an empty stomach as my family was reeling under abject poverty. I travelled to far-off places on tractors, trucks and cycles for playing matches," he said.

# Action plan soon to shore 1,078 new cases push nCoV load to 9,90,075 up coastal embankments

THE STATE GOVT FEELS THAT THERE IS A NEED FOR FURTHER STRENGTHENING OF THE EMBANKMENTS AS FREQUENCY AND INTENSITY OF CYCLONES RISE



Bhubaneswar, August 11: The state government has asked the Water Resources department to prepare an action plan for strengthening saline and flood embankments along the coast within one month.

Chief Secretary Suresh Chandra Mahapatra issued this direction while holding a high-level meeting on changing coastal characteristics and existing infrastructure to combat tidal surge.

Mahapatra directed the department officials to identify the vulnerable locations and tracks where there would be probability of tidal ingress into the land mass. He also asked the officials to identify 'areas at risk' from where permanent evacuation would be the only scientific solution.

Sources said around 1,636-km saline protection embankments and 5,864-km flood protection embankments were built during previous years mostly in the districts like Ganjam, Puri, Jagatsinghpur,

Kendrapara, Bhadrak and Balasore. During the last 10 years, Odisha

faced seven very severe to extremely severe cyclonic storms. The coastal belt witnessed tidal surge of 3.5 metres to 4.5 metres at the time of cyclones thereby causing large-scale saline inundation.

In the wake of increasing frequency and intensity of cyclones, there is a need for further strengthening of the embankments.

The Chief Secretary directed the engineers of the department to talk to the people who live close to the sea and who have their landed properties on the coastline and convince them about the necessity as well as the utility of strengthening saline/flood embankments. Raising height of embankments would save them from tidal surge and inundation in future. The department was asked to prepare the action plan focusing on highly vulnerable tracks within a month, the source said.

Bhubaneswar, August 11: Odisha's Covid-19 tally rose to 9,90,075 Wednesday as 1,078 more people tested positive for the infection, while 65 fresh fatalities pushed the coastal state's coronavirus death toll to 6,630, a Health official said.

The number of active cases in the state came down to 10.682 as 1.319 more people were cured of the disease, taking the total number of recoveries to 9,72,710.

Khurda district, under which Capital city Bhubaneswar falls, registered the highest number of fresh cases at 372, followed by Cuttack (147). No new case was recorded in Koraput, while the remaining districts reported fresh infections in double digits, said the official.

Khurda also recorded the highest number of fresh fatalities at 20, followed by Cuttack (12) and Nayagarh (six).

The state has thus far tested over 1.67 crore samples for Covid-19, including 68,724 in the last 24

Odisha's cumulative positivity rate stands at 5.19 per cent, while the daily test positivity rate stands at 1.56 per cent, the official said.

The state has inoculated over 1.84 crore people, of whom 42.55 lakh have been fully vaccinated. Public Health director Niranjan

Mishra said that Odisha will have RT-PCR testing laboratories in all the 30 districts from August 15, up from 14 districts at present.

Puri, August 11: Ahead of reopening Srimandir for public darshan from August 16 in a phased manner, the Shree Jagannath Temple Administration (SJTA) Wednesday issued the standard operating procedure (SOP) for different categories of people.

In a notification, the SJTA rolled out the SOP for the servitors' families, local residents and devotees from within the state and outside.

According to SJTA chief administrator Krishan Kumar, the 12th century shrine, which remained closed for public since April 24 this year in view of the second wave of Covid-19, will reopen for public August 16 as per the state government's order. However, family members of the servitors will be allowed to have darshan of the

deities from August 12 to 13. The darshan timings will be from 7am to 7pm on all the days, when temple is open for darshan of the Lords, he said, adding that the residents of Puri municipality area will be allowed entry for darshan from August 16 to 20. All devo-

tees will be allowed entry from August 23. The temple will, however, remain closed for public darshan on Saturdays and Sundays during shutdown as a measure to contain the spread of novel coronavirus and in order to sanitise the temple precincts.

The temple will also remain closed on major festive occasions in order to avoid huge gatherings that are expected on such festive occasions. Accordingly, the temple will remain closed August 30 (Janmashtami) and September 10 (Ganesh Chaturthi).

"This situation will be reviewed again for October 2021 or as required," Kumar said.

It has been made mandatory for all the devotees to wear masks all the times, inside and outside the temple, sanitise hands before entering the shrine, maintain physical distance at all times as per Covid-19 guidelines and follow Covid-appropriate behaviour.

Devotees visiting the temple will have to produce the final certificate for Covid-19 vaccination (of having taken two doses) or Covid-19 negative certificate (RT-PCR) of testBetween 7am & 7pm: while family members of servitors will be allowed to have darshan of the deities from August 12 to 13, residents of Puri municipality area can enter the 12th century shrine from August 16 to 20. Devotees will be allowed entry to Srimandir from August 23



their visit to the temple, the SOP said, adding that people will be required to bring their photo ID card like Aadhaar or voter ID.

Devotees are also requested not to touch statues or idols inside the Srimandir. It is prohibited to take flowers and lamps inside the temple. There will be big containers placed at the entrance, where such items can be dropped, if being carried by the devotees, the SOP said.

Devotees are not allowed to light lamps inside the temple while chewing of tobacco or paan and spitting inside the temple premises is strictly prohibited. A fine of ₹500 will be levied for each violation, the SOP said.

These apart, there is a blanket ban on carrying polythene bags inside the temple. A fine of ₹100 will be levied for each violation, it said, adding that there will be no partaking of Mahaprasad on Ananda Bazar and the temple premises. However, the devotees can carry Mahaprasad and partake it at their place of residence or any other convenient place.

There will be a separate queue for differently-abled devotees, for the vehicles will be done only at Jagannath Ballav Mutt premises or any other designated place, it said.

The SJTA advised senior citizens (above 65 years), persons with co-morbidities, pregnant women and children below 10 years not to visit the temple in view of the prevailing Covid-19 situation.

The family members of servitors will be allowed darshan from Mangal Alati till Rati Pahuda through any of the gates. While entering the temple, they are required to produce their health insurance card or any other ID card issued by SJTA along with photo ID card like Aadhaar or voter ID card.

Devotees will enter through the barricades opposite to the shoe stand, situated on North-East side of the temple complex. All devotees will enter through Lion's Gate.

After darshan, the exit will be through north gate. The queue system will open from 7am, August 23. Devotees will leave their belongings at the designated place outside the temple, produce their ID proof for verification and follow the Covid-19 guidelines.

WRONG INFO ABOUT LAND LEASE IN KOLABIRA

POST NEWS NETWORK

Jharsuguda, August 11: The district administration has reportedly suspended a revenue inspector on charge of providing wrong data on lease of a government land in Sodhamal mouza under Kolabira tehsil, but top officials are allegedly trying to escape from this mess, a report said.

According to the report, Collector Saroj Samal has suspended Sarmarsingha RI Jagdish Sahu for furnishing wrong information about 8 acres of land before it was to be leased to a private agency. The total land in the area is 779 acres and 87 decimal belonging to khata no-490 and plot -1353.

Waste Mahandi Management Services had applied at Kolabira tehsil office August 2, 2019, for lease of the 8 acres. The agency is owned by Bishal Das, son of Health minister Naba Das. However, when local peo-

Former tehsildar Sanjib Patel has been served show cause in this regard, said the Collector

ple came to know about the attempt by the tehsil administration to lease out the land, they had opposed it. Bishal Das took back his lease application October 23, 2019. The tehsildar had to cancel his lease application.

A year later, the same agency applied to take lease of the same 8 acres of land through IDCO. The Collector had approved the lease after spot verification. IDCO then had asked the agency to deposit ₹1.20 crore towards

In fact, the land was full of trees while the revenue department after conducting a survey of the land had reported that there were only bushes on the land.

Locals were shocked over this faulty report. A local youth club moved the High Court against this wrong report by the tehsil.

The HC had directed the Collector to submit a report on the status of the land. A committee headed by sub-collector Shiba Toppo was formed to look into the matter.

The committee comprising the sub-collector, the regional officer of the SPCB, the Jharsuguda tehsildar, and the Sambalbur ACF made onthe-spot investigation and found that there were a large number of trees like sal and piasal on the land. The report has been submitted to the HC.

A former Collector and two former tehsildars allegedly provided wrong information about the land.

The then tehsildar and present Lakhanpur BDO Sanjib Patel was served show cause, the Collector said, adding that the land has not been leased out.

arly in his career, the economist Joseph E. Stiglitz had an extended stay → in Kenya, where he was struck by various oddities in how the local econ-✓omy operated. Sharecropping was one such anomaly. If farmers were required to surrender half of their harvest to landlords, Stiglitz wondered, wouldn't that greatly tax incentives and thus reduce efficiency? Why did such a system persist?

Stiglitz's quest to resolve this paradox led him to develop his seminal theories on asymmetric information, for which he would later be awarded the Nobel Memorial Prize in Economic Sciences. "The time I spent in Kenya," he reminisced, "was pivotal in the development of my ideas on the economics of information."

Similarly, the economist Albert O. Hirschman was in Nigeria when he observed behaviour that he found puzzling. The rail company, long a public monopoly, had begun to face competition from private truckers. But instead of responding to this pressure by addressing its many glaring inefficiencies, the company simply deteriorated even more. The loss of consumers, Hirschman reasoned, had denied the state firm valuable feedback. This observation about rail transport in Nigeria was the seed that grew into his phenomenally influential book Exit, Voice, and Loyalty. (Hirschman also fully deserved a Nobel Prize, but never got one.)

These stories attest to the value of being able to see the world in all its variety. The social sciences are enriched when received wisdom is confronted with 'anomalous' behaviour or outcomes in unfamiliar environments, and when the diversity of local circumstances is fully considered. This observation should be uncontroversial. Yet one would not know it from the way that the economics discipline is organised. The leading economics journals are populated predominantly by authors based in a handful of rich countries. The gatekeepers of the profession are similarly drawn from academic and research institutions in those same countries. The absence of voices based in the rest of the world is not merely an inequity: it impoverishes the discipline. When I recently took over as president of the International Economic Association, I looked for data on the geographical diversity of contributors to economics publications, but I found comprehensive and systematic evidence to be surprisingly scarce. Fortunately data collected recently by Magda Fontana and Paolo Racca of the University of Turin and Fabio Montobbio of Università Cattolica del Sacro

Cuore in Milan provide some striking initial findings.

As I suspected, their data show an extreme geographic concentration of authorship in leading economic journals. Nearly 90 per cent of authors in the top eight journals are based in the United States and Western Europe. Moreover, the situation seems similar with these publications' editorial board membership. Given that these rich countries account for only around one-third of global GDP, the extreme concentration cannot be explained wholly by inadequate resources or less investment in education and training in the rest of the world – though those factors surely must play some role.

Indeed, some countries that have made huge economic strides in recent years nonetheless continue to be severely under-represented in top journals. East Asia produces nearly one-third of global economic output, yet economists based in the region contribute less than five per cent of the articles in major journals. Similarly, the shares of publications from South Asia and Sub-Saharan Africa are minute, and significantly lower than these regions

already small weight in the world economy. Beyond resources and training, access to networks is key in the generation and diffusion of knowledge. Whether a piece of research is taken seriously depends critically on whether the authors have gone to the right schools, know the right people, and travel on the right conference circuit. In economics, the relevant networks are based predominantly in North

America and Western Europe. The predictable objection here is that many of today's leading economists are from developing countries themselves. True, in some ways, economics has become more international. The number of foreign-born resear in leading North American and Western European economics departments and research networks has grown. As a student from Turkey who first ar-

rived in the US at the age of 18, I certainly benefited from these networks. Researchers in advanced economies also have been paying more attention to developing countries, reflecting the fact that development economics has become a much more prominent field within the discipline. In the development-economics master's programme that I run at Harvard University for example, only a minority of faculty members are from the US. The rest are

from Peru, Venezuela, Pakistan, India, Turkey, South Africa, and Cameroon.

But none of these positive developments can fully substitute for local knowledge and insight. Foreign-born economists in the West are typically absorbed into an intellectual environment dominated by rich-country issues and concerns. The visiting economist's exposure to diverse local realities remains limited to happenstance and coincidence, as in the stories about Stiglitz and Hirschman, Just think of all the important ideas that remain undiscovered because researchers from the academic periphery lack a re-

Economics is currently going through a period of soul searching with respect to its gender and racial imbalances. Many new initiatives are underway in North America and Western Europe to address these problems. But  $geographic\ diversity\ remains\ largely\ absent\ from\ the\ discussion.\ Economics$ will not be a truly global discipline until we have addressed this deficit as well.

#### Orismology

his word rarely sees the light of day. Its only recent outing one can find was in the 2001 National Spelling Bee in the US, but then the easy words, like the poor spellers, get weeded out early in that contest. You will find it only in the larger dictionaries. It is defined in two slightly different ways. One is that it is the science of defining technical terms, but it is also used less rigorously as an alternative for terminology. If you go by the original Greek, you have to accept the first definition, as it comes from horismos, a definition plus the -ology ending for a field of study. The first persons to use it were the pre-eminent experts on insects in the early nineteenth century, William Kirby and William Spence. They didn't like the way that in terminology a Latin stem had been joined to a Greek suffix, so in their textbook in 1816 they created orismology as an alternative. They were better entomologists than etymologists, since the word really ought to have an initial h. The linguistic purity of orismology was not enough to ensure its widespread adoption, and it now languishes as a hard word for expert spellers and a topic of pieces like this one.

# A NEW VARIANT OF POPULISM

ost of the 'geopolitical' threats, real or confected, that capture headlines in the West nowadays are exogenous - emanating from China. Russia, Iran, and so forth. But others lie within the world's democracies. Among these are the US Republican Party's embrace of Trumpian authoritarianism, which is eroding the country's democracy, and the possibility that new unanticipated variants of populism will take hold around the world.

One new variant of populism might involve hostility toward both costly green policies and vaccination against COVID-19. And it would be driven by a combination of genuine concerns about pocketbook issues and the kinds of conspiratorial lunacy that thrive on the internet.

Anti-green populism is particularly likely to flourish in the more fossil fuel-dependent economies of Central and Eastern Europe, in response to the European Union's new strategy for reducing greenhouse gases by 55 per cent by 2030. Indeed, the socalled Fit for 55 plan would seem to call for the wholesale remodeling of these economies.

Consider Poland, which generates 70 per cent of its energy from coal and receives additional supplies through a gas pipeline from Russia. Coal is especially abundant in southern Poland, where it is used to fuel giant power stations that provide industry with cheap electricity.

If it is to meet EU emissions targets, Poland is going to have to decarbonise more extensively and rapidly than anyone else. The government recently set an ambitious goal of reducing the proportion of coal in the country's energy mix from 70 per cent to 11 per cent by 2040. But that will have massive implications for mining, which employs some 100,000 heavily unionised and politically influential workers.

Moreover, with little wind or sunshine in winter, Poland is ill suited for renewable-energy deployment. Instead, it has set its sights on 'solutions' like nuclear power and the 'Baltic Pipe' gas pipeline - subsidised by the European Commission to the tune of 215 million (\$251 million) – to

import gas from Norway via Denmark.

But neither of these options has gone down well in Germany. If Poland's efforts to align with EU policy put it at loggerheads with key neighbours and trade partners, it will be damned if it does and damned if it doesn't. The conditions are set for a thriving antigreen populism.

Yet this populist threat is hardly limited to Central and Eastern Europe. Opposition to climate action could just as easily spread to Europe's more established democracies if costly items like air source heat pumps and smart meters are rendered technologically redundant, or if vehicles with internal combustion engines are forced off the road by government fiat.

In fact, France was briefly the epicenter of an anti-green backlash in Europe, with the rambunctious gilets jaunes (yellow vest) protests that began in 2018. Angry citizens who rely on cars to get around their country districts eventually forced President Emmanuel Macron to rescind a new tax on diesel fuel. They had a point, considering that the infrastructure for more expensive electric vehicles simply does not exist in France (or anywhere else).

More recently, a significant share of this cohort seems to have joined with militant anti-vaxxers (many of them on the far right) who have adopted various libertarian poses propagated on the internet.

This confluence of grievance may have traction, especially as more conventional populist movements have begun to take a battering, notably in Hungary, Poland, Slovenia, and elsewhere. People have grown weary of authoritarianism, corruption, and divisive ness during the pandemic - a crisis that was grossly mishandled by populist governments, in particular The likes of Hungarian Prime Minister Victor Orbán are the elite, not some anti-systemic opposition to it.

Opposition to vaccination is as old as inoculation itself. The English city of Leicester used to be a hotbed of it. In 1885, 100,000 people there attended an anti-vaccination rally, complete with a child's coffin and an effigy of Edward Jenner, the pioneer of smallpox vaccination. Such movements were often based on a fusion of fundamentalist Christianity (which opposed interference in God's work) and suspicion of powers being arrogated by the modern state, which made vaccination mandatory for infants or children entering school.

Nowadays, any online search of vaccines immediately reveals a disproportionate number of antivaccination sites, as well as pernicious guff claiming that the barring of unvaccinated youth from nightclubs is akin to Jews being sent to Auschwitz. Versions of that analogy have long appeared in the British Daily Telegraph,

courtesy of its dogmatically libertarian commentators, who have made common cause with the likes of the Fratelli d'Italia (Brothers of Italy). Italy's homegrown fascist movement. Any enemy of the EU is their best friend by default. Although the overwhelming majority of Italians support the government's green pass initiative, the Fratelli's leader, Giorgia Meloni, loudly does not.

In the homeland of Louis Pasteur, such militants are particularly exercised by the government's vaccine-passport rules which exclude the unvaccinated from concerts, cinemas, museums, swimming pools, theaters, and restaurants where 50 people or more are gathered. More trouble may ensue if nurses (only 50 58 per cent of whom are vaccinated) are prevented from working until they receive two doses; or if railway workers raise objections about having to enforce vaccinepassport rules on local and commuter trains. No job should involve the risk of being headbutted or punched in the face.

It was perhaps inevitable that the parasitic populist right would latch onto these issues. Although Marine Le Pen of the far-right National Rally party has typically hedged her bets, her former righthand man, Florian Philipott, was very vocal at the biggest of the many anti-vaccine rallies in July. These are growing in size by the month, with 200,000 attending the first one in August. This 'movement' flourishes among the semieducated in small towns and in cities like Marseille, where obdurate pastis guzzlers and religious immigrant communities also contribute to its ranks.

Still, one can see the outlines of an emerging political fusion between irrationality and pocketbook issues. As anti-vaxxers and anti-greens join forces, any number of stray populist demagogues might seek to lead such a movement. That underscores the importance of UN initiatives such as Team Halo, which has brought together scientists to publicise the importance of vaccines, especially on social media platforms.

## False narrative of 'Anaemia Mukt Bharat'

**DIFFERENT** PERSUASIONS, BE IT THE SEN MODEL **OR THE BHAGWATI MODEL, SEEM TO BE APATHETIC TO MAKING EFFECTIVE INTERVENTION FOR REDUCING ANAEMIA AMONG CHILDREN AND WOMEN** 

he World Health Assembly had set a target to reduce the prevalence of anaemia among women in the age group of 19-49 by 50 per cent by 2025. As per the Global Nutrition Report 2020. India will miss this target by miles. Anaemia is a pernicious social health issue which affects over 800 million women globally. Nearly 53 per cent of women in the reproductive age group of 15-49 years and 58 per cent of children in the age group of 6-59 months in India are affected by anaemia (NFHS-4 survey). The government of India (GOI) launched the POSHAN Abhivaan in 2018 to reduce anaemia at a faster clip by effective use of technology, convergence of different stakeholders and fostering a Jan Andolan to rev up awareness and behavioural change. In April 2018, it launched the Intensive National Iron Plus Initiative (I-NIPI) for an 'Anaemia Mukt Bharat'. As against the abysmally small reduction of anaemia cases by 1 per cent per year during 2005-2015, the I-NPI initiative sets a target of 3 per cent reduction per year.

The primary causes of anaemia

are iron deficiency and inadequate intake of Vitamin A, folate and Vitamin B12. Infectious diseases like malaria and TB further aggravate this problem. The flagship programme envisages provision of prophylactic iron folic acid supplementation, deworming tablets and IFA tablets to school children and women.

In December 2020, the GOI came up with a survey of 22 states and Union Territories on the trends of anaemia in its NFHS-5 factsheet. According to the factsheet, anaemia among children has come down from 58.4 per cent to 53 per cent (2015-2020). However, among women in the reproductive age group it has gone up from 50.3 per cent to 53 per cent. For developed states like Gujarat, anaemia among children has gone up from 62.6 per cent to 79.4 per cent and among women from 54.9 per cent to 65 per cent. Even in a state like Kerala with better HDI record, anaemia among children has gone up from 35.7 per cent to 39.4 per cent, and among women from 34.3 per cent to 36.3 per cent. Almost all states show an upward trajectory.

Different persuasions, be it the Sen Model or the Bhagwati Model, seem to be apathetic to making effective intervention for reducing anaemia among children and women. The NFHS-5 factsheet does not cover Odisha which has an enviable record of reducing anaemia among children from 65 per cent to 44 per cent (2005-2015) and among pregnant women from 68.1 per cent to 47.6 per cent (2005-2015). With initiatives like the Mamata Yojana and the women's selfhelp group movement, Odisha's record is better than prosperous states like Gujarat.

In case of children, the crucial period when iron-deficient anaemia develops is 6-18 months when iron requirement is ten times higher by body weight compared with an adult. Food diet in most developed countries is adequate in iron content as they consume more animal food, especially meat and fortified food. In developing countries like India infants depend on iron from breast milk, which is not adequate. In Chile, they experimented with milk powder that was fortified with iron, leading to very little iron deficiency. Iron fortified infant food can become a game changer for India. A large number of Indians sub-

sist on iron-deficient vegetables due to religious, economic and cultural reasons. Large scale iron supplementation and fortification of commonly consumed vegetable food stuff should be promoted. According to the Constitution, it is the duty of the State to improve nutrition level in the country (Article 47), ensure proper maternity care and relief (Article 42) and support early childhood care (Article 44). These were the premises set forth by the founding fathers of our Constitution to promote basic nutritional justice for our children, adolescent girls and expecting and nursing mothers. God-like technology and convergence models solving all problems seem to be ineffective due to lack of appropriate political priority by most states and the Centre. It would be a pity if COVID-19 becomes an excuse for the states and the Centre to fail in their responsibilities to make appropriate nutritional intervention for an 'Anaemia Mukt Bharat'.

Rasulpur, August 11: Large scale irregularities in distribution of urea among farmers in Jajpur district have come to the fore, a report said. Reports said the irregularities were not limited to its overpricing or delayed distribution but smuggling of the fertilizer to out-

Farmers and traders from Rasulpur, Dharmasala, Bari and Barchana blocks under Dharmasala agriculture office have alleged urea smuggling to other districts and West Bengal. They alleged a large chunk of urea supplied to the district by various companies has been handed over to three to four wholesalers in Korei block for distribution

These wholesalers instead of supplying it to retailers allegedly transport the urea stock to West Bengal and various other districts at a premium. As a result, this has given rise to urea scarcity in Rasulpur and Bari blocks where a majority of residents earn their livelihood from farming.

Lack of action on part of the district administration and district agriculture authorities has emboldened some retailer to carry out their work with impunity.

state government provides urea to farmers at subsidised rates. Various fertiliser companies supply urea to districts for which they have signed an agreement with the government.

The smooth distribution of urea among farmers is vested with the district agriculture officers while the district administration is supposed to monitor the supply. However, fertiliser companies supply urea as per their whims due to the apathetic attitude of the district administration and agriculture officials.

They do not keep the district administration informed of the stocks and supply it to the district and hand over the stocks to a few wholesalers.

Sources said that the district administration has submitted its indent with the state government for 14,700 MT of urea for this kharif season. Accordingly, over 1000 MT of urea is required for Rasulpur block. Meanwhile, Nagarjuna Fertilizers has supplied 1407.595MT, Coromandel Fertilizers 651.690 MT, India Phosphates 274.230 MT, IFFCO Fertilizers 510.300 MT to the district which together works out to 2843.815 MT.

However, to the surprise of farmers Rasulpur block has received only 188.550 MT while 2089.615 MT has been supplied to a few wholesalers in Korei block. Moreover, retailers are not using point of sale (PoS) machines while selling fertilizers to farmers. As PoS machines are not used during sale, the urea stock available in the district is different. The online portal shows urea is available with the district while in reality the district lacks fertilizers

Contacted, Ajay Kumar Senapti, chief district agriculture officer, said wholesalers and fertiliser companies have been directed to give details of urea supplied to the district and their plans on its smooth distribution. He, however, assured to review the wrong doings

## Baghua, Daha reservoirs dry; farmers struggle

Bhanjanagar, August 11: Insufficient rainfall has triggered drought fears in Bhanjanagar area of Ganjam distrcit while two water reservoirs in the area have become dry, leaving little water for farming, a report said.

# Tribals turn to quacks in Boudh

TWO HOMEOPATHIC HOSPITALS IN HILLY AREAS OF HARBHANGA HAVE NO DOCTOR

Boudh/Talagaon, August 11: The government spends crores of rupees to boost healthcare in both rural and urban areas. However, some existing healthcare centres in remote and tribal-dominated pockets under Harbanga block in Boudh district have been paralvsed for want of doctors and staff.

People in these areas allegedly have no option but to seek treatment from quacks, traditional healers and witch doctors. The sorry state of healthcare has exposed the failure of institutional healthcare delivery system, a report said.

According to reports, Harbhanga is a hill-locked and tribal-dominated region. Most of the people are daily wagers. The government has set up two homeopathic hospitals at Kushang and Madhapur.

Healthcare has come to a halt for some days at the two hospitals for lack of doctors. Earlier, thousands of people in the two panchayats used to seek treatment at the hospitals, but they are now deprived of it.



'The hospitals have turned into haunted houses with no doctors at all. They are locked now. A peon only comes to Madhapur homeo-

pathic hospital," locals lamented. This hospital was coming handy

for people living in hilly villages like

Kandara, Kachapaju, Silikuti,

Kuchapaju, Sulugaon, Lengerapaju and Chhatrapada.

Social activists say, "As no doctor is available at the two hospitals, people resort to herbal treatment or knock the doors of witch doctors. Their condition often gets complicated for wrong treatment while

# minor murder case

Lifer for youth in

Berhampur, August 11: A local court sentenced a youth to rigorous life imprisonment after convicting him for the kidnap and murder of a minor boy, Wednesday. The additional district and sessions judge (ADJ) Prasanna Kumar Panda heard the matter and handed down the punishment to Lingaraj Sethi, 27, of Brahmanipalli village under Chhatrapur police limits.

The judge also slapped a fine of ₹20,000 on him apart from the punishment. In default, the convict has to serve an additional two years of imprisonment, the judge observed. The judge passed the order on the basis of statements recorded by three police officers and 17 witnesses.

This was stated here by additional public prosecutor (APP) Gyanendranath Jena who pleaded the matter in the court on behalf

of the state government. Jena said two police officers investigating the case submitted the charge sheet in the court indicting the involvement of Sethi in the crime.

According to the case diary, Sethi was in one-sided love with a girl of his maternal uncle's village Gurundi. Sethi asked the girl to marry him to which the latter denied. Enraged, he threatened to kill her brother. He tried all sorts of tricks but the girl refused his proposal

Accordingly, he kidnapped the younger brother of the girl Bhiku Sethi, studying in Class-VII, December 6, 2018. Police registered a case after the boy's mother filed a complaint in the police station. Police launched a probe and recovered the decomposed body of the boy from a mango orchard near the village, December 10, 2018.

Police changed the previous kidnapping case into a murder and arrested Sethi. During interrogation Sethi admitted to the crime where he disclosed to have killed the boy by slitting his throat and slicing his private part after the latter's sister refused to marry him, he claimed.

# Communal sloganeering: Court Goa sheds its colonial legacy grants bail to ex-BJP member

A video showing anti-Muslim slogans being raised during a protest at Jantar Mantar was widely circulated on social media

New Delhi, August 11: A Delhi court Wednesday granted bail to former BJP spokesperson Ashwini Upadhyay who was arrested in connection with the communal slogans allegedly raised during a protest at the Jantar Mantar here.

Metropolitan Magistrate Udbhay Kumar Jain granted relief to Upadhyay, an advocate, on a bond of Rs 50,000. "As far as the offence u/s 153A (promoting enmity between different groups on grounds of religion, race, etc) of IPC is concerned except for mere assertion, there is nothing on record to show that the alleged hate speech to promote enmity between different groups was done in the presence or at the behest of the accused," the judge said in the order.

During the hearing, the court also inquired from the public prosecutor and there was nothing against the accused in the alleged video. While granting bail, the court noted that there was no chance that the accused will abscond.

"Conspiracy is no doubt hatched behind closed doors and that the investigation in the present matter is at nascent stage. That however, does not imply that liberty of a citizen be curtailed on mere assertions and apprehension," the

The prosecution opposed the application during the hearing on the ground that release of the ac-

cused will be prejudicial in maintaining public tranquillity and will create further serious law and order situation. There are chances that the accused will create communal disharmony, it said. Senior advocate Vikas Singh, appearing for the accused, termed the arrest as "blatant abuse of power by the police".

Police cannot apprehend anyone indiscriminately, he said, adding that it was an admitted fact that the accused was present at the spot in the morning and not at the time of alleged incident relating to hate speech committed

Senior advocates Sidharth Luthra and Gopal Shankarnarayan and advocate Ashwani Dubey also appeared for the accused. The defence counsel further added that the FIR was registered belatedly. The counsel submitted that Upadhyay was being illegally incarcerated and therefore bail should be granted to the accused forthwith.

Opposing the application, the public prosecutor said that the protest was made during the pandemic during which large gatherings are not being allowed to prevent the spread of Covid-19, and that the gathering was held without any permission

The gathering organised by the accused was an unlawful assembly in which he actively participated knowing the common object of the gathering, the prosecutor said.

The court rejected prosecution's contention related to the pandemic, saying that it is a difficult time indeed for everyone and serious view should be taken against those who violate the guidelines; yet, the offences, as far as the breach of these guidelines is concerned, are bailable in nature and can be dealt by the trial court on merits.

While granting the bail, the court directed the accused to cooperate with the ongoing investigations and join the probe as and when summoned by the investigating officer. It further directed the accused not to leave the country without the court's permission and "scrupulously appear at each and every stage of the proceedings before concerned court so as not to cause any obstruction or delay to its progress". The accused was sent to the judicial custody Tuesday by a court here, considering that his bail application was pending.

Across the state there is little appetite for the territory's 450 years of European heritage

Panaji, August 11: Lorraine Alberto teaches Portuguese language at Goa University, but students are in short supply in this former colony.

Across Goa there is little appetite for the territory's 450 years of European heritage.

Colonial homes that are falling into disrepair and Bollywood's increasing cultural dominance portend the disappearance of local history in a place where speaking Portuguese was once a passport to status and power.

"My children don't speak it at all," Alberto told the AFP news agency. "They just don't see the

point of learning it. Those alive in 1961, when Indian troops marched into Goa and incorporated it into the rest of the country, recall an overnight transformation. India's exit from the British empire in 1947 spurred many Goans to demand an end to Portuguese rule, but few expected so much to change so quickly.

"It was a very strange feeling.. The changes came so fast," said Honorato Velho, a retired school principal. The 78-year-old, who once lived next door to the grandfather of Portugal's Prime Minister Antonio Costa, fondly remembers a childhood peppered with European and local influences.

But his enthusiasm has not been inherited by the next generation.

"My wife and I still speak Portuguese out of habit, but never with our children," Velho told AFP.

Across the state, homes influenced by old Portuguese design trends are falling into disrepair or being pulled down to make way for apartment blocks. Only a handful of traditional homes have been earmarked for protection from development or destruction, according to author Heta Pandit. The gradual disappearance of covered terraces and mother-of-pearl shell windows - built to diffuse harsh sunlight – is not just a loss to architecture, she said.

"These houses are evidence of Goan history, they are capsules of our culture.

Some Goans have nonetheless found themselves drawn into a relationship with their heritage,

At a recent outdoor concert in a coastal village, dozens of people gathered to listen to Goan singer Sonia Shirsat, an accomplished performer of traditional Portuguese fado music. The 40-year-old specialises in the melancholy, guitardriven genre, which was born at the turn of the 19th century and was in recent years recognised by UN-ESCO as an "intangible cultural heritage".

Shirsat paused between songs to patiently explain the meaning behind each track, knowing many in the enraptured audience spoke little if any Portuguese.

It is a role she is well-suited to play, tracing her own journey from a teenager who refused to learn Portuguese to a fado artist who is now training others to follow in her footsteps. "My mother tried to teach me the language, but I just wasn't interested," she told AFP.

That changed when Shirsat met a Portuguese guitarist who told her that her rich, velvety voice was ideal for the genre.

She decided to move to Lisbon for training, becoming the first Indian to stage a solo fado concert there in 2008. Shirsat has since performed all over the world, sometimes incorporating a cross-cultural element with the use of Indian instruments like the sitar.

All fado songs are infused with a sense of yearning for the past, but in Goa, they also serve as a bridge between two eras.

"Fado doesn't just talk about what is lost, it also talks about what is to come," she said.

"It has lived in Goa for over 100 years. If we don't preserve it, it is as if we are killing a part of

## Remains of Dalit girl cremated in Delhi

The tragic incident has led to a nationwide outcry with many political leaders visiting the parents of the victim

New Delhi, August 11: The cre sue and feet of the Dalit girl, who was allegedly raped and killed in southwest Delhi's Old Nangal area, was conducted Wednesday by her parents, police said

The girl died under suspicious circumstances August 1 even as her parents alleged that she was raped and forcibly cremated by a crematorium's priest.

"The girl's parents received her mortal remains from Deen Dayal Upadhyay Hospital. They performed the cremation at Old Nangal crematorium in the presence of 15 to 20 people known to them," Deputy Commissioner of Police (southwest) Ingit Pratap Singh said.

During the cremation, around 25 to 30 people from the nearby tent, where a protest against the incident



was going on, tried to intrude. The girl's parents, however, objected and the police asked the intruders to leave, he said

Police said security personnel have been deployed outside the crematorium gate to prevent such

After the cremation, the girl's parents went back to their home with the local beat staff as they feared that they might be stopped by those who opposed the cremation, police said.

The Dalit girl lived with her parents in a rented house in front of the crematorium. August 1, she went to get water from a cooler at the crematorium. Around 6 pm that day, the crematorium's priest, Radhev Shvam, and two-three others called the girl's mother to the

Showing the girl's body to her mother, they claimed that she got electrocuted while getting water. There were burn marks between her left wrist and elbow, and her lips were also blue.

The priest and the others dissuaded her mother from making a PCR call, saying police would make a case out of it and steal the girl's organs during post-mortem examinatiom, so it was better to cre-

The girl was cremated, but subsequently her parents alleged that it was done without their consent. Four people, including the priest,

have been arrested in the case. The agitated locals, along with the parents of the girl, had blocked a road in the area demanding justice. However, the city police have cleared one stretch.

The tragic incident has led to a nationwide outcry with many political leaders visiting the parents of the victim. The case was later transferred to the Crime Branch.

## Microplastics present in tap water supplied to Goa households: Study

Panaji, August 11: A recent research by the CSIR-National Institute of Oceanography (NIO) has found the presence of microplastics in tap water supplied to households in Goa, an official said Wednesday.

Addressing a press conference here, principal scientist of CSIR-NIO Dr Mahua Saha said microplastics were found in tap water drawn from Margao, Panaji Mapusa, Canacona and Marcel, spread over both North and South Goa districts.

The research by the CSIR-NIO and Delhi-based NGO Toxics Link was conducted on pre-treatment raw water and treated tap water, sourced from reservoirs at Selaulim, Opa, Assonora and Canacona in the coastal state, associate director of the NGO Satish

The study was initially meant to be conducted across various cities in India last year, but was restricted only to Goa due to the COVID-19 induced lockdown, it was stated.

Microplastics were found in the tap water drawn from various places in Goa, including Margao, Panaji, Mapusa, Canacona and



Marcel, said Saha, who headed the research. The major characteristics of microplastics found in tap water were similar to those found in pre and post-treated water samples, with black and blue colour ones, made of polyisoprene (used in rubber, footwear etc), ethylene vinyl alcohol (used in packaging, drugs and cosmetics) and polyvinyl chloride (pipes) polymer, she said.

The increased presence of microplastics in tap water can be attributed to abrasion of plastic par-

ticles, Saha said "Household pipes in the tap water distribution system in India are mainly made of plastic or cast iron. Hence, corrosion of plastic pipes might have taken place between the water treatment plants and outlets, adding microplastics to the treated water," the scientist said, adding that hazard levels of microplastics has not been estab-

lished as vet.

# 'Hope buses' bring school to Delhi students

New Delhi, August 11: Every weekday four buses head into the New Delhi slums to give the children of migrants, labourers, ragpickers and scavengers a chance at an education they might not get otherwise.

Each bus goes to two locations a day, setting up an onboard classroom to give about 50 children at a time basic lessons in math, body parts, English and Hindi, along with daily meals.

Ages range from 3-13, and some activity-based lessons are held outside.

These "Hope Buses" of nonprofit group TejasAsia are one of several grassroots initiatives in India helping to fill the education gap caused by the coronavirus pandemic. Another such initiative delivers lessons by loudspeaker

to children in rural areas. TejasAsia has been operating

the mobile schools a few years now, said Ebna Edwin, a project coordinator for the group, but they have become more critical since the pandemic struck.

Schools across the country have shut and moved classes online amid repeated lockdowns to curb the spread of COVID-19 over the past year, impacting nearly 247 million Indian children from 1.5 million schools,

according to UNICEF. Even for children in the slums who went to regular schools prepandemic, their families are often too poor to afford the phones or other devices needed to study online. For others, the two hours on the bus are time away from manual labour or scavenging the land-

fills with their families. Data from India's latest Annual Status of Education Report show that the national dropout rate has risen to 5.5% from 4% over the last year.

"It takes about six months to establish our programme in one location," he said

The NGO wants to expand its reach to ten more locations in different states but has put these plans on hold as funds and resources have been redirected during the pandemic

The Hope buses are reaching nearly 400 children across Delhi and neighbouring areas.

Mumtaz Begum, who lives in a neighbourhood of huts in northern Delhi, said her two daughters had improved a lot after they started attending school on one of the buses.

"We want our kids to learn and 🗦 grow," she said.

Ten-year-old Azmira, who has been studying on one of the mobile schools for four years and sat in a bus with a mask on, said: "We all really like coming hereand studying. The teachers are very good."

## 23,500 FRESH CASES, 116 DEATHS

# Govt rejects claims 'Parl mayhem' shocks Naidu

New Delhi, August 11: Rajya Sabha Chairman M Venakaiah Naidu broke down Wednesday as he expressed deep anguish over some opposition MPs climbing on the Table of the House, and said he couldn't sleep because of the sacrilege in Parliament, which is regarded as the "temple of democracy'

Expressing distress over the ruckus created by opposition MPs in the House Tuesday when a discussion on farmers' agitation against farm bill was taken up, he said he struggled to find a provocation or reason for such a low in the "august House"

"I have no words to convey my anguish and to condemn such acts. As I spent a sleepless night last night, I struggled to find the provocation or reason for forcing this august House to hit such a low yesterday," an emotional Naidu said as he read out his remarks at the start of the proceedings in the Upper House of Parliament.

Regaining his composure he continued to read his remarks but was interrupted by some TMC and Congress MPs who raised the issue of House dignity also being lowered by the passage of numerous bills within minutes and without debate. One MP said the Chair should be impartial, following which slogan-shouting TMC and few other MPs trooped into the well of the House. "Please have the decency. You may not agree," Naidu, who completed four years in office Wednesday, said as he continued to read his remarks amid sloganeering. Thereafter he adjourned the proceedings for almost an hour. On Tuesday, some TMC, Congress

and Left MPs climbed on the House Table which is placed right below the presiding officers' chair, forcing multiple adjournments.

"I rise in deep anguish to place on record the way this august House is being subjected to sacrilege and that too, propelled by a sense of competition among some sections of the House, since the commencement of this monsoon session," he said. "Everything said or done violating, hurting or destroying the sacredness of any place amounts to an act of sacrilege." Stating that the Parliament is regarded as the 'temple of democ racy', he said the table area where the officers and reporters of the House, the Secretary-General and the Presiding Officer are seated is considered as the holy sanctum sanctorum of the House.

"A certain degree of sacredness attached to this place. In our temples, devotees are allowed only up to this sanctum sanctorum and not beyond," he said. Entering this sanctum sanctorum of the House, in itself is an act of sacrilege and it has been happening as routine

## 'Army alert to scuttle terrorists' plan in J&K'

Jammu, August 11: Just days ahead of the Independence Day Jammu and Kashmir Director General of Police (DGP) Dilbag Singh disclosed on Wednesday that Pakistan-based terror outfits, including the Lashkar-e-Taiba (LeT) and the Jaish-e-Mohammad (JeM), are planning major strikes in the Union Territory, while asserting that the security forces are alert to thwart any such attempt.

He also said anti-terrorism operations are going on in both the divisions of Jammu and Kashmir and the security forces are keeping a tight vigil to frustrate Pakistani attempts to lure youngsters into committing terror

"There are reports that Pakistani terror outfits like LeT, Hizbul Mujahideen (HM) and JeM are looking for an opportunity to carry out major terror atacks in the Jammu region as well as in the Kashmir region. "Our forces are alert and the police are working in close coordination with the intelligence agencies and other security agencies. I am confident that we will be able to thwart such designs of the terrorists," the police chief told reporters in Kishtwar district.

After visiting Rajouri the previous day, the DGP reached Kishtwar on Wednesday morning to review the security situation ahead of the Independence Day in the district that saw repeated attempts by the ultras to revive terror activities. On the arrest of two newly-recruited HM terrorists from the Dachhan area of the district two days ago, Singh said, "It is an ongoing process. The operations are going on all over the Kashmir and Jammu regions." "In Rajouri, two terrorists were eliminated in a joint operation by the police and the Army in the Pangai area. There are reports about the presence of more terrorists in the area who have crossed over from Pakistan," he added. The DGP said Pakistan and agents sponsored by the country are trying to activate certain overground workers (OGWs) of terror outfits in Jammu

and Kashmir.

## Parl passes Bill to restore states' power on OBC list

New Delhi, August 11:A constitutional amendment bill to restore the powers of the states to make their own OBC lists was passed by Parliament Wednesday, with the opposition and treasury benches joining hands in the Rajya Sabha to approve the legislation.

The Constitution (One Hundred and Twenty-Seventh Amendment) Bill, 2021 was passed by the Lok Sabha, a day before. Social Justice and Empowerment Minister Virendra Kumar said the bill will help restore the powers of states to have their own lists of OBCs which was negated by the Supreme Court. The bill was passed in the Rajya

Sabha, with 187 members voting in its favour, and no one opposing it. Some amendments moved by the opposition were negated. The Rajya Sabha, which has been witnessing a logjam over issues such as Pegasus and farm laws, Wednesday discussed the bill for about five hours as members from both treasury as well as opposition benches participated in it.

Kumar said the legislation will help 671 communities, almost onefifth of the total OBCs in the country, get reservation in jobs and educational institutions. The 102nd Constitution Amendment Act of 2018 inserted articles 338B, which deals with the structure, duties and powers of the National



Commission for Backward Classes,

Communities (SEBCs) and the



#### CDC urges pregnant women to get jabbed

Washington: Pregnant women should be vaccinated against Covid-19, based on a new analysis that did not show increased risk for miscarriage, the US Centers for Disease Control and Prevention said Wednesday. The CDC said it has found no safety concerns for pregnant people in either the new analysis or earlier studies. It said miscarriage rates after vaccination were similar to the expected rate. Pregnant women can receive any of the three vaccines given emergency authorization -Pfizer, Moderna or Johnson & Johnson.

#### FB removes anti-vax influencer campaign

Providence: Facebook said Tuesday that it has removed hundreds of accounts linked to a mysterious advertising agency operating out of Russia that sought to pay social media influencers to smear Covid-19 vaccines made by Pfizer and AstraZeneca, A network of 65 Facebook accounts and 243 Instagram accounts was traced back to Fazze, an advertising and marketing firm registered in the United Kingdom. Facebook said Fazze's work was primarily done from Russia on behalf of an unknown client.

#### Canada extends ban on flights from India

Toronto: Canada has again extended its ban on arriving passenger flights directly from India till September 21 due to the risks posed by the Covid-19 pandemic, the federal transport ministry has said. In April, Canada banned all direct flights to and from India when the second Covid-19 wave hit India. The date of reopening has been postponed many times. "After reviewing public health data, we have decided to extend the direct flight ban between Canada and India until September 21, 2021," Omar Alghabra, Minister of Transport of Canada, tweeted Tuesday.

#### Covid vax centres attacked in France

Paris: Vandals have attacked more than 20 vaccination centres and other health facilities, daubing some with Nazi-themed slogans, as the French government steps up its Covid-19 vaccination drive Anger has been fueled by the introduction of a health pass showing proof of vaccination or a recent negative Covid-19 test which is now mandatory for entering restaurants, trains and other public places.

Algiers, August 11: Wildfires tearing through forested areas of northern Algeria have killed at least 65 people, state television reported Wednesday, as some of the most destructive blazes in the country's history continued to rage.

The government has deployed the army to help fight the fires, which have burnt most fiercely in the mountainous Kabylie region, and 28 of the dead are soldiers, with another 12 critically injured with burns. Forest fires have set large parts of Algeria, Turkey and Greece aflame over the past week and a European Union atmosphere monitor said the Mediterranean had become a wildfire hotspot aided by in-

creasingly hot weather. Dozens of separate fires have raged through forest areas across northern Algeria since Monday and Tuesday Interior Minister Kamel Beldjoud accused arsonists of igniting the flames, without providing any evidence.

The worst hit area has been Tizi Ouzou, the largest district of the Kabylie region, where houses have burned and residents fled to shelter in hotels, hostels and university accommodation in nearby towns.

The government has said it will compensate those affected.

## **Taliban could take Kabul** in 90 days: US intelligence

Kabul, August 11: Taliban fighters could isolate Afghanistan's capital in 30 days and possibly take it over in 90, a US defence official told Reuters Wednesday citing US intelligence, as militants took control of ninth provincial Afghan capital.

The US official, speaking on condition of anonymity, said that the new assessment of how long Kabul could stand was a result of the rapid gains the Taliban had been making around the country as USled foreign forces leave.

'But this is not a foregone conclusion," the official added, saying that the Afghan security forces could reverse the momentum by putting up more resistance

Wednesday's loss of Faizabad, capital of the northeastern province of Badakhshan, was the latest setback for the Afghan government, which has been struggling to stem the momentum of Taliban assaults. Jawad Mujadidi, a provincial

## Canadian jailed in China for spying

## 94K US kids got Covid last week

New York, August 11: Covid-19 cases among US children are climbing at an alarming rate, with nearly 94.000 diagnosed with the virus last week and trends showing a "continuing substantial increase"

Children now account for 15 per cent of Covid-19 cases in the US, according to a study released by The American Academy of Pediatrics (AAP). The same set of numbers also appear to show that severe illness, hospitalization and death are rare in children who get sick with the Coronavirus.

As of August 5, nearly 4.3 million children have tested positive for Covid-19 since the onset of the pandemic. Child cases have steadily increased since the beginning of July,

says the AAP report. Fears are spiralling that states without tough mask mandates will likely be slammed once again by rising Covid-19 cases as students return to the classroom.

The CDC recommends universal indoor masking by all students (age 2 and older), staff, teachers, and visitors to K-12 schools, regardless of vaccination status. Many state governors are defying the mandate even as their ICU corri-

#### UK man held for espionage in Berlin

A British man suspected of spying for Russia in exchange for cash has been arrested in Germany, federal prosecutors said Wednesday, in a stunning case compared to a Cold War thriller. The suspect identified only as David S, who worked as local staff at the British embassy, "on at least one occasion passed on documents he acquired as part of his professional activities to a representative of Russian intelligence". "The accused received a cash payment in an unspecified amount in return," the federal prosecutor's office said in a statement. The suspect was believed to have been spying since November 2020 "at the latest". His arrest was the result of a joint operation by German and British authorities. The British embassy in Berlin declined to comment.

Moody's said capital spending by the three refiners will remain high on strong demand for petroleum products and government efforts to boost investment spending to support economic growth.

## Fintechs attract record \$2bn in H1, says report

Mumbai, August 11: Attracting a little over \$2 billion in the first half this year, the domestic fintech sector has almost matched its total funding in the entire 2020, making it the best run ever, according to a report.

The record investments have been led by merchant platform Pinelabs' \$285 million from private equity funding round, \$100 million venture capital funding rounds Cred's (\$215 million), Razorpay (\$160 million), Kreditbee (\$153 million), Ofbusiness (\$110 million) and Bharatpe (\$108 million), a KPMG report released Wednesday said.

Most of the money has flown into the digital banking space and the second biggest was insurtech. wherein the first half saw several such startups, including Turtlemint (\$46 million), Renewbuy (\$45 million), and Digit Insurance (\$18 million) raising funds from the midsized private equity and venture capital funds, it added.

According to the report, four of the top ten deals in Asia were into domestic companies during the period under review.

While the Noida-based Pinebabs \$285 million was the third-largest in Asia, the \$215 million in a Series D round by the Mumbai-based financial software firm Cred was the fourth largest in the continent.

Bangalore-based payments app Razorpay's raised \$160 million in the series E round, making it the eighth largest, and lending app Kreditbee's mopped up \$153 million in series C round, the tenth-largest

#### **Economic growth** picking up pace: PM

'We have taken bold decisions. Reforms continued even during pandemic. The government is doing reforms not out of compulsion but out of conviction." he said while addressing the CII's annual meeting.

Assuring all support to the industry, Modi said that India is receiving record foreign direct investment (FDI) because of reforms done in the last few years.

The Prime Minister said that the major responsibility for the success of the self-reliant India campaign lies with the Indian industry. Modi asked the industry to take full advantage of the atmosphere of trust for India's development and capabilities.

Highlighting the changes in the approach of the current government and changes in the ways of working of the current setup, he stressed that the new India of today is ready to march with the new world.

"India, which was apprehensive of foreign investment at one point of time, is welcoming investments of all types today. Similarly, tax policies used to induce despondency among the investors, the same India can boast of the world's most competitive corporate tax and faceless tax system." he said.

## Exports may touch \$1tn by FY28: Secy

#### THE COMMERCE SECRETARY SAID THAT INDIAN EXPORTS HAVE BEEN ROUGHLY FLUCTUATING BETWEEN \$290BN AND \$330BN FOR THE LAST 10 YEARS

New Delhi, August 11: The country's merchandise exports are expected to touch \$1 trillion by 2027-28 and the government has laid down a road map, including district as an export hub scheme, to achieve that number, Commerce Secretary BVR Subrahmanyam said Wednesday.

This fiscal, the commerce ministry is aiming at \$419 billion of exports and for that a detailed analysis has been carried out and the target was disaggregated at the level of country, commodity, region, and states across 31 commodity groups.

The secretary said that Indian exports have been roughly fluctuating between \$290 billion and \$330 billion for the last 10 years.

'We have actually laid down a roadmap on how we hit \$500 billion in merchandise exports and when we hit a trillion dollar exports. Our guess is that, by 2027-28, very very modest estimates, we should

touch \$1 trillion figure in exports of merchandise." Subrahmanyam said at the CII's Annual Meeting

He also said that work is underway for the services sector as well and the target is to take these exports to \$700 billion

The services exports' sector has "no mother, and they are an orphan in many ways" as it is distributed among 30 different departments of the government, he said, adding "we are going to start an exercise. We export about \$200 billion services every year. The target is actually to hit about \$700 billion by 2027-28"

Listing out steps which the ministry is going to take to achieve these targets, he said as Merchandise Exports from India Scheme (MEIS), and Services Exports from India Scheme (SEIS). are stopped now, the government will notify Remission of Duties and Taxes on Export Products (RoDTEP) rates probably by Friday.

#### I-T dept to refund excess interest, late fee



New Delhi: The Income Tax Department Wednesday said it will refund the excess interest and late fee paid by taxpayers due to software error while filing ITR for 2020-21. The last date for filing ITR for last financial year has been

extended till September 30, 2021, from July 31 to give taxpayers compliance relief during the pandemic. However, some taxpayers complained that interest and late fee was charged while fil?ing income tax return (ITR) after July 31, 2021. The department in a tweet said the ITR software was rectified on August 1 itself to remove the error due to incorrect computation of interest under section 234A and late fee under section 234F of Income Tax Act.

#### Now, Microsoft challenges cloud contract won by AWS

San Francisco: After a bitter war over the \$10 billion JEDI Cloud computing contract, Microsoft and Amazon have once again locked horns, this time over another \$10 billion contract by the US National Security Agency (NSA) won by Amazon Web Services (AWS), the retail arm of Amazon. According to a report in Washington Technology, Microsoft is challenging that decision at the Government Accountability Office (GAO), "saying NSA didn't conduct a proper evaluation" while considering a Cloud provider for its new project code-named 'WildandStormy'. A decision is expected back from the GAO by October 29. In a statement to NextGov, an NSA spokesperson said that "the Agency will respond to the protest in accordance with appropriate federal regulations." The NSA is pursuing a "Hybrid Compute Initiative" to manage what goes into a "commercial cloud infrastructure and what pieces cannot be moved".

## **'VIL's position** to remain tough'



New Delhi, August 11: Vodafone Idea's cash flow analysis indicates that its situation may remain challenging even after any relief measures, and the telco needs "meaningful capital infusion" with a long gestation period to become competitive, a report by Credit Suisse said Wednesdav.

## Hackers return \$260mn to crypto platform

or hackers behind one of the biggest ever cryptocurrency heists have returned over a third of around \$600 million in stolen digital coins, a blockchain researcher said Wednesday. Poly Network, a decentralised finance platform that facilitates peer-to-peer transactions, announced the hack on Twitter, posting details of digital wallets to which the tokens were sent.

London, August 11: The hacker

The value of the coins in the wallets was just over \$600 million at the time of the announcement, according to blockchain analysts. Poly Network later urged the hackers to return the stolen funds to several of its digital addresses. saying it planned to take legal action.

By late afternoon around \$258 million in stolen tokens had been returned, according to public blockchain records and crypto tracking firm Elliptic

Tom Robinson, Ellipic's co-

founder, said the extraordinary move could have been prompted by the headaches of laundering stolen crypto on such a scale.

Poly Network did not respond to requests for further details about the heist or the return of the funds. It was not immediately clear where the platform is based, or whether any law enforcement agency was investigating the heist.

The size of the theft was comparable with the \$530 million in digital coins stolen from Tokyo-based exchange Coincheck in 2018.

# LORD'S TEST AWAITS INDIA





R Ashwin may come into playing XI in injured Shardul Thakur's place

London, August 11: Captain Virat Kohli might have to seriously consider playing his best spinner Ravichandran Ashwin while expecting a far better show from the seasoned batting line-up when India meet England in the second Test at the Lord's starting Thursday.

While India were in a better position to win the first Test before heavens opened up on the final day, the first innings score of 278 was still below par as none among Kohli, Cheteshwar Pujara and Ajinkya Rahane (horrible mix-up) scored runs.

Not to forget that all three haven't scored heavily in the past two years and save Rahane, who got a hundred in Melbourne, the other two batting mainstavs haven't been able to convert a lot of their half-centuries into three-figure mark

As far as team combination is concerned, Shardul Thakur's hamstring injury does again tilt the lower-order batting balance although the Mumbai seamer didn't trouble the scorers in the only innings that he played.

Ashwin, who was dropp playing XI in the drawn opening game in Nottingham because of Ravindra Jadeja's superior skills with the willow, is back in the mix as Thakur seems to have done his hamstring some damage during the training session at the Lord's Monday.

It's still not clear whether he picked up the injury during the first Test or not. With Thakur being all but ruled out of the upcoming match, Kohli might have to revisit his 4-1 bowling combination which can't be cast in stone considering the lean nature of his team's lowerorder batting

London has been recording a maximum temperature of 24 degrees with average temperature around 14 degrees.

It would be interesting to see if England retain a green top like they did in 2018 when Indian batting collapsed twice in two days and all-rounder Chris Woakes walked away with the honours.

In case, the pitch is on the drier side, there could possibly be no harm in playing both Ashwin and Jadeia, who can trouble this brittle England batting line-up with their different variations.

The poor quality of new generation of England Test players was exposed again as skipper Joe Root had to come to his team's rescue for the umpteenth time with a fifty in the first innings and possibly a match-saving 21st Test hundred in the second essay.

There is every possibility that Rory Burns could be replaced by Haseeb Hameed, who scored a hundred opening the innings for the Combined Counties against Indians in the tour game last month.

For Kohli, if four pacers are non-negotiable, then one among Ishant Sharma or Umesh Yadav will be straightaway replacing Thakur but the choice might not be

But adaptability is the rider that Indian skipper used during that post-match conference and hence Ashwin, who is currently on the verge of surpassing Harbhajan Singh's (417 wickets) tally, comes into the picture.

If the skipper believes that his batting needs to be suitably beefed up, then Ashwin is the right choice in case weather permitting, there is something available on the fourth or fifth day Lord's pitch.


New Delhi, August 11: Star javelin thrower Neeraj Chopra's historic gold-winning feat in the Olympics was listed as one of the 10 magical moments of track and field in the Tokyo Games by World Athletics.

The 23-year-Chopra clinched the country's maiden Olympic medal in athletics with a best throw of 87.58m on Saturday to become only the second Indian to win an individual yellow metal in the Games

"Most keen followers of the sport had heard of Neeraj Chopra before the Olympic Games. But after winning the javelin in Tokyo, and in the process becoming India's first athletics gold medallist in Olympic history, Chopra's profile sky-rocketed," the global governing body said on its website.

WA noted that the 23-year-old Chopra had 143,000 followers before the Olympics, but now has a staggering 3.2million (on Instagram), making him the most followed track and field athlete in the world.

In a tweet posted after winning the gold in Tokyo, Chopra has said, "Still processing this feeling. To

veiled as PSG's first marquee signing for 42 million euros (USD 49 million), Messi joined on a free transfer after bidding a tearful farewell to Barcelona Sunday. Messi's net salary of 35 million euros (USD 41 million) is less than Neymar's (37 million euros/USD 43.4 million).

After taking over at PSG in June 2011,

cash-rich investors QSI now boast one of the best squads in European soccer, having already signed Italy's Euro 2020-winning goalkeeper Gianluigi Donnarumma, veteran Spanish defender Sergio Ramos and former Liverpool midfielder Georginio Wijnaldum on free transfers.

**MESSI** sends PSG

One transfer outlay was the hefty 60 million euros (USD 71 million) it spent on Achraf Hakimi from Italian champion Inter Milan. He is arguably the best attacking right back in Europe and scored a fine goal on his league debut.

Qatari-backed PSG has been desperate to win the Champions League, falling just short when it lost the 2020 final to Bayern

Now, with Messi on board, it has arguably the strongest attack in the game. Eager fans waited at Le Bourget airport Tuesday afternoon and broke into chants of "Messi! Messi!" as he waved from a window wearing a T-shirt emblazoned with "Ici C'est Paris" (This Is Paris) - a favorite chant among fans.

His arrival surpasses the fanfare of Neymar's world-record signing for 222 million euros (USD 261 million) from Barcelona in 2017, and Zlatan Ibrahimovic's brazenly self-promoting presentation by

the Eiffel Tower in 2012.

Their transfers boosted TV viewing figures considerably, with broadcaster Canal Plus getting a 40% increase for Neymar's first few games.

But neither Neymar nor

Ibrahimovic won a Ballon d'Or — Messi has a record six of the top awards — and PSG's revenue stream from marketing and merchandising will greatly benefit. His staggering tally of 672 goals for Barca includes an

extraordinary 50-goal season in 2012; 96 league goals and a remarkable 133 overall across 2012 and 2013; eight Spanish league and six Champions League scoring titles.

Messi has four Champions League trophies with Barcelona, a record 91 goals in a calendar year for club and country, and a 2021 Copa America title with Argentina.

His next quest is to help PSG win the elusive Champions League title it craves. With Messi in the side, PSG has to deliver. Messi will wear the No.30 jersey the same number he wore in his first two seasons with Barcelona before switching to No.19 and then the prized No.10, which Neymar gets to keep at PSG.
