



State Transport and Commerce Minister Padmanabha Behera said, "Whatever policy decisions on motor vehicles were taken by the Centre are being implemented by all states including Odisha. As the Prime Minister had announced

Exit frenzy kills 8 at Kabul airport

■ As Taliban wrap up their takeover of Afghanistan, citizens scramble to leave the country. Panicked Afghans were seen desperately trying to get on flights out of the country

Kabul, August 16: At least five people have been killed at the Kabul airport and three stowaways were reported to have fallen to their deaths from an airborne plane as thousands of Afghans are desperately trying to get on flights out of the country amid increasingly chaotic scenes, media reports Monday.

US troops fired shots in the air at the Hamid Karzai International Airport to prevent hundreds of civilians running onto the tarmac after they took over Afghanistan's air traffic control. Witnesses said it was not clear whether the victims were killed

by gunshots or in a stampede. Footage published by Asvaka showed three stowaways falling to the deaths after clinging on to the wheels of a military plane as it took off from Kabul airport.



Panicked Afghans were also seen climbing up the outside of an airbridge in a bid to get onboard planes and chasing a US military

C-17 down the runway. Videos also showed hundreds of people running alongside, and in front of a US Air Force plane preparing to take off. All commercial services have been suspended, with only military flights leaving the country as the UK. US and other western countries repatriate their citizens. It comes as the UK Ministry of Defence confirmed the first British nationals had landed at the RAF base Brize Norton after being evacuated from Kabul

NEW DELHI: Air India cancelled its Delhi-Kabul-Delhi flight that was scheduled to be operated Monday and carriers running flight services

between India and the western countries avoided the Afghan airspace after it was declared "uncontrolled" by the Kabul airport authorities, senior officials said. The Air India flight was the only commercial service scheduled to be operated. between India and Afghanistan Monday. The national carrier is the only airline that has been operating flights between the two countries. Afghanistan stares at an uncertain future as President Ashraf Ghani left the country just before Kabul fell

into the hands of the Taliban.

104 KIDS TEST

Bhubaneswar, August 16: Amid concerns that the third wave of the pandemic would have a greater impact on children, 104 kids testing positive for Covid-19 in the state has set alarm bells ringing, Monday.

Odisha Monday registered 868 new Covid-19 cases, which took the tally to 9,95,433, while 66 fresh fatalities pushed the toll to 6,953, a health department official said. Of the 868 new cases, 104 are in the age group of 0-18 years, he said.

According to chief of Directorate of Medical Education and Training CBK Mohanty, "Since the population of 18 years of age and below is not inoculated, the probability of them getting affected is more. School authorities and parents have a specific role to play in protecting them.'

According to the health department, 50,689 Covid-19 cases have been recorded among children in the age group of 0 and 14 thus far. Odisha's percentage of infection among children and adolescents is mostly at par with the national

average, the DMET chief stated. Khurda district, of which the state capital Bhubaneswar is a part, recorded 256 new cases, followed by Cuttack at 154, the official said. Three districts - Koraput, Nabarangpur and Subarnapur – did not report any new case. Sambalpur reported the highest

Can't compel reluctant Centre to file affidavit on Pegasus: SC

■ The Centre's unwillingness to file a detailed affidavit on the controversial Pegasus expose has rattled the Supreme Court

New Delhi, August 16: The Supreme Court Monday said it cannot compel the "reluctant" Centre to file a detailed affidavit on pleas seeking information if Pegasus spyware was used to snoop on certain citizens and steps it took to probe the allegations amid vehement claims that there was "nothing to hide" and it will set

up a panel to examine all aspects related to the issue.

The apex court bench headed by Chief Justice NV Ramana would Tuesday deliberate on whether the Centre should file a detailed affidavit in the matter, after the short one in which it submitted Monday that the pleas were "based on conjectures and surmises or on other unsubstantiated media reports or incomplete or uncorroborated ma-

Solicitor General Tushar Mehta, appearing for the Centre, said the matter, if gone into on the basis of unsubstantiated reports, may have "national security implications" and it cannot be handled by asking

The ministry of electronics and Information Technology in a twopage affidavit told the bench, also

comprising justices Surya Kant and Aniruddha Bose, that "to dispel any wrong narrative spread by certain vested interests" and with an object of examining the issues raised, the Centre will constitute a Committee of Experts in the field which will go in to all aspects of the issue.

'You see, when the government is reluctant, then can you force it to file a detailed affidavit?" the bench said, adding, "We will continue tomorrow... If Mr Mehta (Solicitor General) may decide to file an affidavit, then we have noth-

ing to say, or we will hear all of you.' The law officer said, "The government is not reluctant at all... I ask myself a question if a one page affidavit is filed saying that Pegasus was not used then will

they withdraw the petitions. The

He said, "If it is for fact finding, then I am for it. But if it is for sensationalising which is alien to Article 32 then I cannot help it. It looks like petitioners want to go somewhere else other than what courts want to see." Senior advocate Kapil Sibal, appearing for veteran journalists N Ram and Sashi Kumar who have filed one of the petitions in the matter, argued that the Centre should file an affidavit stating whether the government or its agencies have used Pegasus. The Solicitor General said the Pegasus issue would involve the aspect of national security and the matter is "sensitive".

'White Spider', Sarai App to arrest crimes

Bhubaneswar, August 16: The Commissionerate Police Monday launched operation 'White Spider to make the slums drugs free and also unveiled a software application, Sarai App, to keep tabs on suspicious activities in hotels and lodges in the Capital city.

Speaking on the issue, Commissioner of Police Saumendra Privadarshi told the media that it is mandatory for the lodges and hotels under the Sarai's Act to share all the details about their establishment with the police. This apart, they are supposed to share the records of visitors checking in and out with the police.

'The Commissionerate Police has developed an app named 'Sarai' to streamline the aforesaid task. The hotels and lodges in Bhubaneswar have to send all their activity details to police on a daily basis by installing the app in their systems," he said.



Additional Chief Secretary (Health) PK Mohapatra has asked Regional Medical Research Centre (RMRC) director Sanghamitra Pati to go ahead with the survey in Sambalpur, Sundargarh, Jharsuguda, Keonjhar, Khurda, Puri, Balasore, Mayurbhanj, Jajpur, Kandhamal, Kalahandi and Nabarangpur. The state will spend Rs 57.70 lakh for the survey. "The state level serological surveillance will be conducted in the 12 districts to estimate and compare the age-specific prevalence of SARS-CoV-2 antibodies in the general population and healthcare workers across the state of Odisha," Mohapatra said in a letter.

Rasulpur, August 16: The state government has launched Balaram Yojana (Bhoomihina Agriculturist Loan and Resources Augmentation Model) to provide crop loans to landless farmers, a report said.

However, the scheme has failed to take off due to various conditions laid down in the guidelines to provide crop loans and the restrictions imposed by the banks, the report said. As a result, sharecroppers and landless farmers who lack resources to carry out agricultural activities have failed to avail loan under the scheme.

The matter has been reported from Rasulpur block where agriculture officials have failed to implement the scheme in over 80 per cent panchayats. Reports said the block has 28 panchayats. However, Agriculture officials have so far managed to form only one joint liability group on the basis of guidelines comprising 14 families of landless cultivators in five panchayats.

They are Rajendrapur, Samantarapur, Bandhadiha, Singhapur and Mugupala panchavats. What is worse is that it took around a year for them to form the joint liability group. The delay has sparked concern among the Agriculture department officials working in the grassroots level.

Sources said the scheme was launched in the state, July 6, 2020. The banks have been directed to provide loans to the landless families. The Agriculture department was directed to form one group each in every village comprising five families of landless cultivators.

The aim of the scheme is to provide a minimum of ₹50,000 and maximum of ₹1.6 lakh as loan to each group. The village level Agriculture workers and Krushak Sathis are required to form the group. Accordingly, groups have been formed in the block but the banks have decided to provide loans only to 14

Meanwhile, the Agriculture officials have failed to form groups in several panchavats as it has become difficult for them to get landless farmer families. Moreover, the banks are verifying the loan transaction records of the group members before sanctioning loans.

A member of the group is declared ineligible for a loan if he has defaulted in repayment of any previous loan. As a result, for a single person the whole group suffers in availing the loan.

Moreover, the landless farmers provide the details of the land (khata and plot numbers) they are cultivating without the consent of the landowners while applying for the loan. This results in face-off between the two following which the landowners lodge complaints against the concerned farmers. As a result, it becomes difficult for a group to get a loan and, in most cases, the loan is declined to the group.

This apart, a bank declines a loan to the group if a loan on the land which he has mentioned in the application is

outstanding on the landowner. The Sharecropper Act has also been violated in the scheme. The rule mandates that the landowner who has more than 10 acres of farmland can handover his land to landless farmer in getting a loan.

Landless farmers have demanded to simplify the loan process under the scheme and to make provision of loan to individual farmers instead of a group. When contacted, Bhagydhar Sahu, Block Agriculture Officer, said that every attempt is being made to make the scheme a success in the block as per rules framed by the government

Woman flees village fearing ostracisation

Sajanagad, August 16: A woman in Jharanaghati village under Berhampur police limits in Balasore was forced to flee her village with her family members after a villager warned of ostracising her and her family members as the police failed to act on her complaint, a report said.

The matter came to the fore after the woman was left to starve without food after fleeing her village and admitted to Nilagiri hospital in Balasore district in a critical condition, the report said.



The woman was identified as Chhabi Bindhani, 30, wife of a migrant labourer Raju Bindhani at Jharanaghati village under Pithahata panchayat of Nilagiri block and Berhampur police limits.

The woman narrated her ordeal before the

media persons when they visited her and demanded justice for her and family members. However, police are yet to speak on the issue or register a case on her written complaint. The incident has spread anger and shockwaves in the district. Reports said that Chhabi was staying with

her three children at home in the absence of her husband. Trouble started after a co-villager Bhilu Bagal and his family members suspected her fidelity and started abusing her. Bagal even threatened to ostracise her by depriving her of fire and water.

Shocked over the development, the woman informed her husband and lodged a complaint at the local police station, August 11.

Enraged over her move, Bagal banned her from using fire and water in the village and threatened her family members of serious consequences. Panicked, she finally decided to leave the village as police did not act on her complaint even after two days.

Later, she along with her family members fled the village through the backyard of her house. Her health condition deteriorated after she failed to get any food after leaving her village. Later, she was admitted to the hospital.

State witnessing rise in sale of vehicles running on clean fuel

Bhubaneswar, August 16: After decades of dependence on fossil fuel. the transport system in Odisha is gradually witnessing a transition to cleaner fuel for both private as well as public vehicles.

Data available from the Ministry of Road and Surface Transport claim that over past several years, more and more vehicle owners in the state are showing interest in electric vehicles, hybrid vehicles and non-polluting energy such as compressed natural gas (CNG).

While the number of vehicles run on petrol is highest, the share of cleaner fuels is gradually increasing its presence in the automobile sector.

As per official data, April 1, 2021 onwards, the state witnessed registration of 2,83,450 and 37,133 vehicles run on petrol and diesel respectively. During the same period 2,229 hybrid vehicles were sold across the state the third highest number after petrol and diesel vehicles.

Interestingly, electric vehicles were the fourth dominating category with registrations of 1,752 electric vehicles between April 1, 2021 and August 14, 2021. Similarly, 72 CNG vehicles and 286 petrol/CNG vehicles were registered with the state transport department

Sabka Prayas

he Prime Minister's Independence Day speech delivered from the ramparts of the Red Fort has turned out to be an exercise in hyperbole rather than a blueprint for what his government proposes to do to tackle the grave problems on ground ravaging the country's economy and wreaking havoc on the lives of citizens in the grip of the COVID-19 pandemic. The PM did what he is so good at, which is to weave verbal magic, churning out catch phrases and slogans and drawing up grandiose plans which are either poorly executed or remain only on paper. He has been doing this since he delivered his first such speech after assuming office in 2014. This year's notable coinage of catch phrases is - 'sabka prayas'- which is an addition to the already existing slogan of 'sabka saath, sabka vikas, sabka viswas.' The mantra is followed more in breach than in observance.

We need to understand what that Sabka Prayas phrase implies. There is something called the Ben Franklin effect. The Ben Franklin effect is a proposed psychological phenomenon: a person who has already performed a favor for another person is more likely to do another favor for the other than if they had received a favor from that person. Let us think back to the last few years.

Swachh Bharat or Clean India was a central government program. A tax in the form of a cess was imposed on the citizens to fund this program. The cleanliness drive was a complete failure. One of the best examples to check on was visible near the exit gates of the New Delhi Railway Station. Yet the PM asked every Indian to contribute 100 hours towards the cleanliness drive. Now look! Most Indians have forgotten about the drive as also that they are still paying the Swachh Bharat cess.

Surrender LPG subsidy was another call for action by the PM. People went $\,$ haywire and were comfortable to socially enquire from friends and relatives

whether they had given up the subsidized cylinder. We all know now where all that sacrifice has landed and which corporate is immensely benefitting from it. The task however was left on the citizens to implement. Today, if anyone questions as to who benefitted from surrendering LPG subsidies, people in general feel as if their pro-nation activities are being questioned



One is reminded about what the PM had said after surprising the nation with his

Demonetization decision 8 November 2016. He had then asked citizens to shoulder the hardship for a short while in the interest of the nation and requested for 50 days of patience. People felt their sacrifice would eradicate black money, combat terrorism and currency counterfeiting and halt corruption. It was made out to be everyone's battle against these evils. While a blossoming economy of the country died a sudden death, most people even today are unwilling to accept that this single executive decision has broken the back of

When COVID struck the country, the PM asked for patience while imple menting an almost overnight lockdown, leading to a migrant crisis of epic proportions. Then Indians were asked for various favors including banging pots and pans and lighting candles to ward off the virus. When COVID spread and deaths increased, it was projected as the failure of the people to abide by mask wearing, social distancing and other mandates. More patience and cooperation was asked of people. With COVID raging on even today, instead of blaming the vaccination shortages or the neglected healthcare infrastructure of the country, people lament on not having done more themselves

Interestingly, with such tasks placed on the shoulders of citizens on a daily basis, when any of these programs fail, it is the failure of every citizen. The citizen therefore is defensive and angry if any one points out those failures. The average Indian feels so invested in these processes that no one questions the absurdity of the planning, designing and execution of the programs. A dog chasing to bite its tail goes round tirelessly without achieving any results. This is the exact kind of motion that many Indians have been put into while the folks in power have cleverly maneuvered to not be held accountable for any of their acts.

Orrery

The orrery was invented by George Graham about 1710; the first example was constructed by the London instrument maker John Rowley. It was a device of arms and balls and gears, run by clockwork, that showed how the planets and their satellites moved around the sun as time passed; the Earth typically took about ten minutes to go round once, so it could hardly have been an enthralling spectacle by the standards of today. We ought to call it a graham, after its inventor, but John Rowley made a copy for Charles Boyle, the fourth Earl of Orrery, and ingratiatingly named it in his honour. It's really a reference to a geographic area, since the Boyles took their title from an ancient term for a part of County Cork, Ireland. (Boyle was described later that century as "one of the literary ornaments of the reign of Queen Anne"; he was a relative of the more famous Robert Boyle, he of Boyle's law.) The orrery became a popular amusement and teaching device; no progressive educational establishment was without one. But not everybody was enthralled by it: in 1833 the Astronomer Royal, John Herschel, called it a "childish toy", and Charles Dickens wrote an unflattering description of a public lecture that featured one in The Uncommercial Traveller: "My memory presents a birthday when Olympia and I were taken by an unfeeling relative — some cruel uncle, or the like to a slow torture called an Orrery ... It was a venerable and a shabby Orrery, at least one thousand stars and twenty-five comets behind the age Nevertheless, it was awful".





Instead of an obsessive desire to lose weight, those who suffer from orthorexia have an unhealthy obsession with healthy eating. In their search for dietary purity, they may become so restrictive about what they eat — for example, avoiding fatty foods, those containing preservatives, those with salt or sugar — that eventually they become as dangerously thin as an anorexic. The word, and the identification of the condition, is attributable to a Colorado specialist, Dr Steven Bratman, who published a book on it in 2001, describing the condition as a "fixation on righteous eating". He coined orthorexia in 1997 on the pattern of anorexia, from Greek orthos, "correct or right", plus orexis, "appetite". A person with the condition is an orthorexic.



crazy, experiment to give every adult the right to vote. Democracy unleashed from the word go. No other modern nation has done it. Would it survive as a single nation? Would not competitive politics further divide the nation? Not only has the nation survived, but democracy has also thrived. Its health can never be taken for granted, but it is more robust now than it was in 1947. India is very much a free democracy. But as the famous quip goes, "eternal vigilance is the price of freedom and democracy." India's democracy project is akin to a company, which is run by a management team appointed by the shareholders. The managers are the elected representatives and officials of the government at all three tiers, and the shareholders are the citizens and voters. If the management is hijacking the company, it is as much a fault of the silent, indifferent, complacent shareholders or voters, as the wrongdoers themselves. Of course, the 'regulators' -- the courts, the Lokpal, the Constitutional authorities -- are all responsible for

how well the 'company' is doing. There are so many metrics along which we can measure the performance of the 'company', or

rather the Republic of India. For instance, we could measure, how well have we done on the socio-political metrics. Have we been able to overcome social hierarchies to be able to give every citizen an equality of opportunity and access? On the political metric, do we have a genuinely representative democracy that represents every Indian's voice? The ultimate minority in any society is the individual. Thus, protection of minority rights means protecting the individual's rights. Those rights are both positive and negative. The positive rights are right to freedom of expression, to freely move anywhere in the country, to pursue livelihood and practice one's faith. The negative rights include right not to be harassed by the police or any organ of the state, at least not without due process. Many of these metrics can be measured and quantified in a fairly objective way. We can measure how we stand in comparison to other democracies of the world. It is however more important that we are progressing along our own historical path. That is irrespective of how we stand in comparison to other countries, are we doing better as a robustly func-

tioning democracy than in 1947? Are we better at our platinum jubilee than we were at the golden jubilee?

Apart from the socio-political dimensions are the economic development dimensions. Here we can use many indicators, such as per-capita income, literacy rate, school and college education attainment, access to drinking water and electricity, access to medical facilities, job opportunities and so on. Is it possible to coalesce all these into one or two meaningful indicators, easy to track and that can give a sharp estimate of where we stand? One is reminded of 'Project Tiger' launched nearly 50 years ago. The basic idea of that project is that by focusing on the health and habitat of the tiger, it was an indirect way of ensuring the health of the entire system of flora and fauna, of forests and wildlife. For if the tiger was prospering, then so were its prey, like deer and bison, which meant there was adequate green vegetation providing food and habitat to the lower organisms in the food chain. Similarly, if one were to focus on a 'Project Tiger' metric to capture economic development in India,

In the early 1970s, Professor MD Morris was given the task of devising a quality-of-life index. He developed the physical quality of a life index, which later was adopted as a Human Development Index (HDI) by the United Nations Development Programme. The HDI is a simple average of three components, income, life expectancy and literacy. The first is an economic variable, the second is about health and the third is about education. All three are also included in the 17 Sustainable Development Goals (SDGs) adopted by all members of the United Nations in September 2015. India's HDI rank in 2019 was 131 out of 189. The HDI rank is a relative ranking, so if your peer countries are progressing faster than you, then your rank falls back, even if you have done much better than your previous year.

The HDI rank is one metric that we must focus on. It can be measured in a highly disaggregated way You can have an HDI for the whole nation, or for each state of India or a separate one for urban and rural areas of each state, or broken down into male and female HDI, or even in a more granular fashion As such we have already identified the 100 most backward districts of India, which we term as 'aspirational' whose HDI is very low. One can quibble that even the HDI is an 'average' so it misses out on high performance islands. If one has to focus on only one metric, what would that be? What is the 'tiger' in this project approach? Some economic studies suggest, if there is a single metric to chase, it is the infant mortality rate (IMR) at age one. This is the number of deaths of children under one year of age, for every 1000 live births. For India this number is about 30. India has a higher IMR than neighbours Bangladesh, Nepal and Bhutan. The best in the world is 1 or 2. Imagine achieving this aspirational IMR benchmark. This is the project 'tiger' that we need to work on.

Does Taliban victory mean a Pak triumph?

THE TALIBAN **TODAY ARE NOT** THE ONES WHO **WON IN 1996. THE NEW TALIBAN HAVE SHIA AND UZBEK COMMANDERS**

Afghanistan is somehow victory for Pakistan too. To the contrary, Pakistan's problems begin now. Pashtun population on both sides of the border is just one of them. The failure of the Istanbul conference on Afghanistan reflects Pakistan's inability to persuade the top Taliban leadership to attend what was billed as a 10-day jamboree. All participants, including Ashraf Ghani, were expected to emerge having sorted out Afghanistan from A to Z.

Nothing of this happened. Turkish Foreign Minister, Mevlut Cavusoglu came down a few notches in his boss, Tayyip Erdogan's esteem. The Foreign Minister believed that Pakistan would deliver the Taliban

at the conference. It could not. Describing Indo-Pak dynamics on Afghanistan as a zero-sum game has antecedents. In 2010, Gen. Stanley McChrystal, as the force commander in Afghanistan, was unhappy that the popularity of India's socio-economic development work distracts Pakistan from its waron-terror focus. To this, Gen. David Petraeus added his bit: "India's Cold Start doctrine worries Pakistan." It is impossible for an itinerant journalist to gauge public interactions in Kabul, Gardez and Mazar-e-Sharif some years ago surprised me: Pakistan was seen as a troublemaker. India's development works were appreciated. At night all of Kabul was glued to Bollywood on TV.

After US Deputy Secretary, Richard Armitage threatened to "bomb Pakistan into the stone age' a terrified President Pervez Musharraf made a U-turn. His army turned upon exactly the mujahideen that ISI had trained to see the back of the Soviets in 1989. This about-turn by Pakistan became part of the historic memory of Taliban. That's the rub: the 'unreliability' quotient of Pakistan was cited even by the Taliban spokesman who showed disinterest in the Istanbul conference.

Abdus Salaam Zaeef was the Afghan Ambassador in Islamabad and a friend of the late Mullah Omar. After Pakistan joined the war on terror. Zaeef found himself in Guantanamo Bay for four years. Zaeef was bitter: "The manner in which they treated our prisoners was worse than the Israeli treatment of Palestinian prisoners." These plaints belong to an era many moons ago. Surely, the situation has changed after Prime

who won in 1996. The new Taliban have Shia and Uzbek commanders too but keep your fingers crossed for the women of that country.

Was this collapse of a large section of the Afghan Army unexpected? Is one to believe that greenon-blue attacks had ended just because the US media had stopped reporting such incidents? US officers training the Afghan army were frequent victims of their own trainees. Little wonder President Joe Biden was almost hitter "I don't regret the decision to withdraw.

He said the US had spent \$3 trillion for 20 years training and equipping an Afghan Army of 3,00,000. "Now it is time for the Afghans to sort it out among themselves.'

Years ago, a former Governor of Balkh, Prof Habibullah Habib, told me a story which sounded conspiratorial then. "The British Provincial Reconstruction team was doing excellent work in the north of the country." Why did they so willingly agree to vacate the peaceful region for the Germans to take over? What surprised Prof Habib even more was the alternative destination selected by the British contingent. They chose to be headquartered in the troubled

t is a flawed line of thinking opinion across the board, but my Minister Imran Khan took charge. province of Helmand - why?

have been answered two days ago by a former British Defence Minister, Johnny Mercer, who served in Afghanistan: "A lot of British blood was spilled in Helmand." He asks angrily: "Was it really for nothing?" Helmand is the world's largest centre for poppy production which blossomed in 20 years of the war.

His colleague, another Defence Minister, Tobias Elwood has gone one better; he wants Afghanistan re-invaded.

Criminalisation of politics

Sir, The Supreme Court and the high courts have always batted for transparent and accountable politics in the country. The 2018 Constitutional Bench headed by then Chief Justice of India, Dipak Misra, in Public Interest Foundation versus Union of India, not only made public declaration of all assets by contesting candidates compulsory, but also barred candidates with criminal charges from contesting any election. However, several loopholes remained unaddressed, and were exploited by wily politicians. The foremost -- candidates with pending cases could still contest as is happening now. Looking back, will there be any politician left to contest elections if this rule is scrupulously adhered to? Reasons for giving ticket to a candidate with criminal antecedents, the SC had said, are to be put on party websites and social media accounts. Well, nothing much appears to have happened on this front. But the latest SC verdict has come down heavily on political parties failing to comply with its order. The top court has fined several political parties for disobeying it. It also has modified some of its own directions. What the court has done is to minimise the reason of 'winnability' cited by parties for doling out tickets to tainted politicians. Credibility, qualification, performance and merit of a candidate should matter for parties as much as the ability to win. However, lack of transparency and accountability in political contributions, and the absence of an independent audit of such transactions, may continue to help tainted candidates. Moreover, the onus also lies on the voters who will have to make wise choices.

Malkangiri, August 16: Out of the ₹100 crore announced by Chief Minister Naveen Patnaik after inaugurating Gurupriya bridge July 26, 2018 for the development of pisciculture as well as the fishing community in the district under the 'Socio-Economic Transformation and Upliftment' (SETU) programme, so far only ₹18 crore has

SETU vojana is for the development of Swabhiman Anchal, the erstwhile cut-off region in the district, now connected with the mainland.

The residents of the district, including the fishermen, held the district Fisheries department and Odisha Pisciculture Development Corporation (OPDC) responsible for the inability to spend the fund for

The assured money was given to the district Fisheries department to increase the production of fish in Chitrakonda, Satiguda and other medium reservoirs. But, the department failed to spend the money. In three years, it could just spend ₹18 crore. At the same time, due to the negligence of the OPDC, hundreds of fishermen are yet to get fishing equipment like fishing boats, nets and life jackets. As of now, they are forced to fish putting them in harm's way. In the last three years, many fishermen

also lost their lives to mishaps as

they didn't have equipment like

Meanwhile, some beneficiaries have dug up ponds to produce fish and fingerlings. For these, they either took loans from banks or invested their savings. But the ultimate result was not satisfactory. Since, these ponds failed to produce fingerlings, some traders from other states are producing and selling fingerlings to the fishermen here at exorbitant prices.

Some fishermen alleged the fingerlings sold by traders from other states are of inferior quality.

The onus lies with the OPDC for its failure to set up fingerling production centres in the district. Instead, the OPDC procured fingerlings from Bolangir, Kalahandi, Ganjam and Bhubaneswar and brought them to Malkangiri district, spending extra money on fares. These fingerlings were released in Chitrakonda and Satiguda reservoirs. But, according to the fishermen, these reservoirs don't have fish of the same fingerlings.

When contacted for his comment in this regard, district Fisheries officer Rajendra Patra said 21 beneficiaries dug up ponds on 16.40 hectares in 2017-18. Of them, six took bank loans and 15 invested their own money. They were given ₹41lakh towards rebate.

Similarly, in 2018-19, 98 beneficiaries availed bank loans and 96 spent their own money to dig up

ponds. While ponds were dug up on -69.80 hectares, ₹1.74crore was given to them as rebate. In 2019-20, 77 beneficiaries dug up ponds on 55 hectares and were given ₹1.37 crore as rebate. As many as 118 beneficiaries dug up ponds on 86.30 hectares and were given a subsidy of ₹2.15 crore.

"To release 2 crore fingerlings in several reservoirs in the district. the OPDC and the district Fisheries department were given ₹2.80 crore under the SETU yojana. Similarly, ₹58 lakh was spent to buy 100 fishing boats, nets and life jackets, ₹2.40 lakh spent to give training to 25 societies of fishermen, ₹10,000 to each society. Another ₹48 lakh has been sanctioned to construct a house at Chitrakonda. The work on the house has not been started as vet since the process of tender is yet to be started. Thus, out of the sanctioned ₹100 crore, only ₹17.48 crore has been spent," informed

The OPDC has received money to provide boats and nets. The contractor who has been awarded the tender to provide boats has not supplied even a single boat so far. The district Fisheries department has also failed in supplying life

"The failure of OPDC and district Fisheries department has resulted fish kept in ice being sold everywhere in the district. People are falling ill after consuming these fish," some residents alleged.

They have urged the government to intervene and initiate steps so that the fingerlings and fish production increases and resultantly the people will no longer suffer from any disease.

The construction work commenced in May, 2017 and the contractor firm was asked to complete the work by December, 2018.

Later, the department felt the requirement of two more spans. As a result, the project cost was revised to ₹30.57 crore.

Pawar says amendment a 'fraud', seeks caste census

Mumbai, August 16: Terming the recent Constitutional Amendment, restoring power to states to have their own OBC lists for reservations in government jobs and education 'a fraud', Nationalist Congress Party President Sharad Pawar Monday demanded a caste-based Census, providing states empirical data and hiking the cap on reservations above 50 per cent.

He said that unless the 50 per cent quota limit imposed by the Supreme Court in its 1992 landmark verdict is relaxed, states cannot prepare their own lists of socially and educationally backward classes (SEBCs). "In reality, it (the amendment) will be of no use... The Centre took away the rights of the states around a couple of years ago to prepare and maintain their SEBC lists and that has been restored now. The government has betrayed the OBCs. Today, almost all states have more than 50 per cent reservations," said Pawar. Giving details, he said the percentages for different states are: Madhya Pradesh - 63 per cent, Tamil Nadu - 69, Haryana - 57, Rajasthan - 54,



Lakshadweep - 100, Nagaland - 80, Mizoram - 80, Meghalaya - 80, Arunachal - 80, Maharashtra - 65, Haryana - 67, Rajasthan - 64, Telangana - 62, Tripura - 60, Jharkhand - 60, Uttar Pradesh - 59, Himachal - 60, Gujarat - 59, Karnataka - 50 per cent, etc.

He said that since the Centre is silent on the issue of relaxing the 50 per cent quota limits, the Maharashtra government will be in no position to restore the proposed 12 per cent in education and 13 per cent in government jobs for the Maratha community that was scrapped by the Supreme Court

While the Centre later gave a 10 per cent quota for Economically Weaker Sections, almost 90 per cent states have exceeded the 50 per cent quota limits, so the Centre's move will be of no use now, he claimed. The NCP chief said the state NCP Minister Chhagan Bhujbal has been repeatedly demanding the empirical data from the Centre to enable the state conduct surveys and prepare their own SEBCs list.

While the previous UPA-II Government had initiated steps in this direction. Prime Minister Narendra Modi's government put this on the backburner, he claimed.

Ganga continues to flood Bihar

New Delhi, August 16: For the second consecutive week, the Ganga is flowing in a severe flood situation, due to combined effects of river runoff from the Yamuna and its northern tributaries.

As per the CWC Flood Forecasting Network, one station in Bihar is is in 'Extreme Flood Situation', 31 stations - 21 are in Bihar, six in Uttar Pradesh, two in Assam and one each in Jharkhand and West Bengal -- are in 'Severe Flood Situation' and 25 stations - 10 in Bihar, six in Uttar Pradesh, seven in Assam and one each in Arunachal Pradesh and West Bengal - are flowing in 'Above Normal Flood Situation'.

The main Ganga stem is flowing in severe flood situation in Ghazipur (Uttar Pradesh) to Murshirabad (West Bengal) districts. From Ghazipur to Ballia (UP), the river is in falling to steady state, whereas from Patna and downstream, it is flowing with rising trend. "Alert may be kept in districts of Varanasi. Ghazipur, and Ballia (UP), Buxar, Patna, Munger, Bhagalpur (Bihar), Sahibganj (Jharkhand), and Malda and Murshirabad (West Bengal). Propagating peak inflow will further increase the water level of main Ganga stem in Bihar, Jharkhand and West Bengal in next 2 to 3 days," the CWC said.

At the Bhagalpur site of the CWC, water level of Ganga was expected to cross high flood level. Middle reaches of Ganga in districts such

as Badaun and Farrukhahad (UP) are in above normal flood situations, River Ghaghra in Barabanki, Avodhva & Ballia (UP) and Siwan and Saran (Bihar) districts is flowing in above normal to severe flood situations with rising trend due to past two days rainfall in the catchment. The Rapti is flowing in severe to above normal flood situation in Balrampur, Siddharth Nagar and Gorakhpur districts (UP). River Sone and Punpun are flowing in severe flood situation in Patna.

"Currently, the flood that originated in tributaries of Yamuna last week is passing through Ganga and it may take another 3 to 4 days to pass through completely; in such situation further runoff created due to intense rainfall in the catchments of north tributaries of Ganga may not stream into Ganga easily. The flooding situation in districts such as Ballia (UP), Saran, Bhagalpur, Khagaria, Vaishali, and Katihar (Bihar) may get accentuated." the CWC warned.

Mumbai, August 16: Authorities in India's financial capital Mumbai have almost fully resumed suburban rail services for the first time in more than a year, as part of a wider easing of COVID-19 restrictions, as the pace of infections de-

Previously, only essential workers were allowed to use the trains. but those who are fully vaccinated were allowed on board trains from Sunday. Parks, seafronts and playgrounds were also allowed to stay open for all until 10pm, from the previous closing hours of 4pm, the city's civic body said.

Monday, the second day that trains were 95% open, crowds were sparse because of a public holiday. In normal times, more than 8 million people travel on Mumbai's local trains every day, but services have been closed to commuters since March 2020, when the first COVID-19 related lockdown was

announced in the state. In February this year, commuters were allowed on trains at non-peak hours, before being shut again as the country faced a devastating



second wave that killed hundreds of thousands.

The thriving metropolis in the largest industrial state of Maharashtra, saw a peak of 11,000 daily cases a day at the height of the second wave in May-June, but new cases have fallen after stringent lockdown curbs, with overnight infections dropping to 267 new

cases and four deaths Sunday. India is relying on two homeproduced vaccines, Astra Zeneca's Covishield, which is manufactured in India by the Serum Institute of_ India, and Bharat Biotech's Covaxin. Almost half of India's 950 million adults have received at least one

BIHAR CAN CONDUCT CASTE CENSUS ON ITS OWN: DY CM

Patna, August 16: Amid the rift between the BJP and the JD(U) over caste based census, the former seems to have softened its stand on the issue. Bihar's deputy chief minister Renu Devi has said that the state government can conduct a caste based census on its own.

Renu Devi, during the Sahvog programme Saturday said: "The Karnataka and Odisha governments have conducted caste based census at their own expense. The Bihar government is also independent on opting for the same. However, the central government has a clear stand of not to conduct caste based census in the country."

Earlier, Bihar chief minister Nitish Kumar while advocating a caste based census, wrote to Prime Minister Narendra Modi urging

him to consider the same. Some JD(U) ministers have openly said that if the Centre would not conduct a caste based census, the Bihar government is capable of doing that at its own expense

Besides Renu Devi, Ram Surat Rai, another minister in the Nitish Kumar government under the BJP quota, advocated a caste based census in Bihar.

The Bihar legislature has twice passed a resolution for a caste based census unanimously --February 18, 2019 and February

The $\ensuremath{\mathrm{JD}}(U)$ has support from the opposition RJD and another ally of the NDA -- the Hindustan Awami Morcha (HAM) -- on the issue.

The BJP has however supported caste-based census only for SC/ST, which constitute only 15 per cent of the total population.



Centre allocated ₹267.35cr to Kerala

3 Naxals held

Raipur: Three lower-rung Naxals, who were allegedly involved in the killing of a civilian in 2019 and also in incidents of damaging roads, were arrested in Chhattisgarh's Dantewada district, police said Monday. 'WILL STAND BY OUR **AFGHAN PARTNERS'**

India is in constant touch with the representatives of Afghan Sikh and Hindu communities, said the Ministry of External Affairs Monday asserting that the country will facilitate repatriation to India of those who wish to leave Afghanistan

New Delhi, August 16: India Monday said it will "stand by" its Afghan partners, take all steps for the security of Indians and its interests in Afghanistan and facilitate the repatriation of Sikhs and Hindus who wish to leave the wartorn country, in its first reaction following the takeover of Kabul by the Taliban.

External Affairs Ministry spokesperson Arindam Bagchi said the situation in Afghanistan is being monitored on a constant basis at high levels and that the suspension of commercial operations at Kabul airport has forced a "pause" in India's repatriation efforts. Capping its month-long rapid advances, the Taliban took positions in Kabul on Sunday evening hours after Afghan President Ashraf Ghani left for an unknown destination, paving the way for the takeover of the capital as well as the country

"The security situation in Kabul has deteriorated significantly in the last few days. It is changing rapidly even as we speak. The Government of India has been closely monitoring all developments in Afghanistan," he said.

Bagchi was replying to media queries on the situation in

Afghanistan following the takeover of the country by the Taliban. "We are in constant touch with the representatives of Afghan Sikh and Hindu communities. We will facilitate repatriation to India of those who wish to leave Afghanistan," the MEA spokesperson said. "There are also a number of Afghans who have been our partners in the promotion of our mutual developmental, educational and people-to-people endeavours. We will stand by them," he said.

Bagchi said India is waiting for the resumption of flights to restart the repatriation process. "Commercial operations from Kabul airport have been suspended today. This has forced a pause in our repatriation efforts. We are awaiting the resumption of flights to restart the process," he said.

"The situation in Afghanistan is being monitored on a constant basis at high levels. The Government will take all steps to ensure the safety and security of Indian nationals and our interests in Afghanistan," Bagchi added.

The MEA spokesperson also referred to periodic advisories issued by the Indian embassy in Kabul for the safety and security of Indian nationals in that country, including calling for their imme-

Students return to classes in more states

New Delhi/Lucknow, August 16: Uttar Pradesh and Andhra Pradesh Monday joined the states where schools have cautiously restarted physical lessons after the ebbing of Covid-19 cases, while in Uttarakhand and Bihar, students of more classes returned to the offline mode.

States which had started physical classes in schools after a gap of a year were again forced to order closure due to the second wave of coronavirus in March-April this year. Schools across Haryana, Gujarat, Odisha and Madhya Pradesh, however, began reopening after mid-July in a staggered manner, starting with grades

A 50 per cent cap on attendance



and holding of classes in shifts to ensure social distancing, sanitisation and mask-wearing were among the Covid-19 norms being followed by the schools, which largely reported thin attendance.

Similarly, states like Punjab, Himachal Pradesh and Chhattisgarh had resumed physical classes from August 2, while

Karnataka is planning to do so from August 23. Schools for classes 9 to 12, universities, colleges and coaching institutes will be allowed to reopen in Rajasthan from September 1 Earlier this month, the Uttar Pradesh government had announced that schools would reopen for students of classes 9 to 12 from August 16 with 50 percent at-

On Monday, some schools started offline classes in shifts while adhering to Covid protocols, but the attendance was thin

The state government said teaching activity may be considered for classes 6 to 8 from August 23 and for classes 1 to 5 from September 1.

The Cathedral Senior Secondary School in Lucknow said about 100 students attended classes Monday.

India needs to strengthen security set up at J&K borders: Experts

THERE ARE **APPREHENSIONS THAT PAKISTAN'S ISI MAY PUSH AFGHAN MILITIA INTO J&K TO DISTURB THE** PREVAILING SECURITY **SCENARIO**

New Delhi, August 16: In the wake of the Taliban taking full control in Afghanistan, experts have cautioned the Indian security agencies to increase vigil on the international border with Pakistan in Jammu and Kashmir.

There are apprehensions that

Pakistan's ISI may push Afghan

militia into Jammu and Kashmir to disturb the prevailing security scenario.

In this regard, they have anticipated that the redeployment of Pakistani terrorist groups like Lashkar-e-Taiba (LeT) and Jaishe-Mohammed (JeM), who have targeted Jammu and Kashmir and other parts of India in the past, may be activated again.

'The security agencies in India need to be careful and on high alert and need to take all possible steps to check the infiltration from the Pakistan side into Jammu and Kashmir: The ISI was also instrumental in pushing the Afghan militia into J&K when they were ousted from Afghanistan after the US security forces launched military operations against them," former Home Secretary GK Pillai said in a statement. A senior official in the



security set up said on the condition of anonymity that this may seriously undermine the aspirations of the Kashmiri population for peace and the desire of the Indian government to work for

the sustainable development of the region. Referring to the Soviet invasion and occupation of Afghanistan in 1979 that witnessed a heavy resistance movement by the Afghan local militia for eight years

when the Soviet troops withdrew in 1988, the experts recounted how Pakistan's deep state diverted vast stockpiles of Afghan war arms and ammunition to Kashmir in the late 1980s to fight a proxy war that continues till date.

However, some experts also feel that it is a little early to speculate about such things as the present Taliban appears to be different

from what it used to be in 1999. "This is a little premature to speculate such terror threats on Jammu and Kashmir as the Taliban are in the process of settling down in Afghanistan but the security forces need to be on high alert in J&K to prevent such incidents", former DGP of J&K Police Ashok Prasad, said.

Noting that this Taliban are different from what it used to be in the past, he said that the Taliban is in

the process of settling down in Afghanistan, and they will aim to get recognition of their government from other countries before embarking on such endeavours. Taliban insurgents swept Kabul after the US-backed Afghan government collapsed and President Ashraf Ghani fled the country on Sunday, bringing an unprecedented end to efforts made by the US and its allies to transform the war-ravaged nation in the last two decades.

India has been a key stakeholder in Afghanistan and it has invested nearly \$3 billion in carrying out nearly 500 projects across that country. Afghanistan's security forces collapsed or fled in the face of a Taliban offensive that tore through the country, ahead of the plannedwithdrawal of the last American troops at the end of the month.

What does the Taliban takeover mean for women?

Many fear it could mean a severe rollback of rights. Afghan women have made major gains since the overthrow of the Taliban. Many are worried they will once again be confined to their homes. The Taliban have said they are no longer opposed to women attending school but have not set out a clear policy on women's rights. Afghanistan

Will the Taliban once again

harbor Al-qaida? That's anyone's guess, but American military officials are worried. In the peace deal signed with the United States last year, the Taliban pledged to fight terrorism and prevent Afghanistan from again becoming a base for attacks. But the US has little lever-

age to enforce that. Technological advances over the last 20 years allow the United States to target suspected militants in countries like Yemen and Somalia where it does not have a permanent troop presence. The Taliban paid a heavy price for their role in the September 11 attacks and likely hope to avoid a repeat as they seek

to consolidate their rule. But earlier this year, the Pentagon's top leaders said an extremist group like al-Qaida may be able to regenerate in Afghanistan, and officials are now warning that such groups could grow much faster than expected.

Afghanistan is also home to an Islamic State group affiliate that has carried out a wave of horrific attacks targeting its Shiite minority in recent years. The Taliban have condemned such attacks and the two groups have fought each other over territory, but it remains to be seen whether a Taliban government will be willing or able to suppress IS.

Within a little more than a week, Taliban fighters overran more than a dozen provincial capitals and entered Kabul with no resistance, triggering the departure of Afghanistan's president and the collapse of his government. Afghan security forces in the simply melted away. By nightfall, police checkpoints were left abandoned and the militants roamed the streets freely.

The pace of the military collapse has stunned many American officials and other foreign observers, forcing the US government to dramatically accelerate efforts to remove per sonnel from

retrospective taxation to come soon, says FM



New Delhi, August 16: Finance Minister Nirmala Sitharaman Monday said that the rules for the recent taxation amendment bill will be framed soon. "We will have to wait for the rules to be framed under the recent taxation amendment bill," she said during an interaction with reporters here.

The Taxation Laws (Amendment) Bill, 2021 was passed by the Parliament in the recently concluded Monsoon Session, to do away with the contentious retrospective tax demand provisions and its passage may end the much stretched tax disputes with UK's Cairn Energy, and Vodafone Plc.

The Bill has amended the Income Tax Act, 1961 so as to provide that no tax demand shall be raised in future on the basis of the said retrospective amendment for any indirect transfer of Indian assets if the transaction was undertaken before May 28, 2012 - when the finance bill was passed by the Parliament in 2012

On the GST compensation issue, Sitharaman said that if GST revenues collection continues like this, then the Centre would be able to pay compensation as per the agreement.

She noted that the Centre will have to consult with states in the GST Council to assess the situation on repayment of borrowing be-

Rules for withdrawal of WPI inflation eases to 11.16% in July

The high rate of inflation in July 2021 is primarily due to low base effect and rise in prices of crude petroleum and natural gas, mineral oils and manufactured products as compared to the corresponding month of the previous year

New Delhi, August 16: Easing prices of food products, primary articles sequentially decelerated India's July 2021 wholesale inflation. The annual rate of inflation, based on wholesale prices, was at 11.16 per cent last month from 12.07 per cent in June.

However, on a year-on-year (Y-o-Y) basis, the Wholesale Price Index (WPI) data furnished by the Ministry of Commerce and Industry has risen exponentially over July 2020, when it stood at (-) 0.25 per cent.

'The annual rate of inflation is 11.16 per cent (Provisional) for the month of July 2021 (over July 2020) as compared to ((-) 0.25 per cent) in July 2020. The high rate of inflation in July 2021 is primarily due to low base effect and rise in prices of crude petroleum and natural gas, mineral oils, manufactured products like basic metals, food products, textiles, chemicals and chemical



products etc. as compared the corresponding month of the previous year," the ministry said in its review of 'Index Numbers of Wholesale Price in India' for July.

On a sequential basis, the expenses on primary articles, which constitute 22.62 per cent of the WPI's total weightage, increased at a slower rate of 5.72 per cent

than 7.74 per cent in June 2021. Similarly, the prices of food items

rose on a slower rate at 4.46 per cent from 6.66 per cent reported for June. On a Y-o-Y basis, the cost of the

fuel and power category rose by 26.02 per cent against a rise of (-) 9.84 per cent Y-o-Y. 'The WPI inflation cooled for

the second month in a row to 11.2 per cent in July 2021, modestly trailing our expectation (11.5 per cent), benefitting from a favourable base effect, a welcome softening of food price pressures and the uncertainty related to the Delta plus variant arresting the rise in commodity prices," ICRA Chief Economist Aditi Nayar said.

India Ratings & Research Principal Economist Sunil Kumar Sinha: "This is partly due to base effect as the WPI witnessed deflation during April-July 2020. However, deflation in WPI has been witnessed earlier also during November 2014-June 2016 but it did not give rise to double digit or high inflation in the following year."

"The key differentiator is global commodity prices, especially the crude oil prices. Sustained high taxes on petroleum products has worsened the matter even more leading to retail petrol prices breaching the ₹100 per litre mark at several places.

STEEL INDUSTRY CAPACITY UTILISATION

State incurs ₹7,770 crore revenue loss, job opportunities in 2020-21

Bhubaneswar, August 16: Odisha lost around ₹7,770 crore of revenue and thousands of employment opportunities in 2020-21 because of the underutilisation of the installed capacity of steel, pellet and sponge iron plants in the state, industry experts said. As per information from the

government's Steel & Mines Department, out of the total installed capacity of steel of 33 MTPA. Odisha-based steel plants produced 20.5 MT steel in FŸ 2020-21. The experts said that the loss of

production by these industries is primarily due to low production and huge dispatch of iron ore outside Odisha by the merchant mines.

"Former CM, Biju Patnaik, who



pioneered industrialisation in Odisha had envisioned 100 per cent utilisation of raw materials produced in Odisha by state-based industries only.

Contrary to his vision, merchant mines are diverting 80% of iron ore out of the state. The continued manipulation of iron ore availability and prices will lead to the end of the Odisha Steel industries and MSMEs, with 40% capacity unused that day is not far", said BS Pani, an industry expert. The experts also said that if adequate iron ore could be made available in Odisha, the steel industries could have produced as per their installed capacities, generating much more revenue for the state. "In the last fiscal Odisha mer-

chant mines produced 23% less iron ore, compared to the financial year 2019-20. During the year, around 80 percent of the iron ore produced in Odisha was taken outside the state.

This has created a severe shortage of iron ore for Odisha based plants evidenced by the highest ever surge of iron ore prices in the state situation is critical as some MSMEs are even facing the threat of closure due to raw material scarcity" said a senior official.

SAUDI ARAMCO-RIL **DEAL TALKS IN ADVANCED STAGE**

Aramco is discussing the purchase of around 20 per cent stake in the Reliance arm for about \$20-25 billion, reports have said. A query on the matter from RIL did not elicit a response while mail sent to Aramco remained unanswered till the filing of the story.

Tariff hike key to

New Delhi, August 16: Amid an existential struggle, Vodafone Idea Monday said while its recent tariff tweaks are steps in the right direction, such changes are not enough to solve the industry's structural issues, and tariff hikes and floor pricing remain critical for

the sector revival. Speaking during the Q1 earnings call, Vodafone Idea CEO Ravinder Takkar said although Kumar Mangalam Birla recently stepped down as chairman of Vodafone Idea, "he as well as Aditya Birla Group (ABG) and the Vodafone group are committing to providing support and guidance to the company, in line with the stated positions of both the groups".

'We will thus continue to get the benefit of their experience and support," Takkar said. On fundraising, Takkar maintained that VIL continues to remain in active discussions with potential investors.

Citing the recent "tariff interventions" undertaken by VIL, including entry-level corporate postpaid plans and other offerings, Takkar said, "While these tariff interventions are steps in the right direction and will help in improving ARPU, such changes are not material enough to solve the structural issues that the industry is facing".

The company continues to engage with the regulator on floor pricing, which is "critical and necessary" to improve the overall health of the industry, he observed.

Aramco will be to be formalised in an "expeditious manner during this year", after obtaining required regulatory clearances.

Aramco Chairman Yasir Al Rumayyan has been appointed as an independent Director of RIL with effect from July 19.

Ambani had said that Rumayyan's joining the board is also the beginning of internationalisation of Reliance and more announcements on international plans of the company would come in times to come.

Basel, August 16: Roger Federer is going to miss the US Open and be sidelined for months because he needs a third operation on his right knee, a procedure he said will leave him with "a glimmer of hope" that he can return to competition.

Federer announced the news Sunday via a video message on Instagram. "I've been doing a lot of checks with the doctors, as well, on my knee, getting all the information as I hurt myself further during the grass-court season and Wimbledon," Federer said.

"Unfortunately they told me for the medium- to long-term, to feel better, I will need surgery, so I de-

cided to do it. I will be on crutches for many weeks and then also out of the game for many months."

The 40-year-old Federer, who has 20 Grand Slam singles titles to share the men's record with Rafa Nadal and Novak Djokovic, acknowledged there was a chance his playing career could be over, but he said he would rehab the knee with the goal of making another comeback.

"I want to be healthy. I want to be running around later, as well, again, and I want to give myself a glimmer of hope, also, to return to the tour in some shape or form,' Federer said. "I am realistic, don't get me wrong. I know how difficult it is at this age right now to do another surgery and try it.'

Son gives Cityzens hard time

London, August 16: If this was a first taste of life without Harry Kane for Tottenham, maybe that prospect isn't so terrifying after all. At least not while Son Heungmin is still at the club.

Son netted a second-half winner Sunday as Tottenham opened the Premier League season with an impressive 1-0 home victory over defending champion Manchester City—the team that has spent the summer trying to buy its talisman

New Tottenham manager Nuno Espirito Santo left Kane out of his team altogether amid continued speculation about a pending move to City, but still ended up with a statement victory on his debut.

Son finished off a quick counterattack in the 55th minute and Tottenham effectively neutralized City's many attacking threats in front of a packed home stadium of about 58,000 fans.

Kane's absence was the big pregame talking point, although Nuno said the decision was made solely because the England striker only returned to full training Friday after his holiday. Son insisted the Tottenham players had no difficulties putting all the speculation aside.

Based on this performance, City might need Kane more than Spurs do—especially after letting Sergio Aguero leave on a free transfer this summer.

This was the final game of a crowd-pleasing opening Premier League weekend and City was the only big title contender that failed to start with a win. Chelsea, Manchester United and Liverpool all opened with big victories Saturday.

City dominated possession but struggled to break down a disciplined Tottenham side, which was content to sit back and wait for opportunities to counter.

City's record signing Jack Grealish showed early flashes of his abilities - breaking forward in the opening minutes to draw a free kick just outside the area — but missed his best chance to score when his shot from a tight angle was easily saved by Hugo Lloris in the 75th.

Riyad Mahrez had City's best chance of the game in the 35th when he met a cross from Raheem Sterling but shot wide after failing to cleanly connect with the ball.

Son had already threatened on a couple of counterattacks by the time he put Spurs ahead. The South Korea international collected the ball down the right flank, drove at defender Nathan Ake and then cut inside to bend a low shot inside the far post.

Steven Bergwijn had a great chance to double the lead on another counter just before the hour mark, but shot wide. Guardiola brought Kevin De Bruyne off the bench in search of an equalizer and the Belgian forced a save from Lloris with a dipping shot from distance in the 84th.

Madrid, August 16: The post-Lionel Messi era began for Barcelona with fans chanting his name in the stands and players overcoming his absence on the field.

Barcelona's first season without Messi in 17 years started with a 4-2 win over Real Sociedad in the Spanish league on Sunday, with many in the crowd of more than 20,000 at the Camp Nou Stadium paying tribute to the Argentine star and protesting against the

club for letting him go. The majority of fans loudly chanted Messi's name in the 10th minute, a reference to the No.10 jersev he used to wear at the club. Many fans were wearing or carrying Messi's jersey, and several banners honored the playmaker.

"Forever grateful to Messi," read one of them. There were also some jeers against Messi, though, who was already in France with PSG after Barcelona failed to give him a new contract because of its financial struggles. Some fans preferred to chant "Barca, Barca" instead of his name. On the field. Barcelona opened the scoring in the 19th with a header by Gerard Pique, who also was loudly cheered by fans after agreeing to reduce his salary so the club could register other players in time for the opener.

Martin Braithwaite added to the lead with goals in first-half stoppage time and in the 59th. He also assisted in Sergi Roberto's final goal in second-half injury time. Memphis Depay, the club's top offseason signing, helped set up two goals.

Sociedad, coming off a fifthplace finish last season, pulled closer with a goal from Julen Lobete in the 82nd and with a superb freekick — which Messi would have been proud of — taken by Mikel Oyarzabal three minutes later.

The last time there were fans at the Camp Nou was March 7, also in a match against Real Sociedad. Spanish health authorities allowed the league to restart with crowds of up to 40

Correa, starting in attack in place of Luis Suarez, opened the scoring with a low shot from outside the area in the 23rd. He added his second from inside the box in the 64th after Iago Aspas had equalised for the hosts by converting a 59thminute penalty kick following a hand ball by Marcos Llorente.

The benches were emptied in stoppage time after an altercation following a foul by Hugo Mallo on Suarez. Mallo and Atletico's Mario Hermoso got red cards.

Club's debt now at USD 1.6bn

MADRID: Barcelona's president presented a grim picture of the club's financial situation Monday, saying its debt had risen to 1.35 billion euros (USD 1.6 billion).

Joan Laporta blamed the previous administration of Josep Bartomeu for the club's "dramatic" situation that ultimately led to Lionel Messi's departure. Laporta accused Bartomeu of countless "lies" and said he and his board of directors must be held accountable.

Laporta said the club had losses of 481 million euros (USD 567 million) and was left with a negative net worth of 451 million euros (USD 532 million), making it dif-

ficult to negotiate with players. "Our salaries represent 103% of the club's total income. That's 20% to 25% more than our competitors," Laporta said in a news

conference. "We have found our-

selves in a difficult situation to renegotiate the players' contracts."

The club lost star player Messi to PSG this month because it could not give him a new contract that would fit within the Spanish league's strict financial fair-play regulations.

The club's debt included almost 390 million euros (USD 460 million) related to player salaries, Laporta said. More than 670 million euros (USD 790 million) was debts with banks, while some 40 million euros (USD 47 million) was linked to membership losses. The impact of the coronavirus pandemic was 91 million euros (USD 107 million), he said.

Laporta was among those targeted by some fans in the team's Spanish league opener Sunday, when it defeated Real Sociedad 4-2. There were banners outside the Camp Nou criticizing Laporta and accusing him of not doing enough to keep Messi
