

Bhubaneswar, August 18: The National Green Tribunal has asked the Odisha government to notify 14 elephant corridors in the state within the next two months. The order was passed Tuesday, realising a long-standing demand of elephant conservationists.

This development comes after years of exercise for setting up such corridors and subsequent litigations by the 'Wildlife Society



of Odisha' demanding notified paths for the jumbos in the state. This is needed to safeguard the paths taken by the tuskers during their normal movement and also to prevent man-elephant conflict.

In an order passed by the Eastern Zonal bench of NGT, judicial member B Amit Sthalekar and expert member Saibal Dasgupta have asked for notification of the 14 corridors identi-

"In our view, since the action plan has been submitted and 14 elephant corridors have been identified by the State Respondents, Government of Odisha, we, therefore, dispose of this original application with the direction to the Respondent No.1 (state government) to notify the elephant corridors in terms as identified by the Asian Nature Conservation Foundation (ANCF), within a period of two months from today in accordance with law," the written order of the NGT said.

Wildlife conservationist Biswajit Mohanty, through his NGO 'Wildlife Society of Odisha', had moved the NGT. He argued that Odisha hosted the highest number of elephants in eastern India as per the 2015 centified as ecologically sensitive zones under Section 3 of the Environment (Protection) Act, 1986.

The NGT order comes in the wake of rising elephant deaths in Odisha since 2001. As against 33 elephant deaths per year on an average between 1990 and 2000, 46 deaths were reported annually on an average between 2001 and 2010. The figure has gone up to 76 deaths per year since 2010.

Shankar Prasad Pani, NGT lawyer told Orissa POST that recognition of elephant corridors could pave the way for declaration of these areas as sensitive zones similar to other protected areas which can prevent starting and operations of industries and other environment-threatening units.

New Delhi, August 18: Domestic cooking gas LPG price was increased Wednesday by ₹25 per cylinder. This is the second time that LPG prices have gone up in two months. Earlier rates were hiked July 1 by ₹25.50 per cylinder. Subsidised LPG will now cost ₹859 per 14.2-kg cylinder in the national capital, according to a price notification of oil companies. Non-subsidised LPG rates were increased August 1 by the same proportion, and now the subsidised cooking gas prices have been raised. There is hardly any difference in the rate of subsidised and non-subsidised cooking gas. The latest increase in subsidised LPG price now

COAL RATES SET TO RISE

New Delhi: More problems are in the offing for consumers as coal prices may see a substantial hike in the near future. This is because trade unions at Coal India Ltd have demanded a 50 per cent increase in workers' wages. If the demand is met, price of coal will also skyrocket. The trade unions have already conducted their first meeting on salary increase with the management last month. Coal India however, has declined to comment on the issue.

The price of domestic cooking gas has more than doubled in the last seven years. The retail selling price of domestic gas was ₹410.50 per 14.2-kg cylinder March 1, 2014.

In a small relief for consumers diesel prices were cut by 19 to 21 paise across India, while petrol rates remained unchanged, according to the notification.

Bhubaneswar, August 18: The proposed Birsa Munda International Hockey Stadium at Rourkela in Sundargarh district will be ready by July 2022, Chief Secretary SC Mahapatra said Wednesday. A high-level delegation of state government officials led by Mahapatra visited Rourkela, Wednesday to review various development works. Secretary (5T) VK Pandian, National Health Mission (NHM) director Shalini Pandit and Sports Secretary R Vineel Krishna accompanied him.

Work is going on in full swing for the hockey stadium where some matches of the 2023 Men's Hockey World Cup will be played Construction of parking space and



dormitories for players is also progressing smoothly. We have set the target to complete the entire work by July 2022," Mahapatra said.

"The civil work of the Biju Patnaik Indoor Stadium in Panposh has reached the last stage and it will be operational soon. There will be three indoor badminton courts and three outdoor tennis courts. A stateof-the-art gym is also being set up for the players," informed Mahapatra.

The stadium with a seating capacity of 20,000-plus will be the largest hockey stadium in India. It will co-host some matches of the 2023 World Cup along with the Kalinga Stadium here. Chief Minister Naveen Patnaik had laid the foundation stone in February 2021 for the stadium.

The team also reviewed the Rourkela airport expansion project. The Rourkela airport expansion project has been taken up by the Airport Authority of India (AAI). The terminal building will also be constructed there by May 2022, Mahapatra told the media.







Facelift for British-era loco as relocation plan shelved

Puri, August 18: After a hue and cry over a proposal to relocate the British-era steam engine from the premises of Chanakya BNR Hotel here, the East Coast Railway (ECoR) authorities have refurbished the antique railway machine.

The railway authorities had made an attempt to relocate the locomotive to somewhere else August 8. However, the proposal was shelved in the wake of stiff opposition from the locals, sources said.

Many social activists and intellectuals of the city, meanwhile, urged the ECoR to make special arrangements for preservation of the steam engine.

"The British-era locomotive has been displayed on an open space at the hotel for the last several years. The Railway authorities should immediately build a shed for the steam engine. They should develop the site as a small museum to attract visitors," said Hector Mishra, who was leading the protest over relocation of the locomotive from the front.

CBI probe sought into 12 'murders'

Cuttack, August 18: A public interest litigation (PIL) has been filed in Orissa High Court seeking CBI probe into 12 sensational deaths/murder cases in the state including that of motivational speaker Aditya Das.

Petitioner Surendra Panigrahi has made the CBI, Odisha Chief Secretary, Home secretary, Director General of Police, the chief of Crime Branch and the superintends of police in several districts parities to the case.

Panigrahi, the state president of Bharatiya Vikash Parishad, claimed that the police have failed to arrest the main accused in many of these murder cases. Some influential people including a few politicians were involved in these cases, alleged the petitioner.

"The police often try to hush up some murder cases. They have failed to solve many sensational deaths," he said. Panigrahi has sought HC's intervention for CBI probe into the cases.

SC seeks status report from states on vacancies in SICs

New Delhi, August 18: The Supreme Court Wednesday directed Odisha and other states to file status reports giving details about the vacancies and pendency of appeals in the State Information Commissions (SICs).

A two-judge bench of the apex court comprising Justices S Abdul Nazeer and Krishna Murari noted that Odisha has created only two additional posts of information commissioners. However, the top court had directed to create three additional posts. The bench adjourned the matter for three weeks and sought a status report by the next date of hearing.

During the hearing, the counsel appearing Odisha submitted that four information commissioners are now working and advertisements for Chief Information Commissioner (CIC) and one in-



formation commissioner have been published.

The Health and Family Welfare (H&FW) department thanked the health workers as well as the citizens for their proactive participation in making the vaccination drive successful.

As per the data available in the CoWIN portal, the coastal state has so far administered as many as 2,00,71,492 doses of the vaccine.

Over 1.54 crore people in the state have received their first dose, while 46.51 lakh have been fully vaccinated. Moreover, 87.05 lakh people in the age group of 18-44 years have received the jab till now, while 65.26 lakh people in the 45-60 age group and 48.39 lakh beneficiaries above 60 years of age have also been inoculated.

993 fresh infections push tally to 9,97,146

He said entire Puri beach has been described in religious texts as 'Mahodadhi Tirtha'. It is one of the five Tirthas (holy places) of the country. Devotees perform Pinda Dan (last rites) of their ancestors while many rituals connected with Srimandir and Samudra Arati is performed on the beach. The state government, he said, should stop this idea.

Senior Congress leader Suresh Kumar Routray condemned the creation of another blue flag beach. He said Puri beach is unique and famous for its golden sand.

Hundreds of fishermen and small traders are earning their bread and butter by doing business in the beach.

The Congress said it will launch an agitation in front of the Lions' gate of Srimandir if government did not reconsider its plan.





Pax Americana Dies

The terrorist takeover of Afghanistan, following President Joe Biden's precipitous and bungling military exit, has brought an ignoble end to America's longest war. This is a watershed moment that will be remembered for formalising the end of the long-fraying Pax Americana and bringing down the curtain on the West's long ascendancy.

At a time when its global preeminence was already being severely challenged by China, the United States may never recover from the blow this strategic and humanitarian disaster delivers to its international credibility and standing. The message it delivers to US allies is that they count on America's support when they most need it at their own peril.

After all, the Afghanistan catastrophe unfolded after the US threw its ally - the Afghan government – under the bus and got into bed with the world's deadliest terrorists, the Taliban. President Donald Trump first struck a Faustian bargain with them, and then the Biden administration rushed to execute the military exit dictated by the deal, even though the Taliban had been openly violating the agreement.

The dramatic collapse of the Afghan defences and then the government was directly linked to the US betrayal. Biden admits Trump "drew US forces down to a bare minimum of 2,500" in Afghanistan. By refusing to retain that small military footprint and by ordering a

rapid exit at the onset of the annual fighting season, Biden pulled the rug out from under the Afghan military's feet, thus facilitating the Taliban's sweep.

The US had trained and equipped the Afghan forces not to play an independent role but to rely on American and NATO capabilities for a host of battlefield imperatives - from close air support, including drones for situational awareness, to keeping US-supplied weapon systems operational. Biden's calamitous troop pullout without a transition plan to sustain the Afghans' combat capabilities unleashed a domino effect, with 8,500 NATO forces and some 18,000 US military contractors also withdrawing and leaving the Afghan military in the lurch.

As former CIA Director General David Petraeus has explained, ever since US combat operations in Afghanistan ended January 1, 2015, Afghan soldiers had been bravely "fighting and dying for their country" until the US suddenly ditched them this summer, mortally compromising Afghan defences. This assessment is reinforced by the number of military deaths: Since the US combat role ended more than six and a half years ago, Afghan security forces lost tens of thousands of soldiers, while the Americans suffered just 99 fatalities, many in non-hostile incidents.

This is not the first time the US has dumped its allies - or even the first time in recent

memory. In the fall of 2019, the US abruptly abandoned its Kurdish allies in northern Syria, leaving them at the mercy of a Turkish offensive.

But in Afghanistan, the US sowed the wind and reaped the whirlwind. Its self-inflicted defeat and humiliation have resulted from a failure of political, not military, leadership. Biden, ignoring conditions on the ground, overruled his top military generals in April and ordered all US troops to return home. Two decades of American war in Afghanistan culminated with the enemy riding triumphantly back to power.

Whereas 58,220 Americans (largely draftees) were killed in Vietnam, 2.448 US soldiers (all volunteers) died over the course of 20 years in Afghanistan. Yet, the geopolitical implications of the US defeat in Afghanistan are much more significant globally than the American defeat in Vietnam.

The Pakistan-reared Taliban may not have a global mission, but their militaristic theology of violent Islamism makes them a critical link in an international jihadist movement that whips hostility toward non-Sunni Muslims into nihilistic rage against modernity. The Taliban's recapture of power will energise and embolden other violent groups in this movement, helping to deliver the rebirth of global terror.

FOOD SYSTEMS ON EDGE

he COVID-19 pandemic has ruthlessly exposed the global food system's deficiencies, and a massive escalating hunger crisis now looms. A quarter of humanity lacks secure access to food, with one in ten people affected by severe food insecurity, and up to 811 million people hungry. Another quarter of the world's population suffers from various forms of malnutrition, including obesity, with huge negative effects on health.

Both trends are on the rise, and both are directly connected to injustice and poverty. No matter how much food the world produces. failure to address power imbalances in the global food system will mean that hunger persists and food-borne illnesses explode. Many hope that the United Nations Food Systems Summit in September will be a catalyst for real change. But the gathering is more likely to legitimise and cement the current inequitable model of industrialised food production.

That would be bad news for the world's hungry people, the majority of whom - 418 million - live in Asia. More than 282 million live in Africa, where chronic hunger affects one in five people and is increasing faster than in any other region.

Hunger is primarily a problem of accessibility. People go hungry not because there is insufficient food in the world, but because they are poor. Were it not for injustice and inequality, the record global wheat production in 2020-21 could in theory feed up to 14 billion people. But agricultural products go to those with the greatest capacity to pay - including in the feed industry and the renewableenergy sector - and not to the most vulnerable people. Market power trumps food sovereignty.

Violent conflict, extreme weather due to climate change, biodiversity loss, and the economic turmoil caused by COVID-19 lockdowns have worsened the situation of vulnerable people. And water becomes increasingly scarce for smaller farmers when bigger investors use it in intensive

irrigation schemes.

All these crises limit poorer people's capacity to buy food or produce enough to be self-sufficient. As a result, 155 million people across 55 countries suffered from severe hunger in 2020, an increase of 20 million from 2019.

Since the Green Revolution in the 1960s and 1970s, we have continuously heard that increasing agricultural productivity is the kev to fighting hunger and feeding the world's population. Today, global corporations like Corteva (formerly the agricultural unit of DowDuPont), Bayer/Monsanto, and ChemChina/Syngenta promote productivity through the use of chemical pesticides, artificial fertilizers, and genetically modified or commercially grown hybrid seeds that cannot be reproduced. But such capital-intensive agriculture cannot serve those who lack the basics for secure food production: land, water, and regionally rooted knowledge systems.

Meanwhile, nearly two billion people globally are now overweight or obese. Mexico, where about 73 per cent of the population is overweight, is a particularly worrying case. If current dietary

habits persist, 45 per cent of the world's population could be overweight by 2050. This will result in exploding healthcare costs, with diet-related health costs linked to mortality and non-communicable diseases projected to ex-

Again, powerful economic interests are fueling this trend. The food and beverage industry profits greatly from selling unhealthy processed food and sugary drinks. After all, fat, sugar, and carbohydrates mixed with a lot of salt are the cheapest calories. In 2019, the world's five largest food and beverage companies - Nestlé, PepsiCo, Anheuser-Busch InBev, JBS, and Tvson Foods – had a combined revenue of \$262.7 billion. Healthy diets are much more ex-

pensive, so obesity is often a result of poorer populations' low purchasing power. The UN's Food and Agriculture Organisation estimated that a diet with sufficient calories cost \$0.79 per day in 2017, whereas a diet with sufficient nutrition cost \$2.33 per day, and a healthy diet cost \$3.75-making it unaffordable for more than three billion people.

In the Taliban's emirate, al-Qaeda, remnants of the Islamic State (ISIS), and Pakistani terrorist groups are all likely to find sanctuary. According to a recent United Nations Security Council report, "the Taliban and al-Qaida remain closely aligned" and cooperate through the Pakistan-based Haqqani Network, a front for Pakistani intelligence.

The unravelling of the effort to build a democratic, secular Afghanistan will pose a far greater threat to the free world than Syria's meltdown, which triggered a huge flow of refugees to Europe and allowed ISIS to declare a caliphate and extend it into Iraq. The Taliban's absolute power in Afghanistan will sooner or later threaten US security interests at home and abroad.

By contrast, China's interests will be aided by the Taliban's defeat of the world's most powerful military. The exit of a vanquished America creates greater space for China's coercion and expansionism, including against Taiwan, while underscoring the irreversible decline of US power.

An opportunistic China is certain to exploit the new opening to make strategic inroads into mineral-rich Afghanistan and deepen its penetration of Pakistan, Iran, and Central Asia. To co-opt the Taliban, with which it has maintained longstanding ties, China has already dangled the prospect of providing the two things the militia needs to govern Afghanistan: diplomatic recognition and much-needed infrastructure and economic assistance.

The reconstitution of a medieval, ultra-conservative, jihad-extolling emirate in Afghanistan will be a monument to US perfidy. And the images of Chinook and Black Hawk helicopters transporting Americans from the US embassy compound in Kabul, recalling the frenzied evacuation from Saigon in 1975, will serve as a testament to America's loss of credibility - and the world's loss of Pax Americana

Overweening

A person or group described as overweening may demonstrate presumptuousness, arrogance, conceit, self-importance or an excessively high opinion of themselves. While I share the general European aversion to the overweening US firearms lobby, gun ownership has two compelling arguments on its side (The Independent, 18 Dec. 2012). The word comes from the older noun and verb overween. Both have now almost entirely vanished but were available to the writers of an earlier age. Perhaps one reason why overween became unfashionable is that we lost its second part. Ween is Old English, a Germanic form that survives, for example, in modern German wähnen, to imagine or to believe wrongly. In English, it meant to think or surmise. By the nineteenth century it had ceased to be a common verb and turned up almost exclusively in the fixed phrase I ween

ndia needs pragmatic policies ment. Most resort to a four to seven to revive its sagging economy and save its wealth. Policies such as automobile scrappage, promoting electric cars, banning single-use plastic, and imposing heavy penalties on violators are detrimental to the interests of the nation.

It is nice to synchronise with Fourth UN Environment Assembly 2019, but it is imprudent to overlook the conditions of the country which is reeling under poverty-like conditions. The wealthier nations have different problems and solutions, but India must not ape these. Indians are trying to come out of decades of poverty. It is a gradual process. An individual does not transform in a jiffy. Mere change in income level is also not guarantee that overnight he would have different economic status.

Let us for instance check how an individual acquires a motorcycle or a car. It is certainly not luxury in a country where public transport is rudimentary to have an automobile to help one travel with a bit of ease. The process has its rigmarole. Not more than a per cent of people can make full down pay-

years or more repayment schedule. Announcing the vehicle to be a junk in 10 years does not make sense. Besides, if someone has spent a lifetime to pay for his prized car or any other possession, who is the State to declare it junk?

It is an individual's property, he is its custodian and nobody else without his permission can issue an order that it can be seized by a State agency without violat ing the fundamental rights. These issues cannot be discussed merely on legal grounds, particularly in a society where the State agencies feel they are not answerable to anyone. It is a strange anti-people mindset of an executive that is appointed by a government elected by the people. It is like the servant disowning the master. Most problems that are being heaped on the people start with this convoluted mindset.

The government's estimates that the scrapping policy would bring ₹10,000 crore investments are illusory statistics. It has ignored the fact that the total registered vehicles in 2019 were 295.8 million -29.6 crore. In 2011, 14.2 million ve-

hicles were registered. In other words, these 14.2 million-- 1.4 crore vehicles, most having a fine workable life, would now, as per the arbitrary policy of 10 years, be declared junk. Is that rational? This means at least 1.4 crore families would be deprived of their wealth. which let us assume they had acquired on an average cost of about ₹3 lakh per family. A total cost of

₹4.2 trillion! It is an imprudent decision and must be junked by a country that has 80 crore – 60 per cent - people sustaining on free food doles. No sane country would waste such wealth knowing that most losing their vehicles would never be able to purchase another in their lifetime because by these 10 years, most of the 1.4 crore people may have become senior citizens with neither a job nor a pension or an income but many paying a hefty income-tax out of their savings.

Similarly, impractical is the single-use plastic ban. A plastic bag or a car seat or a computer cover cannot be recycled. The policy makers look for simplistic solutions that are neither worth their value nor useful in any other terms.

But billions are being wasted on looking for 'no-solution'. The result is to be seen everywhere, not only in urban areas but all across rural areas along the highways, roads or habitats. The Swachh Bharat is not becoming clean for these reasons and the country is ready to repeat its mistakes. Plastic disposal needs a virulent solution. This country is nowhere near it.

Look at the contrast of e-vehicles that also use maximum plastic to keep their deadweight low. The latest lithium-ion batteries have a life of two-three years -- or 300 to 500 chargings. If the battery is completely discharged, it can no longer be recharged again. The e-vehicle would not be less pollutant.

And the nation is committing yet another folly. It wants to give up diesel, the cheapest petroleum byproduct, as per international petroleum lobby decision. It would treble crude imports. Yes, the policy makers are committing too many silly mistakes. Let India have its own policy and not follow the western sharks so that it is easy to tread a path to prosperity.

Deogarh/Sambalpur, August 18: Fake farmers have allegedly managed to get themselves enrolled under the Pradhan Mantri Fasal Bima Yojana (PMFBY) while scores of genuine farmers have been left out of such crop insurance benefits in Deogarh district, a report said.

Such allegations have come from Sadho panchayat. The area comes under Kendeijuri primary cooperative society. Over a hundred farmers in the panchayat alleged they are unable to avail of PMFBY.

The farmers had drawn attention of Deogarh Collector, the tehsildar, district civil supplies officer and assistant registrar of cooperative societies about the insurance mess August 10. "But no action was taken. We appeal to the administration for an investigation into the irregularities in crop insurance," farmers lamented.





REMAINS OF GUPTA ERA FOUND IN SAMBALPUR

Sambalpur, August 18: Wall structures constructed with bricks dating back to early Gupta period were found in Sambalpur district, a report said. The bricks were first observed by members of the Indian National Trust for Art and Cultural Heritage (INTACH), following which they informed the research scholars. Subsequently, the team visited the site August 15, it said.

The breakthrough has been achieved by a team of faculty and researchers of the History department of the Sambalpur University. The team members claimed the remnants of the ancient period are spread in neighbouring Angul and Boudh districts.

The remains of a bye-gone era have been discovered at Badamal under Jujumura block and are spread over an area of 2 km from Durgapali to Bada Bazaar under Sambalpur civic body limits. Historians claimed that human settlements used to exist in the region centuries ago and this is evident from the remnants of burnt bricks.



The shape of the bricks resembles the bricks used during the Gupta period. However, carrying out an archaeological survey to find newer details is not an easy task as large-scale construction work is taking place in the area due to rapid urbanisation.

The matter came to the fore after scribes Deepak Kumar Panda, Kulamani Patel and historians Bibhudendra Mishra and PK Mishra stumbled upon the remains of the ancient civilization and informed the History department of the university.

A team of historians comprising Prof Pradip Kumar Behera, Nabin Kumar Sahu, Khirasindhu Barik and Khageswar Bhoi of Sambalpur museum visited the site and carried out a detailed examination. Later, they visited the bank of Harihar creek and Asuragad and conducted various examinations.

During the excavation, they discovered precious stones like garnet, berry, aquamarine, amethyst, corundum, carnelian, agate and chalcedony stones. glass beads, necklaces, stone and iron implements as well as open air and well protected tool-manufacturing units.

A rectangular shaped human settlement had flurished at the place during the Maurvan era. Similar settlements have been discovered at other places as well. Remains of a mega construction have also been found on top of Sindol hill, about 45 km to the south of Sambalpur town. This place bears resemblance to the leaning temple of Huma in Sambalpur town and the remains available at Durgapalli. Given this evidence, Sambalpur town is believed to be as old as the Gupta era or might be older than it is thought.

A archaeological survey could shed more light on this theory, the team members said. This apart, glass bangles and glass wares of various colours at Tentulipalli valley on the Mahanadi river bank and at Krumapadar near the river bank have been unearthed.

The team members claimed that iron melting was widely prevalent in 7th century BC. Similar remains of brick-made structures, iron implements and guardwall around well made of burnt bricks have been found at Tarporgarh.

A circular fort-like structure that has been discovered in Chhattisgarh was also found at Tarporgarh. Remains of burnt bricks have been found at Manmunda block of Boudh district and in Budhigarh near Madanpur-Rampur in Kalahandi district which probably belong to the Gupta era, Prof Sahu said.

Why 3 decades later Kashmir is cool to Taliban

New Delhi, August 18: Kashmir's politicians, both separatists as well as mainstream, have maintained near-total silence over Taliban's capture of Afghanistan after a pro longed strife of 20 long years. However, the visibility of a wave of jubilation among the separatists, militants and their shrinking supporters is not completely concealed.

As news of the fall of Kabul flashed in the media Sunday, 15 August, Dr Sheikh Showkat Hussain, formerly a professor of Law at the University of Kashmir and the Central University of Kashmir gave vent to his euphoria. "And say truth has come and falsehood has vanished away," he tweeted a Koranic verse with its English translation. "Falsehood is indeed bound to vanish." Showkat commented, without linking his expression explicitly to Kabul's capture by Taliban.

"Can't imagine the feeling of Kashmiris", commented one Shoaib. Another follower appreciated: "Aap kii baat sach nikli"-acknowledg ing that the retired university teacher's prophecy had come true. Almost all of Prof. Showkat's eight books have been released and ap-



preciated by Kashmir's tallest sep aratist hardliner Syed Ali Shah Geelani.

obviously exultant. For many of them, it stirs their adrenaline. Had it happened in 2018 or before, there would have been nightlong firecrackers and celebrations on the streets in downtown Srinagar," reasons a senior political analyst. He recollects the jubilation triggered by release of five top militants in exchange for Rubaiya Sayeed in December 1989.

Kashmir has gone through a sea change in the last over three years as the Centre has tightened its grip with detention and house-arrest of hundreds of the separatist activists who would be usually on the forefront of all the street turbulences in 2008. 2009, 2010 and 2016. Killing of civilians in protest demonstrations, clashes with police and security forces, funeral processions of slain militants, stone pelting and pellet injuries have fallen to the lowest point of the last 31 years.

Even in the year 2020, the valley's separatist sections sounded ecstatic over the killing of the Indian soldiers in a clash with the Chinese army on the LAC in Ladakh. The sentiment looked phenomenal when former Chief Minister Farooq Abdullah said in an interview that the Chinese would help the

Kashmiris retrieve Article 370 Around the same season, many among the separatists began seeing Mohammad Bin Qasim, the conqueror of Sindh, in Ertugrul, the protagonist of a Turkish period se rial promoted by Pakistan Television. But it all fizzled out soon when a large number of the Kashmiris began participating in the Government's 'Naya Kashmir' initiative. The UT administration's recent decisions include surveillance of government employees' political and social media activities, dismissal of officials involved in 'anti-national' activities and denial of government jobs, trade licences and passports on the basis of 'negative reporting' by the Criminal Investigation Department (CID).

"Those days are gone when a separatist leader publicly invited Taliban to so-called Jihad in Kashmir; when the Kashmir University students chanted an anthem 'Teri jaan meri jaan, Taliban Taliban'. Yes I agree there was a different situation until the last day of the PDP-BJP government. Had this Taliban takeover happened in that era, the separatists would have brought thousands on the streets, said an assistant professor of jour nalism at a government college.

Karnataka to screen 1.5 crore **JCCI for resumption** children ahead of third wave of 'Darbar move'

Bangalore, August 18: The Karnataka government is all set to launch a flagship programme 'Arogya Nandana' under which 1.5 crore children will be screened ahead of the third Covid wave, Minister for Health Dr K. Sudhakar announced.

Experts have expressed fears of a possible third wave of Covid-19 affecting children. Keeping in view of the projections, the state government is launching a new programme called 'Arogya Nandana'. The flagship programme is an attempt to reach out to all 1.5 crore children of the state.

"Under this scheme, all children will be undergoing health screening. The children with malnutrition, immunity issues will be identified and in coordination with the Women and Child Welfare department, we will see to it that children get nec-



essary nutrients and food supply which will provide them immunity from Covid," Sudhakar explained. The state government, in its remaining 21 months, is intending to bring about complete change. No other government in Karnataka has recruited 4.000 doctors in a period of 4.5 months and it has been done, he added.

CM Basavaraj Bommai will inaugurate the programme and plans of the project are ready. "This is CM Bommai's dream. The project

has been implemented in Haveri and Udupi districts where he was district in charge minister before. The project has been extended to the whole state now. Over 1.5 crore children will be screened across the state and the government has the infrastructure to reach out to all of them," Sudhakar said.

Since it is suspected that 28 lakh people who were affected with coronavirus and later recovered face the threat of being infected with Tuberculosis. The government has already launched another flagship programme to conduct tests to ascertain whether this section of people got affected with TB, he explained. "Early detection and treatment helps us to contain TB spreading on a large scale. In 5 years, infection rate has increased by 33%. Jammu. August 18: Asserting that COVID-19 has badly hit tourism, transport and trade sectors in Jammu and Kashmir. Jammu Chamber of Commerce and Industry (JCCI) Wednesday demanded a special relief package for these sectors.

The Chamber also advocated continuation of the bi-annual 'Darbar move', an age-old practice under which the J&K government functions six months each in the twin capital cities.

It also asked the administration to focus on promotion of tourism in Jammu province, including the possibility of Wagah-type parade at Suchetgarh and revoking of the notification regarding re-registration of vehicles purchased by local residents from outside the Union Territory.

The demands were highlighted in a memorandum which was submitted by a five-member delegation led by JCCI President Arun Gupta to Chief Secretary A K Mehta at a meeting here, a spokesperson of the trade body said.

Sharing the copy of the memorandum, the JCCI said the practice of darbar move was aimed at "maintaining communal harmony" among the people of Jammu and Kashmir regions and "we therefore request (the government) to continue the practice.

J&K Lieutenant Governor Manoj Sinha administration had June 20 announced that the J&K administration has completely transitioned to e-office, thereby ending the practice of the bi-annual 'darbar move

"Now, both the Jammu and Srinagar secretariats can function normally for 12 months. This will save the government Rs 200 crore per year, which will be used for the welfare of the deprived sections," he had said.

However, various stakeholders, including traders and transporters, have openly voiced their resentment against the decision on the plea that

the practice, which was started by Maharaja Gulab Singh in 1872, gives a big boost to Jammu economically.

Thousands of families from Kashmir used to move along with darbar to spend winter in Jammu.

The JCCI advocated special incentives for tourism, transport and trade sectors, saying the outbreak of the COVID-19 pandemic last year and subsequent lockdown had hit them hard.

"We urge the government to make some mechanism for survival and revival of these sectors,' the memorandum said, also requesting for a revival package to give relief to the small-scale business houses especially the non-essential shopkeepers.

The JCCI demanded continuation of the VAT and power amnesty scheme and also pleaded for relief to the business community from paying rent to various departments for the lockdown period

Claiming neglect of the Jammu region in the tourism promotion, the memorandum called for focussed attention on Patnitop, Bhaderwah, Banj, Sarthal, Kishtwar and Doda. Besides, it also requested the Centre to explore the possibility of Wagahtype parade at Suchetgarh in RS Pura sector of Jammu to boost border tourism.

The trade body requested for completing of pending work on the ongoing projects like artificial lake on River Tawi, Mubarak Mandi Heritage Complex, and development of banks of river Tawi on the pattern of Sabarmati and heritage circuit at the earliest.

It demanded removal of security pickets in and outside the famous Raghunath temple in the city, claiming that the installation of the pickets have affected the flow of devotees. The JCCI called for intensification of vaccination drive against COVID-19 across the Union Territory and allowing functioning of banquet halls and cinema halls with 50 per cent capacity.

New Delhi, August 18: After breaching the value of one in the first week of August, the R number, which reflects how rapidly the coronavirus pandemic is spreading, has been steadily ebbing in the country including Kerala and some northeastern states, according to researchers

"India's R has fallen to around 0.9," Sitbara Sinha of the Indian Institute of Mathematical Science, who is leading the research, told PTI, citing their data.

The R-value of Kerala, which has the highest number of active cases in the country, is now below one, signalling a relief to authorities who have been struggling to bring down the infection levels in the state.

Earlier this week, Union Health Minister Mansukh Mandaviya, visited Kerala with a central team to review the COVID-19 situation in the state

The minister said the Centre has allocated Rs 267.35 crore to the state to strengthen its health infrastructure and will also provide 1.11 crore vaccines in August and September. There are currently 4,98,630 people under surveillance in various districts of the state. Of these, 4,70,771 are in home or institutional quarantine and 27,859 in hospitals, according to the state health department.

Conversely, if R is greater than one, the number of infected people is increasing in each round and, technically, this is called the epidemic phase.

After the devastating second wave that saw hospitals and health infrastructure being overwhelmed by the patients infected by SARS-CoV2 coronavirus, the R-value started to decline. During the March-May period, thousands of people died due to the infection while lakhs were infected.

In its bulletin Wednesday, the Ministry of Health said India saw a single-day rise of 25,166 new COVID-19 cases, the lowest in 154 days, taking the tally to 3.22.50.679

SC notice to Centre, WB on plea against inquiry by state

New Delhi, August 18: The Supreme Court Wednesday asked the Centre and West Bengal government to respond to a plea challenging the setting up of a Commission of Inquiry by the state to probe the Pegasus snooping allegations.

A bench headed by Chief Justice N V Ramana issued notices to them and posted the matter for hearing August 25. Advocate Saurabh Mishra, appearing for the petitioner, told the bench that the Commission of Inquiry should not conduct further proceedings in the

interregnum. He told the bench. also comprising Justices Surva Kant and Aniruddha Bose, that public notice has been issued by the Commission of Inquiry and proceedings are taking place on a dayto-day basis. "We will see, wait", the bench said and asked him to serve the copy of the petition to the respondents. The counsel argued that the petition challenges the notification, issued by the West Bengal government last month appointing a Commission of Inquiry to probe into the snooping allegations, on the ground of jurisdiction. "The problem is there is some inconsistency in your affidavit. You say you

want inquiry, at the same time you are opposing the Commission of Inquiry," the bench said, adding, "In your affidavit and in your petition, you must be consistent.' Solicitor General Tushar Mehta, representing the Centre, said he would be assisting the court on Constitutional questions involved in the matter. "This is unconstitutional is all I can say," he told the bench. Former Supreme Court judge Justice Madan B Lokur and former chief justice of Calcutta High Court Justice Jyotirmay Bhattacharya are the members of the Commission of Inquiry announced by the West Bengal government last month."

Justice Kaul had authored the judgment granting permanent commission to women, when he was in the Delhi High Court.

WASHINGTON: The US State Department has released a joint statement signed by about two dozen nations expressing concern for the rights of Afghan women and girls and urging those in power in Afghanistan to "guarantee their protection." Wednesday's statement was signed by the United States, Britain, the European Union and 18 other countries. It says the statement's signatories are "deeply worried" about the Afghan women's "rights to education, work and freedom of movement" in the wake of the Taliban takeover.

"Afghan women and girls, as all Afghan people, deserve to

live in safety, security and dignity," it said. "Any form of discrimination and abuse should be prevented. We in the international community stand ready to assist them with humanitarian aid and support, to ensure that their voices can be heard.'

EUROPEAN UNION

MADRID: The European Union's top diplomat says that it is necessary to talk with the Taliban to secure the evacuation of foreign nationals and those Afghans who have worked with NATO forces.

"I said that we must speak with them and some people found that scandalous," Josep Borrell, the EU's High Representative for Foreign Affairs and Security Policy, told Spanish National Radio Wednesday. "But how are we supposed to open a safe passage to the airport if we are not speaking with those who have taken control of Kabul?"

Borrell said his main concern is the immediate situation of those

needing help to immediately leave the country for fear of reprisals.

'My responsibility is to identify and help move those who have worked with us," Borrell said. "(But) that does not exclude the EU from opening its arms to other people.'

"What has happened in Afghanistan is a defeat for the entire western world and we all must have the courage to accept that," he said.

CHINA

BEIJING: China says it is waiting for the establishment of an "open, inclusive, and widely representative" government in Afghanistan before it decides on the issue of recognition.

"If we are going to recognize a government, we will have to wait till the government is

formed," Foreign Ministry spokesperson Zhao Lijian said Wednesday. "Only after that, will we come to the question of diplomatic recogni-

tion," Zhao told reporters at a daily briefing. Zhao reiterated Beijing's hopes for a "a smooth transition" following the Taliban's sweep to power to avoid further violence or a humanitar-

ian disaster. 'China will continue to support the peaceful reconstruction of Afghanistan and provide assistance to Afghanistan's economic and social development within its capacity," Zhao said. Beijing long called for the US to leave Afghanistan, but has condemned what it calls the "hasty" retreat of American forces for the current instability.

Two doses should be given to the most vulnerable worldwide before boosters are administered to those fully-vaccinated, he said, adding: "We are a long, long way from that."

'UNITE AWARE' is a situational awareness software programme that allows a Peacekeeping Operations Centre to visualise and analyse the ground situation in a conflict zone on a real-time basis. It will help in increasing situa-

tional awareness and provide terrainrelated information to peacekeepers. India has contributed USD 1.64

million towards the project.

This project aims to demonstrate the impact of modern surveillance technology on the detection of asymmetric threats. The aim of the project is to improve camp security for UN peacekeepers, the overall security situation, and the quality of situational awareness, ২ the Ministry of Affairs said.

India has partnered with the UN to roll out the UNITE Aware platform initially in four UN Peacekeeping Missions MINUSMA (Mali), UNMISS (South Sudan),-UNFICYP (Cyprus) and AMISOM (Somalia).



Book tells Siraj tale 'Manner of defeat could hurt' England

London, August 18: Former England skipper Andrew Strauss feels the manner in which Joe Root's team capitulated against a firedup India in the second Test could hurt the "bruised and battered" hosts in the remainder of the fivematch series.

From a seemingly comfortable position, England fell to a 151-run defeat on the final day at the Lord's. "They were favourites but let things slip before lunch (on final day) and then had another top-order collapse," Strauss told 'Sky Sports'.

'Those early wickets put huge pressure on the middle order and India just had enough overs to bowl them out. It was feisty."

He said India "thoroughly deserve" to go one up in the fivematch series. "Every series with India, and particularly (Virat) Kohli, is feisty and as the match was on the line you expected nothing else. It has been five brilliant days of Test cricket.

"India were exceptional and there were times when England looked like they were going to get out of jail but, in the end, you have to say that India deserved it, they did enough to win. England are going to be absolutely battered and bruised as a result of that," he added.

Strauss has also called for a change in England's top-order after



Test at Headingley. For the first time in Test history, both England openers were dismissed for ducks in the same innings of a home match. "At some stage if you keep being two or three down for nothing, it's going to come back to haunt you."

'Yes, they were two good balls to get rid of Burns and Sibley but, of course, then Joe Root is under pressure, (Haseeb) Hameed is under pressure and then Jonny Bairstow and the middle order as well. You just can't keep doing that time after time," Strauss said.

Sibley averages just 14.25 across four innings in the series and with only one half-century in his last 15 Test innings, Strauss expects the 25year-old right-hander to be axed. Root (128.66) is the only England player averaging over 30. "I think it might be time to bring

Sibley out of the firing line. He has looked out of touch. I think Ollie Pope is probably going to come back in, who has been in and around the squad, but is it right for him to be batting in the top three? It is not an easy solution.

'There are a lot of problems for England, no doubt about that. If they had got away with it again, we might have been able to paper over the cracks but not anymore."



Princepal 1st Indian to be on NBA title winning team

New York, August 18: Young cager Princepal Singh became the first Indian to be part of an NBA title winning team when his side Sacramento Kings clinched the 2021 NBA Summer League crown. The 6-foot-9 forward made history

by being the first Indian to be part of a championship roster at any level of the NBA. The Kings dom-

inated the championship game against the Boston Celtics, clinching the title with a 100-67 win Tuesday.

The win also made the Kings the only franchise to win multiple Summer League titles, having previously clinched it in 2014, according to the NBA.

In the final, Princepal, an NBA Academy India alumni, played the last 4:08 minutes of the game and put his name alongside Satnam Singh Bhamara.

The 20-year-old's appearance in the championship game comes exactly a week after he made his brief yet landmark debut at the Summer League, where he checked-in for the final 1:22 minutes of a Kings' victory over the Washington Wizards.
