### CCI slaps ₹200cr fine on Maruti Suzuki

NEW DELHI: The Competition Commission of India imposed ₹200 crore fine on Maruti Suzuki for indulging in unfair trade practices. The fine has been slapped for "indulging in anti-competitive conduct of resale price maintenance in the passenger vehicle segment by way of implementing discount control policy vis-à-vis dealers," the CCI said Monday. Besides, the watchdog has directed the company to desist from indulging in anti-competitive practices. MSIL had an agreement with its dealers whereby the dealers were restrained from offering discounts to customers.

### **Experts warn of 3rd** wave of Covid-19

NEW DELHI: An expert panel, set up by an institute under the Ministry of Home Affairs (MHA), has predicted a third wave of COVID-19 hitting the country anytime between September and October and suggested significantly ramping up vaccination pace.

The committee of experts, constituted by the National Institute of Disaster Management (NIDM), also said children will have a similar risk as adults since paediatric facilities, doctors and equipment like ventilators, ambulances, among others are nowhere close to what may be required in case a large number of children become infected.

The report, which has been submitted to the Prime Minister's Office (PMO), observed that only around 7.6 percent (10.4 cr) people are fully vaccinated in India and if the current vaccination rate is not increased. India can witness six lakh cases per day in the

New Delhi, August 23: Finance Minister Nirmala Sitharaman Monday unveiled an ambitious ₹6 lakh crore National Monetisation Pipeline (NMP) that included unlocking value by involving private companies across infrastructure sectors - from passenger trains and railway stations to airports, roads and stadiums.

As many as 25 Airports Authority of India (AAI) airports, including ones at Chennai, Bhopal, Varanasi and Vadodara, as well as 40 railway stations, 15 railway stadiums and an unidentified number of railway colonies have been identified

for getting private investments. Under the plan, private companies can invest in projects for a fixed return using the InvIT route

### Centre calls all-party meet on Afghanistan

New Delhi, August 23: The government has called an all-party meeting Thursday on the devel opments in Afghanistan. Parliamentary Affairs Minister Pralhad Joshi said External Affairs Minister S Jaishankar will brief the floor leaders of political parties on the present situation in Afghanistan in the in-person meet.

The government's briefing is expected to focus on its evacuation mission from Afghanistan as well as its assessment of the situation in the war-torn country in the wake of the Taliban seizing control of almost all key Afghan towns and cities, including Kabul.

"Floor Leaders of Political Parties would be briefed by EAM @DrSJaishankar on the present situation in Afghanistan, on 26th August, 11 am in Main Committee Room, PHA, New Delhi. Invites are being sent through email. All concerned are requested to attend," Joshi tweeted. West Bengal Chief Minister Mamata Banerjee said that representatives of her party, the Trinamool Congress, will attend the meeting. "We will definitely be attending Thursday's all-party meeting on Afghanistan," the TMC supremo told reporters at the state secretariat in Kolkata.

Earlier, Jaishankar said Prime Minister Narendra Modi instructed the Ministry of External Affairs to brief the floor leaders of the political parties. "In view of developments in Afghanistan, PM @narendramodi has instructed that MEA brief Floor Leaders of political parties. Minister of Parliamentary Affairs @JoshiPralhad will be intimating further details,' Jaishankar said on Twitter.

The Taliban swept across Afghanistan this month following the withdrawal of the US forces from the country. As part of its evacuation mission from Afghanistan, India has already brought back around 730 people including members of the Afghan Sikh and Hindu communities. India Monday brought back 146 of its nationals in four different flights from Qatar's capital Doha,days after they were evacuated from Afghanistan.

New Delhi, August 23: The Supreme Court Monday set aside the order of Orissa High Court that had directed Pari's father Ashok Sahoo to approach the magistrate's court for his grievances on the investigation.

The SC also restored the Ashok

Sahoo's disposed writ petition in the High Court for fresh hearing.

A two-judge bench of the Supreme Court comprising Justices AM Khanwilkar and Sanjiv Khanna disposed of the writ petition and the SLP filed by Pari's mother and father and granted liberty to the petitioner to amend the writ petition in the High Court to seek further relief.

"In peculiar facts of this case and the circumstances, we deemed it appropriate to set aside the impugned order of the Orissa High Court and remit the petitioner Ashok Kumar Sahoo to the High Court by restoring the writ petition filed by him in the High Court for being considered afresh on its own



merits and in accordance with law after giving opportunity to the petitioner to amend the writ petition including to ask for further relief as may be advised," the bench ruled.

Senior advocate Kapil Sibal argued that the state government had approached the High Court





# **Joint marketing framework** for cash crops on the cards

Bhubaneswar, August 23: In a bid to enhance farmers' income and keep the middleman in procure ment of farm produce at bay, Chief Secretary SC Mahapatra has asked the department officials concerned to create marketing facilities for

Mahapatra gave this direction at a high-level review meeting held here Monday on the activities of National Agricultural Cooperative Marketing Federation (NAFED) in Odisha and possibilities of further collaboration with the federation.

Considering the possibilities for joint marketing of cash crops, he directed the departments of Agriculture, Horticulture and SC&ST Development to identify cash crops which can be promoted for augmenting famers' income.

The meeting revealed that some varieties of fruits, vegetables, pulses, oilseeds, millets could be produced and marketed on large scale in collaboration with NAFED.

Mango, jackfruit, pineapple, watermelon, pumpkin, elephant foot yam, ginger, arher, millets, peanuts, sunflower, green gram, black gram, Bengal gram, sweet corn, bajra, maize, toor k-18, scented rice (baasmati), mustard, chilly, brinjal, turmeric, coriander, potato, onion and other crops could be marketed in collaboration with NAFED.

Managing Director of NAFED Sanjeev Chadha mentioned that the federation would provide support and assistance to farmers for cultivation, procurement, branding and marketing of the cash crops in collaboration with the state agencies. Further, the Chief Secretary ad-

The JMF would have Farmer Producer Organisations (FPOs). self-help groups (SHGs), Primary Agricultural Cooperative Societies (PACS) and ITDAs as the active partners in up-scaling the cultivation of cash crops and procurement of the produces directly from the farmers, he said. Such strategies, he added, would prevent the possibilities of distress sale and unnecessary intervention of unscrupulous middlemen.

# Srimandir reopens for all after 4 months

place. No devotee will face any problem while visiting the temple and no threat of Covid-19 infection also," said a devotee from West Bengal.

The temple has been closed for the entry of the general public following resurge in the Covid-19 cases April 24, 2021.

All devotees will be required to bring their photo ID card like Aadhaar or Voter ID and enter through the Lions' Gate. After darshan, the exit will be through the North Gate.

It is mandatory for all devotees to wear masks all the time, inside and outside the temple, and they should sanitise their hands before

# City shrines reopen, but devotees fewer

Bhubaneswar, August 23: After more than three months of closure owing to Covid-induced lockdown, all religious institutions in the state capital, except Lingaraj and Iskcon temples, re-opened to public Monday.

Due to surge in Covid cases, the Bhubaneswar Municipal Corporation (BMC) had May 5 ordered closure of all religious institutions in the city for general public until further instructions. However, observing drop in cases, the BMC allowed reopening of all temples, churches, mosques and other such places with Covid guidelines in place.

According to the notification issued by the BMC, no devotee will be allowed inside the Garbha Gruha (sanctum sanctorum) of the temples and darshan can be allowed from a safe distance only.

The devotees are also not allowed to light diyas (earthen lamps) or offer prasad at the temples.

The civic authority also said that managements of the religious institutions should ensure a minimum 6-feet social distancing among the visitors inside the shrines.

"At any point of time, not more than 25 persons will be allowed to congregate at any religious shrines. Under no circumstances, social distancing norms should be violated. All temples, mosques, churches, gurdwaras shall ensure RT-PCR testing of their priests or servitors. Only RT-PCR negative and final Covid vaccination certificate holders will be allowed to perform the rituals," the BMC order reads.

Meanwhile, several religious institutions here reported sparse crowd on the first day of the reopening.

It can be mentioned here that Lingaraj and Iskcon temples are slated to reopen September 1.

# BJP, BJD cross swords over agri issues

Bhubaneswar, August 23: The Bharatiya Janata Party (BJP) and Biju Janata Dal (BJD) Monday indulged in blame game over farmers' issues in the wake of drought-like situation in the state.

Speaking to reporters here, state BJP president Sameer Mohanty slammed the BJD government for failing to create adequate irrigation facilities for the farmers. As per a statement given by the Water Resources minister in the Assembly, irrigation facility for 35 per cent of the arable land has been created only in 251 out of 314 blocks in the state, he said.

"The BJD, in its election manifestos in 2014 (Assembly polls) & 2017 (Panchayat polls), had assured the people to create irrigation potential for 10 lakh hectares each time. However, it is yet to be achieved," Mohanty said. The BJP leader urged the state government to form a task force immediately to mitigate the imminent droughtlike situation. He further said that the BJP would send four teams to

different areas, where drought looms\_\_\_ large, to take stock of the situation.

Replying to Mohanty, Rajya Sabha MP and Biju Janata Dal (BJD) national spokesman Sasmit Patra said that the farmers in Odisha have been subjected to harassment by the insurance companies over Pradhan Mantri Fasal Bima Yojana (PMFBY)

Lakhs of Odisha farmers are affected by PMFBY across Bargarh. Sambalpur, Sonepur, Deogarh, Bolangir, Nuapada and Kalahandi. Over the past five years, ₹1.26 lakh crore has been paid as crop insurance premium across India and ₹87,320 crore received as claims. The insurance companies made ₹40,000 crore of PMFBY money, detrimental to the interests of farmers, Patra said.

He said Odisha farmers filed crop insurance claims of ₹2,090 crore between 2018 and 2019 but the insurance companies disbursed only 50 per cent of these claims. The farmers are facing repeated harassment from insurance companies relating to the assessment of their claims and payments under PMFBY, he said

### Two decomposed bodies recovered; murder suspected

# Pradeep Panigrahi moves SC against Odisha Lokayukta

# **Even after 2 years, young** farmers yet to get loan

Balasore, August 22: While two vears have passed since the implementation of Mukhyamantri Kurshi Udyog Yojana in Balasore district, not a single agri-entrepreneur has been identified under the scheme in the region yet, a re-

The scheme has failed to garner any success due to alleged negligence of the Agriculture department and delay in sanctioning of loans by banks. The apathy of these two has proved to be stumbling blocks in the success of the scheme in the district, the report said.

According to reports, the scheme was launched in the district in December 2020 and the objective behind the scheme was to identify a young farmer from each block who is interested in agriculture-oriented business and provide him/her loans from the banks to further their business.

Under this scheme, the government provides financial assistance in the form of capital investment subsidy on loans to young entrepreneurs for setting up new agroindustries in the state. The Mukhymantri Krishi Udyog Yojana encourages young entrepreneurs to set up a new businesses and increase production in the agriculture sectors.

However, till date not a single entrepreneur has been identified. This has triggered sharp resentment among the young farmers interested in taking loans under the scheme to boost their business.

Sources said that many youths in the district returned home during the pandemic after losing their jobs and the scheme held promise for them. The state government had launched the scheme to provide livelihood opportunities to such young farmers

The Agricultural Promotion & Investment Corporation of Odisha Limited (APICOL) was assigned the task of identifying young farmers in the block-level, especially those whose annual income is more than ₹2 lakh. The youths identified under the scheme should have the capacity to invest ₹2 lakh to ₹10

Rout further said that the district Collector has directed the banks to provide loans to the identified young farmers under the scheme.

# Primary school teachers deputed to high schools



'FILLING UP OF **VACANT POSTS IN SCHOOLS SHOULD** TAKE PRECEDENCE OVER DEVELOPING **INFRASTRUCTURE**

Bhanjanagar, August 23: Three schools in Bhanjanagar block in Ganiam district will be converted into smart schools and a sum of ₹1.65 crore will be spent on their infrastructure development.

However, local residents are not in favour of the government spending so much money on the schools' infra development. According to them, filling up of vacant posts in schools should take precedence over developing infrastructure.

Badakodanda Jawahar High School, Gallery High School and Bhanjanagar Adarsha Vidyalaya in Bhanjanagar block will be transformed into smart schools. For this, each school has received ₹45 lakh under the Mo School Abhiyan. Badakodanda Jawahar High School and Gallery High School have received an additional sum of ₹15 lakh each, thanks to the efforts of Forest, Environment and Climate Change Minister Bikram Keshari Arukh. This assistance was provided from the grant Bhanjanagar block received from the state Finance Commission. A total of ₹1.65 crore will be spent on the three schools' infrastructure development. If required, there is possibility of more money being pumped in.

Once completed, these smart schools will have two special classrooms, one e-library, modern toilets and a play ground. The construction work is going on in full swing. In phases, other schools will also be converted into smart schools.

According to local residents, the state government is not concerned about filling up vacant posts of teaching staff as it is about developing the infrastructure of the schools.

Substantiating their view, the villagers said that there are 27 such high schools in Bhanjanagar block that do not have adequate teaching and non-teaching staff.

Upendra Bhanj High School, the oldest institution in Bhanjanagar block established in 1884, has only eight teachers. A high school should have a minimum of 12 teachers. Such shortage of teachers is proving to be detrimental for students' education and learning process.

While the process of filling up of vacant posts has reportedly been started, a stop-gap arrangement has been made for the time being. Primary school teachers are going to staff-



## Tibet & Taliban

he sweeping and lightning control of Afghanistan established by the Taliban during the past few days has injected a new significance into the celebration of the 70th anniversary of the takeover of Tibet by China through the invasion by the People's Liberation Army. China, which has always remained in touch with the Taliban, has been one of the first nations to suggest that it will be willing to officially accept the Taliban government. China would need the support of the Taliban in keeping fundamentalist forces from creating trouble in the Xinjiang region where China has incarcerated more than a million Uyghur Moslems. The development in Afghanistan, China seemingly fears, might give a fillip to resistance movements by religious minorities in its Xinjiang province and Tibet. The top leadership of the Chinese Communist Party has already held talks with a Taliban delegation, led by key leader Abdul Ghani Baradar in China.

Tibet is important to the Chinese scheme of things as the religious head of the Buddhists in Tibet, the Dalai Lama, commands global respect for his untiring efforts to retain the religious and cultural freedom of Tibetans even within the framework of Chinese rule. This is the reason why a senior Chinese official emphasised at an event that all Tibetans should embrace the Communist party rule and share the "cultural symbols and images of the Chinese nation." Wang Yang, a member of the politburo standing committee, China's most powerful political body, made the remarks during a ceremony marked by extravaganza and glorification of the leadership of President Xi Jinping in front of the Potala Palace in Lhasa, the sacred home of Tibet's traditional Buddhist leaders. Propagandists in the 1950s and 1960s used to extensively display Mao Zedong's portraits at rallies and celebrations to promote a personality cult around him. However, most leaders after Mao eschewed the practice. This is now being revived to help Xi consolidate his position in all parts of China.

Accordingly, China's official media has reported in detail Wang's claim that all religions in China were "Chinese in orientation." He appealed to Tibetans to make sure Tibetan Buddhism gets guidance in adapting to the socialist system. He chose the occasion to send the message to religious minorities in Tibet, Xinjiang and Inner Mongolia. In these three regions, repression and punitive measures are reportedly resorted to regularly to reduce the presence of local languages and cultures and also deal with separatist activities with an iron hand. In Tibet, authorities have allegedly jailed and beaten monks and nuns, subjected villages to political education sessions, imposed restrictions on daily life, including education and jobs, and mounted mass surveillance. Mandarin is being forcibly promoted as the medium of instruction in Tibetan schools, while the Tibetan language is taught merely as a subject. This is apparently intended to erase Tibetan culture.

The 70th anniversary has been taken very seriously in the wake of the Taliban takeover of Afghanistan to stem the tide of religious upsurge within Chinese regions. The anxiety of the Chinese leadership was reflected in the planning of the event attended by 10,000 select people. The CPC's position on the invasion and takeover of Tibet is that it was a peaceful liberation of Tibetans from an oppressive theocracy practised by the Dalai Lama. The event was, predictably, showcased as a gala affair through live coverage for both the national and international audience. A massive four-storey portrait of Xi Jinping was put up at the venue. In fact, Xi's recent visit to Tibet was the first ever by any Chinese President. It also seemed to send the message to India about China's intentions to mobilise its forces and strategic powers close to Indian borders from Ladakh to Arunachal Pradesh.

China has launched a massive propaganda on its "achievement" in transforming Tibet from a "medieval, exploitative society" to a modern, socialist system. Its official media claims Tibet today has entered a stage of rapid economic development and despite the COVID-19 pandemic, it has registered GDP growth of 9 per cent. It showcases the numerous modern residential buildings, shopping malls, trendy bars, Tibetan-style night clubs, restaurants, theatres, museums, and art galleries in Lhasa as visible signs of the growth story

China is also reportedly worried over a leadership change in the Tibetan government in-exile operated from Dharamshala. Penpa Tsering, former speaker of the "parliament-in-exile," was declared in May the Sikyong, i.e. the leader of the "Central Tibetan Administration." He took over from Lobsang Sangay, who had served in the position for 10 years. China calculates the new leadership will continue to seek Tibetan independence aggressively.

Apart from keeping its hold strong on Tibet, China has lofty plans to get a grip on Afghanistan after the exit of the United States. Instead of a military approach, as practised by the US, China wants to induce the Taliban to cooperate by offering legitimacy and financial support to its government Russia is already towing the Chinese line in relation to Afghanistan, as also Pakistan and Iran. India, considered a US ally, needs to tread softly and strategically in this changing scenario in its neighbourhood.

his and the related words painism and painience are creations of Dr Richard Ryder, a British psychologist, ethicist and retired professor. He has a long-standing concern for animal rights - he claims to have coined speciesism in the 1970s to refer to what he called in 1975 "the widespread discrimination that is practised by man against other species." He made painient and painience from pain by analogy with sentient and sentience, so that painient means being able to feel pain, while painience is the quality or state of being painient. Painism is his term for the moral theory that requires us to reduce the pain of others who suffer the most, especially that of individuals. All three words have been known since the middle 1990s, though they remain rare. Painism gained attention in 2001 through his book Painism: A Modern Morality; in it he argues that anything that can feel pain can suffer and so must have rights, specifically in the case of animals to be protected from human use and abuse. He wrote recently in a newspaper article: "Our concern for the pain and distress of others should be extended to any 'painient' being regardless of his or her sex, class, race, religion, nationality or species. Indeed, if aliens from outer space turn out to be painient, or if we ever manufacture machines who are painient, then we must widen the moral circle to include them.'



This story was largely ignored by most US media. But in the little coverage it received, the US government was made to appear well intentioned. The Post itself wrote that the US government could not settle on clear objectives and was also unable to "tell friend from foe." It added that ushering in a culture of democracy was stymied by the indigenous culture's stubborn strands of "tribalism, monarchism, communism, and Islamic Law."

The US media tried to spin large scale corruption of enormous US government expenditure in Afghanistan as a problem only among Afghans. However, it is hard to believe that the US intelligence and politicians had absolutely no idea about thousands of ghost Afghan soldiers that were supposedly being paid for training, but never existed. High-grade military equipment often disappeared without a trace. With its militarytechnological prowess, the US

could not locate and uproot opium trade - the economic lifeline of the Taliban - to a large extent.

The discomfiting explanation is that many representatives and affiliates of the US government participated in this elaborate corruption. Loot of this magnitude had to have the blessings of American bureaucrats, military contractors, intelligence operatives, politicians, and even some senior military personnel. However, a reading of the US history and its 'nation building' projects point to a deeper problem - this corruption is merely a consequence of a structural problem in the American economy- the Military Industrial Complex (MIC).

America's MIC is a trillion dollar business through an alliance between its defence industry and top military-security establishment, seeking to determine foreign policy. The MIC generates huge profits and high-paying jobs from the invasion and occupation of other countries. But the project is presented as "protecting or ushering in democracy," "nation building," "protection of religious and sexual minorities." To earn legitimacy around the globe, the MIC playbook was also deployed in Afghanistan to bring forward some women and minorities to token positions of power.

The MIC's "permanent wars" are unpopular among the majority of Americans, who noted that in Afghanistan alone there were around 2,500 deaths of their troops, physical and mental trauma of thousands from among 775,000 American soldiers. Most of these soldiers come from the working and lower middle classes. Americans understood how Afghanistan, by 2020, drained \$2 trillion in expenditure, while benefiting select corporations. As a recent article analysed, "If you purchased \$10,000 of stock evenly divided among America's top five defense contractors (Boeing, Raytheon, Lockheed Martin, Northrop Grumman, and General Dynamics) on September 18, 2001 — the day President George W. Bush signed the Authorization for Use of Military Force in response to the 9/11 terrorist attacks—and faithfully reinvested all dividends, it would now be worth \$97,295.'

The threat of the MIC was flagged as early as 1961. Outgoing President Eisenhower had then spoken of "a permanent armaments industry of vast propor-

tions... the total influence - economic, political, even spiritual is felt in every city, every State house, every office of the Federal government." Anti-war activists have been warning that the MIC hand is seen in America's forays into Iraq, Libya, Syria, Yemen, and Somalia. Every new country that America steps into attracts fresh orders for choppers, armoured vehicles, bombs, guns, and assorted weapons. With a military budget of an estimated \$778 billion, the USA was the world's largest spender in 2020, accounting for 39 per cent of global military spending or as the next 12 largest spenders combined, as per an analysis by Stockholm International Peace Research Institute (SIPRI).

Despite its war profiteering, the MIC has been largely flying under the radar of American political discourse. Mainstream media, heavily dependent on advertisements from defence manufacturers, actively works to suppress dissenting voices. As America withdrew from Afghanistan, media houses and vested interests have been exploiting the anguish of Afghans. Despite 20 years of failure, the Biden administration's decision to exit is being portrayed as "sudden," "irresponsible," and "selfish." Afghanistan has demonstrated a poor human rights record even during the height of American occupation. But the record is amplified or muted by US media de pending on how profitable the war is for its defence advertisers.

America's longest war may have ended, but Afghanistan is just one box on the chessboard. Ordinary Americans are helpless as the mighty alliance of the MIC, political class, military-security elite, and corporate media continue to recruit and sacrifice their children and their tax dollars to plunder countries in the Middle East and Africa. In capitalism's holy ground, even democracy is a business.

But with their lukewarm cooperation on COVID-19 vaccines, they have missed an important opportunity to demonstrate their ability to mount a strong collective response to a global crisis.

The pandemic has hit the BRICS hard. India has recorded the highest number of infections within the group (and the second most globally, after the US), with 32.2 million at the time of writing. Brazil has reported 20.3 million cases, Russia 6.6 million, South Africa 2.6 million, and China where the pandemic originated fewer than 100,000. Total COVID-19 deaths across the five countries now stand at 1.25 million, with Brazil and India accounting for 80

per cent of these. This heavy toll - and the fact that the rich countries of the G7 have purchased over one-third of the world's COVID-19 vaccine supply, despite accounting for only 13 per cent of the global population should have provided an impetus for stronger cooperation among the BRICS countries. But as the University of the Witwatersrand's Vishwas Satgar noted recently dur-

Russia, India, China, and Policy Center, the BRICS countries South Africa-collaborate in "have seen a divergence, inconsistency and lack of cooperation on COVID-19 vaccination.

> Even some of the vaccines developed by BRICS countries themselves have received a mixed reception within the bloc. In August 2020, Russia became the first country in the world to register a COVID-19 vaccine candidate, and three months later, it became the first among the BRICS to announce a high-efficacy vaccine: Sputnik V. The vaccine is reportedly 92 per cent effective against the coronavirus. But scientists have criticised the rapidity of the Sputnik V trials and lack of transparency regarding the raw data, and the WHO has yet to approve the vaccine.

Among the other BRICS countries, the Brazilian Health Regulatory Agency initially blocked Sputnik V in response to data indicating adverse side effects. It reversed this decision in June 2021 and allowed the import of 928,000 doses. India received 125 million doses of the vaccine in May 2021

The South African Health Products Regulatory Authority has not approved Sputnik V for use and is awaiting further data from the Russian Gamaleva Research Institute. which developed the vaccine.

In contrast, the WHO granted

vaccines emergency-use listings in May and June 2021, respectively. Brazil participated in Sinovac trials and, following positive results, has continued to use this vaccine. But although the Drugs Controller General of India announced in June that WHO-approved COVID-19 vaccines will no longer require post-approval bridging trials and batch testing in India, it is unclear whether the country will include the Sinovac and Sinopharm vaccines in its immunisation programme. Likewise, South Africa gave the Sinovac vaccine the green light for use in July 2021, but has yet to announce any procurement plans.

Then there is vaccine manufacturing. India accounts for 50 per cent of all global vaccine supplies, and the Serum Institute of India - the world's largest vaccine producer – has worked with the Oxford Vaccine Group to produce Covishield, a local version of the AstraZeneca-Oxford COVID-19 vaccine. The Indian and South African vaccine producers have entered technology-centered agreements with their Western partners, but do not own any COVID-19-related patents. In an attempt to address this issue, even before concluding these agreements, the two countries' governments led a push at the WTO in October 2020 to waive intellectual-

property rights for COVID-19 technologies and vaccines.

But BRICS foreign ministers posal until June 2021, eight months after it was first submitted. China and Russia had previously remained silent on the issue, while Brazil, as BRICS expert Karin Costa Vazquez notes, was the only member of the group openly to oppose this idea, in direct alignment with former US President Donald Trump. Brazil's position became more supportive only in early 2021, after India said it would start sending COVID-19 vaccines to key partner countries, and US President Joe Biden's administration announced its support for the proposed IP waiver.

The pandemic has tested the BRICS countries' collective strength, and found them largely wanting. The bloc has therefore missed a chance to bolster its advocacy of international governance reform, and cast doubt on its fitness for purpose in responding to arising critical global challenges.

## Begging is not a crime

Sir, According to an estimate, there are more than four lakh men and women who beg for a living in India. Arguably, beggars are not a sight for sore eyes. Disheveled men and women running after people asking for alms can be repulsive. But does that mean beggars must be isolated and put behind the bars? In other words, are beggars criminals? Different courts have regularly addressed the issue. Some high courts have had divergent views on begging. The Delhi High Court, for example, had questioned how begging can be seen as a crime when it is a direct offshoot of the failure of a government to provide food and shelter to its citizens. Recently, the Bombay High Court adopted an opposite view. Like any other citizen, those who beg should also "work for the country," it had said. The court went on to say that everything cannot be handled by state governments. However, the Supreme Court, while hearing a petition said that beggars were products of socioeconomic depravity and begging is a source of livelihood to people who are robbed of education or employment. While a final judgement in the case is yet to come, the court's observation is sympathetic. Control of begging is a state subject, and many states have taken a strong view on begging. Some have viewed begging as a social crime. But all are dictated by the Bombay Prevention of Begging Act, 1959. Some stringent penal provisions are provided in the Act. Those defined as beggars under the Act can be rounded up without warrant and subjected to 'summary trials' with a punishment ranging from one year to 10 years. Certain mafia syndicates are active in recruiting beggars to suit their needs. Therefore, states should tread carefully on the larger problem. Ganapathi Bhat, AKOLA

Meanwhile, Srikant Nayak, a member of Bhitarkanika Eco-sensitive Zone Committee who has been staging a sit-in protesting against the project for 14 days now has again written to the Principal Chief Conservator of Forests (PCCF) demanding that the latter stop the construction work on the project and protect Bhitarkanika by sending a team to study the project's impact on the region

Nayak further said that a water treatment plant is under construction at Nuahat under Chandbali block in Bhadrak district for supplying water to four blocks and three NACs of the district. Water from Kharasrota river is being drawn from near Barunadiha for this treatment plant. These two places come under Bhitarkanika's eco sensitive zone. Moreover, the report and resolution prepared for the project are based on false information, he alleged

To substantiate his claim, he provided proof in the letter, it was learnt. Even various environmentalists in the state have expressed their concern over the project.

Similarly, Saroj Kumar Pattanayak, a retired PCCF, said, "There are 410 villages in Bhitarkanika area. The villagers need sweet water for agriculture. This apart, sweet water is also required for sustenance of different varieties of tress in saline forest During monsoon, there is no dearth of sweet water in the area. But, during the remaining part of the vear, supply of sweet water diminishes. In search of sweet water. wild animals often sneak into human habitations. Keeping these factors in view, a special report needs to be prepared. The eco sensitive zone monitoring committee can take a decision whether to give permission for the project or not.'

Citing the example of Sundarbans, Suresh Kumar Mishra, a wildlife expert and retired DFO, said, "The number of 'Sundari' trees in Sundarbans is next to nothing. This has happened only due to lack of sweet water. If Bhitarkanika does not get enough sweet water, several trees would disappear and there would only be trees that can withstand saline water.

At the same time, crocodiles inhabiting the region would migrate elsewhere for sweet water, resulting in frequent man-crocodile conflicts. Without sweet water, the natural resources at Bhitarkanika can't be saved. A chance should be given to a technical team to assess the adverse impact of the project on Bhitarkanika National Park.'

# Three, including scribe, held for 'buying' infant for ₹2,000 -

THE ACCUSED INCLUDE A CHILDLESS COUPLE AND A WEB REPORTER

Baripada/Saraskana, August 23: Jharpokharia police in Mayurbhanj district arrested three persons, including a couple and a Web reporter, for allegedly selling a two-month-old newborn in the area for ₹2,000, police said.

Acting on a complaint, police rescued the newborn from Rairangpur and admitted the infant to Pandit Raghunath Murmu (PRM) Medical College and Hospital at

The accused were identified as Prahallad Pratihari and his wife Liza Partihari of Sankhabhanga area under Saraskana police limits and Tapan Dandapata.

A case was registered in this connection and the accused were produced in a court, Monday. A sum of ₹2,080 was seized from the accused woman, Jharpokharia IIC Subhransu Nayak said.

According to reports, the mother of the baby, who is also the complainant and deserted by her husband, is a native of Danadar under Jharpokharia police limits in the district. She had filed an FIR with the Jharpokharia Police Sunday

in this regard. As per sources, the woman was staying at Kundalbani area with the baby. However, as the baby was not keeping well, she decided to take him for treatment to Sirsa Community Health Centre (CHC). She was returning home after get-

ting her baby was examined by a doctor from the CHC when the Web reporter Dandapata waylaid her forcibly picked her and her baby on his vehicle and fled with them. He tried to lure her by offering money and other things and asked to hand over the infant to him. The accused even threatened her of dire consequences if she did not hand over the baby to him.

The woman refused to oblige when Dandapata called the couple to the spot. The childless couple reportedly lured her with ₹2,000 and took the baby with them assuring her to get him treated by

The woman was very disturbed and alerted others about the incident as the couple did not reSoon people gathered at the spot, while police also reached the place and took stock of the situation. Meanwhile, Dandapata also reached the spot and tried to suppress the matter. However, the locals nabbed him and beat him up black and blue in the presence of police.

Police rescued Dandapata and, on the basis of his information, rescued the baby from the house of the couple in Rairangpur. Police arrested Dandapata and the couple in this connection. However, the three have rejected the charges.

Meanwhile, the infant has been admitted to the Paediatric Intensive Care Unit at PRM Medical College & Hospital for treatment. Further investigation into the matter is underway.

# Housing benefits elude Juangas

35 JUANGA FAMILIES INHABIT THE REMOTE BARAGADA VILLAGE AND THEIR LIVING STANDARD HAS **REMAINED WHAT IT WAS TEN YEARS AGO**

Keonjhar, August 23: Despite a host of welfare schemes and measures undertaken to bring about a change in the lives of tribals, many from the Juanga tribe have been leading a miserable life in the hilly areas of Bansapal block in Keonjhar

According to reports, 35 Juanga families inhabit the remote Baragada village and their living standard has remained the same as it was ten years ago.

They live in mud houses with thatched roofs as none of the various housing schemes of the state and the Central government has remained out of  $\bar{b}$ ounds for them.

Although 10 Juanga families in the region were to receive houses under a scheme, construction of those houses has been left half way for years. The authorities concerned have not taken any step to get these housing units completed,



it was alleged.

Besides, elderly persons of the village, including Sana Juanga, Saibani Juanga, Bansidhar Juanga, Chanda Juanga, Sidhha Juanga and Kansla Juanga, have been left out of social security schemes like pensions and others.

The Juanga-dominated village is tucked away in the hilly terrains where the livelihood of people is solely dependent on minor

forest produce. The village is 50 kilometres away from the block headquarters. In the absence of proper communication facility, people are compelled to suffer a lot, it was alleged.

This village has a drinking water project, but all taps do not work. In such a situation, the tribals are forced to consume water collected

from a nearby stream. "Though the village has electricity, low voltage has been a major problem. We are clearing all the dues, but do not receive receipts," said Yadav Juanga.

Some conscious residents alleged that a number of welfare schemes for the tribals are not reaching them. "The village development has been given a short shrift despite funds coming from the government. Moreover, there is no proper road to the village. As a result, access to ambulance and fire tenders is almost impossible,' some villagers lamented.

Owing to lack of any means of livelihood, tribals here have resorted to shifting cultivation by burning trees to clear the forest. For them, working in MGNREGS has been a dream, they alleged.

"As they have no sources of livelihood, they are bound to destroy the forest to make space for cultivation. This has led to the loss of natural environment," observed Pradip Rout, a social activist.

# Umar Khalid calls Delhi India's first smog tower comes up in Delhi riots case 'cooked up'

New Delhi, August 23: Former JNU student leader Umar Khalid, arrested under the Unlawful Activities (Prevention) Act in the north-east Delhi riots conspiracy case, told a Delhi Court Monday that there were various contradictions in the police's claims and called it a 'cooked up' case.

Khalid, along with several others, has been booked under the stringent anti-terror law UAPA. They are accused of being the 'masterminds' of the February 2020 violence, which had left 53 people dead and over 700 injured. He has sought bail in the case.

Trideep Pais, Khalid's lawyer, told Additional Sessions Judge Amitabh Rawat that the FIR was cooked up and unnecessary, and was used selectively to target and frame them. The counsel pointed to two contradictions in Delhi Police's claims. Firstly, he showed the court a 21-minute video clip of Khalid's speech in Maharashtra, which the prosecution had allegedly labelled inflammatory.

The lawyer, pursuant to showing the video, apprised the court that his client did not give any call for violence through the speech and in



fact gave a message of unity to the people. "A message of unity based on Gandhi ji was given by Umar Khalid that day. It was termed as terror. Content is not seditious. He is talking about democratic power. He referred to Gandhi," Pais added.

Secondly, he argued that as per the police case, Khalid conspired with other accused January 8 to cause riots during former US President Donald Trump's visit, however, the news about his visit was announced only in February.

"These are the kind of lies they are peddling. This is a joke. This FIR is a cooked-up theory. Is it that easy to prosecute people? Do you have no responsibility as a prosecu-

tion?" Pais said. Delhi Police had recently said that the bail plea has no merit and that it will demonstrate the prima facie case against him before the court by referring to the charge sheet filed in the case.

In April, the former JNU stu-

dent was granted bail in one of the riot cases. The court while granting him bail noted that he was not physically present at the scene of the crime on the date of the incident. Besides him, JNU students Natasha Narwal and Devangana Kalita, Jamia Coordination Committee members Safoora Zargar, former AAP councillor Tahir Hussain and several others have also been booked under the stringent law in the case.

THE NATIONAL CAPITAL IS AMONG THE MOST POLLUTED CITIES IN THE WORLD

New Delhi. August 23: Chief Minister Arvind Kejriwal inaugurated the "country's first smog tower" at Connaught Place in Delhi, one of the most polluted cities in the world, Monday and said it will prove to be a path-breaking milestone and many such structures can be installed in the capital if the pilot project yields results.

"This is the first such smog tower in the country. It's a new technology. We have imported it from the US. The structure will suck polluted air from above and release clean air from below. It will purify 1,000 cubic metres of air per second," Kejriwal told reporters.

The smog tower has 40 fans and 5.000 filters developed by experts at the University of Minnesota which also helped design a 100-metrehigh smog tower in Xian, China.

According to reports, the experimental tower in northern China has brought a noticeable improvement in air quality.

A Delhi government statement said the 24-metre-high smog tower at Connaught Place, one of the biggest commercial centres in the capital, is based on a downdraft air-flow model

Its 40 huge fans will suck air from the top of a special type of canopy structure and release clean air filtered through novel geome-



try filters, it said.

Since it's a new technology, it is being implemented on an experi-

(TPL) built the smog tower with technical support from IIT-Bombay and IIT-Delhi, which will analyse

'The experts will analyse the functioning of the smog tower and tell us if it is effective. If it is successful, many such smog towers can be installed across Delhi. If not, we will work on some other technology... I think it will prove to be a path-breaking milestone," he added. In November 2019, an expert panel estimated that the capital will need 213 such anti-smog towers. "Data analysis will start immediately. The initial trends will be available within a month... I am also excited to know if we succeeded or not," the chief minister said, adding that a detailed performance report will be ready within two years.

### It rains when farmers sing; Cambridge to pursue research INDO-ASIAN NEWS SERVICE

Jaipur, August 23: Believe it or not! It always rains when Rajasthan farmers take umbrellas to their fields and sing Raga Megh Malhar under the open sky when there is scanty rain.

This is a rare event and is said to date back around 1.000 years -- it is followed by farmers singing songs in glory of Veer Tejaji, a local hero who sacrificed his life to protect cows. Rajasthan's 'Teja songs' sung in glory of Veer Tejaji. a Jan Nayak also known as people's hero, will soon be researched by PhD students in the UK, historians say here.

Seeing the popularity of Teja singing, a 300-page book was written on this singing format 11 years back by Madan Meena who hailed from the eastern belt of Rajasthan with the support of Cambridge University. The book has been made available to researchers there. Now the students will be pursuing a PhD there and will research Teja songs. All the documents related to the Teja singing book 'Teja Gatha' and complete information along with files of audio and video recordings are also available on the website of Cambridge University, says Ashok



Chaudhary, a veteran historian.

"In 2008, we made an attempt to revive this centuries-old tradition and connected with artists. We were taken to forts, palaces and villages and now the art is known to everyone in Rajasthan," he said.

Locals in the desert state have seen a strong connection between this music and rain. When this music is sung by farmers in the desert state during scanty rainfall, Lord Indra blesses the earth in the form of rain, say Dr Rajni Gawadiya, state president of the Karmabai Jaat Women Institute.

These heroic songs, being sung since the 10th century in different ways in different parts of the state, are believed to be similar to what foreigners call Opera in their countries.

As the Opera style of music in foreign countries holds a special place in its own way, similarly Teja songs of Rajasthan also hold a special place for its different type of singing, says Rajni adding that Teja songs are mostly sung in Nagaur district of Rajasthan to

please the folk deity Tejaji for rain. Farmers generally leave the house with an umbrella even when

there is no sign of rain and sing Tejaji songs. They believe that when they sing non-stop, it rains

# '3rd wave to hit **India in Sept-Oct'**

The vaulting relief over seemingly petering off of the second wave of Covid-19 is watered down by reports that India is headed for a third wave of Covid-19 in Sept-Oct

New Delhi, August 23: An expert panel, set up by an institute under the Ministry of Home Affairs (MHA), has predicted a third wave of Covid-19 hitting the country anvtime between September and October and suggested significantly ramping up vaccination pace.

The committee of experts, constituted by the National Institute of Disaster Management (NIDM). also said children will have a similar risk as adults since paediatric facilities, doctors and equipment like ventilators, ambulances, among others are nowhere close to what may be required in case a large number of children become in-

The report, which has been submitted to the Prime Minister's Office (PMO), observed that only around 7.6 percent

**COVID CRISIS** (10.4 cr) people are fully vaccinated in India and if the current vaccination rate is not increased, India can witness six lakh cases per day in the next wave. "Leading experts have repeatedly warned of an imminent third Covid-19 wave in India. Epidemiologists predict a series of surges till we achieve herd immunity through infection or vaccination and the disease be-

comes endemic." the report said. The NIDM report quoted the prediction of experts from IIT Kanpur



cases per day.

In scenario two, with the emergence of new and more virulent variants, the third wave could peak in September with likely five lakh positive cases per day.

In scenario three, the experts predicted that the third wave could peak in late October with two lakh positive cases per day. According to the report, earlier, it was proposed that if 67 percent of the population became immune (a few by infection and rest through vaccination), herd immunity could be achieved. But this has now been complicated by the new and more virulent mutated variants of SARS Cov-2 that have the ability to escape immunity from earlier infections and in some cases even the prevalent vaccines,

This has pushed the target immune population for achieving herd immunity to 80-90 percent. Hence, our

health system and vaccines are caught in a race against the virus and are trying to catch up with risks that are evolving every day creating uncertainty all over the world, it said.

The NIDM is now taking a clue from several warnings indicating an imminent third wave, trying to understand them and prepare for the third wave. With this backdrop. it engaged with multiple stakeholders from diverse backgrounds in an attempt to formulate consolidated

# NHRC issues notices to Centre, Assam, Mizoram

Guwahati, August 23: The National Human Rights Commission (NHRC) issued notices to the Centre, Assam and Mizoram over the deadly border clash between the two Northeastern states in July, stating that "grave violation of human rights" took place.

Acting on a complaint by one Md Injamul Haque of Assam, the NHRC on Sunday issued notices to the Union home secretary and the chief secretaries of Assam and Mizoram, and asked them to file their reports within four weeks.

"The Commission has considered the matter. Facts of the case are disturbing. The allegations made in the complaint are serious in nature involving deaths and injuries to the public servants. "The case therefore involves grave violation of Human Rights of the deceased and injured. Such types of cases are viewed very seriously by the Commission.



In these circumstances, let a Notice be sent," as per the details of the proceedings. Accordingly, notices were issued and the matter will be put up before the full commission after four weeks. At least six Assam Police personnel and one civilian were killed and more than 50 people injured as the festering border dispute between the two Northeastern states erupted into a bloody conflict July 26. The NHRC said that it had received the complaint from Haque on July 30, alleging attack on senior police officers of Assam, officers of the

Cachar district administration and others by a mob and Mizoram Police. "The petitioner has also given details of the incident that occurred on 26.7.2021 on the Assam Mizoram border wherein public servants lost their lives, got injured in the firing and has prayed for intervention by the Commission in the matter," it added.

During a meeting on August 5 in Aizawl, representatives of the two state governments had agreed to maintain peace and amicably resolve the border dispute through

# India continues evacuation; brings back 146 from Doha

New Delhi, August 23: India Monday evacuated over 70 people, including its citizens and a group of Afghan Sikhs and Hindus, from Kabul to Dushanbe in Tajikistan in an IAF aircraft while another batch of near-equal strength is planned to be taken out of the Afghan capital to the Tajik city at the earliest, people familiar with the developments said.

Separately, India brought back 146 of its nationals to Delhi in four different commercial flights from the Qatari capital Doha, days after they were evacuated from Kabul by NATO and American aircraft.

With Monday's evacuation, the number of people brought back to Delhi has gone up to around 730 since August 16 when the first group was airlifted from Kabul, a day after the Taliban seized control of the Afghan capital city.

The people cited above said the evacuees, who were taken to Dushanbe, are likely to be brought back to Delhi from the Tajikistan capital in a civilian aircraft Tuesday.

India has stepped up efforts to evacuate its citizens as well as its Afghan partners from Kabul in view of the deteriorating security situation in the Afghan capital and other parts of the country after the Taliban swept to power last week. Thousands of Afghans have been crowding around the Kabul airport for nearly a week.

The people cited above said most of the 146 Indians brought back from Doha were employees of western companies and organisations that were operating in

Afghanistan. It was the second batch of Indians that was brought home from Doha. A total of 135 Indians were flown back to Delhi from the Qatari capital in a special flight Sunday. Out of the second batch of Indians who returned home from Doha, 104 people were brought back in a Vistara flight, 30 by a Qatar Airways flight and 11 of them returned by an Indigo flight.

India Sunday evacuated 392 people including two Afghan lawmakers in three different flights under the evacuation mission amid a continued scramble by various countries to rescue their citizens from Kabul.

The Taliban seized control of Kabul August 15 after taking over almost all key towns and cities following the withdrawal of the US forces.

## JNU, TISS STUDENTS WERE DRÁFTED FOR TERROR: NIA

Mumbai/New Delhi, August 23: In stunning revelations, the National Investigation Agency (NIA) has said that the 22 main accused in the Bhima-Koregaon and Elgar Parishad cases had allegedly recruited students of at least two top Indian universities for terror activities in the country, including Maharashtra.

The NIA statement comes in the draft charges filed in the twin cases against 16 arrested accused and six other absconders in the sensational cases that have rocked the Indian polity for the past four years. As per the NIA, the accused had "recruited students from various universities, including the reputed Jawaharlal Nehru University (New Delhi) and Tata Institute of Social Sciences (Mumbai), for the commission of terrorist activi-

ties". The draft charges were filed before the NIA special court last week after its main and supplementary chargesheets were filed earlier, after long investigations into the two cases. When contacted, NIA sources declined to comment, saying the agency has already filed its chargesheet in the case.

Among other things, the accused are charged with promoting the activities and ideologies of banned outfits, and mobilising and training people and students in handling sophisticated arms and explosives.

The NIA's draft charges say the larger objective was to conspire against and destabilise the governments of India and Maharashtra and threaten their sovereignty with large-scale violence.

Taipei: Taiwan Monday started administering its first domestically developed Covid-19 vaccine amid fierce criticism over the approval process. The vaccine Medigen, meaning 'high-end' in Chinese language, is a recombinant protein vaccine developed by Medigen Vaccine Biologics Corp in collaboration with the National Institutes of Health in the US, the BBC reported.

#### **Greece wildfires: Two** new blazes break out

Athens: Greece's fire department scrambled firefighting aircraft and ground forces as at least two new blazes broke out in areas already scarred by wildfires this summer, with strong winds complicating efforts to contain them. The first broke out Monday morning in the south of Evia, Greece's second-largest island, whose north was decimated earlier this month by a blaze that burned for more than 10 days. The second was burning in the Vilia area northwest of Athens. where a major blaze was brought under control Friday after burning for five days.

### 21 dead, 20 missing in Tennessee floods

Washington: At least 21 people died and 20 others were reported missing after severe floods hit Humphreys County in the US state of Tennessee August 21, authorities said. "Today, we are trying to get a good evaluation picture," County Sheriff Chris Davis said Sunday. "The ones we have missing are mainly from the area of the greatest impact of the watcher when it first came up," Davis said, adding that "from children to elderly is what our deceased is ranging from".

### German loco pilots on 2nd 2-day strike

Berlin: Many train drivers with Germany's national railway walked off the job Monday as their union embarked on its second two-day strike this month in a bitter dispute with the company. The GDL union called on passenger train drivers to strike from 2 am Monday to 2 am Wednesday. Freight train drivers already started their strike Saturday afternoon, Railway operator Deutsche Bahn planned to run about one-quarter of longdistance trains, while about 40% of regional and local services were expected to go ahead.

# It's a red line, say Taliban

TALIBAN THREATEN CONSEQUENCES IF THE AUGUST 31 DEADLINE FOR THE TROOP WITHDRAWAL IS EXTENDED

London, August 23: Ahead of an emergency G7 meeting on Afghanistan, the Taliban Monday warned that there will be consequences if the US and UK sought an extension to the August 31 deadline for the US-led troop withdrawal from the war-torn country.

Speaking to 'Sky News' in Doha, Qatar, Taliban spokesperson Dr Suhail Shaheen stated that the month-end deadline was a red line. as any extension would imply an extended occupation of the country.

He said the timeline had been laid out by US President Joe Biden and threatened consequences if the US and UK sought an extension to that deadline.

**KABUL:** A firefight at one of the gates of Kabul's international airport killed at least one Afghan soldier early Monday, German officials said, in the latest chaos to engulf Western efforts to evacuate those fleeing the Taliban takeover of the country. The shooting at the airport came as the Taliban sent fighters north of the capital to eliminate pockets of armed resistance to their light-



ning takeover earlier this month. The Taliban said they retook three districts seized by opponents the day before and had surrounded Panjshir, the last province that remains out of their control.

### **UK** struggles for influence

he messy exit of Western military forces from Afghanistan and the swift takeover of the country by the Taliban has stunned officials in Britain and strained the UK's "special relationship" with its most important ally, the United States, London's powerlessness, so far, to change Washington's course also is a blow to UK hopes that an assertive "Global Britain" will be a major global player in the wake of its exit from the European Union. The main stumbling block ahead of an emergency summit of Group of Seven leaders Tuesday is a deadline for the US effort to evacuate thousands of Americans, Afghans and others from Kabul. US troops are scheduled to end their mission August 31, and Britain wants an extension.

### US troops rush evacuations

The US military reported its biggest day of airlifts out of Afghanistan by far Monday, but deadly violence that has blocked many desperate evacuees from entering Kabul's airport persisted, and the Taliban signaled they might soon seek to shut down the evacuation. Twenty-eight US military flights ferried about 10,400 people to safety out of Taliban-held Afghanistan over the 24 hours that ended early Monday morning, a White House official said. After more than a week of evacuations plagued by major obstacles, the number of people flown out met and exceeded US Projections for the first time. The count was more than twice the 3,900 flown out in the previous 24 hours on US military planes.

# 'SE Asia, Indo-Pacific to dictate future of world'

Singapore, August 23: US Vice President Kamala Harris Monday said she believes that Southeast Asia and the Indo-Pacific will dictate the future of the world as she held talks with Singapore Prime Minister Lee Hsien Loong as part of her Southeast Asia visit aimed at bolstering America's engagement in the region.

Harris, at a press conference here with Lee, pointed out that the agreements the US has inked with Singapore and the Southeast Asian region are evidence of its strength and enduring relationships around the globe.

These are not only priorities that relate to the US' security or economic interests but they also relate to challenges the world faces going forward - such as future pandemics and what countries can do together to research on and stop them, she said. "This is a relationship that is based on a shared vision, both in terms of the challenges we face, and also the opportunities that we face... It is about the future in terms of our mutual commitment, curiosity and interest," said Harris, who arrived here on Sunday but was given a formal welcome on Monday

### US offered tanker aircraft for Afghan evacuation

Singapore Monday offered America one of its tanker aircraft to airlift stranded civilians from war-torn Afghanistan, Prime Minister Lee Hsien Loong said as he held talks with US Vice President Kamala Harris during which the two countries signed a number of key agreements to enhance cooperation, including in defence and cybersecurity. Vice President Harris' visit to Singapore is part of a diplomatic charm offensive by the Biden administration in Southeast Asia, a region that is crucial to the future prosperity and security of the United States, amidst China's aggressive actions in the region. Harris thanked Lee for the "very generous offer" to assist the US in its evacuations from Afghanistan.

Colombo, August 23: Sri Lanka's medical experts Monday said the Delta variant of the Covid-19 which is spreading across the country has acquired four mutations due to the high transmission rate but did not have any effect on vaccine efficacy.

Head of the Department of Immunology and Molecular Sciences of the Sri Jayawardenapura University, Professor Neelika Malavige said while the four mutations were found following gene sequencing, there was no urge to panic until the implications of the mutations were established, reports Xinhua news agency.

One of the Delta mutations (A-222V) is seen in many countries, another (A-1078S) is found in Sri Lanka and Malaysia, while the other two (A-701S and R-24C) are



only found in Sri Lanka. These are just mutations in the virus and that does not make these viruses new variants, Malavige was quoted by a local newspaper as saying.

We had identified many other mutations in the previous Alpha variant and in our variant of the Sri Lankan lineage (responsible for the second wave), which were of no significance. Therefore, although some of the Delta variant

### Lanka lauds India's **'continuous support'**

**S**ri Lanka's newly-appointed foreign minister GL Peiris Monday appreciated India's "continuous support" for combatting the Covid-19 pandemic and also the USD 15 million offer to preserve and promote Buddhist cultural sites in the island nation. During a meeting between Peiris and Indian High Commissioner Gopal Baglay here. the two sides highlighted the pivotal importance of relations between Lanka and India which have stood the test of time as close neighbours and expressed satisfaction at the current level of cooperation and resolved to raise bilateral relations in multiple sectors to even higher levels, the foreign ministry said in a statement.

### Highest 1-day spike

Sri Lanka's Health Ministry said Monday that the country recorded its highest single-day Covid-19 tally of 4,282 cases Sunday, taking the total infections to 390,000 since March last year. According to official figures, Sri Lanka surpassed the 4,000mark in daily infections Sunday and now its total active patient count stood at 40,475. The death toll from the virus has reached 7,366. Sri Lanka is witnessing a rapid spike in Covid-19 infections due to the Delta variant and Friday, the country to minimise the spread, the Xinhua news agency reported.

Malavige said that these mutations were highly unlikely to have any effect on vaccine efficacy and requested people to get vaccinated against Covid-19.

Sri Lanka is presently facing a rising wave of Covid-19 infections. suspected to be caused by the Delta variant with authorities declaring a nationwide quarantine curfew since August 20 which will be lifted August 30.

## **RUSSIA TO START BUILDING** WARSHIPS AMID TENSIONS

Moscow, August 23: Russian President Vladimir Putin Monday launched the construction of new nuclear submarines and other warships, part of a sweeping military modernisation effort amid tensions with the West. Speaking in a video call, Putin

gave orders for two nuclear submarines armed with intercontinental ballistic missiles along with two diesel-powered submarines and two corvettes at shipyards in Severodvinsk, St Petersburg and Komsomolsk-on-Amur.

"We will continue to boost the potential of the Russian navy, develop its bases and infrastructure, arm it with state-of-the-art weapons." Putin said. "A strong and sovereign Russia needs a powerful and well-balanced navy.'

The Kremlin has made military modernisation a top priority as relations with the West have plunged to post-Cold War lows after Russia's 2014 annexation of Ukraine's Crimea. Moscow has sought to reestablish a regular naval presence in parts of the world that the Soviet Union had during



the Cold War.

The Russian navy already has a major presence in the anean Sea, with a naval base in the Syrian port of Tartus. It has expanded and modified the Tartus base, the only such facility that Russia currently has outside the former Soviet Union.

'We will continue to show the Russian flag in strategically important ocean areas," Putin said.

Monday's ceremony for the new ships was part of the Army-2021 show intended to showcase military might and attract foreign customers for Russia's arms industries. The week-long show features aircraft. tanks, missiles and other weapons.

"Many of our weapons have the capabilities that have no analogues in the world, and some will remain unrivaled for a long time to come," Putin said

### PRESS TRUST OF INDIA Lahore, August 23: Police in

Pakistan have arrested 126 people allegedly involved in the sexual assault of a YouTuber girl Independence Day at the historic Minar-i-Pakistan, after the incident sparked nationwide outrage and drew international condemnation.

The incident took place August 14 when hundreds of youngsters were celebrating Independence Day at Azadi Chowk near Minari-Pakistan in Lahore. Hundreds of young men can be

seen in the videos throwing the girl in the air for fun, dragging her, tearing her clothes and molesting her.

Police had registered a case Tuesday against 400 unidentified men for assaulting the girl and her companions. Police have arrested 126 suspects so far in this case after identifying them through video footage and sent them to jail for identification parade. The victim will identify the suspects in the jail, Punjab IGP Inam Ghani said in a

statement Monday. He said most arrests came from the surroundings of the Minar-i-Pakistan from where a large number of people had participated in the Independence Day celebration.

# Aid groups: Millions in Syria, Iraq losing access to water

**THE TWO NEIGHBOURING COUNTRIES, BOTH BATTERED BY YEARS OF CONFLICT AND** MISMANAGEMENT, **ARE IN NEED OF RAPID ACTION TO COMBAT SEVERE WATER SHORTAGES**  PRESS TRUST OF INDIA

Beirut, August 23: Millions of people in Syria and Iraq are at risk of losing access to water, electricity and food amid rising temperatures, record low water levels due to lack of rainfall and drought, international aid groups warned Monday.

The two neighbouring countries, both battered by years of conflict and mismanagement, are in need of rapid action to combat severe water shortages, the groups said.

The drought is also disrupting electricity supplies as low water levels impact dams, which in turn impact essential infrastructure, including health facilities.

More than 12 million people in both countries are affected, including 5 million in Syria who are directly dependent on the Euphrates River. In Iraq, the loss of access to

water from the Euphrates and

Tigris River, and drought, threaten



at least 7 million people.

Some 400 square kilometers (154 square miles) of agricultural land faces drought, the groups said, adding that two dams in northern Syria, supplying power to 3 million people, face imminent closure.

Carsten Hansen, regional director for the Norwegian Refugee Council, one of the aid groups behind the warning, said that for hundreds of thousands of Iragis still displaced and many more still fleeing for their lives in Syria, the

unfolding water crisis "will soon become an unprecedented catastrophe pushing more into displacement.'

Other aid groups included Mercy Corps, the Danish Refugee Council, CARE international, ACTED and Action Against Hunger.

They warned that several Svrian provinces — including Hassakah, Aleppo and Raqqa in the north and Deir el-Zour in the east have witnessed a rise in waterborne diseases.

The areas include displacement settlements housing tens of thousands of people displaced in Syria's 10-year conflict.

CARE's regional chief for Mideast and North Africa, Nirvana Shawky, urged authorities and donor governments to act swiftly to save lives. The latest crisis comes on top of war, Covid-19 and severe economic decline, she said.

"There is no time to waste," said Gerry Garvey of the Danish Refugee Council, adding that the water crisis is likely to increase conflict in an already destabilized region.

Severe water shortages have also hit Lebanon, which is mired in the worst economic and financial crisis in its modern history, where more than 4 million people - mainly vulnerable children and families - face critical water shortages in the coming days, the UN's

children agency warned last week. In Lebanon, severe fuel shortages have also halted the work of thousands of private generators long relied on for electricity in the corruption-plagued country.

UNICEF called for urgent restoration of the power supply to keep water services running.

Lebanon's rivers are also heavily polluted. Activists have long warned about pollution levels caused by sewage and waste in the Litani River, the country's longest and a major source for \( \) water supply, irrigation and hydroelectricity.

# 'IMF's allocation is shot in arm for global economy'

Washington, August 23: The IMF will distribute about \$650 billion in new Special Drawing Rights to its members Monday, providing a "significant shot in the arm" for global efforts to combat the Covid-19 pandemic, Managing Director Kristalina Georgieva said.

The International Monetary Fund's largest-ever distribution of monetary reserves will provide additional liquidity for the global economy, supplementing member countries' foreign exchange reserves and reducing their reliance on more expensive domestic or external debt, Georgieva said in a statement.

"The allocation is a significant shot in the arm for the world and, if used wisely, a unique opportunity to combat this unprecedented crisis," she said.

Georgieva said the IMF was encouraging rich countries that receive SDRs to channel them to poorer countries that need them more.

One key option is for wealthier

countries to contribute SDRs to the IMF's existing Poverty Reduction and Growth Trust for low-income countries, she said.

The IMF was also continuing to work on a possible Resilience and Sustainability Trust that could use channeled SDRs to help the most vulnerable countries with structural transformation, including dealing with climate change, she said.

Another possibility, she said, could be to channel SDRs to support lending by multilateral development banks.

The IMF's last SDR distribution came in 2009 when member countries received \$250 billion in SDR reserves to help ease the global financial crisis.

To spend their SDRs, countries would first have to exchange them for underlying hard currencies, requiring them to find a willing exchange partner country.

# PSBs to push co-lending with agri financing, NBFCs

New Delhi, August 23: Co-lending with non-banking firms, digital, agriculture financing, and technological resilience for 24x7 banking are expected to be part of Ease 4.0 Index, a reform agenda for 2021-22 for public sector banks, sources said

Launched in January 2018, Enhanced Access and Service Excellence (Ease) is the common reform agenda for all public sector banks (PSBs) aimed at institutionalising clean and smart banking. Ease 4.0 reforms agenda for financial year 2021-22 is likely to be unveiled by Finance Minister Nirmala Sitharaman later this week, sources said.

She is expected to declare the results of Ease 3.0 Index for 2020-21, they said, adding that PSBs would be rated on various indexes

Sources said, this year PSBs will focus on introducing and promoting new analytics-based offers to existing retail customers like preapproved car loans, EMI offers on e-commerce purchases and also for existing MSME customers.

Such offers will be based on bank transactions, income tax and GST returns, transactions on e-

commerce portals, and other op-



erational data, they added.

As per the proposed reform agenda, banks will leverage partnerships with third parties, including agritech firms and strive to automate processing and sanction of agricultural loans based on field visit, borrower interaction, and risk assessment in states with digitised land records.

Under the co-lending model with non-banking finance companies, banks will take 80 per cent exposure, while NBFCs will provide customer service and grievance redressal.The Finance Minister is scheduled to meet heads of PSBs August 25 to review financial performance of the lenders and progress made by them to support the economy battered by Covid-19 pandemic. Given the importance of the banking sector in generating demand and boosting consumption, sources said the meet ing with MDs and CEOs of PSBs is considered important.

## Pfizer to buy drug developer Trillium

in \$2.3 billion deal



Ottawa, August 23: Pfizer Inc said Monday it would buy Canadian drug developer Trillium Therapeutics Inc in a \$2.26 billion deal to strengthen its arsenal of blood cancer therapies.

Pfizer, which acquired a \$25 million stake in Trillium last year, will buy the remaining outstanding shares for \$18.50 apiece, representing a 203.8% premium on the stock's last closing price.

Pfizer expects to benefit from Canada-based Trillium's bloodcancer therapies that target a "don't eat me" signal used by cancer cells

to evade the immune system. Forty Seven Inc, which is also developing drugs that target the same antibodies, was bought by Gilead Sciences Inc (GILD.O) for \$4.9 billion last year. More than 1 million people worldwide were diagnosed with blood cancer in 2020, representing almost 6% of all cancer diagnoses. The same year, more than 700,000 people worldwide died from a form of blood cancer.

Trillium's U.S.-listed shares were trading at \$17.73 before the bell on Monday, having fallen 59% in 2021 as of their last close. Pfizer bought nearly 2.3 million Trillium shares at \$10.88 each in September.

# India can become world's 2nd-largest cloud talent hub: Study

New Delhi, August 23: India has the potential to become the world's second-largest cloud talent hub with the combined effort of government bodies, education and skilling organisations and technology providers, IT industry body Nasscom said Monday.

Nasscom, in association with Draup, said in a report that India currently ranks third globally with an installed talent pool of 608,000 (FY2021) cloud professionals.

"By 2025, India would have an estimated 1.4-1.5 million cloud professionals (baseline growth). However, with an estimated demand for over 2 million professionals by 2025, India could reach 1.7-1.8 million cloud talent pool with a fairly aggressive skilling

roadmap," the report titled 'Cloud Skills: Powering India's Digital DNA' said. Tata Consultancy Services (TCS) and Accenture were strategic partners for the research effort. With rapid digital acceleration and everything becoming on-demand and need-based, migration to cloud-based services will provide a significant competitive advantage for SMEs and enterprises in the new normal. This is further expected to grow exponentially with accelerated cloud adoption across sectors

Infrastructural agility, flexibility, and resilience on cloud with significantly lower costs, especially post the pandemic, have been the key growth drivers for such a shift, the report said.



'Cloud has moved from being a relative back-end to a front-end (business-facing) technology, enabling on-demand access to resources," Nasscom President

Debjani Ghosh said. For India to carve itself a unique identity as a global hub for cloud solutions, a concentrated public-private partnership and large-scale skilling is the key, she added.Nasscom has set up its FutureSkills PRIME initiative in partnership with the Ministry of **Electronics and Information** Technology (MeitY) to upskill talent in emerging technologies and cloud skills are a key area of focus on this platform, she said.

The report said the demand for cloud solutions is growing exponentially, both in India and worldwide, leading to a higher demand for cloud talent as well. India saw about 380,000 job openings for cloud roles in 2020, a 40 per cent growth over 2019. The demand for cloud skills far outweighs the currentsupply and needs focus across stakeholders on upskilling, it added.

# Ligament tear rules India at Paralympics: Meet the past medallists Bajrang out of Worlds

New Delhi, August 23: Olympic bronze medallist Bajrang Punia will not compete in the upcoming wrestling World Championships after being advised a six-week rehabilitation to treat the ligament tear he suffered in his right knee in run up to the Tokyo Games.

The World Championships will be held in Oslo, Norway from October 2-10 and Bajrang will not be able to begin his mat training until the rehabilitation programme is compete.

Bajrang recently underwent an MRI scan to know the extent of the injury he suffered in Russia in June before the Olympics and consulted Dr Dinshaw Pardiwala, who heads the Centre for Sports Medicine at Mumbai's Kokilaben Dhirubhai Ambani Hospital.

'It's a ligament tear and I have been asked to follow a rehabilitation programme for six weeks by Dr Dinshaw. I won't be able to compete at the World Championship," Bajrang told this agency.

"The Worlds was the only major championship in the calender for this year. I don't see myself competing in any other tournament this season," he added

Bajrang had suffered the injury in the run up to the Tokyo Games when he competed at a Russian tournament – Ali Aliyev in June. Bajrang had forfeited his semifinals against Abulmazhid Kudiev, who got hold of the Indian's right leg and pulled him abruptly in the first

period of the bout. The impact had an effect on Bajrang's right knee and the limping grappler immediately quit the mat but competed at the Olympics and won a bronze in 65kg category.

### **MURLIKANT PETKAR: GOLD**

Petkar won the country's first ever medal at the Paralympics when he clinched the gold in the men's 50m freestyle swimming event, clocking a world record time of 37.33 seconds. Originally a boxer in the Indian Army, Patekar switched to swimming and other sports after losing his arm in the 1965 Indo-Pak war. He was India's first-ever individual gold medallist at the Paralympics and Olympics.

#### **NEW YORK (US), STOKE MANDEVILLE** (UK) PARA GAMES, 1984

#### **JOGINDER SINGH BEDI: 1 SILVER,** 2 BRONZE

Bedi won the silver medal in the shot put event while bagging a bronze each in discus and javelin throw events. He holds the record of being the Indian with the most Paralympic medals.

### **BHIMRAO KESARKAR: SILVER**

Kesarkar clinched the silver medal in the men's javelin throw event at the 1984 Paralympics, co-hosted by Stoke Mandeville, UK, and New York, US. He finished ahead of compatriot Joginder Singh Bedi, who claimed the bronze medal in the same event. With the Tokyo Paralympics opening Tuesday, let's take a look at all the past Indian medallists. India have won 12 medals, including four gold, and as many silver and bronze medals in the Summer Paralympics since its debut at the 1968 Games...

### **ATHENS PARA GAMES, 2004**

### **DAVENDRA JHAJHARIA: GOLD**

Jhajharia ended India's 20 year wait for a Paralympic medal by clinching the gold in the men's iavelin throw at the Athens Games. With his throw of 62.15m in Athens. Jhaiharia set a new world mark, a record that he would rewrite 12 years later. Hailing from a small village in Rajasthan's Churu district. Jhaiharia was around eight vears old when his left hand had to be amoutated immediately after he accidentally touched a live electric cable entwined in a branch of tree he had climbed. Jhaiharia would be in action in Tokyo as well.

### **RAJINDER SINGH RAHELU: BRONZE**

The second Indian medallist at the Athens Games, Rahelu, competed in the 56kg men's powerlifting event. He bagged the bronze with an effort of 157.5kg. Born in Mehsampur village, Jalandhar district, Punjab, Rahelu is suffers

from infantile paralysis. He contracted polio when he was eight

**LONDON PARA GAMES, 2008** GIRISHA NAGARAJEGOWDA: SILVER The lone Indian medallist in the

London edition of the Games. Nagarajegowda grabbed the silver in the men's high jump with a jump of 1.74 metres. With the feat. Nagarajegowda, who has an imnairment in his left leg, became the first Indian to win a medal at that event.

#### **RIO PARA GAMES, 2016 DAVENDRA JHAJHARIA: GOLD**

### Jhajharia etched his name in history books when he sent the spear to a

distance of 63.97 metres in the men's iavelin throw event in Rio, becoming the first Indian to clinch two gold medals at the Paralympics. One of India's most decorated athletes at the Paralympics, Jhaiharia also bettered his world record that he had set 12 years earlier at the Athens Games. He is also competing in the Tokyo Games with an aim of clinching his third gold medal.

### **MARIYAPPAN THANGAVELU: GOLD**

Thangavelu bagged the gold in the high jump event at the Rio Games by

three gold medal-winning Paralympians in the country. Hailing from Salem district in Tamil Nadu, his brilliant effort saw him obliterate the previous Asian record. Thangavelu, who suffered a permanent disability at the age of five when a bus crushed his right leg below the knee, will be defending his gold at the Tokyo Games.

### **DEEPA MALIK- SILVER**

Malik became the first woman from India to win a Paralympic medal when she won the silver in the shot put event in Rio with a best throw of 4.61m. A paraplegic, paralysed from waist down, Malik was consigned to the wheelchair after being operated for a spinal tumour. She currently serves as the President of the Paralympic Committee of India.

### **VARUN SINGH BHATI- BRONZE**

Bhati clinched the bronze medal in high jump at the Rio Games, accompanying compatriot Mariyappan Thangavelu, who won the gold, on the podium. Afflicted by poliomyelitis at a young age, Bhati had produced a personal best mark of 1.86 metres, capping off India's most successful Paralympics till date.
