Daspalla: In a shocking incident, a woman hacked her son to death at Nahakpada village under this police limits in Nayagarh district, Tuesday. The deceased was identified as Basant Behera, 40, son of Sarojini and Panchua Behera. He was allegedly of unsound mind and was regularly assaulting and abusing his mother over trivial issues. The accused took the extreme step after she allegedly got fed up with the repeated assaults and abuses by her son. She made up her mind to get rid of Basant and hacked him to death. Police registered a case and picked up the accused for interrogation.

#### **48 MINING LEASE TENDERS CANCELLED**

## Narayan Rane granted bail

Mumbai, August 24: In a big relief, a Raigad magistrate late Tuesday granted bail to arrested Union MSME Minister Narayan Rane in a case pertaining to his 'slap slur' against Maharashtra Chief Minister Uddhav Thackeray.

The development came around 8 hours after Rane's dramatic arrest by police from his camp in Sangameshwar, Ratnagiri, from where he was whisked off to a Raigad court late in the evening.

The central minister was nabbed - a first ever for the state - after multiple cases were filed against him in various districts for his 'slap slur' targeting Thackeray.

Leader of Opposition Pravin Darekar and others welcomed the verdict, saying it was on expected lines as Rane's arrest was illegal and it was a politically motivated case. BJP leader Sudhir Mungantiwar termed it as a victory of democracy and a defeat of the Talibani mentality' of the government.

Bhubaneswar, August 24: The Board of Secondary Education (BSE) Tuesday declared results of the offline matriculation exam 2021. As per the results, 80.83 per cent students passed the annual high school certificate (HSC) examination on the offline mode. The exams were conducted from July 30 to August 5 at 504 centres where more than 15,136 students appeared for the offline exam after they were not satisfied with the marks awarded to them through an alternative assessment method. Out of them, around 6,620 students applied for HSC examination while 8,493 students for state open school certificate examination

In the HSC exams, 5,233 students cleared the tests while 141 failed. 3100 boys and 2133 girls passed the examination. According to BSE, 42

Bhubaneswar, August 24: A day after Bihar Chief Mminister Nitish Kumar demanded a cast-based census, the Biju Janata Dal (BJD) demanded a central law to remove 50 per cent cap on reservation. Senior BJD leaders and state

ministers Ranendra Pratap Swain and Arun Kumar Sahoo held a joint press conference here Tuesday, on this issue. Swain demanded legislation of a central law to remove the 50 per cent cap on reservation and conducting of caste-based census for other backward castes (OBC) or socially and educationally back-



ward classes (SEBCs).

"More than 50 per cent of Odisha's population belong to OBC and SEBC. However, reservation at the rate of half of their population, cannot be provided to them because the ceiling fixed by the Supreme Court," Swain said.

To remove the cap set by the court, conduct of caste-based census is needed, he said. "Chief Minister Naveen Patnaik had earlier raised the issue and today, we are reiterating the same. NDA's allies also have raised this issue. It will help to ascertain the actual population of backward classes and subsequently, their development can be initiated," the BJD leader demanded. Stating hike in reservation and caste census are two sides of a coin, Sahoo said, "Due to

the capping by courts, OBC population of Odisha are deprived of getting the reservation benefits and facing difficulties." Various political parties with allegiance to the BJP have raised their voice in support of repealing the 50 per cent cap on the reservation. The silence of BJP leaders on this issue shows its apathy towards other backward classes, he said. However, the Odisha chief minister is committed to giving justice to OBCs in the state, he added. State BJP OBC Morcha president Surath Biswal said his party is not silent on this issue. The state has set up a commission to identify the OBC/SEBC people, following the intervention by Union Minister Dharmendra Pradhan. Instead, the BJD government has failed to protect the rights of OBCs.

# Ukrainian plane hijacked in Kabul

The Ukrainian plane that arrived in Afghanistan to evacuate Ukrainians was hijacked by armed miscreants and flown to Iran

New Delhi, August 24: A Ukrainian plane that arrived in Afghanistan to evacuate Ukrainians has been hijacked by unidentified people who flew it into Iran, Ukraine's Deputy Foreign Minister Yevgeny Yenin said Tuesday.

Last Sunday, our plane was hijacked by other people. On Tuesday, the plane was practically stolen from us, it flew into Iran with an unidentified group of passengers onboard instead of airlifting Ukrainians. Our next three evacuation attempts were also not successful because our people could not get into the airport, he said, Tass reported. According to him, the hijackers

were armed. However, the deputy minister did not report anything about what happened to the plane



or whether Kiev would seek to get it back or how the Ukrainian citizens got back from Kabul, onboard of this practically stolen plane or another one sent by Kiev. Yenin only underlined that the whole diplomatic service headed by Foreign Minister Dmitry Kuleba had been working in the crash test mode the whole week.

On Sunday, a military transport plane with 83 people onboard, including 31 Ukrainians, arrived from Afghanistan to Kiev. The presidential office reported that 12 Ukrainian military personnel returned home, while foreign reporters and public figures who requested help were also evacuated. The office also added that around -(100 Ukrainians are still expecting evacuating in Afghanistan.

# Not enough data in India to decide on booster dose

Many countries in the world are going full speed to deliver booster doses to people fully-vaccinated. However, *India still doesn't have enough* data to take a stand on this AGENCIES

New Delhi, August 24: Not enough data has been generated locally to decide on the need for a booster dose of COVID-19 vaccine for those fully inoculated, say experts amid the possibility of a third wave of the viral disease hitting the country between September and October. An expert panel set up by an institute under the Ministry of Home Affairs (MHA) has predicted that the third wave of COVID-19 can hit the country anytime between September and October and suggested significantly ramping up the vaccination pace

The World Health Organisation has, however, sought a two-month halt on administering booster shots of COVID-19 vaccines in view of severely constrained vaccine availability around the globe.

"India will decide on booster dose based on scientific evidence generated locally. Studies are already underway to determine the need and timing of booster for currently used vaccines in the country," said Dr N K Arora, chairman of



the COVID-19 working group of NTAGI. The need for booster doses will be determined by the epidemiology of the Covid infection in the country besides the durability

of protection provided by the current dosage regime of the vaccines. "Any booster dose regime has also to ensure that adverse events are not associated with boosting," Arora said. AIIMS Director Randeep Guleria said there is no definite evidence to suggest currently that there is a need to give booster shots to those who have been vaccinated in the past

"Current data suggests that the vaccines are effective in preventing severe disease and death in those who have been vaccinated, even against the Delta variant. "Also, we should vaccinate those who have not even received a single dose and are in the high risk category first so as to prevent severe disease and death in the upcoming wave. Currently, booster shots are not needed and as more data emerges it will be clear when and what type of booster shot is required," he said.





# **Dip in infections for 6th consecutive day**

**ODISHA REPORTS 625 FRESH COVID-19 CASES, INCLUDING 80 CHILDREN,** AND 67 FATALITIES: DAILY POSITIVITY RATE AT 1.16 PER CENT

Bhubaneswar, August 24: In what could be seen as a sigh of relief, the state has been witnessing decline in Covid-19 cases for the last six consecutive days.

Odisha's Covid-19 tally rose to 10,02,323 Tuesday as 625 more people, including 80 children, tested positive for the infection, while 67 fresh fatalities pushed the state's coronavirus death toll to 7,493, a Health department official said.

Odisha has been witnessing a decline in fresh cases for six consecutive days. The state reported 761 infections Monday, 853 Sunday, 911 Saturday, 986 Friday and 1,041 Thursday.

As many as 366 new cases were reported in quarantine centres, while the remaining 259 infections were detected during contact tracing, he said, adding that the single-day positivity rate stood at 1.16 per cent. Khurda district, under which

Bhubaneswar falls, registered the highest number of new cases at 214, followed by Cuttack (56) and Balasore (50). Cuttack recorded the highest number of fresh fatalities at 20, followed by Jagastinghpur (14) and Dhenkanal (8). Fifty-three coronavirus patients have died due to comorbidities so far.

Odisha now has 8,443 active cases, said the Health department sources. Khurda remains in red zone with 3.268 active cases, while Cuttack is in yellow zone with 1.084 infections. The remaining 28 districts fall under green zone, the official said.

#### Odisha government opened the doors of the Puri Srimandir for devotees, the Bhubaneswar Municipal Corporation (BMC) Tuesday made the production of fully vaccinated certificates mandatory for entering shrines in the state capital.

A notification issued by the BMC said that the decision was taken in view of the prevailing pandemic situation. "A person producing the hard copy or a soft copy (of the fully vaccinated certificate) will be enough for allowing him/her inside the institutions," it said.

The BMC enforcement team will conduct frequent checks to ensure strict adherence to the Covid norms. Any institution found violating these provisions will not be allowed to function, the notification said. While many temples reopened Tuesday, the famed Lingaraj Temple and Iskcon Temple will open their

doors for the devotees September 1.

#### Child dies as utility pole falls on him POST NEWS NETWORK

Begunia, August 24: A four-yearold boy died reportedly after a utility pole fell on him here Tuesday. Sources said that the mishap occurred when the victim, Sai Ranjan, son of Manoranjan Behera of Kendupalli in Kantabada panchayat under Begunia police limits here, was playing near his home in the afternoon.

"A utility pole, though without overhead wires, fell on Sai, leaving the minor critically wounded. Neighbours rushed a profusely bleeding Sai to the district headquarters hospital in Khurda where he was declared 'dead on arrival'," said one of his neighbours. Villagers have blamed the electricity authorities for the mishap and urged the state government for facilitating monetary compensation for the victim.

## Odia labourers murdered in AP prawn farm: Cong

Bhubaneswar, August 24: The Congress party Tuesday alleged that six Odia migrants, who were found dead in a prawn farm at Guntur in Andhra Pradesh (AP) July 30, had been murdered and attempts were made to portray the incident as an accident.

Addressing a presser here, Congress leader Pradeep Majhi criticised the state government and shared the findings of a committee of the party that had visited the spot recently.

Majhi produced several photographs of the site and alleged that the migrant labourers had been murdered in the prawn farm. He sought a proper investigation into the incident by the Odisha government.

"The owner of the farm who had employed child labourers is

yet to be booked by police. We failed to understand what kind of investigation has been carried out in this regard. ## **SUSPICIOUS DEATH OF UTP** Family moves OHRC alleging custodial torture

Bhubaneswar, August 24: A Dalit couple Tuesday lodged a petition before Odisha Human rights Commission (OHRC) accusing prison officials of Jajpur sub-jail of torturing their only son to death while he was an under trial prisoner (UTP). The OHRC has registered a case (2051/21) in this regard.

The complainant, Laxmidhar Patra, is a resident of Pataranga under Korei police limits in Jajpur and is a daily wager. According to the plea, Patra's son Sumanta, 20, allegedly eloped with a minor girl from a nearby village in December 2020. The couple was later traced and brought back by



the family members. Meanwhile, Korei police, having filed a case based on the complaint lodged by the girl's family, arrested Sumanta from his house during the wee hours March 22, 2021. Sumanta was later sent to judicial custody leged that the jail officials had neither informed him about the illness of his son nor about his admission in the hospital.

He alleged that some staffers of the sub-jail had physically assaulted and mentally harassed his son while in custody. Korei police also did not listen to Patra who along with villagers had gone there to file a complaint against the erring staffers.

Patra has urged the commission to direct the competent authorities to initiate an impartial enquiry into the matter. He demanded stringent action against the officials of sub jail. He also demanded compensation of Rs 10 lakh as the deceased was the sole bread earner for the family.



Drought staring at Bolangir dist

FARMERS HAVE LOST HOPES OF CROPS IN AS MANY AS 14 BLOCKS. AS THE DISTRICT HAS RECEIVED **78 PER CENT LESS RAINFALL TILL AUGUST 22. ACCORDING TO AGRICULTURE DEPARTMENT**

Bolangir, August 24: Most areas of this district are reeling under a drought-like situation owing to very scant rainfall in June, July and August. Till August 22, the district has received 78 per cent less rain than normal and the situation may worsen if immediate steps are not taken to check the water scarcity problem.

According to reports, 29.1 per cent rainfall was recorded in the district in June while it was only 22.2 per cent of the normal in July.

Following an assessment of the situation, the Agriculture department said that the district has received 78 per cent less rainfall than the normal affecting paddy farming severely. Farmers have abandoned all hopes for a good paddy harvest this Kharif season.

Thousands of hectares of farmlands have cracked open due to aridity while paddy saplings meant for transplantation have wilted. Post seeding-sowing activities have remained a non-starter.

Such a sorry state of affairs in the farm sector was visible in 14 blocks



of the district, reports said. Farmers of Bidighat under Sadar block said that drought has already made its footfall in most areas.

Describing the situation, Bishnu Bisi, a farmer from Janakpur, said, "For want of rainfall, paddy transplantation could not be done this year. Saplings have started wilting and turned yellow. Seventy

days have passed since seeds were sown. There is no chance of the survival of saplings even it rains now. Paddy farming has been badly affected this year."

Shibankar Dharua, a farmer from Janakpur, said, "I have raised saplings in 12 acres for transplantation. However, transplantation could not be carried out in farmlands

For want of rainfall, paddy transplantation could not be done this year. Saplings have started wilting. Seventy days have passed since seeds were sown. There is no chance of survival of the saplings even if it rains now, says a farmer

owing to severe aridity.'

There is no water in the dams and canals while no alternative exists in the area to channelise water to the farmlands, he added.

District Agriculture Officer Baikuntha Charan Sahu said that Bolangir has received deficient rain. "The government is now planning for alternative crops to save the farmers. But in upland areas, there is no alternative crop. Cash crops like cotton can only be grown in certain lands. Even deciding on the choice of land will be a problem."

# No Af In Cornwall

anadian Prime Minister Justin Trudeau's remark that the Taliban are terrorists and that he would discuss with his G-7 partners in a meeting August 24 the possibility of imposing tougher sanctions on Afghanistan may sound to be an extreme reaction to the humanitarian crisis overtaking that country. But, the situation is turning messier by the hour with US President Joe Biden hinting at not extending the deadline of withdrawal of all US troops by August 31. The exodus of Afghans to other countries and the tales of horror they are telling the world make the Taliban's narrative unacceptable. Taliban's claim that they have changed and there won't be any repetition of the ruthless repression and denial of rights to women as seen during their regime 20 years back is now highly suspect.

G-7 leaders of Canada, Britain, France, Germany, Italy, Japan, and the United States are scheduled to meet virtually and discuss the situation in Afghanistan.

The British government has stopped short of taking a strong position as suggested by Trudeau, but it has made it clear the behaviour of the Taliban will decide the relief on existing sanctions.

Britain's Prime Minister Boris Johnson, who will chair the virtual meeting, has promised "to use every humanitarian and diplomatic lever" to protect human rights in Afghanistan. The G-7 meeting is expected to draw up a plan for a unified approach to the Afghanistan crisis exacerbated by the mad rush of thousands of Afghans towards the airport in Kabul to flee the country fearing reprisals by the Taliban for having worked with the USA and its allies during the war on terror over the past two decades. The leaders of the G-7 countries are expected to reaffirm their commitment to preserving the gains made in Afghanistan over the last 20 years, including girls' education and the rights of women and minorities.

This G-7 meet will be high in contrast to the last one held at Cornwall in June earlier this year. Joe Biden, upbeat after his election win, along with other leaders, only talked about overcoming the pandemic and reviving their economies. No one mentioned or even publicly remembered the longest war ever of the US and its NATO allies that was being fought at that very moment by them in Afghanistan. Little did the world suspect at that time that barely two months later those same leaders would take a step that would put a huge question mark on the relevance of those successful economies in the 21st century. While there is no doubt that the prestige of the US and its strong allies has taken a massive beating with the manner in which the terrible withdrawal of western forces has taken place from Afghanistan yet there is truth in what Joe Biden has said about the two decades old war. The American President has stated that unless the people of Afghanistan want to fight for their own security and freedom, no one else can deliver these to them forever.

Now, it is only India which will have to suffer for its lack of far sighted foreign policies. India just sat in the US bandwagon and expected to reap rich dividends without thinking and planning for the future. It completely relied on the Americans to deliver all that was required to be present in Afghani soil, never even dreaming that the situation could change so very dramatically. Pakistan, on the other hand, had always kept a strong link with the Taliban and encouraged certain bad elements amongst them for maintaining a strong grip on the extremists. The promotion of the Haqqani Network by the Pakistani intelligence agencies is one such notable example. India, on the other hand, has invested billions of dollars in almost all provinces but is now simply cut out and thrown aside. It cannot reenter Afghanistan unless the Pakistani establishment so desires, which seems extremely unlikely. China has played a smart game of piggy back riding on Pakistan to safeguard its western Moslem dominated provinces from being disturbed by Taliban extremism. It has also ensured its total grip on all the precious mines that Afghanistan has to offer. Notable amongst them is lithium apart from incredible deposits of gold, coal and other extremely valuable minerals.

After being jolted out of its slumber, the Indian government has called an all-party meet recently to assess the Afghan situation. Now the effort is to take everyone on board so that when the fallout commences, it would not be just the BJP-led government that will be held responsible. Rather every political party will be roped in together under the call of national unity in the hour of external threat. This glaringly demonstrates how, if internal political opportunism and biases are not kept aside while dealing with external policies and threats, greater national interest is hampered.

# WHY NATION-BUILDING FAILED

The United States invaded Afghanistan 20 years ago with the hope of rebuilding a country that had become a scourge to the world and its own people. As General Stanley McChrystal explained in the run-up to the 2009 surge of US troops, the objective was that the "government of Afghanistan sufficiently control its territory to support regional stability and prevent its use for international terrorism."

Now, with more than 100,000 lives lost and some \$2 trillion spent, all America has to show for its effort are this month's scenes of a desperate scramble out of the country – a humiliating collapse reminiscent of the fall of Saigon in 1975. What went wrong? Pretty much everything, but

Pretty much everything, but not in the way that most people think. While poor planning and a lack of accurate intelligence certainly contributed to the disaster, the problem has in fact been 20 years in the making.

The US understood early on that the only way to create a stable country with some semblance of law and order was to establish robust state institutions. Encouraged by many experts and now-defunct theories, the US military framed this challenge as an engineering problem: Afghanistan lacked state institutions, a functioning security force, courts, and knowledgeable bureaucrats, so the solution was to pour in resources and transfer expertise from foreigners. NGOs and the broader Western foreign-aid complex were there to help in their own way (whether the locals wanted them to or not). And because their work required some degree of stability, foreign soldiers – mainly NATO forces, but also private contractors - were deployed to maintain security.

In viewing nation-building as a top-down, 'state-first' process, US policymakers were following a venerable tradition in political science. The assumption is that if you can establish overwhelming military dominance over a territory and subdue all other sources of power, you can then impose your will. Yet in most places, this theory is only half right, at best; and in Afghanistan, it was dead wrong.

Of course, Afghanistan needed a functioning state. But the presumption that one could be imposed from above by foreign forces was misplaced. As James Robinson



Although the United States clearly could have done a better job of managing its departure from Afghanistan, the tragedy playing out this month has been 20 years in the making. From the outset, America and its allies embraced – and never reconsidered – a top-down state-building strategy that was always destined to fail

and I argue in our 2019 book, The Narrow Corridor, this approach makes no sense when your starting point is a deeply heterogeneous society organised around local customs and norms, where state institutions have long been absent or impaired.

True, the top-down approach to state-building has worked in some cases (such as the Qin dynasty in China or the Ottoman Empire). But most states have been constructed not by force but by compromise and cooperation. The successful centralisation of power under state institutions more commonly involves the assent and cooperation of the people subject to it. In this model, the state is not imposed on a society against its wishes; rather, state institutions build legitimacy by securing a modicum of popular support.

This does not mean that the US should have worked with the Taliban. But it does mean that it should have worked more closely with different local groups, rather than pouring resources into the corrupt, non-representative regime of Afghanistan's first post-Taliban president, Hamid Karzai (and his brothers). Ashraf Ghani, the USbacked Afghan president who fled to the United Arab Emirates this week, co-authored a book in 2009 documenting how this strategy had fueled corruption and failed to achieve its stated purpose. Once in power, however, Ghani continued down the same road.

The situation that the US confronted in Afghanistan was even worse than is typical for aspiring nation builders. From the very beginning, the Afghan population perceived the US presence as a foreign operation intended to weaken their society. That was not a bargain they wanted.

What happens when top-down state-building efforts are proceeding against a society's wishes? In many places, the only attractive option is to withdraw. Sometimes, this takes the form of a physical exodus, as James C. Scott shows in The Art of Not Being Governed. his study of the Zomia people in Southeast Asia. Or it could mean co-habitation without cooperation, as in the case of Scots in Britain or Catalans in Spain. But in a fiercely independent, well armed society with a long tradition of blood feuds and a recent history of civil war, the more likely response is violent conflict.

Perhaps things could have turned out differently if Pakistan's Inter-Services Intelligence agency had not supported the Taliban when it was militarily defeated, if NATO drone attacks had not further alienated the population, and if US-backed Afghan elites had not been extravagantly corrupt. But the cards were stacked against America's state-first strategy.

And the fact is, US leaders should have known better. As Melissa

Dell and Pablo Querubín document, America adopted a similar top-down strategy in Vietnam, and it backfired spectacularly. Places that were bombed to subdue the Viet Cong became even more supportive of the anti-American insurgency.

Even more telling is the US military's own recent experience in Iraq. As research by Eli Berman, Jacob Shapiro, and Joseph Felter shows, the 'surge' there worked much better when Americans tried to win hearts and minds by cultivating the support of local groups. Similarly, my own work with Ali Cheema, Asim Khwaja, and James Robinson finds that in rural Pakistan, people turn to non-state actors precisely when they think state institutions are ineffective and foreign to them.

None of this means that the withdrawal could not have been managed better. But after 20 years of misguided efforts, the US was destined to fail in its twin objectives of withdrawing from Afghanistan and leaving behind a stable, lawbased society.

The result is an immense human tragedy. Even if the Taliban do not revert to their worst practices, Afghan men and especially women will pay a high price for America's failures in the years and decades ahead.

#### Palimpsest

When writing materials like parchment were scarce and expensive, you didn't throw them out because they had been used. Instead, you washed them with a dilute alkaline solution to weaken the hold of the ink on the paper, rubbed them down with pumice stone to clean them, and used them again (medieval monkish writing rooms sometimes had people who specialised in doing this). The result was a palimsest. This meaning is explicit in the original Greek word palimpsestos, which is a compound of palin, "again" and psestos, "rubbed smooth". Often the erasing wasn't altogether successful and the original writing showed through. This is why the word also has the meaning of something that has been changed but which still shows traces of its earlier form, perhaps a building which has been altered but whose original structure is still recognisable. In modern times, historically important documents have been recovered from the half-obliterated writing in palimpsests. David Carvalho wrote in Forty Centuries of Ink: "Manuscripts of the Gospels, of the Iliad, and of works of the highest merit, often of great beauty and accuracy. are dimly seen underneath stupid sermons, and theological writings of a nature so paltry that no man living cares to read them." A palimpsest was found in Constantinople in 1906, which contained underneath a collection of prayers the complete Greek text of several of Archimedes' most famous mathematical writings, one of them previously believed lost.

Ride a bicycle & help the environment

Mike to drive. Her car remains parked on our driveway 99 per cent of the time. Malathi drives it only on weekends, usually to go shopping and to ensure that snakes and other creatures do not start living inside the engine compartment.

Malathi has two preferred modes of transportation: cycling and walking. Only if she's unable to use one of these modes does she resort to a third mode: Huber.

Huber is what you get when you combine husband and Uber.

Yes, if Malathi is unable to bike or walk, she usually gets me to drive her. Did I mention that her car sits idle 99 per cent of the time? Our house, thankfully, isn't far from the university where Malathi works. It's one of the main reasons we bought the house. Malathi can pedal to work in just 12 minutes. It's mostly a downhill ride, but uphill when she returns home, so she praises gravity in the morning, By riding her bicycle, she gets a little exercise, fresh air and the ability to ride on pavements, often passing motorists stuck at traffic lights. She also saves money on petrol and does her small part in reducing air pollution and helping the environment. She doesn't have to worry about parking there is plenty of space on the bike rack outside her building, and no risk of anyone accidentally backing up into her bike.

Many people around the world ride bicycles out of necessity they can't afford to buy cars, motorbikes or scooters. But even in wealthy countries, bicycles are increasingly popular, not just for recreation but also transportation. In Denmark, for example, more than 90 per cent of the people own bikes, compared with about 60 per cent who own cars. The country has promoted biking by building a vast network of bike lanes and bike highways, and by imposing heavy

taxes on petrol and automobiles. Heading home from the office at rush hour, you might find yourself stuck behind dozens of bicycles. You'll feel like you're in the Tour de France, but with no steroids.

Most people do not live close enough to their workplaces to use bicycles. But short errands within their neighbourhoods can easily be done on pedal power. More towns and cities need to create bike lanes to encourage people to ride bicycles and to keep them safer. Too many cyclists, unfortunately, have been struck by cars while riding on the side of busy roads.

Many accidents are also caused by cyclists who don't take enough precautions, whether it's riding too fast, forgetting to apply the brakes, or failing to wear helmets. I always wear a helmet these days, partly because I've fallen off bikes many times. The worst fall occurred in my college days. I fractured a bone in my right hand, but the sympathy I received while wearing a plaster cast almost made it worth it. That's what's great about being young – nobody faults you for being reckless. But if you hurt yourself when you're older, your wife will shake her head and say, "What an idiot you are."

My most recent fall occurred a few years ago, when I was riding a little too fast as I approached an intersection. My rear brakes weren't working well, so I squeezed my front brakes, which caused the bike to throw me off like an angry horse. I injured one of my fingers and scraped my knee. It took me more than a month to recover from the fall. To this day, my finger still hurts and the word 'idiot' still rings in my ears.

Despite my falls, I'm a big fan of the bicycle. It's one of the greatest inventions in history. Not only does it give us cheap transportation, it also gives us enjoyment and exercise – all without polluting the earth.

#### Too late, too little

Sir, This is in reference to "Petrol, diesel rates cut by 20 paise each," Orissa POST, August 23. The reduction in fuel prices came as international oil prices have tumbled. The cut in petrol price came after 36 days of no change. The freeze in prices coincided with the Parliament session, where the Opposition parties tried to corner the Centre on various issues including the hike in fuel prices. International oil rates have fallen to \$66 a barrel from \$75 per barrel they touched last month. According to experts, every \$1 change in crude normally affects retail price of petrol and diesel roughly by 45-50 paise a litre if there's no major change in rupeedollar exchange rate. Indian oil companies take the trailing 15-day average of international rates to determine the prices. So, the retail price of petrol and diesel should have started falling this week and should have come down by Rs 1.5 to Rs 2 a litre. But that's not how it works in India. The average price of Indian basket of crude went up by around \$6.5 a barrel between May and July. So, fuel prices in India should have increased by about Rs 3.50 per litre during the period. #### Stipulated Conditions: Part 'A' : Specific Conditions of Clearance:

- This Environmental Clearance is granted with a Condition that "the Mining activity shall be restricted to 10.594 Ha (diverted land) for which forest clearance has been obtained. Mining activity over the rest of the lease area shall be taken only after obtaining forest clearance for the same.
- iii) Additional air quality monitoring station shall be installed at entry and exit of mines and haulage road, buffer zone and schools and habitations.
   The mine shall implement the Pollution Control Measures and safeguards as proposed in the Environment Management Plan (EMP) of
- Environment Impact Assessment (EIA) report. iv) The proponent shall install STP of adequate capacity for treatment of domestic waste water and treated water shall be reused
- v) The proponent shall obtain permission from appropriate authority including WR Deptt., Govt. of Odisha for drawl of ground water.
- vi) Adequate mitigation measures shall be taken for dust suppression, environment protection in catchment area.
- vii) The proponent shall carry out periodical health check-up of employees due to Occupational Health Hazards by occupational health expert, at least once in six months, both for employees as well as people of neighbouring habitation.
- viii) The transportation of mineral shall be carried out through the covered trucks. Vehicular emissions shall be kept under control and regularly monitored. The vehicles carrying the mineral shall not be overloaded.
- ix) Mineral handling area shall be provided with adequate number of high efficiency dust extraction system. Loading and unloading areas including all the transfer points should also have efficient dust control arrangements. These should be properly maintained and operated.
- x) Garland drains with appropriate size, gradient and length shall be constructed to arrest silt and sediment flows from ore dumps and directly into the water bodies. The water so collected shall be utilized for watering the roads, green belt development etc. The drains shall be regularly desilted particularly after monsoon and maintained properly.
- xi) Public Hearing for the project was conducted on 26th August 2011. The proponent shall comply with all the commitments made to the issues raised by the Public during the public hearing.
- xii) The proponent shall comply to the NEERI recommendations.
- xiii) The mining lease holders shall, after ceasing mining operations, undertake re-grassing the mining area and any other area which may have been disturbed due to their mining activities and restore the land to a condition which is fit for growth of fodder, flora, fauna etc.

#### Part 'B' : Standard Conditions:

(I) Statutory compliance:

- (i) This Environmental Clearance (EC) is subject to orders/judgment of Hon'ble Supreme Court of India, Hon'ble High Court, Hon'ble NGT and any other Court of Law, Common Cause Conditions as may be applicable.
- (ii) The Project proponent complies with all the statutory requirements and judgment of Hon'ble Supreme Court dated 2nd August, 2017 in Writ Petition (Civil) No. 114 of 2014 in matter of Common Cause versus Union of India & Ors before commencing the mining operations.
- (iii) The State Government concerned shall ensure that mining operation shall not be commenced till the entire compensation levied, if any, for illegal mining paid by the Project Proponent through their respective Department of Mining & Geology in strict compliance of Judgment of Hon'ble Supreme Court dated 2nd August, 2017 in Writ Petition (Civil) No. 114 of 2014 in matter of Common Cause versus Union of India & Ors.
- (iv) This Environmental Clearance shall become operational only after receiving formal NBWL Clearance from MoEF & CC subsequent to the recommendations of the Standing Committee of National Board for Wildlife, if applicable to the Project.
- (v) This Environmental Clearance shall become operational only after receiving formal Forest Clearance (FC) under the provision of Forest Conservation Act, 1980 and subsequent amendments thereto, as applicable for the project.
- (vi) Project Proponent (PP) shall obtain Consent to Operate after grant of EC and effectively implement all the conditions stipulated therein. The mining activity shall not commence prior to obtaining Consent to Establish/Consent to operate from the concerned State Pollution Control Board.
- (vii) The PP shall adhere to the provision of the Mines Act, 1952, Mines and Mineral (Development & Regulation), Act, 2015 and rules & regulations made there under. PP shall adhere to various circulars issued by Directorate General Mines Safety (DGMS) and Indian Bureau of Mines from time to time.
- (viii) The Project Proponent shall obtain consents from all the concerned land owners, before start of mining operations, as per the provisions of MMDR Act, 1957 and rules made there under in respect of lands which are not owned by it.
- (ix) The Project Proponent shall follow the mitigation measures provided in MoEF & CC's Office Memorandum No. Z-I1013/57/2014-IA.II (M), dated 29th October, 2014, titled "Impact of mining activities on Habitations-Issues related to the mining Projects wherein Habitations and villages are the part of mine lease areas or Habitations and villages are surrounded by the mine lease area".
- (x) The Project Proponent shall obtain necessary prior permission of the competent authorities for drawl of requisite quantity of surface water and from CGWA for withdrawal of groundwater for the project.
- (xi) A copy of EC letter will be marked to concerned Panchayat/local NGO etc. if any, from whom suggestion/representation has been received while processing the proposal.
- (xii) State Pollution Control Board shall be responsible for display of this EC letter at its Regional Office, District Industries Centre and Collector's office/Tehsildar's Office for 30 days.
- (xiii) The Project Authorities should widely advertise about the grant of this EC letter by printing the same m at least two local newspapers, one of which shall be in vernacular language of the concerned area. The advertisement shall be done within 7 days of the issue of the clearance letter mentioning that the instant project has been accorded EC and copy of the EC letter is available with the State Pollution Control Board and website of the Ministry of Environment, Forest and Climate Change (www.environmentclearance.nic.in). A copy of the advertisement may be forwarded to the concerned MoEF & CC Regional Office for compliance and record.
- (xiv) The Project Proponent shall inform the MoEF & CC/SEIAA, Odisha for any change in ownership of the mining lease. In case there is any change in ownership or mining lease is transferred than mining operation shall only be carried out after transfer of EC as per provisions of the para 11 of EIA Notification, 2006 as amended from time to time.
- II) Air quality monitoring and preservation:
- (i) The Project Proponent shall install a minimum of 3 (three) online Ambient Air Quality Monitoring Stations with 1 (One) in upwind and 2 (Two) in downwind direction based on long term climatological data about wind direction such that an angle of 120° is made between the monitoring locations to monitor critical parameters, relevant for mining operations, of air pollution viz. PM<sub>10</sub>, PM<sub>2.5</sub>, NO<sub>2</sub>; CO and SO<sub>2</sub> etc. as per the methodology mentioned in NAAQS Notification No. B-29016/20/90/PCI/I, dated 18.11.2009 covering the aspects of transportation and use of heavy machinery in the impact zone. The ambient air quality shall also be monitored at prominent places like office building, canteen etc. as per the site condition to ascertain the exposure characteristics at specific places. The above data shall be digitally displayed within 03 months in front of the main Gate of the mine site.
- (ii) Effective safeguard measures for prevention of dust generation and subsequent suppression (like regular water sprinkling, metalled road construction etc.) shall be carried out in areas prone to air pollution wherein high levels of PM<sub>10</sub> and PM<sub>2.5</sub> are evident such as haul road, loading and unloading point and transfer points. The Fugitive dust emissions from an sources shall be regularly controlled by installation of required equipments/machineries and preventive maintenance. Use of suitable water-soluble chemical dust suppressing agents may be explored for better effectiveness of dust control system. It shall be ensured that air pollution level conform to the standards prescribed by the MoEF&CC/Central Pollution Control Board.

even if it is a part of approved mining plan modified after grant of EC or granted by State Govt. in the form to Short Term Permit (STP), Query license or any other name.

- (ii) The Project Proponent shall get the Final Mine Closure Plan along with Financial Assurance approved from Indian Bureau of Mines/ Department of Mining & Geology as required under the Provision of the MMDR Act, 1957 and Rules/ Guidelines made there under. A copy of approved final mine closure plan shall be submitted within 2 months of the approval of the same from the competent authority to the concerned Regional Office of the Ministry of Environment, Forest and Climate Change for record and verification.
- iiii) The land-use of the mine lease area at various stages of mining scheme as well as at the end-of-life shall be governed as per the approved Mining Plan. The excavation vis-a-vis backfilling in the mine lease area and corresponding afforestation to be raised in the reclaimed area shall be governed as per approved mining plan. PP shall ensure the monitoring and management of rehabilitated areas until the vegetation becomes self-sustaining. The compliance status shall be submitted half-yearly to the MoEF & CC and its concerned Regional Office / SEIAA, Odisha.

#### (VI) Land reclamation:

- (i) The Overburden (O.B.) generated during the mining operations shall be stacked at earmarked OB dump site(s) only and it should not be kept active for a long period of time. The physical parameters of the OB dumps like height, width and angle of slope shall be governed as per the approved Mining Plan as per the guidelines/circulars issued by D.G.M.S w.r.t. safety in mining operations shall be strictly adhered to maintain the stability of top soil/OB dumps. The topsoil shall be used for land reclamation and plantation.
- ii) The reject/waste generated during the mining operations shall be stacked at earmarked waste dump site(s) only. The physical parameters of the waste dumps like height, width and angle of slope shall be governed as per the approved Mining Plan as per the guidelines/circulars issued by DGMS w.r.t. safety in mining operations shall be strictly adhered to maintain the stability of waste dumps.
- (iii) The reclamation of waste dump sites shall be done in scientific manner as per the Approved Mining Plan cum Progressive Mine Closure Plan.
  (iv) The slope of dumps shall be vegetated in scientific manner with suitable native species to maintain the slope stability, prevent erosion and surface run off. The selection of local species regulates local climatic parameters and help in adaptation of plant species to the microclimate. The gullies formed on slopes should be adequately taken care of as it impacts the overall stability of dumps. The dump mass should be consolidated with the help of dozer/ compactors thereby ensuring proper filling/leveling of dump mass. In critical areas, use of geo textiles/ geo-membranes / clay liners / Bentonite etc. shall be undertaken for stabilization of the dump.
- (v) The Project Proponent shall carry out slope stability study in case the dump height is more than 30 meters. The slope stability report shall be submitted to concerned regional office of MoEF & CC, Govt. of India, Bhubaneswar as well as SEIAA, Odisha.
- (vi) Catch drains, settling tanks and siltation ponds of appropriate size shall be constructed around the mine working, mineral yards and topsoil / OB / waste dumps to prevent runoff of water and flow of sediments directly into the water bodies (Nallah/River/ Pond etc.). The collected water should be utilized for watering the mine area, roads, green belt development, plantation etc. The drains/ sedimentation sumps etc. shall be de-silted regularly, particularly after monsoon season, and maintained properly.
- (vii) Check dams of appropriate size, gradient and length shall be constructed around mine pit and OB dumps to prevent storm run-off and sediment flow into adjoining water bodies. A safety margin of 50% shall be kept for designing of sump structures over and above peak rainfall (based on 50 years data) and maximum discharge in the mine and its adjoining area which shall also help in providing adequate retention time period thereby allowing proper settling of sediments/ silt material. The sedimentation pits/ sumps shall be constructed at the comers of the garland drains.
- (viii) The top soil, if any, shall temporarily be stored at earmarked site(s) within the mine lease only and should not be kept unutilized for long. The physical parameters of the top soil dumps like height, width and angle of slope shall be governed as per the approved Mining Plan and as per the guidelines framed by DGMS w.r.t. safety in mining operations shall be strictly adhered to maintain the stability of dumps. The topsoil shall be used for land reclamation and plantation purpose.
- (ix) The mining lease holders shall, after ceasing mining operations, undertake re-grassing the mining area and any other area which may have been disturbed due to their mining activities and restore the land to a condition which is fit for growth of fodder, flora, fauna etc.

#### (VII) Transportation:

- (i) No Transportation of the minerals shall be allowed in case of roads passing through transportation of the minerals leaving an adequate gap (say at least 200 meters) so that the adverse impact of sound and dust along with chances of accidents could be mitigated. All costs resulting from widening and strengthening of existing public road network shall be borne by the PP in consultation with nodal State Govt. Department. Transportation of minerals through road movement in case of existing village/rural roads shall be allowed in consultation with nodal State Govt. Department only after required strengthening such that the carrying capacity of roads is increased to handle the traffic load. The pollution due to transportation load on the environment will be effectively controlled and water sprinkling will also be done regularly. Vehicular emissions shall be kept under control and regularly monitored. Project should obtain Pollution Under Control (PUC) certificate for all the vehicles from authorized pollution testing centers.
- (ii) The Main haulage road within the mine lease should be provided with a permanent water arrangement for dust suppression. Other roads within the mine lease should be wetted regularly with tanker-mounted water sprinkling system. The other areas of dust generation like crushing zone, material transfer points, material yards etc. should invariably be provided with dust suppression arrangements. The air pollution control equipments like bag filters, vacuum suction hoods, dry fogging system etc. shall be installed at Crushers, belt-conveyors and other areas prone to air pollution. The belt conveyor should be fully covered to avoid generation of dust while transportation. PP shall take necessary measures to avoid generation of fugitive dust emissions.
- (iii) Traffic management shall be done as per recommendation of Traffic Management Study Report.
   (iv) The Project Proponent shall provide parking plaza for the heavy vehicles within the lease area as recommendation of NEERI.
- (VIII) Green Belt Development:
- (i) The Project Proponent shall develop greenbelt in 7.5m wide safety zone all along the mine lease boundary as per the guidelines of CPCB in order to arrest pollution emanating from mining operations within the lease. The whole Green belt shall be developed within first 5 years starting from windward side of the active mining area. The development of greenbelt shall be governed as per the EC granted by the Ministry irrespective of the stipulation made in approved mine plan.
- (ii) The Project Proponent shall carry out plantation/afforestation in backfilled and reclaimed area of mining lease, around water body, along the roadsides, in community areas etc. by planting the native species in consultation with the State Forest Department/ Agriculture Department/ Rural development department/ Tribal Welfare Department/Gram Panchayat such that only those species be selected which are of use to the local people. The CPCB guidelines in this respect shall also be adhered. The density of the trees should be around 2500 saplings per Hectare. Adequate budgetary provision shall be made for protection and care of trees.
- (iii) The Project Proponent shall make necessary alternative arrangements for livestock feed by developing grazing land with a view to compensate those areas which are coming within the mine lease. The development of such grazing land shall be done in consultation with the State Government. In this regard. Project Proponent should essentially implement the directions of the Hon'ble Supreme Court with regard to acquisition of grazing land. The sparse trees on such grazing ground, which provide mid-day shelter from the scorching sun, should be scrupulously guarded/ protected against felling and plantation of such trees should be promoted.
- (iv) The Project Proponent shall undertake all precautionary measures for conservation and protection of endangered flora and fauna and Schedule-I species during mining operation. A Wildlife Conservation Plan shall be prepared for the same clearly delineating action to be taken for conservation of flora and fauna. The Plan shall be approved by Chief Wild Life Warden of the State Govt. (v) And implemented in consultation with the State Forest and Wildlife Department. A copy of Wildlife Conservation Plan and its implementation status (annual) shall be submitted to the Regional Office of the Ministry.
- (IX) Public hearing and human health issues:
- (i) The Project Proponent shall appoint an Occupational Health Specialist for Regular as well as Periodical medical examination of the workers engaged in the mining activities, as per the DGMS guidelines. The records shall be maintained properly. PP shall also carry out Occupational health check-ups in respect of workers which are having ailments like BP, diabetes, habitual smoking, etc. The check-ups shall be undertaken once in six months and necessary remedial/ preventive measures be taken. A status report on the same may be sent to MoEF&CC Regional Office and DGMS on half-yearly basis.
- ii) A commitment in form of an undertaking for periodical occupational health checkup of the employee and the local people shall be done through an occupational health expert as per the detailed action plan submitted with the proposal within 6 months from the date of issue of Environmental Clearance.
- (iii) The Project Proponent must demonstrate commitment to work towards 'Zero Harm' from their mining activities and carry out Health Risk Assessment (HRA) for identification workplace hazards and assess their potential risks to health and determine appropriate control measures to protect the health and wellbeing of workers and nearby community. The proponent shall maintain accurate and systematic records of the HRA. The HRA for neighborhood has to focus on Public Health Problems like Malaria, Tuberculosis, HIV, Anaemia, Diarrhoea in children under five, respiratory infections due to bio mass cooking. The proponent shall also create awareness and educate the nearby community and workers for Sanitation, Personal Hygiene, Hand washing, not to defecate in open, Women Health and Hygiene (Providing Sanitary Napkins), hazard of tobacco and alcohol use. The Proponent shall carry out base line HRA for all the category of workers and thereafter every five years.
- The proponent shall carry out occupational health surveillance which be a part of HRA and include Biological Monitoring where practical and feasible, and the tests and investigations relevant to the exposure (e.g. for Dust a X-Ray Chest; For Noise Audiometric; for Lead Exposure Blood Lead, For Welders Full Ophthalmologic Assessment; for Manganese Miners a complete Neurological Assessment by a Certified Neurologist, and Manganese (Mn) estimation in Blood; For Inorganic Chromium-Fortnightly skin inspection of hands and forearms by a responsible person. Except routine tests all tests would be carried out in a Lab accredited by NABH. Records of Health Surveillance must be kept for 30 years, including the results of and the records of Physical examination and tests. The record of exposure due to materials like Asbestos, Hard Rock Mining, Silica, Gold, Kaolin, Aluminium, Iron, Manganese, Chromium, Lead, Uranium need to be handed over to the Mining Department of the State in case the life of the mine is less than 30 years. It would be obligatory for the State Mines Departments to make arrangements for the safe and secure storage of the records including X-Ray. Only conventional X-Ray will be accepted for record purposes and not the digital one). X-Ray must meet ILO criteria (17 × 14 inches and of good quality). The proponent shall maintained a record of performance indicators for workers which includes (a) there should not be a significant decline (v) in their Body Mass Index and it should stay between 18.5 -24.9, (b) the Final Chest X-Ray compared with the base line X-Ray should not show any capacities,(c) At the end of their leaving job there should be no Diminution in their Lung Functions Forced Expiratory Volume in one second (FEV1). Forced Vital Capacity (FVC), and the ratio) unless they are smokers which has to be adjusted, and the effect of age (d) their hearing should not be affected. As a proof an Audiogram (first and last need to be presented), (e) they should not have developed any Persistent Back Pain, Neck Pain, and the movement of their Hip, Knee and other joints should have normal range of movement, (f) they should not have suffered loss of any body part. The record of the same should be submitted to the Regional Office, MoEF&CC annually along with details of the relief and compensation paid to workers having above indications. The project proponent shall ensure that personnel working in dusty areas should wear protective respiratory devices and they should also be provided with adequate training and information on safety and health aspects. Project Proponent shall make provision for the housing for workers/labors or shall construct labor camps within/outside (company owned (vii) land) with necessary basic infrastructure/ facilities like fuel for cooking, mobile toilets , mobile STP, safe drinking water, medical health care, creche for kids etc. The housing may be provided in the form of temporary structures which can be removed after the completion of the project related infrastructure. The domestic waste water should be treated with STP in order to avoid contamination of underground water. #### (III) Water quality monitoring and preservation:

- (i) In case, immediate mining scheme envisages intersection of ground water table, then Environmental Clearance shall become operational only after receiving formal clearance from CGWA. In case, mining operation involves intersection of ground water table at a later stage, then PP shall ensure that prior approval from CGWA and MoEF&CC is in place before such mining operations. The permission for intersection of ground water table shall essentially be based on detailed hydro-geological study of the area.
- (ii) Regular monitoring of the flow rate of the springs and perennial nallahs flowing in and around the mine lease shall be carried out and records maintain. The natural water bodies and or streams which are flowing in an around the village, should not be disturbed. The Water Table should be nurtured so as not to go down below the premining period. In case of any water scarcity in the area, the Project Proponent has to provide water to the villagers for their use. A provision for regular monitoring of water table in open dug wall located in village should be incorporated to ascertain the impact of mining over ground water table. The Report on changes in Ground water level and quality shall be submitted on sixmonthly basis to the Regional Office of the Ministry, CGWA and State Groundwater Department/State Pollution Control Board.
- (iii) Project Proponent shall regularly monitor and maintain records w.r.t. ground water level and quality in and around the mine lease by establishing a network of existing wells as well as new piezo-meter installations during the mining operation in consultation with Central Ground Water Authority/State Ground Water Department. The Report on changes in Ground water level and quality shall be submitted on sixmonthly basis to the Regional Office of the Ministry, CGWA and State Groundwater Department/State Pollution Control Board.
- (iv) The Project Proponent shall undertake regular monitoring of natural water course/water resources/springs and perennial nallahs existing/ flowing in and around the mine lease and maintain its records. The project proponent shall undertake regular monitoring of water quality upstream and downstream of water bodies passing within and nearby/adjacent to the mine lease and maintain its records. Sufficient number of gullies shall be provided at appropriate places within the lease for management of water. PP shall carry out regular monitoring w.r.t. pH and included the same in monitoring plan. The parameters to be monitored shall include their water quality vis-a-vis suitability for usage as per CPCB criteria and flow rate. It shall be ensured that no obstruction and/or alteration be made to water bodies during mining operations without justification and prior approval of MoEF&CC/SEIAA, Odisha. The monitoring of water courses/bodies existing in lease area shall be carried out four times in a year viz. pre- monsoon (April-May), monsoon (August), post-monsoon (November) and winter (January) and the record of monitored data be sent regularly to Ministry of Environment, Forest and Climate Change and its Regional Office, SEIAA, Odisha, Central Ground Water Authority and Regional Director, Central Ground Water Board, State Pollution Control Board and Central Pollution Control Board. Clearly showing the trend analysis on six-monthly basis.
- (v) Quality of polluted water generated from mining operations which include Chemical Oxygen Demand (COD) in mines run-off; acid mine drainage and metal contamination in runoff shall be monitored along with Total Suspended Solids (TDS), Dissolved Oxygen (DO), pH and Total Suspended Solids (TSS). The monitored data shall be uploaded on the website of the company as well as displayed at the project site in public domain, on a display board, at a suitable location near the main gate of the Company. The circular No. J- 20012/1 /2006-IA.II (M) dated 27.05.2009 issued by Ministry of Environment, Forest and Climate Change may also be referred in this regard.
- (vi) The project proponent shall construct retaining wall and settling pond within the lease area. Further, check dams shall be constructed at strategic locations in which rain water passes in rainy season. Finally, the excess superannuated after sedimentation shall be allowed to spill away through stone pitch structure to the nearby valley.
- (vii) De-silting of agricultural lands in buffer zone and beyond including nearby Nalas/rivers perennially periodically and perpetually caused due to wash up of minerals/Ob/dumps shall be done as per SOP submitted. A legal affidavit shall be submitted within 6 months from the date of issue of Environmental Clearance to this effect with periodicity of de-silting.
- (viii) Detail design of the existing retaining wall and the proposed for the expansion from a chartered Civil Engineer shall be submitted within 6 months from the date of issue of Environmental Clearance to ensure that no silt after wash up is escaped from the core / buffer zone of the mines.
- (ix) Project Proponent shall plan, develop and implement rainwater harvesting measures on long term basis to augment ground water resources in the area in consultation with Central Ground Water Board/ State Groundwater Department. A report on amount of water recharged needs to be submitted to Regional Office, MoEF&CC annually.
- (x) Industrial waste water (Workshop and waste water from the mine) should be properly collected and treated in an ETP as proposed so as to conform to the notified standards prescribed from time to time. The standards shall be prescribed through Consent to Operate (CTO) issued by concerned State Pollution Control Board (SPCB). The workshop effluent shall be treated after its initial passage through Oil and grease trap.
- (xi) The water balance/water auditing shall be carried out and measure for reducing the consumption of water shall be taken up and reported to the Regional Office of the MoEF & CC and State Pollution Control Soard.

#### (IV) Noise and vibration monitoring and prevention:

- (i) The peak particle velocity at 500m distance or within the nearest habitation, whichever is closer shall be monitored periodically as per applicable DGMS guidelines.
- (ii) The illumination and sound at night at project sites disturb the villages in respect of both human and animal population. Consequent sleeping disorders and stress may affect the health in the villages located close to mining operations. Habitations have a right for darkness and minimal noise levels at night. PPs must ensure that the biological clock of the villages is not disturbed; by orienting the floodlights/ masks away from the villagers and keeping the noise levels well within the prescribed limits for day /night hours.
- (iii) The Project Proponent shall take measures for control of noise levels below 85 dBA in the work environment. The worker engaged in operations of HEMM, etc. should be provided with ear plugs /muffs. All personnel including laborers working in dusty areas shall be provided with protective respiratory devices along with adequate training, awareness and information on safety and health aspects. The PP shall be held responsible in case it has been found that workers/ personals/ laborers are working without personal protective equipment.

#### (V) Mining Plan:

(i) The Project Proponent shall adhere to the working parameters of mining plan which was submitted at the time of EC appraisal wherein year-wise plan was mentioned for total excavation i.e. quantum of mineral, waste, over burden, inter burden and top soil etc.. No change in basic mining proposal like mining technology, total excavation, mineral & waste production, lease area and scope of working (viz. method of mining, overburden & dump management, O.B & dump mining, mineral transportation mode, ultimate depth of mining etc.) shall not be carried out without prior approval of the Ministry of Environment, Forest and Climate Change, which entail adverse environmental impacts,

#### (X) Corporate Environment Responsibility (CER):

- (i) The activities and budget earmarked for Corporate Environmental Responsibility (CER) as per Ministry's O.M dated 30.09 .2020 or as proposed by SEAC should be kept in a separate bank account. The activities proposed for CER shall be implemented in a time bound manner and annual report of implementation of the same along with documentary proof viz. photographs, purchase documents, latitude & longitude of infrastructure developed & road constructed needs to be submitted to Regional Office MoEF&CC annually along with audited statement.
- (ii) Project Proponent shall keep the funds earmarked for environmental protection measures in a separate account and refrain from diverting the same for other purposes. The Year wise expenditure of such funds should be reported to the MoEF & CC and its concerned Regional Office / SEIAA, Odisha.

#### (XI) Miscellaneous:

- (i) The Project Proponent shall prepare digital map (land use & land cover) of the entire lease area once in five years purpose of monitoring land use pattern and submit a report to concerned Regional Office of the MoEF&CC.
- (ii) The Project Authorities should inform to the Regional Office regarding date of financial closures and final approval of the project by the concerned authorities and the date of start of land development work.
- iii) The project proponent shall establish a solar power plant with 30KVA capacity within the lease area as proposed.
- (iv) The Project Proponent shall submit six monthly compliance reports on the status of the implementation of the stipulated environmental safeguards to the MoEF&CC & its concerned Regional Office, SEIAA, Odisha, Central Pollution Control Board and State Pollution Control Board.
- (v) A separate 'Environmental Management Cell' with suitable qualified manpower should be set-up under the control of a Senior Executive . The Senior Executive shall directly report to Head of the Organization. Adequate number of qualified Environmental Scientists and Mining Engineers shall be appointed and submit a report to RO, MoEF&CC.
- (vi) The proponent shall comply all the specific conditions as recommended by CSIR-NEERI on carrying capacity study (as applicable) in time bound manner as proposed.
- (vii) The mining lease holders shall, after ceasing mining operations, undertake re-grassing the mining area and any other area which may have been disturbed due to their mining activities and restore the land to a condition which is fit for growth of fodder, flora, fauna etc.
- (viii) The project proponent shall augment infrastructure on drinking water, health care and education in nearby villages as per time bound action plan submitted.
- x) The project proponent shall obtain permission from DGMS under 106(2b) to carry out blasting operation within the lease area.
- (x) The concerned Regional Office of the MoEF&CC shall randomly monitor compliance of the stipulated conditions. The project authorities should extend full cooperation to the MoEF&CC officer(s) by furnishing the requisite data / information / monitoring reports.
- (xi) Any appeal against this Environmental Clearance shall lie with the National Green Tribunal, if preferred, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.

Chennai, August 24: The central agencies are on high alert after the arrest of Sri Lankan national Suresh Raj or Chinna Suresh and Soundararajan from Kochi and Chennai in the last week of July.

The National Investigating Agency (NIA) sleuths who are probing the seizure of five AK 47 rifles and ₹3000 crore worth of drugs from a Sri Lanka boat off the Kerala coast March 25, 2021, have found that the ar-rested were handled by a Pakistani national and that the two were involved in smuggling the drugs for garnering funds to the now-defunct Liberation Tigers of Tamil Eelam (LTTE). Suresh, according to NIA



sleuths is a Sri Lankan national and has been staying illegally in India for the past several years without any Visa or Passport. He has a PAN card, Aadhaar Card, Driving license, voter ID card, and Indian passport. The NIA revealed that he had got all these using forged

documents to prove his credentials.

According to Central intelligence agencies that are tracking the seizure and the arrest of the Sri Lankan nationals, the drugs, and weapons from Pakistan were headed towards Hambantota port in Sri Lanka and from there to other international destinations. Sources in the agencies told IANS that the drugs and weapons from Pakistan are being smuggled using networks in Tamil Nadu and Kerala for scouting funds to the operational activities of the now-defunct LTTE.

The arrested Suresh Raj and Soundararajan have told the investigating officers that the LTTE network is active in certain pockets of Tamil Nadu. After the arrest of the duo, the Q' branch of the Tamil Nadu police have conducted combing operations in several parts of the state and have taken into custody certain people. However, sources in the police said that no arrests have been recorded so far.

Besides stringent legal action against them, they also urged the Congress national leadership to direct Sidhu to immediately rein in his aides in the interest of the party as well as the country.

Nobody can or should be allowed to undermine these sacrifices and jeopardise the safety of our country and its people, they emphasised, citing, in particular, the grave implications such statements could

Chennai, August 24: With uncertainty continuing to loom over the sale and use of firecrackers during Diwali, the Indian fireworks industry production has come down drastically by 60 per cent at Sivakasi in Tamil Nadu, said industry officials.

Sivakasi in Virudhunagar district in Tamil Nadu accounts for nearly 90 per cent of the country's firecracker production, and has 1,070 firecracker units located in and around the city. About 300,000 workers are directly employed whereas another 500,000 workers are in the allied sectors.

The demand from North India has come down drastically as there is uncertainty about sales of fireworks during Diwali. Further the huge left over stock of last year with the wholesalers and retailers is also impacting the production this year. Rajendra Raja, Vice-President, Indian Fireworks Manufacturers



Association, told IANS. Dealers in seven states have leftover stocks. Hence the demand has come down. As per the market reports, people want to celebrate Diwali with firecrackers and dealers are willing to buy. But uncertainty on being allowed to burst the firecrackers and the fear of

Sivakasi in Virudhunagar district in Tamil Nadu accounts for nearly 90 per cent of the country's firecracker production compared to their old products.

Even though the bulk of the industry's production is consumed during Diwali, seasonal demand during Holi, Raakhi, Patang festivals which used to be there has gone down this time around, industry officials told IANS.

The NCR, Punjab, Rajasthan and other North Indian areas are major markets for firecrackers accounting for not less than 40 per cent of the industry's sales.

Normally after Diwali, the wedding season would kick in where novelty items would be sold. Then sales of firecrackers during New Year, mainly hotels being the buyers and Holi will happen.

Fireworks units have not only scaled down their production but also stopped making some items. The units are not making all the products they used to make, Raja added.

While sales have gone down, the prices of raw materials have gone up by about 30 per cent, he added. The lack of demand woes of the

Nowhere around the world has any country banned fireworks during Covid situation during their festival celebrations, industry officials said.

According to Raja, sales in Tamil Nadu normally pick up around this time, but it has not happened.

Though it may not be a `boom' Diwali this year, industry officials are hopeful that it would not be a doom Diwali.

## FARMERS END STIR AS CM **HIKES SUGARCANE PRICES**

Chandigarh, August 24: Punjab's sugarcane farmers Tuesday withdrew their agitation in response to Chief Minister Amarinder Singh's announcement of a ₹35 per quintal hike in the state agreed price (SAP) for cane crushing season 2021-22, taking the price to ₹360 per quintal, ₹2 higher than in neighbouring Haryana.

The matter was resolved during a meeting of farmers union leaders with the Chief Minister here, during which Amarinder Singh, while agreeing to the SAP hike, said the state's fiscal situation had prevented adequate increase in the SAP for the past three-four years. The farmers union leaders had

earlier pointed out that Punjab had failed to hike sugarcane SAP in proportion to Haryana over this period, causing fiscal losses to them. The Chief Minister said the farmers were not to blame for the problem, which was caused by Punjab's poor finances. While he was always with the farmers and wanted to do his best for their welfare, the state's fiscal crisis had prevented him for increasing SAP earlier, he said, adding balancing the needs of the farmers with those of the cooperative and private sugar mill owners was tough, given the prevailing fiscal situation.

The farmers' union leaders, rep resenting the Sanjha Kisan Morcha which has been spearheading the sugarcane farmers' agitation for the past several days, thanked the Chief Minister for addressing their problem and announcing the SAP hike. They also expressed their ap-

preciation for the ₹5 lakh compensation and jobs to one family member each of the Punjab farmers who have lost their lives in theongoing protest against the farm Laws at the Delhi border.

The Covid-19 vaccine of Indian pharmaceutical firm Gennova Biopharmaceuticals, the first homegrown mRNA-based shot, was found to be safe and effective in an early-stage study, the government said. Government authorities have also approved further studies to test the vaccine's efficacy in a larger population. Gennova plans to conduct a mid-stage study at about 10 to 15 sites and a late-stage trial at 22 to 27 sites in India. The company's vaccine development, partly funded by the government, will utilise the clinical trial network under the biotechnology department of the ministry of science and technology. # 121 cases pending against MPs/MLAs in CBI courts, SC told

#### INDO-ASIAN NEWS SERVICE

New Delhi, August 24: The Supreme Court has been informed that a total of 121 cases are pending trial against sitting and former MPs/MLAs in special CBI courts across the country, and as many as 58 of them are punishable with life imprisonment. However, in over a third of the cases, the trial is moving at snail's pace - charges have not been framed, though offences were committed several years back.

Senior advocate Vijay Hansaria, appointed amicus curiae in a 2016 petition filed by advocate Ashwini Kumar Upadhyay seeking direction to fast-tracking of criminal trials against sitting and former MPs/MLAs, has filed the report in the top court. He has been assisted by advocate Sneha Kalita in the matter.

Earlier, it was reported that that there were a total of 151 cases, but that was caused by a typo in the report, which was subsequently corrected. The fourteenth report, in the matter, said: "It may be noted that out of 121 cases pending trial before the Special Courts, CBI, as many as 58 cases are punishable with life imprisonment. In 45 cases, even the charges have not been framed, though the offences alleged to have been committed several years back.'

The CBI has furnished a status report dated August 19, to the amicus mentioning the details of the cases pending trial before different CBI courts and those under investigation. The CBI cases pending investigation against MPs/MLAs are 37. The oldest pending case is in Patna, where the accused was charge-sheeted June 12, 2000. The report highlighted inordinate delay in several cases pending trial before CBI courts in different parts of the country.



As per details of the cases pending trial before different CBI courts. total number of MPs involved is 56, of which sitting MPs are 14, former MPs are 37, and expired MPs are five. Total number of MLAs involved in 121, including 34 sitting, 78 former 78, and nine expired. According to the Enforcement Directorate's status report, a total number of 51 Members of Parliament. both sitting and former, are accused in cases arising out of offences under Prevention of Money Laundering Act, 2002. However, the report does not show as to how many MPs/MLAs are sitting and/or former legislators.

The report suggested that courts before whom the trials are pending may be directed to expedite the trial of all pending cases on day-today basis in terms of Section 309 of the CrPC.

"All the High Courts may be directed to issue administrative instructions to the effect that the concerned courts dealing with cases investigated by the CBI and the Enforcement Directorate shall deal with the cases pending before MPs/MLAs on priority basis and other cases shall be dealt only after the trial in these cases are over," said the report.

The report further suggested that cases where investigations are pending before the ED and the CBI, a monitoring committee may be constituted comprising of the following: former judge of the top court or the former Chief Justice of a high court, the Director, ED (or his nominee not below the rank of Additional Director), the Director, CBI (or his nominee not below the rank of Additional Director), the Union Home Secretary (or his nominee not below the rank of Joint Secretary), and a judicial officer not below

**Compulsory 14-day** guarantine for **Afghan evacuees**

New Delhi, August 24: The Union health ministry has issued a memorandum mandating compulsory minimum 14 days institutional guarantine for those being evacuated from Afghanistan, at the ITBP Chhawla Camp here, amid Covid-19 pandemic outbreak.

The ministry said the Centre is undertaking emergency evacuation of people from Afghanistan to India and considering the nature of crisis, it has already allowed exemption from mandatory pre-boarding RT-PCTR testing (presently mandated for international travellers) for people who have been evacuated from the war-torn country.

"Coronavirus transmission (including circulation of variants) in Afghanistan is unclear at present, as a matter of abundant precaution, it has been decided that the arriving persons shall undergo a mandatory minimum 14 days institutional quarantine at Sector Headquarters Logistic and Communications, Indo Tibetan Border Police (ITBP), Chhawla Camp, Najafgarh Road, New Delhi," the office memorandum dated August 23 said.

The Ministry of External Affairs and the Ministry of Civil Aviation shall intimate ITBP adequately in advance about the exact date and timing of these incoming flights along with the passenger manifest. The said information may also be provided to the Government of NCT of Delhi," it said.

Meanwhile, India Tuesday brought back 78 people, including 25 of its nationals and a number of Afghan Sikhs and Hindus from Dushanbe, a day after they were evacuated from Taliban-besieged Kabul to the Tajik city.

New Delhi, August 24: Pakistan has raised objections to the design of India's Kiru hydroelectric plant, a mega 624 MW project over the Chenab in Jammu and Kashmir, but New Delhi asserts that the project is fully compliant with the Indus Water Treaty, officials said Tuesday.

Confirming this development, India's Indus Commissioner Pradeep Kumar Saxena told PTI that his Pakistani counterpart Syed Muhammad Meher Ali Shah raised the objections last week. Saxena, however, asserted that the design of the project is fully compliant with the provisions of the Indus Waters Treaty (IWT). It has been certified by the Central Water Commission, an apex organisation of the country in the field of water resources. This run-of-river project is being implemented by **Chenab Valley Power Projects** Limited, a joint venture of the

National Hydropower Company and Jammu and Kashmir State Power Development Corporation (JKSPDC).

"As a responsible upper riparian state, India is committed for full utilisation of its rights and believes in an amicable resolution the issues raised by Pakistan side in letter and spirit of the treaty.

"Pakistan's objections on this project may come up for discussions in the next meeting of the Permanent Indus Commission scheduled this year in Pakistan. In the forthcoming meeting, the Indian side will explain its position and hope that Pakistan will appreciate the same and its apprehensions will be addressed through discussions," Saxena said. The treaty provides Pakistan the right to raise objection on Indian design within three month of the receipt of the information. India has supplied the information on this project in June to Pakistan.

The apex court, which was hearing separate appeals of the Attorney General and the National Commission for Women(NCW), had January 27 stayed the high court order which acquitted a man under the Protection of Children from Sexual Offences (POCSO) Act saying "groping a minor's breast without 'skin to skin contact' cannot be termed as sexual as-

'Suppose, tomorrow a person, wearing surgical gloves, touches the entire body of minor, then he would not be punished for sexual assault as per this judgment. This is outrageous. Saying that skin-to-skin contact is required would mean a person, wearing gloves, getting an acquittal. The High Court did not see the far reaching consequences",

he said. "The judgement is outrageous and would set a dangerous precedent.'

Venugopal also referred to the definition of sexual assault under section 7 of the POCSO Act, and said this provides for a jail term of three years and is akin to the offence of outraging the modesty of a woman under section 354A of the IPC. He referred to the facts of the case as well and said the minor. who was stalked and groped by the accused, raised an alarm at the top of her voice and an FIR was lodged without any delay

#### Papua New Guinea bans India flights



## 'More disruption as transport, digital tech become one industry'

If autonomous electric vehicles can become practical, that will cause a huge change in the way people use vehicles, says battery pioneer Akira Yoshino

Tokyo, August 24: Akira Yoshino, a co-winner of the 2019 Nobel Prize in chemistry for his work on lithium-ion batteries, can take credit for the upheaval in both the automotive and technology industries.

Lithium-ion batteries have provided the first serious competition in a century to fossil fuels and combustion engines for transportation. Now an honorary fellow at Asahi Kasei, the Japanese chemical firm where he has worked for nearly 50 years, Yoshino sees more disruption ahead as transportation and digital tech-

ing lithium battery technology. Speaking to Reuters, Yoshino said: "There are two major areas of innovation that would be the key. One would be new cathode materials and anode materials. The second one would be the svstem where the EV is used. In other

words, how people will be using the EVs, and how they charge them and discharge them. If autonomous electric vehicles can become practical, that will

cause a huge change in the way people use vehicles, he added. On wireless charging of electric

vehicle batteries, he said: "The basic technology for wireless charging is not a problem. The problem is how to apply this in a prac-

tical system. There are two possibilities. One is cars that are

parked in a certain place where wireless charging is available. The

second one is while the car is moving. It's probably not going to be on every road, but on certain roads where this is available, that could be possible."

"If you think of autonomous electric vehicles, the vehicles will know when they need to charge and on their own just go to the charging station. That kind of situation can be practical sooner than you think.

On fuel cell vehicle batteries Yoshino said: "With the fuel cell vehicle, there are challenges on the technology and the costs, but you can overcome them. If you think about the longer term, 2030 to 2050, autonomous shared vehicles are going to come about. Hypothetically, an autonomous vehicle could be run by a gasoline engine, it could be electric, it could be a fuel cell. It doesn't matter what the power source is. But it needs to replenish its energy somehow. If the vehicle can't do that automatically without a human intervention, the system is kind of meaningless. The same thing would be true for gasoline or hydrogen.'

'In that sense, the electric ve- ২ hicle is the one that can replace its energy automatically. If you think of the Roomba vacuum cleaner, this goes around the room and it goes and recharges itself. If the Roomba needed a person to comeand fill up the tank, nobody would want to buy the Roomba."

Kohli's last international hundred came in November 2019 and though he has scored a couple of 40s in the series so far, the expectations have always been sky high from the modern great.

He looked a tad vulnerable around the off-stump in the first two Tests and one can expect him to present a tighter technique when the ball is pitched on the fourth stump at Headingley.

The form of Cheteshwar Pujara and Ajinkya Rahane had also been a cause of concern for India but that has been put to rest after the experienced duo batted for almost 50 overs on day four of the Lord's Test and were responsible for taking the game to the final day before the Indian pacers



# Bumrah wasn't trying to dismiss, feels Jimmy

LEEDS: Senior England pacer James Anderson has hinted that Jasprit Bumrah was not trying to get him out during the Lord's Test in which the Indian fast bowler rattled him with a barrage of bouncers.

Bumrah bowled a 10-ball over mostly comprising bouncers and one of them hit Anderson on the helmet. Words were exchanged following that incident and Anderson was not pleased about the Indian's tactics.

"I got caught off guard a little bit because all the batters coming in were saying how slow the pitch was. Banged in short; it was really slow. When I came out to bat, Joe Root said Bumrah was not bowling as quick as he normally does, Anderson said on the BBC Tailenders Podcast.

"And then, the first ball was 90 miles an hour and on the money, wasn't it? And it felt like. I haven't felt like this ever in my career. I felt he wasn't trying to get me out. "He bowled an over, maybe 10, 11,

12 balls (10). He was bowling noball after no-ball, bowling short. I think he bowled two on the stumps which I managed to dig out."

The following day Bumrah got the taste of his own medicine but the Indian handled the England pacers rather well and shared an 89-run stand with Mohammad Shami to set up a big win for the visitors.

R Ashwin, who did not play that game, also spoke about that incident between Bumrah and Anderson. "England took that Anderson incident very personally. Bumrah said he didn't even know what happened but all of us got together and told him what Anderson said to him and that riled us up. What happened next was extraordinary," said Ashwin on his Youtube Channel.

#### **Ex India footballer** Chandrasekhar dies

KOCHI: Former India footballer and Olympian O Chandrasekhar, who was part of the gold medal-winning Indian team at the 1962 Asian Games, died Tuesday at his residence here, family sources said. He was 85, and survived by three children. Chandrasekhar, a defender in his playing days, was suffering from age-related ailments for some time, a source associated with the family told PTI. He was a member of the Travancore-Cochin Santosh Trophy team and had captained the Indian team in a few tournaments. Most notably, he was a member of the 1960 Rome Olympics Indian team besides being part of the 1962 Jakarta Asian Games.

Tokyo, August 24: In manner most fitting, the Tokyo Paralympics began here Tuesday with the central theme of 'We Have Wings' in a colourful opening ceremony, depicting the para athletes' endeavour to fly high in the face of unimaginable adversities.

At times tugging at the heartstrings, the otherwise joyous and colourful opening ceremony - the main character of which was a 'little one-winged plane' - encapsulated the idea that every human being has its own wings, and by mustering courage and spreading them wide, it can go anywhere irrespective of which way the wind blows.

Emperor Naruhito declared the Games open in front of a nearempty stadium before the Paralympic flag was carried into the National Stadium.

International Paralympic Committee President Andrew Parsons said the organisers of the Tokyo 2020 Paralympics can deliver a 'safe' event.

Prior to that, the ceremony paid homage to the resilience of para athletes while giving the message of moving forward amid the unrelenting devastation being caused by the COVID-19 pandemic.

The Paralympics have returned to Tokyo for the first time in 57 years, making the Japanese capital the first ever city to host the

Games twice. The ceremony was set in a 'Para

Airport' – a symbol of diversity and inclusion - and began with a video that depicted the strength of para athletes

In the video, a gentle breeze turned into a huge gust of wind that reached the stadium and swept through the field of play. Following this, a group of crew members, who work at the airport, began a countdown at the end of which fireworks lit up the night sky to celebrate the start of the Games.

IPC chief Parsons and Naruhito were welcomed to the stadium following which the Japanese flag was carried to the stage by six individuals including Kaori Icho, four-times Olympic freestyle wrestling champion and Takumi Astani, a rescue worker. Sombre music played in the background. After introducing the 22 sports

and events at Tokyo 2020, a colourful line of light appeared at the end of the first video, which then transformed into the runway of the Para Airport. Giant propellers and balloons surrounded the outer stage, forming the Agitos symbol of the Paralympics.

After the Parade of Nations came the 'little one-winged plane' performed by young 13-year-old wheelchair-bound Yui Wago, who had never acted before.










A torchbearer waves to the attendees after lighting the Paralympic cauldron
