Bolangir farmer dies by suicide over crop failure

Bolangir, Sept 3: With drought situation looming across the state, a farmer allegedly committed suicide over loss of paddy and cotton crops in Tureikela block of Bolangir district.

The deceased was identified as Rechaka Banchor, 60, of Kadobera village under Tureikela block. He had gone to his farmland Thursday. On returning from the farmland, he allegedly consumed poison, his family members claimed.




After he drank the poison, Banchor's family members rushed him to the Kantabanji hospital However, as his condition deteriorated he was shifted to the Bhima Bhoi Medical College and Hospital in Bolangir. Banchor died while undergoing treatment at the hospital late Thursday night.

His family members said that Banchor consumed poison because he was mentally disturbed over the crop failure on account of scanty rain. The family members alleged that the bulk of their cotton and paddy crops got damaged due to less rainfall this monsoon season.

The farmer is a landless one. He is survived by his wife and two sons. His family members said that Banchor used to migrate to other states in search of work. This year, he had cultivated paddy and cotton on two acres of land on a share-cropping basis

When contacted, District Collector Chanchal Rana said that he can tell about the incident only after an investigation.

Islamabad, Sept 3: Days after India held its first formal talks with the Taliban, the latter have said that they have a right to speak out in favour of Muslims anywhere, including in Kashmir, indicating a possible failure of India's dialogue with the Islamist group.

Amid concerns in India that Afghan soil under the Taliban regime can be used for terrorist activities against it, Suhail Shaheen, Taliban spokesman for its political office in Doha, in an exclusive interview to the BBC through video link Thursday, said: "We will raise our voice and say that Muslims are your own people, your own citizens and they are entitled to equal rights under your law."

As Muslims, it was the group's right to speak out for Muslims living in Kashmir and any other

PESHAWAR: Describing China as their "most important partner," the Taliban said they look to Beijing to rebuild Afghanistan and exploit its rich copper deposits as the war-ravaged country faces widespread hunger and fears of an economic collapse. Taliban spokesperson Zabihullah Mujahid said the group supports China's One Belt, One Road initiative that seeks to link China with Africa, Asia and Europe through an enormous network of ports, railways, roads and industrial parks. "China is our most important partner and represents a fundamental and extraordinary opportunity for us because it is ready to invest and rebuild our country," Geo News quoted Mujahid as saying in an interview to an Italian newspaper.

In the meeting, Mittal conveyed to Stanekzai that Afghanistan's soil should not be used for anti-Indian activities and terrorism.

It was the first publicly acknowledged formal diplomatic engagement that came two weeks after the Taliban seized control of Afghanistan. Shaheen's remarks came after Al-Qaeda through its Al-Sahab media asked the Muslim community to 'free' other Muslim lands after the liberation of Afghanistan, putting Kashmir on the list of targets

of jihad. Besides Kashmir, it shortlisted the Levant, comprising Iraq, Syria, Jordan and Lebanon; Maghreb, or the region in northwest Africa consisting of Libya, Morocco, Algeria, Mauritania, Tunisia and Somalia; and Yemen on its priorities.

Speaker adjourns House within seconds

Question Hour and Zero Hour were washed out as Opposition parties tried to rake up several issues

Bhubaneswar, Sept 3: Speaker Surjya Narayan Patro Friday adjourned the Odisha Legislative Assembly till 4pm within seconds of its commencement after Congress leader Narasingha Mishra raked up the issue of rampant corruption in the Odisha Public Service Commission.

Mishra stood at his seat and started speaking on the issue. "There is massive corruption in the Odisha Public Service Commission...," he said. Soon the Speaker interrupted and adjourned the House till 4pm. This was the third consecutive day when the Question Hour and Zero Hour of the Assembly were washed out as the Opposition parties tried to raise several issues.

The main Opposition BJP, however, alleged that the House was deliberately adjourned to avoid a disorder in the state for which the party had given notice and it was also accepted by the Speaker.

"The House was adjourned within one minute even before one question was discussed. It is now clear that there has been a secret deal between the ruling BJD and the Congress to avoid a discussion on law and order," BJP chief whip Mohan Majhi said.

"This is something like match-fixing. As per the secret deal, the Congress raised the recruitment scam issue and created din based on which, the Speaker adjourned the House. Law and order issues could not be discussed. We were supposed to raise the law minister's alleged involvement in the Mahanga double murder and other such cases," Majhi

told reporters outside the House. Government chief whip Pramila Mallick, however, said, "The government is ready for discussion on any issue. Instead of raising common issues such as farmers problems and drought situation, they (Opposition) have been disrupting the House over some petty crimes. Have people sent us to Assembly to discuss criminal cases only?

41% growth in

state's August

has recorded 41.32 per cent growth in GST collection in August 2021 compared to the corresponding period of 2020, GST officials said here Friday.

The state's GST collections stood at ₹3,316.55 crore in August 2021 as compared to ₹2,348.28 crore collected in August 2020. This was the second highest growth rate of GST among all major states in the country, said the Odisha Commercial Tax and GST Commissioner's office.

The progressive GST collection till August during the current financial year is ₹16,977.92 crore while ₹9,888.99 crore was collected till August during last fiscal, thereby registering a growth of 71.69 per cent, it said.

Similarly, the collection of Odisha GST has recorded a growth of 39.40 per cent. The OGST (Odisha Goods and Services Tax) collection during August 2021 is ₹956.47 crore while ₹686.15 crore was collected in August 2020

The progressive collection of OGST upto August is ₹4836.75 crore while the state had collected ₹3040.37 crore during the same period in 2020. The progressive OGST collection has recorded a growth of 59.08 per cent till August 2021.

Similarly, there is a collection of ₹792.93 crore in Central Goods and Services Tax, ₹948.21 crore in Integrated Goods and Services Tax and ₹618.94 crore in cess during August 2021.

This growth during August is a result of better compliance by dealers having turnover of more than ₹5 crore as well as follow-up action of non-filer assessment and return scrutiny in case of wrong return filers, said an official.

The increase in the GST collection is due to rise in commodity prices of iron and steel as well as the mining sector and collection from matured GST demand madeby tax officers after return scruting the official informed

Secret funeral plans for Queen Elizabeth II leaked

London, Sept 3: Leaked documents have revealed for the first time Friday the extent of the huge operation that will be launched in the hours and days after Britain's Queen Elizabeth II dies.

Details of what will happen under the codename 'Operation London Bridge' were leaked to US-headquartered news organisation 'Politico', which reports that officials will refer

to the day the Queen dies as 'D Day.' The 95-year-old monarch, the longest-serving in British history, is to be buried 10 days after she dies and her son and heir, Prince Charles, will embark on a tour of

the UK before the burial is held. According to the plans, the late sovereign's coffin will lie in state for three days at the Houses of Parliament, with authorities anticipating hundreds of thousands of people to descend on London sparking fears over gridlock, policing and even food shortages.

A vast security operation has been planned to manage the unprecedented crowds and travel chaos that are expected in the lead-up to her funeral. One memo warns that London could be stretched to breaking point as hundreds of thousands of people make their way to the UK capital. There will be a supposedly 'spontaneous' service at St Paul's Cathedral, according to Politico, and the new King Charles will tour the four nations of the United Kingdom in the days after her death.

The British prime minister and the monarch are said to be in agreement that the day of her state funeral will be a day of national mourning. It will effectively be a holiday, although not described as such.

Buckingham Palace officials have declined to comment, either on the leak or the plans.

In 2017, 'The Guardian' published an article revealing details of Operation London Bridge, which covered how the new King-Charles will be proclaimed at St James's Palace amid visiting royalty.





New Delhi, Sept 3: The Supreme Court (SC) Friday asked the Odisha government to file an affidavit giving details on the imposition of statutory royalties of around ₹319 crore on Sarda Mines Private Limited (SMPL) towards District Mineral Foundation (DMF) fund and National Mineral Exploration Trust (NMET).

A three-judge bench of the apex ourt headed by Chief Justice NV Ramana asked the state government to file its response within two weeks and barred it from taking any coercive action against SMPL.

The bench, also comprising Justices Surya Kant and AS Bopanna, asked the state government why it had not raised the issue of additional royalty deposit in DMF fund and NMET when the matter was decided in January 2020.

During the hearing, senior advocate Kapil Sibal appearing for the mining firm said that the state government cannot compel his client to pay DMF amount on mining activities done till 2014 as the DMF rules were notified in September 2015. Sibal also cited a Supreme Court order of 2017 wherein the apex court had held that the DMF rules can-

not have retrospective effect. Significantly, the state government has asked Sarda Mines to pay around ₹299 crore towards DMF fund and ₹19.98 crore as contribution towards NMET (total ₹319 crore



EOW arrests bizman for City crosses 1K mark in Covid-19 fatalities swindling ₹6cr subsidy

Bhubaneswar, Sept 3: The Economic Offence Wing (EOW) has arrested a businessman on charges of misappropriating government subsidy on the purchase of agricultural equipment between 2017 and 2021. The accused Srinath Rana is a resident of Balasore.

Rana, owner of M/s Tarini Auto Agency in Balasore, was earlier working as the regional manager of a Bangalore-based firm Varushapriya Agrotech Private Ltd which has a branch office at Baramunda in the state capital.

The Bangalore firm was registered with the state Agriculture department to supply various agricultural equipment including rice seedling transplanters to farmers at a subsidised price. The state government usually sends the subsidy amount to the accounts of eligible farmers through direct benefit transfer (DBT).

The accused was authorised by the firm to facilitate subsidies to the beneficiaries from the state, and to register the sale of machinery by uploading the details of the farmers and equipment sold on the website of state Agriculture department.



Panel to oversee contingency crop plan

The decision was taken a day after both the opposition BJP and Congress had demanded declaration of drought in the state so that affected farmers can avail assistance as per the relief code.

The committee has been set up under the chairmanship of the vice-chancellor of Odisha University of Agriculture and Technology. Chief Minister Naveen Patnaik had directed government officials August 31 to implement a contingency crop plan for the benefit of farmers given the prevailing dry spell.

Presiding over a meeting here Friday, Agriculture and Farmers' Empowerment Minister Arun Sahoo instructed that officials should visit the areas under their jurisdiction to monitor the crop condition. "The officials of the departments concerned have also been directed to submit the data related to rain deficiency to their higher authorities," Sahoo said.

The technical committee has been urged to submit its report by September 6, he said.

Beginning from the field level officials to top officers, all will keep a vigil on the situation, Sahoo said.

Kharasrota project will harm **Bhitarkanika: Green activists**



Kendrapara, Sep 3: The diversion of water from the Kharasrota river system in Kendrapara district for a proposed mega drinking water project will adversely affect the fragile mangrove ecosystem in the Bhitarkanika National Park, green activists warned Friday.

The Bhitarkanika forests, the second largest mangrove ecosystem in the country, are now under severe threat due to the planned diversion of freshwater from the Brahmani river basin, noted environment activist Biswajit Mohanty said in a statement.

Mohanty, the secretary of environment group Wildlife Society of Odisha, alleged that the state government had ignored the need to conserve the wetland for posterity even as it is a notified Ramsar Convention site.

The proposed ₹892-crore project will draw water from Kharasrota, a tributary of the Brahmani river, for piped supply to neighbouring Bhadrak district, where the groundwater is heavily saline.

The project has triggered vehement protests across Kendrapara district for a month. Prohibitory orders have been imposed in Balakati, Bharigada and Barunadiha panchayats in Rajkanika block till October 8

Residents of Rajkanika, 125 km from Bhubaneswar, are demanding scrapping of the project over fears that the diversion would lead to

tirely dependent on agriculture. Officials of the Rural Water and Sanitation Scheme, however, insist that the project, which requires 105 million litres of water per day, would only result in diversion of less than four per cent of the water inflow of the river.

Kendrapara sub-collector Niranjan Behera dismissed the apprehensions as "unfounded". Mohanty pointed out that the water diversion from the Rengali canals continued to pose a perceptible threat to the Bhitarkanika mangroves, adding that the diversion of water from Kharasrota would trigger irreversible damage.

The mangrove forests, spread over 195 sq km, have a high level of biodiversity since 62 of the world's 73 mangrove species are found there. It is also the breeding place

diles. The Gahirmatha Marine Sanctuary, which forms the boundary in the east, attracts the world's largest population of Olive ridley sea turtles for nesting.

Without the mangroves, the Gahirmatha sanctuary will become a "marine desert" and lose its richness and diversity, Mohanty said. Hemant Kumar Rout, secretary of Gahirmatha Marine Turtle and Mangrove Conservation Society, said mangrove is the protective barrier of the region against cyclones and tidal surges

Rout asserted that the diversion of water would definitely lead to depletion of water table. It will affect mangrove ecosystem of Bhitarkanika and its flora and fauna, the activist told PTI.

Mohanty, meanwhile, underlined that after Farakka Barrage in West Bengal was commissioned, the Sundarbans mangrove forests were drastically affected. In Bhitarkanika, the situation will be catastrophic for the mangroves in a bad year of monsoon, according

Lack of normal flow of freshwater will increase the saline ingression upstream, affecting the local flora and fauna, as well as the livelihoods of farmers and fisherfolk dependent upon the Brahmani and Kharasrota river systems, he said.

Mohanty expressed apprehension of a quantum jump in mancrocodile conflict since the estuarine crocodiles would leave the core sanctuary area and migrate upstream once the salinity increases.

The state government is yet to reveal how it plans to ensure adequate flow of fresh water in the Kharasrota and Brahmani rivers that feed Bhitarkanika once the Rengali canals start drawing water.

Mohanty suggested that the state government should consider Hadgarh reservoir on the Salandi river or the newly-built Kanpur barrage on Baitarani river as potential sources to meet the requirements of Bhadrak. The "ecological flow" of freshwater to ensure the health of mangroves of Bhitarkanika should be maintained, the ac-

Govt's affidavit at NGT under cloud

Kendrapara, Sept 3: The state government's affidavit at the National Green Tribunal (NGT) about the diversion of the Kharasrota river water to Bhadrak has come under cloud.


According to reports, Sanjay Behrua, a resident of Rajkanika, had filed a petition at the National Green Tribunal on the controversial mega drinking water project that envisages diversion of water to 91 villages in Bhadrak.

The NGT had asked the government to report about the socioenvironmental impacts of the drinking water project.

The state government had filed its affidavit at the NGT on the basis of the report prepared by Prof Dr Sashidhar of IIT-Hyderabad.

The affidavit has now come into question after Dr Sashidhar denied via email that he had conducted any special survey about the impacts of the mega drinking water project on the Bhitarkanika National Park

Various outfits have demanded a survey by a technical team about the impacts of the drinking water KHARASROTA WATER DIVERSION CONTROVERSY



project on the environment and agriculture. Despite opposition by the locals, the government has started construction of an intake well of the project at Barunadiha panchayat. To ward off troubles by locals, the administration has clamped Sec-144 around the project area before its construction.

The project entails supply of Kharasrota water to 91 panchayats and three urban areas under Basudevpur, Tihidi, Dhamnagar and Chandbali blocks in Bhadrak.

Sanjay Behura of Rajkanika alleged that diversion of the Kharasrota water would have an adverse impact on fresh water, agriculture and environment in Aul and Rajkanika areas. He filed a case (23/20) in 2020 at the NGT.

Secretary of the water resources department Anu Garg filed an affidavit at the NGT. In the affidavit, it was stated that there was no negative take by Dr Sashidhar of IIT Hyderabad in his report about the impacts of the drinking water on socio-environmental spheres.

Though the intake well at Barunadiha and the treatment plant the project was given a go-ahead.

Rakesh Mohanty wanted to know of the veracity of the report given by Dr Sashidhar. Mohanty had both telephonic and email communication with Dr Sashidhar August 26 about the socio-environmental impacts of the mega drinking water project.

It was claimed that Dr Sashidhar had not done any special survey on Bhitarkanika biodiversity and had not even visited the project site.

Sanjay Behura, Khitish Kumar Singh, Pradip Kumar Tarai, Duryodhan Mohanty (president of Kharasrota Nadi Bachao Sangram Samiti) and Bhuban Mohan Jena (Jana Adhikar Manch) said the water of Kharasrota is vital for sustenance of Bhitarkanika mangroves, which has been in the list of World Heritage sites. They alleged that the state government has been carrying out the mega drinking water project on the basis of a wrong report. They said, "A technical team should conduct a survey on the impacts of the drinking water on Bhitarkanika biodiversity. Or else, we will take to legal recourse in this matter.

ujarat has got a new Chief Secretary in 1986-batch IAS officer Pankai Kumar, but within babu circles, there is more curiosity about Kumar's predecessor Anil Gopishankar Mukim, who completed his extended tenure. It's not game over yet for Mukim.

The word is that Mukim is nowhere near hanging up his boots. Chief Minister Vijay Rupani had also hinted during a recent Cabinet meet that Gujarat was still keen to avail of his advice and services. Observers, however, are unsure whether Mukim will stay in the state or move to Delhi where he seems to enjoy a good rapport with the power centres. It's possible; DKB has learnt that Mukim may be retained in some post-retirement official position - either in Gujarat or Delhi.

Some babus believe that Rupani could make Mukim the head of the Gujarat Electricity Regulatory Authority or Director of the prestigious Gujarat International Finance Tec-City (GIFT).

There is also talk that given Mukim's standing with the Centre, he could well be named the next Chief Vigilance Commissioner or even be inducted into the Prime Minister's Office (PMO). There are vacancies arising soon and the handpicked will be sought.

Given Modi's soft corner for Gujarat babus, it would not be surprising. Either way many believe that Mukim will be rewarded for his blemish-

SC deplores 'vindictive' actions against babus

The Supreme Court has frowned on the trend of suspension of *babus* for political reasons. It has directed Chhattisgarh Police not to arrest its own suspended senior IPS officer Gurjinder Pal Singh, against whom the state government has slapped

two criminal cases for sedition and amassing disproportionate assets. While the court allowed the state government to continue with its ongo ing investigation against the senior cop, it noted the "disturbing trend" where governments in power initiate action against officers seen by them

to have supported the previous dispensation. This is not something new. The trend was normalised years ago. It is even seen as the "right" of the incoming government to bring in its favourites and "punish" those who are perceived as such. In fact, rare is the instance when

a government does not engage in vindictive politics with the senior babus. Yet, it is heartening that the apex court has chosen to comment on this, not that it would necessarily mean that Singh is out of the woods. The cases against him will continue, but it may be a relief to some others to know that the Supreme Court is on to errant governments and is watching closely.

Delay in key MPSC appointments holds up recruitment

Though the chairman of the Maharashtra Public Service Commission (MPSC) Satish Gavai retires this week, the state government has started the hunt for his successor only now. Babus are blaming the flood situation in Maharashtra for having missed the deadline for filling the vacant posts in MPSC. Besides the outgoing chairman Gavai, four posts of members are vacant.

Sources have told DKB that Gavai had flagged the issue to the government several times. The government's dilly-dallying has resulted in holding up the filling of some 2,000 posts, including engineers and Deputy Collectors.

The MPSC plays an important role in staff recruitment. It is supposed to have six members but, for the longest, it has had only Gavai and another member Dayanand Meshram running the ship. Gavai was an Additional Chief Secretary in the Environment department when he retired two years ago from the IAS.

Looks like recruitments in the state may be delayed even further.


t sounds a dauntingly highbrow term, but the intention is just the opposite — to demystify science and help people engage with it. The technique is based on the discussion of topical scientific ideas with interested people in determinedly non-academic surroundings. The Cafés sum up their intentions with a maxim, too long to be considered a slogan, "We want people to be as opinionated about science as they are about football". Informal meetings are usually held in cafés or bars; a guest speaker talks briefly on a topic and then leads a discussion. The first Café Scientifique was held in Leeds in 1998, with its name invented by the man who started it, Duncan Dallas. "I was reading the paper's obituary of Marc Sautet, the man who founded the cafés philosophiques in France," he recalls, "and I thought 'I'd like to do that'. But the British don't think philosophy is a real subject, so I opted for science instead."



ith the United States' disastrous Afghanistan, the parallels between the 2020s and the 1970s just keep growing. Has a sustained period of high inflation just become much more likely? Until recently, I would have said the odds were clearly against it. Now, I am not so sure, especially looking ahead a few years.


Many economists seem to view inflation as a purely technocratic problem, and most central bankers would like to believe that. In fact, the roots of sustained inflation mainly stem from political economy problems, and here the long list of similarities between the 1970s and today is unsettling.

At home, following a period in which the US President challenges institutional norms (Richard Nixon was the 1970s version), a thoroughly decent person takes office (back then, Jimmy Carter). Abroad, the US suffers a humiliating defeat at the hands of a much weaker, but much more determined adversary (North Vietnam in the 1970s, the Taliban today).

On the economic front, the global economy suffers a lingering productivity slowdown. According to the Northwestern University economist Robert Gordon's magisterial account of innovation and growth, 'The Rise and Fall of American Growth', the 1970s marks a turning point in US economic history, thanks to a sharp slowdown in meaningful economic innovation. Today, even if productivity pessimists grossly underestimate the phenomenal gains the next generation of biotech and artificial intelligence will bring, a large body of work finds that productivity growth has been slowing in the twenty-first century, and now the pandemic looks to be inflicting another heavy blow.

The global economy suffered a massive supply shock in the 1970s, as Middle East countries massively hiked the price of oil they charged the rest of the world. Today, protectionism and a retreat from global supply chains constitute an equally consequential negative supply shock.

Finally, in the late 1960s and 1970s, huge increases in govern-



Many economists seem to view inflation as a purely technocratic problem, and most central bankers would like to believe that. In fact, the roots of sustained inflation mainly stem from political economy problems, and here the long list of similarities between the 1970s and today is unsettling

ment spending were not matched by higher taxes on the wealthy. The spending increases stemmed in part from US President Lyndon B Johnson's "Great Society" programmes in the 1960s, later amplified by the soaring cost of the Vietnam War. First Johnson and then Nixon were reluctant to raise taxes to pay for these costs, fearing a loss of political support. In recent years, first the Trump tax cuts, then pandemic-related catastrophe relief, and now progressive plans to expand the social safety net have hit the federal budget hard. Plans to fund these costs by raising taxes only on the rich are likely to fall far short.

It is true that despite all these similarities, today's independent central banks stand as a bulwark against inflation, ready to raise interest rates if inflation pressures seem to be getting out of hand. In the 1970s, only a few countries had independent central banks, and in the case of the US,

it did not act like one, fueling inflation with massive monetary expansion. Today, relatively independent central banks are the norm across much of the world. It is also true that today's ultra-low global real interest rates provide rich-country governments a lot more room to run deficits than they had in the 1970s. On the other hand, the chal-

lenges of providing for aging populations have become vastly more difficult over the past five decades (at least in advanced economies and China). Underfunded public pension schemes arguably are a much larger threat quantitatively to government budget solvency than debt. At the same time, social pressures to increase government spending and transfers have exploded across the world. as inequality becomes more politically salient for many countries, and improving growth less so. And confronting climate change and other environmental threats will almost certainly put additional pressure on budgets and slow growth.

Sharply rising government debts will inevitably make it more politically painful for central banks to raise nominal interest rates if global real rates start turning upward. High debts are already a reason why some central banks today will hesitate to raise interest rates if and when post-pandemic normalisation occurs. Private debt, which has also soared during the pandemic, is perhaps an even bigger problem. Widespread private defaults would eventually have a huge fiscal impact via lower tax collection and higher social safety net costs.

Before we get too pessimistic, let's remember that the 1970s were followed by the 1980s and 1990s, and a big revival in advanced economy growth, even if it was not as inclusive as policymakers would like to achieve. Then again, the 2030s are a long way off.

Todav's economic challenges are certainly solvable, and there is no reason why inflation should have to spike. Leading central bankers today such as Jay Powell of the US Federal Reserve and Christine Lagarde of the European Central Bank are a far cry from pliable Fed Chair Arthur Burns in the 1970s. They both have superb staffs to support them. Yet all central banks still face constant pressures, and it is hard for them to stand alone indefinitely, especially if politicians become weak and desperate.

America's humbling defeat in Afghanistan is a big step toward recreating the perfect storm that led to slow growth and very high inflation of the 1970s. A few weeks ago, a little inflation seemed like a manageable problem. Now, the risks and the stakes are higher.

Taliban's rise, ISI and Kashmir

he Taliban's rise in Afghanistan has given certain elements in Pakistan an opportunity to portray the Taliban victory as a gateway to Kashmir also. Their imaginations may be running riot, but the reality is that the happenings in Afghanistan may not be as helpful to Pakistan as it is claiming. But it may use the Taliban rise to stir up the 'Islamic sentiments' in Kashmir to fuel the separatist agenda.

The Taliban has too many challenges at hand. Its struggles to form a government, run it, sustain it and save it from many other virulent groups are too many for it to export its help to Pakistan in its Kashmir mission. The Taliban have brought the whole of Afghanistan under its control except the Panjshir province. But it is the Islamic State-Khorasan and the Tehrik-i-Taliban Pakistan (TTP) which have the potential of keeping it engaged.

The IS-K has already thrown a challenge to the Taliban by launching several attacks since the Taliban takeover, including the two at Kabul airport. The IS-K has refused to acknowledge Taliban's supremacy and is prepared to engage in a long-drawn battle that could result in civil war in Afghanistan and cause problems in neighbouring nations. Khorasan involves parts of Pakistan, Iran, Afghanistan and Central Asia. Now that the US is not there, IS-K feels that it has an opportunity to take on the Taliban. The Tehrik-i-Taliban Pakistan

(TTP) or Pakistan Taliban has had an off-on relationship with the Taliban depending upon the situation and the timing. Pakistan also regards it as one of the most dangerous terror outfits in the region. As the Taliban was launching its offensive in Afghanistan, the TTP was carrying out attacks in north Waziristan. It wants an independent state comprising Pakistan's tribal areas, which have faced subjugation for decades from those at the helm in Pakistan. The TTP also has ties with Uyghur groups and has targeted Chinese workers associated with the China-Pakistan Economic Corridor (CPEC). Since China is supporting the Taliban, controlling and containing the TTP will be a hard task.

What Taliban had been for the erstwhile Afghan governments,

the IS-K and TTP could be the headaches for the new Taliban dispensation.

Keeping Afghanistan intact and running the country in an orderly manner are the two foremost challenges of the Taliban. And the challenges are too engulfing for it to spare its men for 'iihad' in Kashmir. However, the feeling that ter-

ror activities may get a new push in Kashmir is not totally unfounded. Pakistan will try and increase activities along the Line of Control (LoC) in Jammu and Kashmir, including infiltration and drone attacks. But, more dangerous is the fanning of the Muslim sentiments regarding the Taliban's resurrection and its 'successful' fight against the 'invader US'. The radicalisation of the youth in Kashmir over the decades has been a major worry for the security forces. And this is what comes in handy for the elements which are working round-the-clock to fan the separatist agenda. Al-Qaeda has given a call for the

'liberation' of Kashmir and other so-called Islamic lands. This might pose more security challenges in the Valley in the sense that Jaish-e-Mohammad and Lashkar-e-Taiba

may increase terror activities in the region to cash in on the rising sentiments of a Taliban win over the superpower US. "If Taliban could overthrow the US, why can't a similar thing happen in Kashmir"-this sentiment will probably become the new weapon for these terror outfits and their mentor, as has been flagged by Al Qaeda.

One of the conditions of the peace deal signed by the US and the Taliban in 2020 was that it should sever ties with all terror groups and not let its land be used for carrying out terror activities. And whether the Taliban will stick to this is a million dollar question.

After the abrogation of Article 370 in 2019, the Indian government took J&K's administration directly in its hands and a number of promises were made. Although political activity has been restored with by conducting the local body polls, the feeling of alienation has not ebbed

The Taliban's rise in Afghanistan is fodder for Pakistan's ISI to again work on the religious sensitivities of Kashmiri Muslims and that is the challenge for the Indian security agencies now.

Usha Patnaik, president of Gania Unnayan Parishad, said abortion of unborn foetus in Navagarh district had created shockwaves all over the country in 2007. However, the administration has failed to check the problem despite passage of 14 years. She said sustained efforts are required to stem the rot. Collector Poma Tudu said illegal action will be taken against those involved in the wrongdoings.

Admin set for leasing out stone mines

Jajpur, Sept 3: Mining in six black stone-bearing mines and a sand tehsil of Jajpur district. The administration is bracing up to hold public hearing on them. Stones will be mined from over several hectares of land. The executive summary of its environmental assessment has been prepared.

However, the district administration has not yet finalised the date, timing, and venues for public hearings. This has caused resentment among people who are interested to take the stone and sand mines on lease. According to reports, there is a

huge reserve of black stone in Bichhakhandi hills spreading over 36.65 hectares. In the past, the hill has been in media focus for rampant plundering of minor minerals like black stone that have a huge demand for infrastructure development.

Regular media reports spoke about the loot of black stones from the hill Following media reports the district administration had



made attempts to check the stone loot. Even Section 144 of the IPC has been clamped in the area to keep off the stone mafia. The stone quarries had been shut. Despite this, stone mining was happening occasionally.

The administration is preparing to lease out five stone mines in Bichhakhandi hill. Stones will be mined in 8.08 hectares in Cluster-4, 10.52 hectares in Cluster-4(B), 6.70 hectares in Cluster-4(C), 6.29 hectares in Cluster-4(D) and 5.06 hectares of Cluster-4(E).

Illegal prawn gheries killing bio-diversity in Kendrapara

Mahakalapara, Sept 3: Even as prawn farming has led to destruction of bio-diversity under this block in Kendrapara district due to discharge of toxic water from the prawn gheries, the state government has failed to act against the wrongdoers, a report said.

Reports said illegal prawn gheries have mushroomed in various coastal pockets of Kendrapara district due to high profit margins in the business. However, mushrooming of the gheries has led to destruction of wildlife, green cover and aggravated soil erosion in the region due to discharge of toxic effluents from the gherries.

Keeping these things in mind, the Orissa High Court had directed the district administration to intensify the eviction of illegal prawn gheries in coastal pockets of the district. However, the district administration except for demolishing a few gheries in Suniti panchayat four months back, has not done much in this regard.

It was alleged that the district administration had launched an eviction drive of prawn gheries but abandoned it midway after big prawn farmers opposed the move. Speculations are rife that the district administration abandoned its move after political leaders intervened in the matter due to upcoming panchayat elections.

Locals alleged that demolition of prawn gheries at a time when panchayat elections were round the corner might result in adverse results. They will also rob them of donations they get from prawn gheries owners. They allegedly intervened in the matter and stopped the demolition of gheries.

400 cases of mystery fever reported in Lucknow

ACCORDING TO A REPORT, AT LEAST 50 PEOPLE, INCLUDING 40 CHILDREN, HAVE DIED

Lucknow, Sept 3: More than 400 viral patients, including 40 children, have been admitted to various government hospitals in the state capital in the past two days. More than 20 per cent of pa-

tients in the OPD are complaining of fever, cold and congestion According to another report, at least 50 people, including 40 children, have died in western Uttar Pradesh's Firozabad district in the last 10 days from dengue. The state

government said the deaths were due

to "Dengue Haemorrhagic Fever,"

which is a severe form of the disease. Other districts in western UP like Mathura and Agra have also reported a rise in dengue, with hospitals teeming with children who are suffering from viral fever

and dehydration.

"A team of the WHO has told me this is Haemorrhagic Dengue which is a very dangerous form of dengue. The platelet count of children collapses suddenly and there is a lot of bleeding," Chandra Vijay Singh, the district Magistrate of Firozabad said in a video state-

There are instructions in the hospitals to not take patients in the OPD section without conducting a Covid antigen test.

As per the hospitals, the number of viral patients has increased by about 15 per cent in the last week.

In the paediatrics department. 12 children suffering from fever have been admitted. Of these, seven are from Lucknow.

The number of people getting tested for dengue, malaria, typhoid is also more than normal.

According to the medical superintendent of the Bhaurao Deoras hospital, Dr Manish, 10 to 15 children with fever are coming daily.

Dr SK Nanda, director of Civil Hospital, said, "The weather is changing rapidly. Humidity has increased in the atmosphere. In such a situation, viruses are present on the lower surface of the atmosphere. There has been an increase in the number of viral fever cases and three dengue patients are admitted in the hospital. There has also been an increase of 20 per cent in cases of viral fever and other related diseases.

Chief Minister Yogi Adityanath has ordered that sanitation and hygiene operations should be taken up on war footing. He has also asked hospitals to brace up to meet the situation which is being closely monitored by health officials.



Jaipur, Sept 3: More than 1.45 lakh "nutrition gardens" developed by women self-help groups in Rajasthan are bringing about a change in eating habits and nutrition level of families in rural areas, a senior state government official

Unlike affluent families that do gardening as a hobby, most taken up the concept of "nutrition gardening" to supplement their income, use vacant land and save on kitchen expenses, the official said.

The primary objective of the nutrition garden programme is to ensure nutrition for SHG members," said Suchi Tyagi, State Mission Director, Livelihood Projects and Self Help Groups (SHG).

The concept is being promoted by the Rajasthan Grameen Ajiveeka Vikas Parishad (Rajiveeka).

New Delhi, Sept 3: The R-value which reflects how rapidly coronavirus pandemic is spreading, has sharply risen close to 1.2 over the last fortnight, mainly driven by cases in states like Kerala and Maharashtra, say researchers.

The R-value calculated between August 24-29 stood at 1.17 as against 0.89 between August 14-17, according to the researchers at the Institute of Mathematical Sciences, Chennai. The rise in the R-value comes after a steady decline in cases in the first half of August in the country.

Up to that date (August 30), the situation looked pretty bad. India's R-value had shot up close to 1.2. Not only is it greater than one, it is much higher than the last time there was a scare of a third wave (it was 1.03 at that time). "This is driven by several states having their R-value go over 1 in the last few days of August -- most notably Kerala and Maharashtra, but also Mizoram and Jammu and Kashmir," Sitabhra Sinha, who is leading the team of researchers at the Institute of Mathematical Sciences, Chennai, told PTI. The R-value of Kerala stood at 1.33. which is the highest number of active cases in the country. Similarly, the R-value of Mizoram was 1.36, Jammu and Kashmir (1.25), Maharashtra (1.06) and Andhra

Biological E gets nod for further trials

Biological E has received approval for conducting phase II/III human clinical trial of Covid-19 vaccine candidate Corbevax on children above five years and adolescents, the Department of Biotechnology (DBT) said Friday. Corbevax, an RBD protein sub-unit vaccine, has been developed with supported from the Department of Biotechnology and its PSU Biotechnology Industry Research Assistance Council (BIRAC), it said. PTI had first reported the grant of approval to Biological E for trial of its vaccine candidate Wednesday.



Taking a serious view of the twin cases which triggered a massive political row, all the accused have been slapped with Indian Penal Code sections pertaining to murder, cheating, conspiracy, besides various sections of the Arms Act, the Explosive Substance Act, and the Unlawful Activities (Prevention) Act.

"The NIA has taken a very strong cognizance of the case given its ramifications. Besides the serious charges under IPC, they have also invoked terror charges against the accused," prominent criminal lawyer J.P. Mishra told IANS.

On the likely punishment, Mishra said that if proven guilty, the accused could face a maximum of life imprisonment since there was no explosion, and a minimum of life term or death sentence in the Hiran murder case.

The IPC sections span criminal conspiracy, destroying evidence to escape the consequences. negligence with explosives, abduction with intent to kill, extortion with threats of death or physical harm, grabbing property, criminal breach of trust by public servant, forgery and forging documents of electronic evidence to pass them off as genuine, possession of a fake seal to commit forgery, common intentions, etc

New Delhi, Sept 3: The Supreme Court Friday junked the plea filed by 1984 anti-Sikh riots convict and former Congress leader Sajjan Kumar seeking bail on medical grounds.

A bench headed by Justice Sanjay Kishan Kaul told Kumar's counsel: "He is accused of heinous crimes. You want him to be treated like some super VIP patient... we won't permit.'

Senior advocate Raniit Kumar. representing Sajjan Kumar, contended before the bench that his client's health was deteriorating, and he had also lost a lot of weight. He also cited a report on his health by a doctor. Kumar claimed that he had

recently collapsed in jail, and he was undergoing treatment in the emergency ICU at Safdarjung Hospital. In its response to the bail plea, the CBI said his medical condition was stable and it was improving.

The bench noted that medical report shows Saijan Kumar is being fully attended to and his medical

condition is stable. The bench, also comprising Justice M.M. Sundresh, declined to entertain the plea by Sajjan Kumar to get him transferred to the Medanta hospital for the treatment of his health issues, despite submitting that he would bear the cost on his own.

"We are not willing to grant medical bail or bail otherwise," said



Hurricane Ida toll rises to 46

New York: A stunned United States East Coast faced a rising death toll, surging rivers and tornado damage Thursday after the remnants of Hurricane Ida walloped the region with record-breaking rain, drowning at least 46 people in their homes and cars. In a region that had been warned about potentially deadly flash flooding but hadn't braced for such a blow from the no-longer-hurricane, the storm killed people from Maryland to Connecticut Wednesday night and Thursday morning.

Israel missile strike targets Damascus

SL extends Covid curbs till Sept 13

Colombo: Sri Lanka Friday extended its nationwide lockdown till September 13, amidst a surge in the number of Covid-19 deaths and mounting pressure on the healthcare system during the third wave of coronavirus. Sri Lankan President Gotabhava Rajapaksa had ordered a 10day lockdown August 20. The decision to extend the lockdown was taken following the Covid taskforce meeting with President Gotabhava Friday, officials said. The lockdown extended from August 30 was due to end September 6.

Large-scale Houthi attacks claim 58

Sanaa: The Houthi militia have launched large-scale attacks against Yemen's government forces stationed in the country's oil-rich province of Marib, which killed 58 people from both sides, a military official said. "Several areas and positions controlled by the government forces were heavily attacked by the Houthis who are expanding their military operations aimed at capturing Marib," the official told Xinhua news agency Thursday. Ferocious battles are still taking place between the two warring sides in various areas of Marib amid intensified airstrikes, the source said.



SL commends UK's decision to proscribe LTTE EU, ASTRA SETTLE VAX

Colombo, Sept 3: Sri Lanka Friday appreciated the UK government's continued partnership in the fight against global terrorism, as it noted the British Home Secretary's decision to keep the LTTE in its list of banned terrorist organisations.

In a communique, the government of Sri Lanka was notified that the UK Home Secretary (Priti Patel) has decided to maintain the proscription of the Liberation Tigers of Tamil Eelam (LTTE) as a terrorist organisation under the UK Terrorism Act No 7 of 2000.

"The government of Sri Lanka is appreciative of the partnership with the UK and all governments



in the global fight against terrorism and remain committed to working with the UK in all efforts to mitigate terrorism and violent extremism that threaten the lives of citizens and endanger global and regional peace and security", the

Sri Lankan Foreign Ministry said, reacting to the development.

The UK Home Secretary's decision, which was taken following the judgement of the Proscribed Organisations Appeals Commission (POAC), rejects the application of a LTTE front organisation to de-proscribe the LTTE in the UK.

The LTTE now remains a proscribed organisation in the UK, as in over 30 other countries worldwide, including in the European Union region. The continuity of the proscription is indicative of the continued threat posed by the remnant of the LTTE group working through its international network, the Sri Lankan Foreign Ministry said.

The LTTE, which led an armed rebellion for over three decades against the Sri Lankan government to set up a separate Tamil homeland in northern and eastern regions of the island nation, was defeated by the Sri Lankan Army in May 2009.

DISPUTE OUT OF COURT

Brussels, Sept 3: The European Union and UK-based drugs giant AstraZeneca announced Friday that they had reached a settlement in a dispute over a shortfall in coronavirus vaccine deliveries

The agreement will see the firm deliver the rest of the 300 million doses it promised under contracts with the EU before the end of March 2022, and brings to an end a battle in the Belgian courts.

Brussels was furious when the British-Swedish pharmaceutical outfit fell far short of its delivery promises, undermining the early stages of the EU Covid-19 vaccine rollout

Officials accused AstraZeneca of prioritising UK vaccine deliveries over the EU order, and European Commission lawyers went to court to demand deliveries or see huge daily fines imposed for any ongoing shortfall.

But the firm argued that its contract with the bloc only obliged it to make "best efforts" to meet its delivery target, and that production bottlenecks in its European plants had been unavoidable.

US FAA grounds Virgin Galactic after flight mishap

Washington, Sept 3: The US Federal Aviation Administration (FAA) Thursday said it was grounding space flights by Virgin Galactic while it investigates why the company's July 11 voyage carrying Richard Branson deviated from its planned trajectory.

The move represents a blow to the private space company as it prepares to carry paying customers following its first fully-crewed test

It is now unclear whether Virgin's next test flight, involving members of the Italian Air Force, will take place as scheduled in late September or early October.

'The FAA is overseeing the Virgin Galactic investigation of its July 11 SpaceShipTwo mishap that occurred over Spaceport America, New Mexico," the agency said in a short statement.

Virgin Galactic may not return the SpaceShipTwo vehicle to flight until the FAA approves the final mishap investigation report or determines the issues related to the mishap do not affect public safety," it added.

The news came after a report said the flight experienced cockpit warnings about its rocket-powered ascent that could have jeopardized the mission.

'US has no plans to release billions in Afghan assets'

Washington, Sept 3: The Biden administration has no plans to release billions in Afghan gold, investments and foreign currency reserves parked in the United States that it froze after the Taliban's takeover, despite pressure from humanitarian groups and others who say the cost may be the collapse of Afghanistan's economy.

Much of the Afghan central bank's \$10 billion in assets are parked overseas, where they are considered a key instrument for the West to pressure the Taliban to respect women's rights and the rule of law. Any unfreezing of these assets may be months away, financial experts said.

Officials from the US State Department, US Treasury, White

House National Security Council and other agencies have been in regdiscussions Afghanistan's finances since the Taliban took over in mid-August, ahead of what the United Nations and others see as a looming humanitarian crisis. Any decision to release the funds

would likely involve top US officials from several departments but will ultimately be up to President Joe Biden, the experts said. Food and fuel prices are soar-

ing across Afghanistan, amid a shortage of cash triggered by a halt in foreign aid, a halt in dollar shipments and a drought.

The US Treasury this week said it had granted a license authorizing the US government and its partners to continue to facilitate humanitarian aid in Afghanistan. It



also gave Western Union, the world's largest money transfer firm, and other financial institutions a green light to resume processing personal remittances to Afghanistan

"Delighted at the way the textiles sector has engaged with the idea of achieving bigger targets. We must aim for a USD 100 billion export target in the next five years," he said. He added that export has to stand on its own feet and has to be independently viable as demand for subsidies would not always help.

On free trade pacts, he said India is interacting with different nations to expedite FTAs or PTAs (preferential trade agreements).

EXPECT FY22 TO BE BETTER ON JOB FRONT AS COS PUSH HIRING: REPORT

Mumbai, Sept 3: Economists at the country's largest lender SBI believe that labour market activity will improve in FY22, saying companies are continuing with their hiring plans as the pandemic wanes.

They pointed to payroll data from Employees Provident Fund Organisation and New Pension Scheme, showing an uptick in new additions to support their optimistic view.

"We expect labour market activity to remain better in the current fiscal as companies will continue with their hiring plans to



get ahead of the pandemic," its chief economist Soumya Kanti Ghosh said in a note. The expectation comes at a time when concerns are being raised about joblessness and the dip in labour participation in the economy coming back to normalcy after the second wave of the pandemic.

As per an estimate by the Centre

for Monitoring Indian Economy, 15 lakh Indians, including 13 lakh in rural areas alone, lost their jobs in August alone. Lack of employment data has been pointed as a concern in India in the past by watchers. In earlier instances, payroll data has been critiqued for restricting to the formal sector in an economy where a bulk of activity is in the informal sector.

The rate of formalisation is now at 10 per cent, while the ratio of first jobs or new payrolls to total payroll was at 50%, indicating every one out of two jobs was a new addition to payroll. This is also an improvement from 47% in FY21. Ghosh said.

This engagement has been ongoing with the UK, EU, UAE, Australia, among others.

The assets under management of Quant witnessed over five-fold rise during January-July 2021. Its AUM in December 2020 stood at ₹521 crore and by July-end it reached ₹2,842 crore, showed data from

primemfdatabase.com. The AUM of ITI Mutual Fund

rose over 100% to ₹1,879 crore and PPFAS Mutual Fund's AUM also nearly doubled to ₹14,318 crore.

Some of the schemes of relatively new fund houses have given blockbuster returns with several of them coming from Quant Mutual Fund. As per the market estimates, ICICI Prudential Technology Fund, Quant Tax Plan Fund, PGIM India Midcap Opportunities Fund, Quant Infrastructure Fund and Quant Active Fund are the top five equity funds giving best returns ranging from 80% to over 100%.

Kotak Mahindra Mutual Fund, a major player in the segment, has the highest AUM of over ₹2.58 lakh crore as of July 2021, 13% higher than ₹22.78 lakh crore, the Prime Database data showed.

According to Pranav Haldea,

Managing Director of Prime

Database Group, the higher growth

rate of AUM of smaller fund houses is due to low base effect along with their identification of specialised offerings.

"One reason is low base effect, and second I think smaller fund houses have done a commendable job in terms of identifying niches where they have specialised," he said. He further said that performance of these mutual funds along with the incumbent giants will continue to

the AUM now stands at close to 35-36 lakh crores. So the growth of these smaller fund houses will also extract a fair share of that growth," he said.

Haldea said that the growth will continue because there will be more channellising of retail savings


into mutual funds going forward. More and more retail investors in the last one and half years have

come to the capital market as various other kinds of investment markets are not providing the investment returns that they are used to.

"So retail investors are increasingly looking at equity and the markets obviously are supportive and the markets are doing really well," he said.

NS Venkatesh, Chief Executive, Association of Mutual Funds in India (AMFI) said: "Mutual Funds have emerged as the preferred savings-cum-investment avenue over the last few years, and the pandemic has actually triggered this shift towards Mutual Funds in a more pronounced way."

This shift will continue in 2021 and beyond, accentuated by Sebi-driven initiatives towards transparency and disclosures, he said.

Harvinder bags bronze for India's first archery medal in Paralympics

TOKYO: Harvinder Singh Friday notched up India's first ever archery medal in the Paralympics, holding his nerves to down Kim Min Su of Korea in a thrilling shootoff for the men's individual recurve bronze in the ongoing Games here.

World No.23 Singh was the first athlete from India to win a gold medal at a major para competition in the 2018 Asian Games. Singh collected three shoot-off wins on the day starting with his triumphs in the opening rounds.

In the bronze playoff, the 31year-old was leading 5-3 before the Kroean clinched the fifth set shooting a perfect 10 to force a shoot-off where the Indian responded in style shooting a perfect 10 against Kim's 8 for a 6-5 (26-24, 27-29, 28-25, 25-25, 26-27) (10-8) win.

In the semifinals, Singh lost to World No.10 Kevin Mather of the USA 6-4 in an intense five-setter (25-28, 24-24, 25-25, 25-24, 24-26).

In the last 16, Singh pipped former World No.1 Bato Tsydendorzhiev of Russia, once again by the thinnest of margins 6-5 (8-7). Singh effected a spectacular turnaround from 0-4 down to bring the match on an even keel 5-5 (26-28, 23-26, 29-26, 23-21, 28-28) and force a shoot-off where he edged out his Russian opponent 8-7.

In the quarters, Singh swept aside 49-year-old threetime Paralympian Maik Szarszewski of Germany 6-2 (25-21, 28-23, 25-28, 26-23) dropping just one set.

Hailing from a middle-class farming family, Singh had dengue when he was just oneand-half years old and a local doctor administered him an injection that had an adverse effect and his legs stopped working properly.



Lekhara becomes first Indian woman to win two Paralympic medals

Tokyo, Sept 3: Trailblazing shooter Avani Lekhara Friday became the first Indian woman to win two Paralympic medals by claiming

the 50m Rifle 3 Position SH1 bronze to add to an unprecedented gold she had secured earlier in the ongoing Games here.

The 19-year-old Lekhara, com-

fied second for the event with a score of 1176, including 51 inner 10s. In the fiercely contested finals Lekhara totalled 445.9 to finish ahead of Ukraine's Iryna Shchetnik,

who let slip her grip on the medal

spot with a poor third shot of 9.9 in

Lekhara had become the first Indian woman to win a Paralympic gold by claiming the top honours in the 10m air rifle standing SH1 event. That was also the first ever shooting medal that India had won in the Games.

The Jaipur-based shooter, who sustained spinal cord injuries in a car accident in 2012 rendering her immobile, had fired a world record equalling total of 249.6, which was also a new Paralympic record.

Prior to her, Joginder Singh Sodhi was the lone Indian to win multiple medals in the same edition of the Games when he fetched one silver and two bronze medals in the 1984 Paralympics. His silver came in shot put, while the two bronze medals were won in discus and javelin throw.

Javelin thrower Devendra Jhajharia is the other multiple Paralympic medallist but all his three medals (two gold and a silver) have come in different editions of the Games

The gold in Friday's event was claimed by China's Zhang Cuiping with a new Games record of 457.9, while German Natascha Hiltrop took the silver with a 457.1 in the final.

Athletes in SH1 Rifle have an impairment in their legs, for example amputations or paraplegia. Some athletes compete in a seated position, while others compete in a standing position.

Lekhara is not done yet and will next be seen in the mixed 50m rifle prone SH1 event also featuring Deepak and Siddhartha Babu.

Debutant Praveen Kumar clinches silver in men's T64 high jump at Paralympics



TOKYO: India's Praveen Kumar clinched the silver medal in the men's high jump T64 event of the Paralympics, taking the country's haul to 11 in the ongoing Games

The 18-year-old Kumar, competing in his debut Paralympics, set a new Asian record with a 2.07m jump to finish behind Great Britain's Jonathan Broom-Edwards, who notched up his season's best effort of 2.10m for the gold.

This was also Kumar's personal best performance and his first major medal since taking up the sport in 2019. The teenager is a Noida resident and is now the youngest medal winner in the Indian contingent here.

The bronze went to Rio Games champion Maciej Lepiato of Poland who produced an effort of 2.04m. T64 classification is for athletes with a

leg amputation, who compete with prosthetics in a standing position.

T44, the disability classification that Kumar belongs to but is eligible to compete in T64, is for athletes with a leg deficiency, leg length difference, impaired muscle power or impaired passive range of movement in the legs.

His impairment, which is congenital, affects the bones that connect his hip to his left leg.

Kumar had earlier won a silver medal junior para world championship in 2019, his debut year. He is currently ranked world No.3 in T44 classification. He has always trained under national coach Satyapal Singh after coming to know of para-sports while competing in the high jump event for able-bodied athletes as a child.

The ongoing Games are turning out to be India's best ever and the nation has so far claimed two gold, six silver and three bronze medals. Kumar is the second teenager in the Indian contingent after the 19-yearold shooter Avani Lekhara, who won two medals - a gold and a bronze, to win a medal at the Games.

Italy share spoils, **Spain suffer loss** in WC qualifying

Milan, Sept 3: Italy finally came back down to earth a bit in its first game as European champion. Less than two months after winning the European Championship at Wembley, Italy were held to a 1-1 draw by Bulgaria in World Cup qualifying Thursday.

That ended Italy's perfect start to the qualifying campaign but nevertheless matched Spain's record run of 35 matches unbeaten, set between 2007 and 2009.

Spain lost 1-2 away to Sweden to drop to second in Group B, while England and Belgium earned big wins to consolidate their group leads.

Federico Chiesa gave Italy the lead after a dominant start but the Azzurri conceded their first goal in the qualifiers when Atanas Iliev leveled at the end of the first half.

Sweden came from behind to beat Spain and leapfrog the visitors for first place. Carlos Soler scored five minutes into his debut for Spain, but Aleksander Isak levelled seconds later. Viktor Claesson found Sweden's winner in the 57th.

In Group E, Romelu Lukaku scored twice as top-ranked Belgium came from an early goal down to beat Estonia 5-2 and stay atop Group E. In Group I, England weathered
