Fifty days have elapsed since Mohapatra was found dead at his official residence.

Boost to research as CET gets unitary varsity tag

Bhubaneswar; Sept 4: The Odisha Assembly Saturday passed three Bills including the one to accord unitary university status to government-run College of Engineering and Technology (CET) here.

The House passed the Odisha University of Technology and Research Bill, 2021 without any opposition. The CET. Bhubaneswar. will now be upgraded to a unitary university, said Skill Development and Technical Education Minister Premananda Nayak.

The technical institute would be renamed as Odisha University of Technology and Research. The

main objective of the university is to facilitate undergraduate and postgraduate education, and research in the field of engineering, science and technology architecture and management, he said.

The Assembly also passed Odisha Town Planning and Improvement Trust (Amendment) Bill, 2021. The Act was amended to achieve goals set under the 5T charter and guidelines of Business Reform Action Plan devised by the Centre.

The Odisha Appropriation Acts (Repeal) Bill, 2021 was also passed in the House. The Odisha Appropriation Acts passed between 1950 and 2011 are included in this Bill.

B TECH GRAD NABBED WITH **1KG CONTRABAND**

Bhubaneswar, Sept 4: The Special Task Force (STF) of state Crime Branch Saturday claimed to have arrested a B Tech graduate after recovering around 1 kg brown sugar worth about ₹1 crore from his possession in Khurda town.

Based on an intelligence input, STF. Bhubaneswar conducted a raid near Kumarbasta fuel station in Khurda town against illegal trade of narcotics. The task force apprehended Manoranjan Das (a B Tech graduate) of Gurujanga area

"During search, brown sugar weighing 1.034 kg and other incriminating materials were recovered and seized from Das's possession. The man could not produce any valid document to support the possession of the contraband, for which he was arrested," a senior STF official said.

Das was then produced before the Khurda Additional District and Sessions Judge Court and was remanded to judicial custody. Police are interrogating him to find out about his associates and buyers. In this connection, STF has also registered a case (31/21) under NDPS Act, 1985.

Since 2020, the STF, in its special drive against narcotic drugs, has seized more than 39 kg brown sugar/heroin and more than 86 quintals of ganja/marijuana andarrested more than 100 drug dealers/peddlers, the official said.

Biden orders declassification of 9/11 probe reports

The push for more information is being driven by victims' families suing Saudi Arabia for alleged complicity in the horrific attacks

Washington, Sept 4: US President Joseph Robinette Biden has ordered declassification of still-secret documents from the government investigation into the 9/11 terrorist attacks during the next six months.

Biden is responding to pressure from families of some of the approximately 3,000 people killed by Al-Qaeda September 11, 2001.

They have long argued that the classified documents might contain evidence that the government of Saudi Arabia, a close US ally, had links to the hijackers who flew into the World Trade Centre (WTC) and Pentagon. "Today, I signed an executive

order directing the Department of Justice and other relevant agencies to oversee a declassification review of documents related to the Federal Bureau of Investigation's September 11th investigations,"



Biden said in a statement. Declassification must take place

over the next six months. "We must never forget the enduring pain of the families and loved ones of the 2,977 innocent people who were killed during the worst terrorist attack on America in our history," said the US President.

The move comes ahead of the 20th anniversary of the attack, which spurred then-president George W Bush soon after to order the invasion of Afghanistan, where the Taliban sheltered Al-Qaeda's leadership. Biden pulled the last US troops out of Afghanistan this week, completing a dramatic evacuation from Kabul's airport after the Taliban defeated the US-backed government and surged back to power.

Bhubaneswar, Sept 4: Members of all parties actively participated in the Question Hour in Odisha Assembly Saturday, the fourth day of the Monsoon Session.

The first three days of the session were washed away because of the ruckus created by the Opposition BJP and Congress members who demanded the resignation of Law minister Pratap Jena for his alleged involvement in a double murder case at Mahanga in Cuttack district, and declaration of the whole state as drought-hit due to scanty rainfall in the peak monsoon season.

However, the legislators Saturday participated in the proceeding following an all-party meeting convened by Speaker SN Patro Friday. The issues raised by the Opposition members will be taken up at appropriate time, one of the members attending the all party meeting said.

During the Question Hour, the House was informed that the state government was planning to set up 24 new Industrial Training Institutes (ITIs) and Working Women's Hostel in five districts.

Skill Development and Technical Education Minister Premananda Nayak while replying to a question said that there are 49 government and 448 private ITIs across the state. As the government is focusing on the skill development of youths, plans are made to set up new ITIs in order to impart training for making them employable,

Navak said. Congress MLA Suresh Routray said that the local industries are not employing the Odisha-trained manpower and hiring technical persons from states like Tamil Nadu and Andhra Pradesh. He urged the government to make it mandatory for industries to employ trained

Repayments delayed but not denied: Sahara

Bhubaneswar, Sept 4: The Sahara India Pariwar has claimed it is facing troubles in repaying money to its investors due to holding up of funds by the SEBI and the restrictions imposed by the government in the wake of the Covid-19 pandemic.

In a press statement, the Group claimed that it had been facing difficulties for last eight years due to imposition of embargoes by the Supreme Court (SC) in connection with a dispute with the SEBI.

Acting upon the SC order, the group has deposited around ₹25,000 crore with the SEBI by selling or mortgaging its moveable and immovable assets.

The SEBI has so far repaid only ₹129 crore to the investors of Sahara. The stock market watchdog had made it clear that it would not entertain any further claims received after July, 2018. However, the watchdog has held up funds deposited by the Sahara Group, said the press

statement. The Sahara Group has approached the SC urging it to instruct the SEBI to return the amounts to investors. However, the petitions could not be heard in the apex court due to Covid-19

pandemic. "The Sahara Group, in association with some foreign companies, has been working on new business arrangements. The Group is expecting handsome amounts from its foreign arrangements. But, restrictions on international flights are preventing the group from finalising its business deals with foreign companies. Covid restrictions have affected the repayment schedule of Sahara," said the press

Hundreds of BJP workers took out a protest rally at Mahatma Gandhi Marg here. Accusing the state government of selling away the buses at throwaway prices, BJP leader Babu Singh said the move is betrayal of the people's interests.

"Is it possible for vehicles to become unworthy of road in just seven years? A vehicle can run for at least 15 years without any fitness issues and around 60 per cent buses in the state are plving even after 15 years. These buses have been sold away in the same manner in which the civic authorities disposed of the bicycles of the Mo Cycle fleet," Singh alleged.

It can be mentioned here that the Bhubaneswar-Puri Transport Services (BPTS), now known as CRUT, was initially launched in 2010 under the public-private partnership mode. Around 185 buses were procured by the state government in between 2010 and 2014. An RTI reply revealed that the procurement was done at an expenditure of around ₹185 crore. However, until the inception of CRUT in 2018, the BPTS was able to generate only ₹8.5 crore in seven vears.

The BPTS had bought 125 buses in 2010 under the JNNURM programme to facilitate city bus service in Bhubaneswar and Puri. An agreement was signed with the private operator Dream Team Sahara (DTS) to operate them for seven years-till 2017. Later, the agreement was extended for another year, till 2018.

"Some officials are involved in the irregularities in the auctioning of the buses. We dare the government to reveal the prices at which the city buses were purchased and later disposed of. The BJD government has deceived the people by selling off the buses at throwaway prices," said a BJP worker.

DEFUNCT LI POINTS TO BE FUNCTIONAL ON WAR FOOTING

Phulbani, Sept 4: While most parts of the state are headed for drought, the state government has taken steps to operationalise the defunct lift irrigation (LI) points in Kandhamal district. The Collector and concerned officials have been directed to take steps in this regard.

According to reports, pani panchayats have been handed out responsibilities to look after the lift irrigation points. Due to alleged faulty management, farmers are unable to get benefits of lift irrigation points.

There are 588 lift irrigation points in the district. Given the drought situation, the government has set a target to make 482 of them functional on a war footing.

If these LI points are made functional, only 9820 hectares will be irrigated. However, many LI points have failed to deliver in Khajuripada, Chakapada, G. Udaygiri and Raikia blocks due to lack of water in rivers.

According to reports, 11 out of 55 LI points in Phulbani block are defunct; 11 out of 97 in Phiringia; 16 out of 41 in Khajuripada, 10 out of 47 in Tikabali, five out of 33 in Chakapada, one out of 25 in Daringbadi; 11 out of 13 in G Udaygiri; five out of 31 in Raikia and eight out of 46 in K. Nuagaon.

A total of 93 LI points have been in disuse in the district. Farmers in



Phulbani, Phiringia, Baliguda, and Tumudibandh mainly make use of LI points to raise paddy, maize and vegetables

Most LI points have been set up along Salki river in Phulbani, Khadgi river in Tumudibandh and Melaruni creek in K. Nuagaon.

For want of rainfall, water flow in these rivers has drastically come down. As a result, LI points are unable to draw water from rivers. In some cases, motors and other machineries have been stolen. Pani panchayats have to look after payment of electricity dues and repair of

LI points. For various factors, pani panchayats are unable to discharge their responsibilities.

As per government guidelines, officials of the agriculture department and horticulture department are supposed to make field visits and facilitate the smooth management of the LI points.

Executive engineer of the LI department, Rudra Prasad Mishra said the energy department has been asked to supply electricity to LI points even though electricity dues are pending for clearance.

Paralakhemundi, Sept 4: The mysterious death of Assistant Conservator of Forests (ACF) Soumya Ranjan Mohapatra has taken a new turn Saturday after a former night watchman claimed he saw Divisional Forest Office (DFO) Sangram Behera visit the residence of the ACF between 12 midnight and 12.30 am.

Such revelation has come at a time when the Crime Branch is still to resolve the mystery behind the death of the ACF. 50 days have passed since the ACF was found dead at his official residence.

The statement of the night watchman gives credence to the repeated allegations by the family members of the deceased ACF that the DFO had illicit relations with his wife Bidyabharati. It is expected that night watchman's allegation against the DFO will force the Crime Branch to bring out the truth. DFO Sangram Behera is one of the accused in the case.

Former night watchman Ganga Pradhan alleged that he was sacked from his job after he saw DFO Sangram Behera visit the house of ACF Soumya Ranjan Mohapatra at around 12.30 pm one night.

Pradhan also accused two other staff of the DFO -- driver Prafulla and gardener Ajay-of hatching a conspiracy to remove him and four others from jobs.

He further said all the staff members in the DFO office will reveal the truth only after Sangram is transferred from there. The Crime Branch had earlier interrogated Sangram for nearly three hours where he denied the charge of his relationship with Bidyabharati Panda.

couple of decades ago, the American musician Ry Cooder visited Cuba. His intent was to revisit the island nation's great musicians, who had been forgotten because the American embargo on their nation meant they could not perform. They included singer Ibrahim Ferrer, who was polishing shoes to make a living, the pianist Ruben Gonzalez, who could not afford a piano, and guitar player Compay Segundo. Cooder's interest brought these musicians back to prominence and a movie, The Buena Vista Social Club, was made on them which became an international hit.

Two men in Delhi, Ashutosh Sharma and Ankur Malhotra, are doing something similar with the musicians of Rajasthan. The Manganiyars are a community based in the western parts of Rajasthan and the eastern parts of Sindh, who for centuries have been performing the folk music of that part of India. For many years now, Malhotra and Sharma (whom I have known for a quarter century) have been travelling and promoting the music of these extremely talented individuals whom even their own country may not be familiar with. And now the Aga Khan Museum has produced a three-part documentary series called 'Searching for the Blues' on the musicians with material shot and recorded by the two men's record firm. Amarrass,

I saw the documentary as it was being put together and then fully on the Aga Khan Museum's website and think it tells one of the most remarkable stories of our time, as important as the Buena Vista Social Club. One of the musicians they came across a decade ago, as

they were driving from hamlet to hamlet was Lakha Khan, from Raneri village in Jodhpur. Lakha Khan had been playing and singing for half a century at that time, making a living by performing at local events like weddings and births (the patrons of the Manganiyars are the local feudal Rajput lords). Khan was playing for the same families that his father and grandfather and great-grandfather played for. Even his instrument was one that came down to him from his ancestors and on which he still played

This instrument was the Sindhi Sarangi, whose sound imitates the human voice. Lakha Khan was the seventh generation of his family to be playing the instrument, and when he met the men from Delhi he played for them. He sang compositions including Hindu bhajans, Sufi kalaams, and folk songs in five languages: Seraiki, Sindhi, Marwari, Punjabi and Hindi. Amazed by the quality of the music, which reminded them of the Blues, the American form which incorporates religious and spiritual themes in soulful, simple songs, the two men recorded and promoted Khan. He began playing widely again, including internationally (footage from these international concerts is there in the documentary). In 2021, Lakha Khan received the Padma Shri, coming into a prominence that was his by right. Lakha Khan is only one of the many men and women from Rajasthan that the documentary series exposes us to. And it is astonishing, even for many of us who may have wide exposure to music, to see how such world-class performers are so little known in their own land. The last episode of the documentary features Dane Khan, the son of Lakha

Khan. Till some time ago, Dane Khan was driving a truck because there it was not possible to make a living from the family tradition. But happily, his father's growing prestige and frequent touring gave Dane Khan the opportunity to provide for his family while continuing the tradition for an eighth generation

Of course this is great news for our culture, which has found a carrier who will take it forward for another few decades, but it also reminds us of how much needs to be done. How many thousands of individuals like Lakha Khan remain in near-anonymity, while possessing our collective treasure? How many like Dane Khan receive this treasure but are not able to pass it on to another generation? We should rejoice in one ending that has turned out to be happy, but should also consider what lessons we can learn from it. The government's promotion of high culture, meaning classical and folk music and dance and theatre, is possibly at its lowest level in our history. One reason is that fewer people are connected to this culture and are more drawn to what is popular than what is classical and traditional. Secondly, the State itself has retreated from these areas. We had the three cultural institutions set up many decades ago including the Sangeet Natak Akademi (1953) for music and theatre, and the Sahitya Akademi for literature and the Lalit Kala Akademi for art established in 1954. But not enough has been done and is being done under them or by our general public, our corporates and our philanthropists and our higher educational institutions to stop the rapid erosion of traditional culture. Along with being reminded of the Buena Vista Social Club, this is also what came to mind on seeing the documentary on the Manganiyars.

COVAX ONUS ON G20

t is one vear since the international community gave its backing to the COVID-19 Vaccine Global Access (COVAX) facility to lead a worldwide effort to end the acute phase of the pandemic. The initiative aimed to ensure that every country, and not just those with sufficient money or resources, could access life-saving vaccines once they became available. As G20 health ministers prepare to meet in Rome September 5-6, they are in a position to ensure that COVAX fulfills its mission.

A year ago, no one knew when or even if it might be possible to develop a safe and effective vaccine against COVID-19, let alone the 20 that are available today. But since making its first international deliveries in February, COVAX - a partnership established by the Coalition for Epidemic Preparedness Innovations, the World Health Organisation, UNICEF, and Gavi, the Vaccine Alliance - has delivered more than 235 million vaccine doses to 139 countries, and expects to deliver another billion doses in the fourth quarter. Only China, India, and the United States have delivered more. This start to the largest and most complex vaccine rollout in history has given hope to millions of people and laid solid foundations for how we respond to future pandemics. Yet, so much more could, and

It is unacceptable that only 1.8 per cent of people in low-income countries have received their first dose of a COVID-19 vaccine, compared to 82 per cent in high- and uppermiddle-income countries. This shocking inequality is as economically senseless as it is destructive to human life, with the latest estimate of the cost of the slow rollout amounting to \$2.3 trillion.

The world was woefully unprepared for a pandemic, and this is reflected in the challenges COVAX has faced. By the time initial funding arrived, wealthy countries had already locked up early vaccine supplies. Export bans affecting key suppliers, and difficulties experienced by many man-

ufacturers in scaling up production to the required level, also undermined COVAX's ability to access doses early.

Given increasing global vaccine inequity and the rise of new. more contagious coronavirus variants, we must put these challenges behind us. Thanks to the support of almost all G20 governments, alongside that of foundations and private businesses. COVAX has now raised nearly \$10 billion and secured more than 600 million donated doses. All the preparations are in place for the most comprehensive vaccination effort that the world has seen

Based on the committed orders COVAX has placed with vaccine manufacturers and the additional donations, hundreds of millions of new doses should now be available each month. We need to make sure they reach poorer countries and get into people's arms. To avoid further delays, and for the facility to succeed, we need support from G20 leaders in four key areas.

First, we need doses, and we need them now. The premise of COVAX was always that the facility should be able to negotiate and buy its own doses. With our early vaccine access compromised. donations have played a vital role in maintaining our ability to keep doses flowing to those most in need. Of the 600 million doses pledged to COVAX to date, 100 million have now been delivered. We need more, and soon, with longer shelf lives and greater certainty so that recipient countries have time to plan their rollout. This can be achieved without jeopardising high-income countries' national vaccination efforts.

We also need G20 leaders to support our call for transparency. COVAX has legally binding agreements with manufacturers for more than four billion doses, but has all too often faced delays in accessing them. Without greater clarity regarding firms' order books, it is impossible to know whether these holdups are due to production challenges or preferential treatment for bilateral arrangements. Insisting that manufacturers are transparent about their order timelines can ensure a level playing field where no one - particularly those living in developing countries - gets bumped to the back of the vaccine queue because of another bilateral deal.

In addition to ensuring that manufacturers keep their commitment to COVAX, governments should make global vaccine access their highest priority. Countries

Based on COVAX's latest forthcoming supply forecast, when topped up with doses through bilateral deals, equitable COVID-19 vaccine access can protect up to 60 per cent of the adult population in 91 lower-income countries. This would represent a huge step toward the WHO target of 70 per cent, which is needed to suppress the coronavirus everywhere, and COVAX represents the best opportunity to achieve it.

Panorama

he panorama was invented by an Irishman, Robert Barker, a painter of portraits and miniatures. He was sketching on the summit of Carlton Hill at Edinburgh in 1787 when he thought of the idea of reproducing the view on a large cylindrical painting that would encircle the viewer. After a lot of experimentation, he produced a work painted on paper stuck to canvas. which he took up to London to show to the famous painter Sir Joshua Reynolds, President of the Royal Academy. Sir Joshua said it was impracticable, because of the difficulties of getting the perspective right, and of mounting and lighting such large pictures, but added that he would cheerfully leave his bed at any time of night to inspect such a work of art if it could be made. Robert Barker persisted, and eventually produced a view of London that he exhibited in premises in Castle Street, off Leicester Square. in 1792. True to his word, Sir Joshua left his breakfast-table and walked in his dressing-gown and slippers to Castle Street to inspect it (he liked it). Barker patented his invention, calling it La Nature à coup d'Oeil at first, but he soon renamed it, taking the word from the Greek pan, all, and horama, a view (from horan, to see). The enterprise was a huge hit with the public and Robert Barker made a lot of money from it. Panoramas became very popular in the nineteenth century, sometimes being as much as 300 feet long and 50 feet high; they included some that advanced on rollers to give an illusion of movement. (They seem to have been more common in the US than they were in Britain, where they were often called cycloramas, a term which is first recorded from the 1840s.) These days, the word doesn't so much bring to mind a painting or photograph as the original view that Robert Barker so successfully simulated in his constructions.

increased to 61.7 per cent (provisional) in 2021-22 from 60.5 per cent in the previous year, the external debt recorded an increase of \$11.5 billion over the last year and there was a fall in corporate tax collection. These not so positive macroeconomic indicators convey a message that asset monetisation may become a means only to manage the liquidity problems

Is the value of monetisation real? No one knows. The monetisation has been valued at ₹6 lakh crore. We should remember that this number is just an estimate which may be realised in the form of cash or by way of private sector investment. The actual money to be realised depends on the nature and the duration of the contracts. Moreover, the choice of contracts is determined by the sector, nature of asset, timing of transactions, target investor profile and the level of control to be retained by the asset owner. So, the value of the asset monetisation splashed all around is a mosaic of different estimated values: market value, cost value, book value, enterprise value. With so much uncertainty the reality gets more blurred.

sets identified for monetisation belong to PSUs. These PSUs are listed companies and are not fully owned by the government. So, when the assets are monetised, the cash realised will first go to the respective PSU. The board of directors of those companies has the right to use the money for the benefit of the specific company. The only way that the government may get the proceeds of the monetisation is by forcing the board to declare dividends. We hope the government will not do so and allow the management of those companies to make the best use of

the money collected. Will monetisation improve productivity? Maybe no. The monetisation has been envisaged without transfer of asset ownership. Only the right to use (RTU) will be transferred to the private party for a consideration. The assets will continue to appear on the balance sheet of the respective PSUs and a corresponding value of RTU may appear on the balance sheet of the private party. Not having the ownership of the assets may lead to lesser interest on the maintenance and upkeep of the asset. So, asset monetisation may improve the productiv-

Will asset monetisation lead to private monopoly? Maybe yes. The recent transfer of airports to the Adani group, which is already having a large stake in ports, coal, power, gas and oil, sends some discomforting signals about the impending private monopoly in infrastructure. With the private monopoly in place one cannot rule out the possibility of increasing tariff to expedite recovery of its investment. High tariff may take many services beyond the reach of several consumers. Moreover, in the pursuit of increasing profit, the private operators may reduce costs, which may result in job losses and wage cuts. So, asset monetisation, if not regulated efficiently, may end up in creating private monopoly which may not be in the public interest.

With so many possible good and bad implications, the least that we could expect from the finance ministry is to be more honest in sharing the true intentions of the plan and be professional in making the asset monetisation work for the benefit of the country as a whole.

Kolkata, Sept 4: In a huge relief for West Bengal Chief Minister Mamata Baneriee, the Election Commission Saturday announced holding of byelections to Bhabanipur Assembly seat, which she intends to contest after her defeat in Nandigram, September 30, prompting the ruling TMC to hail the decision and accuse the BJP of trying to derail the process.

We don't know if holding by-elections to one seat and election to two seats is a practical decision since the pandemic is still raging and there is a lurking threat of a third wave,' he told reporters.

Lalthlangliana. in a letter to his Hailakandi (Assam) counterpart Rohan Jha, alleged that Assam Police personnel had, at gun point, kidnapped JCB operator Lalngaisanga Thursday while he was constructing a private road on the request of the 'Jhum' farmers (shifting cultivators).

"The Assam Police went to disrupt their activity, damaged the door of the excavator, and snatched the keys from the JCB operator, who was blindfolded and kidnapped. He was then dragged by the river, his clothes ripped off, and life threatened. His mobile phone along with JCB keys was taken by the Assam Police," the Kolasib DC said in his letter.

Terming it "a very serious issue" and a "huge setback" towards the initiatives for peace until now, he said that it can further aggravate the situation.

Meanwhile, Jha, in his letter to his Kolasib counterpart, sought the dismantling of two camps and a bunker, set up by the Mizoram Police August 26 in reserve forest at Kachurthal-Balicherra area along the border.

'... but there was no action taken



from your end to de-escalate the issue. A new camp and a road were being built by Mizoram Police at the same Kachurthal-Balicherra area within the constitutional boundary of Assam. Such instances of construction and force deployment are in clear violation of the joint statement issued by both the governments on August 5 and are very detrimental in the peace keeping efforts along the inter-state border." he wrote.

Dismissing the claims of his Mizoram counterpart, Jha said that Assam forest staff, along with the Assam Police, went to the Kachurthal-Balicherra area Thursday and noticed that a road was being constructed inside the constitutional boundary of Assam and instructed the JCB driver to stop the construction and immediately return to Mizoram.

BSF arrests B'deshi cop for illegally crossing border

Siliguri, Sept 4: The Border Security Force has apprehended a Bangladeshi policeman after he illegally crossed the India-Bangladesh international border in West Bengal, the BSF said Saturday.

Mohammad Seikh Sohel Rana (46), an inspector with the Dhaka metropolitan police, was nabbed while he was moving suspiciously in Indian territory Friday.

The BSF north Bengal frontier, in a statement, said the policeman crossed over the India-Bangladesh border with the help of a Bangladeshi tout by paying him Bangladeshi Taka 10,000. The north Bengal frontier guards over 932 kms of the total 4,096 kms of the India-Bangladesh border on the country's eastern flank and is headquartered at Kadamtala in West Bengal's Siliguri.

The policeman told the BSF that he started his journey from Dhaka on a bus September 2 and reached Patgram in the bordering Lalmonirhat district of Bangladesh.

He crossed the international border around 12.30 pm Friday, the BSF said. Rana had joined the Dhaka metropolitan police as a sub-inspector in 2003.

"He was placed under suspension along with 21 other police personnel from 2003-2008 and his suspension was revoked in 2008," the BSF said. The inspector, who hails from Gopalganj district of Bangladesh, said he was planning to go to Kathmandu in Nepal. He has been handed over to the local police, the BSF said, adding that four debit cards, foreign currency, two smart phones with SIM cards and other items were seized from him.

Guwahati, Sept 4: The Assam government will soon amend its sports policy to reserve a certain percentage of jobs for athletes, Chief Minister Himanta Biswa Sarma said Friday.

Besides providing jobs, pension and one-time financial grants to the medal winners at different levels, the government has also made its 'highest-ever allocation' for sports infrastructure development this fiscal, he maintained.

Speaking at a function here, Sarma said, "If we want to encourage more youngsters to take up sports, we have to provide them with jobs too. We will amend the existing sports policy in the state and have a definite percentage of government jobs reserved under the sports quota.'

The current policy had come into effect January 1, 2018, for a period of five years, when the first BJP-led state government under Sarbananda Sonowal was in power. The chief minister further said and Lakhimpur districts.

The CM also pointed out that stadiums were being built in as many as 52 remote locations across the state, and 40 more places will be added to that list this year.

"We will try to introduce coaching facilities next ... We shall encourage every stadium to take up at least one discipline and the government will pay the salary for two to three coaches in each place," he said.

The chief minister, who doled out pension to National Games. Asian Games, Commonwealth Games and Olympics medal winners - none of them government employees -- at the function, said the government will provide such one-time help to players in the future too. Besides sports pension to 99 medal winners this year, onetime assistance of ₹50,000 each was given to 153 players who are in 'government engagement,' the CM noted.

Under the sports policy of the state, appointment letters as inspectors in the excise department were handed over to 2014 World Cup silver medallist archer Sanjay Boro and 2019 Women World Boxing Championship bronze winner Jamuna Bora by the chief minister. He added that sports organisers of the state will also be given their due respect, though sports pension were only meant for the players. Wishing Bhogeshwar Baruah, the state's first Arjuna awardee and Asian Games gold medallist, on his birthday on Friday, Sarma said the success that he hadachieved in the sixties inspires sportspersons to this day.

Wellington, Sept 4: New Zealand Prime Minister Jacinda Ardern vowed Saturday to tighten counterterrorism laws this month after a knife-wielding militant known to the authorities stabbed and wounded seven people in a supermarket.

Police shot dead the 32-year-old attacker, a Sri Lankan national who had been convicted and imprisoned for about three years before being released in July, moments after he launched his stabbing spree Friday.

Ardern said earlier the man was inspired by the Islamic State militant group and was being monitored constantly but could not be kept in prison by law any longer.

I am committing, that as soon as Parliament resumes, we will complete that work - that means working to pass the law as soon as possible, and no later than by the end of this month, Ardern told a news conference.

The Counter Terror Legislation Bill criminalises planning and preparation that might lead to terror attack, closing what critics have said has been a loophole allowing plotters to stay free.

But Ardern said it would not be fair to assume that the tighter law would have made a difference in this case.

This was a highly motivated individual who used a supermarket visit as a shield for an attack. That is an incredibly tough set of circumstances, she said.

Ardern said the attacker came to the attention of the police in 2016 because of his support for a violent ideology inspired by Islamic State.

Flipkart co-founder challenges ED probe

New Delhi, Sept 4: Sachin Bansal, co-founder of e-commerce giant Flipkart, has mounted a court challenge against India's financial crime-fighting agency, which has accused him and others of violation of foreign investment laws. court records showed.

The agency, the Enforcement Directorate, had in July issued a socalled show cause notice to Flipkart, its founders and some investors asking them to explain why they should not face a penalty of \$1.35 billion for alleged violation of foreign investment laws between 2009 and 2015, Reuters reported last month.



Court records and media reports Saturday showed Sachin Bansal has urged a state court in the southern state of Tamil Nadu to quash the agency's notice, arguing that it was issued after an inordinate delay.

The judge in the case, R Mahadevan, heard the matter Friday and asked the Enforcement Agency to file a response, reports said.

Sachin Bansal, the Enforcement Directorate and Flipkart did not immediately respond to requests for comment. Flipkart has previously said it was "in compliance with Indian laws and regulations" and would cooperate with authorities.

The Enforcement Directorate has been investigating e-commerce giants Flipkart and Amazon.com Inc for years for allegedly bypassing foreign investment laws that strictly regulate multi-brand retail and restrict such companies to operating a marketplace for sellers. Walmart took a majority stake in Flipkart for \$16 billion in 2018, its biggest deal ever.

Last week, the apex court had ordered to demolish the twin 40storey towers, which are part of the Supertech's Emerald Court project in Noida, Uttar Pradesh.

'While we respect the Hon'ble Supreme Court order, we have decided to re-present the matter before the Hon'ble Supreme Court in a review application as the towers were constructed as per the approval of the competent authority conforming to the Building bye-laws," Supertech Chairman RK Arora said.

He said in a statement that the Apex and Ceyane towers are not linked to or part of any ongoing project of the company.

Supertech group is developing 10 crore sq ft across its projects, while Apex and Ceyane towers only constitute a mere 6 lakh sq.Ft which is 0.6 per cent of the total portfolio, he added.



"While we have already refunded most of the customers in this project after the Hon'ble High Court, Allahabad decision passed in 2014 - we will further comply with the Hon'ble Supreme Court directions as per the order passed," Arora said.

Supertech's chairman exuded confidence that the order will not have any adverse impact on the company as every project has its own independent RERA Account and cost centre.

"Supertech is a financially stable and strong group. Work is going on at all our project sites as scheduled. "We would like to reassure all our

customers, bankers, vendors and other stake-holders that we will deliver all our projects in the scheduled time frame," Arora said.

The 31-year-old Sarkar, whose right leg was affected after he contracted polio at age one, displayed great resilience during his 22-20, 21-13 win over Fujihara. Sarkar had lost his semifinals against second seeded Bethell, going down 8-21, 10-21. But he re-

Record-breaker Manish bags gold

Shooting medal rush continues as silver winner Adana completes one-two with Manish on podium

Tokyo, Sept 4: Shooter Manish Narwal smashed the Paralympic record to clinch India's third gold in the ongoing Tokyo Games, while compatriot Singhraj Adana bagged the silver to make it a sensational one-two finish for the country here Saturday.

The 19-year-old Narwal, who holds the world record in the category, shot a total of 218.2, a Paralympic record, to claim the yellow metal in P4 Mixed 50m Pistol SH1 event in his debut Games.

Narwal had a keen interest in sports from childhood and grew up wanting to become a football player. Unfortunately, he could not fulfill his footballing dreams due to a congenital ailment in his right hand

His wrestler father Dilbagh tried doing anything to make sure that his son's deformity did not hold him back.

In 2016, on the suggestion of a family friend, Dilbagh took Narwal to a nearby shooting range at Ballabhgarh run by coach Rakesh Thakur. That changed Narwal's life and he instantly developed a keen interest in the sport and started doing practice regularly. But at that time he did not know

about Paralympic Games and he was practising and competing with other athletes for fun.

His talent was spotted by coach Jai Prakash Nautiyal and Narwal won an individual gold in P1 Air Pistol SH1 event in the 2017 Bangkok World Cup. Before that, he won gold medal in P1 and silver in P4 in 2018 Asian Para Games in Jakarta.

LEKHARA TO BE INDIA'S FLAG BEARER

TOKYO: Shooter Avani Lekhara will be the flag bearer of country's contingent during the closing ceremony of the Tokyo Paralympics, here Sunday. The 19-year-old trailblazer Lekhara had won a gold in R-2 women's 10m Air Rifle Standing SH1 event on Monday before claiming the 50m Rifle 3 Position SH1 bronze Friday. "Avani will be the flag bearer and there will be 11 participants from the Indian contingent during the closing ceremony," an official of the Paralympic Committee of India (PCI) said. Lekhara, who was paralysed below the waist after a car accident in 2012, is only the Indian to win multiple medals in a single edition of the Games. Before Lekhara, Joginder Singh Sodhi whad won a silver and two bronze medals in the 1984 Paralympics.

With his feat, Adana, who competes with polio-impaired lower limbs, joins the elite list of Indians who have won multiple medals in

the same edition of the Games. Shooter Avani Lekhara, who won a gold and bronze in the ongoing Games and Joginder Singh Sodhi, who fetched one silver and two bronze medals in the 1984 Paralympics, are the other two Indians who have achieved the feat.

Narwal has also won gold medal with world record in P4 and silver in P4 team event in 2021 Para Shooting World Cup in the UAE. He also won three bronze medals in P1 and P4 (individual and team) in

2019 Sydney Para Shooting World Championships.

His other achievements include gold in P1, P4 and P6 team events and silver in P1 in 2019 Osijek World Cup in Croatia.

Indian shooters have claimed a haul of five medals, including two gold, in the ongoing Games.

As the pistol is held with one hand only, athletes in SH1 category have an impairment affecting one arm and/or the legs, for example resulting from amputations or spinal cord injuries.

P4 is a classification for the mixed 50m air pistol competition. Some shooters compete in a seated position, while others take aim in a standing position as defined in the rules

Teen Alcaraz upends Tsitsipas Splendid Rohit century propels India

New York, Sept 4: Until now, 18 year-old Carlos Alcaraz has exhibited enough promise and precociousness to make people think he eventually could succeed Rafael Nadal as Spain's top tennis player.

Friday at the US Open, with a dramatic five-set victory over No.3 seed Stefanos Tsitsipas, Alcaraz showed why he's been getting so much attention already.

With a tenacity to match his talent, and boosted by a rowdy Arthur Ashe Stadium crowd a tad tired of Tsitsipas' penchant for taking lengthy breaks between sets, Alcaraz won 6-3, 4-6, 7-6(7-2), 0-6, 7-6(7-5) in just over four hours to become the youngest man in the fourth round at Flushing Meadows since a couple of guys named Pete Sampras and Michael Chang in 1989.

He made sure during his oncourt interview at Arthur Ashe Stadium to thank the fans, who are making up for last year's absence — no spectators were allowed because of the coronavirus pandemic then, but it's full capacity now — with plenty of noise.

They chanted "Let's go, Carlos!" They rose to their feet for ovations at various points, including right before the concluding tiebreaker, with



Alcaraz waving his arms to request, and receive, even more support. At night in Ashe, four-time major

champion Naomi Osaka was scheduled to face 18-year-old Canadian Leylah Fernandez.

In earlier action, three women Garbiñe Muguruza, Simona Halep and Angelique Kerber — pulled out three-set victories to advance.

Muguruza got past Victoria Azarenka, a three-time US Open runner-up including a year ago, 6-4, 3-6, 6-2 and next faces French Open champion Barbora Krejcikova. Kerber defeated 2017

champ Sloane Stephens 5-7, 6-2, 6-3. And Halep was a 7-6(13-11), 4-6, 6-3 winner over Elena Rybakina.

Alcaraz was the voungest man to make two third-round runs at a major since Novak Djokovic in 2005. And the youngest to win at least one match at each Slam in a vear since 1989, when that was done by Goran Ivanisevic, the 2001 Wimbledon champion who now is

one of Djokovic's coaches. Now add this: Alcaraz is the youngest man to beat a top-three player at a Grand Slam tournament since the ATP computerized rankings started in 1973.

Rohit Sharma (127, 256b, 14x4, 1x6) showed exceptionally steely temperament to score the eighth and most significant century of his Test career that propelled India to a fighting position with an overall lead of 171 runs after third day's play in the fourth Test against England here Saturday. The Test may not go the distance but what one can surely guarantee is an engrossing fourth day. Any target in excess of 225 and closer to 250 will be challenging on this track and especially with a batting line-up where Joe Root is the only consistent performer.

One of the more elegant among modern day batsmen, Rohit during the series curbed all his ego to present a solid defence but brought his 'Hit-Man' instincts to the fore with a straight six off Moeen Ali.

It took eight years and 43 Test matches to get an overseas hundred and that too in England in tough conditions.

Earlier, there was a lot of restraint at the start when KL Rahul (46, 101b, 6x4, 1x6) was attacking the bowlers before James Anderson (1/49) got rid of the Karnataka man.
