Kerala boy dies due to Nipah virus

KOZHIKODE: A 12-year-old boy died due to Nipah virus infection at a hospital here, state Health Minister Veena George said Sunday. The samples of the boy, which were sent to the Pune National Institute of Virology, confirmed the presence of Nipah virus. "Unfortunately, the boy passed away at 5 am. The condition of the child was critical Saturday night," the minister told the media. Meanwhile, two more people in the state have been identified with symptoms of Nipah virus infection.

4 soldiers killed in Pak suicide attack

KARACHI: A suicide bomber of the outlawed Tehreek-e-Taliban Pakistan blew himself up in the country's restive Balochistan province Sunday, killing at least four security personnel and injuring 20 people, according to officials. The attack targeted a Frontier Corps (FC) checkpost on the Mastung road in Quetta, the provincial capital, Deputy Inspector General of Quetta police Azhar Akram said. The four personnel who were killed in the blast and majority of the injured belong to the FC, which is in forefront of the efforts to tackle militancy in the province. P10

He said over 5,000 'langars' (food stalls), including some mobile stalls, have been set up for the participants. The farmers, including women

carrying flags of different organisations and wearing different coloured caps, were seen arriving at the venue in buses, cars and tractors. One of the participants blew a

'ransingha' (trumpet), the photograph of which was posted by the Kisan Ekta Morcha on Twitter. "In old times, when the fight

was for honour and respect, this instrument (ransingha) was used. Today, a call has been given for war by all 'kisan majdoor' unions against the BJP's 'corporate raj'," it tweeted in Hindi

BATTLE FOR PANJSHIR Afghan resistance leader seeks talks with Taliban

Kabul, Sept 5: The leader of the Afghan opposition group resisting Taliban forces in the Panjshir valley north of Kabul said Sunday he welcomed proposals from religious scholars for a negotiated settlement to end the fighting.

Ahmad Massoud, head of the National Resistance Front of Afghanistan (NRFA), made the announcement on the group's Facebook page. Earlier, Taliban forces said they had fought their way into the provincial capital of Panjshir after securing the surrounding districts

"The NRF in principle agree to solve the current problems and put an immediate end to the fighting and continue negotiations,' Massoud said in the Facebook post.

"To reach a lasting peace, the NRF is ready to stop fighting on condition that Taliban also stop their attacks and military movements on Panjshir and Andarab," he said.

A large gathering of all sides with the Ulema council of religious scholars could then be held, he said

Odisha scripting golden history in sports

Bhubaneswar, Sept 5: Today, if someone talks about sports, especially hockey in India, perhaps s/he will not forget to mention Odisha because the eastern state of the country has been emerging as a sports hub. In fact, people have started calling Bhubaneswar the sports capital of India.

A decade ago, Barabati Stadium-the main cricketing centre in Odisha where a few international matches have been hosted—was the only sports venue recognised by people outside the state. Not to forget some hockey players of vestervears who kept coming from remote areas of the state, making a name for themselves on the international stage. Although Kalinga Stadium was

there in Bhubaneswar, people were not aware of it as the platform was confined to the training of local athletes. But, now, the stadium has become a centre of excellence for sports personalities in India.

The state government has substantially increased its funding for sports. Odisha had allocated nearly ₹100 crore in its annual Budget for 2016-17, which was increased to ₹301 crore in 2020-21. This year (2021-22), ₹400 crore has been allocated to sports.

Chief Minister Naveen Patnaik had rightly said, "Investment in sports is an investment in youth. Investment in youth is an investment in the future.

The growth of Odisha as a sports hub or sports capital did not happen overnight, but a strong effort was made over a period of 7-8 years

The state government, under the leadership of CM Naveen Patnaik, has been giving priority to the sports since 2013, when the state had franchised its own hockey team, Kalinga Lancers, for the Hockey India League. At that time, the state felt the necessity to have a world-class hockey facility in order to host the Kalinga Lancers matches in the Hockey India

League. In 2014, Bhubaneswar conducted the Hockey Champions Trophy. In 2015, the Indo-Japan Hockey series was organised in Bhubaneswar. Later in 2017, the final of FIH Hockey World League was also conducted

Just three months before the Athletics 22nd Asian Championships, the Jharkhand government had withdrawn its assurance to host the event. It was Odisha which came forward and successfully organised the mega sporting event, taking it as a 90-day challenge. The state has earned praise from various quarters for

making the event successful. Similarly, in 2018, when Sahara backed out of sponsoring the Indian hockey teams, it was the Odisha government that announced it would sponsor both the men's and women's teams for a period of five year. Recently, the state has announced to sponsors both the teams for another 10 years.

In 2018, the Odisha government announced the setting up of 11 High-Performance Centres (HPCs) in 10 sports disciplines with an aim to develop elite athletes and

strengthen the sporting landscape in the state. Odisha has become the only state in India to set up HPC hub. The state has also set up 16 sports hostels in 15 districts, and each of them runs training and coaching programmes in multiple sports cur-

riculum for around 1,250 budding talent. Speaking about sports infrastructure projects being taken up by the state, Sports and Youth Services Minister Tusharkanti Behera said that Bhubaneswar already has the iconic Kalinga Hockey Stadium with about 15,000 seating

capacity, while the Birsa Munda International Hockey Stadium at Rourkela in Sundargarh is being developed at an estimated cost of ₹112 crore over 15 acres The Men's Hockey World Cup

2023 will be hosted in both Bhubaneswar and Rourkela. The government is also setting up another 20 hockey training centres at different places at a cost of ₹200 crore, Behera pointed out.

Recently, the Odisha Cabinet has

approved the construction of 89 multi-purpose indoor stadiums at a total project cost of ₹693.35 crore to be completed over the next 18 months, the minister further said.

The department has been holding state-level training camps for under-18 athletes for Khelo India Youth Games and National Championships

Sprinter Dutee Chand hailed the state government for extending support to sports and sportspersons as well. "Recently, the state has decided to set up indoor stadiums in the urban areas. It will encourage youths towards sports. The HPCs will also help budding athletes recover quickly from injuries," Dutee said

Former hockey Olympian Lazarus Barla said, "The state has taken a lot of steps for the development of the various sport. The move to set up an international hockey stadium and training centres in 17 blocks of Sundargarh will give a boost to hockey in Odisha.'

He suggested that the state needs to give some more emphasis to promoting sports at the school level to produce international-standard athletes in the near future. Odisha Hockey Promotion Council chairman Dilip Tirkey said that the state has come a long way when it comes to hockey.

"The state has been sponsoring hockey teams since 2018. Now, the government is also giving emphasis to other sports for which indoor stadiums are being constructed across the state," Tirkey stated.

Army veterans on a mission to rejuvenate River Ganga

New Delhi, Sept 5: In a rare display of undiminished passion to rejuvenate River Ganga, a group of army veterans held a 190-day long Atulya Ganga Parikrama to study the various reasons behind pollution in the great river.

The military veterans held a 5,530-km walkathon under their Atulya Ganga initiative for rejuvenation of the river. The walkathon was flagged off by Uttar Pradesh Governor Anandiben Patel December 16, last year at Prayagraj and was successfully accomplished June 23 this year.

Thousands of people from various walks of life participated in the walkathon and the message of urgency towards Ganga reached over 5 million strong masses.

Col Manoj Keshwar, co-founder of Atulya Ganga Trust, said a team led by Maj Gen Bhatt geotagged the sources of pollution in the river during the walkathon and a Ganga health dashboard is being prepared to help fix location and accountability for the pollution.



BJP smells a rat over CCTV installation at police stations

Bhubaneswar, Sept 5: The Bharatiya Janata Party (BJP) Sunday attacked the state government alleging massive irregularities in the installation of closed-circuit television (CCTV) cameras in police stations across Odisha.

The saffron party claimed that the Centre has been funding the ambitious project to install CCTV cameras in police stations as it would ensure transparency. Odisha Computer Application Centre (OCAC), the nodal agency for execution of the project in the state, has procured CCTVs at exorbitant prices.

Highlighting the alleged irregularities in execution of the project, state BJP spokesperson Thakur Ranjit Das said, "Instead of appointing candidates with Information Technology background as the project consultant, the BJD government chose those who have studied BSc (Chemistry). They are not IT experts." This raises questions regarding the transparency of the project being funded by the Union government, he added.

Das further said that CCTV units, which could have been easily bought for ₹6 lakh each in Odisha market, were procured at ₹15 lakh

He alleged that the state government has no care for ensuring transparency at police stations. "The government has awarded the project to those who are from outside the state and their service centres are also operating outside Odisha," Das pointed out.

The party sought cancellation of the tender and proper enquiry into the matter.

Bhubaneswar; Sept 5: The Orissa Environmental Society (OES) organised a webinar Sunday on Similipal - The Pride of Our Natural Heritage'. President of **OES Sundara Naravan Patro, OES** Secretary Jaya Krushna Panigrahi and chief guest M Yogajayanand, Field Director of Similipal Tiger Reserve and Regional Chief Conservator of Forests (RCCF). Baripada discussed the importance of forests in the state as well as issues involving Similipal.

Experts attending the webinar gave a detailed account of the Similipal forest's significance to the state. The forest, located in Mayurbhanj district, is a splendid gift of nature and is considered a treasure house of biodiversity including flagship flora and fauna like tiger, elephant, sal and varied medicinal plants and orchids. For its distinction as a natural heritage of immense significance and for its unique features, it earned the



status of the only biosphere reserve of the state in 1994.

However, the biosphere reserve is going through increasing stress caused by increase in population, over-dependence on its resources, poaching of wildlife, and ecosystem degrading activities by people with vested interests. The forest fires

Shortage of doctors has become acute at Baliguda sub-divisional hospital and the district headquarters hospital. Various organisations have decried the policy of deputation while healthcare has been in mess. In some cases, doctors are appointed, but they do not join the work. Paediatrician Dr Sumit Kumar joined the district headquarters hospital July 5. However, he was sent on deputation to VIM-SAR two days later. His post has been lying vacant since.

The stage is set for yet another unseemly duel between the judiciary and the executive over the appointment of judges in different high courts. For quite some time, a ping pong game is being played by the two constitutional bodies as the government at the Centre is trying to assert its authority over the judiciary and the latter is jealously guarding its independence as guaranteed by the separation of powers enshrined in the Constitution. This time, the confrontation centres around the appointment of 12 candidates, including three judicial officers, to five High Courts the decision about whom the Supreme Court Collegium, headed by the Chief Justice of India NV Ramana, iterated September 3 despite objections from the government. The Collegium's recommendations for the second time were published on the Supreme Court website as well. In fact, the Collegium recommended 68 candidates for a total of 12 High Courts last week. Significantly, the CJI at a programme September 4 expressed the hope that the Centre would give its nod to the recommendations as it had done in the recent case of nine judges who took oath simultaneously. This has prompted Justice BR Gavai of the Supreme Court to compare the CJI with ace batsman Sachin Tendulkar on the ground that since he took over as CJI, he has been "like Tendulkar" breaking one record after another. The judge was effusive in placing on record that the appointment of nine judges for the apex court took place August 31 for the first time in the country. Responding to the compliment, the CJI said it could happen because of a "team effort" and named his brother judges in the Collegium for being "active and constructive partners" in this endeavour. As a result, the number of vacancies in the apex court could be reduced to just one.

According to the Memorandum of Procedure, once iterated by the Collegium, the Centre is bound to make the appointment, even though the Centre can just sit on the recommendations indefinitely. This is why the CJI has said he hopes the names will be cleared. He went a few steps ahead and praised the Law Minister, Kirren Rijijju as being very efficient at his work and he would process the names quickly. The appointment of the 12 candidates has already been hanging fire for quite some time.

It could not be a coincidence that one of the candidates against whom the Centre has raised its objection is the son of a retired judge of the Calcutta High Court who, in his verdict, had ruled out conspiracy in the Godhra train fire in which kar sevaks were killed triggering the Gujarat riots during the tenure of Narendra Modi as Chief Minister. Another candidate against whom the Centre has expressed its reservations is the son of a former High Court judge who currently heads the human rights commission of a non-BJP ruled state. Ironically, the Centre promptly cleared a recommendation made in January 2019 for an Additional Solicitor General who became a permanent judge this week. The suspicion that the Centre's objections stems from political prejudices seems strengthened due to such surmises.

The CJI has also made an observation that is likely to exacerbate the friction between the executive and the judiciary. He has rightly pointed out the "problem" that "everything in this country is shown with a communal angle by a section of the media." The CJI-led bench was hearing a batch of petitions seeking action against news channels for their coloured coverage of the Tablighi Jamaat meeting at the Nizamuddin Markaz last year. The congregation was castigated by the social media and an impression was sought to be created as if the Centre was handling the COVID-19 pandemic efficiently, but the congregation by the minorities acted like a super-spreader. The Centre responded with an iron hand putting many of the organisers and delegates from abroad behind the bars till they were later cleared by the courts for having played no role in the spread of the disease.

However, the corrective measure that the CJI-led bench has urged the Centre to take to rein in biased and highly detrimental coverage by the audio-visual media may prove counterproductive. The Centre is likely to use the opportunity to strengthen its case to impose curbs on the independence of the Press. Predictably, Solicitor General Tushar Mehta, who speaks for the Centre, referred, as solution, to the controversial Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules, 2021, that have been challenged.

There is no doubt that a section of the electronic media, mostly TV channels that sensationalised the Tablighi Jamaat congregation are known apologists of the Centre. While their propensity to work as government propagandists needs to be checked, it would be wrong to allow the Centre to use it as a pretext to curb constitutionally guaranteed fundamental right to freedom of speech and expression. The Centre's defence of the new IT Rules that seek to blur the difference between freedom of the Press and the rights of the audience "who believe and act upon misleading news," is only spurious. In a democracy, the freedom of the Press is inextricably linked with the people's right to know.

The European Union should begin the process of expelling Hungary, and it should then consider doing the same with Poland. Over the past decade, Hungary

and Poland have consistently undermined the rule of law and democratic institutions, which are supposed to be at the core of the European project. Hungarian Prime Minister Viktor Orbán's self-styled "illiberal democracy" is a misnomer: there is no longer any democracy to speak of. Courts are increasingly under the control of Orbán's Fidesz party; the media have little freedom left: civil-society organisations operate under constant threat; and universities have already been stripped of what little autonomy they had. In Poland, meanwhile, the sim-

ilarly authoritarian ruling party, Law and Justice (PiS), has openly followed in Orbán's footsteps. Though it has not yet cowed civil society and the opposition to the same degree, it is steadily undermining the country's democratic institutions

From the EU's perspective, the two countries' refusals to participate in a new European Public Prosecutor's Office should be the last straw. Launched in June, the EPPO has a mandate to investigate and prosecute fraud, embezzlement, and other crimes involving EU funds. Not surprisingly, there is ample evidence implicating both Fidesz and PiS in such abuses. By refusing to recognise the EPPO's authority even as they continue to receive EU funds, Hungary and Poland are making a mockery of the European project and everything it stands for.

Moreover, there is now yet another argument for the EU to act against Hungary and Poland. With the Taliban's reconquest of Afghanistan, there is no longer any doubt that the Western effort to establish democracy and the rule of law by force and foreign aid has failed. From now on, Western countries will have to lead by ex-

In Germany, many major cities - including Hamburg, Cologne, Düsseldorf, Dresden, and Berlin laid in ruins after Allied bombing raids. As many as 20 million Germans were homeless, and 10 per cent of the country's prewar population was dead. The rest of Europe was hardly much better. Occupied France, Belgium, and the Netherlands faced long recoveries after being savagely pillaged by the Nazis.

On top of it all, historic animosities - especially against Germany – were at an all-time high. Many assumed that communism or conservative dictatorships were more likely than democracy to take hold. Peace was viewed as tenuous at best.

But, as we now know, peace prevailed and democracy took root and blossomed in all of Western Europe, except Spain and Portugal (which remained under their own quasi-fascist dictatorships until later decades). Economically, the situation improved almost unbelievably; the three decades following the war came to be known

as les trente glorieuses – the glo rious 30 years.

More recently, the EU's expansion to Central and Eastern Europe was initially a success, too. It is difficult to imagine that Hungary, Czechoslovakia, Poland, and the Baltic countries could have undergone so rapid a democratic transition without the prospect of EU accession and funding. And it is equally unlikely that Poland would have emerged as one of the world's fastest-growing economies without the EU.

But the eastward expansion now looks like Europe's Achilles' heel. Hungary and Poland have come to symbolise the EU's dysfunction and institutional weaknesses.

To be sure, expelling Hungary, and credibly threatening Poland with the same fate, is a serious decision that should not be made hastily. Any member state can elect a government that might try to weaken democratic institutions (as Italy did with Silvio Berlusconi. and as Britain has done with Boris Johnson). Generally, the best way to deal with would-be authoritarians is to allow democratic institutions to do their jobs and trust voters to remove dangerous politicians.

But Hungary has become the exception that nullifies the rule. After more than a decade under Orbán's Fidesz Party, its democracy appears to have been fatally wounded, raising doubts that voters could ever remove the current regime.

The longer the EU continues to treat Hungary like a normal democracy, the more damage it will do to its own brand. It should start the process of changing its rules, so that it can take action against Hungary and Poland, even if these countries try to use their veto power. It should then invoke Article Seven of the Treaty on European Union to suspend Hungary's voting rights, and then stop the delivery of EU funds to the country while it works out the best way of terminating its membership. Barring some miraculous last moment return to democracy, Hungary must go in order for the

Pantechnicon

A word mainly in British usage for a furniture removal van, it's a compound of two classical Greek words: pan, "all", and tekhnikon, "artistic; belonging to the arts", hence "a place for all the arts". It was invented in 1830 as the name for a bazaar, a kind of early craft shop, which opened in that year in Motcomb Street in the Belgravia area of London. There was a fashion for terms in pan- at that period, such as panopticon, Jeremy Bentham's name for a circular prison of his invention, which was later used as the name of a London showroom for novelties. Panorama was invented by the Irishman Robert Barker. All three may have been influenced by Milton's Pandemonium as a name for Hell in Paradise Lost. literally "the abode of all the demons". Alas, the scholarship of the Pantechnicon's proprietor was not matched by his business acumen. The enterprise soon closed and the building, constructed to be fireproof, was turned into a furniture repository. The vehicles that transported furniture to and from it were dubbed pantechnicon vans, inevitably shortened to pantechnicons. The name has easily outlasted the building, which, despite its reputation, burnt down in 1874.

INDIVIDUAL **DECISIONS ABOUT** WHETHER OR NOT **TO MARRY AND WHOM TO MARRY ARE OUTSIDE THE STATE'S JURISDICTION**

he Chief Justice of India in a recent lecture observed that "law can be used not only to render justice, it can also be used to justify oppression." He went on to say that a Rule passed by Parliament can be classified as 'Law' only if it embraces the principle of justice and equity. A 'Just Law' would have higher legitimacy and acceptance than an 'Unjust Law' even if the latter elicits the adherence of some segments of society to the detriment of others.

It is in this context that the recent order of the Gujarat High Court staying the implementation of the Gujarat Freedom of Religion (Amendment) Act, 2021 (Hereinafter, Amending Act) amending the Gujarat Freedom of Religion Act. 2003 (Hereinafter, Act 2003) has to be understood. Section 3 of the Act 2003 outlawed the use of coercion, allurement, or fraudulent means to convert an individual from one religion to another. The Amending Act amended Section 3 of Act 2003 to provide that even conversion by marriage would be considered as an act of forceful conversion.

When the said Amending Act was challenged in the Gujarat High Court by a religious organisation named Jamiat Ulama-e-Hind, the Court observed that a plain reading of Section 3 of Act 2003 post amendment would suggest that a "marriage itself and a consequential conversion is deemed as an unlawful conversion." Hence, the Court held that merely because a conversion takes place post marriage, it cannot be termed as an unlawful or forceful conversion. It also infringes upon the right to choice as provided under Article 21 of the Constitution

The Court relied upon the case of Shafin Jahan v. Ashokan (Hadiya case). The facts of the case were that Hadiya was the daughter of Ashokan. She left her hometown in Kerala to study Homoeopathy at Salem, Tamil Nadu. One day, the family noticed that she was unwilling to participate in Hindu rituals. One month later, her father received information that she has started attending classes in 'purdah'. Later, it was also found that Hadiva had married Shafin Jahan and was planning to travel to the Middle East. The dispute finally went to the Supreme Court where the basic question that arose was whether the father's right to protect the interest of his daughter would prevail

over the adult daughter's own right to choice?

The Court interacted with Hadiva and found her to be devoid of any mental incapacity or vulnerability. It gave a lot of importance to the fact that Hadiya was a major and was capable of deciding her future. The Court observed that social values and morals are important but they cannot override the constitutionally guaranteed freedom to marry a person of one's choice as provided under Article 21 of the Constitution. The government may regulate the conditions of valid marriage or procedure to annul a marriage. However, neither the government nor the society has any power to determine the partner of an individual or the person one loves. Social approval is not required to recognise intimate personal decisions. Hence, the Court finally observed that the marriage between Hadiya and Shafin stands valid and neither her father nor the State can be allowed to interfere in their personal choice

The Lata Singh v. State of UP is another relevant judgement. In this case, the Supreme Court went on to clearly observe that once an individual becomes a major, he/she

can marry according to his/her likes. If parents do not approve. the most they can do is to cut off social relations with their children. They cannot threaten or commit violence against the couple.

The Gujarat High Court order although not final and binding comes as a solace to interfaith couples living in fear. The Court has rightly stood up as the custodian of the citizens' rights. The Amending Act is against numerous Supreme Court judgements and legitimises an unjust rule as described by the Chief Justice of India. It creates a scenario where the "legislator becomes the transgressor.'

Our Constitution's strength stems from its recognition of our culture's multiplicity and diversity. Individual decisions about whether or not to marry and whom to marry are outside the State's jurisdiction. The intervention by the State in such issues has a significant chilling impact on the exercise of liberties and freedom of choice guaranteed by the Constitution. Let's not allow fear to silence freedom.

Wear seatbelts

Sir, The horrific car crash in Bangalore killing seven on the spot has rekindled the importance of wearing seatbelts. Almost all modern cars come with inbuilt safety mechanisms. Plenty of them have special features that contribute to life saving processes. Still, cities are witnessing gory accidents claiming precious lives. Three point seatbelts are popular though more refined belts are available. Secondary impact is minimised and passenger positioning is largely maintained with their use. When a car stops suddenly due to an external impact and suddenly loses momentum. the passengers still tend to move unless there is a system to prevent them from moving, and the seat belt comes handy. What the seatbelt does is to increase the time of the forward falling process of a passenger thereby drastically lessening possibilities of grievous injury that may have occurred by collision of the body in the car with steering wheel, dashboard or other parts without the preventive action of the seatbelt. Generally, shoulder, abdomen and hips are protected due to this. Another important protective device is the airbag. This is, of course, a luxury of a few select cars where immediately after a crash when the car stops, air bags are inflated as a result of seatbelt sensors cushioning the body parts to a great extent. The signal passed from the seatbelt sensors result in the formation of nitrogen gas -- this inflates the airbag. Rear seatbelts can minimise injury by about 75 per cent and death by approximately 25 per cent. The problem lies in the blatant disregard of rules by passengers. Although drivers wearing seatbelts are not uncommon, the same cannot be said of other occupants of the vehicle.

A tender was then floated for the project. However, two years passed by without any further development. Now contractors are not keen to take up the job as cost of the materials has gone up in these few years. A new estimate for the project was worked out and a fresh tender was floated.

However, till date, the project has not got environmental clearance. A total of 407 trawlers and 200 motorised boats are engaged in the Balaramgadi area. Owing to the absence of a jetty or a harbour, most of the vessels prefer to trade the catch at Digha in West Bengal and not at fishing centres in Balasore

Badal Das, president of Matsyajibi Sangh said, "There is an urgent need of a harbour. Fishermen face a lot of difficulties due to its absence. They have

to go to Digha for trading. As a result, the government incurs huge revenue losses.

As the fishing habrour is getting delayed, there is a plan to construct a pucca pindi at a cost of Rs 1 crore

The Collector will send the proposal to the Odisha government. After the government sanctions funds for the pindi, the fishermen will not have to go to Digha to sell fishes.

For the Balaramgadi project, 55.01 acres of land had been allotted to the fisheries department August 14 and an estimated budget of Rs 48 crore has been earmarked for it. Former MP Rabindra Jena said that the state government has laid stress on the development of the proposed fishing harbour. After environmental clearance, it will be set up, he added.

District Fisheries officer Pradip Ghose said that the land for the fishing harbour has been identified while DPR is being prepared. A fish sale centre at a cost of Rs 1 crore will be set up, he informed.

The new app will help the fishermen know where fish can be available and on the climatic conditions. The information on movement of fishing shoals is updated once every 24 hours while the app also lets you identify danger zones like coral reefs and sunken ship wreckages

Other details like wind speed and wave height are updated once every six hours

Fishermen say that the app has helped them tremendously by increasing the catch and sales, thereby income.

The fishermen can download the application in their mobile phones and know their geo-coordinates to keep away from notified fishing ban area of Bhitarkanika Wildlife sanctuary, Devi, Dhamara and Rushikulya river mouths designated for Olive Ridley conservation.

The new app will help them know about potential fishing zones, state of the ocean and weather forecast, global positioning system, danger zone alerts, disaster alerts and market realities, emergency contact number and international border lines

Moreover, services such as news alerts, information on government schemes and subsidies, training programmes, latest information on technological innovations etc. are provided to the fishermen on a regular basis, allowing them access to a range of knowledge services.

Nipah adds to Kerala's Covid worries

Thiruvananthapuram/Kozhi kode, Sept 5: As Kerala reeled under a daily increase of nearly 30,000 cases of COVID-19, the deadly Nipah virus has come as another thorn in its side, prompting the state to further heighten the alertness of its health machinery to prevent an outbreak of a different infection.

The southern state, which already saw a localised outbreak of 63 cases of Zika virus in July that were mostly confined to Thiruvananthapuram, however, need not be concerned about the spread of Nipah infection as preventive measures like use of masks and PPE kits -- are already in place due to COVID-19 and intensive contact tracing was going on, state health minister Veena George said n Sunday.

Meanwhile, the central government has rushed a team from the National Centre for Disease Control (NCDC) to provide support to the state, where a 12 yearold boy died due to Nipah Sunday and two others displayed symptoms of the virus infection.

However, experts, like Dr Amar Fettle, Dr TS Anish and Dr TN Suresh, told PTI that there was less cause for concern at present as the state has already dealt with the Nipah virus twice in the past - when it reared its head in 2018 and 2019 -- and the risk of transmission would be less this time round as protective measures, like wearing of

masks and PPE kits, are already in place. They also said that Nipah infections are usually confined to small clusters or areas. The experts said that "inten-

sive contact tracing" and quarantine of all primary contacts were the two main steps to be taken to ensure effective control over spread of the infection.

Dr Fettle, the nodal officer for H1N1, said that the Nipah infection is very pathogenic, but it is more likely to spread once the patient's condition becomes severe -- when

he/she is hospitalised. He said that risk of the infection spreading would, therefore, be higher in the hospital than at community level. Hence, while doing contact tracing, people who may have come into contact with the pa-

tient at the hospitals should be "meticulously traced," he said. Dr Fettle further said that steps taken by the state to tackle COVID-19. like preparing a time stamped route map of patients, would come in handy here also as it would help public health authorities inform

people about the places visited by the infected person and at what times

This will let people know as to who all need to quarantine themselves or come forward for testing if they exhibit symptoms and would avoid widespread panic in the district or state, he said.

Dr Anish, a specialist in community medicine, and Dr Suresh, general secretary of the Kerala **Government Medical Officers** Association, were also of a similar view that contact tracing and

Moreover, due to the prevailing COVID-19 pandemic, people are already taking preventive steps like wearing masks and kits, and therefore, the spread of Nipah may be less.

Jaipur, Sept 5: Married at the age of just seven, a 19-year-old 'Balika Vadhu' of Rajasthan's Bhilwara district finally got freedom from the clutches of child marriage after 12 years.

The child bride, Mansi had knocked the family court in Bhilwara and pleaded for annulment of her child marriage. Hearing her plight, the Family Court Judge Harivallabh Khatri showed sensitivity and gave a strong message against child marriage by pronouncing a historic verdict of annulment of Mansi's child marriage.

Mansi, originally a resident of Paldi in Bhilwara district, was married at the age of seven in 2009 to a groom, who was a resident of Baneda Tehsil. For about 12 years, she suffered the brunt of child marriage. Mansi told IANS, "With the help of Dr Kriti Bharti didi, I have got freedom from the exile of child marriage. I am studying for my second year BA and now I want to study further and become a teacher."



New Delhi, Sept 5: The Centre has shared a set of parameters with all states and UTs to enable service providers and monitoring teams under the national Covid-19 vaccination programme to identify any fake Covid-19 vaccines so that they are not admin-

Currently, the Serum Institute of India's Covishield, Bharat Biotech's Covaxin and Russian vaccine Sputnik V are being administered to eligible beneficiaries under the ongoing Covid-19 inoculation drive in the country.

"It was requested that the vaccines need to be carefully authenticated before use...The information on genuine Covid-19 vaccine labels and additional information of the Covid-19 vaccines in use is being enclosed for reference of program managers and service providers under the National Covid-19 Vaccination Program. "The service providers and monitoring teams for Covid-19 vaccination may be informed about these details and to ensure due diligence towards recognition of counterfeit vaccines," Additional Secretary Manohar Agnani said in a letter to



This comes days in the backdrop of concerns flagged by the WHO over counterfeit/falsified Covishield vaccine being identified in the South-East Asia and Africa region of WHO

The SII logo is printed on the adhesive side of the label and at a unique angle and position which can be identified by only a select few who are aware of the exact details.

The lettering is printed in special white ink to be more clear and readable. According to the parameters, the entire label has been given a special texture honeycomb

effect which is visible only at a specific angle. At strategic locations, the honeycomb design has been altered slightly and certain additional special elements added to the texture design such that it is not visible to the layman, but people who know the subtle changes can easily check and verify the authenticity of the

label and vial. The anti-counterfeit features in the Covaxin label include invisible UV helix (DNA-like structure) which is only visible under UV light, micro text hidden in label claim dots, which is written as CO-VAXIN, green foil effect in X of "Covaxin" and holographic effect on COVAXIN. As for Sputnik, imported products are from two different bulk manufacturing sites from Russia and, hence, there are two different labels for both these sites. While all the information and design are the same, only the manufacturer name is different.

BJP orders poll surveys

fter developments in Afghanistan, the BJP has ordered fresh election surveys in five poll bound states due in February-March 2022 -- UP, Goa, Manipur, Punjab and Uttarakhand. The surveys have also been ordered in Gujarat and Karnataka which will go to polls by the end of 2022. Though the BJP is a weak wicket in Punjab having just three MLAs and without an alliance partner. Yet, it has hired two agencies to assess the ground level situation in the border state. The BJP is closely monitoring the situation and wants to prevent AAP and the advent of Navjot Singh

they are not good for the betterment of the state. In the remaining four states, different survey agencies prominently associated with some TV channels have been given huge contracts. Some of the leading psephologists have been hired to give their independent feedback to the party. It is widely believed that the BJP had backed Capt. Amarinder Singh in 2017 Assembly polls to ensure that AAP is kept out. Interestingly, two agencies have been specifically told to assess the mood of the people if anti-Taliban stance will pay rich dividends to the BJP. It is largely due to this very reason that cases have been slapped in some BJP-ruled states under the NSA and UAPA against those speaking in favour of the Taliban. Interestingly, the RSS is conducting its own surveys through different teams. The BJP wants to know which prominent leader in the state is getting the traction and what are the issues so that the high command drafts campaign policies accordingly. This pre-poll survey is the first in the series and the second survey will be held around November-December. The recent 'Mood of the

Nation poll' by a leading channel may have given 24% popular votes to the Prime Minister, a fall from 66% in 2019. But the same survey gave BJP 269 Lok Sabha seats if polls were held right now, a heartening feature.

No booster dose for now

The Covid-19 working group is not in favour of a 'third Booster dose' for those who had already taken double dose. The Covid-19 Working Group, a highest policy making body of experts set up by the Union Government, has conveyed that there was no need to give the third booster shot to prevent Covid as is being propounded. "There is no need to give a third booster Covid vaccine in India. Neither the WHO nor other eminent experts have recommended it. Even data emerging from the UK and USA where the third booster dose is administered has not shown such benefits," the expert group said. The Working Group, which deliberated on a variety of sensitive issues relating to the vaccination program, is of the firm opinion that

"there is no need for a third booster dose." Dr Rakesh Agrawal, Director of Director of Jawaharlal Institute of Postgraduate Medical Education & Research (JIPMER), Pondicherry and member of the Covid Working Group went on record to say that the efforts must be to vaccinate maximum number of people in the shortest possible time. "This alone will prevent deaths and hospitalisation," he said. Secondly, no one claimed that double vaccinated persons would not be infected. The latest studies have shown that double vaccinated persons will not die of Covid-19 unless they have serious commodities.

PM frees 'babus' from shackles

n order to protect the serving and retired bureaucrats and top ranking persons, the Modi government has provided a shield to protect them from harassment by the CBI and probe agencies in future. This has been done to expedite the process of decision making in the government at all levels which has been hurting the country's growth path. In a latest

order issued last night by the Modi government, all Union Ministers, Ministers of State, MPs, Chief Ministers, MLAs, CMDs of PSUs and top officers of the government at the Centre and states have been given unprecedented protection. In a detailed 8-pages order, the Department of Personnel & Training no 428/07/2021-AVD IV(B), directed the states and probe agencies to ensure that no officer less than the rank of the Director-General of Police or equivalent shall inquire into the complaints of allegations against these top ranking persons in the executive. The rule 17A was amended and a new SOP issued where inquiry will be conducted by different ranks of Police Officers against different ranks of public servants. For example, additional DG level officers alone would personally hold inquiry, investigation or enquiry into complaints and list them specifically before going ahead with it against public servants of level 14 & 15 and Board level PSU directors of the state and the Central governments. Similarly, two other categories have been created for every rank and the power of police inspector has been curtailed in terms of initiating a probe directly.

Dubai, Sept 5: A ballistic missile attack aimed at Saudi Arabia's oilrich eastern region was intercepted on Saturday, the Saudi-led coalition fighting the Houthi group in Yemen said in a statement carried by Saudi state media.

The missile was intercepted over the city of Dammam, according to a source familiar with the matter who declined to be named and social media reports.

The shrapnel of the missile scattered over the Dammam Suburb neigbourhood, injuring two Saudi children, while 14 residential houses suffered light damages, Saudi state news agency SPA said, citing a statement by the defence ministry. The coalition blamed the attack

on the Iran-aligned Houthi forces. There was no immediate claim of responsibility in Houthi-run media. The coalition also said it intercepted and destroyed ballistic missiles heading towards Jazan and Najran, both in the southern part

of the country.

Eastern Saudi is home to significant oil infrastructure which has previously been targeted and hit by aerial attacks. An attack in September 2019 on two Aramco plants in the east temporarily knocked out half the country's oil production.

Yemen's Houthis, who regularly launch drones and missiles into the kingdom, have claimed responsibility for several attacks on Saudi oil installations in the past.

A source familiar with the matter said there was no impact on facilities belonging to state-controlled oil giant Saudi Aramco and that the attack happened outside of Aramco facilities

"The Ministry of Defense will take the necessary and deterrent measures to protect its lands and capabilities, and stop such hostile and cross-border attacks to protect civilians, in accordance with international humanitarian law," the ministry said in a statement according to SPA.

said. The Chinese aircraft flew in an area closer to the Chinese than Taiwanese coast, roughly northeast of the Pratas, according to a map provided by the ministry. There was no immediate comment from China.

The last such large-scale activity, June 15, involved 28 Chinese air force aircraft, the largest incursion reported by Taiwan to date.

Soldiers dissolve government in Guinea

Conakry. Sept 5: Soldiers who staged an uprising in Guinea's capital Sunday said in a short broadcast on state television that they have dissolved the constitution and the government in the West African state.

However, the defence ministry said an attack on the presidential palace by mutinous forces had been put down. Heavy gunfire had broken out near the presidential palace in Conakry Sunday morning, with several sources saying an elite national army unit led by a former French legionnaire, Mamady Doumbouya, was behind the unrest.

An unidentified soldier, draped in Guinea's national flag and surrounded by eight other armed soldiers, said in the broadcast that they planned to form a transitional government and would give further details later.

The soldier spoke after videos shared on social media - which could not immediately authenticate - showed President Alpha



Conde surrounded in a room by army special forces.

The defence ministry said the attemped insurgency had been put down. "The presidential guard, supported by the loyalist and republican defence and security forces, contained the threat and repelled the group of assailants,' it said in a statement.

'Security and combing operations are continuing to restore order and peace.

Earlier, videos shared on social media showed military vehicles patrolling Conkary's streets and one military source said the only bridge connecting the mainland to the Kaloum neighbourhood, which houses the palace and most government ministries, had been sealed off.

New Delhi, Sept 5: The government's collections from levy of excise duty on petroleum products have jumped 48 per cent in the first four months of the current fiscal year, with the incremental mopup being 3-times of the repayment liability of legacy oil bonds in the full fiscal, official data showed.

Controller General of Accounts in the Union Ministry of Finance showed excise duty collections during April-July 2021 surging to over ₹1 lakh crore, from ₹67,895 crore mop-up in the same period of the previous fiscal.

After the introduction of the Goods and Services Tax (GST) regime, excise duty is levied only on petrol, diesel, ATF and natural gas. Barring these products, all other goods and services are under the GST regime.

The incremental collections of ₹32.492 crore in the first four months of the fiscal year 2021-22 (April 2021 to March 2022) is three-times the ₹10,000 crore liability that the government has in the full year towards repayment of oil bonds that were issued by the previous Congress-led UPA government to subsidise fuel.

HOUSING DEMAND RECOVERY Anarock eyes up to 50% revenue growth in FY22

New Delhi, Sept 5: Property consultant Anarock aims up to 50 per cent growth in its turnover to around ₹450 crore this fiscal year on the back of recovery in housing demand after the second wave of the Covid pandemic.

Mumbai-based Anarock, which is one of the leading housing brokerage firms in the country, had clocked an 18 per cent growth in its revenue at around ₹305 crore during the 2020-21 financial year despite the pandemic.

In an interview with PTI, Anarock Chairman Anuj Puri said,

"Housing demand bounced back strongly both after the first and second wave of the Covid. The recovery happened much faster than our expectations.

He expects a strong housing demand during the upcoming festive season as it was seen during the last year.



Data from primemfdatabase.com showed that the AUMs of the other major players HDFC Mutual Fund, ICICI Prudential Mutual Fund, Kotak Mahindra Mutual Fund, and Nippon India Mutual Fund stood at around ₹4,37,093 crore, ₹4,34,180 crore, ₹2,58,416 crore and ₹2,57,544 crore, respectively, higher by 8.5 per cent, 9.4 per cent, 13.4 per cent, and 16.3 per cent from their respective AUMs in December 2020.

Backed by a low base, smaller fund houses have also witnessed a higher growth rate in their AUMs during the period. In tandem with the rise in the equity market, small players made giant strides during the year.

Indian athletes bag record 19 medals in Tokyo

Tokyo, Sept 5: Inspirational, incredible and indomitable. This is how India's performance at the Paralympics Games here can aptly be described. India's paralympians finished off with a historic 19 medals, including five gold. It helped them finish 24th in the medals' table. The tally also included eight silver and six bronze medals.

Even on the last day of compe titions, the medal rush did not stop and Krishna Nagar won a gold after Suhas Yathiraj signed off his brilliant run with a silver to complete a remarkable badminton show. The duo's performance was like icing on the cake for the contingent.

In all, 54 came here and 17 of them left with medals around their necks. For the first time, the attention in India will definitely turn to paralympic sports.

It was an improved performance no doubt but calling it just improvement would be an understatement given that India's overall Games haul was a mere 12 before this edition.

India beat Nepal

The first match had ended in a 1-1 draw. India were dominant in the first half, but were kept at bay by Nepal goalie Kiran Limbu. Even then Chhetri and Anirudh Thapa missed golden opportunities to put India ahead. Tokyo, Sept 5: The final act of the delayed Tokyo Olympics and Paralympics came Sunday. It was almost eight years to the day after the Japanese capital was awarded the Olympic Games.

The Paralympics ended a 13-day run in a colourful, circus-like ceremony at the National Stadium overseen by Crown Prince Akishino, the brother of Emperor Naruhito. The Olympics closed almost a month ago.

These were unprecedented Olympics and Paralympics, postponed for a year and marked by footnotes and asterisks. No fans were allowed during the Olympics, except for a few thousand at outlying venues away from Tokyo. A few thousand school children were allowed into some Paralympic venues.

"There were many times when we thought these Games could not

happen," Andrew Parsons, president of the International Paralympic Committee, said Sunday. "There were many sleepless nights. But finally its done," Parsons added. The closing ceremony was en-

titled 'Harmonious Cacophony' and involved both able-bodied actors and others with disabilities. The theme was described by organisers

as a 'world inspired by the Paralympics, one where differences shine'. "I believe that we have reached the end of games without any major problems," said Seiko Hashimoto, the president of the Tokyo organising committee.

The Paralympics involved a record number of athletes – 4.405 - and a record number of countries won medals. They also saw two athletes from Afghanistan compete, both of whom arrived several days late after fleeing Kabul.

The costs also set records. A study by the University of Oxford found these to be the most expensive Games on record. Japan officially spent USD 15.4 billion to organise the Olympics and Paralympics, double the original estimate. Several government audits suggested the real costs are twice that. All but USD 6.7 billion is public money.

But there was fallout, however, and lots of it.

Japanese Prime Minister Yoshihide Suga announced Friday that he would not continue in office. Suga hoped to get a re-election bump from the Olympics. He got the opposite as his approval rating plummeted after a slow vaccine rollout in Japan, and a contentious decision to stage the Games during the pandemic.

New York, Sept 5: Shelby Rogers lingered on the court and panned her phone around at the fans at Arthur Ashe Stadium for a snapshot souvenir of the scene after she beat Ashleigh Barty for the first time. Not just at the US Open tennis tournament, but for the first time in her career.

Rogers was winless in five meetings — four this year — against the No. 1 player, forcing the last American left in the women's draw to mix up her methodology.

Urged on by a raucous crowd at the Flushing Meadows here, Rogers smacked winners, stayed patient - and waited as a rattled Barty hit a slew of unforced errors that led to another early exit here for the reigning Wimbledon champion. Rogers rallied from 2-5 down in the third set to upset Barty 6-2, 1-6, 7-6 (7-5) Saturday night for the biggest win of the 28-year-old's career.

"I just tried to get the crowd into it. I said, 'You know what, if I'm going to go down, I'm going to give a last dying effort'," Rogers said after the match. "You find ways to stay -(in the present and stay not thinking about I'm down 2-5," Rogers added.
