Schools shut after 34 pupils test Covid +ve

Bargarh/Dhenkanal, Sept 7: A

total of 34 students from two high

The Kanapura High School in Kamakhyanagar locality was shut down for a week after 20 persons tested positive for Covid-19. Among those hit by the Covid-19 virus 14 were students, officials said Tuesday. Officials stated that 334 random samples were collected from students and staff of the school including teachers. When reports came it was found that 14 students (all hostel residents), five teachers and one peon have been infected by the virus. The management decided to shut down the school for seven days. The students have been sent to their homes.

The Bargarh administration shut down the hostel of the pri-

vate school after 19 inmates tested positive for Covid-19 over past four days. All the affected inmates are within 14 to 16 years of age. Initially, seven students tested pos-

San Salvador: El Salvador Tuesday became the first country to adopt bitcoin as legal tender, a real-world experiment proponents say will lower commission costs for billions of dollars sent from abroad but which critics warned may fuel money laundering. The change means businesses should accept payment in bitcoin alongside the US dollar and will remain legal tender. 






Passage of the PR bills in the Assembly Tuesday has removed the hurdle before holding of elections to the long-pending urban local bodies in the state

Bhubaneswar, Sept 7: Paving the way for elections to various urban local bodies (ULBs), the State Assembly Tuesday passed the Odisha Municipal Laws (Amendment) Bill 2021 to keep the overall reservation in the ULBs at 50 per cent.

Housing and Urban Development Minister Pratap Jena introduced the bill Tuesday evening which was then passed in the house.

Article 243T of the Constitution provides for reservation of seats in municipalities. Accordingly, the Orissa Municipal Act 1950 and the Orissa Municipal Corporation Act 2003 provide for reservation of seats for elections to the extent of 27 per cent in favour of BCC in the state, Jena said in his statement. Similarly, for SCs & STs, as per provision of the Constitution, reservation of seats has been made in tion to their population in the respective urban areas. In view of the above statutory provisions, in some of the ULBs the reservation of seats for SC, ST and backward classes exceeds 50 per cent.

In 2013, the Orissa High Court had directed the state government to make reservation of seats for SC, ST and BCC within 50 per cent in accordance with the judgment passed by the Supreme Court in the K Krishna Murthy case. Challenging the order, the state moved to the Supreme Court which had upheld the decision of

In order to comply with the decision of the courts, the government has amended the laws to limit the total extent of reservation for election in ULBs to 50 per cent.

With this amendment, the upper ceiling of reservation of seats for SC, ST and BCC will be 50 per cent and the upper limit of reservation of seats for BCC will not ex-

ceed 27 per cent. The government will first give priority to ST and SC population The upper ceiling of seat quotas

- for SC, ST and BCC will be 50 pc and the upper limit of seat quota for BCC will not exceed 27 pc
- The Assembly has also passed the Odisha Repealing Bill, 2021 to repeal 206 obsolete laws that cover the year from 1974 to 2015

in reservation. The remaining seats, if left, will be reserved for the backward class citizens with a maximum ceiling of 27 per cent, sources said

Making a similar provision, the state government has also introduced the Odisha Panchayat Laws (Amendment) Bill, 2021

in the Assembly. The bill has been introduced to make necessary amendment in the Orissa Grama Panchayat Act-1964, the Orissa Panchayat Samiti Act-1959 and the Orissa Zilla Parishad Act-1991 to reserve a maximum of 50 per cent seats in the Panchayati Raj Institutions for SC, ST and OBC.

The Assembly has also passed the Odisha Repealing Bill, 2021 to repeal 206 obsolete laws that cover the year from 1974 to 2015. The principal object of the repealing Act is to lessen the burden of the Statute Book. Besides, the House also passed the Odia University (Amendment) Bill, 2021.



Solna (Sweden), Sept 7: Israel was way ahead of the rest of the world when it came to COVID vaccination, so it's not surprising that data from this corner of the Mediterranean causes a lot of excitement - it's a glimpse into the future.

Researchers at Maccabi Healthcare Services in Tel Aviv released a preprint suggesting people who had been infected with COVID had greater protection than vaccinated people against becoming reinfected with the delta variant. Unfortunately, some took this to mean that getting COVID is a better idea than getting vaccinated.

First, the possibility that a COVID infection leads to longer-lived immunity than vaccination is not farfetched. Infection exposes our immune system to several viral proteins, whereas the most commonly used COVID vaccines introduce a single antigen: the spike protein. This results in a more directed but also a more restricted immune response than after infection.

Although people who have had COVID can get reinfected, naturally acquired immunity continues to evolve over time and antibodies remain detectable for longer than



was first anticipated. New evidence suggests that immunity following both severe and mild infection protects against both symptomatic and asymptomatic reinfection.

However, apart from the danger of drawing conclusions from data

that other scientists have not yet reviewed, it is also crucial to put the data in the right context. Although the study draws attention to the

potency of naturally acquired im-

munity, it does not consider the

risks involved in achieving natu-

ral immunity through infection. Nor does it cast a shadow on vaccine-generated immunity.

In fact, the benefit of vaccination is not even addressed in the study since unvaccinated people without prior infection were not included for comparison. The low rate of COVID-related hospitalisations among vaccinated participants (eight out of 16,000) would probably be strikingly lower than among non-vaccinated people without prior infection, but this group was not included in the analyses.

A common reason to remain unvaccinated is the misconception that waiting for natural immunity by choosing infection over vaccination is an option. But infection-acquired immunity may come at a heavy cost.

New York: US actor Michael K. Williams, one of television's most memorable stars of recent years for his role as Omar Little in The Wire, has been found dead in his New York City apartment, police said Monday.

News of the death of the 54year-old triggered an outpouring of grief among fans and former colleagues.

The actor's representative said it was "with deep sorrow that the family announces the passing of Michael Kenneth Williams.

The Brooklyn native had been widely hailed for his role in gritty thriller The Wire, in which armed robber who spe-

Oppn corners govt over law & order

Three Maoists were killed and 25 were arrested while 15 laid down their arms this year, govt tells House

Bhubaneswar, Sept 7: Opposition BJP and Congress Tuesday claimed that the law and order situation has collapsed in the state.

Participating in a debate on an adjournment motion moved by the BJP members in Assembly, BJP chief whip Mohan Majhi said the law and order situation has deteriorated in Odisha while citing the Mahanga triple murder case.

This is a politically-motivated crime as Law Minister Pratap Jena

has been named in the FIR. However, police have dropped Jena's name from the chargesheets. The Salipur JMFC court has ordered an investigation into the involvement of the minister in the case, he said.

"To ensure a free and fair probe, Jena should resign from his post. Because, a police inspector may not be able to interrogate the minister," Majhi added. The BJP leader also attacked the government over Paralakhemundi ACF Soumya Ranjan Mohapatra death case and Manavbad Sangathan chief Manas Das case.

Congress legislature party leader Narasingha Mishra alleged that 'Talibani rule' is prevailing in some places of the state. He criticised the government for initiating police action against around 2,000 people of Kendrapara who agitated against a water supply project.

"The number of crimes has gone up in Odisha. The atrocities against women and minor girls are on the rise. Odisha will be the Number 1 state in crimes against women, if we consider the size of our population vis-à-vis other states," Mishra lamented. The situation is alarming and the police are unable to control it. There is no doubt on the ability of police officers but the state has vacancy of around 11,000 posts in the po

In his reply, MoS for Home, Dibya Shankar Mishra said the law and order situation is under control in Odisha. The state police was able to control the Covid-19 situation. A total of 62 police personnel have been

martyred on the line of Covid duty, he said. The government is implementing emergency response support system (ERSS) to control crime and provide emergency services with its command centre in Bhubaneswar. All emergency services will be delivered on dialing 112, the minister added.

Sensitive crimes against women have been categorised as Red Flag cases for proper monitoring. In 2021 (till July), 81 Red Flag cases have been taken up, the MoS said. Mishra said no terrorist activities

have been reported in the state and the Left-wing extremism (LWE) situation has improved significantly. Out of the 15 Naxal-hit districts, five districts— Angul, Boudh, Deogarh, Nayagarh and Sambalpur - were removed from the security related expenditure list of the Centre.

He claimed that due to strong police action, three Maoists were killed and 25 were arrested while 15 laid down their arms this year.

On Mahanga murder case, Mishra said a chargesheet has been filed against 13 accused and three were shown as absconders. One of the accused was killed in a road accident. He said the Salipur JMFC Court has ordered the police to reinvestigate the allegations made against Jena. Meanwhile, the opposition Congress created a ruckus in the House over the state government's decision of capping the maximum height of Durga

Govt to take a call on new courts this year

Bhubaneswar: The state government will hold meeting with a high-level committee at the earliest for opening new courts in the state, Law Minister Pratap Jena told the Assembly Tuesday. Replying to a question of Dhruba Charan Sahoo (BJD), Jena said that the meeting of the high-level committee to consider the proposals for opening of new courts could not be held during the last two years due to Covid-19 pandemic. This year, however, the government has decided to hold the meeting, he added. The minister said that the meeting will decide the number of new courts to be set up and also their locations. Jena said that the committee in 2019-20 had decided to set up an Additional District Judge Court at Pattamundai, Now steps are being taken to create required posts for the court. After creation of posts, the government will take steps to make the courts functional, he said.

Another such facility—Nagar Van—is being developed in the Temple city, he added. He also said that two urban patches—Nandan Van and Arogva Van—have also been developed in the Silver city. These spots could be transformed into urban forest parks with basic infrastructure, parking and amenities.

The meeting decided that a joint committee comprising senior officers from departments concerned would soon identify the sites to be taken up for the urban forest parks in the first phase.

Provide drought aid to farmers pronto: BJP

ers. The Chief Minister has not uttered a single word on the issue. Farmers in the state have started committing suicide due to drought and other farm related issues," he said.

The BJP leader said that the party has visited several parts of the state and took stock of the drought situation. The party was told that even the revenue inspectors are not visiting the affected

farmlands. 'The government discussed the issue when our party moved an adjournment motion in the House. If drought sets in for one year, the impact could be felt in the coming years too," Samal said.

He also added, "The government needs to announce drought aid for affected areas promptly. We should now have a long-term action plan to mitigate drought. The situation is grim in 27 districts which needs immediate intervention from the government."

The BJP leader said that the state government should enquire about the crop damage caused by dry spell and provide timely compensation to the affected farmers of the state to ensure that farmers do not end their lives owing to distress and government apathy.

'The government had earlier boasted of giving irrigation facilities to each block but the ground reality is open to all," he said.

Kotia dispute is a long pending border issue between Andhra Pradhesh and Odisha. Both the states have been claiming sovereign rights over the area, which consist of 27 small tribal hamlets on the border.

After Panjshir's 'Fall'

n the midst of conflicting reports on the Taliban's success September 6 in getting control of the Panjshir Valley, the last bastion of resistance against Taliban takeover of Afghanistan, comes a strongly-worded message from Iran warning 'foreign powers' against meddling in Afghanistan affairs. Iran, which shares a 900 kilometre border with Afghanistan, has announced it would probe whether Pakistan, as reports strongly suggest, aided the Taliban in overrunning the resistance in Panjshir. The presence of ISI chief Lt Gen Faiz Hameed in Kabul from September 4 was indication of the key role that Rawalpindi played in the fall of Panjshir.

Pakistan is believed to have helped the Taliban with its air power to neutralise the National Resistance Front led by Ahmad Massoud, the son of former anti-Taliban commander Ahmed Shah Massoud killed by the Al-Qaeda two days before the 9/11 attack on the twin towers in the USA. Ahmad Massoud has reportedly fled Afghanistan, though in a video message he exhorted anti-Taliban forces to keep up resistance. Apparently, there are pockets in Panjshir Valley where the NRF is still holding out.

This is the first time that Iran has criticised the Taliban for taking control of Panjshir by force and it assumes significance since it has, over the vears, developed good relations with the Taliban, Pakistan's reported involvement seems to be causing concern to Iran which is keen on maintaining a workable relation with the Taliban in the management of the country. Iran's Foreign Ministry Spokesman Saeed Khatibzadeh denounced violence in the northern Afghan valley, where two senior figures of the NRF were killed. He told reporters Iran was investigating reports about the presence of foreign forces in the valley. Iran has trained tens of thousands of Afghan Shia fighters, known as the Fatimiyoun who fought in Syria and Libya. Having returned to Afghanistan, it is rumored, they can take on the Taliban also

Iran's position on the developments in Panjshir, publicly articulated for the first time since the fall of Kabul August 15, shows the struggle among foreign powers - Pakistan, Iran, China and Russia - to fill the vacuum created in Afghanistan following the US' withdrawal of troops from the country. Afghanistan occupies a highly important position in the geopolitics of central, south and west Asia. The economic and political interests of China, Iran and Russia hinge on the stability in Afghanistan and the ability of the Taliban to ensure counter-insurgency operations don't pose any threat to their respective internal affairs. Though the new Iranian government has not yet indicated whether it will recognise the new political dispensation in Kabul, many Iranian officials have, in recent weeks, called for a peaceful transfer of power and the formation of an inclusive government.

The Taliban have formidable challenges ahead as they are positioning themselves to begin their new regime in Afghanistan. To deliver what they promise, they need technocrats and foreign assistance, both advisory and on the ground. If they resort to the brutal methods they had used during their first rule two decades back, international actors will maintain and intensify sanctions. Currently, the Taliban regime faces the loss of billions of dollars frozen by the US government. The country's illegal and informal economies can only offset a part of those losses. The Taliban cannot augment the country's poppy economy as the global market is already saturated with opioids. They can't ban poppy cultivation on which a large part of the Afghanistan population depends. While the country is reeling under COVID-19, nearly 90 per cent of the population lives in poverty and 30 per cent faces acute food insecurity. The Taliban will struggle to find jobs for the many now-unemployed soldiers of the Afghan security forces whom the United States paid. They will have to trade with Iran, China, and Central Asia for the country's economic rejuvenation. For this they will have to accommodate Tehran, Beijing, and Moscow's principal counterterrorism interests. Apart from the West only China and the Gulf countries have potentially deep aid pockets. Pakistan has been providing military and intelligence aid, but its own economy is in shambles. Despite Pakistan's triumphalism over catapulting the Taliban into Afghanistan, the latter may try to free themselves from its control. Already, top Taliban leaders, such as Abdul Ghani Baradar and Sher Mohammad Abbas Stanekzai, have indicated their interest in the new trade routes being developed by Iran and India connecting the Central Asian countries bypassing Pakistan.

It all now depends on whether the Taliban truly want Afghanistan's economic growth and development. If so, then they will have to ensure peace and stability with the help of an inclusive government. If religious bigots take control of the government and dance to the tunes of Pakistan and China, as observed with the Haggani Network's actions. Afghanistan and the region will be plunged into further chaos.

■ Paraprosdokian

orothy Parker once quipped about a Yale Prom, "If all the girls attending it were laid end to end, I wouldn't be at all surprised." Herman Mankiewicz said of Orson Welles: "There, but for the grace of God, goes God". (It has also been attributed to Sir Winston Churchill, as a put-down of Sir Stafford Cripps, but Herman Mankiewicz got there first.) Some unknown comic has written: "Where there's a will, I want to be in it" and another has created "Mary had a little lamb; the midwife was surprised." What connects these witticisms is that their endings are unexpected, a violation of expectations whose surprise provokes laughter. It's a useful trick for comedy writers. Paraprosdokian is the term for it that has become moderately well known in recent decades; it's particularly widely used online, probably because mentioning it is a good excuse for repeating choice quotes from witty writers. The word hasn't yet reached any dictionary that we know of and that includes the recent revision of the letter P in the Oxford English Dictionary, though the editor of the Macquarie Dictionary of Australia says that it will be in its next revision. That's led some, including the Canadian broadcaster and writer Bill Casselman, to argue that it's not a proper term in rhetoric: "The word paraprosdokian was made up by some semiliterate doofus late in the 20th century." He challenged those who thought otherwise "to show me one single citation for the word paraprosdokian earlier than 1950 CE". The phrase para prosdokian occurs in classical Greek literature, meaning "contrary to expectations," but at some point the two words have been run together. Who first did this is untraceable, but as the earliest recorded use was in Die Sprache als Kunst by Gustav Gerber, dated 1884. Paraprosdokian looks odd to us because the -ian ending is more commonly found in adjectives in English than in nouns (though a few, such as comedian and tragedian, do contain it). In the Greek phrase, prosdokian is an inflected form of prosdokia, "expectation" - whether for good or ill, hence Sir Compton Mackenzie's comment - where the final n is the marker of the accusative case that conventionally followed the preposition para. The English word would be better as paraprosdokia, using the root form of the noun. That does occasionally appear in scholarly literature, though like the other form it's not in any of our dictionaries, and the established use of paraprosdokian means it's too late to convince anybody to change.

ebruary 20, 1947, Clement Attlee, the socialist British prime minister, informed parliament that India would become independent no later than June 1948. Attlee could not wait for the British to withdraw from a country whose leaders, Muslim and Hindu, had long been clamouring for independence. But India was seething with violent unrest. Muslim leaders were afraid of Hindu dominance. Worried that a civil war might land the British in an uncontrollable situation, Attlee decided to end the British Raj even earlier.

Indian independence began August 14, 1947. Pakistan broke away. Horrendous violence between Hindus and Muslims claimed a half-million lives. Many more lost their homes. The wounds of partition are yet to heal.

Attlee was widely blamed for getting out too soon and leaving the former colony in chaos. If only a better police force had been organised. If only the army could have kept order. If only the British could have left once the country was stable.

US President Joe Biden now finds himself in the same situation. American troops have left Afghanistan in a bloody mess. Critics of Biden's decision to withdraw claim that the United States should have stayed longer. In the opinion of Robert Kagan, a wellknown American promoter of robust military policies, the US should have promised to stay at least 20 years, instead of being non-committal. After all, the US military presence was minimal and could easily be afforded. But in that case, why just 20 years? Why not 40? Why not forever?

The question is whether Attlee, or Biden, could ever have left India or Afghanistan in a stable condition. At least Attlee knew that India, and even Pakistan, would be governed by responsible, mostly moderate men. Jawaharlal Nehru and Mohammed Ali Jinnah were nothing like the Taliban. Both were widely regarded as legitimate leaders - and still there was a civil war. Biden didn't even have the luxury of leaving Afghanistan in capable hands.

It is easy to blame Attlee and Biden for the violence that followed their decisions. Perhaps

they made mistakes. In hindsight. it may be possible to see how they could have mitigated some of the damage. But both leaders were caught in the same colonial trap that ensnared so many other imperial powers. Once you make local elites dependent on the power and money of a foreign occupier, it becomes almost impossible to leave without causing mayhem. And the longer the foreign power stays, the worse the mayhem often becomes.

Harold Macmillan, the Conservative prime minister who sensing "the wind of change' blowing through colonial Africa in 1960, managed the withdrawal of British rule, was once asked by the very conservative American journalist William F. Buckley Jr. whether Africans were ready to rule themselves. Macmillan didn't think so. But he added that this was all the more reason why they should be free to try. These were their countries. They had to learn how to govern by governing. For the British to hang on and throw the best and brightest anti-colonial activists in prison would only make that harder.

Empires are rarely established by design. Most European empires started as trading posts. Local rulers were cultivated, bribed, and set against one another. For a long time, great chunks of India were ruled by a British trading company. Colonial governments then took over to protect the commercial interests of the home countries. Imperial rule was often justified by Christian missionary zeal, or, very late in the game. around the very end of the nine teenth century, by high-minded ideals of educating native elites to mimic the West.

The US has been more halfhearted about its colonial enterprises. After all. Americans are supposed to be against imperial ism. Their stated justification for fighting communism in Vietnam, or dictatorships in Iraq or Afghanistan, has been to enlighten the benighted populations through free-market capitalism and democratic government, often with disastrous consequences.

Whatever the justification for foreign intervention, the results are the same. Local elites, such as the Afghans who governed Kabul and other cities, might do well. But dependency - not just on another state, but on NGOs and other wellmeaning institutions that do what governments should be doing fuels corruption. Money flows too easily into ever deeper pockets. And the very presence of foreign military force and political tutors, who may have little understand ing of how things work in the

countries they occupy, makes it ever harder for the local people

to rule themselves. The colonial elites, bloated with free money, have no legitimacy in the eyes of their compatriots. Rebels and revolutionaries may have more, but only know how to rule by force. The imperial power is trapped. Leaving is almost always

bad. Staying is worse. Attlee and Biden understood this. That is why they wanted to get out. Biden is accused of naivety and seen as a hapless old man who had no idea what he was unleashing This is unlikely. I think he decided it was time to leave without delay precisely because he knew it would be a big mess; better to get it over with than become further ensnared by the colonial trap.

This might seem callous. But Biden can't be blamed for the rise of the Taliban, or the fragile state of a country that has seen far too many wars and invasions. The US should not have been there in the first place, but that is a lesson that great powers never seem to learn.

Celebrities too deserve some privacy

INDEED, A MALE INTERVIEWER WOULD BE WIDELY DENOUNCED FOR ASKING MIRABAI CHANU OR PV SINDHU. "DO YOU HAVE A **GIRLFRIEND?**"

reeraj Chopra was fairly wellknown before this year's Olympic Games, but winning a gold medal in Tokyo propelled him to stratospheric stardom. He became a national hero and legendary athlete with a single throw of the javelin, and everyone wanted to know everything about him. Where did he grow up? Who were his childhood idols? What did he eat for breakfast? Did he wear briefs, boxers or trunks?

Almost every media outlet in India wanted to interview Chopra and every Indian with the slimmest of journalism credentials wanted to pepper him with questions. It was only a matter of time before someone asked a question that seemed inappropriate to some people. The first person to ask such a question was Navika Kumar of *Times Now*, who asked the 23-year-old athlete if he has a girlfriend. A girlfriend!

"No, I don't have a girlfriend," Chopra responded, adding that he was keeping his focus on sports right now. He seemed unfazed by the question, but others on social media found it inappropriate, wondering

what the reaction would be if a sportswoman were asked the same question by a male interviewer. Indeed, a male interviewer would be widely denounced for asking Mirabai Chanu or PV Sindhu, "Do you have a girlfriend?'

In this day and age, we should not be making any assumptions about sexual orientation. We should ask questions such as "Are you dating someone right now?" and "Do you have a significant person in your life other than your coach?' Otherwise, we risk making some people uncomfortable.

But are questions about relationships always inappropriate? Not necessarily. Many athletes are eager to talk about their significant others. It all depends on context. A press conference immediately after an athlete wins a competition is not an appropriate setting for relationship questions, unless you are asking Neeraj Chopra about his relationship with his javelin.

Reporter: "Can you tell us more about your relationship with your javelin?

Chopra: "Yes, it's a Valhalla javelin, made by the Swedish company Nordic Sport. It helped me win gold. I love it. It will always have a special place in my heart.' Reporter: "Do you let other peo-

ple hold it and throw it?'

Chopra: "Yes, we have an open relationship. We are there for each other, but we are not clingy." While many people would con-

sider Navika Kumar's question fairly innocuous and not an invasion of privacy, the same can't be said about a question posed to Chopra during a virtual event hosted by *The Indian Express*. The question came from art historian Rajeev Sethi. Prefacing his question with a compliment ("What a handsome young man you are!"), Sethi said he wanted to ask a question on the minds of crores of Indians: "How do you maintain a balance between your sex life and athletic training? I know this is a weird question.

It wasn't just a weird question. As far as I know, it was the weirdest question that has ever been posed to an Olympic gold medallist

get the opportunity to question Olympic athletes. The social circles of art historians and Olympic athletes usually do not overlap. Historians generally hang around with other historians, and athletes hang around with other athletes. And now we know why.

Chopra, to his credit, responded politely: "Sorry, sir. I have said sorry, you can know my answer from that.'

Sethi did not give up. He tried to explain why he was asking his question, but that only made things worse, "My heart is overwhelmed by your question," Chopra said, which was a polite way of saying, "You have pierced my heart with your weird question.

As the only Indian to ever win an Olympic gold medal in athletics, Chopra has become a celebrity, but even celebrities deserve some privacy. Do we really need to know about Chopra's sex life? No. but perhaps the art historian would like to volunteer some details about his.

Pathetic state

Sir, The pathetic state of Indian higher education is discernible in the fact that even the best Indian higher education institutes (HEIs) do not get a top place in international rankings. It is worrisome that not a single Indian HEI appears among the top 200 in the latest Times Higher Education (THE) global rankings. In fact, the rankings are not done based on the excellence in teaching, research or reputation. THE considers parameters such as knowledge transfer that measures participation in exchange programmes and collaboration with other international universities and measures progress against the UN's Sustainable Development Goals (SDGs). Several Chinese universities figure among the top 100. In contrast, only three Indian HEIs figure in the 300-400 category. Criticism can be levelled against the parameters used for rankings but it must be understood that HEIs that wish to be globally competitive must strive for it. If India wants to be an academic superpower, it needs to do a lot. While India's National Education Policy 2020 is considered a game changer, pathetic performance of HEIs is a matter of concern. India must take a leaf out of the book of China and overcome the drawbacks in the higher education sector.

Nipah nightmare

Sir, The Nipah nightmare is taking the country by storm. After a gap of three years, the zoonotic infection was reported in Kozhikode district of Kerala. When Kerala suffered such an epidemic during the floods three years ago, then Health Minister KK Shailaja managed the situation very well. However, Shailaja was shown the door by CM Pinarayi Vijayan after he formed government in the state for the second time. A 12-year-old boy recently died after getting infected by Nipah virus, while two health workers, who attended to the boy, are under treatment at the Kozhikode Medical College and Hospital. The virus is transmitted to people from animals and can also be passed on through contaminated food or directly from person-to-person. Fruit bats are considered to be a natural reservoir of the virus. Symptoms include acute encephalitis and respiratory illnesses. An alert has been sounded in Kozhikode and surrounding districts of Malappuram and Kannur. Health Minister Veena George has said the government has contacted the Indian Council of Medical Research to procure monoclonal antibodies for treatment of the disease. The medicines would be made available from Australia in a week.

Land acquisition on fast track for Subarnarekha port project

THE STATE GOVERNMENT HAD ANNOUNCED SETTING UP OF THE RIVER-BASED POR ABOUT 14 YEARS AGO. CHIEF MINISTER NAVEEN PATNAIK HAD, HOWEVER, LAID THE **FOUNDATION STONE FOR THE PORT IN 2019**



Langaleswar, Sept 7: The government has set a target to complete the infrastructure works of the Subarnarekha port project at Choumukh under Baliapal block in Balasore by 2024. "Land acquisition for the railway project and road for the proposed port project is in full swing," said Ranjan Satpathy, social scientist of Tata Company.

According to reports, a four-lane road will be laid from Gandhi Chowk to Choumukh. A special office has been opened in Baliapal. A railway line will be laid from Amarda station to the port site. Four camp offices were opened at different places to look after the land acquisition. A special office has been opened for examining land records. Land acquisition officers have been appointed. 197 acre of land is to be acquired for these

The state government had announced setting up of the riverbased port about 14 years ago. Chief Minister Naveen Patnaik had, however, laid the foundation stone for the port in 2019. Addressing a public rally in Bhograi in December 2006. the Chief Minister had announced the port project at an estimated cost of Rs 5.000 crore at

However, just two days after this announcement, the location of the port was changed. The state government signed an agreement with the Chennai-based Creative Port Development Limited to set up this port at Choumukh.

In 2018, Tata Steel proposed to pump in about 51 per cent of the total investment. The Chief Minister, while addressing a youth rally February 13, 2019 in Balasore claimed the port project will create scope of employment for 12,000 people with development of roads and railway connectivity in the region.

"The port will usher in development in south Baliapal region. A huge scope of employment and income generation will be created around the river-based port. All are requested to help in the project," said Satpathy.

Initially, locals united under the Bhitamati Surakhya Committee used to oppose the project saying that it would displace a large number of people while their livelihood depends on paddy farming, fishing, betel leaf and betel nut

Farmers in Baliapal fight shy of growing jute

As the use of single-use plastics and other non-biodegradable materials has been banned, it is high time the state government gave special attention to promote jute farming

Langaleswar, Sept 7: At one point in time, thousands of farmers living in the riparian areas of the Subarnarekha river under Baliapal block in Balasore used to cultivate jute on a large scale. Jute farming then was lucrative for them and they earned a healthy sum to manage their families.

However over the years, the extent of jute farming in the region has declined as farmers say that they fail to get profitable prices for the crops compared to the labour and cost inputs. Many farmers



have shunned jute cultivation over the years. They also lamented that they are turning away from this crop as no government support is

Jute used to be widely cultivated in Asti, Kumbhari, Nijhira, Srirampur, Debhoga, Bishnupur, Madhupura and Jamkundi panchayats. Baliapal was once the highest producer of jute in the state. Jute was also being exported outside the state from this area.

30 years ago, the Central government used to procure jute though a cooperative society. Farmers earned a lot then by sell-

However, 8 years ago, the society was closed down. Farmers had to resort to distress sale of their crop. Jute was being supplied to jute mills in Rupsa, Dhanmandal (Jajpur), Dhenkanal and Kolkota.

"Traders are now buying jute from us at cheaper rates. We have to incur losses. Why should we do jute cultivation when we have to face losses," famers like Bhagirathi Panda, Narayan Sethi and Amulya Gangai lamented.

They demanded that the cooperative society should be revived so that they can sell their crop at right prices. Farmers will be encourstantially in the state. Jute was cultivated in around 2,000 hectares from 1970 to 1995,

but it came down after 2000. Jute was once widely cultivated in other districts like Kendrapara, Cuttack, Jajpur, Bhadrak, Puri. Khurda and Nayagarh. In some of these districts, jute cultivation has now completely stopped.

As the Centre and state governments have banned the use of plastics and other non-biodegradable materials, it is high time the state government gave special attention to jute, they said.

Experts say, the district has favourable climatic conditions and land resources for jute cultivation but little government support led to a sharp decline in its cultivation. Hence, farmers are turning to other crops to earn a living.

Bhawanipatna/Jeypore, Sept 7: Over 1.5 tonne of cannabis worth Rs 1.22 crore was seized and five suspected drug peddlers were arrested in Kalahandi and Koraput districts, police said Tuesday.

Acting on a tip-off, the Jeypore Sadar police station in Koraput busted a drug-smuggling racket Monday and recovered cannabis weighing 1,008 kg from a truck that was intercepted, police said.

The market value of the drugs is estimated to be over Rs 1 crore. The driver was arrested and later two suppliers were also nabbed, an officer said.

Rs 1.65 lakh in cash, the truck, a car

Srinagar becomes new epicentre for militant activities

Srinagar alone recorded 16 terror-related incidents, 21 % of the total of 75 incidents reported from across the Valley till so far this year

New Delhi, Sept 7: Despite the number of terror incidents has gone down by 40 per cent in Jammu and Kashmir as compared to the last year, the capital city Srinagar, has become the new epicentre of terror activities in the last one year, leaving behind some south Kashmir districts.

A source in the security set up said that Srinagar alone recorded 16 terror-related incidents, 21 per cent of the total of 75 incidents reported from across the Valley till so far this year, leaving behind the traditional hotbed of terrorism of Pulwama, Anantnag and Shopian.

These revelations are part of an internal assessment of the Central Reserve Police Force (CRPF) which has been playing a crucial role in anti-terror operations in the UT and also intelligence agencies which were sent to the government.

According to the report,
"Srinagar emerges as the hotspot
of terrorists. Incidents (are) being
driven by TRF and the capital town
has also reported the maximum
security forces' casualty in action
this year. Out of the 15 casualties
reported across the Valley this
year, eight came from Srinagar."
Srinagar has also recorded the

highest number of recoveries of IEDs and out of 8 IEDs recovered so far. three are from Srinagar.

"Reflective of increasing violence, out of 75 terrorist incidents reported in the Valley this year, Srinagar accounts for the maximum number of incidents (16, 20 per cent) which is significantly higher than its share in the previous years (2019-6 per cent, 2020-5 per cent). This year, however, a shift in focus is clearly discernible," the report revealed.

"Another worrying trend is the propensity of terrorists to use IEDs in Srinagar. Out of 8 IEDs recovered this year, 3 were in Srinagar. It is assessed that 8-10 terrorists are active in the district (Srinagar)," it added.

The security forces have assessed that increased terror activities in Srinagar is a result of the recruitment drives initiated by the Pakistan based terror group Lashkare-Taiba (LeT)'s front - The Resistance Front (TRF)'. Its commander Abbas Sheikh is named as one of the top 10 terrorists by the J&K Police and has been frequently spotted in Srinagar with an aim to recruit militants and develope a strong network of hardcore OGWs (overground workers), an official in the security forces said.

MEHBOOBA PLACED UNDER HOUSE ARREST

Srinagar, Sept 7: PDP president Mehbooba Mufti was put under house detention Tuesday and she claimed that the decision of Jammu and Kashmir authorities to restrain her movement had "exposed the government's claims of normalcy".

She also hit out at the Centre alleging that while the government was expressing concern for the rights of the people in Afghanistan, the same were being denied to Kashmiris.

"GOI expresses concern for the rights of Afghan people but wilfully denies the same to Kashmiris," she added.

Mehbooba posted pictures of a security forces' vehicle blocking the main gate of her Gupkar residence. According to officials, Mehbooba had expressed a desire to attend a family function in South Kashmir's highly volatile Kulgam district.

The authorities persuaded her not to go for the function as some antinationals were still trying to vitiate the atmosphere in the valley following the death of pro-Pakistan separatist Syed Ali Shah Geelani. Mehbooba has been vocal since

his death and Monday she accused the administration of turning the valley into "an open air prison" where "the dead aren't spared".

"A family isn't allowed to mourn and bid a final farewell as per their wishes. Booking Geelani sahab's family under UAPA shows GOI's deep-rooted paranoia and ruthlessness. This is New India's Naya Kashmir," she tweeted.

However, hours later, the Jammu and Kashmir Police released videos of the funeral of Geelani, who died on September 1 at his home after a prolonged illness. He was 91.



A statement was also released by the police clocking events after his death saying that its officers were made to wait for three hours at the separatist's home when they went there for his burial.

Refuting rumours allegedly being floated from across the border, the Jammu and Kashmir Police also released four videos through its Twitter handle to show that Geelani was laid to rest as per rituals in the intervening night of September 1 and 2.

"After the death of SAS Geelani, IGP Kashmir Shri Vijay Kumar met both of his sons at their residence at 11 pm, condoled them and requested for burial in the night for the larger interest of the general

public due to potential major L&O (law and order) situations. Both agreed and asked to wait for two hours until relatives reached," the police said on its Twitter handle.

The IGP Kashmir personally spoke to a few relatives and assured them of safe passage, they said.

"However, 3 hours later, probably under the pressure from Pakistan and miscreants, they behaved differently and started resorting to anti-national activities, including wrapping the dead body in Pakistani flag, making loud sloganeering in favour of Pakistan and instigating neighbours to come out," the police said.

They said that after persuasion the relatives brought the body to the graveyard and performed all rituals "with due respect in presence of members of Intizamia Committee and local Imam".

"The refusal of both his sons to come to the graveyard indicated their loyalty to the Pakistani agenda rather than their love and respect for their departed father," they added. The sons offered Fathia (prayers offered at the funeral) at 11 am September 2.

DOOR-TO-DOOR COVID SURVEY IN UP

Lucknow, Sept 7: The Yogi Adityanath government in Uttar Pradesh has launched a state-wide surveillance drive from Tuesday, under which the health officials will be going door-to-door and identify people with viral fever, Covid symptoms, and other diseases arising out of the seasonal vagaries.

This is designed to contain waterborne diseases in the state.

Chief Minister Yogi Adityanath, while addressing a high-level meeting on Tuesday, asked concerned officials to admit only serious patients in the OPDs/IPDs of hospitals. Health teams have been directed to spray anti-larva and undertake fogging drives in the areas where more than one dengue patient is found. People have also been advised to take precautionary measures to check the breeding of mosquitoes in and around their houses. He said that source reduction activities should be conducted regularly in rural and urban areas as per

Muzaffarnagar (UP), Sept 7: Eight years since the Muzaffarnagar riots of 2013, 1,117 people accused in 97 cases related to murder, rape, robbery and arson among others connected to the violence have been acquitted over lack of evidence.

Seven people were convicted in a single case related to the murder of two youths, Sachin and Gauray, in Kawal village in the district. This, together with the stabbing to death of another person, Shahnawaz, August 27, 2013 by six people had triggered the riots, according to police. A special investigation team (SIT) was set up by the state government to look into the riots cases.

According to officials of the SIT, police had registered 510 cases



against 1,480 people and filed chargesheets in 175 cases. An official of the SIT said that over the years, 97 cases have been decided by a court which has acquitted 1,117 people accused in those due to lack of evidence.

The prosecution has not filed

an appeal in any of these cases, he said. The seven people convicted in the Kawal village double-murder case were sentenced to life imprisonment. The SIT could not be file chargesheets in 20 cases under sections 153A and 295A of the IPC since it did not get permission for prosecution from the state gov-

ernment.

Meanwhile, the Uttar Pradesh government has decided to withdraw 77 cases related to the riots, but the court has given permission for withdrawal in just one case which is against 12 BJP leaders, including Uttar Pradesh minister Suresh Rana, BJP MLA Sangit Som, former BJP MP Bhartendu Singh and Vishva Hindu Parishad (VHP) leader Sadhvi Prachi. SIT officials said 264 accused in the riots cases were facing trial at present.

Mayawati woos Brahmins

Lucknow, Sept 7: Bahujan Samaj Party president Mayawati Tuesday asserted that the BSP would form the next government in Uttar Pradesh with the support from the 'Prabuddha Varg' (Brahmin).

Addressing a meeting at the BSP headquarters here to mark the culmination of the party's 'Prabuddha Varg Sammelans', Mayawati said, "We have always respected all castes. This party does not belong to any one caste but to all.

"As Chief Minister in all my terms, I have ensured that everyone got due respect. The interests of Brahmins and other communities are secure in the BSP."

She further said that she had never made false promises to people like the BJP does, but has worked for the development and welfare of all

the development and welfare of all. In her first public appearance in the pandemic, Mayawati clarified that she did not hold meetings during the pandemic because that would have given the state gov-



ernment a chance to target her party members.

"Even for the Prabuddha Sammelans, the state government had set a limit for participants. They would have put my party workers in jail if the numbers exceeded the limit and that would have impacted the party campaign for elections," she explained.

She said that after the BSP started Prabuddha Varg Sammelan, other parties followed suit. "But the 'Prabuddha Varg' is intelligent enough to know where their interests are safe," she said.

Mayawati also asked her party leaders to enrol a minimum of 1,000 Brahmins in each Assembly constituency in the state.

Kerala lifts night curfew

Thiruvananthapuram: Kerala Chief Minister Pinarayi Vijayan Tuesday said that it has been decided to forthwith do away with the night curfew and the "stringent intensified" restrictions Sundays. The move comes as the state Tuesday reported 25,772 fresh Covid-19 cases. The CM said the decision to do away with restrictions was taken in the Covid review meeting as the TPR in the state, which was around 18.49 per cent in the last week of August, fell to 17.91 in the first week of September. On Tuesday, the TPR was 15.87 per cent. Vijayan said if people continue to be more vigilant, the number of cases can be brought down. After daily cases rose to more than 30,000 following the Onam celebrations, the state had brought in night curfew from 10pm to 6am from Monday to Saturday to check the increasing numbers.

11K-volt wire falls on house

Dhanbad: A man was killed and three members of his family critically injured as an 11.000-volt overhead wire fell on them when they were sleeping on the roof of their house in Jharkhand's Dhanbad district, police said Tuesday. The incident happened around midnight in Pandarpala in the Bhuli outpost area, they said.



Standoff between farmers and cops Apex court grants

Karnal (Haryana), Sept 7: Police used a water cannon near the district secretariat here as thousands of farmers marched towards the complex demanding action over a police lathi-charge last month.

Farmer unions had warned that protesters would lay siege to the mini-secretariat if action was not taken against officials involved in the lathi-charge in Karnal August 28.

Swaraj India chief Yogendra Yadav claimed that protesters -marching to the secretariat from the venue of a mahapanchayat five kilometres away – had already begun a gherao there.

Farmers reached the New Anaj Mandi for a mahapanchayat in the morning, riding tractors and motorcycles. As they gathered there, an 11-member delegation was invited by the local administration to discuss their demands and dissuade them from marching towards the secretariat.

'Our talks with administration failed as they did not agree to our demands," senior farm leader Joginder Singh Ugrahan said about three hours later.

Farm union leaders then urged the large gathering at the mahapanchayat to march peacefully towards the mini-secretariat, five kilometres away. The leaders told the farmers not to enter into any confrontation with policemen, and squat

more time to Centre for filing response

New Delhi, Sept 7: The Supreme Court Tuesday granted more time to the Centre to decide on filing a further response to a batch of pleas seeking an independent probe into the alleged snooping of certain people in India through the use of Israeli spyware Pegasus and slated the matter for further hearing September 13.

A three-judge bench headed by Chief Justice N V Ramana had issued a notice to the Centre on the pleas on August 17, while making it clear that it did not want the government to disclose anything which compromised national security. The Centre had earlier filed a short affidavit on the matter.

As soon as the matter came up for hearing before the bench, also comprising Justices Surya Kant and Aniruddha Bose, Solicitor General Tushar Mehta, appearing for the Centre, said that due to some difficulties he could not meet the officials concerned to take a decision on filing of the second affidavit and sought listing of the cases either on Thursday or Monday.

"My Lords, I need to take a call

on filing a second affidavit. It could not be decided due to some difficulties. Kindly give me time till Thursday or Monday," the law officer said. The CJI said the Centre's affidavit is there.

To this, the law officer said that the Centre was to take a decision on filing of a second affidavit in the matter: Senior advocate Kapil Sibal, appearing for senior journalist N Ram, said that he does not have any objection to the request.

"List it Monday," the bench said. The Centre had earlier filed a limited, short affidavit in the apex court saying that the pleas seeking an independent probe into the Pegasus snooping allegations are based on "conjectures and surmises or on other unsubstantiated media reports or incomplete or uncorroborated material". It said the position on the issue has already been clarified in Parliament by IT Minister Ashwini Vaishnaw. With a view to dispelling any wrong narrative spread by certain vested interests and examining the issues raised, the government will constitute a committee of experts. it had said.

Sibal, on behalf of some of the petitioners, had responded by saying that the security of the state is as important to the citizens of this country as it is to the state. "We don't want the state to give us any information about any security aspect in respect of use of any device. That is not our intention and that is not even the petition," he had said.

The top court, while issuing notice on the pleas, had said that it did not want the government to disclose anything related to the national security and had asked the Centre what is the "problem" if the competent authority files an affidavit before it on the issue.

India administers 70 crore Covid vax doses so far

New Delhi, Sept 7: The cumulative number of COVID-19 vaccine doses administered in the country has crossed 70 crore, with the last 10 crore doses being given in just 13 days, the fastest so far, the Union health ministry said Tuesday.

More than 67 lakh (67,43,698) doses have been administered till 7 pm, it said. The daily vaccination tally is expected to increase with compilation of final reports for the day by late night.

'Average Indian diet provides only 70% nutrition'

New Delhi, Sept 7: Nearly nine out of 10 doctors and nutritionists believe that the average daily Indian diet fulfills only 70 per cent or even lower nutritional needs of a person, according to a survey released Tuesday.

The findings are based on a nationwide survey of 220 healthcare practitioners (doctors and nutri-



tionists) by multivitamin supplement brand Supradyn

The survey brought to light an alarming gap in meeting the body's

100 per cent nutrition requirements across all zones in India.

As many as 90 per cent doctors and nutritionists agreed to at least a 30 per cent nutrition gap in average daily diet even among states that predominantly consume nonvegetarian foods.

Further, the survey showed that vitamin B12 and D3 are the top two vitamins lacking in an average daily diet across the country, followed by zinc, iron, calcium, folic acid, and vitamin C.

A whopping 73 per cent doctors and nutritionists believe that this inadequacy can be overcome with a daily dose of multivitamin-multimineral supplements.

a surprising truth: an average daily diet cannot always meet 100 per cent of your body's nutrition requirement. Including a daily multivitamin-multimineral supplement can help bridge the nutrition gap and provide your body with optimum energy and immunity levels," added Dr Jenam P. Mehta, Consultant Physician and Chest Specialist, Member of European Respiratory Society.

With Covid-19 pandemic having reset priorities, health and wellness have risen to the top of minds. Hence, meeting daily requirements of nutrients should be looked at as a growing necessity, not just an added advantage, the survey suggested.



Colombo, Sept 7: The Sri Lanka Parliament Monday passed the 'state of emergency' with claims to seize hidden food stocks amid soaring prices of food and essential items.

The ruling Gotabaya Rajapaksa government passed the state of



emergency with majority votes, with the opposition parties complaining that the law is a danger to democracy, rights and freedom of expression as the same law could be used to suppress dissent voices against the government.

Rajapaksa had August 30 gazetted state of emergency as a means to maintain food supplies and essential services during the Covid19 pandemic. The regulations had to be passed by the Parliament within 14 days

The President also appointed a senior military official in a new post titled Commissioner General of Essential Services to control the distribution of essential consumer goods, including paddy, rice and sugar. Amid the price hike, traders were hoarding essential goods like

sugar and rice. The price control imposed by the government also led to a shortage of food items like milk powder.

However, the opposition alleged that the state of emergency has been imposed not only to control essential food prices, but also to silence the dissent against the government

Tamil National Alliance (TNA) lawmaker M A Sumanthiran said there is no guarantee that the law will not interfere with the freedom of expression

He argued that the existing laws are sufficient to control the prices of food and their supplies. The law will not confine only to the essential services but it would threaten the human rights as well, Sumanthiran argued.

Bangkok, Sept 7: The main underground group coordinating resistance to Myanmar's military government issued a sweeping call for a nationwide uprising Tuesday, raising the prospect of spiraling unrest.

Perseverance rover collects first Martian rock sample



Washington, Sept 7: NASA's Perseverance rover Tuesday completed the collection of the first sample of Martian rock, a core from Jezero Crater slightly thicker than a pencil.

Mission controllers at NASA's Jet Propulsion Laboratory (JPL) in Southern California received data that confirmed the historic milestone, the US space agency said in a statement. The core is now enclosed in an airtight titanium sample tube, making it available for retrieval in the future.

Perseverance rover retrieved the rock sample at its second attempt



September 1, after failing in its first attempt in early August. While Perseverance, using its 2-metrelong robotic arm, drilled a hole on



Mars, it could not collect and store as intended in its first attempt. Our Perseverance team is excited and proud to see the system

perform so well on Mars and take the first step for returning samples to Earth, said Larry D James, interim director of JPL. After completing the coring

process, the arm maneuvered the corer, bit, and sample tube so the rover's Mastcam-Z camera instrument could image the contents of the still-unsealed tube and transmit the results back to Earth.

After mission controllers confirmed the cored rock's presence in the tube, they sent a command to

complete processing of the sample. Tuesday, at 12:34 am EDT, Perseverance transferred sample tube serial number 266 and its Martian cargo into the rover's interior to measure and image the rock core. It then hermetically sealed the container, took another image, and stored the tube.

Getting the first sample under our belt is a huge milestone, said Ken Farley, Perseverance Project Scientist at Caltech. When we get these samples back on Earth, they are going to tell us a great deal about some of the earliest chapters in the evolution of Mars.

The Mars 2020 Perseverance mission is part of NASA's Moon to Mars exploration approach, which includes Artemis missions to the Moon that will help prepare forthe first human exploration mission to the Red Planet.

Global crypto exchange enters India despite policy uncertainty

MUMBAI: US-headquartered digital currency exchange CrossTower has set up a local entity in India and launched a trading platform to capture the growing domestic crypto market, even as the fate of cryptocurrency in India is still unclear. The company said that CrossTower India has already hired 35 people and plans to increase the workforce to 100 in six to nine months. The company is following in the footsteps of market leader Binance, which entered India in 2019. According to blockchain data platform Chainalysis, India's digital currency market has grown from \$923 million in April 2020 to \$6.6 billion in May 2021. Among 154 countries, India ranks 11th in cryptocurrency adoption, it said. "India will play an important role and we plan to use the country as a hub to expand into other geographies," Kapil Rathi, co-founder and CEO of CrossTower, told Businesshala.

India continues to 'lag way behind' in vaccination: Fitch

New Delhi, Sep 7: Fitch Ratings Tuesday said India continues to 'lag way behind' in COVID vaccination, and the negative outlook on sovereign rating signifies the rising debt-to-GDP ratio.

In April 2021, Fitch affirmed India's sovereign rating at 'BBB-' with a negative outlook. The outlook was changed to 'negative' from 'stable' in June last year on grounds that the pandemic had significantly weakened the country's growth outlook and exposed the challenges associated with a high public-debt burden.

Addressing the Global Sovereign Conference 2021, Asia-Pacific, Fitch Ratings Senior Director, Head of Asia-Pacific Sovereign Ratings, Stephen Schwartz said vaccination is the key to economic recovery across the world.

'The (APAC) region which was so successful in containing the virus early on, got behind the curve when it came to rollout of vaccines. Singapore really stands out now with 80 per cent of its population being vaccinated. But many countries in the region like Vietnam, Thailand and India continue to lag way behind and as a result continue to have periodic restrictions," Schwartz said.

Over 70 crore vaccine doses have been administered so far in India. The country has administered more than 1 crore doses daily in 3 out of the last 11 days.

Schwartz further said the negative outlook in India's ratings is on account of rise in debt-to-GDP ratio and uncertainty about the 'trajectories.'

'Local industries lack adequate bauxite'

Bhubaneswar, Sept 7: Odisha Assembly of Small and Medium Enterprises (OASME), a state-level apex MSME association, appealed to the state government to provide adequate bauxite ore to local industries rather than selling it outside the state. In a letter to Chief Minister

Naveen Patnaik, OASME Chairman Gaurisankar Dash writes, "Your Government has always been sensitive to public opinion. Now the public and state's industries are humbly appealing for stopping the bauxite going outside Odisha. Our humble appeal is for immediate imposition of creation of value



addition facility as condition for taking bauxite.

"Aluminium demand may reach around 12 MnT by 2030. 8 MnT additional capacity and ₹4 lakh crore of investments are likely to be achieved. Odisha with bauxite & coal is eminently placed to get 70% of this investment i.e., around ₹3 lakh crore and employment opportunity for 1 million. Such high investment with thousands of small scale industries and huge employment is possible only if adequate bauxite resource is available in Odisha," Dash added.

The shortage of bauxite has led local traders to bring bauxite from outside the state through bauxite block auction.

The association requested for urgent action for immediate imposition of at least 70% value addition in Odisha.

OASME also urged the state government to take appropriate steps keeping in view the larger interests of the general public as well as the MSME sector of Odisha

MCL supplies 5.18L tonne coal to state's power plants

Bhubaneswar, Sept 7: Raising the bar in supply of coal to power plants, Mahanadi Coalfields Limited (MCL) dispatched over half-a-million tonne coal to consumers from its mines in Odisha.

MCL exceeded 5 lakh tonne offtake target by dispatching 5.18 lakh tonne dry fuel to coal consumers.

MCL dispatched an overall 85 rakes of coal to the power plants, as against target of 84 rakes. The supply of coal through road-mode was at 1.32 lakh tonne, up against the target of 99,000 tonne. Earlier August 30, the company had created a record

demand growth by FY2030.

Even with aggressive projec-

tions of 5 per cent annual growth

of highest ever coal dispatch by rail-mode in a single day. MCL had dispatched 102 rakes from Ib Valley and Talcher Coalfields to various consumers. MCL supplies about 150 million tonne coal to consumers across the country every year.

The company is aggressively implementing FMC (First Mile Connectivity) projects with a capital outlay of ₹3,600 crore by 2024 for rapid movement of coal to the con-

'Proposed coal power plants could jeopardise India's RE goals'

New Delhi, Sept 7: The proposed new coal-based power plants totalling 27GW could 'jeopardise' India's target of 450GW renewable energy by 2030, says a report by Ember and Climate Risk Horizons.

As per the report, 27GW of prepermit and permitted new coal power plant proposals in India are now 'superfluous to its electricity requirements.

These coal project proposals could jeopardise the achievement of India's widely-praised RE target of 450 GW by 2030," it said.

It said these surplus 'zombie' plants - assets that would be neither

dead nor alive - would require ₹247,421 crore (USD 33 billion) of investment, and yet are projected to lie idle or operate at uneconomic capacity factors due to surplus generation capacity in the system.

"As India recovers from the disruption caused by the COVID-19 pandemic, how the country uses scarce public resources will be absolutely crucial. By avoiding these unnecessary 'zombie' coal plants, India can not only save lakhs of crores of rupees, but also lower power costs and reiterate its commitment to the success of its clean energy transition goals," Aditya Lolla, Ember's senior analyst, said.

The analysis by energy experts



at Ember and Climate Risk Horizons demonstrates that India doesn't require new coal capacity

in power demand, the analysis shows that coal-fired generation in FY 2030 will be lower than in FY2020, as long as India achieves its 450 GW RE and other non-coal targets, it stated.

The report finds that over 300 GW of renewable energy (RE) commitments have already been made by India's public and private power generators. Furthermore, it stated that India can meet peak demand in FY2030 even if it retires its old coal plants and stops building new coal

beyond those under construction. By FY2030, India will have a total firm capacity of about 346 GW in addition to 420 GW of variable renewables capacity to meet an estimated peak demand of 301 GW Daytime peak demand would be easily met with India's huge planned solar capacity, while the report shows that evening peaks will be most effectively met by additional battery storage, at a lower cost than building new coal. The analysis reveals that switch-

ing investment from coal projects to renewables and battery storage would save the Indian power system an additional ₹43,219 crore (USD 4 billion) a year from 2027 onwards in terms of reduced power purchase cost - in addition to capex savings - without sacrificing thepower system's ability to meet future demand.

BOPANNA, DODIG GO DOWN FIGHTING **NEW YORK:** Veteran Indian tennis player Rohan

Bopanna and his Croatian partner Ivan Dodig fought their hearts out before losing their men's doubles third round to fourth seeds Raieev Ram and Joe Salisbury at the US Open here. Bopanna and Dodig, seeded 13th, lost 7-6(7-4), 4-6, 6-7(3-7) to the Australian Open runners-up in a gruelling contest that lasted two hours and 30 minutes Monday night. With this defeat, India's challenge has ended at the last Grand Slam of the season. Sania Mirza lost her both women's doubles and mixed doubles first rounds and Ankita Raina also lost in the women's doubles.



Stadium. That let Djokovic, above all, and everyone else, know that Brooksby - a 20-yearold wild-card entry from California who is ranked 99th and never before had been on this sort of stage belonged.

And then, not surprisingly, Djokovic showed why he is who he is and how he's managed to move within three victories of the first calendar-year Grand Slam in men's tennis in 52

Settling in and sending messages, to the fans with roars and to Brooksby with some staredowns, the World No.1 Djokovic improved to 25-0 in majors this year by winning 1-6, 6-3, 6-2, 6-2 Monday night.

He extended his pursuit of a true Grand Slam and a recordbreaking 21st major championship, while also making this the first time in the history of the U.S. Open, an event that dates to the 1880s, with zero men or women from the host country in the quarterfinals.

Diokovic hopes to add a fourth US Open title to a collection that's been boosted by his ninth at the Australian Open in February, second at the French Open in June and sixth at Wimbledon in July. He next meets No.6 Matteo Berrettini of Italy in a rematch of the final at the All England Club.

One key to Monday's turnaround: Djokovic broke in Brooksby's initial service game in each of the last three sets.

Affected by a left hip that bothered him earlier in the tournament, Brooksby was visited by a trainer after the second set and again after the third. Still, for someone who never had set foot on Ashe's blue court until about two hours before the match, when he got a chance to practice there, Brooksby never seemed overwhelmed by the setting or the circumstances

Brooksby's 6-foot-4 strides and reach, his anticipation, his variety that includes a well-disguised twohanded backhand slice, his thinksteps-ahead point construction, his commitment to patterns drawn up by his coach at home in Sacramento since age 7, Joe Gilbert all left Djokovic a tad discombobulated early.

Brooksby's exit — certainly no shame in losing to Djokovic, of course - followed the fourth-round departures earlier Monday by No.22 seed Reilly Opelka from the men's draw with a 6-7(6-8), 6-4, 6-1, 6-3 loss to Harris, and by unseeded Shelby Rogers from the women's draw with a 6-2, 6-1 loss to Raducanu.

Rogers upset Ash Barty, a twotime major champion who is ranked No.1, in the third round, but was unable to produce the same level of tennis in what she termed a "pretty embarrassing" performance Monday. The brackets began with 43 Americans in the singles fields.

DJOKO EXTENDS Vaughan takes a dig at England

London, Sept 7: Battle-hardened India exposed shortcomings of England in all departments with their famous win in the fourth Test, reckons former skipper Michael Vaughan.

India were on the backfoot initially but conjured up a comprehensive 157-run win at the Oval Monday to take a 2-1 lead in the fivematch series. Vaughan found faults in every department of the game.

"The deficiencies of England's Test team were laid bare this week in batting, bowling and fielding. They were beaten by battle-hardened opponents who know how to win the key moments," Vaughan wrote in his column for 'The Telegraph'.

"It started with their catching on day one, continued through their batting in the first innings before their bowling was exposed on a flat wicket over the weekend.

"I would like to know why in the last couple of years this fielding team has not improved. They continue to drop chances and should have bowled India out for 125 in the first innings," he said.

Vaughan said England did not make enough runs in their first innings and also questioned the shot selection of the batsmen. "England played some poor strokes through lapses in concentration. Haseeb Hameed chased a wide ball, for example, and Moeen Ali topedged one in the air when England were strolling the game. Those were poor cricket shots.

Vaughan also found "lack of intent" among England batsmen. "The run out of Dawid Malan was a prime example. If you are busy from ball one you are alert to singles but Malan was on his heels because he was not expecting that call from Hameed. That is a lack of

The former captain also did not like the way England chose their combination for the Oval Test. "Not that long ago England were saying they always wanted one pace bowler in the team. Why did they not go back to Mark Wood for this game? Not for the first time, they selected the team that did well the week before in different conditions. The mindset needs to change. They have to be smarter.

"England have to work out how to become battle-hardened when the pressure is on. I always question some of their thinking. Why did they appoint Moeen as vice-cap-

"He has barely been in the side for two years. It would have been a nice little boost for (Rory) Burns, who is a regular in the side, to be made vice-captain this week on his home ground. It was a decision that puzzled me and perhaps put more pressure on Moeen who is still making his way back in the game."

Police investigates 4 Argentines over chaos

Sao Paulo, Sept 7: Four Argentina footballers are being investigated by Brazil federal police for allegedly providing false information upon arrival here for a World Cup qualifying match.

The Brazil-Argentina qualifier Sunday was interrupted after seven minutes when agents of Brazil's health agency, Anvisa, insisted they should take England-based players Emiliano Martinez, Emiliano Buendia, Giovanni Lo Celso, and Cristian Romero to the airport for breaching coronavirus protocols.

Anvisa said Argentina soccer officials knew since Saturday that the four players — three of whom were on the field — should not play because they were in the UK 14 days before their arrival, but did not inform authorities as required. Visitors from the UK must undergo a mandatory 14-day hotel quarantine.

Brazil federal police confirmed to this agency Monday the four players received a notification to leave the country Sunday night, and had to give written statements to authorities. They flew with the rest of the Argentina squad to Buenos Aires shortly after. The match was abandoned without a

Argentina tweeted Monday that Martinez and Buendia were authorized to return to England so they could rejoin their club Aston Villa. It did not discuss the situation for Tottenham's Lo Celso and

Anvisa director Alex Campos said Argentina "repeatedly ignored the agency's recommendations. "They were first informed Saturday

morning about the players entering the country with false information," Campos told SporTV.

"We could have deported them at once. But we recommended the quarantine. There was another meeting in the afternoon, same message. And then Sunday morning we saw they had attended a training session.

"We never meant to interrupt the match. We were stopped from acting until the time the match began. Our only goal was to take the players who were challenging Brazilian regulations," Campos

"The match could have continued, the interruption was a decision by sports executives. Argentina tried to put pressure on Brazilian authorities and chose to leave if they didn't have those players.' Campos also said the four play-

ers refused to sign a notification of the incident before leaving.

The agency also had access to two documents of the Brazilian Football Confederation dated July 5 and September 2 in which it mentions new government restrictions issued June 23 for travelers who were in the UK two weeks before their arrival.

FIFA has also started an investigation. It said it has received official match reports and has passed them on to disciplinary bodies. No date for a decision has been offered, nor a date for a rematch. FIFA added it "regrets the scenes preceding the suspension of the match."
