DIESEL PRICE HIKED BY 20 PAISE PER LITRE

New Delhi: Diesel price Friday was hiked by 20 paise per litre - the first increase in rates in over two months - as international oil prices neared their highest since 2018. Price of diesel was hiked to ₹88.82 per litre in Delhi and to ₹96.41 in Mumbai, according to a price notification of state-owned fuel retailers. Petrol price was not changed. It costs ₹101.19 a litre in Delhi and ₹107.26 in Mumbai. State-owned Indian Oil Corp (IOC), Bharat Petroleum Corp Ltd (BPCL) and Hindustan Petroleum Corp Ltd (HPCL) hadn't revised fuel rates since September 5 despite a surge in international oil prices. Friday, global benchmark Brent crude rose to USD 77.50 a barrel as crude inventories shrunk from Europe to the US. Oil rates are up 2 per cent for the week and this is the fifth weekly gain.

DELHI COURT SHOOTOUT LEAVES 3 DEAD

New Delhi: Jailed gangster Jitendra Gogi was shot dead Friday inside Delhi's Rohini court by two assailants dressed as lawyers, who were also killed in a swift police counter-fire, officials said. In video footage of the shootout involving the two attackers, who were from the rival gang, gunshots could be heard and policemen and lawyers seen in a scramble, but officials said there were no further injuries or deaths. Delhi Police spokesperson Chinmoy Biswal said both assailants were dead along with Gogi. Delhi Police said in a tweet, "Two gangsters killed in immediate counterfire by Police as they opened fire in lawyers' attire at a gangster UTP (under trial prisoner) in Rohini court premises this afternoon. All 3 gangsters dead.

Modi, Biden discuss Covid, climate, Quad

Washington, Sept 24: US President Joe Biden said Friday that the relationship between India and the US, the world's two largest democracies, is destined to be "stronger, closer and tighter," as he hosted Prime Minister Narendra Modi at the White House for the first bilateral meeting and discussed a wide range of priority issues, including combating Covid-19, climate change, trade and the Indo-Pacific.

 $Modi, who is visiting the \,US \,for \,$ the 7th time after assuming office in 2014, described Friday's bilateral summit with Biden as 'important' as they're meeting at the start of the third decade of this century. "Your leadership will certainly play an important role in how this decade is shaped. The seeds have been sown for an even stronger friendship between India and the US," Modi told Biden.

Biden said the relationship between India and the US is "destined to be stronger, closer and tighter." "I've long believed that the US-India relationship can help us solve a lot of global challenges. In fact, back in 2006, I had said that by 2020 India and the US will be among the closest nations in the world," Biden told Modi.

"Today, we're launching a new chapter in the history of US-India ties, taking on some of the toughest challenges we face together,

starting with a shared commitment," he said.

Biden said he and Prime Minister Modi would talk about what more they can do to fight COVID-19, take on the climate challenge that the world face, and ensure stability in the Indo-Pacific, including with their quiet partners.

India, the US and several other world powers have been talking about the need to ensure a free, open and thriving Indo-Pacific in the backdrop of China's rising military manoeuvring in the region.

Noting that the world would celebrate Mahatma Gandhi's birthdav next week, Biden said, "We're all reminded that his message of non-violence, respect, tolerance, matters today maybe more than ever had."

On this, Modi said, "Gandhi Ji spoke about trusteeship, a concept which is very important for our planet in the times to come.

Scribe drowns during elephant rescue act

Bhubaneswar, Sept 24: Popular television journalist Arindam Das Friday died when an ODRAF powerboat engaged in the rescue of an elephant in Mahanadi capsized at Mundali barrage near Cuttack.

He along with ODRAF personnel and a camera journalist had boarded the powerboat which overturned due to the strong current in the river, the police said. He along with other journalists and three ODRAF personnel were fished out of the water in a critical state and rushed to SCB Medical College and Hospital in Cuttack. "Arindam was received dead. We tried to revive him for over an hour," SCB emmergency officer Bhubananda Moharana told reporters. His associate, camera journalist Pravat Singha is admitted to the ICU of the medicine department of the hospital. "Condition of one of the ODRAF personnel is critical." Moharana said.

Das, 39, who started his career in Odia daily Dharitri, was the chief reporter of a TV news channel. He is survived by his son, wife and mother. He had covered all major events - from natural calamities like cyclones Phailin, Fani anti-naxal operations, crime as well as forest and wildlife. Das had gone to the bank of Mahanadi to cover the rescue of the elephant trapped in the swollen river as part of his assignment. MORE ON P3



Bhubaneswar, Sept 24: The India Meteorological Department (IMD) has issued a pre-cyclone watch for north Andhra Pradesh and adjoining south Odisha coasts.

Under the influence of the cyclonic circulation over east-central Bay of Bengal and neighbourhood, a low pressure area has formed over the same region, which became well marked and subsequently, concentrated into a deression, the IMD said in a spe-

cial bulletin this evening. The system is located about 670 km east southeast of Gopalpur (Odisha) and 740 km east of



Kalingapatnam (Andhra Pradesh). It is likely to intensify into a deep depression during the next 12 hours and intensify further thereafter,

the bulletin said. The IMD further said it is likely to move initially west-northwestwards during next 24 hours and west-southwestwards thereafter and cross south Odisha-north Andhra Pradesh coasts between Visakhapatnam and Gopalpur around Kalingapatnam by evening

of September 26, 2021.

Squally wind speed reaching 40-50 kmph gusting to 60 kmph is likely along and off Odisha coast from September 25 morning. It will gradually increase, with gale speed reaching 70-80 kmph gusting to 90 kmph from afternoon of September 26 till midnight along and off north Andhra Pradesh and adjoining south Odisha coasts. it said. As sea conditions would be rough, fishermen are advised not to venture into sea, along and off Odisha coast northwest and adjoining west-central Bay of Bengal

from September 25 to 27. Under its impact, many parts of Odisha will receive heavy rainfall during next five days. Heavy rainfall would occur in some places of Bhadrak, Kendrapara, Cuttack, Jagatsinghpur, Puri, Khurda, Nayagarh and Ganjam districts

Hotel told to pay ₹2cr to woman for 'shoddy haircut'

The woman who aspired to become a top model was shattered as staff at the ITC Maurya Salon not only gave her a bad haircut but also exhibited medical negligence in hair treatment

New Delhi, Sept 24: The National Consumer Disputes Redressal Commission has awarded a whopping ₹2 crore compensation to a woman whose dream to be a top model was shattered due to a haircut gone wrong by ill-trained staff at ITC Maurya Salon in the capital. A bench of President Justice RK Agrawal and member SM Kantikar said: "There is no doubt that the women are very cautious and careful with regard to their hair. They spend a handsome amount on keeping the hair in good condition. They are also emotionally attached with their hair."

The commission directed ITC to pay ₹2 crore to complainant Aashna Roy within eight weeks for deficiency in service under the Consumer Protection Act. "The Opposite Party No 2 is also guilty of medical negligence in hair treatment. Her scalp was burnt and still there is allergy and itching



due to fault of the staff of Opposite Party No 2," noted the commis-

sion, in its order of September 21. Roy said she has undergone severe mental breakdown and lost her selfesteem, and also refrained from social

activities. "She is a communication professional and required to be involved in meetings and interactive sessions. But she lost her self-confidence due to little hair. She has also suffered loss of income due to mental breakdown

after the shoddy haircut and thereafter the torturous hair treatment. She left her job also," noted the bench.

The bench said Roy has been a model for hair products because of her long hair and she has done modelling for big brands. "But due to hair cutting against her instructions... she lost her expected assignments and suffered a huge loss which completely changed her lifestyle and shattered her dream

to be a top model," it added. The commission said: "There is no doubt that realising the mistake done by its staff, the Opposite Party No 2 offered the free hair treatment to the complainant and complainant was not attended to for a gesture. Hence, we are of the considered view that the complainant is a consumer.

Roy, in her plea, submitted that she went to the salon, which she used to visit since 2004, April 12, 2018, for "hairstyling to have a clean and groomed appearance before the interview panel." However, the hairdresser, chopped off her entire hair leaving only 4 inches from the top and barely touching her shoulders which she had not instructed.

She was again called May 3, 2018, after complaining to the management, for hair treatment. However, during treatment, her hair andscalp got completely damaged with excess ammonia.







State sees dip in daily cases

Bhubaneswar: The Covid-19 caseload in Odisha dipped a little in comparison to a day before with 539 people testing positive for the viral infection during the last 24 hours, a Health official said Friday. Information and Public Relations (I&PR) department sources said that the 539 fresh cases included 316 from quarantine and 223 local contacts. It also included 77 children in the age group of 0 to 18 years. Khurda district, of which state capital Bhubaneswar is a part, reported 254 Covid cases, the highest in the state, followed by Cuttack (48) and Balasore (23). Five districts reported no cases. The Capital city Bhubaneswar reported 218 positive cases during the last 24 hours. The death toll in the state due to Covid rose to 8,163 Friday with the report of six more deaths— three each from Cuttack and Sundargarh— in the last 24 hours. The state has now 5,829 active cases and 10,23,133 total positive cases.

State notifies amended Panchayat poll laws

Bhubaneswar, Sept 24: The state government has issued gazette notification of the amended Panchayat Acts to cap the reservation of seats in the three-tier Panchayati Raj system at 50 per cent for all the three categories comprising STs, SCs and OBCs.

After receiving accent from the Governor, the Law department has issued the notification of the Odisha Panchayat Laws (Amendment) Act, 2021. The Assembly had passed the Bill September 8 this year.

The Act amended relevant provisions of Odisha Grama Panchayat Act, 1964, the Odisha Panchayat Samiti Act, 1959 and Odisha Zilla Parishad Act, 1991, Panchayati Raj and Law Minister Pratap Jena said while piloting the Bill. The amendments in the above three Acts have been made to fix the upper ceiling of reservation of seats for SCs, STs and OBCs at 50 per cent. As per Article 243-D of the

statute, the state government has the discretion of reserving seats for OBCs and accordingly, the Odisha Grama Panchayat Act, 1964, the Odisha Panchayat Samiti Act, 1959 and Odisha Zilla Parishad Act, 1991 have been amended to provide 27 per cent of reservation for OBCs in the elections to PRIs.

Similarly, quota for SCs and STs, as per provision of the Constitution, has been fixed in proportion to their population in Odisha.

HIGH COURT ORDERS STAY ON PUBLIC HEARING TILL NOV 24 IN KEONJHAR

Keonjhar, Sept 24: The Orissa High Court has ordered a stay on the public hearing by the administration about a steel project proposed by the state government at Karakhendara under Barbil teshil of Keonjhar district. This has pushed the project into uncertainty, reports said.

Some people to be affected by the steel plant project have been opposing it for a long time. They alleged that a grama sabha was organised for the project January 16, 2021, seeking people's approval for the project, but the grama sabha was in violation of some guidelines.

"The grama sabha was held in the absence of the local sarpanch. People opposing the project were not allowed to express their views. It was in violation of the guidelines," locals said. Upset, they had also taken up the issue with the district administration.

However, despite all this, the administration did not scrap the public hearing, they lamented. Later,

Hinjili: Plant set up to recycle fish waste

Berhampur, Sept 24: Fish waste will no longer be useless in Hinjili town of Ganjam district as the civic body authorities have set up a processing plant to recycle it into value-added products, mainly liquid fertiliser, an official said Thursday.

The composting unit will process the waste and produce fish amino acid, an organic compound used by farmers to increase yield, Hinjili Municipality executive officer Manoranjan Sahu said.

"Around 20-25 kg of waste is collected from fish markets in the municipality area every day, and its processing has been started on an experimental basis." he said.

The fish amino acid would be produced after 21 days of processing of the waste, he said, adding that around ₹5 lakh has been invested to set up the unit and install two grinding machines.

Govt bends to SC

overnment watchers are keenly watching the ongoing crosstalk between the Supreme Court and the Central government over the lat-I ter's delay in filling the vacancies in the National Company Law Tribunals (NCLT) and the National Company Law Appellate Tribunal (NCLAT). The vacancies have slowed down the insolvency proceedings thanks to the huge backlog of pending cases. The current strength of the former is only 30 members against a sanctioned strength of 63, while the latter is functioning with only eight members against the sanctioned 11 members. Further, both tribunals have functioned without a full-time chairperson

Stung by sharp criticism from the apex court on the delay, the government hastily announced the appointment of 18 more members to NCLT and also announced another acting chairperson for NCLAT. Unfortunately for the government, the SC remains unmoved. None else than Chief Justice NV Ramana has expressed displeasure at these new appointments, stating that the government ignored the candidates recommended by the selection committee. Now the government has agreed to reconsider these appointments within two weeks, essentially going back to the start-

Meanwhile, the apex court also wasn't equally harsh on the government for prematurely terminating the tenure of the acting chairperson of

NCLAT Justice Ashok Iqbal Singh Cheema. It forced the government to reinstate Justice Cheema to be able to deliver the verdicts he was writing or face the event of the new law on tribunals being



The Centre has been forced to concede, but the Supreme Court is unlikely to take its eye off the issue. Watch this space for updates.

The indispensable babu

Retirement age is only a number if you can make yourself indispensable. Gujarat cadre babu K Kailashnathan knows this well. Though the 1979-batch IAS officer retired from service in 2013, he has since continued to work as Chief Principal Secretary to the Chief Minister of the state. Since then, several CMs have come and gone, including but Kailashnathan seems to have become a fixture in the Chief Minister's Office. After the new Chief Minister Bhupendra Patel was sworn in, among the first things the new dispensation did was to renew Kailashnathan's contract, yet again.

Clearly no rolling stone, the babu has found a way to make himself irreplaceable to whoever becomes the CM of Gujarat. He has been a constant in the tenures of former Chief Ministers Narendra Modi, Anandiben Patel and Vijay Rupani and is now going to serve Patel. Even for the BJP government, which is quite generous in giving extensions to its favourite babus, this is a rare extravagance, which may puzzle many – unless some insiders choose to spill the beans on the babu's extraordinary longevity in the corridors of power.

Gaping holes and now less hope

An unprecedented new situation has developed at the secretary-level in the Modi sarkar. The 'babu shortage' at the Centre and also in multiple states, pointed out in this column in detail, now threatens to become a fullblown crisis if the government does not act fast. Fortunately we know, it

There are 13 secretary-level vacancies, including in the all-important PMO, and with seven secretaries poised to retire at the end of the month, the number will shoot up to 20! The empty big rooms at the top mean that Cabinet Secretary Rajiv Gauba and Personnel Secretary Deepak Khandekar are under immense pressure to end this peculiar situation swiftly if it is in their hands to do so.

Currently, sources inform DKB, at least 11 secretaries are holding a dual charge, and one is holding three responsibilities. SK Singh who is secretary of the Department of Administrative Reforms is also overseeing the Department of Pensions and the Ministry of Development of the North-East Region. At least two of those functions are critical. Meanwhile, the newly created Cooperation Ministry is still awaiting its first-ever secretary.

What makes all this more intriguing is that even as these vacancies grow, many officers of the 1989 batch who were empanelled for Secretary-level posts back in February are still waiting and hoping that they may be summoned for these vacant slots. All these positions are critical ones, but the decision-making has increasingly become painfully slow

The gradual loss of their hallowed turf during the NDA regime has been a sore point for the IAS lobby. But further delay in filling vacancies will reduce hope even among the promoted ones.

Deople have been confused about the names and natures of exotic animals for millennia. The camel's name in medieval English was olfend, a word that has been defunct for eight centuries. This was known in earlier Germanic languages and also in Old Church Slavonic (where it was taken to mean "great wandering beast"), but it can be traced back to the Latin elephantus. Basically, people confused the camel with the elephant, not so surprising when you've never seen either and you have to rely on travellers' descriptions relayed many times. Another confusion led to the camelopard, a linguistic cross formed in classical Greek between a camel and a pard or panther. The camelopard wasn't thought to be a hybrid but the name was given to it because its body looked like that of a camel with spots like those of the leopard. We prefer to call it a giraffe (from Arabic zarāfa). The animal called a leopard is the result of yet another confusion - its name is lion + pard, because the ancients believed it was a cross between the two. A camelion, however, has nothing to do with camels. The first part comes from a Greek word meaning "on the ground, dwarf", so the animal was a "ground lion" or "earth lion", which you may feel is an odd way to describe a small lizard. In the fourteenth century, the word became confused with camelopard because of a scribe's error in a text read by the Bible translator John Wyclif and for a while it became identified with the giraffe. It was only a couple of hundred years ago that its name changed from camelion to chameleon under the influence of the Latin version of its name.

FOCUS CARBON REMOVAL

TALK ABOUT GEOENGINEERING

√here ultimately is no way to stabilise the climate without addressing the fact that humans are emitting far too much carbon dioxide into the atmosphere, year after year. But cutting emissions is not the only response to the climate crisis, nor was it the one that scientists proposed over half a century ago in the first-ever government report on climate change

To address the problem of "Atmospheric Carbon Dioxide," noted US President Lyndon B. Johnson's Science Advisory Committee; the "solution" could not be to emit less of the stuff, because that apparently seemed unimaginably costly and difficult to do. Instead, the committee suggested that the effects of excessive CO2 in the atmosphere might be mitigated by brightening the world's oceans to radiate more heat back into space.

Since then, many additional methods of "geoengineering" have been proposed by both scientists and science-fiction authors alike. Some ideas are more realistic than others, and none can substitute for the top-order priority of severing the link between economic activity and CO2 emissions. Nonetheless, emissions represent only the first of many links in the long causal chain from economic activity to climate crisis.

Economic activity produces emissions that drive up atmospheric concentrations, which in turn increases temperatures, thereby creating new conditions that are damaging to human welfare. Whereas cutting CO2 and other greenhouse-gas emissions addresses the first part of the chain, climate adaptation concerns the latter end - from changing temperatures to the impact on society. But the tail end should not necessarily come last in the sequence of our response. If anything, we should have introduced more aggressive adaptation measures a long time ago.

This delay owes much to a previous, longstanding fear among environmentalists that the mere mention of adaptation would undermine the primary aim of cutting carbon emissions. According to this argument, adaptation would

create a "moral hazard": the idea that insulating people from the consequences of their actions will lead them to engage in even riskier

Most environmentalists have since changed their tune, however. In the mid-1990s, then-US Vice President Al Gore avoided discussing adaptation lest it detract from carbon-cutting efforts. Yet, by the early 2000s, he and most others had begun to include it as a point of emphasis alongside mitigation. And by 2013, adaptation was a key tenet in a climate-policy blueprint issued by President Barack Obama's Council of Advisers on Science and Technology.

But mitigation and adaptation do not exhaust all the options. Carbon removal specifically breaks the second link in the chain, from emissions to concentrations. Technically, emissions could stay the same, while removal sucks enough carbon out of the atmosphere to decrease concentrations, lessening the net effect and giving rise to many a "netzero" climate commitment.

That sounds like a win-win. But it turns out to be a rather expensive proposition, especially when looking beyond trees and other "nature-based" solutions. While these remove carbon from the atmosphere, they retain it in the biosphere and are vulnerable to deforestation and natural disasters alike. As with adaptation in earlier

decades, the prospect of carbon removal brings moral hazard to the fore, raising many difficult political questions. With so many opportunities for mitigation available. can we really justify subsidies for expensive carbon-removal technologies? Moreover, why should big polluters be let off the hook?

That second question goes to the heart of many political debates around climate and economic policy more broadly. Is climate change caused by too much pollution, or is it a problem of economic growth itself? Those who believe it is the latter argue for a full-scale reining in – or rechanneling-of economic activity and market forces; some even call for "degrowth" and other more sweeping societal transformations.

The political dynamics driving the carbon-removal debate are even stronger in discussions of solar geoengineering. By reflecting more of the sun's radiation, this potential intervention aims to break the link between atmospheric CO₂ and rising temperatures. It would not address ocean acidification and other problems directly tied to higher atmospheric concentrations, but it could have its own advantages. Chief among these is that the effects could be virtually immediate, reducing temperatures within months and years, rather than decades and centuries

Serious discussions of solar geoengineering have long since moved on from the Johnson White House's ideas about brightening the world's oceans. The most-discussed method today envisions the seeding of small reflective particles into the lower stratosphere to mimic the global cooling effects of large volcanic eruptions.

Some describe this scale of geoengineering as a "last-ditch" option that should be reserved only for a planetary emergency. Others emphasise that it should be viewed only as a potential complement to serious emissions reductions and other interventions – from adaptation to carbon removal with each addressing climate risks

But, again, those who merely argue for more research into solar geoengineering usually meet with strident "moral-hazard" objections as if simply studying the issue will distract from emissions cuts. We must move beyond that argument. Remember, adaptation measures used to be viewed the same way.

Regardless of whether one believes that solar geoengineering is inherently dangerous, potentially useful, or both, one should support more careful, open, and trans parent research into the matter We are not in a position where we can peremptorily reject potential solutions to the climate crisis. If nothing else, geoengineering research could help to educate those who are still dragging their feet on emissions reductions.

After all, by failing to break the other links in the climate chain, we are making it more likely that either carbon removal or solar geoengineering will become a key element in the twenty-first-century climate-policy portfolio whether one likes it or not.

omestic aviation has not been ₹7.000-plus while train travel would able to fly in the past decade. Air India has been running in loss for many years, Jet Airways has gone bankrupt, Spice Jet nearly went under and the profits of Indigo Airlines have taken a hit. All these took place before the Covid-19 pandemic which has only made things much worse. The reason is that the government has been focusing on improving regional aviation while the opportunity lies in long distance flights.

The cost of AC 2-Tier train travel from Delhi to Bangalore in an express train is ₹2,925. In comparison, an air ticket purchase one-month ahead is available at ₹3,170 — which is nearly equal to the AC2 fare. The difference is that AC2 travel takes two nights and one day and involves expenditures of food during this period. The cost becomes more when the food expenditure is added. In comparison air travel from hometo-home takes only about seven hours. Therefore, air travel is successful both in terms of time and cost. However, short notice air travel becomes less competitive. In that case, air travel may cost cost the same ₹2,925 if tickets are available. This shows that air travel is basically successful for long distances.

Compare this with medium distance travel, say, between Delhi and Lucknow. AC2 ticket fare is ₹1,100, while an air ticket purchased one-month before costs ₹1,827. The time taken in hometo-home rail travel is 10 hours against only 5 hours for air travel. However, train travel can be undertaken during the night while air travel has to be undertaken during the daytime and cuts into working hours. The productive day time is lost in air travel. Thus, medium distance travel is successful by train. Only those reluctant to undertake night travel; say for health reasons, train tickets not being available, or having some urgency to reach the destination, may undertake air travel for medium distances

Another policy being pursued by the government is to improve air connectivity with tourist places like Assam and Andaman Islands. Here the problem is systemic to the tourism sector that is beset with problems of law and order, lack of social cohesion and lack of investment in marketing. Tourismoriented civil aviation will succeed only if tourism succeeds, but it shows no signs of happening in the near future

It appears that these factors have been ignored by various agencies repeatedly. The government had set up a working group to suggest policies for the expansion of domestic aviation in 2012. The group recommended that subsidies may be given to regional aviation. Subsequently, the government formulated a National Civil Aviation Policy after which the government started providing subsidies for three years to regional flights. Recently in 2018, Deloitte Consultants have suggested expansion of aviation to smaller towns. All these reports have not delivered because an equally efficacious, if not better alternative of train travel, is available. The improvement of roads in the recent time has made available yet another alternative to air travel for medium and short distances. Travel from Delhi to Dehradun by road or air: for example, would take about the

same 4 hours. However, road travel would not require standing in queues at check-in counters, security check, boarding the aircraft and collecting baggage. Thus, the policy of promoting regional civil aviation is a failure and will continue to be so. The government must instead focus on making long distance air travel more convenient. The recent proposal to expand the Indira Gandhi International Airport at Delhi is thus a step in the right direction. Further, road connectivity to the airports must be improved. The time taken for security check and baggage checkin must be cut. I know of travelers who arrive at airports in London merely 15 minutes before take-off and board the flight seamlessly.

The government must improve the road and metro connectivity to the airports and sort out the kinks in the security checks and other harassments faced by the passengers. These steps could possibly help in jumpstarting regional aviation as well.

Rasulpur, Sept 24: Non-inclusion of artisans other than weavers by NABARD for monetary assistance has triggered resentment among people of Gopalpur village under Prathamakhandi panchayat in Rasulpur block in Jajpur district.

During the recent visit of NABARD chairman GR Chintala to the village, only 250 weavers were picked for assistance. This sparked dissatisfaction among other artisans in the village. It was alleged that the role of NABARD in the development of rural areas

has knowingly been squeezed. During the chairman's visit, a programme was held where it was announced that 250 weavers from Gopalpur village will receive assistance of ₹50 lakh as loan from NABARD. The money will be utilized for procuring raw materials, weaving clothes, designing them and creating a proper market for their products.

NABRAD plays a vital role in the progress of agriculture and rural areas. Besides this, one of its objectives is also to find out those families involved in the nonfarm sector and make them self-reliant by providing them loans.

But the inclusion of only 250 weavers has not gone down well with the rest of the weavers and those associated with non-farm sectors. There are over 5,000 weavers and over 4,000 families who earn their livelihood by making brass and bell metal wares, terracotta products, bamboo articles, wooden and cane furniture and other products.

These families are now passing through a very difficult phase. The outbreak of Covid-19 has dealt a severe blow to their business. "Some of these artisans should have been included in the programme," some villagers observed.

Waste treatment plants in tardy pace Cashew orchard disappears

Bhanjanagar, Sept 24: Work on the solid and liquid waste treatment plants to be set up in all 12 panchayats under Bhanjanagar block in Ganjam district is progressing at a snail's pace. Locals are deprived of the benefits of a clean environment.

Launched by the block administration, the project is moving at a slow pace because of several reasons including poor management and lands for the plants not being identified as yet.

However, setting a target of completing the construction of these plants in 12 panchavats within coming 100 days, the block administration has already started preparation. In this regard, a meeting was convened at the block conference hall Tuesday where block development officer Anil Kumar Sethi, who presided over the meeting, discussed about how the proj-



ect will succeed.

As per discussions, self-help groups (SHGs) will manage the plants in the panchayats. This will not only benefit SHGs but help improve rural sanitation. There will be dustbins for the people. Instead of throwing household garbage here and there, they will put it into them. These dustbins will be provided to them by the panchayats.

Among others, the meeting was attended by block assistant executive officer Ghanashyam Dakua

and engineer of the rural piped water supply department Aswini

But the reality is that people of the identified panchayats are yet to get dustbins. On the other hand, the battery operated vans provided to the panchayats to collect wastage are lying unused. While the work on the mini treatment plant at Kulad is in its last stage, the same at Badakodanda has been left halfconstructed.

With the plant construction work

not yet completed, people are throw ing household garbage here and there, resulting in the government's objective dashing to the ground and people being forced to live in

an unhygienic atmosphere. The panchayats that have been identified to get the treatment plants in first phase are Kulad, Badakodanda, Lalsingh, Mujagarh and Gallery. Similarly, in the second phase, Golapeda, Dihapadhal, Baunsalundi, Dadaralunda, Lembehi, Turum and Baibali are

When approached, senior officer Duma Hembram denied commenting on this, saying ask the ones who are in charge of the orchard. Scores of plans and schemes are being launched in villages. But these projects invariably fail as concerned officials hardly show interest for their success. These days Sialjore village is infamous for corruptions in digging up ponds and preparing orchards.

Local residents demanded that the Sundargarh Collector order an enquiry and take action against those who are found responsible for the failure of such profitable projects.

'Hilsa' lovers make do with baby 'Hilsa'

Bhograi, Sept 24: The very mention of 'Hilsa' fish makes the nonvegetarians' mouths water. But this silver-scaled fish, specifically the big ones, is fast disappearing from their plates as the big size of this variety is getting scarce.

As the demand for the fish is high, the fishermen are making do with baby Hilsa. And so are the 'Hilsa' lovers.

Because of low pressure-induced rains, Hilsa fish is heading towards coasts. For a week now, baby Hilsa is caught abundantly at places like Udaypur, Talasari, Bichitrapur, Kirttania, Choumukha, Dagara, Bahabalapur and Kashaphal along the Balasore coast and at fishing harbours at neighbouring Digha, Shankarpur, Tazpur, Mandaramani and Junaput.

During monsoon, Hilsa from Myanmar and Bangladesh do come from deep sea to coasts and estuaries in large numbers to get sweet water and lay eggs. Now being the



favourable time to catch 'Hilsa', fishermen are sailing into deep sea and return with 'Hilsa' Hundreds of trawlers are leaving from the fishing harbours on a daily basis. But the plight is that big size Hilsa is eluding their nets. At the end of the day, they have to make do with baby 'Hilsa'

The demand for baby 'Hilsa' is not so high in the market. As of now, since the market is glutted with this fish, its price has witnessed a fall. While a 'Hilsa' fish weighing below 500 grams is currently selling at ₹200 to ₹300 a kilogram, the same fish weighing over 500 grams is fetching something between ₹500 to ₹1,000 per kg.

Regarding the reason why bigger size 'Hilsa' is disappearing, the experienced fishermen and oceanographers are sharing a theory that the harsh sound produced by the fishing trawlers and wastewater discharged into the sea by the industries are the two main reasons why big size Hilsa is not available.

The fishermen say the big size 'Hilsa' has been elusive for the lastthree years. This year it seems the climate is favourable, they added.

Calcutta HC reserves order on Bhabanipur by-poll

BENGAL CHIEF MINISTER MAMATA BANERJEE IS A CONTESTANT. IS SCHEDULED SEPTEMBER 30

Kolkata, Sept 24: The Calcutta High Court Friday reserved judgment on a PIL questioning the Election Commission's contention of a "constitutional exigency" for holding by-election to Bhabanipur assembly seat in Kolkata.

A division bench comprising Acting Chief Justice Rajesh Bindal and Justice Rajarshi Bharadwaj concluded hearing in the matter on Friday and reserved judgment on it.

Election to Bhabanipur seat, where West Bengal Chief Minister Mamata Banerjee is a contestant, is scheduled September 30.

The petitioner claimed that the EC had said in a press note that it decided to hold by-election to Bhabanipur constituency "considering the constitutional exigency and special request from State of West Bengal"

He pleaded the commission cannot be doing so, and as such the court should interfere into the

The EC, on its part, said the petitioner is attempting to mischaracterise the meaning of the term constitutional exigency, maintaining that there can be no possibility of the same being construed as an influence on voters.

Mamata Banerjee has to win to the Bhabanipur Assembly by-election to stay on as Chief Minister

Kolkata, Sept 24: Raking up her defeat from Nandigram in the Assembly elections earlier this year, Trinamool Congress chief Mamata Banerjee has again claimed that the vote was rigged.

Banerjee, who is her party's candidate for the Bhabanipur Assembly by-poll, has to win to stay on as Chief Minister.

Addressing a public meeting ahead of the September 30 by-poll at Chakraberia in Bhabanipur, she said. "I will prove it in court that the Nandigram vote was rigged From day one, they (BJP) conspired against me. They injured my leg as a result of which I had to campaign all through the Assembly election in a wheelchair. But I wasn't ready to accept defeat.

She claimed that the BJP wouldn't even have got 30 seats if the polls were held free and fair.

In the run-up to the polls, which were held between March and April, Banerjee took everyone by surprise with her announcement that she would contest the Nandigram constituency against East Midnapore against onetimelieutenant-turned-BJP candidate Suvendu Adhikari.

The outcome of the polling April 1 literally came down to the last round of counting and was eventually decided in favour of Adhikari by a margin of 1,956 votes. He was subsequently made the Leader of

Opposition in the state Assembly. She yet again exhorted all voters to step out and exercise their franchise, come rain or shine. Rain is forecast for September 30. "I request everyone to go out and vote even if it rains.'

Flashing the victory sign at voters in Chakraberia, the Trinamool supremo said it was destiny that brought her back to Bhabanipur for a by-poll that will decide if she remains chief minister. "'B' stands for Bhabanipur and also for Bharat. Remember that," the CM said.

"Vote even if it rains. I will stand to suffer if I don't get every single one of your votes. Don't be complacent in assuming that my victory is guaranteed. Please don't do that. If you want to see me as chief minister, you must vote for me. Every vote is crucial. If I do not win, someone else will become the chief minister as we are in majority," Banerjee said.

Electrocution deaths: A cause of worry for Bengal

IN THE LAST TWO DAYS, 13 PEOPLE DIED OF ELECTROCUTION IN THE WATERLOGGED STREETS OF KOLKATA AND ITS ADJOINING AREAS

Kolkata, Sept 24: The death of two minor girls – 13-year-old Anushka Nandi from Bandhab Nagar Colony and 12-year-old Sneha Banik from the Motijheel area, who were electrocuted after coming in contact with an electric pole, a portion of which was submerged in a waterlogged area, has exposed the state government's inability to protect lives from unsafe and faulty electric supply system.

In the last two days, 13 people died of electrocution in the waterlogged streets of Kolkata and its adjoining areas.

"There are many open ends of wires inside the uncovered boxes at the base of electric lamp posts. When the streets are waterlogged, these live wires remain submerged electric

That was the case of Anuska both students of Class VI, were rushed to the state-run RG Kar Medical Hospital, but were declared dead on arrival.



Delhi court shootout leaves three dead

MEMBERS OF A RIVAL GANG ENTERED THE PREMISES DRESSED AS LAWYERS AND OPENED FIRE

New Delhi, Sept 24: Jailed gangster Jitendra Gogi and his two assailants posing as lawyers were killed inside a crowded Rohini courtroom Friday in a dramatic shootout that also saw the police fire bullets in retaliation, officials said.

Video footage of the incident, which exposed security lapses in the system, showed policemen and lawyers rushing out in panic as gunshots rang out inside courtroom number 207.

The two gunmen dressed as lawyers belonged a rival gang, officials said.

Witnesses said a woman lawyer also received a bullet injury in her leg and one claimed that the gang members pumped 10 bullets into Gogi

Police said the incident happened around 1.15 pm when Gogi was taken to the courtroom for a

"For the first 15 minutes, I could not figure out what was happening there." Advocate Manoj Kumar Nigam, who was also there, said a woman lawver has received a bullet injury in her leg.

A senior police officer said that Gogi was escorted by members of the counterintelligence unit of the Delhi Police's Special Cell.

'When Gogi entered the courtroom, the two assailants in lawyers' uniform opened fire on him. Immediately, the personnel from the counterintelligence team retaliated and the two assailants died on the spot," he said.

The joint commissioner of police (northern range) has been asked to enquire into the incident and submit a report. Some lawyers claimed this is not the first such shootout incident at the Rohini court.

"I was stepping out of the court when the incident happened. I heard firing and later more rounds were fired...This (incident of firing) has happened for the fourth or fifth time at Rohini. So, the situation has not improved," said advocate Rajiv Agnihotri.

Jitender Maan alias Gogi, who carried a reward of ₹6.5 lakh on his head, was arrested along with his three accomplices -- Kuldeep Naan alias Fajja, Kapil alias Gaurav and Rohit alias Koi -from Gurgaon by a team of Special Cell in March last year, according to police.

The Special Cell was on the lookout for Gogi, Fajja and Gaurav for a long time before tracing them to their hideout in Gurgaon.

A few months ago, Fajja had managed to escape from the police custody when he was being produced in the Karkardooma court, another senior police official said

Since that incident, the counterintelligence team of the Special Cell escorted Gogi and his associates to the court for hearings, he said.

UPSC ALLOWS UNMARRIED WOMEN TO APPLY FOR NDA

New Delhi, Sept 24: The Union Public Service Commission (UPSC) has allowed unmarried women to apply for the national defence academy (NDA) and naval academy exam, an official statement said Friday.

The move follows a **Supreme Court directive** on the issue last month

In compliance with the apex court's interim direction, the UPSC has decided to open the application on upsconline. Nic. In for this exam to enable "unmarried women candidates only" who are otherwise eligible in terms of nationality, age, educational qualification etc., the statement said.

Physical standards and the number of vacancies for women candidates would be notified after it is received from the Ministry of Defence, it said.

The application window will remain open for women candidates from September 24 to October 8 (till 6 PM), said the statement issued by the UPSC. No application will be accepted beyond the prescribed last date/time, i.E., 08.10.2021(till 6 PM) or through any mode other than the aforesaid online mode, it said. "Women candidates are not required to pay fee for their application for this examination," the statement said. The examination is scheduled to be held November 14, an official said.

The admission of the women candidates in the national defence academy and naval academy examination (II), 2021, will remain provisional and subject to the final outcome of a writ petition pending in the court or such other order(s) as may be passed by the Supreme Court and action by the government of India in the matter, the statement said.

THE MINISTRY OF DEFENCE ANNOUNCED THAT IT HAS SIGNED A ₹22,000-CRORE **CONTRACT WITH AIRBUS FOR 56 C-295 MEDIUM** TRANSPORT AIRCRAFT FOR THE INDIAN AIR FORCE

New Delhi, Sept 24: Indian Defence Ministry signed contract worth around ₹22,000 crore with Airbus Defence and Space, Spain Friday for procurement of 56 C-295MW transport aircraft for the Air Force.

The C-295MW aircraft is a transport aircraft of five to 10 tonne capacity with contemporary technology. It has a rear ramp door for quick reaction and para dropping of troops and cargo.

Of these 16 aircraft are to be delivered in flyaway condition from Spain and 40 are to be manufactured in India. These 56 C-295MW transport aircraft will replace the ageing Avro aircraft of the Indian Air Force. On September 8, the government had approved procurement of 56 transport aircraft from Airbus Defence and Space S.A for the Indian Air Force. The Cabinet Committee on Security approved the procurement of 56 C-295MW transport aircraft. Sixteen aircraft will be delivered in flyaway condition from Spain within 48 months of signing of the contract and 40 will be manufactured in India by TATA Consortium within ten years of signing of the contract.

This is the first project of its kind in which a military aircraft

will be manufactured in India by a private company. All 56 aircraft will be installed with indigenous Electronic Warfare Suite. "The project will give a boost to the aerospace ecosystem in India wherein several MSMEs spread over the country will be involved in manufacturing parts of the aircraft," the ministry had said. This will provide a major boost to the 'Atmanirbhar Bharat Abhiyan' (Self-Reliant India Campaign) as it offers a unique opportunity for the Indian private sector to enter into technology intensive and highly competitive aviation Industry. The project will augment domestic aviation manufacturing resulting in reduced import dependence and expected increase in exports. A large number of detail parts, sub-assemblies and major component assemblies of aero structure are scheduled to be manufactured in India.

The programme will act as a catalyst in employment generation in the aerospace ecosystem of the country and is expected to generate 600 highly skilled jobs directly, over 3000 indirect jobs and an additional 3,000 medium skill employment opportunities with more than 42.5 lakh man hours of work within the aerospace and defence sector of India.

New Delhi, Sept 24: A special study, conducted in the age group of 18-50 years, across four cities, has shown that 44 per cent of the urban millennials skipped breakfast during Covid times.

The study was done between March 2020 and February 2021 by London-based market research major Euromonitor International and PepsiCo India through its

According to an official release, the study highlighted that 44 per cent of urban millennials skipped breakfast and delayed meals due to increased household chores and late start to the day.

The study further pointed out that increased consumption of fruits, vegetables, and whole grains, including oats, emerged as the key trend during the pandemic.

Titled "Changing lifestyles and dietary habits of Urban Indian consumers post Covid", the study was conducted involving 1,000 respondents in the age group of 18-50 years, focusing on urban millennials in Delhi, Mumbai,



Bangalore, and Kolkata. The study analysed the changing lifestyle

and dietary patterns of people post-Covid to understand consumer behaviour.

It tracked a changing pattern, particularly amongst urban millennials towards dietary habits for a healthy immune system and maintaining weight.

The study also mapped if changed behaviours would sustain in the future and outlined the fact that weight watchers must understand the significance of having meals on time and consuming nutrient-rich breakfast.


Further, it found that 71 per cent. of urban millennials leaned towards the popularity of fad diets,


including keto, intermittent fasting, and weekly detox plan, among others to maintain weight.

Vidhi Sharma, consultant, Euromonitor International said, "While millennials acknowledge the importance of breakfast and believe that it should have wholesome nutrition, they often tend to skip breakfast due to their work schedules or tend to just grab a quick snack in the morning. Popular fad diets are supporting this behaviour of skipping breakfast."

Talking about the study findings, Sonam Vij, Associate Director and Category Lead - Quaker Portfolio, PepsiCo India said, "Urban millennials are now increasingly focusing on improving their physical and mental health that constitutes an active lifestyle. We also see that they are shifting to food choices for a healthy immune system as shown by the study.'

Further, according to the report, with immunity emerging as one of the top concerns among the urban millennials, nearly "60 per cent" of them admitted of starting doing "yoga and walking/running" during the COVID-19 pandemic for their physical and mental wellness.

Modi meets Harris; discusses bilateral ties

Washington, Sept 24: Prime Minister Narendra Modi has described India and America as "natural partners" as he held the first in-person meeting with Vice President Kamala Harris at the White House during which they decided to further cement the Indo-US strategic partnership and discussed global issues of common interest, including threats to democracy, Afghanistan and the Indo-Pacific.

"India and America are natural partners. We have similar values, similar geopolitical interests," Modi said in a joint media appearance with Harris on Thursday, the first-ever person of Indian origin to be elected as the vice-president of the United

Noting that India and the US are the largest and oldest democracies, Modi said the two countries share values and their coordination and cooperation is also gradually increasing. Both the leaders appreciated that the bilateral relationship is on a sound footing. Foreign Secretary Harsh Vardhan Shringla told reporters here while giving details of the meeting that lasted for an hour.

This is the first meeting between the two leaders. Harris had earlier spoken to Modi over the phone in June during the COVID-19 crisis in India. "You are the source of inspiration for so many people across the world. I am completely confident that our bilateral relationship will touch new heights under President Biden

Noting that India and Harris had the US are the largest and oldest democracies, Modi said the two countries share values and their coordination and

cooperation is increasing and your leadership," Modi told

Harris. Later in tweet, Modi said, "Glad

London, Sept 24: Members of Parliament from the UK's All Party Parliamentary Group (APPG) on Kashmir have tabled a motion on "Human rights in Kashmir" for a debate in the House of Commons, drawing a strong reaction from India which said any assertion made in any forum on a subject related to an integral part of the country needs to be duly substantiated with authentic verifiable facts.

The Minister for Asia in the Foreign, Commonwealth and Development Office (FCDO), Amanda Milling, responded to the debate on Thursday by reiterating the UK government's unchanged stance on Kashmir as a bilateral issue.

"The government takes the situation in Kashmir very seriously but it's for India and Pakistan to find a lasting political solution, taking into account the wishes of the Kashmiri people. It's not for the UK to prescribe a solution or to act as a mediator;" said Milling. The Indian government expressed its dismay at some of the language used by participating MPs in the Backbench Debate, specifically Pakistani-origin Labour MP Naz Shah.

A minister from the Indian High Commission in London condemned the attack on Prime Minister Narendra Modi and highlighted Kashmir's status as an integral part of India. "It is with sadness that the High Commission of India notes that an august institution of a fellow democracy has been misused today to level abuse against the elected leader of the largest practising democracy in the world," the minister said, referring to Shah's re-

marks on the 2002 Gujarat riots. "As on previous occasions, the High Commission of India reiterates that any assertion made in any forum on a subject related to an integral part of India needs to be duly substantiated with authentic verifiable facts," the minister added. The debate, which was scheduled to be held in March 2020 but had to be postponed due to the COVID-19 pandemic lockdown, was opened by Opposition Labour Party MP Debbie Abrahams who recounted her visit to Pakistanoccupied Kashmir in February 2020.

Ex-Catalan leader detained in Sardinia

Barcelona, Sept 24: Former Catalan leader Carles Puigdemont, who fled Spain after a failed secession bid for the northeastern region in 2017, has been detained

in Sardinia, Italy, his lawyer said. Puigdemont, who lives in Belgium and now holds a seat in the European Parliament, has been fighting extradition to Spain, which accused him and other Catalan independence leaders of sedition. Lawyer Gonzalo Boye said Puigdemont was detained when he arrived in Sardinia on Thursday, where he was due to attend an event this weekend.

The circumstances under which Puigdemont was taken into custody were not immediately clear. Boye wrote on Twitter the ex-regional president was detained under a 2019 European arrest warrant, even though it had been suspended.

Police at the airport in northern Sardinia didn't answer phone calls Thursday night, while police in the city of Alghero said they weren't aware of his detention.

The European Parliament voted in March to lift the immunity of Puigdemont and two of his associates.

In July the three EU lawmakers failed to have their immunity restored after the European Union's general court said that they did not demonstrate they were at risk of being arrested.

Closest known relatives of Covid virus found in Laos

London, Sept 24: Scientists have found three viruses in bats in Laos that are more similar to SARS-CoV-2 than any other known virus, media reports said

The study, posted on the preprint server Research Square and not peer-reviewed yet, showed that the similarity of parts of the new viruses' genetic code with SARS-CoV-2 reinforces claims that Covid-19 has a natural origin. At the same time, their discovery means there are numerous coronaviruses with the potential to infect people,

Nature reported. The finding is both "fascinating, and quite terrifying", David

Robertson, a virologist at the University of Glasgow, the UK, was quoted as saying. According to researchers at the Pasteur Institute in Paris, and the National University in Laos, the new-found viruses contain receptor binding domains that are almost identical to that of SARS-CoV-2, and can therefore infect human cells, Nature reported. To find the virus, the team took saliva, faeces and urine samples from 645 bats in caves in northern Laos. They found viruses in three horseshoe (Rhinolophus) bat species, which were each more than 95 per cent identical to SARS-CoV-2. The new viruses have been named BANAL-52, BANAL-103 and BANAL-236, the report said.

Further, the scientist with the discovery of bats living in caves in Laos carrying a similar pathogen to Covid suggests a natural spillover rather than a lab-leak.

"When SARS-CoV-2 was first sequenced, the receptor binding domain didn't really look like anything we'd seen before,' Edward Holmes, a virologist at the University of Sydney in Australia, was quoted as saying. This caused some people to speculate that the virus had been created in a laboratory. But the Laos coronaviruses confirm these parts of SARS-CoV-2 exist in nature, he said.

"I am more convinced than ever that SARS-CoV-2 has a natural ori-



gin," said Linfa Wang, a virologist at the Duke-NUS Medical School in Singapore. Relatives of SARS-CoV-2 have previously also been discovered in Thailand, Cambodia

and Yunnan in southern China, the report said.

Together, the study demonstrates that southeast Asia is a "hotspot of diversity for SARS-CoV-2 related viruses", Alice Latinne, an evolutionary biologist at the Wildlife Conservation Society Vietnam in Hanoi, was quoted as saying by Nature.

Researchers at the Pasteur Institute had last year described another close relative of SARS-CoV-2, called RaTG13, which was found in bats in Yunnan. It was 96.1 per cent identical to SARS-CoV-2 overall and the two viruses probably shared a common ancestor 40-70 years ago -- similar to the newfound viruses.

However, there are still missing links to the origins of the pandemic, the researchers said. For example, the Laos viruses don't contain the so-called furin cleavage site on the spike protein that further aids the entry of SARS-CoV-2 and other coronaviruses into human cells The study also doesn't clarify

how a progenitor of the virus could have travelled to Wuhan, in central China, where the first known cases of Covid-19 were identified -- or whether the virus hitched a ride on an intermediate animal. Answers might come from sampling more bats and other wildlife in southeast-Asia, which many groups are doing, the report said.



Net direct tax mop-up grows 74% this fiscal

New Delhi, Sept 24: Net direct tax collection grew 74.4 per cent to ₹5.70 lakh crore between April 1 to September 22 this fiscal, the Finance Ministry said Friday.

The net direct tax collection of ₹5,70,568 crore after adjusting for refunds includes Corporation Tax (CIT) at ₹3.02 lakh crore and Personal Income Tax (PIT) at Rs 2.67 lakh crore.

The net collection (April 1 to September 22) in FY 2021-22 has registered a growth of 27% over 2019-20 fiscal when the net collection was over ₹4.48 lakh crore. In the previous fiscal (2020-21), the net collection was over ₹3.27 lakh crore.

The gross direct tax collection for 2021-22 fiscal stands at over ₹6.45 lakh crore, compared to ₹4.39 lakh crore in the corresponding period of the preceding financial year, registering a growth of 47 per cent over last fiscal. The gross collection was 16.75 per cent higher than ₹5.53 lakh crore collected in 2019-20 fiscal (April-September 22).

China's Central Bank RBI issues Master Direction on loan transfer

Mumbai, Sept 24: The Reserve Bank Friday issued Master Direction on loan transfer, requiring banks and other lending institutions to have a comprehensive boardapproved policy for such transactions.

Loan transfers are resorted to by lending institutions for various reasons, ranging from liquidity management, rebalancing their exposures or strategic sales. Also, a robust secondary market in loans will help in creating additional avenues for raising liquidity, the RBI said.

The Master Direction has also prescribed a minimum holding period for different categories of The provisions of the direction are applicable to banks, all non-banking finance companies. including housing finance companies, NABARD, NHB, EXIM Bank, and SIDBI

loans after which they shall become eligible for transfer. The direction, the RBI said came into effect immediately.

As per the direction, a loan transfer should result in immediate separation of the transferor from the



loans to the extent that the economic interest has been transferred.

In case of any retained economic interest in the exposure by the transferor, the loan transfer agreement should specify the distribution of the principal and interest income from the transferred loan

between the transferor and the transferee(s), it added. It further said a transferor can-

not re-acquire a loan exposure, either fully or partially, that had been transferred by the entity previously, except as a part of a resolution plan.

Further, the transferee(s) should have the unfettered right to transfer or otherwise dispose of the loans free of any restraining condition to the extent of economic interest transferred to them.

Meanwhile, the RBI also is

CCI fines beer cos for cartelisation

New Delhi, Sept 24: The Competition Commission of India has passed a final order against three beer companies -- United Breweries Ltd (UBL), SABMiller India Ltd (now renamed Anheuser Busch InBev India Ltd) and Carlsberg India Private Ltd (CIPL) for indulging in cartelisation in the sale and supply of beer.

The competition regulator has imposed a penalty of ₹750 crore on UBL and ₹120 crore on CIPL based on the evidence presented on their act of cartelisation.

Allegations of cartelisation were levelled against these companies in various states and Union Territories, including through the platform of All India Brewers

Association (AIBA). The legal provisions were not followed in Andhra Pradesh, Karnataka, Maharashtra, Odisha, Rajasthan, West Bengal, the National Capital Territory of Delhi and the Union Territory of Puducherry, in collectively restricting supply of beer in Maharashtra, Odisha, and

Sharjah, Sept 24: Chennai Super Kings produced a clinical all-round show to humble Royal Challengers Bangalore by six wickets and claim the top spot in the IPL pecking order here Friday.

RCB skipper Virat Kohli (53, 41b, 6x4, 1x6) and young Devdutt Padikkal (70, 50b, 5x4, 3x6) struck brisk half centuries in an impressive 111-run stand but CSK pulled the strings to restrict them to 156/6 after electing to bowl.

The in-form Ruturaj Gaikwad came good again with a quick 38 (26b, 4x4, 1x6) while Faf du Plessis made 31 (26b, 2x4, 2x6) at the top to lay a strong foundation for CSK to chase the modest target in 18.1

The win took CSK to the top spot with 14 points. They overtook Delhi Capitals, who also have 14 points, but the vellow brigade has better net run-rate of 1.185, compared to 0.613 of the Delhi team.

While it was the second consecutive win for CSK, the RCB now have lost both the games post the league's resumption.

Gaikwad and Du Plessis added 71 runs in 8.2 overs and later Moeen Ali (23) and Ambati Rayudu (32, 22b, 3x4, 1x6) also got starts but could not convert those into big knocks. Suresh Raina (17 n o) and skipper MS Dhoni (11 n o) ensured that there was no twist in the tale, taking the side past the finish line.

Neither Mohammed Siraj nor Navdeep Saini could trouble the CSK openers. Whether the ball was pitched up, short or bowled at good length, Gaikwad and his Protea partner treated them with equal disdain.

Gaikwad punched the ball hard and even reverse swept with ease before Kohli pulled off a stunning low catch off wrist-spinner Yuzvendra Chahal (1/26).

Realising that spinners may turn the game around, Kohli handed the ball to off-spinner Glenn Maxwell (1/17) and the Australian responded with the wicket of Du Plessis, who was guilty of playing a loose shot.

MORGAN PRAISES 'SUPERSTAR' BOW

Madrid, Sept 24: Barcelona's ongoing crisis keeps getting worse, with the team unable to win on the field and the club's players, coach and president growing increasingly at odds.

Barcelona was held to a 0-0 draw by Cadiz in the Spanish league Thursday, extending its winless streak to three matches and adding pressure on coach Ronald Koeman. Koeman a day earlier surpris-

ingly read from a prepared statement in the pre-match news conference and downplayed the team's chances of winning titles this season.

President Joan Laporta, who said he was caught by surprise by Koeman's statement ahead of the match, has been at odds recently with the coach who was hired by former president Josep Bartomeu.

Barcelona, without Lionel Messi after nearly two decades, had to hold on in the end against Cadiz after midfielder Frenkie de Jong was sent off with a second yellow card in the 65th minute. Koeman also was sent off for complaining to the referee in the final minutes.

The draw left Barcelona in seventh place in the league standings, seven points behind leader Real Madrid with a game in hand. Madrid routed Mallorca 6-1 at the Santiago Bernabeu Wednesday to stay two points ahead of defending champion Atletico Madrid, who won 2-1 at Getafe Tuesday.

Barcelona were coming off two consecutive setbacks at home a 0-3 defeat against Bayern Munich in the Champions League and a 1-1 draw against Granada in the Spanish league, when it needed a 90th-minute equaliser to escape defeat.

Cadiz nearly opened the scoring through Alvaro Negredo's shot from outside the area in the 46th, forcing Marc-Andre ter Stegen to make a difficult save by the top

One of Barcelona's best chances was a low shot by Memphis Depay that was stopped by Cadiz goalkeeper Jeremias Ledesma a few minutes later. The Dutch striker missed an opportunity to score the winner deep into stoppage time when his shot from inside the area went wide in a one-on-one situation.
