#### LEGISLATURE NEEDS TO REVISIT LAWS: CJI

Cuttack: The Chief Justice of India, Justice NV Ramana Saturday said the Legislature needs to revisit laws and reform them to suit the needs of time and people so that they match "practical realities". The CJI, while inaugurating the new building of Odisha State Legal Service Authority here, said there is need for the executive and the legislature to work hand in hand in realising "constitutional aspirations". "I emphasise, our laws must match with our practical realities. The executive has to match these efforts by way of simplifying the corresponding rules," Justice Ramana said. He also emphasised that it was important for the Executive and Legislature to "function in unison in realising Constitutional aspirations."

Chennai: The Income Tax (I-T) department has detected ₹300 crore undisclosed income and seized ₹9 crore unaccounted cash during its search and seizure operations on two private syndicate financing groups here. The I-T officials carried out their search and seizure operations at 35 premises September 23. According to I-T Department, the searches, so far, have resulted in the detection of undisclosed income of more than ₹300 crore. Unaccounted cash of ₹9 crore has been seized so far. The evidence found in the premises of the financiers and their associates revealed that these groups have lent to various big corporate houses and businesses in Tamil Nadu, a substantial portion of which is in cash, the I-T Department said Saturday.

# UTKAL DUST SOLD AS DREAM

The Aditya Birla Group firm has done much harm for the local populace. What it has achieved to state is of very little consequence compared to the sufferings of people

Tikiri (Rayagada), Sept 25: The expansion of Utkal Alumina, a subsidiary of the Aditya Birla Group, at Tikiri under Kashipur block in Rayagada district, from 1.5 Million Tonne (MT) per annum to 2 MT brought no cheers to the locals on whose land the plant has been set up. However, the Chief Minister of

Odisha Naveen Patnaik was seen congratulating the Aditya Birla Group while inaugurating the capacity addition,

saying, the plant has played a crucial role in the state's progress.

To understand this apparent contradiction between the claims and the ground reality, this correspondent visited Tikiri. From what is visible there, it can be concluded that the company has been rather too lucky in hard-selling its story to the state government which seems very willing to buy whatever is thrown at it.

For instance, at Dimindi village which is 50 km from Rayagada town, it is shocking to see the pathetic condition of villagers. The

hamlet shared its borders with the alumina plant's boundary wall. The air is so very polluted here that from their shanties to each leaf on the trees to every movable and immovable object, all have a thick layer of dust on them.

A talk with Suresh Behera, a villager, revealed that Utkal Alumina had taken away his landthe only source of livelihood-and paid some small money but had promised them jobs in the plant as the principal allurement way back in 2009. However, the company has not honoured its own promises till 2021. On the contrary, it has re-

peatedly used force of private strong arms along with the police to silence villagers whenever they sought an audience with the company higher-ups. Behera flashed

a company provided appointment letter of 2009 which has reneged on. Rupen Naik, a co-villager, echoed Behera's reactions "Look at the appointment let-

ter the company gave me in 2009. Since then I have been doing rounds of the plant. There is none to listen to my woes. At the time of acquiring our land, the company gave me money in two installments of Rs21,000 and Rs1 lakh. With this money can I buy one acre land here now?" Suresh asked. Private land in that locality was selling at four times the cost paid by the com-



pany. It was the job in return for land offer that was successfully used as bait by the company with these illiterate villagers. "At first, we were reluctant to part with our lands. A village meeting was held where political leaders of almost all major political parties assured us that everything in our village would turn into gold. The Collector, tehsildar and other officials also sang the same song to dupe us," Suresh said.

The company has acquired nearly 500 acres from Dimindi alone, promising the villagers a better life. They were assured of schools, street lights, safe drinking water and a modern amenities filled life. "I have learnt welding and gas cutting. Yet, I am jobless. Whenever we approach the com-

pany authorities, they tell us to go to ministers and politicians instead. All this while workers from outside were getting jobs here, at

the cost of locals" Rupen said. The villagers said they had gone to Bhubaneswar and had staged a sitin last year to protest against Utkal Alumina's misdeeds and anti people policies in the backyards of this state. This act of agitating against the Birla company so unnerved the district administration that the Collector himself came over to their protest site at Bhubaneswar and called them back, promising their grievances would be immediately addressed. "Whenever we visited the company, asking for jobs, the company CEO and other officials drove us away, saving if we persist in our demand for

jobs, they would slap false cases on us," Rupen said. The villagers believed in these threats since they themselves observed how the district administration and especially the police worked as agents of Utkal Alumina. The company also reneged on its promise to shift the lcoals to a different location.

Sarojini, another resident of Dimindi village, said they have used up whatever little money they received from the company in lieu of their family assets (land). "We feed our families by doing menial jobs like sweeping and working as maids," she said biting from a cucumber with salt.

They said, "We have sought the help of media. Reporters have visited our homes at different times. But, sadly, none has published our stories." The women emphatically stated that the company had paid and bought over these journalists in the same manner they have silenced

the babus (government officials). By the time this reporter left the village, the contradiction in the claims and reality had been unraveled. The Aditya Birla plant has done much harm to local people. What it has achieved for Odisha is of little consequence in comparison to the sufferings of people. Locals claim all the firm has done is use the minerals and manage the optics. They invited people from other parts of Odisha to visit their villages and see the truth with their own eyes. ## Gulab landfall today; 7 dists on high alert

The cyclone is likely to make landfall between Gopalpur and Kalingapatnam at 5:30 pm Sunday

Bhubaneswar, Sept 25: Barely four months after 'Yaas' wreaked havoc in Odisha, the coastal state is bracing for another cyclone, 'Gulab', which is likely to make  $land fall\ Sunday\ evening\ between$ Gopalpur and Kalingapatnam in Andhra Pradesh, said the India Meteorological Department (IMD) Saturday.


The deep depression over northwest & adjoining west-central Bay of Bengal has intensified into cyclonic storm Gulab and lay centered about 370 km eastsoutheast of Gopalpur and 440 km east of Kalingapatnam at 5.30 pm," the IMD said. The cyclone is likely to move nearly westwards and cross north Andhra Pradesh - south Odisha coasts between Kalingapatnam & Gopalpur around Sunday evening, it said.

Squally wind speed reaching

75-85 kmph gusting to 95 kmph is likely along and off Odisha coasts from Sunday afternoon till midnight in Ganjam, Gajapati districts while 55-65 kmph gusting to 75 kmph is likely along & off Khurda, Puri, Rayagada & Koraput districts. Wind speed reaching 50-60 kmph gusting to 70 kmph over Nabarangpur and Malkangiri is also predicted. Similarly, squally wind speed reaching 40-50 kmph gusting to 60 kmph is likely to prevail along & off remaining parts of Odisha Sunday. Under its impact, heavy rainfall would occur in some places of coastal and south Odisha districts in the next two days.

There may be damage to thatched huts, power and communication lines due to breaking of branches. Paddy crops, banana, papaya trees and orchards

may also suffer damage. As the sea condition would remain rough, fishermen are advised not to venture into the sea, along & off Odisha coasts northwest & adjoining west-central Bay of Bengal till September 27. Meanwhile, the state government has asked Collectors of seven likely affected districts to remain alert and take measures to counter



the cyclone.

Special Relief Commissioner PK Jena said 42 ODRAF teams, 24 NDRF teams and 102 Fire Service teams will be deployed in seven districts likely to be most affected by the cyclonic storm.

He said the IMD predicted seven districts would experience less wind but heavy to very heavy rainfall Sunday and Monday. Due\_ to heavy rainfall, flash flood may occur in Rushikulya, Nagavali and Vansadhara rivers and landslides in Gajapati and Rayagada districts while small trees may also be uprooted. Jena said

The SRC said as per the forecast made by the IMD, Kandhamal, Ganjam, Rayagada, Malkangiri, Koraput, Nabarangpur and Gajapati districts in south Odisha will be most affected. In addition to these seven districts, relief and rescue teams would also be deployed in Nayagarh district.

As a precautionary measure, Gajapati district administration has cancelled the leave of all officers for two days.

The National Management Committee (NCMC) under the chairmanship of Cabinet Secretary Rajiv Gauba Saturday reviewed the preparedness of central ministries/agencies and state governments to deal with the situation arising out of

the cyclonic storm. Meanwhile, the IMD said Kolkata and its adjoining areas should brace for heavy showers next Tuesday and Wednesday owing to the new weather system near the Myanmar coast. "The system is expected to move northwestwards and reach the West Bengal coast around September 29," it added.

United Nations, Sept 25: Prime Minister Narendra Modi Saturday said that countries with "regressive thinking" that are using terrorism as a "political tool" must understand that it is an "equally big threat" for them, in a veiled attack on Pakistan which is accused by its neighbours of providing safe havens to terrorists.

"Today, the world is facing an increased threat of regressive thinking and extremism. In such a situation, the entire world must make science-based, rational and progressive thinking the basis for development. In order to strengthen a science-based approach, India is promoting experience-based learning," he told the UNGA meeting.

'On the other hand, countries with regressive thinking that are using terrorism as a political tool must understand that terrorism is an equally big threat for them," Modi said in an apparent reference to Pakistan.

Pakistan's neighbours, including Afghanistan's previous government and India, and the US have long accused Islamabad of providing safe haven and support

to militants. Pakistan, specially its intelligence agencies, has close ties with the Afghan Taliban, including its dreaded faction the Haggani Network, which has seized control of Kabul last month.

Bhubaneswar, Sept 25: Contrary to the tall claims by Bhubaneswar Municipal Corporation (BMC) that it has achieved 100 per cent vaccination against Covid-19, data revealed that more than 2.55 lakh people in the Capital city are yet to be fully inoculated.

As per sources, the BMC has administered 23.67 lakh doses in the state capital till September 24. Out of this, 13.16 lakh were given the first dose and only 10.6 lakh took both the doses. These figures suggest that about 10.8 per cent (2.55 lakh) people coming under BMC are yet to be fully vaccinated. In August, the number of people, whose second dose was due, stood at 80,602 (8 per cent).

The civic body's claim that Bhubaneswar became the 'first city to achieve 100% vaccination' has come in for criticism. Experts termed it as 'distortion of data'. The BMC, in August, had acclaimed the distinction by administering 18.35 lakh doses against the target of 18.14 lakh doses. Out of the 18.35 lakh, about 10.59 lakh people were given their first dose while only



7.7 lakh beneficiaries were given the final shots leaving more than 2.8 lakh people due for their second

dose later in September. "Bhubaneswar has a floating

population. We had estimated about 18 lakh doses for the city. However, since Bhubaneswar is one of the cities that provide Covaxin shots, a large number of people came here for vaccination. We have even allowed operation of all health centres on Sundays to boost the coverage but people are forgetting their second dose dates," said a BMC official.

Residents, however, blamed the sluggish vaccination process at the UPHCs and serpentine queues for their reluctance to take the

'The second dose of my 67-year- 🔌 old mother was due earlier this month. We postponed it for serpentine queues. Besides, they are introducing rules without informing us. Last time, I was asked to get a Covid test done before vaccination," said Santilata Behera, a

resident at Rasulgarh.

# 'Hindi films should show sustainable way of living'



The CJI also noted that it is only then the Judiciary would not be compelled to step in as a law-maker and would only be left with the duty of applying and interpreting

At the end of the day, it is the harmonious functioning of the three organs of the State that can remove procedural barriers to justice,

he pointed out. Stating that the Indian Judicial system is faced with twin challenges, the CJI pointed out that the first one is that of "Indianisation of Justice delivery system".

Even after 74 years of Independence, traditional and agrarian societies, which have been following customary ways of life, "feel hesitant to approach the

courts," he noted. "The practices, procedures, language of our courts feel alien to them," he said adding that between the complex language of the acts and the process of justice delivery, the common man seems to lose control over the fate of his grievance. Often in this trajectory, the justice-seeker feels like an outsider to the system, he pointed out.

He, however, said that although it is a harsh reality, the Indian legal system often fails to take into consideration the social realities and implications. He said, "Sadly, our

The MPL 1.0 which was launched in Odisha in Februrary 2020 included nine cities and 214 tax functionaries. It was later scaled up as MPL 2.0 to include all the 114 ULBs. including more than 655 tax functionaries. Furthermore, Jena launched MPL 3.0 Saturday for the coming year.

As per sources, in the first year, the MPL was able to deliver 24% increase in property tax collections for the fiscal 2019-20. The digital collections during MPL 1.0 rose from less than 10% to 43%. The success of MPL 1.0 encouraged the H&UD department to expand this format across all the 114 ULBs

The MPL 1.0 which was launched in Odisha in Februrary 2020 included nine cities and 214 tax **functionaries** 

of the state as MPL 2.0. It resulted in an increase in collections by 15% for the fiscal 2020-21 and digital collections increased to 85% despite a pandemic year. The MPL 2.0 also marked the launch of a new digital dashboard wherein daily collections were recorded on a standard platform across the 114 ULBs.

Bhubaneswar, Sept 25: Odisha's Covid-19 tally surged to 10,23,735 Saturday as 602 more people, including 79 children, tested positive for the infection. Seven fresh fatalities pushed the state's death toll due to the viral infection to 8,170, a Health department official said.

As many as 353 new cases were registered in quarantine centres. while the remaining 249 infections were detected during contact tracing, he said.

Khurda district, under which state Capital Bhubaneswar falls, recorded the highest number of new cases at 266, followed by Cuttack (74). Bargarh, Malkangiri. Nabarangpur and Nuapada districts did not report any new infection.

Two fresh fatalities were registered in Khurda, and one each in

Balasore and Angul. The state currently has 5,930 active cases, while 10,09,582 people have recovered from the disease so far, including 494 in the last 24 hours. Fifty-three patients have died due to comorbidities

The coastal state has tested over 1.96 crore samples for Covid-19 to date, including 72,228 Friday. The cumulative positivity rate stood at 5.21 per cent. The rate of infection among children stood at 13.12 per cent, while the daily test positivity rate was at 0.83 per cent.

Khurda is again placed in red zone as the district currently observes more than 2,500 active cases at 2,668. The state has so far inoculated as many as 2,91,44,376 people. While 2,12,62,873 people have taken the first shot, a total of 78,81,503 people have been fully vaccinated.

Physical mulakat at jails was again prohibited with the onset of second wave of the pandemic in May. Meanwhile, the family members managed to meet the inmates only through virtual mode following the launching of e-Mulakat

system at different jails. However, the Prisons department recently sent a letter to all the jail superintendents in the state to start the physical meeting at their prisons by the strictly adhering to the Covid guidelines. The Directorate also directed the authorities to ensure the implementation of Standard Operating Procedure (SOP) issued by it for the physical mulakat.

A sum of over ₹13 lakh was realised from the defaulting consumers during the drives. In this effort, the company had to face various resistances and, in some cases, they took the help of local police to curb power theft menace," the statement added.

The next meeting of the VSSUT

disciplinary committee will be held Tuesday.

The incident had taken place Wednesday night when a group of senior students knocked on the door of the complainant's room. They asked him to show them his mobile phone. When the victim refused to comply with their demand, the seniors thrashed him. The student's father lodged a written complaint with the dean of the students' welfare of the institute.

At that time, Vice-Chancellor Banshidhar Majhi claimed it was a case of a tussle among students, but announced that the disciplinary committee of the university will hold a meeting over the issue.

In the past, the VSSUT has seen several cases of ragging. In August 2019, a video showing seniors ragging around 50 junior students had gone viral. In the video, senior students were seen tearing the shirts of their juniors, slapping them and forcing them to dance in their undergarments while holding their ears.

The institute had debarred 10 students from appearing for the university examinations for a year and slapped a fine of ₹2,000 each on 52 others for being involved in the incident. Ragging is banned in all

Bargarh, Sept 25: A protest over alleged custodial death of a youth turned violent as police canecharged unarmed protestersin Bargarh, Saturday.

The deceased was identified as Gobind Kumbhar, 25, a resident of ward no-21 of Tora panchayat on Bargarh town's outskirts. Family members, his wife Rubi Kumbhar and residents alleged that Town police picked up Gobind late Friday night and tortured him in the lock up. The deceased is survived by his widow and two minor children.

A youth sustained critical in-

juries on his head in the lathicharge and was admitted to the new DHH for treatment. Meanwhile, DIG (North) Deepak Kumar reached Bargarh and held talks with SP Rahul Jain.

ASP Dillip Kumar Bag rejected the charges stating that Gobind was an accused in an assault case lodged with Town police station. Police, fearing that he might flee home, picked him up from his home late Friday night. He, however, fell



sick Saturday and was admitted to the old district headquarters hospital (DHH) and later shifted to the new DHH where he succumbed during treatment, it was alleged.

The face-off occurred when family members of the deceased along with others reached the new DHH and ransacked the hospital premises despite presence of po-

lice. The deceased's brother Jiten held police responsible for the death of his brother and rushed to the terrace of the seventh floor of new DHH building and threatened to end life if justice is not meted out to them. He climbed down only after people persuaded him not to take the extreme step.

Later, the protestors swarmed Gandhi Square and staged a road blockade alleging that Gobind was tortured in police custody throughout the night that led to his death.

ASP Bag, SDPO Deepak Kumar Gochhayat and local MLA Debesh Acharya tried to placate the agitators. However, they refused to relent. Later, the protestors carrying the body staged a sit-in outside the SP office when police lathicharged them.

## Minor girl sexually assaulted; 6 arrested

# Illegal prawn gheries pose threat to Bhitarkanika, farming HIGH COURT GIVES RESPITE TO PRAWN FARMERS TILL NOVEMBER 26

Kendrapara, Sept 25: Prawn farmers in coastal pockets of Kendrapara have got a respite from the High Court till November 26 so far as removal of illegal prawn gheries is concerned. However, it was alleged that as the administration delays action against the illegal prawn gheries, it will be causing damage to Bhitarkanika sanctuary and paddy farming. Prawn gheries have been made in over 20,000 acres in the district.

According to reports, following an order from the High Court, the administration had started removing illegal prawn gheries. However, some owners of prawn gheries filed three cases in the High Court, stating that their prawn enclosures and ponds are not illegal.

Hearing their case, a division bench comparing Chief Justice S Muralidharan and Justice BP Mohapatra has stayed the eviction drive till November 26.

The court has asked the district administrations of Kendrapara, Khordha and Puri to identify illegal prawn gheries in their areas and submit reports to the court through affidavits within this period.

As per information available from amicus curiae Mohit Agrawal, there are nine complainants in one case. The petitioners have stated that they have been farming prawn in



their own farmlands for their livelihood while their farming has no issues related to pollution.

As many 17 people have filed another petition at the HC. They raised a similar issue. They asserted that they are doing prawn farming in their land with scientific methods.

As questions arose over legal and illegal prawn gheries, the administration of these three districts have been asked to report on illegal prawn gheries.

Social activist Biren Kumar Das said prawn gheries near Bhitarkanika have been posing serious threats to its biodiversity. Besides, farming near gheries is affected by it as saline water from gheries finds way into farmlands.

This scene is common in Mahakalpara, Rajnagar and Rakanika blocks. Paddy farmers and prawn farmers often get into conflicts over release of saline water to farmlands. This leads to law and order in these areas.

It may be noted here that there was a violent confrontation between ghery owners and villages at Kurundi panchayat under Rajnagar block. Prawn gheries have come up over 39 acres of gramya jungle and pasture land.

The social activist pointed out that illegal prawn gheries have mushroomed in 20,000 acres across the district.

Environmentalist Hemanta Kumar Nayak said, the HC, taking serious note of threat to Bihitarkanika biodiversity, directed action against illegal prawn enclosures. He said there are several gheries near Jagatjora.

Sub-collector Niranjan Behera said removal of prawn gherries is going on following direction from the HC. Some prawn farmers have moved the HC.

Their cases will be investigated and reports submitted to the court, he added.

## Marauding tusker destroys houses, crops in Balasore

Rupsa, Sept 25: A tusker went on a rampage and destroyed at least 11 houses, food stocks and farmlands at Gadapada panchayat under Rupsa police limits in Balasore district after it strayed into the area Friday night.

The tusker pulled down houses of 11 people, destroyed their belongings, food stocks and standing crops. Forest officials rushed to the spot and stayed awake all night beating drums and bursting crackers to drive away the pachyderms. However, they had little effect on the animal as it unleashed a reign of terror by pulling down the houses.

The animal made its way into the area from Badaguma via Lachhmankhunta in Mayurbhanj.

The animal damaged the houses of Paintiri Singh, Kuni Singh, Gobind Singh, Adikanda Singh, Ram Singh, Anadi Mohanta and Rameswar Mohanta of Badagumma village, Akshya Palei of Jahata village, Simal Tudu and Chhuta Majhi of Hirapur Nagakhani village. Later, the animal crossed the rail track near Bakharabad railway gate of Rupsa station and strayed into Budhakhandi village where it destroyed the house of Babu Mallick.

After crossing the track, it was found near Bhagabanpur village in Mayurbhanj. Forest officials alerted railway officials to prevent threat to the animal. As a result, train services were stopped on the route for over one and half hours and power connections were also snapped to allow the animal safe passage on the track.

## Female jumbo dies in Lanjigarh

Lanjigarh, Sept 25: A female elephant was found dead in Biswanathpur range under Lanjigarh block in Kalahandi district Saturday. Locals alleged that a herd of elephants was moving in villages and damaging crops and houses for last few days.

On being informed, a team of forest officials rushed to the spot and started an investigation. The cause of its death is yet to be ascertained.

Five elephant squads, five wildlife squads and four sections of officials have been patrolling the area. DFO

## Presumption of guilt

ndia follows the system of common law, introduced to it by Great Britain. However, it has introduced innovation in its law as an independent nation, and one of these is to reverse the burden of proof. In several criminal laws in India, and especially those legislated after 2014, there is a reversal of burden of proof. This means that there is presumption of guilt. The State assumes you have done something wrong and it is for you to demonstrate innocence.

This is the opposite of normal criminal law. For instance, if someone is found with a knife next to a corpse, it is for the State to prove that the person committed murder. However, there are laws in which the State begins with the assumption of guilt. The National Register of Citizens in Assam is one such instance. All individuals in Assam had to submit to the government documents which showed that their ancestors had been in Assam as citizens before 1971. Those who could not have to line up before government tribunals and prove that they were legitimate. If they could not, they were locked up. Hundreds of people are in jail today because of this and more jails are being constructed.

British law says that where a legal burden of proof is on a defendant, they need not prove the issue beyond reasonable doubt. The bar is low. But in India the bar is high as we can see in Assam and elsewhere.

India has enacted so-called 'freedom of religion laws' in several BJP states, reversing burden of proof for conversions. The law was first passed by Uttarakhand in 2018, and then came the Himachal Pradesh Freedom of Religion Act 2019, Uttar Pradesh Vidhi Viruddh Dharma Samparivartan Pratishedh Adhyadesh, 2020 (Prohibition of

Unlawful Conversion of Religion Ordinance), Madhya Pradesh Dharma Swatantreya Adhyadesh, 2020 (Freedom of Religion Ordinance) and Gujarat Freedom of Religion (Amendment) Act. 2021. These laws criminalise marriage between Hindus and Muslims. They say that if anyone converts before or after marriage, then the government will declare the marriage null and void, even if there are children.

The burden of proof to show that the conversion was not fraudulent, through undue influence, or coercion is on the spouse and the family that the person is marrying into. Those who change their faith without an application to the government are sent to jail. The other unique thing about these laws is that they do not apply to Hinduism. The original law in Himachal Pradesh says that 'if any person comes back to their ancestral religion' then this shall not be deemed conversion. The law does not define what 'ancestral religion' means but its meaning is clear: those who convert to Hinduism will not be punished.

The Uttar Pradesh Recovery of Damage to Public and Private Property Act, 2020, was enacted after UP police shot dead 21 protesters during the anti-CAA protests last year. The law gives the state government the power to fine people it suspects of having damaged public property and seizing their homes and other property. Even if the accused is unable to appear before the tribunal, orders for attachment can be passed which cannot be appealed.

Another set of laws, also passed after 2014, reverse burden of proof on cow slaughter. These

laws were also passed by BJP state governments. They are the Maharashtra Animal Preservation (Amendment) Act, 2015, the Haryana Gauvansh Sanrakshan and Gausamvardhan Act, 2015, the Gujarat Animal Preservation (Amendment) Act, 2017, and the Karnataka Prevention of Slaughter and Preservation of Cattle

Act, 2020. The burden of proof is reversed and if one is accused of killing a cow or possessing beef, then it is for the individual to show that they did not kill the animal or that the meat in their fridge is not beef. Gujarat's punishment for cow slaughter, which is an economic crime in India because it aims to protect animal husbandry, is life in iail. No other economic offence draws this sentence. In 2019, under the new law, a Muslim man was sentenced to 10 years in jail after he was accused of serving beef at his daughter's wedding. The police could not prove that this had happened. In that case, the judge said, it was for the man to prove that he was innocent. Because it was not possible to test food that had already been eaten, the court sent him to jail.

Those who transport cattle except under strict conditions are also liable under the law to have their vehicles permanently seized and fined ₹5 lakh. Other laws which have reversed burden of proof are the famous UAPA, which makes it difficult if not impossible for people to get bail once they are accused. All Indian states have preventive detention laws, through which the government can jail people without a crime on the presumption that they will commit a crime in future.

Interestingly, the BJP in its earlier form, the Jana Sangh, had opposed preventive detention laws, but today it is the champion of these laws. The other thing to note is that presumption of guilt laws have been creeping in since 2014 but there is no resistance or even debate on whether we should have them, apparently because the average Indian's faith in the system and its fairness

#### ■ Perissology

Perissology means using more words than necessary to explain one's meaning, a pleonasm. Since perissology is three letters longer than pleonasm but means the same, you may argue it's an example of the related habit of using long words when shorter ones will do. The word comes to us from the post-classical Latin of the fourth or fifth century AD. Romans of classical times knew it as a Greek word, perissologia, which came from perissos, beyond the usual number or size, redundant, superfluous. The prefix perisso- is known in two other very uncommon English words: perissosyllabic, a line of verse that has more syllables than normal, and perissodactyl, a grazing mammal with hooves made up of an odd number of toes, which sounds obscure but is a characteristic of horses as well as tapirs and rhinoceroses. Its opposite is artiodactyl, having an even number of toes, which refers to mammals such as pigs, deer, goats and cattle. Perissology came into English at the end of the sixteenth century but was never anything more than an obscure literary word. In recent centuries it has mainly been exploited for humorous effect. His inscience of avitous justicements, and of lexicology, his perissology and battology, imparted to his tractation of his cause, an imperspicuity which rendered it immomentous to the jurator audients (Letters to Squire Pedant, by Samuel Klinefelter Hoshour, 1856).

## IS DOING BUSINESS DEAD?



As the head of the World Bank division that produced DB from 2012 to 2016. I found the Wilmer Hale report disturbing to read. Yes, countries have always lobbied and jostled to improve their rankings. But I never gave in to any of that pressure. Nor, to the best of my knowledge, did any of my predecessors. It was deeply disappointing to read about how this subsequently changed and what happened inside the Bank, including accounts of junior staff being 'publicly threatened' and feeling "powerless to object to carrying out the data improprieties being requested by senior bank management." This is the kind of behaviour one expects

Woods institution The World Bank deserves credit for commissioning such a transparent investigation, and now it has an obligation to act on its findings. Some senior officials will no doubt be shown the door. But this is also the time to take stock of the entire business of Doing Business. The Bank's decision to stop publishing DB is an understandable initial reaction. But I would advise the organisation to use this interruption to develop a better report,

under an authoritarian govern-

ment, not at a premier Bretton

instead of ending it for good.

I have a long and complicated relationship with DB. Many progressive economists have railed against it because of its admittedly neoliberal bias. But the index also highlighted important shortcomings in many developing countries, where cronyism among big business and government, along with high bureaucratic costs, crush individual enterprise and cripple small businesses. When I was the Indian government's chief economic adviser, I found DB's data useful for pushing reforms that would help the small players.

At that time, I had no idea that I would one day be in charge of the division producing the report. During my transition, I felt like a restaurant patron who had suddenly been asked to run the kitchen. It was an eye-opening experience for me to discover how the DB economies were evaluated. I could see that there was room for improvement, but what truly impressed me was the transparency and integrity of the exercise. It was an expensive operation in which the Bank collected data meticulously from all the economies - 189 at the time - and

then constructed the rankings without regard to who won or lost.

We improved some of the data and the selection of items that we included in the index. But any such change would alter some of the rankings, giving the impression that some countries were doing better or worse than before, when in fact the shifts were entirely due to the changes in our criteria. For that reason, we had to hold back on many planned improvements.

So, what might a new, improved DB look like? For starters, the bank should switch to collecting de facto data. Currently, the bulk of the DB ranking is based on countries' de jure laws - the rules and regulations in the books rather than on what actually happens on the ground. My own backof-the-envelope calculation was that two-thirds of the ranking depended on the de jure.

This causes an obvious problem. Properly devised cross-country rankings, like the pre-2017 DB, spur competition among governments. But authoritarian governments in particular can change their rule books through top-down orders - and thus improve their index score – even if this makes little difference to people's lives. Gathering de facto data will require independent surveys and some randomised data collection, making DB more expensive to produce. But the World Bank can easily bear the additional burden.

Second, DB currently does not include an indicator regarding labour laws and regulations (it did once have, but it was dropped). This is an unfortunate omission which a revamped DB report should redress.

Finally, every time the DB report came out during my years at the Bank, I would be at pains to explain that it was about doing business Achieving a high ranking must not be an all-consuming goal, because the health of a country's economy also depends on fairness and social justice. But once such a game gets started, it is difficult to persuade countries that other things matter besides business.

The World Bank now has an opportunity to correct this by creating a supplement to the DB re port that ranks countries in terms of 'Being Just.' The BJ supplement would assess how fair and just a country's laws and regulations are. This can start as a small exercise, with a BJ ranking being pub lished alongside the DB ranking.

Such an initiative would be bound to generate interest among researchers to investigate the connections between being good for business and being fair and just More importantly, it would create incentives for countries to excel in both areas. Last but not least, it would offer the World Bank an opportunity to rebuild its reputation for producing useful – and impartial – rankings.

## How to avert a global climate catastrophe

**IN MANY COUNTRIES. THE RAMIFICATIONS OF CLIMATE CHANGE FOR WATER SUPPLY HAVE BEEN STAGGERING** 

The hottest day on record in the last decade, however, a steady de-Jordan since 1960 was a staggering 49.3° Celsius, (120.7° Fahrenheit) in July 2018, one month after I became prime minister. Jordan is not unique: heat waves have been causing record-high temperatures in countries from Canada to Australia in recent years. The effects of climate change. while felt locally, demand a global response, which should set binding targets that take into account countries' contributions to the problem and to the solution.

Jordan has been actively pursuing policies and programmes to reduce CO2 emissions. Over the past 15 years, Jordan's annual emissions per capita fell from 3.5 tonne to 2.5 tonne. But Jordan, like the vast maiority of countries, accounts for a negligible share of global CO2 emissions - just 0.04% annually. So even if Jordan was to turn its whole economy green overnight, it would hardly make a dent. This does not absolve us of responsibility, but we cannot overlook the fact that emissions are concentrated: the top 20 emitters account for almost 80% of the annual total, with the US and China alone accounting for 38%.

In many countries, the ramifications of climate change for water supply have been staggering. In the case of Jordan, it made an already tight constraint much more acute. Rainfall was previously the saviour for rural communities that engaged in seasonal rainfed agriculture and herding on semi-arid land. Over cline in average annual rainfall and an increase in the frequency and severity of droughts have undermined these modes of agriculture. deepening the socioeconomic divide between rural and urban areas.

Jordan is by no means unique: the WHO estimates that half of the world's population will be living in water-stressed areas by 2025. In essence, what was previously a regional challenge has now become a serious global governance issue with environmental, political, and economic ramifications

According to the recent the UN Intergovernmental Panel on Climate Change report, the world will not meet the 2015 Paris climate agreement goal of limiting global warming to well below 2°C unless it makes huge additional cuts in CO2 emissions. Quite simply, the results of the world's climate efforts are dangerously inadequate. According to the Climate Action Tracker, current policies put the world on course to be an alarming 2.7-3.1°C warmer by 2100, relative to pre-industrial levels. Yes, many emerging green technologies are promising and should be supported. But in the absence of a global approach, these innovations risk merely redistributing the impact of climate change among countries and regions.

Raising awareness and nudging (and shaming) policymakers is necessary, but not sufficient to avert what UN Secretary-General António Guterres has referred to as a 'climate

igation must be pursued as a global public good. The problem is that such goods are plagued by collectiveaction problems, because the costs tend to be spatially and temporally concentrated while the benefits are diffuse. These difficulties can be tackled only by global governance structures that reduce the cost of collective action, internalise externalities, and counter short-term biases in decision-making.

To address climate change more effectively, we need global governance arrangements that amount to a new global social contract.

For starters, we need a governance structure whose jurisdiction is limited to global public goods that cannot be provided adequately at the national level. Nation-states would be free to opt in and opt out, with the benefits of opting in outweighing those of opting out. Decisions would be taken on a majoritarian basis, with no single country having veto power. There would also be an appeals and adjudication process that allows decisions to be challenged.

Second, a custodial entity would keep track of global natural wealth accounts to address intergenerational equity issues. This entity should be able to place items on the global governance institution's agenda and to appeal decisions.

Lastly, a regime of incentives and disincentives would aim to preserve nature and biodiversity and tax those who consume it, taking wealth and income disparities across countries into account.

Establishing global governance mechanisms that focus on the public-goods and collective-action challenges of climate change will not be easy. Nevertheless, we are not starting from scratch. The WTO provides an example of a strong and successful global governance structure with binding rules. It is thus both ironic and sad that the WTO has failed to incorporate trade-related environmental and humanrights issues into its regulations in order to ensure a level international playing field. After all, with its sanctioning authority, the WTO is best positioned to link issues such as greenhouse-gas emissions

and labour rights to trade rules. Now that the world has become a village, the task facing the region is instead to agree with other countries-our fellow villagers-on how to mitigate our own excesses and avert an existential threat. The solution lies in establishing a global governance system that is based on the nation-state but has the capacity to sanction harmful behaviour.

Some might regard the idea of creating such a structure as farfetched. But unless we do, there is scant hope of preventing the climate crisis - already apparent in Jordan and around the world - from continuing to destroy countless lives and livelihoods.

Dehradun, Sept 25: The Uttarakhand government has said the rapid rise in population is causing demographic changes in certain areas of the state, resulting in migration of several communities from those places besides posing a threat to communal peace.

Expressing concern over the development in an official release here Friday, the government directed the state DGP, all DMs and SSPs to take precautionary steps to resolve the problem.

It asked the officials to constitute committees in all districts that will offer suggestions to the administration for addressing the

Besides, peace committees should

also be set up and their meetings held from time to time to review the situation, the release said.

Such areas in all districts should be identified and action should be taken against anti-social elements residing there, it said.

A list of people with criminal records coming from outside the state and living in these areas should also be prepared after verifying their original place of residence, the release said.

The district magistrates (DMs) have been asked to keep an eye on illegal land deals in such areas and see that people do not sell their lands out of fear or pressure.

Strict action should be taken against people of foreign origin who have obtained forged ID cards or voter ID cards.

Records of such people should be prepared and action taken against them as per the legal provisions, the release said.

The list of directions follows a letter written by BJP leader Ajendra Ajay to Chief Minister Pushkar Singh Dhami recently in which he had alleged that people of a particular community were not only building their places of worship but also buying land in bulk in certain areas of the state causing an exodus of the original inhabitants.

### **Tehri dam achieves** full potential of 830-metre capacity


Rishikesh, Sept 25: The Tehri Dam Project in Uttarakhand reached a milestone as it achieved full capacity of 830 metres, for the first time ever.

Though the project has been providing the much-needed 1000 MW power and other benefits such as drinking and irrigation water, flood moderation, fishing, tourism etc. for the past 15 years, yet its full potential had remained elusive.

The Tehri reservoir could not be raised to Full Reservoir Level (FRL), of EL 830 metres due to different issues. However, with the Centre and the state government's efforts, this mammoth task was achieved after the pending rehabilitation issues of the project were resolved by THDC

The Uttarakhand government permitted raising the Tehri reser-

### voir level to EL 830 metre August 25, 2021. Prior to this permission, dam authorities were not allowed to raise it to full level and full potential as water and power were not getting fully utilized.



The Tehri Dam Project is a multipurpose hydro power scheme on the Bhagirathi river and is the third highest among earth fill dams and tenth highest among all dams. The project consists of a 260.5m high earth and rock fill dam, and four machines of 250 MW each in an underground power house. The project has a capacity to store about 2,615 MCM of surplus flood water during monsoon. Post monsoon, the stored water

provides irrigation support to 8.74 lakh hectares of land in the Gangetic plains of Uttar Pradesh; and also provides around 300 cusecs of drinking water to Delhi for about a 40 lakh population and 200 cusecs to Uttar Pradesh for some 30 lakh population. The project has also enabled the farmers of the Tehri command area to cultivate upto three crops a year.

# As mountain springs dry up, women revive traditional pits

Uttarkashi, Sept 25: Over the last decade, it has become increasingly hard for Sartama Devi to source water around her Uttarkashi village home in Uttarakhand and same has been the story for the rest of her co-habitants

"Our water sources had been drying up with the diminishing monsoons. It has affected our livestock. In our fields, the koda-jhangora (Indian barn millet) crop had been withering away," the 55-yearold said.

Water springs in small amounts in these mountain villages and exhausts quickly as the villagers use it for daily chores and to meet their livestock's needs. These natural springs have not been sufficient for the 300 families in Patara village that have about 275 animals.

Pooja Rana, 27, a farmer who is also Patara's panchayat chief, said that the water taps drawn from the springs in their hamlet are functional for barely an hour or two in the morning. In summers, the taps run completely dry.

It is ironic that river Bhagirathi runs down from its glacial origin at the foothills of Patara -- just 2-3 km away. It later meets the Alaknanda and forms the Ganga. Despite being so close to India's most extensive river system, Patara has struggled.

"People over the decades have migrated, leaving behind their farms. Many have settled on the Delhi-Dehradun road," Devi said.

That is exactly why these Uttarkashi women are bringing chal-khals back to life. These percolation pits are saving women the time and effort it takes to find and carry water over long distances. In 2019, Patara ushered in change when Sartama Devi formed



the Him Patara self-help group to conserve water and revive water sources closer to the village.

With the men mostly absent, having migrated in search of better opportunities, the women became largely responsible for running the village. In their interactions with the local administration, they would constantly bring up the problems they were having with water.

It was then that the village development officer, Sunil Agnihotri, motivated them to set up an SHG and establish contact with NGOs that were working on water conservation in the area.

The women started learning more about chal-khals; these percolation pits used to be built and maintained by mountain communities but this traditional knowledge had been lost over the years. In Pauri, Garhwal, Kumaun and other regions of Uttarakhand, several NGOs have been working the past few decades toward reviving chal-khals.

#### WATER **CONSERVATION**

Chal-khals or percolation pits usually measuring eight metres in diameter and one metre deep. though the size varies, are dug on sloping grounds

They collect water from the rain which seeps into the ground, improving the quality of the soil and recharging the groundwater

On the surface, it meets the villages' everyday needs. A single water body can store up to 64,000 litre of water

However, the work often happens in isolation, with a few villages benefiting and some hearing about it through word-of-mouth while many others still removed the means to access and implement this traditional knowledge. A few years prior, there was some attempt to build chal-khals in Patara under MGNREGA but Sartama

Devi said they were done without much thought and the community didn't know how to maintain them. This time, the 100 or so women who had joined the initiative relied on hereditary knowledge to locate and revive old chal-khals that had fallen into disuse as well as scientifically evaluate ideal locations for new ones.

"For three years, the women from Patara relentlessly worked towards water conservation. Initially, all of our five chal-khals turned barren since we didn't know how to maintain them." They need to be routinely rid of the silt, mud and rocks that accumulate in the pits but due to lack of collectivism people stopped doing these traditional tasks and were dependent on the administration, she rued. "But we revived them and added new ones to the lot," Devi said. At Patara, there are now 11 chal-khals that have collected and stored an estimated seven lakh litres of water over the past three years, helped along by the unseasonal rains.

## **Cong questions Shah's silence**

New Delhi, Sept 25: The Congress Saturday questioned the silence of Home Minister Amit Shah on the open shootout inside a courtroom in the national capital and also the Assam firing incident.

Congress spokesperson Gourav Vallabh also asked whether Shah does not have the time to resolve the issue in Assam.

The country's law and order situation is worsening, with firing taking place inside a courtroom in the national capital, killing people. There are 10-20 rounds of firing inside a courtroom and where is the home minister. Where is his statement, he asked.

Who is responsible for this, Vallabh said, wondering whether the home minister is only supposed to give speeches.

When the law and order situation is so precarious and the country's home minister is silent and gives no statement or takes action, then it is an indication of a 'majboor' (helpless) government and not a strong government. The people of India have never tolerated 'maiboor' (helpless) people, he told reporters. Vallabh said the BJP leadership made several tall promises ahead of Assam elections and asked where those promises are now.

He said never in the country's history has one police force fired upon the police force of another state and killed cops and the home minister is still silent, apparently referring to the Assam-Mizoram border row during which seven people

Without mentioning the Taliban, he said the developments in Afghanistan raised questions about the role of power politics and the use of terrorism as a tool to change state structures and behaviour.

Delving into various aspects of national security, the defence minister also called for greater synergy among the armed forces to deal with future security challenges. In a clear reference to Pakistan, he said the turmoil caused in the region has been brought about by aggressive designs and the active support to non-state players by irresponsible states.

## PM to bring back 157 antiquities handed over by US

New Delhi, Sept 25: Prime Minister Narendra Modi will bring home 157 artefacts and antiquities, which were handed over to India by the US during his visit, with both he and President Joe Biden expressing commitment to strengthening efforts to combat theft, illicit trade and

trafficking of cultural objects. While nearly half of the artefacts (71) are cultural, the other half consists of figurines related to Hinduism (60), Buddhism (16) and Jainism (9), an official statement

said Saturday. Modi conveyed his deep appreciation for the repatriation of antiq-

uities to India by the United States. The list of 157 artefacts includes a diverse set of items ranging from the one-and-a-half metre bas relief panel of Revanta in sandstone of the 10th CE to the 8.5 cm tall, exquisite bronze Nataraja from the 12th CE.

This continues the efforts by the Modi government to bring back India's antiquities and artefacts from across the world, it said. Government sources said that only 13 antiquities were retrieved

between 1976 and 2013. However, between 2014, when Modi came to power, and 2021, over 200 antiquities have either returned or are in the process of

The statement noted that the

#### Syrian dies

Beirut: A Syrian man has died after swallowing gasoline he was siphoning out of his vehicle's tank with a plastic tube, Lebanon's national news agency reported Saturday. Lebanon is witnessing a paralyzing fuel shortage that has driven the public to hoard gasoline and resort to blackmarket vendors, while many businesses have been forced to shut down. A diesel shortage has also caused extended blackouts, in a country dependent on private generators. People queuing for several kilometers (miles) to fill up their tanks are a daily occurrence at gas stations across the country. The long lines have often descended into chaos, and sometimes violence.

#### **Bodies found**

Panama City: Nine bodies of suspected migrants have been found near a remote jungle close to the border with Colombia, local prosecutors said Friday. The bodies, including one child, were found near the Tuqueza and Canaán Membrillo rivers in the Emberá Wounaán indigenous region, according to the Darien province prosecutor's office. Chief prosecutor Julio Vergara said he believes they may be immigrants because a Haitian woman told authorities that on the Tuqueza river heavy rains had produced high waters that had swept away about nine people, who had remained missing.

#### **Icelanders vote**

Reykjavik (Iceland): Icelanders were voting Saturday in a general election dominated by climate change, with an unprecedented number of political parties likely to win parliamentary seats. Polls suggest there won't be an outright winner, triggering complex negotiations to build a coalition government. A record nine parties could cross the 5 per cent threshold needed to qualify for seats in Iceland's parliament, the Althing. Upstart parties include the Socialist Party. which is promising to shorten the workweek and nationalize Iceland's fishing industry.

#### One hurt

Kabul: A Taliban official says a roadside bomb has hit a Taliban car in the capital of eastern Nangarhar province wounding at least one person. No one immediately claimed responsibility for the bombing Saturday. "We keep hearing that Pakistan

Pakistan nurtures terrorists in their backyard in the hope that they will only harm their neighbours. Our region, and in fact the entire world, has suffered because of their policies. On the other hand, they are trying to cover up sectarian violence in their country

as acts of terror." Dubey said. Khan, in his nearly 25-minute address, had spoken about the August 5, 2019 decision of the Indian government on the abrogation of Article 370 as well as the death of pro-Pakistan separatist leader Syed Ali Shah Geelani.

In the Right of Reply, Dubey strongly reiterated that the entire Union Territories of Jammu & Kashmir and Ladakh "were, are and will always be an integral and inalienable part of India. This includes the areas that are under the illegal occupation of Pakistan. We call upon Pakistan to immediately vacate all areas under its illegal occupation.'

## Taliban hang 4 bodies in Herat

'We hanged their dead bodies on the Herat squares as a warning to the other kidnappers," the official was quoted as saying

deserves a place at the UN high table as a permanent member.

India in June asserted that the Inter-Governmental Negotiations (IGN) on UN Security Council reforms can no longer be used as a smokescreen, as the General Assembly decided to roll over the IGN work to the next UNGA session and agreed to include an amendment proposed by the G4 nations of Brazil, Germany, India and Japan.

At present, the UNSC comprises five permanent members and 10 non-permanent member countries which are elected for a two-year term by the General Assembly of the United Nations. The five permanent members are Russia, the UK, China, France and the United States and these countries can veto any substantive resolution. There has been growing demand to increase the number of permanent members to reflect the contempo rary global reality.

A total of 1,663 firefighters have been assigned to battle the wildfire, dubbed Fawn Fire, said Captain Chris Harvey of the Sacramento Fire Department, who was serving as a public information officer for the California Department of Forestry and Fire Protection (Cal Fire) on the incident.

At least 25 structures have been destroyed by the wildfire, which started some 19 km north of Redding city on Wednesday evening and triggered multiple mandatory evacuation orders, reports Xinhua news agency.

It added that 7.641 wildfires have burned more than 2.38 million acres in the state so far this year.

## China frees **Canadians** -

New York, Sept 25: Two Canadians were released from prison and flown out of the country on Friday, Prime Minister Justin Trudeau said, just after a top executive of Chinese communications giant Huawei Technologies reached a deal with the US Justice Department over fraud charges and flew to China

The frenetic chain of events involving the global powers brought an abrupt end to legal and geopolitical wrangling that for the past three years has roiled relations between Washington, Beijing and Ottawa.

The three-way deal enabled China and Canada to each bring home their own detained citizens while the US wrapped up a criminal case against a prominent tech executive that for months had been mired in an extradition fight.

The first activity came Friday afternoon when Meng Wanzhou, 49, Huawei's chief finance officer and the daughter of the company's founder, reached an agreement with federal prosecutors that called for fraud charges against her to be dismissed next year and allowed for her to return to China immediately.

As part of the deal, known as a deferred prosecution agreement, she accepted responsibility for misrepresenting the company's business dealings in Iran. About an hour after Meng's plane left Canada for China, Trudeau revealed that Canadians Michael Kovrig and Michael Spavor were also on their way home.

The men were arrested in China in December 2018, shortly after Canada arrested Meng on a US extradition request. Many countries labelled China's action "hostage politics." "These two men have been through an unbelievably difficult ordeal. For the past 1,000 days, they have shown strength, perseverance and grace and we are all inspired by that," Trudeau said.

News of Meng's pending return was a top item on the Chinese internet and on state broadcaster CCTV's midday news report, withno mention made of the release of Kovrig and Spavor.

It further said the two leaders also looked forward to convening the US-India CEO Forum and the Commercial Dialogue in early 2022, leveraging the talents of the private sector. "The leaders noted ongoing negotiations on an Investment Incentive Agreement that facilitates investment in development projects and committed to an early

such as pharmaceuticals, biotechnology, semiconductors, and information technology.

They also recognised the importance of critical and emerging technologies in delivering economic growth and achieving strategic priorities. They looked forward to reviving the High Technology Cooperation Group (HTCG) in early 2022, with the objective of accel erating high technology commerce in key areas, the joint statement said.

Last month, Dalmia Bharat Limited had unveiled a long-term plan to grow its cement capacity in the country. It plans to raise its cement manufacturing capacity to 110-130 million tonnes per annum by 2031.

## Import duty norm relaxed to improve containers vacancy

New Delhi, Sept 25: The Centre has relaxed import duty norm on improve their availability. At present, keeping containers beyond a period of six months attracts an import duty.

However, an official communique, cited that the policy has been reported to sometimes create perverse incentive among shipping lines to export empty containers to evade duty payment on containers which are lying empty.

The policy was designed to discourage long dwell time of containers and to promote faster turnaround

As per the communique, the problem was brought out in stakeholder consultations held by the Ministry of Commerce and

Working on one of the action tracks identified by the government to ease the problem, the CBIC has issued a guidance to field offices



to extend this period by three months where the container is being taken out of the country in laden condition provided the 6 month period falls before the end of FY22. Extension is to be sought by the concerned importer.

Accordingly, the move is expected to reduce the export of empty containers from the country on ground of imposition of import duty, thus, increasing the availability of containers for the trade.

Lately, disruptions due to the Covid-19 pandemic has resulted in high shipping freight rates and container shortages globally.

## IT dept finds ₹300 cr black money

Chennai, Sept 25: The Income Tax (IT) Department has detected Rs 300 crore of undisclosed income and seized Rs 9 crore unaccounted cash during it search and seizure operation on two private syndicate financing groups here.

The evidence found in the premises of the financiers and their as-



sociates revealed that these groups have lent to various big corporate houses and businesses in Tamil Nadu, a substantial portion of which is in cash, the IT Department said Saturday.

During the search, it was detected that they are charging high rate of interest, a part of which is not offered to tax.

The modus operandi adopted by the groups revealed that most of the interest payments by borrowers are received in dummy bank accounts and the same has not been disclosed for tax purposes.

Further, the unaccounted monies are disguised and brought into the books of account of the groups as unsecured loans, sundry creditors and others.

Other evidence found during the course of the search revealed numerous undisclosed property investments and other income suppression by these persons, the IT Department said.

### New cooperative policy soon: Shah

New Delhi, Sept 25: Union Cooperation Minister Amit Shah on Saturday said the Centre will soon come out with a new cooperative policy and work in tandem with states to strengthen the cooperative movement.

Shah also announced that the number of primary agriculture cooperatives (PACs) will be increased to 3 lakh in the next five years. At present, there are about 65,000 PACs.

He was speaking at the first Sehkarita Sammelan or National Cooperative Conference here. The Ministry of Cooperation was formed in July this year.

Shah said there could be a legal response to it, but he does not want to get into this argument. The Centre, he stressed, will cooperate with

states and there will be no friction "We will work with all states to take forward the cooperative movement," he said, and added the Ministry of Cooperation has been formed to strengthen and modernise the sector. Stressing that the cooperative movement was more relevant today than ever, Shah said cooperatives can contribute a lot in

the development of the country. According to him, the cooperatives will play a crucial part in making India a \$5 trillion economy. Referring to the problems being faced by cooperatives on taxation front and other issues. Shah said he was aware of the concerns and assured that there would be no injustice towards them.

# Semiconductor shortage to further impact PV sales in Sept

New Delhi, Sept 25: Semiconductor supply shortage is expected to further impact passenger vehicles (PVs) sale volumes in September. Lately, a global supply chain shortage of semiconductors have badly impacted automobile production.

At present, these shortages have forced several Original equipment manufacturer (OEMs) to slow down production, thus, further extending the waiting periods of popular, feature-rich and high-end models. According to India Ratings and

Research (Ind-Ra) report, the semiconductor shortage will further impact PV volumes in September. Furthermore, it said that '2W' volumes may remain tepid in September, although sequential recovery is expected to continue in 2HFY22, aided by demand coming from the reopening of educational institutes and offices.

Last month, improvement in consumer sentiments on the back of Onam-led festive demand and a continued decline in daily Covid cases led to a sequential rise in domestic auto sales volumes in August.



that the growth was constrained by supply chain issues especially shortage of semi-conductor chips Sales volumes were 11 per cent lower YoY, mainly driven by a de-

cline in the '2W' segment. Domestic '3W' witnessed 60 per cent YoY sales growth due to the lower base, although volumes were 40 per cent lower than August 2019's, the report said.

The growth trend in exports volumes moderated in August 2021 due to the higher base in August 2020. Still, volumes were higher than the corresponding period in FY20, for the third consecutive month, indicating a recovery to precovid levels.

Domestic PV demand continued its shift towards utility vehi-

cles (UVs) with 38 per cent YoY sales growth; the segment accounted for 49 per cent of the domestic PV sales. The segment's share in PVs is likely to decline further in September, as Maruti Suzuki India Limited has announced around 60 per cent lower than normal production for the month.

Domestic original equipment manufacturers (OEMs) continue to calibrate their production as the global auto industry remains plagued by the semi-conductor chips shortage, worsened by lockdowns in east Asia.



MANCHESTER: Bruno Fernandes missed an injury-time penalty as teammate Cristiano Ronaldo looked on in Manchester United's 0-1 home loss to Aston Villa in the Premier League Saturday. ### Gold eludes India yet again at World Championship

Yankton (USA), Sept 25: The Indian women's and mixed pair compound archery teams signed off with silver medals after losses to Colombia at the Championships here.

India were in pursuit of their first ever gold medal at the world event. For a country that doesn't have a gold yet, India have climbed the most podiums at the event – 10, appearing in eight finals and leaving with silver each time.

The star Indian mixed pair duo of Abhishek Verma and Jyothi Surekha Vennam, who stood fourth in the ranking round, started off with a one-point lead but thereafter it was a story of Colombian dominance. The Indians went down by a four-point margin (150-154).

The seventh seeded women's team of Jyothi, Muskan Kirar and Priya Gurjar, on the other hand, lost by a margin of five points (224-229) against the troika of Sara Lopez, Alejandra Usquiano and Nora Valdez. The Colombians, who topped the rankings, drilled in 15 perfect 10s with five Xs (closest to the centre). Locked 58-58 after the opening end,



the Indian women's team failed to snatch a lead shooting twice in the red circle as their opponents gained a one-point advantage.

There was no stopping the Colombians thereafter as they shot eight 10s from 12 arrows in the last two ends to win their third women's title, and first since 2017.

In the mixed pair event, India had a poor second end where they shot two 9s and one 8 to squander a onepoint lead and lose the match by four points. The duo of Daniel Munoz and Sara, who stood second in the rankings, consolidated after the first end and shot a perfect 40/40 in the third end to win their first ever



mixed gold medal.

Overall, the Colombian pair shot 10 perfect 10s from 16 arrows while the Indians were no match with just eight 10s. For Colombia, it reasserted their supremacy in compound archery taking their alltime gold medal count at the World Championships to four.

India are also in contention for three medals in individual compound events with Verma and Jyothi slated to compete in their respective quarterfinals later Saturday. Ankita Bhakat is the lone archer in fray in the recurve competition ( and she will compete in her lasteight match Sunday.
