New Delhi, Sept 30: Petrol litre respectively.

The price of petrol was hiked to ₹101.64 a litre in Delhi and to ₹107.71 per litre in Mumbai, according to a price notification of stateowned fuel retailers. Diesel rates increased to ₹89.87 a litre in Delhi and ₹97.52 in Mumbai.

This is the second price increase in petrol since the ending of a three-week-long hiatus in rate revision and the fifth in the case of diesel.

Punjab Chief Minister Amarinder Singh said Thursday he will definitely not join the BJP, but will quit the Congress. Sources close to the veteran politician however said that Amarinder is planning to float a new party as he still has the support of 25-30 MLAs in the Punjab Assembly. Once he forms the new party, he will take a plunge in the Assembly elections with the tacit support of the BJP.

So far I am in the Congress but I will not remain. I have already made my position very clear. I will not be treated in this manner," the 'Captain' said Thursday. His comments came after he met Home Minister Amit Shah Wednesday and also had a meeting Thursday morning with NSA Ajit Doval. Soon after; Amarinder removed the word 'Congress' from his Twitter bio.

New Delhi, Sept 30: The Supreme Court Collegium has approved the appointment of two advocates and two judicial officers as judges in the Orissa High Court. The three-member Collegium headed by Chief Justice NV Ramana, in its meeting September 29, approved the proposal for elevation of advocates Aditya Kumar Mohapatra and Mruganka Sekhar Sahoo and Judicial Officers Radha Krishna Pattanaik and Sashikanta Mishra as judges in the Orissa High Court. Earlier, the Supreme Court

Collegium had also recommended transfer of three judges to Orissa High court. They are Justice Jaswant Singh from Punjab and Haryana High Court and Justices Arindam Sinha and Soumen Sen from the Calcutta High Court. The Collegium had also recommended the transfer of Justice Sanjay Kumar Mishra from Orissa High Court to Uttarakhand High Court.

## **Passenger dies after** emergency landing of flight at BPIA

The IndiGo aircraft made an emergency landing after a passenger complained of acute breathing problems

Bhubaneswar; Sept 30: An IndiGo Airline flight from Kolkata to Hyderabad (6E-946) made an emergency landing at the Biju Patnaik International Airport here Thursday due to a medical exigency, airport sources informed. The flight was diverted to the Odisha capital after a 59-year-old man complained of breathing problems.

The flight landed around 6.00pm athe BPIA. The patient, identified as Jayabrata Ghosh, was travelling along with three family members. sources said.

Ghosh was attended by a doctor in the flight itself who detected cardiac problems and suggested that the patient be immediately admitted to a hospital for further medical assistance. By the time Ghosh was deboarded from the flight he was unconscious. He was pronounced dead on arrival at the hospital.

A similar incident had occurred in 2018 also when a flight en route from Kolkata to Bangalore was diverted to the BPIA following a medical emergency. A 32-year-old man needed immediate medical attention for which Indigo flight (6E-822) made an emergency landing atthe BPIA. However, then also the passenger had breathed his last.

Murder mystery solved PIPLI BYPOLL ENDS PEACEFU

Bhubaneswar, Sept 30: Commissionerate Police solved Thursday the mystery behind the murder of a 26-year-old woman, Sandhyarani Sethi whose decomposed body was recovered from a house at Mahavir slum in Baramunda locality here September 7. A team of twin city police team arrested the alleged paramour of the victim from Kolkata. He has been charged with strangulating the woman to death.

The accused identified as Sk Farid alias Kartika Jena, 35, is a native of Nijkasba under Talapatghat coastal police station in East Medinipur district of West Bengal. He was produced in court Thursday and sent to judicial custody.

Farid initially came to Cuttack 22 years ago, but left soon after. Few years later he came here and

started working as a mason. He shifted to Baideswar locality area in Cuttack district where he married a girl of Chadeibandha village under Baideswar police limits in 2008

However, things changed for the worst when Farid met Sandhyarani at Barmunda in 2017. She as a widow sought Farid's help to get some work to support her family. Subsequently, they entered into a

live-in relationship. When Farid's wife came to know about the development, she lodged a complaint with the police. In spite of that. Sandhvarani would frequently engage in arguments with Farid and his wife. So Farid decided to get rid of her.

Farid strangulated Sandhyarani to death September 3 and fled to Kolkata. However, he failed to evade the police, who tracked him down to Kolkata and arrested him.

Pipli bypoll had been deferred thrice for various reasons since it was fixed for April 17 this year after the demise of sitting MLA Pradeep Maharathy

Bhubaneswar; Sept 30: The muchawaited bypoll to the Pipli Assembly constituency went off peacefully Thursday with a voter turnout of over 68.40 per cent. Voting was conducted in 348 booths of the constituency from 7.00am till 6.00pm. There was no report of any untoward incident from the Assembly segment, said Chief Electoral Officer (CEO), SK Lohani after the completion of the polls.

"Polling has been peaceful with 68.40 per cent of the people casting

their votes while adhering to Covid-19 guidelines. Security personnel were present in all polling booths to ensure free and fair voting," Lohani told mediapersons, Thursday evening. He informed that final percentage of the votes

cast will only be available Friday morning. Polling in some booths, however, got delayed due to technical glitches in the electronic voting machines (EVM), some officials informed.

Many people were seen standing

in queues outside polling centres, where markings had been drawn on the ground to enable voters to maintain social distancing.

The fate of 10 candidates in fray including the ruling BJD's Rudrapratap Maharathy, Ashrit Pattanayak of the BJP and Congress nominee Bishwokeshan Harichandan Mohapatra have been sealed in the EVMs. All the candidates cast their votes at their respective polling booths and exuded confidence. Their fate will be known October 3.

The administration deployed around 2,000 security personnel to ensure peaceful voting in Pipli, which has a history of poll violence. While webcasting was done in 175 of the 201 sensitive booths, video recording arrangements were made in 12 booths. Twenty-three micro-observers were also appointed to monitor the voting process.

Tikiri (Rayagada), Sept 30: There is palpable anger among people in the tribal-dominated Kashipur block of Rayagada district in south Odisha against Utkal Alumina. Betrayal by the company that bought their land at cheap rates with the promise that they would get company jobs, non-payment of land dues, its empty promise to relocate land losers and above all non-realisation of other simple commitments such as good roads, education for kids and providing healthcare facilities have all added up to alienate the innocent tribals. The district administration, even though it is aware of the people's miseries, has done precious little to mitigate them. Worse, the administration has turned away from them whenever they looked to it to protect their interest and get justice. And to cap it all, the government machinery was prompt in branding the innocent tribals as Maoists whenever they rose to demand their justified rights. Records show two villagers were shot dead by police because they were demanding justice. Their crime was they believed the words of the authorities and the company and when they expressed displeasure at being cheated, they had to pay the ultimate price.

Recently, people took heart when local MP Saptagiri Ulaka met the Revenue Divisional Commissioner (RDC), Berhampur, to discuss about local issues and exploitation. This

by this correspondent to the RDC to know about the outcome of their meeting went unanswered. However, sources said the RDC has promised to call a meeting of all the stake-holders within three months.

Massive protests had taken place when the Aditya Birla Group decided to set up its plant in Tikiri. People outright denied to part with their land. However, they relented when promises of fast-paced development of the region and availability of facilities at par with those in developed urban areas were made to them. Locals were promised they will see a complete turnaround in their life in 10 years. However, 17 years have since passed. None of the promises have been delivered. Most of the villages around the plant have not received power connections. Doraguda village, where the plant is situated, got power supply four years ago after strong protests continued for very long. However, most of the time, there is no power supply in the village. Till today, there are no hard topped roads nor drinking water facilities in that village.

Tripati Jhodia of Bagirijhola village, where large chunks of private land had been acquired by the company, says Utkal Alumina took five acres from his family.

Vast tracts of land acquired by Utkal Alumina While they received an initial Rs 21,000 per acre, the balance is yet to come. "The company insisted on full handover of land after which they would get jobs. Our lands have long gone to the company's record, but we are still waiting for the jobs.

Some were even given false appointment letters," Tripati said, adding, when people protested they were suppressed by force. The two who were shot down by police were from this village Kabir Nayak, a co-villager, said

they had given a memorandum to District Collector on 1 May 2010 as the company failed to carry out its promises. However, the Collector refused to talk to the company authorities. After visiting the Collector's office several times, the villagers kept quiet. Such stories of unkept promises, deceit and exploitation were heard in most of the nearby villages like Kocheipadar. Bhagaban Majhi, a resident of this village, said the company took over 100 acres of their land without even their knowledge. How is this possible without the help of the administration, he asked. They met several people including the National SC/ST Commission at Delhi, but to no avail. The villagers allege that no matter who comes as Collector cum District Magistrate or Superintendent of Police or their junior officials, somehow all get into the payroll of the company at the blink of an eve. They feel the district administration has been play-

## 2 Odisha hosps top NITI ranking

#### POST NEWS NETWORK

New Delhi, Sept 30: Although Odisha has fared poorly in terms of health facilities in district hospitals, Bolangir and Mayurbhanj districts have secured the top ranks in mid-sized hospitals category in NITI Aayog's performance assessment report released Thursday.

The report titled 'Best Practices in the Performance of District Hospitals' states that the hospitals in Bolangir and Baripada have 2.26 and 2.14 times the requisite staff of doctors in position as prescribed under Indian Public Health Standards (IPHS) norms.

The report revealed that the national average stands at 0.86 times the requisite staff while the state average is 0.94 times. Around 18

to 37 per cent district hospitals in Odisha meet the doctors to bed ratio. However, the state does not meet the required number of nurses in the district hospitals and its average availability of nurses and paramedical staffers in district hospitals is below the national average. The report also stated that most of the district hospitals in the state do not have all 14 core services. On an average the hospitals have been providing only 11 core services to people.

Bolangir's is the only district hospital in the state that has been providing all 14 identified core healthcare services, the report revealed. The ancillary services of the hospital are also very good like the hospital provides mechanised housekeeping services, smart security services with CCTV cameras. mechanised laundry services. help desk services, free diet services, proper waste management services, central registration services, free drug services, free investigation services, free high-end diagnostic services like CT scan. dialysis among other facilities. In terms of availability of beds in the district hospitals, Odisha's position remains below the national average of 24 as the state has 22 beds per 1 lakh population in the district hospitals.

Only 15 district hospitals in the state have a bed occupancy rate of 90 per cent or higher. Deogarh and Gajapati district hospitals have 100 per cent bed occupancy in small-sized hospitals category, while Bolangir hospital has 100 per cent occupancy in mid-sized hospitals category.

# **CB** issues circular post Balanga blast

Bhubaneswar, Sept 30: Following the embarrassment over the mas sive explosion at the depository of Balanga police station, the state Crime Branch (CB) issued a circular Thursday, directing all district Superintendents of Police (SPs) to ensure inspection of Malkhanas at the police stations by Sub-Divisional Police Officers (SDPOs) and Deputy Superintendents of Police (DSPs). The SPs have been asked to ensure the inspection carried out by October 5.

The Crime Branch also instructed the officials to take extra care while storing the explosives. corrosives and highly inflammable materials in the Malkhanas or in the campus of the station following seizure, for the safety of visitors as well as cops on duty.



The Crime Branch directed the officials to not keep any explosive material in the Malkhanas of police station if there was no need for the same. It also instructed the cops to seek the help is necessary to keep those articles of bomb disposal squad of the state police to store explosive in the Malkhana, the same shall be

items in the Malkhanas. 'Explosive materials, corrosive substances, highly inflammable materials should not be kept ordinarily in the Police Station Malkhana. In extreme cases, if it done only after due examination by Bomb Disposal Squad/other specialised agencies with necessary precautions," instructed the Crime Branch.

The officials have been asked to keep the explosive materials in open space outside the Malkhana till the examination is conducted by experts.

Cops have been directed to diffuse or destroy dangerous explosives with the help of Bomb Disposal Squad and other specialised agencies by seeking the permission of respective courts.

Notably, a massive explosion inside the Balanga police station in Puri district damaged the building severely Monday night. A Sub-Inspector Tapoi Nayak, who was in charge of the Malkhana (storeroom), was placed under suspension for dereliction of duty.

Safe drinking water is unavailable in flood-hit areas as hundreds of tube wells in four blocks have been under water. Cases of infection and gastroenteritis are on the rise in the flood-affected areas.

## GI TAG FOR KUCHINDA RED CHILLI LIKE

As local farmers faced frequent droughts owing to scanty rainfall and water scarcity, the erstwhile ruler of Bamanda, Basudev Sudhal Deo had thought of an alternative crop for sustainable farming in 1901. Then he provided quality chilli seeds to farmers and motivated them to adopt chilli farming as a means of livelihood

Sambalpur, Sept 30: The district administration has launched efforts to get the geographical indication tag for the famous red chilli of Kuchinda region in this district.

The matter came to the fore after Ashutosh Kulkarni, IAS probationer and the executive officer of Rairakhol notified area council (NAC) in the district, applied for geographical indication (GI) tag for the popular red chilli of Kuchinda region recently. The chilli has earned a distinct identity of its own as traders from across the country visit Kuchinda to procure the chilli.

However, due to lack of promotion and marketing facilities many farmers were forced to opt out of its cultivation. It is hoped that GI tag will definitely help in sustaining the local farmers in chilli cultivation and help them get better market prices for their produce.

According to the official, traders from Kuchinda and outside buy huge quantities of red and green chilli produced in the sub-division for its good quality. "If GI tag is accorded, then the demand for the local produce would go up, which will help fetch a fair price," the official said.

Reports said farmers of Kuchinda primarily grow chilli. It is now cultivated on 7,845 hectares of farmlands in both kharif and rabi seasons. Nearly 12,000 local farmers earn their livelihood from chilli cultivation.

The harvested chilli is sold for ₹3,000 to ₹3,500 per quintal. In order



to make the farmers self-sufficient, a chilli powder manufacturing plant has been set up in Kuchinda. Members of women self-help groups (SHGs) after receiving training have been managing the plant and manufacturing chilli powder, ORMAS district coordinator Srimanta Hota said. They are selling the chilli powder for ₹15,000 per quintal, he said. To ensure better marketing fa-

cilities, attempts were made to obtain GI tag for the chilli. A private agency has been appointed to prepare a detailed project report(DPR) on the quality of chilli, number of farmers cultivating the crop, demand-supply analysis, farming procedures, its period of inception, demand timing in the market and other factors. The farmers can trade outside the country if GI tag is available to the chilli.

Notably, Kuchinda sub-division is a non-irrigated region. As local farmers faced frequent droughts armers of Kuchinda primarily grow chilli and it is now cultivated on 7,845 hectares of farmlands in both kharif and rabi seasons

# Greening the hardest sectors

Torld leaders are making increasingly ambitious commitments to reduce greenhouse-gas emissions and limit the catastrophic effects of climate change. But to convert commitments into results, more must be done to decarbonise all sectors of the global economy rapidly.

This process will be relatively easier for sectors like electricity and passenger cars, where clean energy solutions are ready for deployment at scale. But it will be much more difficult for aviation, cement, shipping, steel, and other "hard-to-abate" sectors.

Achieving net-zero emissions in these sectors requires the rapid commercialisation of technologies that are not yet quite ready for deployment at scale; and commercialisation, in turn, will require coordination across industries. Companies supplying products such as steel need to align with their customers, financial partners, policymakers and other stakeholders to agree on a decarbonisation pathway for their industries.

Such a consensus is necessary to ensure that everyone understands which technologies are progressing and at what pace. With

that knowledge, everyone can align on the process of investing in low-carbon assets with long life cycles, such as steel mills, cement factories, ships, and airplanes.

Achieving this level of alignment across global industries is not easy, but it can be done. Consider the shipping industry, which has already developed a global decarbonisation pathway under the leadership of the Global Maritime Forum's Getting to Zero Coalition. This four-step alignment process, enshrined in the Poseidon Principles, is now being replicated across other hard-to-abate sectors under the leadership of the Mission Possible Partnership.

The MPP is a global coalition of industrial and climate leaders focused on supercharging efforts to decarbonise some of the world's highest-emitting industries in the next ten years. Its immediate priority this year is to shine a spotlight on the leading hard-to-abate sectors at the COP26 climate-change conference in Glasgow this November.

While the previous United Nations climate change conferences have focused primarily on national commitments and policymaking, additional mechanisms need to be activated to accelerate the pace of emissions reductions. Ambitious climate targets will not be within reach until the leaders of the industries that produce the most emissions have decarbonised their entire global supply chains. As my former colleague Paul Bodnar of BlackRock likes to say, "The real economy is not a side show." Elevating industry to the same level of importance as national governments is critical.

A few key technologies will be essential to decarbonisation efforts across all hard-to-

abate sectors. Chief among these is green hydrogen produced with renewable electricity and electrolyzers. Efforts to scale up green hydrogen production are already underway with programs such as the Green Hydrogen Catapult and the US Department of Energy's recently announced Hydrogen Shot, which is modeled after the successful SunShot program that rapidly brought down solar-panel costs. Moreover, there are early signs of rising industrial demand for the low-emissions products that green hydrogen enables. The automaker Volvo, for example, has announced that it will source fossil-fuel-free steel from the Swedish green-steel venture HYBRIT.

Technologies to improve efficiency are another key (though less exciting) ingredient in decarbonising hard-to-abate sectors. Whether it means deploying lightweight aircraft or constructing buildings with less steel, the less energy an industry uses overall, the easier the process becomes. A recent

inequities are at multiple levels and are mainly caused by attitudinal and behavioural reasons such as ageism and stigma, as well as by physical factors, mainly remoteness of rural settlements and limited outreach of services in those areas. As the battle against coronavirus continues, the digital divide across the population, particularly impacting older people, is proving to be a critical issue.

The UN International Day for Older Persons (IDOP) is being observed every year for over 30 years after the UN General Assembly passed a resolution in this context on December 14, 1990. The IDOP is observed around the world to raise awareness on ageing population, related public health priorities and to build and strengthen solidarity on actions towards healthy ageing.

It is well understood that digital technologies been playing a crucial role in health programmes worldwide, particularly in managing the COVID-19 pandemic. The digital divide is isolating older people and leaving them behind visà-vis progress of health and wellbeing programmes. Hence, IDOP 2021, with its theme, emphasises

on the need to access and meaningful participation of older people in digital world.

IDOP 2021 is also the first important event under the UN Decade of Healthy Ageing which was endorsed by the UN General Assembly on December 14, 2020 through a resolution, spanning 2021 to 2030. The decade of healthy ageing is led by the World Health Organisation (WHO) and is a global collaboration that will bring together governments, civil society, international agencies. professionals, academia, the media, and the private sector, and will continue its interventions in alignment with the last 10 years of Sustainable Development Goals (SDGs) and of the 2030 agenda for Sustainable Development.

To foster healthy ageing and to improve the lives of older people, the decade of healthy ageing will focus on four action areas. The first is to create and strengthen agefriendly environments by removing physical and social barriers and by converting environments into better places to live and age. The second is to combat ageism. The third is to provide integrated care. All older people should have nondiscriminatory access to integrated care which should include prevention, curative, rehabilitative, and palliative, and "end of life" care. The fourth is to support long-term care.

Moving forward, it may be worthwhile to focus on key needs in the context of healthy ageing. The first need is to design a comprehensive communication mechanism and to deliver the decade of healthy ageing messages to all stakehold ers, most importantly to older people themselves. The second key need is to develop a strategy for partnerships which are going to be crucial in engagement of key groups, delivery of services and for research and advocacy. Civil society, government agencies and private sector are three important constituents of the partnerships spectrum, and a clear plan for their engagement must be developed at both macro and micro levels. The third need would be to create some form of guiding groups at national levels or sub-national levels in the case of larger countries comprising representatives from different sectors ensuring dynamic planning, implementation and monitoring of actions.

COVID-related challenges are already an obstacle and will continue to hamper the progress probably for long in future. Mitigation strategies will have to be worked out in advance in the context of community education and delivery of care services using digital education, telemedicine and following COVID guidelines, keeping the local context and situation in view.

Let this IDOP be an important reminder of digital inequities and its impact on public health particularly on old people's health. Ensuring digital equity for older people will need to be a key priority in the future of healthy ageing interventions. Researchers and policy makers have observed that free services are not valued, and hence suggested providing such services recovering at least the operational cost.

analysis from the Energy Transitions Commission (ETC) shows that the first step to building a net-zero global economy by 2050 is simply to use less energy, followed by scaling up and universalising clean-energy sources.

The ETC also highlights the importance of carbon capture and sequestration, which will be needed not only to offset industrial processes that cannot be fully decarbonised, but also to reduce the level of carbon dioxide already emitted into the atmosphere. Accounting for historic emissions is a complex process that most industrial leaders have yet to consider fully. But they had better start thinking about it now, because any realistic pathway to keep global warming within  $1.5^{\circ}$ C of pre-industrial levels will have to include reducing atmospheric CO2.

Not only do we need to remove massive quantities of CO2 from the atmosphere; we also must find long-term storage solutions to keep it locked away for hundreds or even thousands of years. This is where the gap between the net-zero objective and existing technologies is the largest.

Who should bear the costs of tackling this problem? Certainly, many argue that the countries and companies responsible for the largest share of historic global emissions should assume a corresponding responsibility for CO2 removal. In an upcoming article, the World Economic Forum's Global Future Council on Net-Zero Transition will explore this issue and describe different approaches for how we might reach a consensus on responsibility for historic emissions.

As we look toward COP26, we must pay ample attention to all these challenges. National governments and global industries alike need to act immediately to reduce emissions; merely committing to act in the future is no longer acceptable. The longer we fail to lock in more sustainable development pathways, the harder it will be to keep global temperatures at a safe level. Even if we do reduce annual emissions somewhat, it is the cumulative amount of CO2 in the atmosphere that matters. If that is still growing, the problem will not be solved.

We need global leaders everywhere to understand the scale and urgency of the crisis we face. Radical collaboration and coordinated action are required right now, from everyone. It is not just future generations that are depending on us. Even tens of millions of people are already suffering in terrible heatwaves, fires, floods, droughts, and storms. From California and Texas to entire regions of Africa, Asia, and the Middle East, the catastrophic consequences of the climate crisis are compounding. While the costs of reducing emissions are significant, they are negligible compared to the costs of failing to do so.

Constitution has institutionalised the panchayats to function as units of local self-government enabling inclusiveness both in participation and decisionmaking process. The Act recognises panchayat as the most accessible and approachable form of government for people living in rural India, and the delivery of

basic services required by them. The 73rd amendment to the Constitution, in the Eleventh Schedule, also lists 29 subjects that need involvement of panchayats. More than 27 years have lapsed after the constitutional amendment, but wide variations exist across states in the level of powers and functions devolved to panchayats.

The 15th Finance Commission award has created an enormous opportunity for responsive local governance at the cutting edge institutional level of the panchayats by assuring fiscal transfers to (₹2,36,805 crore) during the period 2021-22 to 2025-26.

The grant is intended to be used to improve delivery of basic civic services, including drinking water supply, sanitation including sewerage and solid waste management,

of community assets, maintenance of roads, footpaths, street-lights, burial and cremation grounds and other basic functions assigned to them under their respective statutes. The Commission also strongly recommended that the panchayats need to improve the quality of services they deliver and strengthen accounting, record keeping and accountability mechanisms.

Service delivery standards of panchayat

However, delivery of public services at all levels of panchayats continues to be a focus issue for improving efficiencies and effectiveness as they are unable to deliver quality and timely services. Host of constraints such as lack of adequate staff and, hence, inability to provide frontline workers, insufficient funds in terms of allocation, inability to raise adequate own sources of revenue, lack of technical expertise, etc. are haunting a majority of panchavats in the country However, seriousness of these constraints varies not only across states, but also panchayats within a state.

It is imperative that panchayats must provide quality services to the citizens at an affordable price, and ensure equal access for all. The issue of setting service de-

Setting up of such service benchmarks will help the states and panchayats to set their performance requirements and targets related to service delivery and design institutional strengthening and other capacity building initiatives to attain those benchmarks.

Creation of Grievance Redressal System in panchayats, adequate human resources, synchronising services, upgradation and adoption of technology, and establishment of e-seva or Common Service Centres closer to panchayats will address the issue.

There are large variations in terms of cost and time for delivery of services across India. These variations may be due to the local conditions for sourcing and providing services like drinking water. There are some services which are free in some states and charged in other states. All the charges need to be revised from time to time using cost of living index. The standards suggested are to be considered as desirable standards, which may be included in the Citizens Charter. There are some states which exceed these standards, and many which are far below from these standards.

## **Dengue sees a 12-fold rise** in Ganjam than last year

Berhampur, Sept 30: There has been a 12-fold rise in the spread of dengue in Ganjam district compared to last year when only nine persons had tested positive for the disease, a report said.

The disease has acquired alarming proportions in the district as 106 persons tested positive by September 30 in 17 blocks and in Berhampur Municipal Corporation (BeMC) areas, district health officials said

The rapid spread of the disease has sparked concern among policymakers and residents alike. Meanwhile, 106 persons have tested positive with two more testing positive in Chhatrapur block, Thursday. Among the affected persons, one

is a 12-year-old boy from Chhatrapur while another is a 42-year-old man

#### The disease has acquired alarming proportions in the district as 106 persons tested positive by September 30 in 17 blocks and in BeMC area

of Sana Aryapalli village. In Berhampur, 30 persons including six children have tested positive

for the disease so far. Health officials and residents suspect that the disease might have come from outside of the district. Reports said affected persons, who first tested positive for the disease, had come from outside of the district or from other states. Since then, the disease has been spreading fast in the district. Things have come to such a pass that each day one or two persons test positive. This year, 106 persons have tested positive for the disease while only

nine tested positive last year. This is a 12-fold rise in the spread of the disease compared to last year, health officials said.

When contacted, chief district medical officer (CDMO) Dr Uma Shankar Mishra said Ganjam. Jagannathprasad, Buguda, Kodala and Belguntha blocks have remained untouched by the disease as not a single person in these areas was identified with it. However, the silver lining is that not a single person has died in last nine years, he said.

Notably, dengue had acquired epidemic proportions in Ganjam district in 2012 when a maximum of 533 persons had tested positive. Health officials said stagnation of dirty water is giving rise to birth of Aedes mosquitoes-the carrier of the disease. They said people are being sensitised not to allow water to stagnate around their houses.

They said health officials are visiting spots where dengue patients have been detected and destroying the mosquito larvae. Similarly, sanitary workers

clean the areas of coconut shells. broken buckets and unused tyres as water might stagnate in them and lead to birth of dengue mosquitoes. The BeMC authorities also conduct fogging in vulnerable areas of the city.

In the complaint, the woman officer said that the two-finger test which is an illegal preliminary, unscientific examination of rape victims to ascertain sexual abuse was conducted on her. The woman officer, in the complaint before the All-Woman police, said that the attitude of some of the officers of the IAE who were made aware of the incident, was to force her to withdraw the complaint.

This clearly shows the lack of em pathy on the part of the IAF as well as conducting the illegal twofinger test which was a violation of human rights and dignity of a woman, the complaint states.

In the FIR, the woman IAF officer alleged that she was raped

The woman officer, in the FIR, alleged that senior officers including those in charge of administration were pressuring her to withdraw her complaint.

She later filed a complaint at the All-Women Police Station at Coimbatore after mustering courage September 20 and the accused, Amitesh was arrested.

The Air Force contended that the accused be handed over to them, when he was produced before the Mahila Court in Coimbatore but as the victim and police objected to it, his judicial custody was extended till September 30.

The woman said that she did not know that the two-finger test was banned by the Supreme Court of India in 2013 and said that the test made her nauseous to relive the trauma, according to the FIR.

Mumbai, Sept 30: Most of the agencies that are associated with the investigation around cases that involve former Mumbai Police commissioner Param Bir Singh feel he has fled India.

Singh had appeared before the National Investigation Agency (NIA) April 7. Summons had been issued to him in the Antilia bombscare case, which had taken place February 25.

After the February incident, Singh was transferred to the Home Guards department March 17. He took charge of his office March 22 and is said to have attended office till May 4.

He cited health issues and went on leave from May 5. Sources mention he was in Chandigarh, his home town. Between May and August, Singh communicated with the Maharashtra government seeking extension after extension, citing health issues. Singh claimed he underwent surgery and was bedridden.

Later, around the second week of August, he sought another extension saying he was still unwell and this time sought leave till August 29. However, since then, there has been no communication from him at all. NIA officials, too, summoned Singh in the second week of August but they could not find him anywhere.

In the meantime, the one-man committee of retired Justice KU Chandiwal, which was set up in

March summoned Singh at least four times to come and depose. The commission is conducting an enquiry against former home minister Anil Deshmukh on the allegations levelled by Singh himself.

Singh filed a few affidavits through his lawyers. His lawyers had also submitted that Singh could appear through video conferencing but that was objected by the lawyers. The commission has levied heavy

fines on Singh and has twice issued bail-able warrants against him. Officials from various investigating agencies have visited Singh's residence in Mumbai, Chandigarh and Rohtak in Haryana multiple times but could not find him. His phones still remain switched off.

Apart from the NIA, the commission and the Maharashtra government, which is looking for their missing Home Guard senior officer, Singh's colleagues, too, have been looking for him.

There are five cases registered against Singh. The first case was registered in Thane and the last one in Mumbai. With regards to the Thane cases, a look out circular (LOC) was issued in the middle of August. A look out circular is a notice, which prevents a person from leaving the country.

Singh's lawyers cite client-advocate privilege and refused to talk on the issue. But in the meantime, the Maharashtra government is mulling suspension of its officer, who has been MIA

30 medical students test Covid positive

Mumbai, Sept 30: The Brihanmumbai Municipal Corporation (BMC) administration has ordered RT-PCR tests for medical students of the civic-run GS Medical College in the KEM hospital and their relatives after 30 students were tested positive for Covid-19

"We have asked KEM hospital administration to do Covid test for 1,100 persons - the fellow students and also relatives of affected students," said additional municipal commissioner Kakani

"In the last three days, we found 30 students to be positive for Covid-19. They are quarantined and some of them are shifted to Seven Hills Hospital - a dedicated

Covid facility at Marol. Some of them have mild symptoms and we have kept them under observation. Most of them are vaccinated," he said.

A head of department from KEM hospital said, "Those affected are in the first and second year of MBBS. We have been telling the students to be careful. Mumbai, Sept 30: Environment and water management experts have claimed that "unscientific' works done under Jalyukta Shivar, a flagship water conservation scheme of the previous BJP-led Maharashtra government, led to flooding after recent heavy rains in the state's Marathwada region.

The scheme was launched by the then Chief Minister Devendra Fadnavis for the construction of check dams, rejuvenation of old check dams, repair of Kolhapur Type (KT) weirs and storage tanks and removal of encroachments from river beds so as to increase water percolation.

Two days back, heavy water discharge from the Manjara dam in Marathwada following heavy rains caused flooding in some villages of Beed, Latur and Osmanabad districts.

Talking to this news agency, Pradeep Purandare, former associate professor at the Water and Land Management Institute in Aurangabad region of Marathwada, claimed that "rampant and unsci-

entific" deepening and widening of river beds in Marathwada and the construction of KT weirs led to the recent floods in the region.

"I had raised concerns over the issue from time-to-time, but they were ignored by the then state government," he claimed. Purandare said as a first step

under the scheme, continuous contour trenches were supposed to be made on hill slopes. The deepening and widening of river beds was not a priority, but, during the Fadnavis government, this work was given preference, he said.

"Hence, unscientific deepening and widening of river beds led to an increase in the water flow," he claimed.

The state election commission has directed district collectors to form flying squads for the elections. The squads are to include

one executive magistrate in the rank of tahsildar and revenue divisional officers beside police personnel. They are to act on complaints of violation of model code of conduct, anti-social activities, threat, intimidation, and of bribing voters with liquor and cash.

"The district collectors should constitute the flying squads in a way that they operate 24 hours. The squads with an eight-hour duty on a shift basis should be constituted," a release read.

## **Terror case: Maha ATS arrests one more**

Mumbai, Sept 30: The Maharashtra Anti-Terrorism Squad (ATS) has arrested one more suspect in a case of criminal conspiracy to commit a terror act registered by it, after the Delhi Police recently busted a Pakistan-supported terror module by nabbing six people, a police official said Thursday.

This is third arrest by the state ATS in the case registered by it earlier this month under Section 18 (criminal conspiracy to commit a terror act) of the stringent Unlawful Activities (Prevention) Act (UAPA), he said.

The suspect, identified as Irfan Rahmat Ali Shaikh, a resident of Kherwadi in Mumbai's Bandra area who worked as a tailor, was placed under arrest on Wednesday night, the official said.

Some incriminating documents were also recovered from him, he said.

The polls are to be held in nine districts of the state Kancheepuram, Chengalpattu, Vellore, Ranipet, Tiruppatur, Villupuram, Kallakurichi, Tirunelveli and Tenkasi

The DMK has a lot at stake as it has to prove that its 2021 Assembly election win was due to the people's support towards the programmes and policies put forward by the party. Chief Minister MK Stalin is directly leading the campaign, which is being executed at the grassroots levels by the district office-bearers of the party.

The AIADMK is also active in the fight and with reports coming up of a power feud within the party between Panneerselvam and K Palanisami. The party, which is in a political alliance with the BJP, is facing tough times following the minority communities coming out against it in several areas of the state.

Recently Congress leader Karti Chidambaram said that unless the AIADMK snaps ties with the BJP, the party will face defeats in the elections.

The PMK has already announced that it will contest the elections on its own indicating that all is not well on the AIADMK alliance front.

This has made the contest wide open as in certain pockets these parties have their strongholds and matinee idols have always been a major vote catchers in Tamil Nadu.

R Padmanabhan, Director, Socio-Economic Development Foundation, a think tank based out of Madurai said, "The rural local body polls in the nine districts of Tamil Nadu will find the interesting and tough contest and almost all the main political parties, as well as splinter groups, are actively campaigning as there are huge developments taking place at the panchayat level and the parties do not want to be left out from these.

"The recent announcement of 🗎 PMK that it would go alone in the polls has upset the AIADMK calculations in North Tamil Nadu. The DMK seems to have an edge as the party in power in the state will definitely have a clear edge in ruraland panchayat elections," said Padmanabhan.

## Roads can't be blocked 'perpetually': Top court

New Delhi, Sept 30: The Supreme Court Thursday emphasised that roads cannot remain blocked perpetually and asked the Centre what steps has it taken to remove the road blockade by farmers, protesting against three agriculture laws at Delhi borders. A bench headed by Justice Sanjay Kishan Kaul told the Centre's counsel: "We have already laid down the law and you have to implement it. If we encroach, then you may say that we have trespassed on your domain.'

The bench further added, "How to implement the law is your business. The court has no means to implement it". The top court said there are grievances, which need to be addressed and queried, "How can highways be blocked perpetually? Where does it end". The bench emphasised the problem could be solved through either ju-

A high voting rate at 78.60 per cent and 76.12 per cent was recorded in Murshidabad's Samserganj and Jangipur seats respectively, where polls had to be countermanded during the April-May assembly elections following the death of two candidates

A total of 6,97,164 voters are eligible to exercise their franchise in the three constituencies. Voting will continue till 6 PM.

Banerjee, who is also the Trinamool Congress supremo, is pitted against BJP's Priyanka Tibrewal and CPI(M)'s Srijib Biswas in Bhabanipur.

Banerjee, a voter of the constituency, cast her vote at Mitra Institution school in the area.

New Delhi, Sept 30: Several Congress leaders of the 'Group of 23', which had last year written to party chief Sonia Gandhi demanding an organisational overhaul, Thursday strongly condemned the attack on their colleague Kapil Sibal's house and termed it as "orchestrated hooliganism"

Congress workers protested outside Sibal's house and reportedly damaged a car, after he raised questions over the party's functioning and attacked its leadership.

Senior leaders Ghulam Nabi Azad, P Chidambaram, Anand Sharma, Bhupinder Singh Hooda, Vivek Tankha and Raj Babbar were among those who rallied behind Sibal, with Sharma asking Gandhi to take strong action against those involved. Former Punjab chief minister Amarinder Singh also criticised what he said was an "attack" at the house of Sibal by Congress workers only because he "chose to express views that were



not palatable to the party leadership".

This does not augur well for the party, Singh said, adding that it was unfortunate that the seniors are being "completely sidelined", which is not good for the party. Terming the senior Congressmen as "thinkers", who were important to the future of the party, the former chief minister in a statement said the vounger leadership should be promoted to implement the plans, which the senior leaders are best equipped to formulate.

Covid-19 too is far from over. It is a case of cause and effect.

The survey showed that global citizens worry about coronavirus (36 per cent), unemployment (31 per cent), poverty and social inequality (31 per cent), financial and political corruption (27 per cent) and crime and violence (26 per cent).

## 116 dead in Ecuador prison violence

Quito (Ecuador), Sept 30: Ecuador's President has declared a state of emergency in the prison system following a battle among gang members in a coastal lockup that killed at least 116 people and injured 80 in what authorities say was the worst prison bloodbath ever in the country.

Officials said at least five of the dead were found to have been beheaded. President Guillermo Lasso decreed a state of emergency Wednesday, which will give the government powers that include deploying police and soldiers inside prisons. The order came a day after bloodshed at the Litoral penitentiary in Guayaquil that officials blamed on gangs linked to international drug cartels fighting for control of the facility. Lasso, visibly moved by the carnage, said at a news conference that what had happened in the prison was "bad and sad." He also said he could not guarantee that authorities had regained control of the lockup.

"It is regrettable that the prisons are being turned into territories for power disputes by criminal gangs," he said, adding that he would act with "absolute firmness" to regain control of the Litoral prison and prevent the violence from spreading to other penitentiaries.

Images circulating on social media showed dozens of bodies in the prison's Pavilions 9 and 10 and scenes that looked like battlefields. The fighting was with firearms, knives and bombs, officials said.

Outside the prison morgue, the relatives of inmates wept, with some describing to reporters the cruelty with which their loved ones were killed, decapitated and dismembered. "In the history of the country, there has not been an incident similar or close to this one," said Ledy Zúñiga, the former president of Ecuador's National Rehabilitation Council.

Zúñiga, who was also the country's minister of justice in 2016, said she regretted that steps had not been taken to prevent another massacre following deadly prison riots last February

Earlier, officials said the violence erupted from a dispute between the "Los Lobos" and "Los Choneros" prison gangs. Col. Mario Pazmiño, the former director of Ecuador's military intelligence, said the bloody fighting shows that "transnational organized crime has permeated the structure" of Ecuador's prisons, adding that Mexico's Sinaloa and Jalisco New Generation cartels operate through local gangs.

Sarkozy wasn't present at the Paris court for the ruling. He was accused of having spent almost twice the maximum legal amount of 22.5 million euros (\$27.5 million) on the reelection bid that he lost to Socialist Francois Hollande. The court stated that Sarkozy

Thursday's verdict comes after Sarkozy, 66, was found guilty on March 1 of corruption and influence peddling in another case. He was given a year in prison, and two years suspended, in that case but is free pending appeal. In the campaign financing case,

prosecutors concluded that Sarkozy knew weeks before the 2012 election that his expenses — which are strictly limited under French law were getting close to the legal maximum. They accused him of having ignored two notes from his accountants warning about the money issue.

Bangkok, Sept 30: Heavy floods caused by tropical storm Dianmu have severely impacted almost half of Thailand's provinces with at least seven people dead and one missing, the country's disaster control authorities said Thursday.

The Bangkok Metropolitan Administration warned Thursday that the water level of the Chao Phraya **River is forecast to rise** over the next few days

Heavy rains swept across 31 provinces of the Southeast Asian country, so far affecting more than 220,000 households, according to the Department of Disaster Prevention and Mitigation (DDPM).

The DDPM also noted that the situation in 13 of the affected provinces has improved, but it remained critical in the other 18 provinces.

The Bangkok Metropolitan Administration (BMA) warned Thursday that the water level of the Chao Phraya River is forecast to rise over the next few days, asking people in seven districts along the river to be prepared for potential floods.

Local media quoted Bangkok Governor Aswin Kwanmuang as saying that the level of the Chao Phraya River is currently well below the top of the flood embankmentacross the capital, without any damage to nearby residences.

### Four killed

Dhaka: At least four persons were killed and 11 others went missing when a boat carrying around 50 passengers capsized in the middle of Padma river in Bangladesh. The incident took place in Shibganj Upazila of Chapainawabganj of Bangladesh Wednesday noon.

### Eight injured

Dallas: Eight people, including four firefighters, were injured Wednesday morning in an explosion at an apartment complex in south Dallas, authorities said. Three of the firefighters were critically injured. Firefighters were investigating a report of a natural gas leak at the twostory complex and had reported smelling gas just before the explosion partially collapsed the building, Dallas Fire-Rescue said in a statement.

## Lava flowing into sea creates delta, expands Spanish island

Madrid, Sept 30: The surface of Spain's La Palma Island is continuing to expand as lava from a volcano flows into the Atlantic Ocean and hardens when it comes into contact with the water. European Union scientists said Thursday.

Copernicus, the European Union's Earth observation program, said Thursday that its satellite imagery showed a D-shaped tongue of molten rock building up on the island's western shore measured 338 hectares (835 acres) by the end of Wednesday.

Trade winds typical of Spain's Canary Islands were helping dispel the plumes of water vapour and toxic gases that result when the



lava with a temperature of over 1,000 degrees Celsius (1,800 F) meets the ocean, where the water is 22 de-

grees Celsius (71.6 F). But authorities were on alert because Spain's weather forecaster, AEMET, indicated the wind's direction could change later Thursday and bring the toxic plumes toward the shore and farther inland.

The hydrochloric acid and tiny particles of volcanic glass released into the air can cause skin, eye and respiratory tract irritation. The direction the lava flow could take was also a source of concern. Molten fluid emanating from the volcano that first erupted on September 19 was still running downhill like a river and then tumbling over a cliff into the Atlantic. But uneven terrain could make the lava overflow its current path, spread to other areas, and destroy more houses and farmland.

At least 855 buildings and 30 kilometres (18.6 miles) of roads, as well as other key infrastructure, have been wiped out so far. Banana plantations that are the source of income for many islanders have also been either destroyed or damaged by volcanic ash.

Over 6,000 residents have been evacuated so far, and hundreds more were advised to stay home to avoid the possible inhalation of toxic gases. No casualties or injuries have been reported among La Palma residents since the eruption began.

La Palma, home to about 85,000 people, is part of the volcanic Canary Islands, an archipelago off northwest Africa. The island is roughly 35 kilometres (22 miles) long and 20 kilometres (12 miles) wide at its broadest point.

## Gas prices up by 62%, CNG may also surge

New Delhi, Sept 30: The government Thursday hiked by 62 per cent, the price of natural gas that is used in households for cooking and is turned into CNG for use as fuel in automobiles.

It will also lead to a rise in cost of power generation, but consumers may not feel any major pinch as the share of power produced from gas is very low.

This is the first increase in rates since April 2019 and comes on back of firming benchmark international prices but does not reflect the spurt in spot or current price of liquefied natural gas (LNG) witnessed during the last couple of weeks.

The Petroleum Ministry's Petroleum Planning and Analysis Cell (PPAC) said the rates paid for gas produced from fields given to state-owned Oil and Natural Gas Corporation (ONGC) and Oil India Ltd (OIL) will be \$2.90 per million British thermal unit (mmBtu) for the six-month period beginning October 1, 2021.

## China manufacturing shrinks first time since Feb '20

*China's economy* rapidly recovered from a pandemic-induced slump last year, but momentum has weakened in recent months, with its sprawling manufacturing sector hit by rising costs, production bottlenecks and *electricity rationing*

Beijing, Sept 30: China's factory activity unexpectedly shrank in September due to wider curbs on electricity use and elevated input prices, while services returned to expansion as Covid-19 outbreaks receded, offering some relief to the world's second-biggest economy. The official manufacturing Purchasing Manager Index (PMI) was at 49.6 in September versus 50.1 in August, data from the National Bureau of Statistics (NBS) showed Thursday, slipping into contraction for the first time since

February 2020 Rising Covid-19 cases in tens of cities over the summer also dis-



rupted the manufacturing and the services sectors, though the latter is starting to bounce back as the outbreaks receded.

A sub-index for factory output contracted in September for the

first time since February last year, dragged down by a pullback in high-energy consuming industries, such as plants that process metals and oil products. The gauge stood at 49.6 versus 50.1 a month earlier.

"In September, due to factors such as low volumes of business at high energy-consuming industries, the manufacturing PMI fell below the critical point," said Zhao Qinghe, a senior NBS statistician, in an accompanying statement. "The two indexes of high energy-consuming industries ... are both lower than 45.0, indicating a significant drop in supply and demand.' **HIGH PRODUCTION COSTS** A shortage of coal, tougher emis-

sions standards and strong demand from manufacturers and industry pushed coal prices to record highs and triggered widespread curbs on electricity usage in at least 20 provinces and regions. Higher raw material prices, especially of metals and semiconductors, have also pressured profits of manufacturers. Earnings at China's industrial firms in August slowed for the sixth straight month. A sub-index for raw material

costs rose to 63.5 in September from 61.3 a month earlier, while a gauge of new orders came in at 49.3 compared with 49.6 in August, shrinking for the second straight month. A sub-index for employment remained in contraction, at 47.8 versus 47.0 a month earlier.

A separate private survey also released Thursday that focuses on small and export-oriented businesses showed that factory activity in September neither expanded nor contracted.

Manchester, Sept 30: Cristiano Ronaldo removed his Manchester United jersey, flexed his muscular physique and soaked in the acclaim of the fans after his winning goal in the fifth minute of stoppage time.

Not a bad way for the Portugal superstar to mark another recordbreaking night in the Champions League. On his record 178th appearance in the competition, Ronaldo made his most decisive intervention with virtually the last kick of the game at Old Trafford to complete United's dramatic comeback in a 2-1 victory over Villarreal Wednesday.

After winning a header from a hopeful cross into the area. Ronaldo showed his sprightliness at the age of 36 by then reacting to a loose ball after a touch by substitute Jesse Lingard and shooting underneath Villarreal goalkeeper Geronimo Rulli from a narrow angle.

Old Trafford erupted, with sprint great Usain Bolt — draped in a red-and-white United scarf among the home supporters cele-brating as chants of "Viva Ronaldo" swept around the stadium.

It was Ronaldo's fifth goal in five games since joining from Juventus for a second spell at United, and definitely his most important. Oh, and make that 136 goals in the Champions League — a record.

**UNITED'S NIGHT** 

That Ronaldo had a quiet game, by his standards, might get overlooked because of his late goal. Where would Solskjaer be without Ronaldo?

It was looking like another chastening result for the Norwegian coach, who was starting to come under pressure with United having started Group F with a shocking 1-2 loss at Swiss outsider Young Boys and then losing back-to-back games at Old Trafford on the domestic front — one in the Premier League and another to get eliminated from the English League Cup.

Villarreal looked like handing United a second straight group loss by going in front in the 53rd through Paco Alcacer, who poked in a finish through the legs of United goalkeeper David De Gea following a cross by Arnaut Danjuma.

United had been outplayed by that point. Danjuma had the beating of right back Diogo Dalot time and again down Villarreal's left, and it was only the brilliance of De Gea — who produced acrobatic saves to deny Alcacer and Danjuba in the first half — that kept the Spanish team at bay.

It needed an outrageous strike by Alex Telles to bring United level seven minutes after Villarreal's goal. Picked out by a pinpoint cross from Bruno Fernandes at a free kick, the Brazilian left back took a

step back at the edge of the area and struck a firsttime volley that swerved inside the far post.

surrounding Ronaldo's winning goal, it was another below-par performance from United. The result broke a run of four straight 0-0s between the teams in Champions League play, dating back to pairs of group matches in both 2005 and 2008. The teams also met in the Europa League final in May, with Villarreal winning a penalty shootout following a 1-1 draw.

New Delhi, Sept 30: Drag-flicker Rupinder Pal Singh and defender Birendra Lakra, who played starring roles in the Indian hockey team's historic bronze medalwinning Tokyo Olympics campaign, on Thursday announced their international retirements within hours of each other, creating quite a flutter.

While Rupinder quit "to make way for youngsters" and announced his decision by posting a statement on his twitter page, Lakra's retirement was confirmed by Hockey India.

It has been learnt from reliable sources that both the players decided to quit after they were informed that they will not find a place in India's scheme of things going forward and will be ignored for the national camp that starts in Bangalore next week

The 30-year-old, regarded as one of the best drag-flickers of the country, Rupinder represented India in 223 matches. Nicknamed 'Bob', Rupinder scored four crucial goals, including a penalty stroke in the third-place match against Germany, during India's bronzemedal winning campaign in Tokyo.

"The past couple of months have undoubtedly been the best days of my life. Standing on the podium in Tokyo along with my teammates with whom I have shared some of the most incredible experiences of my life was a feeling I will cherish forever," Rupinder wrote in a statement on his official twitter handle.

"I believe it is time for me to make way for young and talented players to experience every great joy that I have felt in these last 13 years of representing India."

Hours later, Lakra followed suit with Hockey India officially announcing his retirement. The player is, however, yet to make a statement of his own on the matter.

"A solid defender and one of the most influential Indian Men's Hockey Team figures, the Odisha star has announced his retirement from the Indian national team. Happy Retirement, Birendra Lakra," HI tweeted.

The 31-year-old Lakra was one of the vice captains of India's bronze medal-winning side in Tokyo. He was also a part of the 2014 gold medal-winning Incheon Asian Games team and the side that claimed bronze in 2018 Jakarta.

Lakra, who was born February 3, 1990 in Lachchada village in the Sundargarh district, played 201 matches for India. A reliable centre-back known for his calm and composed attitude when put under pressure, Lakra made his debut in 2012 in a Test series against South Africa and was part of the Indian team that finished last in the 2012 London Games.
