

### **RBI Governor gets 3-year extension**

**NEW DELHI:** The government has extended the term of Reserve Bank of India Governor Shaktikanta Das by another three years up to December 2024, according to an official order. Das was appointed the RBI's 25th Governor December 11, 2018 for a period of three years after the abrupt resignation of his predecessor Urjit Patel. An official order dated October 28 said the government has reappointed Das as the RBI Governor for a period of three years beyond December 10, 2021. The decision was taken by the Appointments Committee of the Cabinet headed by PM Narendra Modi. Das is the first RBI Governor to



get extension after the BJP-led government came to power in 2014. Raghuram Rajan was denied extension in 2016, while Urjit Patel quit before completion of his three-year term.

#### Fuel prices hiked for 3rd straight day

NEW DELHI: Fuel prices continued to surge to record high levels Friday, October 29, for the third **PETROL** straight day. In the national capital, petrol and diesel rates soared by 35 paise to cost ₹108.64

₹106.24 (+0.39) and ₹97.37 per litre respectively, according to Indian Oil Corporation. In Mumbai, a litre of petrol now costs ₹114.47, and diesel is sold at ₹105.49 per litre. Petrol price in Chennai moved above the ₹105 per litre-mark and is currently sold at ₹105.43 per litre: while diesel rate stood at ₹101.59 per litre.



## CM raises demand for AIIMS at Sundargarh

■ Patnaik demands 60% share in the clean energy cess collected from Odisha

Bhubaneswar, Oct 29: Chief Minister Naveen Patnaik Friday raised the demand for the establishment of an All India Institute of Medical Sciences (AIIMS) at Sundargarh during a meeting with Union Minister Pralhad Joshi.

Joshi along with Union Minister of State (MoS) for Railways, Coal & Mines Raosaheb Patil Danve met the Chief Minister here at Naveen Niwas. During the meeting, Patnaik said the integrated campus for a 500-bed hospital and 100-seat medical college at Sundargarh has been completed by the National Thermal Power Corporation. However, it is yet to be operationalised.

The Chief Minister hoped that considering Sundargarh's contribution in providing energy security to the country and to the national development in terms of steel and iron ore production, the Centre

will come forward to fulfill the long-standing demand of the people of this tribal-dominated district for an AIIMS. Patnaik also requested the Union Minister for early functioning of MCL Medical College & Hospital at Talcher where infrastructure is ready. This 500-bed and 100-seat medical college and hospital will benefit the people of Dhenkanal and Angul, he added.

The CM also put forth a demand before the Union Coal Minister to provide to the state at least 60 per cent share in the clean energy cess collected from Odisha.

In the year 2020-21 Odisha produced 153.85 million tonnes of coal contributing to about 25 per cent of the country's production.

Government of India collects clean energy cess @₹400 per tonne which amounts to more than ₹50,000 crore. Thus, 60 per cent of the cess will give Odisha an amount of ₹30,000 crore, which can be utilised for the economic development of coal mining areas and the affected people, Patnaik said.

Besides, it will accelerate the state's development in the aftermath of the pandemic, he added.

"I am a father and I can understand the trauma the family must be going through. My deepest condolences to the family of Mamita. The guilty must be given strictest punishment as per law," he said.

The Minister said he was shocked by the manner in which certain media houses have launched a malicious character assassination campaign based on falsehood against him. The smear campaign launched

by the media houses has hurt his family and therefore his family has filed criminal and civil defamation cases against three regional media groups.

the cost of truth, empathy and sen sitivity in heinous offences," he said. As an MLA as well as an ex-Air Force officer, he has attended functions at many educational in-

stitutions, Mishra said, adding in fact, public representatives are supposed to attend functions in educational institutions. "Therefore, a crime happening in any one of the institutions that I have visited as a guest for functions cannot be attributed to me," he clarified.

He urged Opposition parties and media to take up the matter with the police or courts if they have an iota of evidence against him in this matter. "I will not only resign from my position but will also retire from public life, but don't indulge in smear campaigns with personal political agenda," the minister said.

"I had left the high paying job of a pilot and joined politics to serve the people of Junagarh and Kalahandi. I swear in the name of Maa Manikeswari on whom I as well as the people of Kalahandi have deep faith, that I have nothing to do with this offence," he added.

## Orissa HC asks govt to decide on green crackers

Cuttack, Oct 29: The Orissa High Court Friday asked the state government to make a decision on the sale and use of green crackers during Diwali by November 1.

The court's directive came on a petition by the All Odisha Fireworks Dealers' Association and others against the Special Relief Commissioner's September 30 order prohibiting sale and use of firecrackers during the festive season between October 1 and November 1 to protect the health of the general public and curb the spread of Covid-19 infection. A bench of Chief Justice S Muralidhar and Justice BP Routray asked the SRC to hear the petitioners in his office Saturday and make a decision on the issue on or before 10.30 am Monday.

The high court posted the matter for further hearing at 2 pm Monday. The Petroleum and Explosives Safety Organisation, which is under the Union government, informed the court that it has no objection to sale and use of authorised green fireworks during Diwali. **MORE P3**



## **State tops country in** short-circuit deaths

**ODISHA RANKS SECOND AFTER BIHAR** IN TERMS OF **CASUALTIES DUE TO** 'FORCES OF NATURE'

Bhubaneswar, Oct 29: Odisha has topped the country in terms of deaths due to fire caused by electric short-circuit during 2020, as per the annual report on 'Accidental Deaths and Suicides in India-2020 by National Crime Records Bureau

Deaths due to fire caused by electric short-circuit in Odisha during 2020 stood at 490 - the highest such casualties in India. Altogether 437 males and 53 females have lost their lives due to electric short-circuit last vear. said the NCRB report.

Tamil Nadu, Uttar Pradesh and West Bengal registered 186, 158 and 148 deaths due to short-circuit respectively.

The state recorded altogether 1,293 deaths due to accidental fire including electric short-circuit and firecrackers last year, securing the second spot in country in this category. Madhya Pradesh registered 1,390 such deaths in accidental fire last year which is in second position.

Moreover, 60 people died due to explosion of cooking gas cylinders or gas stove blasts in 2020. As many as 741 persons burned

terms of snakebite deaths. Snakebite resulted in the death of 1,105 persons 789 males and 316 females) in Odish nile Madhya Pradesh recorded 2,512 such deaths last year

to death for various other reasons last year. Owing to its geographical location, Odisha always faces the wrath of the natural calamities. The state recorded 1,428 accidental deaths due to 'Forces of Nature' last year. Odisha is at the second spot after Bihar that recorded 1,437

Similarly, 1,711 persons died after accidentally falling off from buildings, vehicles and into manholes or pits. Odisha holds the third spot after Maharashtra (3,326) and Gujarat (1,837). Four persons died in the state after the victims

As many as 1,167 persons lost their lives after falling off moving vehicles like buses, trains and trucks in the state during 2020 which is also highest in the country.

Snakes continue to remain one of the biggest killers in the state last year too. The state ranks second in the country in terms of deaths caused by snakebite. Snakebite resulted in the death of 1,105 persons (789 males and 316 females) in Odisha while Madhya Pradesh recorded 2,512 such deaths

Similarly, 24 including five women lost their lives to attacks by poisonous animals, insects and reptiles last year.

## Firecrackers with Barium salts banned: SC

New Delhi, Oct 29: The Supreme Court Friday clarified that there is no total ban on use of firecrackers and only those fireworks which contain Barium salts are prohibited.

A bench of Justices MR Shah and AS Bopanna however said that no authority can be permitted violation of the directions issued by it and allow banned firecrackers under the guise of celebration.

The apex court further asserted that celebration cannot be at the cost of the other's health.

## DRIVERS RALLY FOR 'COVID **WARRIOR' TAG**

Bhubaneswar, Oct 29: Hundreds of drivers took out a padyatra here Friday to highlight their 10-point charter of demands including 'Covid-19 Warrior' status.

The drivers under the banner of Odisha Driver Mahasangha arrived here early Friday morning and started their padyatra from Palasuni, one of the entry points to the state capital, towards Odisha Chief Minister Naveen Patnaik's residence. Dressed in their traditional khaki uniform, the protestors walked down the main roads of the city causing traffic congestions at many places. They demanded Covid Warrior status, provision of allowance and pension after 60 years of retirement age.

They also demanded extension of validity of their driving licence and special provision for their security.

## SC adjourns hearing on Kotia row with AP

New Delhi, Oct 29: The Supreme Court Friday adjourned the hearing of a contempt petition filed by Odisha against Andhra Pradesh for allegedly violating the apex court's order by transgressing into Odisha's territory.

A two-judge bench of the apex court comprising Justices AM Khanwilkar and CT Ravikumar posted the matter for hearing to November 26. Earlier in August, the Supreme

Court had asked Odisha and Andhra Pradesh to look for a political resolution to the border dispute related to Kotia group of villages in Koraput district.

The state government had submitted to the court that its (Odisha's) claim over three disputed villages in Kotia panchayat is based on the national census of 2011 while Andhra Pradesh is relying on the self survey.

Significantly, Odisha, in the contempt petition filed through advocate Sibashankar Mishra, submitted that Andhra Pradesh willfully and deliberately violated the Supreme Court order dated December 2, 1968 and the judgement dated March 30, 2006 by



transgressing into Odisha's territory. The apex court in its order of 1968 and 2006 judgement had asked the two states to maintain status quo on the boundary dispute with regard to Kotia group of villages with the consent of both

The state contended that Andhra Pradesh changed the name of the three villages of Kotia gram panchayat. The name of Ganjaipadar had been changed to Ganjaibadra, Phattusenary to Pattuchennum Phagusenary Phaguluchennuru.

"The contemners tactfully converted these three villages of one gram panchayat falling under territory of Orissa to three different gram panchayats," Odisha stated in the petition.

## Group clash in Kendrapara leaves 3 grievously injured POST NEWS NETWORK A faction that supported

Patkura, Oct 29: As many as three persons sustained grievous injuries in a violent clash that erupted between two rival factions at Nuapada market under Patkura tehsil in Kendrapara Thursday evening.

The injured were rushed to Kendrapara district headquarters hospital (DHH). Later, two of them were shifted to SCB Medical College and Hospital (SCBMCH) in Cuttack after their condition deteriorated, a police official said.

On being informed by shopkeepers, Patkura police reached the market and launched a probe into the incident. "A youth named Bibhu Sahoo had gone to Nuapada market along with his brother when they were attacked by a rival faction,' Patkura IIC Saroj Sahu said.

## **TUSKER TRAMPLES YOUTH** TO DEATH IN ANGUL DIST

## Disability no hurdle for Kalia

Bhandaripokhari, Oct 29: When the going gets tough, the tough gets going is a popular saying which holds true for physically challenged Sisir Nayak, better known by his nickname Kalia.

People practising Yoga at a camp in Balasore Friday

Kalia, 45, sells tea from another shop's verandah. His black pepper tea is as good as it gets at Kali Bazaar of Bhandaripokhari town in Bhadrak district. And Kalia is managing his business with only one hand.

While boiling tea in a kettle, he said, he is a resident of Chandrabhanupur village under Bhandaripokhari block. "I have been living a physically challenged life for last 25 years. But I have no regret," he added. "I was then 20 years old. In order to help my parents run the family, I



was working at a mill making flattened rice. On a fateful day, a mishap occurred and I lost my right land," remembers Kalia.

He said he did not let the mishap overpower him. Rather he took it as a challenge. Believing in 'Where there is a will, there is a way'. he decided to start tea busi-

ness. "Availing loan from a bank, I built a stall in Kali Bazaar and started selling tea. Destiny played another cruel joke, when my shop was completely destroyed in 1999 Super Cyclone. But I was the same determined Kalia," he

said while attending to his

customers. "I shifted my shop

to the verandah of another's

shop and has since been selling tea from here. Despite difficulties, I have been running my business. Prior to the pandemic situation, I bought 50 litres of milk. Like others, my business has also been affected during this pandemic time. However, with whatever I earn, I am able to run my family. My family comprises six members -- my parents, wife, a daughter and a son. But the fear of being driven away keeps haunting me. To earn something you have to have a shop of your own. So I also have a dream to have a stall of my own," he observed.

The government has many schemes to help out street vendors. But he has been deprived of any government help despite being a physically challenged. "It would be a great help if the administration gets me a stall," he prayed.

## PMO gets a new point-man

autious but gets the job done", is what one senior colleague says of him. Most observers agree that this one vital trait has helped Amit Khare rise to the Prime Minister's Office (PMO) as his new advisor. This, and the fact that he has steered two of the NDA government's flagship policies - National Education Policy and the IT Rules - explain why the 1985-batch IAS officer from the Jharkhand cadre who retired last month, is seen as among the handful of babus considered indispensable by the NDA government.

So, while the high-flying Khare did not superannuate as a Cabinet Secretary as some had expected given his stellar track record, he still retains the key to the mighty PMO Modi. And given the buzz surrounding his appointment, he may well outshine the Cabinet Secretary during his new two-year tenure and may also become principal secretary to PM. Don't forget though that Gauba himself had handpicked him for earlier stints.

Though he has always enjoyed the confidence of his political masters, even in the UPA years but his real stellar rise in the current government may be traced to his days as Secretary for Information and Broadcasting, where he swiftly

earned Modi's attention and was made responsible for all communication strategies. It also gave him better access to the PMO. He will need all these formidable skills to steer the government through key state elections next year as also the lingering post-Covid scenario.

#### **Centre readies for Secretary-level appointments**

Last month (September 22) this column had reported about the babu shortage at the Centre, with multiple secretary-level vacancies, including in the Prime Minister's Office (PMO) even as several eligible officers are still waiting to be summoned for these vacant slots. But the recent and long-awaited empanelment of 12 IAS officers from the 1985 and 1987-89 batches and 27 IAS officers of the 1990 batch is a clear sign that the government is now planning to fill some of the current vacancies as well those that will arise in the next few months due to the retirement of some babus. Babu observers have been quick to note that only one Gujarat cadre officer is in the list. Curious, since this state's cadre usually holds a special place in the NDA government.

At present several secretary-level posts are vacant in the Steel, Drinking Water and Sanitation ministries and the Department of Border Management, among others, are vacant. This situation also prevails in the Department of Biotechnology and the Department of Science and Technology, though these two posts are usually earmarked for scientists. Also, there are several babus lined up for retirement. In the coming weeks, secretary-level vacancies will come up in the ministries of Petroleum and Natural Gas, Housing and Urban Affairs and Environment, Forests and Climate Change. For instance, Tarun Kapoor will retire as Petroleum Secretary next month while Rameshwar Prasad Gupta will retire as Environment Secretary in December.

With such critical posts vacant or soon to be vacated, the decisions have to be taken sooner than later. The latest round of empanelment has now opened the avenues for the government to start making secretary-level appoint-

#### IFoS officers trigger a rumble in the jungle

A piquant situation has developed in Karnataka where several Indian Forest Service (IFoS) cadre posts are filled with non-cadre officers. BK Singh, a former principal chief conservator of forests says that the trend has only become more pronounced over the years, irrespective of which party is in government in the state. IFS officers now tend to get posted outside the forest department, which is severely impacting the conservation and development of forests. It is said that currently, more than 42 cadre posts are vacant across the state.

IFS officers are now being posted in the state tourism department, agriculture department and even disaster management, among others. Sources from the Central government. Though the Forest Services never complained initially, it's now a rumble in the jungle.

They point out that the rules state explicitly that a cadre post shall not be filled by a person who is not a cadre officer except in case no cadre officer is available. In that case, the non-cadre officer will be replaced when a suit-

able cadre officer becomes available. But in the case of Karnataka, the government has allegedly contravened the IFoS cadre rules by appointing non-cadre officers to cadre posts, without approval from Delhi.





his one is as defunct a word as you are likely to meet in this section — it seems to have utterly disappeared from the English lexicon. Like its close relative cancroid, it derives from Latin cancrinus, relating to a crab. It has been used on rare occasions to mean crab-like but more usually a specialised type of backwards motion, curious in view of its derivation, which would imply a sideways movement to match that of the crab. In this sense, cancrine refers to a type of Latin verse that reads the same backwards as forwards, which we would now refer to as palindromic. Cancrine doesn't refer only to verse though: Bach's Crab Canon, which is a musical palindrome, has also been described as cancrine

But there is also hope, because some - not least the climate activist Greta Thunberg, with her longstanding and heartening call for more ambitious action - recognise the scale of the challenge facing humanity. In that spirit, the European Union has launched the European Green Deal, which aims to make the EU carbon-neutral by 2050.

The United States also aims to reach net-zero emissions by midcentury, and recently announced that it would double its financial contribution to help developing countries tackle the climate crisis, to \$11.4 billion per year. Some US lawmakers, notably Representative Alexandria Ocasio-Cortez and Senator Ed Markey, have proposed a Green New Deal, an ambitious plan to redesign the US economy and eventually eliminate all US carbon dioxide emissions.

Yet, despite these efforts, the fact is that we started out late in combating climate change and now need to accelerate corrective action if humans are not to go the way of the dinosaurs. The climate crisis is a global issue and requires action from all countries, but many developing economies, including some of the most climate-vulnerable ones, lack the financial wherewithal to do enough on their own. Some emerging economies, including South Africa and much of South and Southeast Asia, are hugely reliant on coal, and will have to undergo a disruptive green transition.

We therefore need a collective commitment to design support systems – financial and scientific – to help all countries do their part. The 2015 Paris climate agreement was a diplomatic success,

marshaling the support of almost 200 countries. But the world is falling woefully short of meeting the target – limiting global warming to 1.5°C, relative to preindustrial levels – that was agreed in Paris

Will the gathering in Glasgow catalyse genuine action? Thunberg recently warned that "the leaders will say we'll do this and we'll do this... and then they will do nothing." And the widespread frustration at leaders' insufficient climate ambition is not limited to young people. Britain's Queen Elizabeth II expressed a similar sentiment, saying that "it's really irritating when they talk, but they don't do.'

Such despair is natural. When we see climate action trail so far behind rhetoric, we inevitably wonder if all the talk is just hypocrisy.

But it need not be. If we want to bequeath a livable planet to future generations, it is crucial to understand why there may be a disjuncture between what each person intends to do and what the group actually delivers. Iconic games like the prisoner's dilemma have shown this to be the case in the domain of selfish decisionmaking. Mobilising the determination and commitment needed to address the climate crisis is a problem for the social sciences and moral philosophy as much as it is for politicians.

Contrary to what neoclassical economics would have us believe, the modern economy does not operate as a series of impersonal markets driven purely by the aspirations of individual actors. Rather, as Mariana Mazzucato notes in her book Mission Economy: A Moonshot Guide to Changing Capitalism, markets are "embedded in rules, norms, and contracts affecting organisational behavior, interactions, and institutional designs.' It is therefore a mistake to

equate collective action with the sum of individual intentions. When people say they want to do everything to avert climate disaster but do little, this may not be hypocrisy. They may be in the grip of what I have described in a recent paper as "Greta's Dilemma.

In this game, a group of people initially pursue their own interests, with no concern for how the environmental damage caused by their actions will harm future

generations. If people then become environmentally conscious and take corrective action, traditional economic models would predict that such a shift will lead to improvements in future generations' welfare.

But in the complex, strategically connected world that we inhabit today, the outcome may be different. Greta's Dilemma illustrates the paradoxical result whereby individuals who become environmentally conscious collectively do greater damage to the environment. Akin to one of those paradoxical paintings by MC Escher, it is the intertwining of small individual steps that lead the group to a destination they did not seek. Far from helping future generations, they end up hurting them.

Admittedly, this game is crafted deliberately to highlight the paradox. But it shows that, in today's complex global economy, we need to devote much greater attention to the strategic foundations of human interaction in order to design policies that can help us turn away from the brink of climate disaster.

This may sound like a narrow academic argument, but it is not. If we are to realise Thunberg's ambition, which I believe many people - including many leaders genuinely share, we need to use Greta's Dilemma as a basis for designing the policies and institutions we need.

So, although we are right to fret that leaders may not do enough at COP26, we also have to be aware that there is a scientific problem here. On climate change and other issues, we need to understand the social and economic game we are playing, and try to alter its rules so that our individual moral intentions are reflected better in collective outcomes

## Increase autonomy in GS7

The Union government has and movement of goods has beconstituted a Group of Ministers to review the entire GST system. The fundamental issue facing us today is that the states may be in big trouble beginning July 2022. While introducing GST in 2017 the Union government had promised that it will compensate the states for any loss of revenue after the implementation of GST for five years. It was projected that GST revenues will increase by minimum 14% per year. Thus the state governments were entitled to receive 14% more money from GST every year irrespective of what the actual GST collection in their states was.

GST has indeed made trade simple on two points. First, the classification of all goods across the country has been standardised. Previously, kraft paper could be classified as "paper" in one state and "packing material" in another state leading to disputes on the border. Such disputes are no longer possible. Secondly, the whole system of issuing "C" forms for the transport of goods from one state to another has been dismantled come smooth. However, this has come at a huge cost of challenging the autonomy of the states as outline above.

In this respect we can take a lesson from Canada and the United States. In Canada different states levy different rates of sales tax in addition to the GST which is levied by the Central government. Alberta, for example, has only 5% Federal GST. British Columbia has 5% Federal GST plus 7% Provincial Sales Tax. Ontario has 13% Harmonised GST which includes both Federal and Provincial taxes. Yet, there arises no problem in the movement of goods from one state to another and they do not have requirements such as the "C" form. Reason is that they have a standard classification which is applicable to all states along with autonomy to the states to fix the rates of tax. There are no disputes of classification. Every seller collects GST on the goods based on the rate applicable at the point of sale. For example, a manufacturer in Alberta will collect 13% Harmonised GST from a buyer

based in Ontario but collect only 5% GST from a buyer based in Alberta. In this manner the autonomy of the states to levy different rates of GST has been protected while movement of goods from one state to another is seamless. Similarly, in the United States there is no GST. Every state is free to levy different rates of sales tax on goods sold within its borders. Some states levy no sales tax at all. All their revenue comes from state income tax. In other states, there are varying rates of sales tax yet there is free movement of goods. These two examples indicate that the basic purpose of free movement of goods can be achieved without insisting on a uniform rate of GST.

The challenge before the Group of Ministers is to proactively consider the situation that will arise for the states in July 2022 when the states will lose their right to be compensated by the Union government for collecting less GST within their borders. At that time, the states will face a huge drop in their revenues and may be even forced to withhold or cut the salaries of their employees. They will certainly have to cut their capital investments such as in construction of roads and other infrastructure. Therefore, the Group of Ministers should consider modifving GST to allow states to collect different rates of GST as it is done in Canada and the USA. In this way, thereby free movement of goods can take place while the states are allowed to impose different rates of GST according to their own needs and assessments. To give an example, if the head of a joint family is very strict and does not give freedom to the members, then the family breaks up. A similar situation may arise in the country if the Union government insists on implementing GST without giving compensation and also without giving autonomy to the states to levy varying rates of GST. In such a situation, the demand even for leaving the Union may arise and it may lead to the disintegration of the country.

Amid the military confrontation between India and China in eastern Ladakh, India's testing of its most formidable missile is a strong strategic signal to China. The successful test brings even the northern-most part of China within its strike range. It must be understood that China has missiles like the Dong Feng-41 (12,000-15,000 km) that can reach any Indian city. However, India's possession of Agni-V will definitely strengthen its combat power against China. # Memories continue to haunt residents



Erasama, Oct 29: Twenty-two years have passed since Super Cyclone-1999 struck the coastal state October 29, 1999. However, the memories of the devastation caused by the calamity are still afresh in the minds of the residents under this block in Jagatsinghpur district.

The calamity caused unprecedented damage in the area, said, Shankar Charan Sethi, former sarpanch of Ambiki panchayat under the block. The memories of the calamity continue to haunt the residents that wiped out scores of lives, blew off houses and changed the topography of the area, remembered residents Nivas Phandkar, Subrat Samant of Nagar Colony and Debadutta Das, Arjun

Jena of Dahibar village. The calamity unleashed a reign

of terror with heavy rain and gale. Tidal waves rose up to 30 feet and destroyed the topography of the area. Hundreds of lives were lost, houses caved in, trees uprooted and thousands of livestock died in the calamity. The devastation which the residents witnessed 22years back has given way to development in the area. However, the residents are yet to forget the black day of October 29.

Jamuna Phandakar in Nagari village of Ambiki panchayat, about 10 km from the sea, lost 24 members of his family including her husband Susant and father-in-law Atul in the

Around 276 people of 66 families in the village lost their lives. Many of them lost all their family members except themselves. The gale blew off her thatched house which was eventually washed away by the surging tidal waves gushing

towards her village. She climbed to the top of her house but the tidal waves washed it away along with all her family members. Jamuna carrying her 15 month old son was swept away in the waves and got stuck to a banyan tree at Kochila village which was

## Survivors walk down the memory lane

Mahakalpara: Memories of the 'Super Cyclone' that devastated Odisha, October 29, 1999 (Friday) are still fresh in the minds of people. It was one of the most intense recorded tropical cyclones in the last century. The 'Super Cyclone' had caused widespread havoc in many districts of Odisha.

"Approximately 10,000 human lives were lost in the disaster and innumerable domestic animals were swept away in floods that followed the cyclone. Many families went missing. We still shiver in fright when we think of the scary day," some villagers of Ersama block, especially those who survived the tragedy and witnessed devastation from close quarters, said.

Echoing the views, residents of Ambiki and Dahibara villages in Jagatsinghpur district namely Shankar Sethi, Subrat Samant, Debadutta Das and Arjun Jena said, "Wind speeds reached up to 260 km/ph during landfall of the cyclone, which remained the same for nearly 36 hours. The 200-kilometre wide 'Super Cyclone' ravaged all the coastal districts.

Jagatsinghpur, Kendrapara, Cuttack, Khurda and Puri districts faced the maximum amount of devastations. Ersama block in Jagatsinghpur district witnessed the worst devastation due to the cyclone. Cyclone shelters earlier constructed in the block for effective disaster management and to ensure zero-casualty have turned into ruins owing to lack of maintenance and administrative neglect, alleged villagers

Out of the 92 cyclone shelters, 12 made by the Paradip Port authorities and 29 multi-purpose buildings constructed by Maharashtra government have become unusable, they added.

Likewise, some residents of Panikhia-Santalapada village of Nanjura panchayat under Mahakalpara block in Kendrapara district said, "We got the information about the Super Cyclone from a bulletin of Cuttack radio station just a day before the landfall. We had not witnessed such severity of devastation beforehand. Our village is located in close vicinity of sea and tides came at a height of over 15-feet."

## Beneficiaries fume over pending dues

Daringbadi, Oct 29: Scores of projects like farm ponds and cattle sheds under the Mahatma Gandhi Notational Rural Employment Guarantee Scheme (MGNREGS) have been executed in Daringbadi block of Kandhamal district.

These projects are being executed since 2018-19. Some beneficiaries have been provided funds while some are waiting for their dues towards the construction materials they had used in the projects.

Upset over the pending dues, they have warned of agitation. "The government executed these projects in our area to create labour intensive work and earnings so that we can deal with the pandemic difficulties. However, the objective has failed. A year has passed since the works were done, we are vet to receive funds towards materials

we used in the projects," locals lamented.

The beneficiaries said they have borrowed from private money lenders for purchase of construction materials like cement, sand, stone and bricks. They alleged that though they had taken up the issue with the administration several times in the past, the latter is not clearing out dues. "The money lenders have made our life miserable while our dues are not being cleared. If our dues are not cleared by November 3, we will start agitation outside the block from November 5," they rued.

Contacted, BDO Kalakrushna Pradhan said it is a technical issue. Meanwhile, four BDOs have come to the block and gone. Right amounts of funds are not being sanctioned for projects, leading to problems in making bills, he added.

dates in Bhabanipur and Gossaigaon, Akhil Gogoi-led Raijor Dal is contesting in Thowra and Mariani while Hagrama Mahilaryled Bodoland Peoples Front (BPF) is contesting in Gossaigaon.

The AIUDF and the BPF were partners of the Congress-led 10party 'Mahajot' (grand alliance) in the March-April Assembly polls.

According to the Election Commission, around 8 lakh voters, including 3,93,078 female would decide the fate of 31 candidates.



Uppur, Oct 29: Tamil Nadu is considering restarting a shelved 1.6 gigawatts (GW) coal-fired power project in Uppur, two state government officials said, as its debtridden utility seeks to expand its coal fleet to address rising power

The state, India's second mostindustrialised, epitomises the country's approach to balancing energy security and tackling climate change as Prime Minister Narendra Modi heads to Glasgow for the UN COP26 summit: the energy-hungry nation may build more new coal-fired plants as they generate the cheapest power, despite calls to deter use of the dirty fuel.

The project was shelved in March after the National Green Tribunal temporarily suspended an environmental permit granted to the project, citing concerns from local farmers and fishermen over land acquisition, the height of a bridge carrying effluents and the coal being used.

After the order, the Tamil Nadu Generation and Distribution Corp Ltd (TANGEDCO) had decided to shift the project to Udangudi, about 200 km away from Uppur, where a 1.3 GW coal-fired plant is already being built.

However, the new state government, which came into office in the power plant in Uppur. More than 30% of the work is complete and at least Rs10 billionhas already been invested, two officials from

project operator, Tamil Nadu Generation and Distribution Corp Ltd's, told Reuters

"The previous (shifting) decision was taken in haste. So much money has been invested. We are now trying to complete all formalities and restart the project," one of the officials said. They declined to be named as they were not authorised to speak to the media on the issue.

While Tamil Nadu is among India's top renewable energy producers, it is also constructing the most number of coal-fired plants nationwide, according to Londonbased environmental think tank Carbon Tracker.

"New coal projects are also essential because many of our power plants are old, and need to be phased out in a few years," said one of the TANGEDCO officials.

Unlike many parts of Europe or the Americas, India does not have access to cheap domestic gas, which can be used to generate reliable electricity supplies when renewable energy generation drops after sunset or when wind power

output goes down The officials said TANGEDCO has allayed fishermen's concerns at the Uppur plant by offering to increase the height of a bridge carrying effluents, so that fishing boats can pass under it, and is working on fixing land acquisition issues. Local administrative officials in Uppur have already begun compensating residents for taking over their

land for the project.

## TN opens Mullaperiyar dam, India's exotic seaweed industry thriving briskly Kerala's Idukki on high alert

*In view of the opening* of Mullaperiyar dam and predictions of more rains, the Kerala government has also sounded a red alert in Idukki reservoir


Idukki, Oct 29: The shutters of the Mullaperiyar dam in Kerala, operated by Tamil Nadu, were raised Friday morning as the water level in the reservoir crossed 138 ft. Kerala government officials said in

Tamil Nadu government officials raised by 0.30 metres the spillway shutters 3 and 4 of the 126year old dam at around 7:30 am, they said. According to them, 538.16 cusecs of water has been flowing out of these two shutters of the dam since morning.

The water level at Mullaperiyar dam stood at 138.80 ft at 9 am, Kerala government officials said in Idukki. Besides officials from the two states, Kerala Revenue Minister K Rajan and Water Resources Minister Roshy Augustine were

present during the opening of the shutters of the dam. Talking to reporters, Rajan said there was no need for any panic as the government has taken measures

to ensure safety of the people. He, however, urged the people to maintain vigil.



The government has also warned against the social media scare mongers. Tamil Nadu Water Resources Minister Duraimurugan, meanwhile, said the state has been continuously drawing water through tunnel to Vaigai dam.

In addition to such maximum drawing of water through tunnel, the Tamil Nadu government decided to release water from Mullperiyar dam to the tune of about '500 cusecs' by opening two spillway gates from Friday morning, he said in Chennai. This was done after giving notice and warning well in advance to authorities, Duraimurugan said.

"The dam is safe and it is operated and regulated carefully by the Water Resources Department, Government of Tamil Nadu following the Rule Curve approved by the Central Water Commission. Any news contrary to the above are not correct and has to be ignored," the Tamil Nadu Minister said in a statement.

In view of the opening of Mullaperiyar dam and predictions of more rains in the catchment areas, the Kerala government has also sounded a red alert in Idukki reservoir.

Augustine said the Idukki reservoir has enough storage capacity to hold the water being released from Mullaperiyar dam.

The minister has said that there was nothing to be concerned about and people need not panic as the storage capacity of Idukki was 70.5 TMC as compared to 12.758 TMC of Mullaperiyar and therefore, the water released from the latter would only raise the former's level by a

quarter of a foot. People living downstream of Mullaperiyar dam were evacuated as a measure of abundant caution ahead of raising of the shutters.

According to officials, a total of 1,079 people from 350 families who would be affected by the two-foothigh flood have been evacuated.

India is the world's third-largest carbon polluter, behind China and the United States, and has yet to set a target date for its emissions to reach net-zero

But authorities are looking into how seaweed farming could help reduce the impact of greenhouse gas emissions, reverse ocean acidification and improve the marine environment as well as providing a sustainable livelihood for marginalized coastal communities.

"I am doing this for my children... It requires a lot of hard work, but I am able to earn good profits from about four months of work," said Murgesan, who makes Rs20,000 each month farming the fibrous macroalgae, "I would not have been able to educate my children but after doing this, I could send my children to college," she added, smiling as she emerged from the waters in Rameswaram, Tamil Nadu.

M Ganesan, a government marine scientist, said seaweed provides a possible way forward as coastal habitats and wetlands absorb five times more carbon than terrestrial forests.

"It is a miracle crop in many ways; it is eco-friendly and doesn't use land or fresh water. It absorbs

carbon dioxide dissolved in water during photosynthesis and oxygenates the entire marine ecosystem," Ganesan told AFP.

India, which has an 8,000-km coastline, is now aiming to boost production from the current 30,000 tonnes to more than 1 million tons each year by 2025. Murgesan is part of a team of women who work together to cultivate fronds of seaweed on bamboo rafts before harvesting and drying them.

The tropical waters of Tamil Nadu form an ideal environment with one raft yielding up to 200 kilos in around 45 days.

The product is then sent for sale in markets nationwide as well as the United States and Australia through AquAgri, a private company that promotes algal cultivation in India. Popular in East and South East Asian cuisine, seaweed is also used in medicine, cosmetics, biofertilizer and biofuel.

"Seaweed has maior use as a crop biostimulant for increasing productivity and making the crop more resilient to climate induced stresses. It's also used as a major ingredient in meat and food processing,' Abhiram Seth, managing director of AquAgri, said. And while it has not been traditionally popular in India, in July, the government announced some \$85 million in subsidies for seaweed farming initiatives

over the next five years. Seaweed cultivation is already common in Japan, China, Indonesia and the Philippines.

Interest is growing in Australia, which has outlined a plan to develop a \$100-million industry by 2025. Seth said there was potential to


benefit both the environment and farmers like Murgesan. "Seaweeds clean up the water. At the same time, seaweed cultiva-

tors get a sustainable income without having to relocate to urban areas to find work," he explained. Seaweed does not require fertilizer, freshwater or pesticides.

Kelp, one of the most commonly farmed types, grows at a rate of 61 centimeters (two feet) a day. They absorb an estimated 173

million metric tons of carbon each year - the same annual emissionsas New York State, according to a 2016 paper in Nature Geosciences.

# **We stand vindicated: Farm unions**

New Delhi, Oct 29: With the Delhi Police beginning to remove barricades at two farmer protest sites -- Tikri and Ghazipur -- farm union leaders Friday said the move vindicates their stand that they never blocked roads at the city border points.

Farmer leaders said any decision to entirely clear both the carriageways at the protest sites will be taken by the Samyukta Kisan Morcha (SKM), an umbrella body of over 40 farmer unions protesting against the Centre's farm laws.

They, however, said way will be made for traffic to move in the coming days. The Delhi Police's

decision comes days after a Supreme Court hearing that saw farmer unions arguing that the police were responsible for the blockade at the city's borders. Bhartiya Kisan

Union (BKU) office-bearers said police and not farmers had blocked roads, adding that they are being "reopened on the directions of the Supreme Court". In light of the removal of barricades at Ghazipur border protest site, BKU leader Rakesh Tikait said, "The future course of the ongoing farmers' protest would be decided by the Samyukta Kisan Morcha, which is leading the movement against the three farm

fic movement at the borders. For the last 11 months, we have been saying that farmers never blocked roads as we are simply protesting the farm laws. Today we are proved right. It is good that traffic will now be able to move at borders. Kohar said

In February, protesting farmers at Tikri Border cleared the way for an ambulance but it had to return as the Delhi Police had blocked the road, she claimed.

## Priyanka Gandhi meets family of dead farmer

Lalitpur (UP): Congress General Secretary Priyanka Gandhi Vadra Friday met the family of a farmer who died allegedly due to distress over the non-availability of fertilizer. Fifty-five-year-old Bhogilal Pal of Nayagaon died of a cardiac arrest while standing in queue outside a fertilizer shop. He had reportedly been waiting for his turn to purchase fertilizer for two days. Priyanka Gandhi visited Pal's home and interacted with the family members.

Farmer leaders also hoped that the Centre would invite farmers for a dialogue to break the logjam over the farm laws. BKU spokesperson Saurabh Upadhyay said farmers want to go to Delhi but the SKM will take the final call.

On October 21, the Supreme Court had said farmers have the right to protest and was not against this even when a legal challenge against the three farm laws is pending but they cannot block roads "indefinitely", an observation that came amid a blame game between the Centre and the farmer unions.

While the farmers' unions alleged that the police were responsible for the blockade at the Delhi borders as it suits them to allow a feeling in the minds of the citizens that farmers are blocking the road, the Centre claimed there was an oblique purpose behind the protests.

# Aryan still in jail as lawyers get stuck in traffic

Mumbai, Oct 29: Contrary to expectations, superstar Shah Rukh Khan's son Aryan Khan is expected to spend another night in the Arthur Road Central Jail as his bail orders could not reach the prison authorities by the stipulated time of 5.30 p.m. Friday.

Though his legal team led by advocate Satish Maneshinde had rushed from the Bombay High Court to the jail, a mere 8 kms away, they were reportedly stuck in the massive evening and weekend traffic jams en route.

Even Bollywood megastar Shah Rukh who left from his Bandra bungalow in a small motorcade to pick up Arvan from jail, returned home mid-way, though close family friend and ex-actress Juhi Chawla managed to complete the formalities for standing surety. The court has accepted Juhi - a

co-star of SRK in many films - as the surety in Aryan's bail and she signed the relevant papers and executed the bail bond before the court officials, said Maneshinde earlier.

However, since the bail papers failed to reach the jail authorities on time, now Aryan maybe released only Saturday morning after all the formalities are completed. Bombay High Court Justice N.W.

Sambre granted bail to Arvan and two others - Arbaaz Merchant and Munmun Dhamecha - on Thursday evening, but the bail order verdict was issued on Friday afternoon, after which their legal teams ini $tiated\ the\ remaining\ formalities.$ 

Soon after the bail verdict was pronounced Thursday, SRK reportedly shed tears of joy, and later met his entire legal defence team which had been fighting for Aryan's release for the past four weeks.

Meanwhile, in the five-page order, the high court said that Aryan Khan and and his two co-accused Arbaaz Merchant and Munmun Dhamecha, who were also granted bail, shall be released on a personal bond of Rs one lakh each with one or two sureties of the same amount. As per the conditions set by the high court, the trio will have to surrender their passports before the special NDPS court and shall not leave India without taking permission from the special court and that they will have to attend the NCB office each Friday to mark their presence.

## Live-in relationship is personal autonomy, says Allahabad HC

Prayagraj (Uttar Pradesh), Oct 29: The Allahabad High Court has stated that "live-in relationships have become part and parcel of life and need to be viewed from the lens of personal autonomy rather than notions of social morality."

While disposing of two separate petitions filed by interfaith live-in couples, a division bench comprising Justice Pritinker Diwaker and Justice Ashutosh Srivastava observed, "Live-in relationships stand approved by the apex court and should be viewed from the lens of personal autonomy arising out of the right to life and personal liberty as guaranteed under Article 21 of the Constitution, rather than notions of social morality."

The two couples had filed separate petitions alleging that the families of girls were interfering in day-to-day life of petitioners. One petition was filed by Shaira Khatun and her partner, resident of Kushinagar (both majors and in a live-in relationship for two years) and another was filed by Zeenat Parveen and her partner from Meerut (both also majors).

They filed a petition in the high court after the police refused to help them. The court underscored that the right to life enshrined under Article 21 of the Constitution is liable to be protected at all costs and held that police were obligated to protect the rights of the petitioners. Therefore, the court in its order, directed that in the event of petitioners approaching police with complaints of threat to life and liberty, police shall perform their duties under law. The court order comes after the Delhi High Court pulled up the Uttar Pradesh Police for harassing a young adult couple.

## India recorded 1.53L suicides in 2020, over 10K in farm sector

New Delhi, Oct 29: India recorded 1.53.052 suicides -- an average 418 daily -- in 2020, with 10,677 of them by persons engaged in farming sector, according to the latest central government data.

Suicide rate (per lakh population) also increased from 10.4 in 2019 to 11.3 last year, the NCRB, which functions under the Union Ministry of Home Affairs (MHA),

A total of 10,677 persons involved in farming sector (consisting of



5,579 farmers or cultivators and 5.098 agricultural labourers) committed suicides during 2020, accounting for seven per cent of total suicide victims (1,53,052) in the country, the report showed.

Out of 5,579 farmer or cultivator

suicides, a total of 5,335 were male and 244 were female, it showed. Out of 5,098 suicides committed by agricultural labourers during 2020, 4,621 were male and 477 were female, it added

The majority of suicides were reported from Maharashtra (19,909), followed by Tamil Nadu (16.883), Madhya Pradesh (14,578), West Bengal (13,103), Karnataka (12,259), accounting for 13 per cent, 11 per cent, 9.5 per cent, 8.6 per cent and 8 per cent of the total cases, respectively, the data showed. These five states together accounted for

50.1 per cent of the total suicides reported in the country, while the remainder 49.9 per cent were reported from the remaining 23 states and eight union territories (UTs). the National Crime Records Bureau (NCRB) stated

Uttar Pradesh, the most populous state with 16.9 per cent share of the country's population, reported a comparatively lower percentage share of suicidal deaths, accounting for only 3.1 per cent of the total suicides, it added. Delhi, which is the most populous UT, reported the highest number of suicides

(3,142) among UTs, followed by Puducherry (408), the report showed

A total of 23,855 suicides were reported in the 53 mega cities of the country in 2020, the report showed, observing that the suicide rate in cities (14.8) was higher as compared to all-India suicide rate (11.3). According to the report, 'family problems' (33.6 per cent), 'marriage related problems' (5 per cent) and 'illness' (18 per cent) together accounted for 56.7 per cent of total suicides in the country during 2020, it showed.

## Bypolls to 3 LS, 29 Assembly seats today

New Delhi, Oct 29: Bypolls to three Lok Sabha seats and 29 assembly constituencies spread across 13 states and Dadra and Nagar Haveli will be held Saturday with many contests seen as prestige issue for parties hit by defections.

Adequate security and Covid safety measures have been put in place for the electoral exercise. In majority of the seats, the main fight will be between BJP and Congress candidates.

The seats where Lok Sabha byeelections will be held are Dadra and Nagar Haveli, Mandi in Himachal Pradesh and Khandwa in Madhya Pradesh. Of the 29 assembly constituencies going to the bypolls, five are in Assam, four in West Bengal, three each in Madhya Pradesh, Himachal Pradesh and Meghalaya, two each in Bihar, Karnataka and Rajasthan and one seat each is in Andhra Pradesh, Harvana, Maharashtra, Mizoram and Telangana.

The counting of votes will take place November 2. Though bypoll was also announced for the Shamator-Chessore assembly constituency in Nagaland, Nationalist Democratic Progressive Party candidate S Keoshu Yimchunger was declared elected uncontested October 13

In all the three Lok Sabha constituencies, the sitting members had died. The Mandi seat fell vacant after the death of Ramswaroop Sharma (BJP) in March.

## 60% stroke cases lead to disability, 30% cause death: Experts

New Delhi, Oct 29: About 60 per cent of people suffering stroke in India face various degrees of disability some lifelong, said experts

"While the numbers of stroke patients continue to rise exponentially, like many other brain diseases, there is still a remarkable lack of awareness regarding this condition. Timely treatment in stroke will go a long way in improving a patient's quality of life, and reducing lifelong morbidity and mortality," said Pankaj Agarwal, Senior Consultant -Neurology, Head, Movement Disorders Clinic & In-Charge, Deep Brain Stimulation (DBS) Programme, Global Hospital Mumbai.

"Stroke patients who get help from paramedics are more likely to reach hospital for care - in India, that number is only 1.8 per cent. We need uniform emergency medical services (EMS) system and certification of stroke ready hospitals across the country so that people know where to go when they recognise the signs of stroke," added Dr P.N Sylaja, Professor and HoD, Neurology, In-Charge. Comprehensive Stroke Care Programme, Sree Chitra Tirunal Institute for Medical Sciences and Technology (SCTIMST). While traditionally stroke affects older age groups, a large number of ischemic



#### **Canberra** eases **Covid curbs**

Canberra: Coronavirus restrictions in Australia's capital Canberra have eased significantly as residents of the Australian Capital Territory (ACT) were no longer required to wear facemasks outdoors from Friday. For the first time since early August, Canberra's arts and entertainment venues including cinemas and theatres have reopened for up to 75 per cent of their seating capacity, reports Xinhua news agency. Patron cans for hospitality venues have been increased to a maximum of 25 people inside.

## Militant killed

Cotabato: Philippine forces Friday killed one of the country's most-wanted Muslim militant leaders and his wife who were aligned with the Islamic State group and were blamed for deadly bombings, killings and extortion in the south for more than a decade, the military said. Army and police forces raided a hideout of the militant group Daulah Islamiya in a remote area of Talayan town in Maguindanao province and killed its leader, Salahuddin Hassan, and his wife in a 30-minute gunbattle before dawn. More than two dozen other gunmen managed to escape, regional military commander Mai. Gen. Juvymax Uy said.

## **SL** approves five new airlines

Colombo: The Sri Lankan government has approved five new airlines to operate into the country before the end of this year aimed at boosting tourist arrivals following the easing of Covid curbs, Tourism Minister Prasanna Ranatunga said. Accordingly, Sweden's Edelweiss Air will operate a weekly flight and Russia's Aeroflot twice a week from November 1, while Air France will fly three times a week from November 3, reports Xinhua news agency.

#### **Turkey, US discuss** F-35 dispute

Ankara: Turkish and US Defence Ministers held a meeting here to resolve the conflict on the F-35 Joint Strike Fighter program. According to the Defence Ministry in Ankara, the two sides on Thursday also discussed financial issues of the program, adding that the two NATO allies have agreed to continue their talks, reports Xinhua news agency. The discussion came ahead of a meeting between Turkish President Recep Tayyip Erdogan and his US counterpart Joe Biden on the sidelines of the UN Climate Change Conference in Glasgow scheduled to begin on Sunday.

## **G20 leaders converge** in Rome amid security



Rome, Oct 29: The 16th G20 Summit, the first in-person gathering of leaders of the biggest economies since the onset of the pandemic early last year, will begin from Saturday in Italy's capital city amid tight security measures and with a packed agenda.

The summit will be preceded by a G20 Joint Finance and Health Ministers' meeting, which will also be hosted by Rome on Friday, reports Xinhua news agency. According to Italy, holder of the G20 Presidency since December 1, 2020, the Summit's agenda will cover the most pressing global health and economic issues related to the coronavirus pandemic.

These would include the need for the most developed economies to boost their efforts to ensure the fair and equitable global distribution of Covis-19 vaccines, especially to low-income countries.

Earlier this month, UN Secretary-General Antonio Guterres launched an appeal for some \$8 billion to speed up vaccination. The plan unveiled by the World Health Organization (WHO) aims at immunizing 70 per cent of the planet's population by mid-2022.

The G20 leaders are also expected to discuss climate change, digital transformation and sustainable innovation, along with such issues as the situation in Afghanistan, on which Italy called an extraordinary G20 meeting ear-

Since the G20 Summit is scheduled to take place just before the opening of the UN Climate Change Conference (COP26) in Glasgow. Scotland (October 31-November 12), the leaders in Rome are expected to discuss a common strategy in coping with climate change. ## Modi holds talks with top EU leaders

## UK vows retaliation to French fishing threats Britain summoned the French ambassador for a dressing-down after French authorities fined two British

London, Oct 29: Britain's environment minister pledged Friday to retaliate if France carries through on threats to block UK ships from French ports, warning that "two can play at that game in the worsening dispute rooted in Britain's departure from the European Union

Britain summoned the French ambassador for a dressing-down after French authorities fined two British fishing vessels and kept one in port overnight Thursday. Since the UK left the economic orbit of the EU in January, relations between London and Paris have become increasingly frayed as the nations on either side of the English Channel sort out a post-Brexit path.

France has threatened to block British boats and tighten checks on UK vessels unless French vessels get more permits to fish in UK waters. France also suggested it

might restrict energy supplies to the Channel Islands, British Crown dependencies that lie off the coast of France.

"We will see what they do," Environment Secretary George Eustice told Sky News. "But if they do bring these into place, well, two can play at that game and we reserve the ability to respond in a proportionate way."

The UK government said France's ambassador, Catherine Colonna, would be summoned to the Foreign Office on Friday, in an official sign of displeasure. "We regret the confrontational language that has been consistently used by the French government on this issue, which makes this situation no easier to resolve," the British government said in a statement.

France vehemently protested the decision last month by the UK and the Channel Island of Jersey to refuse dozens of French fishing



boats licenses to operate in their territorial waters. Dozens of other licenses were granted. France says the restrictions are contrary to the post-Brexit agreement that Britain signed when it left the EU.

Meanwhile, the European Union's executive said UK authorities withdrew the impounded vessel's license to fish off France on March 1. But Macduff Shellfish, which operates the impounded scallop vessel Cornelis, hit back in a statement, saying it had access to French waters under the Brexit deal and that its activities were

"entirely legal," and that it would defend itself against all claims. Its statement did not offer specifics on licenses.

"It appears our vessel has been caught up in the ongoing dispute between the UK and France on the implementation of the Brexit Fishing Agreement," the company statement said. "We are looking to the UK government to defend the rights of the UK fishing fleet and ensure that the fishing rights provided under the Brexit Fishing agreement are fully respected

## 'Ensure Afghanistan is not used as terrorists' safe haven'

Washington, Oct 29: India and the US have called on the Taliban to ensure that Afghanistan is not used as a safe haven for terrorists, as officials from the two countries concluded their joint dialogue on counter-terrorism to expand their cooperation to combat the scourge.

The Indian and the US sides also called for concerted action against all terror groups, including those proscribed by the UN Security Council such as al-Qaida ISIS/Daesh, Lashkar-e-Taiba (LeT) and Jaish-e-Mohammad (JeM), a joint statement issued after the meeting here said on Thursday.

Reaffirming counter-terrorism cooperation as an important pillar under the US-India Comprehensive Global Strategic Partnership, both sides pledged to further expand cooperation on law enforcement, information sharing, exchange of best practices and strategic convergence on counter-terrorism challenges, it said.

During the two-day meeting here on October 26 and 27, the US reiterated its commitment to stand together with the people and the government of India in the fight against



During the meeting, the US reiterated its commitment to stand together with the people and Govt of India in the fight against terrorism

terrorism. They called on the Taliban to ensure that Afghanistan is not used as a safe haven for terrorists.

The Taliban seized power in Afghanistan on August 15, two weeks before the US' complete troop withdrawal on August 31 after a costly two-decade war.

According to the joint US-India statement, the two countries strongly condemned any use of terrorist in all its forms, and called for the perpetrators of the 26/11 Mumbai attack to be brought to justice. The 2008 Mumbai attack was

one of the most horrific terrorist attacks in India in which 166 people, including six Americans, were killed and over 300 injured as 10 heavily-armed terrorists from Pakistan created mayhem in the country's financial capital. Pakistani national Mohammed Ajmal Kasab, the lone terrorist captured alive, was hanged to death on November 21, 2012. "In line with UNSC Resolution 2593 (2021), both sides called on the Taliban to ensure Afghan territory is never again used to threaten or attack any country, shelter or train terrorists, or plan or finance terrorist attacks," it said.

## Major victory for H-1B employers PRESS TRUST OF INDIA

Washington, Oct 29: In a major victory for H-1B employers, a federal court has approved a settlement under which the US Citizenship and Immigration Services has agreed to qualify market research analyst as a speciality occupation for the purposes of determining H-1B visa application of a foreign professional.

Based on its prior interpretation of the Occupational Outlook Handbook — a Department of Labor's Bureau of Labor Statistics publication profiling hundreds of occupations in the US job market — the USCIS was determining that market research analysts did not qualify as a "specialty occupation".

The settlement approved by the federal district court in the Northern District of California would now let companies request that the USCIS reopen and re-adjudicate their denied H-1B petitions.

"This settlement is an important victory that will benefit hundreds of American businesses and the market research analysts they sought to employ," said Leslie K Dellon, senior attorney (business immigration) at the American Immigration Council.

"The settlement gives US businesses another chance to have their H-1B market research analyst petitions approved — this time under new guidance worked out by the parties to the lawsuit. Each H-1B petition reopened and approved will represent another opportunity for US employers and the workers they sponsored to advance their business objectives," she said.

The class action lawsuit in this regard was filed by the American Immigration Council, American Immigration Lawyers Association, and the law firms Van Der Hout LLP, Berry Appleman & Leiden LLP (formerly Joseph & Hall P.C.), and Kuck Baxter Immigration

Jeff Joseph, partner at Berry Appleman & Leiden LLP, said this settlement finally resolves an issue on which immigration lawyers have been battling the government

## MISSILE KILLS 11 CIVILIANS

The fighting has claimed a high number of fighters from both sides in the past several weeks.

So far, June was considered the deadliest month, with 35 civilians, including children, killed in shelling and missile attacks, said UNHRC

The war has also displaced around 170,000 people who used to live in and around the city and the surrounding province, also called Marib, as well as two nearby provinces, since the beginning of 2020, the UN said

## 'Ghost ships' rise from Pacific after volcanic eruption



**AROUND 24 SHIPS HAVE RESURFACED AS A** RESULT OF THE UNDERWATER SEISMIC ACTIVITY

Tokyo, Oct 29: Twenty-four World War II-era 'ghost ships' have been seen in the Pacific Ocean after a volcanic eruption near Japan's capital Tokyo.

All these ships were sunk during one of the most talked about battles of the World War II. It is being told that after the explosion in the underwater volcano Fukutoku-Okanoba, these ships came above the water and reached the shore. The sunken warships from World War II emerged about 800 miles from Tokyo, footage

and pictures show. The warships were from the Battle of Iwo Jima, an island roughly 760 miles from Japan's capital city.

Seismic activity from an underwater volcano called Fukutoku-Okanoba created a new small Cshaped island which was initially about 1 km in diameter. According to the Japanese Coast Guard, the small island was formed by hardened lava and is made of pumice and volcanic ash. But the same eruption also pushed up 24 ships that sank during the battle of Iwo Jima in 1945. During the battle, 70,000 US marines fought against around 20,000 Japanese soldiers who were hiding out in bunkers within the island's volcanic rocks.

By the end of the war, 20,000 marines had been wounded and nearly 7,000 died. Nearly all the Japanese soldiers were killed in the battle. The vessels that have risen from the bottom of the sea are said to be sunken Japanese ships that were captured by the US Navy in the aftermath of the battle.

Since Iwo Jima had no port, the ships were sunken parallel to the shoreline to form a breakwater, according to the US National Archives. This is not the first time the warships are visible as they could also be seen 35 years ago because ofseismic activity before being dragged to the bottom of the ocean again.

# Fiscal deficit touches 35% of annual target

New Delhi, Oct 29: The union government's fiscal deficit has worked out to be ₹5.26 lakh crore or 35 per cent of the budget estimates at the end of September 2021, as per the data released by the Controller General of Accounts (CGA) Friday.

The deficit figures in the current fiscal appear much better than the previous financial year when it had soared to 114.8 per cent of the estimates mainly on account of a iump in expenditure to deal with the Covid-19 pandemic.

In absolute terms, the fiscal deficit or gap between expenditure and revenue was ₹5,26,851 crore at end of August, the CGA said. For the current financial year, the government expects the deficit at 6.8 per cent of GDP or ₹15,06,812 crore.

As per the data, the central government's total receipts stood at ₹10.99 lakh crore or 55.6 per cent of corresponding budget estimates (BE) 2021-22 up to September, 2021. The total receipts were 25.2 per cent of the BE of 2020-21 during the corresponding period of last financial year.

Of the total receipts, the tax revenue was ₹9.2 lakh crore or 59.6 per cent of BE. The tax revenue was

**IRCTC** stock recovers

New Delhi, Oct 29: Shares of Indian Railway Catering and Tourism Corp pared most of their sharp early losses Friday, as the government reversed its decision to take 50% share of the stateowned company's revenue from convenience fees.

IRCTC plunged as much as 30% in its sharpest intraday fall since listing in 2019, wiping off as much as ₹219 billion (\$2.93 billion) from its market valuation, after the Ministry of Railways asked it Thursday to share 50% of revenue earned from convenience fees from Nov 1. But the stock pared most of these losses after the Indian government withdrew its decision earlier this morning

"Ministry of Railways has decided to withdraw the decision on IRCTC convenience fee," the secretary of India's Department of Investment and Public Asset

**IRCTC** was trading at ₹859.25 down almost 6 per cent while it recovered from the morning lows

New Delhi, Oct 29: Unfazed by the challenges posed by the Covid-19 pandemic, Swedish companies intend to double their investment in the next two years in India, according to the 13th Business Climate Survey (BCS).

The BCS, titled 'Towards Sustainable Growth', is conducted annually since 2008 by the Swedish Chamber of Commerce India (SCCI), along with the Embassy of Sweden in India, the Consulate General of Sweden in Mumbai

and Business Sweden. It attempts to understand the confidence of Swedish companies in India, to identify the obstacles and how they can be reduced.

According to the survey's findings, in the coming year, 80 per cent of the companies project their revenues to increase significantly (34 per cent) or slightly (46 per cent). This has starkly changed when compared with our interim survey in May 2020, where only 28 per cent of respondents projected their revenues would increase over the





Dubai, Oct 29: Skipper Babar Azam hit a composed 51 (47b, 4x4) while Asif Ali hit four sixes in the penultimate over as Pakistan completed a hat-trick of victories in the T20 World Cup (World T20) with a five-wicket win over Afghanistan in a Super 12 Group 2 match, here Friday

Skipper Mohammad Nabi (35 n o) and Gulbadin Naib's (35 n o) unbeaten knocks in a splendid rearguard action had steered Afghanistan to a competitive 147/6 after they were gasping at 76/6.
