PM invites Pope Francis to India

VATICAN CITY: Prime Minister Narendra Modi Saturday said he had a "very warm meeting" with Pope Francis and discussed a wide range of issues, including the Covid-19 pandemic and the challenge posed by climate change, with the head of the Roman Catholic church and also invited the Pontiff to visit India at an early date. Modi, who is the first Indian Prime Minister to meet Francis since he became Pope in 2013, also tweeted pictures of him embracing Pope Francis. "Had a very warm meeting with Pope Francis. I had the opportunity to discuss a wide range of issues with him and also invited him to visit India," Modi tweeted after the historic meeting. In June 2000, late Prime Minister Atal Bihari Vajpayee had last visited the Vatican and met the then Pope, His Holiness John Paul II.



BMC eases cap on social gatherings

BHUBANESWAR: The Bhubaneswar Municipal Corporation (BMC) Saturday allowed further relaxation on the number of guests attending marriage ceremonies, funerals and other ceremonial functions in the Capital city from 50 to 250 now. In a fresh order issued Saturday, the civic body withdrew the restrictions related to gathering and the total number of persons to be allowed in functions related to marriage/death rituals/thread ceremony within its limit. In a bid to contain the spread of pandemic during Durga Puja, the BMC earlier, October 5, had limited the maximum number of people attending public gathering to only 50 within its jurisdiction.



Consensual sex with major no offence: **Allahabad High Court**

Prayagraj, Oct 30: The Allahabad High Court, while rejecting the bail plea of a gangrape accused Saturday, held that consensual sex with a major is not an "offence" but is "unethical, immoral, and against established Indian tradition".

Dismissing the bail plea of one of the four accused, Justice Rahul Chaturvedi said that it was the duty of the man, claiming to be the minor's boyfriend, to protect her when she was being sexually assaulted.

'The moment the applicant submits that the victim is his beloved, it becomes his binding duty to protect the dignity, honour and reputation of his girlfriend. If a girl is major, then having sex with her consent is not an offence, but certainly it is unethical and immoral. and also not in consonance with the established social norms of the Indian society," he said. The court termed the act of the applicant "highly deplorable and unbecoming of a boyfriend".

On February 19, the victim had gone for her stitching class and spoken to her boyfriend Raju and they both planned to meet. Later, they met at a secluded place near a river. It was here that the three other persons came, abused and beat the applicant, and committed the crime. On February 20, an FIR was lodged by the 15-year-old victim.

Chinks in Assembly security

■ The accused duo accompanied the complainant and his son to Treasury on Assembly premises to deposit ₹25 lakh for registering their firm

Bhubaneswar, Oct 30: The arrest of the two conmen by the Economic Offence Wing (EOW) of the state police has exposed the loopholes in security arrangements at high-sensitive zones like the Odisha Legislative Assembly as the accused had easy access to such places.

The fraudsters were also found to have contacts in other vital government offices. EOW sources Saturday claimed to have arrested the two fraudsters for impersonating senior state government officers and cheating a businessman and his son of ₹1.17 crore.

Based on a complaint filed by Rikab Chand Munot alias Mukesh



Jain, proprietor of M/s Rashtriya Stainless Steel, the EOW arrested Suryamani Tripathy and Amit Kumar from Cuttack and Bhubaneswar, respectively, said EOW SP Dillip Kumar Tripathy. The accused were forwarded to

the court of SDJM, Bhubaneswar. The EOW SP said accused Rajesh Gahlot, Survamani and Amit impersonated themselves as the of-

ficers of RAW, IAS and the state works department respectively and duped Mukesh Jain and his son of ₹1.17 crore with the help of a lady who impersonated a lady treasury officer at the Assembly.

They cheated the complainant

and his son on the pretext of arranging big government work orders/contracts. In 2017, Mukesh came in contact with Gahlot, who introduced himself as an officer of RAW claiming several IAS officers of Odisha were his friends, said the SP. Gahlot, who is absconding now, introduced the complainant and his son Akshay to accused Suryamani at Odisha Niwas, Chanakyapuri, in New Delhi as an IAS officer, posted as additional secretary in the Public Works department (PWD).

In January 2018, after being called upon by Suryamani for executing agreement with PWD, pertaining to work orders in favour of complainant's firm, Mukesh & his son came to EIC office where Survamani introduced another accused Amit as an executive engineer working with PWD, the SP further said. Both Suryamani and Amit took the Jains to Bhubaneswar court and prepared the agreements on stamp papers and got the documents /agreement papers purportedly signed by assistant engineer in the office of EIC (Civil), he said.

The EOW found that the accused duo accompanied the complainant and his son to the government Treasury inside the Assembly premises to deposit ₹25 lakh for registering their firm. This has raised questions as to how the accused were allowed entry to such high-sensitive zone without any check. The Jain duo paid cash of ₹25 lakh to one lady, who has been introduced as Treasury officer: In return, Suryamani handed over a fake Treasury receipt in respect of ₹25 lakh to the complainant. Tripathy handed over two fake work orders worth ₹3 crore and ₹4 crore March 15, 2018. The complainants sought information under RTI about the accused and the work orders given to them before they realised that they had been duped.

Police found that Suryamani has been working as a clerk in the office of the Directorate of Technical Education & Training, Cuttack, whereas Amit Kumar is unemployed.

Aryan back home after 26 days in Mumbai prison

Mumbai, Oct 30: Aryan Khan, son of superstar Shah Rukh Khan, walked out of the Arthur Road prison, after spending 26 days in the central Mumbai facility following his arrest during a drug raid on a cruise ship off the city coast.

The 23-year-old, arrested October 3 by the Narcotics Control Bureau (NCB), walked out of the prison at 11am and got into a waiting car, which reached his home Mannat in suburban Bandra shortly after 11:30am.

Aryan came out of the prison a day after a special court issued his release

memo. He was granted bail by the Bombay High Court Thursday. Shah Rukh Khan's actor-friend Juhi Chawla stood as surety for the 23-year-old before the special court, designated to hear cases related to the NDPS. However, he had to be in jail Friday as bail orders couldn't reach the jail authorities by 5:30pm.

Meanwhile, a special court here Saturday granted bail to alleged drug peddler Aachit Kumar and eight others who were arrested by the NCB following a raid on the cruise ship. Of the 20 persons arrested by the NCB after the raid October 2, as many as 14 have got bail so far.

State waives MV tax on electric vehicles

Bhubaneswar, Oct 30: In accordance with the Odisha Electric Vehicle Policy, 2021, the state Commerce and Transport department Saturday issued the official notification for 100 per cent exemption of Motor Vehicle (MV) taxes and registration fees on electric vehicles.

'The state government in exercise

of the powers conferred under the Odisha Motor Vehicles Taxation Act, 1975, do hereby allow 100% exemption of Motor Vehicles taxes and also registration fees in respect of all types of battery operated vehicles (electric vehicles) during the policy period, i.e. up to December 31, 2025," read the notification.

The Ministry of Road Transport & Highways, in August 2021, had published a gazette notification on the amended the Central Motor Vehicle Rules, 1989 where the battery operated vehicles have been exempted from pay-



On the advice of NITI Aayog, the state government had notified the Electric Vehicle Policy, 2021 in September this year. Under the policy, the government has proposed to extend financial incentives for manufacturing industries, buyers, scrapping along with interest subvention in loans, waiving of road tax & registration fees during the policy period (five years). It has also decided to give incentives under the Startup Policy.

G20 struggles to toughen climate goals

■ Keeping 1.5° Celsius warming level within reach will call for meaningful and effective actions by member countries

Rome, Oct 30: Leaders of the Group of 20 (G20) major economies will say they aim to cap global warming at the 1.5 degrees Celsius level what scientists say is vital to avoid disaster, but will largely avoid firm commitments, according to a draft statement seen by Reuters.

The joint statement on the need for climate action reflects tough negotiations among diplomats as the leaders gathered for a two-day summit in Rome, but the draft details a few concrete ac-

tions to limit carbon emissions. "We remain committed to the (2015)




Paris Agreement goal to hold the global average temperature increase well below 2°C and to pursue efforts to limit it to 1.5°C above pre-industrial levels," the draft says.

The statement also says the leaders recognised the key relevance of achieving net zero carbon emissions by the middle of this century. This is a goal that United Nations experts say is needed to achieve the 1.5 degree cap on warming, but some of the world's biggest polluters have still not committed to it.

China, the largest global emitter of greenhouse gases, has set a 2060 target date.

Overall, the fifth draft produced does not seem to have toughened up the language on climate action compared with previous versions, and in some areas it has slightly softened it.

The G20 bloc, which includes Brazil, China, India, Germany and the US accounts for more than 80 per cent of the world's gross domestic product (GDP), 60 per cent of its population and an estimated 80 per cent of global greenhouse gas emissions. Keeping 1.5° Celsius within reach will require meaningful and effective actions by all countries, the latest draft says. That compares with a previous draft which said immediate action was needed, reflecting the painstaking discussions over wording involved in climate diplomacy.

Untimely exits leave family, fans stunned

annada star Puneeth Rajkumar's demise at the age of 46 following a heart attack is the latest this year in a series of sudden deaths of people in their prime, leaving behind stunned families and many questions, often unanswered, of exactly why and how.



Slugfest over Mamita case continues

Bhubaneswar, Oct 30: Continuing its attack on the MoS for Home, Dibya Shankar Mishra, over Mamita Meher murder case, BJP Mahila Morcha national president Vanathi Srinivasan Saturday demanded resignation of Mishra on moral grounds.

Addressing a press conference here, the BJP leader said the Assembly constituency where the crime took place is represented by Mishra and the accused Gobinda Sahu is known to be his close aide. Mishra had visited the school many times. Funds from the MLA LAD have been provided to Sahu's school too, she alleged.

Even though three weeks have passed since the incident, neither Mishra nor anyone from the state government visited the victim's family, the BJP leader said.

"Mishra broke his silence by issuing a statement yesterday and claimed that he is in no way involved in the case. He swore in the name of Goddess Manikeswari and pleaded not guilty Similarly we in the BJP request him (Mishra) in the name of Lord Jagannath to resign to pave the way for a fair probe into the murder case," demanded Vanathi. If he is innocent, what prevented

him from visiting Mamita's home to console the bereaved family, she questioned

Stating that the state BJP has been protesting against this injustice for the last 10 days, she said, "We feel the MoS should step down from his position on grounds of propriety and moral responsibility in view of the suspicion and mistrust generated around his conduct."

BJP leader and MLA from West Bengal, Sreerupa Mitra Chaudhury, who is another member of the BJP central team, slammed the state government for not reaching out to the family even 22 days after the incident.

Chaudhury urged the Naveen Patnaik government to strictly follow the Witness Protection Scheme, 2018, to ensure safety and security ■ BJP Mahila Morcha national president Vanathi Srinivasan demands resignation of Mishra on moral ground

The three-member BJP central team was on a two-day visit to Odisha to carry out a ground assessment of facts related to the Mamita Meher murder case. The third member of the team is Sunita Duggal, a party MP from Haryana. The team visited the victim's native village in Bolangir district and spoke to Mamita's parents and offered their condolences.

Meanwhile, the state BJP Saturday intensified its protest over the issue. Party activists staged protests at Rourkela, Cuttack and Nayagarh in support of their demand for the arrest of Mishra.

The party also observed a 12hour bandh (from 6 am to 6 pm) in several districts, including Boudh, Kendrapara, Balasore and Jagatsinghpur. The party has also called for a 6-hour bandh in Bhadrak district. Youth Congress activists also took out a rally from Congress Bhawan and marched towards Naveen Niwas. However, police prevented them mid-way, leading to a scuffle between the party workers and police. Several Youth Congress activists were also arrested and released later.

Stating the minister's statement is meaningless and baseless, senior Congress leader Ganeswar Behera said, "He (Mishra) has not categorically refuted any charges leveled against him. Mishra should tender his resignation immediately. He should face the investigation to prove himself innocent. Otherwise, Congress will intensify the agitations across Odisha.

The ruling BJD, however, refuted the allegations while accusing the opposition of politicising the issue.

"Everyone knows that a heinous crime has occurred. Mishra has already clarified his stand on this issue. If the Opposition parties have any evidence against him to prove his involvement in the case, then they should produce it before the police and file an FIR or can even move court," said BJD leader Pratap Deb.

"The minister has also said that he is prepared to face action if he is proven guilty," he added.

Attacking back the BJP, the BJD leader questioned what actions have been taken against the Union Minister of State for Home Ajay Mishra in the Lakhimpur Kheri violence case in Uttar Pradesh?

'Earlier, CM Naveen Patnaik has sacked many who have been convicted for crimes. And this time too he won't spare anyone. As the party spokesperson, I can affirm that my leader won't tolerate any nonsense and will take action after the accused is proven guilty," he added.

PM urged to include three more sites in Netaji circuit

Bhubaneswar, Oct 30: An Odishabased organisation Saturday urged Prime Minister Narendra Modi to include three more sites in the Netaji tourist circuit being mulled by the Union government.

Fill up vacant posts of spl teachers, SC tells states

New Delhi, Oct 30: Expressing concern over the shortage of special teachers to teach children with special needs (CwSN), the Supreme Court has directed Odisha and other states to fill up the vacant posts of such teachers.

The apex court noted that a total of 5,966 special teachers in Odisha are registered with the Rehabilitation Council of India against the all-India figure of 1,20,721.

The SC also asked the states to create permanent posts for special teachers by taking into account the pupil-teacher ratio specified by the competent authorities.

"There is a dearth of rehabilitation professionals or special teachers recognised and registered by the National Council for Teacher Education (NCTE). As per the data with the Unified District Information System for Education, there are 22.5 lakh CwSN in the country. However, only 4.33 lakh general teachers have been trained to teach CwSN, in addition to teaching general children, and only 28.535 special teachers are available for children with special needs," the bench observed.

A three-judge bench comprising Justices AM Khanwilkar, Dinesh Maheshwari and CT Ravikumar asked the State Commissioners appointed under Section 79 of the Rights of Persons with Disabilities Act, 2016 to ensure that the directions issued by the apex court are complied with and make recommendations to authorities for the same. The Commissioners were directed to file compliance report by the end of February next year. The Supreme Court also directed the state governments to provide compulsory training to staff and teachers of general schools to handle children with special needs.

Illegal constructions near Srimandir under ASI scanner

Puri, Oct 30: Some people are carrying out construction work within 100 metres of the Meghanada wall of Srimandir in violation of the

On being informed, a joint team of the Archaeological Survey of India (ASI) and Puri Konark Development Authority took stock of the situation and issued a direction for immediate halting of the construction work.

As per the norms, no construction work is allowed within 100 metres of Srimandir, while any construction work within the next 200 metres requires due approval from the ASI, the conservator of the 12th century shrine.

'Some individuals and organisations are carrying out construction work within 100 metres of Srimandir illegally. We had earlier served notices on the individuals and organisations concerned. A team of officials recently visited the surroundings of Srimandir and issued a direction for halting the construction work. Any violation in this regard would invite stern action," said ASI officer Jyotiranjan Pati.

The locals, meanwhile, blamed the ASI, PKDA and the district administration for the illegal construction work within 100 metres of Srimandir.

"A few multi-storey buildings have been illegally constructed within the prohibited zone near Srimandir. The authorities concerned should take immediate steps to raze the buildings," said BJP youth wing leader Jayanta Kumar Dash.

However, Muralidhar Dash, the caretaker of one of the newly-constructed buildings, said they had not received any notice earlier from the ASI to stop the construction work.

BSCL to provide underground OFC network by year end

Bhubaneswar, Oct 30: The Bhubaneswar Smart City Limited (BSCL) said that it will complete the laying of underground optic fibre cable (OFC) network by the year end with the aim to improve the outlook of the state capital. The OFC network will replace overhead cabling.

According to sources, the BSCL, which has planned to lay 680 km of OFC network in and around the city, has so far laid 550 km of cable. Out of the laid cable, about 501 km network has been successfully tested and is live for use. The project began in 2018 to provide licensed Internet providers the services of BSCL optical fibre network for a nominal user fee.

"It was found that for a single or

group of Internet users the service providers were taking the cable overhead making the place look cluttered and complicated. However, it will change after the laying of OFC work is over, RFP has already been floated for the BSCL fibre optic network and very soon the process will be over so that citizens can get the benefit of the facility," said CEO, BSCL, Sanjay Kumar Singh.

It may be mentioned here that the

network infrastructure comprises two types of fibre optics cable, including 120 core cable strands and 12 core cable strands. While 120 core cable strands are used as the backbone connectivity for any communication network, 12 core cable strands are meant for last mile connectivity to smart elements.

Optical fibre communication net work is being established by BSCL as a part of its Smart Solution project to provide seamless and robust connectivity for all the on-field smart elements like CCTV cameras, Public Address System speaker, Dynamic Message Signboard, Traffic Violation Detection System and Wi-Fi access points etc along with various other infrastructures. BSCL also envisages leasing cores of fibre for monetisation and revenue generation.

HC seeks replies from Rayagada, **Kandhamal DMs**

Moreover, three persons had died due to asphyxiation in Kandhamal district in July and three others had lost their lives while working in a sewerage tank in Ravagada October 20.

TREE FELLING FOR HOCKEY STADIUM IN JHARSUGUDA

Forest dept starts investigation

Jharsuguda, Oct 30: The forest department has started an investigation into felling of over a hundred trees to make space for a hockey stadium near NH-49 in Jharsuguda. The stadium will be developed on five acres of land. Orissa POST had published reports about the felling of trees October 25.

In the wake of media reports, the forest department has started an investigation into the matter. As for the issue, DFO Lalit Kumar Patra said he had talked to the Collector for development works, but had not given him permission to fell trees for the stadium

"Nobody has applied for tree felling in the area to carry forward the project," he said.

He added that Jharsuguda BDO had applied to the forest department for permission to remove trees October 11, but he got the ap-



plication October 26. "But there was no mention of the specified land where trees will be removed. After I ordered a probe, ranger Pradipta Kumar Mohanty has

started an investigation," he said. However, BDO Prasanna Pandey had earlier claimed that he had intimated the Collector and the DFO about the need for tree clearing for the hockey stadium.

Lawyer Naresh Nayak said, "Now question arises about the claims and counter claims on the tree felling. If the BDO had applied for permission in this regard October 11, why the forest department has He said pollution level is already high in Jharsuguda. "When there is a need to regenerate forests and plant trees in the district, trees are being cut instead," he lamented.

Social activist Debananda Barik said a sports hostel will be built on 40 acres of land along the NH

It was learnt that the district administration had directed to clear a forest opposite PKSS College adjoining NH-49 near Hansamura-Kantapali in Jharsuguda for construction of a hockey stadium. Trees like Acacia and Eucalyptus had been chopped off between October 20 and 22. On being informed, forest guard Anjali Rath rushed to the spot and seized a JCB machine engaged in the tree felling. However, she released the machine after block development officer (BDO) Prasanna Pandey, who was supervising the operation, intervened. Later, she informed her higher-ups about illegal tree cutting in the forest.

However, environmentalists have alleged that the district administration has not sought prior permission from the forest department to cut down the trees, which it is doing in violation of forest protection norms. Jharsuguda Anchalik Parivesh Suraksha Manch, a local outfit working on environment, opposed such illegal tree-felling and demanded action against those responsible.

Notably, the revenue department has allotted 40 acres of land adjoining the NH-49 near Hansamura-Kantapali for construction of the hockey stadium. A compound wall is under construction on one part of the land while the rest of the work is yet to begin.

Recently, an additional five acres of land belonging to the forest department, opposite of the highway, has been allotted.

Mamita's mother falls sick; shifted to Visakhapatnam

Bolangir, Oct 30: Deceased ladv teacher Mamita Meher's mother Tulasi Meher fell sick and was shifted to Visakhapatnam for better treatment, a family source said Saturday.

At a time when Mamita's death case has sent shockwaves across the state, the mother of the deceased -- who has been under severe trauma after losing her daughter has become seriously unwell.

According to the family source, Tulasi has chest pain and loses consciousness frequently. The family members have rushed her to Visakhapatnam for treatment.

Notably, starting from state to national level, political leaders have been visiting deceased Mamita's family at Jharni village under Turekela block in Bolangir district since the murder mystery was cracked. Both the Congress and the BJP have been demanding the

Trenches to bar mafia from lifting sand

Champua, Oct 30: Illegal sand mining has been rampant at different ghats of the Baitarani river in Champua area of Keonjhar district. As the administration has failed to curb the illegal extraction and transportation of the minor mineral, the revenue department has finally dug out trenches across roads on river embankments to prevent mafia from lifting sand and transporting it from the areas close to Kesharikund and Kalikaprasad.

According to reports, the riverbed of Baitarani at different places has turned out to be a safe haven for sand mafia.

Due to rampant illegal sand mining,



the state government has been losing crores of rupees towards revenue annually. But the administration is allegdly

sitting pretty, locals alleged. Locals said, mafia keeps on plundering truckloads of sand from the river day and night while some quarries have not been made operational even after tenders were finalised. In such a situation, mafia has set its sight on the Baitarani sand.

Sand is being lifted near tourist spots like Kesharikund and Kalikaprasad. Locals voiced fears that if illegal sand excavation goes on in this manner, these tourist sites will face threat.

Earlier, revenue officials used to act against the sand mafia with seizure of vehicles and slapping of fines, but this has stopped for some time.

On being informed, Champua tehsildar Sai Sasmita Hota had visited the spots where sand was mined. She saw some routes on which sand was being transported in tractors from the riverbed.

She had ordered for digging of trenches. Revenue inspectors have initiated digging of trenches across roads to prevent mafia from looting sand, she added.

Youth held for rape in Balasore

he controversy about Sameer Wankhede's Scheduled Caste certificate gives us the opportunity to examine two issues. The first is reservations and the second is religious freedom. On reservations, India allows Hindu, Sikh and Buddhist Dalits access to SC reservation but not Christian and Muslim Dalits. A committee set up by the previous government and headed by former justice Rajinder Sachar recommended that reservations be extended to all Dalits, including Muslims, but this recommendation has not been implemented. Muslims of course today have no political agency in India and cannot make demands such as reservations; they are busy staying out of jail or avoiding being brutalised on the streets.

India gives all Scheduled Tribe individuals, including Muslims and Christians reservations under the ST category. And of course the OBC reservations are also available to Muslims and Christians. It is only the SC category, in which Sameer Wankhede applied, that is denied to them. Wankhede's father was a Dalit and mother a Muslim. It is alleged that he himself is a Muslim and therefore his application under the SC category is invalid.

Dalits and Adivasis who convert are vulnerable, because the State insists on registering them on certificates as 'Christian Adivasi' making it difficult for the individuals to then access their rights including reservation. In Gujarat, some Dalit converts to Christianity officially retain their Hindu faith, and therefore their caste and status, a process the church condones under a doctrine called occult compensation. This term refers to the action of an individual seeking to recover their losses through an extra-legal act,

in this instance, the use of stealth by Dalits to claim their right from a State which is denying it to them unjustly.

The BJP government actively goes after Gujarat's Dalit and Adivasi Christians on the issue of reservations as a way of blocking conversions. March 7, 2011, the Gujarat High Court rejected a Dalit's access to benefits he had earlier received after the government claimed he

The court said that the man, Nimesh Zaveri, and his family would cease to enjoy their rights as Dalits despite having a certificate issued by the government. People may not know that the conversion of SC and ST individuals (and also women) attracts a harsher punishment than conversion of other individuals.

After 2018, BJP states began passing harsher laws that prevent conversions especially linked to marriage. India is a conservative cultural society. The majority of families follow religious practices and traditions at home and it is unusual to have two people with different religions in the same family. It is theoretically possible for two people of different faiths to marry through something called the Special Marriage Act but it has its own problems which we need

The first of the new 'love jihad' laws was the Uttarakhand Freedom of Religion Act, 2018. It is unusual in that it says that people who convert to Hinduism (which is called as 'ancestral

religion') are excluded. Meaning a Hindu cannot convert to Islam to marry but a Muslim can become Hindu for the same reason. The Uttar Pradesh Vidhi Viruddh Dharma Samparivartan Pratishedh Adhyadesh, 2020 has reversed burden of proof. The testimony of an adult woman who says she has changed her faith on her own free will is insufficient evidence and the family she marries into must satisfy the police that they have not coerced her. The Madhya Pradesh Dharma Swatantreya Adhyadesh, 2020 punishes conversion through marriage by 10 years in jail. It also nullifies such marriages even if the couple has children. The Gujarat Freedom of Religion (Amendment) Act, 2021 also has a 10-year jail sentence. Other BJP states including Karnataka and Haryana have promised similar laws soon. It is unusual in democratic countries two decades into the 21st century for laws to become regressive instead of progressive. But that is clearly what is happening in India today and more of this is ahead.

Indians have the fundamental right to "freely to profess, practise and propagate religion." Propagate means to spread. In the Constituent Assembly, this right was debated fiercely on behalf of Christians as part of their right to convert. Ambedkar's original draft submitted to the Constituent Assembly's committees bore the words: "right to profess, to preach and to convert, within limits compatible with public order and morality." He did not comment after the word was changed to propagate because he was satisfied that propagate meant the same thing as convert. Today there is no right to propagate or convert in India. To do so one has to fill out a form and it is for the State to determine whether one can change faith or not. This makes it one of the many peculiar things about our secular democracy.

The right to "freely profess, practice and propagate religion" is at once a fundamental right, meaning one that enjoys a high degree of protection from State encroachment, and also a criminal offence.

■ Playing gooseberry

his odd phrase puzzles everybody who has come across it. Not the least odd thing about it is that in its fairly short history it has flipped sense. Today it means intruding on a couple, usually lovers, who wish to be alone. As you might also say, "two's company, three's a crowd". But when it first appeared, in the nineteenth century, matters were very different. A delightful story by a man who wrote under the pseudonym of "an old bachelor" appeared in Notes and Queries in 1860. He told how he was accompanying his nineteen-year-old niece on a walk when a young man joined them. He went on: I observed nothing particular on the road, except that my niece and our casual companion seemed very much taken up with one another, and left me to my own meditations. But when we reached my brother's house, and the young gentleman had wished us good morning, my niece, to my great surprise, not only informed me that I was the kindest of uncles, but added that she could not express how much she felt obliged to me for doing gooseberry (Notes and Queries, 20 October 1860). The party thus sanctioning is said to do gooseberry. We confess that, had our correspondent asked for the origin of the phrase, we should have felt at a loss; though very possibly some other correspondent may yet come to our assistance. Others did, pointing out that the expression was a shortened form of gooseberry-picker, meaning a chaperone who, innocently or on purpose, allowed himself or herself to be distracted by something of interest notionally picking fruit - so allowing the young couple to be alone together.

FOCUS CLIMATE ACTION

RESTORING CITIZENS' TRUST

♥he world must change how it tackles the climate crisis. The current approach is too slow and risks falling short of our own targets for limiting global warming and mitigating its impact. And, no longer satisfied with political pronouncements, people are demanding action.

This popular unease is borne out by the European Investment Bank's annual climate survey. Some 75 per cent of European Union citizens, 69 per cent of Britons, and 59 per cent of Americans say they are more concerned about the climate emergency than their governments are. And roughly half of those surveyed say the difficulty in solving the climate crisis is primarily due to government inactivity.

For those of us steering public organisations, these findings should be seen as a dire warning. If citizens stop trusting their governments to do something about climate change, many might conclude that there is no hope and give up. Governments then would face an even tougher task gaining public support for the policies and pro-

grammes that are vital to our future. We cannot allow that to happen. The remedy for a lack of public confidence is to invest massively in concrete climate projects and innovations, starting immediately. Climate action represents a tremendous business opportunity, and policymakers must be savvy enough to embrace it. The upcoming United Nations Climate Change Conference (COP26) in Glasgow will serve as a major test of the credibility of governments' commitment to effective action. The whole world will be watching.

For its part, the EU is leading the way with major commitments, including a pledge to reduce its greenhouse-gas (GHG) emissions by 55 per cent, relative to 1990 levels, by 2030. And as the EU's climate bank, the EIB is at the forefront of this effort, with commitments to support 1 trillion (\$1.16 trillion) of investment in climate action and environmental sustainability by 2030. We are in the critical decade



A recent survey in Europe, Britain, the US, and China finds that most people consider climate change to be the defining issue of this century and expect their governments to do more to address it. Policymakers must respond with investments in the green economy before fatalism sets in

for addressing climate change and biodiversity loss. In all the countries surveyed, large majorities (93 per cent in China, 81 per cent in the EU, 74 per cent in the United Kingdom, and 59 per cent in the United States) consider climate change the biggest challenge of this century. Yet there is a lack of public faith in our chances of meeting current goals. In the EU, 58 per cent of citizens believe their country will fail to cut carbon emissions drastically by 2050, compared to 55 per cent in the UK and 49 per cent in the US.

Does this mean our citizens are resigned to environmental disaster? Not yet. A small majority of EU and British citizens believe a radical change in habits is the best way to counter climate change. But technological innovation will be needed to enable those adjustments, which aligns with the views of survey respondents in the US and China about the best way forward

In any case, investment trumps behavioural change. In 2020, unprecedented pandemic-induced restrictions on mobility and economic activity caused a 5.8 per cent drop in global GHG emissions. That might look like good news, but it's really a measure of just how challenging it will be to achieve similar reductions every

year from now on.

We need a technological revolution, and when it comes, we must be prepared to finance it. Decades of investment in renewable energy have paid off. Wind and solar power are now highly competitive and widespread. If every driver in the EU switched to an electric vehicle tomorrow, EIB mobility experts estimate that existing wind turbines would be able to provide 85 per cent of the electricity needed to power them.

Now, we must scale up gamechanging technologies like green hydrogen and advanced energy storage solutions. With 75 per cent more patents in green digital technologies than the US (and four times as many as China), the EU is a world leader in this field. It also has expertise to share in areas such as renewable energy, climate adaptation, flood control, advanced weather forecasting tools, and resilient infrastructure.

Moreover, one-third of the 2 trillion contained in the NextGenerationEU recovery plan and the EU's next long-term budget has already been committed to the European Green Deal. But, to rise to the challenge, we need a Global Green Deal that can mobilise the private sector's full innovative potential and financial firepower. By

exporting its cutting-edge clean technologies, the EU can be the link between those organising climate action, those pursuing innovation, and those managing eco nomic development. These are the pillars upon which a sustainable global economy will rest.

To be sure, there are potential downsides to the green transition, and addressing them requires immediate action. Those hit hardest by the move away from polluting industries will need to be supported through compensatory investment. As we pursue technological breakthroughs, we must not neglect the need for continuing massive investment in mature climate technology such as wind farms. Similarly, efficiency-boosting investments could make a major dent in the 35 per cent of GHG emissions that comes from build ings – the single biggest energy consumers. And energy system integration (through a single market for energy) would go a long way toward achieving the EU's carbon-neutrality target.

For policymakers, the imperative is to eliminate barriers to investment such as regulatory uncertainty and fragmented mar kets, particularly now that COVID-19 has created additional obstacles such as high private-sector debt. According to the EIB's 2020/2021 Investment Report, 45 per cent of EU firms plan to cut or delay their investment plans because of the pandemic.

The message from this year's climate survey is clear. Governments must act now if they are to retain the good will of their citizens That means making immediate climate investment on a massive scale, with a major emphasis on innovation and the opportunities associated with building a new, reinvigorated economy. Europe with its ingenuity and financial muscle, must be at the center of this global transformation.

breaks pose a risk not just to public health but also to global security. Like nuclear proliferation, terrorism, and climate change, COVID-19 has shown that pandemics can rapidly undermine social stability and economic well-being.

This point may seem obvious now. But before the COVID-19 crisis, infectious disease barely registered on the global security agenda. If efforts to change that by establishing new funding and monitoring mechanisms for pandemic preparedness are to succeed, half measures won't cut it. To avoid a repeat of history, our preparations must reflect the true extent of the challenge. We must recognise that pandemics now represent one of the biggest - and most likely - threats

to global security. Preventing future pandemics will require not only the same level of investment as other global security threats, on which trillions are spent routinely, but also an entirely different way of thinking about global security. The pandemic represents a new form of globalised crisis, one that is both caused and exacerbated by the modern world's interconnectedness.

But we saw something similar in 2008-09, when economies fell like dominoes. That was the first globalised crisis of this century, and we are now coming to grips with what will be the century's defining crisis: climate change.

The common denominator in each case is that the crisis demands solutions that no individual government can provide on its own. An infectious disease cannot be fought with traditional security countertions, bilateral diplomacy, deterrence, or military posturing. Rather, it calls for scientific collaboration. resilient health systems, and longterm investments in global health networks. Shows of force and unilateral acts of national self-preservation are useless. Global collaboration, strategic multilateralism. and transnational compassion are the only way out of this kind of

Judging by the current global distribution of COVID-19 vaccines, we have vet to muster the necessary response. The coronavirus is still winning, and a lack of global cowork together toward common solutions in the face of an unprecedented crisis, key governments are still putting their national interest first, at the expense of the global response we need.

The global solution to the vaccine distribution problem is the COVID-19 Vaccine Global Access (COVAX) facility established last year. By ensuring equitable access to vaccines for people in the poorest countries, COVAX is not only saving millions of lives and protecting hundreds of millions more: it is also offering the best path to recovery. Even from a strictly economic standpoint, COVAX is far more cost-effective than any form

of fiscal or monetary stimulus. There are now more than 1.5 billion vaccine doses being produced each month – an astounding feat less than a year after the first vaccine was approved, and just 18 months into the pandemic. It is predicted that a total of more than 12 billion doses will have been produced by the end of this year. Yet while that is enough to vaccinate every adult on the planet, we are still a long way from doing so, because distribution is so inequitable. Shockingly, only 3.1 per cent of eligible people in low-income countries have received at least one dose, on average,

wrong and dangerously shortsighted. By prolonging the pandemic and allowing more opportunities for the virus to generate new variants, it ultimately harms everyone. But this failure will not be corrected until governments start acting globally. Mustering a genuinely global response is necessary both to end this crisis and to avert the next one.

Globalised crises require that we globalise critical resources - in today's case, vaccines. G20 governments have the power to lead the way by ending the vaccine hoarding and export bans that have impeded supplies, and by donating more doses to COVAX. But as urgent as such measures are, they are mostly band-aids – solutions to a crisis within a crisis. To avoid a repeat of COVID-19, we need more expansive pandemic preparedness mechanisms built around the model of globalised resources that COVAX pioneered. We cannot wait until the next outbreak has already become a global security threat. By that time, it will be too late.

Rap on knuckles

Sir, Transparency and accountability are cornerstones of an effective and responsive government. What will happen if an elected government is loathe to come out with facts or becomes too insensitive to criticisms and questions on a contentious issue that has invaded the private space of its citizens? The Supreme Court wants to know, and perfectly so with regard to the Pegasus snoop issue of 2019. 'National security' was cited by the Centre while it consistently evaded uncomfortable questions and parried the Opposition's inconvenient references. Individuals whose private spaces were breached were not only secretly scrutinised but their social media accounts were hacked. The Centre's reluctance to file a detailed affidavit on the issue has sown seeds of suspicion. The top court has succinctly said that there cannot be a 'free pass' for the government every time it invokes 'national security'. Invasion of privacy, if any, should be quite reasonable and backed by constitutional clauses. The committee put in place by the Supreme Court has been given wide terms of reference. Jajpur, Oct 30: A probe into alleged irregularities in disbursal of loans to farmers at the Primary Agricultural Cooperative Societies (PACS), Markandpur in Jajpur district, has been ordered.

It is alleged that government funds worth lakhs of rupees have been siphoned off allegedly by the secretary of Markandpur PACS by illegally keeping the passbooks of farmers with him instead of returning them.

The matter came to the fore after the deputy registrar, cooperative societies (credit) in Bhubaneswar in a letter (dated-26.10.2021) directed the deputy registrar, cooperative societies, Cuttack II division to conduct a probe and take necessary action. The order was made after a farmer, Ajay Kumar Muduli, affiliated to the PACS, lodged a complaint with the directorate.

The deputy registrar, cooperative societies (credit) has also directed to submit an action taken report to the directorate. This is the second major irregularities taking place in the PACS during last three

According to reports, Muduli had taken a loan of Rs 13,000 for

loan in the name of Muduli and gave him only Rs 10,000

Suspecting foul play, Muduli met the secretary and insisted on giving him back the receipt but the latter refused. Muduli visited the bank and made an enquiry where he found that a loan of Rs 21,600 has been withdrawn from the bank against his name.

On being questioned, the secretary said he will repay the rest of the loan amount and will return all his receipts and loan passbooks once the audit gets completed.

Since then a year has passed, but the secretary is yet to return him the receipts or the passbook. Later, the secretary gave him a new passbook which did not have the signature of the bank supervisor.

It was mentioned that Rs 21,600 had been withdrawn as loan September 19, 2021. It is alleged that the secretary used the old receipts and has mentioned the previous loan to sanction a new loan.

What is more surprising is that the secretary has allegedly collected Rs 1000 from each of the loanee farmers when there is no such provision. Moreover, loans have been sanctioned to the kin of the farmers even if a loan is outstanding on the family.

The secretary has allegedly sanctioned loans in the name of fake farmers who do not have farmland. He has also allegedly sanctioned loans to some of its members by mortgaging their properties which is illegal. Farmers have demanded a special audit into the irregularities allegedly committed by the secretary.

Earlier, the authorities of Markandpur, PACS had siphoned off lakhs of rupees by procuring paddy against the names of four members of a farmer's family. The then secretary and some PACS officials were suspended after the Orissa High Court directed a probe.

Mother & child-care hosp work moves at snail's pace

Kendrapara, Oct 30: As if 134 doctor posts out of total sanctioned posts of 224 lying vacant in Kendrapara district was not enough, steps are also not being taken to strengthen the healthcare infra-

structure in the district.

The slow pace of construction of Mother and Child-care Hospital at Samagudia on the outskirts of Kendrapara town indicates nothing but the district administration's inertia. The under-construction facility is five kilometres from Kendrapara district headquarters hospital (DHH). Its construction work started in December, 2018 and is still going on.

Notably, 5T Secretary VK Pandian during his visit to Kendrapara district in 2019 had directed the district administration to ensure completion of the project within four months. But it did not happen.

Since no review regarding the construction work is being carried out by the district administration, the town residents are critical of it.

Expressing concern, Rashmiranjan Mohapatra, an intelligentsia, said the Kendrapara DHH is not big enough to cater to Obstetrics and Gynaecology department. Treatments of mothers and new-born babies are being carried out in an unsafe and dangerous manner. Keeping this in view, a 100-bed hospital is being constructed at Samagudia. The project was initially scheduled to take off in December, 2016 and its construction period was just two years.

However, its construction work started in 2018 and five years have since passed. It was viewed that

the Mother and Child-care Hospital would go a long way in making the district health department active. But it failed drastically.

Echoing the same, another town resident and member of Mahakalpara Youth Club, Bibhuti Bhushan Rout said since the DHH fails to deliver treatment to mothers and babies, the patients after being misled by middlemen are opting for private hospitals and nursing homes.

There the patients are fleeced in the name of treatment. At the same time, incidents of deaths of mothers and newly-born babies are being reported frequently from these pri-

Citing labour unrest as the main reason for this unusual delay, Amarabara Biswal said the contractor of the Mother and Child-care Hospital has also other construction projects of the district administration in its hand. The projects are being executed through subleases. Labourers stop working for not getting their wages in time.

In this regard, social activist Soumyaranjan Biswal said Kendrapara district is not so financially developed. Demanding proper treatment, the district residents are resorting to strike and agitation. That the district administration paying no heeds is a matter of great concern.

When asked, Sub-Collector Niranjan Behera said, "The work got delayed due to labourer unrest and Covid-19 restrictions. However, after the contractor firm was admonished, the work is now going on at full speed. I had visited the site-Monday. The construction work will soon end.'

Mufti writes to PM over action against students

Srinagar, Oct 30: Expressing shock at the punitive action against some Kashmiri students for allegedly celebrating Pakistan's victory over India in a cricket match, PDP president Mehbooba Mufti wrote to Prime Minister Narendra Modi Saturday and sought his intervention so that their future is not destroyed.

She noted that such punitive actions will only further the sense of mistrust and alienation between the younger generation in Kashmir and the rest of the country, and added patriotism and a sense of loyalty have to be cultivated with compassion.

Her letter to Modi came after medical students living in hostels of the Government Medical College Srinagar and the SKIMS Hospital here were booked under the stringent Unlawful Activities (Prevention) Act and three students from Kashmir studying in Agra were arrested for alleged provocative slogans and social media posts celebrating Pakistan's victory over India in the T20 World Cup match played in Dubai October 24.

"I write to you with a deep sense of disappointment and concern about the alarming situation in Jammu and Kashmir. Not too long

ago when you presided over an allparty meeting in Delhi vou expressed your intention to remove 'dil ki doori' between Delhi and J&K. In my capacity as the President of PDP, I suggested a few confidence building measures that would have provided a sense of relief and breathing space to the people of J&K," Mehbooba wrote

"We had been waiting for the rollout of a policy to address the hearts and minds of people, especially vouth," she said. The PDP president said there were also expectations that Union Home Minister Amit Shah's recent visit to J&K would have led to a meaningful reach-out, especially after his statement about engaging with the vouth here.

'Instead, what followed was shocking and worrying. Protests to continue, says BKU as police remove barricades



New Delhi, Oct 30: After Delhi Police started removing the barricades from the Ghazipur border, farmers protesting at the site for nearly a year against the three contentious farm laws have expressed apprehension that they also might be removed. The Bharativa Kisan Union (BKU) has issued a statement appealing to the farmers to reach the site as soon as possible to strengthen the agitation.

"There is no confusion about the status quo on the border. Protests will continue. There is no change in the strategy of farmers," the BKU said in the statement. "It was the police which had put the barricades after the January 26 incident. Delhi Police is correcting its mistake after farmers gave an affidavit in the Supreme Court that they have not blocked the roads. Farmers in large numbers are present at Ghazipur border."

The BKU appealed to farmers to

reach the site as soon as possible and strengthen the agitation. They said there is a conspiracy against the stir and they will fight it. They are using social media to convey the message. In an appeal to the farmers, the BKU said: "Reach the Ghazipur border and strengthen the agitation. Every day there is a conspiracy against the movement. we have to be ready against every conspiracy." BKU media in-charge Dharmendra Malik said: "Our protest will continue with more vigour. We are appealing to the farmers to reach in large numbers."

The Samyukt Kisan Morcha in a statement said: "Our stand is vindicated. It was the police which had blocked the roads, not us. We had left the space for traffic movement, but the police put up the barricades."

Friday, police were seen removing iron nails that were installed on NH9 at Ghazipur, where hundreds of protesters have been occupying a stretch since November 2020.

Farm fires keep Delhi's air quality in 'poor' category

Stubble burning accounted for 12 per cent of the national capital's PM2.5 pollution

New Delhi, Oct 30: The air quality in Delhi remained poor for the fourth consecutive day Saturday with stubble burning accounting for 12 per cent of the national capital's PM2.5 pollution, government data showed

According to the Ministry of Earth Sciences' air quality forecast agency SAFAR, over 1,800 farm fires were observed in the northwest region of Delhi Friday. The Central Pollution Control

Board's data showed the capital recorded a 24-hour average air quality index (AQI) of 268 An AQI between zero and 50 is

considered 'good', 51 and 100 'satisfactory', 101 and 200 'moderate', 201 and 300 'poor', 301 and 400 'very

poor', and 401 and 500 'severe'.

SAFAR said the air quality is likely to improve to the moderate category on Sunday due to change in the wind direction from northwesterly to south easterly.

The Sub-Committee on Graded Response Action Plan (GRAP) had Thursday directed authorities in Delhi and NCR states to implement measures under the 'very poor' category in addition to steps listed under 'poor' to 'moderate' AQI category under GRAP.

The Graded Response Action Plan is a set of anti-pollution measures followed in Delhi and its vicinity towns according to the severity of the situation that comes into force in mid-October when air pollution levels in the region start worsening.

Srinagar/New Delhi, Oct 30: Kashmiri Apples (tsonth) have been mentioned many times in history, far back as the 7th century when Chinese pilgrim Hieun Tsang sang about the fruit's sweetness. The high-altitude temperate region of Kashmir is known to be the ideal fruit cultivation land. During his reign in the Valley, Sultan Zain-ul-Abidin (15th century) imported many fruit grafts and laid out orchards to grow them. But the historical account of Kalhana in Rajtarangni proves that the cultivation of apples in the Valley is an affair that dates back more than 3,000 years.

King Nara in 1,000 BC asked for the fruit to be grown on roadsides, agricultural land, and forests to provide ample food and shade for the needy. Several wild species of the fruit indicate their antiquity and relationship with the Valley. Today apples are synonymous with Kashmir; the Valley is the apple basket of the world growing 113 varieties of the fruit.

Horticulture is one of the prime industries of the Valley - especially the apple industry, which is a means of income for 55 per cent of the Kashmiri population generating revenue of Rs 1,500 crore annually. The Union Territory administration is focused to set up high-density orchards that accommodate more plants with a better yield variety - Grade-A quality apples.

Many districts have witnessed a change of landscape recently; hun-



dreds of acres of land used by brick kiln makers and paddy fields have been converted to apple orchards to support farmers. The government has helped farmers to set up the plant and infrastructure with a 50 per cent subsidy and free consultations on topics such as cutting, pruning, grading. These farmers are making about Rs 1 lakh per kanal shifting to the apple crop.

To boost the horticulture industry J&K administration is promoting new scientific techniques and methods for the farmers to help them produce this sweet king of the Valley. They are setting up free knowledge centers to educate growers on topics like urea spraying purpose, dosage, and timing, to clear misconceptions on crop diseases, and to bring uniformity in yield. The government has provided for farm machines like tractors and sprayers and trained farmers with marketing and packaging know-how. This has changed the economic profile of the industry.

Besides the economic value, the conversion of paddy fields to highvielding apple orchards has created new job opportunities. A year back the Union government had approved the MIS (Marketing Intervention Scheme) for the horticulture sector which continues to ensure optimum prices to the apple farmers and the needed fillip to the economy. It also provides for insurance cover, thereby stabilizing the farmers' income. As 12 LMT (Lakh Metric Tonnes) of apples can be produced under this scheme, job opportunities for ancillary services like transportation, cleaning orchards, labeling, and categorizing, are also on the rise. The MIS scheme launched in September 2019 was lauded by the apple farmers as it was a ray of hope after disturbances in the Valley following the abrogation

of Article 370.

The facility of cold storage in the Valley has also proven to be a boon for the farmers - losses have been minimized to a large extent. Prices have been stabilized at a handsome range; a 10-kg apple box demands anywhere between Rs 1,000 Rs 1,800, depending upon the quality. Cold storages located at Shopian, Pulwama, Lassipora, and a few other areas of the north, can store

up to 2.5 LMT of apples. Now the apples are directly procured by the National Agricultural Cooperative Marketing Federation (NAFED) from the growers/aggregators at optimum prices and the payment is promptly made to the parties through the bank. With no middlemen, no delayed payments, and reduction of distress sales, farmers can focus tension-free on their orchards. The government has also guaranteed NAFED a sum of Rs 2,500 crore for this process; and the losses, if any, are to be shared equally between the Central Government

and UT administration. Kashmir, despite militant activities and cross-border terrorism has always shown exceptional interest in the fruit business, being the biggest producer and supplier of quality apples for centuries. With the new road projects under the National Highways and Infrastructure Development Corporation Limited, the apple business of Kashmir is only looking to compete for the first position in the world. The convenience of good roads will increase outreach for farmers and boost tourism.

'Pak's ISI pushing terrorists to hit **J&K security posts'**

New Delhi, Oct 30: Following the recent civilian killings in the Kashmir, Pakistan's Inter-Services Intelligence (ISI) is now pushing the terrorists and overground workers, as well as hybrid terrorists, to hit the security forces' camps and posts in the Valley, sources said.

The sources quoting intelligence inputs, have confirmed that the ISI has asked the handlers of terror outfits active in Pakistan occupied Kashmir (PoK) such as Lashakar-e-Taiba, Jaish-e-Mohammad and the newly-floated 'The Resistance Force' to instruct its cadre to hit the security forces' camps and posts

They also said that some heavilyarmed terrorists who might have sneaked into the Valley earlier, may sprawl on security establishments. therefore, extra vigil have been instructed without any laxity.

The ongoing anti-terror operation in Poonch has indicated the preparation level of these terrorist groups, they added.

The sources also said that despite the high security apparatus that have activated in Jammu and Kashmir especially after the recent visit by Union Home Minister-Amit Shah, these inputs are a matter of concern.

PM will be more powerful as Cong not serious: Mamata

Panaji, Oct 30: Trinamool Congress (TMC) supremo Mamata Banerjee Saturday trained her guns on the Congress, saying that Prime Minister Narendra Modi will become more powerful as the grand old party is not serious about politics, and alleged that the country is suffering because that party does not take decisions.

Apparently targeting the BJPled central government, she said she will not tolerate Delhi's 'dadagiri' (bullying) any more. Addressing a group of media persons here on the last day of her three-day visit to the coastal state, where Assembly polls are due early next year, Banerjee, when asked about whether she is in the race for the prime minister's post in the next general elections, said she prefers to be an "LIP-less important person" and a street fighter.

The 66-year-old TMC chief arrived in Goa Thursday evening and held several meetings with local leaders of her party and other politicians. Her party has announced that it will contest all 40 seats in the state, which is currently ruled by the BJP.

Speaking about the Congress, she said, "I cannot say everything right now because they didn't take politics seriously. Modiji is going to be more pow-



erful because of the Congress...If one cannot take decision, why the country should suffer for that?'

"They (Congress) got opportunity (in the past). Instead of fighting against BJP, they contested against me in my state. Don't you think when they contested against me, when they contest my political party in Bengal...," she said. Incidentally, her criticism of the Congress came on the day its leader Rahul Gandhi is also in Goa to kickstart the party's campaign in the state.

Recently, poll strategist Prashant Kishor, who is currently lobbying for the TMC for

the upcoming Goa polls, had said that the BJP will remain at the centre of Indian politics for the next many years irrespective of whether it wins or loses elections. He had also taken a swipe at Congress leader Rahul Gandhi for "thinking" that it is just of matter of time before people throw the BJP away.

When asked about Kishor's statement about the BJP, Banerjee said, "I feel that he has said that if we want to defeat BJP, we cannot do it the way Congress is heading. We have to give a strong fight to BJP." Baneriee said the TMC believes in distributing seats for the regional parties in elections.

No backend talks with **Congress: Amarinder**

Chandigarh, Oct 30: Former Punjab Chief Minister Amarinder Singh Saturday dismissed reports of backend talks with the Congress, saying the time for rapprochement is over and his decision to leave the party is final.

Singh reiterated that he will soon launch his political party and said he wanted to build "a strong collective force in the interest of Punjab". "Reports of backend talks with @INCIndia are incorrect. The time for rapprochement is over. The decision to part ways with the party was taken after much thought and is final. I'm grateful to (Congress president) Sonia Gandhi ji for her support but will not stay in Congress now," tweeted Singh's media advisor quoting the former Chief Minister.

Singh was reacting to some media reports which suggested that some Congress leaders are engaged in backend talks to persuade him to remain in the party. "I will soon launch my own party and will hold talks for seat sharing with @BJP4India (BJP), breakaway Akali factions and others for the Punjab (assembly) elections in 2022 once farmers' issue is resolved. I want to build strong collective force in interest of Punjab and its farmers," Singh said.

Farmers, mainly from Punjab, Haryana and Uttar Pradesh, are protesting at Delhi border points against three central farm laws, which were enacted in September last year, and are demanding these be repealed.

New Delhi, Oct 30: A turnout of 50 per cent to 90 per cent was recorded in three Lok Sabha and 29 assembly constituencies spread across 13 states during by-elections Saturday, with INLD leader Abhay Chautala, who quit the Haryana Assembly in protest against the new agri laws, and Congress' Pratibha Singh, wife of late chief minister Virbhadra Singh, among the prominent candidates in the fray.

The voting passed off peacefully and it was ensured that all COVID-19 safety measures were followed, officials said.

In Himachal Pradesh, Mandi Lok Sabha seat from where Pratibha Singh is contesting saw a turnout of 57.73 per cent. She was pitted against BJP's Khushal Singh Thakur, a Kargil war hero who is trying his luck at the hustings for the first time. The Mandi seat fell vacant after the death of Ramswaroop Sharma (BJP) in March. The first voter of independent India, 104-year-old Shyam Saran Negi, cast his vote at the model polling station of Kalpa in Kinnaur district.

Also, the world's highest polling station at 15,256 feet in Tashigang village recorded 100 per cent turnout despite freezing temperature of minus 16 degrees Celsius with all the 47 registered voters - 29 men and 18 women casting their votes, an election official said.

The polling percentage in Fatehpur, Arki and Jubbal-Kotkhai was 66.2, 64.97 and 78.75 respectively. The by-election in Himachal Pradesh is crucial as Assembly polls are due in the state early next year.

Besides the three Assembly seats in HP, bypolls were held in five assembly seats in Assam, four in West Bengal, three each in Madhya Pradesh and Meghalaya, two each in Bihar, Karnataka and Raiasthan and one seat each in Andhra Pradesh, Haryana, Maharashtra, Mizoram and Telangana.

Out of these, the BJP was holding around half a dozen seats, the Congress had nine, while the rest were with the regional parties. The counting of votes will take place November 2.

In Bihar, an estimated 49.60 per

cent voting was recorded in the

two assembly constituencies of Kusheshwar Asthan and Tarapur which were held by the JD(U). In Meghalaya, the highest voter turnout at 90.63 per cent was

recorded in Rajabala while Mawphlang and Mawryngkneng registered 76.9 per cent and 75.06 per cent polling respectively. In Haryana, 80 per cent voting

was recorded in the by-election to the Ellenabad Assembly constituency, necessitated by the resignation of Indian National Lok Dal (INLD) leader Abhay Chautala as MLA in protest against the Centre's new farm laws.

The Dadra and Nagar Haveli Lok Sabha constituency recorded 75.51 per cent turnout as the voting concluded at 7 pm, Election Commission officials said. Khandwa Lok Sabha seat in Madhya Pradesh, whose MP Nand Kumar Singh Chauhan of the BJP had died, witnessed a turnout of 63.88 per cent, while an estimated 64.60 per cent voting was recorded in the three Assembly seats.

Over 86 per cent voter turnout was recorded in Huzurabad Assembly constituency in Telangana with the ruling TRS, opposition BJP and Congress locked in a triangular contest.

In Assam, 69.60 per cent voting was reported in five assembly constituencies of Gossaigaon. Bhabanipur, Tamulpur, Mariani and Thowra seats till 5 pm.

A high voter turnout of ne 71 per cent was recorded till 5 pm in West Bengal's four assembly constituencies. The BJP and TMC held two seats each.

Barring a few stray incidents, polling, which began at 7 am, passed off peacefully in all four constituencies, an Election Commission official said.

Scuffles between TMC and BJP supporters were reported outside a booth in Khardah and security personnel used batons to disperse the crowd.

1 BJP MLA, 6 rebel BSP MLAs join SP

Lucknow, Oct 30: Seven legislators - one from the BJP and six suspended from the $\ensuremath{\mathsf{BSP}}$ - joined the Samajwadi Party (SP) in Uttar Pradesh Saturday in the presence of Akhilesh Yadav, who hit out at Chief Minister Yogi Adityanath and also claimed the BJP and the Congress "are the same".

The people of the state are so agitated that the BJP will be wiped out in the coming days and Bhajpa pariwar (BJP family) will appear as Bhaagta Pariwar (runaway family)," the SP chief said here while taunting the ruling party over its MLA Rakesh Rathore's desertion and indicating that some others from the BJP were also in touch with him in the poll-bound state.

Those who joined the SP - BJP MLA from Sitapur Rakesh Rathore and BSP rebels Aslam Raini (Shrawati), Sushma Patel (Madiyahon), Aslam Ali (Hapur), Hakim Lal Bind (Handia), Mujtaba Siddiqui (Phoolpur) and Hargovind Bhargava (Sidhauli) - expressed

Thousands of fish die as Arunachal river turns black

Thousands of fish were found dead in the river on Friday at Seppa, the district headquarters, District Fisheries Development Officer (DFDO) Hali Tajo said According to preliminary find-

he said, adding that the sudden change in the colour of the water might be due to a huge landslide in the upper belt of the district.

"There may be other reasons as well. The state government should immediately constitute a fact-finding committee to study the situation at the earliest." he said.

The Siang river at Pasighat in East Siang district turned black in November 2017. The then Congress MP from Arunachal East Ninong Ering wrote to Prime Minister Narendra Modi, seeking his intervention, claiming that it was the result of the construction of a 10,000-km-long tunnel in China, which diverted water from Siang to Xinjiang province in the-Taklamakan desert. China had denied the allegation.



US, E3 warn of Iran's N-programme

Rome, Oct 30: President Joe Biden said Saturday that nuclear talks with Iran would resume while he and a trio of European allies warned that Iran has "accelerated the pace of provocative nuclear steps" after they met to align strategy for the negotiations aimed at trying to bring Iran and the US back into compliance with the 2015 nuclear accord.

Biden and the leaders of Germany, France and Britain — known as the E3—met at a pivotal time as Iran continues to enrich uranium to near-weapons-grade levels. The leaders are trying to revive the 2015 deal and restore Iran's program to where it was under the pact, which kept the Islamic republic at least one year away from the potential to field a nuclear weapon.

In a joint statement following the meeting with Germany's Angela Merkel, France's Emmanuel Macron and Britain's Boris Johnson, the four leaders "expressed our determination to ensure that Iran can never develop or

acquire a nuclear weapon.

The leaders also said they shared "our grave and growing concern" that Iran "has accelerated the pace of provocative nuclear steps" after it halted negotiations on a return to the nuclear agreement, formally known as Joint Comprehensive Plan of Action (JCPOA). They also warned that Iran's nu-

tions on international monitoring by the International Atomic Energy Agency "will jeopardize the possibility of a return to" the deal. As the leaders posed for photos be-

fore their closed-door talks. Biden was asked when he would like the stalled negotiations with Iran to resume.

'Thev're scheduled to resume he said, in what appeared to be the first public confirmation by the US of a resumption in negotiations. Iran has yet to commit to a date

G-20 opens with call for more vax for poor nations

Ttaly's Premier Mario Draghi opened a conference of the world's powerhouse economies with a sharp call to pick up the pace in getting vaccines to poor countries, calling the gaping global COVID-19 vaccine gap "morally unacceptable".

Draghi, the host for the two-day Group of 20 summit in Rome, said Saturday that only 3% of people in the world's poorest countries are vaccinated, while 70% in rich countries have had at least one shot.

The call for more collective help for low-income countries sounded a theme running through the summit, which faces a global economy recovering at different speeds. Climate change, vaccines, the recovery, international taxation are all themes occupying leaders holding their first in-person summit since the pandemic took hold.

Draghi welcomed the Group

of 20 heads of state to Rome's Nuvola cloud-like convention center in the Fascist-era EUR neighborhood, which was sealed off from the rest of the capital. Saturday's opening session was focused on global health and the economy.

Rich countries have used vaccines and stimulus spending to restart economic activity, leaving the risk that developing countries that account for much of global growth will remain behind due to low vaccinations and financing difficulties

European Union leaders will meet off-site with African leaders in efforts to further support the continent's poorest economies in the wake of the COVID-19 pandemic. French President Emmanuel Macron told reporters Friday he expects the G-20 to confirm an additional \$100 billion to support Africa's economies.

Three protesters were killed and dozens injured — several by live rounds - as security forces opened fire in several locations, a doctors' union said.

The coup, condemned by the international community, has threatened to derail Sudan's fitful transition to democracy, which began after the 2019 ouster of long-time autocrat Omar al-Bashir. Since then, the military and civilian leaders have governed in an uneasy partnership.

Pro-democracy groups had called for protests across the country Saturday to demand the re-instating of a deposed transitional

government and the release of senior political figures from deten-

The United States and the United Nations had warned Sudan's strongman, Gen. Abdel-Fattah Burhan, that they view the military's treatment of the protesters as a test, and called for restraint.

Burhan has claimed that the transition to democracy would continue despite the military takeover, saying he would install a new technocrat government soon. But the pro-democracy movement in Sudan fears the military has no intention of easing its grip, and will appoint politicians it can control.

Saturday's large turnout is bound to increase pressure on the generals who face condemnations from the US and other Western countries to restore a civilian-led government.

The demonstrations were called by the Sudanese Professionals' Association and the so-called Resistance Committees. Both were at the forefront of an uprising that toppled longtime autocrat Omar al-Bashir and his Islamist government in 2019. They are also calling for the dismantling of paramilitary groups and restructuring of the military, intelligence and security agencies.

All three protesters killed Saturday were shot in Omdurman. One was shot in his head, another in his stomach, and a third in his chest, the Sudan Doctors Committee and protesters said.

Army shelling sets 160 homes ablaze

Bangkok, Oct 30: More than 160 buildings in a town in northwestern Myanmar, including at least two churches, have been destroyed by fires caused by shelling by government troops, local media and activists reported Saturday.



The destruction of parts of the town of Thantlang in Chin state appeared to be the most extensive so far in the ongoing struggle between Myanmar's military-installed government and forces opposed to it. The army seized power in February from the elected government of Aung San Suu Kyi, but has failed to quell the widespread resistance.

Human rights groups and UN Experts have recently warned that the government is planning a major offensive in the country's northwest, including Chin state, along with the regions of Magway and Sagaing. Residents of the rugged area have a reputation for their fierce fighting spirit, and have put up stiff resistance to military rule despite being only lightly armed with single-shot hunting rifles and homemade weapons.





MSMEs hit by NPAs in state

Bhubaneswar, Oct 30: Amid a dying demand in the post-pandemic period, the micro, small and medium enterprises (MSMEs) sector of Odisha witnessed an alarming increase of bad loans during the first quarter of current financial year.

According to the report of The State Level Bankers Committee, Odisha (SLBC), the non performing assets (NPAs) of MSMEs sector stood at 10.12% as of June 30, 2021 compared to 8.55% NPAs during the same period of previous fiscal

The experts said that NPAs in MSMEs sector has increased due to the closure of many industries during Covid-19. The experts also suggested that the state government and bankers should jointly form committees and mentor MSMEs who have taken loans to tackle the situation.

The banks have targeted to dis-



₹41,324.43 to the MSMEs, including Khadi & Village Industries and others under MSMEs, in current financial year. The set target is hiked by 35.68% compared to previous fiscal.

As of June 30, 2021, the banks have disbursed around ₹8978.16 crore to the MSMEs, covering 21.73% of the total target. As per the SLBC Odisha report, the total NPAs stood at ₹13,645.17 crore as of June 30, 2021, increased from ₹11,339.37 crore as of March 31, 2021.

The report suggests that the NPAs of the state as on Q1 ending is 7.20%, which is inclined at a higher side and represents alarming situation in the state. There is a rise in bad loans of Odisha as compared to the quarter ending March 2021 where the NPA percentage was at 6.22%

ket regulator SEBI has warned billionaire Anil Agarwal's Vedanta Ltd for executing ₹1,407 crore of related-party transactions without prior approval of the audit

In a warning letter, which Vedanta as per SEBI directions disclosed to stock exchanges, the regulator said it will take action if such actions were repeated in future. The mining conglomerate's independent auditors had in the firm's annual report for fiscal year 2020-21 flagged related-party transactions.

"With regard to the qualified opinion in respect of the company executing related party transactions worth ₹1,407 crore without prior approval of the audit committee, the company has submitted that the said transaction was ratified later (after a period of about 47 days)," SEBI said in the October

Without disclosing the nature of the transaction, the company stated that the transaction was done at an arm's length and in or-

dinary course of business. "In this regard, attention may be drawn to Regulation 23(2) of SEBI (LODR) Regulations, 2015, which states that all related party transactions shall require prior approval of the audit committee," SEBI said. Accordingly, the submission of the company that the transactions

were done at arm's length distance is not tenable. On the auditor's observation over delay in disclosure of the outcome of board meeting of October 3, 2020, the company submitted that the delay was due to unforeseen circumstances and that it will en-

Dubai, Oct 30: Virat Kohli will be facing the most defining test of his captaincy career as he expects his men to be the proverbial 'phoenix rising from the ashes when India take on a street-smart New Zealand in a 'do-or-die' ICC T20 World Cup Super 12 game here

Having endured a nightmare last Sunday against Pakistan, a match that they would like to forget in a hurry, India have a lot of course correction to do against the Kiwis, more so in getting the roles assigned for the players right.

In the decider, the duo led 6-6, but Takahashi started to dominate the proceedings and soon eked out an 11-6 advantage at the break, with Sindhu going to the net and the Japanese producing a down-theline smash.

Takahashi rode on her attack to gather points easily, leading 14-9. The Japanese set up the points well and closed them out with attacking returns on both flanks. With Sindhu unable to rein in her errors, Takahashi grabbed a massive nine-point match points. The Indian saved one before the Japanese sent one down the line to shut the doors on her fancied rival.
