Covaxin safe, shows 77.8% efficacy: Lancet

NEW DELHI/HYDERABAD: Two doses of Covaxin, India's indigenous Covid-19 vaccine, offer 77.8 per cent protection against symptomatic disease and present no serious safety concerns, according to an interim analysis of its phase 3 trial published in The Lancet Friday. Covaxin, an inactivated whole virus vaccine developed by Hyderabad-based Bharat Biotech, recently received emergency use approval from the World Health Organisation (WHO) for people aged 18 and above. The phase 3 trial findings indicate that Covaxin induces a robust antibody response with no severe vaccine-related adverse events or deaths reported among the trial participants, the authors of the study said. The majority of the adverse events, including headache, fatigue, fever, and pain at the injection site, were mild and occurred within seven days of vaccination, they explained.

Army okays PC to eligible women after **SC** warning

New Delhi, Nov 12: Threatened with contempt action against the Indian Army and its Chief Manoj Mukund Naravane by the Supreme Court over non-compliance of its earlier orders, the defence force agreed Friday to grant Permanent Commission (PC) to all of its eligible women officers.


"We are holding the Army guilty of contempt of court. We are putting you on guard. Since you have not complied with our orders you will have to face the consequences The Army may be supreme in its own authority but this Constitution court is also supreme in its own jurisdiction," the apex court said

The Army had initially said that out of the 36 Women Short Service Commission Officers (WSSCO) in the force, who have filed the contempt petition, it has granted PC to 22 officers while 14 were not considered fit including three on medical ground.

After the top court's warning, the Army informed a bench of Justices DY Chandrachud and AS Bopanna that it will grant PC to all the eligible women officers.

The bench asked Additional Solicitor General Sanjay Jain and advocate R Balasubramanian, appearing for the Army, whether the 11 officers who were left out (except for three on medical ground) had met the 60% marks criteria and whether they have disciplinary and vigilance clearance or not as per the courts criteria laid March 25, this year.

New Delhi. Nov 12: The National Commission for Protection of Child Rights (NCPCR) has asked the Kalahandi Superintendent of Police to conduct a probe into the allegations of sexual exploitation of girls in Sunshine Public School and submit a report

Significantly, the Commission noted that Gobinda Sahu, president of school management committee of Sunshine Public School and the prime accused in the sensational Mamita Meher murder case, allegedly exploited minors sexually in the school.

The NCPCR has asked the SP to submit a copy of the FIR, statements under Section 164 CrPC, ac-



tion taken against the accused and total number girls/boys studying in the school and their age group. The Commission has also asked the SP whether the case was registered under the POCSO Act.

"These sexual activities were done inside a separate room by Gobinda Sahu. He used to tempt the girls for good marks in examination and Minister of State for Home Dibya Shankar Mishra used to visit the school frequently. Girls as well as boys were targeted in the activity of exploitation," the Commission noted.

Gobinda Sahu has been arrested for allegedly killing lady teacher Mamita Meher. The Opposition parties have been demanding action

Home for his alleged links with the accused. The Odisha Youth Congress submitted a memorandum to President Ram Nath Kovind Friday demanding a fair probe into the murder of Mamita Meher.

The Congress party held a sixhour 'hartal' in the state Friday demanding the sacking and arrest of the Minister of State for Home, who is in the eye of the storm for his alleged closeness with Gobinda Sahu.

The 'hartal' began at 6 am amidst tight security and was by and large peaceful with no report of any untoward incident during the day, police said. All non-BJD parties supported the 'hartal'.

has achieved another milestone in the ongoing Covid-19 vaccination drive by administering over 4 crore doses till Friday.

"Happy to share that Odisha has crossed a new milestone by completing 4 crore #COVID19 Vaccination. All thanks to the combined efforts of the Health team and the people of #Odisha," the Health and Family Welfare Department said in a tweet.

The vaccination programme was started in the state January 16, 2021 and is now going on speedily in the state, especially in rural areas. The drive is going on at 2,088 vaccination centres across the state, of which 2.055 are government facilities and 33 private hospitals.



As per data available in the CoWIN portal, as many as 4,00,44,233 doses have been inoculated in Odisha till Friday evening. While 2,67,14,868 people in the state have received their first dose, 1,33,29,365 have been fully vaccinated.

Moreover, 2,22,25,462 people in the age group of 18-44 years have received the jab till now while 1,08,77,902 in the 45-60 age group and 69,40,869 beneficiaries aged above 60 years have also got the vaccine.

Bijay Panigrahi, Health and Family Welfare Director, said the state government has set a target to administer the first dose of vaccine to all by the end of December.

"Earlier, the vaccination programme was carried out at 1.600 centres which was later increased to 2,400 centres across the state. The majority of such centres are in rural areas," said Panigrahi. He said that 40 per cent of the eligible beneficiaries in the state have received both doses, while 82 per cent have received the first dose.

New Delhi, Nov 12: Electronics engineer Siddharth Pandey will become a millionaire after the country's biggest ever public issue, but he says he had to overcome his father's opposition to join fintech firm Paytm when it was a fledgling

Many, like Pandey, will become dollar millionaires when the company lists next week. Those rewards are huge in a country where the per capita income is below \$2,000. Pandey, now 39, is no longer with the company and is working at another start-up that he declined

But he says his seven-year stint at Paytm left him with tens of thousands of shares. He declined to give details, but the shares were priced at ₹2,150 apiece Friday.

Pandey said he would be worth more than \$1 million. "My dad was very demotivating. He said, 'What is this Paytime?'," Pandey told Reuters, referring to the time he joined Paytm in 2013. "For once work in a company

Bureaucratic inertia dogs tourism sector; big push needed

Bhubaneswar, Nov 12: The tourism sector in Odisha, despite its immense potential, is languishing because of bureaucratic lethargy and inefficiency.

Several ambitious projects of the Tourism department, intended to attract huge tourist footfall, are yet to see the light of the day.

Though the state government is allocating more funds to the Tourism department in every budget, execution of many projects has been delayed due to inefficiency and callousness of the officials concerned, sources said.

Shamuka Beach Project in Puri is a classic example of bureaucratic inefficiency. The state government had launched Shamuka Project at Sipasarubali in Puri in 2015 to attract tourists from across the country and abroad to the Holy City.

The government had planned to et up luxury hotels, golf courts and many other recreational facilities on 972 acre land as part of the mega project. In the initial phase, ₹120 crore was sanctioned to develop basic infrastructure at the project site. However, the project has been hanging fire for last six years. Similarly, the ropeway projects at

Kapilash in Dhenkanal and Dhauli in Bhubaneswar are yet to be completed. "There was no significant development in tourism sector in last three decades. Callousness and $in efficiency \, among \, the \, officials \, can \,$ be blamed for the poor state of affairs in tourism sector," said a retired official of Tourism department.

The outbreak of Covid-19 pandemic has also thrown spanner on the development of tourism sector in Odisha. Tourist inflow to the state has gone down by 70 per cent since March 2020. The pandemic has taken a heavy toll on the livelihood of people associated with the sector, sources said.

This apart, the Odisha Tourism Development Corporation has set up Nimantrana restaurant in Bhubaneswar to serve Odia cuisines to the people. "With the arrival of winter, places like Puri, Gopalpur, Konark, Chilika, Paradip, Daringibadi and Koraput have seen a rise in tourist footfall. Online booking for eco-retreats is getting good response. The tourism sector will bounce back if the pandemic situation remains under control," said an official of the Tourism department.



SUM Hospital installs premier CBC analyser

Bhubaneswar, Nov 12: The Institute of Medical Sciences and SUM (IMS & SUM) hospital here has taken a major leap in the field of laboratory haematology by becoming the first hospital in eastern region to install state-of-the-art fully automated CBC analyser with complete systemisation.

The new acquisition is the fourth such installation in the country, said Rajesh Kumar Bhola, Associate Professor in Department of Pathology and in-charge of Laboratory Haematology in the hospital.

The Sysmex XN 3111a analyser, the latest equipment in the field, has the technology to help systemisation in blood counts which includes running CBC, making slides and staining them using the reflex rule, viewing them under an automated digital microscope and classifying the abnormality, he added.

"The major addition to systemization of CBC in IMS and SUM hospital is the digital pathology Cella Vision. When implemented it speeds up and simplifies the microscopy slide review process while delivering more standardised results," the doctor said.

The analyser can do stem cell count too which can help in bone marrow transplantation process.

The equipment was unveiled Friday in the presence of SOA Vice-Chancellor Ashok Kumar Mahapatra, Dean of IMS and SUM Hospital Gangadhar Sahoo, Medical Superintendent Pusparaj Samantasinhar, Deputy Medical Superintendent Rajesh Lenka, Head of Pathology Debahuti Mohapatra, and Director of SUM Central Lab Rajashree Panigrahy.

Odisha logs 263 new Covid cases, 3 deaths

Bhubaneswar, Nov 12: Odisha Friday reported 263 fresh Covid-19 cases, eight less than the previous day, with the tally rising to 10,44,962, a Health department official said.

The death toll rose to 8,373 as three more persons - two from Khurda and one from Mayurbhanj - succumbed to the disease in the last 24 hours, he said.

So far, 53 other Covid patients have died due to comorbidities, the Health department official added. Khurda district, which comprises the state Capital At least 308 more patients recuperated from the highly infectious disease in the last 24 hours, taking the total number of recoveries to 10,33,652

14 more MRF centres for waste mgmt in City

Bhubaneswar, Nov 12: The Bhubaneswar Municipal Corporation (BMC) will add 14 more material recovery facility (MRF) centres to facilitate segregated waste management in a scientific manner.

The march of the civic body in the direction of segregated waste management is supported by micro composting centres (MCCs) and MRFs, said the civic body sources. Initially, 41 MCCs and 10 MRFs were planned but 14 more MRFs have been added to the new plan recently.

Based on the load of dry waste on a daily basis, Commissioner Sanjay Kumar Singh has instructed to construct more number of MRFs. Till now four MRFs are completely functional, civil construction of eight are over and that of the remaining is in process.

In MRF, recyclable materials like cardboard, glass, plastic materials, clothes, leather, shoes and other materials are segregated for processing. The materials are pressed in the belling machine to be handed over to certified recyclers of State Pollution Control Board. Besides, there are weighing

remaining is in process machine and napkin incinerators in each unit.

completely functional,

Five Swachha Karmis from rag pickers' group are engaged in each MRF. They support in segregation of recyclable materials and get a monthly incentive of Rs 7,000.

Out of 24 MRFs planned to cater to the needs of 67 wards, 10 will be in North Zone and seven each in South East and South West Zone respectively. The capacity of each would be 10 tonne per day.

Recent global warming unprecedented in 24k yrs: Study

he speed of human-caused global warming over the last 150 years is faster than anything observed since the last ice age which was about 24,000 years ago, a recent study revealed.

A team led by researchers at the University of Arizona, US, also verified that the main drivers of climate change since the last ice age are increasing greenhouse gas concentrations and the retreat of the

The study, published recently in the journal 'Nature', suggested that a general warming trend over the last 10,000 years, settling a decade-long debate in the paleoclimatology community as to whether this period trended warmer or cooler.

The researchers found that the magnitude and rate of warming over the last 150 years far have surpassed the magnitude and rate of changes over the last 24,000 years. "This reconstruction suggests

that the current temperatures are unprecedented in 24,000 years, and also suggests that the speed of human-caused global warming is faster than anything we've seen in that same time," said Jessica Tierney, an associate professor at the University of Arizona, and coauthor of the study.

'The fact that we're

method is not a perfect thermometer, but it's a starting point. Computer-simulated climate models, on the other hand, pro-

vide temperature information based on scientists' best understanding of the physics of the climate system, which also is not perfect, they said. The team combined both the methods to harness the strengths of each.

"To forecast the weather, meteorologists start with a model that reflects current weather, and then add in observations such as temperature, pressure, humidity, wind direction, and so on to create an updated forecast," Tierney said. The team applied this same idea to past climate.

"With this method, we are able to leverage the relative merits of each of these unique datasets to generate observationally constrained, dynamically consistent and spatially complete reconstructions of past climate change," Osman added.

The team is now working on using the method to investigate climate changes even farther in the past.

Chilling hub closed, farmers suffer



Chhendipada: About 2,500 dairy farmers of Chhendipada block in Angul district are facing hardship as the lone milk chilling centre here is lying nonfunctional. The Odisha State Cooperative Milk Producers Federation (OMFED) has set up the chilling centre with a capacity of 1,000 litre at the block headquarters. Farmers tagged to 16 cooperative societies sell over 1,200 litres of milk. The money thereof was credited to their respective accounts within 10 days. However, for some reasons, the payment was stopped and the outstanding money ran up to over Rs2 lakh. While farmers are yet to receive their payments, the chilling centre is also lying closed for a year now even though its renovated building was inaugurated three months ago. In this regard, the affected farmers had met Sambalpur MP Nitesh Gangdeb. When contacted, quoting the District Collector, Gangdeb said the centre would soon be made functional. Wrong blood transfusion kills woman at RG hospital

Rourkela, Nov 12: A 25-year-old woman died after she was administered a wrong blood type at Rourkela Government Hospital (RGH) in Sundargarh district.

The incident that occurred November 11 speaks volume of medical negligence. The deceased patient's family members have lodged a complaint at Raghunathpalli police station.

According to a source, Sarojini Kak, a resident of Budakata village under Kutra block, was a sickle cell patient. Her family members had to rush her to Rourkela Government Hospital after she fell treatment at bed no-158 of the medicine ward.

She was administered a B+ blood at 11:30 am November 11. Her sister Anjana Kak alleged that Sarojini was given a wrong blood type. "After coming to know that a B+ blood had been administered. I went through my sister's previous records and found that her blood type was O+. Though I brought the attention of doctors and staff to this negligence, they took it casually. The negligence claimed my sister's life," she alleged.

Meanwhile, the police have already initiated a probe into the incident. At the same time, the RGH authorities have formed a fivemember team to probe the allegation. RGH director Dr Santosh Kumar Swain said a five-member team will find out the veracity of the allegation. If it is proved true, action will be taken, he added.

399 PMGSY roads nowhere near completion

CHIEF ENGINEER OF THE PMGSY HAS ORDERED FRESH TENDERS FOR INCOMPLETE PROJECTS

Jajpur, Nov 12: The state and the central governments have emphaised on rural connectivity under the Pradhan Mantri Gram Sadak Yojana(PMGSY), but nearly 400 road projects under this scheme have remained incomplete even 15 years after commencement of their construction, a report said.

This miserable progress of the rural road connectivity has been reported from 13 rural development circles in the state. According to reports, 399 PMGSY roads are ito to be completed.

Of them, 308 projects had been taken up in the first phase while 91 others were in the second phase.

In Angul RD circle, two projects sanctioned in 2006-7 have not been completed.

As many as 124 PMGSY road projects have been stuck midway in Sunabeda RD circle comprising Malkangiri, Nabarangpur, Rayagada and Koraput districts. It was stated that negligence on part of contractors and officials of the RD department is responsible for inordinate delay in the projects.

Crores of rupees are being pumped into these projects to boost rural connectivity in inaccessible areas, but the scheme seems to have failed to achieve its objective in the pockets where road projects



are hanging fire, it was alleged.

In some cases, it was seen that due to substandard work, many road projects are in bad shape in just two or three years after their completion. Expressing concern on the inordinate delay of these projects, the chief engineer of the RD department(PMGSY) has directed the officials of these RD circles to complete the projects by November 31. The PMGSY projects are meant to provide good and motorable roads to villages with a population of 1000 each. The PMGSY is being executed by the rural development department of the state government.

It was alleged that unholy nexus between engineers of the department and contractors has scuttled in-time completion of these projects. For example, the 2.01-km road from Aman to Ambatota and another 6-km road from Khaliberna to Nuagaon in Angul RD circle have been left halfway by the contractors even though their work was started 15 years ago.

Babus may soon run medical colleges in MP

uring the height of the COVID-19 wave last year, the Gujarat government deployed top IAS and IPS officers who held a degree in medicine to tackle the pandemic in the worst-affected areas. The move to use officers with administrative as well as medical skills worked well for the state given the emergency-like situation.

However, a proposal by the Madhya Pradesh government to appoint IAS officers to run 13 medical colleges in the state has not been welcomed by the doctors. While senior babus of the Health Department have dismissed such reports, the state Medical Education Minister Vishwas Sarang has been cautious while saying that the proposal is being studied and a decision will be taken only after careful consideration.

The death of four infants in a fire at a Bhopal hospital recently has focused attention on the state hospital administration. Chief Minister Shivraj Singh Chouhan has been pressed into ordering a fire safety audit of all government and private hospitals in the state. Additional Chief Secretary for Health and Education Mohammad Suleiman is conducting a high-level probe and the report will be submitted to Chief Secretary Iqbal Singh Bains soon.

However, the medical community fears that such appointments will not improve the conditions of medical colleges in the state but rather make matters worse.

Sanjiv Chaturvedi wins his day in court

Embattled Uttarakhand whistleblower Sanjiv Chaturvedi, who is a 2002batch Indian Forest Service (IFoS) officer, currently posted as the Chief

Conservator of Forests in Haldwani, has won a skirmish in his larger battle with the Centre after the Uttarakhand High Court overruled the order of the Central Administrative Tribunal (CAT) in December last year.

Last year Chaturvedi, who is a

Magsaysay Award recipient and crusader against corruption, had filed a petition in the Nainital bench of CAT alleging that the lateral recruitment of joint secretary-level posts through the contract system was "arbitrary, irrational and ridden with irregularities" and needed to be probed. He also challenged the 360-degree system for the appraisal of babus. The tribunal however transferred the hearing of the petition from the Nainital Bench to the principal bench in Delhi. The High Court has said it saw no reason for the case to be transferred since all benches are equal and it cannot be suggested that the principal bench in Delhi is a superior bench.

Much of Chaturvedi's career has been spent in courts or battles with various state governments and the Centre. He was a whistleblower in the forestry case in Haryana and later in the capital when he was the Chief Vigilance Officer of AIIMS where he exposed several financial scams. Currently, he is probing the alleged role of forest officers in illegal construction and felling of trees in the Jim Corbett Tiger Reserve. He has now won his day in court, but his battles will continue.

MEA gets busy with new postings

Foreign policy wonks see in the recent major reshuffle of diplomatic postings as a precursor to the retirement of Foreign Secretary Harsh Shringla early next year. At this early stage, it is not clear whether Shringla who has worked long and fruitfully with External Affairs Minister S Jaishankar will retire or be given an extension. Such decisions are usually known only close to the D-Day. In terms of seniority though, the current High Commissioner to the UK, Gaitri Issar Kumar is in line to step up. But, these days nothing can be taken for granted, as Jaishankar himself knows too well. The current round of postings is focused on the Middle East region. Pavan Kapoor who is ambassador to the UAE will now be our ambassador to Russia. Kapoor has been replaced by Sanjay Sudhir, who was the High Commissioner in the Maldives, Our man in Oman Munnu Mahawar replaces him. Meanwhile, Dinesh Patnaik, who was director-general of the Indian Council for Cultural Relations (ICCR) is the new ambassador to Spain and Secretary Consular Passports and Visas Sanjay Bhattacharya is likely to become our envoy to Switzerland. There will likely be more churning at the MEA in the weeks and months ahead, so watch this space for updates.

■ Carnage

arnage derives from Latin caro, meaning flesh or meat, which was the Csource of the medieval Latin carnaticum for the slaughter of animals and for the meat that resulted. In particular it referred to the ration of flesh that tenants had to provide to their feudal lords. This word moved through Italian and French to appear in English as the figurative term carnage. It was introduced by Philemon Holland early in the seventeenth century, to evoke an image of the bloody butcher's shop transferred to the hand-to-hand hack and slash of the battlefield. He employed it in translations of various Latin and Greek authors, but it was only taken up by other writers many years later. Some other words derived from caro are obvious enough, like carnivore for a meat-eating animal; carrion for the dead flesh of animals; and charnel house, a place in which dead bodies were placed. But would you put that attractive flower the carnation in the same group? One theory is that it was named in the sixteenth century because its flowers were a pink that reminded people of the colour of flesh. But it might just be linguistic confusion, as it had earlier had the name coronation, perhaps because it had been used in chaplets or because its flowers looked like little crowns.

his year's United Nations Climate Change Conference (COP26) in Glasgow has brought a marked shift in focus from the responsibilities of governments to the power of the private sector. If national governments cannot find a way to reconcile their interests and commit to collective action, can the private sector pick up the slack?

This is not merely a question of how much difference individual or coordinated emissions reductions by firms would make, though the answer is probably significant. Rather, it is a question about the potential of the market. Can it be harnessed to deliver the crucial public good of rapid and large-scale emissions reductions?

Lack of financial capital is unlikely to be a problem. Mark Carney, the UN Special Envoy for Climate Action and Finance, made a splash at the meeting by announcing a commitment of \$130 trillion toward the goal of reaching net-zero greenhouse-gas emissions. This eye-watering sum is to be made available by the Glasgow Financial Alliance for Net Zero (GFANZ), a coalition led by Carney that includes some 450 financial institutions accounting for 40% of the world's assets

But this financial commitment raises its own set of questions. Most obvious, how will the money be spent? Will efforts adequately and fairly reflect the interests of the global population – consumers, workers, savers, and investors alike?

In considering these questions, we should take note of another, possibly even more significant development at COP26. Erkki Likannen, Chair of the Trustees of the International Financial Reporting Standards (IFRS) Foundation, announced the formation of the International Sustainability Standards Board (ISSB), which will focus, first and foremost, on climate-related disclosure. This is a big step forward because, as Peter Drucker famously said, "What gets measured gets managed."

The IFRS Foundation issues financial accounting standards that more than 140 countries require. These form the basis for countries' domestic reporting rules; have over the years become the lingua franca of global capital markets.



Whether the market system can be harnessed to deliver the crucial public good of rapid and large-scale emissions reduction remains to be seen. But the creation of a new accounting-standards board focused on climate-related disclosure certainly improves the odds

The reason is simple: clear standards ensure that information is transparent, comparable, and thus useful for analysts, auditors, investors, lenders, regulators, and company managers.

In this sense, the evolution of common reporting standards has been vital to the globalisation of capital markets—a trend that has left a growing share of the world's commercial enterprises subject to the discipline imposed by freely moving private capital. And yet, that discipline currently does not extend to climate-related factors.

Companies are both perpetrators and victims of environmental degradation. They will be affected by the consequences of climate change, such as increasingly frequent and severe extreme weather events, and by government action to reduce emissions and protect or restore the environment.

Yet, as it stands, we do not know exactly how high those costs would be – or how much a given company's activities are affecting the environment – because there is no common system for reporting on the relevant variables. Even from a purely financial point of view, this is a serious problem. These climate and climate-policy-related variables represent major risks, but without consistent, comprehensive reporting, those risks cannot be measured, much less mitigated. That is where the ISSB

comes in. Admittedly, the body's remit is ambitious. It will be global from the start and provide standards covering an immensely complex set of indicators. Of course, there is no alternative: measuring climate-related risks is not a straightforward task, and the challenge seems especially daunting in view of the fact that current financial-reporting standards evolved over many years.

Nonetheless, there is reason to hope the ISSB can deliver.

The ISSB will establish a global "baseline" of minimum standards that companies must meet in reporting on climate-related risks. This baseline will enable investors to compare such risks across companies globally. The ISSB standards will not establish metrics that are related to prescriptive public policies, which most likely will be country-specific. If a country has a particular target or policy in place, it can be added as an additional requirement. The key here is to ensure that local requirements will not lead to an entirely different reporting structure, but instead be additive.

Governance will also be integral to the ISSB's success. Experience has shown that too much top-down direction can stunt the evolution of standards. That is why the IFRS Foundation has established a three-tiered system of governance, comprising a moni-

toring board made up of representatives of capital-markets authorities from around the world, a board of independent trustees, and the International Accounting Standards Board (IASB), an independent standard-setting body. National standard-setters, multilateral organizations, and private companies contribute to the standard-setting process via several advisory committees.

The creation of the ISSB reflects a novel mix of bottom-up and top-down initiatives and the convergence of a diverse range of organisations and individuals. It could not have happened without the path-breaking work of the many actors that understood that capital markets needed sustainability standards. These organizations - the Value Reporting Foundation and the Climate Disclosure Standards Board in particular - defined the first reporting concepts and partly succeeded in securing their adoption by companies. The Task Force of Climate-Related Financial Disclosures and the World Economic Forum also contributed important work.

But while these efforts got the ball rolling, they led to a patchwork of standards and metrics that were confusing to companies and may have enabled greenwashing. Combining these initiatives into a single shared framework required a top-down approach led by a credible authority. Regulators, international organisations, and governments encouraged the IFRS Foundation to take on this role, owing to its strong track record as a standard-setter

for financial reporting.

The creation of the ISSB is exactly what the emergence of climate-related financial standards needed. And the pragmatic mix of top-down and bottom-up initiatives, together with action by a "coalition of the willing," that made it possible may have lasting significance for the world's broader efforts to deliver public goods.

ethane traps 28 to 80 times more heat and causes more warming of the Earth. Large amounts of methane are emitted from agriculture and animal husbandry. The fields of paddy are flooded with water and the oxygen in the water is soon depleted. Subsequently, the leaves etcetera below the water begin to ferment and emit methane. Methane is also emitted by livestock during digestion as well as during fermentation of the dung. The leaves, twigs and carcasses flowing into the reservoirs of large hydropower projects settle at the bottom and ferment and emit methane.

methane.

It is, however, possible for India to reduce methane emissions while promoting economic growth. For example, paddy fields can be intermittently flooded with water instead of flooding them continuously. The short dry period will reduce fermentation and the fresh water will bring in oxygen. The yield will not be affected, while water will be saved and methane emissions will be reduced. The second example is from animal

husbandry. We can reduce methane emissions by promoting breeds that emit less methane.

We had a large number of *gobar* gas plants. The methane emitted during fermentation of the dung got trapped, was burnt in stoves and got converted into less harmful carbon dioxide. The supply of cheap LPG has led to the end of *gobar* gas plants. We must also promote vegetarian diet. More methane is produced in the conversion of feedstock into meat.

The government is making large hydropower projects like Polavaram in Andhra Pradesh and Lakhwar Vyasi in Uttarakhand. These projects will produce electricity at a cost of ₹8 per unit or more. Methane emissions from these projects can be avoided and electricity can be produced at ₹4 per unit if the same money is invested in solar and wind power generation. The government can promote these alternatives and attain both higher economic growth and lower methane emissions.

The price at which water is supplied to the farmers must be increased and sold to them accord-

to move from continuous to intermittent flooding. The price of LPG must be increased so that it becomes profitable for the farmers to produce gobar gas. Tax must be imposed on all meats so that vegetarian diet is promoted. Large hydropower projects must be abandoned or subjected to high tax to promote solar power. These taxes will surely lead to increase in the price of rice, LPG, meat and hydroelectricity. However, the revenue earned from these taxes can be distributed to the citizens of the country through direct cash transfer. The additional payments made by the consumers in the form of these "methane" taxes will be returned to them. Let us say the government collects ₹1,000 crore as methane tax on water used for flood irrigation of rice. This will be paid @ ₹25 per person by the 40 crore citizens who consume rice. Then, the government makes cash transfer of this ₹1,000 crore @ ₹7.40 per person to our 135 crore citizens. The result will be that those who consume rice will pay ₹25 and get ₹7.40; while those who do not

ing to volume to encourage them

consume rice will not pay any amount and get a bonanza of ₹7.40. This will encourage people to move from methane-emitting rice to other crops.

Similarly, let us say the government collects ₹1.000 crore as methane tax on LPG. This tax will be paid by the 40 crore citizens who use LPG. They would pay ₹25 per person. Then the government makes cash transfer of ₹7.40 per person to all the 135 crore citizens. The result will be that those who consume LPG will pay more, while those who use gobar gas will get ₹7.40. In this way we can move towards a low-methane economy without affecting the welfare of the people and also promote economic growth. The caveat, of course, is that these methane taxes should be used to make cash transfers to the people and not used for paying yet higher salaries to the government servants or other government consumption.

Poshan scheme

Sir, "PM Poshan scheme" is good news to lakhs of underprivileged children who are struggling to overcome anaemia and malnutrition. India is one of the very few countries that provide its school-going children one nutritious meal a day. Nearly 12 crore children belonging to government and government-aided schools will benefit from the massive scheme that proposes to run till 2026. The earlier mid-day meal scheme was a reasonable success but suffered due to hiccups in effective implementation owing to corruption. Children's health is at stake when substandard food materials are used to prepare food. An incident in an Uttar Pradesh school, in 2019, where roti was served with salt as a "meal" had made headlines compelling the Centre to totally overhaul the mid-day scheme. The direct beneficiary Scheme (DBT) hopes to take care of this; money will directly be transferred to the school account. Also, the complaints of cooks and helpers, about delayed remuneration, may be taken care by the DBT. Since Poshan is ambitious about taking care of the nutritional aspect of children, the Centre's decision to appoint a nutritional expert to each school is just. Weight, height and body mass index (BMI) can provide an overall health picture of a school kid so that any lag in milestone can be taken care of. Despite all precautions, dishonesty and lethargy may push the Poshan back; making audits mandatory at every school is a step in the right direction. Prajapati gets life term for rape

Lucknow: Former Uttar Pradesh minister Gayatri Prajapati from the previous Akhilesh Yadav-led government, and his two accomplices have been sentenced to life on charges of gangrape. Strongly contesting the ED plea, Deshmukh's lawyers Vikram Chaudhri and Aniket Nikam said that the former minister appeared before the ED voluntarily and even agreed to be in ED's extended custody though he had been granted judicial custody last week. Arguing before Special Judge H.S. Satbhai, they guestioned why the chargesheet was filed without arresting dismissed cop Sachin Vaze, the prime accused, who played a key role but remains 'accused only on paper.

Drugs-on-cruise: Court grants bail

Mumbai: A special court here Friday granted bail to Mohak Jaiswal, who was arrested by the Narcotics Control Bureau (NCB) in the drugs-on-cruise case in which Bollywood actor Shah Rukh Khan's son Aryan is one of the accused. V V Patil, special judge for cases under the Narcotic **Drugs and Psychotropic** Substances (NDPS) Act cases, allowed Jaiswal's plea after hearing extensive arguments. Jaiswal was one of the seven persons including Aryan Khan whom the NCB had apprehended on October 2 before boarding the cruise ship.

Suicide bomber among three militants killed

Srinagar, Nov 12: Three militants, including a 'fidayeen' (suicide bomber), were killed in two separate encounters in Jammu and Kashmir, police said on Friday, taking the number of ultras killed so far this year to 133.

A 'Mujahideen Gazwatul Hind' militant who was assigned to carry out a 'fidayeen' (suicide) attack in Srinagar was killed, while a Hizbul Mujahideen (HM) district commander was among the two ultras slain in an encounter in Kulgam, the police said.

As many as 133 militants, including several top commanders, have been killed this year so far, they said. The 'fidayeen' militant was a relative of one of the accused in the February 2019 Pulwama suicide attack in which 40 CRPF personnel were killed, police said.

A police spokesman said acting on a specific input about a possible terrorist attack and the movement of terrorists in the Bemina area of Srinagar, a checkpoint was established on Thursday to thwart such evil designs. "In the meantime, terrorists attacked a checkpoint established near Bund Bemina which was retaliated leading to an encounter," he said.

In the ensuing gunfight, one terrorist of proscribed terror outfit Mujahideen Gazwatul Hind was killed and his body was retrieved from the site of the encounter, the

Digital evidences recovered from his mobile show that he was prepared by terror outfit for fidayeen attack," the spokesman said.

The officials also said that he used to change his locations fre-

New Delhi, Nov 12: Claiming that the Congress leadership nurses a "pathological hatred" for Hinduism, the BJP Friday said it is at Rahul Gandhi's behest that leaders such as Salman Khurshid, Shashi Tharoor and P Chidambaram have targeted the religion.

Why Ghaziabad continues to be India's most polluted city?

New Delhi, Nov 12: Ghaziabad's Air Quality Index (AQI), which has been reeling under 'severe' category since Diwali, continued to remain at the same level, i.e., at 488 on Friday as well, data from Uttar Pradesh Power Corporation Ltd (UPPCL) showed. Ghaziabad recently topped the list of the most polluted cities in India. However, this has not happened for the first time. In 2020 and 2019 too, the city stood at a similar position, not just nationwide, but on a global scale.

But what is the reason behind it and what are the simplest of the measures that could be taken to

ensure an improved air quality? "Cities like Delhi, Noida and Ghaziabad are most polluted because they are located in the Indo-Gangetic plain and as the winter season approaches, emissions from various activities such as biomass burning etc. gets trapped as the inversion layer comes down and the wind becomes very calm.

"Moreover, the impact of fire counts further deteriorates the overall air quality of this particular region, as it falls in the way of the winds that transport stubble emissions," said Gufran Beig, Founder and Project Director of the System of Air Quality and Weather Forecasting and Research (SAFAR).

The additional contribution of pollution from local sources like transport, bio-fuel and industries further worsens the already stagnant atmosphere," Beig added.

Health Organization (WHO) had released a report on the world's most polluted cities, wherein 22 of the world's 30 most polluted cities were reported to be in India with In March this year, the World Ghaziabad as the second most polluted city in the world behind Hotan

In 2017, the city reeled under the 'severe' category for eight consecutive days from November 9 to 16. Since then, it has become one of the worst affected cities by air pollution in India at this time of the year. According to Central Pollution Control Board (CPCB) data, the monitoring stations in Ghaziabad are running high on PM2.5 -- a primary pollutant.

At 3 p.m. on Friday, the AQICN of World Quality Index project, a non-profit body, recorded an AQI of 259 at Sanjay, and 330 at Vasundhara.

Meanwhile, the air quality in Noida, which had shown some improvement on Thursday after reeling under the 'severe' category since Diwali, again turned 'severe'

on Friday morning. Not only that. Ever since the Graded Response Action Plan (GRAP) measures came into effect on October 16, Ghaziabad has been the most polluted city in the country on seven days -- October 16, 29, November 1, 2, 6, 10 and 11,

A DELHI COURT HAS FRAMED CHARGES OF MURDER, RIOTING, AND CRIMINAL CONSPIRACY AGAINST 4 ACCUSED FOR ALLEGEDLY KILLING A MAN DURING THE RIOTS LAST YEAR

New Delhi, Nov 12: Calling it a calculated attack, a Delhi court has framed charges of murder, rioting, and criminal conspiracy against four accused for allegedly killing a man during the riots here

Anwar Hussain, Kasim, Shahrukh, and Khalid Ansari are accused of allegedly murdering a man named Deepak by beating him mercilessly near Ambedkar College February 25, 2020. He died due to hemorrhagic shock, as per the post mortem report.

Additional Sessions Judge Amitabh Rawat framed charges under requisite sections against the accused persons and explained it to them in vernacular in the presence of their lawyers, to which they pleaded not guilty and claimed trial in the case.

The judge said, "By the manner of their mobilization and intent as construed from their conduct, the said unlawful assembly can be said to have conducted itself for riots and other offences like the murder of deceased Deepak, in the prosecution of their common object.

"The conspiracy is also writ large by the calculated attack on the victim by the unlawful assembly," he said in an order dated



November 9. The judge said that the most important witness in the case was one Sunil Kumar, who was an evewitness to the entire incident and gave a complete picture as to how the deceased Deepak was killed by the "armed Muslim mob consisting of accused persons."

As per the court order, Sunil had stated, "On February 25, one Muslim unlawful assembly coming from Kardampuri Pulia and shouting Allah Ho Akbar was trying to cross the Pulia Gokulpur. The said armed unlawful assembly caught hold of Deepak who was mercilessly beaten.'

Under the Code of Criminal Procedure (CrPC), an accused should be informed of the offence under which he is charged. The basic purpose of the charge is to let them know of the offence that they are charged with so that they can prepare a defence.

New Delhi, Nov 12: Vehicles accounted for more than 50 per cent of Delhi's pollution during the early phase of this year's winter, from October 24 to November 8, according to an analysis by the green think tank Centre for Science and Environment (CSE)

The CSE study released here today is based on real-time data on source contribution from the Decision Support System for Air Quality Management of the Indian Institute of Tropical Meteorology (IITM) in Pune

"The analysis clearly shows vehicles' contribution is half or more. This is followed by household pollution (12.5-13.5 per cent), industry (9.9-13.7 per cent), construction (6.7-7.9 per cent), waste burning and road dust (each varied between 4.6-4.9 per cent and 3.6-4.1 per cent, respectively)," it said.

The Decision Support System of IITM is part of the Air Quality Early Warning System and provides information on the potential emission sources in Delhi. New Delhi, Nov 12: A 97-year-old Indian veteran whose leg was blown off in Italy in World War II has won a battle for a bigger pension that was previously denied to soldiers injured before independence

Sepoy Balwant Singh was one of more than 2.5 million soldiers from British India who took part in the six-year war, fighting for the Allied forces across Europe, Africa



Nearly 90,000 were killed - among them Singh's older brother Jaswant who died in Italy - and around 35,000 others were injured.

Singh, from the northern state

of Rajasthan, was drafted into the British Indian Army's Punjab Regiment in 1943 and nearly killed by a landmine in Italy the following year. After two months in a military hospital he was sent back

He was discharged from military service in 1946 on a general disability pension of 20 rupees that gradually increased to 7,000 rupees (\$94) over the subsequent seven decades.

The Indian government in 1972 decided to grant an additional war

injury pension to soldiers hurt or disabled during battles since 1947 when India gained independence, but not before.

Singh filed a plea with the Armed Forces Tribunal in 2010 under the Indian Army's War Injury Pension scheme to increase his annuity and have his services in World War II recognised.

The tribunal in New Delhi this week ruled in his favour, more than doubling his monthly payout and awarding him back payments, although only back to 2008.

Why rising Covid cases in Europe is a worry for Kerala

EUROPE SAW A SIX PER CENT INCREASE IN NEW INFECTIONS LAST WEEK COMPARED WITH THE **WEEK BEFORE, AND A CORRESPONDING** 12 PER CENT RISE IN DEATHS

Kochi, Nov 12: The rising curve of Covid-19 infections in European countries, especially among fully vaccinated people there, can be worrying for a state like Kerala, where breakthrough infections are spiking each day, said a member of the state's expert panel.

Germany, whose 67.2 per cent population is fully inoculated, reported over 50,000 cases Thursday, the highest since the beginning of the pandemic. UK, one of the worstaffected countries in Europe in terms of Covid fatalities, has also been reporting in excess of 35,000 cases this week

Europe saw a six per cent increase in new infections last week compared with the week before, and a corresponding 12 per cent rise in deaths. The WHO said Europe was at a 'critical point' and could be seeing a spurt in cases due to 'uneven vaccine coverage' and pre-

mature relaxation of restrictions. Dr Anish TS, a member of the expert committee advising the Kerala government on Covid-19, said, "It is worrying for us because Kerala is more epidemiologically similar to the European countries than other Indian states. What's happening there could have similar results here. Why (cases are rising) in Europe is an important question. Is it because the effects of the vaccines are waning? Or since it's winter there right now, there will be more closed interactions. It could be because of such social factors, we still don't know it yet. So it's certainly alarming

But the last seroprevalence survey conducted in Kerala, which pointed to antibodies among 82 per cent of the population, offers hope, he said. "It's clear that we cannot drop our guard right now. But



we hope to tide over (any possible) wave," he said.

In Kerala, 95.3 per cent of the eligible population has got the first dose and 56.1 per cent both doses of the Covid vaccine. In terms of vaccination per million populations in the country, Kerala occupies the top spot, claimed health minister Veena George.

But the trend of increasing breakthrough infections each week in the

state holds on. On Thursday, a whopping 47 per cent of the new cases were found among those who had taken both doses of the vaccine. Another 20 per cent had taken the first dose and 31 per cent were reported to be unvaccinated. However, declining hospitalisation and demand for oxygen and ICU beds in the state suggests that vaccines are proving to protect those infected from serious repercussions.

The health department said that of the 74,976 cases reported between Nov 3 and Nov 9, only 1.7 per cent of them needed oxygen beds and 1.4 per cent ICU beds.

"Almost all the breakthrough infections are not very severe. Comparatively, death rates are low. Such data is very consistent with that from European countries. In other Indian states, breakthrough infections are perhaps not being captured, it may be very mild so that the (health) system doesn't capture it. That may be one reason. The second reason is natural infections are quite high in other states. So it will be a sterilising kind of immunity where there will be no infections at all. Those who have been infected with the Delta variant of the virus once may not get infected again at all," said Dr Anish.

"If you look at the pattern of sterilising immunity, the prevalence of it is quite low in Kerala.

The sero-prevalence study has data on that. In Kerala, more people have immunity via the vaccine, so they are more prone to breakthrough infections.'



UP hospital accused of putting 'dead' man on ventilator

Moradabad (Uttar Pradesh), Nov 12: In a shocking incident the attendants of a dengue patient have alleged that a private hospital in Moradabad put the ailing man on a ventilator "even though he was dead" in a bid to extort

In the video that has gone viral, the attendant is heard purportedly saying that the family members were told that their patient was alive and put on a ventilator. However, one of them managed to get into the hospital ICU and found that the patient was lying dead with the machines shut.

The clip also shows vacant chairs, indicating that no hospital staff was present in the area. Moradabad health department officials said the purported charges levelled in the video will be probed.

The management of the Bright Star Hospital where the alleged incident took place have denied the allegations.

Mukesh Kumar, chief operating officer (COO) of the private hospital, said, "Two critical patients, who were suffering from dengue, were admitted in the hospital with no pulse rate and no blood pressure. They were already critical and, in such cases, survival is almost impossible. Thus, they succumbed to illness.

The hospital was in the news a few months ago when 15 Covid patients had died within 24 hours, allegedly after the facility ran out

It was claimed that the students' test booklets and OMR sheets had gotten mixed up due to the carelessness of invigilators.

Solicitor General Tushar Mehta, appearing for NTA, submitted that answers of the students will be matched with the correct question booklets and added that if the direction to conduct NEET UG re-exam is provided, it will become a pattern.

The Centre told the top court

that every year students will come forward and seek a re-exam for one mistake or the other. The counsel appearing for students contended that they lost precious time during the exam due to the mix up and not answer all questions. However, a bench of justices L. Nageswara Rao and B.R. Gavai said the court sympathises with the students and completely understands their plight, but cannot order re-examination for them.

The Centre had moved the top court against the high court. In the previous hearing, the apex court had stayed the Bombay High Court order, which held up declaration of results. The high court had directed the NTA to conduct re-exam for two candidates by conducting a separate NEET examination be fore declaration of results.

Climate talks enter last stretch

Glasgow, Nov 12: A new draft agreement drawn up for the last scheduled day of the UN climate conference in Glasgow Friday presses countries to reach higher in their plans to tackle global warming but also tries to balance the demands of richer and poorer nations.

While retaining a central demand for countries to set tougher climate pledges next year, the draft uses weaker language than a previous one in asking them to phase out subsidies for the fossil fuels that are the prime manmade cause of global warming.

Leading philanthropies wish to support the signatories of the UN Framework Convention on Climate Change as they take responsibility for climate change impacts by providing quick-start finance for a prospective new facility to support vulnerable countries most hit by the losses and damages resulting from climate change.

CPC hails Jinping as China's 'helmsman'

Beijing, Nov 12: China's ruling Communist Party Friday hailed President Xi Jinping as its "helmsman", a honorific title reserved for party founder Mao Zedong, saying that he has emerged an "anchor" for the party and a "backbone" for the nation, as he geared up for a record thirdterm and beyond.

The Communist Party of China (CPC), which has monopolised political power since the People's Republic was founded in 1949, also attacked American President Joe Biden and asserted that democracy was not an "exclusive patent" of the US and the West.

Defending party's decision to enhance Xi's status as core leader. Jian Jinguan, Director of policy research of the CPC, told a press conference here that for a party with 95 million members and the country with 1.4 billion people, "it will be unimaginable had there not been a core of the party".

It will result in a "lack of cohesion and nothing can be accomplished," Jian said. President Xi, 68, is also the General Secretary of the CPC and the Chairman of the Central Military Commission.

The Plenum of the CPC which wrapped up its four-day closed door meeting Thursday, adopted a land-

mark resolution to cement Xi's "core" status in the country's political history and cleared the decks for him to extend his rule for a record third term next year and perhaps beyond.

The resolution - the only third of its kind in the party's 100-year history after one issued under party founder Mao and his successor Deng Xiaoping - was reviewed and adopted at the sixth plenary session of the 19th CPC Central Committee attended by over 400 senior party officials.

US journalist Danny Fenster jailed for 11 yrs in Myanmar

The court found him guilty of spreading false or inflammatory information, contacting illegal organisations and violating visa regulations

Bangkok, Nov 12: A court in military-ruled Myanmar Friday sentenced US journalist Danny Fenster to 11 years in prison with hard labour, the maximum penalty under three charges, despite calls by the United States and rights groups for his release.

It was the harshest punishment yet among the seven journalists known to have been convicted since the military ousted the elected government of Nobel laureate Aung San Suu Kyi in February.

Fenster, the managing editor of the online magazine Frontier Myanmar, is still facing additional terrorism and treason charges under which he could receive up to life in prison.

Fenster wept after hearing the

sentence and has not yet decided whether to appeal, the lawyer said.

The harsh penalty is the ruling military's latest rebuff of calls from around the world for a peaceful end to Myanmar's political crisis. The government is refusing to cooperate with an envoy appointed by Southeast Asian governments to mediate a solution, and has not bowed to sanctions imposed by the United States and several other Western countries.

"It's clear that Danny is being made an example of, and what it shows is that the junta do not care what the international community thinks. They would do as they want, and this is one example of how they are basically showing the international community that they cannot be held accountable," said Manny Maung, Myanmar researcher for the New York-based group Human Rights Watch.

The army's takeover was opposed by widespread peaceful protests that were put down with lethal force. Security forces killed more than 1,200 civilians and arrested about 10,000 others, according to the Assistance Association for Political Prisoners. Armed resistance has since spread, and UN experts and other observers fear the incipient insurgency could slide

into civil war. Fenster was detained at Yangon International Airport May 24 as he was about to board a flight to go to the Detroit area in the United States to see his family.

Pak played disruptive role in Afghan: CRS

Washington, Nov 12: Pakistan has long played an active and, by many accounts, disruptive and destabilising role in Afghan affairs, including through the provision of support to the Taliban, a latest Congressional report on

In the report, which has been prepared by independent subject area experts, the bipartisan Congressional Research Service (CRS) said that if other countries such as Pakistan, Russia, China, or US partners such as Qatar move towards greater acceptance of the Taliban, it could isolate the United States, weakening

its leverage and giving the Taliban greater opportunities to evade or counter the US pressure.

Most immediately, a more punitive US approach could exacerbate the already dire humanitarian conditions in Afghanistan with uncertain implications for Taliban rule and regional dynamics.

Pakistan has been trying to convince the world to diplomatically engage with the Taliban after they seized control of Kabul August 15. However, the international community is still sceptical about the hardline Islamists, especially on issues like terrorism emanating from the war-torn country and their promises to respect human rights.

The report stated that the acceptance of a Taliban government that acts to secure some US national security interests (such as combatting ISKP) while not governing democratically or protecting human rights could also pose a difficult, if familiar, challenge for US policymakers.

Biden picks former FDA chief Califf to _ again lead agency

Washington, Nov 12: President Joe Biden Friday is tapping former Food and Drug Administration commissioner Robert Califf to again lead the powerful regulatory agency, according to a person familiar with the decision.

Califf's nomination comes after months of the concern that the agency near the center of the government's Covid-19 response has lacked a permanent leader. More than a half-dozen names were_ floated for the job before the White House settled on Califf.

Biden is to make the formal announcement later Friday, said the person familiar, who spoke on the condition of anonymity to preview the announcement. A cardiologist and clinical trial specialist. Califf served as FDA commissioner for the last 11 months of President Barack Obama's second term. Before that, he spent one year as the agency's No. 2 official after more than 35 years as a researcher at Duke University, where he helped design studies for many of the world's biggest drugmakers. Since leaving the government, he has worked as a policy adviser to tech giant Google, in addition to his ongoing work at the Duke Clinical Research Institute



Covid's epicentre again: Europe faces fresh reckoning

London/Milan, Nov 12: Europe has become the epicentre of the pandemic again, prompting some governments to consider re-imposing unpopular lockdowns in the run-up to Christmas and stirring debate over whether vaccines alone are enough to tame Covid-19.

Europe accounts for more than half of the average 7-day infections globally and about half of latest deaths, according to a Reuters tally, the highest levels since April last year when the virus first swept into Italy.

The fresh tumult comes as successful inoculation campaigns have plateaued ahead of the winter months and flu season. About 65% of the population of the European Economic Area (EEA) - which includes the European Union, Iceland,

Liechtenstein and Norway - have received two doses, according to EU data, but the pace has slowed in recent months.

Take-up in southern European countries is around 80%, but hesitancy has hampered rollout in central and eastern Europe and Russia, leading to outbreaks that could overwhelm healthcare. Germany, France and the Netherlands are also experiencing a surge in infections, showing the challenge even for governments with high acceptance rates and dashing hopes vaccines would mean a return to close to normal.

To be sure, hospitalisations and deaths are much lower than a year ago and big variations by country in use of vaccines and boosters as well as measures like social distancing make it hard to draw conclusions for the whole region. DON'T TAKE EYE OFF THE BALL'



Brazil beat Colombia, qualify for World Cup

Sao Paulo, Nov 12: Brazil are celebrating as the first South American team to qualify for the World Cup in Qatar — with several matches in hand and more than a year before the tournament begins in Qatar.

South American football body CONMEBOL says Brazil as the first team of the region to qualify, with 11 wins in 12 matches. The latest came Thursday night here, with Lucas Paqueta scoring the only goal in the 72nd minute in a 1-0 win over Colombia.

The Selecao are 18 points ahead of fourth-place Chile, which can add only 15 points from its five remaining matches. The top four teams in South America earn direct entry to the World Cup.

Paqueta's goal came after Marquinhos found Neymar in the middle of the Colombia defense. Neymar quickly passed to Paqueta, who beat goalkeeper David Ospina with a low crossed shot that ended in the right corner of the Colombian goal. It was one of the few opportunities created by Brazil during

the match.

Brazil sealed their qualification by giving coach Tite his 50th win along with 12 draws and five defeats. Tite took over Brazil in the middle of qualifying for the World Cup in Russia in 2018.

Also Thursday, third-place Ecuador beat last-place Venezuela 1-0 with a goal by Piero Hincapie and Chile had a key 1-0 victory at Paraguay thanks to an own goal by Antony Silva after a corner kick.

Brazil have 11 wins in 12 matches - their match with second-place Argentina in September was bizarrely suspended after seven minutes of play because of concerns from authorities over breaches of COVID-19 protocols. FIFA has not yet decided whether

it will be replayed. Ecuador (20 points) follow their two major rivals in South American qualifiers, with Chile, Colombia and Uruguay tied with 16 points. The Chileans skip ahead for now on goal difference. The fifth-place team in South American qualifiers goes into an intercontinental playoff for a spot in Qatar.

Russia laid down a marker with a 6-0 demolition of Cyprus and Croatia responded with a 7-1 hammering of Malta with two goals from Lovro Majer.

If Croatia are to qualify automatically for next year's tournament in Qatar, it will need to be the first team to beat Russia under new coach Valery Karpin. His team has conceded just once in six games under Karpin. **GROUP J**

Germany have already qualified for the World Cup and cruised to a 9-0 win against Liechtenstein after early concerns for midfielder Leon Goretzka when he was struck in the head and neck by an opponent's boot.

Goretzka was fine, and the incident led to an early red card for Liechtenstein, and a penalty to start the scoring. Leroy Sane and Thomas Müller finished with two goals each and there were two owngoals. Marco Reus had a goal and three assists to his name.

Birmingham, Nov 12: India will face Australia in the opening match when women's cricket makes its debut at the 2022 Commonwealth Games July 29 while the final will be played August 7, the event organisers announced Friday.

Women's cricket is making its debut at the Commonwealth Games with the T20 format. The last time cricket was played in the multisporting showpiece was in the 1998 edition in Kuala Lumpur.

"The women's cricket T20 competition will be held at the Edgbaston Stadium from July 29, with the bronze and gold medal matches taking place August 7,"

said the ECB in a statement.

The first match on the schedule will see Australia take on India in the early session July 29 followed by Pakistan playing Barbados, who were recently confirmed as the team from the West Indies that

will take part in the competition. Other highlights on the schedule include India against Pakistan July 31. Australia will also take on Pakistan August 3.

Hosts England will be in action for the first time July 30, when they will take on the winner of a qualifying tournament which is due to take place at the start of 2022. They will then play South Africa in the early session August 2, followed by a third match against



New Zealand in the evening session August 4.

Seven out of eight qualifiers for

the T20 competition were announced back in April with the final team set to be finalised at the end of January 2022.

ICC Acting Chief Executive Geoff Allardice said: "We have seen tremendous growth of the women's game over the past few years and the Commonwealth Games will undoubtedly be another major moment on that journey.

"Today's announcement of the match schedule gives fans lots to look forward to, not least with the opening game between ICC Women's T20 World Cup 2020 finalists Australia and India and we know that Edgbaston will provide a great stage for the competition.

The schedule for netball was also announced Friday. The announcement of the match schedules for the two team sports comes just a few weeks before tickets for Birmingham 2022 are expected to go on general sale.

Matt Kidson, Director of Sport for Birmingham 2022, said: "Not surprisingly we have already sold thousands of tickets for both the netball and cricket T20 sessions through our ticket ballots...

"But we know that some fans have been waiting to find out the details of the match schedules before choosing which sessions they want to attend, so we're expecting these sports to sell quickly, when ticket sales go live.
