5kg free foodgrains till March

NEW DELHI: The Union Cabinet Wednesday approved a proposal to extend distribution of 5kg foodgrains per month for free under the Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY) to over 80 crore ration card holders for four months till March 2022, a decision that will cost an additional ₹53,344 crore to the exchequer. Free foodgrains under the PMGKAY scheme, which was announced in March last year to provide relief to poor people during the COVID pandemic, is over and above the normal quota provided under the National Food Security Act at a highly subsidised rate of ₹2-3 per kg.

The birth of the republic unclasps almost all the

colonial bonds that kept the tiny island tied to England since 1625

London, Nov 24: Barbados, a former British colony, will next week ditch Queen Elizabeth as Head of State, breaking its last remaining imperial bonds with Britain nearly 400 years since the first English ship arrived at the Caribbean island. Barbados casts the removal of Elizabeth II, who is queen of

Barbados and 15 other realms in-

cluding the United Kingdom, Australia, Canada and Jamaica, as a sign of confidence and a way to finally break with the demons of its colonial history.

This is the end of the story of colonial exploitation of the mind and body, said Professor Sir Hilary Beckles, a Barbadian historian. He said this was a historic moment for Barbados, the Caribbean and all post-colonial societies.

The birth of the republic, 55 years to the day since Barbados declared independence, finally unclasps almost all the colonial bonds that have kept the tiny island in the Lesser Antilles tied to England since an English ship claimed it for King James I in 1625.



It may also be a harbinger of a broader attempt by other former colonies to cut ties to the British monarchy as it braces for the end of Elizabeth's nearly 70-year-old reign and the future accession of Charles, who will attend the republican celebrations in Bridgetown. Barbados's move is the first time a realm has removed the queen as

head of state in nearly 30 years Mauritius, an island in the Indian Ocean, proclaimed itself a republic but remained in the Commonwealth, an association of mostly former British colonies which is home to 2.5 billion people.

Originally populated by waves of Saladoid-Barrancoid and Kalinago migrants, Spanish slaver raids forced Amerindians to flee. Barbados was unpopulated when the English first arrived.

The English initially used white British indentured servants to toil on the plantations of tobacco, cotton, indigo and sugar, but Barbados in just a few decades would become England's first truly profitable slave society.Barbados re ceived 600,000 enslaved Africans between 1627 and 1833, who were put to work in the sugar plantations, earning fortunes for the English owners.

Barbados under English colonial rules became the laboratory for plantation societies in the Caribbean, said Richard Drayton, a professor of imperial and global history at Kings College, London who lived in Barbados as a child.

It becomes the laboratory for slave society, which is then exported to Jamaica and the Carolinas and Georgia after that.

More than 10 million Africans were shackled into the Atlanticslave trade by European nations between the 15th and 19th centuries.

Bhubaneswar, Nov 24: From witnessing unseasonal floods to increasing frequency in cyclones, climate change has affected one and all on the globe. There have been numerous talks at different levels, including summit meetings, on how to protect this fragile planet from imminent extinction. This and many other aspects of climate change were dissected at a conclave here Wednesday.

The event 'Youth Conclave on Climate Change' was organised by leading daily Dharitri, on the occasion of its 48th birth anniversary. The event saw participation by various stakeholders such as young climate activists and those

were on the panels. Split into two sessions, the event was moderated by Sujit Mahapatra, founding volunteer of Bakul Foundation and independent journalist Sampad Patnaik.

The event began with the welcome speech by Adyasha Satpathy, chief executive of Dharitri and Orissa POST. She said Dharitri has

always given importance to youth and environment. Talking about the background of the conclave, she said the youth conclave has been organised to drive consciousness on climate change at local level.

Monika and Nick shared their experiences on climate change and how it is being observed in different parts of the world. "Prior to my working in India, I was in Papua

New Guinea where I had witnessed the impact of climate change when a rise in sea levels affected the island dwellers massively. Irrespective of quality of education children will be deprived of schools due to cli-mate change," Monika said.

Speaking along the same lines, Nick mentioned that in past many civilizations have been destroyed completely due to climate change factors. "Eight out of 10 warmest summers were received in the UK this year. Moreover, it's not just about hot temperatures but about ferocious weather patterns observed all across the globe," he said. Soumya, 24, said he has been

witnessing the impact of climate change in his village from his childhood. "During every cyclone we have to evacuate from the area. It is important that safety of the marine ecosystem should be given paramount importance for the survival of people living in coastal areas," Soumya mentioned.

Pradeep Jena said Odisha is one of the first states to start acting on climate change action plan. "Over last 20 years we witnessed around nine major cyclones. After Super Cyclone, we faced Hudhud, Fani and Phailin which showed something serious is happening,' he added.

In the second session Archana, 26, a member of the UN Secretary General's Youth Advisory Group on Climate Change, spoke vividly on the role of women in climate change. Archana talked about why it's necessary to empower women to lead as they can bring the change in all walks of life and make a difference on climate change.

Sharing his expertise, IMD chief Mrutyunjaya Mohapatra said Odisha with its unique topography is a gateway of cyclones. "The intensity of cyclones, lightning, heat waves is increasing in the state. While rural and tribal communities are worst affected by climate changes, an increasing number of flash floods and water-borne diseases in urban dwellings has affected us. Detection and forecasting of the same is important."

Highlighting on the issue, water activist Ranjan panda said people react to big incidents such as cyclone but the constant rise in sea levels which has devastating effects on coastal habitats in the state is usually getting unnoticed.

Concluding the sessions, Tathagata Satpathy, Editor of Dharitri, said while detection and forecasting of drastic climate events are an important step in preserving life and property we should think a step beyond saving lives and make goals that would conserve and preserve our environment in the long run.

BJP men hurl eggs at CM's convoy; Cong condemns attack

Puri, Nov 24: BJP supporters Wednesday hurled eggs at the convoy of Chief Minister Naveen Patnaik in Puri Wednesday, protesting against the government's "inaction" in the Kalahandi teacher's kidnap and murder case.

The incident happened near the Government Hospital Square when Naveen was returning to Bhubaneswar after attending the foundation stone laying ceremony for the ₹331-crore heritage corridor project in the Temple City.

Despite tight security, the Bharatiya Janata Yuva Morcha (BJYM) supporters suddenly came up and hurled eggs at CM's convoy from outside the barricade, sources said. The BJP activists also showed black flags as Patnaik's cavalcade passed by.

Earlier, three members of BJPbacked BJYM and Congress-affiliated NSUI were taken into custody for waving black flags at Patnaik on Bada Danda (Grand Road) in Puri, sources said.

"Our activists under the leadership of Jayant Das have hurled eggs, targeting the Chief Minister's convoy. This protest will continue till Patnaik takes action against some of his tainted ministers," BJYM state president Irasish Acharya told reporters in Bhubaneswar.

Later, the opposition activists sprinkled cow-dung water on the Grand Road in front of the Jagannath temple to "purify" it, claiming that the "tainted" minis ters made the sacred path "impure".

The FDA is currently working to accelerate efforts to address this critical public health problem and has recently published special guidance on emergency-use injectors. IANS

Kuldiha, a safe haven for exotic birds

Balasore, Nov 24: Kuldiha wildlife sanctuary, spread over 272.75 square/km in Nilagiri and Oupada blocks in Balasore district, is a treasure trove for wildlife lovers and tourists. Significantly, the sanctuary with its rich biodiversity plays host to a number of exotic bird species over last many years. The sanctuary is a safe habitat for elephants, too.

The sanctuary is thronged by elephants, leopards, bears, barking deer, spotted deer, sambars, boars, hornbills, peacocks, hawks, and many species of birds of prey. Now, a major attraction for tourists is a number of foreign birds.

The other major attraction for tourists is tribals living in its surroundings. Their colourful clothing, culture, music, festivals and customs have enriched the area in the sanctuary. According to reports, 254 varieties of birds are found in Kuldiha sanc-



tuary. In winter, thousands of migratory birds fly from Andaman and Nocobar islands, the Himalayas, Bangladesh, South Africa, Indonesia, Sri Lanka, Pakistan and Afghanistan.

Among foreign birds arriving at Kuldiha are Malabar trogon, heart-spotted woodpecker, crimson sunbird, varnai hanging parrot, white rumped shama, blue bearded bee-eater, blue bearded kingfisher, velvet-fronted nuthatch, pin-striped tit babbler, black crested bulbul, black-naped monarch, rosy minivet, Asian paradise flycatcher, forest wagtail and yellow rumped flycatcher. These birds are found to be staying around water bodies at Gadasimulia, Kanjipani,

Mechhakund, Chemachata and Rusiainside the sanctuary. Importantly, population of various birds is increasing in the sanctuary, which has brought cheers to the na-

ture lovers, bird watchers, environ-

mentalists and wildlife activists. The forest department is also enthused over such development. The bird hunting inside the sanctuary has been curbed with a host of protective measures and awareness campaigns by the authorities.

Once in the sanctuary, tourists enjoy the nature agog with rich flora and fauna. Various facilities have been made for tourists- night accommodation and tasty meals at Gohirabhola, boating and wildlife tracking.

The department has made provision of guides for tourists. From November 1 to June 15, tourists are found in large number at Gadasimulia, Jodachua, Kuldiha bungalow, Purunapani, Mukhachaturi, Gohirabhola and Chemachata. Famous Panchalingeswar shrine is also inside the sanctuary.

Tourist guide Manoranjan Das said over the last ten years, foreign birds have started coming to Kuldiha due to its green and safe environment.

Reining in Big Tech

yteDance, the parent company of the popular social-media platform TikTok, has a not-so-secret weapon. Its powerful algorithms are able D'to predict users' preferences with precision and recommend content they actually want to see, thereby keeping them glued to their screens. But ByteDance may soon have to sheathe that weapon - or, at least, dull its blade.

Internet-platform companies in China are facing a slew of new data regulations that could curtail the use of recommendation engines. For starters, the Personal Information Protection Law, which took effect this month, requires platforms to allow users to opt out of personalised content and targeted ads. But China may soon go much further. Its internet regulator, the Cyberspace Administration of China (CAC), recently issued new draft guidelines that entail a host of restrictions on the collection and processing of data and its transfer across borders. Notably, apps would have to obtain explicit consent from users before collecting or using data to make personalised recommendations. In other words, individuals would have to opt into personalisation, rather than opting out of it, as is the current norm.

This policy could go a long way toward eroding the business models of online platforms like Douvin (the version of TikTok used in China) and Taobao (an online-shopping platform owned by the Alibaba Group), with potentially far-reaching implications for future innovation in the Chinese tech sector. The reason is simple: many users, if asked, decide that personalisation is not worth giving up their privacy.

Asking makes all the difference. When Apple buried the option to refuse tracking by apps in its complicated privacy settings, only 25% of users took the time to find it and opt out. But when the company began prompting iPhone users with the opportunity to opt out of tracking, 84% took it

Apple's new opt-out policy, which it introduced to its iPhone iOS last April, has been devastating for US tech firms such as Facebook, whose business models are built on the collection of user data and the sale of targeted ads. According to one estimate, Apple's policy change cost Facebook, Snap, Twitter, and YouTube together nearly \$10 billion in revenue - or 12% of the total - in the second half of 2021. Online advertisers, who now must pay much

more to reach potential customers, are panicking. This is an ominous sign for China's tech companies - not least because the CAC's draft data regulations go well beyond Apple's new rule. Whereas Apple requires apps to get permission before sharing a user's data with third parties, the new Chinese measures would require apps to secure user opt-in even to use the data themselves. China's proposed opt-in requirement also appears to be stricter than the European Union's General Data Protection Regulation – currently one of the world's toughest privacy laws. While the GDPR requires platforms to secure user consent before collecting and processing data, it does not require specific consent to enable recommendation services.

It remains to be seen how Chinese platforms will respond to the proposed regulation. They will almost certainly lobby the government not to implement it at all. If the government refuses to listen, they will probably try to circumvent the rule by redesigning app features, though this will take time and raise serious compliance risks

And yet, for the CAC, the struggles of private tech companies may not be much of a concern. While it is impossible to say exactly what factored into the body's cost-benefit analysis of the proposed opt-in requirement, it seems clear that encouraging business growth and techno-

logical innovation is not part of the CAC's mandate.

So, what are the CAC's goals? To answer that question, we must consider the agency's bureaucratic mission, culture, and structure. Given that Chinese administrative enforcement is shaped by path dependence, we must also look to the CAC's past behaviour - in particular, its status as one of China's most interventionist government departments.

Operating under the Central Cyberspace Affairs Commission, a leader ship group chaired by President Xi Jinping himself, the CAC was initially charged with ensuring cybersecurity and regulating internet content. But since 2013, it has expanded significantly, including by absorbing other cybersecurity agencies In July, the CAC grabbed headlines when it surprised the ride-hailing company Didi Chuxing with a cybersecurity inspection just two days after the firm's initial public offering in New York. The CAC subsequently mandated cybersecurity checks for any data-rich Chinese tech firm planning overseas listings, effectively establishing itself as a gatekeeper for efforts to raise cap ital abroad Given that data are the lifeblood of the platform economy, the CAC has significant scope to expand its bureaucratic bailiwick. And, if the new draft regulation is any indication, it plans to do just that, tearing down the walls surrounding the 'walled gardens' of internet platforms, prohibiting algorithmic price discrimination, and clamping down on other unfair pricing practices. These efforts will undoubtedly overlap with the mandate of China's antitrust regulator, the State Administration for Market Regulation. But no matter: emboldened by the government's push to rein in tech giants, the CAC has big regulatory ambitions. In the coming years, its efforts to realise them will play a major role in determining the trajectory of platform businesses – and tech innovation – in China. ately, the social media space in Odisha has been inundated with worrying video clips showing intoxicated youths brandishing swords and firearms, engaged in violent display of aggression, and reenacting violent scenes from movies, all with an apparent disregard for the law. These youths have come together to form gangs with amusing names and have made social media their medium of choice to manifest their. often violent, intent. People from across the society have sharply reacted to these videos and have raised questions at the effectiveness of the police in putting a check on such spectacles. Although it is the duty of the police to address such issues within the confines of law, some questions need to be asked at the outset. Is this an issue that concerns only law enforcement? What role does technology, more specifically social media, play with regard to such social problems? What drives the youth to emulate violence, and display it so flagrantly? Is it the criminal mind, specific to the actors responsible for these 'performances', or are there other social determinants that promote such acts?

To find answers to the above questions, it is imperative to understand why these relatively younger age groups, including students, are fascinated with violence and aggression. The present younger age groups constitute the first generation of the original social media demography. For these digital natives, social media is a powerful and increasingly exclusive tool to express themselves; their joy, their friendships, their celebrations, as well as their vanity, their sadness and other dark impulses.

Social media trends and the younger demographics' fascination with them, are indicative, no doubt of a larger national wave of social media 'content' fueled by confused, unripe minds staring at an uncertain future. The lack of job prospects, sense of relative deprivation, substance abuse and destabilisation of traditional institutions such as family, com-

munity and an easy, unregulated access to social media have accentuated the crisis. With the traditional social arrangement giving way to a more fluid social order that exists online, the youths are often left to themselves, with the project of self-construction of a unique identity. Pushed by this 'identity crisis', the youths are taking to the internet and social media to vent their fantasies with the hope of carving out a unique identity -- a 'handle' that stands out from the crowd. Acute unemployment and financial insecurity, coupled with alcoholism and drug use, are acting as catalysts in driving such online trends among youths.

The Rakta Charitra and its allied trends are, in essence, just that. An expression of power, confidence, angst and identity that are all derived from either uncertainty or pure vanity or both. Online trends, games, or 'challenges' that stoke the dark juvenile fantasies of violence and chaos, dressed up as cool or edgy and guaranteeing instant fame have become the new templates for self-construction of 'identity'. In the social media ecosystem, these younger users, confronted with an ever worsening identity crisis, are falling victim to the likes, followers and retweets which are nothing short of currency for them, and represent a self-fulfilling and self-driven opportunity to get quick fame.

However, while these instant hollow outrages endorsing violence have the potential to cause actual, concrete unrest and are a general nuisance and disturbance to a peaceful society, they cannot be responded to by way of knee jerk reactions. So where does a solution to such a problem lie, if at all there is one? Or is it a natural by-product of modernity in a society in transition. A crackdown by police, to use the term employed by the popular media, would be an ineffective overreaction at best. Though it is the duty of the police to check such trends, it would be naïve to believe that only police action will help in arresting these trends. Police action, at best would be restricted to apprehend the dramatis personae and charge them with relevant sections of the law. It would take a great deal of time and resources, and the police would still not be able to check these trends considering the speed with which they are being created, and the extent to which they

are being proliferated. To begin with, the issue of unemployment has to be tackled as a priority. Providing meaningful employment opportunities, and creating hope for financial security are inevitable to check the spread of such dark impulses. An effective, and consolatory, check on substance/drug abuse, along with awareness and rehabilitation, are

urgent needs of the hour in order to save the youths from falling into the dark abyss of violence and aggression. Social media is a wild beast. For all its spectacular glory that has the world gaping in amazement, the damage it can cause is massive, and often creeps in unexpectedly. The recent trends are an upshot of an unfettered and unregulated social media ecosystem. Considering that social media is no longer just a virtual world made of fun apps but a full-fledged hyper-reality, there need to be serious deliberations on the effective regulation of this space, and putting a check on the circulation of content that extols violence and aggression.

However, at a deeper level, 'identity crisis' is at the core of this issue. The crucial question then. for society at large, is how to prevent this crisis to check this collective alienation of the younger lot from the society. There is an urgent need to reinvent traditional institutions such as the family and the community. Reinvention of the traditional institutions will illuminate the connections between the individual and the society. A societv that shares, and counsels the anxieties of its young, will go a long way in reassuring them that identity formation is a social project and not a private problem.

All these videos and other deline quent expressions are part of a deeper malaise afflicting today's youth. Rather than being evaluated in isolation, it needs to be assessed within the larger scheme of youth development. We need to work towards developing a consolidated national youth project that helps the young to carve an identity of their own that is not fueled by hollow hashtags, but a sense of purpose. It would, indubitably, be an ambitious project requiring considerable resources and energy, but nevertheless an indispensable one that no nation could risk to abandon.

In 2020, President Donald Trump issued an order banning Chinese graduate students and researchers in a number of scientific fields. President Joe Biden's administration has maintained the ban. Earlier this year. Senator Tom Cotton of Arkansas proposed a prohibition on funding from Chinese entities to US universities and the end of the 10-year multiple-entry visa programme for Chinese citizens. American nationalists like Cotton rarely acknowledge that the Chinese are following a path laid by US students. In the nineteenth century, nearly 10,000 Americans travelled to study at universities in Germany. When they returned, they established institutions modeled on the ones they found abroad. The Americans' adaptations of the German universities were so effective that by 1900, the flow of traffic reversed. Germans attended the World's Fairs in Chicago and St. Louis to learn about American developments in higher education. such as co-education and applied mathematics. Research and innovation in the natural sciences and the humanities expanded as a result of this 'competitive emulation.'

overcame protectionism. Scientists and scholars from the two countries became partners as well as competitors. Professors travelled back and forth between New York and Berlin on exchanges, sharing and advancing ideas.

The two world wars undermined academic cooperation. The university was pulled toward the state and faculty promoted themselves as experts who could advance national goals.

After World War II, it took numerous efforts to revive the dormant values of transatlantic scientific exchange and transparency. Even the international programmes of the Cold War-era, like the Ford Foundation-funded Free University of Berlin, the Fulbright Programme. and the German Academic Exchange Service, were more expressions of 'soft power' than true scientific partnerships.

But US universities today are pulled in divergent directions. Although the majority of their research funding comes from the federal government, they generally support the global sharing of ideas, even with US competitors. That's how knowledge advances. Rather than blocking potential research

tion through financial support and exchange programs. The Biden administration should take this opportunity to promote the value of science as a public good.

In the long history of scientific discovery the recent trend toward nativism is an aberration. Scientific advances and technological innovation require free exchange. Those who want to participate in the scientific enterprise must be willing to open their borders to partners from elsewhere, including potential rivals. Many have asked whether China can become a scientific superpower despite its regressive politics and limited freedoms. But we should also be asking a different question: Can US universities remain the best in the world despite closing themselves off from China and the rest of the global community?

To remain vital and relevant and support both national and global progress – universities must remain open to the world. Americans should know this as well as anyone.

Fall in Covid testing worries authorities

New Delhi, Nov 24: An alarming fall in testing for Covid-19 threatens to undermine India's efforts to contain the pandemic, the federal health ministry said Wednesday in a letter to state governments, as worries grew over fresh waves

of infection abroad India reported on Wednesday 9,283 new Covid-19 cases, a day after recording 7,579 infections - the lowest in 543 days. But testing hovered around 1 million per day for the past few weeks, less than half the capacity.

"In the absence of sustained levels of sufficient testing, it is very difficult to determine the true level of infection spread in a geography," Health Secretary Rajesh Bhushan said in a letter sent to the northeastern state of Nagaland, which has reduced testing by more than a third in two months.

"With a majority of countries see



ing multiple surges in Covid cases in recent times and a few developed countries facing even fourth and fifth waves despite high levels of Covid vaccination, there is a need for continued vigil given the unpredictable and contagious nature of the disease.

The ministry delivered the same warning to other states, though

each letter contained observations specific to the various states' circumstances. India has so far reported 34.5 million infections. The United States has the only higher total number of cases. Deaths in India rose by 437 Wednesday to 466,584.

Health workers have started a door-to-door vaccination campaign in India as tens of millions of Indians have not taken their second dose by the due date. India has so far administered 1.18 billion vaccine doses – at least one dose in 82% of its 944 million adults and two in 44%. Maharashtra Health Minister Rajesh Tope has cautioned that the third wave of the ongoing Covid-19 pandemic is likely to hit the state by December, but it will be mild, Wednesday. The minister's assertions came a day after the Centre chided the state for a drastic fall in the testing rates from 2.69 lakhs per day in May to barely 98.000 now in Nov.

The increased incidence of extreme weather events due to global climate change and the risk associated with severe weather has prompted the Ministry to formulate many target-oriented programmes, which are carried out in an integrated manner through its agencies

As a result, these activities are put together under the umbrella scheme termed as Atmosphere & Climate Research-Modelling **Observing Systems & Services** (ACROSS), with its eight subschemes.

The scheme is being implemented by the Ministry, through its scientific agencies - the India Meteorological Department (IMD), the National Centre for Medium Range Weather Forecasting (NCM-RWF), the Indian Institute of Tropical Meteorology (IITM), and the Indian National Centre for Ocean Information Services (IN-COIS). The Cabinet Committee on Economic Affairs chaired by Prime Minister Narendra Modi cleared the proposal for ACROSS.

"The eight sub-schemes under the ACROSS scheme are multi-disciplinary in nature and will be imand INCOIS to cover all the aspects of the weather and climate. Each institute has a designated role for accomplishing the above tasks through the following eight schemes," a Cabinet communique said, detailing the implementation strategy and target for ACROSS.

The scheme pertains to the atmospheric science programmes of the Ministry and addresses different aspects of weather and climate services.

Each of these aspects is incorporated as eight sub-schemes under the umbrella scheme and implemented in an integrated manner through the aforesaid four institutes.

The eight sub-schemes include Commissioning of Polarimetric Doppler Weather Radars (DWRs) (IMD), Upgradation of Forecast System (IMD), Weather & Climate Services (IMD), Atmospheric Observations Network (IMD), Numerical Modelling of Weather and Climate (NCMRWF), Monsoon Mission III (IITM/NCMRWF/IN-COIS/IMD), Monsoon Convection, Clouds and Climate Change (MC4) (IITM/NCMRWF/IMD), and High-Performance Computing System (HPCS) (IITM/NCMRWF), the release added.

TOTAL FERTILITY RATE DECLINES TO 2 NATIONWIDE

INDO-ASIAN NEWS SERVICE

New Delhi, Nov 24: India's Total Fertility Rate (TFR), the average number of children per woman, has further declined from 2.2 to 2 at the national level and ranged from 1.4 in Chandigarh to 2.4 in Uttar Pradesh, as per a Health Ministry survey. NITI Aayog's Member, Health, Dr

Vinod Kumar Paul, and Union Health and Family Welfare Secretary Rajesh Bhushan released the factsheets of key indicators on population, reproductive and child health, family welfare, nutrition and others for India and 14 States and UTs clubbed under Phase 2 of the National Family Health Survey (NFHS-5) (2019-21).

The survey showed that all Phase 2 states have achieved replacement level of fertility (2.1) except Madhva Pradesh. Rajasthan, Jharkhand, and Uttar Pradesh. The survey has found that the overall Contraceptive Prevalence Rate (CPR) has increased substantially from 54 per cent to 67 per cent at all-India level and in almost all Phase 2 states/UTs with the ex-



ception of Punjab. The use of modern methods of contracep-

The key indicator of the Health Ministry survey has revealed that the unmet needs of family planning have witnessed a significant decline from 13 per cent to 9 per cent at all-India level and in most

of the Phase 2 states/UTs. The unmet need for spacing which remained a major issue in India in the past has come down to less than 10 per cent in all the states except Jharkhand at 12 per cent, and Arunachal Pradesh and Uttar Pradesh - both at 13 per cent.

The strategic 900 km-long Chardham project worth Rs 12,000 crore aims to widen roads and provide all-weather connectivity to four holy places -- Yamunotri, Gangotri, Kedarnath and Badrinath -- in Uttarakhand

New Delhi, Nov 24: Amid concerns over the proposed Chardham project. Union minister Nitin Gadkari Wednesday termed allegations that road construction triggered landslides in Uttarakhand as 'misinformation' and asserted that the government is sensitive about ecology and environment while carrying out development projects.

The road transport and highways minister also asserted that the pace of highways construction in the country will cross 40 km per day in the current financial year.

The pace of highways construction in the country touched a record 37 km per day in the financial year 2020-21.

Recently, the Supreme Court reserved its verdict on pleas with respect to the ambitious project.

'This is all misinformation (Ye galat prachar hai). Earlier there used to be flash floods and cloud bursts which used to cause damages and deaths," Gadkari, who is known for expressing frank views on any matter, told PTI.

His remarks also come against the backdrop of concerns about ecological issues expressed in certain quarters on the widening of the road for the Chardham project.

Gadkari pointed out that now, the hilly terrains have been secured with the construction of a tunnel (beneath chamba town).

Kolkata, Nov 24: Several SFI and DYFI activists were Wednesday detained in Kolkata, after they clashed with police while protesting against an alleged scam in recruitment in the School Service Commission (SSC)

The CPI(M) student and youth wings - the Students' Federation of India and the Democratic Youth Federation of India - had organised a march to the SSC office in Salt Lake Wednesday afternoon, as part of their stir.

Kolkata, Nov 24: Hurrying down the busy Burrabazar area, Elisha Twena, 78, one of the last Jews of Kolkata ducked into a gate hidden by pavement shops selling trinkets at the crossing of Brabourne Road with Canning Street, leading into a stately red building with a tall steeple.

Walking in through an arched door with the 'Star of David' embellished over it. Twena entered a huge hall with chequered marble flooring, regal chandeliers and ancient fans hanging from a two-storied high roof. The hall's Rennaisance stained glass windows, and ornate floral pillars shipped in from Paris gave it a medieval grandeur.

The building which may easily be mistaken to be a Central European church but for its setting is the 137-year-old Magen David Synagogue, considered one of the most magnificent Jewish temples in Asia, built by the 19th century realtor and business tycoon Elias David Ezra, whose legacy still lingers on in a street named after

him in central Kolkata. Like the 20-30 odd Jews left in this eastern mega-polis down from a peak population of 6,000 just after World War II, the Magen David where religious services have long stopped and its older neighbour Neveh Shalom Synagogue built in 1831, remain tucked away in obscurity, hid-



Jewish Boy's School who used to come to this synagogue, migrated out in the 1960s and 1970s in search of better prospects ... we now don't even have a Rabbi left here," said Twena, a pensioner who lives in a penthouse on Louden Street.

Waving his hands towards an empty driveway and garden, he reminisces "this is where we used to play cricket after religious services ... there are no children left to play now, the youngest among us is 53 and the oldest 96."

However, he has no regrets. For him Kolkata or Calcutta as he still calls it, is one of the important centres of Jewish life, and has been ever since Shalome Obadiah Ha-Cohen, a merchant from Aleppo landed in the city, some 223 years ago to become court jeweller to the Nawabs of Awadh and Maharaja Ranjit Singh.

Legend has it that he was asked to value the 'Kohinoor' diamond among other jewels in the 'Lion of Punjab's' treasury.

As Ha-Cohen was joined by his relatives and others from the Baghdadi or middle eastern Jewish community, the city became a hub for Jewish enterprise and trade with connections with Shanghai in the east and London in the west and all important port cities in between

Along with Armenians, Greeks, Parsis and Chinese, Jews brought a special cosmopolitan flavour to colonial Kolkata. The nearby Pollock, Ezra and Synagogue Streets thrived with Jewish families settling down there and the Jewish New

'We were mostly Arab Jews, conservative Jews, but as we interacted with Indians and Europeans, we changed. We shed middle eastern attire for western clothes, the magnificent Magen David was constructed in such a manner that from afar it looks like a church, earning it the nickname 'Lal Girja' (Red Church) ... at the same time we left an indelible impact on the city," said Jael Silliman, 66, a well-known author and scholar.

Hospitals, synagogues, boys' and girls' schools, besides numerous educational and charitable institutions were set up. Ezra who set up the Magen David

in his father's name and married into the wealthy Mumbai-based

'Rothschild of the east', also owned many of Kolkata's landmarks which included Chowringhee Mansion, Esplanade Mansion and Ezra Mansion.

Other Kolkata Jews owned jute mills, cigarette companies, textile and export firms including blue-chip firms – Agarpara Jute Mills, National Tobacco Company and Great Pyramid Insurance.

Kolkata got its first Hebrew press in 1840, and its first Judeo-Arabic weekly 'Mevasser' in 1873. Bene Israeli Jews from Mumbai too flocked to the city, as did European Jews, victims of Nazi Germany's persecution. By the time the Second World War engulfed the world, Kolkata's Jews numbered nearly 6,000. However, the bulk and the heart of the community remained Baghdadi Jews. Kolkata's Jews excelled in the world of movies too, Rachel Sofaer became a top heroine of the silent era under the stage name Arati Devi, while Ezra Mir under the name Edwyn Myers became a well-known film director.

With independence, partition riots and socialistic flavour to India's economic policies, many Jews, who were among the first free marketeers in the world, decided to migrate. "Most of my classmates went to Australia, Canada, the US and England," said Twena. Very fewmigrated to the promised but far more austere land of Israel.

New Delhi, Nov 24: The Supreme Court Wednesday yet again pulled up the central government and state bureaucracy over air pollution in Delhi and wondered why they haven't come up with a permanent solution to prevent stubble burning.

The top court was hearing a plea seeking directions to provide stubble-removing machines to small and marginal farmers for free.

The Supreme Court Wednesday asked the Centre and the NCR states to continue with their measures to curb air pollution and called for advance preventive steps with the help of IMD which has "sophisticated mechanism and tools" to deal with the situation before it becomes severe.

Graded response to deal with the spike in air pollution should be taken before the situation becomes severe, the top court said, adding that it will not close the matter and continue to hear it even if pollution comes down by 'virtue of God's act' or restrictions.

A special bench headed by Chief Justice N V Ramana, which discussed the issue of stubble burning and the problems faced by farmers with the lawyers, once again came down on bureaucrats for their alleged inaction in dealing with this aspect.

RKPA asks states to undertake agri market reforms

Only CNG, electric trucks allowed to enter Delhi

Anaemia among kids, women major concern nationwide, says survey

New Delhi, Nov 24: Anaemia among children and women continues to be a cause of concern. with more than half of them being found anaemic in 14 states and UTs, according to the findings of phase two of the National Family Health Survey (NFHS-5).

The government Wednesday released the factsheets of key indicators on population, reproductive and child health, family welfare, nutrition and others for India as well as 14 states and UTs, clubbed under phase two, of the 2019-21 NFHS-5 here.

The states and UTs which were surveyed in this phase were Arunachal Pradesh, Chandigarh, Chhattisgarh, Haryana, Jharkhand, Madhya Pradesh, NCT of Delhi, Odisha, Puducherry, Punjab, Rajasthan, Tamil Nadu, Uttar Pradesh and Uttarakhand, a Health Ministry statement said.

At the national level, the occurrence of anaemia among women and children was found to be the same as that in 14 states and UTs. The findings for national level were calculated by using data from phase one and phase two of the NHFS-5.

Gautam Gambhir gets death threats

New Delhi: Security has been beefed up outside the residence of BJP MP Gautam Gambhir here after he received an alleged death threat from "ISIS Kash officials said Wednesday. A complaint addressed to the Deputy Commissioner of Police (Central) stated that a death threat from "ISIS Kashmir" was received on the official email ID of Gambhir at 9.32 pm Tuesday, they said. The mail read, "We are going to kill you and your family", the officials said.

The findings of phase one of the NFHS-5 for 22 states and UTs were released in December, 2020.

According to the findings, child nutrition indicators showed a slight improvement at all-India level as stunting declined from 38 per cent to 36 per cent, wasting from 21 per cent to 19 per cent and underweight from 36 per cent to 32 percent. In all phase two states and UTs, the situation improved in respect of child nutrition but the change was not significant as drastic changes in respect of these indicators are unlikely in a short span, the statement said.

"Anaemia among children and women continues to be a cause of concern. More than half of the children and women (including pregnant women) are anaemic in all the phase two states and UTs and all-India level compared to NFHS-4, in spite of substantial increase in the composition of iron folic acid (IFA) tablets by pregnant women for 180 days or more," it said. Exclusive breastfeeding to children under six months of age has shown an improvement in all-India level from 55 per cent in 2015-16 to 64 per cent in 2019-21. All the phase two states

and UTs are also showing a considerable progress, it said.



Norovirus outbreak in Ker: K'taka on high alert

Bengaluru, Nov 24: In the wake of the detection of 13 norovirus cases in Kerala, Karnataka has sounded an alert in the bordering districts of Kodagu and Dakshina Kannada.

In a circular issued on Tuesday, the Karnataka Health Department released guidelines to be followed. It instructed the appointment

of a physician as a nodal officer for every district to manage the situation. District Health and Family Welfare department officers have also been asked to pitch in.

The infection is caused and spread through contaminated food and water.

The person affected with the virus will develop symptoms of vomiting, loose motion, nausea, stomach ache, headache, body pain and fever, it said.

The patients will have to be admitted to hospital. If neglected it will become fatal, it said.

The health department officials have been asked to gather information on sources of drinking water and test them.

The treatment for the infection is non-specific and the patient has

to be treated for symptoms.

The rare norovirus was reported among 13 students of a veterinary college at Pookode in Wayanad district of Kerala in October end. The Kerala government has called upon the people of the state to be on high alert.

The norovirus which is also known as the 'winter vomiting bug' is highly infectious and spreads easily among people. Doctors said that the disease is transmitted by direct contact with an infected person, contaminated food or touching a contaminated surface, and putting unwashed hands in the mouth.

Can double masking for long cause breathing problems?

New Delhi, Nov 24: While wearing double masks, which helps create a strong barrier against Covid-19 infection spread via airborne viral particles, has become the new normal, prolonged wearing of masks can develop hydration issues or other nagging breathing troubles, health experts said Wednesday

"Prolonged mask wearing can be associated with certain problems -- the most common being headaches, dehydration, acne and difficulty in breathing," Radhika Banka, Consultant Pulmonologist at PD Hinduja Hospital & MRC, Mumbai, told IANS.

Breathing issues are "usually seen in mouth breathers and in people with underlying respiratory problems such as COPD (Chronic Obstructive Pulmonary Disease)", she added. According to Ravi Shekhar Jha, Additional Director and HOD, Pulmonology, at Fortis Escorts Hospital, Faridabad, wearing double mask for long hours can also lead to dryness. "It is because natural humidification of nasal mucosa gets impaired," Jha said.

There are various masks available in the market, including cloth masks, surgical masks and respirators such as N-95s. The cloth mask has the least protection and the US Centre of Disease Control and Prevention (CDC) recommends wearing a disposable surgical mask along with a cloth mask for addi-

tional protection. For surgical masks, the knotted technique (that is knotting the ear loops to provide better fit and prevent leakage from the sides) is recommended. But with full vaccination rolled

out in most countries, are double



masks still required? "Even after double dose vaccination, people can get breakthrough infections and can still be asymptomatic carriers and spread the infection. Hence masking is important even after double vaccination," Banka said. The health experts stated that for people living in India, double masks become more important as vaccination of children has not yet begun in the country, and asymptomatic transmission is the highest from children. Added to this is a high population density, where social distancing is not practically pos-

sible in many cases.

Most of the countries which have made masks voluntary are those in the West with low population density, where social distancing is feasible. These countries have managed to vaccinate more than 80 per cent of their population with two doses. Also, masks in these countries are still recommended in enclosed spaces, public transports, healthcare facilities etc. "With only 48 per cent of our population being vaccinated with one dose and 25 per cent being vaccinated with two doses, I do not think India can yet take the risk of removing the mandatory use of masks," Banka said

However, according to Jha, "A single mask, if worn properly, is sufficient." "People who wear double masks, have this tendency of adjusting their masks repeatedly due to breathing issues, and that way the whole purpose of wearing a mask is defeated," he said.

Jha added that for someone like a healthcare worker, who is in an area with high concentration of Covid viral droplets, an N-95 mask should be worn all the time. For other situations, a normal surgical mask (single) is sufficient.

Although several countries have loosened mask restrictions citing vaccine efficacy, various studies and health experts have stressed on the need for continuing wearing masks, even after being fully vaccinated, including booster shots; and following other protective measures such as physical distancing and handwashing. Most people are able to wear masks fairly well for a few hours, but if your job requires you to wear masks for a prolonged period, it is essential to take adequate breaks to hydrate oneself and prevent any skin problems, Banka suggested.

"Booster doses should be considered for all adult individuals prioritising persons above 40 years of age," Ammon said in a recorded statement, noting that boosters should be administered at least six months after completing the

tal of Addis Ababa in recent weeks with the aim of strengthening their negotiating position or simply forcing the prime minster to step down.

While unusual, a leader's move to the front has occurred elsewhere in Africa, but at times with deadly results. Chad's president, Idriss Deby Itno, was killed while battling rebels in April, according to the military.

The prime minister announced earlier this week that he would go to the battlefront, saying that "this is a time when leading a country with martyrdom is needed."

Barrier Reef erupts in colour as corals recover, spawn

Canberra, Nov 24: Australia's Great Barrier Reef is spawning in an explosion of colour as the World Heritage-listed natural wonder recovers from life-threatening coral bleaching episodes.

Scientists Tuesday night recorded the corals fertilising billions of offspring by casting sperm and eggs into the Pacific Ocean off the Queensland state coastal city of Cairns.

The network of 2,500 reefs covering 348,000 square kilometers suffered significantly from coral bleaching caused by unusually warm ocean temperatures in 2016, 2017 and last year. The bleaching damaged two-thirds of the coral.

Gareth Phillips, a marine scientist with Reef Teach, a tourism and educational business, is studying the spawning as part of a project to monitor the reef's health.

"It is gratifying to see the reef give birth," Phillips said in a statement Wednesday. "It's a strong demonstration that its ecological functions are intact and working after being in a recovery phase for more than 18 months.

"The reef has gone through its own troubles like we all have, but it can still respond — and that gives us hope. I think we must all focus on the victories as we emerge from the pandemic," Phillips added.

Los Angeles, Nov 24: NASA launched a spacecraft Tuesday night on a mission to smash into an asteroid and test whether it would be possible to knock a speeding space rock off course if one were to threaten Earth.

The DART spacecraft, short for Double Asteroid Redirection Test, lifted off from Vandenberg Space Force Base atop a SpaceX Falcon 9 rocket in a \$330 million project with echoes of the Bruce Willis movie "Armageddon."

If all goes well, in September 2022 it will slam head-on into Dimorphos, an asteroid 525 feet (160 meters) across, at 15,000 mph (24,139 kph).

"This isn't going to destroy the asteroid. It's just going to give it a small nudge," said mission offi-

cial Nancy Chabot of Johns Hopkins Applied Physics Laboratory, which is managing the project.

Dimorphos orbits a much larger asteroid called Didymos. The pair is no danger to Earth but offer scientists a way to measure the effectiveness of the collision. Dimorphos completes one orbit of Didymos every 11 hours, 55 minutes. DART's goal is a crash that will slow Dimorphos down and cause it to fall closer toward the bigger asteroid, shaving 10 minutes off its orbit

The change in the orbital period will be measured by telescopes on Earth. The minimum change for the mission to be considered a suc-

cess is 73 seconds.

The DART technique could prove useful for altering the course of an asteroid years or decades before it bears down on Earth with the potential for catastrophe.

A small nudge "would add up to a big change in its future position, and then the asteroid and the Earth wouldn't be on a collision course," Chabot said.

Scientists constantly search for asteroids and plot their courses to determine whether they could

hit the planet.

"Although there isn't a currently known asteroid that's on an impact course with the Earth, we do know that there is a large population of near-Earth asteroids out there," said Lindley Johnson, planetary defense officer at NASA. "The key to planetary defense is finding them well before they are an impact threat.

DART will take 10 months to reach the asteroid pair. The collision will occur about 6.8 million miles (11 million kilometers) from Earth. Ten days beforehand, DART will release a tiny observation spacecraft supplied by the Italian space agency that will follow it.

DART will stream video until it is destroyed on impact. Three minutes later, the trailing craft willmake images of the impact site and material that is ejected.

Another English team - defending champion Chelsea - also advanced on the back of a 4-0 win over already-qualified Juventus, who slumped to their heaviest ever loss in the Champions League.

With Liverpool also qualified and Manchester City likely to join them, the Premier League will again be well represented in the knockout stage.

In the men's singles, world number 16 B Sai Praneeth clinched a 21-19, 21-18 win over France's Toma Junior Popov.

In a repeat of last week's Indonesia Masters quarterfinal, Srikanth once again got the better of compatriot HS Prannoy. The former World No.1 Srikanth, who is coming off two back-to-back semifinal finishes at Hylo Open and Indonesia Masters, continued his good run of form as he eked out

a 21-15, 19-21, 21-12 victory over Prannoy in 56 minutes. While Praneeth will next take on Christo Popov of France in the second round, Srikanth will meet
