3 Forest personnel injured in attack on patrol vessel

Kendrapara, Nov 28: Three Forest department personnel were injured in an attack by the crew of a trawler who were illegally fishing in the prohibited seawaters of Gahirmatha sanctuary in Kendrapara district, officials said Sunday.

Twelve forest personnel were in the patrol vessel that was attacked on Saturday, they said. The vessel which was partially damaged, was deployed in the area for the protection of olive ridley turtles.

It was an "organised" attack, a Forest official said, adding that the trawler allegedly chased the patrol vessel and hit it. The Forest personnel were outnumbered by the crew on the trawler and despite provocation, the forest personnel did not open fire, he said.

The Forest personnel, however, managed to overpower the crew of the trawler and arrest nine of them. They were handed over to the Dhamra marine police station for further action, the official said.

The trawler had trespassed into the prohibited sanctuary corridors, contravening the provisions of Wildlife Protection Act and Orissa Marine Fishing Regulation Act, among others

Fishing activity has been prohibited within a seaward radius of 20 km of Gahirmatha marine sanctuary from November 1 to protect olive ridley turtles.

a senior IMD official said Sunday. Speaking to reporters in Delhi, IMD Director General Mrutyunjay Mohapatra said a low pressure area is likely to form over South Andaman Sea and the Bay of Bengal around November 30.

Bhubaneswar, Nov 28: Amid the rising Covid-19 cases in some parts of India and in some foreign countries, state government Sunday geared up to tackle a possible third wave of the pandemic in Odisha.

Chief Secretary SC Mahapatra held a meeting via videoconferencing with all district Collectors, SPs, Chief District Medical Officers (CDMOs) and concerned officials to remain alert for the possible third wave of the pandemic. He directed the officials to remain prepared for the possible third wave.

Schools and colleges have opened in the state and livelihood and economic activities have also started. So, keeping all these in view, all have to remain fully prepared and cautious for another resurge in the Covid-19 cases, he said.

The Chief Secretary advised all the block officials, ward members, Anganwadi workers and health workers to collect ground reports of Covid infection in their respective areas and immediately take action if signs of Covid spread

Fuel prices will fall if 'int'l rates' sustain

New Delhi, Nov 28: Petrol and diesel prices will be reduced only if the current drop in international oil prices is sustained for a few more days, as domestic retail prices are fixed on a 15-day rolling average, official sources said.

Global benchmark Brent crude oil prices remained largely range bound at around \$80 to \$82 per barrel, levels during till November 25.



On November 26, prices fell by around \$4 per barrel till Asian timestamp. However, subsequently after the opening of the US market, with the drastic sell off in Brent Futures, prices fell further by around \$6 to close at \$72.91 a barrel at ICE London

Sources said, this seems like a knee jerk reaction from fears that the new Covid-19 variant discovered in Southern Africa might dampen economic growth and trigger another demand slump.

State-owned fuel retailers Indian Oil Corporation (IOC), Bharat Petroleum Corporation Ltd (BPCL) and Hindustan Petroleum Corporation Ltd (HPCL) revise petrol and diesel prices on a daily basis

New Delhi, Nov 28: Prime Minister Narendra Modi Sunday skipped an all-party meeting called by his government, a day before the start of the Winter Session of Parliament.

Defence Minister Rajnath Singh, Commerce Minister Piyush Goyal were present from the government side. Parliamentary Affairs Minister Pralhad Joshi denied that the Prime Minister violated a tradition by skipping the all-party meet.

"There was no tradition of Prime Minister attending the all party

meeting it was started by Modiji. He couldn't attend the today's meeting," said 'Joshi, adding 31 parties attended the meeting.

'We were expecting that the Prime Minister will attend the meeting and will share something with us. We wanted to ask more about the farm laws as there are some apprehensions that these three farm laws may again come in some other form," said Mallikarjun Kharge, Congress leader in the Rajya Sabha.

Why WHO named new Covid-19 variant Omicron

The decision to skip the two letters and use the next available one to name the latest variant had generated a lot of curiosity and interest on the Internet



Geneva, Nov 28: While picking a name for the variants of SARS-CoV2, the World Health Organisation has so far skipped two letters of the Greek alphabet, one of which also happens to be a popular surname in China, shared even by Chinese President Xi

Jinping The WHO has been using Greek letters to refer to the most widely prevalent coronavirus variants, which otherwise have long scientific names. Before a new variant emerged in South Africa earlier this week, the WHO had already used 12 letters of the Greek alphabet. WHO selected Omicron for this one, instead of Nu or Xi the two letters that precede it.

According to the WHO, Nu could have been confused with the word 'new', while Xi was not picked up following a convention.

"Two letters were skipped - Nu and Xi - because Nu is too easily confounded with "new" and XI was not used because it is a common surname and WHO best practices for naming new diseases (de-



veloped in conjunction with FAO and OIE back in 2015) suggest avoiding 'causing offence to any cultural, social, national, regional, professional or ethnic groups', the organisation said in a statement. The decision to skip the two letters and use the next available one to name the latest variant had generated a lot of curiosity and interest on the Internet.

Depending on the threat they pose, WHO classifies new variants either as 'variants under monitoring (VUMs)', 'variants of interest (VoIs)' or 'variants of concern (VoCs)'. All of them are given scientific names which represent their parentage and the chain of evolution. The Omicron variant, for example, is also known by its more scientific designation B.1.1.529. This designation shows that the variant has evolved from the B.1 variant.

Since the scientific names are not

easy to remember, the more widely prevalent variants started to be named after the country from which they were first reported. Accordingly, there used to be a UK variant, an Indian variant, a South African variant, a Brazilian variant and a few more.

In order to remove the linkage with specific countries, which was triggering a lot of name-calling and blame game, the WHO had decided on a new naming system for easy identification of the prominent variants. It chose to name them after the Greek letters. Accordingly, the variant that earlier used to be referred as the 'Indian' got the name Delta, while the UK one was called Alpha.







Hitman planning to kill bizman held

The arrested criminal has been identified as Sampad Kumar Sahoo, 36, a resident of Krishnanandapur village under Tirtol police limits of Jagatsinghpur.


Sources revealed that some alert locals informed police about two bike-borne miscreants carrying firearms going towards Navapalli area Friday night. 
the scuffle. The cops as well as Sampad sustained injuries during the affray.

New Delhi, Nov 28: The Biju Janata Dal (BJD) along with other opposition parties Sunday demanded that the Union government should bring a Bill in the Winter Session of the Parliament to give legal guarantee on the Minimum Support Price (MSP) for farmers.

Attending the all-party meeting convened by the Union government a day before the commencement of the Winter Session of the Parliament, senior BJD leader and Rajya Sabha MP Prasanna Acharya raised the issue of cost sharing ratio in Pradhan Mantri Fasal Bima Yojna (PMFBY). The BJD MP requested the government that

the cost sharing ratio should be 60:40. He said the Centre should bear 60 per cent cost under the scheme.

Explained: Why risk of stroke rises in winter

THE CHANCES OF A PERSON SUFFERING FROM HEART ATTACK GOES UP NEARLY 33 PER CENT DURING WINTER

everal studies suggest that during winter, risk of stroke, heart failure, cardiovascular issues, arrhythmia and disorders rises several times. Many top cardiologists think that it happens due to body's physiology and the temperature drop that impacts the heart's functionality.

According to a study of JAMA Cardiology, a monthly peer-reviewed medical journal, which analysed information on 2,74,000 people living in Sweden in 2018, the risk of having a heart attack was greatest on days when the temperature was below freezing point.

PLOS One, open access scientific journal, in a study in 2015 found more than 31 per cent increase in heart attacks in the coldest months of the year as compared to the warmest. Several studies suggest that during extreme cold conditions, the risk of getting a stroke increases by 80 per cent, particularly when temperature dips below 15 degree Celsius.

As temperatures drop, the blood vessels tighten and blood flow speeds up to help stay warm. That is why the blood pressure is often higher in colder seasons, opine cardiologists.

"Onset of winters can evoke mixed reactions. As per some study, the chances of a person suffering from heart attack goes up nearly 33 per cent during winters. The coronary arteries like other arteries can constrict during winter which can lead to poor supply of blood to the heart muscle. Decreased blood supply can precipitate myocardial ischemia and



heart attack," said Tarun Kumar, Professor of Cardiology, ABVIMS and RML Hospital.

Tarun said there is increased blood volume during winters. As in summer there is increased fluid loss through sweat which is missing in winters. It can lead to increase salt and fluid retention during winter which can lead to increase in blood pressure and heart attacks.

"Because of hormonal variations during winters there is increase in levels of clotting factors including fibrinogen. Adding fuel to fire is vasoconstriction and platelet aggregability along with clotting factors which can lead to increased tendency for clot formation and heart attacks." he added. Increased calorie intake and decreased physical activity can induce

The coronary arteries like other arteries can constrict during winter which can lead to poor supply of blood to the heart muscle. Decreased blood supply can precipitate myocardial ischemia and heart attack

myriad physical changes in the body including weight gain and vascular changes which can provide a mileu for clot formation and heart attack, he said. adding that elderly, alcoholics, smokers, people with sedentary lifestyles

are more at risk.

While talking about precautions, he advised to reduce exposure to cold, avoid excessive alcohol intake and there should not be coal based or faulty heating appliances in closed rooms. He also advised to go for regular physical activity and blood pressure and blood sugars level checkups after regular intervals.

Vipul Gupta, Director Neurointervention, Artemis Agrim Institute of Neurosciences, said, "One of the prime reasons can be attributed that during the cold season the blood vessels constrict, which leads to increase in blood pressure, which means that the blood has to be really pumped harder in order to travel around the body, making it one of the major factors for the onset of stroke.'

"Also, there are various changes in the chemical balance in our body during winter including cholesterol levels and some other factors that increase the chances of clotting. Changes in the physical activity which usually decreases during the winter as well as weight gain can play a role. Probably this is the reason stroke cases go up by 11 per cent during winter," added Gupta.

Low temperature constricts the blood vessels which in turn increases blood pressure and aggregates blood clotting process, said Cardiologist Praveen Jha.

He said that Vitamin D deficiency is also common in winter which also contributes to cardiovascular disease. Air pollution and physical inactivity are also reasons for rise in heart attacks during winter, said Jha. IANS

"Sustained economic growth over the past 15 years has led to a marked increase in people's incomes. We know that obesity among Indians goes up as they become wealthier. In 2015-16, according to NFHS-4, the proportion of overweight or obese men was five per cent among families in the lowest wealth quintile and 33 per cent in the highest wealth quintile," she said.

"Similarly, the proportion of overweight or obese women was six per cent among families in the lowest wealth quintile and 36 per cent in the highest wealth quintile," she added.

"However, blaming rising incomes is not fair. Much have also to do with poor eating habits. The consumption of unhealthy foods (popularly termed junk foods) that are high in calories from sugar or fat and contain little dietary fibre, protein, vitamins, and minerals is known to increase as families become wealthier. Muttreja explained.

Besides these problems, a vast majority of Indians do not seem to recognise the importance of leading a healthy and active life. They tend to lead sedentary lives and lack the motivation to do exercise of any kind including walking.

Dr Antaryami Dash, Head of Nutrition, Save the Children, India, said every nation is entering into a situation with double burden of malnutrition where there is a coexistence of under-nutrition (stunting/wasting/underweight) and over-nutrition (overweight/ obesity) at the population level. The prevalence is highest in western and industrialised countries, but gradually catching up in developing countries too.

Sarangi attacks govt over poverty

Keonjhar: Bhubaneswar MP and BJP's spokesperson Aparajita Sarangi, who came to Keonjhar on a two-day visit Sunday, said that the mineralrich district has remained poor despite having huge reserves of minerals. Launching a tirade at the state government, she observed, "About 42 percent of the population in the district is living below the poverty line. One in three people in Odisha is poor. Even though a government has been in power for more than 20 years, poverty is not going down." Citing a report of the NITI Ayog at a presser at the circuit house here, Sarangi put forth various data of the district, pointing to the failure of the government. She pointed out a number of problems in various sectors in the district and sought to know why the Kanpur mega irrigation project has remained incomplete over years.

Jumbo dies after falling

Baripada, Nov 28: Forest officials recovered the carcass of a female elephant from the core area of Nana forest range inside Similipal wildlife sanctuary in Mayurbhanj district, Sunday.

The animal, aged about 40, is suspected to have died after falling down from hilltop inside the sanctuary. The matter came to the fore when the forest officials were car-

rying out an enumeration drive of tigers and birds inside the wildlife sanctuary, according to the forest department.

The forest officials noticed the carcass stuck on a tree and recovered it. Sai Kiran, deputy director of North Similipal wildlife sanctuary and Jashipur forest officials launched an investigation into its death. Circumstantial evidences indicated that the animal might have died after sliding down from a height of 30-ft of hilly slope inside the sanctuary. A post-mortem was conducted on the carcass and the actual reason behind its death could be ascertained only after the report is available to the forest de-

partment, forest officials added.

Rice mills throw NGT norms to the wind

SPCB WAS ACCUSED OF SHOWING UNDUE FAVOUR TO THE POLLUTING RICE PROCESSING UNITS

Sambalpur. Nov 28: Severe pollution has made life intolerable for the residents in Sambalpur district, said a report. Presence of many large industries outside the Sambalpur town and rice mills operating inside the town are allegedly contributing to air and water pollution in the area

Both human beings and animals are getting affected and suffering from various diseases as they get exposed to the toxic effluents and smoke emanating from these rice mills. Reports said there are around 52 rice mills in the district but none are allegedly adhering to the rules laid down by the National Green Tribunal (NGT).

On the other hand, the tribunal has directed the State Pollution Control Board (SPCB) to periodically review the pollution control measures in rice mills but the SPCB has allegedly failed to do so. The SPCB, instead of verifying the pollution control measures in the rice mills, is allegedly showing

them undue favour. Rice mills discharge toxic effluents, waste materials and smoke which contribute to air and water pollution. To check and measure



air pollution, the mills install particulate matter emission machine in their premises. These machines, if properly working, will help in checking pollution and presence of particulate matter in the atmosphere.

These machines also help in spillage of the paddy husk, stone granules and dust when paddy is being milled in the boiler machine. Most of the exhaust chimneys lack proper mechanism to check black toxic smoke. Moreover, many of the rice mills throw up waste materials in the open which has led to

pollution in the area, locals alleged. The effluents and discharged

waste materials pollute the ground and air in the surroundings and spread to farmlands and human habitats. Things have come to such a pass that it has become difficult to pass by the rice mills on the road. These pollutants have become health hazards for scores of labourers and officials working in these rice mills. Many of them have been affected with respiratory diseases and other problems.

Labourers have alleged that nothing has been done yet to alleviate the problem despite lodging complaints with their respective rice mills proprietors.

Moreover, water pollution is another major cause of concern. The waste water gives out foul smell which has made life hell for the nearby residents.

The milling of paddy for rice needs water for which the mills are required to install effluent treatment plants (ETP) on their premises. However, nobody is adhering to the rules which have remained only on pen and papers. The ETPs recycle the waste water for use in farm works.

The mill owners however, are allegedly not installing the machines to save money on electricity bills, labour wages and repairing. The SPCB which needs to launch a crackdown on errant rice mills has chosen to remain silent on the issue for reasons known best to it. It is alleged that the pollution board is allegedly forcing the rice mills to buy and install an ETP of a particular firm which is becoming defunct after some time.

When contacted, Ramesh Ekka, regional director, SPCB said the rice mills have been asked to adhere to the NGT rules while raids are being conducted at regular intervals. He warned of taking action against any mill found violating these rules.

Rasulpur, Nov 28: The newly launched 'Mukhyamantri Bunakar Kalyan Yojana' has turned out to be a ray of hope for scores of weavers under this block in Jajpur district who are battling for survival after imposition of Covid restrictions and other reasons.

As many as 612 weavers, all residents of weaver village Gopalpur under this block will be benefitted by this scheme launched by the state government. Financial assistance will be given to over 422 weavers for development of infrastructure while the rest 190 weavers will be provided training for skill upgradation.

Seeking government assistance, these weavers had earlier applied in various schemes. These schemes will bring in improvement in the financial condition of the weavers. The weavers undergoing training will be provided with financial assistance to help them become self reliant. Moreover, many of the weavers who have applied for government assistance will be included under the scheme in phases. The Handloom, Textiles & Handicrafts department has informed that efforts are on to remove the problems of the weaver families.

Reports said that the state government has launched a six point programme for the welfare of the weavers. The weavers of Gopalpur will receive ₹36,56,000 which will benefit them in improving their condition. The scheme is participatory where the government share will be ₹23.90 lakh, whereas the weavers' share will be ₹3.65 lakh.

Under this scheme, 66 weaver families will get ₹24,000 each to buy loom and other materials. Over 280 families will get ₹20,000 each to buy loom materials.

Similarly, 20 families will receive ₹5,000 each to buy dobby machines (used in making the borders of a cloth or saree) while 40 families will receive ₹1,500 each to buy Jakad (a machine used in designing and weaving) while 4 families will get ₹3,000 each to buy Bishnupuri spinning wheel (Charkha). The financial assistance provided by the government will be credited to the savings bank accounts of weavers. To receive the assistance, the el-

Rajnagar, Nov 28: The crocodile research and breeding centre at Dangamala inside the Bhitarkanika national park in Kendrapara district is a tourist draw, but a threeyear-old albino crocodile has now been the star attraction for tourists, a report said.

With the tourism season in, tourists are thronging the crocodile breeding centre to take a glimpse of the white crocodile. The number of white crocodiles in Bhitarkanika touched three. Gori and Malli, two white crocodiles of Bhitarkanika. used to be the centre of tourists' attraction.



It may be noted here that the country's first crocodile research and breeding centre was set up on 115 sqkm in Bhitarkanika park in In 2018, a crocodile nest at Ganjeikhia was damaged by tridal waves. 58 eggs were retrieved from there and put in the artificial hatchery. One of the hatchlings was white

the research centre. One of the hatchlings was white, christened as Gori. For many years after Gori was born, no other white crocodile was born here

In 2003, two white crocodile babies

were spotted at Bankuala forest One of them was christened as Malli. Later Malli began to draw attention of tourists.

In 2018, a nest of a crocodile at Ganjeikhia was damaged by tridal waves. Forest officials and researchers recovered 58 eggs from the nest and put in the artificial hatchery. Only 32 eggs hatched. However, the forest department could not find any white hatchling. Surprisingly, one of them was later found to be white. It's age is three years and four months and is two metre long. Forest officials say, the white crocodile, which is fed 150 gm of shrimp every day, is now the centre of tourists' attraction.

Anglo-French Slugfest

aught in the political crossfire between France and the UK, thousands of migrants, trying to escape poverty and persecution, are risking their lives in the perilous water of the English Channel. These migrants are mainly from Afghanistan, Iran, Eritrea and Sudan.

A humanitarian crisis is snowballing in Europe, but France and the UK are busy playing a blame game. The flashpoint came after 27 migrants including 17 men, seven women and three teenagers, perished November 24 when their boat, an inflated dinghy, sank in the English Channel. This is the biggest tragedy ever, as France's Interior Minister Gerald Darmanin said, involving migrants on the dangerous crossing till date. In all, 31 people were believed to have been on the boat. Their nationalities are still not known. The disaster was only waiting to happen. There seems to an endless stream of people who have been risking their lives in perilous journeys in small inflated tubes that are not seaworthy at all. This is being done in the hope of getting asylum or better opportunities in Britain. In the latest mishap four suspected traffickers were arrested on suspicion of being linked to the sunken boat. 'Human smugglers' have been operating in this lucrative business of ferrying migrants to European countries. As Darmanin pointed out, "It's a day of great mourning for France and Europe for humanity to see these people die at sea.' The minister also lashed out at criminal traffickers luring thousands to cross the English Channel at great risk to their lives.

Britain's Prime Minister Boris Johnson did not lag behind when he expressed his shock and urged France to step up efforts to stem the flow of migrants across the English Channel. He did not waste time blaming France for the tragedy which, according to him, highlighted how efforts by French authorities to patrol their beaches "have not been enough." The two governments have long been at loggerheads over how to prevent the crossings, with each side blaming the other for not doing enough.

Both, French President Emmanuel Macron and British Prime Minister Boris Johnson are busy furthering their political interests as a diplomatic row has erupted between the two countries. France has cancelled its invitation to British home secretary Priti Patel who was scheduled to hold talks on this issue in Paris November 28. Macron is going to face the electorate soon in the Presidential election and migrants' plight is a major issue. On the other hand, Johnson has to serve his supporters with huge funds who are dead against the tide of migrants flowing into the country which the pro-Brexit Johnson-government is committed to stem.

Migrants from around the world have long been using northern France as a launching pad to reach Britain. They have been stowing away in trucks or in dinghies and other small boats organised by smugglers to reach the UK. People fleeing conflict at home have been flocking to towns in northern France for the past few years. The number of such migrants using small boats to cross the channel has grown sharply this year, despite the high risks that are worsening in autumn weather. This is because the COVID-19 pandemic has made it virtually impossible for the migrants to hide themselves in trucks and cross over to the UK, as the pandemic has taken a heavy toll on the movement of trucks. Over 25,700 people have made the dangerous journey in small boats this year alone. This is three times the total for the whole of 2020. French and British authorities have picked up thousands of migrants off both the French and British coasts in recent weeks in scores of rescue operations

But, their efforts are not good enough and there is need for devising better ways to avert repeated human tragedies. Tom Davies, Amnesty International UK's refugee and migrant rights campaign manager, has eloquently summed up the situation when he lamented, "How many more times must we see people lose their life trying to reach safety in the UK because of the woeful lack of safe means to do so?" For years, smugglers have been at work sending migrants to Europe, especially in the UK where the labour policy is such that hired workers need not produce identity cards. This makes the UK the most coveted destination for such migrants leading to tragedies on both land and sea routes. The most horrific case was the death of 39 Vietnamese people who were found dead in a refrigerated truck in 2019.

Europe's migration policy is undoubtedly flawed as the flow of migrants is continuing despite the European countries grudgingly accepting migrants into their soils. For example, 83,000 asylum applications were lodged in France over the past year against 31,000 in the UK. In 2020, the UK registered 5.78 asylum seekers and refugees per 10,000 inhabitants against 16.93 by France, 19.52 by Germany and 60.57 by Greece.

The Anglo-French tussle stems from the fact that the rule for detecting and handling migrants in a humane way that was being followed in the European Union is no longer valid for the UK after the latter implemented its Brexit policy. Under that rule France cooperated with Britain as the onus of bearing the burden of migrants is on the first country where they are found. But after Brexit, the UK is not bound to accept the migrants who set their feet first on its soil. For this reason, it wants stricter vigilance in northern France and is ready to work jointly with France. This runs counter to France's interests of letting its territory to be used as the migrants' gateway to the UK. The war of words - Johnson's letter to France on the migrants' death posted in his Twitter handle and Macron's sharp reaction - does not help matters apart from scoring political brownie points. The two countries need to put their heads together and find a way out of the human tragedy being enacted on both their territories

GROWTH ON HIGH DEBT

ndia joins the world aiming for a super growth on a high debt and infra push for an economic panacea. India's heavy investment over ₹233.08 lakh crore investment in infrastructure, of which the ₹10500 crore Jewar airport in Uttar Pradesh, is officially expected to give a major boost to the economy.

India is not alone as the entire world is trying to do give that needed push. The result is hyper growth in world debt to \$226 trillion. In its 2021 Fiscal Monitor report, the International Monetary Fund (IMF) said India's debt increased from 68.9 per cent of its GDP in 2016 to 89.6 per cent in 2020. It is projected to jump to 90.6 per cent in 2021 and then decline to 88.8 per cent in 2022, to gradually reach 85.2 per cent in 2026. After that, it's projected to stabilise at about 97 per cent of GDP. In a year, India's external debt alone increased by \$11.6 billion.

Jewar international airport has accelerated a process of development in UP with an eye on the ensuing Assembly elections. It may make this part of the National Capital Region one of the most crowded places, inviting large number of migrants that may stress the local resources. Still hopes have been raised and it is certain that cash flow in the region would increase for now.

The withdrawal of the three farm laws has raised aspirations but also rivets eyes to the continuing farm unrest, which the officials say is no more warranted. But severe crash in the stock market has added to a new nagging concern.

The nation hopes to fly on expectations. Similar airport projects, high altitude Himalayan development, large tree felling and acquisition of farm lands across have ecological concerns. But a nation striving hard to come out of the pandemic is certainly looking for a fast development course so that there is cash flow.

The government expanded the National Infrastructure Pipeline (NIP) to 7,400 projects. According

to Department of Industry and Internal Trade, 217 projects worth ₹1.10 lakh crore (US \$15.09 billion) were completed as of 2020. Through the NIP, the government invested US\$ 1.4 trillion in infrastructure development as of July 2021.

A major aspect of this development is infrastructure. It looks good but it is also true that more the investment is made in infrastructure, the nation's cost to delivery increases and in the long run unless there is an overall growth in activities -- from industry to agriculture -- the benefits become expensive to afford.

The IMF says that constraints on financing are particularly severe for poorer countries. Noting that in 2020, the fiscal policy proved its worth. IMF Director for fiscal affairs Vitor Gasper, says the increase in public debt then was fully justified by the need to respond to COVID-19 and its economic, social, and financial consequences. But the increase is expected to be one-off, he added. So

how to scale down the debt needs to be of concern.

These debt dynamics are driven by a strong contribution from nominal GDP growth, accompanied by a much more gradual reduction in the primary deficit, said Gasper. This is a matter of long term concern. It is indicative of a difficult situation continuing for some time. Besides, in its report, the IMF said risks to the fiscal outlook are elevated. This calls for India to review its policies. Let us not forget the 2007-08 global economic meltdown that followed an unsustainable financial behaviour. The results would be high in-

flationary tendencies that would add to the costs further and create an unstable global economy leading to more conflicts and further costs. India's inflation has risen to 12.5 per cent. It is adding to a number of costs, as prices rise wages too rise and a cycle of inflation may well continue. It is also being seen in a regime of high taxations and high penalties on cars and

car uses across the country.

The silliest is the clampdown on outside state registered vehicles in Bihar, and HSRP plates. These are ignored as small issues but these small things are making lives of people difficult. User charges are being recklessly increased. At some railway stations, parking charges are going through the roof. Ostensibly, nobody can be blamed as 'the prices are rising' but that needs a holistic review.

The IMF projects growth at 9.5 per cent in FY2021-22 and 8.5 per cent in FY2022-23. The contraction in economic activity, lower revenue and pandemic-related support meas ures are estimated to have led to a widening of the fiscal deficit to 8.6 and 12.8 per cent of GDP in FY2020-21 for the Central and State governments, respectively.

It notes that fiscal policy continues to support the economy. But the IMF is concerned that despite policy support, bank credit growth has remained subdued, while large corporates have benefited from easier conditions in capital markets. Net inflows and improvement in the current account have supported an increase in foreign exchange reserves. The current account balance is projected to remain in deficit as oil prices rise.

The overall toned down IMF report indicates not an easy situation in the coming years. The concern of the Narendra Modi government is high. It wants to take the economy to a new level through high cost push projects in the hope that there is relief and the government could take credit for solving a difficult situation. It would do well to review the situation once again though it may not be easy in a country where people look for fast solutions.

Steering the country to stabilitv is not easy. It is true that international organisations are cautious while performing governments feel their efforts are being tried to be stymied. India hopes that Modi's efforts belie IMF projections and infra push takes the country to the targeted growth.

Precrastination

any of us are procrastinators, putting off inescapable tasks as long as possible. At Pennsylvania State University, David Rosenbaum and colleagues Lanvun Gong and Corv Adam Potts carried out experiments on the matter which they wrote up in the July 2014 issue of Psychological Science. Subjects were asked to pick up a plastic bucket and take it to the end of an alley. One bucket was close to the starting point, the other much nearer the goal. Surprisingly, the experimenters found that subjects tended to pick up the bucket closer to them and carry it a greater distance to the goal. This persisted even when the experimenters loaded the buckets with seven pounds weight of pennies. When asked why they did this, rather than picking up the bucket nearer the goal and so doing less work, the subjects tended to say that they "wanted to get the task done sooner". The research report suggests that these results imply we often begin jobs earlier than needed in order to get them out of the way, even if it means additional effort. People appear wired to incur a significant physical cost to eliminate the mental burden of knowing that something has to be done. The researchers invented the term precrastination, supposedly the opposite of procrastination. This attitude might seem desirable, but it has been suggested it can be a disguised form of procrastination, by which we tire ourselves out doing trivial and nonurgent tasks which we think of as clearing the decks before getting down to the really important stuff.

Extensive international inspections were put in place. Iran pledged never to develop nuclear weapons.

Experts estimated that these arrangements meant Iran would need up to a year to produce nuclear weapons if it chose to do so and that inspectors would likely catch it in the process. Most of the constraints central to the 2015 accord, however, included 'sunset' provisions, meaning they expire over a 10-15year period.

Once those restrictions disappeared. Iran would need considerably less time to develop a full-

and Iran was given considerable relief from extensive economic sanctions.

Iran chose to comply with the JCPOA. Nevertheless, three years later, in 2018, under President Donald Trump, the US unilaterally exited the accord, which Trump described as 'horrible' and 'one of the worst and most one-sided transactions.' He then imposed a new set of draconian sanctions. Shortly thereafter, Iran moved to keep international inspectors at a distance and steadily edged closer to being in a position to produce nuclear weapons. There is strong evidence that it has enriched sufficient uranium to near the level one or more weapons would require.

Under President Joe Biden, the US has expressed its desire to reenter the pact (negotiated while Biden was vice president) and has urged Iran to do the same. With a new president of its own (Ebrahim Raisi) in place, Iran has declared its readiness to do so, but only if the Trump-era sanctions are first rescinded. If the negotiations lead both sides back into the JCPOA, it would buy close to a decade of limits on Iran's nuclear programme in exchange for lifting many but not

Second, there is no reason to believe that Iran would ever sign on to a 'longer, stronger' nuclear deal (a JCPOA 2.0) that places more severe constraints on its nuclear program for a longer period. Nor is there reason to believe that Iran a decade hence will be fundamentally different in its political makeup or in what it seeks.

In addition, Iran could carry out relevant weapons development in hidden locations that would build on what it has learned in the last few years - activity that could augment the quality and quantity of any nuclear weapons should it decide to pursue them.

The question is not if, but when, we reach this juncture: in months if the negotiations fail, or in less than a decade if they succeed. An Iran allowed to field nuclear weapons or get close to such a point (becoming a threshold nuclearweapons country) would likely be even more aggressive in its efforts

Both Trump and Biden made clear their desire to reduce American military involvement in the Middle East. Because of Iran, making good on this aim looks increasingly unlikely.

Tobacco menace

Sir, The Odisha government has banned the sale and manufacture of gutkha and paan masala. The then state Health Minister Damodar Rout had said that the government would issue required notification under the Food Safety and Standards (Prohibition and Restrictions on Sales) Regulations, 2011, in two to three days, but the present scenario is quite different now. Almost half of the population of Odisha is addicted to tobacco in one form or the other, as per the latest National Family Health Survey (NFHS-2021). According to the survey, 51.6% men of 15 years and above and 26% women in same age category in Odisha are exposed to the use of tobacco. Interestingly, the survey highlighted that the use of tobacco in rural areas is more than that of urban areas. The survey has revealed that approximately 54.1 per cent men and 28 per cent women use tobacco in rural areas as compared to 40.5 per cent men and 16.6 per cent women in urban areas. 18 killed in WB road mishap

Kolkata, Nov 28: At least 18 people were killed during a funeral procession when a vehicle carrying the remains of the deceased rammed into a stationary truck in West Bengal's Nadia district early Sunday, a police officer said.

The victims included six women and a child, he said. Top leaders, including Prime Minister Narendra Modi, Union Home Minister Amit Shah and Chief Minister Mamata Banerjee, have condoled the loss of lives. A mini truck, carrying over 35 people and the bier, hit another stone-laden truck parked on one side of a state highway in Hanskhali around 3 am, killing 12 on the spot, the officer explained. Six others succumbed to their injuries on the way to the hospital or during treatment. Local people and the police shifted the injured to Shaktinagar General Hospital, where doctors, after examining their condition, referred the critical ones to another



medical institution in Krishnanagar. According to the police officer, low visibility due to fog may have led to the accident.

One of those injured said he and others were heading to Nabadwip cremation ground from Chakdah when the accident took place. The PM, taking to Twitter, said, "Extremely pained by the loss of lives due to a road accident in Nadia, West Bengal. My thoughts are with the bereaved families. May the injured recover at the earliest.' Shah, too, prayed for strength and well-being of the grieving families.

UPTET CANCELLED AFTER PAPER LEAK, **26 ARRESTED**

Lucknow, Nov 28: The UPTET scheduled to be held Sunday was cancelled after a question paper for the exam was leaked, an officer here announced shortly before the exam was to begin.

In a statement issued here, the UP Government said that more than 26 persons have been arrested in this connection. Those arrested in Prayagraj include Satya Prakash Singh, an assistant teacher at a primary school in the city's Shankargarh area.

When searched, he was found to have the solved question paper in his WhatsApp. Rajendra Patel - the alleged mastermind of the whole operation - and Chaturbhuj Singh, one of the key players, were also among those arrested from Prayagraj, according to the statement. Besides them, police arrested other members of the gang. including one Sunny Singh, who was instrumental in sourcing solvers from Bihar, the statement said. Four persons were arrested from Lucknow district, and one each from Kaushambi, Ayodhya, and Ambedkarnagar district. Three persons were arrested from Shamli district. These three had procured 10 copies of the question paper for Rs 5 lakh, and had taken Rs 50,000 from 50-60 candidates each to give them access to the papers for reading and memorising. Search is on for the rest of the members of the gang, the government said.

According to experts, getting vaccinated looks like the best available option at present and it can be a game-changer in fighting against the new variant of Covid. "So far, it appears that those who are not vaccinated are at very high risk of getting affected by the severe disease," Ravi Shekhar Jha. Additional Director Pulmonology, Fortis Escorts Hospital, Faridabad, told IANS.

Therefore, vaccination is the best available option at present which can be a game-changer," Jha added. The experts said that we need to understand that the pan-

demic is not yet over and therefore we should not lower our guards and restart taking full precautions as before including social distancing.

OMICRON CONCERN

"The new variant of Covid Omicron has several mutations from previous Covid-19 strains," said Animesh Arya, Senior Consultant in Respiratory Medicine, Sri Balaji Action Medical Institute, New Delhi. "People need to understand that Covid appropriate behaviour and vaccination are the only ways to stay safe from this variant," Arya added.

The new variant identified in South Africa has left the scientific community worried, as they fear that this new strain could fuel outbreaks in several countries and cripple health systems once again. Meanwhile, Indian health experts mentioned that it is premature to say if we are about to face the third wave. However, the kind of carelessness that India has seen in the last few months, if the omicron enters the country, it may have a detrimental effect.

"Do not lower our guards and restart taking full precautions as before including social distancing," Arya said. The South African health officials said the new variant has many more mutations than scientists expected, especially after a severe wave, which was driven by the Delta variant.

Many of the mutations are of concern for immune evasion and transmissibility. It carries a high number of mutations in its spike protein, which plays a key role in the virus' entry into cells in the human body.

Casteism not annihilated after 75 yrs of Independence: SC

New Delhi, Nov 28: Incidents of caste-motivated violence show that casteism has not been annihilated

even after 75 years of independence and it is high time civil society reacts and responds with "strong disapproval" about the ghastly crimes committed in the name of caste, the Supreme Court has said.

The apex court, which delivered its verdict on a batch of pleas in a 1991 Uttar Pradesh honour killing case, in which three persons, including a woman were killed, said it had earlier issued several directions to authorities to take strong measures to prevent honour killings. Those directives should be carried out without any further delay, it said.

A bench headed by Justice L Nageswara Rao also said that to avert trial getting tainted and "truth becoming a casualty", the State has a definite role to play in protecting witnesses, to start with, at least in sensitive cases involving



those in power who have political patronage and zcould wield muscle and money power.

"Two young men and a woman were physically assaulted for nearly 12 hours and killed by the accused

for violating caste-ridden societal norms. These episodes of castemotivated violence in the country demonstrates the fact that casteism has not been annihilated even after 75 years of independence," the bench, also comprising justices Sanjiv Khanna and B R Gavai, said.

The top court, while upholding the Allahabad High Court verdict with regard to conviction of 23 accused in the case, acquitted three persons in view of ambiguity in their identity. Referring to the aspect of witness protection, the bench noted that 12 prosecution witnesses in the case turned hostile.

"Even if the witnesses have turned hostile, their evidence can be accepted, if they are natural and independent witnesses and have no reason to falsely implicate the accused," it said. The apex court said the right to testify in courts in a free and fair manner, without any pressure and threat whatsoever, is 'under serious attack today', and if one is unable to testify in courts due to threats or other pressures, then it is a clear violation of the rights under articles 19 (1) (a) and 21 of the Constitution.

The bench said one of the main reasons why witnesses turn hostile is that they are not accorded appropriate protection by the State. It is a "harsh reality", particularly, in cases where the accused are influential people and are tried for heinous offences and they make attempts to terrorise or intimidate witnesses, the bench said.

The bench said that as a protector of its citizens, the State has to ensure that during a trial a witness can safely depose the truth, without any fear of being haunted by those against whom he or she has deposed. It noted that according to Dr B R Ambedkar, inter-caste marriage is one rem-edy to get rid of casteism in order to achieve equality.

Agartala, Nov 28: Tripura's ruling BJP pulverised Mamata Banerjee's TMC and the Left Sunday, capturing with surprising ease the Agartala Municipal Corporation and 13 other civic bodies where it now has 329 of the 334 seats.

Contesting its first civic polls after it stormed to power in the northeastern state in 2018, the saffron party steamrollered a feeble challenge from the opposition after a vitriol-filled campaign marked by communal tension, clashes and court battles that forced the Supreme Court to intervene and order peaceful polls.

Not a single opposition candidate could win from any ward of the 51-member Agartala Municipal Corporation all of which went to the BJP.

The saffron party's domination was so complete that it secured all the wards in the 15-member Khowai Municipal Council, 17-seat Belonia Municipal Council, 15-member Kumarghat Municipal Council and nine-member Sabroom Nagar Panchayat, state election commission officials said.

Snail species discovered in Meghalaya

Shillong/Agartala, Nov 28: The scientists, who recently discovered a new micro snail species with less than 2 mm in length (adult) in a Meghalaya cave, are conducting a study on mollusc across northeast under a mega project funded by the Department of Biotechnology under the Central government.

Scientists Nipu Kumar Das and NA Aravind, both associated with the Bangalore-based Ashoka Trust for Research in Ecology and Environment (ATREE), recently discovered the new micro snail species, found deep inside a limestone cave at Mawsmai village in Meghalaya's East Khasi Hills district

'We have named this species after the limestone cave. Our species Georissa mawsmaiensis is unique from Georissa sarrita, the closest congener (meaning other members of the same genus), which was earlier described from the Mawsmai vallev of Meghalava, in its shell morphology starting from shell size variation to the presence of four very prominent spiral striations on body whorls of the shell (counting from the suture to aperture, in apertural view), compared to seven in Georissa sarrita," Das told IANS. He said the team compared the morphological characters of the collected snails on the moist limestone rocks, 4-5 metre inside the cave entrance. "However, at present, we don't know whether our species is a true cave species. Further extensive surveys may reveal more interesting facts about natural history, its true distributional patterns, and so on." According to ATREE, the micro snail species

Das said that in the case of the Mawsmai cave in

According to the scientist, these anthropogenic changes along with high tourist influx may pose a threat to this micro snail species, as well as other cave biodiversities.

"Till now, only five snail species have been reported from Meghalayan caves, while there may be many more awaiting discovery. Even though there are so many limestone caves in Meghalaya, very few studies have been conducted on snails from these caves. More studies would help us understand the snail diversity present in these unique cave ecosystems," Das said.





The objective of the CAA is to grant Indian citizenship to persecuted minorities -- Hindu, Sikh, Jain, Buddhist, Parsi and Christian -- from Pakistan, Bangladesh and Afghanistan. People from these communities who had come to India till December 31, 2014 due to religious persecution in these countries will not be treated as illegal immigrants but be given Indian citizenship.

'Nearly all ultras involved in civilian killings neutralised'

New Delhi, Nov 28: Nearly all the terrorists involved in the killings of civilians in Jammu and Kashmir last month have been neutralised and the armed forces are now focussing on intelligence-based "surgical operations" involving smaller teams to deal with terror activities in the Union Territory, sources in the security establishment said Sunday.

They said a "refined" approach to deal with terrorism has been put in place under a more nuanced framework of better coordination among the Jammu and Kashmir police, the intelligence agencies and the Army with an aim to minimise collateral damage. After a spell of relative calm, Jammu and Kashmir witnessed a spate of killings of innocent civilians last month, triggering apprehensions of an intense cycle of violence



and turmoil in the region. The sources said a major focus of the anti-terror drill has been to achieve "zero loss" of innocent lives and all wings of the security forces have been trying to achieve it. That is why the focus has been on "intelligence-based surgical operations" involving smaller teams, with a focus on drawing support from the local population to such actions, they added.

They said 24 civilians were killed and 49 injured in various counter-terror operations in 2018.

Over the past three years, the security forces undertook a series of measures to ensure minimum collateral damage and as a result of such efforts, only two civilians were killed and two received minor injuries in 2021, the sources said.

Asked about the encounter in Srinagar's Hyderpora, they said a certain section is focussing on it to occupy "lost space".

The sources said the security forces have been getting support, including actionable intelligence. from the locals in several parts of Jammu and Kashmir as they have rejected the "false propaganda" unleashed by Pakistan.

The sources claimed that the situation in Jammu and Kashmir has been under control and pointed out that compared to the 318 terror-related incidents in 2018, only 121 incidents were reported in 2021. On October 7, terrorist Mehran Yaseen Shalla killed two teachers inside a government boys' higher secondary school at Safa Kadal, Srinagar. Shalla was killed by the security forces on November 24, the sources said.

Terrorist Adil Ah Wani killed Sageer Ahmed Ansari, a carpenter and a resident of Saharanpur, near the Litar bus stand in Anantnag. Wani was killed by the security forces in Shirmal Shopian on October 20 under the "Operation Dragad", the sources said, citing certain anti-terror operations.



Prime Minister Scott Morrison, whose conservative coalition government faces an election in the first half of 2022, said the law would protect Australians from online abuse and harassment.

Attorney General Michaelia Cash said the legislation, reportedly to be introduced to parliament by early 2022, was needed to clarify that the social media platforms, and not the users, were responsible for defamatory comments by other people. "Čonfusion had been sown by a

High Court ruling in September that found Australian media, as users managing their own pages on a social network, could be held liable for defamatory third-party comments posted on their pages,' Cash said.

"Under the planned Australian legislation, the social media companies themselves would be responsible for such defamatory content, not the users," she said. It would also aim to stop people making defamatory comments with out being identified, she said.

"The platforms could defend themselves from being sued as the publisher of defamatory comment only if they complied with the new legislation's demands to have a complaints system in place that could provide the details of the person making the comment, if necessary," Cash said.

People would also be able to apply to the High Court for an information disclosure order demanding a social media service provide details to unmask the troll, the attorney general said.

Taiwan scrambles to see off Chinese air force

Taipei, Nov 28: Taiwan's air force scrambled again Sunday to warn away 27 Chinese aircraft that entered its air defence zone, Taiwan's defence ministry said, the latest increase in tensions across the Taiwan Strait as China's president met his top generals.

Chinese-claimed Taiwan has complained for a year or more of repeated missions by China's air force near the democratically governed island, often in the southwestern

Josephine Baker, 1st Black woman honoured in French Pantheon

IN ADDITION TO HONOURING AN EXCEPTIONAL FIGURE IN FRENCH HISTORY, THE MOVE IS MEANT TO SEND A MESSAGE AGAINST RACISM AND CELEBRATE US-FRENCH CONNECTIONS

Paris, Nov 28: France is inducting Josephine Baker - Missouriborn cabaret dancer, French World War II spy and civil rights activist – into its Pantheon, the first Black woman honoured in the final resting place of France's most revered luminaries. On Tuesday, a coffin carrying soils from the US, France and Monaco — places where Baker made her mark - will be deposited inside the domed Pantheon monument overlooking the Left Bank of Paris. Her body will stay in Monaco, at the request of her family.

French President Emmanuel Macron decided on her entry into the Pantheon, responding to a petition lobbying for her "pantheonisation." "She embodies, before anything, women's freedom," Laurent Kupferman, the author of the petition for the move, told The Associated Press.

Baker was born in 1906, in St Louis, Missouri. At 19, having already divorced twice, had relationships with men and women, and started a performing career, she moved to France following a job opportunity. "She arrives in France in 1925, she's an emancipated woman, taking her life in her hands,



in a country of which she doesn't even speak the language,' Kupferman said.

She met immediate success on the Theatre des Champs-Elysees stage, where she appeared topless and wearing a famed banana belt. Her show, embodying the colonial time's racist stereotypes about African women, caused both condemnation and celebration

In September 1939, as France and Britain declared war against Nazi Germany, Baker got in touch with the head of the French counterintelligence services. She started working as an informant, traveling, getting close to officials and sharing information hidden on her music sheets.

Researcher and historian Géraud Létang said Baker lived "a double

life between, on the one side, the music hall artist, and on the other side, another secret life, later becoming completely illegal, of intelligence agent.'

She also raised funds, including from her personal money. It is



estimated she brought the equivalent of 10 million euros (\$11.2 million) to support the French Resistance.

After the war, Baker got involved

in anti-racist politics. She fought against American segregation during a 1951 performance tour of the US, causing her to be targeted by the FBI, labelled a communist and banned from her homeland for a decade.

The ban was lifted by President John F Kennedy in 1963, and she returned to be the only woman to speak at the March on Washington, before Martin Luther King's famed "I Have a Dream" speech.

While Baker is widely appreciated in France, some critics of Macron question why he chose an American-born figure as the first Black woman in the Pantheon, instead of someone who rose up against discrimination in France itself.

The Pantheon, built at the end of the 18th century, honours 72 men and five women, including Baker. There are two other Black figures in the mausoleum Gaullist resister Felix Eboué and famed writer Alexandre Dumas.

New Delhi, Nov 28: German luxury car maker BMW believes that reduction in import duties on electric vehicles (EV) for a limited time or for a limited number of units will help create demand in order to help manufacturing of such vehicles in India and bring new technologies quicker to the country, according to a senior company of ficial.

"What we always do is we create demand for a model and then lo-



calise it. We believe these new technologies also have a potential to be localised in future but you need to create a mass demand for that critical mass (for local manufacturing to be viable)." BMW Group India President and CEO Vikram Pawah told PTI.

The only way to do that, according to him, is to fast track it, create the demand before the infrastructure develops or create the demand which will create the infrastructure.

'Then we can localise by that time these technologies which are

what we are seeking from the government is very simple thing, that ves. let us have some reduction in import duties, but only for limited time or limited quantities.

The rationale behind such a demand, according to him is "it will allow us achieve both the objectives. We will be able to keep manufacturing into India, and we will be able to bring these technologies quicker into India." Reiterating that the company has consistently maintained this stand. Pawah said. "That is what our consistency has been always that at any point any new technologies we should do that. It will allow even safety technologies, environment, green technologies to come into India faster."

Currently, India imposes 100 per cent import duty on fully imported cars with CIF (Cost, Insurance and Freight) value more than \$40,000 and 60 per cent on those costing less than the amount.

of coal to the power sector by stateowned CIL rose 22.7 per cent to 291.72 million tonne (MT) in the first seven months of the ongoing fiscal year.

Coal India Ltd (CIL) had dispatched 237.75 MT of coal to the power sector in April-October period of 2020-21, according to monthly summary for the Cabinet for October.

The supply of coal to the power sector by CIL during the last month also increased 21.7 per cent to 47.67 MT, over 39.17 MT in the year-ago period, it said.



The fuel supply by Singareni Collieries Company Ltd (SCCL) to the sector in the seven months increased 66 per cent to 30.67 MT as against 18.47 MT in the year-ago period.

The coal supply by SCCL to the power sector during last month increased 41.7 per cent to 4.71 MT from 3.32 MT in the corresponding month of the previous fiscal year.

Coal India accounts for over 80 per cent of the domestic coal output. The company, which is eyeing one billion tonne of fuel output by 2023-24, will pump over ₹1.22 lakh crore in projects related to coal evacuation, exploration and clean coal technologies by 2023-24.

Out of this proposed spend, CIL has planned to invest ₹32,696 crore on coal evacuation, ₹25,117 crore on mine infrastructure and ₹29,461 crore on project development by 2023-24.

The company will also invest ₹32,199 crore on diversification and clean coal technologies, ₹1,495 crore on social infrastructure and ₹1,893 crore on exploration works.

The investment of ₹1.22 lakhcrore will be utilised to fund a total of 500 projects.

Kanpur, Nov 28: Debutant Shreyas Iyer (65, 15b, 8x4, 1x6) showed his ice-cool temperament under pressure to stand tall with a fine half century which placed India in a commanding position as they set up a stiff victory target of 284 for New Zealand on the fourth day of the opening Test at the Green Park here Sunday.

India declared at 234 for seven for an overall lead of 283 and gave the Black Caps four tricky overs to face under fading light during which they managed four runs and lost opener Will Young to Ravichandran Ashwin. With that scalp, Ashwin became the joint third highest wicket-taker in Indian cricket with Harbhaian Singh (417 wickets).

Along with Iyer, who became the first Indian to score a hundred and 50 on debut, Wriddhiman Saha (61 n o, 126b, 4x4, 1x6) also foiled any hopes that the Kiwis had. In spite of a stiff neck, Saha made an invaluable contribution which will certainly count a lot in the final context of the match.

Saha was involved in two crucial partnerships. First he put on 64 runs for the seventh wicket with Iyer and then added another



67 runs for the eighth wicket with Axar Patel (28 n o, 67b, 2x4, 1x6) to take the game away from New Zealand. When India were 51 for five in the morning session, it was Iyer, Saha, Patel and Ashwin (32, 62b, 5x4) who rescued the side. This is certainly an innings which will give Saha's Test career a new lease of life.

For the Kiwis, Tim Southee (3/75) and Kyle Jamieson (3/40)were the most successful bowlers on an unresponsive track.

If the morning belonged to New Zealand's bowlers, who decided to prolong Cheteshwar Pujara (22) and Ajinkya Rahane's (4) bad patch, the remainder of the two sessions belonged to India for which the dredit certainly goes to Iyer. He once again displayed steely tempera-

ment with some fine shots including huge six over long-off against Will Sommerville. His best shot, however, was an inside out lofted drive off left-arm spinner Ajaz Patel. It was a difficult shot that was perfectly executed.

Credit should also be given to Saha as he batted with an open-
