Resumption of int'l flights put off

New Delhi: The government decided Wednesday not to resume scheduled international flights from December 15, less than a week after announcing the decision in the wake of rising concerns over the Covid-19 variant Omicron. Aviation watchdog DGCA said the effective date for resumption of scheduled commercial international passenger services will be notified in due course. Scheduled international flights remain suspended since March 23. 2020, due to the coronavirus pandemic. The DGCA said that an appropriate decision will soon be taken in this regard.

33 students test +ve in Dhenkanal

Dhenkanal, Dec 1: Thirty three students of Saikrupa Residential College at Kunjakanta locality in this town tested positive Wednesday for Covid-19. Collector Saroj Kumar Sethi has declared Kunjakanta area in Ward No-2 of the town as a containment zone from December 1 to December 10. The news has spread panic among the local residents.

When contacted, CDMO Sujatarani Mishra said that initially four students had tested positive for Covid-19. Later; RT-PCR tests were conducted on 200 students living in the college hostel. The reports came out Wednesday which confirmed that 29 more students have tested positive. Principal Annada Mohanty said that a decision to close the college immediately was taken Tuesday

This is not the first occasion of mass infection among students since the state government decided to reopen educational institutions in a phased manner. Earlier 74 persons including MBBS students and staff of VIMSAR had tested positive for Covid-19 last week.

Ganjam wagon project derailed

■ Former Railway Minister Mamata Banerjee had proposed the setting up of the wagon factory in Sitapalli of Ganjam district. However, it now appears that the project has been shelved for good

New Delhi, Dec 1: The Centre did a U-turn Wednesday over the proposed setting up of a wagon construction factory at Sitapalli in Ganjam district with Railway Minister Ashwini Vaishnaw informing in the Lok Sabha that there is no such plan. Replying to a question by Biju Janata Dal (BJD) MP Achyutananda Samanta, the minister said that factories are set up keeping in mind the overall demand for wagons for the Railways and as of now there is no such re-



"The existing wagon manufacturing capacity in India is adequate. At present, there is no proposal to set up a wagon factory at Sitapalli in Ganjam district of Odisha," the minister said.

Vaishnaw also said that requirement of coaches via-a-vis available manufacturing capacity has been reviewed recently. Requirement of main line coaches in the near future also does not

justify immediately the construction of a new coach factory.

Significantly, the project at Sitapalli was announced by the then Railway Minister Mamata Banerjee in 2011-12 and was supposed to be implemented in PPP mode. However, the project was shelved in 2017 as the ministry cited lack of demand for wagons.

However, following Vaishnaw's visit to Odisha, the ministry decided to review the decade-old project in September this year. The decision was taken after different organisations reiterated their demand for setting up the factory during Vaishnaw's visit to Berhampur in September.

East Coast Railway had written a letter to the Revenue and Disaster Management department to expedite handing over the land for wagon project. A total of 101.6 acres land had also been identified for the project near Jagannathpur railway station, around 20 km from Berhampur. However, in May, the Railways had asked the state government to cancel allotment of land. But after the minister's visit it changed its stance.

'Since the project is under review, the letter on cancellation of land allotment is withdrawn. Therefore, kindly arrange to forward the land schedule. Handing over of land may be expedited," a letter to the Revenue Department from East Coast Railway stated.

Chief Minister Naveen Patnaik had also written several letters to successive Railway Ministers since the launching of the project. Vaishnaw's latest declaration certainly will come as a huge jolt to the state as the project would have created employment opportunities both directly and indirectly.

High drama in Odisha Assembly

Bhubaneswar, Dec 1: The Winter Session of the Odisha Assembly began on a stormy note Wednesday as BJP and Congress members created ruckus inside and outside the House over the Mamita Meher murder case.

Congress members carrying placards first locked the Assembly gates. Then they sat on dharna in front of those demanding the arrest and sacking of Minister of State (MoS) for Home, Dibya Shankar Mishra for his alleged involvement in the Mamita murder case. Among them were senior leaders like Suresh Routray, Taraprasad Bahinipati, Santosh Singh Saluja

and Mohammed Moquim. Later, employees of the Assembly broke the locks and opened the gates for the House to start proceedings. "We staged a demonstration to prevent the entry of the minister in the House. We will not allow the tainted minister to impure the sanctity of the sacred House," Bahinipati later said.

BJP members also met Speaker

enter the Assembly. The members were seen holding banners and black flags. They raised slogans against the government and Mishra on the floor of the House during the second half. They also demanded a CBI probe in the case.

However, all these issues did not seem to bother Mishra who had managed to enter the Assembly premises much before the Congress began their demonstration.

The House proceedings began at 11.00am with strict adherence to Covid-19 protocols. Chief Minister Naveen Patnaik attended the first day of the session through videoconference from his residence 'Naveen Nivas' here, while two members participated while sitting in conference halls of the State Secretariat and another from the district headquarters. Supplementary budget of ₹19K crore tabled

BHUBANESWAR: On the first day of the Winter Session of the Odisha Assembly, Finance Minister Niranjan Pujari tabled Wednesday the supplementary budget of ₹19,833 crore for the year 2021-22. Out of the total supplementary provision, ₹13,568 crore has been allocated towards programme expenditure, ₹4,577 crore towards administrative expenditure, ₹1,682 crore towards disaster management funds and ₹6 crore for transfer to local bodies (Panchayati Rai institutions and urban local bodies), said Pujari. He added that ₹8,256 has been provisioned for State Sponsored Schemes (SSS), ₹5,249 crore for Centrally Sponsored Schemes (CSS) and ₹63 crore for

Central Sector Schemes.

4 COPS BOOKED **FOR MURDER**

Bhubaneswar, Dec 1: The Crime Branch of Odisha Police has booked four police officers for murder over their alleged involvement in the custodial death of a person at the Jeypore Town police station in Koraput district in 2017. Akash Mahuria was allegedly beaten to death inside the police station, January 30, 2017.

The police had then washed their hands off the matter stating that Akash died as he suffered a bad fall while trying to evade the cops who were trying to arrest him.

The four police personnel who have been named in the case are Jeypore police station's former inspector-in-charge Tapan Narayan Rath, former sub-inspectors Siba Prasad Sahu and Rajesh Baliarsingh and former Jeypore sub-divisional police officer Rajendra Prasad Senapati. A case has been registered against the accused under Sections 302, 323, 342, 325, 505 and 34 of the IPC.

A team of the Crime Branch led by ASP Ramchandra Thamba will probe into the case.

Odisha gears up for 'Jawad'

Bhubaneswar, Dec 1: The Odisha government, asked Wednesday collectors of all coastal districts to step up preparations against the approaching Cyclone 'Jawad'. Even though the IMD is yet to predict the exact course of the cyclone, district administrations have been asked to remain alert. The IMD has said that 'Jawad' may hit coastal areas of Odisha as an Extremely

Severe Cyclonic Storm (ESCS). Notably, cyclonic storms having

wind speed of 167-221 kmph are categorised as Extremely Severe Cyclonic Storm by the India Meteorological Department (IMD).

Special Relief Commissioner (SRC) PK Jena said that the decision to put the coastal districts on high alert was taken in a high-level meeting chaired by the Chief Secretary Suresh Chandra Mahapatra. Apart from the coastal belt, the collectors of Mayurbhanj and Nayagarh districts have also been asked to be on high alert.

IMD DG, Dr Mrutyunjay Mohapatra said Wednesday that accurate prediction of the route will only be possible when the current low pressure system will intensify into a depression by Thursday. The IMD also issued 'pre-cyclone watch' for north Andhra Pradesh-Odisha coasts as the storm is likely to approach by December 4

No 'record', so no aid for deceased farmers' kin: Tomar

The Centre will not provide any financial help as it does not have 'data' on farmers who died during the protests against the farm laws

New Delhi, Dec 1: The government has 'no record' of the deaths of farmers who were protesting the three contentious laws – that have now been cancelled - over the last one year, Agriculture Minister Narendra Tomar informed the Parliament in a written reply, Wednesday.

Tomar was questioned on the data of deaths at farmers' protest sites near Delhi borders. He was also asked if the government is planning to give financial relief to the affected families. "The Ministry of Agriculture has no record in the matter regarding the deaths of farmers, and hence the question (of aid) does not arise," Tomar said.

Tomar's statement will certainly attract flak from the opposition. It comes in the wake of the Telengana government announcing ₹3,00,000 ex-gratia to the kin of the 700 farmers who died during the protests. Tomar's statement is quite close to the Centre's remark in Parliament on 'no oxygen deaths' data during the second Covid-19 wave. It also faced a lot of criticism.



More than 700 farmers have died, opposition and farmer leaders have said, during the yearlong protests at Delhi borders against the farm laws that were cancelled Monday in Parliament in one of the fastest repeals the country has recently seen.

Congress leader Rahul Gandhi also attacked the Centre for not allowing a discussion on this issue. We wanted to discuss MSP, the Lakhimpur Kheri incident where four farmers were run over and the 700 farmers who died in this agitation. However, the discussions were not allowed, stated the Congress leader.


While the rollback of the farm laws has taken place in Parliament, as sought by the protesters, farmers are now pressuring the Centre for assurance on the minimum support price (MSP) for their produce - another key demand.

PREZ ASSENT FOR FARM LAWS REPEAL

New Delhi: President Ram Nath Kovind gave Wednesday his assent to the Farm Laws Repeal Act 2021 that was passed by both Houses of Parliament by voice vote Monday. First, the Lok Sabha and then the Raiva Sabha passed 'The Farm Laws Repeal Bill 2021' by voice vote sans a debate amid heavy sloganeering by the Opposition that wanted a discussion on the issue. In both the houses, the Bill was passed within minutes of introduction by the government. Farmers across India under the Samyukt Kisan Morcha (SKM) banner had been agitating since last one year demanding

repeal of the three farm laws.







Ensure street vendors trained on food safety: CS

Bhubaneswar, Dec 1: The state government Wednesday asked the officials to sensitise street food vendors on the adverse effects of adulterated food on health.

Holding the state-level food safety advisory committee meeting on digital mode, Chief Secretary Suresh Chandra Mahapatra said selling adulterated food is a crime akin to selling adulterated drugs. And it must be dealt with an iron hand.

Highlighting the need to sensitise street food vendors on the ill effects of adulterated food, the Chief Secretary asked the officials to ensure food vendors are oriented and trained on preparation of safe food.

Mahapatra asked the officials to collect intelligence from public and police on the quality of food being sold in towns.

The Chief Secretary asked the



officials to hold district-level food safety meetings regularly in a bid to keep tabs on sale of safe food by street vendors and food business op-

Food Safety Commissioner Yamini Sarangi said the State Food Testing Laboratory's capacity has been upgraded. "The lab has been accredited by the National Accreditation and Calibration Board. Besides, a mobile laboratory has been rolled out for testing food quality at fairs and public functions," added Sarangi.

The meeting decided to explore possibilities for providing accommodation to food safety officers at the district headquarters hospitals.

Additional Chief Secretary RK Sharma directed the Food Safety Commissioner to assess require-

ments for up-scaling collection and testing of food samples.

Sources said as many as 3,049 food samples were collected and tested by way of surveillance and enforcement in 2020-21. Out of it, 576 samples were booked under adulteration and misbranding. Similarly, 1,984 samples were tested by end of October of 2021-22. Out of it, 446 were booked under adulteration or misbranding. This apart, 280 cases were compounded with fines.

It was learnt that Odisha's rank in Food Safety Index has gone up to four in 2020-21. It was 26 in 2018-19 and 13 in 2019-20.

Bhubaneswar, Dec 1: The State Transport Authority (STA) Wednesday initiated a training programme, 'Vahak', in a bid to improve the skills of heavy vehicle drivers, thereby reducing road mishaps and the consequent casualties.

 $The \, programme, which \, is \, jointly \,$ being executed by STA, Odisha Mining Corporation (OMC) and Ashok Leyland Ltd, will provide training to 1,000 drivers of OMC during the first phase. Drivers in batches of 60 will undergo training on skills, fuel efficiency, first aid, road safety and road signage for three days. The drivers will be provided with stipend for three days' training programme.

Inaugurating the event, Odisha Skill Development Authority chairman Subroto Bagchi said, "We lost around 10,000 people during the tsunami. India loses 1.5 lakh lives due to road accidents every year which is equal to 15 tsunamis. Unfortunately, we don't realise the graveness of the situation because these are isolated incidents. Road



accidents are a serious cause of concern for all of us. This has serious impact on families and our economy.

Appreciating the efforts of truck drivers during Covid 19 lockdown, Bagchi added, "Truckers are the ultimate lifeline who maintained critical supply chains of food and goods that were high in demand during the lockdown. The refresher training programme will hone the skills of drivers which in turn will help reduce accidents in the state."

Meanwhile, Transport Commissioner Arun Bothra said, "In India, there is hardly any formal training for HMV drivers. There are very few HMV drivers training tracks in the country. Generally, helpers over a period of time become HMV drivers without proper training. Project Vahak is conceived to bridge the gap and enhance the skills of these drivers.'

Orange warning issued for 8 districts

Bhubaneswar, Dec 1: The India Meteorological Department (IMD) Wednesday issued orange warning for eight districts as the low pressure area is all set to intensify into a deep depression Thursday and later a cyclonic storm.

The IMD said, "Cyclone 'Jawad' is likely to move west-northwestwards and concentrate into a depression over southeast and adjoining east-central Bay of Bengal by December 2.

Subsequently, by December 4 the system is likely to move northwestwards, intensify further and reach near north Andhra Pradesh - Odisha coasts," IMD director Mrutyunjay Mohapatra said.

However, Mohapatra also said the

cyclone may change its course and may not cross the coast. It may rather move in north-northeast direction. Or, it may cross the coast and move towards West Bengal. However, in both cases, Odisha will experience rainfall activities.

> The IMD also predicted that intensity of rainfall in Odisha will increase from December 4, especially in coastal districts while interior dis

tricts will experience heavy to very

heavy rainfall. Orange warning has been issued for Mayurbhanj, Balasore, Bhadrak, Kendrapada, Jagatsinghpur, Jajpur, Cuttack, and Puri for December 5. Some places of Keonjhar, Angul, Dhenkanal, Nayagarh, Khurda, Ganjam and Gajapati districts are also likely to witness heavy rainfall on that day, the Met centre said.

CURBING POLLUTION THE SOLAR WAY

Bhubaneswar, Dec 1: National Pollution Control Day is observed December 2 every year in remembrance of those who lost their lives in the Bhopal Gas tragedy when the deadly gas, methyl isocyanate, leaked out of the Union Carbide plant on the intervening night of December 2 and

The day is observed to spread awareness about pollution and its disastrous consequences.

Among all sources of energy, solar power is one of the best ways to reduce pollution, including water and air pollution. Solar power does much more than just saving money on energy bills. Increased use of solar power is one way to significantly diminish water pollution caused by coal and oil-fired

power plants. Similarly, solar energy production does not contribute to release of greengases into atmosphere. According to sources, Odisha government is taking a slew of measures to promote solar energy and the Odisha Renewable Energy Policy, 2016 sets a target of generating 2,200MW additional solar power by 2022. This includes rooftop and other

non-land based solar projects. For states like Odisha, which is prone to cyclone, rooftop solar panel



system installation helps in generating electricity when conventional power remains cut off for weeks.

Urban planner Piyush Ranjan Rout, who has been using 1-KW off-grid solar panel since 2011, said, "Rooftop solar is handy. It helped us during natural disasters such as Cyclone Fani and in other emergencies. We now have plans to expand it so as to make it climate smart. I wish every other household and real estate developer invest in climate neutrality by installing solar projects.'

JK Rath, an industrialist who had installed 3KW rooftop solar power system in 2018, said, "You can get your investment back within five years. Five years ago, I was paying a monthly electricity bill of around ₹4,500-5,000. When I installed a solar geyser, the bill got reduced by ₹600-800 a month." Many institutions in the city like Unit VIII DAV School, Xavier University and others have installed rooftop solar power system. Unit VIII DAV School officials spoke about gen-

eration of 80 per cent of their energy

need from rooftop solar panels. Jayant Sahoo, an engineer at SolarSack, said, "People understand that solar power helps in reducing carbon emission as well as energy bills. People in Capital city usually prefer on-grid system to off-grid system. We have seen 20-30 per cent of the city population shifting to solar power. We also provide 30-40 per cent subsidy on individual solar projects."

Odisha Renewable Energy Development Agency (OREDA) joint director Ashok Choudhary said,

HARNESSING SUNRAYS

Solar power is harnessed using solar photovoltaic (PV) technology that converts sunlight (solar radiation) into electricity by using semiconductors. When the sun hits the semiconductor within PV cell, electrons are freed and bus bars collect the running electrons which results in electric current. Solar energy also slashes electricity bills upto 50% and has long life of upto 25 years. The two types of solar power system which are normally used are: On-grid solar power system/grid interactive system and off-grid solar power system/standalone system.

"Bhubaneswar is one of the 60 cities identified by the Ministry of New and Renewable Energy for Solar City project. We are preparing a concept note which will be submitted to the Energy department.'

He also said the state government with assistance from the Centre is working hard to make Konark India's first ever zero emission town by September 2022.

The government agencies involved in the work claimed that several aspects of the project have already been completed.

Normal to above normal min temp in winter: IMD

INDO-ASIAN NEWS NETWORK

New Delhi, Dec 1: The winter season from December 2021 to February 2022 is likely to experience normal to above normal minimum temperature over many parts of northwest India, most parts of south and northeast India and some areas along the foothills of the Himalayas, the India Meteorological Department (TMD) said Wednesday.

Below normal minimum temperature is most likely over some parts of north-interior peninsula that comprises north Karnataka, parts of Telangana and Marathwada

In its seasonal outlook for winter temperatures, the IMD said that below normal maximum temperature is likely to prevail over most parts of the country except for some parts of northwest India and most parts of northeast India, where



normal to above normal maximum temperature is most likely.

Stating that weak La Nina conditions are prevailing over the equatorial Pacific region currently, the IMD said its forecast models indicate that La Nina conditions are likely to strengthen and peak to moderate conditions during the

upcoming winter season.

"At present, neutral Indian Ocean Dipole (IOD) conditions are prevailing over the Indian Ocean and the latest forecast indicates that neutral IOD conditions are likely to continue during the forecast period," IMD Director General Mrutyunjay Mahapatra said.

Below normal minimum temperature is most likely over some parts of north-interior peninsula that comprises north Karnataka, parts of Telangana and Marathwada

The IMD has been using the latest Monsoon Mission Coupled Forecasting System (MMCFS) model for its forecasts this year. It assesses five global models and takes the best of them.

La Nina refers to the large-scale cooling of the ocean surface temperatures in central and eastern equatorial Pacific Ocean, coupled with changes in the tropical atmospheric circulation, namely

winds, pressure and rainfall. It usually has the opposite effects on weather and climate as El Nino, which is the warm phase of the El Nino Southern Oscillation (ENSO).

"As the changes in the Sea Surface Temperature (SST) conditions over the Pacific and the Indian Oceans are known to influence the Indian climate, the IMD is carefully monitoring the evolution of sea surface conditions over these Ocean basins," he said.

Even the Polar Vortex influences India's conditions and the ensemble models account for all such factors, he added.

Elaborating on a question about the winter temperature forecast, the IMD DG said, "What we are saying is an average of the whole country. It does not mean that the temperature in a given area cannot go below normal or above normal against what we have predicted."

ECoR freight loads up 22% during April-Nov

Bhubaneswar, Dec 1: The East Coast Railway (ECoR) Wednesday stated that it has loaded 150.56 MT of freight during the period from April 1 to November 30 in the current fiscal. It was 123.72MT in the

corresponding period of last fiscal. With this, ECoR loaded 26.84MT incremental cargo during the current financial year by registering an increase of 22 per cent.

During the same period, 100.65 MT of freight carried from Khurda Road Division, 42.15 MT of freight from Waltair Division and 7.76 MT of freight carried from Sambalpur Division. In November, the zone also loaded 19.71 MT of freight as against 18.84 MT carried in the corresponding month last year - an increase of 5 per cent in loading. The zone has also surpassed

the loading target 145.53MT fixed by the Railway Board during the period. This could be possible due to outstanding performance of all the three divisions of East Coast Railway – Khurda Road, Waltair and Sambalpur," ECoR's release said. The statement also said that during the period, ECoR has loaded 84.93MT of coal, 5.25MT of raw material for steel plants, 14.06 MT of iron & steel, 20.37MT of iron ore, 0.75MT of cement, 1.98MT of food grains, 3.39MT of fertilizer, 1.74MT of petroleum oil and lubricants (POL), 2.73MT of freight loaded in containers and 14.96MT of other cargo

Bharatmala project hits hurdle in Koraput

PEOPLE WARN TO SCUTTLE WORK IF ACTUAL PRICE OF THEIR LAND IS NOT PAID

Koraput, Dec 1: The Bharatmala Pariyojana, a Centre-funded road and highways project, has hit a roadblock in Koraput district with land owners warning to scuttle work if they are not paid the actual price of their land to be acquired, a report said.

The matter came to the fore at a meeting of the stakeholders. The meeting was held under the aegis of Bharatmala Jami Surakshya Committee, an outfit under which land losers have come together to protect their cause.

Reports said the present distance between Raipur in Chhattisgarh and Vishakhapatnam in Andhra Pradesh is 514km. The distance will be reduced by 50 km when the highway project is implemented. After passing 124 km in Chhattisgarh, the highway will enter Nabarangpur.

The highway will pass through Nabarangpur for 115km before entering Koraput district. There it will pass through Borigumma, Dasamantpur, Koraput, Semiliguda and Pottangi tehsils before entering Andhra Pradesh

Experts have claimed the project will usher in a chain of prosperity and progress for Koraput district as the project is included in the economic corridor scheme of the

tehsil areas will have to part with their lands.

The issue of land price has sparked resentment among people. Buruda warned that they would resort to an agitation if their pleas are not addressed in time.

Bahinipati warned that the under-construction road in Bharatmala project was not for poor people for which he will make a demand in the State Assembly for payment of actual price of land. Bahinipati was elected as the new president of the outfit.

Two bank robbers shot at in Bhadrak

Bhadrak, Dec 1: Two criminals sustained bullet injuries following an encounter with Gramanchal police near Barapada village in Bhadrak district Wednesday. The two have been identified as Prahallad Das from Soro area and Sushant Mallick from Nilagiri area in Balasore district.

Prahallad and Sushant are suspected to be involved in an ATM loot to the tune of Rs 29 lakh at Charampa in Bhadrak. Further investigation is expected to reveal their involvement in more crimes.

Bhadrak police got information that the criminal duo was present near Barapada. A police team led Bhadrak Rural IIC Alok Kumar Jena raided the place. The two opened fire at the cops and tried to escape. In retaliation, the raid team

"An encounter took place following face-off with the criminals during a raid by Bhadrak police. The two sustained bullet injuries on their legs and were admitted to Bhadrak district headquarters hospital for treatment," a senior official said. Later, the two were shifted to Cuttack for advanced treatment.

Three guns, two swords and four magazines and cash have been recovered from the criminals, the senior official informed. Police have also detained four of their accomplices and are questioning them in this connection.

Notably, armed miscreants had looted around Rs 29 lakh from an ATM at Charampa area November 26 night. The video of the loot captured in a CCTV camera shows a masked man attacking three persons while they were loading the kiosk with the amount.

Case filed against five including three cops

sued a notice to the state home department, Berhampur SP and Golanthara police asking them to file a status report on the case.

The deceased had a spat with Ajit and Amit over some issue at a brick kiln under Golanthara police limits, May 3. On being informed, Golanthara police picked up Ganesh from the place and brought him to the police station where they detained him in the reception room and questioned him about the fight he had with the siblings. Later, Ganesh died in the custody the same day.

> Berhampur, Dec 1: As the three-tier panchayat elections are drawing closer, supporters of other political parties are reportedly headed for the Biju Janata Dal (BJD) in Ganjam. Amid such political jockeying, exodus and merger of party workers are going on in the BJD and the BJP. The Congress, which was humbled in 2017, has failed to match with the two parties.

Party deserters are being welcomed into the BJD and the BJP. The BJD has focused on Gopalpur constituency since MLA Pradip Panigrahy was ousted from



the party. For over a year, Gopabandhu Das, the political secretary to Chief Minister Naveen Patnaik, has been looking after the organisational work in the constituency.

There are 37 panchayats and four zilla parishad zones in the constituency. In the 2017 panchayat elections, the BJP had grabbed two ZP zones even though the ruling party had tried its level best to perform well in all the ZP zones.

Gopabandhu Das works hard to ensure that the BJD should win in all ZP zones this time. There is every effort by the BJD to wean away supporters from other parties.

Cost of Vax Inequity

The damage caused by COVID-19 – exacerbated by the continued appearance of new variants, most recently Omicron - has been catastrophic. More than five million lives worldwide have already been lost to COVID-19, and with confirmed cases on track to swell from 260 million today to 460 million by next autumn, the WHO estimates that five million more people may die from the disease in the coming months.

So, when the World Health Assembly (WHA) gathered for a special session that started November 29, its task was nothing less than preventing the recurrence of such a tragedy. Specifically, the world now needs an internationally binding agreement to prevent future infectious-disease outbreaks from becoming pandemics.

As Tedros Ghebreyesus, the WHO's director-general, has argued, a new agreement should be underpinned by a high-level commitment to health for all, grounded in equity and solidarity between countries. Everyone, regardless of their wealth or income, should have fair access to what they need to maintain their health, and the international community should ensure the equitable use and distribution of available medical resources. That will require a fully functioning global surveillance system, fast-tracking and sharing support in emergencies, and predictable finance.

Nothing illustrates more clearly the need for such an arrangement than the world's collective failure to ensure the promised equitable distribution of COVID-19 vaccines. Although brilliant science and a strong manufacturing effort mean that we will have produced 12 billion doses by the end of 2021 enough to vaccinate every adult in the world - 95% of adults in low-income countries remain unprotected. This is perhaps the greatest public policy fail-

The WHO's internationally agreed target of vaccinating 40% of the adult population of every country by December 2021 looks set to be missed by 82 countries. On current trends, it will take until next Easter to get close to 40%, and even then, dozens of countries may fall short. In fact, since the G7 summit in June, when leaders pledged that the whole world would be vaccinated against COVID-19 by 2022, the gap between the vaccine haves and have-nots has widened rather than diminished.

In high-income countries, vaccination rates have risen from 40% in June to roughly 74% now, but they have increased at a glacial pace in low-income countries - from 1% to less than 5%. For every adult now being inoculated in a low-income country, six adults in middle- and high-income countries are receiving their booster shots. And 73% of African health workers remain un-

True, important regional initiatives have taken steps to address the inequity gap. The African Union's vaccine-purchasing

facility, the African Vaccine Acquisition Trust, has bought 400 million single-shot vaccine doses from Johnson & Johnson and, thanks to the Trust's chair, Strive Masiyiwa, and the US government, a further 110 million doses from Moderna, with 50 million to be delivered by March. But this is still not enough to meet the needs of Africa's 1.3 billion people. This inequality is not difficult to explain: a

recent survey by Airfinity has shown that the world's richest countries have bought 89% of all COVID-19 vaccines, and currently retain control of 71% of future deliveries. The Global North has fallen short of its pledges to donate vaccines to the Global South. The US has sent only 25% of what it promised, while the EU, the UK. and Canada have performed even worse, dispatching just 19%, 11%, and 5%, respectively, of their pledged doses. The COVID-19 Vaccine Global Access (COVAX) facility, which had hoped to distribute two billion vaccines by December, now expects to deliver just three-quarters of that amount.

Such is the scale of vaccine hoarding in rich countries that Airfinity estimates that by the end of 2021, 100 million doses in the G20 stockpile will pass their expiration date and be wasted. For G20 countries to hoard life-saving vaccines and deny them to the poorest countries, while allowing tens of millions of doses

to go to waste, is a morally indefensible act of medical and social vandalism that should never be forgotten or forgiven.

Vaccine inequities show why more fundamental changes are needed in the international global public-health architecture of health decision-making. Of course, among international organisations, only the Appellate Body of the WTO and the International Criminal Court, whose decisions are final, have the freedom and authority to make binding decisions that national governments are obliged to follow. And because of that, these bodies are under assault from a coalition of anti-internationalists. Securing a binding treaty

There is already a global-health treaty to reduce tobacco demand and supply, and a 2011 agreement to ensure that the WHO can commandeer supplies of flu vaccine when needed. But the legally binding international pact necessary to enable global-health authorities to do more to prevent, detect, prepare for, and control a pandemic has so far eluded us. At a time when new variants of COVID-19 are appearing, it is imperative that the special summit launches a process to develop a legally binding agreement under the auspices of the WHO constitution.

A robust agreement should contain several key elements. First, globalhealth leaders must have more authority to develop and upgrade health surveillance. Second, we need to build on the pioneering work of the Access to COVID-19 Tools Accelerator (ACT-A) and COVAX, and ensure equitable manufacturing and distribution of personal protective equipment, tests, treatments, and vaccines, so that all countries can protect themselves better against current and future pandemics. Third, we need a global pandemic preparedness board.

But such arrangements will work only if leaders devise a sustainable financing mechanism to address the glaring global inequalities in health provision. Too often in times of global crises, we are reduced to passing the hat or convening ad hoc donor conferences. Ideally, pandemic preparedness should be financed according to a burden-sharing formula that allocates the costs among countries with the greatest capacity to pay. Even now, less than 20% of the WHO's budget is covered in this way. The eradication of smallpox in the 1960s and 1970s was historic not least because the final push was initiated by a cost-sharing agreement among the richest countries.

Failure to meet global COVID-19 vaccination targets could cost \$2.3 trillion in lost GDP by 2025. Given that prospect, the G20 high-level independent panel's proposed \$10 billion annual budget for pandemic prevention and preparedness would offer one of the greatest returns on investment in history. But we must act now - and this week's WHA summit is the place to start.

If you used your smartphone to type a message and found the autocorrect feature altering your spelling or grammar, it is thanks to AI. Suppose vou see vour e-commerce platform Amazon suggesting products that you may want or need, then it is using the recommendation engine powered by AI. If Google photos can pull all the images that match your face from all over the internet, it is using AI-powered face recognition technology. In other words, AI is becoming ubiquitous in our everyday life whether we like it or not.

The history of AI goes back to 1956 when John McCarthy first coined the term. According to the Encyclopedia Britannica, AI is "the ability of a digital computer or computer-controlled robot to perform tasks commonly associated with intelligent beings." One of the fundamental concepts of AI, and perhaps the best known, is 'machine learning,' owed to Arthur Samuel. In particular, he was famous for his Checkers-playing programme created in 1959. one of the first that ended up beating the creator in the game he created. The subsequent conquest of AI in various games such as IBM's Deep Blue in Chess, and Google's Deep Mind in the board game 'go' is legendary.

The easiest way to understand AI is to know that it is a paradigm shift in our approach to problemsolving. The conventional approach relies on a rule or mathematical formula that processes input data to answer. Whereas machine learning, a core concept in AI, comes up with the rule given enough input data with answers are known a priori. For example, one of the fascinating early applications of AI was for computers to read handwritten numerals -for example, a postcode on letters. The AI programme can be trained to recognise any new unlabelled

sample using a set of 70,000 labelled handwritten image samples of numbers 0-9. This is the equivalent of the 'hello world' programme of machine learning in computer vision.

There are three main categories, or paradigms of machine learning: supervised learning, where defined (so-called 'labelled') data and examples are submitted to carry out the task as above; unsupervised learning, where the task is carried out autonomously and usually allows for the identification of structures and trends; and finally, reinforcement learning, where actions are learned through the experiences themselves, as the programme is told when it goes wrong as in the case of the game-playing AI.

Similarly, an increasingly popular subset of AI is 'deep learning,' a concept introduced in 1986 by Rina Dechter. Deep learning is a specific class of machine learning methodologies based on artificial 'neural networks', systems inspired by the neural logic of the brain. Going further than 'basic' machine learning, deep learning uses several layers of so-called 'neurons' or a set of logic gates to extract more complex properties from raw data. These methods, particularly deep learning, are used for various end applications such as facial recognition systems

or automatic speech recognition. Finally, there are two types of AI. First is the narrow AI, or 'weak AI.' It is the AI that is being actively studied and used today - an AI is confined to one or even a few specific tasks with a controlled environment and data Later it is expected to evolve into artificial general intelligence (AGI), or 'strong AI.' Google recently unveiled its 'Pathways' project, which promises to provide a general-purpose AI tool for solving heterogeneous problems that process mixedmode data such as visual, audio or electro-magnetic in a more efficient manner.

AI can be a double-edged sword when it comes to the biggest question facing humanity - climate change and sustainability. With the explosion of AI applications running on vast amounts of data and massive computing power, the technology's energy consumption and carbon footprint are of grave concern. It is projected to grow exponentially over the next decade at a CAGR of nearly 44% globally through 2025. At the same time, AI is being increasingly deployed to address questions like the energy consumption of buildings that account for almost 40% of all emissions. For example, Google's Deep Mind division has developed AI that teaches itself to minimise the use

of energy to cool Google's data centres that have a very significant carbon footprint. As a result, Google reduced its data centre energy requirements by 35%.

AI can be a net positive contributor to environmental sustainability in many industries. In agriculture, AI can help reduce both fertilizer and water use, all while improving crop yields. AI can use deep predictive capabilities and intelligent grid systems to manage the demand and supply of renewable energy. In transportation. AI can help reduce traffic congestion, improve cargo transport, and eventually help with the 'last mile' delivery problems. In facilities management, AI can help recycle heat within buildings and maximise heating and cooling efficiency. It can help optimise energy use in buildings by tracking the number of people in a room or predicting the availability of renewable energy. ONLY TIME CAN TELL whether AI will be an energy-guzzling monster that will make the climate crisis worse or help save humanity from the impending disaster.

Prof Marcus du Sautoy, a mathematician from Oxford University, in his book 'Thinking Better - the Art of the Shortcut in Math and Life,' makes an interesting observation. He believes that the very reasons that make AI and machine learning so powerful in solving intricate problems are what will ultimately save humanity. Humans discover all the intelligent shortcuts while confronted with complex issues that result in most innovations, including AI. Being endowed with great computing power and data, AI would never look for shortcuts, unlike humans. That may be the saving grace that ultimately helps humanity sustain or prosper irrespective of the intelligent

The internet is not the enemy

relive in an age of wonder before Twitter. in which half the world people's health and education, can be a lifeline in a time of disaster or disease, and was designed to be open to everyone but owned by no one. And the COVID-19 pandemic has highlighted both its importance and its potential by forcing the world to connect remotely contact-free, and in real time.

Unfortunately, we also live in an age of fear and suspicion. You don't even need to 'doomscroll' to find claims that the internet is worse than any previous pestilence or war. The internet is the scapegoat for many of today's problems, including terrorism, child abuse, and even the end of democracy.

But think about it. To believe, for example, that fake news is somehow the internet's fault is to forget the state propaganda machines perfected in the twentieth century. Likewise, excessive wealth concentration and overly powerful monopolies are not products of the digital age; once upon a time, there were firms like US Steel, Standard Oil, and the British and Dutch East India companies. Some even hold the internet responsible for the decline of civic values and even civility, as though lying politicians and incendiary speech were not possible

Transformative technologies in which half the world now has access to a technow has access to a technologies have far-reaching effects on socithe internet – that supports eties and individuals. We are now in a period of social change that is unquestionably attributable in part to the rise of the internet, because the tool has created new opportunities.

Some of those opportunities are socially valuable: people can now communicate easily and cheaply with friends or family far away. Some of them are socially harmful: scammers are almost certain to make money. And some are socially ambiguous: traditional authorities and gatekeepers are losing influence because people have more channels and ways to access

But while many of the harms people ascribe to the internet are neither new nor caused by it, governments are seeking to regulate the internet as though they are. Before heading down that path, we had better be sure we are regulating the right thing.

Consider the problem of today's giant tech corporations and their effects on commerce and public discourse. Some advocate applying special regulations to these companies when they reach a certain market capitalisation or level of revenue. But this is hardly the first time the issue of corporate Standard Oil came to dominate the munication at a greater speed than petroleum industry in the United ever before. It is also exceptionally States and many other countries in the late nineteenth and early twentieth centuries, governments addressed the firm's power using antitrust policy, not 'oil policy.' Many people also express con-

cern about internet-enabled political interference, both within a given country and from foreign actors. But it is careless and historically inaccurate to attribute this phenomenon entirely to the internet. The US, France, Russia, and China each underwent violent revolutions in pre-internet times. And long before anyone had sent a datagram on the internet, countries were interfering in other countries' political processes, as both the Soviet Union and the US frequently did during the Cold War.

Political systems, and democracies in particular, depend on the efficient functioning and legitimacy of their governments. It is not possible to solve the problem of popular disaffection with a political regime by controlling information flows from abroad. That was just as true of Russia before 1917, when information was printed on paper, as it is now when it comes in packets of data.

To be sure, some challenges are unique to the internet. For starters,

concentration has arisen. After the technology enables more comdifficult to be confident of the identity of someone online (or even to be confident that it is a person). But these are the types of narrow issues where internet-specific regulation might make sense, if policymakers can be sure that introducing such measures will not

negatively affect the internet itself. The internet is an ecosystem that we need to protect. When considering possible regulations, the best way forward is to undertake an Internet Impact Assessment. much like how we conduct environmental or traffic assessments before deciding whether to build new infrastructure. The evaluation can determine whether a given action will benefit or harm the internet's underlying health.

Above all, we need to ensure that the internet is not made a scapegoat for problems caused by the legal, economic, and political systems where it is used. The internet must remain a tool for all of us. That means protecting it as we would any precious resource.

What's killing the big cats?

one fourth of the country's tiger population -- were said to be present in the forests of the state as of 2019. Therefore, when the state loses tigers, eyebrows are raised. The latest feline to die was a radio-collared tigress. Earlier, another radio-collared tiger was found dead, and de-skinned. Contact with live wires of electric farm fencing is attributed as a reason for the spate of tiger deaths though de-skinning of the animals could only have been done by overactive poachers. So, the unscrupulous elements are taking advantage of either the 'man-tiger' conflict or are on their own. Any tiger death should be ascribed to poaching unless proved otherwise. In all the big cat casualties in Madhya Pradesh, this year, apart from electrocution and poaching, food poisoning could be another reason. Infighting over territorial domination is another major reason why tigers die. Diseases and accidents are not uncommon causes. Be that as it may, safeguarding ecologically sensitive areas, forests, water bodies and grasslands cannot be overlooked anymore by the state government. Villagers and tigers can co-exist and



The rainfall is likely to continue December 2, the IMD added. The unseasonal rains pushed the maximum temperature to 24 degree Celsius, eight degrees below normal, the IMD said.

Assam lynching case: Main accused killed in 'escape bid'

Guwahati, Dec 1: The prime accused in the lynching of AASU leader in Jorhat died after being hit by a police vehicle when trying to escape from custody in the early hours on Wednesday, which prompted jubilation by people across Jorhat city and Chief Minister Himanta Biswa Sarma to say that the state will become crime free.

The opposition on the other hand accused the police of extra judicial killings and some to express concern. Neeraj Das alias 'Kola Lora' (black boy) was arrested Tuesday, a day after the gruesome incident, and was to be produced before the court Wednesday. Jorhat superintendent of police Ankit Jain said that during interrogation the prime accused Neeraj Das alias 'Kola Lora' (black boy) had revealed that a big drug consignment was coming and a police team set out with him at around 2 am Wednesday in a bid to intercept the consignment.

Das tried to escape by jumping off the police vehicle in the lonely stretch on Chinamora-Mariani road and while trying to flee, he was accidentally hit by the police vehicle which was moving at a high speed. "The driver of the vehicle then lost control of the vehicle which rammed into a wall and was damaged," Jain told PTI.

Das was taken to the hospital, where he was declared "brought dead". Three policemen were injured in the incident.

A total 13 people, including Das, were arrested Monday and Tuesday in connection with the lynching of All Assam Students' Union (AASU) leader Animesh Bhuyan. Two others, including a reporter, who was accompanying Bhuyan were injured in the incident on Monday. As the news of Das' death spread people came out to the streets in Jorhat city, which is a major educational hub of upper Assam, and burst crackers in jubilation. Sarma wrote on Twitter, "Assam will be free of crime and criminal - come what May" and retweeted a post by Special DGP (Law and Order) G P Singh.

MONITORING OMICRON LS passes ART Bill SITUATION, SAYS GOVT

New Delhi, Dec 1: The Indian government, before taking any final decision on the resumption of international flight operations, is "closely monitoring" the situation emerging out of the detection and spread of coronavirus' Omicron variant.


According to civil aviation regulator DGCA, stakeholders are being consulted on the evolving situation.

"In view of the evolving global scenario with the emergence of new 'Variants of Concern', the situation is being watched closely in consultation with all stakeholders," the DGCA said in a circular issued Wednesday. "An appropriate decision indicating the effective date of resumption of scheduled commercial international passenger services shall be notified in due course.

Lately, a chorus has grown against the opening of normal international flight operations from December 15 against the backdrop of the new and reportedly more infectious variant.

The demand coincides with the Centre's advisory to states and Union Territories (UTs) to ensure preparedness of health infrastructure like availability of ICU, O2 beds, ventilators, among others, and to focus on rural areas.

At present, several nations have



6 Covid cases from 'at-risk' countries

Six Covid-19 cases were reported Wednesday after screening 3,476 passengers of 11 flights that arrived in India from "at-risk" countries and the samples have been sent for genomic sequencing, the Health Ministry said amid concerns over the 'Omicron' variant of coronavirus. The Centre's revised guidelines for international ravellers came into effect on Wednesday, The fresh guidelines have been issued because of the new SARS-Cov-2 variant which has been designated as a variant of concern (VOC)' by the World Health Organisation.

either closed their air spaces or placed strict restrictions on incoming passengers.In this environment, especially after suffering the massive second wave of Covid-19 which was unleashed by the Delta variant, many are questioning the Centre's move to open up the sector. On Wednesday, the Ministry of Civil Aviation clarified on post-arrival testing protocols.

"Travellers undergoing random sampling may give the sample and be allowed to leave. Now, the random sampling would be limited to 2 per cent as per latest Ministry of Health and Family Welfare guidelines and it would be on a self-paid basis." "Airlines or airports may coordinate with the officials of state or UT governments to select the passenger at random sampling.

The ministry also said that postarrival testing can be exempted "if a person is travelling from a 'not at risk' country and has only a transit in 'at risk' country before taking the destination flight".

A total 1,013 passengers from four 'at-risk' flights successfully completed arrival formalities due to availability of Rapid Antigen Test' along with RT-PCR test, the Delhi International Airport Ltd said in a tweet on Wednesday morning. As many as 792 passengers decided to take the Rapid PCR Test and 221 passengers opted for the RT-PCR rest, it added.

As per Mumbai's Chhatrapati Shivaji Maharaj International Airport, under the latest directive issued by the Maharashtra government, passengers from highrisk countries will be segregated from passengers arriving from low-risk countries.

Earlier, initiating the debate on the ART Bill, Congress MP Karti Chidambaram highlighted the existing lacuna in the Bill and also asked that if the donor was anonymous then why to take their Aadhaar number.

"Will there be a contact tracing if the child wishes to do so after turning adult? " he asked and also



questioned about the pricing regulation as this treatment cost a huge money.

Raising the issues of LGBT couples and single men from using this technology, Chidambaram also said that every Indian who is physically and financially fit to parent a child should be able to be a parent. He also raised his objection to the provision that only married women who had a child should be a donor. Supporting the Bill, BJP MP

Heena Gavit who herself is a medical professional, said that unregulated surrogacy made renting a womb a booming business and vulnerable women became victims.

Ransomware top threat for Indians in 2021

New Delhi, Dec 1: Cybercriminals continued to exploit people's screen habits formed during lockdown to spread scams and ransomware was the top threat for Indians in 2021, followed by crypto scams, a new report showed Wednesday.

Cybersecurity researchers observed a 38 per cent increase in ransomware attacks targeting consumers globally, when comparing the last five months of 2021 to the first five months of the year, whereas for India, that number stands at 65 per cent. On the mobile side, adware and fleece-

ware were among the top threats, according to global security company Avast. "The pandemic has changed nearly every aspect of everyone's lives, and that includes the cyberworld too," said Michal Salat, director of threat intelligence at

"Attackers' methods are becoming more sophisticated. Cybercriminals are using techniques that make them harder to spot and carrying out more personalised cyber attacks. They are also adding new spins on tried and tested techniques, especially in social engineering type of attacks like scams," Salat added. Businesses globally also experienced an increased number of attacks during the June-October period to the tune of 32 per cent.

However, for India, this number was less than the global average and stood at 19 per cent. In general, phishing attacks continued to increase during 2021.

The chances of businesses encounter-

his year, a wide variety of new threats aimed at profiting from or mining cryptocurrencies at users' expenses were reported. Some of the main ones that impacted many countries around the world were Crackonosh, and BluStealer. In addition to Crackonosh and BlueStealer, the researchers also found cryptocurrencystealing malware that was distributed through HackBoss, a Telegram channel which, at the time of discovery, had stolen over \$560,000 from victims.

ing phishing scams has increased globally by 40 per cent in the last five months of the year but was much lower in India with 13 per cent. "Consumers, too, continue to be targeted by phishing scams with the increase in global (24 per cent) and India (23 per cent) figures being nearly the same, the report noted.

In September, the researchers found more than 19,300 Android apps that potentially exposed user data due to an incorrect configuration of the Firebase database -- an Android tool that developers can use with the purpose of storing user data. "Cybercriminals kept up many of their tricks this year, using social engineering to spread malware to get their hands on people's money, abusing technology such as stalkerware to violate people's privacy or deceiving vulnerable audiences into paying for fleeceware apps or unneeded tech support," said Salat.

Suddenly, a leopard appeared there and in a split moment caught hold of her son Rahul with its jaws and ran away, a senior forest official said Wednesday.

Bhopal tragedy: 37 yrs on, ground zero continues to haunt

Bhopal, Dec 1: Spread over 85 acres, the Union Carbide factory premises gives an eerie feeling with falling buildings and evergrowing shrubs, a remnant of an unparalleled tragedy that saw thousands die and lakhs suffer. Thirtyseven years after the Bhopal gas tragedy, December 3 is one of those blots of history that can never see closure

Around half a dozen buildings, which include offices, guestrooms, canteen for employees and workers, situated at different locations of the land are in a dilapidated state. Each one of these buildings had a specific role to play in the process of making and storing of the highly toxic methyl isocyanate (MIC).

Surrounded by dense bushes, and a warning note as a prohibited zone for general public, the only building appearing to be in a better condition -- is the three-storey structure, which used to be the office and the residence of senior employees of the Union Carbide Corporation (UCC), an American chemical corporation owned by Dow Chemical company. In other buildings, time and thieves have im-

printed their mark. Apart from the buildings, some other residues such as big size tanks, iron pipes along with flare towers and some other materials


are also available. A heavily concrete portion of land within its boundary located hardly 300-350 me ters away from the MIC production

site, appeared to be a helipad. One of the three iron tanks (Tank - E610), whose malfunctioning had resulted in the leakage of toxic MIC gas and caused deaths of around 3,000 people within the next few hours after the leak, is seen lying along the roadside within the premises. The reports suggest that the Bhopal UCIL facility had housed three underground -- 68,000 litres liquid MIC storage tanks, named -- E610, E611 and E612.

As per the government's data over five lakh people were exposed to methyl isocyanate (MIC) gas, however, estimates vary on the death toll. A total of 2,259 deaths were immediate, the activists, however, said that around 8,000 people died within two weeks, and another 8,000 or more died from gasrelated diseases over the follow-

Underground tank - E610, that had stored around 42 tonnes of MIC gas at the time of disaster -the intervening night between December 2 and 3 -- was removed from its foundation and set aside

To protect the factory assets from thieves and to prohibit the general public's entry within its premises, the Madhya Pradesh government in 2010 set up a concrete

Meanwhile, Indore Collector Manish Singh asked the industrial and business establishments in the district to ensure that all their employees get the second dose of COVID-19 vaccine within the stipulated period, failing which an FIR will be registered against the employers concerned under the Epidemic Diseases Act 1897

Singh said the district administration is currently sealing such establishments, where the employees have not received a second dose of the vaccine in the stipulated time limit.

PETROL PRICES CUT BY ₹8/LITRE IN DELHI

New Delhi, Dec 1: Petrol prices in national capital fell by ₹8 per litre Wednesday after the Delhi government cut down Value Added Tax (VAT) on the fuel to 19.40 per cent from earlier 30 per cent.

New rates will come into effect from midnight.

This decision came after Chief Minister Arvind Kejriwal chaired a Cabinet meeting this morning. Currently, the petrol is being sold at ₹103.97.

In early November, the Centre had reduced petrol and diesel rates by ₹5 and ₹10 per litre respectively. Post the move, the Opposition parties in Delhi have been urging the AAP-led state government to cut VAT on petrol by at least Rs 10 per litre.



In India, fuel prices differ from state to state depending on the local taxation (VAT) and freight charges. Besides, the central government charges an excise duty on auto fuels. After adding excise duty, dealer commission and VAT, the retail selling price of the petrol gets nearly doubled.

From June 2017 onwards, the petrol and diesel prices in India are being revised daily at 6 a.m. via the dynamic fuel price method. Earlier, this exercise used to take place every fortnight.

New Delhi, Dec 1: The country saw 645 events of heavy rainfall and 168 events of very heavy rainfall in November, the highest in the month in five years, the India Meteorological Department (IMD) said Wednesday.

Peninsular India reported most of the extremely heavy to very heavy rainfall events which claimed 44 lives in Andhra Pradesh, 16 in Tamil Nadu, 15 in Karnataka and three in Kerala.

The IMD said India recorded 11 extremely heavy rainfall (more than 204.5 mm) events this November, equalling the number reported last year. The country reported zero, four and one event of extremely heavy rainfall in November in 2019, 2018 and 2017, respectively.

The country saw 645 events of heavy rainfall (64.5 mm to 115.5 mm) and 168 events of very heavy rainfall (115.6 mm to 204.5 mm) in November, the highest in the last five years, according to the IMD's data.

To put things in perspective, the number of heavy rainfall events this November was more than the total such events in the last four years -- 247 in 2020; 116 in 2019; 135 in 2018 and 139 in 2017.

The Met office also said peninsular India gauged 160 per cent more rainfall -- 232.7 mm against the average of 89.5 mm -- in November, the highest in the month since 1901. The country as a whole received 56.5 mm of rainfall against the normal of 30.5 mm -- an excess of 85.4 per cent -- in November.

Five low-pressure systems in November this year against the average of 2.4 is the reason behind the copious rainfall in peninsular India this time, officials said.

Peninsular India comprises five meteorological subdivisions --Tamil Nadu, Pondicherry and Karaikkal; coastal Andhra Pradesh and Yanam; Rayalaseema; Kerala and Mahe, and South Interior Karnataka. The IMD said the region is most

Study shows Covid ups risk of death within a year

New Delhi/New York, Dec 1: People who survived severe Covid-19 infections are more than twice at risk of dying over the following year, compared with those who experience mild or moderate disease

or remain uninfected, finds a study. The study, published in the journal Frontiers in Medicine, showed that the increased risk of death was greater for patients who are under 65.

Researchers at the University of Florida, in the US, found that severe Covid-19 patients aged under 65 demonstrated a 233 per cent increased chance of dying, compared with the uninfected. This was larger

than the increased chance of dying experienced by severe Covid-19 patients aged over 65, compared with the uninfected. As these deaths frequently occurred long after the initial infection had passed, they may never have been linked to Covid-19 by the patients' families or doctors.

Moreover, 80 per cent deaths that occurred in severe Covid-19 survivors were not linked with common complications from the disease, such as respiratory or cardiovascular issues. This suggests that the patients had experienced an overall decline in their health that left them vulnerable to various ail-

ments, the researchers said.

WWII era bomb blasts in Munich

Berlin, Dec 1: A World War II bomb exploded at a construction site next to a busy railway line in Munich Wednesday, injuring three people, one of them seriously German police said.

A column of smoke was seen rising from the site near the Donnersbergerbruecke station. The construction site run by Germany's national railway is located on the approach to Munich's central station, which is a bit over a km (about a halfmile) to the east. Trains to and from that station, one of Germany's busiest, were suspended.

Unexploded bombs are still found frequently in Germany, even 76 years after the end of the war, and often during work on construction sites.

They are usually defused or disposed of in controlled explosions, a process that sometimes entails large-scale evacuations as a precaution. Bavaria's state interior minister, Joachim Herrmann, said the 250-kilogram (550-pound) bomb was found during drilling work, German news agency dpa reported.

It wasn't immediately clear why it wasn't discovered earlier; in general, sites in central Munich are scanned carefully for possible unexploded bombs.

EU to toughen migrants' entry from Belarus side

Brussels, Dec 1: Top European Union migration officials offered Wednesday to ease asylum rules for Poland, Lithuania and Latvia in response to what the EU says is a 'hybrid attack'' by Belarus to destabilise the bloc using migrants.

The move would make it harder for migrants to enter the 27-nation bloc from Belarus, angering nongovernmental organisations.

Around 8,000 people, many from Iraq, have crossed into the three EU countries since the beginning of the vear. President Alexander Lukashenko is accused of luring them to Belarus with the promise of helping them to enter Europe in revenge for EU sanctions against his government and companies. For six months, Poland, Lithuania

and Latvia will be able extend the period for registering asylum applications from three to 10 days to up to four weeks. Applications would only be accepted at dedicated border crossing points.

The processing could be done at the borders, including any right of appeal, but should be done within 16 weeks. The three countries would also be able to use fast-track national procedures for deporting people

whose applications have been refused. People could be held in temporary reception centres.

Unique effort reopens girls' schools in an Afghan province

Herat, Dec 1: High school girls are sitting at home almost everywhere in Afghanistan, forbidden to attend class by the Taliban rulers. But there's one major exception.

For weeks, girls in the western province of Herat have been back in high school classrooms - the fruit of a unique, concerted effort by teachers and parents to persuade local Taliban administrators to allow them to reopen.

Taliban officials never formally approved the reopening after the lobbying campaign, but they also didn't prevent it either when teachers and parents started classes on their own in early October. "Parents, students and teach-

ers joined hand in hand to do this."

Parents created a telephone chain to pass along the news, and students told classmates.

eh Ismailzadeh, a 14-year-old in the ninth grade, said she cried with happiness at the news. "We had lost all hope that schools would reopen," she said.

On a recent day, girls in a 10th grade chemistry class took notes as a teacher explained the elements that make up water. Lines of younger students marched through the halls to the schoolyard.

New Delhi, Dec 1: India's manufacturing sector activities gained further strength in November, and witnessed the strongest increase in production and sales since February on improving market conditions, a monthly survey said Wednesday.

The seasonally adjusted IHS Markit India Manufacturing Purchasing Managers' Index (PMI), increased from 55.9 in October to 57.6 in November, signalling the strongest improvement in the health of the sector in ten months. Moreover, the headline figure was well above its long-run average of 53.6.

The November data pointed towards tentative signs of an improvement in hiring activity, following three successive months of job shedding

The October PMI data pointed to an improvement in overall operating conditions for the fifth straight month. In PMI parlance, a print above 50 means expansion, while a score below 50 denotes contraction.

"The Indian manufacturing industry continued to expand in November, with growth gathering pace and forward-looking indices generally pointing to further improvements in the months to come," Pollyanna De Lima, Economics Associate Director at IHS Markit, said.

"For now, companies are absorbing most of the additional cost burdens and lifting output charges only moderately. Should raw material scarcity and shipping issues continue to feed through to purchasing prices, substantial increases in output charges could be seen, and demand resilience would be tested," the report said.

On the price front, the cost inflationary pressures remain elevated. The rate of purchase price inflation was little changed from October's recent high, owing to raw material supply-demand mismatches and rising transportation costs.

States' debt-to-GDP ratio worryingly high

Mumbai, Dec 1: The combined debt-to-GDP ratio of states is expected to remain at 31 per cent by end-March 2022 which is worryingly higher than the target of 20 per cent to be achieved by 2022-23. according to a RBI report.

The Reserve Bank's annual publication titled 'State Finances: A Study of Budgets of 2021-22' further said as the impact of the second Covid-19 wave wanes, state governments need to take credible steps to address debt sustainability concerns.

"The combined debt to GDP ratio of States which stood at 31 per cent at end-March 2021 and is expected to remain at that level by end-March 2022, is worryingly higher than the target of 20 per cent to be achieved by 2022-23, as per the recommendations of the FRBM Review Committee," it said.

In view of the pandemic induced slowdown, in its projections, the 15th Finance Commission expects the debt-GDP ratio to peak at 33.3 per cent in 2022-23 (in view of the higher deficits in 2020-21, 2021-22 and 2022-23), and gradually decline thereafter to reach 32.5 per cent by 2025-26.

The RBI report noted that the budgeted consolidated gross fiscal deficit (GFD) of 3.7 per cent of GDP for states for the year 2021-22 - lower than the 4 per cent level as recommended by the FC-XV (15th Finance Commission)-reflect the state governments' intent towards fiscal consolidation. CGST refers to Central Goods and Services Tax, SGST (State Goods and Services Tax) and IGST (Integrated Goods and Services Tax).

Bhubaneswar, Dec 1: Defending champions India beat European giants Belgium by a solitary goal to progress to the semifinals and keep alive their title hopes in the FIH Junior Men's Hockey World Cup at the Kalinga Stadium here Wednesday.

India, who beat Belgium 2-1 in the final en route to their title triumph in the last edition in Lucknow in 2016, continued their domination over the European side in junior hockey

Sharda Nand Tiwari's penalty corner conversion in the 21th minute was enough for India to seal their place in the last four.

The match was a classic example of defensive class from both the sides but the Indians did just enough to edge past their opponents. India will take on last edition's bronze medallist Germany in the semifinals Friday.

The Belgians started aggressively and created pressure on the Indian defence in the first few minutes. But the Indian backline produced good men-to-men marking and stayed calm under pressure to deny Belgium.

In the 13th minute Belgium had the first shy at the goal but Indian custodian Prasanth Chauhan was up to the task to deny Thibeau Stockbroekx from close range. India's first scoring chance came

just seconds from the first quarter through a creative Uttam Singh, but his effort was kept at bay by Belgium goalkeeper Boris Feldheim.

India kept growing in confidence as the match progressed and six minutes into the second quarter, secured their first penalty corner, which was converted by Tiwari.

Tiwari was brilliantly set by vice-captain Sanjay Kumar's dummy and the dragflicker made no mistake in putting the ball into

Two minutes later, Manjeet hit the side netting with a reverse hit. Belgium got a penalty corner in the 26th minute but Jeff de Winter's flick went wide as India went into half time leading by a slender 1-0

There was more drama in store as just at the stroke of the hooter, Germany secured a penalty corner and Masi Pfandt stepped up to take the match into shoot-out. In the shoot-out, Paul Smith, Michel Struthoff and Hannes Muller found the back of the net, while Matteo Poljaric missed.

Spain were awful from the oneon-one situation as Abajo, Guilermo Fortuno and de Ignaci-Simo missed while only Gerard Clapes scored.

Germany are the most successful team in the history of the Junior World Cup having won the tournament six times. The Germans won consecutive titles in 2009 and 2013 in New Delhi, which was their last crown. They secured the bronze medal in the last edition of the tournament in 2016 in Lucknow.

In the second last-eight round

match, it took 24 minutes to break the deadlock when Argentina, the 2005 champions, surged ahead through Joaquin Kruger's field

But Netherlands responded in no time when Miles Bukkens converted a penalty corner in the very next minute to go into half time locked at 1-1. The game eventually turned out to be a heartbreak for Netherlands as an own goal in the 59th minute put paid to their hopes.

Sheldon Schouten was at the wrong end of the proceedings when he deflected in Floris Middendorp's cross from the left flank.
