Bhubaneswar, Dec 4: The India Meteorological Department (IMD), which had predicted that Cyclone Jawad was likely to hit somewhere near Puri, Saturday said that the system weakened into a deep depression and may further convert into a depression before reaching Puri coast.

The cyclonic storm as named by Saudi Arabia as Jawad-the liberal or merciful- moved nearly northwards with a speed of 9 kmph during the past six hours, weakened into a deep depression and lay centered over west-central Bay of Bengal, the IMD said in its evening bulletin.

It is located about 180 km eastsoutheast of Visakhapatnam (Andhra Pradesh), 260 km south of Gopalpur, 330 km south-southwest of Puri and 420 km south-southwest of Paradip, it said.

The system is likely to move north-northeast wards and weaken further into a depression by Sunday morning. It may reach Puri around Sunday noon, it said.

Subsequently, it is likely to con-

tinue to move north-northeast wards along Odisha coast towards West Bengal coast and weaken into a well marked low pressure area during subsequent 24 hours, the Met

department said. It is now clear that this cyclone is not a threat anymore to Odisha or any other areas, as far as the latest bulletin is concerned.

Stating that the state will be impacted by rain and not by wind, Jena said the government has asked the Collectors to access damage caused to the standing crop due to downpour in the coastal region. The crop damage assessment will be done in next 7 days. Jena said.

Omicron enters Guj, Maha; total count 4

Ahmedabad/Mumbai, Dec 4: A 72-year-old man has been found infected with the Omicron in Jamnagar city of Gujarat, days after he arrived in the state from Zimbabwe while another man who returned to Mumbai from abroad also tested positive for the new variant of coronavirus.

As per Gujarat Health department sources this is the third case of Omicron in the country as two persons were earlier found infected with this strain in Karnataka.



Gujarat's Commissioner of Health Jai Prakash Shivhare confirmed that the man has tested positive for the Omicron variant.

The man had arrived in Guiarat from Zimbabwe November 28 and had tested positive for coronavirus December 2, after which his sample was sent for genome sequencing, officials said.

Jamnagar municipal commissioner Vijaykumar Kharadi had said that the sample was sent to Ahmedabad for genome sequencing to ascertain whether he was infected with the Omicron variant.

The man, who hails from Jamnagar, has been living in Zimbabwe since the last many years. He arrived in the state to meet his father-in-law. After he got a fever, his doctor advised him to get an RT-PCR test done. The private laboratory Thursday informed the civic authorities that his report has come out positive for Covid-19, he said.

Similarly, a man from Kalyan Dombivli municipal area near Mumbai who had arrived at the Delhi airport from South Africa via Dubai before flying to Mumbai has tested positive for the Omicron variant of coronavirus, officials said Saturday, adding that it is the first such case from Maharashtra.

The 33-year-old man had arrived in Delhi November 23 and had given his samples for Covid-19 testing at the Delhi airport. He had then taken a flight to Mumbai, official sources said in Delhi.

"A man from Kalyan Dombivli municipal corporation area has tested positive for the Omicron variant. He is the first official case in the state," Maharashtra health director Archana Patil said.

Centre worries over fewer tests in Odisha

Bhubaneswar, Dec 4: The Odisha government has identified a total of 6,970 beggars across the state and is implementing a scheme called 'Sahaya' for their welfare, Social Security and Empowerment of Persons with Disabilities Minister Ashok Chandra Panda said Saturday.

In a written reply in the Assembly, the minister said as many as 4,128 male and 2.842 female beggars have been identified by the state government in all 30 districts. However, Panda said that there is no child beggar in the state.

Cuttack district tops the list with 1,060 beggars, followed by 595 in

Bargarh, 545 in Ganjam, 502 in Bolangir, 447 in Sundargarh, 418 in Khurda, 363 in Kalahandi, 354 in Nuapada and 350 in Puri, Panda added. Among other districts, 283 beggars are identified in Sonepur district, 222 in Koraput, 205 in Angul, 196 in Jajpur, 188 in Bhadrak, 183 in Nabarangpur, 176 in Rayagada, 164 in Mayurbhanj, 132 in Dhenkanal and 131 in Balasore, he said. The process is on to include left-out beggars in the list, Panda said.

The government is implementing Sahaya. In the first phase, special drives named as Niladri Nilaya and Ekamra Nilaya have been launched in Puri and Bhubaneswar towns, respectively, the minister said. Beggar rehabilitation centres have been opened in Khurda and Sambalpur districts while funds have been sanctioned for establishment of such centres in Rourkela municipality, Ganjam and Dhenkanal.

Naidu calls for debate on govts doling out freebies

New Delhi, Dec 4: Vice President and Rajya Sabha Chairman M Venkaiah Naidu Saturday called for a wider debate on harmonising the welfare and development objectives against the backdrop of governments "doling out freebies".

He also said Parliament should meet for a minimum of 100 days every year and state legislatures for at least 90

Addressing an event in the

Central Hall of Parliament to mark 100 years of Public Accounts Committee (PAC), Naidu said expenditures must be carefully balanced so that both short-term and long-term development objectives get equal attention.

"We are all alive to the present scenario of governments indulging in doling out freebees for obvious reasons. While ensuring the welfare and social security of the needy people is an important obligation of the governments, it is time that there is a wider debate on harmonising the welfare and development objectives," he said in the presence of President Ram Nath Kovind, Speaker Om Birla and PAC chairman Adhir Ranjan Chowdhury.

balancing these two objectives for wider consideration", Naidu said.

The Rajya Sabha Chairman lamented that members of Parliament do not attend meetings of parliamentary committees. It was time for "introspection", he said.

Pointing to the scope of wasteful expenditure and misutilisation of scarce resources, Naidu recalled former Prime Minister Rajiv Gandhi saying about 35 years back that out of every rupee spent, only 16 paise went to the people.

Based on the experience of the last 100 years, the PAC can reinvent itself to more effectively handle the complexity of scrutinising the accounts and audit of expenditure through capacity-building, accessing the inputs of experts and information exchanges for setting higher benchmarks and adoption of best practices elsewhere, he said.

"Since the audit review is also a core function of PAC, I suggest that it may be re-designated as Public-Accounts and Audit Committee (PA and AC)," he said.



Odia transgender's life to come alive in bilingual biopic


Bhubaneswar: Known for playing negative roles in Odia films, actor Debasis Sahoo has been roped in to play a transgender's character in upcoming movie T.



NET, IIFT exams postponed in some centres over Jawad

Bhubaneswar, Dec 4: The University Grants Commission -National Eligibility Test (UGC-NET) and an entrance exam of the Indian Institute of Foreign Trade (IIFT) that were scheduled for Sunday has been postponed in some centres of Odisha, Andhra Pradesh and West Bengal due to Cyclone 'Jawad'.

The UGC-NET 2020 and June 2021 has been rescheduled for the centres in Visakhapatnam in Andhra Pradesh, and Puri, Bhubaneswar, Cuttack, Berhampur in Ganjam district and Gunupur in Rayagada district of Odisha, the National Testing Agency said in a notice Friday.

Entrance examination of the MBA (International Business) of the IIFT has been postponed at the centres in Kolkata and Durgapur in West Bengal: Bhubaneswar, Cuttack and Sambalpur in Odisha; and Vijayawada and Visakhapatnam in Andhra Pradesh, it said.

The date of the exam of the candidates who are admitted to the exam centres in the mentioned cities will be announced later, the NTA said. However, candidates are advised to note that the postponement is applied only to the cities mentioned and the exam will be held at all other cities of Odisha, Andhra Pradesh, West Bengal and



other states as per schedule, it said. Candidates check the NTA website - www.Nta.Ac.In - for latest updates, information, and contact the helpdesk – 00140459000 -- or email at ugc.Net@nta.Ac.In for queries, it added.

The NET is conducted on behalf of the University Grants Commission (UGC) for determining the eligibility for assistant professorship, junior research fellowship or both. The deep depression over the Bay of Bengal intensified Friday into Cyclone 'Jawad'.

Centre warns Odisha, 5 others of rising Covid cases

AMONG THOSE FLAGGED, ODISHA'S DHENKANAL DISTRICT REGISTERED A SPIKE OF 667% BETWEEN NOVEMBER 26 AND DECEMBER 2

New Delhi, Dec 4: The Centre Saturday wrote to five states Odisha, Karnataka, Kerala, Tamil Nadu and Mizoram, and the Union Territory of Jammu & Kashmir to express concern over a rapid increase in daily new Covid cases and mortality rates, and underline the danger posed by the

Letters signed by Union Health Secretary Rajesh Bhushan urged concerned state and UT officials to enhance surveillance of foreign arrivals (particularly from 'at risk' countries), monitor emerging hotspots, and ensure that all samples from Covid patients are sent for genome sequencing.

Among those flagged, J&K's Kathua district reported a staggering 727 per cent increase in new cases between November 26 and December 2, as compared to a week earlier. During the same period, Covid cases spiked by 152 per cent in Karnataka's Tumkur district. Similarly massive surges in



weekly caseloads were seen in Mizoram's Saiha (237 per cent) and Odisha's Dhenkanal (667 per cent) districts, the government noted.

The government also expressed concern over jumps in Covid-related mortality figures from Kerala.

12 deaths in Thrissur district between November 19 and November 25 jumped to 128 the next week, and 70 deaths in Malappuram district in the same period became 109 in the next.

Overall daily Covid numbers in India have been on a steady decline since the peak of the second wave in May, when over four lakh new cases were reported in a day. This morning fewer than 9,000 were reported from the previous 24 hours, and the national active caseload remains below 1 lakh.

Declining Covid case rates have been accompanied by an increase in vaccination rates.

All of this, however, is potentially under threat by the emergence of the Omicron variant, which medical experts and virologists believe is significantly more infectious than the Delta strain. Omicron is also believed to have

Man held for duping CA of ₹2.35cr

Kumar, who had a CA firm in Dubai in UAE, was contacted by Chandrakanta Sahu, a friend of the accused Nayak and a CA himself, requesting him for a job in his firm in March 2021. However, Kumar told Sahu that he was warping up his business in Dubai and leaving for India due to Covid.

Subsequently, Sahu introduced Kumar to Nayak telling he would help him get projects in India.



Bhubaneswar, Dec 4: Odisha has encountered 10 cyclones, including the approaching Jawad, in a span of 22 years and the frequency of such natural disasters is on only on the rise, official records of State Disaster Management Authority (OSDMA) showed.

Memories of the 1999 super cyclone is still fresh, wind speed of which could not be properly ascertained at the meteorological centre, Bhubaneswar, as the velocity crossed the capacity of the anemometer available then.

After the 1999 disaster, which left over 10,000 people dead, the state had experienced another major calamity in cyclone Phailin. It made landfall near Gopalpur in Ganjam district October 12, 2013, becoming the second strongest

tropical cyclone in India since the 1999 one. It had hit Odisha at a wind speed of 140 mph.

Twenty-three people were killed in the cyclonic storm after the Naveen Patnaik government set a "Zero Casualty" mission with precautionary measures in place, the records stated. Phailin was followed by cyclone Hudhud in 2014 that struck the Visakhapatnam city of Andhra Pradesh October 12, 2014.

Odisha, too, was affected by Hudhud. More than 60 people lost their lives in Andhra Pradesh, while the casualty count in the state was two.

Subsequently, cyclone Titli in 2018 had left authorities in shock, as the weather system had unexpectedly changed its course and entered Gajapati district, where no major preparations were made

Dhamra and left two people dead. Shortly after, in September, cyclone Gulab crossed the Odisha-Andhra Pradesh coast, bringing with it heavy rain. The remnants of Cyclone Gulab then gave rise to Cyclone Shaheen, in a unique weather phenomenon. The name Shaheen was given by Qatar. Gulab

was proposed by Pakistan. More than 20 people across different states and neighbouring countries died in cyclone Gulab. No death, however, was reported in Odisha, records showed.

Odisha is currently bracing for cyclone Jawad, which is being considered as the first winter cyclone in the state in about 100 years. The system has, however, weakened and may even escape its coast.

The former director of Regional Meteorological Centre. Bhubaneswar, Sarat C Sahu, stated that climate change was a major factor for increase in frequency of

"When sea temperature touches 26.5°C or more, it helps a low pressure intensify. This time, in case of Jawad, the sea water temperature was 29°C. Besides sea pollution could also be another factor that creates an atmosphere suitable for formation of a cyclone," he added.

Locals claimed that the animal might be part of a 33-member herd which had unleashed a reign of terror in the area by destroying crops and properties. The herd had also trampled a farmer to death at Bhalupali village November 29. The herd later strayed into the villages of Subarnapur district and the Baslat area Friday.

Nayagarh ACSO under Vig lens

Nayagarh: Separate teams of Vigilance sleuths carried out simultaneous raids Saturday morning on five places associated with an Assistant Civil Supplies Officer (ACSO) in Nayagarh district, who has been identified as Jayant Kumar Dash. The administration has shifted 173 people to safe places while 73 pregnant women were admitted to different health centres.

If the impact of the cyclone becomes intense, more people will be shifted to safety. The drizzles have affected paddy, vegetables and other crops in the district. In Derabishi, 85 people have been shifted; four in Garadpur; 30 in Marshaghai and 64 in Rajkanika.

Rescue operations in Rajnagar and Mahakalpara were on while officials of various lines departments have been on alert, said the district emergency officer.

MAHANGA DOUBLE MURDER

Show-cause to Mahanga IIC

Nischintakoili/Salipur, Dec 4: A local court at Salipur in Cuttack district issued a show-cause notice to the inspector-in-charge (IIC) of Mahanga police station while rejecting the time petition submitted by the police station in the sensational Mahanga double murder case, Saturday.

The court of judicial magistrate first class (JMFC) asked the IIC, Nihar Mohanty, to explain by 10.30 am of December 10 as to why coercive and punitive action will not be taken against him as per CrPC for failing to appear in person before the court and repeatedly buying time for filing the reinvestigation report and the call detail records (CDR) of the prime accused and deceased Prafulla Biswal and two associates of Minister Pratap Jena.

Umakant Biswal alias Bapi, PA of Jena and Sarat Chandra Nayak, chairperson of Mahanga block, are the two associates of the minister.

In its nine-page order, the court rejected a time petition filed by the police officer and issued the show-cause notice under Section 171 of Indian Evidence Act and 311 of CrPC.

The court expected the IIC to furnish the reinvestigation report



and up-to-date CDR by December 10 apart from submitting a reply to the show-cause notice failing which the court warned of taking stringent action against him.

The IIC instead of appearing in person Saturday made a submission through the government pleader seeking an additional three weeks. He also submitted in writing

that he would file the CDR in court when he will be granted permission by his higher authorities. The court expressed displeasure over the submission and issued the above order.

The Salipur JMFC court November 20 had directed the police to submit the probe status report and CDR of deceased Prafulla Biswal, the prime accused in the case and two associates of Minister Pratap Jena - Sarat and Umakant by November 25. The court had given four days time to Mahanga police till November 29 after it failed to file the reinvestigation report. The Mahanga police, however, sought one more month to file reports, November 29.

Two get life term in sodomv-murder case

Phulbani, Dec 4: A court here has sentenced two men to life imprisonment for sodomising and killing a nine-year-old boy in Kandhamal district five years ago, a sensational murder case that had sent shockwaves across the state.

Special POCSO Judge Bhaskar Chandra Sahu Friday also imposed a fine of ₹1.65 lakh each on the convicts, aged 21 and 20. March 14, 2016, the duo took the minor, who was a friend, to a secluded place under the Phulbani Sadar police station area and had unnatural sex with him.

As the boy warned them that he would reveal it to others, they strangled him with a towel. The body was then buried in the river bed of a nearby hilly stream and his clothes were also burnt,



As many as 15 witnesses were examined in the case, sources said. The court directed that the total fine amount of ₹3.3 lakh will be paid to the victim's family, according to the public prosecutor.

Unsolved Problems

This month marks the beginning of the time two years ago when the government lost its way. The Modi government had fixed the three things it had been campaigning for strongly for decades. The law criminalising triple talaq came August 1, 2019. The Supreme Court had already declared triple talaq invalid so there was no reason for the government to criminalise it but this was done anyway. Four days later August 5, Kashmir lost whatever autonomy it allegedly had and Article 370 was 'deoperationalised'. Earlier in the year, the Balakot strikes had apparently sorted out India's national security problems. November 9, the Supreme Court decided the Babri Masjid issue which had been pending for three decades in favour of the Hindu groups. December 11, after Amit Shah assured the Parliament the day before that a nationwide National Register of Citizens (NRC) was on its way, the government passed the Citizenship Amendment Act.

Four days later December 15, 2019 the Shaheen Bagh protest began, sparking a nationwide movement against the discriminatory law. After this the government has not been able to enforce its agenda and it is striking to see what has happened in the two years since compared to the months before Shaheen Bagh.

Assemblies across India passed resolutions against the NRC. The last of these was Bihar February 20, 2020, where the BJP legislators joined a unanimous resolution against what Shah had promised was coming in Parliament. The Shaheen Bagh protest wrapped up the next month but victory had been already achieved. The Delhi pogrom and the fury of figures like Anurag Thakur and Kapil Mishra showed how deeply affected the government was by the setback. In March began the pandemic and the lockdown flattened the Indian

economy. Per capita GDP went behind Bangladesh, the fiscal deficit was blown and a stressed government passed on the costs of governance to all Indians through extortionate taxes on petrol and diesel. The effects of the lockdown were felt for the full 12 months of financial year 2020-2021 and we are still to recover from it.

Twenty-three crore Indians fell into poverty during the pandemic and the unemployment rate which had already reached a post-1947 high of 6% by 2018 remains there.

In June 2020, the farm ordinances were passed during the pandemic. In September, the Bills were passed in the Parliament without a division vote. The farmers arrived at the outskirts of Delhi at the end of November and remain there even today. The government of course has rolled back the three laws but now faces trouble on the issue of a guarantee on the Minimum Support Price. It is also apparently worried over the fallout of the agitation on its constituency especially among the farmers in western Uttar Pradesh, a state going to the polls in a few months.

In January, 2021, the Biden administration was sworn in, after the defeat of Modi's friend Trump in the presidential elections (other friends like Japan's Abe have also departed). A few days after that India lifted the 17-month internet blockade on Kashmiris fearing pressure from Biden's democracy

In May 2020, India was told the Chinese were aggressively moving into Ladakh. June 15, last year, the two sides clashed with clubs and stones and 20 Indians lost their lives. The situation remains tense along the border and the government suddenly made peace with Pakistan on the Line of Control and shifted tens of thousands of troops over to the China side. The problem of national security, assumed to have been solved after Balakot, was apparently not really solved at all. India's naval alliance with the United States and two other nations (the so called Quad) was demoted this year when the US announced a proper military naval alliance with UK and Australia in the region.

The issue of Kashmir also has not proven to be 'solved'. The state today has no democracy and is the only Indian state/Union territory without an elected government. Violence has not come down as we can see from events daily and from the data. The population has become even more hostile. In effect an army that was tasked with two things: managing a hostile border with Pakistan and counter-insurgency in Kashmir is now tasked with three major things, the third being China.

It is not easy to see how the government and the Prime Minister will come out of this period of slump easily. The economy is said to grow at over 8% this year but that merely brings total GDP back to where it was before the pandemic, when it had already slowed to a crawl.

Perhaps the BJP will win the UP elections but that will be a political win and will leave the problems on the ground from the economy to national security to disaffected farmers and minorities intact.

You're extremely unlikely to encounter this old adjective relating to yesterday, it being one of the rarest in the language. The Oxford English Dictionary has only two examples, one from a glossary of 1656, and my electronic searches have failed to find any more beyond the OED's other citation, which is from William Makepeace Thackeray's A Shabby Genteel Story of 1840: "Thrice a-week, at least, does Gann breakfast in bed — sure sign of pridian intoxication". It has the most respectable antecedents - it's from Latin pri-, before, plus dies, day, and so belongs with diary, diurnal, journal, and journey, all of which can likewise be traced back to dies. However, like an ineffectual political candidate, it was unable to muster enough support to be elected a permanent member of the English lexicon. and we must now consider it to be one of yesterday's words.

Prion

A Nobel Prize has been awarded to Professor Stanley Prusiner for his work in finding the origin of certain kinds of disease in animals and humans. The diseases include scrapie in sheep, bovine spongiform encephalopathy (BSE or mad cow disease) and Creutzfeld-Jacob disease (CJD) in humans, all of which cause degeneration of the nervous system, leading to loss of coordination, dementia and death. They have in the past been called slow viruses because it has been assumed they are caused by a virus too small to detect, and because years pass after infection before visible effects appear. but no virus has ever been found. His theory, developed over the past 15 years, is that the infectious agent is not a virus but a protein, which can force other proteins in the infected body to change shape and so cause disease to develop. He called such infectious proteins prions, an invented word which is a contraction of the full descriptive name proteinaceous infectious particle. The theory, unusually for one gaining a Nobel Prize, is still controversial, with its truth yet to be finally demonstrated experimentally.

and begins to spread -∟one with a worryingly large set of mutations that may make the virus more capable of evading our immune defenses – we are all being forced to reassess the strategies we have come to rely on for protection. In many countries, like the

United States, vaccines have been viewed as the primary ring of protection, allowing Americans to live in relative security from the virus. But the more we learn about the virus' ability to dodge and elude the early lines of immunesystem defense, the more obvious the need for additional measures

Instead of relying on a single layer of protection, we should adopt a 'belt-and-suspenders' approach. Vaccines remain the primary ring of support - the belt keeping our protective pants on straight. But we would do well to add a set of suspenders for additional support, iust in case the belt breaks under mounting pressure from the virus. Based on what we know, our best bet lies with the wider use of monoclonal antibodies for early treatment of COVID-19 and for longterm prevention and protection from the disease.

To see the importance of this approach, imagine a long-term care home in which one resident tests positive for COVID-19, or a ship or submarine at sea, where there would be no possibility of relief from continual and intense exposure in the event of an outbreak. If the people in these congregate settings were immediately administered a single dose of monoclonal antibody treatment, the odds of an infection in that group leading to severe disease would be reduced by up to 70%. And bevond protection from disease, the single dose would also have a powerful preventive effect for future infection, providing ongoing protection for up to eight months (depending on the therapy used).

As is the case for most antiviral

drugs, monoclonal antibodies will

no additional pills and no additional doses required. Consider what this intervention could mean for all the people in congregate living settings or at higher risk of severe disease. If you are older, morbidly obese, immunocompromised, or unable to mount an immune response after vaccination, new data show that you are much more likely than your healthier, vaccinated counterparts to have not only a breakthrough infection but also a more severe illness. This single injection could still save you. Moreover, we already have a very good understanding of the potential adverse effects of mon-

oclonal antibody treatments. All are manageable, which is more than can be said of the antiviral pill molnupiravir, which is currently before the FDA for emergency-use approval. Its potential side effects, heatedly discussed among the FDA experts who issued a very narrow approval, include potential birth

The side effects of other pills awaiting further study are still unknown. The challenge with applying the belt-and-suspenders approach in the past has been the cost of production and the burden of delivery of first-generation monoclonal antibodies. Initially, the therapies could be administered only intravenously, in a clinical setting, over a period of hours. To be effective, the dose needed to be delivered shortly after symptoms appeared and before severe illness set in. Between the high costs and the extra administrative demand placed on overburdened healthcare systems, this treatment option simply could not have been applied broadly as a preventive tool. Instead, it was limited to the select few who could both afford and ac-

But now there is a new generation of antibody treatments that can be administered by injection in a nonclinical setting, at a cost of roughly \$400 per gram (according to my conversations with

Indian manufacturers of monoclonal antibodies). At that price, a single dose should cost no more than \$500 (while still allowing room for profit). Admittedly, \$500 is a relatively steep price if the treatment is used broadly as a means of prevention. Nonetheless, it is far lower than the thousands of dollars a single IV infusion costs, and it pales in comparison to the cost of caring for a person hospitalised with COVID-19. Either way, these treatments offer a compelling return on investment.

What we need now is the same kind of rapid mobilisation that delivered safe and highly effec tive COVID-19 vaccines in record time. That feat was made possible by a coordinated effort between government, global pharmaceutical manufacturers, and health-care payers to streamline the supply chain, improve the speed of delivery, and ensure affordability and accessibility for all those potentially in need.

COVID-19 testing also should be made more accessible, especially in congregate living settings, but also for individuals in general. Antibody testing for those at high risk should become com-

monplace. Omicron's emergence demonstrates that SARS-CoV-2 still has many tricks up its sleeve, the likes of which we may not even be able to imagine. Early tests suggest that monoclonal antibodies are holding up against the new variant. This is promising news, as is the news that the White House will create monoclonal antibody strike teams to administer the life saving treatment. While sartorial observers counsel against wearing a belt and suspenders together, public health calls for precisely such an approach.

vance warning for tropical cyclones in the north Indian Ocean. Take for example, some of the extremely severe or very severe cyclonic storms in the last decade such as Phailin, Hudhud, Titli or Fani. In each case, the meteorological agency provided forewarning much in advance and with near pinpoint accuracy over the landfall location and time. However, these successes should not become the ground to avoid an objective evaluation of its performance. The cyclone 'Jawad' which is still lurking near Odisha coast is a case in point to examine the efficacy of meteorological forecasts from a societal perspective.

The cyclonic storm which developed in the south Andaman Sea before entering into Bay of Bengal was closely monitored by IMD even before it became a low pressure system. It was forecast as early as November 27 that it is likely to intensify to become a low pressure system November 29 and a cyclone by December 3. It was tracked and relevant information was disseminated periodically through mass media and social media. December 2. the forecast was that the cyclone is likely to cross the coast in the early hours of December 4 over north

The India Meteorological of Andhra Pradesh or south of postlandfall? For example, there was landfall location and time. gained global recognition between the two. Thus the districts ent past for its reliable and ado of Srikakulam, Vizianagaram and Visakhapatnam in AP were preparing themselves as also the districts of Ganjam, Gajapati, Puri in Odisha which were issued red warning by IMD for heavy to very heavy rainfall. The specific advisory from IMD that farmers should harvest ripen crops and similar advisories from the state authorities led to premature harvesting in many coastal areas of Odisha. There were also reports of distress selling of farm produce as a result of large scale harvesting and there is no formal government mechanism to deal with such large farm produce in such an emergency situation.

By the noon of December 3, IMD confirmed that the system has become a cyclonic storm but it was revising its forecast. The revised prediction was in terms of landfall location, time and intensity attributed to a curving of the cyclone's path. The cyclonic storm, it was declared, is likely to make landfall in and around Puri December 5 around noon time with the maximum wind speed of 100 km per hour to be observed December 4 and thus categorising it under severe cyclone category. However, it was still not clear from the revised forecasts how will the system move

Department (IMD) has Odisha with the former more likely persisting confusion whether it will travel north-northeasterly parallel to the coast or cross over to the hinterland. In any case, a strike from a 'severe cyclone scale' storm was good enough reason for the state government to press emergency measures including evacuation of people to safe shelters, declaration of holidays for schools in 19 districts, and cancellation of leave for government employees.

The forecast for 'Jawad' was revised once again by the morning of December 4. IMD retained the location and time of landfall to be December 5 but forecast it to weaken considerably prior to its landfall and become a deep depression. Postlandfall it was expected to move along the coast towards West Bengal. Importantly the revised national warning bulletin of December 4 did not recommend harvesting of crops or securing them as was the recommendation in the bulletin of December 3. There was no specific forecast for tidal surge or inundation though sea condition was expected to be rough to very rough. One hopes the latest forecast holds given the difficulty involved in predicting a recurving track of a cyclonic system and in any case, this particular case of 'Jawad' does not stand out well on skills and accuracy in basic parameters such as

The downgrading of the cyclone's intensity to a deep depression is certainly a matter of relief. However. there will be those farmers who have reasons to be unhappy with the meteorological forecast service. A decision of premature harvest was largely based on an anticipated cyclonic intensity with the potential to damage standing crops altogether. In case the system continues to weaken further and is rather limited in its overall impact, then who will be responsible for the material losses of farming families? In a state like Odisha. where farmers are mostly on subsistence agriculture, a harvest decision carries enormous implication for their families and hence meteorological advisory and warning service need to take cognisance of such aspects, and factor them within the advisory framework. As is the practice, there is no provision of any government assistance for such losses. It is time warning services looked beyond their disciplinary perspective to involve other agencies in a multidimensional approach to become more useful



New Delhi, Dec 4: Chief Justice of India N.V. Ramana Saturday said the business community should explore the alternate dispute resolution mechanism like mediation, conciliation, and arbitration to resolve disputes, rather than going to courts,

which should be the last resort. Justice Ramana was speaking at the 'Stakeholders' Conclave' at the International Arbitration and Mediation Centre, Hyderabad. He said in business, differences of opinions should be initially sorted through a dialogue and if this doesn't work then parties should look for people who can resolve the issue by negotiation. He said: "If this also

doesn't work, then the only option people consider is to go to courts. My advice, after participating in the legal profession for over 40 years in different capacities, is that you must keep the option of going to courts as a last resort"

He added, "Use this last resort only after exploring the option of ADR (alternate dispute resolution) -- arbitration, mediation and conciliation. Arbitration and mediation are efforts at restoring a relationship".

He said every day in our lives, we face conflicts - be it between family members or in our business or professional life". Justice Ramana said nobody can imagine a world without conflicts. "Conflicts have a



human face and it helps to be humane in our approach to resolve the same. One must have the foresight to look beyond the conflict", he said.

He said the most important factor behind the resolution of any dispute is having the right attitude. "By right attitude, I mean we should leave aside our ego, emotions, impatience and embrace practicality. But, once these conflicts enter a Court, much gets lost in the practice and procedure", he added. Justice Ramana cited various rea-

sons for opting for mediation or arbitration over traditional litigation, saying its benefits are manifold: fewer delays, less expensive, greater party choice, more control, more comfortable and amicable environment for the parties etc.

Justice Ramana said despite the presence of some arbitration centers in India, Indian parties that enter into an international arbitration agreement often opt for an arbitration centre outside India incurring huge expenses.

AK-203 assault rifles, with an effective range of 300 meters, are lightweight, robust and easy to use modern assault rifles with proven technology that will enhance the combat potential of soldiers to adequately meet present and envisaged operational challenges, the sources noted.

They will enhance the operational effectiveness of the Indian Army in counterterrorism and counter insurgency operations.

The project will be implemented by a special purpose joint venture called Indo-Russian Rifles Private Ltd (IRRPL). TN reduces value of encroached land on water bodies to zero

Chennai, Dec 4: The Tamil Nadu registration department in a government order recently reduced the value of encroached land and properties on water bodies, waterways, and water catchment areas to zero leading to a major hit in the

sale of land parcels in these areas. The decision of the state registration department has come after the Waterworks and Revenue Department in a detailed study found that over 50 lakes in Chennai Tiruvallur, Kancheepuram, and Chengalpattu districts were converted into land holdings and res-

idential properties worth crores. A senior official with the state registration department told IANS:

'In 10 yrs, electrocution claimed 93 elephants in TN'

Chennai, Dec 4: A Right to Information (RTI) activist from Tenkasi in Tamil Nadu, R Pandiraja said that 93 wild elephants were electrocuted in the state in the last ten years up to December 2020. He said that he received a reply to his query from K Muthamizh Selvan, Scientist D (Project Elephant) in the Union Ministry of Environment, Forest and Climate Change.

Pandiraja told IANS: "While 93 wild elephants were electrocuted to death in Tamil Nadu in the last ten years up to December 2020, the national statistics are very disturbing and according to the reply to my RTI query, 1,160 wild elephants died due to various reasons across the country."



The RTI activist, who is also an animal rights activist, said that the loss of lives of wild elephants will alter the ecology of the forests in the country and that the Department of Forests and Wildlife of the Union Government must make more efforts to prevent elephants and other wild animals

from getting killed. R. Pandiaraja said that a total of 186 wild elephants were killed after being hit by speeding trains across the country in the last ten years till December 31, 2020. He said that of this Assam recorded the highest

with 62 elephant deaths while in Tamil Nadu five elephants were killed after being hit by trains.

A total of 741 wild elephants were electrocuted in the country in the last ten years, of which Odisha recorded the maximum deaths at 133. In Tamil Nadu, 93 elephants were killed by electrocution.

As many as 169 elephants were hunted down and poached of which again Odisha tops the list with 49 poaching deaths while in Tamil Nadu, nine elephants were killed by hunters.

Pandiaraja said that 32 elephants were poisoned to death in Assam and in Tamil Nadu, one elephant died due to poisoning. He also said that the Ministry of Environment and Forests had spent Rs 212.5 crore in the last ten years for the conservation of elephants.

The RTI activist who is also a researcher on the ecosystem of wild animals said that the 2017 census revealed that there were 29,964 wild elephants in the country. Karnataka tops the list with 6,049 elephants while Tamil Nadu has 2,761 elephants.

Pandiaraja told IANS: "It is saddening to note that several wild elephants are losing their lives due to callous and negligent behaviour of humans. The recent mowing down of three elephants including two female elephants in the Kanjikode- Madhukkara sector by the Mangalore -Chennai Express train is tragic. If the Railways had been a little more careful, we could have saved the lives of these animals that play a significant role in maintaining the ecological balance.'



TMC bins Sena's editorial piece

Kolkata, Dec 4: The TMC leadership Saturday declined to attach much importance to Shiv Sena's remarks on the party's effort to build an opposition alliance, one parallel to the UPA, and said that it would continue to cobble up an alternative front as the Congress "failed to lead the fight" against the BJP.

In a snub to TMC chief Mamata Banerjee, whose party is currently engaged in a tussle with the Congress, the Shiv Sena Saturday said keeping the grand old party away from national politics while creating an opposition alliance parallel to the UPA is akin to strengthening the ruling BJP and other "fascist" forces.

In an editorial in party mouthpiece 'Saamana', the Sena also said that those who don't want a Congress-led United Progressive Alliance (UPA) should make their stand clear publicly instead of creating confusion by talking behind curtains.

"The Shiv Sena is free to have its opinion. But let's not talk about what is right and wrong. The Shiv Sena itself was part of BJP-led NDA. It left the NDA after a fracas

over the chief minister's post in Maharashtra. It joined hands with the NCP and the Congress for CM's chair," TMC MP Sougata Roy said.

He stated that the party would continue to increase its strength and venture out to other states.

"The TMC only wants opposition unity to be strengthened. We have never said that an opposition alliance will be forged without Congress. But if Congress can't perform its duty, we have nothing to do. They can't blame us for their incompetence. If one fails, then someone else has to fill the

Echoing him, TMC's state general secretary Kunal Ghosh said Shiv Sena's comment is out of its "alliance compulsion" in Maharashtra. "We don't want any misunderstanding with the Shiv Sena. It is running a government in Maharashtra with the support of Congress. So they have some compulsions, and these statements have been made out of that compulsion. We are cobbling up an opposition front as the Congress has failed to do so," he

Last week, the ruling camp in Bengal had said it is "disinterested" in coordinating with the Congress during the winter session of Parliament, but maintained that it would cooperate with other opposition parties on various issues concerning people's interest.

"When it comes to people's pain and loss, Government of India is sleeping. Let's wake them up," Rahul Gandhi said on Twitter while launching the campaign. The Modi government has very tactfully tried to cover up its failures in managing the COVID-19 pandemic by distorting the number of Covid deaths, the party alleged.



"#SpeakUpForCovidNyay so the govt is forced to disclose the correct number of Covid deaths," it said on its official Twitter handle. The party alleged that the government lacked the intention to support the distressed families.

"If the government doesn't have data of Covid deaths, the entire country is willing to share it with the government. There is no dearth of fund.... 2 TSR personnel shot dead by colleague

BMC clamps stringent home isolation norms

Mumbai, Dec 4: With Omicron cases getting detected in the two adjoining states of Karnataka and Gujarat this week, the BrihanMumbai Municipal Corporation (BMC) has introduced a set of stringent home quarantine norms, which include five calls a day and visits by medical teams with ambulance.

BMC Commissioner I.S. Chahal said that after the successful 'Dharavi Model' in the first Covid-19 wave -- which earned global accolades -- and the 'Mumbai Model' which was also very successful, this is the third initiative to secure the country's commercial capMedical teams will be sent with ambulance to see whether passengers are complying with rules

ital from Omicron.

The process will start daily morning with the Mumbai International Airport Ltd sending a list of all Mumbai passengers landing at the Chhatrapati Shivaji Maharaj International Airport, or who have visited from the 'high risk' and 'at risk' nations in the past 15 days, to the Disaster Management Unit (DMU).

Thereafter, the DMU will relay it to the 24 administrative wards based on the passengers' addresses

and then to the Ward War Rooms (WWR) which will track, test and start contact tracing.

Chahal added that the WWR will call each person under home quarantine at least five times a day to monitor their health and also ascertain if they are indeed in isolation at home and following the rules, and if needed counsel them and address their concerns.

Besides, medical teams will be sent regularly with ambulance to see whether the passengers are complying with the rules, and check their health. After seven days in home isolation, they will ensure that the concerned passengers take undergo RT-PCR tests.

The housing societies/complexes

where they live shall be informed in writing by the BMC, asking them to ensure that the passengers remain isolated at home, and no visitors are allowed.

Violators shall face stringent punishment, including being shunted to compulsory institutional quarantine.

If any passengers develop any symptoms, they will be immediately put on treatment protocols or hospitalised, said Chahal.

The WWRs would be adequately staffed and would have multiple functional communication lines and 10 ambulances at their disposal. They would inform the DMU of any violation of the rules by any passenger.

over detection of Omicron variant in the country, with only 2 per cent of surveyed citizens saying that people in their area, city or district are complying well with maskwearing norms.

According to a latest survey conducted by digital community based platform LocalCircles, one in three Indians say most people in their area are not even carrying masks when stepping out of their houses

The survey, conducted in April, received more than 25,000 responses from citizens residing in 364 districts of India. It also said that 29 per cent of citizens rated mask compliance as high. This percentage



dropped to 12 per cent in September. and dropped drastically to only 2

per cent in November. The need of the hour is to educate the public on the effectiveness of masks as two in three Indians are still wearing cloth masks that provide limited protection from COVID-19.

"It is critical that the central government, state governments and district administrations introduce all possible mechanisms to create awareness about mask compliance in light of the Omicron variant and enforce necessary penalties to drive this compliance,' Sachin Taparia, founder, LocalCircles said.

If two individuals in an indoor space are not wearing a mask, in just 10 minutes, the infected person can transmit the virus to the other person, while if both are wearing a fitted N-95 mask, it requires over 600 hours of exposure for transmission, he said.

The Omicron variant, which has scientists and epidemiologists from around the world raising red flags, was categorised as a "variant of concern" by the World Health Organisation earlier this week after it was identified in three countries. Within a week, Omicron has been detected in over 40 countries around the world, with-India reporting its first two cases in Karnataka





US Prez Biden and Russian Prez Putin will speak in a video call Tuesday as tensions escalate over a Russian troop buildup on the Ukrainian border



Washington, Dec 4: President Joe Biden pledged Friday to make it "very, very difficult" for Russia's Vladimir Putin to take military action in Ukraine as US Intelligence officials determined that Russian planning is underway for a possible military offensive that could begin as soon as early 2022

The new intelligence finding estimates that the Russians are planning to deploy an estimated 175,000 troops and almost half of them are already deployed along various points near Ukraine's border, according to a Biden administration official who spoke on the condition of anonymity to discuss the finding.

It comes as Russia has picked up its demands on Biden to guarantee that Ukraine will not be allowed to join the NATO alliance. The official added that the plans

call for the movement of 100 battalion tactical groups along with armor, artillery and equipment. Intelligence officials also have

seen an uptick in Russian propaganda efforts through the use of proxies and media outlets to denigrate Ukraine and NATO ahead of a potential invasion, the official said. Asked about the intelligence finding as he set out for the presidential retreat at Camp David Friday evening, Biden reiterated his concerns about Russian provocations

'We've been aware of Russia's actions for a long time and my expectation is we're gonna have a long discussion with Putin,

The risks of such a gambit for Putin, if he actually went through

with an invasion, would be enormous.

US officials and former US diplomats say while Putin clearly is laying the groundwork for a possible invasion, Ukraine's military is better armed and prepared today than in past years, and the sanctions threatened by the West would do serious damage to Russia's economy. It remains unclear if Putin intends to go through with what would be a risky offensive, they say.

Earlier Friday, Biden pledged to make it "very, very difficult" for Putin to take military action in Ukraine and said new initiatives coming from his administration intended to deter Russian aggression.



Outside the bloc, populist leaders in Brazil and the administration of former US President Donald Trump pressed nationalist policies on the environment that contrasted sharply with Francis' call to care for "our common home."

Opening the second leg of his fiveday trip to Cyprus and Greece, Francis recalled that it was in Greece, according to Aristotle, that man became conscious of being a political animal and a member of a community of fellow citizens.

"Here, democracy was born," Francis told Greek President Katerina Sakellaropoulou. "That cradle, thousands of years later, was to become a house, a great house of democratic peoples. I am speaking of the European Union and the dream of peace and fraternity that it represents for so many peoples.

That dream is at risk amid the economic upheaval and other disruptions of the pandemic that can breed nationalist sentiments and make authoritarianism seem "compelling and populism's easy answers appear attractive," Francis said.

'The remedy is not to be found in an obsessive quest for popularity, in a thirst for visibility, in aflurry of unrealisitic promises...But in good politics," he said.

'India exemplary in publishing its forex market intervention'

The authorities should allow the exchange rate to move flexibly to reflect economic fundamentals, limit foreign exchange intervention, said US *Treasury*

Washington, Dec 4: India has been exemplary in publishing its foreign exchange market intervention, the US Treasury Department said Friday adding that New Delhi should allow the exchange rate to move flexibly to reflect economic fundamentals.

"As the economic recovery progresses, the authorities should continue to pursue structural reforms that can help lift productivity and living standards, while supporting an inclusive and green recover," the Treasury said.

In its semi-annual Report to Congress on Macroeconomic and Foreign Exchange Policies of Major Trading Partners of the United States, the Treasury reviewed and assessed the policies of its major trading partners, comprising more than 80 per cent of its foreign trade in goods and services, during the four quarters through June 2021.

In accordance with the Omnibus Trade and Competitiveness Act of 1988 (the 1988 Act), the Report concludes that no major US trading partner manipulated the rate of



exchange between its currency and the US dollar for purposes of preventing effective balance of payments adjustments or gaining unfair competitive advantage in international trade.

The RBI frequently intervenes in both directions, the RBI purchased foreign exchange on net in 10 of the 12 months through June 2021, with net intervention reaching \$131 billion, or 4.6 per cent of GDP, it said.

The RBI made large purchases between July 2020 and February 2021, followed by modest sales in March and April this year as India's second outbreak took hold and net foreign portfolio flows turned negative, it said.

According to the report, India's goods and services trade surplus with the United States was \$40 billion over the four quarters through June 2021, up substantially from its relatively consistent level of around \$30 billion from 2013 to 2019. The higher trade surplus came largely on the back of higher US imports of Indian goods and steady imports of Indian services, while US exports of both fell due to India's weak domestic demand, it said.

TECHNOLOGY CRACKDOWN Didi plans to exit US stock mkt

Beijing, Dec 4: China's dominant ride-hailing service, Didi Global Inc, has said it will pull out of the New York Stock Exchange and shift its share trading to Hong Kong as the ruling Communist Party tightens control over tech industries.

Didi gave no explanation, but China's leaders increasingly fret about who controls information gathered about its public by e-commerce, ride-hailing and other tech companies. Beijing sees that as a valuable asset and security risk.

Regulators said in July they would step up scrutiny of tech companies with shares traded abroad and their information security and cross-border data flows.

Didi's share price fell 25 per cent fter regulators launched an investigation into its handling of



customer data following its June 30 stock market debut.

"After conscientious research, the company will start delisting operations on the New York Stock Exchange immediately and commence preparations to list in Hong Kong," Didi said on its social media account Friday

A separate statement said US shares would be converted into "freely tradable shares" on another "internationally recognised

The company's shares fell 22.17%, losing about \$8.4 billion in market value. Didi shares have fallen about 57% since their June 30 IPO price

Didi Chuxing raised about \$4.4 billion in its market debut. The company earlier denied a news report it planned to buy back its US shares.

Other companies including Alibaba Group, the world's biggest e-commerce company, and Tencent Holding, which operates the popular WeChat message service, also have been hit by data security and anti-monopoly probes

Over 200 Chinese cos may be ousted New Delhi: If the US loses Chinese

companies, Wall Street will gradually alienate itself from the world's most prosperous market and the US will no longer be the true global financial centre, Chinese state media claimed. After the announcement of Didi leaving US stock market, the US Securities and Exchange Commission (SEC) issued a mandate requiring foreign companies listed in the US to provide audits for inspection. Otherwise, they could be delisted from NYSE and Nasdag in three vears. The new SEC regulation clear ly targets Chinese companies listed in the US. Analysts believe that it could lead to more than 200 companies being kicked off US exchanges, Global Times reported

Agri exports up by 13% in Apr-Nov

New Delhi, Dec 4: India's exports of agricultural and processed food products rose by more than 13 per cent during the first eight months of the current fiscal on a YoY basis.

As per the data furnished by the Ministry of Commerce and Industry, export of products under the Agricultural and Processed Food Products Export Development Authority (APEDA) ambit increased from \$11.671 billion in April-November 2020-21 to \$13.261 billion in April-November 2021-22.

The target for exports under the APEDA basket products has been set at \$23.713 billion for 2021-22.



"The export of rice was the top forex earner at \$5,937 million during April-November 2021-22, growing 11 per cent over the corresponding period of 2020-21 when it had touched \$5,341 million. Exports of meat, dairy and poultry products grew 12 per cent at \$2,665 million in April-November 2021-22, compared to \$2,371 million in the corresponding eight-month period of 2020-21," the ministry said.

Besides, fruits and vegetables exports were up by 12 per cent to \$1.720 billion during April-November 2021-22 against \$1.536 billion during April-November 2020-21

"Exports of cereal preparations and miscellaneous processed items grew by 26 per cent during April-November 2021-22 to touch \$1,418 million against \$1.127 million in April-November 2020-21. Cashew exports also grew by 29 per cent to \$302 million in the first eight months of the current fiscal," the ministry said














INDIA ON TOP DESPITE PATEL FEAT

London: Eileen Ash, the oldest living Test cricketer, has died at the age of 110, the England and Wales Cricket Board (ECB) said Saturday. Ash played seven Tests for England on either side of the second World War, taking 10 wickets at an average of 23 with her right-arm pace bowling. She had made her Test debut against Australia in 1937. She was part of the Ashes tour of Australia in 1949 apart from playing representative cricket for Civil Service Women, Middlesex Women and South Women in the domestic arena. Apart from her cricket career, Ash also worked for MI6, the Secret Intelligence Service, during World War II.
