Mumbai: Activist Sudha Bharadwaj, an accused in the Elgar Parishad-Maoist links case, was Thursday released on bail, after spending over three years in a prison. An NIA court had Wednesday directed the release of Bharadwaj on a bail of ₹50,000. Earlier the Bombay High Court had granted default bail to the activist December 1. Following the completion of formalities, Bharadwaj walked out of the Byculla prison here Thursday afternoon. Bharadwaj was arrested in August 2018 under provisions of the stringent Unlawful Activities (Prevention) Act (UAPA)



Farmers Suspend stir Police, BJYM clash leaves over 20 hurt

■ *The farmers' unions however,* have warned the Centre that they will again resort to protests if their demands are not met and they will review the situation January 15, 2022

New Delhi, Dec 9: The Samyukta Kisan Morcha (SKM) announced Thursday the suspension of its over a year-long agitation and said farmers will head home December 11 from protests sites on Delhi's borders. The announcement came after the SKM received an official letter from the Central government, accepting the pending demands of farmers, including unconditional withdrawal of police

cases against protesters. Farmer leaders in a press conference said they would meet January 15 to see if the demands have been met by the Centre. They asserted they will again resort to protests if their demands are not met.

The government also assured farmers that a committee on minimum support price (MSP) will be formed. It will also have members from the SKM. "This is not the end as the move-

ment is just suspended. We have decided to meet again January 15," SKM core committee member Balbir Singh Rajewal said.

Haryana and Uttar Pradesh, started protesting at Delhi's border points - Singhu, Tikri and Ghazipur – November 26 last year against the

three contentious farm laws. The laws were repealed by Parliament November 29, but farmers continued their protests over their pending demands. Another SKM member Gurnam

Singh Chaduni said that 'a review meeting will be convened January 15 to see if the government has met all the demands. If it does not, we can take a call on resuming the protest'. The SKM had said Wednesday

that it has reached a consensus on a revised draft proposal of the Centre on its pending demands but

had demanded a formal communication on a government letterhead. which was received by Thursday morning.

Union leaders also said that farmers will take out victory marches December 11 to their respective places. They would have done so Friday, but have decided to postpone it as a mark of respect to CDS Gen Bipin Rawat and 12 others who were killed in a helicopter crash Wednesday. The funerals of the deceased will take place Friday.

"Farmers will start vacating Delhi border points from December 11. and this may take some time," farmer leader Rakesh Tikait said. He added that the SKM will remain intact.

Bhubaneswar, Dec 9: The stretch from Master Canteen to PMG square turned into a battleground Thursday after a clash broke out between the members of Bharatiya Janata Yuva Morcha (BJYM) protesting over Mamita Meher murder case and security officials deployed at the site. The violence left 15 police personnel injured while the BJP alleged that a large number of its members suffered injuries. Some mediapersons covering the incident also were injured. Hundreds of BJYM members ugly as the police tried to forcibly remove some BJYM leaders from the spot. Soon it was a free for all with the BJYM members throwing brickbats and other missiles and the police going on a lathi-charge to disperse them.

"Police personnel deployed displayed considerable patience. But, when the protestors went berserk, we were forced to use batons to disperse them. They pelted stones, brickbats and other missiles at the police and ransacked eight police vans. Fifteen cops, including ACP Manas Ranjan Garnayak sustained injuries. Three of them are still undergoing treatment at the Capital Hospital here," twin city Police_ Commissioner Saumendra Priyadarsi informed.

Talcher mourns its fallen IAF hero POST NEWS NETWORK

Talcher, Dec 9: Odia officer Rana Pratap Das was among the 13 persons including Chief of Defence Staff (CDS) Bipin Rawat, who lost their lives Wednesday in the Indian Air Force (IAF) chopper crash near Coonoor in Tamil Nadu.

Das was from Krushnachandrapur village under Kundala panchayat of Talcher locality in Angul district. He was working in IAF as a Junior Warrant Officer (JWO) for last the 12 years, a source informed.



Rana's brother-in-law Sankalp Das confirmed the officer's death on his Twitter handle. "My brotherin-law Rana Pratap Das from Talcher in Angul district in Odisha lost his life in the IAF helicopter crash. I had talked with Rana just two days ago. He said that he would soon fly down to meet us all. I cannot believe that he is no more with us," wrote Das

According to a family source, the deceased IAF officer is survived by his wife, a one-year-old son and elderly parents. Mortal remains of the JWO will be brought Thursday night to his ancestral village in Talcher and his last rites will be conducted, the source added. Both the father and mother of Rana have not been informed about his demise since they are cardiac

Coonoor/New Delhi, Dec 9: Defence Minister Rajnath Singh told the Parliament Thursday that a tri-services inquiry led by Air Marshal Manavendra Singh has started investigation into the Mi-17V5 helicopter crash that killed Chief of Defence Staff (CDS) General Bipin Rawat and 12 others. "A tri-services inquiry headed by Air Marshal Manavendra Singh has been ordered by the Indian Air Force (IAF). A team of investigators had reached Wellington yesterday

(Wednesday) itself and started their work," Singh said in his statement.

The minister also informed that



data recorder were recovered from the site, sources said. These will be taken to Delhi or Bangalore to ascertain the cause of the crash.

The defence minister also wished, IAF's Group Captain Varun Singh, the only survivor in the crash, a speedy recovery. IAF officials are hoping Singh recovers, as he can provide vital clues that led to the crash. The IAF instructor is currently on life support in a hospital in Bangalore. "All efforts are being made to save Group Captain Singh,' said Singh.

The mortal remains of the 13 victims, in caskets wrapped in Indian Tricolour have arrived in Delhi.

Covid-19 hits Bhubaneswar schools

After cases from schools in Angul, Mayurbhanj, Sundargarh districts, educational institutions in the state capital also reported new cases of Covid-19 infections

Bhubaneswar, Dec 9: Amidst the threat of the Omicron variant of Covid-19, more than 10 staff members of Kendriya Vidyalaya -1 here and two boy students of Capital High School have tested positive. Earlier school

students in Angul, Mayurbhanj, Sundargarh and some other districts had tested positive for the virus.

Sources said that the Bhubaneswar Municipal Corporation (BMC) has increased the rate of testing in schools and colleges with the resumption of physical classes. They said the BMC has targeted 1,500 tests at the institutions on a daily basis.

Jitendra Nayak, Headmaster of Capital HS said that swab samples of 372 students were collected Wednesday by the BMC. Reports that arrived Thursday morning showed two positive results.

In a separate development more than 10 staff members of KV-1 also tested positive. Principal Bhupendra Singh said that some of them underwent RT-PCR tests few days back after feeling unwell. Physical classes have temporarily been suspended as the staff is in quarantine.

Meanwhile despite the Covid-19 scare the school is conducting the CBSE Class X and XII board exams for the academic session 2021-22 in two phases. The first term exams will be held in November-December

and the second in March-April, next year.

Singh informed that they do not have the authority to cancel the exams despite the Covid-19 outbreak. He added that the exams will be conducted following all protocols. "Teachers who have tested negative are only allowed and the students will sit for the exams after proper sanitisation and with masks,' Singh said. Some parents on condition of anonymity however, said -(that they have stopped sending their children to school.





Bhubaneswar, Dec 9: Chief Minister Naveen Patnaik Thursday laid the foundation for a global scale Technical Ammonium Nitrate (TAN) Manufacturing Complex at Gopalpur in Ganjam district through virtual mode.

One of the leading manufacturers of fertilizers in India, Smartchem Technologies Ltd, is setting up this unit at an investment of Rs 2,200 crore, which will create employment opportunities for over 1,700 local people.

Speaking on the occasion, Naveen said that the project is another example of state's continuing dominance as a premier investment destination for multiple sectors of industry. "Despite the pandemic situation and consequent slowdown in the economy. Odisha continues to receive new investments. 3,708 road fatalities during Jan to Sept

Bhubaneswar, Dec 9: About 3,708 people have died in road mishaps out of 8,028 accidents reported in the state during January to September, Commerce and Transport Minister Padmanabha Behera informed the Assembly Thursday.

In a written reply to Gopalpur MLA Pradeep Kumar Panigrahy, the minister said that over-speeding, drunk driving, driving on wrong side, jumping red signal and use of mobile phone while driving constituted the primary causes of road accidents in Odisha

On district-wise accidents and deaths, Behera said Khurda, Cuttack, Ganjam and Sundargarh reported the highest number of cases this year. State records 195 new Covid cases, 2 deaths

Bhubaneswar, Dec 9: Odisha logged 195 new coronavirus cases, taking the tally to 10,50,955 Thursday, a Health department bulletin said.

The Covid-19 toll in state rose to 8,428 as a person each from Khurda and Kendrapara districts succumbed to the highly infectious disease. Fifty-three other Covid patients have died due to comorbidities so far, according to official data. Twenty-four children were among the 195 new patients and Khurda district reported the highest number of 99 new infections, the bulletin stated.

The state now has 2,071 active Covid-19 cases, while 10,40,403 people have recuperated from the contagion so far, including 264 in the past 24 hours, it said.

At least 61.899 sample tested during the period and the state's daily test positivity rate (TPR) was 0.32 per cent, the Health department bulletin said.

The study also highlights the importance of recording the time of vaccination or any intervention in clinical and research studies.

"If preliminary data show a difference in efficacy and adverse effects from a drug or vaccine based on time of day, it would behove drug companies to administer the drug at the optimal time. which would reduce the number of participants needed to get a statistically significant difference between drug and placebo," Klerman added.

Sambalpur, Dec 9: A six member bench of the National Green Tribunal (NGT) has accused Hindalco and GMR-- two of the previous coalminers of Talabira coalmine-1 of causing pollution, and slapped a combined ₹10 crore penalty on them, a report said Thursday

The tribunal has penalised them for their failure to spend ₹10 per tonne of coal extracted on the peripheral development of the area and environment protection. The two firms have failed to implement this despite a standing rule. Moreover, the



tribunal has ordered formation of a six-member technical team by the state government to oversee the implementation of its order and submit a report in this regard.

According to the order, Hindalco has to deposit 75 per cent of the penalty money while GMR only 25 percent. The tri-

bunal passed the order December 8 whose last hearing was held November 29.

The matter came up before the tribunal after an environmentalist Subhash Mohapatra, social activists Hemant Rout and Manbodh Biswal filed a case against the Talabira coalminers in the tribunal in 2016. The petitioners alleged that the two coalminers, while mining from Talabira coalmine-1, illegally used the land of Hirakud reservoir, polluted the environment, the reservoir and extracted excess coal. The residents also protested other vi-

olations by the two coalminers.



Funds crunch plagues school transformation programme

Sambalpur, Dec 9: Funds crunch has plagued the government's initiative to renovate rural high schools to make them at par with private schools in urban areas.

The scheme, part of the 5T high school transformation programme, equips schools with facilities like new furniture, audio-visual teaching aids, projectors, science labs and e-libraries, among others. Many of the existing schools have been renovated and given swanky looks. Old furniture like chairs, tables and desks have been replaced with new ones. Classrooms have been revamped with better lighting systems.

However, observers pointed out that this scheme was

ited fund allocation. As a result, renovation of high schools in Sambalpur district has failed to take off.

As many as 25 high schools in Sambalpur district were renovated in the first phase and declared as smart schools, November 16 while renovation of 53 schools is underway in the second

phase. It has come to notice that contractors turn away from undertaking renovation of schools due to funds crunch. Observers point out that unless fund allocation is increased, the scheme may not

yield the desired results. Meanwhile, the state government has directed Collectors to expedite the school transformation pro-

trict administrations have directed respective BDOs to spend the government funds available under SFC, CSFC, Western Odisha **Development** Council (WODC), BRGF, MGNREGS, CRF and even the CSR funds of local industries for transformation of schools. The BDOs also work overtime and expedite the project works.

However, despite the instructions, the district and block administrations are vet to clear the outstanding bills of the consultancy agencies and raw materials suppliers. These agencies have made several efforts to get their bills cleared but in vain. As a result, these agentioned ₹45 lakh for the smart school projects out of which ₹10 lakh will be deposited in the savings bank accounts of the school managing committees.

This fund will be spent on conducting training programme involving teachers, students and guardians while another ₹15 lakh will be spent on buying furniture, science equipment, computers, projectors and materials for science laboratories. The rest ₹35 lakh will be spent on renovation of schools. Most of the high schools in the state have two to three rooms while the rest of school functions from asbestos-roofed houses having mud walls plastered with cement. The repairing and renovation of these schools need more funds. one of the contractors requesting anonymity said.

When contacted, Dillip Kumar Bal, PD, DRDA, said attempts are being made to tide over the fund shortage and expedite the renovation work. He assured that the outstanding bills of the concerned contractors and raw material suppliers will be cleared soon.

hese are tough times for the humanities. Too many liberal arts subjects have come to be seen as fusty and irrelevant. Who can afford to invest in a four-year education focusing on the wisdom of the Mayan civilization or the nuances of Japanese poetry? To adapt Churchill's famous 1939 aphorism about understanding Russia, students today confront a pandemic. wrapped in a technological revolution, inside a climate crisis.

As a proud humanities scholar, I believe that the knowledge my colleagues and I impart is essential to prepare students for future uncertainties. As the past five years have shown, predictions from even our most informed technical experts can easily go awry. The humanities, with their focus on the infinite variety of human expe rience, offer the best insurance against overconfident forecasters.

According to then-Minister of Education Dan Tehan – a not-so-proud humanities graduate - the policy would save students from the kind of education that "nearly cost me the opportunity of getting a job.'



The political empowerment ranking is higher than that of the UK, which is ranked 20th, and substantially higher than that of the US, which is ranked 68th. Even if it looks like an achievement on the surface, if we dig deeper, we find out that the ranking takes into account the number of female heads of state in the past 50 years, which gives India an advantage due to Indira Gandhi's tenure as PM for two terms. Even though her leadership paved multiple forefronts for inclusion of women in politics, this statistic

In the South China Sea, through which around one-third of global maritime trade passes, Xi's regime has stepped up lawfare to consolidate Chinese control, turning its contrived historical claims into reality. Last year, while other claimant countries were battling the COVID-19 pandemic, Xi's government created two new administrative districts to strengthen its claims over the Spratly and Paracel Islands and other land features. And in further defiance of international law, China gave Mandarin-language names to 80 islands, reefs, seamounts, shoals, and ridges, 55 of which are fully submerged.

The Hong Kong National Security Law, enacted in mid-2020, is a similarly aggressive act of lawfare. Xi has used the law to crush Hong Kong's pro-democracy movement and rescind the guarantees enshrined in China's UN-registered treaty with the United Kingdom. The treaty committed China to preserving Hong Kong citizens' basic rights, freedoms, and political self-determination for at least 50 years after regaining sovereignty over the territory.

The strategy's success in unraveling Hong Kong's autonomy raises the question of whether China will now enact similar legislation aimed at Taiwan or even invoke its 2005 Anti-Secession Law, which underscored its resolve to bring the island democracy under mainland rule. With China escalating its psychological and information warfare, there is a real danger that it could move against Taiwan after the Beijing Winter Olympics in February. Xi's expansionism has not spared even tiny Bhutan, with a population of just 784,000. Riding roughshod over a 1998 bilateral treaty that obligated China "not to resort to unilateral action to alter the status quo of the border." the regime has built militarised villages in Bhutan's northern and western borderlands. As these examples show, domestic legislation is increasingly providing China with a pretext to flout binding international law, including bilateral and multilateral treaties to which it is a party. With more than one million detainees, Xi's Muslim gulag in Xinjiang has made a mockery of the 1948 Genocide Convention, to which China acceded in 1983 (with the rider that it does not consider itself bound by Article IX, the clause allowing any party in a dispute to lodge a complaint with the International Court of Justice). And because effective control is the shibboleth of a strong territorial claim in international law, Xi is using new legislation to undergird China's administration of disputed areas, including with newly implanted residents.

New Delhi, Dec 9: India's civil aviation regulator, the DGCA, Thursday extended the ban on scheduled international commercial flights till January 31.

Earlier, India had announced plans to allow resumption of scheduled commercial international passenger services from December 15 with certain conditions.

However, December 1, the Directorate General of Central Aviation (DGCA) said it is "closely monitoring" the situation emerging out of the Covid-19's Omicron variant and the final decision on the resumption of near normal international flight operations will be taken after consultation with stakeholders. In the notification on Thursday, the DGCA extended the ban on scheduled international commercial flights till January 31, 2022. "This restriction shall not apply

to international all-cargo operations and flights specifically approved by the DGCA."

It also said that scheduled international flights might be allowed on selected routes on a case to case basis. India had banned the opera-

Rescind travel bans: IATA to govts

The International Air Transport Association (IATA) called for governments to follow World Health Organisation's (WHO) advice and immediately rescind travel bans that were introduced in response to the Omicron variant of coronavirus. Public health organisations, including the WHO, have advised against travel curbs to contain the spread of Omicron. "After nearly two years with Covid-19 we know a lot about the virus and the inability of travel restrictions to control its spread," IATA Director General Willie Walsh said. According to Walsh, the goal is to move away from the uncoordinated, evidence-absent, risk-unassessed mess that travellers face.



New Delhi, Dec 9: Around 14 million more cases of malaria and 69,000 more deaths due to it were reported worldwide in 2020 than in 2019 and India was the only highburden country to have sustained a reduction in the disease burden, according to a World Health Organisation (WHO) report. It, however, stated the rate of

decline of the disease in India was slower than before the pandemic with the country still sharing over 80 per cent of the malaria burden of South-East Asia. The World Malaria Report 2021, brought out by WHO, highlighted the havoc malaria continues to wreck on the world's poorest and the most vulnerable. It also highlighted sizable gaps

in malaria funding as the demand to sustain progress increased last year to \$6.8 billion with only a tiny increase in malaria funding.



However, the rate of decline was slower than before the pandemic," the WHO report stated.

'Even before the Covid-19 pandemic struck, global gains against malaria had levelled off." said WHO Director-General Dr Tedros Adhanom Ghebreyesus in a statement. Alongside plateauing investments, a sharp drop in malaria testing and gaps in mosquito-control measures contributed to the thwarted progress in the high-burden countries, the World Malaria Report 2021 stated.

Ravaged by the pandemic, India only managed to fulfil 50 per cent of its planned distribution of longlasting insecticidal nets and had also recorded a reduction in other measures like the indoor residual spraying during 2020, the report stated.

Kohima, Dec 9: The Naga Students' Federation (NSF) and The Eastern Naga Students Federation (ENSF) Thursday demonstrated outside the Raj Bhavan here against the killing of 13 civilians by the Army in Mon district and demanded the repeal of the Armed Forces (Special Powers) Act

They demanded that the 'draconian act' be repealed once and for all and that human rights be restored in the state. The activists carried placards

some of which read 'Repeal the draconian law - Armed Forces Special Powers Act', 'Nagas have every right to live in peace' and 'We stand in solidarity with our Naga brethrens - The innocent civilians who were brutally killed at Oting village, Mon district'. They also burnt effigies of se

curity forces and shouted slogans 'Repeal AFSPA'.

The student unions demanded that the Centre set up a court monitored committee headed by a retired Supreme Court or High Court Judge for an impartial probe into the Mon firing.

They sought the identification of the army personnel involved in the incident and demanded that they be "booked for the highest level of punishment.

They also demanded that the action taken against the perpetrators be made public.

NSF president Kegwayhun Tep addressing the gathering said the killing took place at a time when the Naga people from across the region come together to celebrate their rich cultural heritage and identity through the Hornbill Festival and wait to celebrate Christmas.

He demanded that the Centre immediately stop its "policy of militarisation of the northeast region.

"We cannot allow this draconian law to cause further terror in our homeland," Tep said adding that as long as the 'draconian' AFSPA remains in force in the state, the land and its people will be tormented by fear and uncertainty.

The AFSPA,1958 is one of the more draconian legislations that the Parliament has passed in its 75 years of being, said former NSF president Chuba Ozukum. He recalled that as the then pres-

ident of the student body, he had staged a sit-in demanding repeal of Act some 25 years ago at the same place. The enforcement of AFSPA has

resulted in innumerable incidents of arbitrary detention, torture, rape, and looting by security personnel in Nagaland and the north eastern region, he claimed and said the Centre keeps extending AFSPA in Nagaland every six months but fails to take into account the ground reality. If the country is trying to be-

come a permanent member of the United Nation's Security Council, it should "first do away with the out dated and draconian AFSPA ... This inhuman law has lost its relevance in a civilised society and its applicability has no place in the modern world. AFSPA must be repealed if the Government of India truly honours the Naga peace process and a peaceful solution to the vexed Indo-Naga political talks," Ozukum said.

As there are not many food stalls here once you cross the border, people prefer to grab a quick bite here," said Sanjay Sharma, who runs a small hotel with his wife here.

The Christmas rush is missing. But some extra bucks are coming in because of this unfortunate incident." Sharma, who had left his home in Bihar three decades ago, added. Bipin Baruah, who sells tea and breakfast to the morning crowd in nearby Sonari town, echoed Sharma and said, "Since lockdown, business had been really down. These few days we have been getting a few extra customers." A local youth activist, sipping a cup of tea at Baruah's stall, added, "There are about seven-ten hotels with accommodation facilities. Protest sites were like home, will be lifelong memory, say farmers

New Delhi, Dec 9: After spending over a year agitating against the three farm laws at three Delhi border points, many farmers became nostalgic as Samkvukta Kisan Morcha announced that thousands of protestors would start vacating the protest sites from December 11. Amrik Singh, aged around 65,

from Patiala said he felt at home in his tent at Singhu border and thought of the possibility of leaving it with a heavy heart.

"I don't feel like leaving it all behind and all those memories of struggle, moments of jov and friendships we have formed." he said.

'It often occurs to me that I should rent a house here if the protest ends," Singh added in a lighter vein. Riding hundreds of tractors and other vehicles, farmers from Punjab, Harvana and Uttar Pradesh in the last week of November 2020 moved towards Delhi demanding repeal of three farm laws of the Narendra Modi government, Since November 26 last vear, the farmers have laid siege at highways at Delhi's border points at Singhi, Ghazipur and Tikri setting up makeshift accommodation and arrangements of daily life. Saudagar Singh, a middle-aged farmer from Ludhiana, reminisced his struggles during the yearlong protests, narrating the bonds he forged and how many new friends he found at the protest site. "We thought the government will not listen to us and we will have to stay here. But finally we won and farm laws are gone. Now it's time to go home and we are feeling awkward now," he said. Preparing to go home, many farmer protesters said that they will dispose of items of daily use and back carrying their personal belongings and vehicles. "There is not much to take back home. Most of it will be given to local people many of whom are

Delhi's winter PM 2.5 level to be dangerous in 2030 too: TERI

New Delhi, Dec 9: The pollutant PM2.5 in Delhi's air during the winter season will drop by 28 per cent in 2030, but will still be significantly above the national standards of 60 microgrammes per cubic metre, The Energy and Resources Institute (TERI) revealed in a study.

"PM2.5 concentrations in winter are expected to fall by 9 per cent, 21 per cent, and 28 per cent in 2022

levels are to be brought down considerably. Airshed level controls can reduce winter season PM2.5 concentrations by 35 per cent by the vear 2030 when compared to the business as usual scenario.

Director General of TERI Vibha Dhawan, said: "Air pollution should be focused as a problem throughout the year not only during the winter season. Stringent actions are needed in the whole airshed to improve air quality in the NCR. Instead of completely banning the essen-

2025, and 2030, respectively, when compared to 2019, the base year of the study. Though the PM2.5 concentrations may fall marginally over the years, the levels will continue to remain significantly above the national standards of 60 microgrammes per cubic metre," the study titled 'Cost effectiveness of interventions for control of air pollution in Delhi' and supported by Bloomberg Philanthropies issued Thursday, said.

Particulate matter of 2.5 micron size is the major pollutant in Delhi's deteriorating air pollution, and contributed by transport sector, biomass burning, and industry.

In 2019, the PM2.5 concentrations in Delhi violated the annual average standards by about three times. Transport (23 per cent), industries including power plants (23 per cent), and biomass burning (14 per cent) were the major contributors to prevailing winter time PM2.5 concentrations in Delhi dur-

Over 2k construction sites fined for violating anti-dust guidelines

New Delhi, Dec 9: As many as 2,146 construction and demolition sites in the national capital have been penalised for violating Delhi government's anti-dust guidelines.

A fine of Rs 382.06 lakh has been imposed on them for the same. Inspections of the 22,764 construction and demolition (C&D) sites were carried out in 19 days by 585 teams deployed by Delhi government to keep a check at such sites to curb the dust pollution.

The data was shared in a compiled Action Taken Report (ATR) prepared by the Department of Environment & Forest, showing the figure from November 17 till December 6. Earlier November 14. the Commission of Air Quality Management (CAQM) had advised



The CDS is the chairman of the powerful Chiefs of Staff Committee (COSC) that also comprises the three service chiefs.

It is learnt that the possibility of appointing Gen Naravane to the top post is high considering his overall performance as well as the handling of the eastern Ladakh standoff.

The Army Chief is due to retire in April. Gen Naravane is the senior-most among the three service chiefs.

IAF chief Air Chief Marshal VR Chaudhari and Navy Chief Admiral R Hari Kumar had taken over their respective positions September 30 and November 30.

On January 1 last year, Gen Rawat took charge as India's first CDS with a mandate to bring in convergence in the functioning of the Army, the Navy and the Indian Air Force and bolster the country's overall military prowess.

The Samyukta Kisan Morcha (SKM) earlier announced the suspension of the agitation and said farmers will head home from December 11 from protests sites on Delhi's borders.

The announcement came after the SKM received an official letter from the central government, accepting the pending demands of farmers, including unconditional withdrawal of police cases against the protesters. Farmer leaders said they would meet January 15 to see if the demands have been met by the government, asserting that this is not the end of the movement. At the protest sites, farmers were seen dismantling their tents, packing their bags and loading daily use items into trucks to prepare for their journey back home after the victory march December 11

A farmer from Punjab's Moga who had been stationed at Singhu border for the last one year said, "We used to come here in groups of 15. Today, we are loading our things like fans, coolers and air conditioners. We will leave December 11 after the victory march." "We made Prime Minister Narendra Modi agree to our demands. Had he agreed earlier, almost 700 farmers would not have died during the movement. But we are happy that our struggle has bore fruit," he said.

Nirvair Singh, a 60-year-old protester from Punjab, said, "It took 10 people around two hours to dismantle everything. There were 19 of us who had come here and six of us are left now, while others have gone back. We used to come here for 10 days and then go back and then return. We are going to be celebrating our victory and then go back to our homes." At Ghazipur, machines like bread makers and milk boilers will be removed from Thursday night with many protesters starting the journey back home Thursday itself. They said it will take a few more days to remove the temporary structures and accommodations at the Ghazipur site.

New Delhi, Dec 9: Gender pay gap has deepened during the Covid-19 pandemic, with women being left behind on pay raises and bonuses, says an ADP study.

This disparity exists despite the study finding that men and women were just as likely to take on additional responsibilities or a new role due to Covid-19-related impacts on their organisations. ADP Research Institute surveyed 32,471 workers in 17 countries around the world between November 17 and December 11, 2020. The gender pay gap is an issue

that goes much deeper than salaries. There are many factors to consider such as the social dynamics of society, what government support is



available and the culture of a workplace, Yvonne Teo, Vice President

Teo further said that bonus is just one of many factors that have contributed to an increased gender pay gap since the onset of the pandemic.

It doesn't happen overnight. To effectively and sustainably eradicate a pay gap, there needs to be a long-term strategy over three or five years with targets and frameworks in place that cover the employee life cycle, from talent acquisition and promotions to departure and internal education.

Without a dedicated and continued focus on diversity, equity and inclusion across the business, we will see a repeat of the backward steps taken during Covid-19 on gender disparity, Teo said. The ADP study also revealed that employees are still judged for taking advantage of flexible working arrangements (71 per cent of females and 64 per cent of males feel judged). Rahul Goyal, Managing Director - ADP India, said there are implications on employee satisfaction if companies do not solve the issue, which is particularly challenging amidst the current demand for talent.

Employees' perceptions of fairness play a critical part in their sense of loyalty and dedication, which in turn impact productivity and talent retention, and more widely, reputation. If women start to feel that their efforts are being overlooked especially in reference to their male colleagues - that's a situation employers will want to avoid at all costs, Goyal said.

US orders arms embargo on Cambodia

Bangkok, Dec 9: The US has ordered an arms embargo on Cambodia, citing deepening Chinese military influence, corruption and human rights abuses by the government and armed forces in the Southeast Asian country.

The added restrictions on defense-related goods and services, issued by the State and Commerce de partments, are due to be published and take effect Thursday.

A notice in the Federal Register said developments in Cambodia were "contrary to US national security and foreign policy interests.

The aim of the embargo is to ensure that defense-related items are not available to Cambodia's military and military intelligence services without advance review by the US government, it said.

The latest restrictions follow the Treasury Department's ordering in November of sanctions against two senior Cambodian military officials for corruption and come amid increasing concern about Beijing's sway.

At the time, the US government issued an advisory cautioning American businesses about potential exposure to entities Cambodia and its military that "engage in human rights abuses, corruption and other destabilising conduct.

Cambodia branded those sanctions as "politically motivated" and said it would not discuss them with Washington.

The US has similar controls on exports of items that might be diverted to "military end users" in Myanmar, China, Russia and Venezuela.

US exports to Cambodia in 2019 totaled \$5.6 billion. The amount of military-related US exports to Cambodia was not immediately available. The US is the largest export market for Cambodia, a major garments manufacturing hub, but three-quarters of Cambodia's imports are from China and other countries in Asia.

Beijing's support allows Cambodia to disregard Western concerns about its poor record in human and political rights, and in turn Cambodia generally supports Beijing's geopolitical positions on issues such as its territorial claims in the



Milan, Dec 9: Italy's antitrust watchdog said Thursday it had fined Amazon \$1.3 billion (1.1 billion euros) for alleged abuse of market dominance, in one of the biggest penalties imposed on a US tech giant in Europe.

Amazon said it strongly disagreed with the Italian regulator's decision and would appeal.

Italy's watchdog said in a statement that Amazon had leveraged its dominant position in the Italian market for intermediation services on marketplaces to favour the adoption of its own logistics service - Fulfilment by Amazon (FBA)

by sellers active on Amazon.it. The authority said Amazon tied to the use of FBA access to a set of exclusive benefits, including the Prime label, that help increase visibility and boost sales on Amazon.it. Amazon prevents third-party sellers from associating the Prime label with offers not managed with

FBA, it said. The Prime label makes it easier to sell to the more than 7 million most loyal and high-spending consumers members of Amazon's loyalty program.

The antitrust authority also said it would impose corrective steps that



will be subject to review by a monitoring trustee.

Amazon said FBA is a completely optional service and that the majority of third-party sellers on Amazon do not use it.

"When sellers choose FBA, they do so because it is efficient, convenient and competitive in terms of price," the US group said in a statement.

The proposed fine and remedies are unjustified and disproportionate, it added.

The EU Commission said it had cooperated closely with the Italian competition authority on the case, within the framework of the European Competition Network, to ensure consistency with its two own ongoing investigations into Amazon's business practices.

The first was opened in July 2019 to assess whether Amazon's use of sensitive data from independent retailers who sell on its marketplace was in breach of EU competition rules.

The second, in late 2020, focussed on the possible preferential treatment of Amazo's own retail offers and those of marketplace sellers \rightarrow that use Amazon's logistics and delivery services.

This investigation complements today's decision of the Italian competition authority which addresses Amazon's conduct in the Italianlogistics markets, the Commission said Thursday.

Stokes' overstepping exposes Ashes' issue

Brisbane, Dec 9: There was one glaring mis-step from Ben Stokes which cost England a wicket on the second morning of the Ashes, giving Australian opener David Warner a reprieve when he was on 17.

It soon emerged that Stokes, bowling his first over in a Test match since March, had also overstepped the crease on his previous three deliveries and not been called for a no-ball by

the umpires. Later still, Australia's Ashes broadcaster Channel 7 revealed Stokes had overstepped the front crease 14 times in Thursdays' opening session and had only been called twice for a no-ball.

The missed opportunity on Warner was a problem for Stokes and England. The amended decision: no ball. Warner got to play on. One run was added to the total in the sundries column — and an extra delivery had to be bowled in the over.

But it exposed a bigger problem for the match officials. Cricket Australia said a technology problem at the Gabba meant that the third umpire, Paul Wilson, couldn't review TV replays of every delivery to check if bowlers were over-stepping the crease, leaving it to the on-field umpires to make
