#### **UK SEES FIRST OMICRON DEATH**


London: The UK has seen its first death from Omicron, even as the latest variant of the coronavirus is expected to comprise 50 per cent of the cases in London by Tuesday, Prime Minister Boris Johnson said Monday. "Sadly yes, Omicron is producing hospitalisations and sadly at least one patient has been confirmed to have died with Omicron. "So I think the idea that this is somehow a milder version of the virus, I think that's something we need to set on one side and just recognise the sheer pace at which it accelerates through the population. ### Panchayat polls in Feb; dates by end of Dec

■ The SEC has finished revising the electoral rolls and the final voter list is awaiting print

Bhubaneswar, Dec 13: The State Election Commission (SEC) will shortly announce the dates for the three-tier panchayat polls in the state as the final voters' list is ready.

The tenure of the Panchayati Raj Institutions (PRI) in the state will end in March, 2022 and elections to form fresh councils will be conducted before the end of the term. Sources said the dates are likely to be announced by the end of December and the polls may begin in February

The State Election Commission had started the process of preparing the electoral rolls in November. Those who attained 18 as on November 1, 2021, have been included in the voters' list. Names of over 2.61 crore voters have been included in the list.

As 91,913 voter boxes are needed for the poll, the SEC has brought 10,000 boxes from Telangana, 7,000 from West Bengal and 16,000 from

Odisha Small Industries Corporation (OSIC). "Our electoral roll revision process has been completed and the final list has been published in the entire state. We are waiting for the printed copy. The other preparedness from the commission's side has been completed,"

The polls will be held in 91,913 wards among 6,794 panchayats and 853 Zilla Parishad members in the state.

The voting is likely to be conducted on five different dates with one day gap between the poll dates.

Like in last panchayat polls in 2017, a block will be taken as a unit and elections to all Zilla Parishads, Panchayat Samitis, Gram Panchayats and wards coming under the block will be completed on a single date.

The commission has decided to hold the elections in such a manner that the block(s) having maximum booths go to poll in the first phase which would gradually taper off in subsequent phases



# Jawad report in a week

Bhubaneswar, Dec 13: A report on the crops damaged by cyclone Jawad will be submitted to the Centre after its assessment to be completed within a week. This was discussed at the high-level meeting between state government officials

and a central team here Monday. Chief Secretary Suresh Chandra Mahapatra, Special Relief Commission Pardeep Kumar Jena along with senior officers interacted with the inter-ministerial central team after its two days visit

Standing crop on more than 5.78 lakh hectors in 131 blocks of 12 districts were severely damaged. The districts included Ganjam, Bhadrak, Puri, Cuttack, Balasore, Kendrapara, Keonjhar, Khurda, Jagatsinghpur, Nayagarh, Jajpur

and Mayurbhanj. The six-member team led by Saurav Ray, joint secretary, ministry of home affairs, was divided into three sub-teams and had discussions with Special Relief Commissioner Jena. The teams visited Jawad-hit areas in Ganjam, Puri, Jgatsinghpur, Cuttack, Jajpur and Kendrapara.

SRC Jena said that because of standing water in the agricultural fields, the farmers also could not sow seeds for the Rabi crop. "State's climatic condition is also not conducive for late Rabi crop as the temperature starts growing by mid

February," he said. Central team leader Ray said they saw heavy losses to farmers at the ground-level caused by the cyclonic rain. He opined that the famers who suffered losses needed governmental assistance.

### 2 cops killed in J&K attack on Army bus

■ In a day marked by 20th anniv of Parl attack, an Army bus was targeted by militants in Srinagar that killed two cops. The toll may go up considering most of the injured are critical. Attack exposes chinks in security set-up

Srinagar, Dec 13: In a major attack on security forces, two Jammu and Kashmir Police personnel were killed and at least 12 others injured when terrorists fired on a police bus on outskirts of Srinagar city Monday evening, police said. Police sources said the incident was reported from the Pantha Chowk area, on the outskirts of Srinagar city.

'Two policemen were killed and 12 others injured in this attack. All the injured have been shifted to hospital. The area has been cordoned off," a source said, adding that the bus was carrying personnel of Jammu and Kashmir Armed Police's 9th Battalion.

This is a major terrorist attack on the security forces in recent days and it has taken place in an area where many camps of the security forces are situated. At least 14 policemen sustained

injuries in the attack. The injured were evacuated to various hospitals where two of them died. The deceased included an assistant sub-inspector of the armed police. No terrorist outfit has so far claimed responsibility for the firing on the police bus

All five terrorists involved in the attack were also killed. 

### CBSE to give full marks for 'misogynistic' question

■ *In a quick damage control* move, the CBSE has announced awarding full marks to a question in Class X English paper allegedly promoting gender stereotyping and regressive notions against women among young kids

New Delhi, Dec 13: The CBSE Monday dropped a comprehension passage and the accompanying questions from the Class-10 English exam paper and decided to award full marks for it to students, following an outrage over the board allegedly promoting "gender stereotyping" and supporting "regressive notions"

The Central Board of Secondary Education (CBSE) had referred the matter to subject experts Sunday and sought their feedback. In the Class-10 exam conducted Saturday, the question paper carried a comprehension passage with sentences such as "emancipation of women destroyed the

parents' authority over the children" and "it was only by accepting her husband's way that a mother could gain obedience over

the younger ones", among others. Excerpts from the passage have gone viral on social media platforms with users calling out the board for supporting "misogynistic" and "regressive opinions" and the hashtag "#CBSEinsultswomen" trending on Twitter.

"A passage in one set of the English language and literature paper of the CBSE Class-10 firstterm examination held on December 11 is not in accordance with the guidelines of the board with regard to the setting of question papers.

"In this backdrop and on the basis of the feedback received from the stakeholders, the matter was referred to a committee of subject experts. According to the panel's recommendation, it has been decided to drop the passage and the accompanying questions," CBSE Examination Controller Sanyam Bhardwaj said.

#### SC RESPITE FOR CBSE CLASS 12 STUDENTS

New Delhi: The Supreme Court Monday said the CBSE should consider the problem of those students who had appeared in the examinations this year for improving marks in Class 12 but obtained lower numbers, as it will affect the admissions secured by them for higher studies. The students who appeared in the improvement

exams have taken admissions based on their original results and that should not be disturbed, the apex court observed. A bench of Justices A M Khanwilkar and C T Ravikumar was informed that the Central Board of Secondary Education (CBSE) has filed a counter affidavit stating that the previous result of the students, who failed subsequently in the improvement examinations, would be considered and they would have the opportunity to retain it.

"Full marks will be awarded for this passage to all the students concerned. To ensure uniformity and parity, full marks will also be awarded to students for passage number one for all sets of the question paper," he added

Congress president Sonia Gandhi Monday condemned the "blatantly misogynist" and "nonsensical' questions in the Class-10 CBSE exam, saying those reflected "extremely poorly" on the standards of education and testing.

Raising the issue during the Zero Hour in the Lok Sabha, she demanded an immediate withdrawal of the said passage, an apology from the government and a review into this "gravest lapse"

"The passage contains atrocious statements such as 'women gaining independence is the main reason for a wide variety of social and family problems' and if 'wives stop obeying their husbands, that is the main reason children and servants are indisciplined'," she said, read-

ing out excerpts from the question paper. Congress leader Rahul Gandhi also took to Twitter to raise the issue.

"Most CBSE papers so far were too difficult and the comprehension passage in the English paper was downright disgusting. Typical RSS-BJP ploys to crush the morale and future of the youth. Kids, do your best. Hard work pays. Bigotry doesn't," he said.

The CBSE issued a statement Sunday, saying, "The passage in one set of the English paper of CBSE Class-10 first-term examination held on December 11 has received mixed reactions from a few parents and students stating that 'it seems to support regressive notions on family and allegedly promotes gender stereotyping'.'

The CBSE Class-12 sociology exam held earlier this month asked students to name the political party under which the "anti-Muslim violence in Gujarat in 2002" took place, a question the board later said was "inappropriate" and against its guidelines.





#### Norms out for admissions to vacant PG seats

Bhubaneswar, Dec 13: The Higher Education department Monday released a new set of guidelines and dateline for admissions to vacant PG seats (Spot-II) selection for 2021-22 academic session.

The candidates, who have been selected earlier but did not take admission during the previous spot admission, are eligible to apply afresh. The candidates have to provide only one fresh option of universities/colleges for admissions.

The availability of online CAF for vacant PG seats will begin December 15, 2021

The availability of online common application form (CAF) for PG vacant seats will begin December 15, 2021. The last date for providing fresh option in CAF is December 19. The merit list will be published for the PG vacant seats December 22. After generating the intimation letter, candidates are required to report to the allotted institutions with relevant documents from December 23 to 24.

Once intimation letter is generated, earlier admissions in the previous institutes/courses will be automatically cancelled.

In case the candidates don't turn up for admissions within the stipulated time, universities and colleges can select new candidates from the waiting list and update the

# CM launches projects worth over ₹2,500cr in 2 dists

Bhubaneswar/Cuttack, Dec 13: Chief Minister Naveen Patnaik Monday inaugurated and laid the foundation stone of projects worth Rs 2,500 crore while launching the distribution of smart health cards under Biju Swasthya Kalyan Yojana (BSKY) to beneficiaries in Cuttack and Khurda districts.

Patnaik launched the projects spread over various sectors including roads, bridges, drainage, education, health, livelihood, irrigation, energy, women and child development.

He inaugurated 40 projects worth Rs 93.28 crore and laid the foundation stones for 95 projects worth Rs 1,474.88 crore in Cuttack. Later, he visited Begunia in Khurda district, where he inaugurated 126 projects costing Rs 85.53 crore and laid the foundation stones for 406 projects worth Rs 902.44 crore.

### CAG pulls up BDA for shoddy fund mgmt

The decision to deposit ₹61.74 crore in escrow accounts was devoid of merit which deprived BDA of earning interest amounting to ₹1.04 crore between October 2017 and January 2018

Bhubaneswar, Dec 13: Citing inappropriate use of funds, the Comptroller and Auditor General (CAG) of India has said that the Bhubaneswar Development Authority (BDA) has lost interests to the tune of Rs 2.56 crore on various development projects launched in the state capital.

As per the CAG report, the BDA in 2017 had availed Rs 41.16 crore from Odisha Urban Infrastructure Development Fund (OUIDF) for implementation of housing projects to rehabilitate slum dwellers and people belonging to EWS. As per Clause 7 (IV) of the sanction of loan, BDA was to open a project specific bank account with a nationalised bank wherein all the loan amounts and grants received from various sources would be deposited.

For repayment of loans, the BDA would open an escrow account not later than two years from receipt of loan. Revenue generated from the sale of housing units was supposed to be deposited in the escrow account.

However, the auditor, during scrutiny of BDA records during



August-September 2018, found that it had received Rs 61.74 crore of which OUIDF provided Rs 41.76 crore and Rs 20.58 crore came as its own share. The amount was kept in three different escrow accounts in September 2017 even though terms of sanction of loan did not require depositing the amount in an escrow account. Only revenue generated from sale of houses was to be deposited in escrow accounts.

"Since deposits in escrow account are non-interest bearing, the said amount deposited therein, did not fetch any interest. Realising this, BDA authorities transferred Since deposits in escrow account are non-interest bearing. the said amount deposited therein, did not fetch any interest

(January 2018) the fund from the escrow accounts to saving accounts. Following this, the BDA managed to earn interest at the rate of 6.5 per cent on such deposits. Thus, the initial decision to deposit the amount in escrow

accounts was, therefore, devoid of merit which deprived BDA of earning interest amounting to Rs 1.04 crore between October 2017 and January 2018," the CAG

Similarly, on scrutiny of bank pass books (during August 10-October 12, 2018) maintained for Subudhipur Housing Project, the CAG noticed that balance in the saving bank account with Oriental Bank of Commerce was Rs 2.48 crore April 15, 2006. BDA withdrew the entire amount Rs 3.96 crore (including interest of Rs 1.48 crore) from the account and deposited it in a flexi fixed deposit account August 29, 2018 losing an opportunity of earning additional interest of Rs 1.52 crore.

"Since the amount was not required by BDA for 12 years, the amount could have been deposited in a fixed deposit account much earlier, where rate of interest is higher than the savings account. Considering the prevailing rate of interest at 7.10 per cent on fixed deposit up to three years offered by the bank, BDA could have earned interest amounting to Rs 3.00 crore," the CAG observed.

The petitioner alleged that two other films have been selected in several categories though they were ineligible for entry under the Orissa State Awards for Films Rules as they were not original.

During the hearing, Additional Government Advocate PC Panda informed the bench of Justice Arindam Sinha that applicants for the two films, 'Khusi' and 'Golmal Love', had "clearly mentioned" in

the entry forms that those were not dubbed versions, adaptations or remakes of other films.

Panda contended that 'Chhabirani', the petitioner's film, "contained immoral sexually explicit acts and had the potential of creating a furore, if granted the award".

It could have spoilt the social harmony of the society, he claimed. Besides, the second half of 'Chhabirani' was a "blatant copy" of a Bollywood movie, the government counsel submitted.

The kind of violence, rape and murder shown in the movie is in no way part of Odia tradition and culture that the petitioner claimed his film has depicted, he submitted.

Justice Sinha in his order said the ceremony, scheduled to be held Tuesday, would stand postponed.

The bench directed that the state, through its functionary, would reevaluate all entries for awards, and the result would be made known to the petitioner and all stakeholders. The ceremony will be held post disposal of the writ petition, Sinha said.

# BJD calls for 'Indianisation' of judiciary

New Delhi, Dec 13: Advocating for 'Indianisation' of the judiciary, the Biju Janata Dal (BJD) Monday suggested using regional languages at lower courts so that a common man can have access to justice and he is able to understand justice in layman terms.

The BJD MP said that in our country of 1.3 billion people, we have very limited access to information, very limited access to infrastructure and very limited access to the number of the Judges. ### India launches Supersonic Missile Assisted Torpedo System



Balasore, Dec 13: India Monday successfully launched Supersonic Missile Assisted Torpedo System (SMAT) from Abdul Kalam island, formerly known as Wheeler Island, off the Odisha coast, the Defence Research and Development Organisation (DRDO) said.

During the mission, the full range capability of the missile was successfully demonstrated. The system has been designed to enhance anti-submarine warfare capability far beyond the conventional range of the torpedo, the DRDO said.

'This was a textbook launch, where the entire trajectory was monitored by the electro optic telemetry system, various range radars, including the down range instrumentation and down range ships. The missile carried a torpedo, parachute delivery system and release mechanisms," said the DRDO statement. The system is launched from a ground mobile launcher and it can cover a range of distances, the DRDO said.

Defence Minister Rajnath Singh congratulated the teams involved in the successful test of the supersonic missile assisted torpedo system. The development of the system is a perfect example of building futuristic defence systems in the country, he said. A number of DRDO laboratories developed various technologies for this advanced missile system.

According to the Forest department, the tiger counting process will be carried out with the help of trap cameras installed in various reserve forests and pugmarks found around water bodies. It was learnt that about seven leopards are residing in various reserve forests of the district. Their pictures were captured by cameras.

### Most By Need

The attack on four Christians by members of a right wing group in Karnataka December 12 took place a day before the Karnataka Assembly begins the winter session when an anti-conversion Bill is likely to be tabled. The supposed 'crime' of the four was to hold discussions on a drive to distribute religious books. According to police, the victims had come to a rented accommodation in Srinivaspura in Kolar district. Their attackers had first questioned them, snatched their books and set them on fire and then attacked them. This is the latest in a series of attacks on Christians

After the incident, Karnataka Chief Minister Basavaraj Bommai said, "A majority of people want to ban religious conversion. There is no problem if people follow the customs of their respective religions. However, there should be no scope for misusing someone's poverty to lure them into changing their faith." What Bommai has said regarding luring of the economically weaker sections of society to change faiths is not completely off-mark. Similar incidents of conversion have been observed in Orissa over a long period of time. It could be due to this reason that Orissa was one of the early states to enact an anti-conversion law.

 $However, since the Karnataka\,government\,announced\,it\,would\,bring\,the$ anti-conversion legislation in this winter session of the Assembly, attacks on Christians are on the rise. The day before the attack on the four Christians, a man armed with a machete in Belagavi, where the Assembly session is held, supposedly barged into a church and chased the priest in charge. The police registered a case and provided security to the church. The attacker is still

Karnataka has seen an increase in attacks against Christians in October and November after the state government proposed the anti-conversion law in the state. A fact-finding report by several civil society organisations reveals 27 such attacks took place during the first 272 days of this year, while five incidents took place between October and mid-November alone. Uttar Pradesh reported the most such cases (66), followed by Chhattisgarh (47), and Karnataka (32).

The disclosures made in the report by United Christian Forum (UCF), Association for Protection of Civil Rights (APCR), and United Against Hate, paint a grim picture of the communal discord and disaffection that have been plaguing India lately. While Karnataka may rank third among states with the most number of attacks on the community and their places of worship, the reasons for such acts need to be scrutinised thoroughly. Calls registered in the UCF helpline recorded 305 cases across the country in the year till September 2021. The desperate calls were for mob attacks numbering 288, damage to 28 places of worship and injuries during attacks to 1,331 women, 588 tribals, and 513 Dalits. The role of the police, according to the report, casts doubts about the neutrality of the force.

It is well known that social and economic disparities are exploited to a great extent in process of conversion. Wherever there is mass conversion, a common factor has been economic stress experienced by the converted. Although these are truths that cannot be ignored, yet violence can never be condoned. The best way out is not by enacting laws but by making efforts to reach government's welfare measures to those that are genuinely needy. Not everyone wishes to change religions.

Few are by choice. Most are by need.

#### ■ Pronoia

Pronoia is the suspicion that the universe is a conspiracy on your behalf, the opposite of the popular sense of paranoia. It seems to have been invented by the sociologist Fred Goldner in an article in Social Problems in 1982, in which he defined it as "the delusion that others think well of one", the unreasoning belief that your superiors think you are indispensable, that your colleagues adore you, and that you are doing brilliantly in your work. He was warning against the dangers of the rose-tinted view, in which an over-positive view of oneself and the world around one can lead to fatal mistakes. It was later taken up by the short-lived group called the ZIPPies (the Zen Inspired Pronoia Pagans) invented by a London club promoter named Fraser Clark. The word has a small continuing niche, though its adjective pronoid is less common. Looking at these kids, it doesn't require my usual pronoia to think that I'm glimpsing the future of this place (Wired, Jan. 1999). She introduced the CEOs to the flip side of paranoia: "pronoia" — the idea that everyone is not out to get you, but that they are out to love you, or at least to appreciate you, if you reciprocate. According to the new Darwinism, only the pronoid survive in fact, only the pronoid endure and flourish (Fast Company, Nov. 1999).

#### Prosumer

his word is becoming fairly common but can be confusing, as it has two meanings. It was coined in 1980 by the futurist Alvin Toffler — in his book The Third Wave — as a blend of producer and consumer. He used it to describe a possible future type of consumer who would become involved in the design and manufacture of products, so they could be made to individual specification. He argued that we would then no longer be a passive market upon which industry dumped consumer goods but a part of the creative process. Derrick de Kerckhove has called this mass customisation, in which everybody is in effect a member of a niche market, something Internet ecommerce is encouraging through cutting out the middleman between maker and buyer. This sense of prosumer has been taken up by some marketing people, but remains limited in its application. The second usage describes a purchaser of technical equipment who wants to obtain goods of a better quality than consumer items, but can't afford professional items (older terms for goods of this intermediate quality are semi-professional and industrial quality). Here, the word is a blend of professional and consumer. Prosumers of this sort are famed for their enthusiasm for new products and their tolerance of flaws and, from the marketing point of view, have much in common with early adopters. This usage is common among those selling video equipment, digital cameras, and similar goods (and the examples below illustrate this sense). Some manufacturers treat the SOHO (Small Office, Home Office) market as being much the same thing. DVDwiz represents the first truly professional-quality DVD authoring software available to the prosumer and consumer markets, offering the unique creativity level and compatibility so far only available to professionals (Business Wire, Sep. 1999).

#### FOCUS WORLD INEQUALITY REPORT

### LIFTING THE LID

Report 2022, produced by the Paris-based World Inequality Lab, is a remarkable document for many reasons – starting with its demonstration of the immense power of patient collective research.

The World Inequality

The report provides the latest estimates, based on careful aggregation of national data from a multitude of sources, of income and wealth inequality at the national, regional, and global level. It gives long-run time-series data for these indicators, allowing us to consider recent patterns in a broader historical context. And it expands on different dimensions of inequality in revealing new ways.

Any research enterprise as ambitious as this one will inevitably elicit quibbles about the datasets used, the assumptions required to generate particular series, and the ways in which some data gaps have been filled. My own minor criticism relates to the World Inequality Lab's use of purchasing power parity (PPP) exchange rates to determine and compare national incomes across countries.

As I have argued elsewhere, while PPP exchange rates appear to control for cross-country differences in price levels and living standards, they are ridden with conceptual, methodological, and empirical problems. For starters, PPP exchange rates assume that the structure of each country's economy is similar to that of the benchmark country (the US) and changes in the same way over time. When applied to developing economies, this assumption is especially weak.

Moreover, the convoluted weighting procedure for goods can result in the inclusion of unrepresentative, high-priced products that are rarely consumed in some countries. For example, Angus Deaton has noted how packaged cornflakes may be available in poor countries but are bought by only a relatively small minority of rich people. Expenditure weights from national accounts do not reflect the consumption patterns of people who are poor by global standards.

There is a further, and possibly even more troubling, conceptual issue. High-PPP countries that is, those where the actual pur-

chasing power of the local currency is deemed to be much higher than its nominal value - are typically low-income economies with low average wages. PPP is high precisely because a significant section of the workforce receives very low remuneration, which means that goods and services are available more cheaply than in countries where the majority of workers receive higher wages. The widespread incidence of unpaid labour in many poor households in low-income countries further amplifies the effect. So, it is clear that the local currency's greater purchasing power reflects conditions of indigence and low or no remuneration for what could even be the majority of workers.

PPP-modified GDP data may therefore miss the point. By regarding greater purchasing power of a given monetary income as an advantage, rather than a reflection of the greater absolute poverty of the majority of an economy's workers, PPP estimates effectively overstate poorer countries' incomes compared to those of rich economies. For all these reasons, relying on PPP exchange rates in cross-country income comparisons - including for poverty and inequality measures - is extremely problematic. There is a

strong case for sticking to market exchange rates in measuring cross-country inequality, which would likely reveal much greater disparities than those evident in the World Inequality Report.

This objection notwithstanding, the report adds much to our understanding of inequality, especially through two new measures. The first is the female share of labour income, which is a useful indicator of gender inequality Globally this share has remained largely unchanged over the past three decades, at one-third, and has been as low as 10-15% in the Middle East and North Africa (MENA) and below 20% in Asia excluding China. This indicator captures not just labour-market imbalances, but also, implicitly, the greater proportion of unpaid work performed by women within households and communities, which reduces their access to naid work and affects their remuneration in paid employment.

The second innovative measure examines inequality in carbon-dioxide emissions by assessing contributions by income category across countries. The important finding here is that, while inequalities in emissions across regions are high and persistent, such disparities exist not only between rich and poor coun-

tries, but within them. There are high emitters among the rich in low- and middle-income countries, and relatively low emitters among the poor in high-income countries.

For example, the richest 10% of people in the MENA region emit 33.6 tonnes of CO2 per person per year, compared to less than 10 tonnes among the bottom half of the income distribution in North America. (The bottom 50% in Sub Saharan Africa emit one-twentieth of the North American amount, or 0.5 tonnes per capita per year.)

Globally, the richest 10% of the population is responsible for more than half of all CO2 emissions. This point is especially important because, as the report notes, environmental policies like carbon taxes hit the poor the hardest, but this group is rarely if ever compensated for such measures. The new indicator enables a much richer consideration of what socially just climate policies should look like, both within and across countries.

Predictably, the report is strong on appropriate redistributive policies, especially the potential for increased taxation of wealth and corporate profits. There is also scope for looking more closely at 'predistribution,' or the range of regulatory regimes and legal codes that have enabled today's excessive concentration of wealth and income in the first place.

The primary cause of 'predistributive' inequality is, in a word, privatisation: of finance, the natural commons, the knowledge commons (through intellectual-property rights), and public services and amenities. One could add to that states' tendency – glaringly obvious since the 2008 global financial crisis - to protect large-scale private capital, while allowing it to wreak havoc on ordinary citizens.

### The Summit for Democracy

THE SUMMIT **REFLECTS A VIEW** THAT ASSEMBLING A GLOBAL **COALITION OF DEMOCRACIES CAN COUNTER CHINA'S RISE AND** CONTINUED **RUSSIAN AGGRESSION** 

US-sponsored two-day virtual democracy summit wrapped up last week. It was promised by President Joe Biden during his election campaign last year, as he wanted to show that the US has departed from the America First' philosophy of his predecessor Donald Trump and instead will focus on an event that was more about starting a global conversation about how best to halt backsliding than producing immediate results or expanding democracy's reach.

Biden and fellow leaders announced initiatives to stem autocracies from misusing Big Tech to stifle dissent, enhancing election integrity, bolstering independent media and other modest efforts that the President said would "seed fertile ground for democracies to bloom around the world.'

But he also acknowledged that the path ahead was difficult for democracies amid a rise in authoritarianism around the globe. "We know how hard the work is that's going to be ahead of us, but we also know that we are up to the challenge," Biden said in remarks to close the virtual meeting.

However, Biden has been criticised over the guest list of the summit as well as that the summit was targeted at China and Russia and not other autocratic governments and it also missed out on inviting the middle-eastern leaders.

Both China and Russia fiercely criticised the summit, with their ambassadors writing a joint essay ahead of the gathering. They wrote the Biden administration's decision to hold the summit reflected a 'Cold-War mentality' that may stoke up ideological confrontation and cause rift globally. Several countries identified due to concerns raised by civil society groups and the US State Department for their serious anti-democratic trends or human rights concerns — including India, Iraq, Pakistan, Poland, Ukraine and the Philippines — were invited. Critics say that the tactic for smaller countries with highly questionable democratic credentials to get Washington's invite for the summit was to obediently follow the US lead on important international issues.

Jen Psaki, the White House Press Secretary, described the invitations as not intended as a 'stamp of approval' but the administration's desire to seek a diverse range of voices and faces and representatives at the discussion. As per the pro-

tagonists of The Summit for Democracy, it had a larger geopolitical ambition. It reflects a prominent view within the Biden administration that assembling a global coalition of democracies can counter China's rise and continued Russian aggression.

Biden has repeatedly made a case that the like-minded allies and the US need to show the world that democracies are a far better vehicle for societies than autocracies. It is a central tenet of Biden's foreign policy outlook. But his first year in office has been a period that he says has been marked by a 'backward slide' for democracy around the globe.

However, the choice of panellists to reflect US' views also courted controversy. Brad Smith, president of Microsoft, spoke on how to use 'technology for democracy'. John Brothers, president of the billionaire investment giant T. Rowe Price. which holds a massive portion of Venezuelan debt, moderated a discussion on 'responsible investment'. Kent Walker, president of Global Affairs for Google, which has publicly admitted to censoring the World Socialist Web Site, spoke of how private enterprises can aid

'democracy'. Critics assert that the people who could be described as holding a completely contrary position on these issues were invited to speak on how to tackle them, which seems quite farcical.

Biden said it was also a moment for the US to look inward about shoring up its own democratic institutions. But this does not match with what is really happening in the US, movements like Black Lives Matter raised the issue of racial and colour discrimination, on which the Summit was completely silent.

The overall conclusion seems to be that the Summit for Democracy would have been more effective had it remained focused on strengthening and defending democracy rather than highlighting contradictions between democracies and authoritarian rules. As some critics pointed out, behind the pretences of defending democracy against meddling autocrats remains Washington's drive to maintain its global economic hegemony. It also underlined the continuous efforts by Biden to leave a political legacy.

Glaring inequality

Sir, Over 71 per cent students from Class I to X in Odisha do not have smartphones, School and Mass Education Minister Samir Ranjan Dash informed the state Assembly in a written reply to a question by MLA Kusum Tete. The minister said the state government had conducted a survey on the availability of smartphones among the students in September 2020 under the Siksha Sanjog programme. As per the survey, only 28.87 per cent of the total students studying in Classes I to X in Odisha have been able to attend online classes since the COVID-19 pandemic as they have smartphones. The worst sufferers are students in Kandhamal district where only 13.38 per cent have smartphones, the lowest in the state. The other districts with low rate of access to smartphones for students are Rayagada (14.34 per cent), Deogarh (14.87 per cent), Gajapati (15.34 per cent), Malkangiri (16.22 per cent), Koraput (17.87 per cent), Nabarangpur (18.03 per cent) and Boudh (18.61 per cent). Khurda district, which includes state capital Bhubaneswar, recorded the highest percentage (45.80 per cent) of students having access to smartphones. Among other districts, 43.18 per cent students in Jharsuguda, 42.27 per cent in Kendrapara, 41.22 per cent in Bargarh, 38.95 per cent in Jagatsinghpur, 37.60 per cent in Cuttack, 35.83 per cent in Puri and 33.24 per cent in Nayagarh have access to smartphones. *Hitesh Kumar Parida, PANIKOILI*

#### Acid attack

#### Man arrested

Rewa: A man allegedly raped a four-year-old girl residing in his neighbourhood in Madhva Pradesh's Rewa district. police said Monday. The incident took place Sunday evening following which the 22-year-old accused was arrested, they said. The accused lured the girl to his place on some pretext while she was playing outside her house and allegedly raped her. The girl later came out of his house crying and writhing in pain, police inspector Dilip Dahiva said.

shortage of 9,362 officers

New Delhi, Dec 13: The three services are facing a shortage of 9,362 officers and around 1.13 lakh soldiers, airmen and sailors, according to details provided by the government Monday.

In response to a question in Raiya Sabha, minister of state for defence Ajay Bhatt said that the Army has a shortage of 7,476 officers and 97,177 soldiers including Junior Commissioned Officers. According to details provided by Bhatt, the Navy has a shortage of 1,265 officers and 11,166 sailors.

In the Indian Air Force, the number of posts of officers lying vacant is 621 while it is 4,850 for airmen."It is the endeavour of the government to fill up the vacancies in the armed forces in a systematic and timebound manner, which is a continuous process," the minister said.

Bhatt said, at present, 53,569 officers and 11, 35,799 soldiers are serving the Indian Army. The number of officers serving in the Navy is 11,100 while the strength of sailors is 63,515, he said. In the Indian Air Force, the number of officers is 12.048 and while that of airmen is 1, 38,792.


#### Maha reports 2 new cases of Omicron

Mumbai: Maharashtra reported two more patients infected with the Omicron variant of SARS-CoV2 - both having a travel history to Dubai - taking the overall tally of those affected with the new strain in the state to 20, the health department said Monday. Both the patients, including a woman, are asymp tomatic and were fully vaccinated, the health department added, "Two new cases have been found to be infected with Omicron, according to a report released today by the National Institute of Virology - one from Latur and one from Pune," the department said. COVID-19 is caused by the SARS-CoV-2 virus.

The Chief Minister instructed the officials to coordinate with the Central government and ensure two doses of vaccination are completed to all the prescribed age groups by January.

### RS returns bill that brings clarity on enhanced pension

The bill seeks to bring an explanatory clarification about the age of eligibility for enhanced pension for retired judges

New Delhi, Dec 13: The Rajya Sabha Monday returned to the Lok Sabha a bill that seeks to bring clarity on the age of retired judges to determine when they will get enhanced pension.

The Lok Sabha passed the High Court and Supreme Court Judges (Salaries and Conditions of Service) Amendment Bill, 2021 on December 8.

The Rajya Sabha returned the bill to the Lok Sabha after a discussion Monday since it is a money bill. The bill seeks to bring an explanatory clarification about the age of eligibility for enhanced pension for retired judges.

Replying on the bill, Union Minister for Law and Justice Kiren Rijiju assured the House that there is no politics and everyone stands together when it comes to ensuring justice."There should be no gap between the common man and the justice system. I am thankful to all of you for supporting the bill without bringing any politics into it," he said.

According to the bill, in 2009, two laws were amended to provide that every retired judge or after his or her death, the family, as the case may be, will be entitled to an additional quantum of pension or family pension.

Accordingly, the additional quan-

tum of pension to the retired judges of the high courts and the Supreme Court is being sanctioned on completing the age of 80 years, 85 years, 90 years, 95 years and 100 years, as the case may be.

However, in a writ petition filed by a retired high court judge, the Gauhati High Court had held that the benefit of the additional quantum of pension according to the High Court Judges Act would be available to a retired judge from the first day of his 80th year.

Subsequently, the High Court of Madhya Pradesh also directed respondent Union of India to construe the word "from" as it appears on the slab as the first day of entering the minimum age of the slab -- 80, 85, 90, 95 and 100 years -along with other consequential benefits to the petitioners, the Statement of Objects and Reasons of the bill read.

The legislative intent behind the insertion of section 17B and section 16B respectively in the two Acts was to provide the benefit of additional quantum of pension to a retired judge from the first day of the month in which he completes the age specified in the first column of the scale and not from the first day of his entering the age specified therein as interpreted by the high courts, it said.

Special status demand

Patna, Dec 13: The fresh demand for special status to Bihar has brought the differences within the ruling NDA to the fore in the state.

Two days after Deputy Chief Minister Renu Devi termed the Bihar government's demand for special status as "meaningless", Chief Minister Nitish Kumar Monday said she has no detailed information on the issue.

Seeking to play down the differences within the DA, Kumar said, "I will explain everything to her (Renu Devi) when she meets me. She does not have the detailed information about the issue. The demand for the special status to Bihar is totally justified, the

state deserves it". He said the special status, which entitles a state of a number of central privileges, is very essential for Bihar. "So if someone in the state opposes the special status demand, it is possible that the person does not understand the issue," he said in reply to queries by scribes who sought his views on Renu Devi's comment.

Kumar, also senior JD(U) leader, said according to the Niti Aayog Bihar is a backward state. But despite the government's efforts the growth rate is not enough. "Therefore we are demanding special category status ... What is wrong in it?"

At the same, he said Niti Aayog has used old parameters to evaluate Bihar and its evaluation process is not justified as the state is gradually

developing in every sector each year.

## Are you ashamed of PM, HC asks petitioner

Kochi, Dec 13: Examining the maintainability of a plea seeking removal of Prime Minister Narendra Modi's photograph from the COVID-19 vaccination certificate, the Kerala High Court Monday asked the petitioner whether he was ashamed of the PM.

Justice P V Kunhikrishnan said the Prime Minister was elected to power by the people of the country and therefore, what was wrong with having his photograph on the vaccination certificate.

When the petitioner's counsel told the court that in other countries there was no such practice, the



judge orally remarked, "They may not be proud of their PMs, we are proud of our PM.

"Why are you (petitioner) ashamed of the Prime Minister? He came to power through the mandate of the people.... We may have different political views, but he is still our PM,'

the court further said. The counsel for the petitioner --

Peter Myaliparampil -- said that the certificate was a "private space" with personal details on record and therefore, it was inappropriate to intrude into the privacy of an individual. He contended that adding the PM's photo to the certificate was an intrusion into an individual's private space.

To this  ${\rm \bar{t}he}\,{\rm court}, {\rm said}\,{\rm that}\,{\rm the}\,{\rm more}$ than 100 crore people of the country do not appear to have a problem with having the PM's photo on the vaccine certificate, "why do you?"

The court said it will examine whether the plea has any merits and if not, it will dispose of the matter. During the more than an hour long hearing, advocate Ajit Joy, appearing for the petitioner, said that whether to be proud of one's PM was a personal choice.

Joy also told the court that it was not a matter of political differences, as the Supreme Court has laid down guidelines for advertisements and campaigns using public money. He said having the photo on the certificates would also influence minds of voters and this issue was raised during the recent state assembly elections. The central government opposed the plea saying it was publicity interest litigation.

### When Aurangzeb attacks, Shivaji rises: Modi

Varanasi, Dec 13: Lauding the resilience of India's civilisational heritage here, Prime Minister Narendra Modi Monday said tyrants like Aurangzeb tried to destroy Kashi but were consigned to the 'black pages' of history while the ancient city is now writing a new chapter of its glory.

In a speech after inaugurating the Kashi Vishwanath Dham, which has renovated and expanded the temple's premises, Modi said India is now stepping out of the 'inferiority' complex brought on it by centuries of slavery.

He asserted that the new Kashi corridor will give a decisive direction to the country and lead it to a bright future.

Arriving in the holy city, also his parliamentary constituency, Modi paid obeisance at the Kaal Bhairav Temple and then took a dip in the Ganga, from where he collected holy water for worship at the Kashi Vishwanath Temple.

A new history is being created, he said in the speech that mentioned Mughal emperor Aurangzeb Muslim invader Salar Masud and British governor-general Warren Hastings. Sultanates rose and fell but Banaras remained, he said.

"Tyrants attacked this city, tried to destroy it. History is witness to Aurangzeb's atrocities, his terror. He tried to change civilisation with the sword. He tried to crush culture with fanaticism.

"But the soil of this country is different from the rest of the world. Here if an Aurangzeb comes, a Shivaji also rises," Modi said. The PM raised the chant of 'Har Har Mahadev', associated with Lord Shiva, several times.

Many historians believe that Aurangzeb had ordered pulling down the temple to build a mosque. Modi also lauded Rani Ahilyabai for rebuilding the temple and Sikh king Ranjit Singh for gold-plating its domes.

He said the new complex of the Kashi Vishwanath Dham is not just a grand building, but a symbol of the 'Sanatan culture' of India, its spiritual soul antiquity and traditions. Modi expressed his gratitude to workers involved in the construction project, saying they

did not let even the Covid pandemic stop them. In an attraction, he showered a group of them with flower petals and later had lunch with them.

Uttar Pradesh Chief Minister Yogi Adityanath, BJP president J P Nadda and hundreds of seers and saints from across the country attended the ceremony.

The visit triggered a loaded remark by Akhilesh Yadav, whose Samajwadi Party is the main opposition to the ruling BJP in Uttar Pradesh, where Assembly elections are due in less than three months. The minister said the education department has sent a proposal to the environment department, seeking immediate reopening of schools and coaching centres for students in Class 6 and above, and in colleges

For children of Class 5 and below, the education department has suggested reopening schools from December 20, he said

The proposal will be sent to the



Commission for Air Quality Management (CAQM), which has been mandated by the Supreme Court to take a call on the reopening of schools and colleges, Rai said.

He said many agencies have made verbal requests to lift the ban on construction and demolition activities. "We have directed them to write an application to us and the CAQM. We will hold a review meeting in this

regard December 16," Rai said.

The minister said Delhi's air quality index remained between 250 and 325 from December 1 to December 12. But experts have forecast a slight deterioration of air quality in the next three days, he said.

The water sprinkling drive to control dust pollution will continue and necessary directions have been issued to the fire department, civic bodies and other departments, Rai said. Under the anti-dust campaign,

6,953 sites have been inspected and fines of ₹1.65 crore have been imposed for violations at 597 sites. Under the anti-burning cam-

paign, 16,580 sites have been inspected and a cumulative fine of ₹46 lakh has been imposed for violations at 2,490 sites, Rai said.

The environment department has received 6,975 pollution-related complaints on the Green Delhi application since October, of which 81 per cent have been resolved.

Lucknow, Dec 13: Ahead of the 2022 Uttar Pradesh Assembly polls, red caps have gained centre stage and are roiling the political waters in the state.

Though symbols have their own importance, political parties indulge in attacking each other on their flags, banners, posters,

The controversy over red caps started from the Uttar Pradesh Assembly when Chief Minister Yogi Adityanath's address was disrupted by Samajwadi Party (SP) lawmakers who were donning red caps. Taking a jibe at them, Adityanath had said: "Someone is wearing a red cap or a green cap. Don't know whether this has become a tradition. Don't know whether these people wear a cap even at home?

Adityanath also narrated an incident, saying that a two-and-ahalf-year-old child saw a protester wearing a cap and identified him as a goon, post which the SP lawmakers created an uproar.

During a rally in Gorakhpur,



Prime Minister Narendra Modi hit out at the SP, saying that "laal topi waale" (those wearing red caps) were like a "red alert" for the state.

If political analysts are to be believed, these statements have been made deliberately so that the Opposition attacks them and both can trade barbs. In response to the ruling party's jibe, SP chief Akhilesh Yadav, along with his colleagues, went to the Assembly wearing red caps. Akhilesh also replaced his Facebook and Twitter profile pictures with one in which

he is wearing a red cap.

Following Akhilesh, his party leaders and supporters have also started replacing their pictures with ones showing them in red caps. Now, whenever Akhilesh leaves for a programme or rally, he wears a cap. Earlier, Akhilesh did not wear caps, but when his father and SP founder Mulayam Singh Yadav asked him to do so, he started to don it regularly.

In the ongoing tussle between the SP and the BJP, the AAP has also jumped in. Rajya Sabha MP and

AAP's UP in-charge Sanjay Singh shared the Prime Minister's photo on Twitter in which the latter can be seen wearing a black cap, saying people wearing a black cap have a black heart and mind (their mind and heart are not good).

Senior political analyst Ratanmani Lal said that in the present era, leaders of a political party cannot be identified only by symbols. The BJP is associated with the saffron colour but all do not wear it, the BSP (blue) but Mayawati never wears blue, the SP (green), Congress (white) and the SP also with a cap.

The SP chief has made it an identity mark of the party due to which even without taking its name, it can be attacked. The BJP has tried to send across a message to the electorate of Uttar Pradesh that they have to be wary of the SP, but the latter will benefit indirectly

The BJP pointed it out to attack the SP but it worked as a blessing in disguise for the latter as with more people wearing red caps, they will be recognised better.

### After tunnel, hanging house found in Delhi Assembly complex

New Delhi, Dec 13: Months after a tunnel connecting Delhi Assembly (Old Secretariat) to the historic Red Fort was found, a hanging house was discovered inside the Vidhan Sabha premises Monday.

Delhi Assembly Speaker Ram Niwas Goel told the press that the hanging house was found after a hollow wall was demolished.

An inspection will be carried out and the archaeological department will be informed about the same, he added. The tunnel was found in the month of September. Goel had told the media then that the British must have used it to transport con-

victs on death row. Therefore, he said, discovery of the hanging house was highly probable.

However, no official statement has been issued by the archaeological department over the same. The tunnel was also destroyed due to sewer work and Delhi metro construction. This British era iconic building was established in 1912 -- a year after the national capital came to Delhi. It was designed by E Montague Thomas to hold the Imperial Legislative Council and subsequently the Central Legislative Assembly (after 1919), till the newly constructed Parliament House of India in New Delhi was inaugurated January 18, 1927.

July 31, 2019. Advocate Mukesh Saxena, counsel for one of the heirs. Kazim Ali Khan, said "The file has been sent to the apex court for the final de-

Nawab Raza Ali Khan, who let Rampur join India in 1949, was survived by three wives, three sons and six daughters after his death

The government recognised the eldest of his three sons, Murtaza Ali Khan, as the sole inheritor ac-

cording to the customary law. This was challenged in court by



a long battle in the family.

The heirs include late Murtaza's daughter Nikhat Bi, son Murad Mian and late Zulfiqar Ali Khan Bahadur's wife Begum Noor Bano (a former MP), her son Naved Mian and others

The share of Syeda Mehrunnisa Begum, descendant of the late Nawab and wife of Pakistan Air Marshal Abdul Rahim, will be handed over to the custodian of enemy property, which is the Indian government, as she is now a Pakistani national.

It may be recalled that in February 2020, the strongroom of the family at Khasbagh palace was opened as part of the exercise to evaluate the royal treasures. When the locks of an armoury in the palace, spread over 450 acres, was broken, the evaluation team found guns with intricate designs, gem studded swords and handcrafted knives. A garage had vintage cars imported from the US and Europe that included a Plymouth (1957), Dodge convertible (1954), Austin convertible (1956), Buick (1939) and Willys Jeep (1956).

The immovable properties to be divided among 16 claimants include the 200-acre Benazir Bagh palace, Sarhari Kunda palace, Shahbad Bagh palace and a private railway station.

District government counsel Arun Prakash Saxena said, "As per the partition plan, all 16 legal heirs will get a share. Two of the legal heirs have died during the long court battle, and their heirs would be entitled to get their share.

The Muslim law recognises two types of heirs, sharers and residuaries. Sharers are those who are entitled to a certain share in the property, and residuaries would take their share in the property that is left after the sharers have taken their parts.

### switched to clean fuels: Report

All industrial units in Delhi have

New Delhi, Dec 13: Complying with the Commission for Air Quality Management's (CAQM) direction, all 1,636 industrial units that were re-inspected twice in the month of October and November were found to have converted to clean fuels.

The Delhi Pollution Control Committee (DPCC) carried out the re-inspection of 1,636 industries to check the use of fuel or Piped Natural Gas (PNG) and found out that all operating units are complying or using the latter as fuel, the

Delhi government said in a report. The CAQM December 2 directed that industrial operations and processes in the National Capital Region (NCR), not running on PNG or cleaner fuels, shall be allowed to operate only up to eight hours a day from Monday to Friday and shall not be allowed to operate on

Saturdays and Sundays. As per the report, a total of 2,447 industrial sites have been inspected from November 17 to 25. Of these, five were found defaulting which were shutdown and a fine of ₹20

lakh was imposed on them. The inspection figure rose by  $23\,$ 



teams visited 3,002 sites from November 26 to December 6. Five industries found defaulting were shut down and a fine of ₹8.5 lakh was imposed.

The CAQM in its October report had stated that all the identified industries in the national capital have switched to cleaner fuels. However, the neighbouring states are yet to follow suit. Use of noncleaner fuels in the industries of either the capital or its adjoining regions affects the air quality adversely. As per the Centre for Science and Environment (CSE) report, industries contributed 9.9-13.7 per cent to air pollution in the national capital between October 24 and November 8 this year.

Delhi's AQI improved slightly and settled in the 'poor' category at 256 Monday morning.



#### 2 militants killed

Srinagar: Two terrorists were killed in an encounter with the security forces at Rangreth area in Central Kashmir's Srinagar district Monday, officials said, "Two unidentified terrorists killed. Search going on," police said. The gunfight took place after a joint team of the police and the security forces cordoned off the area and launched a search operation on the basis of specific information about the presence of terrorists.

#### Teen arrested

Hyderabad: Police in Telangana's Nizamabad district have arrested a 19-year-old teenager for a triple murder that took place last week. Gandham Srikanth alias Ranampalli Mallanna, who was recently released from jail, allegedly murdered three men who were asleep at a workshop in Dichpally on the intervening night of December 7 and 8. Nizamabad Police Commissioner Kartikeya said after murdering the trio with a hammer, Srikanth fled with their mobile phones and money.

#### Narrow escape

Patna: At least 12 people, including the bride and groom, narrowly escaped a fire that broke out during a wedding ceremony in Patna, a fire department official said. The incident took place on Sunday night inside the Maharaja Garden located in Bailey Road. The fire broke out due to bursting of crackers inside the facility, which is mainly made of wood, the official said.

#### 4 killed, 10 hurt

Bangalore: Four people died on the spot and 10 others suffered severe injuries in a serial accident that took place on National Highway - 4 near Alur Cross in Chitradurga district Monday. According to police, an onion laden truck, en route to Bangalore, turned turtle after one its tyres burst. As a result, the car coming from behind rammed into it. In an attempt to avoid collision, two other trucks overturned. As a result, the traffic on the national highway halted for hours.

#### Two elephants die

Guwahati: Two wild elephants have died of suspected poisoning in Assam's Karbi Anglong district, officials said Monday. A forest department spokesman said that carcasses of a pregnant elephant and a male calf were found at Borbhetagaon in Karbi Anglong district bordering Kaziranga National Park late on Sunday evening.

## Rehabilitate children Goa polls: Mamata in street situations: SC gives new slogan



New Delhi, Dec 13: The Supreme Court Monday said the process of identifying "children in street situations", adversely hit by COVID-19 pandemic, is at a "very slow pace" and directed the states and union territories (UTs) to take immediate steps to identify such children and rehabilitate them without waiting for its directions.

A bench comprising justices  ${\bf L}$ Nageswara Rao and B R Gavai, hearing a sup motu case about the children who are adversely affected by the pandemic by losing either one or both the parents, said that there might be "lakhs of children in street situations" in the country.

The top court took note of the affidavit of the National Commission for Protection of Child Rights (NCPCR), which had conducted meetings with the state and UTs, on the issue such as identification and rehabilitation of such children.

"The data provided by the state governments in respect of the

scheme of rehabilitation for such children has been placed on record. Looking at the number of the 'children in street situations' who have been identified, it appears that the process of identification is at slow

pace," the bench noted in its order. It said when the matter was brought to the notice on November 15 by NGO "Save the Children" which had reported that there were two lakh such children in ten districts of Uttar Pradesh, Maharashtra, West Bengal and Delhi.

"There might be lakhs of children in street situation in the remaining parts of the country who need to be rescued and rehabilitated," it said.

"The state governments/UTs are directed to take immediate action for identifying children in street situation without any delay. The required information shall be uploaded on the web portal of the NCPCR (Baal Swaraj). The concerned authorities of the state government/UTs need not wait for any further direction from NCPCR

or from this court..," it ordered.

The top court said the process of collecting the information with regard to social background of the children, identification of benefits under the individual care plan and the inquires have to be conducted by the Child Welfare Committees under the Juvenile Jusitce (care and protection) Act.

It also directed the NCPCR to file a status report based on the information to be received from states and UTs and upload them on its portal within a period of four weeks from todav.

"In the meanwhile, District Magistrates shall upload relevant information, not restricted to stage one (identification), but also the information relating to the other stages (welfare). The state government and UTs shall file status reports about steps taken for identifying and rehabilitating the children in street situation in period of three weeks from today," it said.

The bench then fixed the case for further hearing of the in January and ordered that the copies of the status reports be given to amicus curiae and the counsel for NCPCR.

Earlier, the bench had directed all the District Magistrates states and UTs to take steps for care and protection of children in street situations prepared by the NCPCR in 2020. It was also brought to the court's notice that there are about 70.000 children in the streets of Delhi alone. Additional Solicitor General K M Nataraj, appearing for NCPCR, had submitted that in his estimate, the number of such children might be 15-20 lakh across the entire country.

Panaji, Dec 13: Giving a new poll slogan of 'Khel Zatlo' in Goa, West Bengal Chief Minister Mamata Banerjee Monday said an anti-BJP alliance has already taken shape in the coastal state under the banner of her party TMC and now it is for the Congress to decide whether it wants to join the grouping ahead of elections to take on the saffron outfit.

Addressing a public meeting at Benaulim in South Goa, Banerjee said the Trinamool Congress (TMC) will not allow the ruling BJP to win the elections in Goa, due in early 2022, this time. At a separate event, Banerjee, who is on a twoday visit to the state, said there will be "Khel Zatlo" in Goa ('Zatlo' is a Konkani term to mean 'will happen').

She had earlier raised the 'Khela Hobe' (game is on) slogan during the West Bengal Assembly poll campaign earlier this year. At the public meeting, she said the Maharashtrawadi Gomantak Partv

(MGP) has already joined her anti-BJP alliance and now the NCP's lone MLA in the state, Churchill Alemao, has merged the party's state legislative unit with the Trinamool Congress (TMC).

"If the Congress thinks they want to defeat the BJP, we have no objection. We already have the MGP on board. If you want to join, join us. We have already formed the alliance," the Bengal CM said after inducting Alemao into her party. Earlier in the day, Alemao merged the NCP's Goa legislature unit with the TMC, giving a boost to the Kolkata-headquartered party ahead of the assembly polls in the tiny seaside state.

Talking about the anti-BJP alliance, Banerjee, who is also the chairperson of the TMC, claimed her party has already become an alternative to the saffron outfit in the state. "The MGP has joined the alliance, the NCP has merged its legislature unit (with TMC). If anyone wants not to divide votes, come and join us," she in a message directed at the Congress

### Digvijaya invites Kamra, BJP MLA says won't allow

Bhopal, Dec 13: Senior Congress leader Digvijaya Singh Monday invited stand-up comedians Kunal Kamra and Munawar Faruqui to hold a programme at Bhopal in the BJP-ruled Madhya Pradesh after they were recently denied permission for shows in Bangalore.

Hitting out at Singh, BJP MLA from Bhopal Huzur Assembly constituency, Rameshwar Sharma, said he will not allow shows of anyone who has disrespected Hindu deities not only in Bhopal but also in the rest of Madhya Pradesh.

"Digvijaya Singh is wishing to invite Pakistan's terrorists to his home for a biryani party. This doesn't mean that we all will accept it," the MLA said.

Faruqui was last month denied a nod to hold a show in the Karnataka capital amid protests by some right-wing outfits. A few days later, Kamra, a vocal critic of the government, said his stand-up shows, scheduled to be held in Bangalore, were cancelled after the organisers received threats.

Earlier this year, Faruqui had spent a month in jail at Indore after a BJP MLA's son lodged an FIR in January accusing the comedian of hurting religious sentiments through his show.

"I will organise a show for you Kunal and Munawar in Bhopal. All responsibility will be mine. The only condition is that the subject of comedy will be Digvijaya Singh. Sanghis (RSS cadre) should not object to this!! Don't be afraid!! Give the date and time as per your convenience. All your conditions are accepted," Digvijaya Singh tweeted Monday.

### New threat: Ozone spike raises concern

Kolkata, Dec 13: The ozone count in central Kolkata was 60 per cent more than the safe levels, raising concerns about public health and the threat it poses to the iconic Victoria Memorial

The eight-hour average was 160 mg/cubic metre in the Victoria Memorial area on Sunday, as per the West Bengal Pollution Control Board (WBPCB). The eight-hour average of ozone should not exceed 100 mg/cubic metre, as per the World Health Organisation. The high ozone level was a result


of typical wintry conditions and accumulated vehicular emission particles in the lower atmosphere, a WBPCB official said. Once the foggy conditions improve, the ozone count will go down, he said.

Environmentalist Somendranath Ghosh said proper monitoring is needed to find the reasons behind

the spike in ozone levels in the ecosensitive zone of the city, often referred to as the 'Lungs of Kolkata' because of the acres of grassland. It is alarming the ozone count even eclipsed the PM 2.5 level of 144 on Sunday noon, he said.

'So many old diesel vehicles are plying. Due to this pollution, the white marbles of Victoria Memorial may turn vellow and the plasters will go off in many chamber walls in the future," he cautioned.

Ground-level ozone is a colourless and highly irritating gas that forms just above the earth's surface, Ghosh said. It is a secondary pollutant as it is produced when two primary pollutants -- nitrogen oxides (NOx) and volatile organic compounds (VOCs) -- react in sunlight and stagnant air, he said. Ozone can cause the muscles in the airways to constrict, trapping air in the alveoli, leading to wheezing and shortness of breath.

### Secretly recording wife's phone call infringement of privacy: HC

Chandigarh, Dec 13: Recording of wife's telephonic conversation without her knowledge is infringement of her privacy, the Punjab and Haryana High Court has observed.

The court of Justice Lisa Gill passed the order last month on a plea filed by a woman who challenged a 2020 order of the

Bathinda family court. The Bathinda family court had allowed the woman's estranged husband to prove a CD pertaining to recorded conversations between him and his wife subject to the condition of its correctness.

"Recording of telephonic conversation of the wife without her knowledge is a clear cut infringement of her privacy," observed the high court."Furthermore, it cannot

be said or ascertained as to the circumstances in which the conversations were held or the manner in which response elicited by a person, who was recording the conversations, because it is evident that these conversations would necessarily have been recorded surreptitiously by one of the parties," it further observed.

The husband had submitted a petition in 2017 seeking a divorce from the woman. Their marriage was solemnised in 2009 and the couple had a daughter together During cross-examination, an application was moved by the husband in July, 2019, seeking permission to submit his supplementary affidavit by way of examination-in-chief along with the CD and transcripts of conversations recorded in memory card or chip of the mobile phone.

### Now, file corruption complaints online with Lokpal

New Delhi, Dec 13: An online system that enables people to file corruption complaints with the Lokpal was inaugurated here on Monday by the anti-graft ombudsman Chief Justice Pinaki Chandra Ghose.

At present, complaints sent by post, e-mail or hand-delivered are entertained by the Lokpal of India, a statement issued by the person-

nel ministry said. Justice Ghose inaugurated the digital platform -- LokpalOnline for the management of the complaints. It can be accessed by the citizens of the country and complaints can be filed from anywhere, anytime at lokpalonline.Gov.In.

Speaking on the occasion, Justice Ghose said LokpalOnline is an end-to-end digital solution for the management of complaints against public servants filed under the Lokpal and Lokayuktas Act, 2013. He said LokpalOnline is a webbased facility, which will quicken the disposal of complaints in an accountable, transparent and efficient manner with benefits to all the stakeholders.

It facilitates the handling of complaints during their complete life cycle, right from filing to the final disposal, and this will bring more transparency and efficiency in the complaint-handling mechanism, Justice Ghose said.

Justice Abhilasha Kumari, Judicial Member, Lokpal, said the

main aim of the Lokpal is to free the country from the malady of corruption and build a strong and corruption-free India. She said in March 2019, Justice

Ghose was appointed as the country's first Lokpal and "as a body, it is still growing and progressing", the statement said. Justice Kumari said steps would be taken to raise awareness about the online Lokpal complaint portal even in rural areas.

The portal provides a dashboard to every complainant, enabling him to view the status of his complaints during their life cycle. "The complainants will also receive e-mail alerts at different stages of the complaints, along with the copy of the order passed by the Lokpal or any

of its benches," the statement said. Highlighting important features of the digital platform, it said it makes it convenient for the com-

plainants to file complaints online from anywhere, anytime and the "identity of the complaint is kept confidential".

"Information to the complainant about action on complaint at every stage through e-mails and SMS, facility to complainant to ascertain status of complaint at anytime and reminders to inquiry agencies through e-mails and SMS" are some other features of the online platform, the statement said.

The CVC, the CBI and other inquiry agencies can upload their reports directly on the LokpalOnline platform and analytical reports can be generated according to the requirements, it added.

The Lokpal was established under the Lokpal and Lokayuktas Act, 2013 to inquire and investigate into allegations of corruption against public functionaries. The Lokpal received 30 complaints against senior central government officials between April and July, according to latest official data.

As many as 110 complaints were received by the Lokpal in 2020-21, a decline of over 92 per cent from the 1,427 plaints received in 2019-20. On March 23, 2019, President Ram Nath Kovind administered the oath of office to Justice Ghose as the chairperson of the Lokpal.

The eight members of the Lokpal - four judicial and four non-judicial -- were administered the oath of office by Justice Ghose on March 27,-2019. At present, the Lokpal has two vacancies of judicial members.

#### Danish, UK boats collide; 2 missing

Stockholm: A Danish cargo vessel capsized off Sweden early Monday after colliding with a British cargo ship in overnight fog, with two crew members missing in the Baltic Sea's freezing waters. The 55metre Karin Hoj barge and 90metre Scot Carrier were sailing in the same direction when they hit each other in the dark at 3.30 am (0230 GMT) in Swedish territorial waters, maritime agencies in Denmark and Sweden said, A search-and-rescue operation involving at least nine boats and a helicopter near the site off the Danish island of Bornholm was called off by late morning as the overturned Karin Hog was towed away in waters full of wreckage.

#### **SL President** suspends Parl

Colombo: In an unusual move, Raiapaksa has proroqued Parliament for one week and left for Singapore on an unscheduled visit. There was no immediate comment from the government on Rajapaksa's decision to suspend Parliament for a week. Parliament, which ended its sessions Friday, was originally set to convene January 11. It will now convene January 18. President Rajapaksa, through an extraordinary gazette notification dated December 12, suspended the assembly. Kabul: The Public Health Ministry under the Taliban-led government in Afghanistan Monday announced that it has launched a campaign to administer polio vaccination doses to more than 9.9 million of children under the age of five. The campaign is the last polio vaccination drive in 2021. It will continue in two weeks. This week it will cover 21 of Afghanistan's 34 provinces.

#### **■ Two lions trigger** panic at airport

Singapore: Two lions were shot with a tranquilliser gun and sedated Sunday at Singapore's Changi Airport after they got out of their freight container, triggering a mild scare in the vicinity, a media report said here. The lions, currently recovering from sedation under the care of the Mandai Wildlife Group here, were being transported in the container to an overseas facility, The Straits Times reported.

# UK reports world's first Omicron death

London, Dec 13: At least one person has died in the United Kingdom after contracting the Omicron variant of the coronavirus. Prime Minister Boris Johnson said Monday, warning that the variant now accounted for 40% of infections in the British capital.

Since the first Omicron cases were detected Nov 27 in the United Kingdom, Johnson has imposed tougher restrictions and Sunday he urged people to get booster shots to prevent the health service from being overwhelmed.

Visiting a vaccination centre in London, Johnson congratulated those getting shots and handed out stickers before telling reporters that a patient had died from Omicron which he said could overcome those inoculated with two shots.

"Sadly at least one patient has now been confirmed to have died with Omicron," Johnson said.

'So I think the idea that this is somehow a milder version of the virus - I think that's something we need to set on one side - and just recognise the sheer pace at which it accelerates through the population."

Johnson said there was a spike in Omicron cases in London, with Health Secretary Sajid Javid saying the variant was spreading at a "phenomenal rate".

Islamabad: Pakistan's top anti-coronavirus body confirmed Monday that the country's first Omicron variant has been detected in an unvaccinated woman through gene-sequencing. The confirmation made by the National Command and Operation Centre (NCOC) came days after a 57-year-old woman in Karachi was suspected of getting infected by the new Covid-19

Beijing: China has reported its first case of Omicron variant of Covid-19 amid a spike in coronavirus infections stated to be that of new Delta strain 'sub-lineage AY.4", prompting authorities to bar millions of people in the eastern province from travelling. The first case of Omicron variant of coronavirus was reported in Tianjin city in north China, state-run CGTN-TV reported Monday. A person who came from overseas was tested positive for the new variant, the report said.

#### Omicron 'very high' global risk, says WHO update

Geneva: The Omicron coronavirus variant, reported in more than 60 countries, poses a very high global risk, with some evidence that it evades vaccine protection but clinical

data on its severity remain limited, the World Health Organization says, Considerable uncertainties surround Omicron, first detected last month in South Africa and Hong Kong, whose mutations may lead to higher transmissibility and more cases of Covid-19 disease, the WHO said in a technical brief issued Sunday. The overall risk related to the new variant of concern Omicron remains very high for a number of reasons, it said, reiterating its first assessment of Nov 29.

### **SA Prez tests** +ve for Covid

Johannesburg: South African President Cyril Ramaphosa has tested positive for Covid-19 and is receiving treatment for mild symptoms. according to his office. President Ramaphosa, 69, who is fully vaccinated, contracted the contagion on a day the country recorded a new high of 37,875 new infections. dramatically up from the previous day's 17.154 new cases.

#### HK tycoon given 13 months prison

Hong Kong, Dec 13: A Hong Kong court Monday sentenced activist and business tycoon Jimmy Lai to 13 months in jail for urging participation in last year's banned Tiananmen vigil, amid a crackdown by Chinese authorities that has rolled back the semi-autonomous city's civil liberties.

The District Court convicted seven others on similar charges and handed out sentences of up to 14 months. Hong Kong's government has banned the candlelight vigil for the past two years on pandemic control grounds, although it is widely believed the ban is intended to be permanent as authorities look to squelch the city's pro-democracy movement.

Lai, the founder of the now-shuttered pro-democracy newspaper Apple Daily, has already been jailed for taking part in pro-democracy protests for which he will serve a total of 20 months. In the latest case, he was convicted Thursday of inciting others to take part in the unauthorised assembly to memorialise those killed in the army's bloody crackdown on student-led pro-democracy protests that centered on Beijing's Tiananmen Square in 1989.

Two other defendants convicted along with Lai, lawyer Chow Hangtung and former reporter Gwyneth Ho, were sentenced to 12 and six months respectively for participating in the vigil. Chow was also sentenced for inciting others to join.

The trio had previously pleaded not guilty to the charges.

Others sentenced Monday included Lee Cheuk-yan, the former chairman of the now-defunct Hong Kong Alliance in Support of Patriotic Democratic Movements of China. Lee received 14 months for organising last year's unauthorised assembly, during which thousands of people gathered to light candles and sing songs in Hong Kong's Victoria Park despite police warnings that they may be breaking the law.

The remainder were gir tences ranging from four months. two weeks, to nine months.

### Musk named Time's 'Person of the Year'

Washington, Dec 13: Tesla Chief Executive Officer Elon Musk was of the Year for 2021, a year that saw his electric car company become the most valuable carmaker in the world and his rocket company soar to the edge of space with an all-civilian crew.

Musk is also the founder and CEO of SpaceX, and leads brainchip startup Neuralink and infrastructure firm The Boring Company. Tesla's market value soared to more than \$1 trillion this year, making it more valuable than Ford Motor and General Motors combined.

Tesla produces hundreds of thousands of cars every year and has managed to avert supply chain issues better than many of its rivals, while pushing many young consumers to switch to electric cars and legacy automakers to shift focus to EV vehicles.

"Even Elon Musk's spacefaring adventures are a direct line from the very first Person of the Year. Charles Lindbergh, whom the editors selected in 1927 to commem-

orate his historic first solo transatlantic airplane flight over the Atlantic, the magazine's editor-inchief, Edward Felsenthal, said.

From hosting Saturday Nigh Live to dropping tweets on cryptocurrencies and meme stocks that have triggered massive movements in their value, Musk has dominated the headlines and amassed over 66 million followers on Twitter.

Some of his tweets have also attracted regulatory scrutiny in the past. According to the magazine, "The Person of the Year" signifies somebody "who affected the news or our lives the most, for better, or worse." Time magazine named the teenage pop singer Olivia Rodrigo as its "Entertainer of the Year", American gymnast Simone Biles "Athlete of the Year" and vaccine scientists were named "Heroes of the Year".

Last year, US President-elect Joe Biden and Vice Presidentelect Kamala Harris were jointly given the Person of the Year title. Time began this tradition in 1927. Facebook CEO Mark Zuckerberg and Amazon founder Jeff Bezos have also received the title in the past.

NATO says there will be no new US missiles in Europe and it is ready to deter new Russian missiles with a measured response that would only involve conventional weapons. But Ryabkov said Russia had a complete lack of trust in NATO.

"They don't permit themselves to do anything that could somehow increase our security - they believe they can act as they need, to their advantage, and we simply have to swallow all this and deal with it. This is not going to continue.

### 'Dubai world's first govt to become 100% paperless'

All internal, external transactions and procedures in the Government of Dubai are now 100 per cent digital and managed from a comprehensive digital government services platform.

"The achievement of this target marks the beginning of a new stage in Dubai's journey to digitise life in all its aspects - a journey rooted in innovation, creativity, and a focus on the future,"

said Sheikh Hamdan in a statement Saturday.

#### US cos register record buybacks

New Delhi: Companies listed on the S&P 500 bought back a record-setting \$234.5 billion in shares in the third quarter of 2021, surpassing the previous record of \$223 billion in the fourth quarter of 2018, according to preliminary data from S&P Dow Jones Indices, The Hill reported. Amid the Covid-19 pandemic and efforts to conserve cash, buybacks fell to around \$89 billion in the second quarter of 2020.

## **Nov retail inflation** climbs to 4.91% YoY

India's economy expanded 8.4% in the September quarter from a year earlier, the fastest pace among major economies, but economists say the pandemic situation is a wild card

New Delhi, Dec 13: India's retail inflation accelerated in November, led by a rise in food prices, but remained within the medium-term target of the central bank, strengthening views that the bank could keep interest rates on hold at its next meeting in February

Consumer prices rose 4.91% in November from the same month last year, speeding up from October's 4.48% but lower than the consensus Reuters poll forecast of 5.10%, Ministry of Statistics data showed Monday.

The Reserve Bank of India left interest rates on hold last week, saving growth was a priority as it warned of risks from inflation and the new Omircon variant on the economic recovery.

The central bank expects retail inflation at 5.1% for October-December period and 5.7% for January-March quarter in the current financial year.

Food prices, which contribute to nearly half of the consumer price index (CPI) rose 1.87% yearon-year in November, compared with 0.85% a month before. Prices of edible oil rose nearly 30% from a year ago period while vegetable prices fell by 13.6%.



Inflation has been within the RBI's 2-6% target range in recent months, and a cut in fuel tax last month by the federal government and softening of global crude oil

prices have dampened inflation-

ary pressures. Economists, have, however warned of risks of uptick in headline inflation over the coming months as companies pass on rising input costs to consumers amid economic recovery.

"CPI inflation is set to rise further over the coming months and the risks are stacked to the upside," said Shilan Shah, India economist at Capital Economics.

However, any rise in inflation is unlikely to trigger monetary tightening by the central bank, he said.

The company mopped up ₹312 crore from anchor investors on Wednesday.

The initial public offer (IPO) has a fresh issue of up to ₹600 crore and an offer for sale of up to ₹798.30 crore. The company on Friday said it has mobilised ₹418 crore from anchor investors.

#### Tega shares zoom 60% in debut trade

New Delhi: Shares of Tega Industries Ltd, manufacturer of consumables for the mining industry, on Monday listed with a huge premium and settled over 60 per cent higher against its issue price of ₹453. It debuted at ₹753, reflecting a premium of 66.22 per cent from the issue price on BSE. It further zoomed 69.33 per cent to ₹767.10 during the day. The stock settled with a gain of 60.15 per cent at ₹725.50. On NSE, it listed at ₹760, a gain of 67.77 per cent. The stock closed at ₹718, jumping 58.49 per cent.

# Vedanta withdraws cases on tax dispute against govt

VEDANTA HAD CHALLENGED THE DEMAND FOR TAXES AT TWO FORUMS -- THE INCOME TAX APPELLATE TRIBUNAL AND DELHI HIGH COURT WHILE ITS PARENT VEDANTA RESOURCES CHALLENGED THE MOVE BEFORE A SINGAPORE ARBITRATION TRIBUNAL

New Delhi, Dec 13: Billionaire Anil Agarwal's mining group Vedanta Monday said it has withdrawn cases in the Delhi High Court as well as before an international arbitration tribunal to settle a ₹20,495 crore retrospective tax dispute with the government.

Post slapping of a ₹10,247 crore tax demand on UK's Cairn Energy Plc for alleged capital gains made on a 2016 internal reorganisation prior to the listing of its India business, the Income Tax Department had sought ₹20,495 crore in taxes (including penalty) from Cairn India for failing to deduct tax on capital gains made by its British parent.

Cairn India was in 2011 bought by Agarwal's group and subsequently, the firm was merged with

Vedanta Ltd. In a statement, Vedanta said it has used the recently enacted law that scraps all demands levied using a 2012 retrospective tax legislation, to settle the dispute.

As conditions for the same, it has withdrawn all legal challenges against the government and given an undertaking to forego all future rights pertaining to the tax demand. Cairn Energy, which has main-

tained that no tax as per the prevalent regime was due on the 2006 reorganisation and won an international arbitration against the 2015 order seeking back taxes, is parallelly settling its dispute with the government. It is withdrawing cases to get a ₹7,900 crore of refund of taxes collected from it using the retrospective tax law.



While the Delhi High Court was continuing to hear the matter, the arbitration tribunal had completed the hearing and was due to pass an order anytime now.

"In view of the recent amendments to the Indian Income Tax Act. 1961 vide the Taxation Laws (Amendment) Act, 2021, which nullifies the retrospective tax imposed by Finance Act, 2012, Vedanta Ltd, and all its related group entities have taken steps to settle disputes arising from Order dated March 11, 2015, passed by the Deputy Commissioner of Incometax, International Taxation, Circle - Gurgaon," the firm said in a statement.

As required by the new law, Vedanta Ltd, along with its related group entities, filed the required statutory forms and undertakings in the prescribed Form 1, seeking to settle the disputes.

The forms and undertakings have been accepted by the jurisdictional Commissioner, and accordingly, a certificate to this effect, as prescribed in Form No 2 has been issued.

"Pursuant to the declarations in the aforesaid forms and undertakings, Vedanta Ltd has withdrawn the income tax appeal pending before the Delhi bench of the Income Tax Appellate Tribunal and also withdrawn writ petition filed before the Delhi High Court," the statement said.

The firm's parent Vedanta Resources Ltd has also filed the application seeking withdrawal of the claim and termination of the arbitral proceedings pending before the Permanent Court for Arbitration in the International Court of Justice it said.

"Vedanta Ltd and its related group entities also declare that no further proceedings or claims shall be initiated in any court or tribunal whether in India or outside India, pursuant to fulfillment of conditions (withdrawal of the tax

demand)," the firm said.

# Real dent Atletico hopes

Barcelona, Dec 13: Karim Benzema and Marco Asensio inflicted the latest blow on Atletico Madrid's title defense after leading Real Madrid to a 2-0 win Sunday to keep their team comfortably at the top of the Spanish league.

Vinícius Júnior again proved to be the difference for Madrid, setting up Benzema and Asensio in each half of the Spanish capital derby.

Diego Simeone's Atlético entered the Santiago Bernabéu needing a win to rekindle their hopes of getting back in the title race, seven months after it beat out Madrid and Barcelona in a thrilling finish to the 2020-21 sea-

But the commanding win by Carlo Ancelotti's side opened a 13-point gap for Madrid over fourth-place Atlético, who have a game in hand. There is still more than half the season left, but the chances of Simeone's team repeating as champion are fading fast.

The leading threats to Madrid are now the pair of rivals from Seville. Sevilla, who also have played one less game than Real, are second at eight points back, followed by Real Betis nine points adrift of Madrid.

Barcelona, the team that traditionally shares the majority of La Liga titles with Madrid, suffered another setback in its post-Messi

A 2-2 draw at Osasuna left it in eighth place, some 18 points behind Madrid. Barcelona has long known that a fourth-place finish to secure a berth in the Champions League is its realistic goal this season, Benzema put Madrid on its way to a 10th straight victory overall in the 16th minute after Luka Modric intercepted a pass by Koke Resurrección to start a coun-

Vinícius set up Benzema by stretching Atlético's defense with a run down the right before find ing his unmarked striker with a cross. Benzema did the rest with a superb sweep of his right leg to drive the ball under Jan Oblak for his league-leading 13th goal.

Another counterattack driven by Vinícius settled the contest when the Brazilian found Asensio

### 'CENTURION' MBAPPE SECURES PSG VICTORY

Paris, Dec 13: Kylian Mbappé scored his 100th goal for Paris Saint-Germain, netting a brace as the French league leader beat Monaco 2-0 Sunday.

The France star, who scored twice midweek in the Champions League in a 4-1 win against Club Brugge, gave PSG the lead from the penalty spot and doubled his tally just before halftime from Lionel Messi's assist.

At the age of 22 years and 357 days, Mbappé is the youngest player to score 100 goals for a single team in the French top flight, according to Opta's analysis of statistics since 1950. The comfortable win increased PSG's lead over secondplace Marseille to 13 points.

PSG had only a couple of chances in the first half and converted both as Mbappé showed no mercy for the club he helped to the French league title in 2017.

The hosts were awarded a penalty after Djibril Sidibe fouled Angel Di Maria. Mbappé took the penalty and beat Monaco goalkeeper Alexander Nübel to break the deadlock in the 11th minute.



Messi initiated the counterattack that led to PSG's second goal. The seven-time Ballon d'Or winner intercepted a pass, ran past defenders before setting up Mbappé, who curled a shot into the back of the net.

The Congressional approval of constitutional reforms came after IBA unanimously approved the recommendations made in a report by independent Governance Reform Group (GRG), led by Professor Ulrich Haas.

Huelva (Spain): Two Indian pairs suffered straight game defeats to make first round exits from the BWF World Badminton Championship here Monday. The Indian duo of Venkat Gauray Prasad and Juhi Dewangan suffered a crushing 8-21, 4-21 loss to Denmark's Mathias Thyrri and Mai Surrow, the mixed doubles first round match lasting barely 21 minutes in all. Then, in a men's doubles match, India's Arun George and Sanvam Shukla lost to the Chinese duo of Ou Xuan Yi and Zhang Nan 15-21, 14-21. Sunday, Kidambi Srikanth defeated Pablo Abian of Spain 21-12. 21-16to begin his campaign on a winning note. The Indian men's doubles pair of Manu Attri and B Sumeeth Reddy, however, lost 16-21, 15-21 to Joel Elpe and Rasmus Kjaer of Denmark in the opening round.

#### **Ajay qualifies for 2022 CWG**

Tashkent: Ajay Singh clinched India's third gold of the Commonwealth Weightlifting Championships here by winning the men's 81kg category. Singh lifted a total of 322kg and also set a national record in snatch (147kg) Sunday night. He became the third Indian weightlifter to directly qualify for next year's Commonwealth Games in Birmingham. Jeremy Lalrinnunga (67kg) and Achinta Sheuli (73kg) have already qualified for the 2022 CWG after winning gold in their respective competitions. The gold winners in all weight categories from this championship directly qualify for the 2022 Birmingham CWG while the rest can make it to the Games through the rankings. Popy Hazarika had also won a silver, in the women's 59kg, with a total lift of 189kg (84+105).
