NETFLIX SLASHES SUBSCRIPTION FEES

New Delhi: Netflix said Tuesday it is slashing its monthly subscription rates by up to 60 per cent in India, as it looks to woo viewers amid growing competition in the over-the-top (OTT) media service space in the country. Users will now pay ₹149 a month from ₹199 earlier for Netflix's Mobile and ₹199 instead of ₹499 for its basic plan for the same period. The standard plan will be charged at ₹499 per month and for the premium subscription, users will have to pay ₹649 for a

month. These plans were earlier charged at ₹649 and ₹799, respectively. "We are dropping our prices and it's across the board, across our plans. This will include all our services - local and global. The biggest drop of 60 per cent is in the basic plan because we want the audiences to watch Netflix on a bigger screen or on any device, so that has gone down from ₹499 to ₹199," Monika Shergill, Netflix VP for content (India), told PTI.



INFLATION SPIKES TO 14.23%

New Delhi: The wholesale price-based inflation surged to more than a decade high of 14.23 per cent in November, mainly due to hardening of prices of mineral oils, basic metals, crude petroleum and natural gas. WPI inflation has remained in double digits for eight consecutive months beginning April. Inflation in October this

year was at 12.54 per cent, while in November 2020 it was at 2.29 per cent. "The high rate of inflation in November 2021, is primarily due to rise in prices of mineral oils, basic metals, crude petroleum & natural gas, chemicals and chemical products, food products etc as compared to the corresponding month of the previous year," sources said.

Sonia holds Oppn meet without TMC

New Delhi, Dec 14: Congress president Sonia Gandhi Tuesday met a group of opposition leaders and held consultations with them to evolve a joint strategy in Parliament, sources said.

NCP supremo Sharad Pawar, J&K National Conference patron Farooq Abdullah, Shiv Sena leader Sanjay Raut and DMK leader T R Baalu were among the leaders who met Gandhi at her 10, Janpath residence.

Sources said more such meetings would be held in the next few days, in a bid to bring all opposition forces together. Significantly, Trinamool Congress (TMC) was not part of the opposition parties that took part in the meeting.

Opposition parties have been protesting the suspension of 12 Rajya Sabha MPs and are holding protests, seeking the revocation of their suspensions. Former Congress chief Rahul Gandhi and leader of opposition in Rajya Sabha Mallikarjun Kharge were also part of Tuesday's meeting. According



to sources. Sonia Gandhi had invited Uddhav Thackeray and DMK chief MK Stalin. Both deputed their leaders -- Raut and Baalu-- respectively.

Earlier in the day, opposition MPs in both Lok Sabha and Rajya Sabha held a protest march from the Gandhi statue in Parliament complex to Vijay Chowk with Rahul Gandhi alleging that the opposition is not being allowed to raise issues in Parliament, which is now merely a building and a museum.

Lakhimpur Kheri, Dec 14: The Special Investigation Team (SIT) probing the October 3 Lakhimpur Kheri violence, has filed an application before the Chief Judicial Magistrate to include new sections against the 13 accused to make their offence punishable under attempt to murder charges

Meanwhile, a court here allowed the SIT to replace lesser charges in the case like causing death by negligence with attempt to murder.

Vidhyaram Diwakar, the SIT investigating officer, filed the application last week in the CJM's court for adding new sections in the warrant, replacing sections 279, 338 and 304A of the IPC.

In his application, the investigating officer pointed out that the incident was well-planned and a deliberate act, and not of negligence or callousness. The investigating officer has re-

quested to add Sections 307 (attempt to murder), 326 (voluntarily causing grievous hurt by dangerous weapons or means), 34 (acts done by several persons in furtherance of common intention) of the Indian Penal Code after replacing sections 279 (rash driving or riding on a public way), 338 (whoever causes grievous hurt to any person by doing any act so rashly or negligently) and 304A (Causing death by negligence) of the IPC.

On October 3, eight people, including four protesting farmers, died after being mowed down by a SUV belonging to Union Minister Ajay Mishra Teni's son Ashish

RAHUL DEMANDS MIN'S SCALP & PM'S APOLOGY



New Delhi: Congress leader Rahul Gandhi Tuesday demanded that Union minister Ajay Mishra be removed from his post over the Lakhimpur Kheri violence and said it is time for Prime Minister Narendra Modi to apologise once again. His remarks came after the Special Investigation Team (SIT) probing the violence, which claimed eight lives including that of four farmers, urged the chief judicial magistrate to replace lesser charges in the case like causing death by negligence with attempt to murder, saying that it was a "pre-planned conspiracy causing death". "Modi ji, it is time to apologise again... But first remove the accused's father from the minister's post. The truth is before you!," Gandhi said on Twitter.

Mishra. A local journalist was also killed in the violence.

The SIT has so far arrested Ashish Mishra, Luvkush, Ashish Pandey, Shekhar Bharti, Ankit Das, Latif, Sishupal, Nandan Singh, Satyam Tripathi, Sumit Jaiswal, Dharmendra Banjara, Rinku Rana and Ullas Trivedi. They are lodged in the Lakhimpur Kheri district jail.

Meanwhile, the Lucknow bench of the Allahabad High Court has given two weeks' time to the state government to file a counter-affidavit on Ashish Mishra's bail application. During the hearing of the case, additional advocate general Vinod Shahi apprised the court about the ongoing investigation.

■ State govt will set up 11 police stations to deal with cyber crimes & economic offences

Bhubaneswar, Dec 14: With a view to controlling rising cyber crimes in the state, the government will set up 11 new police stations to deal with cyber crime and economic offence cases. Chief Minister Naveen Patnaik made an announcement to this effect here

The new police stations will come up at Cuttack, Bhubaneswar, Keonjhar, Angul, Balasore, Mayurbhanj, Puri, Koraput, Bhawanipatna, Bolangir and Kandhamal.

Three such police stations are already operating in Sambalpur, Rourkela and Berhampur. These police stations will be merged with the new system, the CMO said. With the opening of new police stations, the total number of such police stations in the state will go up to 14.

A total of 154 posts have been created in the police department for appointment in these police stations. The approved posts include 14 inspectors, 28 sub-inspectors, 28 ASIs (communications), 28 constables (communications) and 56 constable posts.

The Chief Minister hoped that this step would help in curbing cybercrime and economic offences in livery of speedy justice to people. Cybercrime is a major concern

Cybercrime is involved in bank transactions and complex digital transactions. Therefore, special knowledge and skills are required to properly investigate and control these crimes. This is why the state government took this decision to open 11 special police stations in different parts of the state,

Centre alone earned ₹8L crore from taxes on fuel in three fiscals

New Delhi, Dec 14: The Centre earned nearly ₹8.02 lakh crore from taxes on petrol and diesel during the last three fiscal years, of which more than ₹3.71 lakh crore was collected in FY21 alone, Finance Minister Nirmala Sitharaman informed Parliament Tuesday.

The minister was responding to queries on the hike in excise duty on petrol and diesel during last three years and the details of the revenue earned through various taxes on these fuels.

The excise duty on petrol rose from ₹19.48 per litre as October 5, 2018 to ₹27.90 a litre as November 4, 2021. The duty on diesel rose from ₹15.33 a litre to ₹21.80 during the same period, Sitharaman said in a written reply in the Rajya Sabha.

Within this period, the excise on petrol fell from ₹19.48 per litre as of October 5, 2018 to ₹17.98 as of July 6, 2019; while excise on diesel reduced from ₹15.33 to ₹13.83 during the same reference period.

The excise duties on petrol and diesel were on a rising trajectory till February 2, 2021, to ₹ 32.98 and ₹31.83 respectively, before falling a tad and then declining further to ₹27.90 a litre (petrol) and ₹21.80 (diesel) as November 4, 2021.

Those fully-jabbed at increased risk of Omicron: Oxford

■ *The researchers said people* previously infected or having received double vaccines are more vulnerable to Omicron. However, this effectiveness improves by a third dose of vaccine

London, Dec 14: Two doses of Pfizer and AstraZeneca COVID-19 vaccines generate lower levels of antibodies against the Omicron variant of coronavirus, according to a study which suggests that those previously infected or vaccinated may be at an increased risk of in-

Researchers from the University of Oxford in the UK analysed the impact of the Omicron variant of concern on one of the immune responses generated by vaccination.

The yet-to-be peer-reviewed study, posted on the preprint repository MedRxiv Monday, used blood samples from individuals who had previously received two doses of the AstraZeneca or Pfizer vaccines, and a live virus isolate.

The researchers demonstrate substantial decrease in neutralising titres - a measure of the level of neutralising antibodies generated in responses to vaccination against, or infection from, COVID-19. The results indicate that the Omicron

variant has the potential to drive a

further wave of infections, includ-

ing among those already vacci-

nated, the researchers said.

They, however, noted that there is currently no evidence of increased potential to cause severe disease, hospitalisations or deaths in vaccinated populations. These results align with recently published

data from UK Health Security Agency, showing reduced effectiveness of two doses of these vaccines against symptomatic disease due to the Omicron variant compared to Delta.

This effectiveness was, however. improved by a third dose of vaccine, the researchers said. "These data will help those developing vaccines, and vaccination strategies, to determine the routes to best protect their populations, and press home the message that those who are offered booster vaccination should take it," said Professor Gavin Screaton, Head of the Oxford's Medical Sciences Division, and lead author of the paper.

'Whilst there is no evidence for increased risk of severe disease, or death, from the virus amongst vaccinated populations, we must remain cautious, as greater case numbers will still place a considerable burden on healthcare systems," Screaton said.

Covid vax for kids in six months: SII

New Delhi: Serum Institute of India

(SII) plans to launch a COVID-19 vaccine for children in the next six months, the company's CEO Adar Poonawalla said Tuesday. Participating in an industry conference, Poonawalla said the vaccine 'Covovax' is under trial and would offer protection to children all the way down to three years. Currently, Covishield and other COVID -19 vaccines are approved for people above the age of 18 years. "We have not seen a lot of severe disease in children. However, we will be launching a vaccine in six months for children," Poonawalla said.





Khurda district reported the highest number of 82 cases, followed by 12 in Cuttack and Mayurbhanj district.





Phones disconnect parents with kids: Study

t least 69 per cent of parents believe that they lose track of their children, surroundings when they are immersed in their smartphones and 74 per cent admit to getting irritated when their children ask them something, a report said Tuesday.

A new report titled 'Smartphones and Human Relationships' by the smartphone brand Vivo in association with Cybermedia Research (CMR) showcases the impact of smartphones on users and its effect on their relationships.

"The most difficult thing in any behaviour change that we need is to take that first step," addressing the excessive use of smartphones,



Yogendra Sriramula, DGM, Brand Strategy, Vivo India, told IANS.

"Our job here through this survey and the rest of the campaign is to bring that knowledge from the subconscious mind to the conscious mind," Sriramula added.

The report underlines that the average daily time spent on smart-

phones remains at alarming levels in the post-Covid era as there has been a 32 per cent increase in the time spent on smartphones from the pre-Covid period. Interestingly, the report also

highlighted that while the time that is spent with kids and family, in general, has gone up, the quality of time spent has deteriorated.

At least 80 per cent of smartphone users are on their phones even when they are spending time with their kids and 75 per cent admit to having been distracted by their smartphones and not being attentive to kids even

that their children find it difficult to mix with other kids in a social setting and the overall outdoor experience to be daunting, 90 per cent of parents said that their children are sometimes found to be lacking in acceptable moral and social behaviour.

The overall dependency on phones has increased. People use their phones while eating food (70%), in the living room (72%) and even while sitting with family (75%), said the survey that covered 1,100 consumers, across age groups and demographics, in the top 8 Indiancities, including, New Delhi, Mumbai, Kolkata.

Bhubaneswar, Dec 14: A delegation of Biju Janata Dal (BJD) MPs Tuesday met Union Rural Development Minister Giriraj Singh and demanded PMAY-G houses for the people affected by Cyclone Fani in 2019 and the tribal and poor residents of the state.

The MPs' delegation meeting with the Union minister at the national capital came barely two days after Chief Minister Naveen Patnaik wrote a letter to Prime Minister Narendra Modi in this regard.

The Union Rural Development Minister has assured that he would again meet the BJD MPs in the next few days along with his officers and more deeply discuss it and find solutions, a statement issued by the BJD said.

In a memorandum to the Union minister, the BJD MPs noted that the Chief Minister had already requested the Prime Minister to include the identified left-out eligible households under Pradhan Mantri Awas Yojana Gramin (PMAY-G) in respect of districts not affected by cyclone Fani.

Patnaik also requested the PM to advise the Ministry of Rural Development to open the window of Aawaas + Mobile App for the entire state (Odisha) for a period of one month in order to migrate the data of eligible households from state developed RH (rural housing) portal to Aawaas+ for PMAY(G)

The BJD MPs pointed out that Odisha has conducted identification through state developed RH Portal and found 5.09 lakh eligible families in 16 districts not affected by

housing units. These households are predominantly tribal's in the tribal areas and KBK (Koraput-Bolangir-Kalahandi) districts of Western and Southern Odisha. The data of these families need to be migrated to the PWL of PMA Y(G), they said.

Stating that the Fifth Schedule of the Indian Constitution provides for special protection to these areas as they are tribaldominated and facilitating their speedy development, the BJD MPs wrote in the memorandum that the KBK region in Odisha also suffered in the process.

"We, strongly feel that the peole of western Odisha, scheduled areas and KBK regions should be provided priority focus and houses should be provided to them at the

earliest," the BJD MPs said. They also added that 1.84 lakh houses during Cyclone Fani are staying in dilapidated houses. These families are otherwise not entitled to avail normal PMAY-G houses. The PM during his visit to

Odisha in May 2019 had committed to sanction PMAY-G houses to Cyclone Fani affected families PMAY-G (Special) houses to these 1.84 lakh families need to be sanctioned and the pre-requisite often listen of their name in the PWL (people in waiting list) of PMAY(G) should be waived.

IISER breakthrough in devpt of silver nanoparticles

Indian Institute of Science Education and Research (IISER) Bhopal has developed a safe and easy procedure to produce silver nanomaterials or silver nanoparticles (SNPs) that can be used as antimicrobial agents.

Antibiotic resistance is a serious condition in which bacteria and other microbes that invade the human body become resistant to the antibiotics/antimicrobials that are meant to kill them. The World Health Organisation

(WHO) has declared bacterial antibiotic resistance as one of the worst crises to human health today notwithstanding Covid-19. This problem is also serious in India, known as the antimicrobial resistance capital of the world, due to rampant and indiscriminate use of antibiotics in humans, livestock, and agriculture.

"Silver, the common ornamental metal, when present as nanosized particles -- one hundred thousand times smaller than the width of a single human hair -- have good antimicrobial properties," said Saptarshi Mukherjee, Professor, Department of Chemistry, IISER Bhopal, in a statement.

Medical practitioners have used silver in various forms to prevent infections and promote healing from ancient times. "Generally, silver nanomaterials are produced using toxic precursors that often generate harmful by-products inside the system," said the lead researcher.

But in the new study, published in the journal of the American Chemical Society - ACS Applied Materials and Interfaces, the IISER team used the amino acid Tyrosine to produce nanomaterials of silver that had excellent antimicrobial properties. Tyrosine is present in many food items, including meat, dairy, nuts, and beans.

The researchers treated silver nitrate, the main component of the 'election ink' used to stain nails after voting in India, with tyrosine in the presence of caustic soda.

Tyrosine functioned as a reducing agent and capping agent to produce silver nanomaterials. On examining the product under high-resolution microscopes (TEM and SEM), they found two forms of silver nanostructures - nanoclusters and nanoparticles. The nanoparticles were found to kill microbes such as S. cerevisiae (associated with pneumonia, peritonitis, UTI etc.), C. albicans (oral and genital infections), E. coli (stomach infection), and B. cereus (stomach infection), in about four hours.

The research group has also elucidated the mechanism by which the nanoparticles kill microbes. They found that the nanoparticles generate "singlet oxygen species" that elevates the cellular stress and consequently breaks open/disrupt the cell membrane of the microbes and cause leakage of proteins from the cells, thereby killing them.

While the nanoparticles produced by the above process had microbicidal action, the smallersized nanoclusters are luminescent and can be used as bioimag-



The state has the total power availability of 7,651MW, including 1,295MW from renewable sources, said GRIDCO Managing Director Trilochan Panda.

It is expected that the demand during the peak hour of summer may cross 4,000MW. Keeping this in view, the Chief Secretary asked the power generating companies to maximize their production.

Jajpur, Dec 14: Despite the growing concern over climate change, air and water pollution is reportedly spiraling in major towns and industrial areas in the state

The state government has taken up a host of measures to tackle the pollution-related issues, to alleviate green house effects and carbon footprints, as Odisha has faced frequent disasters owing to climate change, a report said.

If climate experts are to be believed, frequent cyclones, extreme drought conditions, rise of sea level and prolonged heatwave conditions are likely to be the new threats for people in future.

Minister of Forest, Environment and Climate Change Bikram Keshari Arukh had hinted about such threats while replying to a query of MLA Mohan Charan Majhi in the Assembly recently.

The minister also put forth a report detailing various programmes being executed by the Odisha State Pollution Control Board (OSPCB) to tackle pollution and other issues.

Scores of industrial units have mushroomed up in various districts of the state with intention of pushing the development agenda and creating wider scope of employment.

On the one hand, the Forest department has emphaised on protection and regeneration of green cover and the environment, on the other hand, the government is encouraging private players to set up industries at the cost of forests and environment.

In many cases, it is seen that the administration, the SPCB and other agencies fail to act against industries that are throwing all norms to the winds

A report of the National Green

Tribunal (NGT) says seven towns of Odisha are among the 106 cities in the country that have been placed in the list of highly polluted cities.

The highly polluted towns in the state include Kalinganagar Industrial area in Jajpur, Paradip, Talcher, Angul and Sambalpur.

In 2020, Greenpeace had conducted a survey on polluted cities in 100 countries. In the survey list of highly polluted cities, Paradip was placed at 79th position; Kalinganagar at 84th; Rourkela at 85th; Cuttack at 88th and Talcher at 93rd.

The air pollution report of the OSPCB (from August to October) stated that presence of particulate matter in the air of Kalinganagar. Talcher, Rajgangpur and Rourela is much higher than the permissible limits. However, sulphide oxide (SO2), nitro oxide (NO2) and fine particulate (PM-2) are within their permissible limits in the atmosphere in these areas

To make use of industrial waste, the OSPCB has set up fly ash resource centres with a capacity of 35.5 MTPA in 2020-21. Besides plantation in the industrial and mining areas, the OSPCB has planned to set up IREMP in Angul-Talcher, Sambalpur-Jharsuguda and Paradip. The report stated that ₹10 lakh has been utilised for various measures to contain green house effects and carbon blue prints.

654 teacher posts vacant in 208 schools

Keonihar, Dec 14: Secondary education in Keonjhar district is in pathetic shape with 654 posts of teachers lying vacant in 208 government schools in the district. This is despite the fact that over 100 government high schools have been transformed and equipped with better infrastructure and facilities under the 5T Initiative in the district.

As a result, classroom teaching has been badly affected in these schools due to lack of adequate number of teachers. This has given rise to serious concerns among the students at a time when the annual HSC examination is just months away.

Classroom teaching has fallen flat in Nayagarh Nodal High School under Jhumpura block as the **KEONJHAR DIST**

school does not have even a single teacher. Surprisingly, primary school teachers are teaching the high school students here.

Recently, the state government announced 15 per cent reservation for students of government high schools in engineering and medical courses. However, guardians now question why they should send their children to these schools where several posts of teachers are lying vacant.

In some cases, it has been found that Sanskrit teachers are teaching science to the students, while physical education teachers teach history, geography, mathematics and Hindi. In Mochibandh Government High School, the sports teacher was found teaching history and geography to the students.

According to reports, as many 654 posts of teachers, including 49 posts of headmaster, 73 posts of science (PCM), 75 posts of science (CBZ), 151 posts of art teachers, 17 posts of IACT teachers, 17 posts of trained CT teachers, 78 posts of Sanskrit teachers, 114 posts of Hindi teachers and 80 posts of PETs are lying vacant in various schools in the district. The high schools in the district currently have only 1,094 teachers against 1,748 sanctioned posts

Similarly, 103 posts of clerk are lying vacant against 202 sanctioned posts. The district has only 99 clerks working in these high schools. Over 245 posts of peon are lying vacant in the schools against the 461 sanctioned posts. Against the 197 sanctioned posts of night watchman and sanitary workers, 89 are lying vacant.

development of the Buddha Vihar and its establishment as an ancient tourist site had thrice recovered over 50 artifacts. including rare and broken idols of Lord Buddha and Arghya Stupas from the Baitarani riverbed of Sholampur, Mudhapada and Maninathpur.

Recently, several Buddhist artifacts including potteries were recovered from Baitarani riverbed at Maninathpur (Chabisikuda) area. The recovered articles include eight Arghya Stupas and over 50 clay pots.

The artifacts after recovery were handed over to authorities of Buddha Vihar museum at Sholampur. The eight Arghya Stupas made up of Khondalite stone (a typical foliated metamorphic rock) and more than 50 clay pots were recovered.

Archaeologist Sunil Kumar Patnaik and researcher Ekadasi Padhi said that the Arghya Stupas and clay potteries date back to the eighth and ninth centuries.

Out of the four Votive Stupas, three have the idols of Buddhist deities Goddess Tara and another is of Maitreva. The other four are common Arghya Stupas.

he much publicised Democracy Summit organised by the USA in which leaders of over 100 countries, including India, participated last week appears to have turned out to be an inane exercise so far as democracy is concerned. It seems the aim was to bring together leaders of countries the USA considers friendly, no matter whether some of them make a mockery of democratic values in their own countries, so as to put up a show of unity against China and Russia which were not invited to the summit. It may be noted here that the history of the US has been full of instances where despotic rulers across the world have been assisted or propped by America. However, this is not an appropriate time in human history to revisit the sordid past of American misdeeds. The presence of Rodrigo Duterte of the Philippines and Jair Bolsonaro of Brazil, who are known for their anti-democratic actions in their respective countries, puts a question mark on the sincerity of the endeavour. Pakistan decided to skip the meeting presumably following pressure from China and in a way helped US President Joe Biden dodge criticism by his adversaries that Pakistan controlled by its military hardly qualifies to the description of a democratic state.

According to the US State Department, the goal of the summit was to provide a platform for leaders to announce both individual and collective commitments, reforms, and initiatives to defend democracy and human rights at home and abroad. The virtual summit, as the US calculated, would solicit bold, practicable ideas on the themes of fight against authoritarianism and corruption and promotion of human rights. But there is no explanation as to why some countries that can hardly be considered democratic were invited. According to a survey, over 30 per cent of the 110 invited countries are classified as 'partly free.' Three of them - Angola, the Democratic Republic of the Congo and Iraq - are described as 'not free.' The exclusion of countries such as Bangladesh and Sri Lanka raises serious doubts on the criteria applied for countries to be considered democratic. What brings more into question is that if the 'quality of democracy' and the respect for human rights were the criteria, which country is qualified to make that value judgement. The summit has been decried by Russia and China. In a joint rebuff, the Russian and Chinese Ambassadors to the US claimed their own states are democratic in practice, and criticised America's role in effecting regime change and 'democratic transformations' in Iraq, Libya and Afghanistan. The timing of the summit itself - a brainwave of President Biden to showcase his democratic credentials as a counterfoil to his predecessor Donald Trump's bullying tactic – was flawed. For, this year newest democratic entrants, Afghanistan and Myanmar, have switched over to autocratic regimes that rule by the power of the bullets rather than ballots. These developments put into serious doubt the efficacy of the international order in enforcing democracy through external interventions.

As such, the summit would have done well if it could in the first place formulate a globally accepted definition of democracy and a shared understanding of the challenges. It was not enough for the Biden administration to spell out specific targets on helping free media, ensuring free and fair elections and the participation of women, while identifying authoritarianism, corruption and human rights violations as key challenges.

Prime Minister Narendra Modi underscored the importance of the principles of 'inclusion, transparency, human dignity, responsive grievance redressal and decentralisation of power' in Indian democracy. But, the Modi government has invited widespread international criticism for going just in the opposite direction. The repression of the farmers' agitation against now repealed farm laws, incarceration of civil rights activists under various draconian laws levelling trumped-up charges and attacks on minorities during the BJP rule since 2014 have besmirched India's reputation as a democratic country.

The summit did not take note of Myanmar military junta's continued killings of its people in fresh attacks. In one incident last week in a village - Don Taw - 11 people, including children, had reportedly been rounded up by the armed forces and shot dead. Their bodies were then set on fire. The gruesome killings triggered widespread outrage on social media. In the state-controlled media, however, the military denied the report and accused UN officials and others of interfering in Myanmar's domestic affairs and relying on 'distorted news.' The villagers were learnt to be part of a resistance group fighting the junta.

The summit could have also taken up specific instances of attacks on democracy across the world to establish its credentials. By not doing so, it has only lent credence to the trenchant criticism by China that the main motive of

the whole exercise was to revive 'Cold War' tension and isolate China. Be that as it may, it is time the world comes to terms with reality. Today's global situation clearly shows no one nation is capable of being the policeman for the entire world. Apart from dire economic distress of the past few years, the pandemic has made even the richest and the strongest to take a step or two backwards. In this perspective, it is now the responsibility of logical and democratic forces in every country to shed fear and participate openly in the formation of free and just systems.

Proteome

lacktrianglehis is a blend of protein and genome. In the same way that the genome is the collective name for all the genetic material in the cell of a living organism, the proteome is the term for the complete set of the proteins produced from the instructions coded in that genetic material (expressed from it, in the jargon). Recent advances in automatic methods of assay are making it possible to list all the expressed proteins and so determine which ones are present in healthy tissue and which are characteristic of disease. It is expected that this will lead to new methods of diagnosis, and to the discovery of mechanisms by which diseases spread within the body. For example, a team at Oxford Glycosciences in the UK has found 47 proteins in synovial fluid which are unique to persons suffering from rheumatoid arthritis and this has led to the discovery of a previously unknown enzyme responsible for breaking down membranes in joints. The term is said to have been invented by Marc Wilkins and Keith Williams at the Macquarie University Center for Analytical Biotechnology in Australia.

POLARISED VIEWS ON RACE

ebates about race have frequently dominated news coverage in (and about) the United States, often following acts of racial violence or legal proceedings against their perpetrators. But while Americans' attention to issues of race continues to ebb and flow with the news, there seems to be little agreement among citizens and policymakers on what, if anything, to do about them.

One stark and long-standing racial disparity is visible in the differences in socioeconomic outcomes for Black and white Americans. Six decades after the civil rights movement, median Black household income in the US is still only 60 per cent of median white household income, and the share of Black Americans living below the poverty line is more than twice that of white Americans. Average life expectancy in the US is 4.5 years shorter for Black men than for white men, and three years shorter for Black women relative to white women. While home ownership among African Americans rose between 1940 and 1970, it is still barely half the level of white home ownership today. And many of these racial gaps are likely to have widened during the COVID-19 pandemic.

These disparities raise urgent political questions. What share of the US public recognises the chasm, in terms of opportunities and outcomes, that exists between Black and white Americans? Might people agree that an active policy response is needed, but disagree on whether the response should focus on income-targeted redistribution or race-targeted interventions?

Two colleagues and I from the Social Economics Lab at Harvard recently analysed survey responses from a large sample of Black and white Americans to determine what they know about racial inequities, what they believe causes them, and what (if anything) should be done about them. Not surprisingly, we found significant racial and partisan gaps in perceptions about the conditions facing, and the opportunities available to, African Americans.

But the biggest disagreements by far concern the causes of racial inequity and how to remedy them. These divisions are not mainly by race: it is not just about white and Black US respondents hav-

ing different views. Considering only the average perceptions and attitudes among white respondents misses the importance of political leanings

For example, along many dimensions, white Democrats were more aligned with Black Democrats than with white Republicans, Black and white Democrats are much more likely to attribute persistent racial gaps to systemic causes such as the legacy of slavery, long-standing discrimination, and racism. Likewise, both groups support more income-targeted redistribution and race-targeted policies. By contrast, white Republicans tend to support less intervention, because they view racial inequities primarily as the result of individual actions and decisions.

Moreover, we found that racial and partisan gaps are already prevalent among teenagers aged 13 to 17, whose views substantially align with their parents' political affiliations – though they are sometimes even more polarised. For example, teenagers in Republican families are even more opposed to many racetargeted policies than their parents are. This suggests that, by the time they reach adolescence, American children have absorbed their parents' partisan beliefs.

But there are apparent differences by race, too. Most notably, Black and white adolescents are deeply divided over support for reparations. White teenagers oppose preferential college admissions more than white adults do, perhaps because they believe that such policies affect them directly.

Previous studies have revealed that racial segregation and neighbourhood characteristics (such as high poverty rates and significant racial bias) negatively affect African Americans' social and economic prospects. In our study, we used granular data at the ZIP-code level to map perceptions, views, and attitudes to specific local characteristics. We found that white adult respondents from areas with more Black residents and with larger racial gaps are more likely to attribute racial disparities to adverse circumstances, slavery, racism, and discrimination; likewise, they are also more likely to support interventionist policies.

What, then, lies at the core of divergent attitudes toward redistributive policies? Is it beliefs about how large these inequities are, views about how much they matter, or perceptions of their ultimate causes?

To find out, we broke down the underlying factors that shape policy views. We found that it is not the perceived magnitudes of racial gaps, but rather their perceived causes, that have the highest predictive power. Support for racetargeted policies correlates with the belief that past and current racism and persistent discrimination are to blame. Support for income-based redistribution also is positively correlated with per-

ceptions of current racism and discrimination, and negatively correlated with the belief that Black Americans are worse off than white Americans because of a lack of individual effort.

Finally, we examined how providing information on racial inequities might affect respondents' views. When given information about the Black-white earnings gap or the differences in social mobility for Black and white children, respondents tend to adjust their perceptions, but not their policy views. But after hearing an explanation of some of the longstanding and deep-rooted causes such as the redlining of neighbourhoods by mortgage lenders and the resulting residential segregation - respondents tend to offer more support for race-targeted and redistributive policies.

Nonetheless, beliefs about the causes of racial inequities are quite entrenched. While white Democrats tend to become more supportive of policies aimed at closing racial gaps once they are aware of the conditions confronting Black Americans, exposing Republicans to the same facts does not generate more support. In fact, some even respond to such information by deepening their opposition to interventionist policies. This contrary effect appears to be partly driven by the assumption that the information provided was itself biased in a partisan (leftwing) direction.

Americans' views on racial inequities depend on many factors, including knowledge, news sources, and long-standing narratives. While many people are at least somewhat aware of inequalities that correlate with race, they disagree deeply on the causes, how to address the problem, and whether policymakers should even try. Information on the magnitude and severity of racial gaps does not change the narrative that respondents have in mind, often by the time they have reached adolescence. Explanations of the causes of racial gaps can be more effective. But the beliefs that are most polarised and most predictive of policy views are also the hardest ones to change.

If they have even more money, they go to a plastic surgeon and say, "Please make my face look like Deepika's." If they're married, they take their husband to a personal fitness trainer and say, "Please make my husband look like Deepika's.'

It's easy to value your uniqueness when you're a stunning beauty like Harnaaz Sandhu. It's much harder to value your uniqueness when you frighten yourself every time you look in the mirror.

It's easy to value your uniqueness when you have a brilliant mind like Google CEO Sundar Pichai. It's much harder to value your uniqueness when you can't answer any questions

It's easy to value your uniqueness when you can throw a javelin 88 metres like Neeraj Chopra. It's much harder to value your uniqueness when you can't even throw your unemployed cousin out of your apartment.

If you make a list of all the things that make you unique, there are probably some things that are harder to value than others. The mole on your forehead may seem somewhat unique, but it's hard to take pride in that. Having an unusually large mole, however, might get you in the Guinness World Records. And if not a world record, you'll surely be able to land regular roles in the Hindi film industry as a villain.

But even if you have a few negative traits, you can probably find at least one or two positive ones that you can truly take pride in. 

New Delhi/Mumbai, Dec 14: Delhi has reported four more cases of Omicron while eight more persons have tested positive for the Covid-19 variant in Maharashtra Tuesday, taking the tally in the country to 61.

Delhi Health Minister Satvendar Jain said all the six people who have so far tested positive for the Omicron variant in the national capital had a history of travelling abroad. "So far, six people have been found Omicron-positive in the capital. One of them has been discharged. All of them had travelled to foreign countries and were transferred to the Lok Nayak Jai Prakash Narayan (LNJP) hospital from the (Indira Gandhi International) airport." Jain told reporters.

The condition of the remaining five Omicron-positive patients is stable, he said. So far, Maharashtra has reported the highest number of cases at 28, followed by Rajasthan at 17. Omicron cases have also been reported in Karnataka (3), Gujarat

(4), Kerala (1) and Andhra Pradesh (1) and Union Territories of Delhi (6) and Chandigarh (1).

Eight new patients were found to be infected with Omicron in Maharashtra, the state health department said citing a report released on Tuesday by the Punebased National Institute of Virology. Seven of them were from Mumbai and one from its satellite township of Vasai-Virar, the department said, adding none of the eight had an international travel history. Maha stunned by grisly 'beheadings' of two women

Raigad (Maharashtra), Dec 14: Two gruesome cases of 'beheading' of recently-married young women, including one who was pregnant and another allegedly a victim of dowry, in just a week have rocked the state, officials said here.

The latest incident occurred in the tiny hill-station of Matheran in Raigad Sunday, preceded by the 'honour-killing' of a pregnant woman in Aurangabad the previous Sunday.

We have arrested the accused, an IT engineer from Panyel, who allegedly killed his wife, dismembered her head, carried it around 200 metres away from the homestay and flung it into a 200feet-deep ravine at an isolated spot in the hill-station, Matheran Police Station Assistant Police Inspector Sanjay Bangar told IANS.

Early Sunday the accused --Ramsilochal Pal, 30, hacked off the head of his wife, Poonam Pal, 27, left her naked body in the bathroom of the homestay and decamped from there under cover of darkness. According to Bangar, with the dowry angle surfacing alongside infidelity, Pal's family would also be made part of the investigations.

Investigators said the cold-blooded murder was apparently pre-planned as the accused had visited Matheran a few days earlier and conducted a recce of various spots. This is the second such incident, coming a week after the murder and beheading of a 19-year-old pregnant woman, Kishori alias Kirti Thore, with a sickle in Goygaon, Aurangabad, by her mother Shobha S Mote and younger brother Sanket S Mote.

After committing the heinous, premeditated deed of 'honourkilling', the mother-son later clicked selfies with Kirti's severed body, placed her head outside her home before surrendering to the Vaijapur Police.

J&K TERROR ATTACK: DEATH TOLL RISES TO 3

Srinagar, Dec 14: The death toll_ in Monday's terrorist attack on a police bus in Jammu and Kashmir rose to three Tuesday with a constable succumbing to his injuries, while the union territory's police chief vowed that perpetrators would be brought to justice very soon.

Constable Rameez Ahmad of the ninth battalion of the Jammu and Kashmir Armed Police died at the Army's 92 Base Hospital Tuesday morning, officials said.

The Kashmir Tigers, a littleknown outfit which is believed to be a front of the Jaish-e-Mohammad terrorist group, has claimed responsibility for the firing on the police bus that took place on the 20th anniversary of the attack on the Parliament Building. Assistant Sub Inspector Ghulam Hassan and Constable Shafeeq Ali were killed in the attack Monday, while 12 others, including Rameez, suffered injuries. On Tuesday, Jammu and Kashmir Police chief Dilbag Singh ordered a series of measures to be adopted while making the deployment of personnel, their travel as well as in other situations.

Birds being shot using air guns: Govt

New Delhi, Dec 14: Birds are being shot using air guns in different parts of the country, the government said in Parliament while terming it a "serious" issue and that appropriate action is taken by states against it.

Responding to a query raised by Mathura MP Hema Malini whether birds are being shot in the country using air guns. Minister of State for Environment Ashwini Choubey said his ministry is "aware" of the issue. "The ministry is aware that birds are shot using air guns in different parts of the country. Appropriate action under applicable statutes is taken by the respective states/Union Territories as and when such cases are reported," Choubey said in his written reply Monday. "Keeping in view of the seriousness of the issue, the states/Union Territories organise regular awareness programmes during various occasions

to sensitise people for protection of birds," he said. On being asked if the government was working on any scheme for running a campaign to get air guns surrendered in the whole country, Choubey said the ministry provides financial assistance to the states/Union Territories under Centrally Sponsored Scheme 'Integrated Development of Wildlife Habitat', which also includes activities for awareness generation among public for protection of wildlife, including birds.

Women in law face bias: C[[

New Delhi, Dec 14: Chief Justice of India NV Ramana Tuesday rued the fact women in the legal profession face bias, both from their colleagues or litigants, and this affects not just advocates, but also those on the bench.

In his address at the felicitation of Supreme Court judge Justice Hima Kohli by Women in Law and Litigation (WILL), he said: "There are various barriers that women face in the legal profession that merit consideration the continued prevalence of certain attitudes about the role of women in society. This issue is a problem a woman faces regardless of the type of employment. Another issue is the bias that women face, whether from their colleagues or litigants. This bias affects not just women advocates, but also those on the bench.

He added that this creates "a completely unwelcome atmosphere" within courtrooms for women and it is the duty of all lawyers and judges to ensure that a friendly environment is created in courtrooms.

On the aspect of women representation in the judiciary, the CJI said: "The demand for higher representation beyond 50 per cent on the Bench in view of the backlog of under representation of women is taken note of. I promise to take up your demand with my Brothers in the collegium.'

He added that women constitute only around 30 per cent of the judges in the lower judiciary on average and some states have a good number of women judges, whereas in other states, the representation is abysmal.

Chief Justice Ramana said recently while hearing a very sensitive matter, Justice Kohli had observed that "you're dragging your feet" and this was the only observation she made.

He added that next day all headlines were on that quote. He said that she was "a little scared and asked me if she had made a mistake but I told her there is nothing wrong and you're entitled to express your views".

Initiating a discussion on Supplementary Demands for Grants (Second Batch) 2021-22, Shashi Tharoor (Congress) said the Covid-19 pandemic combined with the government's "short-sighted" policy decisions ushered in a period of "uncertainty" for the economic revival of India.

"Our nation's economy continues to battle the significant forces of disruption that were set in motion by the Covid-19 pandemic and

which can trace their way back in our country to the disaster of demonetisation," he said

'While we all applaud the heroic efforts of our health workers, nurses, doctors, the truth is the virus combined with the short-sighted policy decisions of this government has ushered in a period of uncertainty for the economic revival of the country," he said.

BJP member Nishikant Dubey hit back, saying the present government has done more for people than past regimes and efforts were underway to undo certain decisions taken by the erstwhile UPA government. Supriya Sule (NCP) too wondered that the government keeps on saying that GST is doing very well but there is a delay on the part of the Centre to transfer the state's share.

Congress member M K Vishnu Prasad said high petrol and diesel prices have become unbearable and the government is just a mute spectator leaving people at the mercy of oil marketing companies.

Despite reduction in crude oil prices, retail fuel prices have not come down, Prasad alleged.

On the disinvestment policy, Prasad said, the government should consider options for raising its resources rather than selling its PSUs. AIMIM member Imtiaz Jaleel made a strong demand for improving medical infrastructure in the country. Lauding the initiative to promote ayurveda across the country, Jaleel sought to know why the government was "ignoring" Unani system of medicine.

He urged Prime Minister Narendra Modi to make a surprise visit a government hospital as a commoner to understand the reality of medical infrastructure in the country. RSP member N K Premachandran slammed the government for the "sellout" of Air India to the Tata Group and demanded that the financial details of the transaction be made public.

TN to crackdown on bonded child labour

Chennai, Dec 14: The Tamil Nadu government will crackdown on bonded child labour which according to reports from organisations functioning in the field, is rampant in the delta districts of the state.

Sources in the Chief Minister's office told IANS that MK Stalin has directly intervened in the matter and that the state Social Welfare Department has been assigned to conduct a detailed study on the issue. The state government faced backlash after four children, who were bonded labourers at a goat farm in Ramanathapuram, were

The children, Vetrivel (nine), Velayuthan (eight), Sakthivel (seven) and Sundar (six) were bought by the farm's owner Govindarajan from their poverty-ridden parents for

When the children were rescued by a multitask department force in Thanjavur, they were not able to properly communicate as they were living with a herd of 500 goats and without proper food.

According to activist Pathimraj, Govindarajan had convinced the parents and bought the elder children for Rs 50,000 and the younger ones at Rs 12,000. The farm owner later sold the younger siblings to some other person. Pathimraj told mediapersons

that this was only the tip of the iceberg and buying and selling of children have been taking place in several delta districts of the state. The activist said that his NGO,

'Shed India' had rescued more than 40 children from people who had bought them for bonded labour.

mediapersons that they were farm labourers and after the Covid-19 pandemic, were in abject poverty. They had given the children to Govindarajan as labourers and the money they took was the advance of the children's salary.

Despite strict laws in the country against child labour, all the children were under 10 years and subjected to inhumane life for the past two years.

Speaking to mediapersons in Thanjavur, Vetrivel said, "We were given only kanji (porridge) and that too one time a day and we dreamt of eating rice and curry. He used to thrash us when goats were found missing and had to run around to retrieve the goats that had wandered off. We used to walk for 10 km daily from one point to another for grazing the

It was Vetrivel and Velayuthan who had escaped from the clutches of the farm owner and revealed the matter to the public and Pathimraj.

Pathimraj's NGO immediately took up the matter and apprised the Thanjavur District Child Welfare Committee of it.

The children are now under the care of Child Welfare Committee and are trying to get back their communicating skills.

India stuck with Covid vaccines it can't export SC allows double

New Delhi, Dec 14: India is struggling to export its surplus of Covid-19 vaccines as logistical hurdles delay their use in many countries despite low levels of inoculation, vaccine producer the Serum Institute of India (SII) and a government official said Tuesday.

The SII, the world's biggest vaccine maker that produces the AstraZeneca (AZN.L), Novavax (NVAX.O) and Sputnik Covid-19 shots, has already announced plans to temporarily halve output of the AstraZeneca drug until more orders came, including possibly through boosters.

"All over the world, there is enough supply but it is getting the jabs in arms, which will take some time," SII Chief Executive Adar Poonawalla told a virtual conference organised by the Confederation of India Industry.

'Certain countries have only vaccinated to the tune of 10 or 15% of the population, they really need to go to 60-70%. Demand is very much there, but it's going to be spread out now that the supply has superseded the monthly demand.'

Top Indian health official Vinod Kumar Paul told the same event that current global Covid-19 vaccine production was enough to Vaccine

reach the nearly 3.6 billion who

have yet to receive a shot. "India is in a position to offer vaccines, but is there traction (for it)?" he asked. "The debate should be how do we accelerate the delivery, raise the capacity of absorption in many countries, particularly in the African continent.'

Africa's disease control body said late last month many of its nations were struggling with vaccine logistics, as inflows increased suddenly after months of delays.

Some 8% of Africa's total population of about 1.3 billion is fully immunised. India, with the same population, has fully vaccinated 37% of them with the goal to ad-

India's vaccine demand was only about 252 million doses in the past month, against a domestic production capacity of more than 345 million a month of its three main approved shots alone.

The SII's monthly output of the AstraZeneca vaccine, which it brands Covishield, has nearly quadrupled since April to 250 million doses. The shot dominates India's immunisation programme but the company has no further orders from the government.

The COVAX platform that distributes vaccines mainly to lowincome countries has sought only

As December 9, there are 2,410 Covid-19 vaccine doses having an expiry date in December this year, the Rajya Sabha was informed Tuesday. Data on expiry of Covid-19 vaccines at private hospitals is not maintained, Minister of State for Health Bharati Pravin Pawar said in a written reply. Centrally, however, the Government of India closely monitors Covid-19 vaccine stocks in states and Union Territories so as to ensure their optimal utilization, she said

about 40 million doses of Covishield from the SII between November and December after New Delhi lifted a ban on exports.

COVAX, which has an option to buy up to 550 million Covishield doses, is no longer as reliant on the SII as it was before India abruptly stopped vaccine exports in April to inoculate its own as infections surged. Many vaccines have been approved since then.

"It is critical that if India is to remain the pharmacy to the world that it continues to supply even during difficult times," Seth Berkeley, CEO of COVAX backer Gavi, told the industry event.

New Delhi, Dec 14: The Supreme Court Tuesday allowed double lane widening for the strategic Chardham highway project in Uttarakhand, saying the recent past has thrown serious challenges to national security.

The court in the exercise of judicial review cannot second guess the infrastructural needs of the armed forces, the bench headed by Justice D Y Chandrachud said while also setting up an oversight committee headed by former Justice A K Sikri to report to it directly on the project.

In its judgment, the bench, also comprising Justices Surya Kant and Vikram Nath, clarified that the oversight committee will not undertake a fresh environment assessment The committee will receive all

support from the ministries of Defence and Road Transport, the Uttarakhand Government and all district magistrates

The top court said that there are no malafides in the application filed by the Defence ministry. The allegation that its application seeks to relitigate matters or to subvert previous orders of this court are unfounded.

TANAKPUR

As a specialised body of the government, the Defence ministry is entitled to decide operational requirements of the armed forces, including infrastructural support needed for facilitating movement of troops, it said.

'The bonafides of MoD are also evident from the fact that the issue of security concerns was raised during the discussion of HPC and finds mention in HPC report. This MoD has maintained the need for double lane roads for border security concerns.

"The appellants have referred to a statement made by Chief of Army Staff in 2019 in a media interview regarding the adequacy of infrastructure for troop movement. Board of Secondary Education (CBSE) Tuesday warned students against a fake audio circulating on social media claiming that due to an error in Class XII accountancy paper grace marks will be given to students.

"It has been brought to the notice of the board that fake reports allegedly quoting an audio message in the name of Controller of Examination, CBSE are being circulated claiming that due to an error in Class XII accountancy term-1 paper held December 13 'up to 06 grace marks will be given," the board said in an official statement. "The contents in news reports published are totally baseless and false. None of the reporters has spoken to the Controller of Examination, CBSE in this regard and the board has not taken any such decision. CBSE, therefore, warns the public not to fall prey to such unverified news in their own interest," it added. In the purported audio message, the controller was saying, "Don't worry students, if you attempt 28 to 31 questions correctly, you will score around 38 marks".

The development came a day after CBSE decided to award full marks to all students for accompanying questions of a comprehension passage which was dropped following outrage over the board allegedly supporting gender stereotyping and regressive norms. The board also announced setting up of an expert committee to strengthen and review its question paper setting process to avoid such occurrences in the future.

Guj admits more Covid deaths than official tally

Ahmedabad, Dec 14: India's western state of Gujarat has acknowledged more Covid-19 deaths than its official tally, according to a court document filed Monday, lending weight to fears that the country's actual toll was much higher than reported.

Reuters and other media have reported, based on figures collected from crematoriums and cemeteries, that during India's record second wave of cases between April and June, states including Gujarat undercounted deaths as many people died at home due to a severe shortage of hospital beds and oxygen. Gujarat, Prime Minister Narendra Modi's home state, told the Supreme Court it had received 22,557 applications as of Thursday from families of the dead seeking

40,000 and nearly half had been approved. All of them would get 50,000 rupees (\$659) each.

India has reported a total of 475,636 Covid-19 deaths, including many revised figures from states that have come under pressure from courts to accurately represent the scale of the disaster.

The main opposition Congress party said it believed the actual death toll to be still higher.

"We have been saying from the beginning that the Gujarat government has been underreporting Covid-19 cases and deaths," said Manish Doshi, chief spokesperson of Gujarat Congress, adding its surveys had shown at least 55,000 deaths. Gujarat Revenue Minister Rajendra Trivedi, whose department is paying the compensation, did not respond to requests for comment.

Top Pak LeT terrorist killed in encounter

Jammu: A top Pakistani terrorist belonging to the Lashkar-e-Taiba (LeT) was killed in an encounter with security forces in Jammu and Kashmir's Poonch district Tuesday, officials said. A search is underway to track down another terrorist, who was his accomplice, in the area, they said. The Army and police launched an operation after receiving specific intelligence inputs about the presence of armed terrorists in Behramgala area, a defence spokesperson said. In the early hours of Tuesday, a terrorist attempted to escape while firing at the security personnel, he said, adding that the troops retaliated, resulting in the encounter in which the terrorist was killed. One AK-47 rifle, four magazines, one grenade, pouches and some Indian currency were recovered from the slain terrorist who was identified as Abu Zarara, hailing from Pakistan, the spokesperson said.

New Delhi, Dec 14: Observing that fundamental rights are guaranteed to every citizen irrespective of vocation, the Supreme Court Tuesday directed the Centre, all the states and union territories to commence the process of issuing voter, Aadhaar and ration cards to sex workers and keep providing dry ration to them.

apex court, hearing a plea that has raised the problems faced by sex workers due to the COVID-19

pandemic, has been passing orders for their welfare and on September 29 last year, it had asked the Centre and others to provide dry ration to them without insisting on their identity proof.

A bench comprising justices L Nageswara Rao, BR Gavai and B V Nagarathna rued that the directions of the apex court on providing ration cards to the sex workers were passed in 2011 but

they are yet to be implemented. "The state governments and

UTs were directed to issue ration

cards and identity cards to sex workers almost a decade back and there is no reason as to why such directions are not implemented till now," the bench said.

"The fundamental rights are guaranteed to every citizen of the country irrespective of his/her vocation. There is a bounden duty on the government to provide basic amenities to the citizens of the country. The central government, state governments and other authorities are directed to commence the process of issuance of ration cards, voter ID cards and Aadhaar cards immediately," the

bench ordered. The bench directed that authorities can take assistance National AIDS Control



Organisation (NACO) and state AIDS control societies who, in turn, will prepare a list of sex workers after verifying the information provided to them by the community-based organisations. "The status report related

to issuance of ration cards, voter ID cards and Aadhaar cards to the sex workers be filed in a period of four weeks from today and in the meanwhile, state governments and UTs are directed to continue distribution of dry ration to sex workers without insisting on ration cards and other proofs of identity as mentioned in earlier

it said. The bench, which said that the copy of the order be sent to state and district legal services authorities for necessary action, also asked the government to keep the names and identity of sex worker confidential while preparing the various ID cards.

The apex court was hearing a ঽ plea filed by NGO 'Durbar Mahila Samanwaya Committee', which has highlighted the destitution faced by sex workers on account of COVID-19, and sought relief measures for over nine lakh femaleand transgender sex workers across India.





Istanbul: Four foreign children were killed and two people wounded when a fire broke out in the wee hours of Tuesday at an apartment building in Turkey's biggest city Istanbul, the Governor's office announced. The office said in a statement that the fire broke out at around 2.50 a.m. local time (2350 GMT on Monday) in the basement of a five-story building in the Esenyurt district located on the European side of the city. Xinhua news agency reported.

Five dead

Dhaka: At least five people were killed Tuesday after a fire ripped through a factory in Bangladesh's Bogura district, some 197 km northwest of Dhaka. The blaze was brought under control after hectic efforts of about three hours, reports Xinhua news agency. Rafi Al Faruk, duty officer of the Fire Service and Civil Defense Headquarters in Dhak the fire sparked suddenly and spread quickly.

Toll rises to 10

Rio De Janeiro: Rescue teams have raised the death toll from heavy rains and flooding in the Brazilian state of Bahia to 10. The floods forced nearly 20,000 people to move out from their homes, according to the regional Civil Defence agency, with 51 cities having declared a state of emergency, Xinhua news agency reported.

Nine killed

Dar Es Salaam: At least nine people died on the spot and three were seriously injured after a van ferrying newspapers hit a tree in Tanzania's southern highlands region of Iringa, the police said. Allan Bukumbi, the Iringa regional Police Commander, said the accident occurred in Mahenge village in Kilolo district along the Dar es Salaam-Mbeya highway on early Monday morning when the van hit the tree after its driver had failed to negotiate a sharp corner.

Abduction foiled

Wajir (Kenya): Kenyan police has foiled an attempt by suspected al-Shabab militants to abduct faithful at a mosque in Konton, Waiir County, in the northeastern border region. Waiir County Police Commander Hilary Toroitich said a gang of about five had raided a local mosque and taken hostage about 40 faithful who were present, Xinhua news agency reported. Toroitich added that the militants suspected to have crossed from neighbouring Somalia ordered the faithful out and tried to drive them into a thicket heading to the nearby Kenya-Somalia border.

Blinken vows more US military might in Indo-Pacific Over 50 killed in

Jakarta, Dec 14: The United States will expand its military and economic relationships with partners in Asia to push back against China's increasing assertiveness in the Indo-Pacific, US Secretary of State Antony Blinken said Tuesday.

Blinken said the Biden administration is committed to maintaining peace and prosperity in the region and will do that by boosting U.S. alliances, forging new relationships and ensuring that the US military maintains "its competitive edge.

'Threats are evolving, our security approach has to evolve with them. To do that, we will lean on our greatest strength: our alliances and partnerships, Blinken said in a speech in Indonesia, outlining the administration's Indo-Pacific plans. "We'll adopt a strategy that more closely weaves together all our instruments of national power - diplomacy, military, intelligence — with those of our allies and partners." he said. That will include linking U.S. And Asian defense industries, integrating supply chains and cooperating on technological innovation, he said.

Later he signed a series of three agreements with Indonesia's foreign minister, including one that extends until 2026 an existing maritime cooperation pact that among other issues calls for enhanced joint U.S.-Indonesian naval exercises.

Blinken insisted that the US is not trying to force countries to choose between the United States and China, or seeking conflict with China. But he laid out a litany of complaints about "Beijing's aggressive actions" from "Northeast Asia to Southeast Asia and from the Mekong River

to the Pacific Islands. At a daily briefing, Chinese Foreign Ministry spokesperson Wang Wenbin said Blinken's latest comments showed the US was contradicting itself by "playing up the so-called China threat on the one hand while claiming that it has no intention to seek conflict with China on the other."

Wang criticised the US for "frequently sending ships and aircraft to the area to flex muscles and stir up trouble." Blinken is in Indonesia on the first leg of a week-long, three-nation tour of Southeast Asia that will also take him to Malaysia and Thailand. Countering China's growing aggressiveness in the region, particularly in the South China Sea, in Hong Kong and against Taiwan is prominent on his agenda.

Countries across the region want this behaviour to change, he said. "We do too." "We are determined to ensure freedom of navigation in the South China Sea," he said. "It is also why we have an abiding interest in peace and stability in the Taiwan Strait." Blinken said the U.S. "will forge stronger connections" with its five treaty allies in the region — Australia, Japan, the Philippines, South Korea and Thailand boost ties between them and cultivate a stronger partnership with the Association of Southeast Asian Nations, many of whose members feel threatened by China.

"A strong and independent ASEAN has long been central to tackle urgent crises and longterm challenges," Blinken said, in particular calling out the military rulers of Myanmar, also known as Burma, for their February takeover and subsequent crackdown on protesters.

"We will continue to work with our allies and partners to press the regime to cease its indiscriminate violence, release all of those unjustly detained, allow unhindered access, and restore Burma's path to inclusive democracy," he

Haiti explosion

Port-Au-Prince (Haiti), Dec 14: A truck carrying gasoline exploded in northern Haiti, killing more than 50 people and injuring dozens of others, officials said Tuesday.

The blast occurred late Monday in the city of Cap-Haitien, Prime Minister Ariel Henry said, adding that he was devastated. "Three days of national mourning will be decreed throughout the territory, in memory of the victims of this tragedy that the entire Haitian nation is grieving," he tweeted. Henry said his administration

was deploying field hospitals to the area to help those affected. Dozens of bodies lay on the street hours after the explosion as a small crowd stood around them.

No further details were immediately available. Police didn't immediately return calls requesting information. Patrick Almonor, deputy mayor of Cap-Haitien, told The Associated Press that at least 53 deaths and more than 100 injured have been reported following the explosion that burned around 20 homes near the site. He said he expects the number of deaths to keep rising because people who died in their homes have not yet been counted

"It's horrible what happened," he said. "We lost so many lives." Almonor said a local hospital is in dire need of more nurses, doctors and basic medical supplies to help those injured. "We are over-

whelmed," a person identified as Dr. Calhil Turenne told Le Nouvelliste newspaper.

Dave Larose, a civil engineer who works in Cap-Haitien, told The Associated Press that he was driving when he saw ambulances and a crowd of people gathered along a road around 1 a.m.

He said he observed how some people were using buckets to scoop up gasoline from the truck and the street to take back to their house. The explosion occurred as Haiti struggles with a severe shortage of fuel and spiraling gas prices. "It's terrible what our country has to go through" Larose said. Former Prime Minister Claude Joseph also mourned the victims, tweeting, "I share the pain and sorrow of all the people.

Indonesia lifts tsunami alert

Jakarta, Dec 14: Indonesia lifted a tsunami alert Tuesday following a magnitude 7.3 undersea earthquake that struck off Flores Island, triggering panic in a region prone to fatal quakes but apparently causing no major damage or casualties.

According to the US Geological Survey, the quake hit at a depth of 18.5 kilometers (11.5 miles) under the sea, and was located 112 kilometers (74 miles) north of the town of Maumere, the second-largest on the island in East Nusa Tenggara province with a population of 85,000.


After an initial tsunami alert, the Pacific Tsunami Warning Center in Hawaii and later Indonesia's meteorological agency lifted the warning hours after the quake. National Disaster Mitigation Agency spokesperson Abdul Muhari said residents in East Flores district felt the earthquake strongly. Footage showed people running away from buildings that shook from the impact.

Manila, Dec 14: Philippine President Rodrigo Duterte Tuesday withdrew his senatorial candidacy in next year's elections in his latest change of mind over what he plans to do after his turbulent term ends, when critics say he would likely face an array of lawsuits for an anti-drugs crackdown that has left thousands of mostly petty suspects killed.

Accompanied by his executive secretary and security escorts, the 76-

year-old Duterte went to the Commission on Elections in Manila and withdrew as a senatorial candidate. His former aide, Sen. Bong Go, separately appeared at the elections commission earlier Tuesday to withdraw his presidential candidacy,

which he said his family opposed. Duterte did not give any reason for the move but his spokesman, Karlo Nograles, said it would allow the president to better focus on managing the pandemic in the country and ensuring that the May elec-



tions would be peaceful and orderly. Known for his extra tough approach to criminality, Duterte

launched a police-enforced campaign against illegal drugs when he took office in June 2016. The crackdown has left more than 6,000 mostly petty suspects dead based on police figures. Manila-based analyst Richard Heydarian, however, said Duterte's latest move showed how the president, who faces potential criminal suits after his presidency for his deadly anti-drugs campaign, seemed to have lost his political footing after his plan to ensure a friendly succession next year caved in.

Canada apologises for sexual misconduct in military

Toronto, Dec 14: Canada's Indianorigin Defence Minister Anita Anand and the top military commander have tendered a longawaited apology to current and former members of the Canadian Armed Forces who suffered sexual assault, sexual harassment or discrimination.

The Canadian Armed Forces are trying to turn over a new leaf and win back the trust of current and former members who suffered sexual assault, sexual harassment or discrimination based on sex, gender, gender identity or sexual orientation, the Georgia Straight

The long-awaited and historymaking apology to the women and men whose lives were scarred by sexual assault, misconduct and discrimination in the military was delivered by Defence Minister Anand, Chief of Staff General Wayne Eyre and deputy defence minister Jody Thomas on the government's behalf, CBC News reported. The official apology was live streamed within the Department of National Defence and on Facebook.

Mayfield (US), Dec 14: Workers, volunteers and members of the National Guard were spreading across tornado-damaged areas of Kentucky to assist with recovery tasks ranging from replacing thousands of damaged utility poles to delivering bottles of drinking water.

The tornado outbreak Friday that killed at least 88 people in five states — 74 of them in Kentucky cut a path of damage that stretched from Arkansas, where a nursing home was destroyed, to Illinois, where an Amazon distribution center was heavily damaged.

In Kentucky, Gov. Andy Beshear said the toll could grow as authorities continued to work around debris that slowed recovery efforts. Nearly 450 National Guard members have been mobilized in the state, and 95 of them are doing fatality searches.

With this amount of damage and rubble, it may be a week or even more before we have a final count on the number of lost lives, the governor said. Kentucky authorities said the sheer level of destruction was hindering their ability to tally the damage As searches continued for those

still missing, efforts also turned to repairing the power grid, sheltering those whose homes were destroyed and delivering supplies. A fund set up by the state has collected USD 6 million in donations. according to the governor. Kentucky First Lady Britainy Beshear has launched a Christmas toy drive for children affected by the storm. She is asking for unwrapped toys, books, and gift cards of USD 25 that will be distributed to families

17,000 are under boil-water advisories, Kentucky Emergency Management Director Michael Dossett told reporters. State and

local officials said it could take years for some of the hardest-hit areas to fully recover.

"This again is not going to be a week or a month operation, folks. This will go on for years to come. This is a massive event," Dossett said. Five twisters hit Kentucky in all, including one with an extraordinarily long path of about 200 miles (320 kilometers), authorities said.

In addition to the deaths in Kentucky, the tornadoes also killed at least six people in Illinois, where the Amazon distribution center in Edwardsville was hit; four in Tennessee; two in Arkansas, where the nursing home was destroyed and the governor said workers shielded residents with their own bodies: and two in Missouri.

The federal Occupational Safety and Health Administration announced Monday that it has opened an investigation into the collapse of the Amazon warehouse in Illinois.

Mayfield, home to 10,000, suffered some of the worst damage. Debris from destroyed buildings and shredded trees covered the ground in the city. Twisted sheet metal, downed power lines and wrecked vehicles lined the streets Windows were blown out and roofs torn off the buildings that were still standing.

Not far from Mayfield, a church serving as a shelter in Wingo said it expected to host more than 100 people Monday night. Glynda Glover, 82, said she had no idea how long she would stay at the Wingo shelter. Her apartment is uninhabitable since the wind blewout the windows and covered her bed in glass and asphalt.

Nov WPI inflation hits a record of 14.23% y-o-y

WPI inflation has remained in double digits for eight consecutive months beginning April

New Delhi, Dec 14: The wholesale price-based inflation surged to more than a decade high of 14.23 per cent in November, mainly due to hardening of prices of mineral oils, basic metals, crude petroleum and natural gas.

WPI inflation has remained in double digits for eight consecutive months beginning April.

Inflation in October this year was at 12.54 per cent, while in November 2020 it was at 2.29 per cent. The 12-year high inflation print in November is due to low base effect and spike in the fuel index.

"The high rate of inflation in November 2021, is primarily due to rise in prices of mineral oils, basic metals, crude petroleum & natural gas, chemicals and chemical products, food products etc as compared to the corresponding month of the previous year," the Commerce and Industry Ministry said in a statement Tuesday.

Inflation in fuel and power basket was higher at 39.81 per cent in November, as against 37.18 per cent in October. The food index more than doubled to 6.70 per cent as compared to 3.06 per cent in the previous month

Crude petroleum inflation was at 91.74 per cent during the month under review, as against 80.57 per cent in October. However, manufactured items saw moderation at 11.92 per cent, from



12.04 per cent in October.

According to a senior Commerce and Industry ministry official, fuel and power have been the biggest contributors of higher inflation rate as it is almost 40 per cent higher than November 2020.

The international commodity prices and fuel prices have also been very high.

Countries which traditionally have reported low inflation rates like the US have also now reported record inflation levels due to these global effects, the official said, adding, countries like Italy, Spain, Germany and even Singapore are having around 20 per cent inflation.

Primary articles and manufacturing products were barely touch-

ing double digits in spite of low base effects showing the efforts of Indian manufacturers, producers and industry, the official added.

Terming the spike in the WPI inflation to a high of 14.2 per cent as a shock, ICRA Chief Economist Aditi Navar said most non-core categories have exhibited an inflation rate much steeper than expected. The unseasonal surge in vegetable prices, as well as a rise in the inflation for egg, meat and fish, and condiments and spices underpinned the turnaround in the primary food inflation to a 13month high of 4.9 per cent in November 2021, from a disinflation of 1.7 per cent in the previous month, she said

ADB scales down growth estimate to 9.7 pc in FY22

New Delhi, Dec 14: The Asian Development Bank for the second time in three months has scaled down India's growth estimate for the fiscal year ending March 2022 due to supply chain issue of industries.

The Manila-based multilateral development bank pegged India's growth estimate at 9.7 per cent for the current fiscal year in its latest supplement. The ADB had projected a growth rate of 10 per cent for FY22 in its September supple-

In a supplement to the Asian Development Outlook (ADO) 2021, it said South Asia is forecast to grow at 8.6 per cent in 2021, compared with the September's forecast of 8.8 per cent.

"India, South Asia's largest economy, is now expected to grow 9.7 per cent in fiscal year (FY) 2021, which ends 31 March 2022. The reduction of 0.3 percentage points comes amid supply chain issues that are affecting industry. India's outlook for FY2022 is maintained at 7.5 per cent, as domestic demand is expected to normalize," as per the ADB supplement.



In September, it had revised down India's economic growth forecast for the current fiscal to 10 per cent, from 11 per cent predicted earlier, citing the adverse impact of the second wave of the pandemic.

The Ministry of Lab Employment has apprised that **Employees Provident Fund** Organisation (EPFO) has invested ₹2,500 crore in Reliance Capital Ltd (RCL), for which RCL has defaulted in payment of interest from October 2019, Minister of State for Finance Bhagwat Karad said in a written reply to the Rajya Sabha.

He was replying to a query asked by Member of Parliament from RJD, Manoj Kumar Jha, whether it was a fact that Reliance Capital had defaulted on payment of principal and interest obligations on bonds held by EPFO.

The total interest default on the non-convertible debentures (NCDs) (secured) is ₹534.64 crore as of November 30, 2021, Karad said.

Ministry of Labour and Employment has informed that as the maturity date of these in-

vestment has not become due till date, there is no default on principal as on date, he said.

'The matter for initiation of action under the provisions of the Insolvency and Bankruptcy Code, 2016 (IBC), against Reliance Capital Ltd was taken up by EPFO," Karad Citing action taken by the RBI,

the minister informed the house that the apex bank superseded the board of directors of the company on November 29, 2011. It (RBI) has filed an application

on December 2, 2021 for initiation of corporate insolvency resolution process (CIRP) against Reliance Capital at the Mumbai branch of the National Company Law Tribunal (NCLT).

"As per the section 12(3) of IBC. CIRP needs to be mandatorily completed within a period of three hundred and thirty days from the insolvency commencement date,' the minister said further.

Earlier this month, the company asked its creditors to submit their claims with proof by December 20 following initiation of corporate insolvency process against it.

GAIL looks to bring India's first electrolyser

New Delhi, Dec 14: State-owned GAIL India Ltd plans to import India's first and the largest to date electrolyser for producing green hydrogen within a year and may look to hire another ship to ferry LNG from the US, officials said

GAIL chairman and managing director Manoj Jain said his company had launched a global tender to procure a 10-megawatt electrolyser capable of producing 4.5 tonnes per day of hydrogen.

Delivery of the electrolyser may happen in 12 to 14 months. "Not just imports, we are also

looking at domestic manufacturing of electrolyser. Our tender gives preference to domestic manufacturers," he said. The company will install the

electrolyser at one of its gas processing plants in the country. While the firm was initially look-



stock for producing what is known as blue hydrogen, it may look at using renewable energy to split water to produce oxygen and green

or green hydrogen is similar, the former has a carbon dioxide byproduct and the latter is emission-free fuel

Jain said the hydrogen so produced can be sold to users such as fertiliser plants or mixed in CNG for sale to automobiles, helping cut

The largest electrolyser currently announced in India is a 5-MW unit being installed by India's largest power utility NTPC at Vindhyachal in Uttar Pradesh.

NTPC intends to power the electrolyser using a coal-fired superthermal power station, in concert with carbon capture. Renewable electricity may potentially be used in the future, which would make it emissionsfree, but no date has been set for when that could occur.

Separately, GAIL Director (Finance) R K Jain said the company may look to hire a second LNG ship to ferry fuel from the US. The company in February this year hired from Japanese shipping major Mitsui O.S.K. Lines a 180,000 cubic meters vessel for five years and named it GAIL Bhuwan. This vessel was used to transport LNG from the US to Dabhol in Maharashtra earlier this month. GAIL has contracts for procur-

risk of further infection among players and staff. The league wishes a quick recovery to those players and staff with COVID-19.3

The first game to be called off this season due to coronavirus cases was Tottenham's trip to Brighton last Sunday due to at least eight players at the north London club contracting COVID-19. Norwich and Aston Villa have also reported coronavirus cases at their clubs.

They come amid growing concerns in Britain about the spread of the omicron variant, which has led to the reintroduction of some coronavirus restrictions.

The Premier League has emulated national regulations by asking for face masks to be worn again around clubs, while going further than the government by reintroducing social distancing. The frequency of testing on players and staff will also increase. "The safety of everybody is a

priority and the Premier League is taking all precautionary steps in light of the recent rise in COVID-19 cases across the country," the competition said in a statement.

'We will continue to work closely with the government, local authorities and supporter groups, while being responsive to any future changes to national or local guidance.'

The government's appeal for people to get booster vaccines against the coronavirus was backed Monday by Manchester City manager Pep Guardiola, who urged his staff and players to get jabbed.

The league last provided details on vaccinations in October when it said only 68 per cent of players had been jabbed twice and 81per cent had received at least one dose.

The Premier League has avoided a shutdown since the 100-day pause in the season from the start of the pandemic in March 2020. The 40 positive cases at the turn of 2021 was the previous highest number of infections at Premier League clubs in a week since testing started to be announced in May 2020.
