US imposes sanctions on China

Washington: The Biden administration said Thursday it is imposing new sanctions on several Chinese biotech and surveillance companies for actions in Xinjiang province, the latest step against Beijing over human rights abuses of Uyghur Muslims in the country's western region. The Commerce Department is targeting China's Academy of Military Medical Sciences and its 11 research institutes that focus on using biotechnology to support the Chinese military. The Treasury Department is also set to issue penalties against several Chinese entities, according to a MORE P10 senior Biden administration official.



NIA GRILLS TOP MAOIST LEADER

Bhubaneswar, Dec 16: A twomember team of the National Investigation Agency (NIA) Thursday grilled dreaded Maoist leader, Dubashi Sankar in the special jail at Jharpada here for several hours over the Improvised Explosive Device (IED) blast and ambush on security personnel in Chitrakonda area of Malkangiri district in 2012. Four BSF persons died while several others sustained serious injuries in the blast and subsequent firing. The NIA later took over the investigation of the incident from the local police.



The Odisha police and BSF during a joint operation September 13 in Boipariguda area of Koraput district arrested Sankar who was carrying a bounty of ₹20 lakh on his head. Following his arrest, a NIA team from Kolkata reached Jeypore and sought permission of the SDJM court to interrogate Sankar. The court December 13, gave permission to the NIA to do so. Subsequently, Sankar was brought to Jharpada prison from Koraput circle jail on the same day.

The NIA team grilled the Maoist leader for several hours till 5.00pm.

COURT DIKTAT ON LIVE-IN RELATION

Chandigarh: The Punjab and Haryana High Court has observed that merely because two adults are living together for a few days, their claim of a livein relationship based upon a 'bald averment' may not be enough to hold that they are truly in a live-in-relationship. Justice Manoj Bajaj observed this while dismissing the plea of a couple of Haryana's Yamunanagar district seeking protection from the family members of the woman. "Merely because the two adults are living together for a few days, their claim of live-in-relationship based upon bald averment may not be enough to hold that they are truly in live-in-relationship," the court said in its November 26 order.

6,131 teachers appointed

Bhubaneswar, Dec 16: In a major development, the Odisha government appointed Thursday 6.131 teachers in various schools across the state. Chief Minister Naveen Patnaik distributed appointment letters to all the teachers at an orientation programme held at the Kalinga Stadium here. The appointment of new teachers took place just days after the successful completion of the first phase of the 5T High School Transformation programme implemented in 1,075 institutions.

Addressing the orientation programme for the newly-recruited teachers, the chief minister said education is a reflection of the collective hopes and aspirations of the society. He further said that teachers play a vital role in instilling new hopes in students, empowering their imagination and engaging in learning.

Patnaik urged teachers to work for development of creativity and confidence in students. "Education is a process where teachers play the role of real capitalist to build the future of society. Keeping this in mind, my government has put the spotlight on transformation of education in Odisha," Patnaik stated. Under the 5T High School





Bhubaneswar, Dec 16: Chief Minister Naveen Patnaik inaugurated Thursday five sports infrastructure projects and laid the foundation stones for 89 multi-purpose indoor stadiums during a programme at the Kalinga Stadium here. Patnaik inaugurated the Biju Patnaik Weightlifting Hall and a new sports hostel. He also declared open a swimming pool each in Angul and Baripada and an indoor stadium in Rourkela.

Officials said land for all the 89 stadiums have been identified. The tender process to build infrastructure on 87 locations has been initiated and work is expected to start soon. The stadiums are expected to be ready for use in 2022-23. The



multi-purpose indoor stadiums will have facilities for badminton, table tennis and weightlifting. They can also be used as disaster shelters and hospitals, official said.

The newly-inaugurated weightlifting hall at the Kalinga Stadium here will certainly be a huge boost to young lifters in the state, opined officials. The new sports hostel will give a 'feeling of home' to its residents and will enable them to concentrate on their respective disciplines, offi-

cials informed.

The Olympics-type swimming pools in Angul and Baripada will be run by professional instructors with life guards also present. The pools will be used to develop local talent and also benefit local community. The indoor stadium will stand out as a milestone for Rourkela and development hub for shuttlers of that region.

During his visit to the Kalinga Stadium, the CM reviewed the progress of the ongoing projects within it, particularly the indoor aquatic centre. Once completed, the centre will be huge boon for swim mers. Patnaik also reviewed the work on the indoor athletics stadium, the first of its kind in the country. Officials said almost all the projects will be completed within a year.

"These are landmark sports infrastructure which will make Kalinga Stadium as the leading destination in India," Patnaik said expressing satisfaction at the work in progress.

No home isolation for Omicron patients

Bhubaneswar, Dec 16: With new cases of the Omicron variant of Covid-19 emerging in both the neighbouring states of West Bengal and Andhra Pradesh, the Odisha government is on a high alert and is keeping a close watch on the situation. Health Director of the Odisha government, Niranjan Mishra said Thursday that the Omicron variant is five times more transmissible than Delta.

"Steps will be taken to ensure that Omicron variant infected patients will not come in contact with other unwell persons at the health facilities,' Mishra added.

Mishra also said that a strict surveillance is being kept on the visitors coming to Odisha. Foreign returnees from 'at risk' and other countries are being monitored closely. "As Omicron is five times more transmissible than the Delta variant, infected persons will not be allowed home isolation. They willhave to stay in the hospitals designated for them," Mishra informed.

Mumbai, Dec 16: In a dramatic development in the Sheena Bora murder case, allegedly accused mom Indrani Mukherjea has claimed that her daughter is alive, her lawyer Sana Khan said Thursday. She informed that Indrani has written to the CBI last month, asking the agency to look for Sheena in Kashmir. This latest development has added a bizarre twist to the sensational case. In the letter, Indrani claimed

that a woman told her that she had seen Sheena while on vacation in Srinagar. "She wrote to the CBI, we have no details of what she wrote,' said Sana Thursday. Sana added that she will move a formal application for bail when the matter comes up for hearing in the special CBI court here December 28. Indrani has been lodged in the Byculla Women's prison here since 2015 as the main accused in Sheena's murder case.

Sheena (24) was allegedly strangled in a car by Indrani, her then driver Shyamvar Rai and her former

husband Sanjeev Khanna in April 2012. As per the CBI, Indrani disapproved of Sheena's relationship with Rahul Mukerjea, son of former

Sheena's body was allegedly burnt in a forest in neighbouring Raigad district. The murder came to light in 2015 when Shyamvar spilled the beans when questioned by police in another case

After the murder, Indrani allegedly told everyone that Sheena had moved to the US. Based on the driver's statement, police dug up Sheena's half-burnt body from a forest near Mumbai.

Investigators are not taking Indrani's latest claim too seriously, sources say. Some of them on condition of anonymity said that this may be the latest ploy by Indrani to get the sympathy of the judge and get bail.



Alongside Covid-19 pandemic, rising fuel prices upset every Indian household's budget in the outgoing year. Coming on top of thinning out of personal incomes, prohibitive fuel prices kept people on a low. Diesel rates skyrocketed as high as over 30 per cent in one single year while petrol went past a prohibitive `110 per litre. As if this was not enough, the govt kept jacking up cooking gas prices. Pump prices of petrol, diesel along with domestic and commercial LPG prices broke all records. The rates relentlessly went up through most part of the year. There was hardly any slide. **Barring short intervals of pause** necessitated by state polls, fuel continued to burn a hole in everybody's pocket right through the year. A steep cut in excise rate by the Centre and a relatively small cut in VAT by the state

government even failed to assuage the burning tempers of people.

DIESEL, PETROL AND LPG PRICES WENT THROUGH THE ROOF IN 2021

he total increase in petrol and diesel prices added up to ₹36 per litre and ₹26.58 per litre since early May 2020 when taxes on the two fuels were raised to record levels. The spike followed the hike in international oil prices. But the government had skimmed the steep fall in crude prices when they had dropped to 20 dollar a barrel. Petrol went over ₹110-a-litre-mark in all major cities, while diesel crossed ₹100a-litre in more than a dozen states including in Odisha.

Even though both the Centre and the state government together reduced a combined tax load of ₹14 on diesel and ₹9 on petrol in November 2021, petrol today still costs ₹102 per litre (Dec 15, 2021) as against ₹85 (Dec 14, 2020). Similarly, diesel costs ₹92 per litre (Dec 15, 2021) as against ₹75 per litre (Dec 14, 2020). The

total increase in petrol price since May 5, 2020 when the government had raised the excise duty to record levels now works out to ₹35.98 per litre while diesel rates during this period went up by ₹26.58 per litre.

The government had raised excise duty on petrol and diesel to mop up gains that would have otherwise accrued to consumers from international oil prices crashing to as low as USD 19 per barrel. The price onslaught on consumers when they were already suffering from job loss and a sudden contraction in incomes was uncalled for. The increase in fuel

called for. The increase in fuel prices pushed inflation levels as diesel is the mainstay fuel used for transporting goods, including agriculture commodities. Opposition parties including the Congress have been critical of the government over the price hikes and have been demanding


e a further reduction in taxes.

Bowing to sustained pressure from the opposition and electoral compulsions, the Centre November 3, on the eve of Diwali, announced a reduction in the excise duty levied on petrol and diesel. While the excise duty on per litre of petrol was reduced by ₹5, the same has been brought down on diesel by ₹10. The reduction in excise duty is higher on diesel due to its wide usage in the agriculture sector.

The state governments took a cue from the Centre and cut the sales tax (VAT) on fuel by up to ₹5 per litre. Hence, a ₹5 cut in excise duty on petrol and ₹10 on diesel would lead to a revenue loss of around ₹2.10 lakh crore for the Centre.

Bhubaneswar, Dec 16: Following a resolution adopted by Odisha Assembly, Tourism and Culture Minister Jyoti Prakash Panigrahi has written to his Central counterpart. G Kishan Reddy to declare Paika Bidroha as the first war of Indian independence.

Referring Chief Minister's earlier letter. Panigrahi said the rebellion of 1817 took place 40 years before the Sepoy Mutiny of 1857 which is known as the first Indian war of Indian Independence.

It was such an organised and well-structured rebellion that it

posed a serious threat to the authority of the East India Company in this part of the country, he said. The connecting threads that link

the entire journey of Indian Independence Movement cannot miss the visible impact of Paika Rebellion both in form and content. It was a rebellion in which all sections of the society - the

Paikas, Zamindars, Malangis (manufactures of salt), ordinary peasants and tribals (Kondhs. Chohars) participated, he informed in the letter. "The Paika Rebellion represents the emergence of an organised rebellion against the British Rule. It played the role of a torch-bearer and catalyst in shaping people's movement of resistance, which ultimately led to the Indian Independence Movement," he said.

Panigrahi also said that it cannot be called a war of resistance because it was a complete war of Independence against the British regime.

A resolution in this context has been adopted unanimously in the meeting of the Odisha Legislative Assembly held December 7, 2021 to recommend the Centre to consider the proposal positively.



B. Demand Charge:

Demand Charge @ Rs.250 KVA/Month is proposed to be levied from DISCOM Utilities on the excess SMD only when the actual SMD of DISCOM Utilities in a month exceeds the permitted monthly SMD (110% of the approved SMD), to take care of monthly variations subject to year-end adjustment within the permitted annual SMD i.e.110% of the approved annual SMD.

C. Over Drawal and Year End Charges:

The Over Drawal and Year End Charges payable by DISCOM Utilities are presently billed at the corresponding OERC approved applicable BSP in terms of the Judgment dated 07.05.2018 of the APTEL passed in Appeal No.55 of 2015, till intra-State DSM Regulations is pronounced by OERC and implemented in the State. GRIDCO proposes that any excess drawal of energy by a DISCOM Utility during a month over and above the approved energy quantum (Approved MU for FY 2022-23 X No. of days of the relevant month / 365 days) would be payable on provisional basis at the highest OERC approved Power Purchases Rate fixed for a Station for FY 2022-23 (which includes transmission charges and transmission loss) on monthly basis instead of the normal differential BSP applicable to the respective DISCOM Utilities, subject to final Year End Adjustment (YEA) considering the highest Power Purchases rate/ cost including the rate/s of energy drawn through U.I./deviation settlement of the month plus transmission charges and transmission loss.

D. Fuel Price Adjustment :

Fuel Price Adjustment (FPA) mechanism needs to ensure timely recovery of changes on account of fuel cost which is an uncontrollable expense. Ex-post facto approval is provided on quarterly basis by MERC, Maharashtra allowing monthly adjustment of tariff to account for FPA. Some other States also determine the fuel price adjustment on guarterly basis. In Gujarat, FPA upto 10 paise/unit is allowed to be levied without any prior approval of GERC. GRIDCO requests the Commission to provide a mechanism for monthly or quarterly determination of FPA component which can be recovered through tariff as per the practices followed in other States.

E. Rebate:

At present, GRIDCO is raising the BSP bill for a particular month during the 1st week of the subsequent month. The due date for payment of retail supply bill by different category of consumers to DISCOM Utilities is presently kept at seven days and rebate is allowed for payment made by the consumer within three working days. As such, DISCOMs are collecting the revenue from different category of consumers by end of the month of billing itself. In view of above, the BSP bill of GRIDCO needs to be settled by the end of the month of billing itself. Hence, due date of bill may be kept at 25 days from the date of presentation of bill.

GRIDCO states that the maximum rebate to be allowed to DISCOMs needs to be in line with the maximum rebate allowed to GRIDCO by the Generators under prevailing CERC / OERC Terms & Conditions of Tariff Regulations. Accordingly, GRIDCO proposes the following graded rebate for payment of BSP dues by the DISCOM Utilities:

a. For crediting the BSP bill of the DISCOM to GRIDCO's designated current bank account through Letter of Credit on presentation or through NEFT/RTGS within a period of five (5) working days, a rebate of 1.5 % shall be allowed

b. Where the amount is credited on any day after five (5) working days and within a period of twenty five (25) days of presentation of bill, a rebate of 1.00% shall be allowed.

c. The DISCOMs may pay their BSP dues in staggered manner under different rebate option, but for eligibility of rebate, total current BSP dues needs to be settled by the DISCOM within 25th day of presentation of BSP bill.

Delayed Payment Surcharge:

For delayed payment of Bulk Power Supply Bills i.e., payment after the periods of 30 days from the date of submission of bills, the surcharge is to be levied @ 1.50% per month.

G. Duty and Taxes:

The Electricity Duty levied by the Government of Odisha and any other statutory levy/ Duty/ Tax/ Cess / Toll etc. imposed under any law from time to time shall be charged over and above the Bulk Supply Price.

The Legal Gift

The Christmas shopping season is upon us. Whether one is a believer or not it is almost impossible to resist the lure to shop and give gifts at this time of the year. But the biggest gift givers are inanimate creatures without any capacity to believe anything. I am referring not to artificial intelligence but to the legal persons known as ordinary corporations.

Corporations are currently doling out millions, if not billions, of dollars in year-end gifts. In the financial sector, bonuses are up 20-35% compared to last year, representing a merry-go-round that puts several hundred thousand dollars, on average, into the pockets of every recipient. Yet while the amount of these gifts is sizeable, the greatest gift that a corporation can bestow is legal. By securing a new corporate charter, corporations can give their investors everything on their wish lists.

Royal Dutch Shell is only the latest corporation making headlines for gifting a new charter to its shareholders, by moving its headquarters from The Hague to London. The company will ditch its royal title in return for extra cash for its shareholders. Two other Dutch corporations, Unilever and RELX (Elsevier), have already made similar moves. And, more generally, many merger transactions are, in fact, thinly disguised bargains for reaping the benefits of a different legal order.

Where does the extra money for Shell's shareholders come from? A possible source is the new legal and regulatory environment. The fact that shareholder protections in the United Kingdom are stronger than those in the Netherlands arguably could give the company a boost. After all, past research on law and finance suggests that countries with better shareholder protection tend to have more developed financial markets.

But extending this argument specifically to Shell's move raises several objections. At the level of an individual company, there simply are too many

variables in play for corporate governance to have a large effect on the outcome. Moreover, when applying the standard measure for the quality of corporate law - the (corrected) Antidirector Rights Index – the difference between Dutch and English law is not all that great.

The real benefit for shareholders is not governance but cash, which is determined by the prevailing tax law. The Netherlands taxes both dividends and share buybacks at 15%, whereas UK tax law makes it possible to exempt buybacks, provided that a firm has a good tax lawyer on its side.

For Shell and other major polluters that are just beginning the process of shifting from oil and coal to cleaner energy sources, keeping shareholders happy ultimately is more important than achieving a successful transition. As the Financial Times reports, energy executives and investors have come to a "quiet understanding... As companies invest less in oil, more money should flow back to shareholders when energy prices are high."

Moreover, Shell is using its exit from the Netherlands to put some distance between it and the Dutch courts, which reprimanded the company twice in the past year for failing to meet legally required climate commitments that were

touted by the company's own public relations materials. So much for the idea that the private sector will lead the transition to a green economy.

Where does this leave us? In short, polluters plan to butter up their shareholders with handouts and tax-avoidance schemes while their customers foot the bill for the energy transition, and while governments deal with the political fallout. Worse, the gift being lavished on shareholders is not a return on an especially good investment, nor does it bespeak some breakthrough in the energy transition. Rather, it reflects the cash-value of a legal arbitrage scheme that is designed to circumvent the laws of a democratic country the same laws that breathe life into legal creatures like Shell and every other corporation in the first place.

Given their legal pedigree, it is perhaps not surprising that corporations prefer to treat law like just another asset that can be exploited for profit. They routinely hunt for cheaper supplies and outsource production to countries with lower labor costs and weaker worker protections, so why not shop around for law as well? Legal arbitrage is often rationalised as a form of healthy competition that will push lawmakers to write optimal rules. But for whom should the law be optimised? Obviously, shareholders would prefer zero taxes, and polluters would prefer zero emissions standards. The tens of millions of people who are worried about their children's future on a warming planet may have different preferences. hen I first began visiting Barcelona in the early 2000s, it was a dazzling metropolis-optimistic, lively, progressive, and teeming with young people from all over Europe. It balanced its Catalan pride with openness to the world. The 2002 film 'The Spanish Apartment', a comedy about a group of exchange students in Barcelona, showed why it was considered the unofficial capital of Mediterranean Europe.

Unfortunately, in the years since, Barcelona has become a victim of its own success. But the COVID-19 pandemic might open new avenues for its future.

It wouldn't be the first time Barcelona has rebounded. During Francisco Franco's dictatorship, it was considered a gray place that repressed both its natural beauty and its civic life. After Spain's transition to democracy, Barcelona seized the opportunity to be reborn. Many say the turning point was the 1992 Olympic Games, which savvy local administrators leveraged to showcase the city internationally and transform it into an urban heavyweight. With a limited budget, Mayor

Pasqual Maragall capitalised on the Olympics to begin one of the most successful urban redevelopments in late twentieth-century Europe. He enlisted the help of top local and international design professionals to create a municipal plan that ensured the city would benefit from the legacy of the Games long after they ended.

Beyond constructing sports facilities, the plan tackled two of Barcelona's most profound urban challenges: its waterfront and its public spaces. The waterfront had long been cut off from the rest of the city due to myopic infrastructural and industrial development. Today, thanks to major work completed just in time for the Olympics, the port has been integrated with the city by road and public transport, and has become a lively district where swimmers

Likewise, cities could benefit from the pandemic's impact on the infrastructure of higher and vocational education. If Barcelona offered students attending online classes low-cost accommodations, they could finish school and then work in the city as nurses, solar panel installers, or even tech entrepreneurs.

There are numerous, complex issues that would need to be resolved to realise these ideas. And executing them would require courage and audacity. But few places have these qualities in Barcelona's abundance. Catalan creativity and resourcefulness could contribute to solving the great urban conundrum - how to engage with global tourism without succumbing to it - that Barcelona itself helped introduce to the modern world.



INDIA HAS STRATEGIC PARTNERSHIP WITH MORE THAN **A DOZEN COUNTRIES, BUT INDIA-VIETNAM STRATEGIC PARTNERSHIP IS UNIQUE IN MANY** RESPECTS

Vuong Dinh Hue this week on the occasion of the 5th anniversary of the 'comprehensive strategic partnership' between the two countries is suggestive of the growing friendship and cooperation between the two countries and their people. The two countries are also celebrating the 50th anniversary of the establishment of the diplomatic relations between them. India has strategic partnership with more than a dozen countries, but India-Vietnam strategic partnership, which was elevated to 'Comprehensive Strategic Partnership' during Prime Minister Narendra Modi's visit to Vietnam, is unique in many respects. The two countries share cultural proximity and political convergence; there is no major bilateral issue and so much of complementarities and convergence of approaches to international issues. In India's 'Act East Policy', Vietnam is truly the pivot. China's belligerence has given traction to India-Vietnam relations as the two countries continue to face China's aggressive behaviour.

Although India and Vietnam have their own imperatives in the narrative of their robust bilateral relations, developments in the Indo-Pacific, particularly in the South China Sea and also in the Line of Actual Control in India-China border, have added strategic dimension to their bilateral relations.

During the virtual summit a number of bilateral documents, agreements and Memorandum of Understanding were signed. An important document which was adopted by the two Prime Ministers is 'India-Vietnam Joint Vision for Peace, Prosperity and People'. The vision document aims "to guide the future development of India-Vietnam Comprehensive Strategic Partnership", while the 'Plan of Action for 2021-2023' focuses on implementing the Comprehensive Strategic Partnership. An important announcement made during the meeting was the implementation of a high-speed guard boat manufacturing project for Vietnam Border Guard Command under the \$100 million Defence Line of Credit extended by Government of India to Vietnam.

Another important agreement pertains to \$5 million Indian Grant Clean Energy Association aims at promoting and exchanging of knowledge, best practices and sharing of information and to explore new business opportunities to promote solar power in India and Vietnam. A careful and close examination of the agreements and MoUs clearly

indicates the philosophy and guiding principle of India's developmental assistance, which is peoplecentric driven by both the government and corporate sector. These projects and assistances aim to empower people on sustainable basis and are not predatory or mercantilist or exploitative in nature. In recent years there is growing resentment of assistance by some of the donor countries with regard to the hidden aspects of such aids and assistance which at times lead to debt trap and financial hardships. India's development assistance to Vietnam aims at synergising win-win cooperation and earning a lasting and durable goodwill of the people and the government.

New Delhi, Dec 16: Lok Sabha proceedings were adjourned for the day Thursday amid continuous protests by opposition members led by Congress leader Rahul Gandhi demanding sacking of Union Minister Ajay Mishra from the government in connection with the Lakhimpur Kheri violence.

Rahul Gandhi, who had a question on MSME sector listed Thursday, linked Mishra with the Lakhimpur Kheri violence and demanded his ouster when Speaker Om Birla called his name during the Question Hour

It was trouble from the word go, as opposition members trooped into the Well raising slogans and waving placards demanding removal of Mishra, whose son has been arrested in connection with the Lakhimpur Kheri violence in October in which eight people, including four farmers, were killed.

Trinamool Congress members, who had earlier stayed away from the opposition grouping, were also in the Well of the House raising slogans along with members of the Congress and Left parties.

"This minister should be removed from the government...Action should be

taken against him," Gandhi said."We should be allowed to speak about it (Lakhimpur Kheri)," the Lok Sabha member from Wayanad said as opposition members waved placards and raised slogans in the Well of the House.

The Speaker asked Rahul Gandhi to stick to the question related to the MSME sector that was listed against his name.

'You are a senior member. You ask the question number 262. You will be given adequate time to ask the question you have listed for Question Hour. You claim that you are not allowed to speak in the House. I will give you adequate time if you stick to the question listed by you," the Speaker said. Parliamentary Affairs Minister

Pralhad Joshi said Rahul Gandhi was trying to speak at a time when Congress members were in the Well of the House."How can this be allowed. Ask him to call the members back to their seats,' Joshi said

BJP members too were up on their feet as Rahul Gandhi continued to speak on the Lakhimpur violence."Your Kheri minister...Should resign. He should be punished for that. He should be removed from the government," Rahul Gandhi said.

New Delhi, Dec 16: The Congress Thursday accused the government of indulging in petty politics by not remembering former Prime Minister Indira Gandhi during

Vijay Diwas celebrations and termed it of being "misogynist". Former Congress president Rahul Gandhi recalled Indira Gandhi's role in Bangladesh's liberation and said it was under her leadership that India won the war to save the idea of democracy. "Remembering the martyrs and veterans of the 1971 war. India won the war to save the idea of

democracy under the able leadership of Former PM Smt. Indira Gandhi ji. Jai Hind! #VijayDiwas2021," he tweeted.

He also accused the govern ment of ignoring his grandmother's role in the 1971 War and said victory was achieved as the country was united then. She took "32 bullets for the country" but her name was not even mentioned at a government event in New Delhi on the anniversary of the victorv over Pakistan, he said in Dehradun, adding "However, it does not make any difference because I know what she did for the country by giving her blood."

He said the credit for the 1971 War victory goes to the "united fight put up by Indians regardless of their cast or religion". His sister and AICC general secretary Priyanka Vadra said, "Our first and only woman Prime Minister, Indira Gandhi is being left out of the misogynist BJP government's Vijay Diwas celebrations.

She said, this happened on the 50th anniversary of the day that she led India to victory and liberated Bangladesh."Narendra

It was a his tory that reshaped geography as well," Sonia Gandhi said, adding that the 1971 war was a victory of the people of India under the leadership of Indira Gandhi.

Senior Congress leader and Leader of Opposition in Rajya Sabha Mallikarjun Kharge said it was unfortunate that the government did not recognise the role played by Indira Gandhi in the liberation of Bangladesh during

the celebrations.

He said Indira Gandhi used all force to help liberate Bangladesh from Pakistan, which was broken into two pieces, but some people today sought to forget Indira Gandhi and her contribution and did not remember her for her role in the Vijay Diwas.

'They give speeches on Vijay Diwas, they should also tell which government was there at the time and who was leading it," he said, recalling how thousands of Pakistani soldiers were also held at the time and they were later released.

"Bangladesh remembers Indira ji, but our people forget her. Former prime minister Indira Gandhi lauded Indira Gandhi and termed as 'Durga'. The good work done for the country should be remembered and not forgotten. It is very unfortunate that the prime minister and the government did not even name then Prime Minister

Indira Gandhi," he told reporters. Kharge alleged that even inside Parliament, they were not allowed to say anything on this occasion and only the chairman spoke a few words. Congress chief spokesperson Randeep Surjewala accused the BJP government of indulging in petty and cheap politics by not naming Indira Gandhi who led from the front and gave decisive leadership at the time.

"The Modi government and the BJP will not deter from their cheap and petty politics. On the 50th Vijay Diwas of Bangladesh's independence, the Prime Minister and the people in the government did not even take the name of Indira Gandhi, the "Iron Lady" of the 1971 war, is an example of their frustrated and narrow mindset," Surjewala said in a tweet in Hindi, using hashtag "Bangladesh". Deputy leader of Congress in Lok Sabha Gaurav Gogoi said it is unfortunate that the prime minister feels so insecure to not even name Indira Gandhi who gave the leadership during the 1971 war with Pakistan that led to the libera-

tion of Bangladesh. "Today our prime minister unfortunately is so insecure and so weak that he cannot even name the role of Indira Gandhi. This is nothing but an attempt to whitewash and change history. Over 32,000 RTI appeals pending with CIC: Govt

New Delhi, Dec 16: More than 32,000 RTI appeals are pending with the Central Information Commission (CIC), the Rajya Sabha was informed Thursday.

In a written reply, Minister of State for Personnel Jitendra Singh said there was a pendency of 35,178 and 38,116 RTI appeals during 2019-20 and 2020-21, respectively.

A total of 32,147 RTI appeals were pending in 2021-22, as on December 6, 2021, he said. Singh said the government has taken several steps like capacity building through training

and issuance of guidelines for Public Information Officers and First Appellate Authorities, so as to enable them to supply information/dispose of first appeal effectively, resulting in less number of appeals to the information commission.

The government has also issued clarificatory orders impressing upon the public authorities to disclose maximum information proactively so that citizens need not resort to filing of Right to Information (RTI) applications to access information available with the public authorities.

Training is implementing an annual programme Improving Transparency and Accountability in Government through Effective Implementation of RTI Act' wherein state administrative training institutes (ATIs) and State Information Commissions (SICs) have been given financial assistance for awareness generation on RTI by taking up various activities which may include 'nukkad natak' (street plays). use of local folk troupes, development of publicity material in local languages, distance learning programmes, online certificate courses

New Delhi, Dec 16: Amid a chorus of Opposition leaders demanding his removal from the Union Cabinet over the Lakhimpur Kheri incident, the Centre is unlikely to take any action against MoS Home Ajay Mishra Teni, sources said.

According to sources, the view within the government and ruling BJP is that the SIT report, which claimed that the Lakhimpur incident was a "planned conspiracy to murder protesting farmers", is not the final word in the case. There is also a view within the government that the matter is subjudice and pertains to Ajay Mishra's son, Ashish, and not him, sources said.

Six killed, 25 hurt in road accidents

Jaipur: Six people, including a woman and a child, were killed and 30 others injured in three separate road accidents in Rajasthan Thursday. A woman and a child were killed while 25 others were injured when a bus overturned in Jhunjhunu district. In another road accident in Udaipur's Sukher police station area, three people travelling in a car were killed and four others injured in a head-on collision with a truck.

Road projects in J&K create history

New Delhi/Srinagar: Mountainous regions are dotted with tough geographical terrain where quality tunnels and roads are a boon. Lofty mountains, slippery peaks, ridges, gorges, and ravines are the definition of J&K and Ladakh, which separate it from the rest of the country during the winter months. However, with the recent developments, the road and Kashmir and Ladakh regions has mitigated the threat of accidents, and for the first time allowed speedy, smooth travel.



A bench headed by Chief Justice N V Ramana took note of a report filed by the commission which informed it that a decision to lift the ban on certain industries has been taken.

"The committee's report states measures that have been taken. So far as construction activities have been taken it's been stated that a decision will be taken tomorrow. We will list the matter in the first week of February. Meanwhile, we direct the commission to invite suggestions of the general public and experts about a permanent solution to the pollution," the bench also comprising Justices DY Chandrachud and Surya Kant said. At the outset, Solicitor General Tushar Mehta



told the bench that operation of industrial processes related to milk, dairy processing, manufacture of drugs, life-saving medicines and medical equipment has been permitted. He said some industries were permitted for eight hours, some industries said their nature of industries is such that eight hours is not sufficient. "We have asked them to have a continuous process but five days not seven days. And we have staggered industries so they don't function on

the same days," Mehta said. "Thermal power plants that are closed will remain shut but more will not be closed. Decision on construction activities will be taken tomorrow. Hospital constructions are permitted, while trucks, etc. Continue to be banned." he submitted.

Senior advocate Vikas Singh, ap pearing for the petitioners in the case, said only short term measures have been proposed and the problem of air pollution, long term permanent measures are needed.

"These (submitted by SG) are short term measures. I've some suggestions. Some permanent solution has to be found," Singh said. The bench, however, asked him to submit suggestions which would be considered by an expert group constituted by the commission. The commission has told the top court that milk and dairy processing units, ,medicines, drugs and life-saving equipment industries have been allowed to resume full time operations. Besides these, paper and pulp processing industries have been allowed to work five times a week while paddy, rice industries and textile, garment units have been permitted to work five days a week. The commission further told the apex court that power plants have been permitted to operate keeping in view the demand for power.

The ban on construction activities, however, will continue and schools will also continue to function through online mode for the time being which will be reviewed again December 17. The apex court

had earlier taken note of slight improvement in air pollution levels in Delhi-NCR and permitted the commission on air quality management to take a decision on various representations seeking easing of curbs, like ban on construction activities, within a week

On December 3, the bench had directed the Centre and the NCR states to implement the panel's order to curb pollution and sought a proposal to ensure switching over of all industrial units to PNG or cleaner fuel in a time-bound manner or face closure. The bench had also rued that some news reports tried to "portray the court as a "villain" that wanted to close down schools in Delhi-NCR. It had taken note of the commission's proposal that industrial operations in the NCR, where gas is not available and the industrial unit is not running on PNG or cleaner fuels, shall be allowed to operate only up to eight hours a day during weekdays and shall remain closed during Saturdays and Sundays.

SC allows bull races in Maha

New Delhi, Dec 16: The Supreme Court Thursday allowed bull races in Maharashtra, after a four-year hiatus, on the basis of same conditions and regulations as laid down in the amendments to the Prevention of Cruelty to Animals Act (PCA Act) by Karnataka and Tamil Nadu.

A bench headed by Justice A.M. Khanwilkar was hearing an application in the Maharashtra government special leave petition challenging the 2018 Bombay High Court order which stayed the bullock-cart races in the state. The high court passed the order in the backdrop of top court judgment banning traditional animal sports like Jallikattu, terming it an offence under the PCA Act. Senior advocate Mukul Rohatgi

represented the Maharashtra government in the top court. He submitted that Tamil Nadu and Karnataka have passed amendments to the Act to permit races. Rohatgi added that the high court did not grant permission for the races, though the Maharashtra government framed rules to allow them under strict regulations.

The top court noted that Tamil Nadu and Karnataka governments have passed amendments to the Act to allow animal sports. The top court said the same dispensation must apply to the provisions of Maharashtra government, which are similar to the amendments carried out in other states.

These amendments have also been challenged in the apex court; however, the two-judge bench had referred the matter to the Constitution Bench, without a stay on the amendments.

Beijing, Dec 16: The Omicron variant of coronavirus infects and multiplies 70 times faster than Delta and the original COVID-19 strain, but the severity of illness is likely to be much lower, according to a study.

The yet-to-be peer-reviewed study provides the first information on how the novel variant of concern infects human respiratory tract. The researchers from University of Hong Kong found that Omicron infects and multiplies 70 times faster than the Delta variant and original SARS-CoV-2 in human bronchus, which may explain why it may transmit faster between humans than previous

variants. A bronchus is a passage or airway in the lower respiratory tract that conducts air into the lungs. The study also showed that the Omicron infection in the lung is



5 kids die as wind lifts bouncy castle in Australia school

Sydney, Dec 16: Five children died and four others were in critical condition Thursday after falling from a bouncy castle that was lifted 10 metres into the air by a gust of wind at a school on Australia's island state of Tasmania.

The school was holding a celebration to mark the end of the school year. The children who died included two boys and two girls in vear 6, which would make them 10 or 11 years old, said Tasmania police Commissioner Darren Hine. Police later Thursday confirmed a fifth child died in the hospital.

Five other children were being treated, including four in critical condition. Hine said an investigation is underway. Images published by the Australian Broadcasting Corporation showed police officers consoling each other as paramedics provided first aid to victims.

Parents arrived at the school gate to collect their children as helicopters ferried the injured to hospitals. Tasmania state Premier Peter Gutwein called the incident "simply inconceivable... I know this is a strong and caring community that will stand together and support one another.'

Tasmania police commander Debbie Williams told reporters "several children fell from the jumping castle. It appears they may have fallen from a height of approximately 10 metres.



Washington, Dec 16: Global debt rose to a record \$226 trillion in 2020 as the world was hit by the raging Covid-19 pandemic and a deep recession, the International Monetary Fund (IMF) announced.

Debt increases are particularly striking in advanced economies, where public debt rose from around 70 per cent of GDP in 2007 to 124 per cent of GDP in 2020.

Meanwhile, private debt rose at a more moderate pace from 164 to 178 per cent of GDP in the same pe-

riod, according to the IMF. The IMF noted that advanced economies and China accounted for more than 90 percent of the \$28 trillion debt surge in 2020. Egypt's gross public debt to GDP ratio stood at 91.4 percent in 2021. according to the IMF. The IMF officials said that a cru-

cial challenge for policymakers is to strike the right mix of fiscal and monetary policies in an environment of high debt and rising inflation, as the debt surge ampli-

SET TO SURPASS FY'20 RECORD

Apr-Oct iron ore output at 143 MT

New Delhi, Dec 16: India's iron ore production has surged to 143 million tonne (MT) in the first seven months of the ongoing fiscal, and the country is all set to surpass the record production of 246 MT achieved in 2019-20, Mines Secretary Alok Tandon said Thursday.

"The production of another key mineral, bauxite, has also witnessed a vear-on-vear increase in the April-October period of 2021-22," Tandon said during the International Mining Summit with the theme 'Towards a Responsible and Competitive Mining Industry organised by industry body CII.

"During April to October that is seven months of 2021-2022, iron ore production of 143 million tonne is not only 50 per cent jump from the production of 95.5 million tonne in the corresponding year, it is also well on its way to surpass the record production of 246 MT achieved in 2019-20," he said. Stating that the results of policy changes cannot be seen fully in a short span of time, he said, some early trends pertaining to mineral production are encouraging.

"The government has taken several measures, including legislative actions, to propel competitiveness in this sector and with the aim to increase its contribution to the national economy. Besides, several measures have been directed to-

wards the welfare of the people living around the mining areas and sustainability of the environment. With results beginning to show, I find the theme of this conference to be apt in this contextual frame," he said.

In order to boost the competitiveness of the Indian mining industry and to increase social responsiveness, several policy reforms have been brought out in the last few years primarily through the amendments in the MMDR Act.

While certain amendments to the MMDR Act were taken in 2015 and 2020, to meet the changing needs of the mineral sector, the amendment to the Act this year was more wholesome as it was intended to provide a quick boost to mineral production and mineral availability and improve the ease of doing business.

In the context of strengthening the social trust the amendment act of 2015 provides for establishing District Mineral Foundation (DMF) by the state governments in the districts affected by mining operations to take care of people affected by mining related activities.

The rules stipulate a payment of 30 per cent royalty towards DMF for mining leases granted prior to 2015 and 10 per cent of royalty for mining leases granted thereafter. The amount of money collected in DMF so far is about ₹55,000 crore," Tandon said.



Adelaide, Dec 16: Australia shrugged off the late withdrawal of new skipper Pat Cummins because of coronavirus concerns to dominate England on the opening day of the second Ashes test and reach 221/2 at stumps.

Marnus Labuschagne (95 batting, 275b, 7x4) was dropped twice but remained unbeaten at stumps Thursday after sharing partnerships of 172 with David Warner (95, 167b, 11x4) and 45 with Steve Smith (18 batting).

Smith returned to the Australian captaincy for the first time since the 2018 sandpaper scandal after Cummins was ruled out. He was

deemed to be a close contact of a positive COVID-19 case when he dined at a restaurant on the eve of the match.

Smith won the toss and just about everything else went Australia's way to start the daynight test. He was unbeaten after waiting most of the day to bat, with Australia losing just two wickets despite an England attack bolstered by the return of Jimmy

Anderson and Stuart Broad (1/34). Wicketkeeper Jos Buttler took a brilliant catch in the first hour to dismiss opener Marcus Harris (3) but then dropped Labuschagne twice — once down leg-side when he was on 21 and the other when he fumbled a regulation chance

It was a reward for Stokes, who should have had a wicket in the 35th over when Labuschagne gloved a chance down the leg side but Buttler couldn't complete the catch. Most of the drama Thursday

happened pre-match. Cricket Australia revealed only three hours before the coin toss that Cummins was ruled out because he was exposed to a person with COVID-19 in an Adelaide restaurant Wednesday night.

He was deemed a close contact by the state's health authorities and ordered to isolate for seven days. Cummins has already returned a negative test for COVID-19. Smith became the third Australia captain in three Tests. Tim Paine, who replaced Smith as Test captain after the sandpaper scandal in South Africa, quit last month after reports emerged he'd been investigated four years ago for sending an inappropriate text to a work colleague.

He was replaced by Cummins, with Smith as vice-captain for the series-opening win in Brisbane. Now Smith is back.

Cricket Australia chief executive Nick Hockley said Cummins hadn't breached any protocols by dining out and was unlucky to miss the game.



London, Dec 16: Mercedes have confirmed they are withdrawing their protest over Max Verstappen's controversial drivers' championship victory at the Abu Dhabi Grand Prix.

The Dutchman passed Mercedes' Lewis Hamilton on the final lap of the last race of the season to snatch the crown from under the Brit's nose following a controversial period of running under the safety car.

In fury, Mercedes had lodged an appeal over the result, but have now decided against the procedure following talks with the FIA - the governing body of F1.

The 'Sportsmail' had revealed Wednesday that Hamilton had told the team he did not want to win what would have been a record eighth World Championship in court.

Hamilton had been set to win comfortably at the Yas Marina circuit before Nicholas Latifi's

"We appealed in the interest of sporting fairness, and we have since been in a constructive dialogue with the FIA and F1 to create clarity for the future, so that all the competitors know the rules under which they are racing, and how they will be enforced.

'Thus, we welcome the decision by the FIA to install a commission to thoroughly analyse what happened in Abu Dhabi and to improve the robustness of the rules. governance and decision making of F1. We also welcome that they have invited the teams and drivers to take part. We will hold the FIA accountable for this process and we hereby withdraw our appeal.'

Recently, young pistol shooter Khushpreet Kaur Sandhu, who had made her junior India debut at the last World Championship in Lima, committed suicide after registering low scores at the Nationals.

Before that, two more shooters - Hunardeep Singh Sohal and Namanveer Singh Brar — also took the extreme step.
