Bhubaneswar: The India Meteorological Department (IMD) Monday predicted cold wave to severe cold wave conditions are likely to prevail in several parts of Odisha in the next two to three days. As per IMD, northwesterly/northerly dry and cold wind at lower levels is penetrating over Odisha. Under its influence, isolated cold wave conditions are likely to prevail in some parts of interior and adjoining districts of the State during

Dec 20: The state crime branch (CB) investigating the mysterious death of Chittaranjan Palai Monday conducted a lie detection (polygraph) test on two of the accused including a woman at the State Forensic Science Laboratory (SFSL) here. Meanwhile, another suspect in the case is scheduled to undergo the polygraph test Tuesday.

The CB sleuths Monday brought the suspects. Jagannath Sarangi



and two of his aides including the woman, to the SFSL for the lie detection test. The sleuths hope to elicit vital leads that would help them remove the mystery behind the death of Palai. The sleuths asked the accused several queries on their relationship with the deceased and the happenings of the fateful day. Palai's uncle alleged that the deceased had gone to attend a feast where the suspect, Sarangi, along with other friends was present December 11. However, he did not return from the feast.

His uncle lodged a complaint with the police alleging that it was a pre-planned murder. Following an order of DGP Abhay,

# **CM unveils air** ambulance for tribal districts

Bhubaneswar, Dec 20: Chief Minister Naveen Patnaik Monday launched the 'Mukhyamantri Vayu Swasthya Seva' (air health services) under which specialist doctors will be flown to remote areas of the state to treat people suffering

from serious diseases. Patnaik flagged off a flight carrying specialist doctors to the tribaldominated and Maoist-hit Malkangiri district. The doctors after reaching Malkangiri will treat the people suffering from certain serious diseases.

Apart from Malkangiri, the 'Mukhyamantri Vayu Swasthya Seva' will be available in the tribaldominated districts of Nabarangpur, Nuapada and Kalahandi in the first phase. Other districts will be covered under the programme in a phased manner, Patnaik said

#### LONGEST BRIDGE **OVER MAHANADI**



Bhubaneswar: Chief Minister Naveen Patnaik Monday inaugurat ed the state's longest bridge over the Mahanadi river at Gopinathpur in Cuttack district. The 3.4-km-long bridge, connecting Singhanath Pitha and Baideswar in Cuttack district, will reduce the distance by 45 km, benefitting around five lakh people, officials said. The bridge, constructed in T-shape, is built at a cost of ₹111 crore, they said. Patnaik had laid the foundation stone of the bridge February 28, 2014. Ahead of Patnaik's visit, the police detained hundreds of Congress and BJP workers, including former MLA Debasis Patnaik, as they were protesting with black flags at Banki. The opposition activists were demanding the dismissal of Minister of State for Home DS Mishra for his alleged link with the prime accused in the Kalahandi woman teacher's kidnap and murder case.

The sources also said the commission arrived at the proposal to add more seats after the discussion with its five associate members. The commission, headed by for-

mer Supreme Court Justice Ranjana Prakash Desai, had a meeting with five Lok Sabha members from Jammu and Kashmir for the consultations and were asked to respond to the proposal by December 31 this year.

The commission has proposed to reserve nine seats for the ST and seven seats for the SC in the UT, the sources said, adding earlier there were no reserved seats for STs and SCs. If the recommendations are implemented, the Jammu region will have 43 seats while the Kashmir Valley will have 47 seats.

PANAMA PAPERS LEAK CASE

Health and Family Welfare Minister NK Das said specialist doctors required for the treatment of critical patients admitted to various district headquarters hospitals (DHHs), will go to the remote districts to treat patients.

He said doctors from medical colleges and corporate hospitals will be flown to the remote districts through aircraft/ helicopters for prompt treatment of the patients. If required, the patients will be airlifted to various healthcare facilities in Bhubaneswar and Cuttack, the minister said.

So far, the minister informed that a team of doctors of the SCB Medical College and Hospital in Cuttack has been formed for this purpose. Later, doctors of MKCG Medical College and Hospital in Berhampur, VIMSAR in Burla and

other private hospitals empanelled under the Biju Swasthya Kalyan Yojana (BSKY) will be engaged in the service. The service will be offered free of cost to the patients, the minister said. He said the poor patients who were deprived of better treatment by specialists/experts due to location disadvantage, will now avail the benefit from this initiative. Specialist doctors of neurology, nephrology and cardiology department will be flown to the district headquarters hospitals. The follow-up treatment of the patients will be carried out through telemedicine, he said.

Ahmedabad, Dec 20: A Pakistani fishing boat with six crew members and carrying 77 kg of heroin worth around ₹400 crore was apprehended in the Indian waters off the Gujarat coast, officials said Monday. The drug seizure was made after Sunday midnight in a joint operation by the Indian Coast Guard and the Gujarat Anti-Terrorist Squad (ATS), around 35 nautical miles off the Jakhau coast in Kutch district of Gujarat,

They apprehended the Pakistani fishing boat 'Al Huseini' with six crew members on board in the Indian waters and seized "77 kg of heroin worth approximately ₹400 crore," Gujarat's defence PRO said in a tweet in the morning. The boat was later brought to the Jakhau coast for further investigation. he said.

The Gujarat ATS in a release said the Pakistani boat had left the



Karachi port and was trying to establish contact using very high frequency (VHF) radio channel and code words, 'Hari-1' and 'Hari-2', for the delivery of the drugs. The joint operation was carried

out after the ATS received a tip-off that the boat from Karachi was to reach around 35 nautical miles off the Jakhau coast, after crossing the International Maritime Border Line between the two countries. The boat, belonging to one Shahbaz Ali, left the Karachi port and its crew members loaded the drugs sent to them on a fibre boat at a distance of six nautical miles from the Karachi port.

New Delhi, Dec 20: Actor Aishwarya Rai Bachchan Monday appeared before the Enforcement Directorate (ED) here for questioning in a case linked to the 2016 'Panama Papers' global tax leaks case, official sources said.

The 48-year-old daughter-in-law of superstar Amitabh Bachchan is being questioned and her statement is being recorded under the provisions of the Foreign Exchange Management Act (FEMA). The actor has also submitted some doc-

uments to the agency when she appeared before the agency at its office near India Gate. Dubbed 'Panama Papers', an investigation of a stockpile of records from Panamanian legal firm Mossack Fonseca by the Washington-based International Consortium of Investigative Journalists (ICIJ) in 2016 had named several world leaders and celebrities who allegedly stashed away money abroad in offshore companies.

Some of them are stated to be holding valid overseas accounts. The leaks tranche had a total of 426 India-linked cases. The ED has been probing the case linked to the Bachchans since 2016-17.

It had issued notices to the Bachchan family asking them to explain their foreign remittances since 2004 under the Reserve Bank of India's (RBI) Liberalised



Remittance Scheme (LRS) and regulated under the Foreign Exchange Management Act (FEMA). Some documents were submit-

ted by the Bachchans to the agency then. Some other instances of alleged irregularities linked to the family are also under the scanner

of the federal probe agency, the sources said. Aishwarya Rai Bachchan, married to Amitabh Bachchan's actor son Abhishek, was stated by the ICIJ to have links with an offshore entity in the British Virgin Islands (BVI) that was created in 2005. Her family was also stated to be part of this offshore entity that had an "initial authorised capital of USD 50,000." The company was reportedly dissolved in 2008. Abhishek Bachchan has also been examined by the ED in the past in another instance linked to the offshore leaks case, sources said.

The government had created a multi-agency group of central investigative agencies under the chairman of the Central Board of Direct Taxes that also comprised officials from the ED, RBI and the Financial Intelligence Unit (FIU) to monitor the probe.

# Even triple vax can't limit Omicron spread: BioNTech CEO

Paris, Dec 20: Three doses of a Covid vaccine may not be able to curb the rapid spread of the highly transmissible Omicron variant of Covid, warned Ugur Sahin, CEO of Germany-based BioNTech.

According to the World Health Organisation (WHO), the variant, known to escape vaccine immunity, has spread to about 90 countries.

"We must be aware that even triple-vaccinated are likely to transmit the disease. It is obvious we are far from 95 per cent effectiveness that we obtained against the initial virus," Euronews quoted Sahin as saying to the French daily Le Monde Monday. BioNTech partnered with US drugmaker Pfizer to develop the two-dose revolutionary Covid jab, based on mRNA technology.

Despite this, Sahin noted that early data from the UK and South Africa is providing us with "reassuring information"

The latest research from South Africa, where Omicron was first reported, suggested that two doses of the Pfizer/BioNTech vaccine offered 70 per cent effectiveness in reducing the risk of hospitalisation. Israeli researchers have also found that the booster doses of the vaccine works against Omicron.

"There will be a loss of effectiveness against Omicron over time, it's very likely, but it's still to be measured how quickly. I will not base predictions on preliminary laboratory data but on reallife data, which is much more appropriate," the German immunologist said.

Sahin said testing for Covid-19 is important, especially for the eld-



erly and during winter, as are other protective measures such as maskwearing, adding, "otherwise we will not be able to control the rapid expansion of this new variant". The German company is already designing a coronavirus vaccine adapted to the new variant, using Omicron's spike protein and its 32 mutations as an antigen. Sahin announced this should be ready by March, the report said.

"We remain on track with our 100day target, which means we should be able to deliver our first suitable vaccines to Omicron in March, subject to regulatory approval," he said. Some researchers have voiced concern about the effect of these new vaccines as instead of boosting new immune defences, they could risk boosting inadequate ones

"This principle is an unproven hypothesis, personally, I don't think this is a real problem. The immune system has high adaptability and plasticity, and should be able to activate both, strengthening existing immune responses while generating new antibodies," Sahin said, adding "but we will obviously have to assess it.

Scientists at WHO have also predicted that Omicron has "substantial growth advantage" over the Delta variant and it will soon Moderna claims its booster shot effective

Moderna, which has produced an mRNA vaccine, Monday, said that a booster dose of its vaccine appeared to be protective against Omicron. Moderna said that its research so far showed that a 50 microgram dose of its vaccine, which is the current amount for a booster jab, increased the level of antibodies 37-fold, compared with two

doses. It also said a full dose of

antibody levels 83-fold, it said.

# Major fire at Sambalpur gutkha unit, 28 injured

AN ELECTRICAL SHORT-CIRCUIT IS SUSPECTED TO HAVE TRIGGERED THE FIRE

Sambalpur, Dec 20: At least 28 workers, including 11 critical, sustained varying degrees of injuries after a major fire broke out inside a gutkha manufacturing unit located at Saradhapali area in Sambalpur district, Monday.

The actual reason behind the fire mishap is yet to be ascertained. However, it is suspected to have occurred because of an electrical shortcircuit. "Perhaps a blast occurred in a machine from where the blaze spread to other parts in the unit. Most of the employees who were working inside are from outside Odisha," a source informed.

'We were operating a machine when it went off and don't know what caused the inferno. Most of us are out of danger now, but two have sustained



severe burns," an injured worker stated. "A mishap occurred when the workers were packing gutkha. We will carry out a detailed probe to ascertain the actual reason behind the fire," Sambalpur Superintendent of Police B Gangadhar said

The injured were rescued and rushed to Veer Surendra Sai Institute of Medical Sciences and Research (VIMSAR) in Burla. Later, 11 of them were shifted to Ispat General Hospital at Rourkela after their condition deteriorated. According to reports, the

critically injured persons have suffered over 80 per cent burn.

The affected workers have blamed the factory owner for the mishap. They claimed that the fire occurred due to the lack of fire safety and other measures in the unit. Angry locals have demanded arrest of the factory owner. Later, Suryavanshi Mayur Bikash, sub-collector, and Sambalpur SPB Gangadhar rushed to the spot and took stock of the situation. On being informed, a team of local fire services personnel reached the spot and launched a massive operation. They succeeded in dousing the flames after striving for over two hours.

"The entire area was filled with thick smoke and it was impossible to enter the unit. Two floors of the factory were engulfed by fire. We rescued the workers with the help of locals," a senior fireman expressed.

# Overloaded vehicles deprive govt of crores

#### POST NEWS NETWORK

Jajpur, Dec 20: The state government is losing revenue over ₹10 crore annually due to illegal plying of cargo vehicles overloaded with minerals from stone quarries and crusher units in this district.

Road safety measures too have gone for a toss due to rampant plying of overloaded vehicles here. However, no one cares to address the problem as these vehicles ply on roads with impunity. Such apathy and callousness can be gauged if one takes a look at the road condition in Sukinda and Chadheidhara areas connecting Bhuban in Dhenkanal district.

The regional transport officers have been asked to personally supervise vehicles for overloading, but they seem to be apathetic to the issue. The revenue officials are no less responsible for the sorry state of affairs. Reports said that thousands of heavy vehicles like Hywa, trucks and tractors are illegally plying from various stone quarries and crusher units under Dharmasala tehsil in the district. Over 2.000 vehicles ply daily on this route carrying construction materials like boulders, metals, concrete and gravels from the stone quarries and crusher units located in the area.

On the other hand, revenue collection is quite disappointing and does not match with the number of



seven to eight tonnes.

It is alleged that some senior officials of state Transport department are hand in glove with the stone smugglers for whom the annual target for revenue collection is fixed as per their whims. As a result, it becomes easier for the Transport officials to achieve their target and draw appreciation from the state government.

Sources said that various mining firms like IMFA, Tata Mines, OMC and Facor carry out excavation for mining in Kaliapani area of the district. It is alleged that some senior mines officials are also involved in this misdemeanour. Locals have drawn the attention of Dhenkanal and Jajpur Collectors several times but their pleas are yet to be addressed.

# For Women & Children

virtual tug of war has begun between India and Pakistan over handling the humanitarian-economic-political crisis in Afghanistan, each Ltrying to rope in countries of their choice in their bid to consolidate their respective position. India hosted a dialogue in Delhi December 19 with five Central Asian countries - Kazakhstan, Kyrgyz Republic, Tajikistan, Turkmenistan and Uzbekistan. Pakistan in turn organised in Islamabad the same day the biggest conference on Afghanistan since the United States-backed government in Kabul fell in August. It was attended by envoys from 57 member nations of the Organisation of Islamic Cooperation (OIC). The eagerness of Pakistan, which had acted as a sanctuary for the Taliban during the past 20 years when the latter were hunted down by the US troops, was clear from the pronouncements of its top leaders. Pakistan Prime Minister Imran Khan made a fervent appeal to the international community to provide help to the '40 million Afghan citizens' who have been plunged into a catastrophic humanitarian crisis with food scarcity and severe winter cold staring them in the face. The Taliban government is plagued by international isolation and the consequential freezing of its financial resources worth billions of dollars causing serious funds crunch.

India on the other hand pitched for finding ways to help the Afghan people, but insisted on the formation of an inclusive government in Kabul that, in its perception, presupposes any solution to the Afghan crisis. In his opening remarks at the third India-Central Asia Dialogue, External Affairs Minister S Jaishankar spelt out the goals India has set for it and the five Central Asian countries. These include a 'truly inclusive' and representative government, fight against terrorism and drug trafficking, ensuring unhindered humanitarian assistance and preserving the rights of women, children and minorities as key priorities in Afghanistan. The objectives are in keeping with the concerns of the six countries which fear a backlash harming their economic and political interests if the Taliban are given a carte blanche to rule Afghanistan the way they want.

In a clever way the intentions were couched in a diplomatic language when Jaishankar said, "We must find ways of helping the people of Afghanistan." He floated a 'Four C' approach focusing on commerce, capacity enhancement, connectivity and contacts to further expand the cooperation between the two sides. However, the fact remains the volume of trade and commerce between India and the five Central Asian countries has so far been negligible. It is less than 2\$ billion per annum. Jaishankar also underlined the need for having diversified supply chains and more regional solutions to various challenges. In the past few years, although India has been focusing on expanding overall cooperation with the energy-rich Central Asian countries, considering them to be part of its extended neighbourhood yet it has not put in the desired push because it could not predict the Afghan crisis and act judiciously. The recent developments in Afghanistan have only increased manifold the importance of the Central Asian countries with three of them - Tajikistan, Turkmenistan and Uzbekistan - sharing borders with war-ravaged Afghanistan.

The foreign ministers sought to use the current crisis in Afghanistan to forestall any attempt to export terror and commit cybercrimes directed against their countries. Predictably, their joint statement 'condemned' terrorism in all its forms and manifestations. The language leaves no one in doubt about their intent to send the message across to the Taliban regime that providing safe haven, using terrorist proxies for cross-border terrorism, terror financing, arms and drugs trafficking, dissemination of a radical ideology, and abuse of cyber space go against the basic principles of humanity and international relations. While none of these countries recognise Taliban, only Tajikistan has taken a strong stand against any bilateral contacts with the group after it took control of Afghanistan August 15, 2021. Turkmenistan and Uzbekistan have re-opened their missions in Kabul. They have also exchanged ministerial level visits with Kabul, as have Kazakhstan and the Kyrgyz Republic. India has thus far met Taliban leaders publicly only twice, in Doha and Moscow.

One takeaway for India from the meeting is that in the face of Pakistan refusing to allow land trade from India, the five Central Asian countries expressed their keenness to make more use of the sea route via Chabahar, which is connected to Central Asian countries by road and rail through Iran and the International North South Transit Corridor (INSTC) going via the Iranian port of Bandar Abbas. Pakistan appears to be playing smart and it sought to use the common denominator of Islam connecting the OIC countries to bail the Taliban-controlled Afghanistan out of the crisis.

Diplomacy and humanitarian aid should move hand in hand to make the Taliban see reason and wake up to the reality of a liberal world unhindered by varied forms of coercion. Till now the Taliban regime has only declared that it believes in respecting women, but it has not yet made clear whether women will be allowed to pursue studies in classrooms or work in offices. If the Taliban want access to their assets locked in foreign banks and stop economic collapse, according freedom to their women and children seems to have emerged as an important criterion.

# **SOME PRIORITIES FOR 2022**

derstanding of micro-managing lockdown restrictions and finally a weary and perhaps reluctant acceptance that life must go on. Additionally, perhaps this variant while highly infectious, is not as potent in causing fatalities. Of course, this is not to advocate letting the guard down.

The other negatives are distress in the informal economy especially in contact intensive sectors (like roadside vendors, kirana shops, mall workers). The rural economy is also under great stress as is manifest in the increased demand for work under the National **Rural Employment Guarantee** Scheme (NREGS). Despite an expected bumper crop, the prices of cereals are low, and hence the demand for a higher Minimum Support Price. Meanwhile, food inflation is rising thanks mainly due to edible oils (largely imported), and protein items like milk and poultry. Rural unemployment rates and rural wages are stagnating. The CMIE and ILO data show India's labour participation rate (LPR) is only about 40 per cent, the lowest in Asia. This is the ratio of people between 18 and 60, who have a job or are seeking one. Even Bangladesh is at 53, Pakistan at 48 and Nepal at 74. Is India's low ratio revealing discouraged workers, who have given up hope of even finding a job?

India's female labour participation rate at 20 per cent is already the lowest among peer countries and has been a cause for concern for quite some time.

Added to inflation and unemployment (and low LPR) is the phenomenon of increased inequality. The latest World Inequality Report 2022 shows that the top 10 per cent holds 57 per cent of the total national income. Of this the top 1 per cent alone holds 22 per cent of national income, while the bottom half holds just 13 per cent. This makes India one of the most unequal large economies. It also corroborates the recent report of Niti Aayog (based on the National Family Health Survey data) of high multi-dimensional poverty rates in states like Bihar, Jharkhand and Uttar Pradesh. The Niti Aayog measure actually excludes income and depends on measures like infant mortality, ownership of assets and education.

Beyond Omicron, inflation, unemployment, poverty and inequality are other worrving measures such as the slow off-take in credit from banks, little evidence of large investment projects forthcoming from the private sector, and the continued absence of students from schools. This two-year hiatus in schooling can have a long-term detrimental effect on India's human capital development.

So the priorities for next year seem self-evident. Firstly get ready for Omicron, without using harsh lockdowns, or spooking or panicking the public. The vaccination progress must be sustained and accelerated. Secondly, ensure that schools are started everywhere, at least with 50 per cent rotation of students. Skilling and training, including a nationwide portable apprentice scheme with government backed accreditation must be rolled out with urgency. Corporations will readily employ apprentices if they are free from burden of hiring them permanently. Thirdly, start executing the national infrastructure pipeline projects in earnest. These promise expenditure of close to 20 lakh crore annually, which can have a multiplier effect on jobs as well as ancillary and vendor industries. Fourthly, ensure support to sustained export growth. Zero rating of GST is desirable. Don't shackle agriculture exports. The Production Linked Incentive scheme which is currently applicable to 13 sectors must succeed, and should also dovetail with export support. India has to learn from Bangladesh, which with sheer focus on the export of textile and clothing for more than a decade has overtaken India in terms of percapita income. The fifth item is to rationalise the tax burden. The indirect taxes like GST hurt the poor much more than the rich. We have regressed, since the share of direct taxes of the total has fallen. This needs to be reversed. Doing that will also make a dent

Next year will hopefully see the economy on an up-cycle. Private investment is bound to pick up once business and consumer confidence picks up. For that to happen some of the above policy imperatives have to be implemented and require action both from the Central and state governments. Here is wishing all our readers a safe, healthy and prosperous 2022.

In the early years of the twentieth century the German psychiatrist Ernst Kretschmer examined criminals to try to tie their physical shape and constitution to their personalities and mental illnesses. Tall and thin ones he called asthenic and considered them to be the sort that commits fraud and petty theft. A second set were athletic types with well-developed muscles - unsurprisingly, he concluded these were more likely to be violent. The third sort were the pyknic ones, who seemed to be a mixture of the other two kinds so far as their criminal tendencies were concerned. He took pyknic from Greek puknos, thick or close-packed. It appeared first in his book Körperbau und Charakter in 1921. from where it soon moved into English. The American psychologist William Sheldon built on and modified Kretschmer's ideas, coming up with the three terms to describe body types - endomorph, mesomorph and ectomorph that are now more common. He considered Kretschmer's pyknic type to be a mixture of the endomorph and the mesomorph and came up with the phrase pyknic practical joke to describe a person who is muscular in early life but who later goes pear-shaped and balloons out into obesity

A second fascinating entrant to the global water markets is SkyH2O's Atmospheric Water Generation (AWG) system, a proprietary technology that extracts clean fresh water from the atmosphere. The business model here is flexible and scalable, because AWG capacity can be deployed in a distributed manner to reach the ultimate customers, be they governments, households, or industrial, commercial, and agricultural users.

The future of water as a significant asset class depends on the willingness of governments – and ultimately of society at large - to price water at its long-run social marginal cost as a scarce renewable resource. Globally, over 70% of fresh water is used in agriculture. and most of this usage is either free or heavily subsidised. Households in many countries also pay but a small fraction of the longrun social marginal cost of the water they use.

I hope and expect that both these

Sir, Marriage is intended to be a union that binds two souls together for lifetime. Legal marriage age for girls in India was 15 years till 1978. It was raised by three years from that year. The Prohibition of Child Marriage Act was put in place in 2006. And through an amendment to this Act, the Centre has proposed to increase the minimum age to enter into wedlock in women to 21, at par with men. When the minimum age was 18, tendency to marry off girls below that age was very common. Even with the enhanced minimum age for marriage, the proneness of a lot parents to get their daughters married before 21 may not diminish. But 21 is always better than 18 because of the legal definition of a child. The Centre is optimistic about a possible decline in child marriages after the latest amendment. A great deal of child marriages takes place in rural India, and that is another perturbing factor. Girl child marriages in India saw a decline from the early 90s. So, the country has achieved some amount of success in preventing child marriages but obviously the government knows it is too little, too late. But better late than never, so the Niti Aayog was entrusted with the responsibility of suggesting modification in age of marriage of girls considering various factors like health of the mother at a tender age, maternal mortality ratio in young mothers and nutrition in mother and child. Behind all this, the aim is to educate and empower girls alongside employment and independence to make certain they stand on their own feet. A girl's rights with respect to safety, security, sanitation, health and work need no special mention

# **Oppn questions tearing hurry on Aadhaar linkage**

New Delhi, Dec 20: A Bill to link electoral roll data with Aadhaar ecosystem and bring other poll reforms was passed by Lok Sabha Monday after a brief debate and amid demand by the opposition to refer it to a standing committee. The Election Laws (Amendment) Bill 2021, piloted by Law Minister Kiren Rijiju, was passed by a voice vote with opposition members claiming that the move to link electoral roll with Aadhaar number

would violate privacy and could even allow non-citizens to vote. "So, if you are in a position where you are asking Aadhaar for voters, all you are getting is a document

that reflects residence. It does not reflect any proof of citizenship. Therefore, you are potentially giv-



ing the right to vote to non-citizens," Congress member Shashi Tharoor said in Lok Sabha.

Besides linking electoral roll to Aadhaar, the bill also seeks to make the statutes gender neutral by substituting the term 'wife' with 'spouse' to allow husbands of service voters to cast their vote from the place where their wives are posted. It also seeks to provide four qualifying dates -- January 1, April 1, July 1 and October 1 -- in a year for reg-

istration of voters, instead of a single qualifying date -- January 1. The Bill was introduced after 12 noon and passed amid din by 15:10 pm.

**Opposition members slammed** the government for rushing the bill through parliamentary process in a "tearing hurry" and demanded that it be referred to a standing committee. In a statement, the CPI(M) Polit Bureau condemned the manner in which important changes in the electoral laws, which

have far-reaching consequences, have been rushed through Lok Sabha and passed in a din.

Responding to opposition concerns in Lok Sabha, the law minister said the Bill seeks to justify the Supreme Court judgement in the Puttaswamy case that defines the fundamental right to privacy. Rijiju said the Bill justified all the conditions given in the judgement permissible law, legitimate state interests, test of proportionality. He said the Bill will help in weeding out multiple entries in the electoral rolls and ensure that a person is registered as a voter in one constituency and would eventually lead to clean elections. On Aadhaar linkage, Rijiju said, "This is voluntary, not compulsory or mandatory."

The Bill makes it clear that "no application for inclusion of name

in the electoral roll shall be denied and no entries in the electoral roll shall be deleted for inability of an individual to furnish or intimate Aadhaar number due to such sufficient cause as may be prescribed".

Rejecting the demand for referring the Bill to a panel, Rijiju said various proposals which are part of the bill have already been suggested and recommended by the Standing Committee of Law and Personnel. The minister further said that the Bill will cleanse the election system and eliminate multiple entries.

BJP member Nishikant Dubey said the Congress and the Trinamool Congress were opposed to the Bill due to vote bank politics as they will not be able to make Bangladeshi and Nepali citizens voters in India.

He also claimed that the law allows a person to kill in self-defence, suggesting that this is what happened at the Golden Temple when the man was lynched after the alleged sacrilege attempt.

He told reporters that suspecting foul play, the Shiromani Gurdwara Parbandhak Committee (SGPC) task force had stopped the man from entering the Golden Temple but he managed to gain entry inside the sanctum sanctorum after the shift of task force members changed in the evening.

"I feel that he had undergone commando training from the way he jumped the railing and did it (made a sacrilege attempt) in just



six seconds. There is a big conspiracy behind it," Dhami said. On being asked that the man was lynched when caught by the SGPC task force, Dhami said "devotees were angry over this incident".

The man had picked a sword and was going to attack the holv Guru Granth Sahib, which is considered a living entity by Sikhs, Dhami said. One can kill a person in self-defence if somebody attacks with an intention of murder and the law does not consider it as an offence, he said. Before the task force members could do anything. the man was beaten up by the angry crowd that led to his death, he said. Dhami said the SGPC will set up its own special investigation team to "bring out the truth". Dhami said

will comprise two representatives from Sikh organisations, two from the SGPC and two "Panthic" scholars. "The SGPC has watched the CCTV footage to get to the bottom of the incident, he said. "CCTV cameras revealed that the accused reached Sri Harmandar Sahib via Jalliawala Bagh Marg at 8.30 am on the day of incident. During this time, he first came from the Sri Akal Takht Sahib secretariat side around 9 am to enter the 'parikarma', but returned," Dhami said. "He then reached Guru Ramdas

Sarai side through the plaza and entered the langar hall at 9.38 am. He had langar and took tea. From here, he entered the parikarma of Sri Harmandar Sahib at 10.19 am," said Dhami. "He reached inside the sanctum sanctorum for the first time at 10.34 am and at 10:37 am. He went upstairs on Har Ki Pauri and came out at 11.45 am. He then re-entered Sri Harmandar Sahib and committed the highly despicable incident at 5.46 pm," said Dhami.

New Delhi, Dec 20: Bharat Biotech has sought permission from India's drug regulator to conduct a phase-3 study for its intra-nasal Covid-19 vaccine as a booster dose on participants vaccinated with Covishield or Covaxin, official sources said Monday.

The company had in August received the Drug Controller General of India's (DCGI's) nod for conducting phase 2 clinical trials of the nasal vaccine.

"Bharat Biotech has put in an application seeking permission to conduct a study titled 'A Phase 3 Study to Evaluate the Safety and Immunogenicity of BBV154 and BBV152 as third dose (booster) to participants previously vaccinated with SARS-CoV-2 vaccines'," an official said.

BBV154 is an intranasal repli-



novirus SARS-CoV-2 vectored vaccine. Bharat Biotech has in-licensed the technology from Washington University in St Louis, the US.

The company reports that the doses of the vaccine administered to healthy volunteers in the phase-1 clinical trial have been well tolerated. No serious adverse events were reported, the DBT had said.

Previously, the vaccine was found to be safe, immunogenic and well-tolerated in the pre-clinical toxicity studies. The vaccine was able to elicit a high level of neutralising antibodies in animal studies, it added.

New Delhi, Dec 20: A weaker immune system, old age and comorhidities can increase the risk of co-infection from Omicron and Delta variants of Covid-19 at the same time, said health experts Monday.

Last week, scientists at the UK's Scientific Advisory Group for Emergencies (SAGE noted that some people have become infected by both the Delta and Omicron variants that are "operating separately as two epidemics" at the same time, making them seriously ill. The possibility

of a person being co-infected with both Delta and Omicron at the same time "is rare", Dr Dipu TS, Clinical Associate Professor, Division of Infectious Diseases.

Amrita Hospital, told IANS. However, "it's not impossible to have confection of two strains, especially if the patient has an immuno-compromised status", he added. Anecdotal reports have also suggested episodes of co-infection with two different strains of Covid-19 virus in the past. "Even though Covid infections normally only involve one mutant strain, in extremely rare cases, it is also possible that two strains strike at the

As per the SAGE, a successful new variant typically claims dominance by being much more infectious than previous strains, as has happened in the UK with Delta. In its latest update, the WHO said there is still limited data on the clinical severity associated with Omicron. So far it is known that people with Omicron can have the full spectrum of disease, everything from asymptomatic infection, mild infection, with people needinghospitalisation, but not oxygen

# **OMICRON SCARE** All Covid +ve samples to be sent for genome sequencing: Kejriwal

New Delhi, Dec 20: Amid the Omicron scare and the growing number of coronavirus cases in Delhi, Chief Minister Arvind Kejriwal Monday said all samples that test positive for the infection will now be sent for genome sequencing.

He also urged the Centre to allow the administration of booster shots to the fully vaccinated city residents. The chief minister appealed to people not to panic and wear masks as they are the most effective protection against the virus.

"For the last few days, COVID-19 cases are increasing in the city. Yesterday (Sunday), it was over 100. We don't know what type of Covid cases these are, normal or the Omicron variant. So, to ascertain this we have now decided to send the samples of all positive cases for genome sequencing," Kejriwal said at a press conference.

The decision was taken at a meeting of the Delhi Disaster Management Authority (DDMA) during which the Omicron situation, including its possible effects and steps to deal with it, was discussed, according to the Chief Minister. Delhi has reported 24 cases of the Omicron variant so far, according to sources.

Kejriwal appealed to the Centre to allow the administration of booster shots to those Delhi residents who have already received both doses of Covid vaccine. "About 99 per cent of our eligible population has received the first dose and about 70 per cent has been vaccinated with both doses."I request the central government to allow booster doses for all those who have been vaccinated with both doses. We have the infrastructure to administer booster doses. We can start with our healthcare work-

ers and then vaccinate the rest of the population," he said.

Keiriwal also said the home isolation system will be strengthened in Delhi as according to experts the Omicron variant only causes mild symptoms. "We will strengthen the home isolation system as most cases will not require hospitalisation. There is no need to panic in view of the Omicron variant as we have made adequate arrangements in hospitals to deal with any outbreak," he said.

He said the government has made adequate arrangements for hospital beds, oxygen, medicines and everything else that may be needed to combat the virus. "We will not let the people of Delhi face any difficulty in their treatment," he added.

The chief minister held a meeting on November 30 to review preparations to tackle a possible third wave of coronavirus and the spread of the Omicron variant. It has been assessed that 30.000 Covid beds are ready in Delhi. The govstatement said.

Northeastern Frontier Railway spokesperson Guneet Kaur said that there are many instances of alert loco drivers who have saved elephants from being hit but in the recent incidents no information from forest officials or villagers on the movement of animals was received by the nodal railway officials.

"After recent incidents, NF Railway has decided to conduct a detailed enquiry and has imposed caution during train movement along with reassessment of notified elephant corridors being taken up in coordination with the forest department", she said.

#### Assam may bring in law against mob lynching

Guwahati, Dec 20: The Assam government Monday said that it will discuss and consider a proposal to introduce a bill against mob lynching, in line with states like Manipur, Rajasthan and West Bengal.

Replying to the issue of bringing in legislation to stop incidents of mob lynching, Assam Parliamentary Affairs Minister Pijush Hazarika said in the Assembly that the state government has not thought about it so

"Though we have not enacted any law against mob lynching, we must take steps to prevent it. Many such gruesome incidents have shaken us. We will discuss and consider the acts implemented by other states," he said.

Hazarika said that as of now, the Assam government has not looked at the anti-mob lynching laws of states like Manipur, Rajasthan and West Bengal.

"We do not have any information about other states' laws. However, the Supreme Court, in the judgement in Tehseen Poonawalla case, had issued a set of guidelines to stop mob lynching incidents. It had also said that there was scope of enacting antimob lynching laws," he said. The minister mentioned several cases of mob lynching that took place in Assam in last few years that are being tried in fasttrack courts under various sections of the Indian Penal Code. New Delhi, Dec 20: The Commission for Air Quality Management (CAQM) Monday lifted the restrictions on construction and demolition activities in Delhi-NCR and the entry of trucks in the national capital in view of an improvement in air quality and favourable meteorological forecast.

The panel noted that the air quality index in Delhi has improved from the very poor category and has consistently been in the poor category for the last three days.

"Construction and demolition (C&D) activities in NCR shall now be permitted, with immediate effect subject to persons and agencies undertaking C&D activities strictly complying with dust control norms and directions issued under the Construction and **Demolition Waste Management** Rules and CPCB guidelines in this regard," an order read.

"Entry of trucks to Delhi, which hitherto was only selectively permitted, would be permitted with immediate effect till further orders," it said. The India Meteorological Department's fore cast indicates continuation of the favourable trend of wind speed and climatic conditions to facilitate dispersion of pollutants from the region, it said.

# DPCC to study microplastics pollution in Yamuna

New Delhi. Dec 20: In a first-of-itskind survey by a government body in the national capital, the Delhi Pollution Control Committee (DPCC) will conduct a study to ascertain the concentration, distribution and composition of microplastics in river Yamuna, besides soil, vegetables and other edible products

The pollution control body will also examine if the soil in the floodplains of river Yamuna is fit for agriculture, according to officials. Microplastics are fragments of any type of plastic less than five millimetres, according to the US National Oceanic and Atmospheric Administration and the European Chemicals Agency. They enter nat-

ural ecosystems from a variety of sources, including cosmetics, clothing, and industrial processes. Studies conducted earlier have

shown that microplastics carry bacteria that are pathogenic to human and natural biota, and can enrich antibiotic resistant genes from municipal activated sludge. The polymeric compounds and additives such as copper ions used in the production of plastics are toxic. Also, microplastics absorb various toxins



in water that subsequently desorb inside the host organism.

The Yamuna floodplains, stretching 48 kilometres from Palla to Okhla, will be divided into three stretches of 16 km each for the study: Delhi Segment I (Palla to Wazirabad), Delhi Segment II (Wazirabad to Nizamuddin Bridge) and Delhi Segment III (Nizamuddin Bridge to Okhla), according to the terms of reference prepared by the DPCC.

A DPCC official said the idea to study the presence of microplastics in river Yamuna and the national capital originated after an MP asked a question in Parliament about microplastics in river Ganga.

"It is sad that we have not conducted any such study in the national capital," the official said, citing a report by environment research and advocacy organisation, Toxics Link. The Toxics Link study on River Ganga threw up alarming results as "microplastics were found in all the samples"

"Locations with higher population density and greater industrialisation (textile, tannery, etc.) had a higher microplastics concentra-

The river water and the adjacent soil are contaminated with various pollutants, including heavy metals. In this study, the effects of seasonal variations and heavy metal contamination in Yamuna water on physicochemical properties and enzyme activities of soil will be observed," the terms of reference read. Sampling will be collected from 10 points along the river course in summer, monsoon and winter.

# Nations eye Britain's bleak Omicron surge

London, Dec 20: Britain's main nurses' union warned Monday that exhaustion and surging coronavirus cases among medical staff are pushing them to the breaking point, adding to pressure on the government for new restrictions to curb record numbers of infections driven by the omicron variant.

The warning throws into stark relief the unpalatable choice Prime Minister Boris Johnson faces wreck holiday plans for millions for a second year running, or face a potential

tidal wave of cases and disruption. Many governments in Europe and the US are confronting similar dilemmas over how hard to come down in the face of omicron, which appears more transmissible than the previous delta variant that itself led to surges in many parts of the world. Early evidence suggests omicron may also produce less serious illness — though scientists

caution it is too soon to say - and that it could better evade vaccine protection.

Even if it is milder, the new variant could still overwhelm health systems because of the sheer number of infections. Confirmed coronavirus cases in the UK have surged by 50% in a week as omicron overtook delta as the dominant variant. Patricia Marquis, England di-

Washington: Moderna said Monday that a booster dose of its COVID-19 vaccine should offer protection against the rapidly spreading omicron variant. #### SL navy arrests 12 **Indian fishermen**

Colombo, Dec 20: The Sri Lankan Navy has arrested 12 more Indian fishermen and seized two fishing trawlers for allegedly poaching in the country's territorial waters, taking the number of Indians apprehended in the last two days to 55, an official statement said Monday.

The arrests were made in seas South of Mannar in the Sri Lankan waters Sunday

It comes a day after the Navy arrested 43 Indian fishermen and seized six fishing trawlers in seas Southeast of the Delft Island in Jaffna.

"As part of the Navy's effort to prevent poaching by Indian fishing trawlers in Sri Lankan territorial waters, the Navy managed to take hold of 8 Indian fishing trawlers and 55 Indian fishermen during operations conducted by the Northern and North Central Naval Commands 18th and 19th December," the Navy said in a statement.

The operations were carried out adhering to COVID-19 protocols.

Arrangements are being made to hand them over to relevant authorities for legal action after Rapid Antigen Tests of the apprehended Indian fishermen, the statement said.

Fishermen from both countries are arrested frequently for inadvertently trespassing into each other's waters. The fishermen issue has become a major irritant in bilateral ties.

#### Court postpones Suu Kyi verdict

Bangkok: A Myanmar court Monday postponed the issuing of verdicts in the latest of a series of cases against the country's ousted leader. Aung San Suu Kyi, a legal official knowledgeable about the case said. The postponed verdict from the court in the capital, Navpvitaw, is for the second among multiple cases brought against the 76-year-old Nobel laureate since the army seized power Feb 1, ousting her elected government and arresting top members of her National League for Democracy party.

At its strongest, Typhoon Rai packed sustained winds of 195 kilometers per hour with gusts of up to 270 kph before blowing out into the South China Sea Friday.

The number and size of these lakes are increasing so continued acceleration in mass loss can be expected, they said.

Glaciers which have significant amounts of natural debris upon their surfaces are also losing mass more quickly, contributing around 46.5 per cent of total volume loss despite makingup only around 7.5 per cent of the total number of glaciers.

#### HOW THE PROTEST BEGAN

The farmers' year-long agitation began in 2020 L against the three contentious farm laws for agricultural reform. Farmers from Punjab, Harvana and Uttar Pradesh reached Delhi borders and set up camp there in November last year. The farmers demanded that the Farmers' Produce Trade and Commerce (Promotion and Facilitation) Act, 2020; Farmers' (Empowerment and Protection) Agreement on Price Assurance and Farm Services Act. 2020: and the Essential Commodities (Amendment) Act, 2020; be rolled back and a new law made to guarantee the minimum support price for crops. The three laws raised concerns that this will lead to the abolishment of the minimum support price (MSP) guaranteed by the government on select crops and leave farmers at the mercy of big corporates. Since these laws were promulgated, thousands of farmers gathered at the Delhi's borders demanding their repeal, pushing the SAD to quit the NDA government at the Centre. November 2020 saw a nationwide general strike in support of the farmers and thousands converging at various border points on the way to Delhi. Many rounds of talks took place between the central government and farmers represented by the farm unions. All were inconclusive with agreement on only two relatively minor points.

(AISATS). Competition Commission of India (CCI) has approved Talace acquiring shareholding in Air India, Air India Express and AISATS, an official release said Monday.

Deals beyond a certain thresh old require approval from the CCL which has the mandate to ensure fair competition in the market place. AISATS is engaged in the business of providing ground handling services at Delhi, Bangalore, Hyderabad, Mangalore and Thiruvananthapuram airports. It also provides cargo handling services at Bangalore airport, the release said. State-owned Air India has been incurring a monthly loss of more than Rs 600 crore.

Mumbai, Dec 20: India's market regulator ordered a vear-long suspension of futures trading in key farm commodities Monday, as the world's biggest importer of vegetable oils, and a major producer of wheat and rice, struggles to tame food inflation.

India's most dramatic move since allowing futures trade in 2003 threatens market confidence by making hedging difficult at a time of record highs in producer prices, weeks after farmers ended protests that led to the scrapping of contentious reforms.

In its order, the market regulator told commodity exchanges not to launch futures contracts of soybean, soyoil, crude palm oil, wheat, paddy rice, chickpea, green gram, rapeseed and mustard for a year. For existing contracts, no new po-

India (SEBI), added. Traders said the government, facing intense pressure to rein in food prices ahead of key state elections early next year, wanted to curb speculation that might have fuelled the rises.

Indian prices of edible oil prices hit records this year, prompting New Delhi to cut taxes on imports of palm, soy and sunflower oil in October. But the step had only limited impact, as global prices remain high and volatile.

Dhaka, Dec 20: Back to their best after a slow start, defending champions and Olympic bronze-medallist India would start as overwhelming favourites against Asian Games gold winner Japan in the semifinal of the Asian Champions Trophy men's hockey tournament here Tuesday.

The Manpreet Singh-led side's confidence must be sky high as they had thrashed Japan 6-0 in their last round-robin match and come Tuesday, India would definitely fancy another big win en

route to the title clash. Having said that, India will need to guard against complacency as any slip-up could spoil all their hardwork.

India ended the round-robin stage of the five-nation tournament at the top of the standings with 10 points, ahead of Korea (6), Japan (5), Pakistan (5) and hosts Bangladesh (0).

But the start was far from ideal for India. goals. The Indians completely outperformed Japan in all departments of the game in their league match and they would eye an encore in the semifinal as well.

The Japanese will have to lift their game by leaps and bounds and play out of their skin to give themselves any chance of registering an upset win.

Young Suraj Karkera has been brilliant under the bar for India, making some brilliant saves throughout the tournament while the Harmanpreet-led Indian backline too defended stoutly, saving as many as five penalty corners against Japan Sunday.

However, the Indian defence will need to be a little more cautious Tuesday and concentrate on not conceding too many penalty corners, which could hurt them as past results hardly matters in knock-out stage matches.

A slight slip-up or lapse in concentration can derail their campaign and spoil their second successive ACT title. India had won the title jointly with Pakistan in the last edition in Muscat.

Meanwhile, South Korea face Pakistan in the first semifinal Tuesday.

## 2ND ASHES TEST: AUSTRALIA WIN BY 275 RUNS TO TAKE 2-0 LEAD Richardson fifer sinks England

Adelaide, Dec 20: Australia took a 2-0 lead in the five-test Ashes series Monday by beating England by 275 runs and all but ensured the century-old urn will remain Down Under, courtesy a five-wicket haul by Jhye Richardson (5/42).

Set 468 runs to win, England was bowled out for 192 with 21 overs remaining on the final day of play in the day-night Test at Adelaide Oval. Jos Buttler (26) faced 207 deliveries for England before treading on his stumps to be out hit wicket in a losing cause.

"That's the attitude we have to har ness through the whole game, England captain Joe Root said. "The fight and attitude was great today and we just have to do more of it.' Australia stand-in captain Steve Smith said England "showed some really good resistance and fight" "We always felt (it would only take) a couple of balls, there was still plenty of time left. We just tried to stay calm," Smith said.

Only one team has come from 0-2 down to win an Ashes series: Don Bradman's Australians in 1936-37. As holders of the Ashes, Australia needs only to draw the next match.

Paceman Richardson took five wickets as Australia followed their nine-wicket triumph in the first Test in Brisbane with another resounding win, their ninth consecutive win in day-night matches.

Meanwhile, Australia has named an unchanged 15-man squad for the remaining three Ashes Tests. Josh Hazlewood missed the Adelaide Test because of a side strain. Fast bowler and captain Pat Cummins, a late scratch from

Barcelona, Dec 20: Depleted by coronavirus infections, Real Madrid was held 0-0 at home by Cadiz in the Spanish league to end their 10game winning streak across all competitions.

Jorge Molina struck three times in Granada's 4-1 win over Mallorca to become the oldest player — at 39 years and 241 days - to score a hat trick in the top five European leagues.

The stalemate against Cadiz leaves Madrid six points clear at the top. It came a day after second-\_ place Sevilla cut into Madrid's lead by beating defending champion Atlético Madrid 2-1.

Carlo Ancelotti was without Luka Modric, Rodrygo, Marco Asensio, Gareth Bale, Marcelo, and backup goalkeeper Andriy Lunin because of a COVID-19 outbreak. The Belgium forward, who cost Madrid 100 million euros in 2019, hadn't started a match since September, when he was part of the lineup that was embarrassed 2-1 at home by Moldovan side Sheriff in the Champions League.

# Redemption tale: The Srikanth story of guts and grit

New Delhi, Dec 20: From being at the pinnacle of global rankings to hitting nadir by failing to qualify for the Olympics, K Srikanth has seen it all in a matter of four years. So, it was hardly a surprise that the seasoned shuttler's celebrations seemed muted after the historymaking world championships silver.

He is not the one to celebrate comebacks. Instead, Srikanth displayed the equanimity that has helped him stay afloat during his struggle with fitness and form.

It was India's first ever silver medal in men's singles at the prestigious tournament but there were no fist-pumps or "dream come true" quotes. All he could gather was "this is something I really worked hard for, and I am really happy to be here today."

Chief coach Pullela Gopichand understood what the 28-year-old was going through and was glad that he did not get swayed by the success that has followed months of toiling and heartbreak, the biggest one being the Olympic miss.

Even if he had let his hair down a bit, who could have judged him? Because for a while now, the biggest believer in his ability to do something big was Srikanth himself.

Faced with a visa issue, he was not even sure of making it to the tournament, leave alone winning a medal and he was just happy to be competing.

It was in 2001 when the man from Guntur followed in the footsteps of his brother Nandagopal to pick up the racquet. Soon, he was training at the Pullela Gopichand Academy and earned early success as a doubles player but he switched to singles on the advice of the chief coach and burst into the scene with the Thailand Open win in 2013.

He was hailed as the next big thing when he shocked five-time world and two-time Olympic champion, Lin Dan in the final of China Open Super Series Premier event, a performance that also held out promise of a medal at the Rio Olympics. But Srikanth faltered at the quarters at Rio after Lin Dan avenged his loss at the biggest stage. However, the Indian soon returned



to stun the badminton world by claiming four super series title in five finals in 2017, a feat achieved only by the likes of Lee Chong Wei, Lin Dan and Chen Long in a calender year.

But then he injured his knee during the French Open in November that year and aggravated it at the national championships. He recovered to claim the coveted Commonwealth Games gold at Glasgow, 2018 and earned his place at the top of the world ranking for a week in April too.

The knee injury and other niggles, especially related to his ankle, affected his performance. With the Olympic qualification round the corner. Srikanth also rushed his return from injuries and the haste expectedly backfired. The number of internationals wins dwindled because of which his ranking started plummeting and he was out of the top 10 in November 2019.

He stayed committed to the process. A series of quarterfinal and semifinal finishes kept him afloat but he needed a title win, a taste of what it feels to stand at the podium again.
